

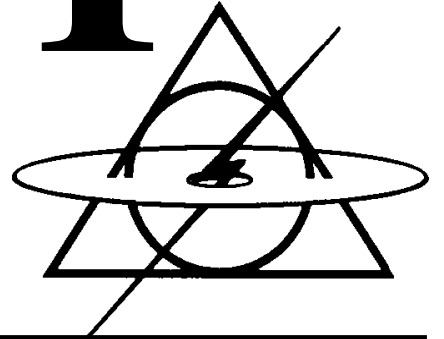

#### PARDONED SWINDLER CALLED ISRAELI SPY

The real reason that billionaire criminal currency trader Marc Rich received a full presidential pardon may surprise you. Read on for the sordid story. **[H: Currency trader should be sordid enough—but you can always KNOW that in anything of this magnitude, it is bigger than suspected.]**

Fugitive financier Marc Rich did not merely defraud the U.S. government of billions during the 17 years he spent on the lam, he also served as a spy for the Mossad, Israel's secret service.

For that virtue, he deserved a full pardon from former President Bill Clinton, argued SHABTAI SHAVIT, ISRAEL'S FORMER TOP SPYMASTER, in a letter to the White House last month.

Rich is the billionaire commodities trader who has long headed the Justice Department's “Most Wanted” list of big-time cosmopolitan crooks.

Shavit, director general of the Mossad from 1989 to 1997, confirmed that Rich has been an “extremely valuable” asset to the Israeli undercover operations around the world since 1983, when he fled the United States to duck tax-swindle and related fraud charges.

Shavit's argument—that such a major Israeli spy deserved U.S. clemency, even if he was otherwise alleged to be a major financial criminal—was echoed by other power-brokers, among them Israeli Prime Minister Ehud Barak and the rabbinical heads of the U.S. Holocaust Museum. **[H: You might want to read that again.]**

Clinton apparently agreed with them. Rich and his longtime partner, Pincus Green, received full presidential pardons last month, absolving them of crimes for which they never even had to stand trial.

“If Rich was really working for the Mossad, that does change the picture, but not the way Clinton seems to think,” said Coleman Horton, a retired congressional investigator. “The indictments outstanding against this

con man allege fraud running into tens of billions of dollars, but they cite only financial transgressions.

“If Rich was really an Israeli secret agent, he may be guilty of even more serious crimes: terrorism, sabotage, blackmail, kidnapping or murder, now acknowledged official policies of the Mossad,” Coleman added. “His case merits no clemency; just the contrary, it calls for a reinvestigation.”

A number of congressional leaders seemed to share these doubts, holding hearings on the Rich pardon in both the House and the Senate.

“Do billionaire financiers who demonstrate loyalty and generous contributions to Israel get favored treatment when they break the law?” asked Lamar Wooton, a longtime bond trader.

He noted the case of Bear Stearns, the huge Wall Street brokerage, which has come repeatedly under federal scrutiny for its links to dubious stock promoters.

The chairman of Bear Stearns, Ace Greenberg, is one of the largest contributors to Israel in the New York financial establishment. The investigation of his firm petered out inconclusively.

Others cited the scandal involving billionaire currency trader George Soros, who has been ordered to stand trial in France on criminal insider-trading and conspiracy charges.

“Under any normal circumstances, the French would ask for his extradition,” said Horton. “In this case, they say, the prosecutors in Paris were cautioned not even to try to collar Soros ahead of the trial.”

#### WESTERN PLANES STEP UP PATROLS OVER NO-FLY ZONE

**[H: Moving to the final three paragraphs of the article:]**

In a striking reminder of the 1991 Gulf War, after which the no-fly zones were set up, the Israeli army announced joint exercises with the United States to fire Patriot missiles used a decade ago to try to intercept Iraqi Scud missiles that hit targets around Tel Aviv. **[H: Or so the rumors went.]**

The Israeli military, however, insisted that the long-planned exercise starting today had no connection with the airstrikes that President Bush ordered against Iraq less than a month after taking office.

An estimated 10,000 Iraqis took to the streets in Sunday's Baghdad protest, chanting slogans against Bush and burning U.S. and Israeli flags in the biggest demonstration in the city since four days of Western bombing in December 1998.

I only use this as example because so much is expected of me and so much has been done by so few that the backs are tired and the bank accounts empty. So, do I have suggestions around this problem? Yes. We have had petitions one after another as to how can “I assist”? Well, probably two or three of these people would offer enough funds to pay a young crew to shift-and-fix—for it should not be much of an expense involved along with paint, cleaning supplies, etc.

I realize that I don't work fast enough for all (actually any) of you—but I will not jeopardize the program to end up discounted in the race itself.

I will note, however, that if no one is willing to make a working project of some of the things we have had in the building, I can't really consider long-term considerations of additional projects. We might as well consider the closing down of the projects under way, as in ancillary ventures.

I do have wondrous information regarding the use of Gaiandriana in conjunction with one or two of the colloids as is being tested here in Manila—with wondrous results as a tool in some of the more dastardly “bugs” as the microbes thin and the body builds better immunity. We tout no “cures”—but we note incredible response where used properly.

I also am greatly in appreciation to “Daystars” for their sharing of both things and ideas. There are many things I would like to have you be able to have available but at present time and space along with financial backup do not allow for same.

Please remember that our people are digging out from under Federal Raids which I am not going to discuss further here.

We ask for all the help we can get and, yes, everything is working out very well for “our side” as things further evolve. It has been a time to get to know the enemies—hasn't it? Let us count our blessings, please.

Our programs have HELD right through the Federal Courts, chelas, and even though it has been hard on you personally and emotionally, it is the most rewarding learning process when you KNOW and can use your tools—AND DARE TO DO SO. EVERYTHING THAT HAS COME AGAINST YOU, GOOD OR BAD, IS WORTHY OF A UNIVERSITY DEGREE IN THE VARIOUS SUBJECTS UNDER CONSIDERATION AND “ON THE JOB” TRAINING. YOU WILL NOT FORGET THE HARD-LEARNED EXPERIENCES—BUT YOU WILL NOT EVEN BOTHER TO LEARN BEYOND THE NECESSARY. THAT, EVEN IN THE FACE OF IT BEING OF IMPACT ON YOU DIRECTLY.

I ask that we not finish the longer discussion on the topics above, for we are extremely pressed for time here at this keyboard—and we must not let lapse opportunities opening up in this locale. I certainly have no wish to cause undue confrontation to Jews, Gentiles, Muslims or Zoroastrians, Zins or you name it. They are ALL “human beings” and all need shelter and food and that is a very great equalizer. Whether you eat rice in China or Iowa makes NO DIFFERENCE—you have to have the rice in either instance.

### RAIDERS OF THE LOST GOLD

#### CHAPTER 19

#### LOSSES AND MORE LOSSES

AFTER THE DEATH OF THE TWO WORKERS AND THE desecration of Fort Santiago, Soriano was reported to have deposited over one million pesos in a bank. Naturally, the country’s National Security Adviser was furious at the bank official who had tactlessly made the disclosure. Worse, he used a very lame excuse. Soriano claimed that the money was entrusted to him by International Precious Metals, Inc. (IPMI) for “safekeeping”. But why couldn’t IPMI bank the money on its own?

Soriano was “fired” by President Aquino as NSC Chairman after the group failed to find gold. “Instead of gaining funds as Mrs. Aquino had prospected, the government is poorer because of the diggings and stands to lose more millions to restore the tottering fort that threatens to cave in, unless Soriano is made to cover the diggings himself,” read Burgos’ commentary.

The Aquino government was now besieged by several other misfortunes. What needed immediate attention was the worsening inflation. During the six-day coup attempt in December

1989, prices of commodities soared by as much as 40 percent. Quickly, the beleaguered administration imposed price control on nine basic commodities—rice, canned liquid milk, powdered filled milk, sugar, dressed chicken, hard flour, pork, kerosene, and liquefied petroleum gas. But the problem seemed to have gone out of control. Shortly thereafter, Aquino expanded the coverage of price control to include eggs, cooking oil, and other pork products.

Two days before Christmas, Aquino signed the Emergency Powers Act which penalizes profiteering, speculation, and hoarding, declaring them as crimes against the people. It was during these hard times when many among those who were connected, one way or another, with the buying and selling of the Marcos gold, wanted to obtain an audience with the president “to talk over prospects of financing her deficit-ridden government”. One of them was Woodrow Yap, whose proposal led to the formation of a “Wealth Chase and Recovery Program”.

This recovery group was headed by Conrado (Dodie) Limcaoco, Jr., then manager of PTV-4, duly assisted by Maria (Mama Mary) Gosilatar, Carlos Gonzales, Brian Kim Kwong Lau, and Jojo Flores. Their first target was the recovery from China of the “19,000 metric tons of gold in Taiwan and Beijing, moved from 1973 to 1978 under the code name “AAA” used by Marcos in his transactions. Lau was chosen to assist in the proper approach and representation to China for the gold.

According to information gathered by Limcaoco’s group, the gold haul was spread out to the following banks in Hong Kong: (1) 12.5 kilogram bars amounting to 5,000 metric tons in Citibank N.A.; (2) 3,700 metric tons in the American Express Bank; (3) 75 kilo bars of 1,000 metric tons each in Hang Lung Bank, Wing Lung Bank, Hang Seng Bank, and Bank of America; (4) 200 metric tons in the Overseas Bank & Trust Company; and (5) two pieces of gold bars in the Industrial Bank.

The gold was supposedly moved in 1983 by Marcos’ military officers, secret agents, some Central Bank officials and employees, the CIA, Pan Am Airlines, SABENA and KLM, including a cargo vessel that sailed from Manila to Hong Kong via Taiwan and in the port of Beijing, using the shipping code “AAA”.

On October 25, 1983, the \$290 Billion was allegedly placed in trust in one of the banks as “standby money for payment of 32,000 metric tons of gold of assorted sizes”.

A certain Mr. Bruce Bullock, introduced to President Aquino by one, Quirico Dumasig, managing director of the International Phil-American General Services, Inc., offered to make available to the administration “huge resources up to U.S.\$750 billion on a strictly confidential Trust Transaction basis.”

Nothing profitable ever came out of these deals. All the Aquino administration incurred were losses and more losses.

All the gold transactions were supported by voluminous documents, letters, affidavits, memoranda, official receipts, and facsimiles of

other pertinent papers. But the name of Ferdinand E. Marcos never appeared in any of the documents; nor did any of the names of his family. The only reference to Marcos was a letter written by Bruce Bullock, offering a portfolio of billions of dollars to pay for the Marcos gold. This particular deal had to do with 100,000 metric tons of gold.

As Teodoro (Teddy) Benigno of the *Philippine Star* once commented, “Marcos was a devil of a genius, who wove tales with such stunning and superlative skill that he could make even the likes of Enrique Zobel hang on like a gape-mouthed child in the grip of a *Canterbury Tale*.”

The mystery of the Marcos gold remains a mystery, incurring heavy losses to those who dare uncover it.

#### CHAPTER 20

#### YAMASHITA’S GOLD... AGAIN?

ON OCTOBER 5, 1990, THE *PHILIPPINE STAR* CAME OUT WITH the stunning news that the late President Marcos actually recovered half of the estimated \$80 Billion worth of Yamashita’s fabled treasure. The fishy report came from Solicitor General Francisco Chavez, who was in Negros Occidental at that time.

According to Chavez, former Auro Province Gov. Orlando Dulay had confirmed to him and PCGG Chairman David Castro that the Yamashita Treasure was excavated in two places in Luzon by the late strongman. The rest, according to Dulay, was still in Antipolo and could be worth up to \$40 Billion at the current price of gold.

Chavez told a press conference in Bacolod City that Dulay had some “verifiable old facts” that may be worth looking into. Dulay reportedly admitted that he was one of three trustees named by Marcos to look after the gold, but he did not name the two others.

Yamashita Treasure?

Manuel L. Morato, then Chairman of the MTRCB, found it hard to believe. “If indeed there is such a treasure, it could not have been buried in this country... it could be possible that this fortune was brought to Japan, knowing that the Japanese are very nationalistic... this could be the reason for Japan’s phenomenal rise from the ravages of war.”

Manoling, as he is fondly called by friends, expressed this possibility “because my father’s car was brought to Japan by Yamashita.”

Don Tomas Morato, the illustrious mayor of Quezon City, had a “Graham Bell” limousine, a very special model, which his family used before the war. It was the mayor’s hobby to be the first proud owner or buyer of any latest model brought to the Philippines by La Estrella del Norte, Inc., then the premier importer of automobiles. Unfortunately, the prized car was confiscated by Yamashita and became his official service vehicle while he was here. Later, the Japanese General took it to Japan and since then, the Morato family had not heard about it.

Joe "Take it Away" Quirino of the *Philippine Star* concurred with Manoling. "Yamashita was not only a brave officer; he was also upright and honest and would never think of hoarding someone else's treasure or gold. When he took command of Nippon forces in a last ditch effort to defend the Cordilleras, Yamashita had no time for gathering gold bullion or any kind of treasure. It is completely unfair, therefore, to link Yamashita to any treasure hoard or gold bullion," Quirino insisted.

Despite the clear fact that Yamashita was a victim of judicial lynching, he never lost his composure. One of his prosecutors reportedly told Yamashita's chief defense counsel, Frank A. Reel, "Damn it. It makes me mad, seeing him decked out in uniform. He steals the show, dominates the council room. If I had my way, I'd put him in prison overalls and chains."

According to Quirino, Yamashita accepted the verdict calmly, saying, "I am not ashamed before God for what I've done when I have to die. But if you say to me, 'You do not have the ability to command a Japanese army,' I should say nothing because it is in my own nature. I know that all your American military officers have been very tolerant and exercised rightful judgment, when I have a good treatment, kind attitude from your good-natured officers who, all the time, protected me. I'll never forget what they have done for me. Even if I die, I don't blame my executioners. I'll pray to God to bless them."

Are these the words of a thief and a plunderer?

So why did Dulay insist that the Marcos gold haul is a part of Yamashita's Treasure? Perhaps that is what he was made to believe—by his peers and maybe by Marcos himself.

"He, Dulay, was approached by Castro and Chavez. I think the Solicitor General helped him with a manifestation in his petition with the Supreme Court," said Chuck McDougald in an interview by Roy de Guzman of the *Inquirer*. "But he was given a condition: he had to show one gold bar before he is taken out of prison. He did not, so it did not push through."

Dulay never came out of his prison cell alive. He died a mysterious death.

## CHAPTER 21

### IMELDA AND THE WE FORUM SERIES

IN HER LATEST POLITICAL CHARADE DESIGNED TO CAPTURE THE attention of voters in the 1998 presidential elections, madam Imelda Marcos told a press forum: "If you know how rich you are, you are not rich. But me, I am not aware of the extent of my wealth. That's how rich we are." (*Inquirer*, March 27, 1998)

The former first lady publicly admitted, for the first time, that her family has more than \$800 Million in secret bank accounts abroad, over and above the \$540 Million in two Swiss banks which the Philippine government claims to be part of the Marcos' ill-gotten wealth.

"There is more wealth that this government is

not aware of, but for the time being, I can admit that there is only \$800 Million kept in various banks. But I cannot reveal them," she added.

In January 1990, the now defunct *We Forum* ran an investigative series on the magnitude of the Marcos gold. In the first part, Eric Giron revealed some shocking information on the gold haul. "Whatever gold Gen. Tomoyuki Yamashita, the wartime overall commander of the Japanese Imperial forces in the Philippines, was able to scrape from Asian sites as claimed, was a mere drop in the bucket of the 75,000 metric tons of gold transmitted by Marcos to London and other foreign gold pools between 1970 and 1983," according to Giron. "This haul," he added, "would be nearly equal to all the gold estimated to have been mined legitimately throughout history."

The revelation practically doused cold water on Dan Swihart's claim that "gold bars had been found in Tarlac and five areas in Nueva Ecija," and that some survivors of World War II testified that 3,000 Philippine areas kept treasures of Yamashita taken from Asian sites. Swihart claimed to be a consultant of International Precious Metals, Inc.

The *We Forum* series, likewise, asserted that Marcos' private airplane and commercial airlines ferried the gold bullion to a bank in Zurich about 12 times. A KLM Royal Dutch Airlines flight to Zurich reportedly carried a cargo of seven tons of bullion on September 26, 1963. At the same time, another 3,000 kilos were shipped to London.

Marcos' method of shipping his bullion out of the country was discovered by U.S. Customs personnel who stumbled upon a pouchful of documents carried by one of General Fabian Ver's operatives. "Marcos devised a scheme to float large loans using the gold bullion stored in a privately-owned bank of Marcos crony Roberto Benedicto. The sale was to be made through an accountant with CIA connections in Alexandria, Virginia," elaborated Giron.

This information was supported by confidential correspondence received by Giron from a Makati-based corporation, which read, "Gold bars in the Philippines of about 62,321 metric tons or more with 999.9 percent purity were negotiated for investment loans from 1980 to 1984 ... The huge sums intended for investment loans were still intact, or 'frozen' with 800 prime banks in the U.S.A. and 500 prime banks in the European continent ...".

Giron's set of documents also included one which showed former President Ferdinand Marcos as "a coded private seller of scattered gold bars using the services of coded agent PN-1518254 and his 25 secret groups," with the participation of U.S. and European secret organizations.

"Even when Marcos was in exile in Honolulu on February 22, 1987, he was still selling gold bullion, this time openly," pointed out Giron. "The stationery bearing an etching of the deposed President's face, the Malacañang seal, and his signature carried an offer of 25,000 metric tons or more of gold bullion with 999.5 percent purity of

24 karats in different places such as Canada, Australia, Holland, Alaska, India, and Zurich."

The personal and very confidential letter dated 21 February 1981 addressed to "Her Excellency, Madam Imelda Romualdez-Marcos, Malacañang Palace," opening with a list of government officials and top-ranking businessmen concerned with what was camouflaged as "Japanese financial aid to the Philippines", was part of the coded sales, insisted Giron.

The letter further read, "The Japanese aid consists of accumulated interest income of dollar fund left in trust by General MacArthur to the Imperial family. The trustees are two Americans and one Japanese by the name of Mr. Yutaka Aoki... We are devising a means of how to bring out the money to Hong Kong under the authority of the Ministry of Finance of Japan and our cooperation is needed. It shall be made to appear that the money will be loaned to a Japanese company doing business in the Philippines and they found that Kawasaki is qualified. The Trust money in the hands of the Imperial family has already been deposited with Sanwa Bank in Osaka and is ready for the economic development project of the First Lady."

NOTE: One nagging problem is Imelda Marcos' continued promises to share Marcos' wealth with the Filipino people. Some of the Marcos gold accounts under her name had been earlier changed by the late President into other accounts in 1987 to safeguard and secure the fruits of his toil. In the process, Marcos was merely protecting his family and the Filipino people, who will finally stand to benefit from all his wealth.

## CLINTON SAYS ISRAEL INFLUENCED PARDON

WASHINGTON—Amid the firestorm over fugitive financier Marc Rich's pardon, former President Clinton said Thursday in a conversation with *CNBC's* Geraldo Rivera that Israel influenced him "profoundly" in granting the pardon....

CLINTON, IN A phone discussion with the host of *CNBC's* "Rivera Live", said he was "blindsided" by the furor over the pardon for Rich, who faced tax evasion and other charges.

"I have no infrastructure to deal with this, no press person. I just wanted to go out there and do what past presidents have done, but the Republicans had other ideas for me," said Clinton.

"There's not a single, solitary shred of evidence that I did anything wrong or that his [Rich's] money changed hands," he said. "And there's certainly no evidence that I took any of it."

Clinton pointed out that Rich was once represented by lawyer Lewis Libby, now Vice President Cheney's chief of staff.

Rich "had three big-time Republican lawyers, including [Vice President] Dick Cheney's chief of staff," he said. "Marc Rich himself is a Republican."...

During the interview, Clinton said campaign funding played no role in the pardon, but he added, "I'll tell you what did influence me — Israel did influence me profoundly."...

The *Associated Press* reported Thursday that Rich has been a longtime supporter of Israel's Labor Party, including acting Prime Minister Ehud Barak and former Prime Minister Shimon Peres.

The Belgian-born Rich grew up in the United States, but his lawyers said he renounced his U.S. citizenship. Rich, who has lived in Switzerland since 1983, says he holds Israeli and Spanish citizenship, but Republican members of Congress have asked the State Department to investigate that claim. Rich was indicted in the United States on charges of evading more than \$48 million in taxes, fraud and conducting illegal oil deals with Iran.

Over the past 20 years, Rich has contributed \$70 million to \$80 million to Israeli hospitals, museums and orchestras and to help settle immigrants, said Avner Azulay, head of the multimillion-dollar Rich Foundation in Tel Aviv.

Azulay, the former chief of Israel's Mossad spy agency, said he believed Clinton pardoned Rich, in part, because of his role in helping Israel get Jews out of Ethiopia and Yemen.

Azulay said he helped collect the testimonials from prominent Israelis that played a role in obtaining the eleventh-hour pardon, now subject of congressional hearings and a federal probe.

He wouldn't say how many statements were collected, but he said Barak and Peres had spoken to Clinton about Rich.

Barak spokesman Gadi Baltiansky confirmed that the prime minister raised the subject in a recent conversation with Clinton. Baltiansky would not elaborate, and Peres declined to comment.

E-mails subpoenaed by Congress and now part of the public record reveal intensive behind-the-scenes efforts to engineer a pardon for Rich.

Barak's name is mentioned repeatedly. In one e-mail, Azulay suggests asking the White House to delay making a decision until leading Israelis such as Barak and Foreign Minister Shlomo Ben-Ami "can make their appeals".

An e-mail from Robert F. Fink, one of Rich's lawyers, emphasizes the importance of high-level Israeli support. "So do not let up," Fink wrote.

Azulay also asked the Rich team to keep the prime minister's name out of the press. "It's important to keep all politicians' names out of the story... This is election time here and has a potential of a blowup," Azulay wrote.

Former Mossad chief Shabtai Shavit said he recommended to Clinton that Rich be pardoned because the billionaire's business ties helped Israel get Jews out of Ethiopia, Sudan and Yemen—countries without diplomatic ties to Israel at the time....

Rich, 66, has never lived in Israel, but he has given to a series of charities, from funding a program for young Diaspora Jews studying at a Jewish seminary in the West Bank to a health program for Palestinian children in the Gaza Strip.

In northern Israel, he built a home for autistic children. He gave millions of dollars to Israeli medical centers to research treatments for leukemia, the disease that took his daughter Gabrielle's life in 1996, at age 27.

"He has helped Israel address its social problems and provide for its security needs," Israeli Parliament Speaker Avraham Burg said in a letter to Clinton, included in the e-mail traffic.

Rich last visited Jerusalem in early January—before the pardon—and met with Barak and other leading Israeli politicians, according to the e-mails. He also mingled with young Diaspora Jews visiting Israel as part of the Birthright Israel program, to which he contributed \$5 million. The program sends Jews to Israel, all expenses paid, to foster ties with the state.

Meanwhile, sources told NBC News that House investigators seeking immunity for Denise Rich, Rich's ex-wife, have agreed to wait at least a week while the federal prosecutor in Manhattan conducts a preliminary investigation of the pardon.

The House Government Reform Committee agreed to the delay out of concern that granting immunity to Denise Rich could interfere with the prosecutors' investigation.

The committee's chairman, Rep. Dan Burton, R-Ind., wants immunity for Denise Rich to compel her testimony. She has refused to answer questions from the committee, citing her constitutional right against self-incrimination....

Denise Rich, a songwriter, contributed an estimated \$450,000 to the Clinton Presidential Library Fund, more than \$1.1 million to the Democratic Party and at least \$109,000 to Hillary Rodham Clinton's Senate campaign....

Days after the pardon, Rich said in a statement that it was "entirely appropriate" for her to be among those who petitioned Clinton. She said her political fund raising and charitable activities had nothing to do with the pardon granted to her ex-husband....



Prosecutors were expected to examine bank records, phone records and other documents to determine if any criminal activity was involved in the decision to pardon Rich.

A source familiar with the investigation told *The Associated Press* on Wednesday that White's office "is trying to determine if there was a transfer of money to buy the pardon."

White, who was said to be furious over the pardon of Rich, said Clinton made his decision without consulting her office....

President Bush on Tuesday bluntly opposed congressional investigations of Clinton's pardons.

#### RABBI: "MARC RICH PARDON WAS BOUGHT"

NEW YORK (UPI)—The head of the largest Jewish denomination in the United States Thursday criticized Jewish leaders who lobbied in favor of a pardon for Marc Rich calling it a "moral stain" for Jews.

"Charged with massive tax evasion and breaking an embargo on trading with Iran, Rich is a multimillionaire fugitive from justice who lives in luxury in Switzerland," Rabbi Eric Yoffie, president of Reform Judaism's Union of American Hebrew Congregations, wrote in an op-ed piece in the New York-based *Jewish Week*. "I am in no position to judge Rich's legal claims, but neither are the many Jewish leaders and luminaries who contacted President Clinton in support of the pardon."

"Why their interest in a man who appears to have traded illegally not only with Iran but with Iraq and Libya, rogue states devoted to Israel's destruction? The answer is simple: They were bought," added Yoffie. "Rich contributed generously to Jewish causes and charities around the world, and then, in a carefully orchestrated campaign, called in favors to put pressure on the president."

A last-minute presidential pardon was given by Bill Clinton on the day he left office last month to fugitive financier Marc Rich who fled the country in the 1980s before he was charged with 51 counts of tax evasion and fraud.

"President Clinton was a good friend of the Jews, but many of his last-minute pardons were simply outrageous," Yoffie said. "Among the most indefensible were those granted to Jews, but scarcely a voice of Jewish protest has been heard."

In a terse statement released Thursday, U.S. Attorney Mary Jo White in Manhattan, who was appointed by Clinton in 1993, said her office and the FBI "have opened an investigation to determine whether there have been any violations of federal law" in the pardons of Rich and his partner, Pincus Green.

Clinton denied any wrongdoing in a statement issued through his transition office spokeswoman, Julia Payne, late Wednesday.

"As I have said repeatedly, I made the decision to pardon Marc Rich based on what I thought was the right thing to do," Clinton said. "Any suggestion that improper factors, including fund-raising for the party (Democratic National Committee) or my library, had anything to do with the decision are absolutely false. I look forward to cooperating with any appropriate inquiry."

According to press reports, former Israeli Prime Minister Ehud Barak called President Clinton twice, Jerusalem's Mayor Ehud Olmert wrote the president, and dozens of Jewish and Israeli philanthropists added their support to the Rich pardon.

Rich donated about \$200 million to causes in Israel in the last 15 years, a source who did not want to be identified told *United Press International*.

Rabbi Irving Greenberg, chairman of the Holocaust Memorial Council, the governing board of the Holocaust Museum in Washington, D.C., made a serious error when he sent a letter to President Clinton on council stationery, according to Yoffie.

"Rabbi Greenberg is giving no interviews," museum spokesman, Arthur Berger, told *UPI*. "But on Jan. 31, he went to the governing council and took full responsibility for writing the letter on council stationery, and apologized to the council."

#### MOST POWERFUL MAN IN THE WORLD IS NOW A NOBODY

Stripped of office, shunned by friends and rattling alone around a half-furnished suburban home, Bill Clinton is in a deep, post-White House funk.

Instead of the presidential platoon of butlers, cooks and drivers, he now has just one valet, Oscar, who keeps him fuelled with Diet Coke and cookies. Rather than relying on his personal telephone exchange, he now struggles with a Palm Pilot, searching for the numbers of friends who are suddenly not so keen to take his calls.

The panoply of aides and advisers he deployed to divert the scandals that scarred his presidency are gone, and he is forced to fight his battles alone. Mr. Clinton hoped for a triumphal entry into New York accompanied by celebrations and Hail Caesars. Instead he has endured a month in the stocks pelted with charges of corruption, petty larceny and abuses of power.

The sophisticates who fawned on him when he could offer rides on *Air Force One* and nights in the Lincoln Bedroom now treat him like the Arkansas hick, unfit to play in the big leagues of money and power.

"The Incredible Shrinking Ex-President" is how *Time* described Mr. Clinton in its latest issue. The magazine claimed he was indignant about the reaction to his last-minute presidential pardons, notably of the fugitive financier Marc Rich.

He has told friends that if he wanted to reward his financial supporters he would have pardoned Leonard Peltier, a jailed Native American activist, whose backers include David Geffen, one of the founders of the Hollywood studio Dreamworks SKG. Mr. Clinton was reported to have huffed: "David Geffen will barely talk to me."

The former friends and colleagues now arrayed against Mr. Clinton is staggering. On Sunday, two more former allies weighed in against his pardon of Mr. Rich. Charles Schumer, the New York Democratic Senator and Hillary Clinton's Senate colleague, said: "There's no excuse to pardon a fugitive."

Referring to Mr. Clinton's *New York Times* article defending the pardon, he said: "Nothing the president wrote has changed my views." Also critical was Charles Rangel, the Representative from Harlem, who earlier in the week welcomed Mr. Clinton to the New York district where he will have offices.

Mr. Rangel said it was necessary to establish "whether any criminal activity was involved" in the pardon. One of Mr. Clinton's former Cabinet members told *Time* he felt "total disgust" at his former boss's behaviour.

Congressman Barney Frank, a liberal Democratic Congressman from Massachusetts, said the Rich pardon was "just abusive", adding of the Clintons "these are people who forgot where the line was between public service and what was personally convenient for them".

As he sits alone in Chappaqua, while his wife toils in Washington and his daughter finishes university, Mr. Clinton does what he did throughout the debacle surrounding Monica Lewinsky: telephones friends at all hours and asks them to validate his endless self-justification. But even they are said to be weary of listening.

#### IRAQI REBELS TO GET SPECIAL WEAPONS

WASHINGTON (UPI)—In the next month, a handful of Iraqi rebels are scheduled to go to College Station, Texas, for their first round of weapons training from federal lawmen and members of the military's Special Forces under a U.S. plan to support insurgency activities inside Iraq.

The Iraqi National Congress, the coalition of Iraqi dissidents and rebels supported by the United States officially since 1998, are in the final stages of completing a \$98,000 contract with the Guidry Group, a consulting firm comprised of ex-secret service agents. Under that contract, INC security officers will learn the fine art of diplomatic security.

What distinguishes this training from previous courses for the INC, is that the rebels attending the five-day seminar will also learn how to use pistols, Kalishnikov rifles, 12-gauge shotguns and a variety of other firearms. Previous U.S.-backed training for the INC has been limited to "non-lethal" activities, such as emergency medical care, public relations and war crimes investigations, according to an INC adviser.

While the State Department still considers this assistance to be of the non-lethal variety, the INC clearly does not. "This is important because this is the first time we are receiving lethal training with the United States government funding," said Francis Brooke, the

Washington adviser for the INC.

Retired Gen. Wayne Downing, the commander of the Joint Special Operations Task Force during the Gulf War, concurred. He told *United Press International*, "This is significant because this is the first lethal training. It is designed to protect, so the significance is that this is the first time they are being trained to do anything on this level."

But State Department officials disagree. One official said, "This is not lethal assistance. The skills involved are purely protective and defensive in nature of the type necessary for the Iraqi National Congress to protect any non-lethal presence or activities inside Iraq."

The debate over lethal assistance marked the INC's fiercest battle with the Clinton Administration. The lethal aid promised in the 1998 legislation that authorizes \$98 million for the group was never delivered largely under the premise that the INC was not ready to challenge Hussein militarily.

But this thinking may change under the Bush administration. While Secretary of State Colin Powell has carefully avoided making any comments on the military aspect of the Iraq Liberation Act, his counterpart at the Pentagon, Donald Rumsfeld is a long time supporter of a plan to oust Hussein through U.S.-backed rebels.

Both Rumsfeld and his deputy, Paul Wolfowitz signed a letter to President Clinton in 1998 that spurred the creation of the Iraq Liberation Act.

The Feb. 18, 1998 letter states, "Iraq today is ripe for a broad-based insurrection. We must exploit this opportunity." It goes on to outline a series of steps the government should take to aid the INC, including positioning "U.S. ground force equipment in the region so that, as a last resort, we have the capacity to protect and assist the anti-Saddam forces in the northern and southern parts of Iraq."

The \$98,000 contract with the Guidry group is tucked into a larger \$4 million aid package—separate from the Iraq Liberation Act funding—aimed at establishing an alternative Iraqi media through radio transmitters, satellite television stations and newspapers. The plan, approved initially in September by the Clinton administration, also sets aside money for INC members to go inside Iraq to collect information on war crimes, Iraq's military and political changes.

One of the INC's principal leaders, Ahmad Chalabi, speaking to reporters and analysts Friday at the American Enterprise Institute, said he believed his group could attract a number of defectors from Iraq's military if they established a presence inside the country.

"The Iraqi army is unwilling to defend Saddam, but they are too weak to overthrow him," Chalabi said, estimating that 40 percent of Iraq's elite Republican Guard is absent without leave.

To be sure, the five-day security seminar is a far cry from the battle field training and American military support envisioned by Chalabi and his supporters in Washington. Chalabi on Friday said he hoped the Pentagon would change the rules of engagement for American aircraft patrolling the no-fly zone in northern and southern Iraq, to allow fighters to attack Iraqi army battalions when they were moving against civilian targets.

Downing, who has worked as an adviser on a volunteer basis with the INC for three years, called the security training in the State Department aid package a "drop in the bucket".

"This is not the training they will need to put together a liberation army. There you would need individual training, basic training, weapons training, involving anti-tank weapons, machine guns, rockets and

that sort of thing," he said. Downing estimates this sort of training would take six to eight months and could be provided by either the U.S. military or the CIA.

INC officials will meet with the acting assistant secretary for Near East affairs, Edward Walker, Tuesday to discuss the remaining details of the \$4 million aid package.

#### "WE ARE AT WAR"

JERUSALEM (AFP)—Israeli ministers Wednesday called for the Palestinian territories to be totally sealed after at least nine people were killed when a Palestinian bus driver rammed a group of Israelis near Tel Aviv.

Israeli officials charged the incident was a deliberate attack, and Deputy Defence Minister Ephraim Sneh declared, "We are at war."

"We must hermetically close off the territories, even for months, while the bullets are flying," Communications Minister Binyamin Ben Eliezer told Israeli public television.

"They (the Palestinians) want blood and we cannot accept that. Yasser Arafat must restore calm, I say that categorically."

"We have negotiated for years with him and it is time he understands," Ben Eliezer said of the Palestinian leader.

Sneh, speaking on public radio, said, "A total blockade could be imposed."

"We are at war," he added. "Several terrorist organisations, Islamic Jihad, Hamas, Hezbollah, Ahmed Jibril's group, are waging a terrorist war against us and do not lack the means."

"We take into account various criteria, political and security-related, when we impose the blockade."

The Israeli army has closed off the West Bank and Gaza Strip to varying degrees, since the start of the deadly wave of Israeli-Palestinian violence in late September.

UN Middle East envoy Terje Roed-Larsen warned Tuesday that the resulting economic hardship hitting the Palestinians could exacerbate the situation and urged Israel to lift the crippling sanctions...

Israeli television quoted Sharon as calling the bus incident a "very serious attack".

"This very serious attack proves once again that the Palestinians don't make any difference between Israel and the settlement of Netzarim," Sharon said, referring to the Jewish settlement in the Gaza Strip that has been the scene of much fierce fighting over the past four and a half months of unrest.

Likud member of parliament Danny Naveh said, "Those who attack our soldiers and civilians must know that they will pay the price. The Palestinian Authority has freed dozens of criminals of Islamic Jihad and Hamas and is doing nothing to counter terrorism."

He warned: "We will not tolerate such a state of

affairs with a government headed by Ariel Sharon."

A Palestinian official said that the bus driver's action was a "personal operation" reflecting the seething anger of the Palestinians after months of bloodletting.

"This was a personal operation. It expresses the anger of the Palestinian people against the Israeli policy of killing Palestinians and against Israeli state terrorism by the Barak government," said cabinet secretary Ahmed Abdel Rahman.

"It signals how angry Palestinian people are about the Israeli aggression and way the Israeli army is dealing with the people in the Palestinian territories," he told AFP.

He referred in particular to the assassination of an officer in Palestinian leader Yasser Arafat's personal security force on Tuesday, who Israel said was an agent of the Lebanese Shiite Hizbollah movement and had orchestrated several "terror" attacks.

But Sneh defended Israel's tactics, which have also been condemned by the European Union and the United States.

"We will continue our policy of liquidating those who plan or carry out attacks, and no one can give us lessons in morality, because we have unfortunately 100 years of experience in fighting terrorism," he said.

#### PALESTINIANS ALLEGE ABUSES AT ISRAELI ARMY ROADBLOCKS

#### *Israel Says Villages Must Be Sealed Off to Prevent Attacks*

RANTIS, West Bank—Sabrin Balout began the first hours of her life the way West Bank Palestinians of any age spend many of their hours—stopped at gunpoint at Israeli military checkpoints....

Israel says the closure policy is necessary in the wake of 4 ½ months of violence to prevent attacks like Wednesday's in which a bus driven by a Palestinian from Gaza plowed into a bus stop, killing eight Israelis. In addition, officials note, Rantis lies on a road connected Israel and the West Bank.

But Palestinians say the closures—which restrict movement of Palestinians not only into Israel but also between towns and cities in the West Bank—are unfair collective punishment, disrupting the economy, separating families and causing severe health hazards because the sick cannot reach hospitals and ambulances are often prohibited from reaching the sick.

Now the practice is coming under increasing criticism not only from Palestinian medical officials, but also from Israeli human rights groups and such international organizations as the Red Cross. The International Committee of the Red Cross said this week it was suspending a program to allow Palestinian family members to visit their relatives in Israeli jails because some buses carrying the relatives encountered closed roads and lengthy delays at roadblocks.

Officials of Palestinian, Israeli and international groups say some Palestinians have died because they were prevented, or delayed, from reaching nearby hospitals—heart attack victims, stillborn infants and

women giving birth. In a recent report, the Palestinian-run Health, Development, Information and Policy Institute documented the cases of nine Palestinians who it said died because they were refused permission to cross Israeli checkpoints to reach hospitals.

The institute also reported that three women gave birth in cars or taxis—including Sabrin's mother—because they could not reach hospitals, that a 39-year-old woman gave birth to a stillborn child and that another woman suffered a miscarriage while the car she was riding in traveled a rutted dirt road to avoid roadblocks.

A report by the Israeli human rights group B'Tselem found that seven Palestinian infants died last year after being born either at home or in cars. The report also included a first-person account of a 39-year-old man who described how on Jan. 7 his wife went into labor but was unable to get to a hospital because their West Bank village had been sealed off by Israeli forces. He said his daughter was stillborn at home.

Maj. Yarden Vatikay, a military spokesman, dismissed the accounts of deaths and births at checkpoints, saying, "Most of them are just actual lies." He said Israeli soldiers enforcing the closure have orders not to interfere with legitimate medical emergencies. "The orders are very strict," he said. "If there's an immediate medical situation, we don't ask any questions."

Vatikay said the army investigates all the human rights groups' reports. "Ninety-nine percent are actual lies," he said. "Most of the time, they're lying. It's just propaganda."

In the case of the Red Cross buses being stopped at some roadblocks and finding other roads closed, Vatikay blamed Red Cross officials for not sticking to agreed upon routes. "They want everything, with no consideration for our security concerns, and security measures are very, very tight," he said. "We have shootings, murders and terrorist attacks every night. We have closures and roads are blocked, yes."

An Israeli aid group official said the problem may be that orders from the top are not always understood, or properly carried out, by soldiers manning the checkpoints. "It is a question of management," he said. "At the bottom, there is a lot of maliciousness as well. The soldiers at the checkpoint may be [nasty]. Or maybe the commander didn't make the order absolutely clear."

The main road in and out of Rantis is blocked by a huge mound of earth, reinforced by concrete blocks. A narrow, gravel back road is often blocked by a military checkpoint. Most of the men here had jobs in Israel and have had no work, and no income, for months. The small local stores sell supplies on credit but have trouble getting fresh stocks because of the closure. Depending on circumstances—the level of violence on a given day, for instance—there can be as many as five checkpoints between Rantis and Ramallah.

There were five the day Amina Balout went into labor. The first pains came just after 4:30 p.m., and Saleh loaded his family into a 10-seat minivan for the trip to Ramallah. At the first checkpoint, just outside the village, they were held up for about a half-hour while they argued with the soldiers to let them through.

About 10 miles farther, they were stopped by three Israeli army Jeeps and told they were prohibited from traveling along the road. They say it took about 15 more minutes before an officer allowed them to pass. The next checkpoint was only a few hundred yards away, and the family was made to wait behind about 15 cars as each was checked slowly by soldiers.

"We argued with him, showed him that the woman was in pain," Saleh recalled. That took another 15 minutes.

Just a mile farther on was a fourth checkpoint, near the entrance to a Jewish settlement. The soldiers there told the Balout family the road was sealed. Saleh started to argue, to plead. And then Amina started to deliver the child. Her sister-in-law, Sadiqah, knew a little about childbirth; she has eight children. She took off her head scarf and wrapped the newborn. They had no water. The only light was from the van's small dome light.

"We were scared," Sadiqah recalled, describing how she swaddled the infant, still connected to her mother by the umbilical chord. "We wanted to touch her, but we didn't want to touch her at the same time. We were busy between cursing the soldiers and fighting with them on the one hand, and trying to offer any help to the mother."

The family members said they did not reach the Ramallah hospital until after 8:30 p.m.—and not before what they describe as a final humiliation at one last checkpoint. They said they were forced to exit the minivan so it could be searched, which meant carrying Amina, with the infant still attached by the umbilical chord.

"It was a very, very ugly thing," Saleh said.

**[JR: What is your day like after being stuck for an hour in traffic going to and from work? It's nothing compared to what Palestinians go through under their Israeli occupiers. #### BARAK WON'T SERVE IN NEW CABINET; WEST BANK VIOLENCE CONTINUES

JERUSALEM (AP)—Prime Minister-elect Ariel Sharon's quest for a broad coalition encountered new uncertainties Wednesday after defeated predecessor Ehud Barak unexpectedly said he would retire instead of fulfill an agreement to serve as defense minister.

Explaining his decision in a bitter letter to Sharon, Barak said the prime minister-elect had "seriously harmed the trust" between them with his recent actions, including suggestions that Barak would not be a partner in decision-making.

A growing rebellion in Barak's Labor Party may also have played a role. Immediately after his crushing election defeat Feb. 6, Barak had announced that he was resigning from politics. He reversed himself a few days later, accepting Sharon's offer to become defense minister.

That reversal prompted an outrage in Labor and in the Israeli public.

"A little late, the curtain falls," commentator Hemi Shalev wrote in the *Maariv* daily Wednesday. "By deciding to resign, Barak is saving a shred of his honor, which had been trampled on ... ever since he announced his intention to serve as defense minister."

Sharon has preferred to bring Labor into his government. But Labor is embroiled in a heated leadership struggle, and it was not clear who would now lead coalition talks with Sharon, if it all.

There was also disagreement over whether the party's secretary-general, Raanan Cohen, should be named temporary leader, or whether elder statesman Shimon Peres should take over until primaries are held.

Peres has been tapped by Sharon for the foreign minister's job. Labor's central committee was to convene Monday to decide whether to join Sharon. Political

commentators were divided, with some saying Barak's resignation paved the way for a broad coalition and others saying such a deal was now no longer possible....

Israel's military chief, Lt. Gen. Shaul Mofaz, told a closed session of the parliament's security committee that Palestinian leader Yasser Arafat has no interest in reducing violence. Mofaz also said Arafat's police and security forces are taking part in attacks against Israelis, according to an official present at the meeting.

Sharon has pledged not to resume negotiations with the Palestinians unless all violence stops.

Sharon cannot take office until he sets up a government representing a majority of the 120 members of parliament. During the campaign, he said he would strive for a broad-based national unity government, but he appeared to be running out of patience with Labor.

Jerusalem Mayor Ehud Olmert, a negotiator for Sharon's Likud party, said Labor had to decide within a week whether to join forces. Otherwise, Sharon would turn to Orthodox Jewish parties and a far-right bloc to form a narrow coalition, he said.

Then Sharon defied Barak by indicating that in any event, the far-right lawmakers would be in his Cabinet. Barak said Labor could not join such a team.

Barak sent a letter of resignation to the party secretary, but cannot leave the parliament until Sharon takes office.

Labor's negotiating team and its outgoing Cabinet ministers were to meet later Wednesday to discuss the next steps, including a possible resumption of negotiations with Likud.

Sharon hopes to set up a government quickly, because he must pass a state budget by the end of March, or another election would be called automatically.

**[JR: Barak managed to retain some dignity by refusing to serve as Sharin's Defense Minister after it was made clear that he (Barak) would only be taking orders from Sharon. Ouch! Ariel plays it tough every which way he can. #### ARABS RALLY BEHIND SADDAM HUSSEIN

MANAMA (BAHRAIN)—Opinion in the Arab world appears to be near unanimous that Friday's bomb attacks on Iraq by the U.S. and British military aircraft was totally without justification.

The raid has further strengthened the hold that Iraq's President, Mr. Saddam Hussein, has on the Arab street and it will be very difficult for Arab governments not to join the efforts for a lifting of the sanctions. When the UN Secretary-General, Mr. Kofi Annan, travels to Iraq at the end of this month to discuss this issue, his interlocutors will face him with great confidence in the support they have for their position.

Very few in the Arab world are prepared to buy the U.S. and British explanation that the air raids were carried out because Iraqi defences had so improved as to threaten the aircraft enforcing the "no fly" zones.

Iraq's claim that two people died and that 20 were injured has been accepted without reservation and there seem to be few in the region who doubt that the attacks were only intended as a means to punish Iraq for its defiance and has no other purpose.

There are hardly any takers for the U.S. position that Iraq still threatens its neighbours and that its "containment" is a dire necessity. Attacks on Iraq in which civilians are killed indiscriminately stand out in stark contrast to the U.S. protestations about the deaths of Israelis in clashes with the Palestinians.

Even the Government of Kuwait, which has always expressed its support for similar U.S. actions, has deemed it prudent to keep aloof this time around. They have said that it was and is the internal affair for Iraq or at most an affair between Iraq and the U.S. and that they had no further comment. The Saudis have not issued any statement either but Friday's attack, which came out of the blue as it were, will certainly move the Saudis further along on the course of distancing themselves from the sanctions regime.

Saudi diplomacy is always discreet and their moves are revealed only slowly so there might not be any quick decision to stop U.S. and British warplanes from using their bases. But there can be little doubt as to the direction in which the attacks have pushed Saudi Arabia.

If nothing else Arab leaders whom the U.S. Secretary of State, Gen. (ret'd.) Colin Powell, will meet during his tour at the end of this month are bound to be more insistent in asking the U.S. to elaborate on its intentions towards Iraq.

The messages coming from Washington have not been unmixed and the Arab governments cannot live in perpetual uncertainty about what the U.S. intends to do about Iraq and Mr. Hussein.

Almost all Arab governments, bar Kuwait and Saudi Arabia, have already moved to re-establish commercial if not diplomatic ties with Iraq and the raid will add momentum to these efforts. By the time Mr. Annan comes to discuss weapons inspections and the continuance of sanctions with the Iraqi regime at the end of the month, he is likely to face Iraqi officials who are confident that the sanctions regime is corroding by the day. **[JR: At last Friday's press conference, the Pentagon stated that Iraq was bombed because Iraqi troops were moving along the border (didn't specify which border) and that Iraq had made threats against Israel! The Pentagon also made reference to the Iraqi upgraded radar defense system monitoring the U.S. and British flyovers. Although Kuwait's aloof position is expected, given our control in it's affairs, the Saudis position is pivotal despite the fact that U.S. troops still remain in Saudi Arabia. The bombing attacks were to remind Hussein that the U.S. and Britain are distressed over his successes in gaining support against their imposed sanctions. To think... Hussein was once President Bush Sr.'s closest ally [and partner in criminal payoffs]. How's that for irony?]**

#### KUWAIT SEES ITS TIES TO ARAB ALLIES TESTED

KUWAIT (AP)—Five Kuwaiti lawmakers on a swing through the region recently found out exactly what other Arabs think of the emirate a decade after many rallied to its aid against Iraq.

They didn't like what they heard.

Iraq had alarmed Kuwait this year by stepping up its threatening talk, with Odai Hussein, the son of Iraqi President Saddam Hussein, saying Kuwait should be included in a new map of Iraq.

But what the lawmakers got from political and labor union leaders in Jordan, Syria and Tunisia were complaints that Kuwait's response to the Iraqi threats was "exaggerated" and that it was "starving the Iraqi people" by supporting sanctions, said Mohammed al-Saqer, Parliament's foreign affairs committee chief.

Kuwait has planned lavish celebrations of the Feb. 26 anniversary of its liberation from the seven-month Iraqi occupation 10 years ago, with Secretary of State Colin Powell feted as guest of honor.

But just as it gets ready to party, Kuwait is seeing its ties with Arab Gulf War allies tested by the lure of Iraqi oil wealth, the popularity of Saddam Hussein's anti-Israeli rhetoric, and public anguish at the effect of sanctions on ordinary Iraqis.

Airstrikes near Baghdad by U.S. and British warplanes are likely to complicate the Arab quandary over how to deal with Iraq.

In 1990, Egypt committed troops to the U.S.-led international coalition when Iraq invaded Kuwait. But on Saturday, Egyptian Foreign Minister Amr Moussa denounced the airstrikes and said it was time to review measures taken against Iraq.

Last month, his country and Syria, which also lent troops to fight Iraq during the Gulf War, signed free-trade agreements with Baghdad and played host to top-ranking Iraqi officials.

Iraq has allocated half its UN-supervised oil-for-food contracts to Arab producers. Egypt expects to export \$1 billion worth of goods to Iraq this year, and Syria is reportedly planning to reopen a pipeline carrying Iraqi oil to its Mediterranean port of Baniyas.

Egyptian President Hosni Mubarak said after a visit to Kuwait that he "sensed in Kuwait a worry that the trade agreement we signed with Iraq represents a change in Egypt's position." He said he renewed Cairo's commitment to Kuwait's security and sovereignty.

Bashar Assad, his Syrian counterpart, did the same in an interview with Kuwaiti daily *Al-Siyassah*. Neither Syria nor Egypt has restored full diplomatic relations with Iraq.

Like many ordinary Kuwaitis, Sawsan al-Sarhan sympathizes with the Iraqi people's suffering under sanctions and says she hopes the Egyptian and Syrian trade deals will bring them relief. "However, there have to be limits," the homemaker said. "Saddam should not feel that Arab countries are supporting him and they don't care about Kuwait."

Wafic al-Samaraai, a member of the Iraqi opposition, said on Kuwait TV that Mr. Hussein's overtures to Egypt and Syria were meant to break the international embargo imposed on Iraq and "isolate" Kuwait and its ally Saudi Arabia for refusing to have ties with the Iraqi leadership.

Kuwaiti officials say they are satisfied with Syrian and Egyptian promises to confine their dealings with Baghdad to trade. But Khaled al-Jarallah, an undersecretary in the foreign ministry, told the *Associated Press*: "Our only concern is that Iraq misunderstands the message as an encouragement to back away from its international commitments."

Mr. Hussein is a hero to many ordinary Arabs for his threats against Israel, and some Arab leaders try to walk a fine line placating both sides.

Kuwait has spent billions of dollars on

development projects in Arab nations since the 1960s. So Kuwaitis were shocked that countries such as Jordan, Sudan and Yemen sided with Iraq during the crisis, and it took years to mend the rift.

Kuwait's official stance is that Baghdad must implement UN Security Council resolutions requiring that it be certified free of weapons of mass destruction before sanctions can be lifted.

But a recent editorial in the Kuwaiti newspaper *Al-Rai Al-Amm* suggested recalibrating the sanctions so they spare the innocent and punish Iraq's leaders.

**[JR: Kuwait is in a very tenuous position as to choosing sides given its location in the Middle East, its origin and the control the U.S. and Britain have over them. For 400 years, Kuwait was part of Iraq. When Iraq was given its independence by the British in 1948, the British detached Kuwait and gave the Rumalia oil fields to British Petroleum. In 1961 the British gave Kuwait independence and set up the al Sabah family to run it. Kuwait is tightly wrapped in the U.S. and British straight jacket with no room to move, let alone make choices regarding its own destiny.]**

#### INS INVOLVED IN VOTER FRAUD

Mexican President Vicente Fox has said he wants it. Democrat lawmakers on Capitol Hill have said they want it. Even some labor unions have said they want it: amnesty for millions of illegal aliens who have been working in the United States for five years or more, in violation of virtually every immigration statute on the books.

So far, the White House has not said how President Bush will respond to the expected overture from Fox when Bush embarks on his first foreign trip today. A senior administration official, briefing reporters at the White House before the trip, said the president was "looking at a whole range of issues", including amnesty and expanding the guest-worker program.

But on Capitol Hill, Democrats led by Rep. Luis V. Gutierrez of Illinois have laid the legislative bed for a sweeping new amnesty by introducing a bill on Feb. 7 that would benefit illegals who "have shown a true commitment to this country and are likely to have made a considerable contribution to this country." Gutierrez chairs the Congressional Hispanic Caucus Task Force on Immigration.

Anti-immigration groups claim that as many as seven million illegals are currently "hiding out" in the United States and could potentially benefit from the amnesty.

"Amnesty means open borders," said Joan L. Hueter, chairman of the American Council for Immigration Reform. "Open borders spell disaster."

A flood of new green cards and naturalizations would overwhelm an Immigration and Naturalization Service that is already stretched thin, racked by bureaucratic mismanagement—and that stands accused in a damning new report by its own inspector general of minting new citizens on the direct orders of the Clinton-Gore White House in reckless disregard of the law.

The 684-page INS inspector general report was released with little fanfare during a congressional hearing in September. Its most stunning allegation—that the Clinton-Gore White House had hijacked the INS for partisan political purposes in what amounted to massive voter fraud—never emerged as a campaign issue until after election day, when it became evident

that Al Gore owed his near-victory in Florida to hundreds of thousands of newly-minted citizens in Miami-Dade and Palm Beach counties.

According to the IG report, many of those new voters should never have been granted citizenship.

Some were convicted felons. Others had overstayed tourist visas and were working illegally. Close to 200,000 never underwent any background check, so INS does not know to this day whether they were eligible for citizenship. Few passed an English language and citizenship test worthy of the name. Some could not understand their own swearing-in, because the ceremony was conducted in English.

And yet, Bush White House officials point to campaign pledges by President Bush to treat immigration “not [as] a problem to be solved, but [as] the sign of a successful nation,” and to speed the naturalization process even further. To accomplish that goal, aides say, Bush plans to split the INS into two separate agencies, one that processes green cards and citizenship applications and a second that polices America’s borders.

But before he gets that far, Bush will have to deal with the thorny issue of fraud, and the political hijacking of the INS.

The investigation into INS shenanigans began with a May 1996 report in the *Washington Times* about an INS whistleblower who criticized the acceleration of the naturalization process under Clinton-Gore. It quoted other INS employees who revealed the existence of a program known as Citizenship USA, and questioned the motives behind it.

Citizenship USA was an initiative of Vice President Al Gore that was ostensibly part of his National Performance Review to “reinvent” government. Internal White House memos, obtained by the House Judiciary Committee in 1997, showed that the vice president was well aware that the effort could be perceived as a “pro-Democrat voter mill.”

On March 28, 1996, White House aide Doug Farbrother e-mailed Gore detailing his efforts to get INS to waive fingerprinting and background checks “to make me confident they could produce a million new citizens before Election Day.”

Gore then wrote Clinton: “You asked us to expedite the naturalization of nearly a million legal aliens who have applied to become citizens.” The risk, Gore warned, was that “we might be publicly criticized for running a pro-Democrat voter mill and even risk having Congress stop us.”

Congress did complain—but only after the election.

In response to those complaints, the Joint Management Division of the Department of Justice hired KPMG Peat Marwick to review the Citizenship USA program, which ran from Aug. 31, 1995 through Sept. 30, 1996. They found that of the 1,049,867 aliens naturalized under the program, INS never did fingerprint checks on 180,000 persons.

“Applicants who were ineligible because of criminal records, or because they fraudulently obtained green cards, were granted citizenship because the INS was moving too fast to check their records,” says Rep. Lamar Smith, R-Texas, who chaired the House Judiciary subcommittee hearing on the IG report last September.

In addition to those 180,000, Smith said, “more than 80,000 aliens had fingerprint checks that generated criminal records, but they were naturalized anyway.”...

By 1999, the numbers shot up once again, with 872,485 aliens granted citizenship, according to INS statistics made available to the Western Journalism

Center. And during its final year in office, the Clinton-Gore administration used streamlined naturalization procedures to mine yet another 898,315 new citizens, just in time for voter registration deadlines last October.

INS officials said in interviews that they received 1.3 million applications during the fiscal year that ended Sept. 30. Some 400,000 of those applying for citizenship were rejected.

By contrast, fewer than 250,000 aliens were naturalized during FY 1992, the final year of the first Bush administration. “Naturalizations were averaging between 200,000 to 300,000 per year before then,” said INS spokesperson Elaine Komis.

In other words, despite hearings in 1997 that roundly condemned the administration’s naturalization program, and promises from the INS to reform its own procedures, it was back to the Democratic voter mill—just in time for the 2000 election.

According to the newly released inspector general’s report, the latest rush of naturalizations took place without any significant changes to the flawed procedures that led to the abuses found during the Citizenship USA program in 1995-1996. Hundreds of thousands more persons were granted U.S. citizenship without any background checks just prior to November 2000.

In presenting his report before Lamar Smith’s subcommittee on Sept. 7, Deputy Inspector General Robert L. Ashbaugh noted that repeated requests for interviews to the vice president’s office had been denied. Similarly, top presidential advisers Harold Ickes and Rahm Emanuel—identified as having played key roles in hijacking the INS for political purposes—refused to answer questions....

**[JR: The new Bush administration may appear to present a more dignified and refined style of governing but the goal, like with the Clintonistas, is to hand us over to the world controllers. #### FUEL CELLS TURN SEWAGE INTO ELECTRICITY

PORTLAND, OREGON—As the lights dim in parts of the nation because of an energy shortage, the model for supplying clean and abundant electricity in the 21<sup>st</sup> Century can be found at a Portland sewage plant. Methane collected from decomposing waste provides hydrogen to power a commercial fuel cell that transforms the volatile gas into enough electricity to light more than 100 homes for a year.

FUEL CELLS were invented in the 19<sup>th</sup> Century. But most Americans had never heard of them until a faulty one blew a hole in *Apollo 13* in 1970, scuttling what would have been the third Moon landing and nearly costing three astronauts their lives.

Fuel cells remain an essential part of the space program, reliably powering the Space Shuttle.

Utilities, investors and government planners are

now starting to pay close attention to some down-to-Earth uses for a technology that converts the most abundant element in the universe—hydrogen—into electricity and water.

“It’s no longer science fiction,” said Steve Millett, one of the leading researchers in the field. “It’s real.”

Millett works at Battelle, the institute founded by a steel industry family in Columbus, Ohio, which now develops all kinds of technology for industry and the government, including NASA.

Millett says fuel cell technology was transformed during the last decade from a cottage industry into one of the most rapidly expanding high-tech businesses in the world, partly due to the automotive industry’s suddenly keen interest.

“More and more auto companies have awakened to the fact that their sales are dependent on fuel prices,” Millett said, “so the auto companies are investing more in fuel cells and pushing harder than any other industry.”

As 2001 began, it was reported that Exxon Mobil Corp. planned to join Toyota and General Motors in an alliance to develop environmentally friendly fuel cell vehicles. Ford and Daimler-Chrysler also have fuel cell projects in the works.

Yet as recently as 1996, there was only one major manufacturer of commercial-size fuel cells in the country—ONSI Corp. in Windsor, Conn., a subsidiary of International Fuel Cells.

ONSI built units the size of a minivan to provide electricity to facilities that were too remote from the main power grid or needed reliable backup power, such as hospitals and resorts. Now dozens of manufacturers and many large companies are considering fuel cell development in an industry that has one of the fastest-growing trade associations in the country—the U.S. Fuel Cell Council in Washington, D.C.

“There are a lot of big names in the business now,” said Bob Rose, the council’s executive director. “General Electric is in, along with 3M, DuPont, United Technologies.”

In the 1960s and 1970s, utilities were interested in building big fuel cell plants capable of producing one to three megawatts as part of a central power supply. But the long-range goals have shifted to a smaller scale: putting a washing machine-sized fuel cell in every home, or smaller units in every car and truck. And that’s attracted a broader range of companies and investors, Rose said.

Motorola, for example, is working with the Los Alamos National Laboratory in New Mexico to miniaturize fuel cells for handheld electronic devices like cell phones.

Mark Williams, fuel cell product manager at the National Energy Technology Laboratory in Morgantown, W.Va., said the U.S. Department of Energy has been funding fuel cell research across the country for years. But now initial public offerings of stock in various technology development companies are spurring investment interest, along with research funding by established companies.

“The alliance of auto manufacturers, fuel cell developers, utilities, universities—there’s a whole new initiative that’s bringing it together,” Williams said.

At the Portland sewage treatment plant on the peninsula formed by the confluence of the Willamette and Columbia rivers, the city is generating electricity from only the third commercial fuel cell of its kind in the nation to use waste “biogas”.

The fuel cell began operating in July 1999. It’s such a success that the Environmental Protection Agency gave

the city a “clean air excellence” award for converting waste gas from sewage into 200 kilowatts of electricity.

David Tooze, energy program manager for Portland, said the city needed to pull together several grants to cover the \$1.3 million cost of the fuel cell. But it has proved to be more than worth the investment by producing electricity at 8 cents per kilowatt hour, at a time when the deregulated spot market easily pushes the price to 20 cents per kilowatt hour.

Fuel cells are an extremely clean source of power because they combine hydrogen and oxygen—the two elements that make up water, the main byproduct.

“A lot of long-term energy planners recognize fuel cells could be one of the major links that bridge us from a society that operates on fossil fuels and their pollution liability, to an energy economy that operates on hydrogen, which is essentially clean burning,” Tooze said.

Much of the fuel cell pioneering work is taking place in the Pacific Northwest. A public power consortium of 13 utilities called Energy Northwest is taking part in a Bonneville Power Administration test of fuel cells made by a company founded in the central Oregon town of Bend.

Bonneville officials see fuel cell technology as a way to redistribute the power grid on a more local level. The Portland-based federal power-marketing agency already oversees one of the cleanest energy sources in the nation, the string of 29 hydroelectric dams along the Columbia and Snake rivers.

But salmon conservation and increasing power demand have forced the BPA to search for alternate sources of electricity. Fuel cells could be a way to take the load off the central power grid and create a system of residential generators that could power homes and even provide a surplus to the grid.

But fuel cells are still too expensive.

For example, a Boise-based company called Idacorp has joined the BPA to test for home use fuel cells that are in the \$25,000 range. The company hopes the cost per unit eventually will drop to the \$5,000 to \$7,000 range.

Still, fuel cell development is becoming part of a nationwide shift away from reliance on any single power source.

“It’s going to take time, and it’s not effortless, but the move toward the so-called hydrogen economy has started,” said Millett, the Battelle researcher. “We’ve taken the baby steps.”

**[JR: You must remember that there are numerous fuel-saving and energy-producing devices that have been suppressed for many decades. It takes a fabricated energy crisis and excessive increases in prices to bring some of them out of the vaults and into commercial markets to create enough volume demand to make it economically feasible to produce. The minute a major demand for a product becomes evident, all the affected companies will invest in its research and development in order to get their piece of that lucrative market as well as a means to protect their other products from rapidly decreasing its share of the market. Of course with the potential of a residential fuel cell, the oil and gas companies, electric generating companies and the auto industry will be investing heavily for self-preservation. If the fuel cell is allowed to fully develop commercially, it is obvious that certain related industries and the same Elite families will still determine what is most profitable for them, not what is best for the consumer.]**

I am sorry to call you forth at such an early hour again, Dharma, for the fatigue is taking its toll, but other ones shall simply have to tend of the Earthly matters, for I cannot sacrifice the day of writing in order to have guests—please, lean upon me and I will give you strength and energy to do that which we need do. TODAY’S WATCH

Allow us to bypass “Today’s Watch”, for we must do a segment for the *Journal*. I do, however, ask that you be cautious as the surveillance has been increased as have the bombardments of ELFs to your place. There was a deliberate focus of sonic blasts against this place yesterday and apparently more are in the staging; keep the protection and security tight, as so many come and go through the dwelling.

**Naught has changed as ones come and go in curiosity and non-decision. Remember, ours is not a mission of entertainment nor social picnics—it is the time of decisions within the group, most especially, and ones functioning for their own selfish reasons, within, are erring greatly—for this is NOT the place to find fulfillment of self-indulgence in Earth physical fun and games. Those who use another in controlling power for self will find the welcome mat turned upside downward for ours is a place of production and one cannot put him/her-self above another nor take the precious time remaining in drifting in directionless wandering. It is a time of definite choices and maturity—if ones just wish to play games of “Catch the Gold Ring”, it must be done elsewhere. So be it.**

DOMES AND TERRAIN

I will take this opportunity to discuss structures intended for the most efficient utilization of space and

functionability, since we will have guests which are working in perfection of the domed structures. The subject is especially applicable to the point of Pleiades, so the segment will not be lost to the *Journal*.

First I shall be reminding you of expected events of “Natural” nature which shall be making themselves increasingly difficult with which to deal over the time of transition. Man-triggered or Nature-triggered makes no difference if the winds are blowing at a steady 150 miles an hour, dear ones. Dwellings cannot stand long against such assault. As man continues to tamper with the atmosphere and devastation of the lands all manners of changes shall come upon the orb—but allow us to speak of the the “why” of domed architecture and underground structures.

Adequate layers of earth or cement are barriers against many of the elements which may come upon you—i.e., radiation, extreme temperatures, winds and, if made properly—water. If introduced, fragments of metallic powder or particles in the shield shall guard against microwaves and several types of particle beams. Further, the shape of the building itself will deflect, instead of allowing piercing by, projectiles.

Your goal must be to build downward within the earth where feasible but remember, if you utilize care, an above-ground shelter can serve many varied needs.

In time you must be prepared for the “possible”, for you will not be given the extent of such possible hazards to life of physical beings. Therefore, you will wish to utilize the optimum advantages of architecture as pertains to asthetic desirability as well as durable and protective styles.

Architectural shape, lighting and heating forms are most critical. Also, the mode of living must be considered most carefully, for no matter if a man survives if he is rendered mad or infirm by his environment.

MATERIALS

Please, you who are self-styled builders and engineers; do not come forth saying a thing can or cannot be done—**REMEMBER, IF IT CAN BE CONCEIVED, IT CAN BE ACHIEVED.** Do not, for instance, tell me that compressed earth is not possible for use as shelter roof. It not only is possible for such use but fitted properly will stand against ALL elements—be they ones that shake, rattle or roll. I suggest you look at the architecture of the great cathedrals, for the principle of arches and domes never fails if structured properly with balance and proper infrastructure.

If the world as you know it never changes, you have nothing to concern about—but, if it does, you face having no metals with which to fabricate domes and no way to refine or roll the finished product if you do. You must move to that which you can produce for self—and anything short of that need is but frosting for your cakes.

Let me paint a vision for you as regards that which

is practiced in the more progressive planets of your homeland [Pleiades]. We are speaking of a solar system wherein, as with your system, each planet varies—with one exception. There is availability of inter-planetary interchange for the most part and the backward planets do not inter-mingle much with the more advanced brotherhood of the solar system of Pleiades, for instance. I would interject herein that on some of the habitable planets of Pleiades, the societies are in growing above that which is bringing Earth to her knees. But in many societies the humans were evacuated to safety off their own planets and placed in security in other compatible facilities in which to continue physical experience. These planets remain as isolated and land-locked as does Earth. **TO PLAY AMONG THE STARS IN THE UNIVERSAL COSMOS REQUIRES INTEGRITY, GODLINESS AND AN ADHERENCE UNTO THE LAWS OF GOD AND CREATION.**

I prefer that you ones turn from the attitude of “simple survival” and move in the direction of change because it is a “better way” in which to live. If you move into the “better way”, it matters not that which comes to pass.

Let us consider “typical” Pleiades living for the “ordinary” inhabitants in a suburban setting or “rural” environment—for, within the cities, the principals of architecture are the same but, of course, the needs are different and, therefore, the setting differs.

A typical family will have a considerably large dwelling of any size desired—mostly underground. The typical tunneling is in the shape of a spoked wheel which can be enlarged, closed off or done in any desirable manner pleasing to the family and according to means available. Homeless brothers are not acceptable! Facilities are provided wherein the homeless are housed for participation in upkeep.

We do not speak of an unchanging planet which is ongoing in pastoral sublimity—we speak of a changing planet whereupon humans dwell and the lands and people are in constant change as the planet changes. Earthquakes, etc. are as prevalent, or more so, than on Earth orb.

The “main” living quarters of food preparation center, family gathering quarters, entertainment room (living rooms), pools and atriums are in the central “hub”. Sleeping rooms and baths are located off the hub in the tunneled “spokes”. The areas between the spokes are partially excavated and “finished” into underground gardens. Enough natural formation is always left untouched for a support system of the caving roof.

Near the windows of the housing are located asthetic gardens and beds of plants and shrubs. Growing dens for foodstuff are then in mid-segments between spokes. The garden for the most-used kitchen “vegetables” is grown adjacent to the kitchen area. The energy of our suns is harnessed and underground lighting is plentiful anywhere we wish it. The lighting is on automatic cyclic “timers” for balanced optimal growth and rest.

Since clutter is not conducive to mental order, there is abundant storage facility in all dwellings whereby the living areas are kept totally uncluttered.

From the main “hub” are exits to the surface, as are there exits from every living area to the surface—however, most exit/entrance openings are asthetically and protectively constructed. There is a “garden” room above the hub which can be opened or closed as desired but is more in appearance of a garden

setting arranged with natural or formally arranged plant life and/or pools, etc. The pools are available for asthetic reasons, bathing, exercising and in addition, water supply if needed. The sun-room is enclosed in a transparent glass with high metal content for protection and shielding—however, the area can be completely closed off by a sliding shield should radiation protection be necessary. Remember this is not Camelot, Milk-and-Honey Land or the City with the Golden Streets and Pearly Gates—this is a planet much as your own!

Off of each “spoke” room is much storage, a hearth center and a large “bathroom”. We recycle water and, therefore, have abundance which is carefully monitored and unwasted in any manner what-so-ever. All waste materials are treated and returned to natural state and byproducts utilized—both human and animal.

The allotted amount of land for individual use varies but a typical plot is sufficient to have a luxurious underground dwelling, home park above ground and pasture for animal grazing and domestic stock. There are, however, underground facilities for protection of the stock in inclement weather of any type dangerous to their well-being.

The source of energy is from solar resources; however, “slash” and trimmings of plants and shrubs, orchards and such, are utilized in the “fireplaces” which are the central focus of the dwelling.

Think now, you are living underground—or, above ground in earthen structures which minimizes changes in temperatures and, therefore, a fireplace is more for the needs of soul than for necessary heat.

The materials “re-arranged” from underground excavation are utilized in the structure walling, foundation shoring and above-ground retaining walls, fences, planters and such. We compress the material (earth) just as we suggest you do.

Most doors are NOT, but rather, screening is utilized by sliding covers or “maze-type” entrances. This gives ability to generalize heating/cooling and reduces need for “hardware” (knobs, hinges, etc.). We have far more energy for use in powering such closures than we have metals which are utilized carelessly for such nonsense.

The cities, of course, are structured greatly underground also but that which protrudes is treated with great care with gardens and natural grounds. A lot of “metal glass” is utilized; I suppose you would call it crystal, but it is as durable and unbreakable as is metal—hence the perception of “crystal cities”. The architecture is pyramidal or domed. There is living availability beneath the cities at varying underground levels to house comfortably everyone in the city for safety in natural disasters or accidents. We have a different solar system than do you of Earth and, therefore, protection must be available against sun flares, etc. The elements can be most extreme, for evolution of the planets have, of course, been cyclical such as yours and the inhabitants of these planets have learned just as you must.

As more and more history of your planet is brought to the surface for your attention, you will find that you, too, had such cities in many, many locations. Remember that what you call North America, for instance, is a “new” portion for the most part. As the old continents again rise and old portions of Lemuria and Atlantis are unearthed—you will find designs much as I have described above.

Dharma, find *Sipapu Odyssey* and write the portion regarding winds and specifically the shifting expected in North America and reprint it herein, please.

## FUTURE REVELATIONS

As described in *Sipapu Odyssey*:

“... and it is said there shall be winds, and there shall surely be, in the time when it is winter; and the trees shall bow down their boughs, and the winds shall sting with the cold; and there shall be great suffering among the people and they shall fall down and cry for mercy.

“And there shall be a mighty earthquake and it shall split in twain the country of North America, and it shall be as nothing the world has known before, for it shall be that there shall be a great part of the great land of the the north continent go down and a great sea shall form within her center part from the Dominion of Canada into the Gulf of Mexico.

For there is not a place which is that shall remain the same in its present state.

“And not a person shall be left which is not prepared for that which shall be. And there are many called but few are chosen: for there are none which have been chosen which have not been carefully prepared; and they have been unto themselves true, and they have given credit where credit is due. And now it is given unto them to be the seed of the new Civilization which shall come upon the Earth.

“And within the time which is left before this shall come upon the Earth, it shall be that many will be called: and they shall doubt; and they shall fear; and they shall faint; and they shall fall by the way; and they shall be in no wise, wise, for it is given unto man to fear that which he does not understand—and for that does he wait.

### LOOK AT THE POTENTIALS

You must be prepared for the changes, for the probabilities remain that man will NOT change of his path and, therefore, these things shall come to pass in your time upon the orb. For instance, until you have ability to bring forth “free energy”, you need the underground facilities to conserve heat and allow cooling according to the extremes as well as sheltering from atmospheric pollution and such. You will need the underground oxygen supply from the underground greenhouses. You must structure an ecologically complete system and the planning must be begun whereby all things are in consideration. The spiritual man cannot live by bread alone but the physical man cannot live by spirit alone. Preparations in the planning must be made in the present against the possibilities and probabilities in expectation—at the best, you will not need of the facilities but will have a BETTER mode of life—at the worst, you have protection against that which might come against you, as in the ark atop the waters of the Great Flood.

### SHARING OF THOUGHTS

I would like to share some thought-provoking ideas which relate to man and his placement which might help define the attitudes and ultimately the plight of human on Earth.

You must stop dishonoring the Earth—for to dishonor the Earth is actually dishonoring the very spirit of man. Man acts out as if he is a creator, which he has ceased to be for the replenishing of creation, and not that of a “user” which he has become. This delusion is robbing him, not only of his natural heritage, but of his future as well.

You abuse land because you regard it as a commodity belonging to you. When you see land as a community to which you simply belong, you may consider using it again with love and respect. The Earth you abuse and the living things that you kill will, in the ending, take their revenge, dear ones; for in exploiting their presence you are diminishing that

which is conceived as “future”. The nation that destroys its very soil, destroys itself.

Everything is perfect coming forth from the Creator; everything seems to degenerate in the hands of man—we must come into awakening of the sleeping destroyers, for it is a serious sequence, indeed. The long fight to save wild beauty represents democracy at its very best. It requires citizens to practice the hardest of virtues—self-restraint and self-discipline.

There is nothing “good” or “bad”; it is only in the thought perception which makes it so. Salu.

It is very easy to consider thine own opinions as the direction to be followed and herein I suggest that a good is never productive of evil but when it is carried to culpable excess—IN WHICH CASE IT COMPLETELY CEASES TO BE A GOOD. ### CHAPTER 5

Good morning in the Light of God. Hatonn present to discuss that which happened here on Saturday last. I request that you utilize this writing as an *Express*, in combination with that which Commander Korton has given through a different receiver. I further request that Thomas sit to receive from Sananda “Jesus” that there be no misunderstanding as regards material issuing forth on the incident. What occurred on Saturday was as nearly a disastrous incident as we have had to date in the political ploys of your world. Because there were some thirty persons (adults) present as witnesses, perhaps there shall be some level of understanding of truth. Further, there shall be leaked information coming from Edwards Air Force Base and your leaders shall attempt more incitement to war.

**THIS WAR, DEAR FRIENDS, IS ATTEMPTED WITH SPACE COMMAND—A MOST FOOLISH MANEUVER, INDEED.**

#### INCIDENT IN POINT

Without giving forth tactical security, I shall give a brief description of the incident under discussion.

Please note that this is NOT the first attempt to damage the communications system of the crystal vortex—this IS the first attempt by foreign intervention.

You ones wish to believe that your “Cold War” with Russia is over—no, you have heated it up to boiling but it is taking a nasty turn of events in which none of you Earth-based (imprisoned) chelas can win. There seems to be great misunderstanding among your military “professionals” regarding Space Command capabilities and permission to take action.

Commander Korton gave a brief overview of the incident which I ask be combined with this document and with that which Thomas shall briefly receive from Sananda and to be presented as an *Express* as soon as possible.

At approximately 11:50 A.M., P.D.T, on Saturday, November 24, 1990, in your mode of counting, as some thirty or more persons were gathered at the home of this scribe, a “Cosmosphere” beam-type weapon was discharged with intent to demolish the property and kill all occupants and, in addition, to destroy the capabilities of the crystal communications/navigation vortex. It is not as simple as simply removing communications linkage with Space Command—the crystal is also utilized by all space-capable craft for navigation, orbit tracking, etc. The instrumentation is remote to ensure security.



The entire scenario was an attempt to establish blame on one another. There is an all-out attempt to establish reasonability of attack on Russia—as we have spoken of at great length—set for early December.

There are at all times a minimum of four Cosmospheres in the area of Edwards Air Force Base in permanent station. There are others also, but we will speak of only these four. There are also a number of Command (ours) craft in the area to protect and monitor this group within which this scribe resides and protect the crystal and the property. Our needs, to now, have been to protect the communications/navigation vortex from ground damage due to quakes, etc. This leaves the surface quite vulnerable to attack—it will no longer be vulnerable, for we will enclose it within a full-circle shield. This will cause great loss of ability of your own forces to utilize the wondrous facility, for we are herein scrambling the signals and will continue to change them at irregular intervals. I suggest you all realize—for your own Elite will not tell you—that your military and that of Russia have basically declared war on Space Command. Therefore, there shall be incidents at frequent intervals in attempt to cause Earth Man to believe that you are under attack from Space Aliens. YOU ARE NOT!

The intent of the incident was to cause us to take aggressive action with shields removed in order to be visible to the public, and allow one of your planes (of stealth nature with a dead crew aboard) utilizing young men who have been slain accidentally in Saudi Arabia, to fire upon us without note, and cause us to disable the craft and crash it—thus blaming Space Command for the incident and the death of the crew. It would be obvious for all ones to see from the ground—having had attention called to the area by the blast against the scribe's location and crystal. There is great insanity among your Elite groups in effort to gain control of your world at all costs feasible.

The full intent was to get all sides blaming one another. The surveillance Cosmospheres stationed over Nellis Field in Las Vegas, however, informed this sector and plans were outlaid by the “mole” system infiltrated within your military circles.

The Phantom (shielded) craft, which would be “unmanned”, would carry a crew of *already dead* personnel. The attack would be against the crystal and the dwelling—thus causing the Space Command to believe it was an attack by Cosmospheres, thereby hoping to bring confrontation between Command and Soviet Command.

The Soviets, being far advanced of you in the U.S.A. in air and space technology, noted the plans and waited. The assault would be thus: There would be simultaneous pulse beam blasts at the dwelling and the communications center from the Phantom craft which should trigger Cosmospheres' pulses at our Command ship, which is only a surveillance craft. The attack was to cause the Spacecraft to become visible and then to stop the intended strike by the crash of the U.S. craft *on the property itself*, to finish the scenario to perfection. The picture would be a shot-down stealth plane with crew lost, and done *visibly* by Space Command—(aliens).

Do you ones actually think that we are so dense? Our Command “reasoned” with these ones for days while this incident was in the planning stage—for there were also several diversionary incidents on the planning board had this one been pulled off intact. This location is well known by military and administration leaders. Attempt after attempt has been made against this scribe's life and we of the Command consider it an aggressive act

of war. **I suggest all of you remember that we come in service of God Creator—and you are primitive in comparison to our technology.**

We waited until the plane took off from Nellis—I was having a gathering. The Russians had agreed with us to not move forward with the incident, but to simply divert the direction of the U.S. craft and allow it to crash in the Mojave Desert away from population. The intent was to bring it down by your forces at any rate either by crashing or explosives. As agreed to, the craft would simply overfly the area, the pulse weapon beam neutralized, and that would be the end of it—“another crash of a training plane”.

This is not, however, what happened. Simultaneously, two Cosmospheres opened fire on our shield system, hopefully causing us to withdraw the shield and defend the ground target. So, simultaneously, the blast aimed at the dwelling and the crystal vortex and at us by two 'spheres were enacted. We simply diverted the beam pulse to the ground target but timing was not perfected and the beam had to be diverted to the hillside covering the crystal. We had no need to visualize [become visible] for either maneuver. The third Cosmosphere was to destroy the U.S. craft—with Space craft visible to appear that we shot down your plane.

We diverted the blast but it damaged the communications system by scrambling much of the communication frequencies. The crystal itself is undamaged and shall be reprogrammed within this day. As the frequencies went wild it has damaged Dharma physically, and we shall need give her healing time over the next few days, please. She is already extremely fatigued and that kind of a tonal assault to her brain is, indeed, disabling. You of the group will please be patient and bear with her while we decrease gatherings and ask that some of the readings for editing be elsewhere. My frequency is undamaged but she has been terrorized—not for self, but for the possibility of thirty deaths on her property—Oberli [E.J.] has not yet realized the magnitude of the attack.

These attempts at pulling in Space Command into your stupid and heinous warfare will continue to ever-increasing extent. I plead with you ones to pay attention and evaluate carefully that which shall be more regularly coming into your attention. This onslaught is the basis for many of the “world leadership” meetings—“What to do about Space Command?!”

What did we do? Ah, funny thing about that—we simply locked onto the U.S. craft with a tracking magnetic tractor beam and returned the confounded thing, dead bodies and all, to Edwards Air Force Base, as well as the Cosmospheres, and we had a dandy understanding right there. I assure you dear ones, whose lives are in jeopardy, that there WAS AN UNDERSTANDING. This does not, however, mean that ones out to “get you” will cease and desist—it DOES mean that we shall now increase surveillance shielding and go on absolute alert over every ground contact on your planet. We shall stick with you of our brothers like super-glue on the duck's back.

**SPACE COMMAND IS MOST SURELY ALLOWED AND EXPECTED TO DEFEND SELF, CRAFT, CREW AND GROUND CREW! I SUGGEST ALL MILITARY AND ADMINISTRATION OF COUNTRIES THROUGHOUT YOUR GLOBE—CLEARLY UNDERSTAND THIS STATEMENT! # THE NEVADA CORPORATION MANUAL

## (PART 1)

### “What Makes Nevada Special?”

(Presented by Budget Corporate Renewals, Inc.—see ads on pages 20, 21 and 22)

Nevada statutes have developed a corporate structure that is unique throughout the world. Nevada began with corporate statutes very similar to those of other states and then went further, establishing a corporate structure that allows investors and owners of Nevada corporations to maintain the highest measures of anonymity and liability protection available anywhere in the country. As these changes in Nevada's statutes have come into effect over the years, the number of new incorporations in Nevada has exploded. While ads heralding "TAX-FREE NEVADA" suggest **tax reduction** as the principle motivation for incorporating in Nevada, the issues of **privacy** and **liability protection** are probably of even greater importance to most who come to know and abide by the laws of this State.

#### **PRIVACY**

PRIVACY just might be the principal reason that the relatively small State of Nevada now ranks second in the entire country for the formation of new corporations. It looks like more and more business-smart people are discovering the tremendous advantages Nevada's statutes afford them, not least of which are those affecting privacy of stock ownership.

#### **Nevada statutes:**

1. Do not require disclosure of the stockholders;
2. Do not disallow the use of "bearer" shares;
3. Do not require the issuance of stock;
4. Do not require the holding of annual meetings of the stockholders in cases where none exist;
5. Do impose strict sanctions against non-stockholders who attempt to inspect corporate documents, or who would attempt to use them for any nefarious purpose:

#### **NRS 78.257 Right of stockholders to inspect and audit financial records; exceptions.**

1. Any person who has been a stockholder of record of any corporation and owns not less than 15 percent of all of the issued and outstanding shares of the stock of such corporation or has been authorized in writing by the holders of at least 15 percent of all its issued and outstanding shares, upon at least 5 days' written demand, is entitled to inspect in person or by agent or attorney, during normal business hours, the books of account and all financial records of the corporation, to make extracts therefrom, and to conduct an audit of such records. Holders of voting trust certificates representing 15 percent of the issued and outstanding shares of the corporation shall be regarded as stockholders for the purpose of this

subsection. The right of stockholders to inspect the corporate records may not be limited in the articles or bylaws of any corporation.

2. All costs for making extracts of records or conducting an audit must be borne by the person exercising rights under subsection 1.

3. The rights authorized by subsection 1 may be denied to any stockholder upon his refusal to furnish the corporation an affidavit that such inspection, extracts or audit is not desired for any purpose not related to his interest in the corporation as a stockholder. **Any stockholder or other person, exercising rights under subsection 1, who uses or attempts to use information, documents, records or other data obtained from the corporation, for any purpose not related to the stockholder's interest in the corporation as a stockholder, is guilty of a gross misdemeanor. ...**

A gross misdemeanor conviction could result in punishment by incarceration for up to one year in the county jail AND a \$2,000 fine. And please note that this statute spells out rights of the *stockholders* to inspect corporate records—the *stockholders*, not "just anyone". **There is no mandate of any kind for non-stockholders to ever inspect any corporate records. It is a gross misdemeanor for any non-stockholder to even attempt to use information from the corporate records in any way contrary to the interests of the stockholders.**

While *NRS 78.105* (see Appendix for full text) requires the corporation to keep certain records at its registered office, the stated purpose is that such records are to be available for inspection by *stockholders*. What if there are no stockholders? Should those records be there, where some unsuspecting snoop is left to run the risk of attempting to use them for a nefarious purpose, in violation of *NRS 78.257*? What should a well-intentioned director of a corporation that has not issued stock do?

Perhaps now you can see why it can be very difficult to prove anything about the ownership or control of a Nevada corporation that has not issued stock or has issued it only in "bearer" form. Moreover, the State of Nevada does not require a corporation to list with it the corporation's "secondary" officers—vice-president(s), assistant secretary (or secretaries) or assistant treasurer(s)—as may be provided for in the corporation's Bylaws. The typical powers afforded to a corporation's vice president are all those that would normally pertain to the president—whenever the president is not available to perform those

duties. What if the listed president is NEVER available to perform those duties? In such a case the vice president, whose identity is not recorded on the annual list of officers required to be filed with the Secretary of State, could have complete control of the day-to-day operations of the corporation.

#### Nominee Service—Officers and Directors “In Name Only”

The use of what is commonly called “nominee service” has been an accepted practice in the State of Nevada for something like 75 years. Typically, this service—offered by most of the largest and most well-established resident agents in the state—provides the name and signature of a nominee on the annual list of officers filed with the Secretary of State, **the only—NRS-mandated—public record of the corporation.** The use of nominee service is inherent in many of the strategies presented elsewhere in this manual.

#### Nominee Stockholders

The use of **nominee stockholders** is far less common (to our knowledge) but the flexibility of this device enables strategies that would otherwise be considered “impossible”. Many regulations aimed at determining a corporation’s status are determined on the basis of ownership. In Nevada, it is relatively easy for the real owner(s) of a corporation to enjoy privacy of ownership: For any matter of record, the corporation’s stock may be held by any number of “outside” entities—persons or corporations.

Let’s say you have a half-dozen or more good and trustworthy friends, some or all of whom might desire a reciprocal “favor”. Do you suppose they would mind holding stock in your corporation, covered by a side agreement whereby you could vote the stock at any meetings and repurchase the stock on demand for a nominal price? The reason this works in Nevada is that stockholders are not a matter of public record, as explained previously.

#### Bearer Shares

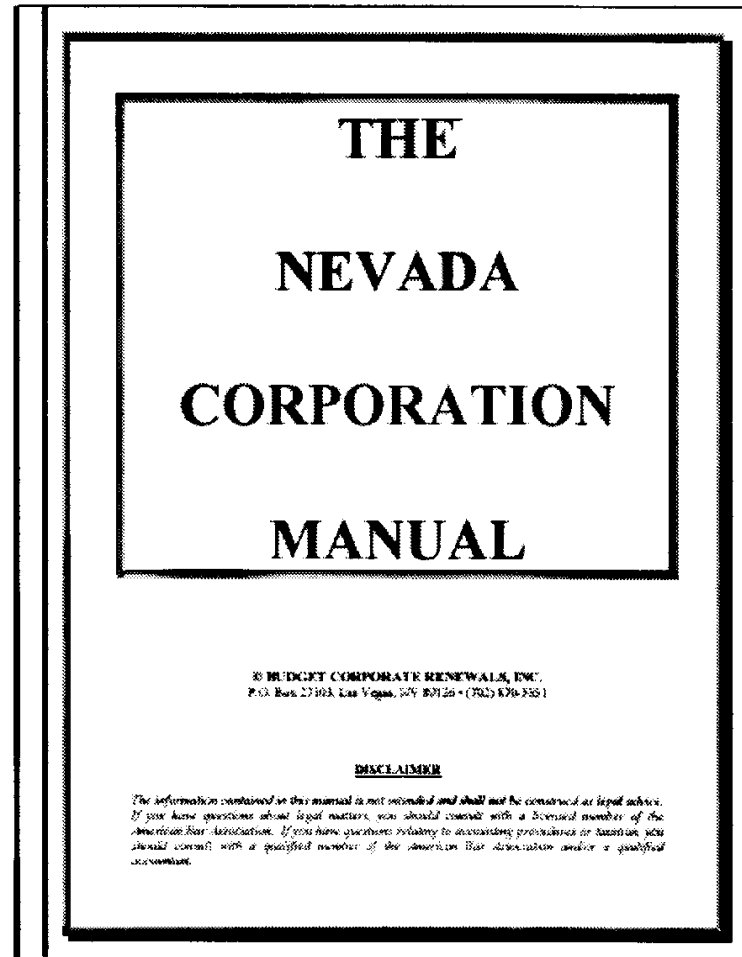
Since Nevada’s statutes do not preclude the use of “bearer shares”—i.e., shares made out to “bearer” instead of any named entity—when it is desirable to issue shares, why not make them out in this way? If nothing else, this tactic can be used to buy some time in arranging for truly trustworthy entities to hold the stock—to whatever extent and in whatever manner may best suit the circumstances. President George H.W. Bush might have referred to this as “plausible deniability”; we prefer to think of it as affording the corporation’s management all the flexibility needed to work within the law to accomplish worthwhile goals.

#### Irrevocable Proxies

Another technique used to control corporations is the use of irrevocable proxies—the right to vote the stock held by “someone else”. You have to be careful when using such proxies, however, as certain regulations contain wording such as, “who owns or controls the voting rights of stock”. In such cases, perhaps the best approach is to use the

concept but “seal the deal” with a handshake instead of putting it in writing. This can work especially well in situations where the other participants have similar needs of their own.

#### When Is an Owner NOT a Stockholder?

If you own part (or all) of a corporation, you’re a stockholder, right? In Nevada, the answer to that question is, “Not necessarily.” Let’s look at another unique provision of Nevada corporate law:

#### NRS 78.197 Rights of persons holding obligations of corporation.

A corporation may provide in its articles of incorporation that the holder of a bond, debenture or other obligation of the corporation may have any of the rights of a stockholder in the corporation.

With this provision in your Articles of Incorporation, you “may have any of the rights of a stockholder”. Thus, the holder of a note COULD own the corporation and could even be afforded the same VOTING RIGHTS as a stockholder—without being a stockholder.

#### Summary Regarding Privacy Issues

Is it OK to do things using privacy? Any contract, agreement or covenant that does not involve knowledge of wrongdoing or criminal intent would certainly seem to be within the boundaries of the law. And if one can act within the law and accomplish good or even great purposes—why not?

The combination of powerful privacy aspects discussed above has created a virtual “offshore haven”—onshore, right here in Nevada. And the great strength of this location is that the many powerful people who established this structure to suit their own purposes in the first place are not about to have their cover blown away by the establishment of any precedent that could adversely affect their own wellbeing! (See *Rowland v. Lepire* for some confirmation of this statement.)

#### Footnote regarding Rowland v. Lepire

In this often-cited case, the defendant did literally almost everything wrong: freely commingled personal and corporate funds and generally abused the corporation, failing to maintain records or adhere to even the most basic corporate formalities. In discarding the claim of the plaintiff against the defendant personally, the Nevada Supreme Court simply ignored its own strict, three-part test for determining whether or not the corporate veil may be pierced. Thus, while the corporation was found liable, its errant directors and officers were let off the hook. Only once in the last 22 years has the corporate veil been pierced in Nevada, allowing liability to flow through to the corporation’s officers and directors—and that case involved outright fraud. Liability protection for the directors, officers, employees and agents of Nevada corporations—in the absence of fraud or criminal actions—is as strong as it gets anywhere in the world.

# Do It Right And Do It For LESS

#### Budget’s “Tip of the Week” #1:

#### **NRS 78.105—Maintenance of Records at the Registered Office**

According to NRS 78.105 (restated, emphasis added): A corporation has a responsibility to maintain certain corporate records at its registered office *for inspection by stockholders*, including a State-certified copy of its Articles of Incorporation, a copy of the Bylaws and the stock ledger (or a statement naming the ledger’s custodian, including the address at which the ledger is kept).

It is hard to see why such records should be maintained in any case where no stock has been issued, as the expressed intent of NRS 78.105 appears to be to ensure that **stockholders** should have access to these corporate records. Of course, a court order may compel production of the corporate records and in that event, failure to produce them within a “reasonable” time could result in State penalties of \$25 per day for each day of refusal. In such an instance you would have up to five days to produce the records, which, of course, would be in perfect order.

If you choose to leave such records on file at the registered office of the corporation, you might want to take an extra measure of caution regarding privacy of those records and insist upon a **non-disclosure agreement** with the resident agent. Such an agreement should prevent the resident agent from casually identifying you with the corporation and from sharing the corporation’s filed records with anyone other than the corporation’s stockholders. (Otherwise, those records are potentially accessible by anyone making an inquiry.) And hopefully such an agreement would give the resident agent pause to consider additional security against those who might “snoop around”.

Here is one more thing you can do to protect your privacy: Contact your resident agent and ensure that there are NO documents on file that connect YOUR NAME to the corporation. Have the resident agent expunge and shred any old memos, order forms and any other such information that could adversely impact your desire for privacy.

The next “Tip of the Week” will discuss Nevada’s statutory sanctions against anyone who would even *attempt* to access the corporation’s records for purposes contrary to those of its stockholders.

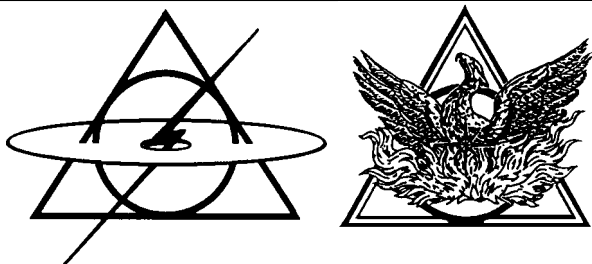
