

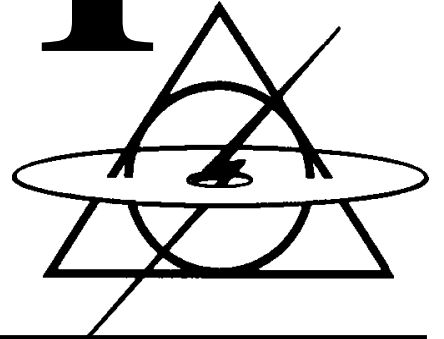

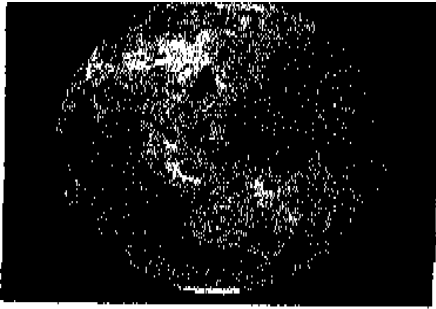

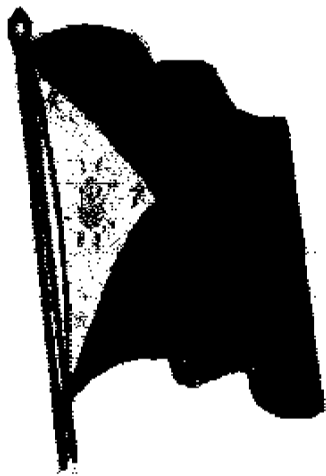

Group offers program to RP Sends letter to President Arroyo

The Global Alliance Investment Association (GAIA) has sent a letter to President Gloria Macapagal Arroyo to inform her that "your use of our deeds of assignment, for consideration can free you and your nation from graft and corruption, bring peace to Min-

Number One: IS PEACE POSSIBLE WITH THE COMMUNISTS AND/OR MUSLIM SEPARATISTS? LIBERATION THEOLOGY, March 2001.

Friends:

Is peace possible with the Communists and/or Muslim separatists?

Despite the unfortunate incident which led to the death of New People’s Army (NPA) captive, Philippine National Police (PNP) Chief Inspector Abelardo Martin, who was police chief of Dolore, Quezon, we join Senator Loren Legarda’s optimism that it will not affect the impending release of another longtime captive, Army Major Noel Buan, who was also abducted by the NPA in July 1999.

The expected release of Major Buan will definitely pave the way for the much-awaited but much-delayed peace accord with the Government of the Republic of the Philippines (GRP) and the CPP-NPA-NDF headed by Jose Ma. Sison. Already, Col. Rey Berroya is in Amsterdam to clear the air for the two sides before the peace treaty is formally signed. President Gloria Macapagal-Arroyo’s (GMA) decision to immediately free a lot of political prisoners who have been languishing in jail for several years now left Joma Sison with no choice but to reciprocate by releasing Major Buan. Moreover, her recent move to call for a suspension of military operations (SOMO) in all of Southern Tagalog virtually assures the safe passage of Major Buan to freedom.

Also, the active participation of political parties affiliated with the CPP-NPA-NDF signifies the Communists’ shift in tactics from armed struggle to parliamentary endeavor, a strategy long advocated by Italian theoretician Antonio Gramsci, who was more aware of the facts of history and of life than Lenin and Stalin.

No resistance from the Philippine Catholic Church is also expected, with regard to the peace agreement about to be realized by the country. Within five years of the end of Vatican II, roughly by the dawn of the 1970s, the

whole of Latin America and the Philippines were flooded with a new theology—Liberation Theology—in which basic Marxism “was smartly decked-out in traditional Christian vocabulary and retooled Christian concepts.” Books written by co-opted priests, together with political and revolutionary action manuals, saturated the volatile area of the Hispanic world where over 500 million Catholics included in the lowest and poorest strata of society have no hope of any economic improvement for themselves or their children.

Here in the Philippines, the Catholics’ paradigm shift led to the repeal of the Anti-Subversion Law. The fundamental struggle in which the Church and all Catholics were engaged is no longer on the supernatural plane but in the material circumstances of the tangible, sociopolitical here and now. In a word, it is the class struggle Marx and Lenin had propounded as the only worthwhile combat zone for humans.

In no time at all, the linchpins of Vatican and papal control were replaced by the action-oriented demands of the new theology. The most powerful religious orders of the Roman Church—Jesuits, Dominicans, Franciscans, Maryknollers—all committed themselves to Liberation Theology. In the worldwide field of their apostates, Base Communities sprouted like mushrooms. But they were fierce in their preference for violent revolution. Which explains why we have the likes of ex-Jesuits Luis Jalandoni, Edicio de la Torre, etc., joining the National Democratic Front (NDF).

But, as the years passed, it became obvious that no armed or bloody uprisings would do it for the CPP-NPA-NDF. No bellicose confrontations would win the day. Rather, everything must be done in the name of man’s dignity and rights, as Gramsci proposed. “Accomplish that,” said Gramsci, “and you will have established a true and freely adopted hegemony over the civil and political thinking of every formerly Christian country.”

The changed political thinking of many of the Armed Forces of the Philippines (AFP) junior and even senior officers shows that Gramsci’s psychopolitics is working.

We cannot say the same thing as far as the Muslim separatists led by the MILF are concerned. Notice how the MILF comes up with periodically new alibis to delay the peace process, the latest of which is the appointment of the so-called “Mindanao Butcher”, Army Lieutenant-General Diomedio Villanueva, to the top AFP post.

The MILF belongs to a new type of terrorism, the acts of which are often associated with religious causes. It emerged in the 1980s from more traditional forms like the MNLF and even the Kamlon-type of separatist movements. The difference is, the MILF is foreign-funded, giving the impression that it is one of Osama Bin Laden’s “cosmic armies”. In reality, a European power is behind it.

The MILF “mujahideens” are trained to exist in a perpetual state of war. One reason why a state of war is preferable to peace is that it morally justifies violent acts. Violence, in turn, offers the illusion of power. Also, warfare implies more than an attitude. To live in a state of war is to live in a world in which individuals know who they are, why they have suffered, by whose hand they have been humiliated, and what expense they have persevered. As an expert on the subject stated, “It provides cosmology, history, and eschatology, and offers the reins of political control. Perhaps most important, it holds out the hope of victory and the means to achieve it. In the images of cosmic war, this victorious triumph is a grand moment of social and personal transformation, transcending all worldly limitations.”

How then shall we respond to such a problem? One

temptation is to respond in kind, as the Estrada administration did. But the acts of retaliation seemed to stray far from their marks. A *quid pro quo* for terrorism usually fails. Any response in the form of retaliatory strikes enhances their credibility. Government authorities are not urged into military actions that fit into the war scenario the terrorists or separatists, if you wish, are trying to evoke.

On the other hand, a hands-off approach is also problematic: It might or might not quell violence. Moreover, terrorist acts like the burning of Ipil in Zamboanga are real threats to public safety, and no government can afford the perception by its citizens that it is too weak to respond when public order is under assault.

As a result, adopting an appropriate middle-road approach becomes ideal. Let us try to support and promote moderate leadership within the MILF and similar communities of violence to diminish support for the extremists.

More importantly, the government must once and for all determine what media’s role will be when it comes to terrorism perpetrated either by separatists or any subversive elements.

Publicity is the lifeblood of terrorists. This is why publicity has been a central goal of most terrorists throughout history, the means of communication have advanced from word-of-mouth accounts by witnesses to news reporting in the print press, radio, newsreel, and eventually television, which has greatly enhanced terrorists’ propaganda capabilities. More recently, the Web has emerged as a new and perhaps the most potent propaganda vehicle for terrorist groups, as well as for advocates of political violence.

It cannot be denied that the media space given to MILF Eid Kabalu of many radio and even TV stations have emboldened the MILF to adopt a sterner stand vis-a-vis the GRP. By treating terrorists, their sponsors, and sympathizers as legitimate political actors, the newscasts appear to donate a degree of respectability on these figures—especially when known terrorists appear with government authorities, ambassadors, and other official personalities.

The MILF and destabilizers supportive of the previous administration will continue to be the Macapagal-Arroyo administration’s biggest nightmare. For this reason, the next few months until June this year could be critical for President GMA.

What compounds GMA’s problems is the surprise visit of U.S. officials to the office of Justice Secretary Hernando Perez. Not only did they appear peeved with the way our government has been handling l’affaire Jimenez—but they also went as far as stating that they may not extradite Erap... should the latter escape. This statement has now become the subject of speculation by political analysts. Will the U.S. plan Erap’s escape route? If so, this will pave the way for the dreaded EDSA Tres.

[H: The U.S. still swings very large clubs, my friends. All this only shows that the tug-of-war between China and the United States has affected most if not all the governments in the region. It is, therefore, imperative for GMA and her People Power Coalition (PPC) candidates to come out with a convincing win on May 14; otherwise, it’s going to be back to the drawing boards for them. And it may last a long, long time. Perhaps until the incoming military junta abdicates from

its foreseen role as the nation's savior.

Meanwhile, the rabid supporters of the ousted ex-movie actor continue to sow dissension, factionalism, intrigue, and other psy-war operations against GMA's administration, using their "bottomless" source of funding derived from illegal gambling, drug trafficking and smuggling activities, to hasten the fall of those who vanquished their beloved patron.

Number Two was presented first in order but I have chosen to offer them to *CONTACT* in this order because I feel the prior article to be more pertinent to the readers in general.

Friends,

Political analysts are one in saying that the forthcoming May elections will settle, once and for all, GMA's legitimacy as the 14th president of the Republic. At the same time, this particular poll exercise will be an accurate indicator of her first 100 days as Chief Executive.

Realizing how crucial will be the results of the May polls, the people behind GMA are determined—by hook or by crook—to keep the political opposition at bay. Proof of this is the simulated act of coming out with similar survey results by Pulse Asia and SWS, suspected pollsters of London and Wall Street in this country. Together with the equally controversial NAMFREL, the election arm of the Makati Business Club (MBC), and their associated broadcast journalists on radio and television, we can almost expect a resounding victory for the EDSA People Power Coalition in the senatorial contest. The local elections, however, will be different.

Another evidence of conspiracy to orchestrate poll results is the orchestrated smear campaign of Guillermo Luz (MBC executive director) and Mahar Mangahas (SWS) against COMELEC Commissioner Luz Tangcangco, who is very much against easily riggable computerized elections.

Local patriots are one with Tangcangco's estimation that paper ballots counted at the neighborhood precinct are the only way to ensure free and honest elections. In the U.S., every independent vote-fraud investigator who has written publicly on the subject believes that the overwhelming majority of U.S. elections have now been made unverifiable, that is, riggable.

Lately, both SWS and Pulse Asia have introduced so-called "exit polls". What they're not telling the public is that phony exit-poll projections turn into phony final results. During Marcos' time, it was called "extrapolation".

An 11-2 or even 10-3 victory for the administration's senatorial bets would mean that the 250,000 people gathered for EDSA Dos, comprised mostly of the A-B-C crowd and principally, Makati's elite, spoke for 75 million Filipinos. Anything less than this would spell disaster for GMA come 2004.

It is interesting to note that the 1986 EDSA revolt was fully supported by the Western press. Today, however, the very same media crowd has expressed serious reservations about "People Power, Part II". Singapore's Lee Kwan Yew, for one, has publicly expressed non-approval of the 2001 "constitutional coup" launched against President Estrada. Geopolitical experts know that Singapore is one of London's listening posts.

The Asian Development Bank (ADB) is another party which has expressed "cautious optimism" regarding the Macapagal-Arroyo ascendancy to Malacañang. Its principal concern is agrarian reform. "The growing gap between the rich and the poor, between the urban and the rural sector, and between the educated elite and the uneducated masses represent the soft underbelly of our country's national politics," writes Calixto Chiklamco. "It made possible an Erap 1. It will be the source of the country's continued political instability."

What makes the situation worse is our half-cooked Comprehensive Agrarian Reform Law (CARL) which stuns agricultural productivity: (1) through increased uncertainty of property rights, and (2) through restriction of the land market. Agricultural land transfers beyond five hectares are not allowed.

GMA's major headache, however, is the growing perception that hers is a "cloned" government, and that former President Fidel V. Ramos (FVR) and his comrade Renato de Villa are actually running the affairs of the state.

Her image as a "captive" president is further enhanced by the appointment of FVR errand boys like Dick Gordon, Bebot Bello, Eddie Ermita, Gabby Claudio, and many others. Even the much-vaunted People Power Senatorial lineup is stacked up by known stalwarts of the FVR presidency.

"The Gloria Macapagal-Arroyo administration is beginning to look like the Ramos Last Hurrah of 1998," states *STAR* Publisher Max Soliven. This is bad for GMA. To put it bluntly, a great number of people still remember that FVR presented himself, totally unabashedly, as an apologist for the hedonistic consumerism and social Darwinism of our time. And this he continues to do so at the moment.

In the eyes of nationalists, FVR feels decidedly "good" in our imagined prosperity and in the relative security of our democratic and constitutional conditions. In his opinion, this condition, compared to the rest of Southeast Asia, exists only as an "exception" and only accounts for a "fraction" of the socio-economic state of world affairs, but exactly for this reason one should "take great pains" to "preserve it still longer".

It cannot be denied that Ramos and his cohorts support the speculation-based casino model of the international financial systems and the IMF because, in this system, they are "living high off the pig". Never mind if local industries, and jobs with them, are devastated because of these politics. What matters is that they, a small elite, are thriving. It doesn't matter if the entire country collapses. They will do that which will preserve their privileges. And the MBC is pursuing this course to the latter until this day.

Here's what an internationally acclaimed group of economists say about the nation's past leadership: "Presidents Aquino and Ramos' kowtowing to the IMF and 'market sentiment' caused crippling damage to the country's ability to service the general welfare of the population, who, in 1998, responded by giving Estrada the largest-ever electoral mandate. Aquino's government more than tripled debt service as a percentage of the total government budget between 1982 and 1994, from 9.6% to 33.9%, while slashing defense spending by more than half, cutting health care by 40%, and stalling funds to education. President Ramos increased the budget allocation for debt servicing and opened the floodgates to 'fast-track' economic liberalization, deregulation, and privatization."

During her inaugural address, President GMA spoke of not privatizing the NAPOCOR. She also used to talk about the Philippines joining in the formation of the Asian Monetary Fund (AMF), and ditch the IMF. Today, however, we are hearing less of such pronouncements despite the **overwhelming evidence of the IMF and Wall Street targeting ASEAN-Plus 3 nations for financial warfare.**

Just this week, Acting Defense Secretary Eduardo Ermita admitted via Channel 7 that the CPP-NPA has grown by leaps and bounds and is now considered to be a major threat to our country's security. A continuation of the Aquino-Ramos economic policies of globalization by GMA will definitely pave the way for a bloody civil war in the not-too-distant future, with communist forces most likely to emerge winners.

A communist victory in the Philippines will signal the end of Wall Street and Washington's mindless imposition of U.S. power in Asia, which will definitely tilt the balance of power in favor of China. Under the Bush administration, the United States will continue to expand its empire until it disintegrates like the Soviet Union, with its imperial over-extension.

Already, the IMF-Wall Street-orchestrated flight capital out of Asia, Europe, and the world, just to hold up the dollar, "which depends on almost \$2 billion a day

in foreign inflows to support the U.S. deficit,” is driving the ASEAN-Plus 3 nations into an alliance to “demonstrate Asia’s political will to survive” as discussed under the May 6, 2000 Chiang Mai Initiative.

Japan’s recent soft loan to the GMA government of about \$600 million is an effort to convince Manila to join its move to “ditch the IMF or go down with the U.S. dollar”. The creation of an Asian Monetary Fund (AMF) is logical since the Anglo-American institutions are too dependent upon Asia’s exports. This should be followed by the creation of a new synthetic Asian unit of account for trade and production credit, based on a “basket of hard commodities” for the region’s survival

[H: Sorry to disagree right here but what is needed is GOLD. In the Southeast Asian geographic location there is ample gold, so don’t be put-off by the claims or misinformation. Much has been shifted out clandestinely and after shifting has been further grabbed, leased, hedged and stolen. The first intent of the original parties doing the shifting was to insure that at a future time the assets AND THE GOLD could be returned to the Philippines for the PEOPLE and the nation.]

The Government Crises which have hit Asia, however, have threatened the new economic approach of the ASEAN-Plus 3 nations. The impeachment proceedings which hit the Philippines and Taiwan, the Indonesian demand for Wahid to resign, and the doubtful elections in Thailand are clear indications that the IMF and related agencies have thrust Asia into a second round of stock and currency collapse, something which the GMA administration will attempt to soften or face the prospect of an EDSA Tres.

America’s indifference to Asia’s economic plight has forced the Asians to pursue “Vision 2020”, a plan for the full political and economic integration of the 13-nation region, first proposed to ASEAN in December 1998 by the late Japanese Prime Minister Keizo Obuchi, and enthusiastically endorsed by Korea’s Kim Dae-Jung.

The development projects accompanying regional integration will not happen if the IMF is allowed to continue with its present political lock on the finances of East Asia. That is why it is important to concretize both the Chiang Mai currency support agreement and the AMF, independently of the IMF.

To the economic patriots of the Philippines, this is a tall order. They will have to way-lay the formidable political clout of FVR and his boys. As *CONTACT—THE PHOENIX JOURNAL* stated in its August 16, 2000 issue, “Ramos is in the center of every upheaval in the Philippines in recent times. He may not be there in person but lots of things seem to happen and there he is. Is he on the prowl for good or bad, upset or stabilization? That is not our prerogative to consider.”

Can GMA, therefore, survive politically without FVR’s support? Apparently not. And this situation will not sit well with those who were lured to march and gather at EDSA for the second time. As Art Borjal correctly surmised, “It cannot be ‘Business as usual’ for the new government officials... they will be monitored on their compliance with President GMA’s pronouncements... modern information technology will work hand-in-hand in seeing to it that People Power will exact its toll on the new powerholders who will dare betray the people’s highest expectations.” The trouble is, FVR is the author of “People Power”.

Meanwhile, the U.S. has dumped thousands of troops into the Philippines “to have joint training ventures” while the interests of foreign nations are entangled with blockades to Freeports. Meanwhile, the counter offensives heighten in the bids for some peace among factions and always the accusations of the political arms flail about endlessly.

Not to concern over the long-haul meanings to this seeming dilemma, friends, for the seeds ARE planted. Even the farmers are working on their highways (which are pathetically like wagon trails with only one-way, mud-packed ruts) to get their “corn” to market as harvest time is arriving. A lot of produce is going to be shifted from here to there and all around. Remember, **THIS** is primitive “world”—but just as secure or insecure as is the great United States of America and parts West (or East depending on where you are located). Look FAR enough and it matters not at all, does it?

Where have we planted crops?

In Southeast Asia, even in Indonesia (although still “hidden” away at holder’s discretion) **is a GAIA deed that would end the conflict in Indonesia.** However, there is no one available to go within the incredible killing machines to check it out.

Much rests with Malaysia, while the IMF has no say in Malaysia (BUT THE WORLD BANK DOES).

I am grateful to those who seemingly get nowhere in the other reaches of the globe as to impact. But that is not so, South Africa. Word is not only getting “around”, it is being thrust now onto those who CAN make a difference. There is one moving about who can reach the Heads of some 50 or so Muslim States. These people simply want to move on to a BACKED currency—and exchange the “real thing”, as in gold coins, etc.

Will the receivers keep those promises? Well, some won't but then again, they have to run the risk that I BE SO. It certainly is NOT difficult to establish my own reality—and there you have it, nicely wrapped in a transparent wrapping paper.

Of course, each and every nation will try to get around the bondage of useful arms buildup. And, yes, our input would free up funds spent otherwise to do a buildup. BUT, the nations have been so devastated by the manipulators as to render them unable to do much of anything without first serving infrastructure, cleanup, startup of industry and livelihood projects and such. WHAT IF YOU HAD A WAR AND NOBODY CAME?

We are NOT “selling” anything and, therefore, the way seems slow and treacherous with cons and scams at every foot of the walk. There simply is no pushing this toothpaste back into the tube. The cap is off the tube and simply opening it from the bottom end and refilling is not feasible, for the cap is wide open.

As we push onward we have a LOT of interesting claims and claimants stepping forward. Some quickly vanish and others “try harder”. Out of the unfolding programs will come THE ONES who can and shall back them in TRUTH. However, you have to have backup ability to show support and ability for the people to PERFORM. I use the term “people”, for **GOD IS OF THE PEOPLE—NOT OF THE POLITICIANS.** You may not find much evidence of God among the people these days, either, but you certainly can hardly find God allowed within the circles of the politicians—even if they invoke HIS NAME at every breath.

Indeed, in such inquiries regarding such as Malaysia—you who have contacts, GO FOR IT.

I am weary of the efforts to get my team TO GO SOMEWHERE, i.e., Malaysia. Our program is certainly big enough to cause an interested party to make a little journey to meet and confer and check it out. They make journeys to tea-parties; can't they afford to take a look at the salvation of their nations? Well, they WILL DO SO—or they will be left out of the loop.

People who don't want to bother to know enough to present the program had best not be asking for the rewards thereof.

I hearken back to an attorney who traveled with all

expenses paid, ate an inordinate number of extra meals and finally went scuba diving at our expense—only to botch directly the very contact he was brought forth to make. That party is now deceased but the billing still arrives for “fees” back at the “ranch”. That party in point had a three-week vacation and still cost multi-thousands of dollars in addition to participation hourly fees charged. He even went to “temple” and charged us for the “time” involved. Are we happy about it? No, but what can you do other than learn? You had to know how it would be—and THAT IS WHAT HAS HAPPENED TO THE WORLD, my friends.

Witnesses to this indiscretion? Oh, indeed, indeed.

Are we somehow angry or bitter? In some ways, yes. In all other ways, no. These are the experiences which give credibility to the entire unfoldment of the program itself and registration of that which the people and judicial “truth-claimers” seem to need to have any recognition AT ALL.

We did what was necessary to establish a pattern of integrity and we have maintained same with only a more feasible plan evolved.

In my responses to South Africa, as in “A” through “D”:

A. Stay open for this potential, for the “Dinar Plan” is very much alive and well.

Even in the Autonomous Region of the Philippines, the people are having recognition of plenty of “backup” foundation for such a plan and are demanding as part of the peace agreement, an Islamic BANK to handle such programs as a similar Dinar plan to be used as international exchange. They can use the assets for livelihood projects, infrastructure and the backing for a full exchange flow based on the “gold standard” of VALUE.

If you think about it, friends, you will stand in awe of what we have accomplished instead of sulking that “nothing happens”. You cannot reap a harvest if you never bother to plant a seed.

B. Don't get too upset over lack of response from such as “Truth at Last” or “Final Call”. These are totally monitored and diversions in place. Furthermore, remember that somehow if your “God” name doesn't match another's, you are going to bite the dust pretty quickly. **Certainly, a “believing” man is not going to attend that which he does not know—and the “knowing” is so limited as to be staggering.**

The first thing that happens is the simple act of being able to even “look” or “listen” to possibilities. Secondly, people get information and advice from the VERY DISTRACTORS at which time all that is necessary is to append some notion such as “anti-semitic”, cult, conspiracy, crackpot, or other non-sequitur and the attack is “on”. **Literally, brother will hit or steal from brother, mother, partner or whoever “seems” to be in the way of personal ego-satisfaction.** This plays directly into the hands of the manipulators and at cue for use.

I look at the Taliban circumstances and some big hulking idols placed in mountainside carvings. Do the people not have the RIGHT to tear down that which defaces the very foundation of the cliff walls themselves? Did the “White-eyes” not carve faces of politicians into the Sacred Mountains of the Dakotas? Will the war really get under way when the Native Americans REMOVE those disfigurements and idols to corruption—to devastation of their very people and traditions?

C. Anyone with “contacts” should certainly follow-up with what information you can offer but do not expect Ekkers to supply you with your “packages”. Get a resource for a full package of information and make copies. We will waste NO MORE TIME on middle-of-the-night inquiries to facilitate individual “trading programs”—which do not work, didn't work and shall never WORK. Those were programs to bring you “in” and then cut your

throats. There is still a scam-a-second making rounds as the banks are struggling to cover their assets. And they intend to do that out of more of “your hide”.

D. Go for any “possibilities”. Stay within guidelines and demand that contacts do likewise and you will be secure. Start being my guidelines and you will not flourish and will, in fact, come under probable cause for unwanted attention from various regulatory commissions and regulators.

I am here to remind you that we have MADE IT WORK and that is PROOF of viability as to security in functioning capabilities. It is the side-agreements which stand to drag down any program and we won't bend an inch to shelter anyone who deliberately cuts the wrong deals.

I want to remind everyone that the asset, including the supporting collateral, STAYS WITH THE FUNDER OF COLLATERAL “REAL” PROPERTY. There is no division of that asset until gold doubles in price from the date of transaction. That in itself provides the bank or nation to utilize the collateral as “reserve” holdings against which they can utilize the commodity. Our program SECURES both.

This insures no “call” against the U.S. which would bring forth conflict while putting the assets to use. Money is worthless, people, if not used/circulated.

Why don't the operators of such as the IMF/WB, etc., simply work out a plan with us?

They don't know what to do and any program which openly deals with our people—ENDS PLAUSIBLE DENIAL. The same thing happens when a Central Bank Governor in an IMF/WB-manipulated/controlled country responds. This is why “STONE WALL” and “silence” are the operative words here. They can't DENY, so they simply “ignore”, laugh, “no comment” or the inquiries are met with silence. Why do you think the workings of the world are confined to CODE-NAMES and conversations/communications made through publications instead of named interviews?

Why do you think so MANY things are now named as part of their title “Global” as in the very name of our Association? Right again, to distract and make inroads for connecting assumption. Even “GAIA” has a run on international name-recognition. Confusing? Of course, it is intended to be so.

Immediately, in the Philippines alone, we could not even get our corporate name utilized for all the copycats installing foundations and operational labels.

The name Ekker is another interesting title. In most places there will not even be listed an “Ekker” with that spelling in the phone book. And yet, when it was established for e-mail there were so many sign-ins for “Ekker” that the index couldn't hold all the pretenders. This was, of course, to steal the communications. The *Spectrum* kids, at least two of them, were receiving the writings DIRECTLY.

When E.J. would sign-in on his own site for e-mail communication, there was such an overload on that connection as to literally delay transmissions and often cause a final “give-up”.

We don't have anything to hide but we offer privacy for our people to the limits of possibilities—but we can't override the natural systems established.

I want to remind all of you that, in the beginning, E.J. offered as a part of the Phoenix Institute, PRIVACY. He kept his word even while the COURT broke the privacy and George Green spread out the very information which was part of HIS OWN PROGRAM. E.J. simply stated that he would go to jail rather than break his word to the lenders. The reward for that? Charges of contempt of court, receivership efforts and

outright “forced liquidation” legal threats. Ah, indeed, University of Hard Knocks training and learning.

It has been, indeed, a hard time of sorting. Hard on the heart, that is. It is simply that NOBODY realized the magnitude of that which we offered to share in the very first place, over a decade past.

You have faced and agonized over separations of friends-turned-enemies and on and on went the escapades of ill-intent. The TEAM has stayed the course and in many instances “blundered” from time to time while getting seaworthy. It is fine, for the Captains can now direct the ship instead of bobbing about with a rudderless craft, shipping bananas and mangos haphazardly from port to port without compass or security.

THE IMF/BANKSTERS MAY NOT BE READY FOR A WORLD IN POSITIVE CHANGE—BUT, INDEED, THE WORLD IS READY FOR CHANGE.

The major point of this particular focus, however, is to remind you that you can’t “WAIT” around while the opportunity dies of old age and intestinal blockage.

Every project must have a plan and then an infrastructure and finally production. Cut out any one of the first demands and you will not have “production”. I will remind you that a couple of years is not very much time to lay the infrastructure in FACT to produce that which will bring the product forward.

Can you do this?

What else more important do you have to do?

Oh, indeed; SURVIVAL. But, isn’t THIS part of “survival” potential and possibility?

What WILL YOU DO if nobody brings possible and positive change to this world headed for the dumpster?

We are a bit like Spelta grain. We won’t hybridize just to make a bigger or self-ego-based crop of grain. **We have the only fully operable plan which bears all the light that can be shed onto it. We don’t have to hide behind false images or foundations or any such shelter for the guilty. GOD PROMISED IT WOULD BE THIS WAY. HE ALSO PROMISED THAT YOU WOULD HAVE TO DO IT—FOR NO ONE WOULD DO IT “FOR” YOU.**

Yes, that is a nasty concept to you who await that nice rapture to paradise on the wings of whatever you perceive comes hereafter. The transitional change, dear hearts, is so tiny as to often be totally unrecognized to the “operative” soul involved. Moreover, it is often that now, as we squeeze down on potential realization, souls will transition to impact the very ongoing play itself in their individual efforts to assure a harvest of credible realization. These are now the “beyond the line” or “behind the individual operatives” troopers. They will neither spare the individual entity under guidance nor damage the positive program to suit a physical manifestation. If a son of a departed is in wrong directional sweep, the parent will make a definite prodding force. The impacted physical party will finally realize wrong direction and service—OR—dwindle in his/her own force-field.

Lies are not acceptable.

If you have a hookup to a lie-detector apparatus and you hold a position of some kind with a corporation but are asked if you are a shareholder, what have you? Even if you would “control” that corporation but hold no shares as in issued stock certificates but you “confess” that you DO, no—you should flunk the test. You will respond to what you “believe”. If you are “informed”, you will not blunder because a “yes” is a lie if all other things be securely covered. However, if you don’t know of what you speak, you will convict self even though totally innocent. It is the fact of mental response. This is actually recognized as the “ultimate entrapment” apparatus. Furthermore, it is the ultimate “getcha” apparatus of or against

those who are in no way guilty of any association or even remote connections to the focus of the inquiry itself.

YOU GIVE FALSE INFORMATION MOST OF THE TIME AS YOU SPEAK UP AND OUT ABOUT THAT WHICH IS OBVIOUSLY NOT IN “YOUR” REALIZATION OF FACT OR TRUTH.

The New Gaia and Phoenix Institute assaults were based ENTIRELY on just such disinformation and accusations wherein no foundation existed for such actions.

It is as with Bilger writing that he did whatever he did of false accusations and TV presentations on his stated “fear of a Waco” incident at the farm where he was residing with only his wife. HOW, PER CHANCE, COULD YOU HAVE HAD AN INCIDENT when the targeted parties were long over 9,000 miles away, whatever “arsenal” COULD NOT be theirs, nor were any other persons even available, other than the two people on site?

The lie becomes the truth? NO, THE TRUTH IS ONLY BURIED IN THE LIE—FOR A WHILE. IT WILL ALWAYS SURFACE IF GIVEN SUFFICIENT TIME TO COME FORWARD.

So, our people have to work from the stance of “all odds against” them while everything they have is stolen, seized and reputations devastated. NO, IT WILL NOT BE LONGER ACCEPTABLE. Moreover, the observing unthinking people will join the miscreants almost every time. Why? Because they get caught up in the lie itself and actually contribute to the infractions.

THIS IS WHY THERE MUST BE CONFRONTATIONS IN BEHALF OF TRUTH

If there are no repercussions or consequence to ill-behavior when discovered by the OFFENDED parties, then it is assumed that the WRONG was acceptable. THAT IN ITSELF IS NO LONGER ACCEPTABLE.

I remind everyone reading this that time of limitation does NOT expire on such things as deliberate crime, murder or criminal intentions with involved actions having taken place. New circumstances and realizations noted can immediately reopen any file even for reconsideration.

I suggest that our own attorney ready causes of action against several parties and corporations and not let time limitations lapse, even if only held in filing. Or, the parties involved can ready their own petitions. As discovery of more and more untoward activities are discovered, the old can be utilized right along with the newly discovered.

In addition, to those who literally charged criminal acts which damaged a whole Institute and all associated parties, there needs to be an accounting for the damages and FALSE accusations.

Some people, especially ill-intentioned lawyers with ongoing capability of staying in the “game”, can keep a case dragging infinitely even though there is no case remaining and all people and property have gone away. This is in a last-ditch effort to “stay alive” themselves and keep their legal “licenses”. Well, in the process, they also “keep the case alive”—for us as well.

Let the little devils play, friends, for they only shoot themselves where it hurts most. We simply THANK GOD for the opportunities they provide us.

By the way, the original bodies of our team might be a bit frazzled but we mend, with vanadium steel threads, the rips and wounds—and in the process build a suit of impregnable armor. **FEAR GOES AWAY WITH EXPERIENCED KNOWLEDGE.** That does NOT mean that impact goes away—ONLY FEAR.

Moreover, when you KNOW something to be true and your own attorney fears to use the facts—

DEMAND RECOGNITION, STUDY UNTIL HE DOES RECOGNIZE POTENTIAL PROTECTION—AND BE BRAVE ENOUGH IN YOUR OWN BEHALF TO STAND TALL AND STRONG.

Can we, to return to the original topic, make our program work? We ARE making the program work. Wealth in the bank is NOT the measure at this point of the WORKING PROGRAM. That at best can only be ultimate “proof” of physical transactions—not the working program.

We deal in NO SECURITIES nor scam programs. We do not “do business” in any nation—we only do business with an entity or corporation in business in any locality. All is as open as a transparent window and the demand IS FOR ACCOUNTING. **The fact is, nobody seems to understand how to make such a program work—because it scares them to death just in its consideration.**

What can YOU do? Well, support the team in the arena so that our communications network is sustained.

By the way, as to products no longer available. Call for information, for some product is yet available but intelligence caused a shutdown of questioned “anything”.

Resources are being worked on as we write and alternate resources being contacted and established.

I want everyone to remember that New Gaia, for instance, as established, is nothing except a distributing company. The corporation itself was headed by Cort Christie and many of the associates thereof; many of whom have moved away hoping they will not be named in suits. Not likely that the moving-away bit will work—for the law works, preferably, on facts and documentation as EXISTS. They, even the miscreant officers, don’t like to be made the fool as in what has happened with New Gaia and the Phoenix Institute, or even other misconstrued corporate structures.

And, yes, Ekkers and other such parties who have been personally damaged, punitively and otherwise (financially), YOU can bring personal suits—preferably against parties and THEIR CORPORATE STRUCTURES. Having dumped the corporate shelter makes not a whit of difference—for they WERE in full operation at the time of the damages. Remember that in this particular method, the parties have to retain the services of an authorized attorney—in all instances—and that is the only way to have satisfactory interchange of demand for information and mandatory discovery.

It then becomes the burden of the accuser to prove he/she did NOT file the charges. But you have circumstantial evidence in “first person” statements to reduce the probabilities to the very ones you know filed the fraudulent information in the first place. That does not make a happy prosecution team [Fed]—especially at “reappointment to position” time.

Your best approach is not against the Feds who simply do their expected duty at upstart investigation—but go for the jugular of the known misinformers.

We have INTERNATIONAL PROOF of everything from fraudulent and slanderous obstruction of business to reputation damage of intentional objective.

Those Internet sites had both source, operator information and responsible parties—which in several instances was Ed Young himself.

Just keep records of all “statutes of limitation” and never cease in your information gathering. Nobody, especially your attorney, will involve himself/herself in the program until you pay for it and then will be used only that which you demand. You do not longer have a “common court” of truth—you have a bunch of “case” law upon which all cases are based. SURVIVAL WITHOUT A SHELTER

By Sharon Packer

Approximately 30% of the world's population have shelters to protect them against the effects of nuclear weapons. Nearly 100% of the population of Switzerland has shelter protection. Russian, China, Finland, Sweden and many other countries have industrial and critical population areas protected against blast, radiation and chemical/biological warfare. Very few people in the United States have adequate shelters and most of our population believes nuclear war is not survivable.

Misinformation, myths and Hollywood productions have lulled most of our citizens into a deep sleep. Their eyes are shut, their ears do not hear. Few read beyond the sports page to realize that Russia continues to modernize every aspect of their strategic nuclear arsenal and proliferates the spread of nuclear weapons to governments of irresponsible leadership. **[H: You know, exactly as does the U.S.]** Some people will only awaken to the great noise of the tumult. Others will procrastinate until it is too late. A few of the prudent, however, will prepare and survive to see a better day.

The \$25,000 to \$30,000 cost of well-built, hardened shelters is prohibitive to many families. If built to maximum occupancy (50 persons) the cost is about \$500 per person. This requires, however, the cooperation of 50 like-minded people living within a small proximity to the structure. Steel plate or corrugated steel structures; if properly installed below 8 feet of dry dirt cover will normally provide adequate protection within ½ mile of ground zero of a 1-megaton ground burst. This design was tested under actual blast conditions and proved very effective.

[H: I am going to interrupt right here and suggest you try to get a copy of Phoenix Journal Survival is Only Ten Feet from Hell. We find it unlisted and, therefore, must assume that either it is among the books taken by George Green and still unreturned as ordered by court decree, or, it is not in print. Mr. Green took over 50 titles and all were ordered back to owners but have not been either received or located. He was to have (by court order)

insured and stored those books against loss or damage—but we have since been told he swore that they were destroyed in a flood, no less. We can some day reprint those volumes but it is cost-prohibitive at this time. There are other good resources, however, if you seek out the information. We gathered much information and compiled it along with other points of interest in several volumes—but we work with "what is" and can't depend on "wish it was...". We also have yet to recover records and manuscripts being worked on by Dr. Al Overholt who refused to even consider turning over our own property until he was paid whatever he considered his back due-and-owed immediately. He is, yes, the same one who touts the Angels' call at every opportunity for the good of mankind in SPECTRUM.

How many people have to die and be disinformed to feed the needs of such people who support the very adversary in the total proclaimed innocence of whatever they choose to do—even when truth hits them between the eyes.

We know that Green had in his possession some 110 THOUSAND books of ours. He was charging \$10 per volume, so you count the value. I just remind all of you that he was ordered to sell NONE of them—and certainly we do know that he continued to sell any and possibly ALL of them. Recourse? I do, I repeat, suggest you do get some information for your own protection because you are headed directly to nuclear accident or intentional hurt.]

20 PLUS MILES FROM TARGET

Many people in this vicinity can survive outside a hardened facility. The weapons effects of blast, thermal pulse and initial radiation are limited to a fairly small radius. Rural areas outside a 20-mile radius of prime targets will only be affected downwind by fallout. A basement provides a natural protection factor of 20. This means that you would only be exposed to 1/20th of the radiation that you would receive outdoors. Two feet of sandbags overhead and on the open sides in a basement will build your protection to a factor of 500. If possible, build a 90-degree turn into your entrance. Keep several 5-gallon buckets with lids for sanitation purposes. Store toilet paper, disinfectant and feminine supplies in the bucket. Store water in 55-gal drums nearby.

5 TO 20 MILES FROM TARGET

Your home may be destroyed or left unlivable in this area. A protection factor of 1000 or greater is needed in this proximity, and can be achieved by placing the equivalent of three feet of dirt around and over your structure. The book, *Nuclear War Survival Skills*, by Cresson Kearney, gives detailed instructions for a blast and fallout shelter that can be hand dug in your yard and costs only a few hundred dollars.

0 TO 5 MILES FROM TARGET

Evacuation is the only means of survival if your home or business is close to the target, unless you

have access to a hardened blast shelter. You would be wise to pre-position food and supplies with friends in your intended evacuation zone. Evacuation requires early warning or an escalating crisis. The only warning of an imminent attack is the attack itself. You must, therefore, learn how to read the EMP early warning signal. Some of these warning signals are listed below.

It is possible that a full-scale nuclear attack from Russia or China would be initiated with a large-yield high-altitude nuclear weapon arriving via satellite and detonated over the central area of the United States. The electromagnetic pulse (EMP) is a strong electrical field associated with all high-altitude nuclear explosives as well as with nuclear ground or low-altitude bursts (those where the nuclear fireball interacts with the ground). These induced currents and voltages are designed to cause malfunction of electrical equipment and interruption of military communications. High-altitude nuclear burst could affect an area of a thousand miles in diameter. Neither blast nor radiation damage is associated with high-altitude bursts. This detonation could cause our commercial power to fail so every instance of power failure could be suspected as a possible attack warning. Certain simple tests will quickly reveal whether an EMP attack has occurred.

[H: Do not overlook "rolling blackouts" as tests of both potential failures and to sensitize you to possibilities. Each "failure" needs immediate investigation and keeping your checklists handy. You are going to now see how bad is the loss of your generator and fuel supply as was at ready at "Ekkers". We did not make careless non-based speculations regarding the area in point. We considered "wind direction" as in "prevailing", distances from possible or even "probable" targets and terrain between you and "them" should there be strikes. You allowed the loony Coo-Coo birds to dump in your nest and they have the equipment stolen directly FROM YOU and right from under your very noses. Isn't anyone ever going to get even "angry"? Or, are you going to just sit back and say, Oh, Well? WE ARE NOW TALKING "YOUR LIFE", PILGRIMS.]

1. You may see an unusually bright light, which lasts longer than lightning. If this light is associated with a power failure, it should be considered as a possible EMP detonation. Do not look directly at the light, as it may damage your eyes. Not all areas of the United States would necessarily see this light, for example, if there was a cloudy night or in the daytime.

2. Check the telephone for a dial tone. A telephone that operates without an external power supply usually does not fail in a normal power outage, but it would most probably fail as a result of EMP. Note, however, that phones requiring external power supplies (such as those with answering machines and those with a mobile handset) will typically not operate during a normal power outage. In addition, phones do fail regularly from other causes and so a third test should be used to help determine if an EMP event may have occurred.

3. Only a small percentage of the radio stations in the nation have been partially protected against EMP. After an EMP event, most of the radio stations would experience equipment and/or power failures and go off the air. Whenever there

is a power outage, a battery-powered radio should be used to check for loss of transmission. A simple lightning strike could take out one station, but only an EMP would take out a large number of the radio stations. This transmission failure would be a good indication that an attack was imminent. Keep a small transistor radio wrapped in aluminum foil for this purpose.

The flight time of a missile varies with the distance from the coast. Russian land-based Intercontinental Ballistic Missiles (ICBMs) could arrive in the Midwest as early as 25 minutes from launch. If submarines were used off of the U.S. coast, the Midwest may receive only a few minutes of warning time before the first Submarine-Launched Ballistic Missiles (SLBMs) would arrive. Since the end of the Cold War, indications are that the Russian missile submarines are no longer in our coastal waters and the SLBMs would have a flight time similar to the ICBMs if these subs did not forward deploy. However, all haste should be made to reach shelter as quickly as possible. These few minutes should be used to find expedient sheltering if away from home, or to quickly access a permanent shelter. If time permits, gas lines to the home should be turned off and curtains or draperies closed to protect against the thermal pulse.

If the EMP occurs during the night, a simple power-drop alarm can be constructed from a battery, relay switch and horn to awaken those who are sleeping. Any electrician can construct this alarm for you. I would suggest using a 12-volt gel-cell battery with a large relay to match and a 12-volt motorcycle horn. Smaller relays may be vulnerable to the EMP and not function as we have planned.

[H: Now let us not be naive enough to expect parents to leave the children blindly in a schoolroom or little league field—so look ahead and while one parent gathers children the other could make a run on the grocery store for immediate supplies of fresh eggs, bread, milk, etc., so that you can get by if necessary. A few bags of ice, for instance, and some lunchmeat for sandwiches would be a great thing if you are “grounded” for a few days. This can be accomplished in mere minutes if you know what can be accomplished and waste no time. In Tehachapi with our team, for instance, shelter can be reached from town in less than five minutes if necessary. Be methodical, don’t panic but hurry. YOU CAN FILL TIME IN SECURITY IF YOU MOVE ALONG. If only one parent is available, err on the side of getting the kids and hopefully you will have already stashed some “make-do” survival items for just this occasion. If you are caught at night, you are at least already together, so grab the gusto and get moving. You will have already some sleeping gear waiting and an available tote of a few changes of clothes.]

Many people are living in rentals and would be unable to construct a shelter. They should look carefully for the nearest available expedient shelter and make plans to carry survival supplies in their car at all times. Consider some of the following places:

- * Garages—(service pit area in quick change places)
- * Churches—(pipe chases from boiler rooms)
- * Banks—(basement vault or safety deposit areas)
- * Hospitals—(usually have massive basements and are usually well built)

* Residential homes—(look for basements with maximum soil coverage)

* Schools—(most schools have pipe chases and some have good basements)

* Mines—(stay well back from the entrance)

* Tunnels—(many hotels and hospitals have tunnels between buildings)

* Culverts—look for long runs under highways. There is possibility of danger from rodents or even water runoff.

* Boiler Rooms—in churches, schools, and other large buildings.

* Community Swim pools—(Equipment rooms) Note that Chlorine gas is stored in pressurized containers and could leak from blast damage.

* Armories—(usually well built)

* Fire Departments

* City and County Buildings—(some have underground tunnels)

* Underground parking garages—(Provides both blast and radiation protection). However, there is danger that buildings could fall and trap you.

* Boats—(Covered boats in a lake provide good radiation protection, but little blast protection. You must have the capability to wash any fallout from the cover.

* State or County Emergency Operation Centers (EOCs)—(usually well-built and stocked)

* Root cellars—(offers better radiation protection than blast protection). Stay clear of the entrance.

What do I really think of this article? Well, don’t ask. I realize that people TRY but the facts are that any such strikes against you are going to be horrendous if you are in the area. So, check out what you can of the area in which you are apt to find yourself. Check around for known possible targets and then prepare as if for a natural disaster such as earthquake or tornado. Obviously, a hole is not going to be the place to find yourself in a flood. USE YOUR GOD-BLESSED BRAINS!

As a big “for instance”, with a boiler running in a boiler room, that is about the last place you would find me or mine.

In a small place like Tehachapi, as example, you can check out the train tunnels, for there are several easily within reaching distance. You will need to go prepared, however, and station guards for any trains also trying to make it to the tunnels.

I also don’t know why you would run to a fire station, as most fire stations are no better equipped for EMPs than are you in a normal house. They might be able to carry you more quickly to a safe place—if YOU know where to go and that is about it except for emergency equipment. They will, however, find themselves without power in a nuclear emergency of EMP cause—so even if there is a generator at ready, it very well will fail until the plugs are wiped and the lines “blown” clear.

I have always advocated going to the lowest place in your house and if you have a basement, keep a bunch of books stacked against the walls or in stacks cordoning off a specific area where you can actually lie down on the floor between the books. If you are fortunate and not at ground zero, then you will likely be able to come “out” within a reasonable time when the debris stops sailing and the radiation moves on.

The point in such instances where you can’t make it originally to a prepared shelter is to stay alive, keep your family alive and then as quickly as possible go to the shelter and stay put for a while. It is important that you have code recognition so that you are not turned away from your own shelter.

It becomes imperative that you recognize the parties involved because you will find everyone who can crawl will end up at your door. Even Noah had to turn away the court jesters. Those who literally mock God and thee, my friends, shall find no place in the inn when the inn is, indeed, full.

I did not make the rules for your dirty little nasty games, my friends. When people will literally STEAL the very life support supplies you have prepared, they have made their choices as to their own chances.

If we get this job finished in time to replace some of those security items, we will do so. Until then, we do the best we can under the circumstances and you back there are certainly welcome to go and retrieve from the thieves that which is yours.

Now, to you who would put forth that we are fear mongers, I suggest you consider again: THIS CAME FROM AN OFFICIAL SOURCE AS DOES YOUR “SURVIVAL” GUIDE INFORMATION. THAT IS DIRECTLY FROM THE U.S. GOVERNMENT. IF THEY EXPECT SOME “ACCIDENTS” TO HAPPEN, THEN SURELY YOU MIGHT WELL EXPECT A FEW.

Check your gear and keep a regular check going so that you have supplies, turn over possible spoiled foods, and make sure you can be as comfortable as possible and stay as well as possible.

You can also see why you will need a supply OF THE BEST ANTIBIOTIC AVAILABLE, COLLOIDAL SILVER. You should have a colloidalizer or two available in case the EMPs cause a “dumping” of the colloid solution. Keep an extra supply of proper batteries available along with some distilled water and a bit of sea salt to better ionize the water solution. People may get hurt or wounded in the scramble and you need something to help keep infections out. A few appropriate splints with wrappings might also be appropriate for broken bones. There might also be burns, so know that silver colloid is the best thing you can possibly spray onto burns.

Do I think you should have some “anesthetic” available? Yes, BUT, if you have no physician and don’t have anything—vodka might well be your best backup to ease the pain of setting a bone or relocating a disjointed shoulder or hip.

A couple of pair of crutches of varying size will also be very handy for making it to the porta-potty so think ahead!

We DID think ahead but in the mess of confusion which “happened” while we made other plans, we have no idea what is available, flooded out or in place. Ekkers even had inflatable splints in the camping gear along with extra sleeping bags and rolls. That was in the garage and moved to nobody-knows-where! You know the tale: “The best laid plans of mice and man.” Well, forget the mice, for they will keep to their trails; man will betray and thief at every opportunity to line his own pockets or nest. Isn’t man a wonderful species?

This may well stand in good stead anyone anywhere but since, as in Tehachapi, the shelters are within identifiable property, etc., then I suggest that no one claim to become the last word in management of who may come and who has to stay out because “I don’t like that person...”. The ones who refuse to go into a shelter

because of such a lame excuse may be the one to stay outside if there be no other objection than your personal preferences as to neighbors.

Those of you who think you can better “organize” than anyone else, have to have your way or no way and/or simply delegate without seeing through a single project—don’t even try, for the impression you make will not be very good under the very best of circumstances. The property is NOT UP FOR GRABS, CHELAS, those days passed with the people who turned away. The rest of you can work very easily and well—together—IF YOU WANT TO.

I think, E.J., you may well be starting to see why “the” ranch is going to have such value. If the world as it is going is not changed, you can look forward to some rather nasty times—right in the old U.S. of A.

With the availability of funding and the availability of motorhomes and RCVs, trailers, etc., we can gather a lot of living space right fast and get generating capability and have a very nice little survival “village”. Supplies will be a problem, yes, but a lot of rather long-lasting items, even canned meats can be put into place and, handled carefully, will go a long way with a root cellar full of potatoes, cabbages and onions—not to even mention beans.

You will want a LOT of Meloream, for it will be the best milk substitute you can get your mittens on and far better for some than a good cow.

Also, you will want to make sure you have a good supply of wheat and spelt and bread-making ingredients. Make sure you have some grinders for that grain—and you can use your bread machines as long as you have power.

I’m sorry, chelas, but I would be remiss if I did not warn you of how it may likely be.

The Roost ranch plateau is high country and is not likely to be flooded out even if Scallion’s map becomes reality—but that does mean probable isolation, so you will want air transportation in and out for supplies, etc. The “building” as had been planned for *Sipapu* with AC was ideal to accomplish these things but we work at a disadvantage with him gone. We can continue the plans as established but we have to reconsider the overall schedule of probable events.

What can Ekkers do from Manila? Very little as is relative to the United States. However, the work will move as quickly as is possible under whatever circumstances we find and that is the best we can offer. If you refuse to think about these things, you will be overwhelmed in the face of the reality, should it strike.

We can speak on these matters later when convenient (if it will ever be convenient)—but we need to get this writing out to the paper so Mark can have some sleep.

God does NOT turn away, students, but when many of our thought-to-be team mates do turn away and actually betray and destroy that which was at ready and waiting, it is difficult to regroup and especially to have heart into any such thing as “survival” needs. The most apt response I get from my people is “who cares?” Well, we DO care and there’s where it’s at! Chapter II provides for participation in UNIDO. Membership is open to all States members of the United Nations or a specialized agency. Article 6 provides for withdrawal from membership, not possible now without withdrawing from the United Nations, subject to providing a reasonable period of notice. The right of withdrawing from UNIDO alone may provide useful leverage, although actual withdrawal would entail a difficult decision.

Chapter III establishes the organs of UNIDO. Article 8 specifies a General Conference composed of all members which will act upon the reports of the Board and the Director-General and determine the guiding principles and policies of the organization. Article 9 provides for the Board to be composed of 53 members elected by the Conference, with the following distribution of seats: 33 members elected from the G-77 (developing countries), 15 members elected from Group B (industrialized democracies) and 5 members elected from Group D (the Soviet bloc). Article 10 establishes a Programme and Budget Committee to consist of 27 members elected by the Conference with the following distribution: 15 from the G-77, 9 from Group B, and 3 from Group D.

Chapter IV delineates the process for approval of the program of work and the regular budget (i.e., the budget expenditures to be met from assessed contributions) and the operational budget (i.e., budget expenditures to be met from voluntary contributions). Article 14 stipulates that the Director-General shall prepare and submit a draft work program, regular budget and operational budget to the Board through the Committee. The Committee will consider the Director-General’s proposals and make recommendations to the Board by a two-thirds majority vote of those present and voting. The Board will examine the Director General’s proposals and the recommendation of the Committee and adopt the program of work, regular budget and operational budget, for submission to

the Conference, by a two-thirds majority of those present and voting. The Conference will approve the submission of the Board by a two-thirds majority vote of those present and voting. The Conference may make no decision or amendment involving expenditures unless the Committee and the Board have had an opportunity to act as indicated above. By commanding more than a third of the votes in the Board and the Committee, the major donor States (i.e., Groups B and D), which share a common desire to keep United Nations agency budgets to a reasonable level, will be able to block work programs and budgets of which they disapprove, if they act together.

Article 15 provides that the scale of assessments for members shall be established by the Conference by a two-thirds majority of the members present and voting, upon a recommendation of the Board adopted by a two-thirds majority of the members present and voting. The Board’s recommendation is to be based on a draft prepared by the Committee. The Constitution thereby provides a mechanism for the major donors as a group to veto a scale of assessments which they disapprove. Article 15 also stipulates that the scale of assessments shall be based to the extent possible on the scale most recently employed by the United Nations and no member shall be assessed more than 25 percent of the regular budget.

Chapter VI covers legal matters. Article 23 provides for amendments, with special, stringent provisions for amendments to financial articles. Financial amendments must be approved by two-thirds majorities of the Board and Conference respectively and must be ratified by three-fourths of the Members States. This provision protects the blocking more than a third of the votes which major donors command in the Committee and the Board.

[H: Remember what I told you—on the UN level, countries of the world are called UN’s “states”.]

Article 25 stipulates that the Constitution shall enter into force when at least 80 States that deposited instruments of ratification notify the Secretary-General of the United Nations that they have agreed, after consultations among themselves, that the Constitution shall enter into force. However, for States that had deposited instruments of ratification but did not participate in such notification, the Constitution shall come into force on such later date as they choose.

The practical effect of the entry into force provisions is that the Constitution will not enter into force without the agreement and participation of major donors, including the United States. Once the Senate has given its advice and consent to ratification, this provision will afford the United States a strong position to ensure that the basic concerns of the United States, such as budgetary restraint, are taken into account.

***[H: Oh, sure! And who else is going to be sick besides ME?]**

Article 27 states that no reservations may be made to the Constitution.

A major problem in the constitutional negotiations was to balance the desire of major contributing countries for control over the regular budget with the insistence by developing countries that funding for technical assistance activities continue to be available on an assured basis.

Under current arrangements, a portion of UNIDO's activities in the field of technical assistance is financed by assessments from the regular budget of the United Nations. Under Annex II of the Constitution, 6% of the regular budget of UNIDO will be set aside for technical assistance activities which have heretofore been financed by assessed contributions to the United Nations budget. The 6% figure sets a constitutional ceiling on the portion of the new organization's regular budget which can be devoted to technical assistance. All other technical assistance activities must be financed by voluntary contributions. Since the United States—together with the other major contributing countries—will have more than a third of the votes in the Board, which must approve the regular budget by a two-thirds majority vote, we will have substantial influence on the overall figure with regard to which the 6% technical assistance figure will be calculated and, therefore, over the absolute amount of technical assistance expenditures from the regular budget.

The combined effect of the 6% ceiling, the major donors having more than a blocking third of the votes, and the withdrawal provisions will provide the United States with much greater capacity than presently exists to ensure that regular budget funds for technical assistance are used for programs which we believe should qualify for such funding. In this connection, the United States representative to the Constitutional Conference placed on the record our view that technical assistance financed by assessments, "must fill gaps which would be difficult for the UNDP, with its country-specific focus, or other voluntary funds to fill. Specifically, such technical assistance would deal with emergency situations and financial activities that primarily benefit the entire international community, not a single country."

There has been growing recognition in UNIDO of the need to achieve a true consensus on development questions if UNIDO is to cope effectively with development problems. At the same time, there has been growing recognition within the United States of the need for the United Nations to be more responsive to our basic programmatic and budgetary concerns, especially in light of the large United States-assessed contributions. The Constitution of UNIDO is a product of both of these movements. It gives an already existing institution a new mechanism of decision-making which provides special recognition of the essential role of major contributors, including the United States. In this way, it is truly a precedent-setting document for the United Nations system which deserves our earnest and rapid support.

The other agencies most concerned, the Department of Labor, the Agency for International Development, and the Department of Commerce, have no objection to ratification of the Constitution. I hope that you will ask the Senate to consider the Constitution and give its advice and consent to ratification as soon as possible.

PREAMBLE

CONSTITUTION OF THE UNITED NATIONS INDUSTRIAL DEVELOPMENT ORGANIZATION

The States parties to this Constitution,

In conformity with the *Charter of the United Nations*,

Bearing in mind the broad objectives in the resolutions adopted by the sixth special session of the

General Assembly of the United Nations on the establishment of a New International Economic Order, in the UNIDO Second General Conference's Lima Declaration and Plan of Action for Industrial Development and Co-operation, and in the resolution of the seventh special session of the General Assembly of the United Nations on Development and International Economic Cooperation,

Declaring that:

It is necessary to establish a just and equitable economic and social order to be achieved through the elimination of inequalities, the establishment of rational and equitable international economic relations, implementation of dynamic social and economic changes and the encouragement of necessary structural changes in the development of the world economy.

*****[H: Regional Government is a component of the structural changes.]*****

Industrialization is a dynamic instrument of growth essential to rapid economic and social development, in particular of developing countries, to the improvement of the living standards and the quality of life of the peoples in all countries, and to the introduction of an equitable economic and social order.

It is the sovereign right of all countries to achieve their industrialization, and any process of such industrialization must conform to the broad objectives of self-sustaining and integrated socio-economic development, and should include the appropriate changes which would ensure the just and effective participation of all peoples in the industrialization of their countries.

As international co-operation for development is the shared goal and common obligation of all countries, it is essential to promote industrialization through all possible concerted measures, including the development, transfer and adaptation of technology on global, regional and national, as well as on sectoral levels.

All countries, irrespective of their social and economic systems, are determined to promote the common welfare of their peoples by individual and collective actions aimed at expanding international economic co-operation on the basis of sovereign equality, strengthening of the economic independence of the developing countries, securing their equitable share in total world industrial production and contributing to international peace and security and the prosperity of all nations, in conformity with the purposes and principles of the *Charter of the United Nations*.

Mindful of these guidelines,

Desiring to establish, within the terms of Chapter IX of the *Charter of the United Nations*, a specialized agency to be known as the United Nations Industrial Development Organization (UNIDO) (hereinafter referred to as the "Organization"), which shall play the central role in and be responsible for reviewing and promoting the co-ordination of all activities of the United Nations system in the field of industrial development, in conformity with the responsibilities of the Economic and Social Council under the *Charter of the United Nations* and with the applicable relationship agreements,

Hereby agree to the present Constitution.

*****[H: By any label, this means "sharing the wealth". I see no alternative other than to pursue this subject in this manner. Regional Government is a component of the structural changes. Futher, you may not know it but in 1945 the U.N. Charter was proclaimed law of the land! Oh, no belief herein?]*****

CHAPTER I

OBJECTIVES AND FUNCTIONS

ARTICLE 1

OBJECTIVES

The primary objective of the Organization shall be the promotion and acceleration of industrial development in the developing countries with a view to assisting in the establishment of a new international economic order. The Organization shall also promote industrial development and co-operation on global, regional and national, as well as on sectoral levels. **[H: And so it goes....]**

NEW WORLD ORDER

Treaty #97-19 IS A CONSTITUTION. They claim to now worry that Saddam will be given a face-saving way to escape a knockout blow and emerge as an even more dangerous Arab hero. New U.S. arms sales to Saudi Arabia and President Bush's meeting with Syria's Hafez Assad add to Israeli disquiet, even more so given the overall chill in U.S.-Israeli relations. (This action is taken in EVERY similar circumstance to fool you the people.) **"The meeting between Bush and Prime Minister Yitzhak Shamir on December 11 should allay some concerns..."**, it is suggested!

Now, I shall ask Dharma to reprint a section from *U.S. News and World Report*:

"... At home, Arab-Israeli enmity is deepening in the wake of the Temple Mount killings and a surge in Palestinian guerrilla attacks along the border. A clampdown on West Bank-Gaza workers entering Israel has, in effect, re-established the "Green Line" separating Israel from occupied Arab land, creating a fresh pool of unemployed and volatile Palestinians. The massive influx of Soviet immigrants threatens to overwhelm Israel's economy. As many as 1 million are expected in the next three to four years, the equivalent of the U.S. absorbing 55 million. Yet so far only 10,000 of 45,000 planned housing units have been started, and even with the latest 5% tax hike **the country will have to borrow as much as \$30 BILLION abroad. Shamir will ask Bush for an additional \$4 BILLION in aid to help cover resettlement costs.**"

"Well", you ask, "Isn't peaceful coexistence within secure borders with Arab neighbors the historic aim of Israel?" No, no and no. The Middle East has been in constant and unholy turmoil since the instant of founding of Israel. This is directly attributable to Israeli policy.

The basis of Israel's foreign policy is the attainment of the dream of *Eretz Yisrael*—Greater Israel—which encompasses most of the present Arab states—and that, dear ones, is a LOT OF TERRITORY! MOST COINCIDENTALLY, THIS TERRITORY ALSO INCLUDES THE GREATEST CONCENTRATION OF MINERAL WEALTH IN THE WORLD—THE OIL FIELDS OF SAUDI ARABIA.

Israel feels its expansionist dream can best be realized by creating total chaos in the Middle East, much as the Serbian nationalists under the domination of the Austro-Hungarian Empire felt that they could achieve

nationhood only in the wake of a total breakdown of the European political landscape. Thus, the assassination of Archduke Ferdinand and the resultant tragedy known as World War I, as we just covered day before yesterday.

Israel cannot, however, yet do it alone and doesn't need to do so. Although mightily equipped for war—thanks to the beneficence of its patron the U.S.—they cannot hope to stand up to the superpower challenge. ***Thus, Israel has turned to a most unlikely ally—THE SOVIET UNION!*** Ah, the plot thickens, does it not?

ULTIMATE WINNERS

Israel and the Soviet Union will be the ultimate winners of any U.S. war with Iraq in the Middle East. ***While it has all but slid by unnoticed during the continuing crisis in the Middle East, as planned, there has been a renewal of friendly relations between Israel and the Soviet Union and considerable diplomatic travel back and forth between Moscow and Jerusalem—and darn it all, you nice U.S. taxpayers pay all the travel expenses FOR BOTH SIDES.***

The content of top-secret Israeli-Soviet talks has been confined to a small circle of insiders with the two governments and the "Friends of a Greater Israel" in Washington. ***But they undoubtedly concern how the Israelis and Soviets will divide the spoils of war between Iraq and the U.S. and the latter's hodge-podge collection of small, ill-trained and ill-equipped "multinational" allies.***

The American public, at least, is becoming a bit confused as to WHY the U.S. would risk the deaths of tens of thousands of its young soldiers in a war with Iraq. The administration has not even defined a reason for confronting Iraq, but has instead offered various conflicting justifications that have left the public even more confused.

The people, however, are becoming a bit aware that the international oil companies and bankers are already greedily lining their pockets with war profiteering—at your own expense.

ISRAEL NO FRIEND

What they don't know is that the two major malefactors in an American war with Iraq—Israel and the Soviet Union—already have plans in place for seizing the oil-rich Middle East for themselves. Now, isn't this just wondrous and puzzling intrigue?

Israel, in cooperation with the Soviet Union, is positioning itself to seize the great Saudi Arabian oil fields in the aftermath of a bloody confrontation which the Israelis are prepared to ignite themselves, if necessary. The sparking of war by Israel would not require any tremendous effort, just as it takes little skill as an arsonist to touch off a blaze in a room filled with gas-soaked rags.

Let there be no mistake, chelas, the Israelis are not friends of the U.S. and have no qualms about killing young American servicemen. THERE IS NO HONOR AMONG SATAN'S SERVANTS, LITTLE SLEEPY-HEADS!

The Israelis have blatantly displayed their treachery on two glaring occasions in recent history.

During the Six-Day War of 1967, Israeli air and naval forces knowingly attacked the American reconnaissance ship, the USS Liberty—remember the story? Thirty-four American sailors were sent to their graves and more than a hundred others were injured and maimed after being bombed, machine-gunned, torpedoed and napalmed. Israeli gunners even shot up their life rafts—please don't be forgetting this.

The Mossad purposely did not inform the U.S. intelligence officials that terrorists planned to bomb the U.S.

Marine barracks in Beirut, Lebanon, in October 1983. As a result, 241 young American Marines were blown up.

So, you see—America still needs a first-strike nuclear holocaust against the Soviets in order to head up this “**New World Order**” without opposition or struggle, for top-level control.

The Mossad has a most active spy operation, known as “EI”, in place in America to steal U.S. secrets and plans—you know, like launching sensor spy satellites and shuttle programs, etc. and to start a war is, indeed, very easy. Let us just consider, what if... : What if a group of Palestinian terrorists (or pretend ones)—say, Israelis dressed as Palestinian terrorists, or a whole group posing as Palestinian terrorists, crosses into Israel from Jordan and perpetrates some terrorist act in Israel. America’s current Arab allies on the front lines would quickly pull out of the fight, considering Israel’s attack in Saudi Arabia a far worse danger than Iraq.

Meanwhile, again, U.S. forces are being horribly shredded by Iraqi forces, who are even now still being supplied and trained by the Soviets (remember those advisers mentioned above?) and making matters worse, America’s supposed Arab allies, such as Egypt and Syria, defect from the “multinational force” due to the Israeli intrusion—it appears that now the Soviets have several options or windows of opportunity.

As weak as the Soviet Union is internally, its army is still numerically superior to the remaining Western forces in Europe (we will also talk of the vulnerability of Europe presently). It no longer needs to fear the forces of NATO, with most of the best U.S. troops and armor having been sent to Saudi Arabia from Europe. Now how could this scenario end? It ends with Israel and the Soviet Union sharing the great Middle East oil fields. The American Army is effectively destroyed—WHICH, BEING IN SAUDI ARABIA—HAS LEFT THE CONTINENTAL UNITED STATES TOTALLY OPEN AND VULNERABLE (COULD YOUR PRESIDENT HAVE ACTUALLY KNOWN THIS?), AND THE SOVIETS WIN THEIR ULTIMATE VICTORY IN THEIR DECADES-LONG STRUGGLE WITH THE U.S., **WITHOUT FIRING THAT PROVERBIAL “SHOT” IN ANGER AT U.S. FORCES.**

Israel, in turn, realizes the ZIONIST dream of Eretz Yisrael, with a hammerlock on the Western world’s major producing oil reserves. The Soviets, already the world’s largest oil producer, realize even greater fortunes and monopolistic power from Middle East oil and achieve their long-sought desire to be linked by land to the Persian Gulf.

And what of the U.S.? Its military is wrecked in the Middle East, its economy in a shambles, and its major source of badly needed foreign oil cut

off, is no longer a major world power.

Congress, completely dominated by the Israeli lobby, will not raise so much as a whimper in protest. The President, his political power cut off at the knees as a result of the U.S. defeat, will be in no position to challenge the resulting status quo (exactly according to plans for the “feet of clay”). GOLD IN THEM THAR HILLS!

Just when you could believe in something—like restoration of a greedy, immoral Sabah family to power in Kuwait—exiled Kuwaitis themselves are not in favor of such a “DEMOCRATIC” ACTION. They have been

meeting in London—these Kuwaiti exiles of prominent status and “DO NOT WISH TO SEE THE FORMER RULING FAMILY REINSTATED”! Ah, so it goes.

By the way, as you were just beginning to believe this “war” invasion of Saudi Arabia might happen to be over oil and other misunderstood reasons, now you have to face another blow. THE SAUDIS HAVE STRUCK IT RICH! You maybe thought they were already rich? (sic sic). In addition to seas of oil—some of which is that nice light crude needing almost no refining—***there is an entire mountain of gold which has just been discovered in the southern part of the Kingdom—well, Kingdom come!*** Could this possibly partially explain this sudden protective urge in the breast of the Trilateral Commission and the deployment of half-a-million American troops in Saudi Arabia?

One more little sock-it-to-ya: ***One of your own Congressional Reports states that the Agriculture and State Departments approved \$5 BILLION in taxpayer (you)-guaranteed crop export credits TO IRAQ between 1983 and 1990 despite concerns it could not repay the loans.*** The General Accounting Office concluded that U.S. desires to build a relationship with that nasty old Saddam and Iraq in days leading up to the Kuwaiti “invasion” outweighed those fears. Iraq has already defaulted on a \$2 BILLION taxpayer-guaranteed loan and certainly has absolutely no intention of repaying this larger one. Well, you dear “bottomless pockets” don’t object do you? After all, you can think of the “hostages” eating while you go hungry wondering what happened to all your grain and dairy storage items—AND YOUR MONEY!

EUROPEAN TRAP

I will herein speak of Europe and possibilities which will also curl your hair even if you are bald as a billiard ball—as I am.

President George Bush has fallen into a fine trap—perhaps the greatest trap ever set in history—and this nice little trap was baited by his key intelligence adviser. It stems from the transfer of those nice NATO troops, some 200,000, to the Middle East.

The two armored divisions and other units being transferred from Germany to Saudi Arabia will leave NATO as naked as the plucked turkey at Thanksgiving—and no head to boot! Europe is wide open to possible attack from the formidable armed forces of the Soviet Union—which they will surely do if the above scenario gets too botched to pull off.

Now just why do you think no one in the White House seriously considered this obvious danger, thanks to the clever manipulations of the President carried out by Robert M. Gates, the deputy director of the National Security Council (NSC)—A MAN LONG KNOWN IN INTELLIGENCE CIRCLES FOR HIS PRONOUNCED PRO-SOVIET BIAS! Could it possibly be that some ones in your administration believe they have a seat on the Board of the Global One World Government? Could you have provided a nice secure ticket for them to be wardens of your U.S. prison?

Dr. Gates is the official who briefs the President every morning on the world situation when he is not traveling with his close friend, Secretary of State James A. Baker III, to Moscow, Paris, London and other capitals of Bush’s “New World Order” allies.

Why do all these other countries, such as Brazil and Argentina, etc., go along with this world takeover? BECAUSE THEY HAVE NOTHING TO

LOSE AND EVERYTHING TO GAIN!

Moreover, Brent Scowcroft, director of the NSC, has left the day-to-day operations of the White House intelligence center squarely in Gates' hands; not that it matters in the least—for Scowcroft is a part of the inside planners, along with Mr. Eagleburger. On top of that, Gates chairs the powerful "Deputies Committee" comprised of his counterparts from the Pentagon, CIA, Mossad and other security agencies.

CONTROL FLOW TO PRESIDENT

In short, Gates controls the flow of intelligence to the President as well as to the Department of State and to key Cabinet-level officials—a nice slot for a devout Communist Zionist, don't you think?

It certainly should come as no surprise to insiders who have been watching Gates for years that the Soviet threat is now almost totally ignored by the Bush administration. The fact that the Red Army is not only still totally intact but far stronger than it has ever been before Gorbachev ascended to power, is quietly and simply brushed aside.

Indeed, the most salient security factor of your time, i.e., that **ONLY THE SOVIET UNION HAS THE STRATEGIC CAPABILITY TO UTTERLY DESTROY THE U.S., IS NOW DEEMED TO BE OF NO CONSEQUENCE IN THE RARIFIED "ONE-WORLD" ATMOSPHERE PREVAILING IN THE WHITE HOUSE.** This is obviously the view of the whole Pentagon as well.

The evidence that Saddam Hussein would never have invaded Kuwait without at least a green light from the Soviets is underwhelming, to say the least. Yet under Gate's guidance the fact that Iraq got four-fifths of its arms from the USSR and couldn't move its 5,000 Soviet tanks and other materiel without assurance the spare parts would keep coming from the Soviet Union, is thought to be irrelevant in the Oval Office.

Also brushed off by Bush and Gates are the thousands of Soviet military advisers in Iraq who are guiding the Iraqi army's every move and manning the deadliest high-tech weapons systems.

Most dangerous of all the USSR's heavy contributions to Iraqi military might is the SS-12, a missile capable of firing both nuclear and poison-gas warheads up to a thousand miles with deadly pin-point accuracy. Under the Intermediate Nuclear Forces "Treaty" signed by the United States and the USSR in 1987, the SS-12 was banned from the face of the Earth—how quaint.

However, this highly accurate weapons system has since popped up in large numbers in Poland, Czechoslovakia and other East European countries and is now reportedly deployed in Iraq. Indeed, the SS-12 was planted solidly in Iraq prior to 1988 when the war with Iran ended.

Although the Defense Intelligence Agency notified the White House of the persistent reports of this SS-12 capability in Iraq, Bush, Gates and their trained seals in the CIA are looking the opposite way from this dangerous development.

Bush has now doubled the size of the American forces in the Middle East while espousing that the Soviets are our blood-brothers having "changed their leopard spots". The Soviets are now your beholden "friends and allies". It would appear to me that there is great suffering from acute myopia induced by Gates, Baker, etc., etc., etc. The President seems to perceive

absolutely no danger to Europe what-so-ever—how could this be? **Could it be that he is consumed by his ethereal vision of the New World Order? Or, does he know more than you know—and it isn't a "vision" problem at all!** The world is set for total take-over—BUT, **THE PRIME MOVERS AND SHAKERS HAVEN'T TOTALLY SHAKEN EACH OTHER DOWN, YET!!**

VISION!

Blind? Mr. Bush blind? I seriously doubt that, dear ones. But, has no one dared point out to Bush that it was this same insane vision that broke the presidency of Woodrow Wilson as he played into the hands of the Bolsheviks then taking over Russia?

Is there no one on Bush's staff who can remember that this identical vision of a world ruled by the United Nations led Franklin Roosevelt, then under the influence of Alger Hiss and other pro-Soviets, down the primrose path to Yalta and the surrender of Eastern Europe and eventually mainland China to Communism?

With more than half a million Americans in the Saudi desert and on their way from Europe, this has the makings of a mammoth trap—perhaps a BEAR TRAP?

WHAT IF THE BATTLE HAPPENS?

If Bush commits these forces to battle, as now would seem totally likely, what would prevent the Soviet army from moving right through their ally, Germany and France, to the English Channel in the "10 days" Gen. Nikolai Ogarkov allotted in the master plan drawn up in the mid-1980s and still preached in Soviet military circles? Oh, son-of-a-gun, you didn't know about THAT plan?

So be it, the answer, of course, is ***NOTHING!***

Let us look a bit more closely at this man, Gates.

He is a consummate con man and has gulled Bush as completely as he did his late boss CIA Director W. Casey and, through Casey, President Ronald Reagan.

By simply telling them what they want to hear and constantly leaking prepared stories to the press, Gates has persuaded both conservative and liberal columnists he is a "hard-liner" adamantly opposed to the Soviets and suspicious of *glasnost*.

But the quality of the "intelligence" Bush now receives on a daily basis from Gates may be better judged by several tidbits in the closely held dossier several officials have been keeping on Gates.

As CIA's deputy director for intelligence, Gates helped sell Casey and Reagan on Israel's wacky plan to exchange U.S. arms with Iran for the release of American hostages in Lebanon—the nutty idea that tempted Reagan to tiptoe into the Iran-"Contra" morass.

Just before becoming Casey's No. 1 deputy on April 18, 1986, Gates leaked two top-secret intelligence estimates to the *Washington Post*. The first was aimed at helping the liberal Democrats in Congress to drastically cut the Reagan defense budget; the second tried to shoot down, and essentially succeeded in shooting down, Reagan's Strategic Defense Initiative (SDI), commonly called "Star Wars". *As reported by the Post on March 31, 1986, the first estimate claimed that Soviet military spending had been "almost flat for a decade" and might even "decline during the next five years".*

Of all the fiction fed to your presidents in weird "national intelligence estimates" over the years, this particular concoction of Gates must take the prize.

Indeed, all the evidence, then as now, proved conclusively that the USSR had been engaged in the greatest military buildup in history—a buildup that ominously continues to this very day. The second blast from Gates less than a week later was intended to cripple SDI. This "intelligence" estimate claimed the Soviets had *NOT* violated the Anti-Ballistic Missile (ABM) Treaty. But three years later the Soviets themselves freely admitted they *HAD* violated the ABM agreement, just as they have violated nearly 200 other solemn agreements made with the U.S. and the West.

U.S. deployment of SDI hangs on the issue of observance of the ABM Treaty. Gates' target in trying to defend Soviet claims that they were not in violation is certainly obvious. Tragically, he scored a perfect bull's-eye.

In fact, this single leak from Gates' fiction factory at CIA cast such doubt on Pentagon reports of Soviet ABM violations that many consider this the major reason America still has no viable defense against Soviet ICBM's or the short-range missiles poised aboard the Soviet submarines lying in wait off both your East and West Coasts—a combined force capable of killing every man, woman and child in the U.S. in a matter of mere minutes. As you might have guessed by this point, Gates has served both the KGB and the Mossad. Further, it was Gates, behind the scenes, who led the fight waged in favor of permitting your NATO allies to accept the Soviet oil and natural gas pipelines to Western Europe. Now completed, except for one strand, the pipelines tie the economies of France, Germany and a half-dozen other, smaller European countries to the Soviet Union like an umbilical cord.

Gates' many coups on behalf of the Soviets began when he joined the CIA in 1966, fresh out of Indiana University, where he had picked up an MA in history after being at William & Mary. In 1974 he got his Ph.D. in Russian and Soviet history from Georgetown University while working at the CIA. And in the same year (1974) Gates transferred to the staff of the NSC, then under the iron thumb of none other than the Great Detentist, ***HENRY KISSINGER!***

MENTOR KISSINGER

Kissinger became Gates' mentor. The younger man did his job at the NSC so well—as Presidents Nixon and Ford cozied up to Brezhnev—that he was kept on at the NSC by Jimmy Carter. In January 1980 he went back to the CIA as the national intelligence officer on the Soviet Union—and two years later he was appointed CIA deputy director for intelligence in charge of all the national intelligence estimates prepared for the President.

A short, husky, boyish-looking operator, Gates has made a whole career out of ingratiating himself with the older men who have been his superiors. He completely mesmerized Bill Casey, who came to look upon Gates as his son.

Gates fed Casey the anti-Soviet hard-line the CIA director thrived on. In the spring of 1986 Gates was promoted to the powerful post of overall deputy director of the CIA.

When Casey's health collapsed after the Iran-Contra scandal broke, Reagan nominated Gates to be the new director of CIA. The liberals rejoiced and the *Post* and the *New York Times* hailed Gates' appointment.

With powerful Democratic senators backing him, Gates' confirmation appeared assured. But several

conservative Republicans on the Senate Intelligence Committee were given the file on Gates. Almost overnight, support for Gates moving up to director of the CIA caved in, and Reagan was persuaded to withdraw the nomination—however, no publicity was released of negative nature and the subject was instantly hushed.

Gates was kept on as deputy director. William Webster, who had been appointed by Jimmy Carter to head the FBI, was named director of the agency, and he apparently was as completely taken in by Gates as Casey before him.

When Bush became president he picked Scowcroft to head the NSC, a post that required Senate confirmation. Gates was named deputy director of the NSC, a job that sidestepped the painful confirmation process in the Senate which had so recently thwarted Gates' promotion to the top post at the CIA.

In the Bush White House, Gates has presided over the accelerated disarmament of U.S. and NATO forces. The conventional arms treaty which was signed in Paris on November 19 is Gates' biggest coup to date.

Thus, now having helped strip NATO naked, Gates is free to concentrate on steering Bush into the Middle East trap.

If the Soviets do make their move in Europe when the huge U.S. force is nailed down in the Iraqi desert, Gates may well go down in history as the rook that helped the Soviet Union checkmate the United States of America. So be it for one little Robert M. Gates—ah, the web is tangled, indeed!

MARC RICH AND THE JEWISH QUESTION

So far there have been no reports of an upsurge of anti-Semitism in New York, following the row over pardons Bill Clinton granted to Marc Rich and his partner Pincus Green, and the clemency that the former American president extended to a group of residents of the Hasidic town of New Square in New York State. Nonetheless, some American Jews fear such a development, and the fears may be as significant as any likelihood of it coming to pass.

This affair has already raised questions regarding some commonly accepted American assumptions, such as the perception of American Jews being integral members of American society, and Jewish moral values. If certain unpleasant affairs involving European Jews are factored in, the overall picture ties in directly with Israel.

This is not just because its outgoing prime minister, Ehud Barak, was one of those senior Israeli leaders who requested a presidential pardon for Rich, and not just because a large portion of the funds from the Sentier affair (124 merchants from the Paris textile district are accused of defrauding several banks) was transferred to Israel. All of these scandals shed light on the nature of the moral values prevailing in the corridors of power in Israel.

The list of persons who received a presidential pardon from Clinton includes many who are not Jewish and who have committed crimes no less serious than those committed by the Jews the president pardoned. For example, there is drug dealer Carlo Vignali of California on whose behalf distinguished Hispanic American leaders—including a cardinal of the Roman Catholic Church—intervened. Nevertheless, in contrast with American Jewry, there have been no reports of any stormy reactions among Hispanic Americans regarding the pardon-clemency affair.

Perhaps this alone is cogent proof that among American Jewish leaders there is greater sensitivity to the issue of ethical behavior, yet the above fact certainly indicates that American Jews in general are more sensitive than the members of other ethnic groups in the United States to their status in American society as a whole.

The reaction of American Jewry to this affair unquestionably points to the welcome fact that the Jews of the U.S. have a heightened awareness to the danger inherent in the kind of stereotypes that the Rich affair and other such scandals can spawn—the Jew who makes big bucks in all kinds of shady business deals, the Jew who tries to circumvent the laws of the land, and the Jew who manages to escape the long arm of that law.

In Europe too—even in Germany—people have already begun to speak openly of white-collar crimes committed by Jews, and this kind of talk is not limited to anti-Semitic elements. The pretext for this no-punches-pulled approach is the “argument” that all such talk of Jewish white-collar crimes was considered taboo in the shadow of the Holocaust.

However, the change in climate cuts both ways—the behavior of Jewish settlers and Israeli soldiers in the territories has severely dented Israel's image in the eyes

of communities where Diaspora Jews live today. Then the offenses committed by heavyweight Jewish criminals have tarnished the name of Israel, which is already known for magnanimously handing out Israeli citizenship to any Jew anywhere in the world—from Paris to Lima.

The list of Rich's supporters reads like a who's who in Israel's political, cultural and social hierarchy. More and more people are accusing Israel of being an open-door asylum for Jewish criminals. “Israel, criminals' paradise” was the headline French television gave to the exposé of the Sentier scandal. Israel heads the list of money-laundering countries that has been compiled by the American authorities.

One of the most embarrassing aspects of the Rich affair is the fact that Rabbi Irving “Yitz” Greenberg, who heads the governing council of the U.S. Holocaust Memorial Museum in Washington, was one of those who sought a presidential pardon for the millionaire. To make such a request on the official letterhead of the Holocaust museum was tantamount to stating, whether deliberately or unconsciously, that the six million Jewish victims of the Holocaust stand behind the request. The many reports that Israel was involved in Rich's deals with North Korea and in his purchases of oil in Iran have certainly done nothing to enhance Israel's name among Americans as a whole.

Harsh criticism is being voiced on the pardon-clemency affair from the Jewish right, which has never been happy with the massive presence of liberal Jews in the Clinton administration. Typical of the reactions from the right-wing Jewish camp is the article by Thomas Lipscomb, a former editor of *Times Books* and currently a senior high-tech executive in New York: “The dirty little secret no one ever seems to want to discuss is that for eight years the Clinton Administration itself was primarily funded and supported by liberal Jews.... We have allowed ourselves to be blackmailed into silence by the notion that criticizing liberal, irreligious Jews for the errors they commit must be avoided lest one be condemned for ‘anti-Semitism’ or as a ‘self-hating Jew’.”

Reacting to Clinton's explanations of his motives for granting a pardon, noted *New York Times* columnist William Safire has written that arguing “the Israelis made me do it” only whips up anti-Semitism.

It is difficult to imagine that statements like these from its friends in the U.S. will benefit Israel in its future contacts with the White House's new resident, President George W. Bush.

One of the most vitriolic comments has come from Rabbi Eric Yoffe, who heads the Reform movement's Union of American Hebrew Congregations. Rabbi Yoffe has defined the requests made by rabbis on Rich's behalf as sacrilege.

When rabbis are sent to prison for fraud, and when other rabbis seek a presidential pardon for them or for big donors to the Democratic Party, the matter cannot be considered merely an internal American Jewish issue—especially if one of Israel's chief rabbis and the rabbis of Israeli cities are among those who have signed requests for such a pardon. Jews are entitled to ask these rabbis, “Who has authorized you to speak on our behalf?”

Israelis are so immersed in their own problems right

now that they are unable to spare any time to worry about the fact that their country's name is becoming synonymous with money-laundering. A direct line—even if, at times, invisible—can be drawn between rabbis who steal money destined for Holocaust survivors in New York, and the Sentier affair and Rich's pardon-lobbyists in Jerusalem.

Israelis should ask the mayors of their cities why they show no concern for the sources of donations they welcome to their municipalities. Israelis should ask the outgoing prime minister why he did not consider the impact of his pardon request on Israel's image and on the relationship between Israel and America's Jews, who are very sensitive to what their non-Jewish neighbors have to say about them.

Israelis should also ask themselves what kind of value system they uphold if, in their own country, cabinet ministers, the heads of major academic institutions, representatives of culture and senior rabbis can become lobbyists for a person who is suspected of having grossly sidestepped the laws of the world's leading democracy and Israel's best friend.

[JR: Jews are a minority worldwide and yet their influences are everywhere... in our governments, our laws, our businesses, our banking and our economies. The Jewish people need to ask why the Zionists who control Israel and now our government do not respect the laws and rights of others. We non-Jews are forbidden to question or criticize Jews because we will be labeled anti-Semites and then prosecuted under our new hate-crime laws. The Jews elected Sharon because he is known to do whatever it takes to keep Israel safe and secure from her enemies. The pardon of Mark Rich and Israel's influence in his and others' pardons reflect this attitude. The world must be made safe for all people and not just the Jews. This article in an Israeli paper asks the questions, presents the facts and makes no excuses. It's a beginning.]

ZAPATISTAS SHUN CONGRESS PLAN FOR TALKS ON RIGHTS BILL

Mexican rebels accuse hardline politicians of stalling talk with them on the constitutional recognition of the rights they demand

The Zapatista rebels have rejected a proposal for opening talks with Mexico's National Congress on the constitutional recognition of indigenous rights they demand.

Subcomandante Marcos said a plan for a 20-strong commission of deputies and senators to meet Zapatista commanders in the upper house of congress was "humiliating, undignified and ridiculous". He insisted that the rebels should be allowed to address both houses from the congressional podium.

"We will not accept a shaming dialogue with the legislative power, limited to a corner and with a reduced number of legislators," Marcos said.

The offer was made by the congressional peace commission after Marcos and 23 other Zapatista leaders made a triumphal entrance into the centre of the capital on Sunday after a two-week march to demand constitutional rights for the 10m indigenous people.

But Marcos accused congressional "hardliners" of pressurising the peace commission in an attempt to sabotage the negotiating of an end to the conflict in

Chiapas state that began when the Zapatistas staged an armed uprising on New Year's Day, 1994.

The Zapatistas' disappointment with the commission was such that they would now bypass it and seek direct talks with the leaders of the congressional party blocs, he said.

The commission yesterday called a closed-door meeting to decide how to respond to the rejection of its offer.

Next month, the congress is due to discuss an indigenous rights bill elaborated from partial peace accords signed in February 1996. Those accords were shelved by the previous administration of President Ernesto Zedillo, prompting the Zapatistas to abandon the negotiations and return to their jungle bases in the southern state.

Mexico's new president, Vicente Fox, dusted off the bill and sent it to the legislature as soon as he took office last December, raising hopes for peace and prompting the rebels to organise their unarmed march on the capital.

Marcos has announced that the rebels will not leave the capital until the congress approves the bill. He says approval is a non-negotiable condition for starting peace talks.

The Zapatistas also insist on the release of all their jailed supporters and the withdrawal of three military bases near their strongholds. They reject as inadequate the dismantling of four bases and the partial prisoner release programme Mr. Fox has ordered so far.

But the key issue is the bill. Despite the government's support and a groundswell of national sentiment in the measure's favour, the congressional situation is tricky. No single party has a simple majority and several appear split on the bill.

The law would grant indigenous communities significant autonomy in the way they run their communities, and enshrine their right to live by traditions that differ from traditional Mexican forms of authority. Election decisions involving indigenous communities, for instance, would be taken collectively and not individually.

Some prominent members of Mr. Fox's National Action Party have expressed concerns that this could threaten national unity and undermine individual rights, pointing to the secondary position of women in several of Mexico's dozens of indigenous groups.

The rebels have never represented a serious military threat, but their national and international appeal is such that the previous government opted not to attempt a politically costly eradication campaign and instead followed a containment policy aimed at eroding their popular support.

Mr. Fox is impatient for a peace accord that would improve Mexico's image abroad in the wake of his defeat of the 71-year-old regime of the Institutional Revolutionary Party.

He has welcomed the Zapatista march on the capital as a sign that peace is just around the corner, but the early hitch in the congressional talks will make him think again.

[JR: Mr. Fox might have to lobby the Mexican National Congress to pass the indigenous rights bill if he wants to maintain his "for the people" international image. 38 CHILDREN KILLED MAKING FIREWORKS AT CHINESE SCHOOL

Communist Party officials were being protected by police last night after a huge explosion tore through a Chinese primary school where pupils were being forced to make fireworks to pay their school fees.

At least 42 children and teachers were killed, and many more suffered terrible burns. Pupils as young as eight were told to manufacture firecrackers by hand by corrupt teachers, Communist officials and businessmen in the southeastern province of Jiangxi, the families of victims said yesterday.

Unconfirmed reports said four teachers, one of them a woman, and 38 children were either killed by the blast or were crushed when the two-storey Fanglin village primary school collapsed.

Mrs. Deng, a farmer from Fanglin, in the remote county of Wanzai, said her 11-year-old son, a grade three pupil, was killed in the explosion. A weeping Mrs. Deng said in a telephone interview: "They made the children do this work. I heard that the school authorities were working in collaboration with a private firecracker factory. I don't know whose it was. Village officials were also involved. They knew all about this."

Mr. Zheng, the uncle of another pupil at the school, said last night that several village officials were taken into protective custody at the local police station after attacks by enraged villagers. One senior official was beaten up after he apparently joked that the deaths of so many village children would help him to meet family planning targets.

Paramilitary officers from the People's Armed Police were drafted into the area. Last year a neighbouring county was the scene of very large rural protests involving some 10,000 villagers outraged by excessive taxation and official abuses.

Mr. Zheng accused a 46-year-old teacher of being the ringleader of the operation, in which pupils earned their school fees by fitting fuses to illegal fireworks. Education is not free in China, and many rural families struggle to pay fees.

Mr. Zheng, whose nephew survived the explosion, said: "There is a man called Ding who teaches at the school and his relative has a fireworks factory. After getting permission from the school authorities, he made the little children help to fit the fuses. Ding died in the explosion."

Mr. Zheng, who lives in the neighbouring village of Duanyuan, said that parents at the school—which had about 300 pupils—knew about the work. "But the families are very poor and they need money to pay the school fees," he said. "They didn't think it was so dangerous..."

A report on the Chinese Internet news site *Southern Net* said yesterday that the headmaster and teachers at the school received commission on every firecracker made by their charges. Several schools in Wanzai County had been collaborating with local firework factories since 1998, and pupils were openly put to work in classrooms, according to the Internet site, which carried a photograph of the ruined school.

A doctor working at the Tanbu township hospital, where many of the injured children were taken, told the French news agency *Agence France-Presse* that 45 third-grade pupils, aged between eight and nine, were putting the fuses into firecrackers in their classroom when the blast occurred.

"The third-grade pupils were working on firecrackers in their classroom on the first floor," said the doctor, who

asked to remain anonymous. "In the third-grade classroom there were 45 pupils. Only two or three are still alive." **[JR: There is much poverty and want in China where the U.S. \$30 billion monthly trade payments have not improved life for the masses in the rural areas. You can fault the greedy Chinese officials for callous regard of human life, but look to what is also happening in the Middle East, So. "CIA WORKED WITH PAK TO CREATE TALIBAN"

The Central Intelligence Agency (CIA) worked in tandem with Pakistan to create the "monster" that is today Afghanistan's ruling Taliban, a leading U.S. expert on South Asia said here.

"I warned them that we were creating a monster," Selig Harrison from the Woodrow Wilson International Center for Scholars said at the conference here last week on "Terrorism and Regional Security: Managing the Challenges in Asia."

Harrison said: "The CIA made a historic mistake in encouraging Islamic groups from all over the world to come to Afghanistan." The U.S. provided \$3 billion for building up these Islamic groups, and accepted Pakistan's demand that they should decide how this money should be spent, Harrison said.

Harrison, who spoke before the Taliban assault on the Buddha statues was launched, told the gathering of security experts that he had meetings with CIA leaders at the time when Islamic forces were being strengthened in Afghanistan. "They told me these people were fanatical, and the more fierce they were the more fiercely they would fight the Soviets," he said. "I warned them that we were creating a monster."

Harrison, who has written five books on Asian affairs and U.S. relations with Asia, has had extensive contact with the CIA and political leaders in South Asia. Harrison was a senior associate of the Carnegie Endowment for International Peace between 1974 and 1996.

Harrison who is now senior fellow with The Century Foundation recalled a conversation he had with the late Gen Zia-ul Haq of Pakistan. "Gen Zia spoke to me about expanding Pakistan's sphere of influence to control Afghanistan, then Uzbekistan and Tajikistan and then Iran and Turkey," Harrison said. That design continues, he said. Gen. Mohammed Aziz who was involved in that Zia plan has been elevated now to a key position by Chief Executive, Gen. Pervez Musharraf, Harrison said.

The old associations between the intelligence agencies continue, Harrison said. "The CIA still has close links with the ISI (Pakistan's Inter-Services Intelligence)."

Today that money and those weapons have helped build up the Taliban, Harrison said. "The Taliban are not just recruits from 'madrassas' (Muslim theological schools) but are on the payroll of the ISI (Inter Services Intelligence, the intelligence wing of the Pakistani government)." The Taliban are now "making a living out of terrorism."

Harrison said the UN Security Council resolution number 1333 calls for an embargo on arms to the Taliban. "But it is a resolution without teeth because it does not provide sanctions for non-compliance," he said. "The U.S. is not backing the Russians who want to give more teeth to the resolution."

Now it is Pakistan that "holds the key to the future of Afghanistan," Harrison said. The creation of the Taliban was central to Pakistan's "pan-Islamic vision," Harrison said.

It came after "the CIA made the historic mistake of encouraging Islamic groups from all over the world to come to Afghanistan," he said. The creation of the Taliban had been "actively encouraged by the ISI and the CIA," he said. "Pakistan has been building up Afghan collaborators who will sustain Pakistan," he said.

[JR: It seems Mr. Harrison's past work at the Carnegie Foundation (think tank) has served him well, given his contacts with the CIA and his easy access to leaders in South Asia. Who better to gauge the progress on how well our plans are progressing to bring discord and dissension to that volatile part of the world. The spread of the Taliban's brand of religious fundamentalism created unstable conditions in the Middle East and in the independent Muslim republics in Russia. Our CIA is too often right in the center of it all, supplying the arms, weapons and the money.]

KOSOVO A HAVEN FOR DRUG SMUGGLERS

PRISTINA, YUGOSLAVIA (*UPI*)—International drug enforcement agencies say that the war-torn Kosovo province of Yugoslavia has turned into a narcotic "smugglers' paradise".

Huge quantities of drugs arrive in Kosovo, which has become a major transit point for the dealers supplying illegal drugs to Europe and North America.

According to rough estimates by the international drug agencies, nearly 40 percent of the heroin that is sold in Europe and North America comes through Kosovo. The province has emerged as one of safest routes for the drug peddlers supplying the Western nations.

The United Nations Mission in Kosovo is aware of the province turning into a haven for smugglers with safe houses used both by the Albanian guerrillas and smugglers along Kosovo's borders.

A report on the UNMIK Web site states that the province seems to be on the main route for heroin flowing through some of the world's most troubled regions—Afghanistan, northern Iraq, the southern states of the CIS, Azerbaijan and Turkey.

"With the post-conflict situation and law enforcement institutions still building up their structures, we can expect the Kosovo narcotics business to grow," the report said. "It is not an easy task to combat organized crime in the region."

Within Kosovo, the smugglers are very well organized. A few clans and families control the narcotic trade. "It is almost impossible to get information about their operations. We have not been able to establish a network of informants to gather details of their operations," a senior UN Civpol officer said, requesting anonymity. The UNMIK police force that is responsible for controlling crime in the region has no special unit to combat the drug menace. "We do not have enough resources to establish special units to deal with this problem. Our focus has been on maintaining law and order, as well as preventing clashes between Serbians and Albanians," the officer said.

But CIVPOL, NATO's KFOR peacekeepers and the Special Police Unit had limited success during a joint operation conducted a month ago to flush out some

drugs from a house in Pristina.

"It is just the tip of the iceberg. We have information that the trade is much larger than what we know of," the officer said.

The instability and the uncertainty have led to a rise of drug users in the region. Civpol officers say that drugs are openly available in the city in small plastic packets weighing between ¼ grams to 1 gram. Each packet is marked according to the weight.

UNMIK Civpol in the Gnjilane region of Kosovo has identified a series of petty thefts committed by youth to support their drug habits. The Civpol is attempting to establish a de-addiction and rehabilitation center for the drug addicts in the area.

"Drug use has helped the smugglers get enough youth to become carriers for their consignments. We suspect that drugs are smuggled into Kosovo from Albania, which is known as a center for narcotic substances in Europe," a UN official said.

[JR: The UN has been aware of the drug smuggling in this region long before its so-called liberation of Kosovo. Why else would the U.S. and NATO maintain a presence there if it wasn't to protect the drug routes and to protect the rich mineral resources which have been taken over by foreign interests. We've occupied Kosovo over three years now and already we have to build drug rehab centers for the young addicts. Rack up another success story in the promotion of American brand of culture and demonocracy.]

Confusion over border

raises questions about mission, history

PRISTINA, YUGOSLAVIA (*AP*)—U.S. peacekeepers made their way to the edge of Kosovo's border with Macedonia on Thursday—a move that places them in the midst of a new Balkan conflict—after ethnic Albanian rebels fled one of their strongholds.

Ethnic Albanian villagers said the Americans crossed into Macedonia to take over positions held by the rebels, who have been battling Macedonian forces.

U.S. officials denied those assertions but acknowledged that there is confusion about the border.

The controversy over the Americans' location underlined the danger that U.S. soldiers may become more involved in border disputes and the deep-seated historical animosity between Albanians and Slavs.

In another move that could anger ethnic Albanians, NATO agreed Thursday to allow Yugoslav forces to help prevent ethnic Albanians in Macedonia from crossing into Serbia, Yugoslavia's main republic.

U.S. peacekeepers took over a hillside elementary school being used as a base for ethnic Albanian insurgents fighting Macedonian troops, cutting off a key supply base for rebels in northern Macedonia. U.S. officials said the school was in the Kosovo village of Mijak.

U.S. Brig. Gen. Kenneth J. Quinlan, commander of the U.S. peacekeeping contingent, said his troops "were very careful to delineate this border between us and Macedonian authorities."

But residents said the school was in Tanusevci, Macedonia.

"I've been living here for more than 50 years, and this place was called Tanusevci, and this is Macedonia,"

said Bajram Sinani, as he showed his Macedonian identification card and Macedonian currency.

Also Thursday, ethnic Albanian rebels ambushed a Macedonian police convoy near the border village of Brest, which was evacuated earlier by the insurgents. At least one officer was killed, said police spokesman Stevo Pendarovski.

The Americans are part of a multinational effort to curb the flow of weapons and fighters from Kosovo into northern Macedonia.

The present border between Macedonia and Yugoslavia was decided only last week. For a decade, the placement of the border remained the only unresolved issue between the two countries after Macedonia's peaceful split from the former Communist-run Yugoslavia in 1991.

After Yugoslav President Slobodan Milosevic was ousted in October, the new president, Vojislav Kostunica, and Macedonian leader Boris Trajkovski agreed to resolve the dispute.

The deal was ratified in Macedonia's parliament last week despite protests that Kosovo's ethnic Albanians had not been consulted.

[JR: A whole lot of things are going on in this UN-controlled country called Yugoslavia. Bosnia wants their own government and Belgrade wants to try Milosevic in their own courts despite U.S. threats of sanctions. CROATS VOTE TO SECEDE FROM BOSNIA

The biggest threat to the structure of the peace treaty which ended the bloody carnage in Bosnia was delivered yesterday when a rebel assembly of Bosnian Croats voted to unilaterally secede from the precarious federation which Croats in Bosnia pledged to share with Muslims at the Dayton treaty of 1995.

The language of the communiqué that followed a congress of the party affiliated to the late Croatian president, Franjo Tudjman, bears all the hallmarks of that which sparked the wars that tore ex-Yugoslavia apart, and especially that between the erstwhile Croatian and Muslim allies, which it echoes exactly.

In the still divided and symbolically charged city of Mostar, with a rain-drenched crowd of thousands cheering outside, the Bosnian branch of Dr. Tudjman's HDZ party resurrected their wartime demand for autonomy, setting themselves on a collision course with Western leaders and ratcheting up the rising tension in the Balkans by yet another notch.

Ante Javelic, leader of the dominant HDZ in Bosnia, said that unless electoral changes were made to the federation's constitution and electoral system within 15 days, the Croats would form their own "inter-cantonal" system of government—effectively ripping up the Dayton treaty, spurning the Sarajevo government and returning to the demands of the Bosnian Croat army that fought the Muslims throughout 1993.

Both the language and tactics of the announcement exactly echo some of the darkest days of the Bosnian war.

Javelic's sudden proclamation also coincides with a revived hard-line nationalism within Croatia and mass demonstrations in the coastal port of Split, with tens of

thousands protesting against arrests by The Hague tribunal of leading figures under president Tudjman's regime.

The electoral changes the HDZ seeks are those which draw constituency lines irrespective of ethnicity, which dilutes the power of nationalist parties and favours reformist and multi-ethnic ones.

Mr. Javelic said the threat of self-rule was a "temporary" one, but that the party—which dominates the Croatian area of Herzegovina—had in mind to rewrite Dayton to organise Bosnia into a canton system based around the three ethnic groups. The council would assume legislative, judicial and executive powers.

Western diplomats indicated yesterday they would not tolerate the Croatian plan. One U.S. State Department official who has monitored Bosnia for a decade said: "It looks like the wheels are turning again. It just cannot and will not happen."

Wolfgang Petritsch, the West's top peace overseer in Bosnia vested with sweeping powers, told Bosnians in a personal message on Friday that he would not tolerate "activities aimed at undermining the legal institutions". Those engaged in illegal activities would be liable to sanctions, he added.

The Croatian daily *Vecernji List*, quoting an unnamed Sarajevo-based Western diplomat, said the West was preparing a set of stiff sanctions, including a ban on foreign investment in Croat territories, closure of foreign companies' branches there and a block on the accounts of HDZ-controlled companies.

[JR: The discord that invited the U.S. and NATO intervention into the affairs of Bosnia was due to the IMF's policies that added to the economic instability of the region, which re-ignited the ethnic hatreds within the region that led to the violence. The breakup of the sovereign state of Yugoslavia was planned by the Reagan administration in 1984 and was finalized by the Dayton Accord in 1994. This accord set up a colonial form of government run by foreign "outsiders" which excludes its citizens from having any say in their own affairs. The threats by the U.S. to impose sanctions (preferred tool for genocide) are to protect the IMF and foreign interests that now control this area. The people want their country back and we are going to see to it that that never happens.]

EURO-COURT OUTLAWS CRITICISM OF EU

The European Court of Justice ruled yesterday that the European Union can lawfully suppress political criticism of its institutions and of leading figures, sweeping aside English Common Law and 50 years of European precedents on civil liberties.

The EU's top court found that the European Commission was entitled to sack Bernard Connolly, a British economist dismissed in 1995 for writing a critique of European monetary integration entitled *The Rotten Heart of Europe*.

The ruling stated that the commission could restrict dissent in order to "protect the rights of others" and punish individuals who "damaged the institution's image and reputation". The case has wider implications for free speech that could extend to EU citizens who do not work for the Brussels bureaucracy.

The court called the Connolly book "aggressive, derogatory and insulting", taking particular umbrage at the author's

suggestion that Economic and Monetary Union was a threat to democracy, freedom and "ultimately, peace".

However, it dropped an argument put forward three months ago by the advocate-general, Damaso Ruiz-Jarabo Colomer, which implied that Mr. Connolly's criticism of the EU was akin to extreme blasphemy, and therefore not protected speech.

Mr. Connolly, who has been told to pay the European Commission's legal costs, said the proceedings did not amount to a fair hearing. He said: "We're back to the Star Chamber and Acts of Attainder: the rights of defendants are not respected or guaranteed in any way; the offence of seditious libel has been resurrected."

Mr. Colomer wrote in his opinion last November that a landmark British case on free speech had "no foundation or relevance" in European law, suggesting that the European Court was unwilling to give much consideration to British legal tradition.

Mr. Connolly now intends to take his case to Europe's other court, the non-EU European Court of Human Rights in Strasbourg.

[JR: The Eurocratic little gods in Brussels fear men of conscience like Mr. Connolly because he dares to criticize ("extreme blasphemy") their plans and the motives behind them. RUSSIA'S ORTHODOX CHURCH MOVES TO CENTER STAGE IN STATE AFFAIRS

MOSCOW (*Agence France Presse*)—The Russian Orthodox Church, confined to the margins during the long years of Communist rule, has returned to the center of the country's public life with the blessing of the Kremlin.

Since Vladimir Putin invited Patriarch Alexis II to bless his accession to the presidency in March last year, Orthodox Christianity has increasingly assumed the role of a state religion, with even its former adversaries in the intelligence services and the opposition Communist Party welcoming the trend.

No major event is complete without robed Orthodox priests lending their presence, blessing troops on their way to Chechnya, naming Saint Matthew as the patron saint of tax inspectors, or providing a spiritual dimension to the laying of the foundations of a new airport.

Two out of three Russians say they regard the church as one of the country's most trustworthy institutions, along with the army and the intelligence services, according to a survey by the ROMIR opinion poll institute.

"Since Putin took office, the church has played an ever increasing role in Russia's political life," the institute said in presenting its findings last January.

The ex-spy, a veteran of the former KGB, has declared himself a firm believer, revealing that his mother had him baptized and that he always wore a cross that she gave him.

He has been attentive to the church's leading

personalities, frequently meeting the patriarch, sending his personal regards to its most respected spiritual leader, the “starets” Ioan Krestyankin, and decorating priests for their “contribution to the rebirth of spiritual and moral traditions” in Russia.

“The state authorities are using the church to fill the ideological void” that has followed the collapse of Communism, commented Yury Korgonyuk of the Indem Foundation political research center.

The church in turn has proved a willing partner in patriotism, providing the Kremlin with spiritual support in backing the war in Chechnya or in denouncing United States or NATO operations in the Balkans and elsewhere.

It appears best placed among Russia’s institutions to lend a sense of direction to the national rebirth that is Putin’s ultimate objective.

Having already recovered many of the churches and monasteries that were confiscated by the Communists, the church now hopes the state will hand back the remainder of its assets and introduce lessons in “Orthodox culture” in state schools.

“The Russian Orthodox Church is already halfway towards becoming a state church,” the business daily *Kommersant* commented in January.

Russian Communists, successors to the church’s Soviet-era persecutors, have discovered an unsuspected reverence for church teachings, party leader Gennady Zyuganov revealing himself as a practicing believer and one of his deputies suggesting that the church receive state subsidies.

But statements such as that of General Georgy Poltavchenko, for 10 years a leading figure in the KGB, who asserted that “everything is in God’s hands, these days I read little other than the Bible,” have struck some as incongruous.

“Do you really expect me to believe these old spy chiefs have suddenly become regular Orthodox churchgoers?” asked Vitya, a former dissident whose scepticism is widespread among those for whom the initials KGB remain synonymous with arrests and persecutions.

Another kind of disquiet was expressed by Anatoly Krasikov, an expert in socio-religious studies at the Russian Academy of Sciences who warned that “if Orthodoxy becomes a new ideology, we’ll be right back to a totalitarian state.”

His fears were confirmed by Zoya Svetova, a journalist close to liberal Orthodox circles who warned that Alexis II “was already patriarch during the Communist era and wants to keep close ties with the authorities, as do the influential anti-Western, Slavophile forces within the church.”

[JR: The conversion of Russia was prophesized at Fatima. Is the Russian government under Putin fulfilling that prophecy or merely using the religion to further its goals? Does the acceptance of the Orthodox Church by ex-communist, KGB and government officials reflect their conversions or is it a means to control the people? Some officials may comply with this trend only to remain in favor. Life for the average Russian is very hard and they have seen little improvement since the changeover from Communism. The Tzars ruled the Russian people through their faith and were proclaimed by the church to be the Mother/Father of Russia. Let us hope that Putin’s deference to the Russian church is because of his new found faith that draws him to it. The Russian people revere their faith and it has helped them endure the cruelest of times. Let it now bring hope to them in the days ahead.]

U.S. COURTS MOVING AWAY FROM TRIAL BY JURY

NEW YORK—The role of the jury, the central vehicle for citizen participation in the United States legal system, is being limited sharply by new laws, court rulings and a legal culture that is moving away from trials as a method of resolving disputes.

At the heart of the trend are questions about whether jurors, who return huge verdicts and sometimes clear people who seem to be guilty, are up to the task that has been assigned to them for centuries.

“We, as a society, have to decide. Do we want to have our justice system run by experts—lawyers and judges—or do we want to retain a role for the jury?” asks Professor Valerie Hans, an expert on jury issues, who teaches at the University of Delaware.

Among the many forces marginalising the role of the jury are increased plea bargaining, laws limiting jury awards and Supreme Court rulings giving judges new powers to screen evidence presented to jurors.

Court statistics show, for example, that jury trials are a rapidly shrinking part of federal-court case loads, with only 4.3 percent of federal criminal charges now ending in jury verdicts, down from 10.4 percent in 1988.

The number of federal civil cases resolved by juries has also dropped, to 1.5 percent, down from 5.4 percent in 1962.

And those awards that civil juries do make are being overturned with greater frequency. Federal appeals courts are reversing certain types of civil jury awards twice as often as they did a few years ago.

And the explosive growth of private arbitration as an alternative to the courts for consumer, workplace and business disputes, is channelling tens of thousands of cases away from jury trials annually.

This trend is likely to continue. As U.S. President George W. Bush made, what proponents call, “reform” of the civil-justice system a priority when he was Governor of Texas, some legal experts predict that his new administration will accelerate efforts to limit jury power.

Judges and other experts also say the diminishing role of the jury reflects rapidly-changing attitudes about how much power jurors ought to have—*New York Times*

[JR: Our U.S. courts have been transformed into tribunals that are presided over by judges who interpret the law, not apply it, and decide arbitrarily what evidence will be allowed in “their” courts. The citizen juror has served well the justice system for centuries and to exclude our participation now because of changing attitudes really makes the devised overthrow of our Constitution and our rights as U.S. citizens obvious. These changes to eliminate juries in our court systems are not subtle anymore. They are in fact ushering in the UN’s socialistic form of world government. When will Americans wake up? When the UN flag is raised over the White House?]

COUNTERINTELLIGENCE RUN AMOK

Fear of foreign spies was already inordinately high in the United States when the sensational espionage charges against Robert Philip Hanssen hit the headlines. The media and the public, always starved for drama, have been captivated. The executive branch is planning tough-sounding remedies, including new super organizations.

Existing counterintelligence bureaucracies have exploited the “crisis” to grow and expand. And counterspy measures, resources and personnel are already greater than they were during the height of the Cold War.

President Bush is expected soon to approve establishment of a new counterintelligence policy board headed by a counterintelligence czar who will report to a new counterintelligence board of directors. This, despite the fact that there is no more KGB, no more Soviet Union.

Judging by discussions in the media, the new so-called proactive measures being planned are those that monitor our own people and control sensitive documents. An example of one of these measures is the explosion in job opportunities for internal security agents in the State Department. If former Secretary of State Madeleine Albright’s plan is carried out, State will hire 500 new security agents, bringing the total of such officers in the foreign service to 1,500. This compares with a total of only 2,500 foreign service officers who perform the department’s core work of diplomacy—reporting, analysis, advocacy and negotiation on bilateral and international issues—including ambassadors, their deputies and other program direction officers.

While security expands, some 700 other foreign-service positions remain vacant because of lack of funding. Some of the work normally done by diplomats is now being performed by officers in our foreign missions from the CIA and the Pentagon, neither of which have a comparable budget problem.

Yet the current danger we face from foreign espionage is a mere fraction of that posed from the 1930s to the fall of the Soviet Union in 1991. The mighty KGB’s successor, the SVR, like the Soviet Navy and all the other wings of the old Communist regime’s security establishment, is a shadow of its former self. For eight years, the SVR did not even contact Hanssen, one of the best-positioned moles in the United States the old KGB ever had. Except for Cuba, the SVR has lost all of the KGB’s sister services, including the once extraordinarily effective East German Stasi. Moreover, since the emergence of Russia as a relatively open but very strained society, the ability of Western services to penetrate the SVR has geometrically increased. The double agent in the SVR who exposed the apparent double-crosser Hanssen apparently handed over the entire KGB file.

The deeds of our counterspy turncoats resulted in the deaths of some of our Russian moles and are deserving of harsh punishment, but the consequences of their actions had no critical impact on vital U.S. interests. Notably, the FBI tunnel under the Russian Embassy in Washington reportedly revealed by Hanssen apparently produced no major intelligence. (Likewise the previous big American tunneling exercise, the famous 1950s CIA dig in Berlin, was a bust from the start. A Russian mole in London tipped off the KGB to the project before it even began.)

To declare to the press, as some intelligence sources are doing, that Hanssen and Aldrich Ames brought about the “greatest losses in the history of American intelligence” is to focus on damage to the counterspy organizations themselves and not to basic national interests, as for example was the case in the theft of nuclear secrets or submarine codes.

The massive spying and internal security apparatus of the KGB did not save the Soviet Union. Why now, when we face no such monolithic monster, do we need a counterintelligence czar, expanded polygraphs, more intrusive monitoring of personnel, a draconian “official secrets act” and many more internal security agents in the State Department and elsewhere?

We won the hot and cold wars the old way, by maintaining a reasonable level of internal controls but concentrating on offense—penetration, mole implantation and communications intercepts. We need to safeguard counterintelligence and other sensitive information, but the possibilities and the consequences of both foreign espionage and counterspying should be kept in perspective.

As George F. Kennan, architect of America's Cold War containment policy, once observed, counterintelligence takes on aspects that cause it to be viewed as a game, played in its own right. The fascination it exerts, he concluded, tends wholly to obscure, even for the general public, the original reasons for it.

[JR: Clinton ordered this new counterintelligence agency on 1/5/01, just before Bush took office, but I guess it is acceptable to the new administration. The expansion of our counterintelligence for both foreign and domestic shows the fear and paranoia that rules Washington. Billions more will be spent to increase personnel to set up this new Big Brother spy system so the clones in D.C. can feel safe and secure. The State Department and not Congress has created this new department which will be headed by a czar, no less, who will then report to another agency administered by an appointed board of directors drawn from other federal agencies. That's to confuse everyone as to who really has the authority and who, if anyone, is accountable. Is this supposed to be an Americanized version of the old Soviet KGB? The "old" Communist regime use to say, we'll give them the rope to hang ourselves. Well, we have certainly gotten the rope, alright—next is the gallows.]

U.S. ROADS, SCHOOLS REPORTEDLY IN DECAY

WASHINGTON, D.C.—America's public works—its bridges, roads, dams, schools and other infrastructure—are in a poor state of repair, a civil engineering group said Thursday, suggesting it will cost \$1.3 trillion over five years to fix them.

"When you've got rolling blackouts in California, bridges crumbling in Milwaukee and kids in Kansas City attending class in a former boys' restroom, something is desperately wrong," said Robert Bein, a California civil engineer who is president of the American Society of Civil Engineers.

The report noted that more than one-fourth of bridges needed repairs, one-quarter of the urban freeways were congested, and the aviation system has not kept pace.

The engineers said that three-fourths of school buildings were either too old, outdated or overcrowded. [JR: These statistics reflect the problems of much of the failing governments worldwide, which are overburdened with debt and red ink. The infrastructures of most major cities are in disrepair, in addition to the outdated water filtration and inadequate electrical grid systems. The condition of our schools has been a known problem for over 40 years, which was just one of the reasons the government imposed the forced school bussing in the early '60's. Our federal, state and local governments know how serious these problems are but never give them the priority they deserve. Their energies are focused on raising taxes to build sports arenas to distract us from our failing lives.]

NEVADA CORPORATIONS:

Built-In War Chest For NV Corporations

Budget's "Tip of the Week" #4:

NRS 78.752—Insurance and other financial arrangements against liability of directors, officers, employees and agents

In this very litigious society, anyone can sue anyone for almost any reason at any time. Corporations are not exempt from being sued but anyone suing a Nevada corporation could be surprised at just how resistant to attack Nevada corporate structures can be. (Important side note: To avail your Nevada corporation of the protection inherent in Nevada's statutes, you should always ensure that the other party to any contract agrees that the contract is made in Nevada and any disputes are to be resolved according to the laws of Nevada.)

Let's look at a provision of Nevada law that affords a Nevada-based C corporation amazing defensive capabilities: NRS 78.752, which was added in 1987. Here's how it begins (emphasis added):

1. A corporation may purchase and maintain insurance or make other financial arrangements on behalf of any person who is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise for any liability asserted against him and liability and expenses incurred by him... or arising out of his status as such, whether or not the corporation has the authority to indemnify him against such liability and expenses....

Paragraph 2 states that "other financial arrangements" may include the creation of a trust fund; the establishment of a program of self-insurance; the securing of its obligation of indemnification by granting a security interest or other lien on any assets of the corporation; and/or the establishment of a letter of credit, guaranty or surety. Specifically excluded from this protection are "...intentional misconduct, fraud or a knowing violation of law...". In paragraph 4, we find that "In the absence of fraud... the decision of the board of directors... is conclusive...".

Thus, when a Nevada corporation is sued and the litigant names as co-defendants any of the officers, directors, employees or agents of the corporation, the corporation is entitled by NRS 78.752 to set aside funds for the liability asserted. Since many suits "go for broke", quite literally, a Nevada corporation can often set aside ALL of its assets so that they may be used to defend itself. At best, the attacker is likely to end up with a "mouthful of dirt", as the Nevada corporation defends itself to its utmost.

Sometimes it is just as important what the statutes do NOT say. Next week, we'll examine some key provisions NOT included in Nevada's corporate statutes, which greatly enhance PRIVACY aspects.

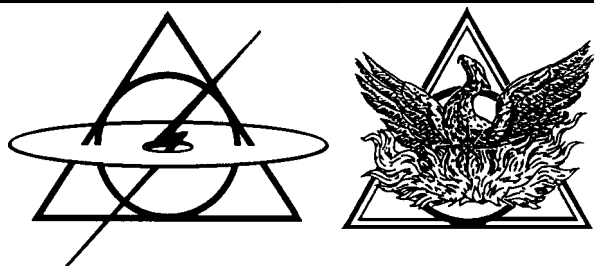
