

# Unchallenged Confirmation Of Operative Richard Armitage

**Armitage confirmed as Deputy Secretary of State in a voice vote on the Senate Floor**

ARMITAGE SNEAKS IN

SEVENTEEN PARAGRAPHS into a story on Bush's retention of CIA director George Tenet, the *NY Times* quietly drops a bombshell. Meanwhile, Gen. Colin L. Powell, Mr. Bush's choice to be secretary of state, has selected Richard Armitage, his close friend and a former Pentagon official, to be the deputy secretary, two Republicans close to the Bush transition team said. Mr. Armitage was initially a front-runner for deputy at the Defense Department, and resisted entreaties to work for General Powell, fearing it might interfere with their friendship. But the general has prevailed upon Mr. Armitage to join him at the State Department, associates said.

Meanwhile, indeed, nothing—not even Ashcroft—raises so many warning flags about the intentions of the Bush administration than does the **resurrection of this veteran of some of the sleaziest and most corrupt**

periods of American foreign policy, including the CIA-drug trade love fest in SE Asia and the Iran-Contra scandal. If we had a press and a Democratic Party worthy of their names, the Armitage appointment would be major news. Here, for starters, are some reasons why:

OLIVER NORTH, UNDER FIRE: [William] Casey handed [Robert] McFarlane a sheet of paper on which he had outlined plans for a new CIA anti-terrorism unit... [it] officially sanctioned a secret entity with a mandate to coordinate our government's response to international terrorism—preemptively if possible, retroactively if necessary. I became its first chairman... My associates on the Task Force included Noel Koch (and later Richard Armitage) from Defense, Dewey Clarridge and Charlie Allen from the CIA, Buck Revell and Wayne Gilbert from the FBI, Bob Oakley from State, and Art Moreau (and later General Jack Moellering) from the Joint Chiefs of Staff

INDEPENDENT COUNSEL'S REPORT ON IRAN-CONTRA: Director Casey's unswerving support of President Reagan's Contra policies and of the Iran arms sales encouraged some CIA officials to go beyond

legal restrictions in both operations. Casey was instrumental in pairing North with [Richard] Secord as a Contra-support team when the Boland Amendment in October 1984 forced the CIA to refrain from direct or indirect aid. He also supported the North-Secord combination in the Iran arms sales, despite deep reservations about Secord within the CIA hierarchy. Casey's position on the Contras prompted the chief of the CIA's Central American Task Force, Alan D. Fiers, Jr., to dovetail CIA activities with those of North's Contra-resupply network, in violation of Boland restrictions. Casey's support for the NSC to direct the Iran arms sales and to use arms dealer Manucher Ghorbanifar and Secord in the operation, forced the CIA's Directorate of Operations to work with people it distrusted... Contrary to their testimony to the presidentially appointed Tower Commission and the Select Iran-Contra Committees of Congress, Independent Counsel determined that Secretary Weinberger and his closest aides were consistently informed of proposed and actual arms shipments to Iran during 1985 and 1986... The notes demonstrated that

Weinberger's early testimony that he had only vague and generalized information about Iran arms sales in 1985 was false, and that he in fact had detailed information on the proposed arms sales and the actual deliveries. The notes also revealed that Gen. Colin Powell, Weinberger's senior military aide, and Richard L. Armitage, assistant secretary of defense for international security affairs, also had detailed knowledge of the 1985 shipments from Israeli stocks. Armitage and Powell had testified that they did not learn of the November 1985 HAWK missile shipment until 1986... There was little evidence that Powell's early testimony regarding the 1985 shipments and Weinberger's notes was willfully false. Powell cooperated with the various Iran-Contra investigations and, when his recollection was refreshed by Weinberger's notes, he readily conceded their accuracy. Independent Counsel declined to prosecute Armitage because the OIC's limited resources were focused on the case against Weinberger and because the evidence against Armitage, while substantial, did not reach the threshold of proof beyond a reasonable doubt.

**U.S. STIPULATION IN OLIVER NORTH TRIAL:** Stipulation 61—In late March 1985, North advised McFarlane that the initial deliveries of U.S. arms from DoD to Honduras had gone well. The Honduran government had expressed its gratitude through those who were supporting the Resistance. North proposed that McFarlane ask Secretary of Defense Weinberger to convey President Reagan's and McFarlane's thanks to DoD personnel who had effected the expedited procurement for the Honduran government, including Assistant Secretary of Defense Richard Armitage and General Gast... Stipulation 92—In late March 1986, Elliott Abrams offered Honduran President Azcona immediate additional security assistance. Lt. Col. North prepared a memorandum from Admiral Poindexter to President Reagan (with copies to Vice President Bush and Chief of Staff Regan) describing the results of Abrams' discussions with Azcona... The Honduran army and navy specifically requested a sophisticated ground-to-air missile on the ground that the U.S. had already furnished such weapons to the Resistance. The total cost for the items ultimately agreed upon was approximately \$20 million. Among [sic] of the additional assistance to Honduras (in addition to President Reagan, Vice President Bush, Regan, and Admiral Poindexter) were Lt. Gen. Gast (Director of DSAA), Assistant Secretary of Defense Richard Armitage, and Deputy Assistant Secretary of Defense Nestor Sanchez.

**BO GRITZ:** [Gritz, a colorful figure upon whom the character of Rambo was partly based, is the most decorated Green Beret commander of the Vietnam era.] What I want to tell you very quickly is something that I feel is more heinous than the Bataan death march... What I'm talking about is something we found out in Burma—May 1987. We found it out from a man named Khun Sa. He is the recognized overlord of heroin in the world... **On videotape he said to us something that was most astounding: that U.S. government officials have been and are now his biggest customers, and have been for the last twenty years.** I wouldn't believe him... We ran the war in Laos and Cambodia through drugs. The money that would not be appropriated by a liberal congress, was appropriated. And you know who we used for distribution? Santos Trafficante, old friend of the CIA and mobster out of Cuba and Florida... Fifty-eight-thousand Americans

were killed. Seventy-thousand became drug casualties. In the sixties and seventies you saw an infusion of drugs into America like never was before.

**PROJECT PHOENIX:** Several figures—including Theodore Shackley, Thomas Clines and Richard Armitage—later associated with the Iran-Contra scandal were involved in Project Phoenix, which was financed in part with opium money. It has been alleged that the close relationship with SE Asian drug dealers continued after the U.S. withdrawal from Vietnam, with Iran used as a conduit for drugs and money. It has also been reported that, as a sequel to Project Phoenix, an off-the-books assassination program was established in Iran.

**RALPH MCGEHEE:** [Ralph McGehee is a former CIA officer who has exposed agency wrongdoing.] The Phoenix or Phuong Hoang Operation was originally designed to neutralize, that is assassinate or imprison, members of the civilian infrastructure of the [Vietnamese] National Liberation Front. Phoenix offices were set up from Saigon down to the district level. Their functions were to: (1) collate intelligence about the Vietcong Infrastructure; (2) interrogate civilians picked up at random by military units carrying out sweeps through villages; (3) neutralize targeted members of the NLF... The original Phoenix concept was quickly diluted, for two main reasons: (1) pressure from the top to fill numerical quotas of person to be neutralized; (2) difficulties at the bottom of identifying NLF civilian infrastructure, who were often indistinguishable from the general population, and the near impossibility of proving anyone's membership in the NLF. The result was vastly to increase the numbers of innocent persons rounded up and imprisoned, indiscriminately murdered, and brutally tortured in an effort to show results... Between 1968 and 1972 hundreds of thousands of Vietnamese civilians were rounded up and turned over to the Vietnamese police for questioning. Such interrogation has usually been marked by brutal torture.

**AFTER THE WAR:** At the end of 1975, Armitage became as a special consultant to the Department of Defense, working out of Bangkok and dealing with unrepatriated prisoners and the missing in action. Armitage also started a mysterious business called the Far East Trading Company. Meanwhile, from 1976 to 1979 in Iran, Richard Secord was supervising the sale of U.S. military aircraft and weapons to Middle Eastern nations. During this same period, there are reports that Shackley, Clines, Secord, and Armitage set up several curious corporations and subsidiaries around the world including Lake Resources, Stanford Technology Trading Group, Companie de Services Fiduciaria, CSF Investments and Udall Research Corporation.

**ARMITAGE AND POWELL:** Powell and Armitage apparently met first in 1981, and later, when Powell served as chairman of the joint chiefs, they started to call each other daily to share information and bounce ideas off each other, according to a 1993 profile in *USA Weekend*. They have become sounding boards for just about anything the other guy wants to discuss. Often they talk, if only briefly, two or three times a day. *Newsweek* reported that Armitage may be Powell's closest friend.

**ARMITAGE AND ROSS PEROT:** Perot and Armitage met in 1986 when Armitage was working on the POW-MIA issue. Perot, bothered by problems with the POW program as well as reports of Armitage's involvement with drug traffickers, urged

Armitage to resign. Armitage told the *St. Louis Post Dispatch*, I found out he was putting his mouth on me, and I asked him to come to my office. Armitage told Perot that federal investigators had cleared him. Perot went to see President Bush who said it was a matter for the FBI. Perot then met with FBI Director William Webster and subordinates, pointing out, among other things, that Armitage had given a character reference for a Vietnamese woman convicted of conducting a major illegal gambling operation in Arlington, Virginia. Bush nominated Armitage to be Secretary of the Army in 1989—but Armitage withdrew before the confirmation hearing following reports that Perot and veteran organizations were gearing up to oppose him. Syndicated columnist Jack Anderson reported in 1986 that the President's Commission on Organized Crime had questioned Armitage about his relationship with the Vietnamese refugee. Powell sided with Armitage on the issue.

[The pro-CIA *Time Magazine* rises to Armitage's defense.]

**GEORGE J. CHURCH, TIME MAGAZINE, 1987:** Among the targets of Perot's current probe are some whose names have surfaced in connection with Iranscam. He has been looking into the alleged links between ex-CIA agents Thomas Clines and Theodore Shackley, retired Generals Richard Secord and John Singlaub, Iranian-born Businessman Albert Hakim and other former and present Government officials going back to the early 1960s. I think we'll conclude that Admiral Poindexter and Colonel North were bit players, he told the *Washington Post*, and the major characters were people who were in the weapons business for years, some of whom had CIA connections. A far more curious target is Assistant Secretary of Defense Richard Armitage, a man widely respected for his integrity and effectiveness. After his appointment in 1981, Armitage began working in Southeast Asia to track down reports of MIAs in Viet Nam; Perot suspected him of not doing enough. Last October, Perot met with Armitage at the Pentagon and bluntly demanded that he resign. Perot's stated reason was that Armitage had written, on Pentagon stationery, a glowing character reference for a Vietnamese woman refugee, Nguyet Thi O'Rourke, who had been convicted of running a gambling operation in Virginia. Armitage later conceded that using Pentagon stationery had been dumb, but not illegal or improper. At the meeting, Armitage vigorously denied any implication that he had anything to do with an illicit arms or drug network... Lately, Perot and his investigators have been interviewing people who have also been questioned by the Christic Institute, a Washington public-interest law firm. Christic last year filed a suit in Miami against Clines, Shackley, Secord, Singlaub, Hakim and 24 others; Armitage is mentioned several times but is not a defendant. The suit charges that some of the defendants became involved in drug smuggling from Southeast Asia in the early 1960s—and later in a series of shady weapons deals around the world, using the profits to finance covert anti-Communist activities. But the lawsuit's allegations, many of which are inaccurate or based on false assumptions, are a shaky foundation on which to base an investigation. Armitage calls the suit malicious and has a four-page list of factual refutations. For example, an affidavit filed by the Christic Institute's attorney claims that Armitage was in Bangkok setting up a company that allegedly served

as a front for the movement of opium money during a period in the late 1970s; part of that time he was actually living in Washington and working as administrative assistant to Senator Robert Dole.

ARMITAGE AND BURMA: UNOCAL is the leading American investor in Myanmar, a target of widespread sanctions and boycotts for its repressive regime. In 1997 Richard Armitage reportedly went to Burma on a trip sponsored by the Burma/Myanmar Forum, a Washington group with major funding from UNOCAL.

QUESTIONS NEEDING ANSWERS: Before Richard Armitage holds another public office, we need the answers to a few questions such as:

\*What exactly was his role in the disastrous, deadly, and deeply corrupt CIA arrangements with the SE drug trade?

\*What is in Lawrence Walsh's files concerning Armitage's involvement in Iran-Contra?

\*What is in Ross Perot's files concerning Armitage and what is Armitage's response?

\*Do the files of the Kerry Committee that investigated Iran-Contra shed any light on Armitage's role?

\*What was the nature of the various business enterprises with which Armitage has been affiliated?

Dear Congressman Hamilton,

Because Bo Gritz has served for two years as Chief of Congressional Relations for the Pentagon, it is highly probable that you and the others on the Iran-Contra Committee are well acquainted with him.

Attached is a partial list of radio and television shows on which Mr. Gritz has expressed his belief that Richard Armitage, Ted Shackley, Felix Rodriguez and Thomas Clines have been engaged in major Southeast Asian narcotics trafficking with the late Santo Trafficante.

This is most disturbing since I have been told that the above were involved with Santo Trafficante in CIA-Mafia assassination attempts against Fidel Castro in the early 1960s. Indeed, the careers of these shadowy figures weave through many scandals and many foreign-policy disasters both in Latin America and Southeast Asia—as well as the Nugan Hand Bank collapse. They seem to just float away from one ugly scandal after another giving the impression that they are protected from very high up.

Bo Gritz filmed 40 hours of interviews in Burma conducted with General Khun Sa, the acknowledged heroin kingpin of the world, in which Khun Sa revealed the names of his largest American customers. Senator Inouye, Jack Brooks and Les Aspin have copies of the edited version of this videotape. In this tape Khun Sa proposes a plan to stop the shipment of 900 tons of opium to the U.S.

If there is some truth in these allegations of Mr. Gritz, then it seems to me that public hearings are required. Perhaps the best approach would be to reconvene the Iran-Contra Committee.

I should think that you would want to take the most direct path to an understanding of this very serious matter and this would be to pick up your telephone and call Bo Gritz 702-723-5266 at his Nevada home. Please find the courage to call Bo Gritz and listen to what he has to say.

Please have someone from your staff call me to acknowledge receipt of this correspondence and to assure me that this matter will be treated with the necessary seriousness.

**RICHARD ARMITAGE QUIETLY CONFIRMED  
AS DEPUTY SECRETARY OF STATE**

FTW—On March 23, after being recommended in a unanimous 18-0 vote by the Senate Foreign Relations Committee, former Vietnam-era covert operative and Contra-era figure Richard Armitage was confirmed as Deputy Secretary of State in a voice vote on the Senate Floor. The unchallenged confirmation of a figure who had previously been investigated by President Reagan's

Commission on Organized Crime (1984) for alleged links to gambling and prostitution was totally ignored by the major American media. Armitage has already begun work at the State Department and is deeply involved in negotiations over a U.S. spy plane recently captured by the Chinese government.

The total lack of opposition to Armitage's appointment indicates an apparent inability of the U.S. Congress to muster any critical examination of appointments or policy at a time when an imperiled U.S. economy and an almost combative Bush Administration is dealing with mounting economic and political challenges around the globe.

Armitage, who was denied a 1989 appointment as Assistant Secretary of State because of links to Iran-Contra and other scandals, served as Assistant Secretary of Defense for International Security Affairs in the Reagan years. U.S. Government stipulations in the Oliver North trial specifically named Armitage as one of the DoD officials responsible for illegal transfers of weapons to Iran and the Contras. But Armitage's dirty past goes much deeper.

A Vietnam veteran and graduate of Annapolis, Armitage's roots have been thoroughly intertwined with the likes of CIA veteran Ted Shackley, Richard Secord, Heine Aderholt, Elliot Abrams, Dewey Clarridge, Edwin Wilson and Tom Clines. All of these men have been directly linked to CIA covert operations, the drug trade, the abandonment of U.S. prisoners of War after Vietnam and/or Iran-Contra. Armitage has also been routinely discussed in *FTW* as a Bush-era covert functionary who has been linked to covert operations, drug smuggling and the expansion of organized crime operations in Russia, Central Asia and the Far East.

In 1986 a private dispute between POW activist Ross Perot and Armitage went public as photos of Armitage with a topless Vietnamese nightclub owner Nguyen O'Rourke brought allegations of gambling and prostitution close to Armitage's doorstep. The stories went public when *TIME* and *The Boston Globe* wrote lengthy stories on the feud in 1986 and 1987. That scandal arose as a result of 1984 investigations by President Reagan's Commission on Organized Crime in which the photo and documentation of gambling charges and prostitution led to direct Armitage's close association with O'Rourke. Then-LAPD Assistant Chief Jesse Brewer, a former Commanding Officer of this writer, served on the Reagan Commission.

The 1992 best seller *Kiss The Boys Goodbye* by former "60 MINUTES" producer Monika Jensen-Stevenson details Armitage's role as Reagan point man on Vietnam POW-MIA issues and describes why Armitage has earned the enmity of many POW activists. However, in a 1995 interview with *The Washington Post*, Colin Powell referred to Armitage as his "White son". This, notwithstanding the fact that the 6 foot, balding, power-lifter, now 56, can still bench press 300 or more pounds and reportedly "enjoys killing".

William Tyree, Special Forces Veteran who has provided much reliable information and documentation to *FTW* in the past said, "Armitage used to 'sit ambush' on the trails in Laos and Cambodia. He liked it. Now when Powell, 'the dove' sits down at a table with Armitage 'the killer' beside him—the message will be that Armitage can reach across the table and deal with the other party on the spot." That message will not go unheard. [END]

In addition, any contact to any others is closed off—the inhabitants are locked into the planet system.

On some worlds, the fallible creatures are also exiled to great islands, if the grade of fallibility on the concerned world is very low. This manner of punishment assures security, and at the same time the fallible ones are no burden to the natural society. Moreover, this form of punishment is humane and suitable because the fallible ones are not obstructed in their development. Does it begin to bring memories of your own beginnings, perhaps? **Could it be that you are a “prison” planet?** Of course, for God always gives unto his creations a place to reform, restructure, recreate and “serve their time”, so to speak. Teachers and guides, wardens and guards are always sent to guide and effort at rehabilitation—then there is a graduation and if rehabilitation into truth and rightness of action is accomplished, the “inmates” move on and the negative unlearned ones are placed into other suitable accommodations until they DO learn Universal behavior. **Most of Earth's real criminals never see the inside of a prison—for the real criminals of humanity are the ones who set up the false teachings and the heinous laws which create injustice, force and degradation unto the soul.**

In very ancient times different fallible creatures were exiled from different worlds in this Universe to your Earth, as well as from our race also. We do not keep “dates” and “calendars” as do you, so let us consider it was “a long time ago”. Since in our Pleiades star system, there is interplanetary travel and interchange, the laws are very similar on all inhabited orbs and will do for general purposes of discussion at this time.

Our races are monogamous, after a thorough clearing up of facts in respect to belonging together. Mistakes, of course, cannot be excluded, for the life-forms are not very far advanced of your own

racess—but these, if necessary, are still later eliminated. Descendants are regulated by the highest council, meaning that a definite amount of births within a defined amount of time and space is observed, so as to preserve the race without overpopulating. It is totally controlled by responsible “ACTIONS” and not “control” by artificial means, devices nor destruction of “accidents”—there simply are no “accidents” through total dedication of self-responsible actions.

Married couples remain in that alliance during their life-experience cycle. When you have careful pre-union understanding and friendship, then you have no problem with irresponsible behavior—for a marriage represents friendships within the boundaries of Law of balance and harmony and total responsibility to the planet upon which all must reside. Since the physical greed, power and social needs of the procreation act are evolved out of the picture, procreation is with intent and great planning in responsibility. Since Pleiadians live to be hundreds and hundreds of years of age, it requires this same discipline over a period of many centuries. Pleiadians do have one of the highest forms of human civilizations—for the needs of the balanced planet are strictly adhered unto and ones who refuse the responsibility are given homes in places such as Earth. When ones who have broken lesser obligations are placed, it is often that the “prison”, if you will, becomes inappropriate for their deviation of behavior—or rehabilitation is fulfilled, and then “graduation” day arrives and/or the planet becomes so unbalanced that the darker forms of experience are placed elsewhere—as with your planet.

There will be evolution into higher dimensional values and density and fully developed ones will transverse with her. The totally negative life-forms will be separated away and placed in suitable “classrooms”. The guides and wardens will have served their time of duty and will be allowed to further experience according to growth levels—or simply return to God-Source. Many of you will desire returning to Pleiades to experience awhile in that goodly environment; many will wish to move with Earth into Radiance of Shan; and many of you will wish to return, or remain, with the healing planet to nurture and re-create a habitable placement.

I specifically used the term “monogamous” because we do not use without responsibility, the sexual act and, therefore, there is no need of multiple partners. Persons in need of care and life-nurturing assistance are cared for properly and not in any way USED for the personal experience of lust, greed and/or sexual misbehavior. Marriage and creation are most highly esteemed and most carefully regarded in all respects. This is why we denounce the “behavior” of deviant groups—not the love and energy exchange of people. A friend can be as or more dear than a spouse—but there is no physical sexual actions intruded into the relationship. Children ARE NOT ACCIDENTS! FROM IRRESPONSIBLE BEHAVIOR—NOR ARE THE BASE DISEASES STEMMING FROM THESE UNIONS.

Divorce as you know it is insufficient and admitted in only the worst cases, such as when one of the union is exiled. This is most rare, indeed. Our laws have worked in harmonious balance for millenniums.

### WHAT OF LOVE FOR ANOTHER, SAY OF ANOTHER WORLD?

So what of such a love? Do you mean as perhaps I might LOVE Dharma? I, representing masculine and she representing feminine? What of it—we, especially one of higher dimension even than another planetary system, have no need for such expressions! Love as you express of it is not even entered into the picture of higher dimension. Love is all inclusive and I love Oberli even as much as I love Ranos, Ilsie, Daylene and/or Dharma. Further, ask any one of these ones—once touched by the Love of higher understanding, there is naught of Earth experience to match the experience. Love is an emotional experience—untouched by any human physical beingness—you simply have forgotten.

What you usually refer to as Love is a simple infatuation for another—expressed in a totally physical manner—missing the wondrous beauty of the emotional fulfillment, for you place pleasure in the place of emotional fulfillment. When you merge two souls—that, dear friends, is LOVE! One can merge with every body in the system and you will find yourself only worn out and disease ridden—not fulfilled, at peace nor content—you will only have formed a bad habit and will search for even one more with which to tamper. Ah, yes, Earth mankind has forgotten the difference in LOVE and love. There is no LOVE to be expressed in any manner as I feel for you of my children in journey—I, at thousands of years of age in your counting and you, as babes and toddlers. But you must understand that many of you have walked with me through the eons of time and have only FORGOTTEN! This is why you are pulled to me as a magnet to the iron filings—for we are of the same essence and THAT, dear ones, IS THE TRUTH OF ETERNAL LOVE IN ITS WHOLENESS—I WOULD GIVE ALL THAT I AM AND HAVE UNTO YOU, FOR YOU AND WITH YOU—AND NOW, SOME RETURN THAT GIFT UNTO ME AND UNITED WE CANNOT FAIL TO ACHIEVE OUR GOAL—FOR THAT KIND OF LOVE IS THE TRUTH OF THAT WHICH IS GOD! Man is the creature who is envious of any relationship which he perceives excludes self—and, therefore, it is a singularly excluding of self. When man loses his self-orientation then, and only then, can he enter into such a relationship as God-LOVE, for all is in behalf of the OTHER. However, in fact, the LOVE OF THAT KIND OF NATURE only returns to self, the fullness of the relationship, for neither is TAKING from the other—BOTH ARE GIVING ALL THAT CAN BE GIVEN—EACH MORE THAN HIS WHOLE.

Each and all have the ability by mind power to pull unto self any desired “thing”. So, I suggest you be most careful regarding that which you desire—for you may be unfortunate enough to pull it unto self. **It is when you rise above self of the physical that you find truth and all knowledge and then, only then, is peace and tranquility achieved.** It can only come through the “giving” and proper “accepting” and

“exchanging” of emotional equality and not physical experience, that truth of life meaning is understood. **THIS IS YOUR BIRTHRIGHT: FREE-WILL THROUGH CHOICE AND THE RETURN UNTO THE ONENESS WITH GOD! ALL OTHER IS SIMPLY “THE JOURNEY” THROUGH THE LESSONS UNTIL TRUTH IN GOD-NESS IS ACHIEVED.**

Wherein the physical only visualizes that which is physical—higher essence sees only that which is spiritual. I see you ones as the soul essence which you are and the physical falls away. I can see beyond the ego of the physical experience and understand the impact of the human physicalness—but it is the soul I see as I look within your places—so you are actually quite safe from prying eyes in the bath. My communion is with soul—not the physical. I understand the physical impacts of living—but those are for YOU to have conquest; they are not of my business—except as they impact that which is within my jurisdiction or group of committed workers within my Command. Then, neither do I have control—only in request for separation until direction is isolated and decisions are made—for I, nor my brothers, have any intent to ever intrude other than to speak warnings and give guidelines for participants in this mission.

### NO REFLECTION OF GODLESSNESS

Ones who have intent for participation in the transition with communion with Higher Brothers of the Cosmos or, and more especially, in relationship to higher energies of other dimensions—agree to abide by God’s Laws and The Creation’s Laws in that example is total as regards “actions”. There will be the lusting and greeding as long as there is physical—how the human “acts” in the given scenario is that which is ultimately important.

Do not go about saying we “kick you out” or “isolate you” if you are acting in behavioral ways deviant from Cosmic law, for YOU will have made that choice—not we! YOU may change your actions at any time but you cannot “fool” us! We see only soul intent! Past errors? So be it; in God’s realms past ignorance is all points of the law—it is important when it is “deliberate actions in defiance to those laws”. If you do not approve of those laws, it is your choice, but I promise you—you who continue in Satan’s trappings will not find your next journey through the gates into Godness, for learning of the laws and abiding therein is the price of that lovely transition. For instance, the Pleiadians want no irresponsible, misbehaving humans cluttering their life of balance. There will be no “sleeping around” to introduce envy, self-gain and/or base human behaviors accepted. You had all better rethink the “RAPTURE SCENARIO”. If you are ill-using physical-ness, you aren’t going to “rapture” to anywhere physical that I recognize as “higher” dimension—and most certainly not unto God! **NO EVIL INTENT SHALL ENTER INTO THE HOUSE OF GOD!**

Now, when you speak of inter-planetary beings of human format, much changes in perception. Ones of higher learning often make changes into what would be considered “lower” vibrations and often join with the “lower” frequency being in what you might loosely refer to as a “love” relationship—but it is not handled

as a physical matter at that level even if it entails physical actions. This means that the “lower” being will grow rapidly or there will be a lot of pain borne by both, for the “higher” being will be unable to compromise soul truth—it happens frequently.

Sometimes ones, say from Pleiades, come for rotations of duty upon your placement and then there is subjection to your own environment with the consequent loss of memory data and often these ones are lost to the environment and activities of Earth plane. Often good “receivers” of higher energy forms are lost to the Earth environment and ego state as surrounds the dense capsule of your planet. It is, indeed, hard to keep those conduits open and as such, many are only opened in these recently current times to allow for purity of communication. They simply were not opened at the earlier time in order to serve in proper sequence. Each fragment serves at its given proper sequence of experience—the students then must discern the changes, for it is part and whole of the learning requirements. **YOU EACH MUST LEARN THE LESSONS PRIOR TO TRANSITION AND THE OLD MUST BE CAST ASIDE. FOR INSTANCE—YOU MUST RELEASE THE LIE THAT ANY ONE BEING COULD ABSOLVE YOU OF YOUR SINS AND ERRORS. NO ONE CAN DO ANY SUCH THING FOR ANOTHER! YOU WILL STAND RESPONSIBLE AND ANSWERABLE FOR YOUR ACTIONS IN THE PHYSICAL EXPERIENCE—NO MORE AND NO LESS—YOU!!**

#### OTHER PLANETS IN YOUR SOLAR SYSTEM

We, serving in the Pleiades Command for instance, are only allowed to speak of certain things and explain only so much. These neighboring planets have been priorly occupied in former times by our races, and are by minimal measure still today important as bases and other extraterrestrial homing centers for starship attachment—usually of higher dimensional “rating”.

I, for instance, effort to carry somewhat current information regarding your solar system in my mind in respect to the level of my experience at the current time; however, I do not have interest in other than your evolution and my Command at the present experience. I simply have no interest at this time, in the other systems. You ones are not destined to be placed on these other planets when evolved from this Earth plane and, therefore, I spend little time inputting other data that can be garnered from other teachers if the interest and curiosity abounds—I am interested in changing your truth and knowledge and getting you into safety and security—prepared and ready for transposition. My thrust, and the thrust of Sananda “Jesus”, Korton, etc., is to bring as many as possible into awakening and full decision in Godness to move into other responsibility—ours is not a sojourn to philosophy and speculations of how it may be next door. If your only intent is on such trivia—go unto another for your lesson,s for ours is far advanced of trivia not applicable directly to your transition.

**We are come to awaken ones to their purpose, bring truth and prepare for the reclaiming of the Kingdom unto God.** I am not, for instance, concerned with that which might be going on on Venus or Mars except as Earth bases

thereon might impact you as World citizens—specifically within my Command. Truth is truth is truth—but in addition, ones of my Command must **HEAR THE CALL TO PURPOSE!**

Dharma, write this document immediately—did you not note the energy wave that struck this dwelling? It is fine, chela, your attention is removed but we will lose the document if you do not attend it. Thank you.

We have you very well shielded now and it is very difficult to get through the web to vulnerable attack spots—we can deflect quite efficiently now with little damage sustained—however, there is continual barrage against the computers and electronics systems and any electric interruption can wipe out the programs and data storage systems. Simply take care.

I suggest you ones who come into writings by ones who claim physical behaviors with extraterrestrial beings—be most careful, indeed—for the inter-change would be exaggerated according to the perceptions of the ego of the writer. No celestial being would ever even be tempted to pull an Earthian from his path by such dalliance, for the discipline would be great on his own level and especially at this time of sequence; an extraterrestrial of higher understanding such as would be a teacher or speaker—would simply never participate in such behavior—check with former contactees such as Billy Meier for confirmation. Semjase is a most beautiful creature in Earth perceptions—and I believe she gave Billy quite a good and grand, unmistakable lesson regarding such matters as Earth-type behavior and LOVE. Misbehavior of higher brotherhood from other star systems would be met with severe discipline and would be totally unacceptable.

Further, for “Space-beings” to respond to personal, egotistical demands to become “visible” to “prove” something or another is equally unacceptable. Regardless of who believes otherwise, it is most often totally destructive behavior to become visible—especially on such cause and demand. Most ones are quite honest and relate that “I” need to see or touch—but many will place it as “we” and “for our good” and “so we can better serve”, etc. No, it is always for “me”, “I” and “self”—if not, it will be left to the discernment of the higher being for the better good of the whole—without exception.

Does this mean that each will not desire “for me” “for I” for “self”? Of course not and the desire will be always at the forefront—however, the acceptance of “higher truth” will always prevail and the thought will always return to “for the highest Cause” and “not my ego will, but Thine higher truth” shall always prevail if given in truth of higher Cause. The ego will always seek satisfaction and the quicker the better—“instant Patience” and “undelayed gratification of whatever is the point of attention”. Remember the obligation of the higher resources unto you at this time and bear with their limitations as given forth unto them—**THEY ARE TO ACT WITH TOTAL DISCERNMENT WITHIN HIGHER KNOWLEDGE AND THEY MAY NOT PLAY YOUR GAMES ON DEMAND. IF THEY FALL INTO THE TRAP OF RESPONDING FROM EARTH “DESIRE” STANDPOINT—THEY WILL BE RELIEVED AND RETURNED HOME.**

I would clarify another point, however, in some instances—and you ones will know of the one or two

circumstances of which I speak—a joint intent will have been established through two energy forms and then the separation will be caused whereby there is one in one plane of experience and the other in another—**FOR THE PURPOSE OF INTER-ACTION AND TASK PERFECTION AT THE PROPER TIME OF TERRESTRIAL/EXTRATERRESTRIAL JOINT ACTION.** I believe that one, Gabriel, shall recognize of that which I speak. The loyalty and communications have never been severed and there is no misunderstanding of intent. The purpose always becomes quite obscure with the one left on Earth sphere—for the density reduces ability to retain memory patterns. It is true trust and ego allowance to maintain that wondrous communion through such dimensional changes. Many of us walk together but in separation become unable to recall—it is now the reawakening unto those connections in a most unphysical manner—the higher energy will never allow reverting unto the human behavior patterns. The human involved may have very vivid memory visions of such interchange—but that is exactly that which it will be—recall visions—dreams. It depends totally on intent of purpose within the missions as to whether or not there will be actual physical visualization. I do not mean to complicate the subject; it is just that the contacts are so misperceived and humans are so easily deceived and duped by ones claiming this and that status.

Always you can discern in truth according to the Laws of God and The Creation—truth will always move you in soul unto the Lighted God; evil will pull you away from the God-ness: no more and no less. If there is anything in the projections of so-called energy voices or projections that diverts physically or in intent from the God-truth, get away from the energy—for it is not of God. The laws are most succinct without maybes or sometimes—the laws are always! Therefore, it becomes, indeed, easy to discern he who gives false teachings and that which does not. It does indicate, however, that you must know the Laws and I remind you that **EVERY ENERGY BIRTHED UPON YOUR PLACE—CARRIES THAT PARTICULAR KNOWLEDGE WITHIN.** It does help to brush up on them into your consciousness.

Allow us to close this segment as it grows long and we cannot cover the entire of the subject matter herein so allow us a break. Thank you.

#### TODAY’S WATCH

Greetings in the Light of Radiance. Hatonn present that we might continue on our *Journal*. As we watch this day I would ask that you carefully consider that which is coming forth from the different areas of the world in regards to that which you have labeled AIDS. Also, pay attention to the new implant which is utilized on the female of your species to prevent pregnancy. Is there no end to which you will not go to substitute for responsible behavior? So be it. Do you not see that—if left to

your own devices as moving between subtle birth control and AIDS—you, yourselves, will wipe out your species? If something is not done soon, the whole of the Brazilian population will be devastated just as is Africa. Now, instead of teaching your young generations to use control and responsible behavior—you will sterilize a whole generation of women before you are finished and all in the name of safe-sex. “Like lambs to the slaughter!” Each “thing” will come forth as planned, upon your nations, so that you eagerly bring down the shackles upon selves—demanding it, in fact.

For my group of “touchy” friends—since the incident two Saturdays past—last evening was simply the Shuttle coming home to roost—from Australia. How much will you accept, people of the lie? So be it.

Allow us to continue with our *Journal*—for it seems time is of utmost importance in which to bring you into truth and alignment with God. AHO!

### PLEIADIAN CONTACTS

Speaking in behalf of Pleiadians I shall simply utilize first person in order to achieve brevity—I shall speak of positions of higher dimension at a later portion. You must now become familiar with that which IS as regards placements as you move from this orb—I speak in generalities unto some 6½ billion persons of separate fragmentation so, please, you must also generalize my lessons, for we have not time to speak to each in formal format. You may go within, inquire and receive answers—but I find few who “listen” so this will suffice. You can confirm this truth from ancient teachers such as Little Crow, other contacts such as Billy Meier (in his early contact days), etc. First, it would seem appropriate to outlay that which happens as we make contact with ones of your races on your planet.

I hear and see the ones who stand forth and denounce the receivers as stationed about your place, saying, “Why not me, I have been willing to make contact for years—why not me?” Because usually those ones have only personal interest and/or it is not yet time in the sequence for utilization and transference of information in that particular sector. It is a true worker who is willing and patient to await that which is his purpose—in support of those who are in service presently. One job in proper sequence is of no greater importance than is another—only different and given differing times of projection.

Herein, I caution Dee that that which she is projecting regarding receiving from the Command be tempered with great wisdom. Do not misunderstand that which you receive and perceive to be from Korton. You have opened a can of worms to divide and fragment workers.

If ones wish to sit pen for self and/or contact higher self or the energies of higher consciousness—fine; to contact and receive for one in our Command or functioning at this time in this specific operation only confuses and hampers our work. You all must first understand the communications and it is evident that you do NOT.

Perhaps for some it is fine to sit with pen and dally upon the paper—however, mostly, all that will

be received is tampering energy forms. This mission is far too important to allow such trivial pursuit of fun and games. For instance, to fragment my communications at this time is absolutely unthinkable—for man is confused enough without fragmenting further in misperceptions.

I shall not elaborate on that which is happening to other scribes but I assure you that we do not deal in simple higher thought forms. I give forth exactly that which I wish stated—in pulsed beam format and simply “allowing” the flow is not sufficient from a scribe. Everything that touches the scribe’s personal space is an impact upon that which is written and thus the training is hard and LONG in order to bypass that seeking input for personal instructions. If we have need of personal data exchange, we handle it in proper format, in separation of duties. We are not in the business of teaching everyone to “channel” or “write”, etc. In this location, specifically, we have too many willing teachers—and confusion can be the only outcome as the information is spread about. If each of you will do your job and cease trying to be the scribe or receiver—we shall have a wondrous working relationship; if we simply have another group of gathered channels—we defeat purpose from foundation upward. I ask you to simply check out that which you do—and see if we can discipline selves into conformation.

We of the Command, as we move along here, will be making less and less contact with various ones and we surely do not wish the general masses to “try their hand and mind at this ‘game’”. You need a source of unquestionable TRUTH and ones coming into the writings must know it. We, too, must have focus and “non-generalized” input and output—you have too many “Bibles” as it is.

Let me explain our contacts and why fragmented diversification is unacceptable. It is out of the question and not possible to have random contacts as we approach the time of focused function. Each must contact the truth within but I again caution you of my tribe, do not try to teach all to receive, for you are giving erroneous information for this purpose—reaching within is fine, but I ask that you leave the lessons of “channeling” and “scribing” unto the Higher Command. This is not to pain anyone but I remind you of the human format—when you ask a higher energy for input—he is required to respond if asked in truth—YOU MUST USE THE DISCERNMENT OF PROPER USE OF THE MATERIAL—AND YOU MUST BE VERY, VERY SURE YOU KNOW OF THAT WHICH YOU DO! There are not more than five receivers trained for this job, so I ask that if you are one, you care for that responsibility greatly. I know that which is meant—the general masses do not! Therefore, it is YOU who must be in the use of great and perfect judgment. I, Hatonn, do not relinquish this Command to any—NOT TO ANY!

If contact is opened with an Earth human, then this is based on his prior pre-conditioning, often lasting decades on your placement alone—even if he is not in knowledge of that which is coming forth. This includes guidance in tremendous variety of concerns.

We will only open contact with an Earth human when necessary spiritual conditions are perfected and when sequence of events are proper—this is not something discerned from

human vantage point and humans do not have awareness of that which is required to disallow pre-conceived human ego projections into the equation.

We can only open contact with an Earth human if his development has proceeded so far that he is able to work out and recognize basic truths by himself, alone, without the help of fellow creatures or books or literature being resorted to. This does not mean these items will not be utilized for confirmation and focus—it means that they may have no impact of consciousness. A contact scribe is one who pens or writes exactly that which is projected as nearly to perfection as language translation allows. Does the receiver act in robotic fashion? Yes! When the space is in clearance, it is a physical circuitry which comes into operation—and opinions and reflections must be put aside until such time as the conscious ego can again ponder a given subject. This scribe, for instance, regardless of how it appears to you ones in presence, is specifically from this place to fulfill this particular function upon your place. What is experienced in ego format requires great attention but that becomes moot, for she is in complete justification with our intent and purpose—having been sent for this specific mission. Of course, human impacts are great but not to the extent which might seem to present themselves. If confronted, there will be no deviation in behalf of Earth choices but in many ways she becomes as the child and then it is most important that significant others within her functioning space keep absolute intent uppermost without swaying as to focus. It makes Oberli, for instance, need to be abrupt, strong and unbending—and ones working in this area must come to know as much and be not offended if he seems harsh and/or rigid. He will not even realize WHY he is unbending and/or without human allowances which are his usual attitudes regarding human actions—it is required, for when receiving and scribing, Dharma has no ability in human format to respond or react in clarity.

If we initiate contact with an Earth human without these premises being fulfilled, then such a contact is a preliminary undertaking for special purpose, and usually after achievement of the objective the MEMORY IS ELIMINATED, as for example happens continually with Dharma herself—she spends the majority of her time with us, as do you other ones in this particular mission—and you do not remember as much in your consciousness. This is for your security and the security of the mission—it is with total free-will and agreement. If you cannot seem to understand the requirements and cannot maintain this discipline, then others are placed within the “slots” of function. There are too many impacts of Earth experience on ego consciousness, in some instances, to allow total participation. This is not negative, this is simply the way it IS. Further, if this be the case, it is often of only temporary nature and the one in point is never offended nor slighted—for only the ego consciousness would be slighted—and therein, lies the answer each would seek. If ego consciousness is embarrassed or offended—check most closely, for this mission is one of purity and selflessness. You may have all the opinions you desire but if they differ from your ascribed and accepted mission—you will use the discipline to keep them to yourself except as discussion among your immediate family of brethren.

The human entities are set by contracted agreement and will be specifically suited for a given objective, such as ones who are given to “find” or “discover” specific artifacts or information, etc. We often expect too much of ones, in our own perception, for we have a tremendous task to perform and ones simply are lost to the physical format or are pulled temporarily from the intent by Earth impact or other human entities. We are patient as perceived time allows but sequence moves forward and this cannot always be accomplished. We must work within our own limitations as Cosmic Brothers finding necessity to function within your own similar “time” frame of experience.

If we open contact with an Earth human, then we undergo this in accordance with higher authorization, and with the person specifically designated for this—as with ATON, the Christed Energy, etc. At planetary transitions there is always the total direction from the Higher Source—we act only as the preliminary Hosts under total and complete Command of higher Lighted Resources. One very obvious reason is that too many humans in the first position may upset everything by even the slightest misperception input data and human opinion. It is simply as you put it nicely in the kitchen: “Too many cooks spoil the stew”.

We are not allowed to make ourselves visible to more Earth beings than corresponds with our objectives. This precaution concerns private and military and official desires aimed at taking possession of one of our ships and other such objects of our contacts. Then, as always, discretion is not for the Earth contact to decide nor should he even be informed. You ones want all the “secrets” beforehand without thought of consequences to self or the mission. We are expected to have higher intelligence as to that which is proper and that which is human curiosity. You will note that if we had followed that which you ones desired and required in the beginning of our contacts—you would all be blown away by this point in time! Ponder it before you ask your next “proof” of “purchase”. Because of this, we only cultivate contact with Earth humans known to us, sent by us for a given purpose and proven totally trustworthy in all respects. Sometimes this is simply an agreement that nothing of meaningful content will be left within the consciousness to outlay. There must be total confidence in the security of the objectives in every respect from business instructions to strategy. We bring you knowledge to get you through the transition and to share as we give guidelines—not for you to toy with, gain great riches or disperse at random—we give specifically and exactly as for our special mission with you and your group and further instructions will always be given—usually privately within intended receiving minds.

Testing is intense—ones are expected to perform to the utmost ability of perfection regardless of the task involved—in the upstart it will hardly ever be a task which the human desires and will always require great humility and self-disassociation. If ego-self cannot be set aside, the contact must be forfeited—for the intent is still of Earthly physical need and the contact will not be further contemplated.

With the selected human contact in focus, we initiate communication in most unexpected and

secret ways. This is why simply to sit with pen in hand is foolish, indeed, unless you simply try to contact higher intent of self. Our requirements will be so difficult, disciplined and scrambled that ones of ego-orientation will be totally discouraged. Most early contacts will fit into this category and will usually place meetings, writings, scribing, etc., down the list of priority when confronted with human decision, especially physical choices regarding other ego-fragments. Surprisingly enough, transition of a species and planet, as well as oneness with God, is usually taking second seat to the lover or perceived physical gain or relationship, especially as involves sexual involvements and/or acquisition of material “things”. Sometimes these things are to be first considered—but it is important to see if that priority services God or YOU.

You ones who work with us would blossom at our presence—but most of the ones on your place would panic and be totally terrified, not to even consider the offensive measures that would be undertaken by your military and government. If you think Saudi Arabia looks like an armada to end all armadas—forget the concept—at this point the entire world WOULD unite against us and that is exactly the point being projected by your world leaders.

Sometimes we allow bits of evidence unto the few—and very often it turns into negative response, so we must be most cautious and in spite of that which you of our beloved workers desire, we must use higher and better founded intelligence regarding actions. For instance, we fully intend to participate in the filming of the first projected pictures—however, if at the time security is breached or attention is undue—we will not! Does that mean we are less real? If it means *that* to you involved, I suggest you had better look again at your opinions. If you are prepared in any event—what difference does it make? So be it.

With Earth human—“some” is never “enough”. If we parked a craft in your door-yard, you would not believe it is we unless we pour out all over your property and jeopardize the very crew you demand to see and touch. No, we must use good judgment to the perfection of ability—and we do have a great deal of ability in that measure. Hatonn has been known to err—ATON has not.

#### ALL KNOWLEDGE AND TRUTH ALREADY PRESENT

It is important to consider still another matter of which I shall often be in the reminding. **All truth and knowledge has remained preserved upon your place as brought forth or transmitted right up to this present epoch, though it may be totally forgotten, somewhat forgotten, disregarded and/or lost by the Earth human.** As truth, knowledge, wisdom, and love, and all power of the spirit are unchangeable and constant, and the same in the present, this all must be conceived there and continue upward into man’s higher understanding. In other words, truth, knowledge, wisdom, love and so forth, must simply be brought together again—remembered and integrated.

What you call, by an old (for you) language, the backward relating “religion”, should for this case, and which has to be done, by the same old language, be

called “rel-e-geon”. The definition of the word as broken into meaning indicates that “all has to be brought together again”, which is to be considered rel—e—geously, but not religiously. In consequence, the already existing materials should be newly assembled, to lead into the future. After the “releageon” must begin the way of evolution, which has a two-fold meaning. You know one meaning of evolution as development and unfolding in the sense of something already existing, but still concealed, that must develop, which in a spiritual sense means, must “rise from the sub-conscious towards the conscious”.

The second meaning of this term has been lost to you for a long period of time, namely that something not yet existing is explored, developed, and unfolded, and “becomes”. Because this meaning of evolution was lost, man lives under a false impression that evolving material already exists to be unfolded and developed. However, it is that the indwelling spirit has stored those matters and things which it collected in the course of its material existence in material bodies and lives. This, according to your understanding, is a very large bunch, but in truth is very little in comparison to all that IS.

During innumerable further experiences, the spirit must explore further, must search and must find; thus he must assemble further knowledge, recognitions and experiences which then establish themselves in him as faculties. Because the spirit continues after the material death of the body—and exists within spheres of living of the “other world”—it works upon the achieved results of the other experiences, and fixes these results inside it in what you call the “sub-conscious”. Upon taking up the human form of life, the obtained knowledge and faculty is anchored in the sub-conscious, and must evolve slowly in the human form of life to help in new lessons and recognitions toward developing conscious talents—the God consciousness or “higher supra-conscious” is a compilation of all of soul experience.

Allow us to close this segment, for I wish to discuss prior contacts, their purpose and dispersion of information. It is as usually occurs when higher energy forms touch one another for purpose of presenting truth and spiritual knowledge—the human becomes entangled with that which is exciting, human and greedy in intent. The truth of the higher purpose becomes misplaced in the contact with the unexpected—and exploitation swings into full action. The subject and purpose of the contacts become lost in the reality of the physical presentation. In other words, the Pleiadians become the point and not the purpose of their presence. Once man has been distracted and the slightest projection of falseness of intent enters the picture—the contact is usually lost to God’s intended fullness of purpose, for controversy becomes the issue—not God’s message. So be it.

You need no "sign", Dharma, for your space is clear and I am present. Let us continue with our subject within this *Journal*. To request a "sign" that you might "know" is only to further doubt. Because "another" says 10% of thy truth is tainted means nothing. There is no acceptable percentage of taint within our works. Perhaps errors can occur, for we are producing our work on a human level; perhaps sorting tools of words are used, but not "tainting". The intent, although unwittingly projected, is to stop the publication of these *Journals*. No more and no less. I am sorry for all parties involved but know, chelas, it will always be over worldly material desires that the perpetrators betray themselves. In the instance of the Gatehouse, it is a misunderstanding regarding funds; in the projection of discrediting your material, it is misperception. Do not waste of your time in the pondering of "who" did "what" and further, how can you "lose" of a thing you never "had". You had your perceptions and others had theirs—do not further disturb yourself, for it slows our work. I have heard your call and I have received of it—we have a job to get on with and you shall do so, please. The only Evil present in this space is that which we are in the printing thereof.

Let me surprise you even further—thousands of Satanists will obtain this book. The evil personality loves the ego-stroking of recognition and it will shock some into change. These *Journals* must be distributed far and wide—immediately—the truth is the only thing that can set you free. Ones are now in the scanning of the pages and it requires study and attention to obtain and retain the value from these books. He who simply scans and thinks he has absorbed it all should keep of his negative or discounting opinions to himself, for understanding will not be complete. Nay, unfortunately, for a weary world in trouble, we bring total truth and that is the sad part of it. The joy held within is the "hope" for humanity which is brilliant, indeed. **It is not through the efforts of higher beings; it comes from human realization and action which will produce the positive works and regain control and order from the chaos.** If each does his selected task, we shall get our work done in timely manner and great brotherhood shall spring forth from beautiful unity. So be it; let us continue.

Let us set aside, for the present, the question of "reality" of a being called Satan. That point, whether it appears this way or not, is not the ultimate issue at hand. If a thing exists as reality in the mind, be it singularly perceived or mass perception—it becomes "real".

I would like to insert a parable at this point. Let us say a baby who is at the age of toilet training is being scolded for soiling his diapers. Now, let us say that there is a little puppy within the household; the puppy soils the floor and an adult strikes the animal and it dies of the blow. What think ye the child's mind accepts regarding the dangers of such action? Might the child become totally compulsive and obsessive in some deviation from accepted "norms"?

Let us consider for a moment how a concept becomes instilled within a mind. "Magical thinking" is uppermost and can take a variety of forms but, basically, it is a belief that thoughts in and of themselves may cause events to occur. This is one point that is most important regarding even this document—people think that if they read of it, it then becomes birthed into reality.

Young children normally think magically—and here I do not refer to dreaming and pretending. I speak, for instance, of a child of say, five, who gets jealous of his new baby sister and thinks: "I wish she were dead!" He might very well become totally obsessed and anxious, fearing that she actually will die because he wished it. Or, what if the baby becomes ill, he may be consumed with guilt, feeling that his thought caused her to become ill. Worse, what if for some reason the baby dies—I believe I make my point.

The reason I dwell on these examples is that at some time within the lifespan of such individuals, they are very apt to make a "pact with the devil". Now why wouldn't one make a "pact with God"? Because the mind within knows the source of the problem and knows it is not "normal" belief or action to believe in "magic". "Magic" is somehow mentally related to "evil".

It is when man faces unthinkable danger, sorrow, pain, etc., then is when he makes unbalanced promises to God. He further does not seem to be too concerned with the breaking of these promises to God. He really is nervous about breaking a pact with the Devil. Do you find this interesting?

This is the danger of placing total trust in a fortune-teller; if, even in error of calculations of star signs, one is told he will die at a certain place and time, he will usually manage to do so—that is the horror of a "curse", for it is the belief in the magic itself.

Let us assume, further, that one of the above individual's beliefs were based in Christianity. Now you have presented an almost impossible confrontation to overcome. According to this model, humanity (and perhaps the universe) is locked in a titanic struggle between the forces of good and evil, between God or Christ and the Devil, Satan. The battleground of this struggle is the individual human soul. The entire meaning of human life revolves around the battle. The only question of ultimate significance is whether the soul will be won to God or won to the devil.

By establishing a pact with the devil, a relationship of terrifying "reality" has been fixed within the mind. Now, the only way left to the individual is to dare to retract the pact and turn to the God source for protection. It is not thus, but in a terrified mind it is the only solution. This neurotic symptom, confronted, is often a crucial turning point of existence within an individual which usually has cosmic significance.

We have now spoken of one aspect of magical belief which can leave a person crippled and the perceptions clouded as to truth. No psychiatrist can "reason" a return to health, nor can the individual afflicted recognize his problem—for the truth of the cause of his actions which would cause a pact with the Devil is hidden in the first place.

Now, here is where the self must go within and find the incident which caused the disarrangement in the first place and confront it head on. This is where a trained hypnotherapist working in integrity can be the only helpful entity. The mind must move within self and "remember", which it cannot do while in a conscious state of being.

This is why, however, man lumps the hypnotist in the category of Devil's advocate and assistant; because evil does not want to let go once it has claimed a subconscious mind for itself.

It is most interesting to note that the medical profession does not have a very broad-minded approach to Evil as a valid factor and has refused to come up with a classroom field of psychology of evil. Why would this be so? Because the concept of evil has been central to "religious" thought for millions of years. Therefore, you will keep it separated from your science of psychology—and your human edicts come down "thou shalt not mix the two".

Somewhere in the era of Mr. Galileo it became an unwritten social contract that "natural" and the "supernatural" would forever be alienated.

Now look what you have set up in your involvement with such attitudes. Religion agreed that the "natural world" is the sole province of the scientists. Science agreed, in turn, to keep out of the spiritual, or anything to do with "values". Indeed, science defined itself as being "value-free".

But how can you leave the most crucial cause out of mental unbalance? Well, you cannot and, therefore, you continue to have distorted, valueless humanity in epidemic proportion. Worse, the medical discipline will accept the tool of hypnosis only on their limited and inept guidelines—partially for fear they will assist in "curing" the patient and lose of the mammoth income guaranteed by mental illness.

It is a most difficult subject, indeed, for it is a most non-definable term—and science must have defined guidelines and labels for everything. Theologians suffer no such compunction and will bite off all manner of evil demons whether or not they are, in reality, present. There is no left brain/right brain delineation for the theologian. Let's just exorcise the demons and hope the human survives. Sometimes there is demon possession and it works; most often it is mental misperception of fact and the patient is more traumatized by the ordeal and sent to his demise in an institution as "hopelessly insane".

The problem of evil is a very big mystery, indeed. It does not submit itself easily to reductionism. However, some questions about human evil can be reduced to a size manageable for proper scientific investigation. Nonetheless, the puzzle pieces are interlocked and severing them one from the other is all but impossible.

Your major problem when regarding evil is that it cannot be separated from goodness. For were there no goodness in the world, you would not be considering the problem of evil. I am constantly petitioned with, "Jesus, why is there evil in the world?" Why do ye not ask me,

“Why is there good in the world?” Well, let me give you a few observations that we might get the boring lesson matter over with and on to the violence of present evil, which you all seem to attune to much faster.

**Evil is always in opposition to life.** It is that which opposes the life force. It has, in short, to do with “killing” (murder)—namely, unnecessary killing, killing that is not required for biological survival. Don’t get confused by the abstract definitions intellectually thrown at you which render the explanation irrelevant. MURDER IS NOT ABSTRACT.

Don’t err in restricting murder to the corporeal state. **Evil is also that which kills spirit.** There are various essential attributes of life—particularly human life—such as sentience (emotional), mobility, awareness, growth, autonomy and “will”. It is possible to kill, or attempt to kill, one of these attributes without actually destroying the body. Thus you may “break” a person without harming a cell or hair on the physical body.

The desire for “breaking” of another, is usually the desire for control of that other—to make them controllable, to foster their dependency, to discourage their capacity to think for themselves, to diminish their unpredictability and originality, to keep them in line. This would be a term described in your vocabulary as “necrophilia”. The opposite of a necrophile would be a biophile. A biophile is a person who appreciates and fosters the variety of life forms and the uniqueness of the individual; whose aim it is to avoid the inconvenience of life by transforming others into obedient automatons, robbing them of their humanity.

Evil, then, is that force, residing either inside or outside of human beings, that **seeks to kill life or liveliness.** Goodness is its opposite. Goodness is that which promotes life and liveliness.

#### THE CENTRAL MESSAGE, WHETHER OR NOT YOU LIKE OF IT

You are going to take God, Christ-ness, and yourselves far more seriously than you now do. From the very beginning you have been told that God created you in His own image. When are you going to take that seriously? When are you going to recognize and accept the responsibility that you are Godly beings? When will human life again have sacred importance?

I am come that you might have life, and that you might have it more abundantly. Does it strike you as so strange that I, too, relished the things of the physical life and lived abundantly even two thousand years ago? I was not so strange, I enjoyed weddings and celebrations, wine, fine oils and good companionship. Length of a life-span is of very little value compared to the vitality in the living.

I repeat—let the dead bury their dead, for if you are alive it has no relationship to you. I dwell on the spirit of life, in liveliness.

Satan, the very spirit of evil, was a murderer from the beginning. Evil has nothing to do with natural death; it is concerned only with unnatural death, with murder of the body or the spirit. You ones in human format must take your human life so seriously that you also take human evil far more seriously—seriously enough to study it with all the means at your command, including the methods of science. You must recognize evil for that which it is, in all its ghastly reality. This is not morbid. To the contrary, it is in dedication to “life... more abundantly”. The valid reason to recognize human evil and study it well is to allow of the healing wherever you can, and eventually wipe its ugliness from the face of this wondrous Earth.

You can no longer simply turn your eyes and ears away from the problem which is growing in boundless

measure—you must look at it most minutely and with intent to heal humanity of this blight. Healing is the result of love; it is a most closely integrated relative of love. Wherever there is love, there is healing. Where there is no love, there is no healing. There must be love of life and respect and reverence for life and livingness—man turns to the Satanic cults and worship to “belong”, therefore, to heal there must be “belonging” and love offered in abundance along with human caring.

You must know that all dis-ease is physical AND emotional so both must be considered in any instance. You must further be able to distinguish between human evil, such as murder, and natural “evil” as perceived through death and destruction resulting from fire, flood, and earthquake.

Further, do not be misled into the assumption and perception that real evil does not have anything to do with a mother of one or five children who lives next door, or the deacon or minister in the local church building. Evil human beings are most common and usually appear quite ordinary and are mostly located in just such places.

There are several “levels” of evil possession and let us consider them in lumps. One type of evil concerns those in the process of “sliding” into evil. The other concerns those who have already slid, “fallen victim” to and been taken over by “radical” evil. These are simply recognized myths upon your place and I find them suitable enough for description.

#### THE HELPLESS CHILD

This is a most unpleasant confrontation, for parents do not wish to believe that they perpetrate evil upon their children unless they are openly practicing Satanic rituals. However, the most abundant form of evil is passed through in just such manner.

To children, their parents are like gods. The child assumes that that which the parent does is the way that things should be done. They are not able to make realistic assessments of their parents’ behavior. Treated badly by its parents, a child will usually assume that it (the child self) is the “bad” one. If treated as an ugly, stupid second-class citizen, it will grow up with an image of itself as ugly and stupid, etc. Reared without love, children come to believe themselves unlovable. Whenever there is a major deficit in parental love, the child will, in all probability, respond to that deficit by assuming itself to be the cause of the deficit, thereby developing an unrealistically negative self-image. They will ultimately respond to what they perceive as some type of evil within themselves.

So what does this all have to do with evil in general? Well, if you confront a child in trouble—look for the evil within the parental beings. You will know and recognize it when it comes into your presence. You, if you are within the Lighted protection, will be revulsed by the presence when it enters into your space. You simply will find the humans of evil-ness most unpleasant within your proximity. This is a most saving response to the impacted one—however, if a child is involved and being in the living hell of a victim—you have responsibility to that little being.

There will be many symptoms to show you—for evil is obligated to wear a sign upon its countenance. First you will be uneasy in its presence, there will be a mixed note of fear and pity, and those possessed of evil live in sheer terror—for they most often are attempting to keep that portion of their being quite secret and thus hidden away. **BEWARE IF YOU KNOW ONE IS PRACTICING EVIL IN ANY FORM AND YOU ARE COMFORTABLE IN THAT PRESENCE—YOU ARE IN TROUBLE!**

#### EVIL VS. SIN

Let me draw a simple distinction between sin and evil, for both are constantly misunderstood. **SIN IS NOTHING MORE AND NOTHING LESS THAN FALLING SHORT OF PERFECTION—IT IS A FAILURE TO BE CONTINUALLY PERFECT WHETHER INTENTIONALLY OR ACCIDENTALLY. BECAUSE YOU ARE ALL HUMAN, IT IS IMPOSSIBLE FOR YOU TO BE ALWAYS IN PERFECTION; THEREFORE, ALL ARE SINNERS. “SINNERS” ARE NOT EVIL.**

**EVIL ONES ARE ONES WHO ARE SELF-RIGHTEOUS WHO BELIEVE THEY ARE WITHOUT SIN BECAUSE THEY ARE UNWILLING TO SUFFER THE DISCOMFORT OF SIGNIFICANT SELF-EXAMINATION.**

Unpleasant though it may be, the sense of personal sin is precisely that which keeps your sin from getting out of control. It is painful at times, but is a very great blessing because it is your one effective safeguard against your own proclivity for evil.

**IF YOU ARE WILLING TO SERENELY BEAR THE TRIAL OF BEING DISPLEASING UNTO YOURSELF, THEN YOU WILL BE FOR ME A MOST PLEASANT PLACE OF SHELTER.**

Evil ones *do not* serenely bear the trial of being displeasing to themselves. In fact, they don’t bear it at all. There is almost an unbelievable lack of self-recrimination in evil ones. They are prone to openly state flagrantly their selfish actions without any seemingly hesitation whatsoever.

The varieties of people’s wickedness are manifold. Resulting from refusal to tolerate the sense of their own sinfulness, the evil ones become uncorrectable grab-bags of sin. They are, for instance, remarkably greedy people. Thus they are cheap—so cheap, in fact, that their “gifts” may, indeed, even be murderous in nature.

Sin is usually due to physical or character laziness and that is followed closely by pride. Sins are quite repairable—except the sin of believing one is without sin.

Here I wish to give great credit to author Gerald Vann for *THE PAIN OF CHRIST AND THE SORROW OF GOD* (Temple Gate Publishers, Springfield, Illinois, Copyright by Aquin Press, 1974, pp. 54-55). I shall herein quote, for understanding most often comes as understanding from human viewpoint:

“There can be a state of soul against which Love itself is powerless because it has hardened itself against Love. Hell is essentially a state of being which we fashion for ourselves; a state of final separateness from God which is the result not of God’s repudiation of man, but of man’s repudiation of God, and a repudiation which is eternal precisely because it has become, in itself, immovable. There are analogies in human experience: the hate which is so blind, so dark, that Love only makes it the more violent; the pride which is so stony that humility only makes it more scornful; the inertia—last but not least the inertia—which has so taken possession of the personality that no crisis, no appeal, no inducement whatsoever, can stir it into activity, but on the contrary makes it bury itself the more deeply in its immobility. So with the soul and God; pride can become hardened into hell, hatred can become hardened into hell, any of the seven root forms of wrongdoing can harden into hell, and not least that sloth which is boredom with divine things, the inertia that cannot be troubled to repent, even though it sees the abyss into which the soul is falling, because for so long, in little ways perhaps, it has accustomed itself to refuse whatever might cost it an effort. May God in his mercy save us from that.”

SCAPEGOATING

**A most predominant characteristic of the behavior of the evil person is the constant scapegoating. Because these ones feel themselves above reproach, they must lash out at anyone who reproaches them. They will sacrifice any other to preserve their own self-image to the point of total absurdity to the witnessing entity. They will go to preposterous limits to preserve that self-image of perfection. Since the evil, deep down, feel themselves to be faultless, it is inevitable that when they come into conflict with the world, they will invariably perceive the conflict as the world's (or other's) fault.** Since they must deny their own badness, they must perceive others as bad. They project their own evil onto the world. They never think of themselves as evil; on the other hand, they consequently see much evil in others and proclaim it most loudly.

One author on your place defined evil “as the exercise of political power, that is, the imposition of one’s will upon others by overt or covert coercion—in order to avoid... spiritual growth”. In other words, the evil attack others instead of facing their own failures. Spiritual growth requires the acknowledgment of one’s need to grow. If you cannot make that acknowledgment, you have no option except to attempt to eradicate the evidence of your imperfection.

Incredible as it may appear, evil people are often destructive to unlimited extents because they are actually attempting to “destroy” evil. The problem, of course, is that they misplace the focus and locus of the evil. Instead of destroying others, they should be destroying the sickness within self. As life often threatens their false self-image of perfection, they are most often busily engaged in hating and destroying that life—usually in the name of righteousness. The fault, however, may not be so much that they hate life as that they do NOT HATE THE SINFUL PART OF THEMSELVES.

**You must associate some words with evil people and those are “image”, “appearance”, and “outwardly”. While evil persons seem to lack motivation to actually be good, they intensely desire to appear good. Their “goodness” is all on a level of pretense. It is, in effect, a lie and the lie is not so much to deceive others as it is to deceive self. These evil ones will not endure the pain of self-reproach.**

AH, SO—RIGHT OR WRONG

Self-deceit would be unnecessary if the evil had no sense of right or wrong. You lie only when you are attempting to cover up something you know to be illicit. There is no need to hide unless you first feel that something needs to be hidden.

Yes, a paradox! Evil people feel themselves to be perfect; however, at some unacknowledged level of sense, they know themselves to be most imperfect—which, of course, is intolerable and begins the cycle all over again. At one and the same time, the evil are aware of their evil and desperately are trying to avoid the awareness. Rather than blissfully lacking a sense of morality, like the psychopath, they are continually engaged in sweeping the evidence of their evil under the floor covering of their own consciousness. Therefore, the essential component of evil is not the absence of a sense of sin or imperfection—but the total unwillingness to tolerate that sense. Just as with other problems, a

good example of which is alcoholism—until the problem is accepted and acknowledged, there will be no cure.

You can usually recognize evil by its very disguise. The lie can be perceived before the misdeed it is designed to hide—the cover-up before the fact. You can witness the smile that hides the hatred, the smooth and oily manner that masks the fury, the velvet glove that covers the fist. Because the evil are such experts at disguise, it is seldom possible to pinpoint the maliciousness of the evil. The disguise is often impenetrable—but what you can catch are glimpses of the uncanny game of hide-and-seek in the obscurity of the soul, in which it, the single human soul, evades itself, avoids itself, and hides from itself.

**Since the primary motive of the evil is disguise, one of the places evil people most often are found is within your churches. Does this make you feel comfortable? How better to conceal evil than to be a deacon or some other highly visible form of Christian within your culture? In other parts of the world you might have to turn to the good Hindu or good Moslem, etc. This is not to cast the spotlight on the whole but rather to point out that evil people tend to gravitate toward piety for the disguise and concealment it can offer unto them.**

What might help distinguish the evil from the rest of you “sinners” is the specific “type” of pain they are running away from—for all are running away from pain toward that which they classify as happiness and joy. The evil are not pain avoiders or lazy people in general; to the contrary, they are most exerting in their continuing effort to obtain and maintain an image of high respectability. They may very willingly, even eagerly, undergo great hardships in the search for status. It is only one particular kind of pain they cannot tolerate and that is the pain of their own conscience, the pain of the realization of their own sinfulness and imperfection.

The evil hate the light—the light of goodness that shows them up, the light of scrutiny that exposes them, the light of truth that penetrates their deception. **The evil will, further, attempt to annihilate any and all who cast light on them and their activities and, therefore, the light bearer becomes, in fact, the target of the evil aggressor.** To maintain the dark secret, the light must be extinguished at any cost—participants of a group of evil congregates must cause ALL to practice some extent of total evil action to maintain the lie. Through participation is always the threat of discovery, so threats—so heinous in nature that one would be terrified to reveal truth—must be employed. And so be it that we will leave this portion at this point. It has been a lengthy session and it is time for a respite.

I will move to stand-by, that this chapter might be brought to a close.

POWER AND CONTROL

The drive most noted in evil persons is characterized by unsubmitted will. All ones who are mentally healthy submit themselves one way or another to “something” higher than themselves, be it God or truth or love or some other ideal. They look beyond into truth instead of just “the way I want it to be”. In other words, what is needed by that “other” “beloved one” becomes priority rather than the total selfishness of self-desires and self-gratification. **In yet other words, healthy individuals submit themselves to the demands of their own conscience. Not so the evil ones, for in the conflict between their guilt and their will, it is the guilt that must go and the will that must win. Evil people are extraordinarily willful, determined to always have their own way and have a most remarkable power in the manner in which they attempt to control others.**

You ones go about the decision of evolution against creation and cannot come to balance, for man is so obviously strong-willed in choices—and desires control beyond reason. Your scenarios never change—you never learn by that which goes before in the history lessons.

You tempt yourselves into acceptance that the problem of evil lies in the will itself. Perhaps the evil are born so inherently strong-willed that it is impossible for them ever to submit their will. And yet, a characteristic of all “great” people is that they are extremely strong-willed—whether their greatness be for good or for evil. I, Jesus, as you called me, was unbending and strong-willed; ah, but so was one named Hitler—could it be the difference in “willingness” and “willfulness”? Mine willfulness was that of our Father’s—Mr. Hitler’s was that of his own.

It also becomes evident, doesn’t it, that the one whose will is of his own is threatened greatly by goodness? It, therefore, leads to the need of destruction of the goodness or that one which represents such. Thus murder is born. It is better, of course, if the evil one can cause the one of goodness to acquiesce in total submission and give through total abandonment of goodness into the hands of the evil.

I think your psychiatrists might label this type of behavior of self-demand, narcissism. It is not strong enough a term for evil—so let us call evil a disease of cancerous, or malignant, narcissism. Your church authorities have generally considered pride first among the “sins”. “Pride goeth before the fall”—and so it is. Pride is actually the same as cancerous narcissism, but I want you to realize I can also speak your “hidden” languages.

Somehow within the minds, from onset of Adam and Eve in your mythology, there has been envy and pride. Cain felt somehow less than Abel in God’s eyes, so he proceeded to solve the problem in the typical fashion—murder him. The same happened, dear brothers, when God required Christ and Satan to each present a plan for dealing with the infant human race. Satan’s plan was simple, of the sort that most business and military leaders of today would choose. God had armies of angels at his command; just assign an angel with punitive power to each human, and He would have no trouble keeping them in line. Christ’s plan was radically different and more imaginative and biophilic: Let them have free will, and go their own way; however, let me live and die with, and as, one of them, both as an example of how to live and of how much You care for them. Of course, you will assume that God must have chosen the Christ plan as being the more creative. Of course, Satan rebelled at the choice. The rest of the story is clear. **WAS IT SIMPLY POOR CHOICE ON MY PART? CAN GOODNESS ULTIMATELY WIN OVER EVIL? WELL, ULTIMATELY, IT HAS**

**ALWAYS ENDED IN NEAR ANNIHILATION OF THE SPECIES—AND SO IT WILL AGAIN. THE ENERGY UNBALANCE BECOMES SO DESTRUCTIVE THAT THE GAME MUST BE BROUGHT TO A HALT TO KEEP FROM IMPACTING THE UNIVERSE AS A WHOLE. OH, YOU DON'T LIKE THAT WHICH IS BEGINNING TO SEEP INTO THY VISION?**

While man has rewritten his guidebooks to proclaim the soul goes “somewhere” or “nowhere” or “anywhere”, the words mean naught to the soul—it just goes on and on and on experiencing and growing.

#### COULD IT BE?

**COULD IT BE, DEAR ONES, THAT GOOD GETS BETTER AND EVIL GETS EVEN MORE EVIL UNTIL ULTIMATELY BOTH HAVE MATURED TO A POINT OF PERFECTION IN THE EXTREMES? COULD IT BE THAT BOTH ARE COMING AGAIN UPON YOUR WONDROUS PLACE FOR THE MAJOR CONFRONTATION? COULD IT BE THAT YOU ARE NOW REQUIRED TO MAKE SOME FINAL CHOICES FOR THAT CONFRONTATION IS AT HAND? I UNDERSTAND THAT YOU PREFER TO THINK THAT THERE IS A SIMPLE LITTLE NEGOTIATION AND ALL IS LAID TO REST. NAY, IT SHALL BE MAJOR NEGOTIATION AND CONFRONTATION—AND ULTIMATELY GOD AND THE CREATION (NATURE) SHALL INTERVENE.**

It can be noted upon your place that evil generally “runs” in families. Would that not be logical? If parents are cruel and unloving, however, or the childhood otherwise traumatic, then the child will need his own “pride” to preserve as a fortress against the vicissitudes of an intolerable life. It is the same with the genesis of human evil. Even in architecture, the builders of your medieval cathedrals placed upon their buttresses the figures of gargoyles—themselves symbols of evil—in order to ward off the spirits of greater evil. Thus children may become evil in order to defend themselves against the onslaughts of parents and elders who are more evil.

The facts are, that some of you are very good and some of you are very evil—and most of you are somewhere in between. Now, as individuals you can move yourselves one way or another along the continuum. Unfortunately, it works out to be much like the rich getting richer and the poor getting ever poorer—it seems most evident that the good get better and the bad get worse.

Your capacity to choose, changes constantly with your practice of life. The longer you continue to make the wrong decisions, the more your heart hardens; the more often you make the right decision, the more your heart softens—or comes alive.

Each step in life which increases your self-confidence, your integrity, your courage, your conviction, also increases your capacity to choose the desirable alternative, until eventually it becomes more difficult for you to choose the undesirable rather than the desirable action. On the other side, each act of surrender and cowardice weakens you, opens the path for more acts of surrender, and eventually freedom is lost. Between the extreme when you can no longer do a wrong act and the extreme when you have lost your freedom to right action, there are innumerable degrees of freedom of choice. In the practice of life, the degree of freedom to choose is different at any given moment. If the degree of freedom to choose the good is great, it needs less effort to choose the good. If it is small, it takes a great effort, help from others, and favorable circumstances, indeed.

Most people fail in the wondrous art of living, not because they are inherently “bad” or so without will that they cannot lead a better life; they fail because they do not wake up and see when they stand at a fork in the road and have to decide. They are not aware when life asks them a question, and when they still have alternative answers. Then with each step along the wrong road it becomes increasingly difficult for them to admit that they are on the wrong road—often only because they have to admit that they must go back to the first wrong turn, and must accept the fact that they have wasted energy and time.

Therefore, you might conclude that human evil is a process whereby evil choices require ultimately becoming evil. Ah, but this underestimates the very power of the “will” itself. Ones continually make evil choices (such as becoming blood affiliates with Satanic churches) for no apparent reason at all except through pure desire to exert freedom of his or her will. They know exactly what they are doing. They know what is supposed to be the right action but refuse to be bound to notions of morality or even to their own conscience. In other words, if they do the good thing, it would be simply because it is the good thing. If they do the bad thing, however, it is solely because of desiring to do so. The choice is usually to do the bad thing, because it is a freedom of choice to do so.

#### EXERCISING FREEDOM OF CHOICE

Sometimes only the agony of free choice remains to an individual—only the will remains.

When you are right “up against it” the unknowns outweigh the knowns—and just as with a crucifixion staring you in your human face, you become all but helpless in the terror. This is because those terrors are engraved upon the soul memory forever—for each act becomes a portion of memory and the total fear of the unknown. Death of a body comes most hard in most instances and always most outrageously at the hands of evil.

Once steeped in evil—“possessed” is the literal word—the casting off of that energy is all but physically and mentally death producing. Evil consumes and “takes over”, the light of goodness requires the freedom of will and choice—always remember the difference and you will understand which is assisting you in your choices. When faced with the ultimate rejection of the evil, all manner of attacks come upon the mind and physical frame and the demon itself becomes king of the hill.

At a time such as this, the mind will relinquish all logic attached to mental illusions about psychological motivations, behavioral stimulations, rationales, mentalistic hedges, situational ethics, social loyalties and communal shibboleths—all these large named states of mental being go where they belong—into the waste heap. For in the end all you have remaining is your “will”. All that remains is your choice of free will. How many free-will choices will you make before you make the ultimate one? How many have you already made? I speak of choices without outside stimuli or background in memory; without any push from acquired tastes and persuasions; without any impetus from a desire to live or die—for at some point you will actually be indifferent to both. At some point in this journey you will be as the mouse who sits equidistant from his favorite cheeses and yet starves to death because he cannot decide which way to go.

Ah, but the paradox, on the one hand, free will is a reality and you can be free to choose without “shibboleths” for criterion of a distinctive grouping—or accepted common ideas; or, on the other hand, you cannot choose “freedom” itself. **There end up being only two states of being:**

**submission to God and goodness or the refusal to submit to anything beyond one's own will—which refusal automatically enslaves one to the forces of evil. You must ultimately belong either to God or the devil.**

Every square inch and every split second in the universe is claimed by God and counterclaimed by Satan—there is no neutral ground even for you fence-sitters and middle-of-the-road standers—ultimately, there must be a choice. You can assume that the only true state of freedom is to stand exactly halfway between God and the devil, uncommitted either to goodness or to utter selfishness—but that freedom shall be torn apart, for it is intolerable and, in fact, the choice is already made by the inaction toward either.

#### RECOGNIZING THE DIS-EASE

Realize, please, that in accepting a situation as existing and the ability to label that situation gives some amount of power over it. So far “evil” as a state of being is unnamed in your lexicons—you “feel” certain emotions and instinctive “feelings” in the presence of the energy—revulsion, dread and unease. However, the emotional range is too large to actually categorize by explicit guidelines, just as is goodness.

You cannot, however, even begin to deal with a disease until you identify it. The help or treatment of an illness begins with its very diagnosis. But what of evil? Can it ever be defined as “illness”? The people labeled evil are rarely crazy or mad. They are not babbling, drooling or demented in a defined sense.

At this point I wish to interrupt this thought to allow you to ponder something. Very often when an extremely evil person is taken away from his setting of evil doing—let us say, arrested and cast into prison, there is often an extreme change to God. This is by no means “always” but is especially evident in young Satanists who are caught in the emotional “high” of a moment. Why do you believe this to be so? Because the devil energy is through with them—they have outlived their usefulness and contribution ability. **GOD NEVER TURNS AWAY NO MATTER HOW LATE THE HOUR NOR THE ACTIONS BEFORE THE RETURN TO GRACE.** Further, removed from the constant bombardment of the hypnotic “spell” of the evil lords and the company of the band of hoodlums—reality returns vision and perspective. **Evil must feed on itself to survive—remove the food source and the entity can return to a semblance of order and balance.**

**THERE IS SOMETHING YOU WHO WOULD CAST BLAME MUST KNOW. THE CHOICES TOWARD EVIL ARE WILLINGLY MADE REGARDLESS OF CIRCUMSTANCES AND FURTHER, NOTHING WHICH IS COMMITTED IN A STATE OF HYPNOTIC TRANCE IS BEYOND THE CAPABILITY OF THAT INDIVIDUAL IN A STATE OF CONSCIOUSNESS. THIS IS ABSOLUTE!**

Well, it is obvious that you cannot place a medical diagnosis upon evil—for then you would need diagnose good as a disease. You have quite a gathering of humanity upon Earth at this time and you can look at a few outstanding potentials.

There are a sufficient number of people in all cultures and at all times who have achieved in their full adulthood a kind of gracefulness of existence so that you can generally say of them: “They have become truly ‘human.’” By that description it would indicate that their lives actually touch on the divine. You can study those people and examine their characteristics and find that they are wise, aware, enjoy life with fervor, yet face and accept death;

they not only work productively but creatively, and they obviously love their fellow human beings, whom they lead with a benignity of both intent and result.

You will observe, however, that most people are so crippled in body and spirit that they cannot possibly ever attain such a lofty condition, even through their best efforts, without massive therapeutic assistance. Among these latter crippled legions—the mass of suffering humanity—the evil reside, the most pitiable of all humanity. Man will require that their own bodies become infirm that the choices seem to be taken from their own control—however, it is equally as obvious that the very act of such is having made “the choice”. Ones victimize themselves and, of course, it is mostly at a level beyond that which the consciousness understands. These results can be traced back to causative factors within the individual’s experience, let us example: A person has an attack of asthma every time they feel ignored, stressed, isolated or uncared for. Are they victims? They are victimized by self; their motives, failures, and choices are deeply and intimately involved in the creation of their injuries and diseases. Although ones who have these psychosomatic illness all have a degree of responsibility for their condition, you still consider them ill. But evil fits no such category, so it is difficult to classify it as an illness—for it fits both the category of cause and effect.

Evil in an individual can almost always be traced to some extent to his or her childhood circumstances—the sins of the parents and the nature of their heredity. Yet evil is always a choice one has made—indeed, a whole series of choices. We do not speak here of “justification of choices”; we simply must recognize “choice” involvement.

Well, if you can “diagnose” evil, it must indicate illness or disease which is any defect in the structure of your bodies or personalities that prevents you from fulfilling your potential as a human being. BUT, OFTEN EVIL ONES DO FULFILL THEIR POTENTIAL IN A MOST HORRENDOUS MANNER.

Further, there is no medical cure for evil. To cure evil requires a final choice to turn from evil into goodness. It is, however, necessary that the phenomenon be looked at most carefully—for if evil is, indeed, an illness, it should then become a research project like any other disease. But it actually only requires a choice of action and no amount of forcing of “treatment” will change an iota of the status of the so-called patient, any more than all the forcing of evil upon a truly good person will change his intent. Well, both evil and goodness can be labeled as diseases—the ultimate diseases, for it is in the state of one or the other that a man will pass from one dimension into that of another and will further decide where the entity is destined to function in that “other” dimension. Ah, yes, it is most confusing and yet most cut-and-dried (I believe is your suitable statement). Ones will either move into the ultimate separation from God or to oneness with God—or a zillion choices of in-between experiences at differing levels of soul growth. It will ultimately be, however, individual choice—meanwhile, the higher energies are drawing up sides and you, friend, will make your choice! So be it and selah.

## STORM TACTICS: WATER

There are three things of absolute importance to mankind’s survival—energy, fertile soil and water. Without soil and agricultural water, we wouldn’t have food. Without drinking water our bodies couldn’t survive. Water is the medium that connects life to the minerals in the soil, which become the nutrients for all plant life. There is no substitute for water.

Increasingly, we are seeing chronic water shortages around the globe in close to 40% of the world’s population centers. It is severe enough that last year water ministers from around the world met at a summit in the Netherlands to discuss a pending water crisis. The U.S. Central Intelligence Agency, in its “Global Trends 2015: A Dialogue About The Future With Non Government Experts,” listed water problems as possible reasons for international tensions and war during the next 15 years.

In fact, Middle East tensions are currently rising over water rights between Turkey, Israel, Syria and Iraq. Turkey’s eagerness to sell water to Israel, while reducing the flow of the Tigris and Euphrates to its Arab neighbors, is placing Ankara in a dangerous position. Water is more important in the Middle East than oil. The current dispute over the water rights of the Tigris and Euphrates could be a *casus belli* for years to come. Last year Sudan’s former Prime Minister Sadiq al-Mahdi threatened war over the water rights of the Nile. In the end, the ultimate battle in the Middle East may be over water—not oil.

In April of last year, a bipartisan House caucus was convened to discuss the growing problems with our nation’s water infrastructure. Municipalities that face a growing water crisis are calling for major Federal legislation similar to the TEA-21 Transportation Bill and the AIR-21 Aviation Bill. Over the next two decades, it is estimated human water consumption will increase by over 40% and water demand for agriculture will grow by 17%. The impetus behind these various public interest groups is for federal funding to repair and meet existing water infrastructure and meet standards of the Clean Water and Safe Drinking Water Acts. According to the Water Infrastructure Network (WIN), America’s water and wastewater systems will have to invest \$23 billion a year over the next two decades to meet the standards of the Clean Water and Safe Drinking Acts. Yet while government statutes require new standards, federal contributions to water and wastewater continues to decline. According to WIN, current federal funding is about \$3 billion a year when \$23 billion a year is needed. In essence, we have been legislating new standards without the funding necessary to meet them.

According to WIN, there are three major areas of core water infrastructure needed to meet this country’s demand for clean safe water. [1] drinking water supply systems, [2] domestic wastewater management systems, and [3] wet weather runoff control systems and management practices. To meet these needs will require cooperation among federal, state, and local authorities.

The private sector will also play a growing role. The problem with cooperation today is that the water industry is made up of an amalgamation of several sectors. They range from municipal water districts, water utilities, filtration and equipment companies, to the beginnings of a water resource commodity market.

The government will be reluctant to fund the entire needs of upgrading and replacing the nation’s aging and deteriorating water infrastructure. This opens opportunities for the private sector. Water utilities are expanding into the home and commercial water treatment market. There is growing acceptance of private water utility operators, especially as municipal budgets become constrained. There are over 55,000 water systems in the U.S. Most of them are small and inefficiently run. The potential for consolidation is wide open. Faced with an aging water system, many municipalities are turning to the private sector. Some are selling their systems in an effort to privatize, while others are seeking joint ventures.

As water gains national attention, it will afford new opportunities for investor-led water utilities. The future will be favorable for private sector companies connected to the needs of our nation’s water infrastructure. There will be opportunities for water utilities, water treatment equipment and systems management companies, construction and engineering firms.

The water-related industry is relatively small. It is made up of U.S. water utilities, international water utilities, water filtration and treatment companies, and water resource management companies. The capitalization of the whole sector is small in comparison to most S&P 500 companies. Most of the companies in the industry are small to mid-cap. The foreign companies are the largest. However, consolidation within the industry affords investors many opportunities. Buyouts will continue and eventually a few giants will emerge to dominate the industry. Right now it is in its infancy. It would surprise most investors to discover that the water industry has been outperforming the market.

Energy and water are key resources to any nation’s prosperity. Today’s nation states will increasingly find themselves in conflict over access to the Earth’s vital resources. Minerals, energy, and water have been involved directly and indirectly in warfare. We have already fought two world wars and one regional war during the last century over oil. Oil was at issue in two of these wars and the victors were those who had access to oil—and controlled it. The one resource that is essential to all sides in warfare is water. Water, along with oil, are key resources for which wars have been fought over in the past and will be fought over in the future.

**[JR: Water will be the “new wave of the future” for investors. It will outdo oil as earth’s most precious resource. Unlike oil, water sustains the life of all living life forms. Tensions are now growing in the Middle East over water rights and is an issue growing in our own Southwest. Our filtration systems are outdated and need upgrading to filter out the new strains of bacteria and parasites now present in our waters. Watch for the globalist**

**speculators to come in and control the water, just as they do with oil, gas, minerals and precious metals. Privatizing of public water systems will give control over to the (UN) elitist speculators who have already gained control of the lands and their use.]**

### THE HOAX THAT STARTED A WAR

#### ***How the U.S., NATO and the Western media were conned in Kosovo***

Back in March, 1999, what tipped the scales for then U.S. president Bill Clinton to launch an air war against Serbia, were reports of a massacre of 45 Albanian civilians by Serb security forces at the village of Racak, some 30 km from Pristina in southern Kosovo.

Clinton told the world on March 19, 1999: "We should remember what happened in Racak... innocent men, women and children were taken from their homes to a gully, forced to kneel in the dirt and sprayed with gunfire." Photos circled the world. NATO bombing began March 24, and lasted 78 days.

White House press secretary Joe Lockhart said of Racak: "A strong message will be brought to President (Slobodan) Milosevic about bringing those to justice who should be punished for this..."

U.S. Foreign Secretary Madeleine Albright, eager to make war against then-Yugoslavia and speaking on CBS' *Face the Nation*, cited Racak where, she said, there were "dozens of people with their throats slit." She called this the "galvanizing incident" that meant peace talks at Rambouillet were pointless, "humanitarian bombing" the only recourse.

Germany's Foreign Minister, Joschka Fischer, told the newspaper *Berliner Zeitung* that the Racak massacre "became the turning point for me" and war was the only answer.

Canada's then foreign minister, Lloyd Axworthy, called the massacre "a disgusting victimization of civilians."

Human Rights Watch (HRW) reported the dead had fingernails torn out—evidence of torture.

On Jan. 16, the day after the actual massacre, William Walker, the veteran American diplomat who headed peace verifiers for the Organization for Security and Co-operation in Europe (OSCE), was taken by Kosovo Liberation Army members to Racak to see the bodies in the ditch. He declared that the dead "obviously were executed where they lay."

His OSCE report spoke of "arbitrary arrests, killings and mutilations of unarmed civilians" at Racak.

Canada's Louise Arbour, then special prosecutor for the war crimes tribunal, (hand-picked for the job by Albright) was prevented by Serb authorities from visiting Racak. She vowed retribution for the massacre, urging that "international troops on the ground" were the only way to effect arrests.

When Milosevic was indicted as a war criminal, the massacre at Racak was cited as evidence. The *London Times* wrote that victims had their eyes gouged out, heads smashed in, faces blown away at close range, all "farmers, workers, villagers, aged 12-74, men, women, children."

Serbian and Belorussian forensic people investigated, but were suspect, so the European Union authorized a forensic team from Finland, headed by Helena Ranta, a dental pathologist, to investigate.

The Finnish report was not made public.

Ranta gave a press conference at which she was vague, admitting there was no evidence of mutilation or torture, and that Yugoslav authorities had co-operated. But she also called the killings "a crime against humanity", widely interpreted to mean Racak was indeed a cold-blooded massacre.

It has since turned out, through subsequent investigations by German, French and American correspondents and by human rights and peace groups, including the anti-war International Action Centre and the Liberty Foundation, that the Racak massacre seems an enormous, albeit effective, hoax perpetrated by the Kosovo Liberation Army to persuade the U.S. and NATO to attack the Serbs. The goal was independence for Kosovo, possibly leading to the dream of a Greater Albania.

We now have a far better idea of what really happened at Racak—a pre-crisis town of 2,000 and a stronghold of KLA agitation. By January 1999, most of its population had fled to a nearby town, Stimlje, leaving perhaps 400 people behind. When four Serbian policemen were ambushed and murdered in two separate incidents in a week, Serb security forces surrounded Racak and attacked. The Serbs tipped off foreign journalists who came to see. Fighting was savage and brief, not only in town but also in the countryside.

Journalists found Racak had few people actually living there.

Some 20 bodies were counted. The Serbs and journalists left at dusk. The next day, Jan. 16, the KLA was again in control.

During the night, it seems that all the KLA killed fighting in the area—45 of them—were dumped in a gully at Racak and journalists and the OSCE investigators invited to see what was described as the "massacre" of unarmed civilians.

Military insignia and/or badges had been removed from clothing, military gear replaced by civilian clothing. No weapons were in sight. The hoax was on. William Walker was first on the scene and believed what he saw and was told. The international press relayed his outrage to the world.

Forensic evidence showed—as the Finnish team has since confirmed—that most of the 45 Racak dead had been shot at long range, not execution-style. Corpses tested positive with residue of gunpowder on their hands, indicating they had been firing weapons. No ammunition or shell casings were found near the bodies, where they had supposedly been massacred, nor were there pools of blood.

Pathologists also found the 45 dead men had all been shot in different parts of the body, from different directions, indicating a battle somewhere else, then dead dumped together for effect.

Until recently, no one was interested in the truth. "Whether or not it's a massacre, nobody wants to know any more," wrote Austria's *Die Welt* newspaper. Autopsy findings were delayed while the thirst for war echoed in the halls of allied power.

The German newspaper *Berliner Zeitung* got access to the Finnish forensic findings, and sent a team of reporters to investigate and concluded: "In all probability, there was no Racak massacre at all..."

French journalist Renaud Girard of *Le Figaro* was in Racak and was puzzled that reports failed to mention it was a "fortified village with a lot of trenches"—a KLA stronghold. Although he wrote an initial massacre story, he later had doubts: "I felt something was wrong."

Christophe Chatelet of *Le Monde* was in Racak the day of the Serb attack, and found one dead and four wounded when he left at dusk. The next day the KLA showed bodies from a massacre that hadn't been there before. "I can't solve that mystery," he said. (At the time, KLA commander-in-chief Hashim Thaci told the *BBC*: "We had a key unit in the region and had a fierce fight. Regrettably, we had many casualties, but so did the Serbs.")

Further investigation shows that two TV journalists for *Associated Press* and two teams of OSCE observers also saw the fight for Racak from a hill, entered when Serb security forces did and left when they left. The *AP* crew filmed a deserted village. It was overnight that the KLA returned and gathered their dead from the fighting. Next day, Walker told the world how adults and children had been "executed," some as they tried to flee. *CNN* reporter Christiane Amanpour, wife of U.S. State Department spokesman James Rubin, showed little skepticism in reporting on the "massacre of civilians".

It changes nothing, but Racak should make people wary of government propaganda about areas where they have little knowledge, but strong feelings. Remember the emotions generated about "ethnic cleansing" in Kosovo?

At the end of World War II, the population of Kosovo was 50-50 Serb and Albanian. By 1999 it was 90% Albanian. Today, it's close to 96%. Over 50 years, who's been "ethnically cleansed"? Today, Albanians in Macedonia are using arguments similar to those used against Serbs in Kosovo—prejudice, being frozen from jobs, discriminated against. Rarely mentioned are maps produced in Albania that show not only Kosovo, but parts of Macedonia and Montenegro as part of "Greater Albania".

It doesn't take an Einstein to realize that the U.S., NATO and Western media have been conned and manipulated into supporting an aggressive exercise in nation-building that is not likely to be resolved peaceably. NATO's beleaguered soldiers are innocents caught in a Balkan quagmire, thanks to a blundering, myopic, vainglorious political leader.

U.S. VETOES DRAFT RESOLUTION  
ON UN MISSION  
TO PROTECT PALESTINIAN CIVILIANS

The United States vetoed on Wednesday a UN Security Council draft resolution proposing the deployment of an international observer force to protect Palestinian civilians.

By virtue of the draft, which received nine votes in favor, one against (United States) and four abstentions (France, Ireland, Norway, United Kingdom), the council was requesting the Secretary-General to consult the parties—Israel and the Palestinians—on immediate steps to implement the resolution.

Before introducing the text, Council President Volodymyr Yel'chenko (Ukraine), said his country would not take part in the vote. Under the project, the Council would have expressed its full support for the work of the fact-finding committee established at Sharm el-Sheikh and would have called upon all parties to cooperate fully with it, and to resume contacts on implementation of reciprocal security commitments.

The Council would also have called for an end to the closures of the occupied Palestinian territories; full cessation of settlement activities; the transfer by Israel to the Palestinian Authority of all due revenues; and the institution of additional confidence-building measures, including unequivocal public statements supporting all commitments made at Sharm el-Sheikh.

Palestinian observer said that the meeting's negative result meant that the Council had been prevented from following through with its duties in maintaining international peace and security.

Palestine had made every possible effort to arrive at a positive conclusion, even at the expense of its own position. Ultimately, it could not give up the legitimate needs of the Palestinian people, including the need for international protection, especially since no alternative text had been tabled. Palestine would be present at a later date to see what could be done in cooperation with the Council members who were ready to work for peace, justice and legitimacy.

**[JR: The UN only goes through the motions of resolving the Palestinian conflict. They spent months reviewing the Sharm el-Sheikh report without coming up with any solution or recommendations. U.S. TO DEVELOP  
NEW ANTI-MISSILE SYSTEM FOR ISRAEL

TEL AVIV—The United States has agreed to cooperate with a research and development program leading to a new missile defense systems with Israel.

A senior Israeli official said the systems would augment the current Arrow anti-missile program. Israel plans to deploy three Arrow batteries over the next three years.

Defense Ministry director-general Amos Yaron said the U.S. agreement came during talks last week with the Bush administration, *Middle East Newslines* reported.

Yaron said Washington agreed to develop new systems meant to counter the ballistic missile and non-conventional threat being developed by Iran and Iraq.

"We discussed continued cooperation and our will to expand the basis set by the Arrow," Yaron said. "We discussed new systems. I have to say that the response was mostly positive and I expect a very good future in our relations with the Americans."

Yaron would not elaborate but said the issue would continue to be discussed over the next year. Israeli officials said Prime Minister Ariel Sharon urged Defense Secretary Donald Rumsfeld to approve the launching of joint development of a system that could destroy enemy missile launchers.

Israeli officials want the administration to approve such a program, called post-launch intercept, before the end of fiscal 2001, when money for the Arrow program expires. Sharon reviewed his visit to the United States with ministers on Sunday.

"During his U.S. meetings, Prime Minister Sharon emphasized the dangers posed by the striving of radical elements in the region—mainly Iraq and Iran—to arm themselves with non-conventional weapons and ballistic missiles," a Cabinet statement said.

In an interview with Israel Radio, Yaron said the administration has pledged to stop Iran and Iraq from obtaining weapons of mass destruction. Both countries are said to be pursuing the development of nuclear weapons as well as intermediate-range ballistic missiles.

"This was the central focus of our future relations," Yaron said. The Israeli defense official said the United States is also concerned that the Lebanese Hizbullah has acquired rockets from Iran capable of reaching central Israel. This would mean that Hizbullah has obtained rockets with a range of 150 kilometers.

On Sunday, Hizbullah denied that it received such missiles. A Hizbullah spokesman said the Israeli assertion was meant to obtain additional aid from the United States.

Iran's ambassador to Lebanon, Mohammed Ali Sabhani, also denied that Teheran supplied such missiles. **[JR: The Bushites at our Israeli White House are working overtime to meet the demands of their Zionist controllers. Mr. Yaron, Israel's Defense Minister, doesn't have to back up his claim against Iraq, Iran and Lebanon because our Mr. Rumsfeld and his associate Mr. Wolfowitz, at the Defense Department will GIVE those Arrow anti-missile systems for Israel top priority. Also, our Yiddish-speaking Secretary of State, Sir Colin Powell has assured Mr. Sharon, "that the people of Israel would always have the support they needed from him and the U.S. so they can live safely." AMMAN'S SUMMIT  
SUPPORTS THE PALESTINIANS,  
HALTS COOPERATION WITH ISRAEL

The Arab leaders on Wednesday ended their two-day summit in Amman by voicing strong support for the Palestinian people, calling on the UN Security Council to shoulder responsibility by providing the necessary protection to the Palestinians. The Arab leaders also condemned the U.S. Veto at the UN

Security Council that blocked the formation of an international observer force in the occupied territories.

The final communique released by the summit also called on all Arab states to continue suspension of multilateral talks with Israel and halt all regional cooperation with it.

The Arab leaders "salute the Palestinian people on their heroic uprising against the Israeli aggression."

They voiced their backing for the Palestinian people in their "heroic struggle" and support for the Palestinian Intifada and the right in resisting the occupation "until their national and just rights are attained," especially the right to return back home and to establish their own independent state with Jerusalem as a capital.

The Arab leaders also denounced Israel's continuous aggressions against the Palestinian people and Israel's violations of human rights, especially the collective punishment and continued attacks on vital institutions and which constitute war crimes against humanity and racist practices.

The leaders call in the UN Security Council to shoulder the responsibility of providing the necessary international protection for the Palestinian people and to try Israel war criminals who committed massacres and crimes against Arabs in the occupied territories.

The Arab leaders express their dismay at the U.S. veto at the Security Council that blocked the formation of an international observer force in the occupied territories. They declare their total rejection of the American justifications which do not conform with the role of the United States as a cosponsor of the peace process and a permanent member at the Security Council.

The Arab leaders hail the Higher Council for al-Aqsa Fund and the Jerusalem Intifada Fund for its quick response to the support the budget of the Palestinian Authority by paying USD 15 million as a soft loan that was approved out of the total USD 60 million in line with a proposal submitted by Saudi Arabia.

In view of the difficult financial and economic situation the Palestinian people undergo, the Arab leaders delegate the higher council of the two funds to respond to the Palestinian Authority's request to pay an additional amount of (USD 180 million) to support the Palestinian Authority's budget for the next sixth months.

The Arab leaders also welcomed the gesture made by Iraq to allocate one billion EURO from its oil export sales to secure humanitarian and basic needs for the Palestinian people and to help the families of the "martyrs" of the Intifada.

The Arab leaders warn Israel against the repercussions of departing from the foundations and principles of the peace process laid down in Madrid in 1991 and warned against the outcome of ignoring it or presenting alternatives that do not conform to the basis of international legitimacy.

The Arab leaders ask Arab states to continue the suspension of multilateral talks and halt all regional economic co-operation and activities with Israel and to firmly confirm Israel's endeavors to penetrate in the Arab world under any cover and to stop establishing any relations with Israel.

The Arab leaders also demanded the reactivation of the Arab boycott against Israel through the regular convening of boycott conferences called by the main boycott office to prevent dealings with Israel.

They call for setting "a clear Arab strategy to uncover Israeli schemes which do not seek peace and threaten security."

The Arab leaders also pledge their backing for Lebanon and Syria and rejected Israeli threats which have escalated recently against the two countries. They commended the Lebanese resistance against Israeli occupation and call for the release of all Lebanese detainees and prisoners in Israeli prisons.

The Arab leaders also affirm that achieving peace and security in the region require Israel to sign the Non-Proliferation Treaty and to put all Israeli nuclear installations under international inspection. They confirm the importance of ridding the region of nuclear and mass destruction weapons.

The Arab leaders renew their backing and solidarity with Libya in demanding that the Security Council immediately and completely lift the sanctions imposed on Libya after Libya fulfilled all the commitments stipulated in the Security Council. The Arab leaders support Libya in its demand to obtain compensations for human and material losses incurred because of the sanctions.

**[JR: Kofi Annan didn't offer much hope for the Palestinian people at the Arab Conference. Why didn't Annan express the Security Council's concerns regarding the escalation of violence in the occupied territories and the U.S.'s veto against sending UN observers? The Arabs need to use their influence to pressure Israel economically, diplomatically and to reveal every dirty trick she has used to stop the peace process. This also should apply to the U.S. Most importantly, Israel must be pressured to sign the Non-Proliferation Treaty and allow International inspections at her nuclear sites. The UN demands inspections of Iraq as a gesture of peace and good will so why does Israel get a pass on such a vital issue? Israel is an unbending, belligerent, arrogant and greedy neighbor who is a destroyer of peace for the entire world.]**

#### HUSSEIN CONDEMNS JEWS; ARABS DIVIDED ON IRAQ

AMMAN, Jordan—Arab leaders repeatedly expressed support Tuesday for the Palestinian rebellion against Israeli rule, sometimes using the issue to camouflage a deep Iraqi-Kuwaiti rift that is blocking any joint effort to lift UN sanctions against Iraq.

At the first regular Arab summit gathering in more than 10 years, some of the most soaring oratory came from President Saddam Hussein, whose speech, delivered by a deputy, painted Iraq as the savior of the Arab people.

Ending with the line, "May God damn the Jews!" Hussein said Iraq was ready to "liberate" Palestine and threatened that other Arab leaders would face the wrath of their people if they did not take part.

President Bashar Assad of Syria also used his speech to lash out at Israel. He said that in electing Ariel Sharon, a man viewed in the Arab world as a killer for his long association with deadly attacks on Palestinians, the Israelis showed they were not interested in peace.

In a slight departure from the past, some of the younger leaders said pointedly that speeches were not enough. King Abdullah II of Jordan, along with the young Syrian president, noted that summit meetings had been producing oratory for years and that the Arab on the street wanted more.

Despite such comments, there was no immediate sign that this gathering, an attempt to return to regular

annual meetings, would move very far beyond speeches.

Meeting during the weekend, foreign ministers failed to find a middle ground between the Iraqi and Kuwaiti positions on the sanctions.

"What has been proposed to us until now is not acceptable," said Tariq Aziz, Iraq's deputy prime minister. Iraq wants Arab leaders to break the sanctions, condemn U.S. and British air patrols over Iraq, and encourage civilian flights to Baghdad.

The Kuwaitis, while agreeing the sanctions should end, balked at any Arab stance that lacked an explicit commitment by Iraq not to threaten Kuwait.

"Iraq is responsible for the violation and destruction of Arab solidarity when it invaded Kuwait more than 10 years ago," said Muhammad Salem al-Sabah, Kuwait's minister of state for foreign affairs.

Hussein focused on Israel, saying 7 million Iraqis were willing to fight Israel for the Palestinians. "By God we will bring them with an army whose end will be in Baghdad and its forefront will make the criminal Zionist invaders' and occupiers' blood run cold," he said.

The speech, which was read by Izzat Ibrahim, vice president of the Revolutionary Command Council, said the blockade of Iraq and the battle of the Palestinian people should be considered one issue.

UN Secretary General Kofi Annan used his remarks to the gathering to suggest that Iraq comply with Security Council resolutions, saying Iraq will accomplish more through cooperation, not confrontation.

In electing Sharon to be their leader, Syria's Assad said, Israelis had chosen a man who hated anything to do with Arabs.

"We say that the head of the government is a racist, it's a racist government, a racist army and security force," he said, adding that by extension, "It is a racist society and it is even more racist than the Nazis."

To show his support for the Palestinians, Assad met with Yasser Arafat, whom his father had ostracized for decades.

**[JR: Hussein of Syria more than just lashed out at Israel. He accused the Israelis of using Nazi-like tactics to control the Palestinians in the occupied territories. #### LEBANON DECRIES ISRAELI WEAPONS COMPLAINT

The Israeli government is "in no position" to complain about the deployment of Iranian missiles in Lebanon because the Jewish state is itself replete with powerful weapons, said Lebanon's top leader.

Prime Minister Rafiq Hariri said on Saturday that because of Israel's powerful arsenal, the Jewish government "is not in a position to raise the issue of arms," according to the privately owned TV network the Lebanese Broadcasting Corporation International.

Hariri was reacting to earlier statements by Israeli Prime Minister Ariel Sharon, who has accused Iran of making Lebanon "the center of international terrorism", after transferring to Israel's northern neighbor ballistic missiles capable of striking the heart of the Jewish state.

Regarding those missiles, Hariri said, "This is military information that nobody will confirm or deny, but does Israel not have arms?"

The Lebanese leader's comments come as separate intelligence reports say that Israel is preparing a possible pre-emptive strike against the Lebanese bases housing the Iranian missiles....

The report said that before returning from a visit to Washington, D.C., last week for discussions with the Bush administration, Sharon told the *Wall Street Journal* and President Bush about the presence in Lebanon of Iranian Pager surface missiles with a range of 120 kilometers—capable of striking heavily populated central Israel.

The missiles were flown in last year through Damascus military airport and transported by truck to bases in Lebanon, the report continued. From there, they passed to the direct command of Iranian Pazaran (Revolutionary Guard) officers who maintain them.

Nevertheless, Hariri said that "Israel has atomic and nuclear bombs... all sorts of ballistic weapons—a real arsenal," and therefore had no right to condemn Lebanon for basing the Iranian missiles.

He also noted that Israel has "refused to sign a treaty which would have the Middle East... region free of weapons of mass destruction."

Hariri said he did not believe "there would be a war in the region."

"Wars cannot be justified and do not solve any problem," he said. "I don't think major powers would let a war break out, especially since Arabs are seeking peace."

Meanwhile, Iran rejected Sharon's accusations as "ridiculous lies" and said the Israeli leader was trying to divert the international community's attention away from "the Zionist regime's... intensification of violence" while adopting "a policy of threats"...

Iranian foreign ministry spokesman Hamid-Raza Assefi, in televised comments, said that Israel's "regime is based on terrorism."

Also, Assefi suggested that the Jewish state was attempting to exact revenge against Lebanon after withdrawing from the region last year, following a 22-year occupation.

"Israel... has been uttering more and more lies since its humiliating defeat in Lebanon," he said.

The DEBKA file report said Sharon had gained approval in Washington for the Lebanon strikes, should they become necessary.

Also, the report said the Bush administration had given the green light to Sharon to strike "at the core of the blossoming radical Middle East bloc linking Baghdad, Gaza, Tehran, the Hezbollah and possibly Damascus, before it ripens."...

Separately, *WND* investigative journalist Kenneth Timmerman told a private luncheon in Los Angeles over the weekend that he expects a new conflict to break out between the U.S. and Iraq, as well as Israel and Syria, within a few years.

"There's no doubt that there will be war between Iraq and the United States, but President George W. Bush will set the timetable and will finish the job" that his father, former President George H. W. Bush, did not, Timmerman said, as quoted by the *Jerusalem Post* on Saturday.

Timmerman has covered the Mideast for nearly 20

years; during fighting in Lebanon in 1982, Moslem forces imprisoned him for a month, he said. The internment changed him from a "Palestinian sympathizer" into a "conservative" reporter who favors Israel, the *Post* said. **[JR: Israel's threats and warnings to Iran, Iraq and Lebanon have become weekly news items. She is setting us up to initiate a confrontation and is not above falsifying the facts to justify her aggressive moves. She has the pledge and support of Secretary of State Sir Powell and the approval from the Oval Office; Israel will use any excuse to invade Lebanon and to eventually annex it to Israel to further her territories in the Middle East. UN AGENCY TELLS FARMERS,  
PREPARE FOR THE WORST

ROME, Italy (ENS)—The billions of dollars of crops lost in floods and storms over the last decade could have been minimized if countries had developed disaster management strategies that included early warning storm forecasting systems, says a United Nations agency.

The comments marked the opening of the United Nations Food and Agriculture Organization's (FAO) Committee on Agriculture in Rome this week. The committee is expected to recommend action on key development issues, including biosecurity, sustainable agriculture and climate change.

The effects of climate change, namely flooding, desertification and drought, are increasingly being felt by the agricultural sector. In a report to the committee, the FAO says agriculture has an important role to play in lessening those effects.

Agriculture's potential for sequestering carbon, the foremost greenhouse gas, and for reducing greenhouse gas emissions by substituting fossil fuels with biofuels, are explored in the report, titled, "Climate Variability and Change: A Challenge for Sustainable Agricultural Production."

Biomass can be used to generate electricity, heat homes, fuel vehicles and provide process heat for industrial facilities. The FAO says its energy contribution could be increased significantly through modern conversion technology.

This increase could have a significant impact for mitigating carbon dioxide (CO<sub>2</sub>) emissions, sequestering carbon and increasing employment for farmers in remote rural areas.

The report stresses the importance of countries developing strategies to cope with climate-related disasters, and incorporating those strategies into long-term development programs.

"The most immediate and visible impact of storms on agriculture is the damage to standing crops, livestock, household property, production assets and physical infrastructure," says the report.

"This may result in food supply shortages at household, community, and sometimes national levels," it continues.

The report cites figures from the most recent *World Disaster Report of the International Federation of the Red Cross*. The agency said windstorms and flood-related disasters between 1990 and 1999 together accounted for 60 percent of the

total economic loss caused by natural disasters.

"Apart from the immediate devastation—death, injury, hunger and starvation—disasters disproportionately affect the poor, making them even poorer by destroying the few assets that they possess," the report says.

The report recommends developing long-term programs to reduce storm-related agricultural losses. It suggests doing this by evaluating land use, conducting vulnerability and risk assessments, and taking inventory of traditional community land management practices.

It adds that crop, livestock, fisheries and forestry practices and farming systems suitable for vulnerable areas should be identified. These programs should include a preparedness plan for relief and rehabilitation, says the report.

ARMED UN TROOPS ARRIVE TO HELP CONGO

KALEMIE, Congo (AP)—Their faces pressed against a fence, dozens of Congolese children chanted "peace" in Spanish as soldiers from Uruguay set up camp Thursday on Lake Tanganyika, the first armed UN troops on a mission to help end Congo's 2 ½-year civil war.

The 110 South Americans were the first of 2,500 armed UN troops sent to try to bring an end to the conflict that erupted when rebels took up arms to oust Laurent Kabila from power in August 1998. Five other African nations became embroiled in the conflict.

The rebels are backed by Uganda and Rwanda, while Angola, Zimbabwe and Namibia have supported the Congolese government. All sides signed a cease-fire agreement in Lusaka, Zambia, in 1999, but all have violated it.

The UN Security Council last year authorized a 5,537-strong force to oversee the Lusaka agreement, but in February decided that about 3,000 troops would be sufficient. This includes the 2,500 armed troops and about 500 unarmed military observers, charged with verifying the pullback.

Kalemie, 990 miles east of the capital, Kinshasa, is one of four headquarters where the multinational force will guard equipment, supplies and vehicles for the UN observers.

"Your arrival here represents a significant step forward and is a sign of the progress being made in the peace process," Maj. Gen. Mountaga Diallo of Senegal, the UN force commander, told the Uruguayans.

Since the Jan. 16 assassination of Kabila, his 29-year-old son Joseph has pledged to do everything possible to end the war and meet the key provisions of the peace agreement his father had refused to carry out, including deploying the UN troops.

But Diallo said Wednesday that government forces

and their backers had failed to meet a midnight deadline for a 10-mile troop pullback, which the rebels undertook on March 15. Troops from Rwanda and Uganda that were supporting the rebels met Thursday's deadline.

A UN spokesman said the UN mission had verified the withdrawal of Rwandan forces and the rebel Congolese Rally for Democracy from the town of Pweto in eastern Congo. Congolese government troops also were staying away from Pweto.

There have also been withdrawals by Rwandan and rebel troops from Kabinda in the diamond-rich southern Congo, and the Congolese government claims to have withdrawn across the Ubangi River in the north, Eckhard said. But the UN mission has not observed any withdrawal by government forces from Kananga in south-central Kasai province.

There has been concern that UN troops in Congo could fall into traps like those laid by rebels in Sierra Leone for UN forces in the West African nation.

The last time the United Nations sent armed troops to Congo was in June 1960, shortly after independence, when the southeastern province of Katanga threatened to secede.

The observers will split into teams of four, to verify the disengagement of warring parties and report cease-fire violations.

**[JR: The UN's presence in the Congo is not to protect lives but to protect the interests of the British. England has carved this region up into separate states and has controlled the regional wars that are ongoing. This is in line with her 1940 Kampala Plan to genocide the people of this region. LIBRARY AIRS SPIRIT OF LINDBERGH'S

PRINCETON BOROUGH (AP)—A moment in history was replayed in vivid detail yesterday when a Princeton University librarian unsealed six boxes of the personal papers of famous aviator Charles Lindbergh and his wife, Anne Morrow Lindbergh.

The papers included the manuscripts and notes that led to the publication of two controversial books—one by Lindbergh and one by his wife—arguing that the United States should not get involved in World War II.

The boxes also held a number of letters from the public, most of them expressing support for the couple's arguments in the books, which were published in 1940 and 1941.

The letters were from typical citizens and also well-known individuals, including poet W.H. Auden and author Pearl S. Buck, said the librarian, Don Skemer, curator of manuscripts in the library's Department of Rare Books and Special Collections.

"It was a slice of history," Skemer said of the papers, which will now be available to researchers at the university's Firestone Library. "It gives you the detail and puts flesh on the bones, the Lindberghs on a day-to-day basis and how they worked and interacted with other people."

Charles Lindbergh gained worldwide attention in

1927 when he became the first person to fly solo and nonstop from New York to Paris. He and his wife drew the nation's sympathy five years later when their infant son, Charles Jr., was kidnapped and killed.

The Lindberghs, who lived near Hopewell in the early 1930s, gave Princeton the six boxes of papers in 1941 with the stipulation that the material remain sealed until after they both died. Charles Lindbergh died in 1974, and his wife early this year.

Yale University has the bulk of the couple's papers, including personal diaries and writings about the kidnapping, Skemer said. Some of those papers may be unsealed within the next few years, he said.

The Princeton papers, the first collection of unpublished Lindbergh writings to be unsealed anywhere—were previously viewed only by the couple's youngest daughter, Reeve, and a biographer, Princeton University graduate and trustee A. Scott Berg.

Princeton librarians are considering arranging a public exhibit of some the papers, Skemer said.

The materials give a clear picture of the American public's opinion on U.S. involvement in World War II, Skemer said.

The 1,500 letters in the boxes show that "85 to 90 percent were opposed to involvement in the war," he said. "Some said, 'You Nazi swine,' but others said 'You are on the right track.' This gives flesh to the dry statistics we have concerning the opinion of Americans in opposition to World War II one year before Pearl Harbor."

The papers, painstakingly organized, dated and fastened with brass paper clips, also reveal some details about the couple's relationship, Skemer said.

The two edited each other's work, liberally adding comments in the margins, the librarian said. The papers that resulted, he said, show that the couple were not nearly as decisive as they appeared to be.

In particular, Skemer said, Charles Lindbergh appears to have struggled for a long time before deciding who to blame for attempting to lead the United States into the war. Lindbergh's notes show that he considered blaming "foreign nations" but rejected the idea, Skemer said.

In a magazine article titled "A Letter to Americans", Lindbergh pointed a finger at Britain. Soon afterward, in a speech in Des Moines, Iowa, he included the Roosevelt administration and Jews as "agitators for war". In fact, some have questioned whether Lindbergh was a Nazi sympathizer.

After moving his family to Europe following the kidnapping of his child, Lindbergh witnessed the growing strength of Germany's Luftwaffe and became convinced that the United States could not win a war against the country, Skemer said.

In 1938, while fulfilling a U.S. military request to survey German air power, Lindbergh received a medal from Nazi official Hermann Goering honoring his aviation skills. Later, as the war escalated and America got involved in the fighting, Lindbergh refused to return the medal, Skemer said.

The book that Anne Lindbergh produced from her notes on file at Princeton, "The Wave of the Future: A Confession of Faith," were at least as controversial as her husband's writings and speeches.

Berg, in his Pulitzer Prize-winning biography titled *Lindbergh*, writes that Anne Lindbergh's book was reviled almost as much as Hitler's *Mein Kampf*.

In it, the wife suggested that the war in Europe was not a "fight between good and evil," but a struggle between "forces of the past" and "forces of the future".

Some interpreted that as a suggestion that Americans

should stand back and let Nazi Germany or Communist Russia continue what they were doing.

Charles Lindbergh won the Pulitzer Prize in 1954 for *The Spirit of St. Louis*, his account of his 1927 trans-Atlantic flight. With *Gift from the Sea*, published in 1955, Anne Lindbergh reached best-seller status and an audience of women around the world.

Charles Lindbergh also grabbed fame for working with a physician friend to invent a pump that later paved the way for organ transplants.

**[JR: The Lindbergh papers serve as a testimony to the fact that almost 90% of Americans were opposed to our involvement in WWII and fighting another war in Europe. Roosevelt was persuaded by England to do otherwise. Lindbergh's views against the war caused him to be censured by FDR. Charles and Anne grew up in politics as Lindbergh Sr. was a Congressman for 10 years and Anne's father was a U.S. Ambassador. Lindbergh Sr. strongly opposed the formation in the U.S. of the foreign Federal Reserve banking system and accused them of causing the financial crash of 1929. Some historians hold the view that the kidnap and death of the elder Lindbergh. We know now that the Elite controllers of the world are not above committing such acts to silence their detractors. #### ENLISTING SCIENCE TO FIND THE FINGERPRINTS OF A CREATOR

BURLINGTON, WASHINGTON—In this rural farming community, a high school biology teacher named Roger DeHart set out to question Darwin's theories of evolution. He never mentioned God.

He dissected such scientific topics as bacterial flagella, fossil records and embryonic development. Examine the evidence, he told the students, and ponder the Big Question: Is life the result of random, meaningless events? Or was it designed by an intelligent force?

Over nine years, DeHart would introduce ideas about this theory of "intelligent design". Then a student protested that DeHart was pushing religion. Then the ACLU filed a complaint. In 1999, school authorities ordered DeHart to drop references to *design* and stick to the textbook.

Last week, DeHart was told he could not even introduce materials questioning Darwin's theories. Now DeHart is being portrayed as a martyr in the movement promoting intelligent design, the newest twist in the timeless debate over the origin of life.

The idea that an intelligent force guided Creation is as old as Plato. But it is sparking modern battles as a new breed of mostly Christian scholars redefines the old evolution-versus-creationism debate and fashions a movement with more intellectual firepower, mainstream appeal and academic respectability.

The scientific establishment generally rejects the theory. But design advocates aim to reshape modern intellectual culture by marshaling scientific evidence that life was created by a transcendent mind, rather than by impersonal, random natural forces.

"Our work will alert people to the possibility that God is real rather than a projection of the mind," declared

Phillip Johnson, a UC Berkeley professor emeritus of law whose 1991 book, *Darwin on Trial*, laid the foundation for the emerging movement.

Arguments about the theory's use have arisen in public schools from Washington to Minnesota. On Saturday intelligent-design theorists made their first appearance at the National School Board Assn. Convention in San Diego to explain to school system attorneys why their ideas should be allowed in classrooms.

Unlike biblical literalists who believe God created the world in six days, most theorists of intelligent design are reputable university scholars who accept evolution to a point. But they question whether Darwinist mechanisms of random mutation and natural selection can fully account for life's astonishing complexity.

Instead, using arguments ranging from biochemistry to probability theory, they posit that some sort of intelligence prompted the unfolding of life—say, by producing the information code in the DNA.

Some proponents are doing theoretical work: seeking systematic ways to detect intelligence in life, for instance, or evidence to argue that intelligent design is a better explanation than Darwinism for such events as the abrupt appearance of advanced organisms during the "Cambrian explosion" 500 million years ago. Others are more experimental, analyzing DNA thought to be useless junk for actual functions as a way to show that an intelligent agent designed it that way for a purpose....

One 1999 national survey by *Scientific American* magazine showed that fewer than 10% of National Academy of Sciences members believe in God [!!!]. By contrast, 90% of Americans not only believe in God but say God played at least some role in creation, according to the Gallup Organization.

"We are taking an intuition most people have and making it a scientific and academic enterprise," Johnson said. In challenging Darwinism with a God-friendly alternative theory, the professor, who is a Presbyterian, added, "We are removing the most important cultural roadblock to accepting the role of God as creator."

Most design scientists are more circumspect about identifying the designer as God. But the work's clear religious implications have propelled the issue beyond science into passionate arguments about the separation between church and state, academic freedom and societal values.

Is intelligent design research "stealth creationism" funded by evangelical Christians? Is it legitimate science that students should be able to debate? Will it renew the culture by reawakening the human spirit from decades of materialism?

Eugenie Scott, executive director of the National Center for Science Education in Oakland, said most scientists do not accept intelligent design as valid science.

For example, Ken Miller, a Catholic biochemist at Brown University and a leading critic of intelligent design, argues that design advocates are simply wrong on the science....

Miller and others charge that advocates of intelligent design duck their peers—failing, for instance, to publish their arguments in major scientific journals—because their enterprise is religious, not scientific.

"They are using political and social tools to gain acceptance in the classroom that they are unable or unwilling to win in the scientific community," Miller said.

But design advocates claim they have been deliberately snubbed by the scientific establishment. In one celebrated case, Professor Dean Kenyon of San

Francisco State University was removed from teaching biology by his department chairman in 1992 after criticizing Darwin's theories, but was reinstated by a vote of the Academic Senate.

Other scientists report receiving correspondence from colleagues who confess doubts about Darwin's theories but **are afraid to go public for fear of career setbacks.**

"There's a sense in the scientific and academic community that this stuff needs to be shut down—that 'ID' is evil and if it succeeds it will overturn science," said William Dembski, a mathematician at Baylor University in Texas. Dembski was stripped of his directorship of a new campus institute on intelligent design after holding a controversial conference on the issue.

The university says Dembski was removed because of uncollegial behavior, not the content of his work; Dembski continues his design research at Baylor as an associate research professor.

To push intelligent design into the public square, Johnson, the movement's strategic mastermind, has fashioned a two-pronged "wedge strategy".

The first step is to open academic debate by pressing scientists to explain whether evolutionary claims are based on "impartially evaluated evidence or philosophical dogma".

The second tactic is to unify the religious world—Christians, Jews, Muslims and others who believe in a Creator—to produce a constituency that would insist that intelligent design be considered an option for debate.

To support those efforts, advocates of intelligent design have acquired significant research funding. In 1996, the Discovery Institute in Seattle launched a science and culture program that is emerging as the intelligent-design movement's national think tank.

Primarily funded by evangelical Christians—particularly the wealthy Ahmanson family of Irvine—the institute's \$1-million annual program has produced 25 books, a stream of conferences and more than 100 fellowships for doctoral and postdoctoral research. Fieldstead & Co., which is owned by Howard and Roberta Ahmanson, has pledged \$2.8 million through 2003 to support the intelligent-design program....

REPORT: NMD FOR "ROGUE STATES"  
NOT NECESSARY

WASHINGTON (UPI)—Unwarranted concern over "rogue states" has led to pressure for the United States to deploy a national missile defense system far more quickly than it can or should, according to a new study by the Cato Institute.

The report says that the U.S. should take more time

to develop and test the missile defense system, which is the most technologically challenging weapon ever built. It also asserts that there is time to do this because the threat from rogue states, now often referred to as states of concern, has declined.

In *The Rogue State Doctrine and National Missile Defense*, authors Ivan Eland and Daniel Lee argue that although the international threat environment has changed, policymakers have become stuck in a rogue-state doctrine that is no longer grounded in reality.

Eland and Lee argue that the new administration should focus on the intentions of rogue states, not just on their technological capabilities. "After all, no U.S. policymaker believes that the nuclear forces of France and the United Kingdom threaten U.S. security," they note. "The rush to build a missile defense system assumes a worst-case scenario that focuses on the possibility rather than the likelihood of an attack by a rogue state."

The rogue-state doctrine assumes that so-called rogue-state actors "are irrational and thus 'undeterrable,'" the authors say. However, that assumption is wrong, they argue. Rogue states have developed ballistic missiles primarily in response to regional rivalries, not in any attempt to threaten the United States.

Those countries also develop longer-range missiles because they are nervous about the presence of American troops nearby: missiles offer a way of deterring American intervention. "If American forces were less likely to intervene, those nations would have less incentive to develop long-range missiles and much less reason to target them at the United States," Eland and Lee point out.

Recent developments within these rogue states may well reduce the likelihood of future antagonism between them and the United States, they say. But that, they add, depends on U.S. willingness to rethink its policies towards countries such as North Korea, Iran and Iraq.

"If left alone, those small, poor states in remote parts of the world would have no quarrel with the United States," they argue. Less antagonistic relations would buy time to look at whether a missile defense system is needed and whether it would work.

**[JR: It is not reasonable for us to spend billions more on or improve our missile defense systems when we already have huge stockpiles of weaponry. The only wars tolerated should be the war of words through diplomatic channels. If the U.S. didn't represent such a threat to the rest of the world no one would be arming and pointing missiles at us. We have become like Israel—we see danger and enemies everywhere.]**

GOLD-EAGLE INTERVIEW WITH JASON HOMMEL  
ON HIS VIEW OF GOLD

**GOLD-EAGLE:** Would you tell us why the bullion banks with such a huge SHORT GOLD position have not taken any significant actions to cover?

**Hommel:** Many of the banks ARE covering. But for each bank that covers, there has to be a counter party who accepts the risk that they wish to cover. What has happened is that the exposure has been shifted onto fewer and fewer big banks, which have been named in GATA's lawsuit. These are: Goldman Sachs, Deutsch Bank, and I think Morgan? (see [www.gata.org](http://www.gata.org)) I believe the

positions of gold owed by two of these banks is a matter of public record, yet not too well publicized in the media, except on the Internet.

The point is that gold is owed. To truly cover, they would have to BUY BACK the gold itself. Where would someone buy 10,000 to 20,000 tons of gold today, without affecting the price of the commodity in the positive direction??? When the Bank of England's sales of 25 tons move the market?! And the Washington Agreement, limiting gold sales by most of the central bankers of Europe to 400 tons per year caused a massively quick run up to \$340 from \$250?

The way these positions have been consolidated is that the big players know that they would have to buy gold at higher prices if they started buying. So they MUST keep selling. It's a sickness, a catch-22. They are digging their own graves. There is a way out, maybe, politically. They can simply default on the promise to pay gold, (bankruptcy!) and do a cash settlement, without actually buying physical [gold] which would cause a massive run up in the price beyond what is possible to pay. But to foreign powers such as oil, to which much of this gold is owed, this will be like an act of war.

Again, the size of the gold owed is massive. \$80-100 Billion for one bank? If gold tripled, this would be like owing \$300 Billion, like taking a \$200 Billion loss, and this is nearly equal to the assets of the largest banks in the world. And these are the banks that are "too big to fail", whose failure would pose a "systemic risk". Since "covering" would require buying back the gold, causing a run up in price, and failure, I don't think the biggest players ever really want, or intend, to cover. Do you? They simply can't. The gold is not there to buy anyway.

**All they can really do under the current rules, prior to default, is to prolong the game, by looking for other nations to keep selling or leasing their gold, and this has been going on for the last several years as these players keep getting desperate.** After the Washington Agreement, smaller and smaller nations who were not a part of the agreement kept announcing they would either sell or lease their gold. Kuwait agreed to lease a few tons of gold (maybe 70?) in return for military weapons. Figuring out how much gold was leased and the cost of the military supplied, showed that they leased their gold at the cost of about a \$600-800/oz. favor, if my memory serves.

**GOLD-EAGLE:** Gold at \$260 per troy ounce is cheap, but will gold be cheaper? (Particularly, if we take a strong dollar factor into our consideration?)

**Hommel:** At \$260, how much cheaper do you need gold to get? If you adjust for inflation, it's lower than any time in history (except for briefly in the early 70s), going way back even to when gold was \$20/oz, prior to the revaluation to \$35/oz. during the Great Depression in the 1930s. If you adjust for inflation not using government figures, but true figures, then gold is even cheaper. The last time gold was this cheap, adjusted for inflation, was early 70s, at the start of the decade-long run up from \$35 to \$840, a 24-fold increase.

Gold, may, in fact, get cheaper. What if it goes to \$250 again, or even as low as \$240? Whoop-de-do! Who cares? Why wait? Is the \$20 savings worth it? And what is the guarantee you will be able to buy later at these fire-sale prices? What if it goes up to \$4000 before you

buy? Think risk vs. reward. The point is that it can't go as low as zero, unlike paper, which can. It costs money to take gold out of the ground, and lower than \$300 is causing mine closures. And in the current price environment, 2500 tons is pulled out of the ground annually, while 4000 tons is purchased for things like jewelry, which cannot be easily repurchased once it finds its way into the hands of people in India, who have no use nor affinity for paper dollars.

Yes, with the strong dollar, and as long as the dollar gets stronger, this will help put a lid on gold. However, with Greenspan increasing M3 at about 10% annually since 1995, why should we continue to expect a strong dollar for much longer? With the economy and stocks dropping, why expect a strong dollar? With pressure to lower interest rates, why expect a strong dollar? With the manufacturing base destroyed in the U.S. since NAFTA and GATT, in the mid-90s, why expect a strong dollar? With the trade deficit ever increasing, and nothing to sell to the rest of the world, how long can our strong dollar continue? What happens when those dollars that are going overseas come home to buy something? What will they buy when we have nothing to offer, no stocks, few manufactured goods, and the little that can be bought here can be purchased elsewhere because they are produced with cheaper labor? How can we export a massage or a lap dance, or similar frilly service economy? We can't. When the overseas dollars show up, and with liquidity being needed to prop up our failing stock market, we have a recipe for inflation, a weak dollar is coming. Want to try and time exactly when? What for? Fiat dollars like ours have collapsed as much as 30% or 50% in a single day. Even the almighty U.S. Federal Reserve dollar collapsed by 8% overnight in recent years. **History has shown the way that gold could easily "pop" up to \$600/oz., overnight, and that's just for starters.**

**GOLD-EAGLE:** Equity markets are way down, and we think they will continue to decline. Nevertheless, funds fleeing the stock markets are flowing to bond markets, rather than to gold. Is this anomaly due a strong dollar?

**Hommel:** I think the markets are down for nearly the same reason everyone else does. They were overvalued. Companies which never saw a profit, at multiple Billion-dollar valuations? There was something fundamentally wrong with that.

Moreover, I believe bonds are more attractive than gold for several reasons:

\*\*\* because they pay interest, and gold does not

\*\*\* because they are "sold" by institutional salesmen, gold is not

\*\*\* because gold purchases are actively discouraged at institutional levels

People who think gold will go up are sold "Call Options", which are derivatives on the paper contracts, instead. As I have hopefully shown, these paper contracts will eventually be worthless, because they can NEVER be honored with real gold. And paper-on-paper, (options on contracts) which are denominated in paper dollars, are really just funny when you think about it. Again, why wait, or be bamboozled into thinking that some counter party will honor their "impossible to honor" agreements? **Just buy the real stuff and sit and wait.**

**GOLD-EAGLE:** If the dollar continues to be strong, does that mean the gold price will continue to decline?

**Hommel:** Buying gold at institutional levels is a real hassle. They require all sorts of paper agreements prior to making the sale for you, which actually takes a few weeks to process! Then they hassle you with "storage fees" and mystify you with "assaying fees" which will be assessed if you tell them you want to take possession of the gold itself—and not use their storage facility, which they may charge up to 1% per year for. They say the assaying fees will be pricey, without telling you the price, so as to discourage people from actually taking possession of gold, and to talk you into the high storage costs. And this does not even begin to include the commission, which is another charge. It's real funny, they will tell you "don't buy gold, because of these charges", but they charge commissions for everything else they will sell you. And after all of this, they will then tell you not to buy "spot" gold, but a futures contract to get the gold cheaper, which involves another set of paperwork, and which is buying into the very thing you don't want—the paper market.

And if you buy gold in an IRA, which you can do, what's the point? You can't take physical possession! And if the company which holds your gold defaults, then you are basically out of luck. And if you actually own physical gold, and it does run up in price, there is no capital gain to begin with on gold sales, so there's really no need to hold it in an IRA, the purpose of which is to let your money grow without capital gains accruing. Buying gold in an IRA is just a way to keep the IRA money safe.

**And if gold does run up really high, who is to say the government won't change the rules on you like they tend to do? If they decide to confiscate gold, IRA gold will be gone. Gold in the hand can still be hidden.** Why not just "buy into the system" with bonds and avoid the hassle? Which people do.

**GOLD-EAGLE:** Gold is a commodity, and supposedly is not allowed to be manipulated, legally speaking. On the other hand the U.S. dollar is a currency and, therefore, the U.S. government does have the right to decide the value of its own legal tender. Consequently, since keeping the dollar value high means maintaining a lower gold value, do you think it is plausible that the U.S. government will continue to support a strong dollar (and conversely suppress the price of gold) with a view to preventing bullion banks from collapsing?

**Hommel:** If the United States government decided to continue manipulating gold on the world markets, by secretly selling gold from the U.S. reserves, as it has done historically, there is a way to calculate how long they could continue to do so. Simple math, really.

The current deficit is 1500 tonnes. 4000 tonnes consumed and growing, 2500 mined and shrinking. The U.S. gold reserve is about 8000 tonnes, (down from the historic high of 27,000 tonnes). Using that gold to supply the market to satisfy the deficit of 1500 tonnes per year would deplete the U.S. hoard in how many years? Just over 5 years. Like I said, it's simple arithmetic. But think for a moment. If this gold were to be secretly dumped to keep the price low, then less and less gold would be mined, as is occurring, and more and more gold would be purchased, as is occurring, as people figure it out, like they always do, and have figured out as history has proved. Thus, the end would come much, much sooner than 5 years, and the U.S. government would probably not continue to play the game realizing they cannot do it longer than 5 years anyway.

Somebody high up will surely realize that it might be good to hold on to some of the gold reserves and not let it all go for short-term political gain. As it is, the last time we played this game, we lost 2/3rds of our reserves. Why play it again, when the outcome will simply impoverish our nation's reserves of wealth?

**My conclusion is that we should not depend on the government to preserve wealth for us. They fail every time. Instead, we should take advantage of government stupidity and lack of foresight, and protect wealth by buying gold personally. Buying gold and silver right now is better.**

**Unlike Gold, silver has been consumed by industry on a massive scale. Today, there is ten times as much gold above ground than silver. Silver is more rare. And if the problems for storing gold were bad, it gets worse when you have to move around a few hundred pounds of silver for a mere \$25,000 investment. With silver, you get so much for your money. It's truly a rare case of under valuation; which will probably turn out to be the golden opportunity of a lifetime.**—Jason Hommel, [group@spintheweb.com](mailto:group@spintheweb.com)

#### "THE TEN TRILLION DOLLAR TUMBLE"

The first quarter of 2001 put the Great Bear Market of 2000-200[?] into the history books. The NASDAQ lost a stunning 25.5 percent in the quarter, by far its worst quarter ever. The S&P 500's 12 percent quarterly loss was its worst since 1987. The DJIA fared best, losing "only" 8.4 percent, its worst first quarter in 23 years.

The NASDAQ's Great Bear Market "celebrated" its first birthday on March 10. The 64 percent fall from grace in one year can perhaps be considered the worst bear market of any major market average, ever. Only the DJIA's 80 percent crash from 1929 through 1932 is of the same order of magnitude. Note, of course, that the Great Depression's Bear Market took four years to play out while the NASDAQ's current Great Bear is just a year old.

The Great Bear Market of 2000-200[?] has been devastating and demoralizing for the bulls. Even their hero, Sir Alan of Greenspan, could not ride in to the rescue and stop the Great Bear. Sir Al and his pals cut interest rates three times in the quarter—and the Great Bear gobbled up the rate cuts like honey from a hive.

Short-term, the bounce off of last Thursday's spike-low evolved into a buying frenzy. Such rapid reversals from widespread bearishness to near-panic bullishness are typical of counter-trend bear market rallies. The Street is convinced that the bottom is in, there will be no recession, or only a brief, mild one, and that now is a once-in-a-lifetime bargain-hunting opportunity. [Anyone's tummy hurting from uncontrollable laughter?!] The foregoing are all signs of classic bear market rally mentality. The Great Bear will do its best to confound these irrational expectations.

After the DJIA's 16% short-term plunge from 10,858 on March 8<sup>th</sup> to March 22<sup>nd</sup>'s spike low of 9,107, and really the entire year-long 64% crash in the NASDAQ, the Great Bear seems close to finally having its fill, at least for this meal. The mini-panic of

March did show some signs of the panic and capitulation that typically mark solid lows. Shorts were covered and margin calls were liquidated. Mutual fund redemptions picked up. A lot of towels were thrown in, but not enough to generate that elusive historic one-day crash. Indeed, the markets seem to have weathered the risk of that crash, at least for this leg of the Great Bear Market of 2000-200[?].

Yet not all investors suffered in the first quarter. The 19 "Great Bear" mutual funds we have identified out of an industry of 10,000 funds were the stars of the quarter. Thirteen of the top fourteen funds were "bear funds". The Rydex Dynamic: Venture 100 Fund soared 56 percent to top the quarterly scoreboard. Please see our Great Bear Funds Page for more information.

In Elliott Wave terms, the decline is playing out right on target. As we said last month, "The NASDAQ is nearing completion of its third major leg down of the Great Bear. Wave Five of that decline has more to go, probably to around 1,800, before a multi-week wave 4 rally ensues."

The NASDAQ bottomed (so far) at 1,794 on March 22<sup>nd</sup>. The short-term wave patterns suggest there's still a bit more to go on the downside to complete this leg of the decline, which should be followed by a large wave 4 counter-trend rally. Be prepared, as we know that bear market rallies are often sharp and swift.

The markets are at an interesting and important short-term juncture to open the second quarter. The DJIA has bounced off 9,700 three times in the last two days. Any break thereof should now usher in the completion of this leg of the decline. At a minimum, another several hundred points would be at risk for both the DJIA and the NASDAQ. If there's a bit more spring in the current small bounce, both 10,000-10,100 on the DJIA and 2,000-2,100 on the NASDAQ should provide formidable resistance and will likely halt the rally.

Our Elliott Wave chart reprinted from last month stands intact.

We firmly believe that whatever rebound the markets are able to muster will just be a pause. Bear Market rallies serve their purpose, namely to relieve the massive oversold technical indicators and excessive pessimism that are generated by the selling.

Richard Arms, inventor of the indispensable TRIN (ARMS) index, reports from his Website at [www.armsinsider.com](http://www.armsinsider.com):

"The message seems clear. We are seeing oversold levels that are rare, and have always, in the past, pinpointed a time to be aggressively buying stocks. It is hard to go against the crowd when the bearishness is so widespread. Being contrary at important turning points has always been extremely difficult, but extremely profitable. We seem to be at, or near, such a point."

For the first time in nearly 2½ years, we are lifting our FULL CRASH ALERT warning, as this leg of the decline nears completion.

For speculators, a tradable counter-trend rally is imminent. Protect the gains on your profitable short positions and prepare to go long.

For shorter-term aggressive investors, look to take profits on your Great Bear Fund positions. Longer-term aggressive investors may want to just ride out the counter-trend rally.

For conservative investors, five percent in a

money market fund is hard to beat, plus you get to sleep nights.

We'll keep you informed throughout the month with our daily updates as we zero in on the conclusion of this leg of the decline.

From within the heart of the Great Bear Market of 2000-200[?], now is not the time to abandon the mainstay of our diet, contrarianism.

By the time the mass media recognizes a financial trend, it is usually almost over. Add to this [bearmarketcentral.com](http://bearmarketcentral.com)'s selection as *U.S. News*' "Best of the Web" Site of the Week, and you can't help but think that the bulk of this leg of the Great Bear is just about over and a significant but temporary low is nearby.

A Gallup survey as reported in *Newsweek* magazine revealed that 29 percent of respondents are more worried about their personal finances due to lower stock prices, while 69 percent aren't more worried. Expect to see such sentiments reversed by the end of the Great Bear.

The March 18<sup>th</sup> Sunday *Wall Street Journal* ran a story featuring "Twenty Ways to Sidestep the Selling Frenzy." Among the pearls of wisdom:

#1: Now that stocks are cheaper, you should like them even more.

#7: Stop looking at the stock tables and mutual fund quotations. Why torture yourself?"

#9: Root for the bear market to continue, so you have more time to buy shares and reinvest dividends at today's cheaper prices.

#17: Cut your spending so you have more money to invest at today's depressed stock prices.

The *WSJ* wants you to believe that what worked so well in the old bull market, namely "buy the dips", is still the best strategy. **We beg to differ, and believe that "sell the rallies" is now the name of the game.**

The current leg of the Great Bear has been driven by falling earnings and massive corporate layoffs. Each time the NASDAQ appears ready to mount a rally, a new "earnings warning" disappoints The Street and adds fuel to the Great Bear's appetite.

The Street's new buzzword is "visibility", or more to the point, the lack thereof. Day after day, CEOs and analysts appearing on CNBC report that their crystal balls are so fogged up that they just have no confidence in the short-term outlook for their companies. In a Great Bear Market, you can be sure than the vast majority of surprises will be to the downside.

**Many more earnings shockers are just around the corner as first quarter reports start to trickle in. We believe these reports will confirm that the economy has been in recession for months—and the situation is much worse than the official U.S. government statistics would lead you to believe.**

For example, the monthly unemployment report is but a figment of a bureaucracy's imagination. The calculations are riddled with all kinds of subjective adjustments—some politically motivated, outdated and outmoded models, seasonal adjustments, and other fudge factors.

Cold, hard and indisputable corporate layoffs are accelerating, as about 400,000 have been announced since December. These are real cuts from important leading companies: General Electric to cut 75,000 jobs, Montgomery Ward 28,000, Daimler-Chrysler 26,000,

Motorola 20,000, and on and on.

Such companies do not take such actions without much forethought. Hell hath no fury like a laid-off worker. Clearly, the CEOs of GE, Daimler-Chrysler, Motorola, *et al.* are seeing much more than a brief "V-shaped downturn".

The disappointing sales and earnings will ripple up and down the corporate supply chain, causing a spiraling effect that will take the economy down faster than most are expecting.

So-called new economy management practices such as "just in time" manufacturing, computerized inventory control and tightly integrated supply-chain management all created tremendous efficiencies that helped prolong the record-long economic expansion of the 1990s. Such efficiencies will be thrust into reverse and accelerate the downturn. Orders will be quickly pulled from the pipeline in record numbers as the economy screeches to a halt.

In this day and age of instantaneous global communications, investors have become conditioned to expect instant gratification. Their time horizons have contracted to hours and days instead of weeks and months. They are expecting and demanding the V-shaped recovery, now! Not!

**Conventional "wisdom," always to be taken with a large grain of salt, has it that lower interest rates lead to higher stock prices. The markets' performance so far this year banishes such folly to the old wives' tales bin. As we've been discussing for the past few months, lower interest rates certainly haven't helped the Japanese market recover from its burst bubble of 1990.**

**For eleven years, they're been "pushing on a string" yet the Nikkei 225 still stands some 65 percent below its peak. Current interest rates in Japan are essentially zero, and as columnist George Will notes, even that's not low enough to spark a revival.**

Can President Bush's ten-year \$1.2 trillion tax-cut plan save the day? Not when you consider that in all, about \$5 trillion of U.S. wealth has been devoured by the Great Bear in just over one year. That's about 40% of annual Gross Domestic Product, or about \$50,000 per family.

American household net worth fell 2 percent in 2000, the first fall in the 55 years that the Feds have been computing such data. They will get more sticker shock when their quarterly 401k reports start showing up in their mailboxes in a few weeks.

The *Economist* magazine estimates that \$10 trillion in market value has been lost worldwide. That's about 30% of world GDP. "Can the world escape recession?" asks the *Economist*. What do you think?

The outbreaks of Mad Cow and foot-and-mouth diseases in Europe are right out of a cheap Sci-Fi thriller gone bad. This is a serious situation having a serious impact on the world economies, particularly of course in Europe. For openers, economic losses in Britain alone are estimated at \$15 billion, and the situation is far from under control.

Oh, yeah, the last confirmed case of foot-and-mouth disease in the U.S. was in, uh, oh, 1929.

"No bull market has ever started with the Dow Jones Industrial Average selling at 21 times earnings," says Dow Theorist Richard Russell.—**Grizzly's Growlings Current Report; [grizzly@bearmarketcentral.com](mailto:grizzly@bearmarketcentral.com)**

RESEARCHERS DEFEND PLANS  
TO CLONE HUMANS IN SECRET

WASHINGTON—Two groups of scientists Wednesday testified that they were gearing up to clone human beings in secret laboratories and that they saw nothing illegal in their quest.

However, they did say that they had received warning letters from the U.S. Food and Drug Administration (FDA) on Tuesday. The contents of those letters were not disclosed.

But Kathryn Zoon, director of biologics evaluation and research for the FDA, said people who undertake experiments deemed unsafe could be subject to a \$100,000 fine and up to a year in prison.

Rep. James C. Greenwood (R-Pa.) called the hearing to consider the need for a law banning human cloning.

“Although publicly funded human cloning research is prohibited—privately funded human cloning research is not,” said Greenwood, who chairs the House Energy and Commerce Committee’s Oversight and Investigation subcommittee.

Panos Zavos, a fertility specialist who recently left the University of Kentucky, told the subcommittee that he expects to create a human clone within two years in a laboratory outside the United States.

“Those who want to ban this (cloning) would have stopped Neil Armstrong from flying to the Moon and banned Columbus from discovering America,” he said.

And Brigitte Bossellier, a chemist and chief scientist for the Canadian group Clonaid, said it was preparing to create a clone from the cells of a child who had died. The work, she said, was being done at a secret laboratory somewhere in the continental United States. [**Camp David?!**]

Clonaid is run by a religious order known as Raelians who believe that humans were cloned thousands of years ago by extraterrestrials.

Bossellier read a letter at the hearing from the child’s father. She said he paid \$500,000 for the procedure and asked that his name not be revealed.

She read, “I decided I would never give up on my child. I knew we only had one chance—human cloning.”

Others, however, testified that any children created through cloning [**soulless entities**] would likely have serious defects. [**Ditto for adults!**]

Rudolph Jaenisch, who clones mice at MIT’s Whitehead Institute, said that efforts to clone a human would almost certainly result [**have already resulted**] in hundreds of miscarriages, stillbirths, infant deaths, and children with serious heart, kidney and brain defects. “I believe, there probably isn’t a normal clone [**right on!**] around,” he said, referring to the animals [**?!!!**] cloned so far.

The cloned sheep, Dolly, he said, may not have had perfect brain function—“You don’t need that much brainpower to graze in the field.” [**or, apparently, to occupy prestigious political positions worldwide**]

The problem, he said, is not that the clones have genetic defects, but that something goes wrong in a process called reprogramming, in which the genes in a cell are prompted to launch the life process. Normally, he said, that reprogramming process takes place when egg and sperm unite. With cloning, it’s stimulated by electricity or some other artificial means.

[**MM: Isn’t it reassuring to now find out that this already-perfected, four-decades-old genetic “human cloning” technology is going to be scientifically practicable “within two years” at some “secret laboratory” somewhere?**]

# Fortress-Like Shelter Or House Of Cards?

Budget’s “Tip of the Week” #7:

**Checklist for Adherence to Corporate Formalities**

**Proper operation** of a corporation can make the difference between having a fortress-like shelter or a precariously balanced “house of cards”. If you are operating a Nevada corporation, you might want to review this checklist to determine for yourself which you are building:

- Read and understand the Articles of Incorporation and Bylaws and act in conformance with them.
- Read the governing law for the corporation: *Nevada Revised Statutes (NRS), Chapter 78*.
- Include reports of officers and committees in the corporate records.
- Record all major decisions of Directors in corporate resolutions or meeting minutes.
- Document contracts, even (perhaps especially) verbal ones, within the corporate records.
- Correctly handle and document corporate loans, making interest payments as required.
- Properly maintain the corporation’s books and accounting records.
- Whenever signing on behalf of the corporation, indicate title; do not sign personally or you may forego the inherent liability protection normally afforded by Nevada’s statutes.

**Additionally, if stock is issued:**

- Hold annual meetings of stockholders.
- All actions of stockholders must be done by vote and duly recorded.
- Give proper notice or use appropriate waiver of notice (usually specified in the Bylaws) for stockholders’ meetings.
- Elect directors as necessary and conduct other business in appropriate meetings, duly recorded.
- Hold regular meetings of the Board of Directors, at least annually.
- Give proper notice or use appropriate waiver of notice (usually specified in the Bylaws) for directors’ meetings.
- Elect officers and conduct other business in the manner specified in the Articles of Incorporation and the corporation’s Bylaws.
- Record proper minutes of such meetings.
- Maintain the stock ledger properly.


