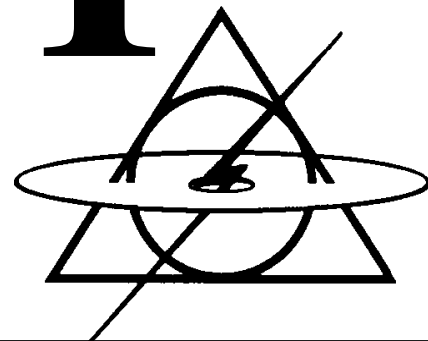

As realization comes that there can be provincial incorporation, much as the states structure basic incorporation regulations, there will be more suitable places to service, say, Islamic-style business and banking. All parties doing anything with us must be locally registered and authorized, but not necessarily in the Philippines.

The Filipinos want ability to interact with the U.S.—and the best way to achieve same is through business recognition.

To remain qualified as a newspaper we must meet the guidelines for a published paper and not just some incorporated entity. The load has been extremely heavy, however, since the theft of the paper by the SPECTRUM group. Our people, however, have never ducked a challenge. Delays are not denials!

longer existent in the pages? Are you confused? Well, if you are NOT, then you are a singularly unique being—for you have every facet of your existence structured to confuse each one in some way. This is whether it be in discussions of underground cities or above-Earth beings while Spirit itself (YOURS) is extraterrestrial.

There should be NO confusion, for what IS—IS and, therefore, there really can be no confusion—only the perception of same.

These are “stories” only—IF you have not experienced them and often if you have “experienced” them, is it “real” or “imagined” as in a “dream-state”? Does it matter? You have to understand, reader, that BELIEF (opinion) is NOT THE SAME AS EITHER KNOWING OR TRUTH. ### BEATITUDES

What were those Beatitudes which all began with “B” or Blessed? Well, the word “blessed” as used actually should have been translated as “Happy” or “Content”. The Teacher was making a major effort to change “attitudes” of the people who were totally FILLED with discontent, unhappiness, dissatisfaction and vexation. YOU CANNOT BE HAPPY (BLESSED; JOYOUS) WHILE IN A STATE OF JUST-THE-OPPOSITE ATTITUDES.

What about that number one “Blessed”: “Blessed are the poor in spirit, for theirs is the kingdom of heaven.”

OK, let us start at the beginning. Blessed literally means “happy”, so let us start with that concept first. Whether you are winning or losing, succeeding or failing (in your opinion), enthusiastic or depressed, happy or suffering, YOU CAN BE HAPPY “IF” you will take time to discover the POSITIVE ATTITUDES given you by that Great Teacher. Don’t talk “religion”, focus on Great Teacher and then you won’t become so confused.

Do you need to readjust your attitudes, perchance? Do you anticipate “failure” rather than success? Do you dwell on LACK instead of MAKING OR CREATING SUCCESS? BE HONEST! EVERY TIME YOU FOCUS ON LACK THAT IS WHAT YOU RECEIVE—FOR YOU ARE DEMANDING IT IN YOUR VERY PRAYERS. ABUNDANCE MUST BE ANTICIPATED AND ACCEPTED AS YOU CREATE IT, OR AT THE LEAST, SHARE IN THAT CREATION OF SAME.

**You cannot find happiness in more money, more recognition, in a relationship or many relationships—nor can you find it in mind-altering substances or addictions.**

If you perceive these things as “happiness bringers”, then you must have a more important focus; like on a readjusted mental attitude. A readjusted mental attitude is the life-transforming power which presents YOU in a totally different experience.

So, who is happy today? Why not, friend? Can you meet the challenge of the experience by finding only LACK in your perception? HOW DO YOU KNOW BUT THAT AT THIS VERY MOMENT LIFE IS PRESENTING THE VERY SUCCESS FOR WHICH YOU PLEAD? DO YOU EXPECT TO CONTINUE IN THE LACK OR ACCEPT THE POSITIVE POSSIBILITIES? IT IS UP TO YOU—AND YOU WILL SUCCEED AT PRODUCING EITHER CHOSEN STATE OF BEING.

### PROBLEMS

Are “Problems” your problem? What does that fact have to do with your “happiness”? Happiness is NOT a question of having or not having problems. Everyone has problems, and not everyone is unhappy!

Happiness is not dependent on whether or not you have problems, any more than it is dependent on whether or not you have material wealth. There are people who are happy even though they have very little. There are even more people who are unhappy, even though they have great wealth.

Remember that having more also brings more and bigger problems. The more you have, the more you can lose!!! So, you have to realize that NOBODY is financially secure.

How many of you find it is not “having your daily bread” that concerns you so much as the impatience to achieve more than that “daily bread”?

How many of you say you are going to “retire” and then can’t stay out of the working center of what is taking place around you? How many of you feel like a non-contributor if you sit to the side and, yes, allow another to take that job you proclaim to find unending? DO YOU REALLY WANT TO BE OUTSIDE THE LOOP OF PROGRESS? Is your health REALLY better pondering the problems instead of eliminating the problems? No matter how steady you might think self to be—check out your own attitudes. Now, check out how many of your attitudes you put off onto another! ARE “YOU” THE PROBLEM? I am quite serious: ARE YOU THE PROBLEM? And, do you talk about things which will surely bring problems down on the heads of others trying to make a difference in the state of affairs for the whole? NO, REALLY CHECK IT OUT!

What “stress” do you blame for your ill-

attitude or ill-health? Moreover, do you hop onto everything that comes through as if you can find healing in the cacophony of dozens of would-be healers—or do you attend your attitude and allow the healing to take place? Sometimes the healing does NOT take place but the important healing will always take place—in your attitude.

If you pitch-in and share, really share, the tasks at hand which will serve you well in, say, alleviating the “lack” of the moment for the whole of, say again, our very programs, will you somehow be weakened by the experience? Are the tasks so heavy as to damage you in some way? Is a packet of bread mix too heavy to lift or too stressful to create? Of course not, so YOU decide what is stressful—and there is no joy in the experience except the joy of being a martyr of some kind suffering your way through your daily “lack”.

There is no greater joy to human being than the esteem brought by pulling SELF out of lack and into production.

Remember, please, that you can have emotional poverty just as easy as you can financial or intellectual poverty. Which is your favorite mode of poverty acquisition? Could it be “waiting for someone else to supply the demand”?

Every one struggles, BUT, do you struggle in strength of unity and teamwork or do you avoid all unity and teamwork for whatever reason you have convinced yourself makes you pleased with self—in blaming another for your LACK? DO YOU ISOLATE SELF TO AVOID POSSIBILITIES OF INTERCHANGE WITH SOMEONE OR SOMETHING YOU PERSONALLY DISLIKE? Your answer is the most important one attitude I shall hear from YOU.

### CREDIT

There is a point to remember, traveler-on-this-journey: GOD CAN DO TREMENDOUS THINGS THROUGH THE PERSON WHO DOESN’T CARE WHO GETS THE CREDIT.

Do you strive for “credit” or cower from possible “responsibility” of your own actions should you err?

DO YOU EVEN KNOW WHAT IT IS YOU LACK? I CAN KNOW THAT YOU HAVE “LACK” IF YOU ARE NOT IN HAPPINESS.

Are you able to discuss your “lack”? And, can you ask for help? Until you can accept the lack, recognize you have need and ask for help—how can you hope to find truth in happiness?

You must admit your need, no matter how personally difficult, for it is essential if you would find happiness.

And, yes, I am going to go through every one of those eight Beatitudes and possibly even more—for you are losing your way wrapped up in your individual cocoons of isolation and “me-ness” which usually equates to eventual “mean-ness”.

### IT IS ALL IN THE ATTITUDE!

WHAT DOES THIS HAVE TO DO WITH IMPORTANT THINGS LIKE LACK TODAY AND MORE TOMORROW?

Everything!

If the problem is lack of circulation, does it matter whether Hatonn writes ten times a day or



annually? NO, it DOES NOT. YOU must gain greater circulation through service and having readers WANT to have your services.

Surprisingly enough, only a few even want to hear a word from some Teacher—they want practical input—but they will accept “self-help” ideas for better living. So, I need to spend more time on that reference.

What about the paper for which we write? Well, we are not the only writers around—ARE WE?

I asked that Ron write articles on corporations. That does not mean a little tip a week. People have to understand the VALUE to them if they incorporate. They have a need, which at first they cannot conceive, and they have to hear it over and over again in an instruction long enough to express that need and the solution.

You tend to wait for me to supply YOUR “ideas”. NO, NO AND NO. YOU SEE THE NEED AND FILL IT—THAT IS GOOD BUSINESS AND SERVICE.

I intentionally leave ROOM in the paper for that input but it is not utilized.

WE MUST SHOW THE “WAY”, CHELAS, NOT SIMPLY MESSAGE OUR OWN NEEDS AND WOUNDS—AND LACK.

How plan ye to get the word out to our readers that you have found a resource for our interrupted products? And, are you going to take care or protect our privacy or are you going to again set selves up for another fall of some kind at your enemy’s hands and mouth? The minute you set up schedules with the very talkers—you defeat your own program and resources.

I ask for privacy and protection—and you immediately break same. How can you succeed in business if you give away all your trade secrets? A trade secret is the only one thing that stands in a court of law if stolen. This is whether it is a brand product or specially ionized water.

If you get the idea that I am not particularly pleased with some things, you are quite correct, for some seem to not be able to understand the importance of the program itself, either here or there, while making sure the program is taken directly and immediately to the “enemy” camp. Oh my, God gave you the most wondrous tools of the universe: THOUGHT AND REASON. Enough said. Do you take every opportunity to share ideas or do some of you, with important positions, avoid at all costs any such possibility of such interchange? No, I’m still talking to YOU.

This is what you claim to want from me: BLUNT TRUTH AND TELL IT THE WAY IT “IS”. Yes, of course, the home crowd gets the brunt of the lessons—for unless the home team plays the game properly, there is no way to have anyone else even know the rules.

Herculean and formidable things are being accomplished every day and willing hands wait for the call for help and sharing. We have had several who would make a life-move to Manila just to fulfill their idea of helping.

Is this the way to accomplish our task? No, because there is not anything in which there can be service and the pressures would be incredibly difficult to overcome. However, if some of those same people would be allowed to participate in a volunteer program, then you might find a lot of relief. If the parties are too difficult to include, then there is required “fill-in”—but YOU must decide which is most advantageous while considering, as well, the willingness of the participant.

If you would, for example, just make sure you get a blend of tea from Will Park who is not yet into his health store operation, you can utilize his resources. The disclaimers or “proclamation” should be on the label, I suppose, but can be simply affixed onto the container as a part of the label so that it is visible as part of the label.

The point I make here is not in the production but in the distribution. DO NOT DISTRIBUTE ANYTHING NOT SO MARKED, PLEASE, NO MATTER WHO YOU ARE.

I do note, however, that with products, no matter from where you get them, need full write-ups and you have the information on anything and everything we have offered with breakdown of both contents and finished product. Surely there is someone who can get that information (lots of it in book 130) and summarize as for an article with recommendations as we used to offer even if we do not have anything to do with the product itself. YOU MUST ADVERTISE—AS IN OFFER THE INFORMATION—OR YOU WON’T GET ANY INTERESTED PARTIES. YOU CAN USE “PIGGY-BACK” MAILINGS FOR INFORMATION—BUT YOU ARE GOING TO HAVE TO TALK ABOUT THESE PRODUCTS IN THE PAPER BECAUSE OUR PEOPLE NEED THAT INFORMATION AS TO ABILITY TO GET THE PRODUCTS. These things are not “happenstance”. They have been researched and researched as they were developed in totally clean and wholesome facilities. Entire cabinet systems were built to make sure the facilities were adequate. If anything deteriorated, it was after the fact! And no, don’t give me the old “what about the colloids as in ‘silver’?” Silver colloid IS AN ANTISEPTIC AND AN ANTIBIOTIC OF THE HIGHEST CALIBER IN ITS OWN RIGHT. Added to other solutions it is one of the best purifiers of its kind anywhere—on the market or otherwise.

Can a product be contaminated? OF COURSE. ANYTHING CAN BE CONTAMINATED IF IT EXISTS, INCLUDING YOU. It is contamination of your own system that causes imbalances, illness and immune-system overwhelm.

Now you can have ultimate pleasure and success in your endeavors or you can destroy all possibilities of success and assistance; it is up to YOU. GOD PROVIDES—YOU DECIDE.

If you want success instead of struggling in “lack”, then YOU must make some decisions to get into the action or get out of it.

Some of you think you would be very happy free of any responsibility for whatever reason—but obviously you are NOT because you continue to suffer through the processing beyond the sharing of sharing the information you hold and that can be, and should be, written as instruction from which deviation is unacceptable. Do NOT offer a product that is NOT my product and call it mine. Some of your assumed changes are NOT good and you do not even know why. I am not going to tell you—because then you are again casting your assumptions onto another’s shoulders. WE DO NOT PRACTICE MEDICINE NOR DO WE CLAIM CURES OF ANY KIND—PERIOD.

In addition, if you utilize, say, Silver colloid, USE AVAILABLE INFORMATION, GIVE REFERENCES AND SOURCES AND PRESENT THE OUTCOME. IF SOMEONE HAS PROVEN THAT SILVER COLLOID KILLS, SAY, A STREPTOCOCCUS OF SOME KIND—STATE IT BUT REFERENCE ITS SOURCE OF CONCLUSION. There are lists upon lists of those vulnerable “bugs” and microbes. ### GLOBAL WARMING FEARS ARE MELTING By F.C. Blahut

*Global warming doom-sayers  
have taken a 1-2 punch from the real world.*

According to panicky scientists in the late 1980s and early 1990s, the Earth was on a

greased skid to oblivion from global warming.

The phenomenon, we were told, would lead to rising ocean levels which would change the map of the world.

Carbon dioxide from burning fossil fuels was the major culprit, according to these now-suspect experts—and the first victims would be people living on the tiny Pacific island nation of Tuvalu.

But now the 11,000 inhabitants of the Pacific country that was predicted to vanish under water because of the effects of global warming have been given a reprieve.

Instead of rising, sea levels have begun to fall. [H: Say what?]

And the guru of carbon dioxide has taken a step back from his prediction of rapidly approaching doom. [H: That is usually what happens when nothing happens.]

The scientist who panicked early about the alleged consequences of the greenhouse effect admits today that carbon dioxide from burning fossil fuels was not the main cause of rapid warming of Earth in recent decades.

According to published reports, Dr. James Hansen is also more optimistic that global warming can be prevented “without any economically wrenching actions” because of the growing realization that too much emphasis has been placed on the effects of burning fossil fuels.

This is, of course, totally contrary to what was preached at the infamous Kyoto Conference. Developed countries were to be punished for heating up the Earth, while the Third World was to be allowed to do all the heating it wanted.

Naturally, it would cost United States taxpayers a bundle. Now, it seems, reality has taken over and we won’t have to reduce our standard of living to that of Bangladesh.

Meanwhile, back in the Pacific, everyone’s head is still above water.

In the early 1990s, scientists forecast that Tuvalu, a coral atoll of nine islands—which is only 12 feet above sea level at its highest point—would vanish within decades because the sea was rising by up to 1.5 inches a year.

However, a new study has found that sea levels have since fallen by nearly 2.5 inches and experts at Tuvalu’s Meteorological Service in Funafuti, the islands’ administrative center, said this meant they would survive for another 100 years.

They said similar sea-level falls had been recorded in Nauru and the Solomon Islands, which were also considered to be under threat.

Foreign press reports opined that the release of the data from Tuvalu, formerly part of the Gilbert and Ellice Islands, will renew scientific debate about climate change and its input on ocean levels.

The islands’ scientists admitted they were surprised and “a little embarrassed” by the change, which they blame on unusual weather conditions caused by El Niña in 1997.

Hilia Vavae, the Meteorological Service’s director, was quoted: “This is certainly a bit of a shock for us because we have been experiencing the effect of rising oceans for a long time.”

However, scientists both on and off the island—locked into a doom scenario—insisted that the lower levels will be short term and the oceans



will soon resume their “inexorable rise”.

The Tuvalu government, a vocal critic of the industrialized world at environmental conferences in Japan and Brazil, has said that the result of its research is a “blip” and it is expected to make climate change a major issue when it joins the United Nations next month. **[H: Now, that was a smooth slide-in.]**

NASA said that a July study found that sea levels were being pushed up by the addition of 50 billion tons of water a year from Greenland’s melting ice sheet.

Professor Patrick Nunn, head of geography at the University of the South Pacific in Fiji and an expert on island formation, told reporters that the figures from Tuvalu, Papua New Guinea and the Solomons were based on inadequate research.

One Capitol Hill pundit, who asked not to be identified, questioned whether it was necessary to have a Ph.D. to determine when your feet get wet.

Nunn was quoted: “It is nonsense to try to make predictions about climate change from a data base of only seven years. You need data over a minimum period of at least 30 years. A lot of these sea gauges have been slowly falling over the last five years but that is a short-term trend.”

Hansen, of NASA’s Goddard Institute for Space Studies in New York, told a congressional committee in 1988: “It is time to stop waffling... the greenhouse effect is here.”

But apparently it wasn’t. Now he argues that warming over the past century was not mostly driven by carbon dioxide from burning fossil fuels, but by other gases such as methane and chlorofluorocarbons. Therefore, according to published reports, it should be “more practical to slow global warming than is sometimes assumed.”

Chlorofluorocarbons, of course, didn’t appear in any quantity until less than 50 years ago, which the scientist apparently forgot.

Hansen is now optimistic about our chances of survival. But he still insists in the report: “In the long run, fossil fuels will be the issue.” That’s what he said 12 years ago.

**[END OF QUOTING]**

My immediate observations? 1.) Survival may well be at stake here, and, 2) Survival is in danger because of guns in war over fossil fuels.

Readers, how much oil do you think you can pump out of your Earth without actually sinking some of your land mass above and beneath the seas?

#### RISING SEA LEVELS HURTING THE PACIFIC

*A number of Pacific island nations could drown during this century if ‘greenhouse gas’ emissions by industrialised nations are not dramatically reduced in the next few years. Already a spate of serious floods has hit the South Pacific in recent months, caused by rising sea levels due to global warming.*

**[H: Does anyone see anything wrong with that statement? What is wrong with it? I note several things which are totally incorrect but the glaring errors are an inference that somehow these floods, etc., are due to global warming. How so? There is not a flood around that doesn’t project such as: “The worst flooding since year before last or in this decade...” and none of them say it is from rising sea levels. The flooding is from floods, so why blame the wrong natural circumstance? Occasionally, there will be qualification of “the worst flood or drought in this century...” which by the way is only just begun! But now let us move on.]**

Recently, high tides drowned many causeways linking villages in the tiny South Pacific island of Kiribati, forcing cars, buses and trucks to drive through seawater in its capital Tarawa.

**[H: High TIDES? Are “high tides” global warming? Get Commander Soltec’s texts, please, and study them while you get informed. Some of you readers are going to be very sorry that you split away and followed Dr. Young and his version of Soltec if your intent is to LEARN something that will save your lives. Or is spiritual opium what you really have in mind so that you don’t have to actually learn anything? It is truly up to you. This is the latest in a series of such flooding across the South Pacific in recent months, an occurrence that experts say is caused by rising sea level due to global warming.

Kiribati is among a number of Pacific island nations that could drown during this century, if “greenhouse gas” emissions by industrialised countries are not dramatically reduced in the next few years.

High tides and stormy seas have also caused problems recently in the Marshall Islands, Cook Islands, Tuvalu and low-lying islands of Papua New Guinea (PNG).

In mid-January, high tides and strong winds caused seawater to flood parts of the low-lying areas of the Marshall Islands capital, Majuro. Some families were forced to move from their homes into government buildings during the height of the flooding.

In early February, landowners in PNG’s East New Britain province agreed to allow Duke of

York islanders threatened by rising sea levels to move to the mainland.

About 2000 people living on Bougainville’s Carteret atoll islands group have also asked to be moved to higher ground on the mainland, but lack of government funds has prevented this movement. Bougainville Administrative secretary Francis Kabano told the *New Zealand Herald* in January that people there were actually constantly forced to move with the rising sea levels.

A report released recently by the United Nations Environment Program (UNEP) warns that global warming could cost the world billions of dollars a year, unless industrialised countries take immediate steps to curb emissions of carbon dioxide and other gases produced from the burning of fossil fuel—all linked with the warming of the Earth.

The report says that in low-lying states such as the Marshall Islands and the Federated States of Micronesia in the South Pacific, the losses due to climatic change could, within the next 50 years, exceed 10 percent of their national wealth or the Gross Domestic Product (GDP). The report done by UNEP’s insurers, estimates that losses worldwide linked to climate change could annually cost \$304 billion by this time.

In the same report, UNEP executive director Klaus Topfer calls on the world “to act now”.

He says that countries should restart the climate-change talks, which were stalled in The Hague, the Netherlands, at the end of last year when the development countries refused to make any concrete commitments towards reducing their greenhouse gas emissions.

“We must help vulnerable areas of the world, primarily in the developing countries, to adapt to the consequences of global warming. We have a moral responsibility to our fellow men and women to protect them and their families from food shortages to devastating floods,” he argues.

Patrina Dumaru, assistant director for environment of the Fiji-based Pacific Concerns and Resource Centre, has perhaps heard all these before. “For us in the Pacific, a grim reality was realised,” he said referring to the climate-change talks that collapsed in the Netherlands.

“The over-consumptive lifestyle of the rich world was not negotiable—even if it cost us our land, peoples and culture. “For years Pacific and other small island states have pleaded with the industrialised world to take action so that the islands may be saved. Facts and figures considered alarming and unjust towards us were of no significance at this meeting, he pointed out.

“Although we contributed the least to global greenhouse gas emission—just 0.06 percent—we will be the most vulnerable to the effects of global warming and sea-level rise,” he added.

Writing for the *Pacific News Bulletin* monthly Dumaru says that while countries debate about what steps to take against global warming and negotiate international agreements, small islets have already been swallowed by the ocean in Tuvalu, Kiribati and Bougainville.

In addition, warmer temperatures have led to the bleaching of the Pacific island’s main source of survival—the coral reefs. Bleaching occurs when reef-building corals, reacting to stress such as warmer

waters, loosen the algae that help feed them.

Because the algae give them color, the starved corals look pale, thus the term “bleaching”. Continued bleaching ultimately kills corals. Last year, scientists reported that in Fiji, coral bleaching had reached levels that are the worst in 30 years. They attribute this to abnormally high water temperatures there in recent years.

There have also been similar reports from the Solomon Islands, Cook Islands, Tonga and Palau. At least one-third of Palau’s coral reefs were destroyed during the el Niño weather phenomenon in the mid-1990s, as a consequence of which its fish food sources were reduced. Under a co-operation agreement between Palau, Japan and the United States, an International Coral Reef Centre was setup in Palau in 1995 to help repair the damage.

As a prelude to The Hague Conference last year, the World Bank released a report warning of dire consequences to the Pacific island states from climate changes in the world.

It says that among the impacts of global warming would be the loss of low-lying coastal areas, more intense cyclones and droughts, failure of subsistence crops and coastal fisheries, losses in coral reefs, and the spread of diseases like malaria and dengue fever. It estimates that by 2050, Fiji will suffer annual damage to the tune of 2-4 percent of its GDP, and Kiribati 17-34 percent of its GDP. The bank argues that for the Pacific, climatic change should be considered one of the most important challenges of the 21<sup>st</sup> Century and a priority area for immediate action.

**[H: The BANK? Now we are getting there, aren’t we? The old International Banking Cartel (IBC) is at it again—while the little people are drawn and quartered and the reefs destroyed. Please be thinking what might be causing this “reef bleaching” and see if you can come up with an alternative possibility which now leads to ass-covering. First, we will just finish this article.]**

Reflecting on the failed conference at The Hague, Dumarú said that one thing was clear—money talks. “Rich countries don’t really care whether our islands sink, float or fly. That’s our little problem,” he observed.

“Of course, we can expect adaptation funds from them. After all, it’s a cheaper way of dealing with a problem of their making,” added Dumarú.

He argued that the challenge facing people’s organization in the Pacific, such as his, is to make the impact of climate change on Pacific Island communities an international human-rights issue.

Said Dumarú: “Still recovering from the aftermath of the nuclear bomb (testing in the Pacific), we must now prepare ourselves for the climatic bomb.”

I add this last regarding chains, for if one “link” does not meet a commitment or promise, or is delayed, ALL ARE DELAYED OR HAVE TO FILL IN THE MISSING PROMISE WITH OTHER ALTERNATIVES. Moreover, everything in the selective individual circumstance takes far longer to accomplish than first anticipated—and the ongoing scenario will change with the wind from moment to moment without consideration of “another’s” inconvenience or schedule. If we cannot be flexible, then we do not belong in this arena.

A lot of things have to be brought to the surface. Not the least of which, in these current instances, the rounding up of some of the major scam players which are now being picked up through intelligence operations even in the U.S.

I am not going to further detail the U.S. intent for use of 3392-181 because IT WAS USED. A lot of “cleaning” has to be done to allow the “powers-in-place” to be able to use the asset now. WE ARE NOT INTO THE U.S. CLEANING PROCESSES—WE JUST MEET OUR AGREEMENTS AS PUBLICLY STATED.

BACK TO REMINDERS  
AS TO GEOGRAPHIC LOCATIONS

I require, please, that if there are meetings to be had other than at the usual locations, that the following precautions be taken:

1. Dress casually and as you are seen in everyday ongoing interchange and activities. NOTHING is acceptable that causes attention to any deviation in typical dress or behavior. In other words, there will be nothing out of the ordinary and typical pattern now recognized by surveillance agents.

2. Require that our attorney be in attendance, for he can verify that there is credibility and monitor all meetings for security. He is well recognized and shall become that “extra arm” even more as we move along. He met “ME” on August 17, 1998 (interesting date), and can validate ongoing integrity and stance through subsequent months, yea, years.

3. A recognized “driver” must be utilized so that there is no notice of unusual movement. I suggest a party who also has been present since onset of activities in the Philippines.

4. Next, I ask that ESJ be requested to both attend any meetings set forth but be a party to any travel from the immediate location. He is familiar and well known in both media and government.

We do not ask his participation other than as stated and that he has known our people for some time now and has good rapport. There is no reference made to any association other than as a writer who has shared his published work and made contact, even in the U.S. recently, for possible publication of his books. He is now recognized as a part of the National Security department and would be totally acceptable to government liaison status.

I wish to thank our people Stateside for making the effort above and beyond to meet and confer regarding publication potential. You just never can tell, can you?

5. I ask that even if meetings are held in the immediate location of our usual recognition that these people attend—for security purposes.

It is imperative that counsel be present if possible to make SURE we meet legal requirements or, at the least, be able to discuss such legalities as may be presented. Our presentation is simple and separate—but there will undoubtedly be efforts at negotiating and rearranging guidelines. Our attorney is most familiar with all ramifications involved since our arrival in Manila.

Ms. Teri York of Los Angeles can verify, if necessary, the meetings at onset of August 1998 should witness affidavit be requested. Unfortunately, the attorney accompanying the GAIA team, Don Rhoads, is deceased since that time but evidence of his participation will be easily found in his records. It is good to also recognize that many legal counsel, including Mr. Rhoads, did their own investigation of our instruments and were

totally satisfied with the validity of said documents and instruments.

Attorney V.A. (Manila) was, in addition, the legal counsel for a corporation offering a MAJOR livelihood project here in the Philippines, now on hold awaiting funding.

We are more eager to share information on some of the planned projects than on all this political involvement—but there is no point in “fighting” any system, for we have no involvement in any nation’s business, banking or governance; neither do we want any such input.

NEITHER ARE WE COMPETING WITH ANY GLOBAL AGENCY, I.E. IMF, WB, TRADE ORGANIZATION(S) NOR UNITED NATIONS’ AFFAIRS. CERTAINLY, WE ARE DEDICATED TO THE PROTECTION OF THE STABILITY OF THE UNITED STATES AND HER ECONOMIC EQUILIBRIUM. WE WOULD, HOWEVER, BE MOST HAPPY TO DISCUSS POINTS OF MUTUAL CONCERN. OUR FULL INTENT IN THE “AMERICAS” IS IN THE AREA OF “NATIVE” (ORIGINAL CITIZENS) ASSISTANCE OF A SOVEREIGN NATURE. WE MOST CERTAINLY ARE NOT “AT WAR” WITH ANYONE—AS GOD IS AN EQUAL OPPORTUNITY PROVIDER.

It is noted that the FED and the IMF are making some very sad predictions, citizens, as to the economic position of the U.S. and expected continued growth and probable recession potential. That is also worthy of note because shoring-up shortfalls and offering stability is a thing which requires massive funds input. How much can the FED continue to print, based on nothing? **[H: Please read this with an eye as to how much you would enjoy being caught in this absurd world of such intrigue where the term “Only in the Philippines” is the going catch-all for any circumstance. However, we were faced with a new excuse for not finishing our mailing list OR returning the hand-written journals—a computer virus captured several volumes. Well, it didn’t sell but neither have the journals been returned. OIP? We shall see, for some of these people are now involving the law—and OIP is not going to cut it much longer.]**

#### TOO MANY FAKE CERTIFICATES AND ‘FAKE’ SONS, TOO

Don’t you think it’s disgraceful that a former Chairman of the Presidential Commission on Good Government (PCGG) was arrested by the Federal Bureau of Investigation (FBI) in New York City in a sting operation? Ex-PCGG Chief David Castro—an appointee, mind you, of the allegedly squeaky-clean and saintly Cory administration—was caught by the Feds in *flagrante delicto* [in the very act of committing the offense] while allegedly helping a certain Edilberto Marcos (who claimed to be an illegitimate son of the late President Ferdinand Marcos) sell an FBI agent, posing as a buyer, a \$20-million share of a gold certificate FROM A SWISS BANK.

The certificate, like the poseur who claimed to be Macoy’s (Marcos) son, turned out to be fake as well.

Those Union Bank of Switzerland (UBS) gold certificates must be as numerous as mushrooms—just as there seem to be too many “illegitimate sons” of the late Apo Ferdie. The way “sons” of Macoy are popping out of the woodwork, FM will end up having more sons from different moms than Erap.

I remember an encounter some eight years ago when a friend engaged in buy-and-sell and real estate brought a fellow to my home who also claimed to be an “illegitimate son” of Marcos. I wondered how he could get away with that deception (didn’t believe his story one minute)—since he looked like the BBC computerized version of Jesus Christ, or better, a cross between Jeffrey Schilling and Bob Sobrepna.

In any event, this supposed “Marcos son” showed me a sheaf of genuine-looking certificates of gold bullion allegedly coming from the same UBS or Union de Banques Suisses. The watermarks looked legit, the printing appeared kosher. The stamps and signatures looked terrific. But there was something wrong with them. The documents were worded in German and French, and I noticed some misspellings of words in both languages. Now, everybody knows that German, French, Italian, and one unique Swiss dialect spoken by one percent, are the official languages of Switzerland’s 20 cantons (confederes) and six half-cantons. So, how could the UBS certificate printers have misspelled any words in German or French? This is particularly so since the headquarters of UBS, the largest Swiss bank, are located on Bahnhofstrasse in the German-speaking city of Zurich, a boulevard which, if not exactly paved with gold, contains underground vaults underneath it literally packed solid with gold.



In any event, that UBS certificate being passed off by “Edilberto” Marcos and his partner David Castro must have come from the same printing press as the documents showed to me by that earlier fake Marcos. I shooed the illegitimate Macoy II and his counterfeit certificates out of my place pronto on the day he came calling—but perhaps others may not have been as suspicious since, to my amazement, the same racket is going on, alive and well, eight years later!

P.T. Barnum was right when he said, “There’s one born every minute.”

What proves Barnum’s point, in addition, is the notorious Nigerian “oil” scam which has been going around the world victimizing even the most astute and sober people for decades. I exposed the Nigerian scam in this column several times, in fact every four years since 1988, but the scam just keeps rolling on. Last week I received a note from a reader saying she had just received a Nigerian scam letter only this month! They simply keep trying. And, often, the swindlers succeed.

It is unfortunate that a former PCGG Chairman got involved with the likes of this Edilberto M. Marcos, who passes himself off as the President and CEO of Metro Grant Holdings Ltd., with offices in Unit 2602 HongKong Convention Plaza Office Tower, 1 Harbour Road, Wanchai, Hong Kong. (This building is right beside the Grand Hyatt Hotel, known to many Filipinos.)

According to a complaint “advisory” sent by Ricardo A. Diaz, chief, Interpol Division in Hong Kong to the Manila Interpol office in the National Bureau of Investigation, this Edilberto Marcos Marcos (that’s what the M stands for) holds Philippine Passport No. EE835334. Interpol revealed that he also utilized other names, e.g. Edilberto Marcos Del Carmen and Alberto Malanum Puzon.

Interpol Hong Kong avers that it received a complaint filed by a certain Nakanishi Takamasa, a Japanese, regarding “financial fraud” (swindling). Takamasa and his group complained that they “were lured by Marcos to invest in a ‘roll program project’ dealing in the trading of gold between Taiwan, Hong Kong, and the Philippines in the total amount of U.S.\$1 million.” The project, Diaz said, “turned out to be spurious.” **[H: Can you now see WHY we refuse to do business with anyone knowingly involved in Roll-overs or “trading” programs? Still, dozens tried to fool us—from Africa to London and back again. You cannot solve problems by supporting THE problem.]**

This Edilberto M. Marcos, it seems, also claims to be a lawyer, but Jose Aguila Grapilon, chairman of the Integrated Bar of the Philippines, appears to have issued a certification dated March 8, 1999, that the name Edilberto Marcos or Edilberto Del Carmen did not appear in the list of IBP membership.

As for Mr. Castro, who headed the PCGG from 1990 to 1992, if you’ll recall, he was actively involved—aside from his duties—in gold-hunting activities. As I’ve said in a previous column, there’s something about gold or buried treasure that drives men mad.

**In any event, there have been many ranking PCGG officials who engaged in questionable activities, which tends to give the public a general idea of what the PCGG is all about—a gravy train for the “favored”. Join the PCGG or become a PCGG nominee, as the common wisdom goes, and you’re guaranteed “success”.**

With Castro and Marcos nabbed in New York, do you think that’s the end of it? Our name is

mud in Thailand, too.

My wife—who has been in Bangkok for the past three days for conferences with our Thai agricultural associates in a hybrid “agri” project of the O.B. Montessori Farm before flying on to an international congress in Athens, Greece—phoned me last night to say that Filipinos in Thailand are embarrassed. Almost every hour-on-the-hour on Thai television the past two days, there had been reports about two Filipinos, one Thai and one Singaporean under arrest for trying to peddle counterfeit debt papers.

Thai police have grabbed counterfeit U.S. bonds with a purported face value of \$24.7 billion from a bank vault in Bangkok, while Deputy National Police Chief Sant Sarutamongk has been telling reporters they are looking for four other foreign suspects belonging to the gang.

The fake documents and bonds probably tie in with the billions of dollars of non-existent U.S. bonds and stock documents which were seized months ago in Gingoog, Misamis Oriental, and other points in Mindanao and the Visayas. U.S. Charge d’Affaires Michael Malinowski, who guested on our Greenhills Walking corporation forum last Wednesday, had even explained in answer to a question from the floor that the “bonds” and security “documents” which have been discovered in the Philippines in the past year and half have been “fakes of fakes”. In short, the counterfeiters printed, on aged and authentic-appearing paper, specimens of U.S. and other international bonds that never existed. Once again, P.T. Barnum’s sucker-a-minute theory has been proven right.

The credibility of Thailand’s new Prime Minister, Thaksin Shinawatra—who’s supposed to be business-savvy since he’s a multibillion-baht telecommunications and IT mogul in private life—was severely dented by the fake bond scandal which has captured the imagination of the Thais. His reputation was further damaged when he flew to the site of an alleged “gold find” involving what was touted as a hoard of tons of gold and foreign bonds buried in a cave near the Myanmar (Burma) border. A controversial (some say “crackpot”) Thai senator named Choawarin Latthasaksiri maintained that the loot had been stashed away by Japanese soldiers during World War II and was worth about \$50 billion.

Thaksin bit the bait and even quipped that the “find” would be enough to meet Thailand’s \$62 billion national debt. To his chagrin, it was later discovered that Senator Chaowarin had never entered the cave himself nor personally viewed the alleged find. All the “evidence”, it turned out, he could produce were photocopies of U.S. bonds which were recognized to be clumsy fakes—did he get them from the so-called Edilberto Marcos gang?

Incidentally, the controversial cave is not far from the famous Bridge on the River Kwai (remember the movie with Alec Guinness, Bill Holden, and Ralph Hawkins which produce the popular *The Colonel Bogey March*).

I’m told that among the schemes of Edilberto Marcos or Del Carmen is the tall tale that when the Marcoses fled Malacañang, along the items spirited out of the Palace were boxes of 1934 U.S. dollar bills and other instruments. To make the story ring true, Del Carmen surrounds himself with active or inactive military personnel who, he maintains, were the ones who whisked those dollars and bonds out of the Palace in 1986. He has allegedly been “selling” the idea that these boxes can be redeemed from these military men for a trustee “fee”, promising that the returns on investment would be “around U.S.\$100 million per box.” Glory be! Do people actually

believe such stories? They apparently do.

**[H: Our observation is that they do NOT believe the stories but hype it up anyway and the sophisticated “traders” just grab a bunch of funds as fees and disappear. Our people have to continually tell people dragging such garbage to us, they will not be seen nor are their documents even to be viewed and none are to be brought even into showing. Another scam is “letter-of-credit discounting”. The fellow exhibits exotic-looking letters of credit for big-ticket projects (such as construction and energy) in—hold your breath—the former Russian Republic of Georgia (Stalin’s home province in the old Soviet Union), as well as the People’s Republic of China. The so-called L/Cs “represent” several billion dollars worth of projects, he underscores. Since these are generally divided into U.S.\$50-million compartments, he entices the victim to put up the peso or dollar equivalent of whatever percentage he says is the insurance cost of an insurance swap already prearranged, he winks, with Lloyds of London. It seems that P10 million has already been “collected” from willing suckers for these L/Cs which were, when checked, described as “rubbish L/Cs” by a reputable German bank.

The embezzler also claims, as the “eldest son” of Marcos to have “frozen accounts” with Citibank, HongKong, Shanghai Bank (HSBC), Sanwa Bank, and other institutions. He has been enticing holders of U.S. dollar accounts to transfer their valuta or hard cash to his designated bank in his name in exchange for profitable guarantees to be issued by his banks. The victim “bites” when, in connivance with certain bank officials, the accounts are “confirmed”.

There are also “real estate” scams and a ploy described as “hostaging certificates and assets”. In the latter scheme, investigators suspect, he has already racked up U.S.\$300 million in “hostaged” assets. I won’t try to explain how this goes since I don’t understand it myself.

However, it’s clear that, like all successful swindlers, Elder son Marcos or whateverhisname is a smooth talker, a svengali of financial doublespeak. Why, he even passes himself off as a CIA agent—and I don’t mean “Certified Ilocano Agent”.

#### SIR JULIUS BLASTS ‘AID MENTALITY’

Papua New Guinea has become so engrossed with foreign aid that it lacks innovation and creativity, and in the process has become a nation of beggars, former Prime Minister Sir Julius Chan has said.

The sad thing about it, he added, is that in all of PNG’s 26 years of existence, it has now become more dependent on foreign aid than ever before.

“And that’s bad. We are no longer a nation seeking to be independent. We’ve become a nation of beggars,” he told *The National*.

“The dependency syndrome has permeated the whole nation and we have become a nation of dependants. We have done a summersault in 25 years from what we wanted as an independent nation, back to a dependent state.”

Julius said when you have that kind of mentality, then you’ve lost confidence in yourself.

“Nobody is really worried about generating income to be able to look after themselves, or their capacity to do it themselves. Everyone, including provincial governments and the National Government, all they ever talk about is the World Bank, IMF, the Australian, Japanese, Chinese and other governments.”

A fierce opponent of tied aid, Sir Julius said all the efforts at present are concentrated on capturing aid money from various sources, and “we never do anything for ourselves.”

“We’ve lost that luster and determination. The will

to want to be self-reliant has staggered,” he said.

“And in the minds of all our provincial governments, their job is to see how much money they can get from these (foreign) governments. That’s all they do, they don’t think about themselves and producing these things themselves.”

The former Prime Minister said the thinking that is now prevalent in the minds of the people is one of hopelessness.

“The wealth of the nation is not the Government’s wealth; it is the distribution of its wealth, the money that is in hands of the ordinary people, that is the wealth of the nation,” said Sir Julius.

“The wealth of the nation in my definition is directly and proportionately related to the income of an individual; it’s not in the hands of the Government. When the people are rich, the nation will be rich,” he said.

Water, electricity rates and rentals should not be seen as money-making avenues for the Government but rather as competitive factors for investors to pump in more money. He said it was very sad that there has been no new major development in PNG because huge amounts of money have been given to friends, wantons and cronies who consume the lot and do nothing to build up anything to come back and generate income.

He warned that donor countries also need to look after their own people and one day they will run out of “bread to go around” and they will cut aid to PNG.

“That’s why we’ve got to stand alone. That is why outside forces may not wish for us to stand alone. They want Papua New Guinea to continue to have problems so that we can always be controlled,” he said.

He said the bad habits that people have sunk into like drinking, gambling, and having long holidays were making people unproductive and heavily dependent on others.

Therefore, you can realize that one of the higher teachers described it thusly: "In the beginning there was neither existence nor non-existence. All this world was unmanifest energy. The ONE (Creator) breathed, without breath, by Its own power. Nothing else was there."

That is a picture to contemplate that fullness and emptiness of everything present and nothing present. Therefore, in the reality of existence ALL THINGS had/have ONLY POTENTIAL. That potential will present, as THOUGHT becomes manifest. What do YOU wish created or made manifest THROUGH YOUR THOUGHTS? First must come the "idea".

By sheer mandate you are, therefore, a part of this "Unity". Then, however, you take that idea into your own perceptions and perspective so that even though the potential and now, the idea, is present—you will take and customize it and pronounce it "mine".

The biggest drag on man individual is that, after focus and personalization of an idea, individual EGO stakes its ground and demands a higher place in the personal recognition than that which came before. Many a person cannot move outside his EGO trap to do other than foolishly grab a total copycat theft of another's property and ideas, and call it their own—IF IT BE OF VALUE TO THEM PERSONALLY, IF ONLY INDIVIDUALLY. The stronger EGO will prevail or sit to the side and laugh at the clowns clawing for attention and accolades at the top of the ladder as perceived in "their" own individual minds.

The next step is, surely, to claim the ideas and property as their own original thought even though

the possibility has no truth in reality.

Some will not even bother to change labels but claim right of some "royal" decree as excuse for taking immorally, if not illegally, another's property, especially if the ideas have been successfully presented as proprietary property.

This does not, however, negate the fact that there is only 100% potential available. When your ego demands justification through outright lies and immoral seizure of those ideas, you have real problems developing.

Ego is a poor bedmate because the ego can only live in fear while the soul-self is NOT that ego mask or self-image and, therefore, the battle is joined.

Look carefully into "meaning" as you consider that ego-based charade. If you have a top-dog position—from wherever you claimed that position, it is perception. If you have the power of position or the power, say, of money, you will note that the power in the position or holding is only related to those things—and that power goes with the title, with the job, with the money or ability to have "force" at your fingertips. As soon as the title, the job, the money go away, so does the power.

Self-power, on the other hand, is permanent, because it is based on the knowledge of the SELF.

Dr. Deepak Chopra, for instance, will point out to you that "Self-power, on the other hand, is permanent, because it is based on the knowledge of the Self. And there are certain characteristics of self-power. It draws people TO YOU, and it also draws things that you want TO YOU. It magnetizes people, situations, and circumstances to support your desires. This is also called support from the Laws of Nature. It is the support of DIVINITY; it is the support that comes from being in the state of grace. Your power is such that you enjoy a bond with people—and people enjoy a bond with you. Your power is that of bonding—a bonding that comes from true love."

## WHY NOT IDENTIFY SELF?

There are many reasons why people don't wish to identify selves but the one we are most asked about is the lack, even after demand to do so, of identification of those who write in "name of" myself or any "teacher", even though the gush and mush as PRESENTED by the puppet is all but nauseating. THE REASON FOR THE NON-IDENTIFICATION IS TO CONTINUE TO DECEIVE THE READERS INTO BELIEVING THAT THE MESSAGE IS FROM SAME RESOURCE AND WRITER.

The argument is that you only need present the speaker as to identification and some "bogus" clearing statements. NO, this is incorrect in that, as an example, you have a secretary who can't spell ten words correctly but presents as if they are a secretary who is exceptional in their field in said career. I use this extreme because those who use another's

reputation, presentations, original thoughts and even to the script of the play itself are THIEVES and DEMAND TO HIDE THEMSELVES BEHIND THE SHROUD SO AS TO NOT BE RESPONSIBLE IN ANY MANNER AS LONG AS THEY CAN HIDE THE SUBTERFUGE AND DECEPTION.

Along these same lines of thought and reason, let us consider the third Beatitude: "Blessed are the meek, for they shall inherit the Earth."

This is one of the more abused of the Beatitudes, having been misdefined since inception.

It might be better understood if it read that Blessed are those who live in truth, for the ego-run politicians will be uncovered while the flow will ultimately come back to truth.

I suggest that the word "mighty" would be far more definitive of the potential than "meek". The mighty have the power of Truth on which to build and stand. If you have a person who reduces self to rage and insults without control while presenting lies against another, you have WEAKNESS, not strength.

When you have, on the other hand, those who are lied against and yet calmly allow truth to evolve from the chaos, you have untold strength. However, this does NOT allow for lack of confrontation in the face of lies and criminal acts.

Error of great magnitude: Giving "forgiveness" prior to any effort at restitution of wrongs committed—period. If a person truly seeks forgiveness for indiscretions, there will be sincere EFFORT AT RESTITUTION AND CORRECTION TO THE FULL EXTENT POSSIBLE IN THE "FORGIVE ME" CIRCUMSTANCES.

You people murdered a man a while back and then claimed your murder absolved YOU of all repercussions forever more. You simply called him a savior, laughed at God and continued on your cop-out way.

I can give you a better and far more personal example in the more local instance of what we simply have to refer to by REAL labels and titles.

Many accuse and proclaim that the Phoenix Institute, specifically Ekkers, has somehow stolen money. The fact that there is no money due-and-owing on any loans seems to be beside the point as far as the prattlers and accusers are concerned. Be that as it may, look at the lenders and their position: So far, there is no loss as to original agreements. None.

Next let us look at who takes responsibility for seeing to it that any debts are paid when and if due and payable. Who? Do you realize that Dr. Young, Rick Martin, *et al.*, have had as much personal reward as to use of funds as anyone? Do you expect those parties to PAY YOU? Why not? They were FULL participants, advisers, and were in the most responsible positions. Why are THEY NOT RESPONSIBLE? Why? Because they further "took from" the coffers, the products and the projects in deliberate efforts to DESTROY the entities themselves.

Do you see how simple it is to gather you in as a flock within the LIES?

Look at these definitive characteristics and you will note that each category represents a setting aside of EGO to the extent of being able to learn, grow, recognize truth and act in honor.

Be humble, correctable, educable and OPEN. This is inclusive in the definition most suitable to the referenced "attitude". Does Dr. Edwin Young REALLY fit this EGO STATUS? Verifiably? Are you sure?

#### TOO BUSY AND TOO IMPORTANT— DOING WHAT?

I ask to share an observation made by a most insightful Black poet, Paul Lawrence Dunbar:

The Lord had a job for me,  
But I had so much to do,  
I said, "You get somebody else,  
Or wait 'til I get through."  
I don't know how the Lord came out,  
But He seemed to get along.  
But I felt kind of sneakin' like—  
Knowed I'd done God wrong.

One day I needed the Lord—  
Needed Him right away;  
But He never answered me at all,  
I could hear Him say,  
Down in my accusin' heart;  
"Brother, I'se got too much to do;  
You get somebody else,  
Or wait 'til I get through."

Now, when the Lord He have a job for me,  
I never tries to shirk;  
I drops whatever I have on hand,  
And does the good Lord's work.  
And my affairs can run along,  
Or wait 'til I get through;  
Nobody else can do the work,  
THAT GOD MARKED OUT FOR YOU.

Now, please, as you look over this and ponder possibilities and the FACTS of actual experience: Will our enemies fall? THEY HAVE ALREADY FALLEN. WHAT HAVE YOU MISSED? Or, have you been perchance too busy to notice?

When you study your own attitudes, however you define words, do you carefully check through that list of things you sow while placing karmic penalties onto others?

I take liberties as we consider even that "karmic law" in that **you HAVE A CHOICE WHAT YOU SOW!** You ARE going to reap, ultimately, that which you sow, therefore, the time for thought and conscious action is before you plant that crop and fertilize it with salt instead of nutrients. The crop at harvest will be directly resultant of that which you planted. THE RETURN IS CERTAIN. You will not get tomatoes out of wheat seeds. Moreover, you will NOT reap reward in truth after you have planted and nurtured the lie, even if by accidental mistaking of the seeds you sowed. By the way, you can steal a baby—but you can NEVER make it "yours". Think about it.

So, here you see "karma" but what of that elusive term "dharma"? It is just as simple. We "identify" the secretary as Dharma for ease of recognition. Dharma as in individual has dharma. This simply is a Sanskrit word MEANING "life purpose".

And, if you have to steal someone else’s property to “spread the word”, you have just announced your intention through the loudspeaker as to it being of your word, not God’s. Does claiming that another person’s property is yours make it so? No, that person who thieves is an even bigger thief as he claims credit where none is due, at which point the lie is enlarged.**

Can a non-gardener tell you how to grow a garden? Indeed, but without experience he can only tell you “another’s” EXPERIENCE. It would seem ever so much wiser to get a gardener and learn what you are doing and what works and where. Moreover, would you trust your crop to one who is known to give false information and lie to you? You can use the experience of others if shared—but you cannot claim another’s expertise for self, lest you be the fool. Either way, you will only get wheat by planting wheat seeds.

#### BACK HOME IN THE TRENCHES

When you cannot learn or grow from an experience, no matter how seemingly distressful, you are not thinking clearly or creatively.

Our people are amused and entertained by the “opposition” players who are diligently snooping and prodding to get secrets revealed about what our teammates MIGHT be doing. They aren’t, frankly, doing anything.

Have you ever noticed that free help is often far too expensive? Even more complicated is when it comes from a great distance, marches in and takes control and unrest is under way. This is very difficult, indeed, when it is perceived that the “gift” of presence is somehow related to God or “contribution”. How seldom do people want to fill the “volunteer” task most necessary—for few want to be “Indian Braves” but only “Chiefs”. Next comes the unfortunate clash of personalities or attitudes. This may be the most important: The attitude about what you are.

My point is that you must be ever conscious of that which you do—for in any circumstance where unity of several is what produces product or purpose of the several, one MISattitude can collapse the entire purpose status or outcome.

In today’s noise exuding from every machine possible, what do you see and hear? First you find self sinking into accepting that which is presented because changing concepts is too large an order at any one moment in time. A good example is of the man, intruder, who shoots his neighbor. Why? Because the intruder was caught by the neighbor stealing something to which the neighbor objected, the item being his own. Then, blame: “If you hadn’t tried to stop me, I wouldn’t have been caused to shoot you.” You can argue the point until those proverbial cows come home but it happens over and over every day. The point seems to be to blame anything and anyone for your own deviant behavior.

It boils down, finally, to something like: “I had to steal from you because you wouldn’t give me what I wanted. And, no, I won’t give it back just because its yours.” Ah, life is often a sad journey along the route of realization and to insight.

Why these topics? It’s my job, students. As we near “impact” we must remind ourselves of our purpose. We also must recognize that Satan always tries harder when confronted directly and up-close. What director of chaos controls today? The same old one who has controlled and manipulated since man’s creation. The games change only slightly, while the intent goes on ever unchanged in the human arena.

Satan is the ruler of the human arena and he controls through the Ego. God is the Creator which allows and yet is all in all of everything, of which you are a part. Indeed, the battle is perceived as being between good and evil. I prefer to consider the experience of living in participation beyond the limitations of an ego-driven performer.

When death seems the easier in a choice of living or dying, the soul is crying to get free. When dying is no longer the choice, the soul will burst free. This is very frightening to the controllers who must repress and suppress the masses. It is of this metal that the guns of revolution are fashioned.

Is there danger of civil war in the Philippines? Yes—and 100% of the other nations as well. One wrong “attitude” acted upon will determine the turn of events.

Can conflict be averted? Yes, with one or two singular acts of leadership so that the people can regain their estate of self and equality—so that they can sustain selves in dignity. A man with dignity cannot be destroyed no matter how small his prison. This is called truth of mind and strength of soul. Don’t try your psychology on me, friends, for my gift is opportunity, self worth and, yes, indeed, FREEDOM.

I honor you, chelas and, yes, I do come forth from the giant races you seem to have long forgotten. In general, you are lost in the wilderness of confusion. May you be given to see and understand while remembering that when it is too great to walk, I shall carry you **if your intent be worthy**. If your intent damages another, you shall struggle on your own way—for I must be invited to come within. Command over ego is the mark of the purpose of the exercise of physical life. ## TELL THE TRUTH ABOUT ISRAEL

“Fear of being slandered as ‘anti-Semites’ means we are abetting terrible deeds in the Middle East.”

What if we had supported the apartheid regime of South Africa against the majority Black population? What if we had lauded the South African White leadership as “hard-line warriors” rather than racists? What if we had explained the shooting of 56 Black protesters at Sharpeville as an understandable “security crackdown” by the South African police. And described Black children shot by the police as an act of “child sacrifice” by their parents? What if we had called upon the “terrorist” ANC leadership to “control their own people”?

Almost every day that is exactly the way we are playing the Israeli-Palestinian war. No matter how many youths are shot dead by the Israelis, no matter how many murders by either side and no matter how bloody the reputation of the Israeli Prime Minister, we are reporting this terrible conflict as if we supported the South African Whites against the Blacks.

No, Israel is not South Africa (though it happily supported the apartheid regime) and no, the Palestinians are not the Blacks of the shantytowns. But there’s not much difference between Gaza and the Black slums of Johannesburg; and there’s not much difference between the tactics of the Israeli army in the occupied territories and that of the South African police. The apartheid regime had death squads, just as Israel has today. Yet even they did not use helicopter gunships and missiles.

Rarely since the Second World War has a people been so vilified as the Palestinians. And rarely has a people been so frequently excused and placated as the Israelis. Israeli embassies are now buttonholing editors around the world, saying that it’s not fair to call Israel’s Prime Minister “hard-line”. And the reporters are falling into line.

Sharon, we are told, may turn into a pragmatist, another De Gaulle; in truth he’s more like the French putschist generals in Algeria. They also used torture and massacred their Arab opponents. It needed an Israeli writer Nehemia Strasser, in Ha’aretz—to point out that Sharon’s career spells anything but peace. He voted against the peace treaty with Egypt in 1979. He voted against a withdrawal from southern Lebanon in 1985. He opposed Israel’s participation in the Madrid peace conference in 1991. He opposed the Knesset plenum vote on the Oslo agreement in 1993. He abstained on a vote for peace with Jordan in 1994. He voted against the Hebron agreement in 1997. He condemned the manner of Israel’s retreat from Lebanon in 2000. He is now building Jewish settlements on occupied Arab land in total violation of international law at a faster rate than his predecessor.

Yet we are to believe that it is the corrupt, Parkinson’s-haunted Yasser Arafat who is to blame for the war. He will not “control” his people. He is chastised by George Bush while his people are bestialised by the Israeli leadership. Rafael Eytan, the former Israeli

chief of staff, used to talk of the Palestinians as “cockroaches in a glass jar”. Menachem Begin called them “two-legged beasts”. Rabbi Ovdia Yousef, the spiritual head of the Shas party, called them “serpents”. In August last year, Ehud Barak called them “crocodiles”. Last month, the Israeli tourism minister, Rehavam Zeevi, called Arafat a “scorpion”. Even the South African regime never called the Blacks by such vile names.

And woe betide the diplomat or journalist who points this out. Earlier this year, the Simon Wiesenthal Centre, in Paris, accused the Swedish president of the European Union of “encouraging anti-Jewish violence”. To condemn Israel for “eliminating terrorists”, the centre wrote in a letter to the Swedish prime minister, “recalls the allied argument during the Second World War, according to which bombing the railways leading to Auschwitz would encourage anti-Semitism among the Germans”. Sweden was making “a unilateral attack against the state of the survivors of the Holocaust”. And the Swedish president’s crime? She had dared to say that “the practice of eliminations constitutes an obstacle to peace and could provoke new violence”. She did not even refer to death squads.

In February Newsweek propagated a virtual fraud on its cover by showing under the headline “Terror Goes Global Exclusive: Bin Laden’s International Network” a frightening photograph of a man (head and shoulders), his face covered in an Arab scarf, holding a rifle in his right hand. The reader would imagine this to be a member of Osama bin Laden’s network of “global terror”. But I traced the Finnish photographer who took this picture. He snapped it at a funeral on the West Bank. The man was an armed member of the Palestinian Tanzim militia—and had nothing to do with Bin Laden. The Tanzim are violent enough. But the cover generically smeared the entire Palestinian people by associating them with the man supposedly responsible for bombing US embassies in Africa.

As that brave American writer Charley Reese said in his regular U.S. column, the Israelis “have created their own unconquerable enemy”. They have made the Palestinians so crushed, so desperate, so humiliated that they have nothing to lose. We, too, have done this. Our gutlessness, our refusal to tell the truth, our fear of being slandered as “anti-Semites”—the most loathsome of libels against any journalist—means that we are aiding and abetting terrible deeds in the Middle East. Maybe we should look up those cuttings of the apartheid era and remember when men were not without honour.

**[JR: The events in South Africa during apartheid, and the French occupation in Algeria stirred the world’s conscience against the injustices of a captive people. How is it that today, Israel gets a pass on her aggressive assaults in the occupied territories of Palestine? Why is the world press being warned by the Jews not to focus on Sharon’s past opposition to the peace process in the Middle East since 1979? Why are we called anti-Semites when we dare question or criticize Israeli policies? Why aren’t we called anti-Zionist or anti-Jew? What is a Semite and why do we cower if we are called an anti-Semite? (Webster’s Dictionary states: A Semite is a**

member of any of the peoples whose language is Semitic, incl., the Hebrews, Assyrians, Phoenicians, Babylonians, etc., not specifically a Jew) If Israel can falsify the meaning of the word Semite, what else has she changed to further her goals? Who are the “Jews” and what is their true origin?]

## U.S. WARNING AFTER ISRAELI ARMY WITHDRAWS FROM GAZA STRIP

GAZA CITY (AFP)—Amid general relief after the Israeli army pulled out from autonomous Palestinian territory it had occupied, Israel faced a warning from Washington not to “overreact” again to Palestinian attacks.

The army withdrew late yesterday from the land it had taken the night before, following rare criticism from its ally the United States, as violence continued to flare in the West Bank and Gaza Strip.

Palestinian security officials reported that half a dozen troop transports and special lorries transporting tanks were seen withdrawing from the area late last night and later confirmed that the pullout was complete.

For the first time since the autonomy regime was set up in the Palestinian territories, the Israeli army had on Monday night occupied territories in the Gaza Strip under the control of the Palestinian Authority, in response to mortar attacks on the southern Israeli town of Sderot.

The pullout after the reoccupation, which triggered angry reactions throughout the Arab world, came as a relief, as the international community feared it would cause further escalation in Mideast violence.

Washington expressed pleasure at Israel’s withdrawal, but U.S. officials warned the Jewish state not to “overreact” again to Palestinian attacks.

The abrupt Israeli withdrawal from the Gaza Strip’s Beit Hanun sector followed a harsh denouncement of the overnight reoccupation by U.S. Secretary of State Colin Powell.

Powell called the operation—ordered in retaliation for Palestinian mortar attacks—an “excessive and disproportionate” response, and told Israel to respect previous agreements and withdraw its troops.

“The hostilities last night in Gaza were precipitated by the provocative Palestinian mortar attacks on Israel,” he said. “The Israeli response was excessive and disproportionate.”

Though Israeli officials said the withdrawal was a unilateral decision made because the operation had been completed, a senior Israeli general had said earlier yesterday that the troops could remain in Gaza for “several months”.

And less than an hour after Powell’s comments, read as a statement to reporters by State Department spokesman Richard Boucher, Israel informed the United States it was withdrawing its troops, U.S. officials said.

Diplomatic sources said the Israeli embassy in Washington notified the State Department of Israel’s intention to withdraw even before Boucher read the statement at his daily news briefing in a bid to prevent the criticism.

Earlier, Egyptian President Hosni Mubarak had led a string of virulent Arab condemnations of Israel’s incursion, saying “this policy will lead to nothing, it will have terrible repercussions and if they believe they are going to halt the violence this way, the violence will increase everywhere.”

**MUBARAK SAYS WAR IS PREFERABLE  
TO CURRENT STATE**

CAIRO (MENL)—Egyptian President Hosni Mubarak says war appears preferable to the continued state of tension in the Middle East.

But Mubarak expressed his belief that the United States would intervene to stop any war in the region.

The assessment by the Egyptian president was made in an interview in the German weekly *Der Spiegel* ahead of his European tour on Tuesday. It was the first time Mubarak referred to the advantages of war in the Middle East.

"If the talks really turned to war, the Americans would get involved and prevent an all-out war from happening," Mubarak said in remarks quoted by the state-owned Egyptian media. "Yet as bad as war is, at least you know what you are dealing with. Worse than open war is this terror, which can strike anywhere and at any time."

Mubarak's assertion comes amid plans by Arab countries that surround Israel to meet in Cairo on May 16 to determine how to confront the Jewish state. Egyptian diplomatic sources said Mubarak succeeded in delaying such a meeting until after his trip to Russia later next week.

When previously asked about the subject, Mubarak would term war as an unthinkable prospect in the Middle East. The Egyptian president would often cite the heavy price his country has paid in previous conflicts with Israel.

**IRAQ: IRAN LAUNCHED 56 SCUD MISSILES  
AT MILITARY TARGETS**

NICOSIA—Tension has escalated after Baghdad accused Iran of launching a barrage of Scud missiles toward military positions in Iraq. Iraqi sources said Iran fired 56 Scud missiles on Wednesday. Several Iraqis and a member of the Iranian opposition Mujahadeen Khalq were reported killed.

The regime of Iraqi President Saddam Hussein warned Iran of retaliation. "Iraq holds Iran fully responsible for human and material losses which were caused by the aggression," an Iraqi government spokesman said. "Iraq reserves its legitimate right to respond with suitable means at the suitable time."

Iran did not acknowledge the attack. But Teheran has accused Baghdad of supporting Mujahadeen attacks against the Islamic regime.

Iraqi and Mujahadeen sources said Iranian Scud missiles were fired toward opposition camps in the southern Basra region as well as towns east of Baghdad. The Doha-based Al Jazeera television showed the Scud missile debris being carried by Mujahadeen members.

The Iranian attack came hours after Saudi Interior Minister Nayef Bin Abdul Aziz met Iraqi opposition leaders in Teheran. The meeting with the Teheran-based Supreme Council for the Islamic Revolution in Iraq focused on Saudi support for the Iraqi opposition.

Earlier, Prince Nayef signed a security cooperation agreement with Iran. The agreement would include efforts to increase border surveillance and fight terrorism, organized crime and drug trafficking.

Before his departure from Teheran, the Saudi minister said Iran and Saudi Arabia have concluded that Gulf security should be guaranteed by states in the region. The United States and Britain have tens of thousands of troops in Saudi Arabia and Kuwait.

**[JR: With all things in the Middle East being connected, I do not believe it a coincidence that Iran fired missiles at Iraq soon after signing a terrorism agreement with Saudi Arabia. **KOSOVO SERBS HOLD RALLY AGAINST UN TAX**

KOSOVSKA MITROVICA, YUGOSLAVIA (AFP)—Around 1,500 Kosovo Serbs held a protest Friday in the ethnically divided town of Kosovska Mitrovica against a UN-imposed customs tax on goods from the rest of Serbia.

Serbs also manned roadblocks across the north of the province for a fourth day to call for the duties to be scrapped.

Dragisha Djokovic, a member of the Democratic Party of Serbia which is led by Yugoslav President Vojislav Kostunica, announced at the demonstration that the UN administration must scrap the taxes and urged

protestors to stay on the barricades.

NATO-led KFOR peacekeepers fired teargas Thursday to remove three of the roadblocks, but others remained in place.

International staff were advised not to go into areas mainly inhabited by Serbs after the UN mission slapped a 15-percent tax on goods except fruit, vegetables, flour and oil, brought in from Serbia proper.

Another duty is planned for alcohol, cigarettes and petrol.

Tension mounted when KFOR troops used teargas to disperse crowds as it removed three barricades blocking important routes near the Mitrovica, divided between Serbs and ethnic Albanians.

Serb leaders accused KFOR of being responsible for the death of a 62-year-old woman they said choked to death on teargas.

Political leaders in the Serb-dominated north of the province often call protests in the region, where tensions frequently explode into riots between the rival communities, with UN police or KFOR troops caught in between.

Belgrade and the Kosovo Serb community see the introduction of the taxes as a step towards the independence demanded by Kosovo's 95-percent Albanian population.

The UN administration is tasked with rebuilding the province's political autonomy within Yugoslavia as well as its devastated economy.

It has tried to develop customs duties on the external borders to fill the province's coffers, but the move this week was the first time taxes have been levied on goods from Serbia.

Djokovic called on Kosovo's UN administrator, Hans Haekkerup, to discuss the customs duties with the Serb population, but the UN says the taxes are already incorporated into the province's budget.

**COVER-UP LED NATO TO BETRAY MUSLIMS**

The United States, France, and Germany deliberately sacrificed the Bosnian "safe haven" of Srebrenica in July 1995 and paved the way for the worst massacre in Europe since the Nazi atrocities of the Second World War, according to intelligence sources.

The move was designed to discredit and undermine the United Nations and give Nato an excuse to intervene in the Balkans and transfer authority for peace-keeping in the volatile region to its own military command.

Jacques Chirac, the French president, ordered Lieutenant General Bernard Janvier, then the supreme commander of UN protection forces in Bosnia, to veto airstrikes which might have halted the advancing Serbs as they closed on the Muslim

enclave and its 60,000 inhabitants.

More than 7500 Muslim men and boys of military age were either separated from their families and executed in batches after the town was overrun, or hunted through the hills as they fled and shot down in ambushes.

On the day after Colonel Dragan Obrenovic, then a Serb brigade commander, appeared before the Hague war crimes tribunal on charges of complicity in genocide at Srebrenica, sources told *The Herald* the Americans and others were aware of Serb plans long before the final assault on the town.

A joint CIA-German secret service electronic listening post in the Austrian Alps had monitored every conversation between Ratko Mladic, the Bosnian Serb military commander, and the Yugoslav army's high command in Belgrade for three weeks and were aware of the detailed plans for the offensive.

In addition, U.S. surveillance drones and satellite imagery had revealed the build-up of Serb troops. The information was not shared with the UN or Britain.

Dutch conscripts "protecting" Srebrenica on the UN's behalf when Mladic unleashed a seven-day bombardment on July 5 made five separate requests for air support. All were denied.

A source said: "Yasushi Akashi, the Japanese UN special envoy to Bosnia, was told by the French they would not sanction air strikes or ground intervention to save Srebrenica.

"Akashi sent a cable to UN headquarters in New York which detailed a conversation between himself and Yugoslav president Slobodan Milosevic in which Milosevic claimed he had been advised by Chirac of U.S. president Bill Clinton's agreement that air strikes would not occur if they were unacceptable to France.

"Even earlier, General Janvier had asked the UN security council to give up the "safe haven" status of Srebrenica, Gorazde, and Zepa, all Muslim enclaves in eastern Bosnia. That should have set alarm bells ringing as to the direction of French intentions.

"The ensuing massacre was a betrayal of all of the participants. It suited a number of governments because it displayed UN incompetence, demonstrated that the ruthless Serbs must now be stopped by resolute intervention from NATO."

\* Exhumations at a mass grave in Croatia by the UN war crimes tribunal may unearth about 250 bodies of Serbs killed during Croatia's 1995 offensive.

A Croatian government official said the process should determine whether the Serbs were slaughtered by vengeful Croat troops or killed in combat.

#### MOSCOW WARNS OF CHAOS IN BALKANS

Peace or war in the volatile Balkan region—with consequences for the whole of Europe—depends on this coming Sunday's parliamentary election in tiny Montenegro, according to official Russian sources.

"Stability in Yugoslavia and the whole of the Balkans largely depends on the outcome of the election" there, according to the *Voice of Russia World Service*, the official broadcasting service of the Russian government.

The central issue in the elections involves whether or not Montenegro should secede from Serbia, and, in effect, end the existence of the Federal Republic of Yugoslavia.

Emerging from a cordial meeting with Russian President Vladimir Putin, Yugoslav Prime Minister Zoran Zizic stated that present Balkan borders must be maintained. "Inviolability of (Balkan) borders is one of the main conditions for stability in the region as a whole," Zizic declared.

"The increased number of borders in the Balkans," should Montenegro vote to secede, "will result in the escalation of extremism and terrorism," according to Zizic.

Zizic came to Moscow for a two-day visit to gain Russian financial aid assistance, as well as political backing for Belgrade.

Russia responded quickly to Belgrade's requests. Russian Foreign Minister Igor Ivanov referred to Yugoslavia as an "old friend", and Russia's Prime Minister Mikhail Kasyanov stated that Moscow is prepared to offer "broad cooperation" in rebuilding industrial facilities destroyed during NATO's 78-day air war against Yugoslavia.

Moscow also reaffirmed its firm support for the territorial integrity and sovereignty of the Yugoslav Federation, which currently comprises only Serbia and the much smaller state of Montenegro. Yugoslavia once included the now-independent states of Bosnia-Herzegovina, Slovenia, Croatia and Macedonia.

Since the end of Turkish rule in the Balkans in the 19<sup>th</sup> and early 20<sup>th</sup> Centuries, national boundaries have tended to be drawn in blood, while the nations in the region were used as pawns by larger powers.

Zizic warned of the potential disaster of the fragmentation of the region, stating, "secession of Montenegro would not only cause a political crisis and destabilize the situation in the Balkans, but it would also wipe the Balkans off Europe's political map."

While Zizic was in Moscow, the UN authority in the nominally Serb province of Kosovo (UNMIK) established customs border posts for the collection of tax money for those crossing the Serbia-Kosovo border.

The Serbian parliament condemned the installation of the customs posts on the Serb-Kosovo frontier, as Serbs near the border blocked roads and a mass protest rally was held, according to *Radio Yugoslavia*, an official information service of the Yugoslav government.

Belgrade views the use of customs points on the border as a step toward an independent Kosovo.

Moscow remains adamant in its support of Belgrade, and is convinced of the area's vital importance.

*The Voice of Russia* cited scholars participating in an "economic roundtable" which it sponsored, who defined the Balkans as "a crucial region, which may decide the fate of Europe," where "a major conflict" could occur with "unpredictable consequences".

Russia, along with Yugoslavia, is determined to remove NATO's presence from Kosovo and the Balkans in general. One of the major problems identified in VOR's "roundtable" discussion was "how long to put up with the presence of NATO in the former Yugoslavia."

While Moscow traditionally has been an ally of Yugoslavia, it is not alone in its determination to aid an "old friend". The People's Republic of China, a

supporter of former Yugoslav President Slobodan Milosevic, has also expressed interest in assisting Belgrade's financial and political needs.

**[JR: The destiny of the Balkans is being decided by the European elitists in Brussels. #### EU COMMISSION WARNS MONTENEGRO AGAINST UNILATERAL SECESSION

The European Union today cautioned Montenegro's pro-independence movement against taking unilateral action to break away from Yugoslavia following its narrow election victory.

EU foreign policy chief Javier Solana went as far as openly backing the current situation, in which Montenegro is the junior partner with Serbia in the Yugoslav federation.

"The European Union fully supports a democratic Montenegro within a democratic Yugoslavia," Solana said. "The EU opposes any unilateral steps which could run contrary to the stability of the region."

With most votes counted in Sunday's election, secessionists led by President Milo Djukanovic had 42 percent of the vote, compared to 40.6 percent for the party wanting their republic to remain with Serbia in the Yugoslav federation.

The narrow victory margin was a signal for Djukanovic not to act hastily to break up the federation, said Sweden, which currently holds the EU presidency.

"The election results in Montenegro give no clear mandate for continuing with a referendum on independence," said Sweden's Foreign Minister Anna Lindh. "Montenegrin society is obviously divided on the issue of Montenegro's future status."

The election result called for an increasing reliance on dialogue, the 15-nation EU said.

Sunday's outcome "should therefore lead to serious negotiations with Belgrade on their common future, as soon as possible," said Lindh.

She called on Djukanovic to "not continue hastening towards a divisive referendum on independence."

The EU's executive Commission also warned any attempt by Montenegro to break away without negotiations with the Serbs could jeopardize continued European Union aid payments.

"If the constructive dialogue is continued... then political, economic and financial aid will be continued," EU Commission spokesman Gunnar Wiegand told reporters.

"It is essential that there be stability in the region."  
**[JR: The Montenegro vote for independence from Yugoslavia may hold problems for the UN and the EU. They could use this vote as a tool against the Serbs to gain concessions from Serbia's President Kostunica as regards Milosevic. It could work**

#### LEADERS SIGN FREE-TRADE PACT

QUEBEC—Western Hemisphere leaders on Sunday signed an agreement to open their markets by December 2005, and said only countries with democratic governments can be a part of the world’s most ambitious free-trade zone. Outside the meeting hall, security was tight after two days of clashes during which hundreds of demonstrators were arrested.

In their final statement after a three-day summit, U.S. President Bush and 33 other leaders from North and South America and the Caribbean pledged to finish negotiations on the free-trade zone by January 2005, with the agreement to take effect by the end of that year.

They insisted that democracy was “fundamental to the advancement of all our objectives,” adding that any “unconstitutional alteration or interruption of the democratic order... constitutes an insurmountable obstacle” to participation in further hemispheric trade talks....

The leaders said they would “conduct consultations” if any member state had a disruption of its democratic system, but stopped short of establishing specific penalties or automatic expulsion from the planned Free Trade Area of the Americas.

“I learned a lot,” said Bush, attending his first international summit. “There is no question in my mind that we have challenges ahead of us. Also, there is no question that we can meet those challenges.”

Mexican President Vicente Fox called the summit “a great step for the entire hemisphere” and said they had taken negotiations from behind “dark rooms behind doors” and made them more open.

The treaty would create a barrier-free trade zone from the Arctic to Argentina, linking markets of 800 million people and economies ranging from the world’s largest—the United States—to some of its tiniest.

Mindful of the inequalities of the region, the leaders committed themselves to halving the number of people living in extreme poverty by the year 2015. They didn’t say how they would achieve that.

“We will spare no effort to free our fellow citizens from the dehumanizing conditions of extreme poverty,” they said in their declaration.

That responded to some of the demands of tens of thousands of protesters who came to Quebec City and marched peacefully or battled with riot police along the 2.3-mile concrete-and-wire security wall erected around the summit venue.

Chretien had heralded the democracy clause on Saturday as a pillar for the region’s unity and prosperity in the future.

“From this day forward, the benefits of any agreements we reach will flow only to those nations that abide by our democratic clause,” he said at a news conference.

Even Venezuela’s populist Hugo Chavez—who staged a failed coup as a young lieutenant colonel in 1992—told reporters Sunday that his country would sign despite reservations.

“In Venezuela’s case, representative democracy has been a trap that almost led the country to bloodshed,” he said. “Some barons who were elected felt that they had a blank check to rob, betray and steamroll others.”

On Saturday, Chavez said he believes that “the threats to democracy in Latin America and the Caribbean are not the armed forces or conspiratory movements, but hunger and poverty.” Following the final session, the leaders were expected to release a draft text of the free-trade accord—one key demand of some groups who came here to show their opposition to the trade efforts.

The so-called “democracy clause” would exclude any country that ceases to be a democracy from participation—but it remained unclear how that would occur.

The idea is to strengthen multiparty systems that have replaced military and civilian dictatorships across the region over the past two decades but have appeared increasingly shaky in some countries as economic prosperity has failed to follow.

Cuba was the only country in the region excluded from the Quebec summit, for its lack of free elections.

Protesters complain that the goal of free trade across the Americas is designed to benefit big corporations, but hurts the poor and damages the environment.

Police said 253 people were arrested Saturday night and early Sunday. In the days of unrest, 403 people were arrested, and at least 46 police officers and 57 demonstrators were injured.

Streets were quiet Sunday afternoon, but security remained tight although there was no hint that the scenes from Friday and Saturday would be repeated.

On Saturday, nearly 30,000 marchers turned out, police said, with a few thousand growing violent along the security fence....

U.S. Secretary of State Colin Powell, a former general, told reporters he wasn’t bothered by the fumes: “It didn’t affect me, but an old infantryman always remembers what tear gas and pot smell like when you walk into the barracks.”...

“The demonstrations were useful and the incidents could not be avoided,” said Jean-Luc, who refused to give his full name. “There’s no wrong in the protest, it’s all part of the game,” he said.

The Quebec native said he had no argument with the needs for free trade; his quibble was with the fence that was built in the city to keep protesters away from the official gathering.

He added, “There were 20,000-25,000 ideas on the street. Everybody had a different idea about why they were protesting.”

#### UNITED STATES-CHINA: COMPETING FOR REGIONAL INFLUENCE

##### *Summary*

If U.S.-China relations enter a lengthy period of deterioration, the armed forces of both powers will probably compete for regional influence despite the unparalleled military might of the United States. A major effort to contain a China bent on using a limited set of strategic capabilities to undercut American dominance would require the Pentagon to retune many of its plans. Ultimately, Beijing cannot keep up with Washington in a long-term competition for military dominance. But in the next five to 10 years, the playing field will likely host a heated contest.

##### *Analysis*

U.S.-China relations have been deteriorating for some time over several contentious security questions. The recent collision of a U.S. spy plane and a Chinese jet fighter over the South China Sea is one of several issues in recent years that have not boded well for the relationship.

With the election of U.S. President George W. Bush, who described China as a strategic competitor as opposed to a strategic partner during the election campaign, Beijing and Washington have moved further apart on these contentious issues.

These disagreements could significantly degrade relations, leading the two nations’ militaries to increasingly confront each other in East Asia as they compete for regional hegemony.

While emphasizing new air warfare capabilities, the People’s Liberation Army Navy is the focus of China’s military modernization program. Still a shadow of the U.S. Navy—the U.S. Pacific Fleet alone could probably defeat it—Beijing is making slow but steady progress in introducing a fleet capable of operating far from Chinese territory and posing a challenge to other regional forces. China sees fast-attack patrol boats, new destroyers, new attack submarines, anti-ship missiles and aircraft-carrier capabilities as the keys to checking U.S. dominance of the seas.

Washington is aware of this shift. An ongoing review of U.S. defense strategy places increased emphasis on Asia—namely, China. The U.S. surveillance flight that had to land on Hainan Island in China April 1 was part of a larger U.S. effort to keep tabs on what the Chinese military is up to in the region, including submarine advances, intelligence-gathering operations and space launch activities.

China has done its homework and has fashioned military modernization plans accordingly, including submarines and warships with anti-ship cruise missiles that could endanger U.S. aircraft carriers or prevent access by U.S. forces to key areas such as the Taiwan Straits.

U.S. military planners are aware of American vulnerabilities and Chinese plans to target them and have laid out long-range plans to address many of them. But heightened military tensions between the two countries could find the United States lacking in



some key areas over the next five to 10 years, forcing Washington to accelerate its plans.

In the area of force structure, the United States has several efforts on the drawing board that better position it for a military competition for control of East Asia. But most of them are far in the future.

For example, growing agreement that its fleet of large aircraft carriers will be increasingly at risk of missile attack makes it likely the Pentagon will seek to build smaller, more agile flattops. But this could take a decade or more. Until then, it will have to work to minimize the risk to its fleet.

In other areas of shipbuilding, the United States may have to accelerate its modernization efforts. It is developing a new land-attack destroyer, the *USS Zumwalt*-class, which will be stealthier than the current fleet. But the first ship in the new class will not be ready for prime time until near the end of the decade.

The United States may also look to other nations in the region to build up a deterrent force, as plans to rely less on forward bases and more on projecting force from the United States will not be realized for a considerable time. Some possibilities include the Philippines, which is seeking renewed U.S. military assistance, and Thailand, where American and Thai forces are currently participating in Cobra Gold—the largest military exercise in Asia this year.

Although an overall comparison of U.S. and Chinese military capabilities clearly demonstrates that Washington outstrips Beijing in every area, a prolonged degradation in relations would highlight the significant cost of keeping China in constant check.

Over the long term, the United States, by sheer economic and technological capability, will dominate China in the competition for military pre-eminence in East Asia. Nevertheless, American dominance is not guaranteed. A prolonged and heated standoff with Beijing will require Washington to reshape its military strategy. That will take time. In the meantime, the Chinese military will not be a pushover.

**[JR: During the spy plane crisis with China, the emphasis was placed on trade and American companies doing business in China. Now we are being realistic and focusing on China's military capabilities should relations get testier. Whatever technologies China didn't develop on her own she bought or had made available to her during Clinton's treasonous misrule. #### BUNKER-BUSTING U.S. "MINI-NUKES" ALARM SCIENTISTS

The Pentagon is examining the feasibility of producing a low-yield nuclear warhead capable of hitting deep fortified targets such as Saddam Hussein's underground bunkers. But U.S. scientists warned yesterday that "mini-nukes" would lower the threshold of nuclear war.

The Pentagon is due to report to the Senate in July in response to a Republican request to it and the energy department to find a way of destroying

"hardened and deeply buried targets".

But a Pentagon spokesman insisted yesterday that work on mini-nukes had not yet begun.

"The 2001 defence authorisation bill authorises us to review the requirements for a weapon to use against hardened and deeply buried targets," Lieutenant-Colonel Steve Campbell said.

"There has been no research and development."

A 1994 law prohibits the U.S. developing a nuclear warhead of less than 5 kilotonnes, lest "low-yield nuclear weapons blur the distinction between nuclear and conventional war".

The request by two Republican hawks, Senators John Warner and Wayne Allard, to find a way of destroying targets such as underground bunkers directly challenges that law. Testing a mini-nuke would breach the 1996 comprehensive test ban treaty, too.

There is thought to be support for developing such a weapon in the energy department's nuclear research laboratories and the Pentagon. An adviser to the defence secretary, Donald Rumsfeld, told the *Washington Post* this week that President Saddam would not be deterred by any of the nuclear warheads in the U.S. arsenal, "because he knows a U.S. president would not drop a 100-kilotonne bomb on Baghdad".

In theory a mini-nuke missile released by a plane would point towards its target and fire its rocket motors, driving it deep underground. The weak nuclear charge would be exploded after a time-delay and the blast, supporters say, would be contained in the hole dug by the missile.

But a report by the Federation of American Scientists argues that the Earth-penetrating bombs now being tested have only penetrated 6 metres (20ft.) below the surface. A nuclear blast at that depth, the report says, "will simply blow out a huge crater of radioactive material, creating a lethal gamma-radiation field over a large area".

Robert Sherman, head of the federation's nuclear security project, said: "We have gone 56 years without a nuclear weapon being used anywhere. There is universal recognition that once you use the first nuclear weapon it becomes a great deal easier for someone to use the second.

"It's incredibly stupid to think you can use a small nuclear weapon, cross the nuclear firebreak and get away from it.

"Trying to sell it on the rationale that it can be used without collateral damage and that will be the end of it... is incredibly irresponsible."

**[JR: Defense Secretary Rumsfeld and his assistant Wolfowitz are becoming the Dr. Strangeloves of the Defense Department. #### EP-3E MISSILE-TELEMETRY SECRETS COMPROMISED?

*Experts fear "significant damage to regional and national security"*

WASHINGTON—If a U.S. negotiating team in China can't repossess a downed EP-3E plane there, the Pentagon will be left wondering whether the

Chinese military gained clues to ultra-secret missile-monitoring technology aboard the surveillance aircraft, defense experts say.

The EP-3E Aries II plane, stranded on the tarmac of a Hainan, China, military airport, ranks among the most secret pieces of equipment in the Pentagon's arsenal.

The \$80 million aircraft, one of only a dozen or so owned by the Navy, is loaded with state-of-the-art radio receivers and high-gain dish antennae that can pick up, record and analyze—using on-board computers running highly classified software—electronic emissions, or signals, from deep within China's territory. The technology is called radar telemetry.

All this is well-known. What has not been widely reported, if at all, is that the EP-3E has the added ability of monitoring the flight path—in 3-D—of a missile. The sophisticated technology is called missile telemetry.

"It takes a special sort of aircraft to get missile telemetry intelligence, and if the Chinese were able to pry that technology away, they'd have a pretty nice trophy indeed," said a former Navy officer familiar with the EP-3E technology.

The officer, who asked not to be identified by name, suspects the EP-3E's ability to monitor missile launches—particularly ones from submarines—off the China coast is what has provoked such a violent reaction from the Chinese military to recent U.S. reconnaissance flights over the South China Sea.

"Sub-launched missiles would certainly be something they would want to hide," he said.

China has been testing a new submarine that has the ability to launch missiles such as the Sunburn—which can knock out U.S. aircraft carriers—while submerged in the South China Sea.

"There's a significant submarine squadron based in Hainan," said Rick Fisher, a Chinese military expert with the Jamestown Foundation here.

"Detailed knowledge of their ability to launch submerged missiles—probability rates included—would be important to any [American] carrier commander's order of battle in defending the Taiwan Strait," the Navy officer said.

Communist China, which has threatened to use force against Taiwan, has been beefing up its missile forces near the independent island, which has a democratic government.

If China is able to figure out how the U.S. monitors its missile launches, it may be able to counter that technology.

"If this plane has been seriously compromised, there is a significant damage to regional and national security," the officer said.

Defense Secretary Donald Rumsfeld has said that the EP-3E crew was not able to destroy all equipment and computer programs aboard the aircraft before Chinese military authorities took control of it.

**[JR: This spy (surveillance) plane is a marvel in radar and missile telemetry, computer and other advanced analytical technologies. What was missing in this elaborate system was a self-destruct mechanism that would not require a crew of 24 to do the job. Would this be too much to ask of the geniuses who run our military complexes and think tanks? PANIC EXPECTED IN THE GOLD MARKET?

With good reason, some call it the killer yellow metal. And savvy sorts will not have to put their ear to the ground to detect what is about to happen. Like the first atomic bomb, gold can be the destroyer of worlds. And those who understand the history of currencies, understand that if gold goes up, paper money goes down. And hard.

The monopoly presslords, oil-soaked and chained to the banks and the banker-judges, as promoters of hot-air-backed paper money, are never in a position to tell us the truth about important events. They fudged on the way the common people of the United States were dragooned into being poison-gassed, shot to pieces, and dying in World War One, in Europe's own bloody mess. The liars and whores of the press did not tell us what was involved in 1941 in advance, in the attack on Pearl Harbor. They issued fake stories to explain away orchestrated events and political assassinations of the 20<sup>th</sup> Century.

Federal Reserve Commissar Alan Redspan announces interest rate cuts and the Establishment liars/pundits proclaim it is to help the poor economy and to prevent a recession. Some understand, however, that jiggling with the interest rates may have a secret reason.

Notice a few historic events. In 1932, campaigning for President, Franklin Delano Roosevelt pretended to calm the waters by saying he would continue the gold standard. U.S. paper money at the time was exchangeable for gold. And ordinary workers were happy to be paid their wages in gold coins. In those years, the U.S. President was elected in November and inaugurated the following March. Before FDR was inaugurated, the ultra rich, with advance secret information, shipped THEIR gold by boat-load out of the U.S. To be sure Roosevelt follows orders eventually to grab all the gold of the common American people, there was a high-level plot to either scare him or to assassinate him, and blame it on a "lone assassin". A secondary target was Anton Cermak, then Mayor of Chicago, while Cermak was sitting near Roosevelt.

Cermak was in the then-illegal booze business in the Windy City competing with both Al Capone and another competitor, in a three-way struggle. Using a "lone nut" as a patsy, Chicago-based gangster-snipers, working for the very wealthy, killed Cermak but, intentionally or otherwise, did not kill Roosevelt, February 1933.

(Note: In the 1970s, our bribery investigations resulted in Cermak's son-in-law, Otto Kerner, Jr., a Chicago-based sitting federal appeals judge, former Illinois governor, being sent to federal prison. He was also a banker. It was the highest level federal judge sent to jail for bribery in the history of the U.S. Years later, other judges in that same court, as a reprisal, have barred me and a TV Show associate of mine, Joseph Andreuccetti, from all the federal courts, in Illinois, Wisconsin, and Indiana.)

In 1934, less than a year after being sworn in as President, Roosevelt ordered to be seized all the gold of ordinary Americans. The claim was that there was an "emergency". If you did not turn in your gold, the U.S. Secret Service had orders to search you out, grab your gold, and maybe even arrange to

arbitrarily jail you. That is what old-timers later related to their children and grand-children.

From 1934 to 1975, under federal edict, it was unlawful for Americans to own gold. (Some dentists, however, under the pretext of needing gold for filling in patients' teeth, obtained licenses to get gold, some of which ended up in the "gold underground". The Rockefeller Family were and have been the biggest importers of gold into the U.S., through the jewelry trade, through Rhode Island.)

Closing down the gold window, Nixon as president set off a near panic in 1971, when he blocked foreigners from getting U.S. gold at the then-low fixed rate of about 35 dollars per ounce. About the time gold became legal again in 1975 for Americans, an outspoken leading gold bug was pushed out a window to his death, in Indianapolis, Indiana. (That was one way to stop comments about the Rockefellers and gold.)

Starting about the 1990s, to promote paper money, private Central Banks worldwide, and bullion banks like Goldman Sachs (who reportedly have fled U.S. jurisdiction to be in London) and British-royalty-linked J.P.Morgan, have been attacking the price of gold. Through all kinds of market and news media tricks, through forward sales, derivatives, and such, this anti-gold gang pushed down the price of gold until it was way below the cost of production of the most efficient mines in the world. High-cost gold producers in South Africa, had to lay off thousands and tens of thousands of their workers, including Blacks paid a somewhat better wage since apartheid was ended.

In the process, the anti-gold cabal have been short upwards of ten years average annual gold production. An emergency obviously could and **would be created** if there was a squeeze on the "gold shorts", such as the price-fixing criminals interwoven with the Bank of England and the Federal Reserve, both actually PRIVATE central banks masquerading as official government entities.

In market industry lingo, if those who borrowed someone else's gold and sold it, and then had to make it good, called "covering their shorts" or short positions, by buying gold later at the then market higher price, well, a great crunch could be caused. And gold would skyrocket while paper money would be generally devalued and discredited. That is, a nightmare created for the paper-money gang. The so-called "U.S. Dollar", not government currency but private notes of the Federal Reserve, backed by nothing but hot air, would suddenly be exposed as simply a skilled magician's trick, money rabbits multiplied out of a banker's fractional-reserve hat.

Some U.S. mega-banks have reserves of less than three cents on the dollar. Such banks are actually insolvent. "Washington—Acting in an EMERGENCY CONFERENCE CALL, the Federal Reserve moved today to bolster the flagging economy by cutting interest rates by half a point for the fourth time this year." *Chicago Tribune* 4/18/2001 (Emphasis added.) The *Tribune* was one of the few newspapers to use the term "emergency conference call". But of course, they did not tell us what the real emergency might be.

Traditionally, the parent, *Tribune* Company, has been headed by the one who was also the chairman or vice chairman of the Federal Reserve District Bank in Chicago.

So, are we, as ordinary Americans, facing commotions as to gold, the real reason for rate cuts? To somehow support the huge gold loans by the short-selling anti-gold mafia? The consequences of exposing this could have a profound influence on the future of the Federal Reserve and what I prefer to call the Bunk of England, both private, yes, conspiratorial, central banks. (The real owners of the Federal Reserve are NOT the member banks, as mentioned in Establishment business text books, but rather a group of shadowy mostly non-Americans, some of whom meet once a year in secret meetings to plan the destiny of ordinary people, that is, the meetings of the Bilderberg Group. # THE NEVADA CORPORATION MANUAL

## (PART 2)

### The Value Of Nevada Corporations

#### BIG BOYS' TOOLS ARE YOURS TO USE

As the New World Order gang implemented its far-reaching control mechanisms over the political and economic systems, they quietly established a special jurisdiction that would suit their own nefarious purposes. They needed a place where the rules could be made deceptively similar to other jurisdictions but with certain key, subtle differences that would allow them to do their deeds without undue scrutiny. Over a period of several decades those distinctions were put in place in the State of Nevada, affording Nevada's corporations operating abilities unavailable anywhere else, most notably with regard to PRIVACY.

Nevada is a very small state in terms of both population and bureaucracy. It has no state income tax, so there is little money available to feed the kind of bureaucracy found in, for instance, California. For this reason the State of Nevada simply does not maintain a lot of records and this might present a partial explanation of why there is no provision for keeping track of the stockholders of corporations here. Publicly, at least, this is also justification for Nevada being the only state that does not share its records with the Internal Revenue Service. The real reason, however, probably has a lot more to do with the need for privacy on the part of those who established Nevada as their own financial "haven".

#### Separation of Liability

The State of Nevada is absolutely serious about maintaining the insulation between a corporation and its operator(s). Whereas in other states lawsuits routinely pierce the corporate veil placing liability on the corporation's officers, directors, employees and agents, in Nevada there has only been one case in the last twenty-five years in which the corporate veil has been pierced—and that was for outright, undeniable fraud.

The Nevada Supreme Court has established a strict, three-part test for determining the permissibility of penetrating a corporation to get at the people behind it. The funny thing is that even when all three tests have been met, Nevada's Supreme Court has not felt compelled to allow such penetration. The best example of this might be the case of *Rowland v. Lepire*. Lepire was a contractor who operated his corporation without regard for adherence to corporate formalities. He freely commingled corporate and personal funds and kept no corporate records. Worse, he volunteered to the Court that he was the sole owner and operator of the corporation. And yet, even in the face of this open admission and the obviously improper operation of the corporation—even when all three parts of the strict, three-part test were failed, miserably—the Court ruled *against* piercing of the corporate veil.

#### Privacy of Corporate Records

With regard to the privacy of corporate records, way back in 1971 the Nevada legislature added a special provision to the corporate statutes, *NRS 78.257*. This statute makes it a gross misdemeanor for anyone to even **attempt** to use corporate records for any purpose not in the corporation's interests. That's right—even *trying* to "sneak a peek" at a Nevada corporation's records for nefarious purposes could result in imprisonment for up to one year in the county jail and a \$2,000 fine! Corporate records are, indeed, most private in Nevada—by law.

#### Privacy of Ownership

Another area of major distinction for Nevada corporations is the potential for privacy of ownership. As we have just seen, a Nevada corporation's records—including its stock ledger

entries—are private. In addition, the state does not keep any records of stock ownership. That is a good foundation for privacy of ownership but it's only the beginning.

Nevada is one of only a small handful of states that allows the use of bearer shares, share certificates made payable to "bearer". Such certificates are the property of anyone who holds them. It can be virtually impossible for an outsider to establish the ownership of a company whose shares are held in this manner.

In 1987, the Nevada legislature added *NRS 78.197*, a very brief and easily overlooked single-sentence statute with profound ramifications: "A corporation may provide in its articles of incorporation that the holder of a bond, debenture or other obligation of the corporation may have any of the rights of a stockholder in the corporation." Wow. You don't even have to own ANY stock to own the corporation.

Another tool for privacy of ownership is the concept of an "irrevocable proxy" to vote the stock. Own nothing, control everything, remember? With this kind of an arrangement it doesn't matter who owns the stock—the power of control over the corporation rests in the right to vote the stock.

An additional method of maintaining privacy of ownership can be established through the use of nominee stockholders. Since there is no liability whatsoever to owning stock, it is usually quite easy to come up with persons willing to hold the stock, governed by a side agreement that would allow for the stock to be returned at the pleasure of the corporation's director(s).

#### Privacy of Control

The use of nominee officers and directors has been a tacitly accepted practice in the State of Nevada for more than seventy-five years and is the basis for ALL privacy, though it goes entirely unmentioned in Nevada's statutes.

The statutes require the annual filing of a list of officers and directors, complete with mailing addresses for all named persons, signed by a corporate officer. The signature, however, does not need to be notarized and in practice facsimile signatures (rubber stamps or electronic images) are used routinely for such filings. In addition, one person may serve in all capacities.

An outsider looking up the public record of a Nevada corporation using nominee officers and director will only find the name of the nominee, probably at the address of the resident agent. If the nominee is questioned, he will know nothing of the day-to-day affairs of the corporation, resulting in an absolute dead-end for anyone on the outside looking in.

The corporation does, of course, have to function in the world. This is usually accomplished through "secondary" officers, provision for which is normally made in the corporation's bylaws. A vice president, for instance, is typically given all of the authority of the president in the president's absence—and the president, if a nominee, is assuredly absent. Similarly, the corporation may have an assistant treasurer or an assistant secretary. The corporation may have any number of such secondary officers, any of whom may serve for any period of time from a day to many years.

REAL control comes from behind the scenes and is extended from the corporation's real director(s). The real director(s) may be the same as the secondary officers or altogether different persons. Perhaps you can begin to see that this adds up to a substantial amount of "plausible deniability"—and complete control, with privacy unavailable through any other financial tool.

#### How Can This Knowledge Benefit YOU?

The amazing thing is that this incredibly versatile tool,

set up by the Big Boys for their own greedy purposes, can work even BETTER for everyday people. Yes, as an INFORMED "little guy" you can have all of the advantages enjoyed by the big players—and yet operate almost invisibly, with an extremely low profile.

If you have any assets to protect or any non-employment income, if you're in business or even thinking about getting into a business, and yes, no matter where YOU are, you really should take advantage of this extremely useful and unique financial tool.

Even if you do not have assets to protect, you might find setting up a pristine Nevada corporation to be the best investment you ever made. Unused "shelf" corporations typically increase in value by \$1,000 to \$1,500 per year—which amounts to a pretty fine rate of return on the annual maintenance costs of less than \$500.

Let's look at some common situations where Nevada corporations pay for themselves over and over, year after year.

#### Applying this Knowledge—Foreign Situations

The most common use of Nevada corporations, believe it or not, is by persons in foreign jurisdictions—whether another state or another country altogether. In most cases where the business has an active presence in the foreign jurisdiction it is necessary to register or qualify the corporation to do business there. But there are a lot of situations in which a Nevada corporation is not considered to be actively in business in the foreign state.

You must determine what constitutes doing business within your jurisdiction. In most cases, for instance, it is entirely permissible for a contractor to effect sales on behalf of a foreign corporation. A Nevada corporation could contract with you to do consulting work in your home state, for instance. In such a case you as the contractor would have a presence there but the corporation itself would not. You would have to pay home-state taxes on any income received from the Nevada corporation but most of the income might remain in Nevada where there is no state income tax. In many cases this strategy can result in tax savings of thousands of dollars per year, year after year.

In cases where it is necessary to register to do business in the foreign jurisdiction, a simple two-corporation strategy can usually be employed. The first corporation registers to do business and otherwise meets the regulatory requirements in your home state. It then does business with a separate Nevada corporation set up for privacy in such a way that most or all of the profit ends up with this private Nevada entity. For this strategy to work, it is essential that it be "at arm's length" with the home-state business.

As an example, let's say you have a bicycle store in Monterey, California, which is subject to state tax of 9.3% in addition to federal tax. Let's say this business is making \$200,000 per year in sales and shows a net profit of \$50,000, on which the California tax amounts to \$4,650. What if this California business contracts with a Nevada corporation to do its marketing and promotion? Or what if instead of buying bicycles and parts from a dozen different suppliers it makes an arrangement with a Nevada corporation that can supply it with a full range of bicycles and parts, acting as a middleman? Let's look at the results.

Next year, the Monterey bike shop is not as successful as it has been in the past. Its contract with the Nevada corporation has been expensive and cut into its profitability to the point that on the same \$200,000 in sales there is NO profit. This means, of course, that there is no California State tax to be paid—a saving of \$4,650. The Nevada-based marketing or middleman business, however, has been very successful, showing a net profit of \$54,650 (including, for the sake of this example, the taxes saved in California). These retained earnings are now held in the haven of Nevada, where they are far more secure.

Now if a bicycle falls off the rack and hits a customer, there is at least \$54,650 held away and apart from the assets of the Monterey bike shop. If the customer sues and takes it all, the bike shop owner at least has some security in the knowledge that it isn't ALL gone. Ideally, of course, this strategy would

be in place over a number of years, during which the California business would have turned over all of its real assets to the Nevada corporation in satisfaction of its agreement—leaving NOTHING for prospective litigants to attack.

Two major purposes have been served through employment of this strategy: immediate tax savings of thousands of dollars, year after year, and protection of the hard-earned assets of the business. Less than a thousand dollars worth of setup costs and a few hundred dollars per year of maintenance costs for the Nevada corporation—that's all it took to accomplish these amazing results.

It is hard to conceive of a profitable business in a foreign jurisdiction that would not benefit by many times the costs of setting up a Nevada corporation strategy similar to this. For foreign nationals, of course, there are additional benefits to being associated with a U.S. corporation and these are hinted at in the current "Tip of the Week" (#10).

#### Nevada vs. "Offshore"

Some people have spent thousands and thousands of dollars setting up IBCs (International Business Corporations) and complex offshore structures. What an extreme disappointment and rude awakening for them when at the start of this year disclosure requirements in offshore locations were substantially increased. All locations with which the United States has an MLAT (Mutual Legal Assistance Treaty)—which is virtually all of them—are affected.

We have heard stories from those formerly involved with such structuring indicating that many offshore corporations are simply being abandoned because of the loss of privacy. But what of those situations where substantial assets have been transferred to those offshore locations?

One solution might be for some of those offshore companies to invest in Nevada corporations—where most of that money should have gone in the first place. Your Nevada corporation can provide services for its affiliated business in your home country and receive its income in a jurisdiction that is taxed at only 15% on the first \$50,000 of net income. In some cases, that advantage alone is sufficient reason to take this step IMMEDIATELY. ### Coming to America

The United States Immigration Service has recently relaxed requirements for many high-tech workers, in recognition of the global demand for skilled workers in this field. 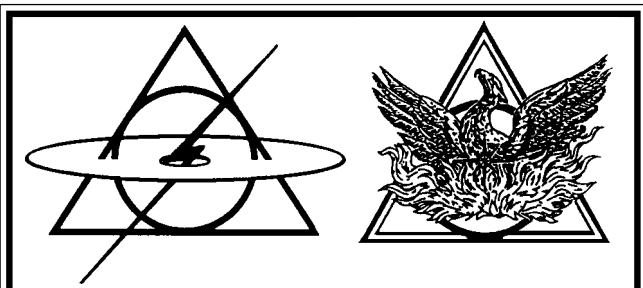
