

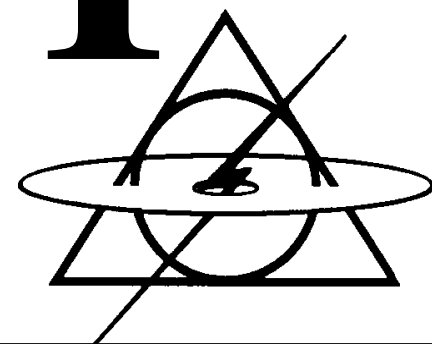

CHAPTER 48

BIO-PSYCHOLOGICAL WARFARE

Almost everyone has heard about psychological warfare. In the case of war you for instance poison the water supply of the enemy and disseminate viruses or bacteria. That is not new, but have you ever considered where these warfare agents are tested?

I will cite a few examples:

In 1950 a U.S. NAVY vessel testing the attacking and defending possibilities of biological weapons had San Francisco (U.S.A.) for six days befogged with the bacterium *Serratia*. Almost all of the then 800,000 citizens felt some of it. Today it is known that *Serratia* bacteria causes a kind of pneumonia that can be deadly.

The army further disclosed that between 1949 and 1969 a total of 239 tests in the open had been carried out, eighty of which were with germs, that makes four attacks per year on American cities, and that for twenty years! According to CIA reports, during the same period and independently, the agency also bombarded towns with bacteria and germs. Apparently they stopped after 1969. **[H: No, they did NOT stop.]**

The Americans were not only bombarded with germs,

but also with something much more effective. As the NBC announced on July 16, 1981, the Northwest of the U.S. had for several years been subjected to low frequency wave attacks by the Soviet Union. These radio waves were set to the biological electric frequencies. They are known as ELF (extremely low frequency) waves and had been discovered at the beginning of this century by NIKOLA TESLA. (Books are available.) In 1884 Tesla came to work with Edison, but they soon parted ways because of differing views about the production of electric energy and Tesla decided to work for Edison's competitor Westinghouse. In 1892 the first power station for alternating current, designed by Tesla and constructed by Westinghouse, was put in operation at Niagara Falls. A short time later Tesla catapulted into a "scientific super-space" where, as far as we know today, no scientist alive then was able to follow. Only the banker J.P. MORGAN (J.P. Morgan & Co. was the representative of N.M. Rothschild & Co. in the U.S.) who had financed Westinghouse seems to have understood what was afoot. Tesla had started to tap into the energy field that surrounds the Earth and fills space, then called ether, and draw out energy—for free, of course. At the same time he used the energetic field of the ether for several forms of communication and energy transport. Energy sources like coal, oil and water would become obsolete, as would electrical high tension power lines. Ships, and automobiles, aircraft factories and houses could draw their energy directly from the energy field of the ether. By the end of 1898 at his Colorado Springs experimental area financed by J.P. Morgan, Tesla came very close to the technical solution of collecting energy from the ether. Today this technology is known as the conversion of "gravitation energy" or of "tachyon energy". Morgan understood very clearly what this development meant. The control by electricity, oil, petrol, coal, etc., would no longer have been assured. Therefore he ordered work to cease and Tesla's Colorado Springs centre to be destroyed. But Tesla did not give up. Until his death on January 7, 1943, he brought forth a staggering number of inventions, some revolutionary and some whose implications can even today only be guessed. His inventions could in a short time turn the Earth into a paradise, but—as you now know—this is not what our *manipulators* want.

Among those developments were machines that can gather energy from the ether (today the tachyon field) and transform it into usable energy and a "solid state converter" (1931) which drove a special electrical motor that was installed in a heavy luxury limousine and gave the latter a performance similar to the petrol engine. The car was test-driven for a week at 130 km/h—fuel cost ZERO! (This appliance the size of a wine box produced enough energy to run a whole household!) He further succeeded in starting artificial earthquakes by a vibration induced in the tachyon field that then was transferred to all matter. He once subjugated a whole block in New York to such a quake. Apart from having a patent for the remote control of vehicles (1898) he also had developed energy transmission without cables.

[H: An interesting thing flows from such a device as mentioned above and one which is contained in a device no larger than a fist, a counter to earthquakes. If you interrupt (counter) the frequency build-up in the Earth building to a quake, you can stop the major damage as an outcome.]

But what concerns us in this book is his discovery of standing waves (which we will look into a bit later) and of extremely low frequencies known as the "Tesla effect". These experiments formed the basis of all modern research

in the area of ELF communication. If the tachyon field is subjected to an ELF wave and is then aimed at a human being, electrical functions in the brain are disrupted which causes severe disturbances in the waking consciousness. The neurological and physiological functions are interfered with by a diminution of the mental functions and thus make the person more susceptible. From an article by the "Associated Press" of May 20, 1983 we learn that this is intended, for apparently the USSR has used a device called LIDA from about 1960 onwards to influence human behaviour with low frequency radio waves. In the USSR LIDA was used to calm people and to induce a trance-like condition. Psychic problems, neuroses and hypertension can be thus treated, but states of aggression or depression may also be caused. Large LIDA units had been used to irradiate with aimed beams individuals, towns and even whole areas of the USSR and the U.S. to effect certain modes of behaviour. According to the U.S. defence intelligence agency it is possible to have sounds and even whole words "appear" in the brain of a human being, but also to cause strokes, cardiac arrests, epileptic fits and other illnesses by remote control.

One of the earlier cases of the "invisible war" that became known was the so-called "Moscow signal". When the U.S. embassy was checked for "bugs" in 1962, a microwave beam aimed directly at the embassy was detected. Under the CIA project "Pandora" the motives for this microwave attack were investigated. It was found that headaches, eye aches, vomiting, tiredness, general weakness, nausea, irritability, fear, depression, disturbed sleep, tension, inhibited intellectual functions, reduced memory and cancer were among the effects caused by the microwaves. According to security advisor Zbigniew Brzezinski the U.S. personnel of the Moscow embassy has the highest incidence of cancer in the world. After a short respite due to demands President Lyndon Johnson placed with Prime Minister Aleksei N. Kosygin the microwave bombardment of the embassy was resumed.

Through the so-called *psychotronics* with Tesla weapons that are relatively easy to build it is possible to disengage the waking consciousness in soldiers and thus stop their will to attack. In an article in *Magazine 2000*, Nr. 97 of December 1993 we read:

"New psychotronic weapons:—Do you remember the images from the Gulf War where thousands of Iraqi soldiers who capitulated, came out of their trenches and surrendered even to journalists, were welcome cannon fodder for the American artillery, despite their white flags? More and more military experts are now convinced that this sudden and lemming-like surrender was not due to the poor supply situation of Saddam's troops but to psychotronic mind-control weapons of the U.S. Some of these high-tech super weapons use the effects of radio waves on the human brain. The January 1993 edition of Aviation Week and Space Technology reported that the U.S. Defence Ministry was now equipping rockets with devices that could create electromagnetic impulses (EMPs) to "paralyze" the enemy without having to resort to atomic, biological or chemical components. This type of weapon was mainly aimed at disrupting the enemy's electronic systems. Other devices use supersonic sounds of ELF (extremely low frequency) waves that cause nausea and vomiting and seriously interfere with the sense of direction of those attacked. These weapons have a range of at least 2,500 kilometres."

Just as the aggressiveness can be diminished, centres of aggression can be produced of which civil wars, unrest, collective suicide, hatred, etc., may result.

In insider publications one often reads about the so-called Tesla weapon. These are very

effective devices that use the unlimited energy potential of the tachyon field in space for power.

The best-known authorities in this sector are the U.S. army colonel and physicist Thomas E. Bearden and the American physicists Sidney Hurwitz and Guy Obelensky. The latter two have for years been actively working for Israeli defence. In 1969 Hurwitz had constructed a Tesla weapon that in a radius of 300 metres drastically raised or lowered the gravitational acceleration of ferrous metals. So Hurwitz could, for instance, make a tiny pistol weigh many kilogrammes and change the dimensions so that the ammunition would no longer fit. With stronger influencing he had the arm's metal rip to pieces "like dough". (These tests were filmed and are shown in the video trilogy *UFOS: From Legend to Reality—Top Secret—The Contact* by Royal Atlantis Film GmbH, Munich, Germany, Tel. 089-850 5494. There is also an interview with Thomas E. Bearden).

WEATHER WARFARE is another subject most people don't know about. Before we look at it though, let us deal with the weather in general.

We assume that the main problem causing today's weather anomalies is the fact that the Earth gradually cools while the doubling up to now of the CO₂ content of the atmosphere causes a warming up (greenhouse effect). An article in the *Neue Solidarität* (*New Solidarity*) of February 24, 1993 adds:

"Recently one could read in the well-known magazine Nature that here is a vast discrepancy between the 'climatic breakdown' predicted by the most expensive mainframe computers and reality. In the January 28 issue we published an article by Jonathan D. Kahl titled 'The Absence of Any Signs of Greenhouse Warming over the Arctic Ocean over the Last Forty Years'."

The beginning of the article shows already what this is all about:

It states that the general circulation model of the atmosphere predicted an increased greenhouse warming in higher latitudes. They published temperature measurements in the lower troposphere over the Arctic Ocean made between 1950 and 1990. They had analysed more than 27,000 temperature profiles. Most trends were statistically not significant. In particular they had not noticed any large-scale warming of the surface as predicted in the (climatic) models; indeed they discovered a marked cooling for the seasons of autumn and winter over the western Arctic Ocean. This discrepancy suggests that today's climatic models do not correctly represent the physical processes that influence the polar regions.

Moira Timms writes in *The Six O'clock Bus* (Turnstone Books, London 1979) that observatories at the polar circle report that during the last thirty years the temperature had fallen by about 6 degrees C.

The Neue Solidarität goes on:

"It would be hasty now to conclude that the greenhouse models were proved wrong, and this for a very simple reason: The greenhouse models cannot be disproved by any measurements or any other scientific facts. They are irrefutable because they have nothing to do with scientific statements. Climatic models are sociological manipulative instruments that allow to construct from a sufficient number of external parameters and arbitrary observation data disaster scenarios with a maximum political 'potential for being put through'. Therefore we predict that the very data from Kahl's study—which today apparently contradict the climatic models—will in just a few weeks belong among the best confirmations for the greenhouse theory. The flexibility of those models should not be underestimated."

A subject that never appears in the media is that of a

possible new ice age. After studying rock and soil samples over decades many reputable meteorologists and geologists have come to the conclusion that during the next fifty years an ice age should establish itself. According to their views an ice age is independent of the greenhouse effect caused by the pollution of the atmosphere. In only a few decades the cooling would equal the warming presently occurring.

It is even more worrisome when we consider that only 1% less sunlight could cause the next ice age. The reduction of irradiation through environmental pollution is less disturbing than the fact that a gigantic volcanic eruption could diminish sunlight considerably. Clouds of fine ashes from such an eruption can stay in the stratosphere for years and lower the temperatures on the surface by several degrees. Very little of this ever appears in the media. You should not believe everything appearing in the media about environmental pollution. It is advisable to also lend an ear to the other side.

But there is a completely different side to the subject of weather about which the media also keep silent:

That today's weather situations cannot always be dismissed as "capriciousness" and that natural disasters, earthquakes, storms and drought periods are everything else than "punishment of God" is shown by the following quote from Moira Timms' *The Six O'clock Bus*:

"Without a complete theory about why the climate is changing all attempts of man to alter it are certainly dangerous (similar to a therapy with drugs that fight the symptoms without attacking the cause). Is this what Johann Friede was alluding to? 'Not everything will be the result of natural causes, rather humanity will reach for the clouds and thus endanger its very existence' In 1975 in the U.S. alone nine programmes for weather modification by the government and sixty-six programmes by other agencies were conducted. These programmes contain a plethora of climatological experiments like the seeding of clouds with particles for condensation to produce rain, to suppress hail, to disperse fog, to influence hurricanes, to divert blizzards or snowfall, the production of earthquakes and tidal waves, suppression of lightning, etc. If today's trend of unpredictable and cold weather persists, North America, Canada, Northern Europe and Russia will suffer most. Weather theft aided by complex technological means where weather is diverted from poor countries could be a very real problem in the near future when 'natural' disasters, famine and drought hit the less developed nations. This could even lead to war. As all attempts to harness natural forces this will also lead to manifold repercussions. So far no international laws have been passed that limit the 'weather monopoly' which in itself seems to be very lucrative. To create 'weather' in one place is only possible by affecting its potential in another place."

"In 1973 Honduras accused the U.S. of stealing its rain and causing a severe drought when the U.S. diverted the hurricane 'Fifi' to safeguard the Florida tourist industry. This hurricane caused the severest damage in the history of Honduras. El Salvador that suffered severe droughts had leveled a similar complaint against the U.S., like Japan which thinks the seeding of typhoons off Guam deprived it of the scarce but vital rain. Rhodesia and Israel had both been accused of rain theft by their neighbouring states. The UN worked on a ban of environmental war, but that is a complex and difficult matter and it is well nigh impossible to seal that tight. In The Cooling Lowell Ponte cites military men who admitted that aircraft of the U.S. government had ended droughts on the Philippines and the Azores to safeguard U.S. military interests, but that they had declined to answer pleas by several nations in the African Sahel zone suffering from drought and

hunger on the grounds that American private companies could be approached. Ponte also describes Soviet plans to change the normal weather structures within the USSR drastically to increase agricultural production."

There is also proof that the massive destruction caused by El Niño in the Pacific Ocean during 1982/83 was deliberately caused by the Soviets by an interference in the ionosphere. The phenomenon known as El Niño is an ocean current that disrupts weather by natural changes occurring about every ten years. Usually this causes heavy rainfall over parts of Peru and a limited area opposite the South American west coast. But the 1982/83 Niño effects were drastically different: The trade winds over the equator which in the southern hemisphere normally blow from east to west somehow were subjected to a barrier effect and thus caused the water currents that normally flow towards Asia to flow back and to build up before the west coast of South America. For reasons unknown to the meteorologists the trade winds then reversed direction and thereby caused cloudbursts in Peru and drought in Australia. Further this caused earthquakes, mud avalanches and tornadoes in Southern California, over the west coast of North America and in Alaska.

This example exactly explains the effects of ELF waves that are beamed with a Tesla amplifying transmitter through the earth into the ionosphere to produce gigantic standing waves. These in turn serve as a weather blocking mechanism producing a sudden and unexpected barrier effect in the east-west trade winds. Dr. Michrowski of the Canadian State Department wrote already in 1978 that in the winter of 1976/77 the Soviets succeeded in determining the resonance of the earth and thus were able to produce relatively stable standing waves fixed to a location with which the flow of the jet streams in the northern hemisphere could be checked or moved.

Not only do the purposeful changes to the weather by ELF waves have a detrimental effect on natural weather structures and the rhythm of the tides, they also have a pathogenic effect on humans and a negative influence on animals who depend on warm wind and ocean currents or are guided by them, by disturbing their natural rhythms and thus sentencing them to death. Flights of birds cannot find the island on which they normally breed and whales lose their orientation because the currents have changed. (Very valuable information about changing the weather and about psychological warfare can be found in the book *Nikola Tesla—Freie Energie statt blut und Öl!*, VAP-Verlag Wiesbaden, Germany, 1991).

The reader is here reminded of the fact that in the case of an ice age or the worsening of the effects of environmental pollution there are only a few or even no alternatives and solutions available. For the elite though who since 1957 know about our disastrous environmental conditions the case is quite different.

At that time prominent scientists met at Huntsville, Alabama to monitor data and information from the newly installed satellite programme. One of the persons present, Dr. Carl Gerstein, predicted that the pollution in the upper atmosphere and the hundred billion tons of CO₂ that had settled there would have disastrous effects by the end of the millennium. They reached the opinion that during the coming century human life would no longer be possible on the Earth's surface due to the effects of this pollution. Therefore they developed a plan that today most UFO-logists are familiar with and whose publication had cost the lives of several persons already.

The plan was as follows:

ALTERNATIVE 1: Detonation of a nuclear device in the stratosphere to enable the CO₂ to escape into space.

ALTERNATIVE 2: Building vast subterranean self-sufficient cities where the “elite of society” would be sent and where they could live until life on the surface would again be possible.

ALTERNATIVE 3: Colonisation of another planet, e.g. Mars.

Alternative 1 was later declared too dangerous and removed from the programme. The other two alternatives however, were steadily put in action.

ALTERNATIVE 2 comprises—according to my research—already seventy-five subterranean cities, sixty-five of them on the North American continent, one in the Swiss Alps, one in the Transvaal, South Africa, and one in Pine Gap, Australia. (The others I cannot remember because I was only allowed to look at a relating list for a short moment.) Among the American underground cities are the subterranean bases Dulce Base, New Mexico, Area 51, Groom Lake, Nevada, the “Country Club” in Maryland and Los Alamos, called “Dreamland” in California in which genetic experiments on humans (cloning), test flights and copies of crashed saucers are made as well as developments like pulsar drives are tested.

In April 1992 I interviewed a lady in Sidney, Australia who does not want to be named. She had worked for an Australian “cleaning brigade” and on their behalf had also entered the underground air base PINE GAP. She said, despite the threat of severe penalties—that Pine Gap was about thirteen kilometers deep, functions on the basis of free energy, had lakes, suspension railways, its own fruit and vegetable gardens, etc. According to official information Pine Gap can withstand a direct nuclear hit without problems. (More about Pine Gap in Stan Deyo’s *Cosmic Conspiracy*).

ALTERNATIVE 3 apparently was begun in 1959. In the late Fifties already American saucers had been built with the aid of German scientists who had helped build the German saucers—Viktor Schauberger (VRIL 7) among others—and by using the technology of UFOs crashed in the Western U.S. A secret programme parallel to the official space programme was started where the moon’s surface was explored using saucer technology. Beginning in 1960 two moon bases run conjointly by Americans and Russians were erected on the eastern edge of the MARE IMBRIUM. Those were the ARCHIMEDES BASE and the CASSINI BASE, named after the craters in which they were set up. The moon bases were planned as stop-off places on the flight to Mars.

On May 22, 1962 the first manned landing on Mars is said to have happened. This landing as well as the flight across the Mars surface with commentaries by the American and Russian crew was recorded from the saucer.

In January 1977 this film was given to Sir William Ballantine, a renowned radio astronomer, by Harry Carmell, a NASA staff member.

On February 6, 1977 Ballantine had planned a meeting with John Hendry, the manager of a daily newspaper, to discuss publication of this film. On the way to Hendry he died in a mysterious car accident. Aided by Ballantine’s wife and Carmell the film finally reached the hands of the *Science Report* team of the English Sceptre TV station and was broadcast in the next installment of the *Science Report*. The station then received the *tip* that they would lose their licence if they would continue to report on this subject. The film shot from the cockpit of the flying craft shows a brief view of the instrument panel where the outside air pressure registers with 700 millibars and the outside temperature with 4 degrees C. The astronauts whose voices had also been recorded cheered and shouted: “It is the 22nd of March 1962, we are on Mars—and we have air!”

Remarks:

If I have so far held back with my personal hypotheses, I would nevertheless like to state one here. I hear the reader say: “What a lot of nonsense, we know that life on Mars is impossible.”

My question to you then: Do we actually KNOW? Let’s be honest: the only thing we know about Mars is what has appeared in NASA reports or what is published in the common textbooks. The public has been TOLD that there is no life on Mars, but that does not mean that we KNOW! You have to realize that the space programmes are again monopolies, and no one except the scientists directly involved in the projects REALLY know anything. Whatever information they choose to release we have to take for granted, since at this moment we cannot fly up to Mars to personally check it out. Let us assume that Mars is really *dead*; then it’s just back to square one; we would realize that we have to stay on Earth and that no adventure is waiting for us *out there*. But if we assume that life on Mars would be possible in one form or another—perhaps under galls domes with filtered air—do you think that this would be divulged just like that? The Viking 1 pictures of July 31, 1976 shot from an altitude of 1,278 miles over the northern hemisphere show the now well-known Mars face (1.5 km long) and to the left of it the symmetrical forms of several pyramids. The very existence of these buildings is revolutionary enough to shake all the so-called world religions to their foundations by hinting that the earthbound human race is perhaps not alone after all and definitely not the “crown of creation”.

The existence of the pyramids allows two hypotheses that destroy all previous accounts about the history of humanity. The builders of the pyramids were either our predecessors, raising the question of how they got to Mars. If that was the case they had to have possessed an advanced technology, a fact that western religions and science denies. Or the builders of the pyramids were not related to humans, which means that the pyramids bear witness to the existence of extraterrestrial life-forms, another fact that the aforementioned institutions steadfastly deny. Perhaps the builders have not disappeared, but have just moved a level lower? If, however, they did colonize Earth at one time they probably are one of our main races now. (Perhaps the red race, just as the name implies?)

We have enough different races whose cosmogony maintains just such an event in the past. The movement of the canals of Mars hitherto inexplicable to the astronomers supports the theory that Mars cannot be completely dead. If Mars was really dead as many so-called scientists claim, and if no other life exists in the universe, if we humans can roam freely—at least in our own solar system—the question then arises of what happened with the Soviet probe Phobos II that landed in 1989 on Phobos. Further there exists a logbook of the VRIL-7 about its first flight to Mars without a landing. It describes the surface

and the Cydonia region in much more detail than the photos of the Viking in 1976 showed! A film exists of this flight (shots inside the saucer and out, from the cockpit), but I cannot provide any leads to it except that it is said to be in the hands of the Societas Templi Marcioni. I just cannot believe that the Americans and the Russians are not able to build an anti-gravity drive, too, as the Australians have already done, according to Stan Deyo.

ALTERNATIVE 2, the underground cities, however is a reality. So, if the second alternative was carried out, why not also the third?

The complete story of Alternative 3, the alleged state of Mars, its atmosphere, the suppression of information, the construction of bases, the measures for protection and camouflage, the housing of personnel, transport, the brainwashing of personnel and the difficulties that apparently arose and perhaps are still existing are to be found in Leslie Watkins’ book and video *Alternative 3*.

CHAPTER 50

THE CIA AND THE SHAH

In 1979 the hated Shah who got his power in 1953 aided by the CIA was chased from Iran by the revolution.

Since as a rule most employees at a U.S. embassy are also CIA members, the Iranian rebels, who knew about that fact, in revenge took the U.S. (CIA) employees hostage. The CIA in turn retaliated by telling the leader of Iraq, SADDAM HUSSEIN, that this was a good time to invade Iran since the latter at this time was weakened (which was not necessarily true).

The invasion by Hussein was successful and the Iranian hostage-takers let Jimmy Carter know that they would free the hostages in exchange for arms. Since most of their arms bought during the Shah's time were from the U.S., they had to get ammunition and spares from the States, too. President CARTER however refused this deal and at the same time started a secret mission with the CIA (Desert One) to free the hostages.

But the CIA did not exactly like Carter since he had instigated drastic cuts for the CIA. So an early opinion poll was launched to ascertain which candidate was more likely to win the next presidential elections—Carter or Reagan. The people voted for Carter. The CIA however wanted Reagan and so they planned to sabotage the rescue mission DESERT ONE so President Carter would lose face.

At the same time WILLIAM CASEY, former CIA director and head of Reagan's election committee had established contact with Iran's revolutionary leader AYATOLLAH Khomeini. Casey told him that Reagan would carry the next election and that he could therefore deal with him as Reagan's representative. William Casey had a good reputation because he was instrumental in the building of the largest lorry manufacturer in the world, the Kama River Lorry Co. in the Soviet Union. Since Casey was also chairman of the Export Import Bank, Khomeini decided to collaborate with him.

In the third week of October 1980 GEORGE BUSH (Skull & Bones member and later U.S. President) and RICHARD ALLEN as Casey's representative met with the agents of the Iranian Hizbollah extremists at the Hotel Raphael in Paris. There it was agreed that the U.S. would transport arms to Iran via Israel and that the Iranians would free the hostages the moment Reagan was declared President. The first arms delivery was to take place two weeks later (in March 1981). [Really?]

The CIA's sabotage of Desert One planned by themselves was successful. The rescue mission failed and Carter was replaced by Reagan. The hostages were freed and the first arms delivery via Israel was made. Between July 24 and 27, 1981, the Israeli arms dealer Yaacov Nimrodi signed a 135 million dollar contract with Iran for the delivery of 50 land missiles, 50 mobile missiles and 68 Hawk anti-aircraft missiles.

Another deal that became known was that made by the Swiss arms dealer, Andreas Jenni, together with the arms dealer Stuart Allen McCafferty, who flew 360 tons of M-48 tank spares to Iran in a CI-44 freight plane chartered from the Argentine airline company Aereo Rioplatense. The whole thing cost them 27 million US\$ and they made two successful flights from Israel to Iran. On July 18, 1983 the plane was shot down over Soviet Armenia by a Russian MIG-25 on its return flight from the third delivery.

These arms deals would hardly have been possible without GEORGE BUSH and Richard Allen.

In this case, too, the official media reports were far removed from what really occurred.

[H: You should be ready, willing and able to see the foundation being laid for the PLAN for unlimited money which ultimately ends up as the asset held now by GAIA.

This sucked in the very resource that could "back" such a major plan as presented by Ferdinand

CHAPTER 51

SADDAM HUSSEIN AND "DESERT STORM"

Iraq had just come out of a senseless war with Iran that had no other reason than to enable international arms dealers to reap enormous profits. For in the beginning of the Eighties the U.S. had passed on to the Iraqis false intelligence (as just mentioned) indicating an easy and fast victory over Iran. This prolonged war however had dealt quite a blow to the Iraqi economy (a debt of US\$ 65 million in 1989 alone). Next to the Soviet Union France had been the main supplier of arms.

The time had come—according to Pike's letter the end phase—to ring in the third and last war. For this a trouble spot was needed in the Near East. This was cleverly planned, for in the *Bible*, in the Revelation, the last battle starts in the Near East. Thus those following the *Bible* and those believers not very well informed in geopolitical matters are misled. They would believe that this was God's judgement. But it isn't. It is the judgement by the Illuminati.

So it was planned to set a trap for SADDAM HUSSEIN. He should give England and the U.S. an excuse

to intervene by military apparently to safeguard the world oil supply. In June of 1989 a delegation with Alan Stoga (KISSINGER ASSOCIATES LTD.), members of the board of the Bankers Trust, Mobil, Occidental Petroleum and others followed an invitation by Saddam Hussein to Baghdad. The project at the centre of discussions—the Badush Dam project, that within five years would have made Iraq independent of food imports—was turned down. The delegation insisted that first the national debt had to be paid up and thus the oil industry should be at least partly privatized. Saddam Hussein of course declined.

By the end of 1989 the US\$ 2.3 billion George Bush had promised Iraq were blocked (by the Banca Nazionale del Lavoro BNL). Thus at the beginning of 1990 Iraq was cut off from all loans by Western banks. Now Sheik Al-Sabah, emir of Kuwait and friend of the English royal family entered the game. Up to now he had channeled money into Iraq, as bidden by London and Washington, to keep the eight-year war going that brought the arms dealers money and Israel political advantages. At the beginning Kuwait was asked to dump cheap oil on the market despite signed OPEC treaties disallowing this. Several diplomatic advances by the other OPEC countries tried to keep Kuwait from continuing on this dangerous path, but without success.

In July 1990 the quarrels between Kuwait and Iraq escalated. At the Bilderberger meeting of June 6 to 9, 1990, the decision had been made that was delivered to Saddam Hussein on July 27 by April Glaspie, the American ambassador in Baghdad:

"The U.S. will not intervene in the argument between Kuwait and Iraq." (The official minutes of this meeting were published after the beginning of the Gulf War.)

This of course gave Saddam the go-ahead. On August 2, 1990, Iraqi troops invaded Kuwait. Naturally the ruling family had been forewarned by the CIA and had left the country, jewels and Rolls Royce and all.

The next six months saw the enactment of a well-staged play. On September 11, PRESIDENT BUSH ANNOUNCED HIS NEW WORLD ORDER. There were many meetings to avoid a war that had long since been decided. And so the U.S. troops entered the Gulf War on January 15, 1991.

James H. Webb, Marine supreme commander under Reagan, described this scenario:

"The aim of our presence on the Persian Gulf is to start off the NEW WORLD ORDER of the Bush administration (an Illuminati puppet), and I don't like that at all."

Perhaps you would like to compare this with what was broadcast in the news at the time.

William Cooper had announced the date of the invasion by U.S. troops one year before the beginning of the Gulf War. He had taken the information from secret papers to which he had had access during his time as Naval Intelligence officer. He announced that date during a workshop that had been recorded on video, proving that he gave the date one year before the Gulf War.

That war had been planned and prepared long in advance, and so is the Third World War, whether you believe it or not.

For years it has been an accepted fact that the Zionists planned to make Jerusalem the administrative centre of the one world government. This goal had been stated in 1962 by Israel's Prime Minister DAVID BEN-GURION. Any attempt to establish such a world alliance with Jerusalem as its centre would surely start the Third

According to William Cooper the Third World War is planned for the middle of 1996. He got this information from secret papers he had seen during his time as a Naval Intelligence officer. Thus it is planned to destroy one of the three largest American cities (New York, San Francisco or Los Angeles) with an atom bomb. Extremists from the Near East crisis area (Iraq?) will be blamed to have a reason to start the Third World War.

Was the bomb that exploded at the World Trade Centre perhaps just a test to see how the masses would react? Think about it!

Personally I don't think that World War III will start in 1996, but I know that our “friends” had planned to make it happen by then, and they will try everything they can to get their world dictatorship as early as possible. I believe however, that things will work out quite a bit differently. **[H: Please keep in mind that most of this book was done in 1993 and put to press in 1995. (Today is May 29, 2001.)]**

World War III already started some forty years ago. But the war they fight is the silent war they always prefer. It's not a fight against a certain nation on this planet; it's a fight against all the people on this planet. The Illuminati have been very successful in these last decades to enter every single house on this planet through television, radio, literature and food, to change people's attitudes towards them and towards their goals. They radiate their ELF waves (refer to the chapter on weather control) upon you, and you don't even recognize that they are messing with your behaviour and with your brain. That's what is really happening.

But there is still a power on this planet (three-dimensional) that the Illuminati are very much afraid of—besides the loving forces from outer space and from the spirit realms who guide us every minute.

[H: How nice!]

I spoke to a rabbi recently and confronted him with the question whether he knew that they wouldn't reach their goal but would lose everything, even their lives, and he said: “YES, I KNOW, BUT WE WILL TAKE AS MUCH OF YOU (GOYIM) WITH US AS POSSIBLE (OFF THIS PLANET).”

CHAPTER 53

GERMANY REUNITED (TO FALL)

Russia and communism had fulfilled their tasks as bogeymen and could now be dissolved. With the Russian enemy the Western nations had been forced into alliances that put UN and NATO law above the national laws. Everything went smoothly. Now the time had come to unite the U.S. and the S.U. officially, although where capital and arms production was concerned they were never really apart.

U.S.—S.U.: do you see the similarity? Accidental? Is

it perhaps accidental, too, that both the Soviets and the U.S. not only use the pentagram on all their arms, tanks and planes but use it also as a state symbol (Red Star, Pentagon), and what about the *all-seeing eye* of the Illuminati which adorns the Great Seal of the U.S. and is at the centre of the emblem of the Marxist regime?

[H: I will note something right here as to those *Journals (Phoenix)* that were published by George Green through America West. Without focusing on it I will remind all of you readers who have those early books through America West to actually LOOK AT AMERICA WEST'S LOGO—IT IS A TRIANGLE WITH NO LESS THAN THREE OF THOSE ALL-SEEING EYES.

NEXT, IF YOU HAVE ACCESS, look at the logo of *SPECTRUM* and what do you find in a rather more subtle but more impressive way—an all-seeing beam from the triangle flowing directly from the lower point of the RED ray. This is another symbol of the Illuminati and is more specifically related symbolically to the Red Shield of the Rothschilds.

Do the persons involved know as much? Not all of them because they are too ego-centered to even consider such a thing. Where, however, does that put you who just tag along in your blindness?

Anyone who breaks the laws of God and/or of man in such games as Twin Flames, Soul Mates (for the express purpose of using another person), takes for self in ego-snatched proprietary property as well as hard product and property, including MONEY yet—is of Satan's workshop—and they are bound to WEAR A SIGN AND BEAR A CLUE. However, who YOU befriend and support is certainly your business—but don't be shocked when you are excluded from the door of those you injure in the process of same.

You have to understand that the TRIANGLE has a most Godly meaning but a pyramid has quite another symbolic meaning as well as a prism having even a greater meaning, most of which you would wish to deny in the open Light of Truth.]

Now it was once again Big Brother's turn to stage something. A world army was planned by the UN, after all.

The collapse of oil prices in 1986 had hit the Soviet planned economy very hard. From the Seventies onwards oil export had been an important foreign exchange source for the Kremlin. The earnings were just then going down when Gorbachev with his reforms promised more than he could keep. The resulting economic chaos was one of the reasons why Moscow relinquished liaisons to the Eastern European satellite states. Many Soviets counted on a reunited Germany as the ideal partner for the building of the Russian economy.

In November 1989 was when the Soviet rug was pulled from under the feet of East Germany. Under pressure by the refugees leaving via Hungary and the freedom movement on East Germany's streets the old GDR was dissolved within weeks. While outwardly the dramatic end of Communist tyranny was celebrated, the Illuminati had serious doubts about the success of a people's revolution in Eastern Europe. They were further alarmed by the prospect of an alternative to the U.S. economic policy developing in Germany. Therefore the Anglo-American media was quickly given the key word **Fourth Reich**.

The political strategists in London and Washington saw long-term repercussions of German unity and a renewed, strong and eventually independent Germany only too clearly. They also realized the danger that the Project Germany

might be successful—against the Illuminati’s will—in raising and pulling along other countries because of the power and faith of 85 million people.

In summer 1990 the Thatcher government—according to London sources—had the British Secret service considerably strengthen its activities in Germany and to this end established a new Secret Service department. The Bush administration, too, took steps to strengthen its influence on German policy. An independent and positive development is not part of the plans of the Illuminati.

Thus, on November 30, 1989, Alfred Herrhausen, chairman of the Deutsche Bank and member of the Bilderberger group, was assassinated by professional killers (not the Red Brigade, the RAF—Rote Armee Fraktion!). Herrhausen was an important advisor to Kohl. A few days earlier, in an interview with the Wall Street Journal, he had talked about his plans for the rebuilding of East Germany. In one decade it should become Europe’s most progressive industrial nation. He also talked about a funding programme for Third World nations. Apparently Herrhausen had positioned himself against the system of the Establishment, which he had clearly stated at the BILDERBERG conference of 1988 and at a meeting of the “American Chamber of Commerce”, also in 1988. Later the head of the Treuhand, Detlev Rohwedder, was also shot dead. An assassination attempt on Wolfgang Schauble failed to kill him. All attacks were linked to the rebuilding programme in East Germany.

That the phantom of the Red Brigade had to take the blame in the killing of Herrhausen is close to a bad joke. Herrhausen was one of the most vulnerable personalities in Germany and special security arrangements had been made. The security department of the Deutsche Bank guarded his person, the police was responsible for patrolling the area where he lived and used for the observation of the residential area specially trained and equipped units of the Hessian mobile task force (MEK). Despite this the assassins managed to dig a hole in the street in Bad Homburg, to lay a cable and resurface the road without anybody noticing. Chief Federal Prosecutor VON STAHL told the members of the Bundestag that the attack had been planned a week earlier and that the assassins had already installed almost all parts of the later bomb trap, including the cable subsequently identified as the lead to the fuse mechanism.

On the day of the attack the assassins installed a photoelectric barrier and positioned the bomb mounted on a bicycle so that Herrhausen’s car had to pass immediately by it. All these preparations happened at a location that had been patrolled by the police just half an hour before without them noticing anything untoward.

This is remarkable, because a janitor of the swimming baths nearby had seen—about half an hour before the attack—some young men who acted conspicuously. In addition the trap would only work if Herrhausen’s car would pass first through the photoelectric barrier, not preceded by another car.

The former president of the Bundesverfassungsschutz (the German secret service), DR. RICHARD MEIER, told the Bundestag (the German parliament) one week after the attack, that the car normally leading Herrhausen’s three-car convoy had been called off. (Had somebody from the RAF telephoned and said that the first car was hindering the assassination?)

Another peculiarity thought out by the assassins which points to a lot of experience in handling military explosives is the fact that the bomb was fashioned as a *hollow charge*. This had the effect of the shock wave being

directional instead of uniformly extending all around. The building of this bomb as well as the knowledge of the weak points of the armoured Mercedes car with the opening side windows about which only a small circle of security specialists who had seen the pertinent test results knew: all this cannot by any stretch of the imagination be blamed on the RAF terrorists or any other beginners.

The security service could not find any useful leads at the site of the attack that would enable them to point to any group of perpetrators. A piece of paper with a five-pointed star, a picture of a Heckler & Koch submachine gun with RAF stenciled on and the words “Kommando Wolfgang Beer” had been left behind which, however, did not lead anywhere. As with all the other attacks apparently made by an RAF since the arrest of the so-called second RAF generation around Christian Klar and the now well-known disappearing of part of the terrorists in the former GDR since 1984, there was and is not a single proof of an actually existing leftist terrorist group that can legitimately be called RAF.

There are no fingerprints, no saliva on cigarette stubs, no hair nor any other useful leads to the perpetrators who for nine years now have been bombing, shooting and recently expertly blew up a prison. The letter claiming responsibility in the Herrhausen case was so flimsy that the former Federal Minister of the Interior SCHAUBLE criticized that the contents of the letter were curiously at odds with the severity and technical perfection of the assassination. There is a desperate lack of proofs or even hints and clues of a terrorist organization RAF, still the security service of Germany is holding on to the theory of an RAF committing these crimes.

On July 1, 1992 the authors of a German TV report in *Brennpunkt* (focus) titled *The End of the RAF Legend* showed the results of their research. They postulated that the so-called third generation RAF that was officially blamed for these attacks existed only as a legend that was no longer tenable. The *Brennpunkt* authors Wolfgang Landgraeber, Ekkehard Sieker and Gerhard Wisniewski elaborated on their thesis in their book about the *RAF Phantom* (Knaur Verlag). Their main arguments:

1. Contrary to the first (Meinhof, Baader, Enslin) and the second (Susanne Albrecht, Christian Klar) RAF generations the so-called third generation leaves “not even a hint of a clue” at the scene of the crime.

2. The persons counted among the third generation (e.g. Christian Seidler) all disappeared without trace in the mid-Eighties without any sign of life ever emerging since.

3. The *cells* being commanded by terrorists in prison is doubted if not outright excluded by specialists. The *command level* had to be elsewhere.

4. The only clues from which the perpetration by the RAF had been deduced were the *letters claiming responsibility* that were deemed *authentic* by the Federal Secret Service. The methods used to reach this verdict are not above doubt, however,

5. The main point in the programme was an interview with the principal witness of the Herrhausen case, Siegfried Nonne who now retracted his statement of January 1992. He said that he had been forced by members of the Hessian office responsible for defending the constitution threatening him with imprisonment and murder to make the false statement of having harboured the perpetrators in his apartment in Bad Homburg and to have helped them prepare the assassination of Alfred Herrhausen.

The TV team reached the conclusions that the third generation RAF were a phantom artificially kept alive to mislead the population. Further there was the suspicion that the political powers of the Federal Republic of Germany

had not only tolerated but fostered outright the disappearance of a large section of RAF members in the former GDR in the late Seventies and early Eighties.

It is probable that not only the secret services of the Allies but also the German authorities had known that these former RAF members had gone underground in the GDR. The public however was led to believe that these people still shown on “Wanted” posters had something to do with the attacks in the Eighties. In the most recent attack that the so-called RAF claimed having perpetrated was the expert detonation of the prison building at Weiterstadt, everything was as usual: just a paper with the RAF emblem and the commando name, otherwise no clues, no mistakes, no witnesses.

The Italian journalist Cipriani had interviewed the former American Air Force colonel Fletcher Prouty who finds the key to Herrhausen’s assassination in the first eleven pages of a speech Herrhausen was going to deliver in the U.S. four days after his murder. It contained Herrhausen’s vision of a new evaluation of the situation between Eastern and Western Europe which would have changed the destiny of the world. Colonel Prouty said in the interview further that Alfred Herrhausen, John F. Kennedy, Aldo Moro, Enrico Mattei and Olof Palme had all been murdered for the same reason—because they did not accept the world being controlled by the condominium of Jalta. In every case it had been the deed of a small elite [group] that saw their power founded upon the idea of a “pax mondiale” (world peace) threatened.

Remarks to Today’s Situation:

The purposefully staged wave of asylum-seekers arriving in Germany forms part of the elite’s plan for a New World Order. It is used to build up hostility to foreigners, xenophobia, in Germany. Thus the right-wing political parties would get more adherents and acts of violence by right-wingers towards asylum-seekers and the handicapped would increase to justify the propaganda slogan “Fourth Reich” disseminated by the Anglo-American Establishment.

Since the reunification of the two German nations and the demise of the order of Versailles and Jalta the political class of Germany refused to openly stand up against the geopolitically motivated propaganda of a Rise of a Fourth Reich. Quite on the contrary: Some forces, e.g. the chairman of the European Trilateral Commission, OTTO GRAF LAMBSDORFF, follow political-economically the same aggressive course with the same effect as the objectives of the geopoliticians—no infringement on the failed politics by the IMF, the holding at bay of German initiatives.

The outbursts of Mr. Peter Glotz, one of the SPD leaders, against the condemnation of the Serbian aggression in the Frankfurter Allgemeine Zeitung bear witness to the geopolitical views within Germany. The geopolitically aligned nations (England, France and the U.S.) would like a second Near East, an open wound in the southern flank of Europe (war in Yugoslavia), to stop an eventual Eurasian reform which could be centred on closer collaboration with Russia, France and Germany. If one country can influence the events in Eastern Europe, then that country is Germany.

Under these political guidelines all efforts contravening this plan, e.g. the German economic development endeavours towards the East, have to be thwarted at all cost.

The vulnerability and weakness of Chancellor Kohl and his government could not have been better demonstrated before the world than by the fact that in the same month the wall came down, Dr. Alfred Herrhausen, speaker of the board of the Deutsche Bank fell victim to a terrorist attack

whose instigators and executors remain unknown until today and can walk free without fear of persecution.

Strategically far-sighted, Alfred Herrhausen had proposed for quite some time a remission of debt for developing countries, especially in the year of the crash of 1987. But in the eyes of his enemies his proposals were absolutely unbearable, since besides the remission he now also asked for an economic development plan for Eastern Europe. Herrhausen spoke of a Polish development bank modeled after the Credit Bank for Reconstruction. Here Herrhausen contravened—not just in the eyes of Colonel Prouty—the unwritten laws by the Londoner and New Yorker monetary power groups and so got caught in the terrorist net of his enemies.

At the significant moment of the collapse of the Communist system in the East Chancellor Kohl failed to instigate a global change of direction towards a real rebuilding plan for the East. This would have necessitated a break with the predominant financial circles at home and abroad and would have fundamentally influenced the traditional power structures of the old victorious powers. According to *Der Spiegel* Chancellor Kohl said after the murder of Herrhausen that he had lost a strategically thinking close advisor and that now petty minds dominated in most of Germany.

Following this terrible deed Kohl and his government did not dare to expose the reasons for the crime to the public and to motivate police and investigators in such a way that the murderers and the men behind would be caught, their motives established and their deed atoned. Instead, the public was told something about a “third RAF generation”, supported in part with false testimony.

Four years after the assassination of Herrhausen the void he left is very apparent. Entrepreneurs and leaders in economy, science and research avow that, even if the need for a LaRouche development plan in the “production triangle” of Paris-Berlin-Vienna, with extensive infrastructural measures in the energy, traffic and water-supply sectors is recognized as the motor of a Eurasian upswing, no one would now, after the killing of Herrhausen, risk his or her head for programmes which are recognized as being correct, with which run counter to the predominant monetary power ideology.

The murders of Herrhausen and Rohwedder have given those political trends in Germany a boost which stand for an economic “going for broke” policy patterned after the worst free trade doctrine. Now, after the first strike waves in sixty years had hit the new German states some begin to realize the extent and devastating effects of the economic ruination policy. Now Germany has close to four million unemployed, four hundred thousand of them youths. The economic research institute Prognos expect unemployment to rise to 17%, around 7.5 million.

The outbreaks of violence, especially aimed at foreigners, but also against the handicapped and the homeless, that in 1992 had caused the deaths of seventeen people, seven of which were foreigners, are seen by the press that had talked about the threat of Fourth Reich before as confirmation for their thesis of a flare-up of neo-Nazism.

The federal government had tried to correct this distorted image with differentiated reports. Since autumn 1992 more than three million Germans and foreigners have taken to the streets to demonstrate with lit candles for solidarity against xenophobia.

Who are the culprits? More than 70% of the accused are under twenty. They had grown up in the West in the time after the educational reform by Willy Brandt, raised by parents who themselves had still felt

the effects of the teachings by the “Frankfurter Schule” in school, on the radio or in television. The largest number of the crimes considered right-extremist were committed in North Rhine-Westphalia, the most populated state (more than 500), followed by Baden-Wurttemberg (more than 250) and Brandenburg (229).

The distorted picture that was propagandistically disseminated at home and abroad shows the geopolitical intention (the weakening of rebuilding impulses towards the East) as well as pure hypocrisy.

With the aid of official documents and topical interviews with leading American neo-Nazis and KKK members it is possible to trace back how for many years, in fact since the Seventies, Germany had been a very busy playground for these racists and skinheads from America. It is shocking to note that the activities of the NSDAP/AO (Neo-Socialist German Workers’ Party/Exterior and Planning Organization) of the American GARY REX LAUCK and his German cronies—MICHAEL KUHNEN who died of AIDS was a close party supporter of Lauck—can until today work across the ocean unhindered by American authorities or custom and frontier controls, despite ever more signs are surfacing pointing to some secret service *helping hand* in establishing the violent neo-Nazi scene in Germany and in the U.S.

This development and its counterpart, the ANTIFA—Potential der Autocomen (Potential of the Autonomous) are instruments of the strategy of tensions against Germany’s inner and out[er] peace. The VVN (Vereinigung der Verfolgten des naziregimes—Association of those Persecuted by the Nazi Regime) that had been directly financed by the Stasi and the old GDR now works directly with the BdA (Bund der Antifaschisten—Alliance of Anti-Fascists) and set themselves up as spearheading the anti-fascist fight.

As you can see, the Illuminati here again have financed both sides, in the best Machiavellian manner, and so control them both. On the one side the chain leads from the Scottish Rite of Masonry (Mossad, KKK, B’nai B’rith, Anti-Defamation League (ADL), NSDAP/AO) to the German neo-Nazi and skinhead scene and on the other side the Stasi network controlled by the Communist system that extends into the *Antifa* and left extremist scenes.

The GESINNUNGSGEMEINSCHAFT DER NEUEN FRONT (GdnF’s Interest Group of the New Front) founded by Kuhnén in 1977 with its 400-odd members is one of the most important groups of specialists who is closely linked to the NSDAP/AO. A large portion of the propaganda material of the FAP (Freie Deutsch Arbeiterpartei—Free German Workers’ Party) recently banned, came from the NSDAP/AO.

There are more interesting links to be uncovered. The leader of the English skin rock band SCREWDRIVER, Ian Stuart, for instance works with the BRITISH NATIONAL FRONT. Until 1985 they belonged to the WHITE NOISE CLUB of the British National Front in which racist English skinhead bands grouped themselves. In 1985 Ian Stuart founded the BLOOD & HONOUR movement through which they disseminated the “White Power” idea of the Ku Klux Klan. But not only skin rock bands formed part of that group of specialists. The satanic band KISS (Kings In Satan’s Service) who openly profess to Satanism and who wrote the double-s in the shape of the SS-runes until they were prohibited to do so) is in direct contact with Anton LaVey’s CHURCH OF SATAN, the biggest official satanic church in the world. The Church of Satan had in the past built very close relationships with English and American satanic rock

groups. The British group BLACK SABBATH with the singer Ozzie Osbourne for instance, had been supported by them. The ROLLING STONES, too, had close links with the Church of Satan.

The neo-Nazi and Satanist MICHAEL AQUINO is the leader of the Satanist sect TEMPLE OF SETH that came out of the Church of Satan.

In the Sixties and Seventies he had been officer of psychological warfare in the U.S. armed forces, also author, philosopher and historian for the Church of Satan. In 1981 lieutenant colonel Aquino was EUROPEAN ADVISOR on the American general staff. The same Aquino held a satanic ceremony on Wewelsburg Castle in Germany, where SS leader Heinrich Himmler had a room installed for black masses.

In order to perform his present function as Satanist and right-wing radical within the U.S. army he had to form a better controlled group that went further than the Church of Satan: THE TEMPLE OF SETH. Aquino, who is also involved with sexual and satanic child abuse, the neo-Nazi Gary Rex Lauck and the right-wing radical Anton Szandor LaVey as well as Michael Kuhnén are closely linked with the present Grand Dragon of the Knights of the Ku Klux Klan, DENNIS MAHON (all those mentioned are also homosexuals, by the way). And via Aquino they all are linked to the already mentioned TAVISTOCK INSTITUTE for psychological warfare in Sussex, England.

MONTAGU NORMAN, head of the Bank of England from 1920 to 1944, who had supported the rise of HJALMAR SCHACHT and thereby of Hitler, was—according to his own statements—also Hitler’s best friend. Norman was also a wild mystic, a theosophist and often prone to frequent psychotic attacks. Towards the end of the war Norman withdrew from the Bank of England and devoted his time to working for the World Association Against Mental Illness. He appointed Brigadier JOHN RAWLINGS REES as president of the association.

Norman’s wife was a fanatical racist and sat on the BRITISH HEALTH BOARD. Brigadier Rees, head of the department for psychological warfare in the British army, was the head of the TAVISTOCK INSTITUTE in England. It was thanks to this kind of supporters that the nightmare of the Nazi *study of race* and their world view could survive in the West. Many Serbian commanders who these days order ethnic cleansing and mass rape in Bosnia-Herzegovina have psychiatric training from the Tavistock Institute, among others.

COURT RULING MAY HALT ENTIRE PRIVATISATION PROCESS Commentary by Frank Senge Kolma

With the nation’s eyes riveted on the University protest and the related tragic events of last week, few may have taken notice of the court decisions relating to the Privatisation Commission. The implications of these decisions on the Government’s privatisation program, a subject at the centre of the protests, are substantial.

They may go as far as halting the entire process of privatisation, a cornerstone policy of the Morauta Government. [Current government.]

The National Court last month decided that the liabilities of the State-owned Papua New Guinea Banking Corporation were transferred, together with its assets, to the Privatisation Commission, which is the agent preparing the bank for eventual privatisation. **[H: And taking the entire reserves, gold, EVERYTHING, from the nation and turning it over to the World Bank/IMF.]**

In the case of Kenneth Bromley vs the Privatisation Commission, the former bank employee contested that contractual obligations owing to him to the tune of K1.6 million plus interest were now the responsibility of the Privatisation Commission, arguing that the liabilities of the bank were now inherited by the Privatisation Commission. The National Court agreed this was so and ruled in his

favour. The Privatisation Commission last week failed in its bid to stay the court order and on Friday paid K1.7 million into the National Court registry to stop itself from being placed under receivership.

The payment removes the injunction on the sale of PNGBC but the entire privatisation process may now be halted because of the precedent this decision sets. Every other State-owned enterprise earmarked for privatisation will now transfer both assets and liabilities to the Privatisation Commission and some of those liabilities are in the millions of kina. The Commission has neither the budget and manpower nor the mandate to deal with the liabilities of these entities.

As an example, the National Court ruled on Monday, July 2 that the Motor Vehicles Insurance Limited is responsible for damages and liabilities incurred while it was operating under a trust. The court further ruled that all its liabilities and damage claims amounting to millions of kina are the responsibility of the PNGBC, which owns MVIL through its holding company. This clearly means that the MVIL liabilities at over K100 million might also be transferred to the Privatization Commission.

The Deed of Settlement and Indemnity signed between the liquidator and MVIL makes it absolutely clear and inescapable for the bank to meet all MVIL liabilities. If it were to dispose of MVIL liabilities, MVIL would be left with assets totaling a mere K4.971 million.

Such is the magnitude of the decision that the privatisation process might never get under way. This is an area where even the World Bank and IMF cannot intrude unless they want to fund the massive liabilities of all the statutory organisations.

In the first place, it was farcical to even contemplate that you can separate the assets of a company and dispose of it and leave the liabilities alone.

The University student protest may not now even be an issue as the central tenet of their contention may be halted as a matter of course. It is also as good a time and as divine an opportunity as any for the Government to use this court case to review the privatisation program under its present format.

The intelligence report, dated JULY 5, also claimed Abu Sayyaf elements are to be deployed in Metro Manila to launch bomb attacks on the United States Embassy along Roxas Boulevard.

The intelligence report cited Bin Laden as calling upon all Muslim mujahideen, or religious warriors, to step up their jihad or holy war against the U.S. and Israel.

[H: Do any of our people see a possible connection with the head of the Department of Interior and Local Governments (DILG), and an “emergency” trip to the U.S.?

Can you possibly think of anything more intense than this prospect to pull in troops to protect the Embassy, et al?]

Sources confirmed to *The STAR* that the elite Presidential Security Group (PSG) has been placed under heightened alert due to the possible bomb attacks and

have taken extra measures to secure the entire Malacañang compound. **[H: Ah, indeed, all the while the real culprit is INSIDE the inner circle.]**

Aside from strict searches of vehicles entering the Palace area, security for the First Family was also beefed up after separate reports of an Abu Sayyaf assassination plot against Pampanga Vice Gov. Juan Miguel “Mikey” Arroyo, the President’s eldest son.

But Mrs. Arroyo, apparently smarting from public criticism when she bared an incipient and apparently aborted destabilization plot against her administration last month, refused to reveal details.

“I cannot share them with you lest my critics will attack me again for revealing raw information,” the President said, adding she wants to leave the war against the Abu Sayyaf to the military establishment.

The President also did comment on the appeal of Sen. Rodolfo Biazon to convene the National Security Council (NSC) to assess the security situation before the 12th Congress convenes on July 23.

BIAZON MADE THE APPEAL A FEW DAYS AFTER THE ABU SAYYAF DECLARED THEY WOULD CONTINUE KIDNAPPING AMERICAN NATIONALS IF THE GOVERNMENT REFUSES TO GRANT THEM A SEPARATE HOMELAND AND THE U.S. DOES NOT WITHDRAW SUPPORT FOR ISRAEL.

While the Abu Sayyaf had always made vague non-monetary demands, it was the first time it made such a grandiose condition and it has been interpreted as a confirmation of Bin Laden’s supposed financial support. **[H: NOTE THE JOURNALISTIC PHRASING TO COVER THE LIE.]**

THE INTELLIGENCE REPORT WAS ALSO DATED A DAY BEFORE BIAZON BARED INFORMATION THAT ABU SAYYAF BANDITS ARE AGAIN TRAINING WITH THE TALIBAN CLIQUE OF AFGHANISTAN.

The Philippines does not recognize the Taliban government nor does it have diplomatic ties with Afghanistan.

[H: I had intended to end the article copy at this point but it seems a great disservice to you of our teams to do so. This is the intended “Death” of a Nation—and you need to know how it works in the destroyer’s camp. The Abu Sayyaf, which means Bearer of the Sword, was founded by Abdurajak Janjalani, a Muslim scholar, or Ustadz, who was among the 1,000 Southeast Asian Muslims who were supposedly recruited by American intelligence operatives to help the Taliban in their guerrilla war of independence against the Soviet Union in the 1980s.

It was during this training that Janjalani and other recruits from the Philippines, Indonesia and Malaysia came into contact with Bin Laden’s group, which has since risen to power with the departure of the Soviet Union from Afghanistan.

The United States claims Bin Laden has financed several terrorist groups and activities and is believed to be hiding in Afghanistan under the Taliban government’s protection.

When the impoverished Janjalani returned from Afghanistan, he tried to build a religious base by espousing fundamentalist Muslim principles beside criminal activities, like the raid on Ipil town in Zamboanga del Sur in April 1995.

But after Janjalani was killed by government forces at Lamitan, Basilan on Dec. 18, 1998, the Abu Sayyaf shed its religious pretensions and openly pursued criminal activities in Mindanao and neighboring Malaysia.

According to Biazon, some 50 members of the Abu Sayyaf are again training with the Taliban under Bin Laden's auspices—a claim confirmed by Vice President and Foreign Affairs Secretary Teofisto Guingona Jr.

TALIBAN ALSO HELPING MILF?

Sources at the Department of Foreign Affairs (DFA) confirmed said the Taliban government is not only training Abu Sayyaf bandits but Moro Islamic Liberation Front (MILF) rebels as well.

As this developed, Guingona confirmed that former Ambassador to Thailand Reynaldo Arcilla was appointed member of a committee of experts that was tasked to study on how to implement sanctions against the Taliban government.

[H: ARE WE STILL TALKING ABOUT THE PHILIPPINES WHICH HAS NO RESOURCES FOR INTELLIGENCE SERVICES, ANY CONNECTION WITH THE TALIBAN GOVERNMENT OR RECOGNITION, EVEN, OF AFGHANISTAN? Guingona said the actions of the committee were among the steps taken by the UNITED NATIONS SECURITY COUNCIL against Afghanistan's terrorist activities.

Guingona said the UN Security council adopted in December last year a resolution calling for an arms embargo on Afghanistan, demanding the closure of the terrorist camps and the surrender of Bin Laden and his trial in the U.S. **[H: Hummnnn, trial in the U.S.? And we have yet to stop sophisticated arms from reaching "outback" jungles of Southern Mindanao, Philippines? Oh, barf, readers.]**

In order to implement the resolution, the UN created the committee of experts with Arcilla as one of the members.

One of the documents that were made available to the committee members was a Russian intelligence report that claimed foreign nationals—among them 50 Filipinos—were being trained in terrorist camps in Afghanistan.

Guingona said that if the reports are true, it would only confirm that "there is a design by some to cause further trouble in the South."

DFA sources claimed Taliban was the only government that supported the MILF's plan to create a separate Islamist state in Mindanao.

But the sources said most of the foreign assistance to the MILF was coursed through non-government organizations (NGOs) from foreign countries.

"What is established certainly is that there is a flow of foreign assistance to the MILF," the source said. "Most of them are coursed through the NGOs. We can't really say whether a government is involved except for the Taliban."

The source also said Pakistan and Libya also have NGOs that support the MILF through various forms of assistance.

UNREST: AN ACCIDENT WAITING TO HAPPEN

It almost seems that the tragic events of the last two weeks had to happen. The conditions that gave rise to the demonstrations and their inevitable conclusion have been building for years and will remain long after the inquiries are completed and we hear the true story about the unnecessary deaths of the students.

The simple fact is that development in PNG has come to a standstill and population has not, so there are more and more people chasing fewer and fewer jobs with the result that they are becoming more and more frustrated and angry.

The reasons for people moving to towns and cities are many. Some move because they think that the opportunities for employment are better, many because they know that they can get access to the basic health and education services easier than they can in their villages and homes.

Others just believe that no matter how hard it is to get a job in the city, life will be better than in the place they come from, others have no clear reason, they just come.

The population of PNG is now more than five million, it is growing at three percent per year which means that it will double every 23 years. This would put an incredible strain on any society even if its economy was booming and there were plenty of jobs available.

A fast population growth means that there is a higher proportion of young people in the population and this means that the economy has to provide more services, especially education, to this large group of young people.

It means that those who are in the age where they are producing goods and services have to make more

and work harder to support these young people.

Unfortunately it will also mean that there will be much greater pressure on farming land. The period between using the same piece of land for gardening has already been reduced in many places.

In the old days gardens would probably be left for periods of around 20-25 years or more before the same land was used again.

The cycle allowed the forest to regrow and the richness in the soil to be built up again.

These patterns and farming systems had been built up over thousands of years and were mostly in balance with Nature.

On the other hand for many reasons the population of PNG was not growing very quickly due to traditional methods of birth control, disease and death, lack of modern medicines and the types of houses people lived in which resulted in them inhaling smoke every night of their lives.

All of that has changed, modern medicine has increased the length of people's lives (not as much as in other Pacific countries) and more children are being born and surviving even though this figure is much worse than other developing countries.

This population growth has meant that people can no longer leave their land to rest and regain its richness, they have to use it to feed the increasing number of people in their families and clans. This means that the land does not produce as much food as it did before and more land has to be used to get the same amount of food.

It also means that there will be more erosion as the topsoil is washed away; and this will mean that the soil will not grow as much because most of the nutrients that feed the plants come from the topsoil. In other words it will be harder for people to feed themselves in the same way they have been used to; and many more will move to the cities and towns searching for jobs and opportunities for business.

What can we do to slow this down or keep people back in their villages? The first thing is to make life in the village at least as attractive as it is in the towns.

This means that we have to do more research into farming systems so that we can teach farmers how to look after their land better.

It means planting different crops that restore the "gris" to it, how to use all of the vegetable matter as compost rather than burning it and how to use better varieties of plants that produce more food from the same area.

We have to help them grow more cash crops and improve the methods they use to grow these crops so they get more money from the same area of land.

This means research and it means getting agricultural extension to the people again. It seems that the new provincial reforms have been even less effective than the old ones in getting extension to farmers; and many farmers have not seen an extension officer for more than five years. The other problems about cash cropping are that the roads and transport system are so bad that farmers often cannot get their produce to market. If they can, it costs so much for freight that they don't make any profit and soon stop producing.

Combined with all of these problems are law and order.

Farmers have their crops and gardens destroyed by tribal fighting; and they run a risk of losing their produce to raskols on the way to market. Buyers are afraid to venture into isolated areas because there is such a high chance they will be robbed. Village trade stores close because they are being

continually robbed so there are none of the things that town people take for granted available in the villages.

These are all powerful reasons why so many decide to try their luck in the cities.

We have to restore the roads to most villages and reduce the time they have to walk to reach a road, aid post or school.

We have to make sure that the aid posts have orderlies and enough medicines and the schools have teachers and education materials. In other words we have to guarantee that the rural people have access to the same services that their city cousins have.

Even if we do all of these things, it is unlikely that we will stop the flow of people to the cities. Nowhere else in the world have governments been able to prevent this movement. It is exactly the same in the developed world as it is in the poorer countries.

Australia has gone from a country in which around half the people lived in the country to about 10 percent today. More and more small towns are being deserted as people crowd into the cities especially on the east coast. That means that we have to look for new solutions to the problem. This will be hard; and for many people it will be impossible to understand the pace of change taking place. They will become confused and angry as their land is squatted on, the competition for jobs increases and the services in the towns and cities strain to cope with the rate of growth.

The number of people seeking employment will increase; and many will turn to crime.

DR. THEO LEVANTIS, AN AUSTRALIAN ACADEMIC WHO HAS DONE A LOT OF WORK IN PNG HAS ESTIMATED THAT MORE THAN 20 PERCENT OF ALL PORT MORESBY DWELLERS DEPEND ON CRIME FOR THEIR DAILY LIVING. Hard as it will be for many people, especially the old, PNG will have to adapt to these changes—or conditions will get steadily worse; and we can expect many more riots and demonstrations by people who have little hope and who live very unsatisfactory and often unpleasant lives.

[H: Does this seem somewhat difficult to swallow, especially the crime statistics? Well, there is a portion of an even more "unfortunate" country where the people live 100% off crime. Everybody who needs takes whatever from anybody who has. Someday, readers, you will be able to name those countries, i.e., the U.S., et al. It is often better recognized as "politics".]

The most elementary of these changes is the need to find a way that frees up land for use by traditional owners and potential developers. The systems are already available to do this. What is needed is for traditional landowners to demand whatever assistance they need to be able to formalise agreements and create more lease and leaseback systems that benefit everyone and prevent the loss of the all-important sense of ownership.

We have to create an attractive investment climate so that both PNG investors and overseas investors want to come to PNG. We have to prevent any more ill treatment of investors like DScan in Kokopo where a genuine investor has decided to leave PNG because no one can sort out their problems in finding a resource they can use to manufacture their product.

Papua New Guineans have to embrace the modern world and demand the right to carry on business and find employment.

Traditional ways of living were not designed to cope with the problems of large towns and cities; and the

movement to the cities is not going to stop.

The other thing that has to change is the massive corruption in our system. It is totally unrealistic to expect that the people in general will have any respect for property and life if they see their leaders continuing to steal and be paid massive amounts of money by the state. **People continually wonder why small criminals who steal to stay alive are sent to jail while those who steal millions walk the streets and continue to hold high office.**

This has filtered down to the ordinary man in the street; and he or she no longer has any respect for property because they believe that most of it has been obtained illegally.

Naturally people are angry about corruption; and this anger is likely to erupt into violence at any time. The time for ordinary Papua New Guineans to have an impact on these problems is the elections.

The choices are between more politicians who will try to get votes by bribery and promises to small numbers of friends and political parties and candidates who have some answers to these very difficult and complex problems.

If we do not elect leaders who see the need for change and have some idea how that change can be made, we can expect to have many more people dead on the streets in the future.

[H: Please refer to prior information and remember that there is a standing demand before the Prime Minister of PNG for a price to be paid for the deaths of students in the recent major uprisings where it was found the police were at fault.]

OMBUDSMAN SUPPORTS COMMISSION OF INQUIRY

The Ombudsman Commission has written to the Prime Minister, Sir Mekere Morauta, in relation to last week's unrest in the National Capital District, supporting the proposed establishment of a commission of inquiry.

But it has also cautioned the Government that the issue of compensation should be handled “with extreme care”.

Chief Ombudsman Ila Geno said in a statement yesterday that he had notified Sir Mekere that the matter was within the jurisdiction of the Ombudsman Commission because the conduct alleged to be wrong was the excessive use of force by a government body, the police force.

Mr. Geno said that an investigation could start on a complaint (for example, by people involved in the demonstration or by relatives of the deceased or injured) or on the Commission's own initiative.

The Ombudsman Commission said it has wide investigative powers at its disposal and is widely regarded as an independent apolitical and impartial body.

Mr. Geno said the Ombudsman could prepare a detailed report, containing findings and recommendations and present its report to the Parliament. **[H: And just how long do you suspect it would take to do such a report? Perhaps until after the people are all dead and gone?]**

“Another disadvantage is that an Ombudsman Commission inquiry would not be public. The hearing of evidence would have to be conducted in private as required by the Organic Law,” he said. **[H: You know, as are the**

secret Grand Jury hearings in the U.S. where the “defendant” or “accused” has no ability to attend said sessions or to be represented by counsel—a total “railroad” situation by those in prosecutorial power.]

He pointed out to the Prime Minister that while the matter was clearly within the ambit of the Commission, it would prefer that some other independent and impartial body—and one that is adequately resourced—undertakes the investigation. **[H: Resourced? There are not even food funds much the less enough money “in the world” to properly resource such committees.]**

Mr. Geno said the Ombudsman Commission supports the reported proposal to set up a commission of inquiry. **[H: By definition isn't the office of the Ombudsman a “commission of inquiry”? In addition, what's to inquire about? The students told exactly what they were about—non-privatization to retain PNG's sovereignty, including the assets in their Central Bank. What is not to understand?]**

“At the moment, while tensions and frustrations are still at a high level, it is important the people aggrieved by what has happened have a public and controlled forum to vent their feelings, and that this be made available as soon as possible.”

Mr. Geno said that the death of people involved in a public demonstration was a matter of great historical significance to PNG and there were many questions that needed to be raised and answered. The best way to do that was by a full, fair and open public inquiry, he added.

He cautioned that the issue of compensation be handled with extreme care. ... “It is very important that you and the Government be fully and properly advised as to the legality and propriety of meeting such demands.

“The Government may be setting a very dangerous precedent by meeting such demands at this time, when the facts surrounding the deaths are still unclear.

“There may be implications under the Leadership Code for leaders who agree to pay compensation without the benefit of proper advice or without the payments being authorized under the Public Finances (Management) Act.”

So, readers, what is your Confusion Fog-Factor Quotient for this morning? Moreover, what kind of settlement, if any, do you think might come out of this kind of shift-foot dancing?

“EMPOWER THE POOR
TO FIGHT NATION’S POVERTY”

July 5th, 2001

TO: PEOPLE OF PAPUA NEW GUINEA

Obviously, to uplift our poor is not just a matter of instituting pro-poor and livelihood programs. A person need not be an Economist to understand the anatomy of poverty and arrive at a quick solution. Just like a family, a nation PNG through its Government (as head of family) needs to take the appropriate steps to avoid penury, and what are these steps?

FIRST, the family must generate income and provide for future needs by having its members engaged in income-earning activities, by having just enough number of children that can be supported by the family finance and by providing savings and insurance. The nation, in turn needs to attain “PRODUCTIVITY” and “ECONOMIC” progress by promoting agriculture, industrial and services enterprises that are compatible with the nation’s rich natural Resources and human resources. The family planning needs to be liberalized to avoid overburdening the nation’s infrastructure, educational, social and other facilities. Savings consciousness needs to be fostered and financial and political insurance schemes must be entered into to cover unforeseen development.

SECOND, the family must spend only within its incomes, with priority given to food, shelter, clothing and health. Gambling and other vices must be avoided as well as ostentation and foolish pride. In the same manner, the country should avoid “DEFICIT”. If foreign loans are to be made, these should be used for productive enterprises so as to avoid crippling debts and debilitating interests. In Papua New Guinea, the national Government’s inefficiency and waste, graft and corruption and massive interest payments practically throw away approximately 60% of Government revenues.

THIRD, the family needs to develop its members properly through appropriate education and training in preparation not only to be productive members of society, but more to be disciplined and moral persons, steeped in family virtues and work ethics. Along the same vein, the government needs to upgrade the education and practical training of its people, especially the youths, by stressing moral development and by deregulating private education. The quality of public education should be given priority over political considerations, i.e., over political influences in its operation and maintenance and in the pricing of tuition and other schools fees.

FOURTH, a family has to safeguard its members’ health through hygiene maintenance, nourishing food (fruits and vegetables), regular habits and exercise, and by shunning cigarettes, alcohol, drugs, illicit sex and other vices.

On this score, the Government can maintain national health by providing adequate funds and effective controls for the health and medical (hospitals, disease preventing, etc.) sectors as well as for the conservation of the environment (forest, rivers, seas, air, etc.); in addition, discipline needs to be stressed to logging operations, gold mining, oil drilling and lastly, garbage nationwide should be recycled.

FIFTH, a struggling family in disarray can hardly

hope to rise from poverty; cooperation, harmony and stability are needed in the family. Splits, conflict, separations are certain to make life miserable.

In the same way, a nation that is bedeviled by insurgencies, peace and order problems and injustice and thus is suffering from the resultant massive fund allocations to resolve such problems, can hardly hope to help the poor rise from poverty. If there is no National Unity among its Leaders and its various sectors with everyone hating one another to practically manifest political chaos, the poor home for the mass of its people are the results.

LASTLY, a family needs to uphold moral and ethical standards and virtues as well as to stress civil consciousness among its members to achieve permanent and sustained well being.

Wealth obtained through illicit or immoral means cannot be a source of wholesome happiness. It can even lead to a national chaos. Thus, in our country, where Spiritual and ethical virtues are sometimes ignored despite the various religions’ exhortations, poverty and misery are certain to abound.

The government (as head of family) should discourage the reign of greed, the tolerance of dishonesty. In summary, a family and the mass of people of the nation that are suffering from the following factors, all or partly, will suffer poverty and will need to reverse such deficiencies:

1. Insufficient Income
2. Overspending
3. Inadequate Educational and Moral Development
4. Poor health
5. Disharmony & Instability
6. Unsatisfactory Ethical & Spiritual Values

POVERTY & UNEMPLOYMENT:

These two obstacles to PNG’s Economic progress are the outcome of “LOW PRODUCTIVITY”. This arises when Government engages in private enterprises by providing subsidies to unprofitable business, wastes funds on politically-oriented livelihood projects, promulgates policies that result in unproductive labor and unwarranted coddling of squatters and supposedly deprived persons. These practices must be “TOTALLY AVOIDED”. It’s the ripe time to turn to constructing “DOWNSTREAM PROCESSING PLANTS” for all rich valuable mineral resources, food products to create jobs and let’s stop allowing “RAW” resources out of the country where the nation earns very, very little cash revenue for its exports.

IMF/WB/ADB/NWO:

IMF/WB offer virtually “NO” substantive public documentation of its hidden decisions except for a few pages in press releases that are shorn of its technical details needed for serious professional evaluation of its progress; so if they can do that, PNG will be lucky with the GAIA COLLATERAL, but we have to kick-start the program quickly before it is too late.

“LET US ALWAYS THINK AS PAPUA NEW GUINEANS, FOR THE GOOD OF OUR MOTHERLAND, PNG. THE LAND IS OURS, AND WE HAVE ALL THE RIGHTS TO MAKE FIRM DECISIONS WHILE STANDING FIRM TO SAFEGUARD THE WELFARE OF OUR PEOPLE, BUSINESSES AND THE GOVERNMENT OF TODAY AND INTO YEAR 2001 AND BEYOND.

“OUR POPULATION WILL GROW AS YEARS GO BY; REMEMBER TO NOT ALLOW OTHERS TO DWELL IN IT OR WE WILL BE THE SLAVES IN OUR MOTHERLAND IF WE DON’T CAREFULLY PLAN AND FOCUS ON THE HIDDEN HAZARDS AND RISKS THAT WILL AFFECT OUR SOCIETY, BUSINESSES AND IMPORTANTLY THE PEOPLE AND OUR MOTHERLAND, PAPUA NEW GUINEA.”

THE WORLD’S GREATEST ENEMY:

In the last four years many economic theories are in doubt as to why country or even private individuals come to such poor economic states in their lives. For the most part, the enemy is “poverty” and ironically, the very essence of its cause also spells its relief, “Money”.

It is quite an intriguing fact how one fights poverty; some, with exasperation would exclaim, “get the job”, as if that was the easiest thing to do, or the most available to all. More helpful would be that “MORE PEOPLE SHOULD CREATE POSSIBILITIES” for jobs for other people. The spirit is willing, but alas, the “flesh” is weak, there being a need for the presence of money to create jobs in order to create money.

When we look closer at the television, read newspapers, or walking or driving past the squatters, the fight necessarily involves all of us; those who have much, those who have little in our daily lives, in frivolities that we can do without, in sharing, not necessarily in exact monetary amounts the bounties we have both as individuals and as nations, with those who have not. Some people may think the idea too radical or too idealistic and would make a wild suggestion, “COME ON AND GET TO THE POINT.” We are born once and live in a real world, and we need solutions that come down to Kina and toea. I agree, but if we fight as one, efforts shall be priceless and in the end, monetary contributions with happiness derived in the process and efforts in easing poverty. It is a truth that from divine examples, we learn solutions to Earth sovereignty’s insoluble problems. Many earthly problems can be solved. That goes back to the people and Governments of individual Nations. Right now the worldly “poverty” is a sad disease that needs to be solved and cured quickly. The Government can legislate programs to benefit the poor, sometimes it works—sometimes it does not. Permanence of such a state of solution lies in the integrity of programs to attack root causes of poverty by giving solutions that are more far reaching than “table to tummy” economy, with permanent benefits, and again, more philosophical and substantial to work-on and change the future of PNG.

Today, in a fast changing world with the increase in population and resulting diminishing reserves of the economic theories and solutions stated by economists, there are good and educated solutions which are results of study and proven logic. In a fight against poverty, whether we fight as individuals or as a Nation, the same is also true. We have to be armed with a steadfast armor of self-sacrifice. If the Nation wishes to request, His Excellency, Sir Mekere Morauta, the Prime Minister of Papua New Guinea, Ministers of the Parliament, Provincial Governor’s Council and Local-level Government should quickly “focus” on these efforts in fighting the war against poverty and its wider and broader significance and deeper effects that have long depressed our country.

People should understand that the economy is only part of a wider scope, and is not an end in itself. It is simply a means to a greater end, one that is enjoyed not only by the rich, but should be by everyone. Another very important point is the infusion of Human Rights—and Business is possible by making the work-place safer for all. Giving what is basically due to the employees such as fair wages that allow decent living, a safe and healthier working environment, holidays with pay, an equal chance at promotion and developing one’s skills among others, does not necessarily mean that the company is upholding human rights, because people can adapt to this mode of environment, thinking and living through education. Education is not imposing one’s own beliefs and views onto the other, or moralizing; instead, it is a process of growth

and a journey of understanding and considered action, nor does it stop at just knowing and learning how something can work. In PNG poverty remains the greatest abuse to human rights, and is a problem that can be solved very quickly.

One of the other important matters to seriously consider is the unrelenting arithmetic of population growth which is once again receiving the attention of Environmental and government Bureaucrats Worldwide. Two years ago (1999), some 150 million people were added to the World Population, bringing the total close to six (6) Billion people. The nation of Africa, where per capita incomes are now lower than they were at the start of the 1980s, continues to be the fastest growing continent. Over all, the number of Africans is increasing at three (3) percent per year. So the predicted figure of six-point-seven (6.7) Billion is now likely to be reached in year 2005 and by year 2030, if the annual growth rate remains at the current level of 1.7%, the world population could reach 10.7 Billion. If we glance over the same year (2030) the population of PNG may be around (8) million, and if PNG is to continue to BORROW here and there and pay hefty annual interest for the FOREIGN LOANS, it will continue to "BORROW" forever. So, let us put our WILL together and quickly find the way out. HOW? Stated below is the solution for PNG:

PROBLEM #1. Gold-based currency is old-fashioned, awkward, difficult to manage and transport, and on and on it goes. **SOLUTION:** WRONG, what is wrong with gold-based currency is that it will not INFLATE to suit Bankers (limiting their profits) and Politicians (removing a significant source of hidden tax upon the people as well as imposing an unyielding discipline on certain kinds of Government spending).

What is NOT WRONG with the Gold-based currency is that no inflation allows Bankers to make a profit at very low (less than 4%) interest rates which allows more people to BUY DECENT HOMES, SMALL BUSINESSES TO FLOURISH, TAX RATES TO BE REDUCED and a healthier environment for all commerce. And the poor benefit even more than the rich. Gold-based currency is already INTERNATIONAL and is acceptable (take a look at the Swiss) directly in International trade without the losses to FOREIGN EXCHANGE imposed by the International Bankers. When all currencies (in the region or International) are Gold-based, all of those currencies become freely exchangeable and cannot be MANIPULATED.

PROBLEM #2. The amount of new currency issued by the Central Bank of PNG must be strictly limited to increases in the nation's PRODUCTIVITY. **SOLUTION:** Why are such FALSEHOODS taught in the Schools of Economics and Political Science? To cause the people of the poor/or underdeveloped Nations like Papua New Guinea to BORROW from the Richer Nations, thus exporting their Sweat, Ideas, Talents and Substance. THIS IS SIMPLY A SMARTER WAY OF COLONIZING THE POOR COUNTRIES. PNG IS NOT POOR; IT IS BLESSED WITH RICH AND VALUABLE RESOURCES BUT NEEDS MONEY TO ESTABLISH "DOWNSTREAM PROCESSING PLANTS" IN ORDER TO CREATE MORE JOB OPPORTUNITIES AND SHOULD ONLY EXPORT FINISHED PRODUCTS AND NOT RAW RESOURCES ANY LONGER.

A far better way is that PNG become better informed of alternatives so that it can do all of its yearly development projects funding "internally", thus re-circulating and recycling the interest, ideas, sweat, substance and talents within the country. No more—zero—money should ever again be BORROWED from offshore for any value-enhancing of the country's projects, or to operation of the National Government. With a Gold-Based currency wherein at least 40% of all new currency issued is used to purchase GOLD, the local currency (KINA) will hold,

actually gain, its value, no matter how much is issued.

PROBLEM #3. The IMF/WB are said to be our friends. **SOLUTION:** Let us NOT be naive. They are the "Collection Agents" of International Bankers. If you were a pure politician having NO REAL INTEREST in the people you represent in the national parliament, you would find their rationale to be quite palatable; if not, you will be pleased to learn that with our assistance you will soon have the money with which to pay off and bid them farewell. Please be advised that their whole thrust is to drive PNG deeper into the DEBT TRAP; even now, how different are you from slaves?

All of the PROFITS and the money needed to build our ECONOMY are SIPHONED OFF to them in HIGH INTEREST payments. The more we grovel to foreigners for funds, the more we have NO CONTROL OF THE VALUE OF THE KINA and in fact we are disciplined daily by those who do. Should we live in terror every day that their RATING AGENCIES will downgrade our credit rating and make our borrowing more expensive?

WE HAVE TO DO SOMETHING DIFFERENT

"WE CANNOT BORROW OURSELVES OUT OF FOREIGN DEBT." How can Global Alliance Investment Association (GAIA) help? By making it possible for PNG to return to the use of Gold-based currency. That will get our motherland, PNG, triple ("AAA") credit rating, which the country will no longer need since it will never again need to BORROW even one kina from abroad. It stabilizes the value of the kina which can then be used as International Currency. It will be able to pay off the OUTSTANDING FOREIGN LOANS. The Central Bank of PNG will be enabled to issue all of the funds necessary for all of the National-Value-enhancing projects that we have enough manpower to accomplish. Labor will grow scarce and wages will go up. It will look like INFLATION, BUT IT WILL NOT BE because of a weakening of the kina, it will be in response to the increasing value of the country which can, nay, **must** be matched by issuance of new money which will not only strengthen in value as the Gold reserves grow both physically (in the vault) and in higher prices (per ounce) soon.

But what of foreign trade, we may ask? Why would we need it? Not for foreign exchange. With Gold-based currency and no inflation along with plenty of Project Money, the PNG economy will soon be a major NET EXPORTER with Downstream Processing Plants established in every region to create more jobs for the unemployed and only FINISHED PRODUCTS ARE FOR EXPORT which also applies to food products, minerals, petroleum, natural gas, etc. In addition, the Nations with which we trade will soon far prefer our Gold-based currency.

HOW DOES IT WORK?

It is not complicated, because each issuance of GAIA Deeds is a small portion of the Accumulated Interest on:

1. Debt of the U.S. Treasury
2. Guaranteed by the U.S. Federal Reserve System and its owners
3. It is payable in GOLD

The only known collateral of higher or equal quality is Physical Gold. It is used as a BANKING RESERVE just as would be any other U.S. Treasury Debt. Using it as a RESERVE, the Central Bank of PNG can issue new currency and/or credit to purchase Gold to be brought to the vault of the Central Bank to there be used as further RESERVES upon which to issue Gold-based currency, or Gold-based Lines of Credit to finance Medium/or Multi-Million Kina Projects. As long as Gold is purchased first, there will be no LOSS in the value of the kina. In fact it will grow in value as compared to NON-GOLD-BASED currencies. If you follow the Transaction closely, you will see that there is virtually

"zero cost" to the country or the Central Bank of PNG, yet the amount of Gold acquired in this way can be almost without limit. All that is needed is for the Prime Minister, the Governor of the Central Bank, Finance and Treasury Department, Bankers Association of PNG, and finally, the National Executive Council (NEC) to accept the GAIA Deed as Reserves on the same basis as other U.S. Treasury Debt.

The transaction can be structured as a joint venture partnership between GAIA and the Central Bank or more likely a project proponent. In any event it will be a 50/50 partnership, 50% of the Gold purchased to be held in the funding bank, whether Central Bank or Commercial bank, to support the funding of the project or Gold-backed currency issued by the Central Bank. GAIA's portion can then be made available as a reserve to the funding bank through a simple "K100" per year lease fee which allows GAIA to retain its interest in the gain of the price of Gold, again with no cost to PNG's banking system. **No more than 10% of the Deed amount will be taken offshore as a loan or line of credit by GAIA. The balance will be left "on-shore" in PNG to strengthen the Country's Banking System. GAIA is offering assistance while asking very little.** Granted that there may be varying degrees of mutual involvement, the more closely we work together, the more effective we will be at ALLEVIATING THE POVERTY of our people. We will point out that all of the Gold is held in the country's Central Bank and/or Commercial Banks so there is no danger of losing the real value to any foreign entity.

We recognize that PNG has a Board of Investments, Bankers Association and perhaps other legal institutions that will want to understand our offer. We will do what we can to assist. **We are quite sure that, without one dissent, they will vote to remove the yoke of the IMF/WB and its companions, once they understand that it can be done with no loss at all to our beloved motherland, Papua New Guinea.**

WHEN LIFE IS HEAVY BUT YOU CANNOT STOP

Hatonn—We take our journey through life experiences and the testing comes when the heart becomes heavy, the load seems too much, and the task appears impossible. Ah, in many ways, my students, this is an EVERY day occurrence if only you knew the infinite things of other lives which make the “whole” of even your own experience.

You must, in the instances of impacting happenstance, take a deep breath, consider options—and let go. It is most often NOT YOUR BUSINESS WHICH BRINGS DISCONTENT. OTHERS MUST WORK OUT THEIR OWN DIRECTIONS, ACTIONS, INTENTS AND, YES, FULFILLMENT.

A nation is only made up of INDIVIDUALS doing whatever they are doing, thinking whatever they are thinking (manipulated or otherwise) and generally able to focus on the most topical focus of any day or date.

When the heart is heavy, however, STOP, LOOK, AND LISTEN—WITHIN.

IF YOU CAN FIND JOY WITHIN YOU,
YOU HAVE ALL THE FULFILLMENT
YOU CAN EVER HAVE,
BUT IT MUST BE YOURS—
NOT DEFINED IN A BOOK—
YOURS!

I have said “JOY”, not all things you “want” or think you need to make your way satisfactory in accomplishment as set forth on your “agenda”. Note how often “your” schedule is ACTUALLY a fitting of wishes of OTHERS, which are not necessarily impacting on YOU unless you allow it to be so.

Know, please, that as you accept responsibilities and others come forth to share and that sharing is accepted—the program itself diverts itself into “another’s” agenda. We have witnessed this over and over again with our projects and programs. When something seemingly isn’t happening quickly enough on “now their” agenda, the old is tossed out, buried if possible, and negative activities begin. NO, I WILL NOT ALLOW THAT TO HAPPEN AGAIN TO OUR PHOENIX PROJECT. Man must help himself, do that which is HIS TO DO, but my team will not withdraw in order that those who think they might know better ways to accomplish something, actually destroy progress made.

To truly have peace and joy within—certainly, you have to HAVE same within. Therefore, to simply announce either is not an answer, although it is very much the way to check it out as to status at present, begin to change your own attitude about all things as they confront you and, yes, allow the positive impacts to be all that are harbored within.

This in no way means you simply “discard” the negative impacts or perceptions—but confront them for what they are: negative possibilities—then see what positive aspects you can bring to your conscious realization.

Why must you start and end with SELF?

Because it is far more difficult to make peace with yourself than it is with anything else or anyone else. Life is interesting, readers, for you can live at odds with other

people, but you cannot live well at odds with yourself.

This is what is meant by “looking within” for the answer to all things. It does not mean that you go within and make conclusions when you are dealing with lies in the first place or have no truth of what you are discerning.

Let us say your neighbor comes rushing to you and says John Doe is coming now to kill you. Perhaps you know John and perhaps not; however, you now are informed that John has a gun (for instance) and is after you. What would you do? Well, you would likely first call in the emergency police and then get yourself armed.

Let us say that John now shows up and you are so afraid that you shoot John and he dies before your eyes. Now, what if there was no gun at all—only gossip. What if there was a gun but John was bringing it to you so that you would have some protection against marauders—like your informant neighbor?

This is more drastic a circumstance than you usually face from gossip but it suffices. YOU DID NOT HAVE ENOUGH INFORMATION (DATA IN) TO MAKE EVEN AN INNER DECISION OR CONCLUSION. BAD DATA IN—BAD DATA OUT!

IT IS STUPID, INDEED, TO SAY “GO WITHIN” TO GET ALL YOUR ANSWERS. YOU MAY WELL NEED TO GO WITHIN—BUT IT WILL ONLY RESULT IN “YOUR OWN” PERCEPTIONS AT BEST—BASED ON INFORMATION, MISINFORMATION, DISINFORMATION—OR FRANKLY LIES IN ANY EVENT. FIND OUT TRUTH BEFORE YOU END UP DOING ABSOLUTELY RIDICULOUS REACTIONS TO ANYTHING. WHEN YOU ARE INFORMED AND KNOW, THEN YOU CAN ACT. THIS IS WHY TRUTH WILL NOT SET YOU FREE, BUT FIRST HAVE TRUTH AND THEN IT IS THROUGH ACTION IN THAT TRUTH WHICH CONCLUDES IN FREEDOM.

With the loss of our talented wood manufacturers to competitors in China, this giant Asian country, with its cheaper but higher-quality products, is going to gobble up the traditional markets which the Philippines used to supply and earn big dollars from. Remember how Thailand was able to beat us in the bagoong and patis manufacturing business? The Thais pirated Pinoys to teach them how to beat us in a field we used to excel in. How pathetic!

Janis talked to John earlier today and he sounded good except for being tired of hospital food. He had been doing laps (walking) in the Physical Therapy Dept.—150 feet without stopping, a short rest, and then another 150 feet. Thursday the 5th he was supposed to go to the Skilled Care Unit but was found to have a fever and was not allowed to move. They did a CAT scan of his abdomen Friday night and found a pocket of fluid that they decided to drain. John thought it contained some pus—and so now he has another drainage bag. The wound they are packing has two holes with a sinus connection between them. He had been feeling weaker since the fever but today he felt better.

We talked to Jean later this evening and she said he was moved today to the Skills Care Unit where his physical therapy will be intensified. They expect him to be there for 1-2 more weeks and then go home. They are doing another CAT scan Monday to see if there are any remaining problems. Jean said he had an infected IV line in his neck (as it had been in so long) and he's now taking antibiotics.

Nursing care took a turn for the worse earlier this week when John had to wait for 2 hours for a nurse to come after he called repeatedly. Jean also had to complain because they were having John change his colostomy bag and then not washing his hands afterward—also not washing his hands before he eats. This is a very frustrating time due to this setback but overall, progress is being made. Jean is carrying a big responsibility in his care and doing a great job of it—but sounded tired tonight. Hi Folks,

Jan and I are up in the mountains in Summit County this weekend for a symposium for nurse practitioners at the Keystone Resort that Jan has to attend to keep up her accreditation for her license. While she's in class, I'm on vacation so I took some time this AM to call John—and does he sound good! I hadn't spoken with him myself since just after he got the tubes out of his mouth, so naturally he sounded a lot different—more like himself—today. He feels that a major factor with him is his energy level. Mentally he feels like he could walk out of the hospital tomorrow morning—until he tries to get out of bed and is then snapped back to reality. But he's making definite improvements. While some dead skin will have to be cut away from his open stomach wound, the size of the holes have reduced by half. Originally, the top wound was as big as a quarter and the lower one was as big as a half dollar. There were 50 staples in all his incisions.

John's guessing that he might get to go home sometime next week but, of course, it's up to the doctors. He passed his Occupational Therapy class three days ago. That's where they train him how to get dressed, shower, change the colostomy bag, etc. I asked him if they gave him a certificate or plaque

for passing and he laughed saying he didn't think so. After a couple months at home—and based on his progress—they will offer to remove the colostomy bag if John's up for another surgery.

There was a wheelchair ride a couple days ago back to ICU to visit with the people that worked so hard to save his life. John said they were a miracle—they said he was a miracle—and it sounded like everybody got pretty emotional and rightfully so.

John was eating lunch as I finished talking to him—egg salad, chicken noodle soup, Jell-O, and Boost, a protein drink. He had pizza last night but has been through the hospital menu a number of times now. However, he misses their dog, Duncan, and surely would like to get home. So John's exit is the next hurdle—keep the thoughts and prayers coming.

All for now—I have to go pick Janis up at her classes.

THE LONG VIEW: THAT OLD-TIME RELIGION

The setting Sun was shining warmly, but it wasn't a very good omen as I strolled one evening this week into the so-called "bugs' bash", the once-famous, but these days sadly under-attended, midsummer barbecue of the British United Gold Society. It is my own fault: If I am foolish enough to attend esoteric events, I am bound to run the risk of bumping into my old adversary Fringe Freddie.

Sure enough, there he was, glass of champagne in hand, advancing towards me. I looked around desperately, but was hemmed in by the promotional stall for a gold-mining stocks Website on one side and the PR advisers of the World Gold Council on the other. He wore a yellow metal badge proclaiming: "Bring back the gold standard." There was no escape.

"Are you still punting on gold, Freddie?" I opened provocatively. "It must be 18 months since we last met, and you don't normally back losers for that length of time. Gold, after all, came within a whisker of a 22-year low when it sank to \$256 an ounce in April, and it has not recovered very much."

Freddie grinned, revealing a new gold tooth. "Like nearly all the rest, you've been deceived by the dollar propagandists, old boy," he responded. "Over the past 18 months the bullion price has RISEN against the yen and the euro, not to mention the pound sterling. Oh, and

it's easily beaten the main stock market indices, too.

"Not bad, eh? And it's only the beginning. Several attempts at an upside breakout, the latest of which took the price up 11 percent, have been smothered by intervention. **But the anti-gold conspiracy organised by the U.S. government is running out of time and metal. A big price upsurge, maybe a doubling, is just around the corner.** Just look at the mining stocks: Your own FT Gold Mines Index is up 25 percent since April."

I replied that I had heard the gold conspiracy stories time and time again. But the gold bugs were trying to create a mystery where there wasn't one. Mining output was rising steadily, thanks to improvements in technology, and the price was being driven down. Gold was a relic that was simply out of date.

No rational argument has any chance against a fervent conspiracy theorist, however. Freddie's eyes began to gleam, in a manner normally triggered by a major crop failure and the mouthwatering prospect of a global famine. The immediate object of his attention, though, was the yellow metal.

"The signs are all there, old chap," he hissed. **"Official lending of gold by the central banks has been much more than the 5,000 tonnes they admit. The recent jump in the gold lease rate shows that some of the lending central banks have backed off, because they worry about running out of bullion. Meanwhile, the Americans are desperately printing dollars to stop their economy diving into a recession. Gold is the only place left to go."**

The gold "carry trade", the manoeuvre in which big banks have borrowed gold at very low lease rates and invested the proceeds in bonds, is making a big running profit. But the profit is destroyed, and could be turned into a massive loss, if the bullion price rises sharply. Hence the allegations of price manipulation.

But I pointed out that a professor at the London Business School, Anthony Neuberger, was hired by the World Gold Council to investigate whether activity in derivatives was seriously depressing the gold price. Last month he reported that the effect was small. An effective extra supply of 4,000 tonnes may have been generated during the 1990s, but that compared with an existing global hoard of some 140,000 tonnes.

"Be honest," retorted Freddie. "You've only read the spin doctors' press release and not the full 120-page report. The professor was required to accept the bogus official statistics as accurate. Even so, he has confirmed that the lending market is very fragile, and horribly vulnerable to a serious squeeze. Watch this space."

Instead I looked optimistically towards the buffet table, where the menu was advertised as ingots of golden trout and 22-carrot salad. But the charcoal barbecues seemed to be causing problems, so there was no easy escape from the party pest.

"All right, I admit there are some interesting parallels with what happened to the London Gold Pool in the late 1960s," I said. "It was a previous exercise in U.S. Treasury-inspired gold-market rigging, to thwart gold bugs inspired at the time by General de Gaulle. After the policy became too expensive and was abandoned, the bullion price went from \$35 to, in the end, \$800. But that was in the context of Vietnam War spending, an oil-price shock and an inflationary flare-up."

Freddie's gold tooth glistened again in the evening Sun. "Did you mention the oil price?" he chortled. "What a coincidence. And American consumers are spending on fighting Ho Chi Minh. Now the U.S. government will have to admit defeat again.

"It will all come right out into the open soon

when the U.S. Treasury is forced to respond to the court case being brought by the Gold Anti-Trust Action (GATA) committee, the group of American gold defenders organised from Texas. The Bush regime will cut its losses and regard it as an opportunity to repudiate what the Treasury did in pursuing the strong-dollar policy under Rubin and Summers.”

I couldn't, I said, imagine that GATA would get anywhere through the courts. But it was significant that the U.S. Business Roundtable, representing manufacturing industry in the grip of a nasty profits collapse, was pressing this week for a more competitive dollar. Currency strength was a useful weapon to head off domestic inflation during the great boom; in contrast, as the global economy took a dive, we now seemed to be heading straight for beggar-my-neighbour territory.

But I said I was sorry that I couldn't pursue the argument any further, because I needed to check out the details of the gold mining stocks Website. When you are trapped by Freddie, any excuse will do.

His voice pursued me, nevertheless, his phrases punctuated by that familiar braying laugh. “Currency turmoil... bullion banks melted down... hedge books in chaos.” It may have been my imagination, but gold fever has an emotional connection with old-time religion, and I'm sure I heard him tail off with: “The end is nigh!”

FDIC—YOUR DOLLARS ARE SAFE!

Most of us have insurance. Auto insurance especially, since accidents do happen, and one can never predict when some nutty, pimple-faced, testosterone-soaked, teenage male will attempt to test GM's differential gears with his hopped-up V-8, and lose control of it. Most of us have hospitalization, some have life insurance, (I hope not whole life) and most of us have a homeowners policy, which covers fire, accidents, and broken pipes, among others. It is said that the insurance companies have assets the equivalent of 82% of the value of American properties. This is an impressive figure... to put it mildly. My claims on insurance in my entire life have been less than \$800, so they have made out fine on my account. I hope you have been as careful and lucky as have I!

Then there is the so-called “Social Security” system, installed by FDR and his Democrat Congress. (FDR is probably the worst president we have ever had, or if not, is at least on a level with LBJ and Abe Lincoln.) Social Insecurity is a better term for it, as it is nothing more than a fantastic Ponzi scheme. It is said that much of today's youth believes it will never receive a cent of the massive amounts of dollars extracted from their paychecks every week to fortify this boondoggle. I think they will get it as promised but, of course, perhaps in worthless greenbacks.

Actuaries determine, based on actuarial tables, how much you pay in premiums and if you get insurance at all. If there is a pretty good chance you will use the insurance, you probably won't be able to purchase any. This is why insurance companies are so wealthy. When

hurricanes blow Florida away, the losses for insurance companies are huge, and after paying legitimate claims, many refuse to insure Florida any longer. It's the same reason that teen-aged boys have a hard time getting their cars or themselves insured. There's just too much risk.

It's fun to go to the bank with a deposit, and look at the lovely, impressive, imprimated sign boasting that the bank has insurance with the FDIC (Federal Deposit Insurance Corp.) to the extent of \$100,000 on each account. It sort of gives you a sense of strength! A sense of security... and, well... just a happy feeling of permanence, and rock solidarity. Gee Dad, it's a Wurlitzer! Ain't life grand, knowing your dollars are safely tucked away in the vault—and that the FDIC will shoulder any chance of a financial meltdown, crooked bank officers, bad loans, or other mayhem? Really?

We have already looked at the private insurance companies and their assets, so we know that if we get burned, flooded, or in some way inconvenienced, we will be taken care of; but how about the FDIC? A few years ago, the FDIC had less than a nickel tucked away for each \$100 worth of insurance—and now it may be no more than a penny or two; non-copper pennies, of course. **Does it make you feel secure to know that your bank deposits are insured by an insurance company with a cent or two on deposit for each \$100 worth of insurance?** Not me, but then I never have any dollars in a bank other than “float” between checks and cash being deposited and withdrawn a few days later, when the checks are paid to another bank. A thousand or so maybe, but no savings accounts, CDs, or the like. When I get extra bucks, I immediately turn them into something tangible, like the old Mercedes I spoke about in a former piece—but mostly more gold and silver. Understand, gold and silver owe nothing. They don't have to pay up, or be insured, because they themselves are the value.

So, if the corner bank goes belly up, what happens to your deposits? They will be paid by the FDIC, of course. It happens a couple of times a week somewhere in America, and it is promptly paid. The FDIC hasn't had a run that taxes its reserves as the FSLIC (Federal Savings & Loan Insurance Corp.) did a few years ago, which broke it. But it still paid. The pressman pushed the “start” button, and the payments rolled off the presses. If there were ever a major dollar meltdown—and banks everywhere were insolvent—the same thing would happen, so your dollars are safe. As long as there are trees to cut, paper to make, and ink and presses available, you will be secure in your dollars. Oh, yes, I forgot to tell you: Since the dollar has lost most of its purchasing power anyway, what began as a \$3,000 FDIC insurance on your deposits, became \$10,000, was raised to \$40,000, and then to the current \$100,000. When a pack of cigarettes has gone from 13 cents to \$2.25, gasoline from 19 cents to \$2 a gallon, and homes in the same ratio, the “insurance” on your account had to be increased. It's a simple proof that dollars are a poor way to save! The FDIC is only a pseudo insurance company. It would fail any test of a legitimate insurance institution, as it has virtually no assets to back its insured. Like Social Security, any major claims would be paid via bookkeeping gimcracks and the printing press. All Social Security involuntary withdrawals from your paycheck are simply used to pay current bills—and there isn't a silver dime in the entire Social Security “trust fund”, as they like to call it. The FDIC has a few million dollars stashed away to satisfy the few bank failures that occur every month, but if a massive meltdown occurred, your deposits would be paid in bright, stiff, uncirculated bills, fresh off the presses.

And with the presses running night and day to pay your dollar deposits, their purchasing power would be vanishing like the Indian Monkey Boy, when an intelligent person with a camera tries to find him. A pack of Marlboros will eventually cost \$20. That sounds as silly as telling someone in 1955, when they were 13 cents, that eventually they would cost \$2.25. My Mom and Dad bought the 6-bedroom, 4-bath, 3-story, brick home in which I was raised in the northwest section of Washington D.C. for \$3500 in 1935. If you told them it would sell for 70 times that, 60 years later, they would have thought you to be balmy! When they bought their new 1940 Plymouth for \$660, they would have you committed if you told them that a new Plymouth would cost 30 times that 40 years later.

For you non-thinkers who keep saying, “My heavens Ermatrude, bread has gone up again,” STOP AND THINK. PRICES DON'T GO UP. DOLLARS GO DOWN. STOP SAVING IN DOLLARS! But don't worry about it if you do save in them, because the NUMBER of dollars is secure. It's the PURCHASING POWER of them that is as secure as a noise ordinance on the 4th of July. Yes, Ermatrude, your savings account is secure, and the dollars will be paid if the bank goes under. Yes, Hortense, the FDIC is there to make your dollars secure from bank shenanigans and robbers. All will be fine if it is dollars you save in and depend upon for your security. And, of course, your Social Security checks will be issued, you young whippersnapper. After all, don't you know that the monetary system is based upon “The Full Faith and Credit of the U.S. Government?” What more could you ask?

I depend upon things I can see, touch, feel and admire—and you should also. I depend on my home, tangibles in all forms such as my tools, that old Mercedes, my safe full of goodies, my pistols and other firearms that remain loaded, and my intelligence and fortitude. I save in gold and silver, which owe no one, and don't depend on fallacious promises, contracts and “insurance” issued by the fatuous fatheads in D.C. After all, can this nonsense continue much longer? Will our dollars be further diluted with a pointless war somewhere in the world, as has happened several times already? They will continue to be diluted by the ever larger bureaucracy's payroll and reckless spending, that's for sure. When government spends \$2 trillion, and collects \$1.7 trillion, they print the balance, thereby diluting the existing dollars. It's as if you watered down your Jack Daniels. It just doesn't have the strength it had before dilution. The Black Jack doesn't kick, and the buck doesn't buy. Tough Stock Market Will Get Tougher Still

Equity prices were hit hard last week, but they remain hugely overvalued. Leading to the big declines last week were report after report of negative earnings, especially in the technology sector. Also stunning the market was a much bigger than expected unemployment claim number which indicates things are not turning around in the economy when the global economy needs the U.S. to continue being the engine that keeps the world economy from falling off a cliff.

With regard to earnings reports, it was the severity of declines, which in many instances were far worse than the

analysts had anticipated, that really floored the markets. In many instances the analysts' estimates were extremely optimistic compared to the actual numbers. We may look for more of the same next week. If so, look out below!

The action last week was, I believe, just a minor taste of what is yet to come for the stock market. Why so? Because even with the trashing of stocks last week, the S&P 500 is selling at an astounding 26 times earnings. As Richard Russell recently pointed out, when stocks sell at a mere 22 times earnings, based on history you can expect to earn an average of only 5%. Wait to see how many Americans head for the equity exists when sub-5% returns become a reality—especially given the major declines suffered by inexperienced investors over the past couple of years.

Mounting Signs Of Deflation

Richard Russell has been latching on to the deflation theme and I think he is exactly "spot on" with this theme. He noted last week that the bond markets are certainly not spotting any serious inflation problems because the differential between the 10-year T-note and the TIPS (inflation adjusted T-note) is down to 1.90—meaning that the bond market is not worried about inflation.

Richard does not buy into the gold manipulation story as I do, so he also erroneously views gold's weakness last week as another sign of deflation. Someone should tell Richard sometime, that it is during the Kondratieff winter (severe deflation and depression) that gold investments perform best of all.

But Richard hits the nail squarely on its head when he warns of overproduction and that this is only going to get worse with the unleashing of China and India. He also notes that Japan is too a leading producer of things—and now with Japan again in an economic downturn and with a new leader now ready to bite the bullet that should have been bitten ten years ago, look out. We could be ready for a major decline and trade wars in the Far East which could really accelerate things to the downside not only in that part of the world but also in this hemisphere. Richard Russell then pointed to a column written by Mort Zuckerman in *U.S. News & World Report*. Here is what Zuckerman said:

"The consumer is now in hock. He's carrying too much debt. Consumer spending has been contracting all this year, down to a rate of 4% in the first quarter and to a rate of 1.5% in the second quarter—and the decline is accelerating.

"The reasons for consumer behavior are plain: the wealth effect of the stock market drop and weakened job market. Unemployment has risen to 4.5% and more than 400,000 people have filed claims for unemployment benefits, a number typically associated with a recession. The consumer is also constrained by a rising debt burden, which now approximates 22% of disposable income. Average credit card debt per household in the 1990s grew by 150% from approximately \$3,000 to \$7,000.

Zuckerman then reportedly concluded his piece by saying, "If there's a surprise waiting for us in the second half of this year, chances are it won't be a recovery of growth but, rather, a disappointment that the combination of Fed easing and Tax cuts have failed to jump-start the economy. 'Why' because of the triple whammy of weak consumer spending, declining capital spending, and tumbling exports."

James Sinclair "Climbing A Wall Of Worry"

Gold Producer Short Sellers will be hung out to dry by the Gold Bullion Bankers—James Sinclair

The following remarks by famed gold trader Jim Sinclair were published on June 26th at www.lemetropolecafe.com. Jim knows the gold market as well as almost anyone alive, so I think his following comments provide great insight for all of us.

"Gold is breaking out to the upside amidst the proverbial "wall of worry" and with most market participants clueless as to what gold is all about.

"A flurry of buying emanating from the cash market set off some excitement on Comex as the Goldman Sachs Dwarfs were routed when their hold-the-\$275-line-at-all-costs was overrun. Only "shoot themselves in the foot" producer selling by the likes of Placer Dome stopped an accelerating rally.

"The grandest commodity moves of all come when the specs are long and the commercials are short. The reasons are fairly simple. Producers (commercials) that continue to hedge in this environment think like rats in an electric shock maze. They are conditioned, are too close to the market and think in the past. Some producers are pulling sell-forward triggers as if they have just bounced off a shock wall—they are just reacting, not thinking. It was what they have done for years, so they keep doing it, not taking the time to analyze what is happening around them. They have been conditioned by The Gold Cartel to do just that. As a result, many producers will be the last to realize that a giant gold bull market is in play and that the 21-year gold bear market is over.

"The devious bullion dealers in the cabal will cover their own shorts first, and try and get long before they inform the gullible producers what the new game is. They need as much producer selling as possible for their own covering.

"One day does not make a market, but you will not find a more constructive chart than this one."

Why did Barrick Buy Homestake?

So what was the acquisition of Homestake by Barrick all about? With Homestake holding very small gold hedge position compared to that of Barrick—which is insanely hedged out on some of its future production as far out as ten years—the acquisition raises some very interesting questions. Does Barrick want to use Homestake's future non-hedged gold production as a means to help it meet its hedged obligations because it is concerned about rising gold prices and an otherwise inability to meet those obligations? Or is it getting ready to hedge Homestake's future production in a continuation of the vicious anti-gold industry practice it has engaged in on behalf of the Hannibal Lectors of the gold bullion banking industry?

Was Barrick encouraged by the bullion banks to take over Homestake so that the bullion banks could begin to get themselves in a long position in gold first, before the price of gold begins to skyrocket? Time will tell, but the sinister side of me thinks Sinclair is right, that Barrick is "like a rat in an electric shock maze". And Hannibal Lector (Goldman Sachs & the other Gold Cartel banks) may like to see Barrick short gold still further so it can take the long side of those transactions, thus protecting its position against the inevitable squeeze in the gold markets where supply has been inadequate to meet demand year after year after year. Whatever the case, we live in interesting times. Things should get very exciting in the gold industry in the not-too-distant future.—**Jay Taylor, Editor of J. IS SILVER MONEY?

I took out my *Black's Law Dictionary* and looked up money. Interesting when one will look at the legal aspects of things. I will admit I have an old version, 1968 to be exact. The reason is bias on my part. It seems the definition of things keep changing as we move forward in time. To quote *Blacks Law Dictionary*, Money: "In usual and ordinary acceptation it means gold, silver, or paper money used as circulating medium of exchange, and does not embrace notes, bonds, evidence of debt, or other personal or real estate. Lane v. Railey, 280 Ky.319,133 S.W. 2d 74, 79, 81."

Reading further we find:

In its strict technical sense "money" means coined metal, usually gold or silver, upon which the government stamp has been impressed to indicate its value. In its more popular sense, "money" means any currency, tokens, bank-notes, or other circulation medium in general use as the representative of value. Then under that several more sites are named.

Silver has the six aspects of money in a classical sense. It is divisible, durable, convenient, consistent, has utility value, and cannot be created by fiat. Silver is used as a medium of exchange and as a store of value.

Before we get into a big argument about whether silver is money or not, I need to point out a couple of details. First, it is a recorded fact that silver has been used in more places and for longer periods of time for money than gold. Secondly, I would like to quote Nobel Laureate Milton Friedman, who stated "The major monetary metal in history is silver, not gold."

Quoting from the Silver-Investor.com Website: "It is impossible to write about silver without evoking emotions, although it is my goal to be as objective as possible. There are very strong views about this metal both positive and negative. One such area involves the silver-as-money issue. The facts are that precious metals are rare, fiat currencies can be printed at will, and have always been abused."

My projection for the ultimate price of silver would be meaningless, but the facts surrounding the value can be objectively studied. In the end we all have a vested interest in the monetary system holding together. Precious metals are a barometer of world financial health. If gold and silver start moving up in a manner similar to 1979-1980, then the paper-money game is essentially finished. Will this happen? Objectively, I do not know! **However, I do know, throughout all of recorded history when a country has adopted a monetary system founded on edict (fiat), the nation has had a financial collapse.** As we enter the next Millennium, remember the gold window was closed in 1971 and for the first time in history, the reserve fiat currency is worldwide phenomena.

The price of silver is a function of the understanding of the market itself. When the market understands that money based on unsound principles cannot help but fail eventually, then the true value of silver will be determined. Until that time arrives it is prudent to prepare some savings in the form that best retains value.

It would be of tremendous importance to everyone if I were able to predict one event in the investment world that had a 100% certainty of being fulfilled. I cannot—however, here is something to ponder. **All fiat currencies have eventually reached their intrinsic value of zero. This implies that the dollar will reach zero as well.** Now, we currently are under the influence of a "strong" dollar. We must ask ourselves; strong relative to what? If the Federal Reserve admits that today's dollar is worth the equivalent of five cents in 1913, we have lost 95% of the

purchasing power. So I ask how strong is today's dollar? Is the dollar's strength based upon the restraint of the printing press, the rate of return (interest rate), the productive capacity of the people, or faith?

Now, take the time to look at your "money"—be it coin or currency. You will notice that all have the statement "In God We Trust". Are we to put our trust in Mr. Greenspan, the Fed, or any political affiliation? Or are we to trust the source? Before I am accused of going religious on my readership, let me make my point. The source of all wealth is land. If you believe God created the Earth, fine, if not fine; we all can agree we live in a physical universe and land composes part of the Earth's character. Let me repeat myself, the source of all wealth is land. That is an interesting concept is it not? Gold and silver are mined out of the Earth; many foodstuffs are grown in soil; houses, apartments and shopping centers are built on it. In fact, most of the list of commodities are derived from the land in one way or another—from soybeans to cotton, from sugar to copper. However, there is one subset that trades on the commodities exchanges that is the sole creation of man—fiat currencies, bonds, notes, and bills. (Not money according to *Black's*.)

The world has entered into a great economic shift from paper assets to hard assets. This cycle repeats itself; and now is the time when investors should be shifting assets—or should have liquidated their stocks and bonds and begun to accumulate physical-commodity-type assets. This is the real thing; commodities cannot and will not go bankrupt; there is real tangible value and most commodities are required by mankind.

Now we have some insight into where we are in the economic cycle between paper assets and physical assets. What takes place at the end of great inflations? What does history teach us? Actually, at the end of the inflation cycle, two interesting things happen. First, real money as defined above begins to appear in the market for everyday transactions. Almost anyone on the Internet is aware gold can and is used for transactions through e-gold, GoldMoney and a few others. Once a person or business has enrolled with an Internet gold holding company, transactions over the Internet can be made using gold. **There are also some actual warehouse receipts being used by NORFED and Millennium Money. These warehouse receipts are exchangeable by the bearer on demand for actual silver or gold. The receipts themselves can also be used to purchase everyday items.**

The second issue is that man-made instruments are exchanged for real wealth at an accelerating rate. Those that have saved U.S. "dollars" decide to buy something with them. The problem is that once this transfer begins, there are not many places to find safety. Because money represents something that can be used presently or stored for future use, this shift becomes very intriguing. Although the major shift is into commodities, which of the commodities are able to fulfill the ability to be spent presently or be stored value for future use?

Yes, land and real estate can and will be used—but land is not very liquid. The only real places to transfer the financial asset class are into the metals.

What would happen if one of our foreign-exchange partners running a balance of trade surplus decided to use some U.S. dollars (bond holdings) to buy real wealth? It would have to funnel money into the area slowly because too big a buy at one time would move the market a great deal. Once this shift was seen by the market, the tendency would be for others to follow.

Mexico is considering using its silver as a financial store of value. Some banks actually offer their customers money as defined above. This is a noble and

valiant act. Some economists in Mexico have argued that the Mexican people have imported about as much U.S. paper as would ever be needed—and it might be wise to recycle this paper.

Grupo Elektra, quoted on the NYSE under symbol EKT, and Banco de Mexico, Mexico's Central Bank, have signed a contract authorizing Grupo Elektra as a distributor of Banco de Mexico's "Libertad" one-ounce silver .999 coin, which has no face value and is legal tender under certain circumstances.

Grupo Elektra operates 550 stores throughout Mexico. It will initiate operations in silver sales and repurchases from the public at five stores in the Cuernavaca area, for the purpose of gathering experience in this field, which is new to the company. National expansion will follow shortly thereafter.

An interesting question to ask yourself is: "When or under what circumstances would silver (or gold) be the most valuable? This question poses some interesting aspects because it tests your own belief system. Do you trust the government or the source? The most important time may be when the man-made asset class loses value and is shunned in favor of something real. Since there are too many paper claims outstanding versus the amount of silver or gold available, not everyone will be able to shift into a financial asset that has stood the test of five millennia.

Sooner or later, nearly everyone everywhere will catch on to the fact that the currency game is drawing to a close, that all fiat currencies are doomed. Action in the marketplace suggests this recognition is spreading; using gold-backed Internet currencies; and the potential for a major silver producer (Mexico) to encourage its people to obtain value-based money. A flight from all national currencies into real value is developing and will gain momentum. COLORADO TO COMPUTER-MAP DRIVER'S FACES

First it was the photo-radar vans snapping pictures of Denver-area speeders.

Now, some fear Big Brother's roving eye soon will be watching all of Colorado with the arrival of a new European import called "face recognition".

The Department of Motor Vehicles, in an effort to prevent identity theft and driver's license fraud, is buying cameras that will map every driver's facial characteristics like a three-dimensional land chart.

The danger, critics say, is that the technology could eventually be expanded to monitor the comings and goings of ordinary Coloradans.

This week, Tampa, Florida became the first city in the United States to install similar high-tech security cameras on public streets to scan crowds in the city's nightlife district. Images will be compared against a database of mug shots of people with active warrants.

"There is a danger," said Rep. Matt Smith, a Grand Junction lawmaker and attorney who serves on a statewide task force studying the issue of privacy. "The intended purpose of facial recognition is to help the state prevent the theft of identity. Now the question is, 'What will its future use be?'"

"There has to be a point where the government doesn't have its nose over every shoulder," he said.

Mug shots compared

Old driver's license photos will be scanned into a

computer database using the new technology. Then, starting next July, new mugs will be compared with those on file to make sure people are who they say they are when they go to get, or renew, a Colorado driver's license.

It doesn't matter if you gain 200 pounds and go bald between photographs. Short of plastic surgery, the camera will recognize you.

"Facial recognition deals with spatial details, where a nose is compared with the eyes," said Dorothy Dalquist, spokeswoman for the Colorado Department of Revenue. "Baldness doesn't count, and weight doesn't either. It's the basic facial structure."

The state legislature authorized the technology during the last session. State officials won't disclose the cost of the system until they meet later this month with officials from Polaroid, one of the companies involved in making the system.

In the beginning, face recognition will be used to try to prevent criminals from obtaining multiple driver licenses under others' names, Dalquist said.

"We know of cases where individuals steal personal information from other people, forge documents and go to six or seven driver license offices getting licenses with their pictures and other people's identities. In theory, they have a legitimate license, but in actuality, they're not who they say they are," Dalquist said. "Now, we will be able to say after the first one, 'No, you can't have another one.'"

Or the police could be called in.

"My guess is if we saw something that is an egregious misuse of the system, we might alert law enforcement to that," she said.

The cameras can't prevent the types of fraud that now occur when people make their own driver's licenses using home computers and the Internet. However, as part of the new program, invisible markers will be added to each new license so stores or banks can scan the card to see if it's genuine.

Privacy concerns

The technology has raised concerns about privacy, ethics and government intrusion. Privacy advocates are concerned that a database of photographs could itself spill into the Orwellian realm.

"We all want to catch as many criminals as we possibly can, but we also have to be concerned about the privacy issues," said Sen. Ken Gordon, D-Denver, a member of a state task force set up to craft legislation aimed at protecting privacy. "Information obtained for one purpose is sometimes used for reasons that were not contemplated by people who set up the system to begin with."

Gordon said Colorado already sells driver records to insurance companies for \$5 million a year.


"If we're going to create a database of photographs of every driver in Colorado, will it be used only to protect against criminals?" Gordon asked. "Or will it be used for commercial purposes or marketing or to produce books of people's photos. We have to be careful."

Colorado's new system could pave the way for expanded use, say for instance tapping into a criminal database and finding out if someone getting a driver license is a fugitive.

"I'm sure law enforcement would appreciate it sometime in the future," Dalquist said. "Right now, we're not hooking into their data process. We're trying to protect citizens against identity fraud, and businesses, too."

But some say this latest technology could continue to grow into a Tampa-like monitoring system.

Last month, Denver police used low-tech, hand-held video cameras to catch rowdy partygoers celebrating the Colorado Avalanche's Stanley Cup victory.

"We haven't discussed it," said Denver police Sgt. Tony Lombard, "not at this point."

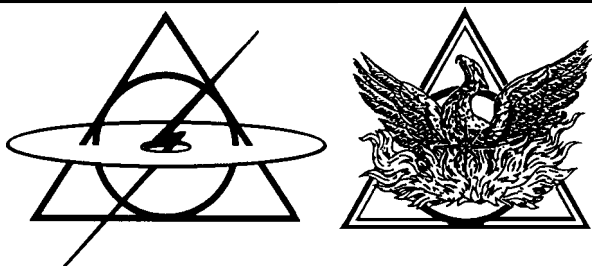
