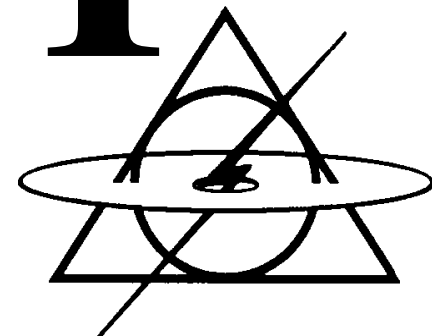

privacy and more especially for those who meet with us to see if we accomplish some assistance.

CHAPTER 57

L. RON HUBBARD AND THE CHURCH OF SCIENTOLOGY

Another personality with an interesting background is the now deceased L. RON HUBBARD, the founder of the Scientology church. Since this book here is dealing with background knowledge, perhaps we should look at the background of L. Ron Hubbard whose organization is really victimized in public.

In the early days of MK ULTRA, the consciousness control programme in the U.S., the former naval officer Hubbard had researched the mechanism of human thinking, knowing about what secretly went on in the Navy. After refusing to comply with government research and to join the control psychiatrists, he published the book *DIANETICS—the Modern Science of Mental Health*. The book proclaimed mental freedom and integrity as the birth right of humanity. The book made the bestseller lists and Hubbard's "auditing techniques" were described as very successful. Some of the processes that Hubbard offered to reach mental freedom were secretly used by the government to try and enslave the people. Other techniques described by Hubbard were indeed antidotes to the MK ULTRA methods of consciousness control.

The U.S. government then started a devilish slander campaign against Hubbard that was led by the section for mental control at the CIA. The still young author had—probably inadvertently—revealed the key of one of the best-kept secrets of the cold war. His office was broken into and a protocol was stolen that described the mind control techniques now known as PSYCHOTRONICS. Hubbard and his colleagues were physically attacked and only narrowly escaped a kidnap attempt. But the enormous influence by the Scientology churches shows that Hubbard was not just an innocent victim. And L. Ron surely knew a thing or two about some important events of this world because he not only spent his "magician years" in Aleister Crowley's Thelema Church in California, but he had also risen to the 33rd degree in the Scottish Rite Masonry (perhaps even to the Illuminati degrees).

But let's get to the "real" stuff now. What I just told you so far can be found in other books, too.

So now I will tell you something about L. Ron Hubbard and his Church of Scientology which you won't find in any other book on this planet.

JOHN TODD, himself a former member of the Council of Thirteen describes the pyramid as follows:

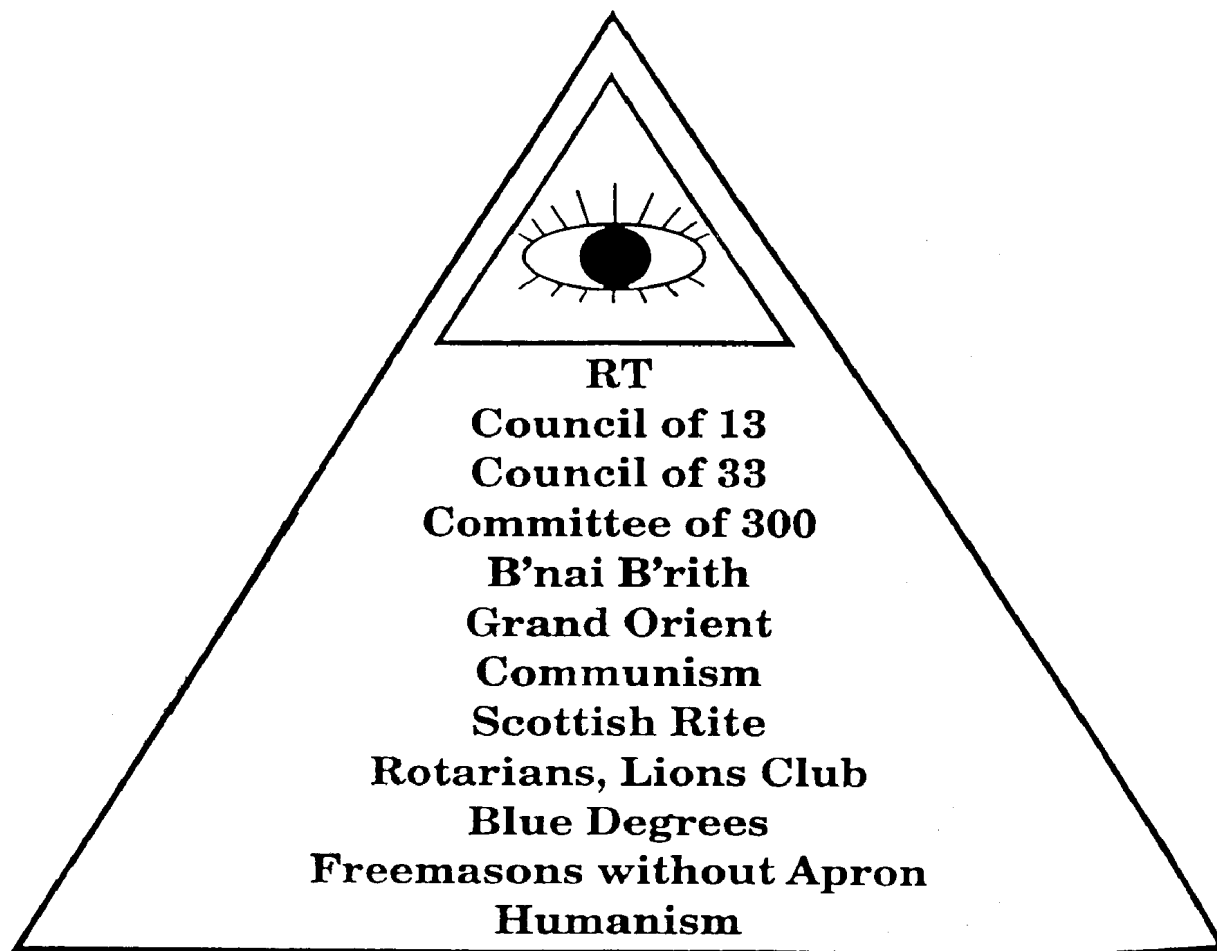

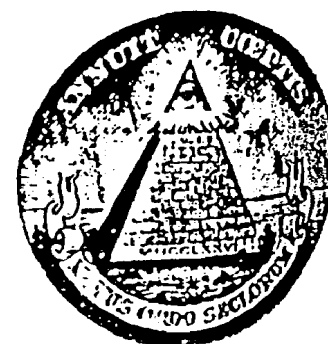

Today’s most successful background organizations:**The Council on Foreign Relations (CFR)**

This was established in 1921 by the Round Table group and is also known as The Establishment, the Invisible Government, or the Rockefeller Ministry for Foreign Relations. This semi-secret organization is today one of the most influential societies in the U.S. and its members are without exception U.S. citizens. Today the CFR exercises a tight control over the nations of the western world, be it directly through links to similar organizations or through institutions like the World Bank in which it holds the chair. Since the foundation of the CFR all U.S. presidents except Ronald Reagan had been members before their election. Reagan’s vice-president though, George Bush, was a member. In 1977 Bush was even director of the CFR. The CFR is controlled by the Rockefeller syndicate and realizes the latter’s goal, the One World Government.

[H: It is not an accident that Reagan was “left out of” everything possible. He was a figurehead while Bush, et al., ran the nation and set up the New World Order. Reagan was instrumental in the plan being worked out with F. Marcos of the Philippines and the securing of gold and currency around the globe—but BOTH were betrayed when the plan was set and ready to move. This is also WHY Reagan was pronounced to have Alzheimer’s disease, for he didn’t really ever KNOW much and couldn’t, therefore, “remember”—but he could spill the beans about what he DID NOT KNOW. The innermost circle of the CFR: Order of Skull & Bones.

Skull & Bones

Its members call it “The Order” for short, to some it has been known for more than 150 years as Local 322 of a German secret society. Others call it Brotherhood of Death. The secret order of Skull & Bones was introduced to Yale University in 1833 by William Huntington Russel and Alfonso Taft. Russel had brought it to Yale from his student days in Germany in 1833. In 1856 the order was incorporated into the Russel Trust.

Among other things the order forms the inner circle, the elite, of the CFR. The inner circle of the Skull & Bones in turn is the Jason Society.

The entanglements of the Order of Skull & Bones have been mentioned throughout the book.

The order is also linked with Lord Milner’s group, The Round Table, since the CFR was founded by it.

The Round Table

Cecil Rhodes as a member of the Committee of 300 founded The Round Table in England on February 5, 1891. Among the founding members were Stead, Lord Esher, Lord Alfred Milner, Lord Rothschild, Lord Arthur Balfour. The structure of the group was—like Hitler’s SS—copied from the Society of Jesus, the Jesuit Order.

The main objective of this group was the spreading of the British Empire across the world with English as the world language. Rhodes strove—as far as I know—really for a positive world government for the good of humanity, but the group was later infiltrated by Illuminati agents. Via the Rothschilds the Round Table is linked with the Zionists, in the U.S. also with the Schiff, Warburg, Guggenheim, Rockefeller and Carnegie families. Later Lord Milner took over as the head of this group out of which came—as already mentioned—the Royal Institute of International Affairs (RIIA) and the CFR. Lord Milner is also a leading member of the Committee of 300. The Institute for Advanced Study (IAS), also spawned by the Round Table, employed Robert Oppenheimer and Albert Einstein who later developed the first atom bomb on behalf of the IAS.

The German branch of the RIIA and the CFR is the Deutsche Gesellschaft fur Auswartige Politik (DGAP—German Society for Foreign Policy). It was founded on March 29, 1955, as an independent and non-party association. The members discuss the problems of international politics and economics, especially of Europe. Its influence on Germany is perhaps not as strong as that of the CFR on the U.S., but the names of the most important members speak of themselves.

The Bilderbergers

This secret organization was started in May 1954 at the Hotel de Bilderberg in Oosterbeek, Holland, by the Committee of 300 through Prince Bernhard of the Netherlands. The Bilderbergers are a group of around 120 persons from the high finance circles of Western Europe, the U.S. and Canada. Their main objectives—as formulated by Prince Bernhard himself—are a world government by the year 2000 and a global army through the UN. The group is also called the “invisible world government”.

An advisory group composed of the management committee (24 Europeans and 15 Americans) decides who will be invited to the meetings. Johannes Rothkranz writes that only persons who have proven their unwavering loyalty to the Rockefeller-Rothschild intrigue are ever invited. The Trilateral Commission

This secret organization was founded in June 1973 by David Rockefeller and Zbigniew Brzezinski for the Committee of 300 and set to work because the established organizations like the UN were going too slow in establishing a One World Government. The Big Boys wanted action. This elitist organization aims at pooling the top heads of the industrial and commercial giants, i.e., of the trilateral nations—the U.S., Japan and Western Europe—and thus at forcing the New World Order. It offers the elite coming from the different branches of Freemasonry world-wide meeting opportunities for secret co-operation and it is meant to give the Bilderbergers a broader political basis. Club of Rome

The Club of Rome which I have not mentioned yet is, according to Ovin Demaris (*Dirty Business*), a group of international members of the “establishment” from around 25 countries (about 50 people). It was founded by the Rockefeller clan (on their private estate at Bellagio, Italy) and is financed by them.

The main objective is once more a world government by the elite. The Club of Rome has also worked out a world religion and had the mistaken belief in an energy crisis and an overpopulation of the Earth spread by the media. According to William Cooper they apparently also developed the AIDS virus (naturally with an antidote) and spread it among the people in order to start the great racial cleansing programme for the world government. (More facts and names about AIDS can be found in William Cooper’s book *Behold a Pale Horse*) and Dr. John Coleman’s publications. **[H: You will be able to get it ALL if you just get the *Phoenix Journals*.]**

The United Nations

At the Freemason Congress in Paris, June 28-30, 1917, the guidelines for the League of Nations were accepted and approved. This was the beginning of the League of Nations established in Geneva in 1919.

In 1945, in San Francisco, the United Nations Organization emerged from this. It is an institution fashioned by the Illuminati, the biggest Masonic lodge in the world, in which all nations of the world shall unite. Ironically, yet as stated in the rules of Machiavellianism, item 4, summarized in the preface, the people of all the nations of the UN now ask this institution to solve their problems and to intervene in their wars to end them, although the men behind that very institution have themselves instigated all the wars of the last two centuries.

In public the UN appears as a good friend to all and sundry who “will take care of the affair”. At least forty-seven CFR members were among the American founding delegates, including David Rockefeller. The UN emblem is a clearly Masonic symbol and I will compare it here to the American Masonic Great Seal.

The globe of the UN and the circular form of the Great Seal with the inscriptions ANNUIT COEPTIS (He—God—has favoured our undertakings) above and Novus Ordo Seclorum (New Order of the Ages) below the pyramid show the objectives of the world rule.

The 33 degree fields of the UN globe and the 33 stones of the pyramid represent the 33 degrees of the Scottish Rite of Masonry.

The ears of corn with 13 grains each to both sides of the globe, the 13 steps of the pyramid and the 13 letters in ANNUIT COEPTIS symbolize the 13 grades of the Illuminati hierarchy and refer to the Jewish lucky number 13. The number 13 is the most important number in Freemasonry and has several meanings. Jesus had 12 disciples and was Himself the thirteenth. In the cabala, in numerology and with the 13th Tarot card, “Death”; the 13 means transformation, alchemy, rebirth, the Phoenix rising from the ashes, knowledge of the secrets and thence the ability of materialization and dematerialization, the ability to create from the ether (as Jesus, Buddha, Hermes Trismegistos, Saint Germain and many others did, e.g. making bread out of “nothing” (the ether), the so-called Philosophers’ Stone).

On the obverse side of the Great Seal we find the Phoenix (changed in 1841 to the American bald eagle) symbolizing the 13, the transformation. He has 13 feathers in each wing, 13 arrows in the right talon, an olive branch with 13 leaves in the left. His beak holds a scroll with the inscription E PLURIBUS UNUM (Out of man, one) has 13 letters, surmounted by 13 stars arranged in the shape of a star of David. On the breast is a shield with 13 stripes representing the original 13 States under Congress.

Remarks:

The German *Dea* petrol stations of the RWE (Rhenish-Westphalian Power Co.) are represented by an upside-down pyramid with 13 stripes. In the U.S. there is a petrol company “76”. 7 plus 6 equals 13. There are hundreds of examples, just look at company logos, products, TV advertising, State seals and flags, etc.

The same goes for one of the largest Masonic companies in the U.S., Procter & Gamble. The name has 13 letters and the company logo is one of the oldest Masonic symbols: a bearded man in a circle with 13 stars before him. Perhaps it is of interest to note here that in the *Wisconsin Report*, the chairman of Procter & Gamble said [in]1984 on TV:

“I made a pact with Satan! In exchange for commercial success I have signed away my soul to him...”

(More information about the meaning of these and other symbols can be found in Gary Allen: *None Dare Call it Conspiracy* and in Masonic literature.)

These are some of the most important organizations in finance, commerce and politics who aim for a **One World Government**.

One group of immense importance we have not considered yet is the **Rockefeller Empire**. But Gary Allen in his two books has dealt with them at length, and it is following the same objectives.

The Rockefeller empire is the main financing force behind the CFR, the Trilateral Commission and the Club of Rome.

You will probably have noticed that you read the same names over and over again. It would be interesting to have a list of names of the “council of 13” or the “council of 33”. But we know their goal and how they plan to reach it which is more important and should in my view suffice.

In Finkenstadt’s: *Eine Generation im Banne Stans* John Todd goes on:

“If you ask the head of a coven who is the world’s mightiest witch, he will say: Ruth Carter Stapleton, the sister of former president Jimmy Carter. I don’t know whether Jimmy Carter is a Freemason. Normally, if you want to be a politician in the U.S., you have to be a Mason, because this is the way to enter the political circles. Since Wilson, president during the First World War, there was not one president who did not belong to the Illuminati, except Eisenhower, and he was controlled by them. There are about 5,000 people in the world who have a deeper insight about the Illuminati. Millions of people work for these few. The situation with the Freemasons is similar. Only those in the 33rd degree of the Scottish Rite had also the knowledge. The others simply don’t have it. They own every large petrol company in the world. 

I believe that all will see—as they see the attacks of such as V.K. Durham through the New World Order "officials" and "assets"—that our program IS NOT simply a hand-out deal with any one, State, or Nation.

Therefore, please do not despair in "delays" from day to day—for sometimes we simply need to await the next move by our "enemies", i.e., hummnnn... "The Philippine Minister of Foreign Affairs" with a U.S. phone number. See, chelas, if you are patient, you learn a lot, don't you? You haven't even scratched the surface of that ONE presentation. SUBJECT: G.A.I.A. SUPPORTS PNG's PRIVATIZATION PROGRAM.

It is our pleasure to submit our proposal to your high office on the eve of the investigation of the last week's shooting incident during the rally against the Privatization Land Mobilization, IMF and World Bank Activities in the Country. Sir, if you want our immediate support to make Privatization Program successful, it should be for the People of Papua New Guinea, its Local Level Governments, Provincial Government and its National Government of the motherland, Papua New Guinea.

Before we proceed deep into the real issue, our group would like to know from your high office how much money is needed to stabilize the following Agencies:

1. PNGBC
2. ELCOM
3. Post PNG
4. Air Niugini Airlines
5. TELIKOM
6. Harbors Board
7. Water Board
8. MVIL
9. 19 x Provincial Governments
10. National Capital Dist.
11. Local Level Governments
12. National Treasury

Concerning NPLs (Non Performing Loans) of the Commercial banks, and if you were to calculate "ALL" of the distressed Outstanding "DEBTS" of the Companies involved, GAIA would provide a DEED to a new established Debt Management Corporation the purpose of which would be to REVIVE and REFINANCE those companies. The shareholders could be local businessmen, bankers, academics, advanced business students, and perhaps some from the business press. The DEED should be large enough to assure the corporation's ability to purchase "ALL" of the "DEBTS" and bank loans plus their accrued interest as well as provide additional working capital to REHABILITATE all of those borrowers adjudged to be eligible, as well as provide compensation to a support staff. The shareholders compensation would be expected to derive from their shareholdings.

When GAIA issues the DEED it would be presented first to the National Treasury for approval and registration for use, then be delivered to PNGBC or BPNG (central bank), i.e.; shown on the day deposit books as an increase in RESERVE just as if you were making a loan secured by any other U.S.-Treasury Debts. Funds drawn from the bank of BPNG to purchase an equivalent amount of GOLD and using the gold as the Collateral, providing LINES-OF-CREDIT to the corporation and GAIA.

GAIA will be permitted to draw as much as 10% of the amount of the DEED that is credited as an addition to RESERVE for its use, Offshore, the remaining 40% remains as an addition to the STATUTORY RESERVE with a stipulation that any increase or decrease in the price of GOLD will accrue to GAIA. The other 50% will be used to pay for the Non-performance Loans/Debts and begin their rehabilitation. This can take as little as 3 banking days to implement and it will be done there in PNG. Perhaps it might be useful to recap the transaction as an example so that you can see the actions to be taken and the results.

Suppose the NPLs/DEBTS of the above mentioned bank and agencies total @ K1 million. To provide for rehabilitation and operating capital we could double that to K2 million. The GAIA standard formula is to issue the DEED for 2.5 times the amount needed in the LINES-OF-CREDIT = K5 Million.

The DEED you receive for K5 million is deposited and placed in the bank vault and accounted as U.S. Treasury Debt of K5 Million. If you are not allowed full face value/or current value on U.S. Treasury debt as a RESERVE, we can make the deed large enough to OFFSET the discount, so for the purpose of this example, let us assume no discount.

Showing the additional K5 million in your RESERVE account, you can then request that BPNG purchase (they probably have it in inventory) K5 Million worth of GOLD to be placed in the STATUTORY RESERVE ACCOUNT. As long as it is used to purchase gold to be HELD (NOT TO BE SOLD) as a "NATION'S PHYSICAL RESERVE" in the Banking system (especially in the central Bank of PNG) the BPNG can issue/or print "NEW" currency without any inflationary effect.

Quite the opposite, the effect of several large transactions will strengthen the value of the KINA as well as the FOREIGN EXCHANGE POSITION. At this point, you have the DEED worth K5 Million and K5 Million worth of Gold in the Central Bank Reserve Account, for which you have borrowed K5 Million (hopefully at a very low rate) from the Central bank, so you have a NET GAIN to reserve of K5 Million.

Using the gold as SECURITY, you arrange the LINES OF CREDIT for the corporation and GAIA. Again, because you have the necessary reserves, the BPNG can cover your draws without disturbing the value of the KINA. If both GAIA and corporation wish to immediately draw the maximum of their LINES OF CREDIT, your bank would have an equity of K2.5 Million above their draws. The corporation can draw K2 Million and GAIA K.5 Million. The corporation might draw K1 Million immediately to pay for the Bank Non-Performance Loans but it will be some time before the entire K2 Million is drawn, if ever.

[H: It must be noted that only a percentage of GAIA's holdings would be drawn except for singularly backed projects, the Alliance operations and its own projects. The industrial involvement would be simply to provide more funds for LOCAL projects and to purchase addition GOLD for security backing and reserves. THE WEALTH, THEREFORE, IS HELD "IN-COUNTRY" AS, AT THE LEAST, RESERVES and any portion above necessary amounts to secure currency or projects can be utilized to assist other nations as might be desirable. All this is fully explained in information already provided so will not be provided here.]

In summary, the statement of your "troubled" bank will show a dramatic improvement. It has a "NET INCREASE" in Reserve of at least K3 Million, it has no Non Performance Loans and it has K1 Million in the till that is now "Free and clear". PNG to believe the big banks will save the situation is just that, propaganda to mislead and keep motherland, PNG off balance, hoping, and hesitating until it is too late. The latest incident is a clear indication, and the more we wait they will create massive shortage of KINA currency in PNG Banking System.

BE WARNED: NO MONEY—NO CREATION OPPORTUNITY—NO FOOD—RALLYING, LOOTING & BURNING RESULT IS = CHAOS.

G.A.I.A. has sufficient Collateral of 1,000 times more than the PNG Annual Budget and is ready, willing and able to issue DEED for Papua New Guinea. We kindly request your high office to seriously give consideration on this golden offer and also give a thought over the proposed name, NATIONAL ASSET & TRUST MANAGEMENT LIMITED (NATML). I hope the name will give a clear identity to what you are trying to establish regarding the "DEBT" management firm. We have already prepared an Information Document in preparation to give funding under the Reform System and this is in order to PNG not to BORROW from the IMF/WB/ADB/BIS or any Foreign Loans in the future. Ramos Knows Validity Of PHOENIX PROJECT

DJE—Thank you for the bread machine. It came with too little information to name names and places. BUT, we experienced a full-blown first: It arrived via UPS, customs cleared and presented at door late yesterday afternoon. I'm confident the guys at the Post Department will find some way to punish us for "non-ransom". It is now on the floor in the bedroom, doing its first checkout.

Having forgotten most of what I once knew about making bread with bread machines, I did however do all the proper settings, pushed the "start" button and NOTHING happened. After some half-hour of wailing (and badgering E.J.) I RE-READ the instructions which told me that if you use "whole grain" settings, you will have a pre-rest period of 30 minutes. By that time I had reset everything two or three times and had to WAIT through another half-hour to keep the timer healthy.

Just this instant got information in the form of a call from the "sender". Thank you, Dave.

E.J. let him listen to the machine humming and dancing away and I think he might have been concerned. But, after listening to "nothing" for an hour we enjoy hearing it talking "bread language".

The floor to our place is SOLID, as in cement with parquet Narra-wood covering. The cement, however, is typical OIP (only in the Philippines) quality of "level" which in no-wise resembles "level". It is fine, great, wonderful—we will do what you do here with uneven tables—put folded paper under the corners.

Oh, Dave, about your friend with cancer. That is a hard one on our hearts. We watched Zita, Rick's mother, actually begin to recover and then she actually starved herself away. I have to believe that she had a prolonged period of functional living. She confided to me privately before her death, however, that things in her life were getting more and more difficult to manage personally.

We simply CANNOT offer anything as to suggestions. It has been found and reported, however, that many of the cancer mutation cells are caused by a viral introduction within normal cells. This in itself indicates that there are possibilities available through anti-virals. I know even less about the drug producers' "drugs" which might be available.

Please KNOW that cancer cells themselves are simply mutations of normal cells which the body generally, with a good immune system, discards. When a viral component enters the picture, though, it causes inner-cell response. This will usually begin in the infection-fighter cells

in the blood which then lodge wherever a kindred cellular soul can be located. If you can neutralize the component segment and you stop the mutation which allows the immune system to then, hopefully, recover itself enough to hold its own.

There are a couple of physicians in the Philippines that are getting interesting results from a mixture of Chondriana and colloidal silver or "a mixture of several colloids" added.

There is a pretty good way to check possible results from such a regime, especially when you have ability to medically research. In the U.S. there are limitations which are not present in other countries, especially Third World—except possibly the Philippines.

With "injection" of the Drias (whatever label chosen) and together or separately with colloids, there is usually a response at about one hour which can result in typical "crisis" response often presenting as chills, possibly fever and then an almost immediate clearance of those symptoms.

We have experienced, ourselves, with a hefty amount of some two ounces of colloid and approximately the same of Gaiandriana orally, the same type of "crisis" symptoms. We cut back to the minimum number of drops when symptoms clear.

These are also the results being experienced with Dengue Fever in the acute phase. We are told that this has been really seemingly effective in children. Children simply respond rather than have so much input from mental conditioning. There must be something to it or the Feds wouldn't be trying so hard to stop it.

Why would I dare say that there is known evidence that there is viral presence? The Cancer Institute said so after checking myriads of cancer cells with electronic microscopes. I personally have never seen it. They even tried to blame contamination but had to finally acknowledge the microbe presence.

It is also known that there is presence, in AIDS patients, of HIV viral particulate in the lesions. But it is also recognized that there are similar but not identical other viruses presence in the cells.

For instance, in AIDS where more cancer studies have been made public, there is a pattern of "Secondary Syphilis" (which is a Spirochetsial organism) present.

Now, we KNOW that before the antibiotics such as penicillin the diseases such as Syphilis were treated with gold and sometimes even mercury. It was found that gold in colloid form was harmless, except to the microbe, even though metallic gold particulate was damaging as are many metal particles. It seems the world stopped using its brain with the invention of chemicals and antibiotics presented by the drug houses.

We are a controlled people where the idiots can actually get away with saying, for an instance, AIDS is non-transferable by kissing, etc. Now, the very test for AIDS and HIV testing is done

through swabbing the mouth. And we do nothing while nations die. It is obviously intentional.

This caused "cancer" researchers to turn attention to possibilities in the "general group of malignant forms" of this possibility of "invasion". I'm sure I don't have the terms properly expressed but I do know that we will do some presentation, at least on this topic, as we get a break in our job here.

We can only be SURE of one thing: WE WILL BE GIVEN AS LITTLE INFORMATION AS POSSIBLE.

I have also been asked about these little colloidalizers. I don't know much about them but I do know one thing: When you get a good colloidal solution it can be diluted with water and it goes a very long way but it is "better" for drop intake and certainly the cost is minimal. Most people simply don't want to bother with making it themselves.

Frankly, a lot of people use it for pets and, yes, indeed, plants.

I remember that one of our people with a dairy herd got bag-and-teat inflammation and he keeps it totally under control with the colloids and now has happy, smiling cows with no signs of Mad Cow episodes, even at milking time. He has been really unhappy since the Federal Raids on New Gaia. That is another story and there were several users for that purpose.

Another good one was the use of the silver colloid on burns, even saddle burns would remain uninfected and heal quickly.

I need to go check progress on the bread front and I have asked Cmdr. to please give a little input on what in the world is happening here NOW? And what, if anything, we should be doing?

Day before yesterday there was an explosion across the street and we immediately got called and warned to STAY PUT and do not go to the area. I guess we appreciate the warnings, but this is really getting old. Gosh, we could have enough trouble in Tehachapi.

There have been outright publications of intent to bomb—and the list is long and the causes many. This explosion, however, seems (at last report) to have been a propane cooking gas-tank. Lots of people were hurt. They even smelled gas but the security guards wouldn't let the customers OUT of the store. Now, how about that one for a "make you feel secure"? The Austrian Ambassador's wife and child were in the place, so perhaps there will be some attention to the idiocy which never ends.

The President is to make her first State of the Nation Speech and you would think it is something like the first siege of the Bastille. The "masa" is planning to have at LEAST 30-50 thousand demonstrators AGAINST her. The labor unions also plan a work stoppage Monday (the day of the speech).

Now, it is obvious that something had to be done, so the old teams who put her into power are holding their own "support rallies" at the EDSA shrine. Seems they can't get enough of the discontent.

In view of the last few days, however, it is a bit annoying that it is all being set forth by FIDEL V. RAMOS! He is the one, by the way (it is reported), also doing the destabilization program against GMA. Button, button—who's got the button? (An old game from a very long ago childhood.)

The Central Bank shored up the Peso but it is only stopgap because it was found that the manipulation came in the "dollar" MARKET. Thus the CB Governor had his "discipline of bankers" meeting—but is still after the "dollar hoarders". Is this any way to run or stabilize a nation?

The "flash flooding" of Manila yesterday is also a major sign of bad things to come because the setup for floods is so ripe (no pun intended).

Now let's look at the wages in Manila where PRICES run, in Makati at least, the same or in some instances worse than in the U.S. Here there is a "minimum" wage level of LESS THAN \$5.00 "A DAY". The wish is to raise that to about \$7.00 A DAY. That is expected to close a lot of businesses. It is that serious, readers.

There are also attempts, as Global now knows, to move some of the squatters out of some of the worst city areas and into housing—BUT THERE IS NO WATER TO THE AREA. Golly, gee, they are asking US for help in order to dig wells to salvage the situation. Of course, they also only have electricity a part of each day.

We have the new information and fee changes required by the State so current information can now be made available.

As I recall, though, he didn't actually bring in the hard copies while they were here because I don't remember them being present when I first saw them. Furthermore, it was about the time Manny headed for the U.S., somewhat ticked off, nicely put, at Rick.

We won't even look at this junk any more—and when anyone tells us about these "opportunities", we refuse to even speak about it. We are pretty confident that many have been deliberately sent in to check us out. It works out well and integrity is reaping its rewards in peace and conscience.

Before we came to Manila we had a contact by a man who said he worked with the IMF. That seemed to have been so. He said that the IMF was buying up a lot of "that paper", etc. We did get confirmation of one thing: "We can't do anything with THAT ONE; it is different." Well, we knew it was "different" but "how different" I guess we had to wait to discover. We certainly were hiding NOTHING from V.K. Durham because those were the first assignments made.

Our method of sorting? We trust NOBODY and we distrust NOBODY. If a man calls himself Jesus Christ, we call him "Yeesuus" or "Mr. Christos". When they show up with EVIDENCE that they can get backing for whatever they get from us—then we discuss it as a project and will work the delivery flow with others so that we are OUT OF IT. These people have to help themselves or they are no better off than they were—which is about as bad as it can get.

It has been verified as to "a" Russell Herman's participation over here in the Philippines. It if was not "V.K.'s" Russell, then I suggest the LAW look carefully at said V.K. Durham and her adventures because she was obviously part of the program. She said she had been in the President's Secret Security Service and so was Russell. I don't know anything about them except what was produced as proof of documentation which THEY shared with us and which has proven to be TRUE.

Strangely enough, Cmdr. GCH wrote and we faxed the letter to Imelda Marcos. She replied within half an hour. We were in Malaysia at the time. She asked to be called immediately on our arrival back in Manila. We made that call and the documents or phone calls were no longer ALLOWED TO GO THROUGH. The major victims of kidnapping before, and perhaps still, now that the Americans are so popular for hostages, are the Chinese. BUT the Chinese "traders" are most frequently killed in the process.

I am certainly glad that "judging" was not part of the assignment here. And, yes, indeed, we would be most pleased to meet with Fidel Ramos. I believe he might well be bright enough to see the proposal offered here and never mind certificates in Durham Holding Trust.

I certainly am NOT saying that V.K. Durham hasn't migrated to Iowa—for we had, several years ago, heard that she had been evicted (in fact, tried to

get money FROM US to avoid same). Fortunately, I suppose, we didn't even get word until too late. We "heard", but never confirmed, that she moved with people she had asked to be Trustees, either WITH Rays or after Rays resigned. That was somewhere, we understood, in the South, i.e., Mississippi or Louisiana.

Prime Minister Sir Mekere yesterday defended his Government's structural adjustment program, which includes privatisation, and challenged his critics to offer him alternatives.

He confirmed telling Privatisation Commission Chairman Ben Micah and Minister Vincent Auali not to make public statements while the “fire is still burning” from the recent student protest, saying... “It's like feeding kerosene to the flames.”

“Privatisation will go on. My point was that, and I'll be honest with you, the fire is still burning, for the Chairman to come out, is like feeding kerosene. So I told him you know, in fact I thought it was dangerous.

“The whole nation is still mourning the death of Papua New Guineans over issues that are utterly misunderstood, totally emotionalized for different motives and it is not proper to say the obvious,” said Sir Mekere.

“And I want to make this point, when the people say stop privatisation, chase all the white men out, don't borrow any more money, I want you to come out and tell me what are the alternatives. If they give alternatives I will consider them very seriously... Frankly, I know of no other way than what I'm doing,” he said. **[D: Right here lies the wisdom of insisting that what is done be done by natural citizens of any place, not a bunch more “white men” running around pulling strings, including US.]**

He named suspended Southern Highlands Governor Anderson Agiru as one of the critics who should offer him some alternatives in relation to the “right time” for privatising the PNG Electricity Commission.

“Can someone tell me, Anderson Agiru included, in relation to Elcom, when is the right time to do it? What are the tests that you give me so that I can say the time is right?”

“Can someone tell me... how to halt the loss of value of Elcom assets? Or are we going to wait until there is nothing left to sell and then the time is right? Or do you quicken up the pace? Most people do not understand why we are doing it.

OKAY THE POINT IS THIS, WE HAVE THE WORLD'S BEST PEOPLE SERVING PRIVATISATION; MANY PAPUA NEW GUINEANS DON'T UNDERSTAND THE CONCEPT AND THOSE VULNERABLE PEOPLE I HAVE SEEN ARE MANIPULATED BY PEOPLE WITH WRONG MOTIVES.

“I was looking through the newspapers this morning, one of them shows a woman and child and what do they know about privatisation? How can they sit there three nights and three days, why were they there?”

“So this is why we are here now. We will try and explain but I can't go on explaining until the nation is dead. I've got a big job, that is to lay the foundation... that's exactly what I set out to do and that's what I'm doing,” said Sir Mekere.

STRIKE TO CONTINUE

The indefinite strike by PNG Banking Corporation workers will continue today as union executives and the bank management meet again to try to break the deadlock from yesterday's compulsory conference brokered by the Labour and Employment Department.

The disputing parties met twice yesterday—at 10am and 3pm—at the Labour and Employment headquarters in downtown Port Moresby but failed to resolve their differences.

The bank staff executives immediately called for the sacking of the senior management executives, including expatriates. The bank management however, was not available to comment on their differences.

Banking services nationwide were disrupted yesterday with most PNGBC branches remaining closed while others were opened either all day or partially to serve their major clients.

Automatic Teller Machines (ATM) including the EFTPOS and other international banking systems operated normally and were not disrupted.

These services are expected to continue today.

In Port Moresby, striking bank staff gathered at the OTC Oval at Five-Mile during the day in support of their executives who were negotiating their packages.

The management was understood to have organised staff from the Boroko branch to serve customers at the Waigani branch while the downtown branch continued to operate under tight security.

Union members went to the Waigani branch at 12 noon yesterday to urge their colleagues who were working to stop work as a sign of solidarity against the management.

PNGBC National Staff Association president Luke Elijah expressed disappointment that the management had refused to correct breaches in a recent MOU between the two parties.

THE REAL CONDIT SCANDAL

You know what bothers me about the Gary Condit scandal? Already there's a drumbeat to gloss over the adultery part of it. Sure, there are other much more serious problems. A young intern is missing. She's almost certainly been murdered. There are allegations of obstructing justice, abuse of power and so on. But do we really want to come to a national conclusion that adultery is not our concern just because there are larger issues involved?

I don't think so. And yet, there I am, sitting on the set at *Fox News* last week, listening to Dick Morris define adultery as a private decision between a congressman and his intern. Now Dick's a smart guy—adviser to presidents and senators, a political whiz for sure. But I'm watching his mouth move and his words seem strange—in fact, from another planet.

"It's none of your business or my business what an adult congressman does with an adult intern," he says, meaning I assume anyone over 18. "We cannot get to a point where sex between consenting adults—even if it's adulterous—is grounds for dismissal or resignation from Congress, but withholding information when a girl's life is in danger sure is. Hey, sex with interns is acceptable, murder is not."

What's happening to this country? Who says we have to make a choice between murder and adultery as a reason to throw a bum out? What are we doing, making a list? Let's see, a congressman must resign if he/she commits murder, rape, torture, child molestation, genocide, or adultery—wait a minute—that's six and we can only have five impeachable offenses. So, OK, we'll dump the least offensive from the list of "man's-inhumanity-to-man" reasons why a congressman should resign or be tossed out.

Of course, we don't have to make that choice. Congressmen should be ousted for both murder and adultery (not to mention the others). Even in jaded Europe, politicians still resign because of sex scandals with interns. At least they have some shame left. But here in America—where we're supposed to be leaders of the free world—I have to listen to Dick Morris joke that if all the adulterous politicians were removed from Congress, they couldn't hold a quorum.

OK, that's funny for a second. Then you want to cry. These are among the most powerful men and women in the world. Since when is betraying spouse and family no big deal? Since when is leading a lying, double life—tiptoeing around elevators in disguise—an acceptable way for our leaders to conduct their private lives? That's the real scandal.

Try this on for size: While it's true that adultery isn't against the law, our culture should still reject it and view it as something devastating to family structure—which it absolutely is. We should find adultery intolerable in our midst—and especially among our political leaders. Let's face it, any nation that wants a future in this world must protect its social integrity.

And yet, step by step, we keep lowering the moral bar for our leaders—not a smart thing for a free society that depends on its leaders to be honest

brokers. It seems to me that adultery—especially with interns—is a good place to draw the line when it comes to private perversions. Of course, there's really nothing private about it, as Condit is learning.

What is adultery at its core? It's gross dishonesty directed at the very people who depend on your honesty the most—your family. Adultery is "breach of trust" in the extreme. You made a commitment in the form of a serious pledge to your wife or husband and your children—adultery makes that pledge a pathetic joke. Adultery says that the honor of your family is no big deal. Adultery says you have no self-control, or worse you don't want it.

But, meanwhile, pundits like Dick Morris would have us believe that people who betray their families by night are, by day, completely honorable with their constituents, their fellow politicians, and their staff (not counting interns).

In this post-Clinton era, we increasingly encounter this "laissez affair" attitude—adultery apologists tell us personal behavior does not affect public policy. What, are they nuts?

A case could be made that not only does private behavior affect public policy—private behavior *is* public policy. Not all politicians live by polls. Most of them actually believe in and live by their votes. How do we think divorce got to be so accepted in American society? Do we really think our political leaders back then had no personal ideas about divorce in their own lives? Can you think of any politician who is gay who stands firm against gay rights—or imagine pot-smoking politicians fighting to keep their habit illegal? Private behavior is not only relevant in our national dialogue, it is the key to understanding what's happening in America.

And it's not just our politicians. More and more Americans are excusing their personal "dalliances". There's that word the pundits love—as if adultery's not so bad when it's called a dalliance or how about "peccadillo". I left church that Easter Sunday and spent the afternoon at the White House having oral sex with an intern half my age, but it's OK, honey, cause it's just my peccadillo at work. We can tell the children it was a dalliance, dear, a little hanky-panky, just an extra-marital affair; that's all.

The rationalizations are getting incredible. I had one guy call my *WABC* radio show last week and tell me that he had to have an affair because it was the only way he could stay sane in his unhappy marriage. That's the culture talking through us. No, he didn't have to have an affair—he chose to have an affair because he thought it would give him something extra. Maybe it did—maybe it didn't. [MM: See your doctor and get tested to find out!] The point is that if we can't be faithful to our spouses, we'll have no social structure that will last—no culture with any wisdom—and no hope for our young.

Fewer and fewer children come from two-parent families. No surprise. Before long we are going to be a country of basket-case kids, who become basket-case, voting adults.

We need a national dialogue—an honest one—to ask some *hard* questions. I have a friend whose particular Jewish tradition requires arranged marriages—and guess what? They have a much lower divorce rate. What is it that they know that we don't

know? Now I'm not suggesting arranged marriages, but let's at least have the courage to understand why their culture works the way it does. What can we learn from them? [MM: Certainly, very little!]

First, the young obviously honor their parents and trust their advice. Second, they come from a strong culture and faith that absolutely frowns on adultery (intolerant, aren't they?). But third, and perhaps most important, they enter their marriages with a different attitude than we romantics who expect never-ending happy days of marital bliss. They marry to love and serve each other. It's about life and love—not pleasure and happiness.

We want our politicians to serve us honorably in just this way—to have an understanding that next to their families, we are the most important duty in their lives. Our warriors are expected to sacrifice their lives for us, but all we ask of our political leaders is that they be self-sacrificing in the duties of their office. Second to their families, they should be honor-bound to us.

I guess that's the point, isn't it? If we are second in importance to their families and they break faith with their families, then where does that leave us? **Condit should resign as a matter of honor. But, of course, that requires having honor in the first place. He's already traded that away for a little pleasure, a little fleeting happiness. Now he's lost both—his honor and the pleasure that was so important to him.**

I wonder how he'll vote if his constituents in Modesto, Calif., decide that people should be able to sue for damages in civil court when their spouses commit adultery. Of course, we all know personal behavior doesn't affect public policy, don't we?

Our letter-writing campaign to Congress has gotten some interesting results—another letter of explanation from Federal Reserve Chairman Alan Greenspan and, more interesting still, a memorandum from one of the Fed's top lawyers asserting that he can't remember anything about the crucial issue we have been pressing with the Fed lately, an issue he is documented to have been involved with.

Greenspan's latest was sent to Kentucky U.S. Sen. Jim Bunning and was prompted by an inquiry from GATA supporters in that state, Mr. and Mrs. Rupert C. Raymond, to whom we are deeply grateful.

Below are Greenspan's letter, the memorandum that accompanied it from the Fed's lawyer, and some comments from GATA Chairman Bill Murphy.

I think this new correspondence suggests that the Fed is trying to push onto the Treasury Department all responsibility for the scheme to suppress the gold price and to cover up the traces of the Fed's own awareness of the scheme.

We'll continue to press for more complete answers. But GATA's supporters in the United States can help us by sending to their U.S. senators and representatives the questions we recently proposed putting to them. You can find them here:

Thank you for your recent letter requesting information related to an inquiry received from two of your constituents, Mr. and Mrs. Rupert Raymond. The Raymonds' letter principally concerns remarks made at a January 1995 meeting of the Federal Open Market Committee (FOMC) by Virgil Mattingly, in his capacity as general counsel to the FOMC. A memorandum addressed to me from Mr. Mattingly on this matter is enclosed for your information. The memorandum responds to the matter raised by the Raymonds in their letter.

I would like to take this opportunity to confirm the statements I made last year regarding the Federal Reserve and gold in a letter to one of your colleagues, Sen. Joseph Lieberman. In that letter I said:

"The Federal Reserve owns no gold and, therefore, could not sell or lease gold to influence its price. Likewise, the Federal Reserve does not engage in financial transactions related to gold, such as trading in gold options or other derivatives.

Most importantly, the Federal Reserve is in complete agreement with the proposition that any such transactions on our part, aimed at manipulating the free price of gold or otherwise interfering with the free trade of gold, would be wholly inappropriate."

These statements accurately reflect the facts and longstanding Federal Reserve policy with respect to gold.

I hope this information is helpful. Please let me know if I can be of further assistance.

This memorandum responds to your request for information related to recent inquiries the Federal Reserve has received regarding remarks I made at a January 1995 meeting of the Federal Open Market Committee ("FOMC") in my capacity as general counsel.

These inquiries focus primarily on a statement attributed to me that appears on Page 69 of the published transcript of the January 31-February 1, 1995, FOMC meeting to the effect that the Exchange Stabilization Fund ("ESF") has engaged in "gold swaps". Given the passage of time, some six years, I have no clear recollection of exactly what I said that day—but I can confirm that I have no knowledge of any "gold swaps" by either the Federal Reserve or the ESF. I believe that my remarks, which were intended as a general description of the authority possessed by the Secretary of the Treasury to utilize the ESF, were transcribed inaccurately or otherwise became garbled. The Federal Reserve's lack of involvement with gold and gold-related financial instruments is set forth accurately in your January 19, 2000 letter to Senator Lieberman, a copy of which is attached. My remarks should not be interpreted as modifying in any respect what is set forth in that letter.

With respect to activities of the ESF, I note the Treasury Department stated in a recent federal court filing that the ESF has not held any gold since 1978. [END]

Here's my take on the Alan Greenspan/Virgil Mattingly matter:

* Greenspan most certainly presided over this 1995 FOMC meeting and does not want to deal with the truth and the facts. Thus, he turned to Mattingly.

* Greenspan does not want to discuss the gold swaps and what is really going on with America's gold, so he hid behind Mattingly.

* It appears that Greenspan has not responded to anyone since his response to Senator Lieberman 18 months ago. GATA's stepped-up letter writing to members of Congress has him backpedaling.

* It is clear that Greenspan briefed Mattingly on the response he should make, as by supplying Mattingly with a copy of his letter to Lieberman and the Fed's party line.

* Mattingly, an accomplished lawyer, is full of it. His response does not pass the smell test. GATA has the transcript of the 1995 FOMC meeting. Was it "garbled" or "transcribed inaccurately"? No way! Here's the quotation attributed to Mattingly:

"It's pretty clear that these ESF operations are authorized. I don't think there is a legal problem in terms of the authority. The statute [31 U.S.C. s. 5302] is very broadly worded in terms of words like 'credit'—it has covered things like the gold swaps—and it confers broad authority."

What do you think?

* There was no letterhead on Mattingly's memo, nor did he sign it. Did Mattingly even write it in the first place?

* Mattingly has Reg Howe's lawsuit on his mind, as noted in his memo to Greenspan.

* Once again we see the line from the Treasury Department's response to the lawsuit: "The ESF has not held any gold since 1978."

This represents more disinformation, using Clinton-type "definition of is" language. Maybe the ESF has not "held" gold since 1978—but it surely has been dealing in it, based on all the evidence the GATA camp has uncovered and published.

It appears that the U.S. Government is engaged in a massive gold market cover-up for its manipulation of the price of gold. Fortunately, due to the pressure GATA supporters are putting on the government, the anti-gold cabal is making more and more mistakes. As each week passes, they are looking more like "The Gang That Couldn't Shoot Straight".

They certainly are incapable of giving the "straight scoop" to members of Congress and other inquirers.

Greenspan's response to Senator Bunning sidesteps some questions asked by the Raymonds, specifically whether "gold swaps" were discussed at the FOMC meeting at issue.

Let us review the incriminating FACTS regarding the cover-up. Please review Reg Howe's latest essay, "Judicial Holding Pattern: Giving the Defendants Plenty of Rope", at www.GoldenSextant.com.

* The Fed has suddenly stopped reporting gold held by the ESF. That means that we can no longer monitor:

* Discrepancies between the Fed's gold certificate account, which by law must include certificates for all gold held by the Treasury, and the total U.S. gold stock, including gold held by the Exchange Stabilization Fund, reported in the *Federal Reserve Bulletin*. By definition, these discrepancies reflect positive or negative month-end gold balances at the ESF—and thus necessarily imply corresponding gold-trading activities by the ESF.

* Close inspection reveals extensive trading activity in the summary of financial statements for the ESF, which are included in the quarterly *U.S. Treasury Bulletins*. Yet Treasury Secretary O'Neill said the following to U.S. Rep. Ron Paul at a meeting of the House Financial Services Committee:

"My memory is that last year there was one transaction. It was a fairly small transaction involving an agreed intervention vis-a-vis the yen. It was the only transaction last year, I can assure you."

* That does not fly. As Reg Howe comments about O'Neill, "He says nothing to explain how this 'one... fairly small transaction' produced significant trading losses at the ESF in the two quarters preceding it, or why it caused such a large loss in fourth."

* In September 2000, more than 54 million ounces of gold, reportedly held at the U.S. Mint at West Point, N.Y., were switched from the "Gold Bullion Reserve" category to "Custodial Gold Bullion" (in the report of the Financial Management Service/Department of the Treasury Website) without footnote or explanation. **This amounts to the apparent loss of gold ownership of more than 20 percent of the total U.S. gold reserves previously thought to be part of our national asset base. The term "reserves" obviously connotes ownership, while the connotation "custodial" refers to taking care of another's property.** The 48-million-plus ounces at the U.S. Mint at Denver, Colo., continued to be reported as "Gold Bullion Reserve".

This reporting was both before and after the September reclassification of gold at the U.S. Mint at West Point—and no other "custodial" positions for any other location have ever been reported.

To further confuse the issue, the categories of "reserve" and "custodial" gold have both been eliminated as of the May 2001 report. Both categories were consolidated and are now labeled "deep storage gold".

Could the "duck" story ever be more appropriate? That is, if it looks like a duck, quacks like a duck and walks like a duck, it most likely IS a duck. **Well, Greenspan and O'Neill are ducking questions about what the United States is doing to manipulate the gold price. Gold acts like it is being manipulated, looks like it, and the "quacking" Abbot-and-Costello "Whose on First?"-type reactions by the U.S. Government to cover up its gold market activities are evidence that GATA is correct and has them nailed.**

This is a national disgrace. No wonder Senator Bunning, a Baseball Hall of Fame pitcher, said the following at the hearing on the nomination of Roger W. Ferguson Jr. on June 13, 2001:

"Mr. Chairman, I would like to thank Dr. Ferguson for testifying today and I would like to thank you for holding this hearing. Dr. Ferguson, I appreciate your coming to see me last week. I think we covered a lot of ground. As you know, I expressed my strong concerns with the Fed talking about the financial markets. Obviously, every time the chairman speaks, the markets listen. But I am concerned that the Fed has tried to influence market levels...."

Senator Bunning is a man for GATA supporters to focus on, as he is a member of the Senate Committee on Banking, Housing and Urban Affairs. He is also chairman of both the Subcommittee on Economic Policy and the Subcommittee on Financial Institutions and the Subcommittee on Securities, which oversees banking, insurance, securities, and consumer protection.

Might Senator Bunning finally be the politician who will not stand for these un-American activities—and seek out the truth and confront this nonsense?

* Neither former Treasury Secretaries Rubin and

Summers, nor Treasury Secretary O'Neill, have addressed any member of Congress in writing regarding any questions asked of them regarding gold. No one at the Treasury has yet answered any questions regarding what prompted the September reclassification of the gold at West Point to "custodial" status, or, more specifically, whether this changed status indicated that the gold had been committed to one or more swap transactions.

Could it be any more obvious that they are hiding something? The lessons of Watergate have gone for naught. It seems that the U.S. Government is proving GATA's case for us. It certainly is easier now for the average layman to understand that something is VERY wrong. Why else would the Treasury and the Fed be jumping through hoops to avoid telling the simple truth?

The cover-up of the Watergate burglary is what did the Nixon administration in. This cover-up is far more serious as it affects many governments and the economies of the poor gold-producing nations and perverts the integrity of the American financial system. It also makes a mockery of our justice system and rule of law.

Is this the America you want your children and grandchildren to inherit? If not, keep the pressure on the Treasury and Greenspan by contacting and re-contacting your senators and representatives about the gold cover-up. Our tactics are working. The U.S. Government is out of control on this one. Fortunately, their "slip is showing". GATA's "enveloping horn" has them staggered. We must keep the pressure on them and we will.

A LIGHTNING BOLT OF REALITY— THE UN THREAT TO AMERICA

Is the United Nations threat to American freedoms genuine? For years, I shrugged such a farfetched notion off. I would listen patiently to very earnest folks who spouted a seemingly endless stream of dire warnings about global and One World Government. I reckoned they had fallen under the influence of the conspiracy conjecturers and spent too much time reading spy thrillers and watching science fiction.

As I researched the plight of farmers, ranchers, miners, loggers and other people who made their living from the land, it became apparent that their livelihoods and homes were being annihilated by international treaties and agreements. Global pacts hidden darkly in the background apparently drove major federal government actions that were hostile to people who work the land.

The first lightning bolt of reality exploded into my dumbed-down brain when a very knowledgeable scholar gave me a copy of a 1972 environmental law paper by the International Union for Conservation of Nature and Natural Resources (IUCN) Morges, Switzerland. In the IUCN paper, *The Easement as a Conservation Technique*, chapter two, titled, "The Need for Conservation Easements in the United States" explains how governmental agencies can regulate private property without owning or paying for it. It also suggests that CE's are a method for Non-Governmental Organizations (NGOs) to achieve regulatory authority. It further explains how state and federal constitutional private property rights laws could be circumvented.

In researching the IUCN I found that they are the environmental agency of the United Nations, bringing together 76 states, 111 government agencies, 732 NGOs, 36 affiliates and some 10,000 scientists and experts from

181 countries. Their membership list of signatory American agencies and NGOs has dumbfounded me.

U.S. agencies with IUCN membership and providing funding include: Department of Agriculture; Forest Service; Department of the Interior; National Park Service; U.S. Agency for International Development; National Oceanic and Atmospheric Administration; Department of Commerce; and Department of State.

A very few of the many IUCN NGOs members are: The Nature Conservancy; Defenders of Wildlife; Environmental Defense Fund; National Audubon Society; National Parks and Conservation Association; National Wildlife Federation; and Natural Resources Defense Council. In fact, almost all of the Major NGOs who are wreaking ruin on proud and productive Americans are IUCN signatories.

Further research proved that The Tax Reform Act of 1976 incorporated principles favorable to the IUCN vision. Virtually, elements of the act were a rubber stamp of the IUCN agenda. Simply summed up, their agenda is global environmental regulation. To regulate the world environment, they must, of course, regulate the people.

I followed that thread into the spool and stumbled on a United Nations Website, U.N. Protected Areas in the United States. The Website contained 129 fine-print pages of U.N. Protected areas in America! 129! Millions upon millions of acres of our country are listed. Those protected areas are regulated by the IUCN. When I compared the U.N protected areas to regions that are under fire from federal regulators and environmental takings that force people from the land, I found they are the same.

Other documents also have severely unnerved me. The United Nations Program of Action of the International Conference on Population and Development produced a how-to-manual, *The Forced Relocation of Rural Populations*, which was distributed in Africa and included the stated mission, "To foster a more balanced spatial distribution of the population by promoting in an integrated manner equitable and ecologically sustainable development."

One of the concepts advanced in the U.N paper will ring true to countless rural Americans who helplessly watched their lives be destroyed by environmental regulations. "When rural resident inhabitants are denied access to the natural resources essential to their livelihoods, they will be forced by economics to relocate."

Our own government has two publications in print that will raise your hackles: The first, *Your Rights and Benefits as a Displaced Person* (Publication No. FHWA-PD-95-010) states, "Government programs designed to benefit the public often result in acquisition of private property and sometimes in the displacement of people from their residences, businesses, or farms." The other pamphlet, *Acquiring Real Property for Federal and Federal Aid Programs and Projects* (Publication No. FHWA-PD-95 005), spells out how the government can take your land. The U.S Government publications and the *U. N. Manual* have analogous themes.

The Endangered Species Act is a concrete example of the authoritarian power of international treaties over Americans rights and property. Read U.S. Code 16, Sec. 1531 (a) (4) Congressional Findings and Declaration of Purposes and Policy. You will find that the Endangered Species Act is conformable to and in accordance with:

- (A) migratory bird treaties with Canada and Mexico;
- (B) the Migratory and Endangered Bird Treaty with Japan;
- (C) the Convention on Nature Protection and Wildlife Preservation in the Western Hemisphere;
- (D) the International Convention for the Northwest Atlantic Fisheries;
- (E) the International Convention for the High Seas Fisheries of the North Pacific Ocean;
- (F) the Convention on International Trade in

Endangered Species of Wild Fauna and Flora; and

(G) other international agreements

In a mockery of the "advise and consent" responsibility placed upon the Senate by our *Constitution*, the U.S. Senate ratified 34 international treaties without debate, without a vote—and almost without notice during the 106th Congress.

So, am I hearing the flutter of black helicopter rotors and the goose-stepping tread of foreign troops? No. **However, the evidence that our freedoms are being methodically destroyed by federal agencies that kowtow to international powers is both concrete and public.**

The clamor to get America out of The U.N. is direly inadequate. If our country is to regain sovereignty, we must abrogate all international treaties and require that our federal bureaus withdraw from U.N pawn agencies.

STAFF EXPOSED TO LETHAL VIRUS AS LAB TRIES TO COMBINE HEP-C AND DENGUE

IMPERIAL College, London, renowned as one of Britain's leading research institutions, was fined £25,000 and ordered to pay more than £21,000 costs yesterday for exposing staff to a potentially lethal new virus for which there is no cure.

The college's "seriously flawed" approach to health and safety matters raised a distinct possibility that both hepatitis C and dengue fever could be released into the open while it was attempting to create a hybrid from the two.

Neither staff nor members of the public were adequately protected from the possibility that the man-made organism could have escaped, Blackfriars Crown Court in London was told.

Scientists, led by Dr. John Monjardino, failed to use sealed cabinets while studying the virus and made no emergency plan for dealing with a spillage. Staff at the college, part of London University, were not provided with protective clothing and had to walk through a room used as an office by other university employees in order to dispose of contaminated material.

Keith Morton, for the prosecution, said: "They were creating a hybrid virus for which no vaccine or treatment exists. Safety measures should have been of a very high standard to protect staff and the general public. They have shown a disregard for basic measures to ensure and monitor safety, as a consequence of which their employees were exposed to a very real risk of infection."

Contrary to expected procedures, the Health and Safety Executive was only notified that the research had begun when a researcher inquired about transporting the hybrid virus to Oxford. A subsequent inspection in December 1998 uncovered the potentially hazardous regime. While Judge David Martineau acknowledged that work on finding a vaccine for the two diseases was very important, there could be no excuse for such lapses, he said. Hepatitis C is frequently fatal, while dengue fever causes a severe but non-fatal reaction.

Imperial College admitted one count of "failing to apply principles of good microbiological practices and principles of good occupational safety and hygiene" under the Genetically Modified Organisms (Contained Use) Regulations 1992. It also pleaded guilty to one charge of breaching the Health and Safety at Work Act 1974.

The college and its safety advisers were each fined £20,000 in March for exposing the public to an "unacceptable risk" from the HIV virus. In 1998 it was fined £4,500 for exposing a worker to an "animal allergen".

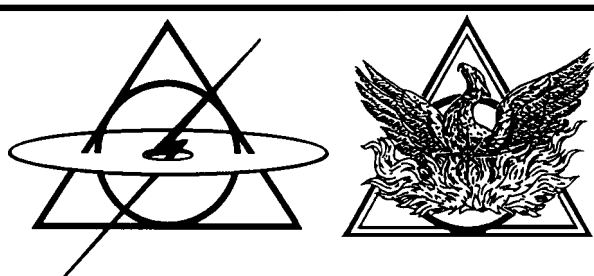
WORDS OF WISDOM FROM HATONN
