

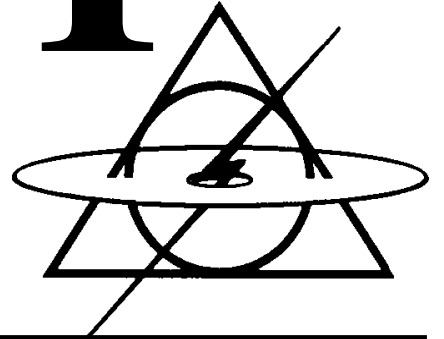

One tenet of the New World Order is to have a Cashless Society.

The Illuminati have well prepared the people for this with the electronically readable banker's and credit cards, telephone cards, insurance cards, petrol cards of the many oil companies, etc.

The masses were easily convinced of the advantages of this system by the argument that payment without cash is safer, simpler and more practical. This idea has just got to be thought through to the end. As soon as the people have a multitude of these electronically readable cards they will be told that it is much easier still and even more practical to have just one card instead of many.

This is the *debit card*, the so-called ONE CREDIT CARD FOR EVERYTHING, that has already been introduced in New Zealand, Australia and Canada. They still have the other credit cards, too, but the debit card is already in circulation.

Finally we will have a laser tattoo. Invisible to the eye, a *bar code* is tattooed onto the right hand or the forehead. The code on your hand then serves for payment, but in addition for identification. A *scanner* will read the code and all information needed is "at hand".

These are not ideas of the future, they are dead serious. The laser tattoo has been tested in Disneyland for fifteen years already. Persons who were going to stay several days were given the choice between a pass or a tattoo on the left hand. They wanted to see how people react to this and whether in time they would get used to it.

Official forms asking where the mark is preferred (F=forehead, H= hand) have been readied on an international level. These are tests to slowly get the people used to this before it becomes compulsory. As much as seven years ago Holland started to mark homeless persons with a laser tattoo on the forehead. The populace is told that in this way criminality, especially in Amsterdam, will be curbed. In the meantime laser tattoos have already been officially introduced in places. Saying that business travelers could be dealt with more efficiently, American airports have been equipped with scanners reading the invisible tattoo on the right hand. And the number using this *service* is constantly rising, because *time is money*.

You will not actually be forced to accept the tattoo, but you will not have much choice unless you are self-sufficient. At one point the shops will no longer accept cash. And the peoples will be shown just how safe this new method is. Theft is no longer possible, for where there is no money, none may be stolen. Every criminal can be found by satellite because of the laser tattoo, and it will no longer be possible to cross a frontier illegally.

This will really be the total control of humanity. Free will has no room any longer, every step is supervised, everything you do, you own, how much capital you have, where you are, what you buy and sell, every information can be called up by Big Brother. Make the effort and read George Orwell's book "1984", the planned new age slave system is very well described therein.

In the *Bible*, Revelation 13:13-18, we read:

Many observers in the U.S. have noticed the striking similarity of the programs offered to the public by the three "independent" television networks. For the first time, we present a detailed study of the directors of the three networks, revealing their interlocking banking and industrial connections, indicating that instead of three major networks we actually have only one.

NBC, a subsidiary of RCA, has the following directors:

John Brademas, President of New York University, Chairman of the Federal Reserve Bank of New York (which dominates the other Federal Reserve Banks by its control of the money market), and director of the Rockefeller Foundation. Brademas has received the George Peabody Award (George Peabody established the Peabody Education Fund which later became the Rockefeller Foundation), and he was named Humanist of the Year in 1978.

Cecily B. Selby, born in London, England, national director of the Girl Scouts, director of Avon Products and Loehmann's, a dress firm. She is married to James Coles, president of Bowdoin College since 1952.

Peter G. Peterson, former head of Kuhn, Loeb Co., and ex-Secretary of Commerce.

Robert Cizik, chairman of Cooper Industries (sales of 1.5 billion pounds), and director of RCA and First City Bankcorp. First City was identified in Congressional testimony as one of the three Rothschild banks in the United States.

Thomas O. Paine, president of Northrup Co., a large defense contractor. Paine is a director of the influential Institute of Strategic Studies in London, director of the Institute of Metals, London, American Ordinance Assn., and many other professional munitions associations.

Donald Smiley, Chairman R.H. Macy Co. since 1945; he is also a director of Metropolitan Life and U.S. Steel, known as Morgan-controlled firms, and director of Ralston-Purina Co., and Irving Trust.

David C. Jones, President of Consolidated Contractors, director of U.S. Steel, Kemper Insurance Co.

Thornton Bradshaw, Chairman of RCA, director of Champion Paper Co., Atlantic Richfield Oil Co., Rockefeller Brothers Fund, and the Aspen Institute of Humanistic Studies.

Although not listed as a director of NBC, Andrew Sigler is a director of its parent company, RCA. Sigler is Chairman of Champion Paper Co., and director of General Electric, Bristol Myers, and Cabot Corp. (which traditionally has had heavy CIA involvement).

Thus we find that NBC has many Rothschild and J.P. Morgan connections among its directors, who include the chairman of the key to our monetary control, the Federal Reserve Bank of New York and other directors associated with such Rothschild operations as Kuhn, Loeb Co., First City Bankcorp, and the Institute of Strategic Studies in London.

ABC-TV includes among its directors not one, but two, directors of J.P. Morgan Co.; Ray Adam, director

of Metropolitan Life, Cities Service, Morgan Guaranty Trust, and Chairman of the \$2 billion NL Industries, a petroleum field service concern; and Frank Cary, Chairman of IBM, director of Merck, J.P. Morgan Co., Morgan Guaranty Trust, and Merck Drugs. Chairman of ABC is Leonard Goldenson who is a director of Allied Stores, and the Advertising Council, and Bankers Trust. Other directors are Donald C. Cook, general partner of Lazard Freres banking house, director of General Dynamics, and Amerada Hess; Leon Hess, Chairman of Amerada Hess; John T. Connor, of the Kuhn Loeb law firm Cravath, Swaine & Moore, who was former Asst. Secretary of the Navy, president of Merck Drugs, U.S. Secretary of Commerce 1965-67, Chairman of Allied Chemical from 1969-79, director Chase Manhattan Bank, General Motors, Warner Lambert, and Chairman of J. Henry Schroder Bank, and Schrodgers Inc. of London; Jack Haisman, Vice Chairman of Belden-Heminway, a large goods manufacturer which was founded by Samuel Hausman of Austria; Thomas M. Macioce, Chairman of Allied Stores, director of Penn Central and Manufacturers Hanover Trust, one of the Rothschild banks in the United States; George P. Jenkins, Chairman of Metropolitan Life (a J.P. Morgan firm), director of Citibank, which has many Rothschild connections, St. Regis Paper, Bethlehem Steel, and W.R. Grace Co.; Martin J. Schwab, Chairman of United Manufacturers, and director of Manufacturers Hanover, a Rothschild bank; Norma T. Pace, who is also director of Sears Roebuck, Sperry, 3M and Vulcan; Alan Greenspan, consultant to the Federal Reserve Board, director of J.P. Morgan, Morgan Guaranty Trust, Hoover Institution, *Time* and General Foods [**H: WE ALSO KNOW THAT HE NOW AND HAS FOR QUITE A WHILE, HEADED THE FEDERAL RESERVE.**]; Ulric Haynes Jr., director of the Ford Foundation, Marine Midland Bank (which is owned by the Hong Kong Shanghai Bank), Cummins Engine Co., and the Association of Black Ambassadors.

Thus we see many J.P. Morgan and Rothschild associations among the directors of ABC which was recently purchased by Capital Cities Communications Co., whose chairman is Texaco [?], whose most prominent director is Robert Roosa, senior partner of Brown Bros. Harriman, a firm with close ties to the Bank of England. Roosa headed the Roosa Brain Trust at the Federal Reserve Bank of New York which produced Paul Volcker. Roosa and David Rockefeller were credited with selecting Volcker to be chairman of the Federal Reserve Board. John McKinley, Chairman of Chase Manhattan Bank; and Thomas Aquinas Vanderslice, who is Chairman of the electronics firm GTE, and a former Fulbright Scholar who is now trustee of the Aspen Institute of Humanistic Studies.

Of the three major networks, CBS is the pillar of the "Establishment". Its financial expansion for years was directed by Brown Bros. Harriman, whose senior partner, Prescott Bush, was a longtime director of CBS. (His son, George, later became Vice-President and President of the U.S.) When General Westmoreland sought to recover damages from CBS for a vicious personal assault on his reputation, Westmoreland seemed certain to win a stunning victory, until CBS brought in former CIA officials who testified that Westmoreland's claims had no basis. George Bush was formerly HEAD of the CIA. Westmoreland surrendered, and withdrew his suit.

Ted Turner's expressed intention of buying control of CBS was applauded by millions of patriotic Americans, who had endured its vicious assaults on decent Americans with no means of protest. However,

Turner's campaign was viewed in London as a direct attack on the power of the Bank of England and its American subsidiary, Brown Bros. Harriman. Turner was finally deterred from his goal by a clever manoeuvre which diverted him into purchasing MGM-United Artists, one of whose directors is Alexander Haig, former White House intimate and Secretary of State, later chairman of United Technologies. Turner believed he was buying MGM's extensive library of films for his WTBS channel, but the Wall Street Journal later chortled that he had been tricked, and that most of the film library had been sold before he negotiated for MGM. To finance his purchase of MGM-United Artists, Turner intended to borrow 515 billion [?] through Drexel Burnham Lambert, the American branch of the Banque Bruxelles Lambert, the Belgian branch of the Rothschild operations.

CBS is a \$4.5 billion a year operation, which banks through the Morgan Guaranty Trust Co. William S. Paley, heir to a cigar fortune, has been chairman of CBS for many years. To those who do not know of CBS' many CIA and British Intelligence connections, he is supposed to run it as a one-man operation.

Directors of CBS are Harold Brown, who was Secretary of the Air Force from 1965-69, Secretary of Defense from 1977-81, and is now executive director of the Trilateral Commission;

Roswell Gilpatric, who has been with the Kuhn Loeb law firm of Cravath, Swaine & Moore since 1931, and served as director of the Federal Reserve Bank of New York from 1973-76;

Henry B. Schnacht, chairman Cummins Engine Co., director of AT&T, Chase Manhattan Bank, Council on Foreign Relations, Brookings Institution and Committee for Economic Development; Michel C. Bergerac, Chairman Revlon, director Manufacturers Hanover; James D. Wolfensohn, former head of J. Henry Schroder Bank; Franklin A. Thomas, head of the Ford Foundation; Walter Cronkite; Newton D. Minow, director of Rand Corp., Pan American, Foote Cone & Belding;

Marietta Tree, director of Winston Churchill Foundation, Ditchley Foundation, U.S. Trust, and Salomon Bros. She is a granddaughter of Endicott Peabody, founder of Groton, which trains America's elite. She married Ronald Tree, a high official of British Intelligence, and godson of Marshall Field. She and her husband gave an ancestral estate, Ditchley Park, to the Ditchley Foundation. Located near Cambridge, it was W. Averell Harriman's headquarters during World War II when he coordinated the partnership of Franklin D. Roosevelt and Winston Churchill, who actively disliked and distrusted each other. They usually checked with Harriman before agreeing to any action. The Ditchley Foundation serves as a conduit for instructions to many American groups from the Tavistock Institute, an arm of the British Army Institute for Psychological Warfare. Marietta Tree's career gave rise to the term "beautiful people", to describe members of the glittering international set that represented the operations of the World Order. She began working for Nelson Rockefeller in 1942, and later served as Ambassador to the United Nations.

One victim of the CIA-British Intelligence operations at CBS was Roger Mudd, generally considered the brightest star among television reporters. A direct descendant of Dr. Samuel Mudd, who spent years as a political prisoner after the Civil War, Roger Mudd had a brilliant 19-year career at CBS, but was passed over as successor to Walter Cronkite in favour of Dan Rather. The excuse was that he was not "vicious enough", but the real reason was the he had "sand-bagged his chances" (according to the Wall

Street Journal) in 1980 when he conducted a revealing interview with Teddy Kennedy which destroyed Kennedy's chances of being elected President.

Because of continuous Tavistock Institute-British Army Institute of Psychological Warfare control over the major television networks in the United States, ABC, CBS, and NBC present many programs heavily slanted in favour of psychiatry. They also emphasize the current "liberal" preoccupation with racial integration, crippled persons (who represent less of a threat to the mauling parasites), sports programs, and jiggle shows (also known in the trade as "t and a shows").

Although the three networks are supposedly in bloodthirsty competition with each other, viewing of the daily evening news programs reveals that each of the competing networks shows exactly the same items of news each evening, usually in the same order. Almost all of the "news" stories are propaganda items intended to further current World Order goals. The only variations permitted in the iron control over network TV news is the final item, which is a "human interest" story. It usually praises a child who has collected considerable sums of money for UNICEF, or some other World Order operation.

For many months, the three "independent" networks have emphasized a hate campaign against South Africa on their evening news presentations. One could hardly believe that they are attempting to "conquer" South Africa for the World Order, because the Rothschilds and Oppenheimers won control of the rich South African gold and diamond fields in the Boer War of 1899. Today, DeBeers, the diamond monopoly, is operated by Oppenheimer and the Rothschilds, as is the gold mining, exemplified by their ownership of the giant Anglo-American Corp. of South Africa Ltd. Apparently, the parasites would like to exterminate the Boer population of South Africa, which has lived there for three centuries, and replace it entirely with black workers. Some observers might call this "genocide". Each evening, the three networks outdo each other in their campaign of vilification of the white citizens of South Africa. The rioting and looting committed by the blacks, as well as the vicious murders of their fellow blacks, are glossed over by the news reports as inevitable results of "white oppression". As usual, there is a more immediate benefit gained from this continuous propaganda barrage. The Rothschilds have profited enormously from currency speculations in the rand, i.e. the South African "dollar". In a few months, they were able to drive the rand down from a value of \$1.35, to thirty-five cents, selling short all the way. On September 2, 1985, they ran it back up a full ten cents, from thirty-five to forty-five cents. This might seem small change to non-investors, but it has paid off handsomely for the speculators. The fact that the network hate campaign continues unabated suggests that there is still plenty of money to be made in the rand.

On July 31, 1985, the Chase Manhattan Bank announced it would not renew any loans to South Africa. *Businessweek*, Aug. 12, 1985, reported that this threw South African business into a panic. The bankers then demanded that South Africa give blacks the vote. Gavin Relly, chairman of the giant Oppenheimer-Rothschild conglomerate, Anglo-American Corp., tried to force Botha's government to accede to these demands. Botha refused. Relly then went to Zambia to negotiate with the Communist-dominated African National Congress, preparatory to turning South Africa over to them.

The similarity of the major networks evening "news" programs has given rise to a report that, each day, a list of ten or twelve "acceptable" news stories is prepared

by British Intelligence in London for the networks, teletyped to Washington, where the CIA routinely approves it, and then delivered to the networks. The “selectivity” of the broadcasters has never been in doubt. Edith Efron, in *The News Twisters*, (Manor Books, N.Y., 1972) cites *TV Guide's* interview with David Brinkley, April 11, 1964, with Brinkley's declaration that “News is what I say it is. It's something worth knowing by my standards.” This was merely vainglorious boasting on Brinkley's part, as he merely reads the news stories previously selected for him.

Efron concludes this important book, which was refused by all the major New York publishers, as follows:

“The networks actively slanted their opinion coverage in favour of the black militants and against U.S. policy on the Vietnam war.

“The networks largely avoided the issue of violent radicals.

“The networks actively favoured the Democratic candidate, Hubert Humphrey, for President over his Republican opponent, Richard Nixon.”

Efron could not foresee in 1972 that, having lost the election to Nixon, the networks would engage in a successful bid to negate the election and drive him from the White House through their trumped up “Watergate” campaign.

It seems incredible that there are literally thousands of interesting and vital news items from all over the world available to the networks' evening “news” programs, and yet they are restricted to the ten or twelve stories approved by London. The American public has known for years that something was amiss. As cable programs became available, there were mass defections from the networks propaganda vehicles. Some authorities report that the three networks have lost 40% of their viewing audience, although they are desperately trying to conceal this. If forced to revise their advertising rates accordingly to their actual viewing audience, they would be technically bankrupt, as their revenues would not cover operating expenses.

Television is a medium of light. It is a reflection upon all of us that we have allowed it to be taken over by the forces of darkness. What has been taken from us can't be regained. Taxation is the medium by which the parasites maintain economic control over us because we refuse to admit the obvious fact that “Taxation is the price we pay for irresponsibility”.

We advise Americans to go to the United States Attorney and ask for an investigation of Criminal Syndicalism. We have exposed in great detail the interlocking Rockefeller Foundation, Ford Foundation and Federal Reserve control of television and the goals of the World Order which they espouse. There are adequate laws on the books which forbid all of these activities. Corpus Juris Secundum 46, Insurrection and Sedition, sec. 461c, “Sabotage and syndicalism aiming to abolish the present political and social system, including direct action and sabotage.” Corpus Juris Secundum 46:462b, “Statutes against criminal syndicalism apply to corporations as well as to individuals organizing or belonging to criminal syndicalist society; evidence of the character and activities of other organizations in which the accused is a member or is affiliated is admissible.” This means that any of the networks presenting a program inimical to the interests of the American nation, and seeking to change its character to that of a “1984” style dictatorship, can be charged under the law of the United States.

Corpus Juris Secundum 22A identifies Criminal Syndicalism: “In a prosecution for being a member of an organization which teaches and abets criminal syndicalism, evidences of crimes committed by past or

present members of the organization in their capacity as members is admissible to show its character,” *People v. LaRue*, 216P627CA276. This means that you can introduce into a charge of criminal syndicalism any information about activities of any organization with which any director of any television corporation is involved. Look into it! **[H: Ah, BUT, who is there of you brave enough to send the very best—yourself?]**

So, now you know who owns the three biggest American TV companies, and you can't deny that there is—obviously not accidentally—a Jewish banking background. But let's have a look at who founded them, and everything will make even more sense:

National Broadcasting Company (NBC): David Sarnoff  
Columbia Broadcasting Service (CBS): William S. Paley  
American Broadcasting CO. (ABC): Leonard Goldenson

**[H: We have been given no “ending” to Mr. Mullins' writing, so we leave it to you to sort it as readers; however, I suspect it is along about here.]**

If you now remember the “Mosaic Law”, the phrases we read out of the *Talmud* as well as the *Protocols*, you will understand why so much rubbish comes out of Hollywood and pollutes the world (horror, violent action movies, porno, computerized-off-nature kids... everybody knows what I mean). If somebody would be interested to enrich the world, he wouldn't produce horror movies or other violent stuff. Whatever comes out of Hollywood is never the truth. They turn history around to make people believe what they want them to believe. (They make the king Richard Lionheart who really was a cruel slaughterer a fatherly ruler.)

“By their deeds ye shall know them.”

Well, at least I have recognized them by their deeds, understand what they are up to and why they are up to it. Have you recently heard about a second Goethe or Mozart or Hesse coming out of that scene? No? Neither have I. Have you ever thought about why there are no people of genius coming out of our youth anymore? Most of them are TV addicts and TV believers and just repeat what they've been told in their schoolbooks. Most of them like to drive big cars and eat fast-food junk, and they are not even interested in a technology that would make their cars run twice as fast with no gas at all. Perhaps you can imagine that I'm not very happy to know that much stuff at my age. I'm pretty much by myself, even though I have traveled extensively on five continents. There's almost nobody I've met, not even among grown-ups, who is able to confront the coming situation without fear, consciously and responsibly, because most people don't know who they are, what they are here for and what life is all about.

3. *He (the Beast) also forced everyone, small and great, rich and poor, free and slave, to receive a mark on his right hand or on his forehead, so that no-one could buy or sell unless he had the mark, which is the name of the beast or the number of his name.*

*This calls for wisdom. If anyone has insight, let him calculate the number of the beast, for it is man's number. His number is 666...*

In the Cabala, as in the Tarot Card VI, The Lover, the number 6 symbolizes Temptation, the way from the spiritual into the physical, whereas the number 9, the number of wisdom, symbolizes the way back from the physical towards the spiritual.

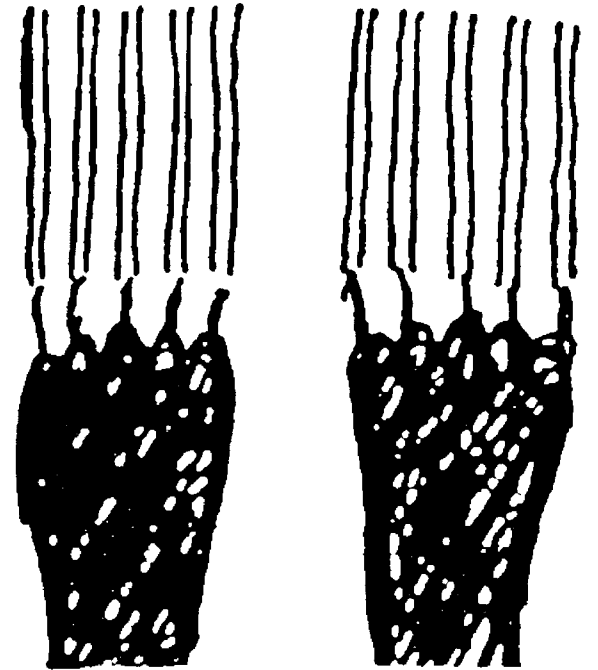
The Hopi Indians of North America have a prophecy that states:

“No-one will be able to buy or sell if he has not the mark of the Bear. When this mark will be visible, the third Great War will come.”

**[H: There is a diagram which shows the interpretation of this prophecy and should be placed here.]**

### One way of interpreting the prophecy

The mark of the Bear looks like this:



Now compare this with the bar code:



Imagine that the Hopi Indian was shown a vision several hundred years ago in which he sees a bar code. Since he naturally is unfamiliar with today's name for it, he describes it as looking like the traces a bear leaves when he sharpens his claws on a tree.

The bar pattern on the products have several lines that depending on thickness and spacing stand for a specific number whereby the product and its price can be identified.

You can see the twelve shorter double lines, like the tracks of the bear's claw, six to the left and six to the right (in the beginning there used to be only five). In addition there are THREE longer lines, left, centre and right. If you now look for a 6 in the short lines and compare it with the long, you will see that the longer ones also each represent 6. The three longer lines are always the same in every bar code all over the world, only the short lines change. The computer hence always reads 666.

And I promise you that if things don't drastically change, and soon, we will soon be unable to buy anything without a bar code. And then, sooner or later, you will have it on the hand or on the forehead.

The largest computer in the world to which all others are linked stands in Brussels, and it is called “La Bete” (The Beast).

It is easy to solve the problem of *how to force the bar code upon the people*. Instead of occasional small economic crises the international bankers will now start a worldwide crisis that will be the worst we ever suffered. This event will be used to introduce a single world currency, a world bank with absolute control and payment without cash. Once the world's banking systems have all collapsed, there will be no alternative to the debit card and people will have to accept it. The only way around the card and a subsequent tattoo is to be self-reliant, to have some gold and silver and to produce something (agriculture and crafts) to barter with others. Thus it is indispensable to live in the countryside for leading an independent and self-sufficient life is all but impossible in a city.

**[H: I can't help but interrupt here to emphasize what was just stated above. And also I must point out that you who walked with me (us) and assisted in project possibilities have now turned and run after the very ones who are costing you everything you worked to accomplish—even to the farm which was leased and for which storage was given facility. Through misuse and theft the first tenants took value which left little for actual "farming" and/or research on our special grains, etc. Now we have had to forfeit the land itself and only retain the buildings thereon to preserve a place for working as in "office" after losing the center in town. It is also continuing to be leased to TRY to preserve the stored grains and other items for which the farm was under purchase agreement as well as retain the use of wells for irrigation. We do not have enough funds currently to cover the rental payments.**

So, when "cause and effect" is considered, it is hoped that you all will each remember the effect was CAUSED by your lack of foresight as you tipped down the primrose path with your declared ENEMIES and users. You want God to offer and give you security and you are not patient enough to even work in your own behalf as you blame and shame the ones who have stayed the course. Is it not time you people start looking at the picture and DOING something positive to assure selves some protection and assistance? Can we get the land back into our care? Not many of those who stayed the course want the further beatings of heart and mind. Many of YOU have literally supported the adversary DIRECTLY. What yet do "we" owe to you who have lied, cheated and thieved from us? Oh, indeed, you have been fooled into aiding and abetting the *Spectrum* group, as a for instance, and have cast a shadow of great hurt as you serve "the beast". So be it—for those choices are of your own discretion.

However, where will YOU go when the fire from the sky falls? What will you eat with no land to till or seed to grow? It is time you get serious about these things, for these writings are old and outdated—you are now in the final stages of the take-over and you still blame God and Brother. Look at self and perchance you'll see your brother differently.]

**Another interpretation of the number 666**

This is numerology, the calculation of the name. As stated in the excerpt from the *Bible*, this concerns the number of its name (the Beast's). According to the Cabala every letter corresponds to a number. Every letter and

every number in turn has a specific meaning or character. If I know the meaning of the numbers, I can determine from the calculated number character and fate.

666=6+6+6=18. The 18 corresponds in the Cabalistic numerology to confrontation with emotion, secrets, falsehood, lies, egoism, criminality, destruction, accident-prone, general difficulties, illness, danger...

The eighteenth Tarot card is "The Moon"

This card symbolizes emotion, grief, solitude, illness, accident-proneness, dreams (difficult times).

I took this numerological deciphering of the name of Karl von Habsburg from an Australian book called *The United States of Europe*. The author, a devout Christian, describes the Habsburg dynasty with their deeds. He tries to prove that the Holy Grail is not—as hitherto assumed—a vessel that had contained the blood of Jesus but rather the lineage with the blood of Jesus. He further states—as do Baigent, Leigh and Lincoln in their book *The Holy Blood and the Holy Grail*—that Jesus was not only married but had also fathered children. The marital status of Jesus is one of the great secrets of the *Bible*, he says. And in Judaism this is strange behaviour indeed.

From the Gospels, he writes, it is known that a large number of his disciples had been married (Peter for instance) and Jesus taught just that. In the Gospel of Matthew 19:4-5:

"Haven't you read, that at the beginning the Creator 'made them male and female', and said, 'for this reason a man will leave his father and mother and be united to his wife, and the two will become one flesh'?"

Marriage was compulsory according to Jewish custom. The unmarried state was severely judged. If Jesus had not been married, he would not have been accepted by the Jewish people as he was, and this kind of break with Jewish tradition would have found some mention in some of the gospels. Further Jesus was called *Rabbi* by his disciples. And the Jewish law of the Mishnah clearly states that an unmarried man cannot be a rabbi.

Baigent, Leigh & Lincoln add:

"Underlying most Christian theology is the assumption that Jesus is God incarnate. In other words God, taking pity on His creation, incarnated Himself in that creation and assumed human form. By doing so He would be able to acquaint Himself at first-hand the vicissitudes of human existence. He would come to understand, in the most profound sense, what it means to be a man—to confront from a human standpoint the loneliness, the anguish, the helplessness, the tragic mortality that the status of manhood entails. By dint of becoming man God would come to know man in a way that the Old Testament does not allow. Renouncing His Olympian aloofness and remoteness, He would partake, directly, in man's lot. By doing so, He would redeem man's lot—would validate and justify it by partaking of it, suffering from it and eventually being sacrificed by it.

"The symbolic significance of Jesus is that he is God exposed to the spectrum of human experience—exposed to the first-hand knowledge of what being a man entails. But could God, incarnate as Jesus, truly claim to be a man, to encompass the spectrum of human experience, without coming to know two of the most basic, most elemental facets of the human condition? Could God claim to know the totality of human existence without confronting two such essential aspects of humanity as sexuality and paternity?"

**[H: Wow!]**

The authors go on to describe how after the flight from the holy land the wife of Jesus with her family found refuge in the south of Gaul where the lineage was continued in a Jewish community. It seems that during the fifth century this lineage united by marriage with the royal line of the Franks and thus founded the Merovingian dynasty. The descendants of Jesus have survived all attempts at wiping them out. Later the royal blood was safeguarded by the Prieure de Sion. This is a secret society whose aim it was—according to these authors—to keep and guard this secret about the marital status of Jesus. Grand Masters were among others: Leonardo da Vinci 1510-1519; Robert Fludd 1595-1637; Isaac Newton 1691-1727; Karl A. Emanuel von Lothringen 1746-1780; Maximilian Franz von Habsburg-Lothringen 1780-1801.

The house of Habsburg-Lothringen descends—according to the authors—directly from the Merovingians and therefore from the lineage of Jesus. There are however several other families who can claim the same for themselves.

Baigent, Leigh & Lincoln say to this:

"During the nineteenth century the Prieuré de Sion, working through Freemasonry and the Hieron du Val d'Or, attempted to establish a revived and 'updated' Holy Roman Empire—a kind of theocratic United States of Europe, ruled simultaneously by the Habsburgs and by the radically reformed Church. This enterprise was thwarted by the First World War and the fall of Europe's reigning dynasties. But it is not unreasonable to suppose that Sion's present objectives are basically similar."

It is very probable that these aims are still followed today. Judging from the speech Otto von Habsburg—Honorary Knight of the Deutscher Orden (Teutonic Order of Knights)—gave on May 9, 1993 at Bad Mergentheim before the Deutscher Orden, it is still in its interest to establish a "Fatherland Europe". It is most certainly no accident that recently the son of Archduke Otto von Habsburg (member of the Committee of 300), Karl von Habsburg, should marry the daughter of Baron Heinrich von Thyssen-Bornemisze (also member of the Committee of 300). The author sees a link between the purported Habsburg history, the 666 deciphering of Karl von Habsburg's name and of the Revelation.

By the way, the Habsburgs are in possession of the spear with which the Roman centurion Gaius Cassius had pierced the side of Jesus. Around the myth of this spear several thousand pages have been written (among them Trevor Ravenscroft: *The Spear of Destiny*).

Whether the events concerning the family of Jesus did actually happen this way or not, the Catholic Church has something to hide and reacts very sensitively—probably they secret pertinent documents. The question whether Jesus was a father or not is by itself unimportant because it won't change anything in today's world, except perhaps for some possible descendants or some fanatical so-called *faithful* who



confound the person with the importance of his teaching, who do not succeed in translating their *faith* into action. There is a big difference between believing in Christianity and practising it.

I don't claim that Karl von Habsburg is unmasked by the numerological value of his name as the "Antichrist". This was taken as an example of one way of looking at the number 666, and there are many more people who have that number. So do not create a new enemy concept. Yet it could be that he is still to take up a key position; remember that the Habsburg dynasty belongs to the Black Nobility as well as to the Committee of 300. Just be alert about what goes on around you while you spiritually develop further. That the so-called Antichrist is not to be found externally will be further discussed in the chapter "What Can We Do?".

**A further example yet, in the Old Testament (1 Kings 10:14)**

"The weight of the gold that Solomon received yearly was 666 talents."

People of the Thule-Gesellschaft had interpreted thus: Since 666 is—next to 333 and 999—also a gold standard, and since in Revelation 13:18 it is said that the Beast, whose name is 666 and who causes everyone to have the mark on the right hand or on the forehead, is the JEWISH MONETARY POWER.

That the number 666 has to do with the bar codes, the credit card systems, with banks then and with money, is clearly shown by the fact that the number of the code of the World Bank number is 666. Or that the cards of the Australian banks in Bombay is coded 666. New American credit cards now also show a 666. The Olivetti computer system "P 6060" uses numbers starting with 666. Computer receipts all over America have a group of grey dots on them surrounding the number 666. Every Israeli lottery ticket has the number 666 stamped on. The international line access code in Israel is 666, etc.

Rockefeller's EXXON is also interesting:

The double cross which is formed by the two combined X's in EXXON (have a look at their emblem) is an old symbol of the Scottish Rite as well as of Satan worshippers.

But there is still another meaning to the 666, the most important one in my view, of which I have not found mention in any other book so far:

Who introduced and uses the credit cards in the world? The banks. Not the little ones, but the big ones. And who are the big international bankers? The Khazar-Jewish ones—the Illuminati!

OK. And who are the Jews (especially the Talmudists) waiting for?

The Messiah!

And why are they waiting for the Messiah? Because the *Talmud* tells them: "When the Messiah comes, all will be slaves of the Jews!" (Erubin 43b)

This Messiah must be a very nice guy, if he wants to make you and me to be slaves of the Jews. Let's have a look whether there is any "proof" to this anywhere. As you know, symbolism and numerology is a very important tool to the Masons as well as to the users of the Hebrew language.

So, we want to analyze the word MESSIAH! But MESSIAH is an English word, and it doesn't even come out of the Hebrew tongue. Its origin is the Greek language: MEISSIAS. Now we want to take that name in the Greek Alphabet add it up and see who the Jews are waiting for so fervently:

Remember again what has been said in the *Talmud*:

"When the Messiah comes, all will be slaves of the Jews". (Erubin 43b)

So what does all this mean?

Well, to explain this, I have to jump ahead and state some views from the last chapter of this book.

I believe the *Protocols of the Elders of Zion* and the *New Testament* of Satan give an adequate picture of the machinations used by the wire-pullers of world events. Someone might want to claim that this activity by the Illuminati towards world rule is unrealistic and improbable, that the peoples of this Earth are not deceived and the masses can not be guided and embroiled

in war. But any critical person cannot deny the conflicts, the hatred, the wars and unrest, the hunger and the misery in this world, the splitting up of nations, the still escalating racial hatred in EVERY country of this world, the striving for independence, the powerlessness of the rulers, the corruption of the politicians, the escalating perversion and brutality of humanity, the unlimited indebtedness of the states, the instability of the currencies, the economic crises, the collapse of agriculture, the unemployment, the unrest among the populace and above all the godlessness of the people.

It is rather a strange *coincidence* that the present situation of the world so perfectly fits the *Protocols* and that the plan of Albert Pike has been translated into action with such frightening accuracy. I would also like to recall the fact that five ROTHSCILD agents were present at the signing of the Treaty of Versailles, which can be verified in any history book. They acted as ADVISORS to the leaders of England, France and the U.S. And since we know that the treaty was fashioned in such a way that war was absolutely inevitable EVERYBODY will see what had been the advice of the ROTHSCILD AGENTS. Think about this conscientiously.

To quote Franklin D. Roosevelt:

**"In politics nothing ever happens accidentally! If something occurs, you can be sure that it had been planned that way!"**

Thus I come to the conclusion that up to this point in history all the important events in politics and finance run according to the Illuminati's guidelines. Only those in the know can see the interrelation. If you think back to the subject of *information control* and to the list of names, you will understand why only very few "really know". This is also the reason why Hitler had all the occult and educational literature burned. As Dieter Rugeberg says:

**"Occultists can only be recognized by occultists!"**

An atheist or materialist will never understand or be able to follow the trains of thought or the motives of an occultist. One distinguishes between constructive (or positive—also called spiritualists) and destructive (or negative) occultists; the *positive* uses his knowledge of the spiritual laws to understand life and thereby to help himself and others, the *negative* uses it exclusively for himself, i.e. for the realization of his own ego.

Thus the highest occultists (negative in this case) of the planet, the Illuminati, the elite and all their follower lodges occupy, as the uppermost levels in finance, politics, economics, religion and science, almost all the leading positions and they use the old satanic knowledge for their plans. On the other side are the six billion people who purposefully are kept **ignorant** in falsified religions, atheism, realism, materialism and trusting science, thus speak a different language and exist in this world with nary an idea of what is really going on.

Confirming this, Rugeberg writes that:

"All those atheists and agnostics who chorus with the 'progressive' section of the Church that occultism and magic is only a daft superstition do not at all realize that they fell prey to a willfully planned politics of certain church and lodge circles. Many a famous atheist would turn in his grave if he knew that his honours and decorations were put on them by members of occult orders and lodges to use him as a tool for the dissemination of certain misleading ideas." (*Geheimpolitik—Secret Policy*)

They had planned both World Wars (and the coming one, too), financed and won them. They also brought the bane of drugs upon us. They plan and cause expansions and depressions in the economy of the nations

and use political and economic events to their advantage and to the detriment of the populace. This is also the reason why they are so inconceivably rich. These people on the one hand want to be respected and worshipped, while on the other hand and in secret they bring disaster to the nations and instigate wars. Over the centuries they have created opposing sides to confuse people, and then use others who work for them to stand at the front and do the dirty work. If something goes wrong, the puppets are blamed and not the puppeteers.

A majority of humanity actually believes that if a war breaks out today, the nation concerned was also the perpetrator. Those believing themselves clever by proclaiming that certain nations were predestined for war, like the “Evil Russians” or the “Yellow Peril” or “Germany Forever Fascist” are either acting stupid or actually are stupid.

Where do you believe a Chinese, Russian, Arab, German, American, Serb or any other government gets the money to build its armaments industry? Do you really think that there is one nation who could build an armaments industry with their own savings? Today there is not a single nation on this world that is not so indebted that it could exist without credits from the international bankers. Do you think the Serbs have enough money for arms to wage their war with? If the Russians had ever started a world war, from where do you think would they have lent [borrowed?] the money? Naturally from the international bankers.

It is not for nothing that Rothschild owns a bank in the Kremlin. That is why they are called INTERNATIONAL bankers. They are not especially concerned about England or the U.S. Wherever money can be got you will find the international bankers. And since a war is the best possible money source, they are always interested in provoking wars.

**[H: This is a good place to remind you that ALL of the U.S. money is borrowed from the Fed/IMF, et al. The taxpayers' funds go to pay the INTEREST ON THAT MONEY! Moreover, YOU are paying massive interest on money that has no VALUE whatsoever—and you end up paying for it at least twice and sometimes a hundred times over. You are but bond-slaves, citizen. Then you pay taxes on more taxes on the things you buy or licenses you get. Remember, that as long as a thing or “right” can be confiscated for any reason, taxes or otherwise—IT IS NOT YOURS!]**

If these bankers don't want a war there is no credit and therefore no arms. It is that simple. If a nation wants to go to war, it first has to ask the bankers whether or not they agree to it. If they do agree, the armaments industry is built up with their financial support and off you go. Do they not agree, because it might contravene their own plans, there is no credit and without money there are no arms and without arms there is no war. In the case of war though it is not a question of a few million, it concerns sums in the billions.

As I have shown in the course of this book, the money for the Bolsheviks for the Germans before and during the Second World War, for the Russians, for the Communist system and also for Saddam Hussein always came from the same lenders. That is why nothing is ever accidental in politics or war. If there is a war, it must have been planned, otherwise no funds would have been made available. Consequently the present and future trouble spots are wanted and perfectly planned to reach the one overriding goal, the *One World Government*.

The Illuminati themselves claim that they have to set up this one world government to finally establish global peace. It is interesting that they use war as the means to get there.

Do you think that they will change and act differently once the world government is established?

**By their deeds ye shall know them!**

Actually there is nothing to be said against a world government; it is the ultimate goal of this planet, if only it is led by people who have the well-being of their fellow-men on their minds and who vouch for development mentally, spiritually and above all freely, i.e. no secrets before anyone, the right for free development for everyone by presenting the knowledge so far held back should this be wished. The world government that has been talked about in this book is of the elite and for the elite only, i.e. the rest of humanity is kept unknowing and is thus enslaved.

If you still cannot believe that “those up there” are not interested in what the people want, whether they are alright, whether they survive the next war or not, then why are there no shelters for the people except in very few countries like Switzerland?

Did you ever realize this? And the danger of a new war that might also include Germany is very real, not just because it says so in the *Protocols of the Elders of Zion* and in Albert Pike's letter. The Serbs have only got to realize their threat of firing rockets on Germany should it interfere in the Yugoslav war. Or, should hunger and poverty in the CIS states and the North Africa “third world countries” increase even more—which can be predicted without any special powers of prophecy—they will not go to China or the U.S. to get what they need, they will go to Germany first. The Swiss have no problem with this because they have their shelters and guns in their homes and also live in the mountains where the hungry will not want to climb. But the Germans will have to be rather defenceless against these events. For the elite and our politicians who “really have earned the privilege” of survival there are numerous perfectly laid out underground bases with food and everything necessary for the survival of several decades. Yet the naive *rank and file* has conveniently been *forgotten*.

Just think this through. How would you react if tomorrow the Serbs would gun Munich or Stuttgart?

Former Illuminatus George Orwell in his book *1984* has clearly described how things could be in the eyes of the Illuminati. This includes control by a laser tattoo. There were several attempts to stop the publication of *1984*.

Naturally it is not too late. A lot can be done if the people of all nations would give up their appalling ignorance and would really start to be concerned about humanity and the planet Earth.

But through the games of the Illuminati we are so beautifully caught up in our own small world of problems that most have long lost track and therefore have pulled back from the world's activities.

Just a short example illustrating this last remark:

The mass media (controlled by the Illuminati) is drumming into you that in order to be a good citizen you have to have a great car, your own house, a family, a career, designer clothes etc. After seeing this picture of the perfect “member of society” for decades on TV and in print your subconscious has absorbed the information and now you are convinced that you really need all these things (the same of course goes for attitudes and fashions). To get all this you have to really work hard. But you cannot work fast enough. You want these things now. So you buy on credit and with installment plans and slowly but surely you are caught in the net that has been laid out for you so perfectly, and obligations and debts will tie you up for decades.

Add to this the family and the kids, the money for holidays, car repairs, etc. you are finally trapped in the vicious circle “created by yourself”, with your oh so

many problems, so you find neither time nor inclination to check whether what you happen to be doing is what you actually want to do.

And then some time you discover that you are not at all happy with what you created in the outer world and that today you would go about it differently but that now it is too late.

This is, simply put, what is planned in the *Protocols of the Elders of Zion* and that for decades happens in all countries of this world. In addition you might feel inadequate to deal with all the problems and you look for refuge in drugs and alcohol. Once you have reached that point, the race of this life is all but over anyway. Yet some still make it. In the next chapter I will show that it is never too late.

But treating symptoms does not suffice, like cutting the Illuminati out as if they were a sick organ, here we have to deal with causation.

You yourself are the solution to your problem or of the conditions presented in this book. Had you checked whom you vote for and what you support daily, the world would look different today and the Illuminati would have no power over you. With “you” I mean every human being on this planet.

How did Ross Perot, candidate in the last presidential elections in the U.S. say so succinctly:

**“If you want to find out what is wrong with your country, go look in the mirror.”**

Here some will possibly say:

*“Wait a minute, this all started long before my time and there are six billion people actively involved, why should I start changing things?”*

Because you are aware that here something is going wrong! Your *consciousness* has changed, you have realized that there are other, better ways to deal with life and thereby you are distinct from your “unconscious” fellowman. You now are responsible for the cognition you just gained. Before you may just have said: “I didn't know about it.” But now you KNOW. And now you can't just sneak off.

We are all only abused because we are not critical enough and don't watch out. But just as we slid into it, we can get out again. On a physical level it might be important to become self-sufficient. To plant our grain ourselves, to sink wells, keep a few goats for milk and cheese, use alternative power, bury some gold in the garden for emergencies... just be independent.

This does not necessarily mean that one has to cut back on normal life. Today there are many communes leading an almost luxurious life. Certainly more in the States than in Germany. But it works anywhere. You don't have to do it all by yourself. Add your best friends, those you trust, and do it together. Together it will be easier, because each and everyone is unique and in one way or another, *special*.

**[H: Oops! Right here WATCH IT. Be careful in this “commune” naming. You will be immediately registered as a CULT—and you will be harassed out of every good thing you hoped to accomplish. You can work together toward some gainful projects WITHOUT BEING A COMMUNE OF SOME KIND. You must be self-sufficient and GROW something that can be productive and sustaining or you will have only once again fallen into a pre-laid TRAP.]**

So we can balance each other.

Find people of a like mind. Start by reading critical literature and go to pertinent lectures; increase your knowledge and form discussion circles. Subjects like “free energy devices” and the construction of them are certainly not uninteresting. It is also important to speak of emotions. But get to the point, don't circumlocute and just *discuss*.



Possible solutions in the outer, the material world are given in some of the books in the literature list.

Many historians themselves have been caught up in the web of entanglements and have transferred their own cause-finding and responsibility to the Zionists and the Jews. Some Christian researchers went for the Freemasons and believed they were guilty of it. Not all the members of the Rothschild family are beholden to the ideology of world rule! So do not make sweeping judgements! The reason for this book is NOT to pinpoint some perpetrator or other, but to recognize the principles and the modes of action and to look now at possible solutions.

Again very clearly:

The Illuminati are not part of any religion, party, nation or group, but they used them all as cover. Therefore I would like to state once more that this game had started thousands of years before any of the persons mentioned in this book were even born, and it will not end with them either. You must read *The Gods of Eden* by William Bramley.

Ruggerbert writes:

In negative or black magical orders all the important written documents are rendered in a secret script that can only be deciphered by the unknowing by using the appropriate key. The materialistic historians will have a lot to learn in this respect if they don't want to do without the whole truth."* (Geheimpolitik)

or

**"Birds of a feather flock together."**

The product produced is changed from the pre-processing components—and we will not give forth the procedure, as that is recognized as a "trade secret". All components are well-recognized items and fully approved for supplemental use.\*\*\*\*

## OXY SOL

(Oxygen in Solution)

Just as air is taken into the body through the lungs, there must be a "conversion" process which frees oxygen which in turn is then used by the body in every cellular part thereof. It is recognized that in some processes in which the body-lung conversion system is compromised, oxygen begins to be in short supply. There simply is, in most cases, already a great shortage of oxygen in the air you breathe.

With this shortage there is great compromise to the entire body's ability to function. One major compromise is to the individual's immune system, leaving the body open to opportunistic microbe invasion.

With lung compromise for any reason there is a buildup of mucous or damage to the conversion system which disallows the free passage—before and after separation into component parts—of the air.

Oxy Sol provides an alternative method of getting oxygen molecules into the body's circulatory system other than through respiration via the lungs.

Oxy Sol is also effective in topical applications. This is recognizing that there is a "disinfectant" quality to the solution which inhibits bacteria from the oxygen itself and also from the other components of the solution which have been tested and proven to be effective in microbe decimation. The word "decimation" is carefully chosen because there is truly a dismantling of the organisms themselves.

We would give an example of fleas as an infestation parasite. Each organism has several stages of development. What may well dispose of the flea may not dispose of the egg or larvae.

Therefore, since Oxy Sol is an immediately-acting solution, it is also rapidly used and passed

on through the body. Depending on the use you have, it needs a replenishing dose frequently, or regularly, throughout the day.

Therefore, only a few drops are required to offer quite a healing tool.

THERE ARE NO HARMFUL SIDE EFFECTS EVER REPORTED—BUT RIGHT UP FRONT WE WILL DESCRIBE SOME SO-CALLED SIDE-EFFECTS. IN "INFECTION"-CLEARING THESE ARE WELCOME SIGNS.

There is no harm from using large quantities of Oxy Sol—but there can be a side-effect of what can adequately be described as a "high" from oral use.

What is often an "effect" of large doses of what is often called aerobic oxygen, is a "kill-off effect" from the dispensation of toxic microbes.

This usually presents as would a "crisis" in a disease process. This can present with a bit of fever which is not even noted until there is a reaction of the body which will resemble a nervous reaction much like over indulgence in a stimulant such as comes from caffeine or ephedra. This will usually be followed by a generalized "weak" sensation often referred to as "queasy". This is most often followed immediately by some amount of sweating which is described as "clammy" or cold sweat.

## USES OF OXY SOL

This product has been available for over ten years as a New Gaia product which was often used in conjunction with a separate product of silver colloid which is a fully recognized antibacterial agent.

Oxy Sol will impact all the same microbes but all colloidalization is done through chemistry. We do not refer to chemicals as in a "chemical" colloidalization process because chemical indicates to most people a "chemical" or artificial additive. Preferably this process for Oxy Sol is a CATALYTIC process which means, simply, a biochemical reaction but that remains unchanged at the end of the reaction. Our best examples are enzymes which are natural biochemical catalysts. In general practice most catalysts are used to speed up reactions.

There is nothing in Oxy Sol which is not found in the very basic makeup of the human body and functioning body systems, catalytically converted for ability of instant use of oxygen molecules.

For a brief usage description we offer the following:

Oxy Sol offers a very high concentration of non-toxic stabilized electrolytes of oxygen. Oxygen in molecular form.

One of OXYGEN'S many properties is destruction of harmful bacteria. But more importantly for this particular product are the known qualities of destruction of anaerobic infectious bacteria which are living, active, occurring, or existing in the ABSENCE OF FREE OXYGEN. Example: clostridia. This is an organism which often causes infections resulting in "gangrene". Gangrene is best described as "death of tissue". It is usually associated with LOSS OF BLOOD SUPPLY to

an infected area. This is usually followed by bacteria. Thus we come back to “anaerobic bacteria” which can only GROW IN THE ABSENCE OF OXYGEN.

This is a long way around to pointing out that these particular anaerobic bacteria build up major ways of keeping OUT oxygen.

Oxy Sol provides a way, a carrier, to move within the bacterial cell in a very natural manner, either through the blood supply or in the absence of blood supply as in certain skin problems, topically.

Now to consider AEROBES.

An Aerobe is an organism that respire aerobically. Almost all living organisms (plants as well as animals) are aerobes, and will die in the absence of oxygen. So, we are going to discuss a bit of information on Oxy Sol regarding this aerobic phenomenon and why you may well wish to utilize Oxy Sol with some of the other “dria-drios” solutions.

**AEROBIC RESPIRATION:** A form of respiration that requires the presence of oxygen (usually dissolved in water) for the efficient release of energy contained in food molecules, such as glucose.

Aerobic respiration occurs inside the MITOCHONDRIA (AquaGaia®) of the cell and, unlike anaerobic respiration, involves the complete breakdown of glucose to give carbon dioxide, water, and large amounts of energy (stored in the form of ATP molecules), which will subsequently be used by the cell for driving its metabolic processes. And, yes, this CAN be broken down into a formula:  $C_6H_{12}O_6 + 6O_2 \rightarrow 6CO_2 + 6H_2O + 2,880 \text{ kJ}$ .

We cannot refer to Oxy Sol without also acknowledging this AEROBIC quality, by definition, of the product itself. There are other products which utilize “aerobic” in the name of the product itself.

Researchers have not found any anaerobic infectious bacteria that “aerobic oxygen” does not kill.

It has been found to be effective against Salmonella, Cholera, E. coli, Streptococcus, Pseudomonas and Staphylococcus A. It is even effective against Giardia-Lambliia, yeasts and candida. Because of Oxy Sol’s other qualities, you will find it effective against all microbes in which silver colloids are effective.

This is not for the purpose of a chemistry or science, or even a biology lesson; it is that all people should be informed both about their bodies and what you use as an additive or supplement to your body’s functioning.

Oxy Sol is from a catalytic process which includes the presence of silver and gold which produces a colloidalized solution containing microscopic silver and gold—both known for healing qualities.

It is suggested that a small container may be carried with you for the following reasons:

It is non-toxic and, therefore, totally safe.

### Applications

There are many applications for the use of Oxy Sol (aerobic oxygen). The major areas of its application are to kill off harmful organisms and to increase the concentration of Oxygen.

The World Health Organization (WHO), which may well spread more disease than it contains, nonetheless tested Aerobic Oxygen and found it to be effective against various organisms common to drinking water. It was concluded that it is indeed an effective disinfectant and most certainly would have other applications.

For purification of fluids:

1. Add approximately 5 drops per 8 oz. glass of water (or less), juice or milk. Just as silver colloids will keep milk fresh from spoilage, so too will 3 to 5 drops of Oxy Sol in a half gallon of milk keep it fresh for a long period of time. Oxy Sol will not, in that quantity, kill off your good bacteria.

**TRAVELERS SHOULD ALWAYS HAVE SOME AEROBIC OXYGEN WITH THEM AS THEY TRAVEL FROM HOME. THERE IS SUCH RECOGNITION OF CONTAMINATED WATER EVEN IN CITY SYSTEMS THAT IT IS WISE TO PUT A FEW DROPS IN EVERY GLASS OF WATER IN RESTAURANTS AND ANY OTHER WATER SUPPLIES. EVEN BOTTLED WATER IS NOW RECOGNIZED AS OFTEN BEARING BOTH BACTERIA AND PARASITES.**

2. Add seven to 10 drops of Oxy Sol per gallon of water to inhibit growth of disease bacteria.

3. Add 10 drops per gallon, or 1 to 2 ounces to 45-55 gallons, of water, for longer storage.

4. Use with tooth care. Remember that tooth decay and gum problems are caused by infectious bacteria. A couple of drops on your toothbrush inhibit disease bacteria. It is also suggested that 1-3 drops of Oxy Sol on the toothbrush to store will keep it sanitary when not in use.

5. To Control bacteria contamination: Use on vegetables, seafood, poultry or any meat (especially recommended for pork), add 40 to 60 drops per gallon of water. 6. Oxy Sol is excellent as a mouthwash. Add about 10 drops in 2 ounces of water. Swirl in mouth or gargle for a few seconds, then swallow. Oxy Sol is excellent in the case of sore throat, mouth ulcers, etc., for repeated use. This solution can be placed into a spray bottle and used FREQUENTLY.

\* Angina attacks. (Especially useful if away from home and there is shortness of breath with chest-neck pain and or discomfort in the chest.)

\* Asthma & emphysema

\* Bronchial infections

\* Sinus infections

\* Epileptics and Alzheimer’s sufferers seem to respond rapidly to the oxygen enhancement.

\* Poor circulation (Exceptionally good taken regularly three to four times daily.)

\* Candida

\* Headaches (Often a headache is simply lack of available oxygen.)

\* Energy levels (There is often an immediate response in increase in energy level.)

There will be a notable increase in ability to withstand the usual susceptibility to disease processes. And, if an infection occurs a shortened disability period is noted.

The following information may or may not be enclosed with the product itself as required by law, but for discussion must be noted:

The body must have oxidation and oxygenation,

which energizes cells to biological regeneration. The lack of oxygen in proper quantity in the system is the major prevention of these vital processes of the foundation of life and death itself as relative to cells and functioning of the body systems.

It, therefore, has to be noted, as well, that some processes, yea, even to cancer cells, are growth-inhibited in an environment of high-oxygen content.

In an oxygen-poor environment in the body it is known that yeasts or fungal infections like candida albicans occur most frequently.

**IT IS BOTH KNOWN AND NOW RECOGNIZED THAT OXYGEN PLAYS A PIVOTAL ROLE IN THE PROPER FUNCTIONING OF THE IMMUNE SYSTEM AND THUS IN RESISTANCE TO DISEASE, BACTERIA, AND VIRUSES.**

As more and more of the disease organisms fail to respond to treatment, thus called “resistant strains”, it is imperative to keep the IMMUNE SYSTEM functioning as well as it can be maintained. Antibiotics ALSO KILL YOUR GOOD OR BENEFICIAL BACTERIA thus weakening further the Immune System. If you would have a good immune system, you have to attend it, for no one can do it FOR YOU.

**It may well mean more to you to realize now that oxygen deficiency is becoming recognized as the single greatest cause of all diseases.**

There are several other things which enhance the utilization of cellular oxygen and cellular interchange with such as Oxy Sol and those products are known to you who have become familiar with such as Gaiandriana, AquaGaia, etc. Those are solutions of “carrier” molecules which can merge instantly within other cells. This allows elements and colloids to move INTO other cells and allows something such as a virus which dwells inside other cells to be impacted directly.

Oxy Sol (liquid oxygen plus) has been observed by researchers and from reports, yea, even from doctors, that it has assisted patients with Alzheimer’s disease process symptoms reduction. Sometimes in such a disease process as is Alzheimer’s, increased amounts of Oxy Sol up to three to four times as much is more notable in short-term observation of memory recall.

Regular intake of liquid oxygen has inhibited epileptic attacks, it appears. In a medical setting the intravenous or injectable solution has stopped attacks in progress. We make no claims nor suggest this use at home.

### 14 COUNTIES ON ALERT FOR VIRUS

A Madison County [Florida, U.S.A.] man was in the hospital Monday fighting the first suspected human case of West Nile virus in Florida, prompting health officials to issue a medial alert for the illness for 14 northern counties.

State officials said the patient is older than 50 but would not release many specifics on his condition. They said he is being treated in an intensive-care unit at an undisclosed hospital, where the focus is preventing serious complications from the virus.

"Death is always a concern" with West Nile virus, said Dr. Steven Wiersma, acting state epidemiologist with the Florida Department of Health in Tallahassee, "Especially with someone who is that ill."

West Nile is a form of encephalitis, or swelling of the brain, that can lead to permanent disability or even death from organ failure. The patient's symptoms included confusion, hallucinations and fever, Wiersma said.

The medical alert, previously issued in three counties where the virus was found in birds, was extended to 11 more counties Monday. Health officials are urging residents to use insect repellent and take other precautions to avoid getting bitten by mosquitoes.

At the same time, they said there is no reason for panic. "I don't think it's particularly alarming," Wiersma said. "We have a long history in this state with [mosquito-borne] illnesses."

West Nile made its first U.S. appearance in New York in 1999, when at least 62 people were infected and seven people died from it. Mosquitoes get West Nile from biting infected birds, which harbor the virus. The insects then pass it to humans through bites.

**[H: Oh, would it be that simple but, of course, it is not. As with any virus, however, the fact is that it easily mutates and adjusts to any host it can find. This is not to terrify you but to KEEP YOU AWAKE.]**

To date, 11 states have found West Nile in animals. But only New York, New Jersey and Connecticut have reported human cases of the illness. Florida is expected

to be added to the list officially by next week, after the diagnosis is confirmed through a blood sample sent to the Centers for Disease Control and Prevention in Atlanta.

In the meantime, Central Florida health officials say they have seen little evidence that local bugs are infected with encephalitis-causing viruses.

All Florida counties watch out for the disease by keeping chickens that are tested for several forms of encephalitis, including the more common St. Louis and Eastern equine varieties. A few Orange County chickens have shown Eastern equine encephalitis, but not enough to cause concern, said Bill Toth, an epidemiologist with the Orange County Health Department.

"We're watching the situation very carefully, but our surveillance doesn't indicate anything going on yet," Toth said.

Up North, the virus was carried by one species of mosquito: *Culex pipiens*. This mosquito does not live in Florida, and health officials are setting traps and running tests on insects to find the variety causing the infection here.

"We know that we are dealing with a different kind of mosquito here, and it might be one that is more likely to feed on people," said Lisa Conti, state public health veterinarian with the Florida Department of Health in Tallahassee.

West Nile was detected earlier this month in dead crows in several Panhandle counties. The state has confirmed the virus in 18 animals in seven counties. The animals include crows, a horse, blue jays and a hawk.

Wiersma thinks the virus will move throughout the state.

"It moved pretty quickly from New York to Florida," Wiersma said. "There's nothing to keep it from moving between us and you in Central Florida."

The 14 counties in the alert are Holmes, Washington, Jackson, Bay, Cahoun, Gulf, Franklin, Liberty, Gadsden, Wakulla, Leon, Jefferson, Madison and Taylor.

The virus first appeared in the United States in 1999 killing 7 people in the New York City area.

Mosquitoes carry it:

1. Virus survives winter in bodies of adult *Culex* mosquitoes.
2. Infected mosquito bites bird, infects it.
3. Other mosquitoes become infected by biting bird.
4. Infected mosquitoes pass the virus to birds, humans and horses.

One variant of the virus causes West Nile fever in horses.

How it affects humans:

Virus enters the bloodstream from insect bite, immune system usually destroys it. If virus survives in body, it can infect membranes around the spinal cord and brain (encephalitis).

Symptoms are often mild:

- Fever
- Headache
- Body aches
- Skin rash
- Swollen lymphnodes

It is not known whether or not it can be transmitted by person-to-person contacts. Worse yet, however, it is not known if it can be transmitted from infected birds directly to humans.

WASHINGTON (*AFP*)—A chilling scenario of possible national collapse was presented Monday to U.S. lawmakers by a group of prominent security experts, who warned that a biological terrorist attack on U.S. soil could bring the country to the brink of disintegration.

The panel, which included former deputy secretary of defense John Hamre, Oklahoma governor Frank Keating and former Senator Sam Nunn, presented their conclusions after holding a two-day exercise, code-named "Dark Winter", which featured a computer-simulated bioterrorist attack on three U.S. states.

Members of the House Subcommittee on National Security closely listened as participants painted a picture of the world's most powerful nation descending into chaos in a matter of several weeks.

The game starts with a brief television report that about two dozen people checked into an Oklahoma City hospital with an unidentified illness. Doctors soon find the patients have smallpox, a highly contagious and deadly disease UNSEEN in the United States since 1949.

Similar smallpox cases are reported in Pennsylvania and Georgia. By day six, 300 Americans are dead and 2,000 others are infected. Cases of smallpox are reported in Mexico, Canada and Britain, according to the scenario.

Meanwhile, the U.S. health system is overwhelmed, the 12 million doses of smallpox vaccine quickly disappear, schools nationwide are forced to close, and public gatherings are limited due to fear of contagion.

Droves of Oklahomans, anxious to flee, stream toward Texas—but the Texas governor, eager to protect his own residents, closes the border and deploys the state National Guard. Shots are fired.

STANDOFF. As the standoff between Texans and Oklahomans deepens, a rift opens between federal and local authorities. Members of the U.S. National Security Council suggest “nationalizing” the national guard, while state governors insist on keeping the local troops under their control.

On day 12 of the scenario, when the death toll reaches 1,000, interstate commerce grinds to a halt and stock trading is suspended. Demonstrations demanding more smallpox vaccines turn into riots. The United Nations moves its headquarters from New York to Geneva, Switzerland.

Less than two months after the outbreak, when the number of dead reach one million and three million more are infected, the president, played in the exercise by Nunn, gathers his top aides to consider imposing martial law.

Dead silence reigned in the hearing room as Hamre and Nunn presented their findings with the help of colorful “emergency newscasts” prepared by the nation’s leading television broadcasters, who also took part in the exercise, which took place at Andrews Air Force Base outside Washington, D.C. in June. BUT, BACK TO THE Philippines—The headline in the Business Section today reads:

[QUOTING *The Philippine STAR*, Tue., July 24, 2001:]

**GOV'T EYES \$-LINKED NOTES  
TO EASE PRESSURE ON PESO**

**[H: Is there intelligent life on Planet Earth? Well, we have found very little so far.]**

Government is working on issuing dollar-linked peso notes in hopes of easing pressure on the local currency, the Bureau of Treasury (BT) said yesterday.

The notes are fixed-rate government securities to be denominated in pesos with a dollar equivalent based on the foreign exchange rate on the issue date.

National Treasurer Sergio Edeza said the government would initially issue a total of about P5 billion worth of the instrument carrying two- and three-year maturities. **[H: Oh, sure, everything will be running along in two or three years. Won't it? YOU CANNOT BORROW YOUR WAY OUT OF DEBT! ANYONE IN THERE?]**

Edeza said the paper would carry coupon rates three to four percentage points lower than those of same-maturity Treasury bonds. **[H: NOTE: There is always a talk around the pond so that there is never an interest rate given. They quickly move off into confusion compounded with peso rates.]**

"The issuance will be able to help the government ease the pressure on foreign exchange market by issuing the dollar-linked instrument instead of selling dollars," Edeza said.

"Also, the government will be borrowing at favorable rates compared to the prevailing market rate," he added.

The instrument is one of the measures of the government—and the Bangko Sentral ng Pilipinas (BSP) agreed to pursue to ease the pressure off the local currency, which hit a six-month low of 54.335 to the dollar last week.

At the Philippine Dealing System (PDS) the peso closed 25 centavos lower at 53.400 from Friday's close of 53.150 to the dollar. It opened slightly lower at 53.260 before hitting a low of 53.400-\$1. Total volume traded was to \$11 million.

The instrument also aims to reduce pressure on domestic interest rates, by partly providing financing for the government's funding requirements which would otherwise be met by increased domestic borrowing.

Government has mandated three financial institutions, subject to the grant of presidential full powers and Monetary Board approval, to work on the issuance of the bonds. THE THREE ARE RIZAL COMMERCIAL BANKING CORP., MULTINATIONAL INVESTMENT BANK CORP., AND DEUTSCHE BANK.

**[H: Enough of that one; even I can't stomach it.]**

**FOREX SPECULATORS FACE STIFF SANCTIONS**

**[H: Don't bite on this. It is a usual threat and nothing EVER happens except: "Look how hard I tried..."]**

The Bangko Sentral ng Pilipinas (BSP [Central Bank]) warned banks that effective today it would make good its threat to suspend the foreign exchange trading licenses of banks, including their directors and country managers found violating the rules on DOLLAR TRANSACTIONS.

The BSP has noted the recent rise in incidents of transactions, aggressively testing the boundaries of existing prudential regulations. In fact, some have already breached such limits. Such behavior contributes to the volatility of foreign exchange rates and should not be encouraged," said BSP Governor Rafael Buenaventura in a statement.

Buenaventura said that to restrict further speculations against the peso, the central bank will seriously consider a proposal to further reduce the amount of dollar transactions that will require complete documentation from \$10,000 to \$5,000.

Buenaventura said the BSP is also enumerating some of the more serious infractions, such as disregard of prior central bank approval where required, absence of supporting documents when transactions are consummated, remittances on non-registered investments, sales to non-residents or directly for credit to foreign currency deposit unit (FCDU) accounts, evidenced splitting of remittances, and determined speculative transactions which include "churning", or banks trading currencies for capital gain without any underlying trade-related purpose.

At the same time, Buenaventura said the central bank will apply the monetary sanction of imposing a P30,000 penalty imposed per day per violation and will be based on per transaction basis. The non-monetary sanctions include reduction or suspension of overbought limits; suspension of opening of letter of credit and over-the-counter sale of foreign exchange for a period of up to six months; suspension of derivatives activities for a period of up to six months, suspension of foreign currency deposit unit authority for a period of up to six months.

The other non-monetary sanctions also include a reprimand of bank officers who approved the transaction; suspension of bank officers and directors for local banks and country manager for foreign banks and permanent disqualification of bank officers and directors.

Buenaventura noted that people have been careless in their transactions in the wake of recent speculations against the peso.

Although there are no reported large dollar outflows, the BSP chief said the buying of dollars in recent weeks, especially those that have not been complying with the central bank rule, calling for the submission of original documents to justify the purchases, have contributed to the scarcity of the greenback.

He said the BSP will now be stricter in insuring the rule is complied with in the wake of the weakening peso.

He said the BSP will now be stricter in ensuring the rule is complied with in the wake of the weakening peso.

The BSP imposed the rule last year when the peso became volatile, especially after a series of scandals, including insider trading in the stock market and the jueteng payoff scandal which led to the downfall of former President Joseph Estrada.

Earlier, BSP Deputy Governor Alberto Reyes said at least 10 of the country's biggest banks were not only skirting submitting the original documents, but were also making purchases just short of \$10,000 to go around the rule. No documents are required for transactions below \$10,000.

"They usually split the purchase to less than \$10,000, selling it to different clients with the same addresses," Reyes added.

Also, most banks just submit xerox copies of these documents which could be easily tampered with, Reyes said. (Rocel Felix)

#### WELCOME ABOARD

This publication marks the 25<sup>th</sup> anniversary of the Third World War, called the “Quiet War”, being conducted using subjective biological warfare, fought with “silent weapons”.

#### SECURITY

It is patently impossible to discuss social engineering or the automation of a society, i.e., the engineering of social automation systems (silent weapons) on a national or worldwide scale without implying extensive objectives of social control and destruction of human life, i.e., slavery and genocide.

This manual is in itself an analog declaration of intent. Such a writing must be secured from public scrutiny. Otherwise, it might be recognized as a technically formal declaration of domestic war. Furthermore, whenever any person or group of persons in a position of great power, and without the full knowledge and consent of the public, uses such knowledge and methodology for economic conquest—it must be understood that a state of domestic warfare exists between said person or group of persons and the public.

The solution of today’s problems requires an approach which is ruthlessly candid, with no agonizing over religious, moral, or cultural values.

You have qualified for this project because of your ability to look at human society with cold objectivity, and yet analyze and discuss your observations and conclusions with others of similar intellectual capacity without a loss of discretion or humility. Such virtues are exercised in your own best interest. Do not deviate from them.

#### HISTORICAL INTRODUCTION

Silent weapon technology has evolved from Operations Research (O.R.), a strategic and tactical methodology developed under the military management in England during World War II. The original purpose of Operations Research was to study the strategic and tactical problems of air and land defense with the objective of effective use of limited military resources against foreign enemies (i.e., logistics).

It was soon recognized by those in positions of power that the same methods might be useful for totally controlling a society. But better tools were necessary.

Social engineering (the analysis and automation of a society) requires the correlation of great amounts of constantly changing economic information (data), so a high-speed computerized data processing system was necessary which could race ahead of the society and predict when society would arrive for capitulation.

Relay computers were too slow, but the electronic computer, invented in 1946 by J. Presper Eckert and John W. Mauchly filled the bill.

The next breakthrough was the development of the simplex method of linear programming in 1947 by the mathematician, George B. Dantzig.

Then, in 1948, the transistor, invented by J. Bardeen, W.H. Brattain, AND W. SHOCKLEY [**H: An acquaintance/friend of Dr. Ed Young, as claimed by Dr. Young.**], promised great expansion of the computer field by reducing space and power requirements.

With these three inventions under their direction, those in positions of power strongly suspected that it was possible for them to control the whole world with the push of a button. [**H: REREAD THAT PLEASE.**]

Immediately, the Rockefeller Foundation got in on the ground floor by making a four-year grant to Harvard College, funding the Harvard Economic Research Project for the study of the structure of the American economy. One year later, in 1949, the United States Air Force joined in.

In 1952 the original great period terminated, and a high-level meeting of the elite was held to determine the next phase of social operations research. The Harvard project had been very fruitful as is borne out by the publication of some of its results in 1953 suggesting the feasibility of economic (social) engineering. (*Studies in the Structure of the American Economy*—copyright 1953 by Wassily Leontief, International Sciences Press Inc., White Plains, New York.)

Engineered in the last half decade of the 1940s, the new Quiet War machine stood, so to speak, in sparkling gold-plated hardware on the showroom floor by 1954.

With the creation of the Maser in 1954, the promise of unlocking unlimited sources of fusion atomic energy from the heavy hydrogen in seawater and the consequent availability of unlimited social power became a possibility only decades away.

The combination was irresistible.

The Quiet War was quietly declared by the international elite at a meeting held in 1954.

Although the silent weapons system was nearly exposed 13 years later, the evolution of the new weapon systems has never suffered any major setbacks.

This volume marks the 25<sup>th</sup> anniversary of the beginning of the Quiet War. Already this domestic war has had many victories on many fronts throughout the world.

**[H: Seems to me in casual counting you are certainly well into half a century of full assault against you people.]**

### POLITICAL INTRODUCTION

In 1954 it was well recognized by those in positions of authority that it was only a matter of time, only a few decades, before the general public would be able to grasp and upset the cradle of power, for the very elements of the new silent weapon technology were as accessible for a public utopia as they were for providing a private utopia.

The issue of primary concern, that of dominance, revolved around the subject of the energy sciences.

### ENERGY

Energy is recognized as the key to all activity on Earth. Natural science is the study of the sources and control of natural energy, and social science, theoretically expressed as economics, is the study of the sources and control of social energy. Both are bookkeeping systems: mathematics. Therefore, mathematics is the primary energy science. And the bookkeeper can be king if the public can be kept ignorant of the methodology of the bookkeeping.

All science is merely a means to an end. The means is knowledge. The end is control. Beyond this remains only one issue, "Who will be the beneficiary?"

In 1954 this was the issue of primary concern. Although the so-called "moral issues" were raised, in view of the law of natural selection it was agreed that a nation or world of people who will not use their intelligence are no better than animals who do not have intelligence. Such a people are beasts of burden and steaks on the table by choice and consent.

CONSEQUENTLY, in the interest of future world order, peace, and tranquility, it was decided to privately wage a quiet war against the American public with an ultimate objective of permanently shifting the natural and social energy (wealth) of the undisciplined and irresponsible many into the hands of the self-disciplined, responsible, and worthy few.

In order to implement this objective, it was necessary to create, secure, and apply new weapons which, as it turned out, were a class of weapons so subtle and sophisticated in their principle of operation and public appearance as to earn for themselves the name 'silent weapons'.

In conclusion, the objective of economic research, as conducted by the magnates of capital (banking) and the industries of commodities (goods) and services, is the establishment of an economy which is totally predictable and manipulatable.

In order to achieve a totally predictable economy, the low-class elements of the society must be brought under total control, i.e., must be house-broken, trained, and assigned a yoke and long-term social duties from a very early age, before they have an opportunity to question the propriety of the matter. In order to achieve such conformity, the lower-class family unit must be disintegrated by a process of increasing preoccupation of the parents and the

establishment of government-operated day-care centers for the occupationally orphaned children.

The quality of education given to the lower class must be of the poorest sort, so that the meat of ignorance isolating the inferior class from the superior class is and remains incomprehensible to the inferior class. With such an initial handicap, even bright lower-class individuals have little if any hope of extricating themselves from their assigned lot in life. This form of slavery is essential to maintaining some measure of social order, peace, and tranquility for the ruling upper class.

### DESCRIPTIVE INTRODUCTION OF THE SILENT WEAPON

Everything that is expected from an ordinary weapon is expected from a silent weapon by its creators, but only in its own manner of functioning.

It shoots situations instead of bullets; propelled by data processing instead of chemical reaction (explosion); originating from bits of data instead of grains of gunpowder; from a computer instead of a gun; operated by a computer programmer instead of marksman; under the orders of a banking magnate instead of a military general.

It makes no obvious explosive noises, causes no obvious physical or mental injuries, and does not obviously interfere with anyone's daily social life.

Yet it makes an unmistakable 'noise', causes unmistakable physical and mental damage, and unmistakably interferes with daily social life, i.e., unmistakable to a trained observer, one who knows what to look for.

The public cannot comprehend this weapon and, therefore cannot believe that they are being attacked and subdued by a weapon.

The public might instinctively feel that something is wrong, but because of the technical nature of the silent weapon, they cannot express their feeling in a rational way, or handle the problem with intelligence. Therefore, they do not know how to cry for help, and do not know how to associate with others to defend themselves against it.

When a silent weapon is applied gradually to the public, the public adjusts/adapts to its presence and learns to tolerate its encroachment on their lives until the pressure (psychological via economic) becomes too great and they crack up.

Therefore, the silent weapon is a type of biological warfare. It attacks the vitality, options and mobility of the individuals of a society by knowing, understanding, manipulating and attacking their sources of natural and social energy—and their physical, mental, and emotional strengths and weaknesses.

### THEORETICAL INTRODUCTION

**"GIVE ME CONTROL OVER A NATION'S CURRENCY, AND I CARE NOT WHO MAKES ITS LAWS."**—Mayer Amschel Rothschild (1743 - 1812)

Today's silent weapons technology is an outgrowth of a simple idea discovered, succinctly expressed, and effectively applied by the quoted Mr. Mayor Amschel Rothschild. Mr. Rothschild discovered the missing passive component of economic theory known as economic inductance. He, of course, did not think of his discovery in these 20<sup>th</sup>-Century terms, and to be

sure, mathematical analysis had to wait for the Second Industrial Revolution, the rise of the theory of mechanics and electronics, and finally, the invention of the electronic computer before it could be effectively applied in the control of the world economy.

### GENERAL ENERGY CONCEPTS

In the study of energy systems, there always appear three elementary concepts. These are potential energy, kinetic energy, and energy dissipation. And corresponding to these concepts, there are three idealized, essentially pure physical counterparts, called passive components.

(1) In the science of physical mechanics, the phenomenon of potential energy is associated with a physical property called elasticity or stiffness, and can be represented by a stretched spring.

In electronic science, potential energy is stored in a capacitor instead of a spring. This property is called capacitance instead of elasticity or stiffness.

(2) In the science of physical mechanics, the phenomenon of kinetic energy is associated with a physical property called inertia or mass and can be represented by a mass or a flywheel in motion.

In electronic science, kinetic energy is stored in an inductor (in a magnetic field) instead of a mass. This property is called inductance instead of inertia.

(3) In the science of physical mechanics, the phenomenon of energy dissipation is associated with a physical property called friction or resistance, and can be represented by a dashpot or other device which converts system energy into heat.

In electronic science, dissipation of energy is performed by an element called either a resistor or a conductor, the term 'resistor' being the one generally used to express the concept of friction, and the term 'conductor' being generally used to describe a more ideal device (e.g., wire) employed to convey electric energy efficiently from one location to another. The property of a resistor or conductor is measured as either resistance or conductance, reciprocals.

In economics these three energy concepts are associated with:

(1) Economic Capacitance—Capital (money, stock/inventory, investments in building and durables, etc.)

(2) Economic Conductance—Goods (production flow coefficients)

(3) Economic Inductance—Services (the influence of the population of industry on output).

All of the mathematical theory developed in the study of one energy system, (e.g., mechanics, electronics, etc.) can be immediately applied in the study of any other energy system (e.g., economics).

### MR. ROTHSCHILD'S ENERGY DISCOVERY

What Mr. Rothschild had discovered was the basic principle of power, influence, and control over people as applied to economics. That principle is "when you assume the appearance of power, people soon give it to you". **[H: Try that one on for Dr. Ed Young, along with total authority in all matters.]**

Mr. Rothschild had discovered that currency or deposit loan accounts had the required appearance of power that could be used to induce people (inductance, with people corresponding to a magnetic field) into surrendering their real wealth in exchange for a promise

of greater wealth (instead of real compensation). They would put up real collateral in exchange for a loan of promissory notes. Mr. Rothschild found that he could issue more notes than he had backing for, so long as he had someone's stock of gold as a persuader to show to his customers.

Mr. Rothschild loaned his promissory notes to individuals and to governments. These would create over-confidence. Then he would make money scarce, tighten control of the system, and collect his collateral through the obligation of contracts. The cycle was then repeated. These pressures could be used to ignite a war. Then he would control the availability of currency to determine who would win the war. That government which agreed to give him control of its economic system got his support. Collection of debts was guaranteed by economic aid to the enemy of the debtor. The profit derived from this economic methodology made Mr. Rothschild all the more wealthy and all the more able to extend his wealth. He found that the public greed would allow currency to be printed by government order beyond the limits (inflation) of backing in precious metal or the production of goods and services (gross national product, GNP).

**[H: I think you should read the above a couple of dozen times and check where you are today.]**

#### APPARENT CAPITAL AS "PAPER" INDUCTOR

In this structure, credit, presented as a pure circuit element called "currency", has the appearance of capital, but is, in fact, negative capital. Hence, it has the appearance of service, but is, in fact, indebtedness or debt. It is, therefore, an economic inductance instead of an economic capacitance, and if balanced in no other way, will be balanced by the negation of population (war, genocide). The total goods and services represents real capital called the gross national product, and currency may be printed up to this level and still represent economic capacitance; but currency printed beyond this level is subtractive, represents the introduction of economic inductance, and constitutes notes of indebtedness. War is, therefore, the balancing of the system by killing the true creditors (the public which we have taught to exchange true value for inflated currency) and falling back on whatever is left of the resources of Nature and the regeneration of those resources.

Mr. Rothschild had discovered that currency gave him the power to rearrange the economic structure to his own advantage, to shift economic inductance to those economic positions which would encourage the greatest economic instability and oscillation.

The final key to economic control had to wait until there was sufficient data and high-speed computing equipment to keep close watch on the economic oscillations created by price shocking and excess paper energy credits (paper inductance/inflation).

#### BREAKTHROUGH

The aviation field provided the greatest evolution in economic engineering by the way of the mathematical theory of shock testing. In this process, a projectile is fired from an airframe on the ground and the impulse of the recoil is monitored by vibration transducers connected to the airframe and wired to chart recorders. By studying the echoes or reflections of the recoil

impulse in the airframe, it is possible to discover critical vibrations in the structure of the airframe which either vibrations of the engine or aeolian vibrations of the wings, or a combination of the two, might reinforce resulting in a resonant self-destruction of the airframe in flight as an aircraft. From the standpoint of engineering, this means that the strengths and weaknesses of the structure of the airframe in terms of vibrational energy can be discovered and manipulated.

#### APPLICATION IN ECONOMICS

To use this method of airframe shock testing in economic engineering, the prices of commodities are shocked, and the public consumer reaction is monitored. The resulting echoes of the economic shock are interpreted theoretically by computers and the psycho-economic structure of the economy is thus discovered. It is by this process that partial differential and difference matrices are discovered that define the family household and make possible its evolution as an economic industry (dissipative consumer structure). Then the response of the household to future shocks can be predicted and manipulated, and society becomes a well-regulated animal with its reins under the control of a sophisticated computer-regulated social energy bookkeeping system.

Eventually every individual element of the structure comes under computer control through a knowledge of personal preferences, such knowledge guaranteed by computer association of consumer preferences (universal product code—UPC—zebra-stripe pricing codes on packages) with identified consumers (identified via association with the use of a credit card and later a permanent 'tattooed' body number invisible under normal ambient illumination).

#### SUMMARY

Economics is only a social extension of a natural energy system. It, also, has its three passive components. Because of the distribution of wealth and the lack of communication and consequent lack of data, this field has been the last energy field for which a knowledge of these three passive components has been developed.

**Since energy is the key to all activity on the face of the Earth, it follows that in order to attain a monopoly of energy, raw materials, goods, and services and to establish a world system of slave labor, it is necessary to have a first-strike capability in the field of economics. In order to maintain our position, it is necessary that we have absolute first knowledge of the science of control over all economic factors and the first experience at engineering the world economy.**

In order to achieve such sovereignty, we must at least achieve this one end: that the public will not make either the logical or mathematical connection between economics and the other energy sciences or learn to apply such knowledge.

This is becoming increasingly difficult to control because more and more businesses are making demands upon their computer programmers to create and apply mathematical models for the management of those businesses.

It is only a matter of time before the new breed of private programmer/economists will catch on to the far-

reaching implications of the work begun at Harvard in 1948. The speed with which they can communicate their warning to the public will largely depend upon how effective we have been at controlling the media, subverting education, and keeping the public distracted with matters of no real importance.

#### THE ECONOMIC MODEL

Economics, as a social energy science has as a first objective the description of the complex way in which any given unit of resources is used to satisfy some economic want (Leontief Matrix). The first objective, when it is extended to get the most product from the least or limited resources, comprises that objective of general military and industrial logistics known as Operations Research. (See simplex method of linear programming.)


The Harvard Economic Research Project (1948-) was an extension of World War II Operations Research. Its purpose was to discover the science of controlling an economy; at first the American economy, and then the world economy. It was felt that with sufficient mathematical foundation and data, it would be nearly as easy to predict and control the trend of an economy as to predict and control the trajectory of a projectile. Such has proven to be the case. Moreover, the economy has been transformed into a guided missile on target.

The immediate aim of the Harvard project was to discover the economic structure, what forces change that structure, how the behavior of the structure can be predicted, and how it can be manipulated. What was needed was a well-organized knowledge of the mathematical structures and interrelationships of investment, production, distribution, and consumption. To make a short story of it all, it was discovered that an economy obeyed the same laws as electricity and that all of the mathematical theory and practical and computer know-how developed for the electronic field could be directly applied in the study of economics. This discovery was not openly declared, and its more subtle implications were and are kept a closely guarded secret; for example that in an economic model, human life is measured in dollars, and that the electric spark generated when opening a switch connected to an active inductor is mathematically analogous to the initiation of a war.

The greatest hurdle which theoretical economists faced was the accurate description of the household as an industry. This is a challenge, because consumer purchases are a matter of choice which in turn is influenced by income, price, and other economic factors.

This hurdle was cleared in an indirect and statistically approximate way by an application of shock testing to determine the current characteristics, called current technical coefficients, of a household industry. Why GAS Costs \$2.00 Per Gallon.

Finally, because problems in theoretical economics can be translated very easily into problems in theoretical electronics, and the solution translated back again, it follows that only a book of language translation and concept definition needed to be written for economics. The remainder could be gotten from standard works on mathematics and electronics. This makes the publication of books on advanced economics unnecessary, and greatly simplifies project security.

## DIETARY DETECTIVE STALKS THE SHELVES

### A researcher forages through the health claims of herbal supplements.

After Bill Obermeyer clears the breakfast table, he drags out a microscope, aligns plastic bottles of a foul-smelling herb on the dining room table and digs into a musty, yellowing pharmacopeia. The family dog, an extra-large Jack Russell terrier, is led away.

Tucked into the bend of a quiet street in a modest neighborhood in Pasadena, Md., Obermeyer’s cozy white bungalow again becomes a center for clandestine investigations that have exposed some of the most woeful examples of sham and incompetence in the herbal marketplace.

Tall and thin as a *Typha angustata* (i.e., narrow-leafed cattail), he pads around sockless in a cardigan, blue jeans and deck shoes, looking more like a 4-year-old man of repose than an investigator. His house is redolent with herbal fragrances—except for the valerian powder, which smells like wet socks, and as quiet as the breeze sifting across his porch. It is a simple setting for what has become high-impact work.

Obermeyer is waiting for his four-person staff to return from a shopping spree to pick up a random assortment of nutrition bars—high-protein, low-fat, low-carb so-called “energy” bars. The sticky bricks of pressed fruit, grain and juice concentrate that have become the port-o-meal of choice for fad-conscious consumers have recently drifted into his line of sight.

“They say low-carb, but that’s actually illegal because there is no definition for low-carb,” he says, poking into boxes of bars stacked on his dining room table. “I also suspect a lot of these we’ll find don’t include glycerin in their total carbohydrate content. Look, this one says 2½ carbs in there—that’s pretty low. It would have to taste like cardboard.” At this point, nothing would surprise him.

During his career, Obermeyer has discovered herbal supplements peppered with pesticides and expensive dietary supplements devoid of their advertised ingredients. He’s examined tablets stuffed with sawdust, glass, sand, feathers and stuff that looked like floor sweepings. Sometimes these come from major manufacturers, sometimes not.

### Wild marketplace

Formerly a natural-products chemist with the Food and Drug Administration, Obermeyer has spent the last 18 months foraging this wild marketplace as research director of Consumer Lab, an independent business that tests, grades and offers its studied recommendations to the public **for a small fee** from its Website. Relying on independent labs around the country, he has so far analyzed 321 brands of vitamin supplements, Ginkgo biloba, saw palmetto, glucosamine chondroitin, Asian and American ginseng, creatine, calcium, coenzyme Q-10, Saint Johnswort and echinacea. The results underscore why *caveat emptor* remains a great axiom.

### From meadow to medicine, the industry is largely unregulated

Largely unregulated by the FDA, the American herbal industry sells an array of medicinal herbs and

vitamins as dietary supplements, otherwise known as nutraceuticals. No matter what you call them, nutraceuticals make up a multibillion-dollar business that sells products of mixed quality sometimes floated on extraordinary marketing claims and the equally extraordinary hopes of largely uneducated consumers.

Critics argue that, without controls, the industry has been conducting a social experiment using unregulated chemicals with consumers as guinea pigs. On the other hand, quality manufacturers worry that without some way for consumers to distinguish first-rate products from the fraudulent, the industry could wither.

It was into this vacuum that, in 1999, a physician in New York named Tod Cooperman brought Obermeyer, hiring him away from the FDA and establishing Consumer Lab as a for-profit business. The idea was to create a kind of Underwriters Laboratory for the herbal industry. Within six months, Obermeyer began exposing false labeling claims and apparent chicanery or incompetence.

With his 10-year FDA service, Ph.D. credentials in pharmacognasy and bevy of publicity-generating reports, he quickly became one of the authorities sorting out how Americans will be informed and protected in the murky nutraceuticals game.

And he acts as if it just hasn’t been all that complicated.

“We target things that are either well-known problems or something that could be a problem,” Obermeyer says.

In the case of ‘SAM-e—S-adenosyl-methionine, a dietary supplement used for depression as well as osteoarthritis—Obermeyer found that one of the highest-priced products “didn’t have anything in it”. Almost half of the 13 SAM-e products tested failed, showing less than the amount of SAM-e described on labels.

One-third of the 27 brands of Saint Johnswort brands failed his testing; 11 out of 25 echinacea brands failed; almost a third of the 25 brands of glucosamine supplements failed.

What about multivitamins? Of 27 brands, a third failed Obermeyer’s tests. Some had too much of certain vitamins on the labels, some too little; one did not disintegrate enough to deliver the ingredients.

**He is not nearly done, either.** His target to-do list includes valerian, MSM, phytoestrogens, isoflavones and iron supplements.

The simplest things demand the earliest scrutiny—“a little smoke and mirrors,” as he says, will fool the casual observer.

### Tips for consumers

- Know the scientific or species name of any supplement, which will help assess ingredient labels.
- Discuss any supplement with your doctor before taking it, particularly to consider possible interactions with other medications.
- Be careful about consuming herbal products if you have allergies to certain plants, pollen or flowers.
- Understand dosage requirements. In some cases, a particular supplement requires extended treatment; in others, frequent use could be harmful.
- Select for product freshness by evaluating the expiration date.
- Be aware that words like “natural” and “organic” do not suggest safety or effectiveness.
- Understand that herbal products are not universal panaceas, nor are claims by manufacturers always backed by scientific evidence.

SOUTH AFRICA HIV PREVENTION PROGRAM  
OUTRAGES HEALTH MINISTER

The launch of the Greater Nelspruit Rape Intervention Project—the inappropriately acronymed Grip—was heartily welcomed by the police, courts and doctors in South Africa's eastern province of Mpumalanga last year.

Three rapes a day are reported in and around Nelspruit. More than half the victims are girls under 15 years old, because of a widely held belief in the region that sex with a virgin is a cure for HIV.

Grip's volunteers—mostly Black women—provided comfort, help and information for rape victims from the moment that they stepped into two of the areas largest state hospitals. The management of the Rob Ferreira Hospital gave the organisation a small room for the purpose.

Grip saw to it that the women who walked through the door saw a doctor in an instant, and cut the average waiting time for rape victims to see the police from 48 hours to three. And if the rapist was caught, volunteers followed the case through the courts and made sure that the victim didn't have to wait in the courthouse corridor with her attacker.

It was an outstanding advance on the days when raped Black women were forced to sit in a hospital waiting room for hours before they saw a doctor—and were then confronted with indifferent and abusive policemen who frequently saw no crime in rape.

But Grip fell foul of the authorities with another of its services. The organisation ensured that women were swiftly given access to anti-retroviral drugs, paid for by donations. The quicker the drugs are taken, the greater the likelihood that they will stave off HIV.

The Mpumalanga provincial health minister, Sibongile Manana, was outraged. She said President Thabo Mbeki had banned the supply of anti-retrovirals and that their prescription was an attempt to poison Black people and was “undermining the present government”.

Ms. Manana ordered Grip out of two public hospitals and sacked the district health manager for failing to get written permission for the group, even though nearly 50 organisations work on the same premises without such authorisation. When Rob Ferreira's management tried to object, five top administrators—including the head matron and the hospital manager, who are both Black—were charged with “gross misconduct” and faced dismissal.

Charges were dropped when the provincial government's own lawyers said there were no grounds for a hearing. But Ms. Manana publicly announced that the officials had admitted their guilt. “She went to the newspapers and said we admitted we were guilty and she refused to correct her lie,” said Rob Ferreira's superintendent, Dr. Thys von Mollendorf. “She is upset because we say Grip provides an invaluable service. We at the hospital management are very upset that the minister wants to remove them.”

The ruling African National Congress (ANC) women's league approached Grip's Black female counsellors with a promise of jobs with the provincial government if they signed a petition denouncing the rape support group. “As members of the ANC, we cannot defy our government and its policies. We cannot defy our President Thabo Mbeki in his call against the use of

AZT,” the petition read. It went on to compare the supply of anti-retrovirals to the work of South Africa's own Dr. Mengele—notorious apartheid-era scientist, Wouter Basson, who is on trial for murdering Black people during drug experiments.

As a result of the confrontation at Rob Ferreira, eight of its senior doctors are leaving. In March, Rob Ferreira Hospital's HIV committee, chaired by a Black doctor, wrote to the provincial health department saying it backed the rape support group and wished it to remain. Ms. Manana says no; this is how the president would want it.

**WHAT IS HAPPENING TO AMERICA'S GOLD?**

This past December I wrote (Letter No. 276, “The Smoking Gun”) about my discovery of a discrepancy between two reports that tracked the status of the U.S. Gold Reserve. The Federal Reserve prepares both reports.

The first report is the balance sheet of the Federal Reserve, and the item of note is an entry entitled “Gold Stock”. Because of its ownership of the Gold Certificates issued by the U.S. Treasury, the Federal Reserve has a claim to the total U.S. Gold Reserve, reportedly 261.6 million ounces. Therefore, this liability of the U.S. Treasury—evidenced by its Gold Certificates to pay gold—is an asset on the balance sheet of the Federal Reserve.

The second report prepared by the Federal Reserve presents the U.S. Reserve Assets, which records all of the Treasury's international monetary assets. These include the Treasury's holdings of foreign currencies, SDRs issued by the International Monetary Fund, and gold. The item of note in this report is also the gold stock, which again is this same U.S. Gold Reserve.

Thus, it is clear that the gold held by the U.S. Treasury—the U.S. Gold Reserve—does double duty.

First, it provides a reserve at the Federal Reserve. In other words, because the Gold Certificates are an asset of the Fed, this claim to the U.S. Gold Reserve imparts value to the liabilities of the Fed, of which the most important are the Federal Reserve Notes that we carry in our pocket as cash currency.

But there is a second use as well because the U.S. Gold Reserve is also recorded as part of the international monetary assets of the U.S. Treasury,

the total of which are a measure of this nation's financial strength relative to other countries.

The important point is that last December I observed that the weight of gold in these two reports was different—and I explained why each weight should always be identical. Thus, the Gold Certificates owned by the Federal Reserve should always be equal to the U.S. Gold Reserves reported as part of the U.S. Reserve Assets. They are the one and the same hoard of gold—and there is a body of federal law saying so.

Further, we have been repeatedly informed by various Treasury and Federal Reserve officials that the U.S. government does not intervene in the gold market, that it does not trade gold for its account or the account of others, and that the U.S. Gold Reserve remains in storage at Fort Knox and the other depositories. If their contention was true, then why are these two reports showing different weights for the same hoard of gold?

The answer I pointed out last December is that the clandestine activities of the Exchange Stabilization Fund (ESF) belie the pronouncements of Treasury officials about that department's so-stated inactivity in the gold market. We know that the ESF is active in the gold market because the Federal Reserve says so in its report of the U.S. Reserve Assets.

This reports states that this weight of the U.S. Gold Reserve is the "Gold Stock, including Exchange Stabilization Fund". Thus, the difference in weights between these two reports is attributable solely to the gold activity of the ESF. As I stated last December, there is no other alternative. So at the time I discovered this discrepancy, I wondered how the Treasury would eventually come to explain this difference. How would they address the ESF's activity in the gold market? How would they explain away their previous statements on record that neither the U.S. Treasury nor the ESF is trading gold?

In the months that have passed, the Treasury has continued to deny U.S. government activity in gold. But that is not all the Treasury has been doing. It has also been working hard to cover up its tracks.

The U.S. Reserve Assets report now excludes all reference to the ESF, and previous reports already published have been changed. Not only were the figures adjusted, but all reference to the ESF has been eliminated. Reg Howe posted to his Website (<http://www.goldensex.com/commentary18.html#anchor12493>) an excellent article addressing this change, and says: "The figures could not be changed without a change in description, proof that the earlier discrepancies were, indeed, on account of gold held by the ESF." Indeed.

The Federal Reserve stopped mentioning the ESF in these reports in February. I guess the January 2001 report was already being prepared when my December article appeared, so it was too late to change that report. Thus the U.S. Treasury has enlisted the Federal Reserve as its partner in crime, as it is after all the Federal Reserve that prepares these reports. And what is that crime?

Without any explanation to anyone (including Congress to my knowledge), the U.S. Treasury has taken steps that can be of no other purpose and have no other intent but to hide the truth. The ESF has been erased out of the U.S. Reserve Assets report as if it never previously existed. Thus, these new reports being prepared by the Federal Reserve (and up to now they had probably been prepared this same way, since the ESF was formed in 1934)

ensure that the American public will no longer see this gold-related activity by the ESF.

As I write this, I shake my head in disbelief. All I can think of are those old photographs showing sclerotic Soviet despots standing on the parapets of the Kremlin, which would somehow miraculously and inexplicably change over the years depending on who fell out of favor. Having had their erstwhile colleagues air-brushed out of those old photographs as well as Soviet history books, those despots who survived the purge acted as if the truth never existed. Are our Treasury officials no better than that with their apparent reckless disregard for the truth, air-brushing the ESF out of the Federal Reserve reports? Before you answer that question consider also another recent damning action by the Treasury.

This past April I wrote (Letter No. 283, "Behind Closed Doors") about the Treasury's unexplained reclassification of that part of the U.S. Gold Reserve in the Treasury depository at West Point as "Custodial Gold". Using minutes of the Federal Open Market Committee of the Federal Reserve—actually, very revealing minutes referring to "gold swaps" that apparently were inadvertently not redacted before being made public—and by other corroborating evidence, I suggested that the term "Custodial Gold" meant that this part of the U.S. Gold Reserve had been swapped with gold owned by the Bundesbank.

My assertion provoked controversy but no denial from the Treasury. Alarming, not only was the Treasury silent to me, its critics, and others searching for the truth, the Treasury was apparently also silent to Congress. But recently, the Treasury has "spoken".

Last month all of the U.S. Gold Reserve was reclassified. None of the gold stored at West Point, Fort Knox, and the other depositories is called U.S. Gold Reserve or even Custodial Gold. All of it is now labeled as "Deep Storage Gold". **[MM: Apparently, it's stored so DEEPLY that it actually has yet to be mined/recovered—but they're staking their claim anyway.]**

This action raises a lot of serious questions.

Does this change of label mean that this gold is no longer the U.S. Gold Reserve, and if so, why? But if it still is the U.S. Gold Reserve, then why did they change the label, and why don't they still call it the U.S. Gold Reserve? How can the Treasury act unilaterally without any prior public notification informing anyone that this gold asset would be reclassified? What is the Treasury trying to cover up by this latest action? **[MM: That's obvious: Show me the physical gold!]**

While I was pondering these and other questions, more intriguing news has come to light. The Federal Reserve has released to Sen. Jim Bunning an internal memo to Alan Greenspan from Virgil Mattingly, general counsel of the Fed, whose quote of the "gold swaps" in the FOMC minutes was included in my April article.

Mattingly now says that he has no "clear recollection" of what he actually said at the FOMC meeting that fateful day, but nevertheless he believes that his remarks "were transcribed inaccurately or otherwise became garbled". Hmmm, "transcribed inaccurately". So he didn't say "gold swaps" to provide an example of ESF authority? Well, let's see. What could he have said, and how were those words transcribed inaccurately? Would the correct transcription have been "bold wasps"?

Or did Mattingly really say that day that ESF authority was demonstrated by "cold swats"?

Actually, there is no need to guess what Mattingly really said. The Federal Reserve's Website says:

"Beginning with the 1994 meetings, the FOMC Secretariat produced the transcripts shortly after each meeting from an audio recording of the proceedings."

Therefore, there is no need to speculate what Mattingly really said. Let's go back and listen to the original tape of the meeting. And while we're at it, let the American public listen to the WHOLE TAPE, including all of the material and discussions about the ESF that were redacted from the transcript released to the public.

These recent developments have stimulated in my mind a lot of questions. Why is the U.S. Gold Reserve no longer called that by the Treasury? Why did the Treasury force the Federal Reserve to change its reporting of the U.S. Reserve Assets to exclude the gold-trading activity of the ESF? And who is the mastermind behind what obviously is becoming a clear (and probably illegal) coverup of the truth?

These are only a few of the questions that I would like answered. But all of them pale in comparison to one big question: What is happening to America's gold?

A note on "earmarked gold".

I mention in the above article the recent essay written by Reg Howe, and provide a hyperlink to it. I strongly recommend that you read this essay because it is full of informative material, including details of the so-called earmarked gold being stored at the Federal Reserve Bank of New York.

This gold is owned by foreign governments and institutions such as the International Monetary Fund, but is stored at the New York Fed. It is specially "earmarked" in order to establish that this gold is not part of the U.S. Gold Reserve, some of which is also stored at the New York Fed.

This weight of earmarked gold is one of the largest hoards in the world stored in any one place, but its size has been declining in recent years. There were 13,387 tonnes of earmarked gold stored at the New York Fed in 1990, but this total has dropped to 9,235 tonnes as of April 2001, which is the most recent report, a decline of 4,152 tonnes, or 31 percent.

There has been a pattern to this flow of gold out of the New York Fed, mainly reflecting bigger flows out when the gold price is rising. This pattern of activity may have been one of the factors that Fed Chairman Alan Greenspan was referring to when he testified before Congress that "central banks stand ready to lease"—that is, lend—"gold in increasing quantities should the price rise".

However, that pattern has been changing. Since September 2000 at least 40 tonnes of gold have been removed from the New York Fed each month. Reg Howe notes that "the central banks have not only increased their leasing and sales activities but also made them less obviously targeted to price increases". This observation is important.

In my view, this change in the pattern of dishoarding from the New York Fed **smacks of desperation**. The shorts need physical bullion to keep the gold price from exploding. The shorts can't get this bullion from new production or other sources, so they have to pull it out of the New York Fed, regardless of whether the gold price is rising. More gold is coming out of the New York Fed each month than is being mined by South Africa, the world's largest producer.

According to the Washington Agreement, central banks cannot dishoard more than 400 tonnes per year, nor increase their lending of gold. If so, then why is gold being pulled out of the New York Fed at a rate more than 480 tonnes per year? But the real picture is probably even worse.

It is likely that the 150 tonnes being sold by the Bank of England this year is stored in the BoE's own vault in London, not the New York Fed. So when taking the 80 tonnes' difference calculated above and this 150 tonnes, we can conclude that 230 tonnes more gold is being dishoarded from the New York Fed than required for the central banks if they are indeed sticking to their Washington Agreement. I see only two interpretations to this analysis.

The obvious conclusion is that the central banks are breaking the Washington Agreement and selling more than 400 tonnes per year and/or increasing their gold lending. The less obvious conclusion is that the central banks that signed the Washington Agreement are indeed sticking to it, but some non-signatory is lending and/or dishoarding gold.

Though long-time readers of these letters know that I have a very low regard for central banks and their commitment to honor their agreements/promises, I think that they deserve the benefit of the doubt this time. My guess is that someone else is shipping this 40 tonnes of gold a month out of the New York Fed.

If we assume that the signatories of the Washington Agreement are indeed honoring their commitment, and given the size of the weight of this gold being shipped monthly out of the New York Fed, there are only two possible parties that have this much gold—the International Monetary Fund and the U.S. Treasury.

So could the Treasury somehow be swapping more gold with the Bundesbank? Or is the IMF involved? I think it is the latter.

Note all of the talk in this past weekend's G-8 meeting about debt relief for poor countries, but in contrast to years past, there's been no mention of selling the IMF's gold to raise the money to provide this relief. Maybe they are purposefully not mentioning the IMF's gold because they are already tapping into it. [END]

#### THE RATS ARE LEAVING THE SHIP!

I get a lot of things forwarded to me by clients and friends—and I, in turn do the same to them. I thank Jeff L. for a story from the (London) *Times* of July 9<sup>th</sup>, whose headline is, "Share Selling By U.S. Directors Reaches Record". (A lot of times, the U.S. media ignore stories that are deleterious to their home subscribers.)

When ships sink, the rats leave. They realize it is either take a chance on swimming, or surely drown. Their little pea brains tell them that. Are U.S. executives, CEOs, and "insiders", acting like the rats, who leave when they know the jig is up? I don't write about stocks, because I have had no faith in them for several years. I write about the folly of such, the absurdity of paper "money" and saving in it—but the story may be indicative of just how far down the stock market has yet to go.

I laugh at the attempted quashing of so called "insider trading", because stopping that would be as impossible as trying to bicycle to the Moon. Anyone who has any information about a corporation, known to few, be they employees, or even someone who adds two and two to get four, can be considered an "insider". I have known for a long time that platinum was being withheld by the Russians, who have a lot of it. PT (platinum) had to go down eventually, when the Ruskies needed an infusion of capital. As I write this, Platinum is \$502, down from \$625—and possibly headed further south, to its former level of the \$450 area. I don't KNOW this, but if anyone gleaned from the news that Russia was withholding, had a huge supply, was broke and would eventually need to sell, they could have been an "insider", couldn't they? If a new source of widgetarium is discovered, those who know about it first, will be "insiders" in the

widgetarium market and can make a lot of profit. For that matter, no matter how large or small the corporation, its stock prices can be manipulated by the management, or large shareholders. Simply by dumping large amounts of it, or buying large amounts of it, to either make the stock go down or up—and they can take advantage of their manipulation. The exact same thing is happening in precious metals, with central banks and governments doing the manipulating. The only stock buyers that are not "insiders", are the know-nothings, who have no connections or knowledge and follow the crowd—as I said previously, getting on the trolley as it nears the end of the line. The trolley must turn and return to its origin, turn around again and follow the same path over and over again. Doesn't the stock market's record over the last hundred years act like it is almost on a track, just like a trolley car?

(As an aside: In large cities, when the geniuses bussed the trolley lines, ridership always declined. The busses rode not nearly as smoothly, made more noise, and the unconscious assurance of rails made riders feel safer, knowing a driver couldn't go where he wanted, and they would have to return to where they started.)

Here are a few quotes from the London *Times* story: "Share selling by directors of U.S. companies has reached record levels... Selling directors now exceed buyers by a ratio of five to one... directors are seeing no improvement in order books, and they are dumping their own shares even though the share prices are already low... 1800 directors and insiders were sellers in the past week."

These "directors" that are unloading, even though they may have already lost a bundle, are not stupid. They are the "insiders". They know the orders aren't coming, some expenses are constant, employees have been laid off, advertising cut, (advertising revenues are way off in all media) and like rats, they had better get off the boat before it sinks. A lot of corporate "boats" have already sunk. **If the reader has stocks, doesn't the above indicate that it might be a bit provident to get out before they go down even more?** No, I don't know this will happen. If I knew what was going to happen tomorrow, I would be a billionaire! No one knows what will come tomorrow. Maybe the eventual huge earthquake will take out the Long Valley, near Mammoth, in California, where they have dozens of small earthquakes every week. Maybe a terrorist will smuggle in a suitcase atom bomb and blow up something. Maybe the stock market will shoot up like a rocket. Maybe, maybe, maybe, but no one knows. We just make decisions on the best information we can get.

In the '50s, an average working man, making \$65 a week, could support a family, purchase a home and new car. Today? You must be kidding! We now have a lower standard of living than our parents did 50 years ago. There is no other way to look at it. If there is, please inform me of it at [gold@gwe.net](mailto:gold@gwe.net). Wages have not gone up nearly as fast or far, as have prices, in funny money.

"Oh, but the dollar is sound, why it is like Atlas, who held up the world. Every world commodity is traded in dollars, and even some other nations have based their currencies in dollars. I am secure in dollars." If you believe that, you are a fool. The dollar has lost about 70%, or more, of its purchasing power in the last 50 years.

Paper "money" can radically devalue in quick order. In America, it has occurred pretty rapidly, but the Turkish lira is now 1,500,000 to the dollar, and the Indonesian rupiah is 11,300 to the dollar, an 800% drop. If so, it may be economically smart to buy a half a beef, or a quarter beef, which will save you big bucks.

#### HOUSE BACKS BAN ON HUMAN CLONING FOR ANY OBJECTIVE

WASHINGTON—After an impassioned debate that pitted the promise of cures for disease against the horror of making babies that are genetic replicas of adults, the House of Representatives voted by a wide margin today to ban cloning, not only for reproduction but also for medical research.

The bipartisan 265-to-162 vote came after lawmakers rejected a less restrictive measure that would have prohibited making babies by cloning while leaving open the door for

“therapeutic cloning” experiments in which scientists would create embryos that could be used to treat disease.

Therapeutic cloning is legal in Britain. The far-reaching bill the House adopted, which is backed by President Bush, would not only prohibit it, but would also outlaw the sale of treatments developed from it.

“I think the House spoke very, very loudly today that this is morally and ethically inappropriate,” said Representative Dave Weldon, a Florida Republican who was the bill's chief sponsor. “It clearly sends a message that there is a place we don't want to go, and that is the manufacture of scientific embryos for research.”

The cloning debate is tangled up with another scientific controversy steeped in politics, that of embryonic stem cell research. The House action—the first time lawmakers have voted on cloning—comes as President Bush is weighing whether to permit federal financing for studies on stem cells derived from human embryos, and it complicates both the politics of the debate and the business of stem cell science.

President Bush praised the House vote.

“The moral issues posed by human cloning are profound and have implications for today and for future generations,” he said in a statement issued by the White House. “Today's overwhelming and bipartisan House action to prohibit human cloning is a strong ethical statement, which I commend. We must advance the promise and cause of science, but must do so in a way that honors and respects life.”

But the vote against cloning does not necessarily dim the prospects for Congress to approve federally financed stem cell research should President Bush come out against it. Lawmakers say that is because those studies would be limited to cells extracted from embryos that would otherwise be discarded by fertility clinics, which does not seem as extreme to many people as therapeutic cloning.

“People see a difference between the idea of stem cell research and cloning,” said Representative Henry A. Waxman, a California Democrat who voted for the less restrictive measure. “The idea of cloning is very terrifying because it is creating a copy of another human being. I think members haven't looked at all the nuances.”

Stem cells are extracted from human embryos, when they are tiny clusters of no more than 300 cells; the work attracts intense criticism from abortion opponents and religious conservatives because the embryos, which they view as human life, are destroyed by the experiments. Because stem cells can grow into any type of tissue in the body, scientists regard them as the building blocks of a new era of regenerative medicine, in which doctors will heal patients using their own tissues.

But to realize the full promise of stem cells, many experts say, the cells must be compatible with patients' immune systems. That is their rationale for therapeutic cloning; by creating embryos that contain patients' own DNA, they say, they could develop tissues that would be an exact match for patients.

Already, a Massachusetts company, Advanced Cell Technology, has announced its intention to conduct therapeutic cloning experiments; that work would become illegal should the House bill become law.

“It is disappointing that we are not having a more reasoned debate,” said Mike West, the company's chief executive, in an interview tonight. He described the discussion on the House floor as “two hours of rampant misinformation”.

Representative James Greenwood, the Pennsylvania Republican and sponsor of the bill that would have permitted therapeutic cloning, described the House vote today as “flat-earth kind of thinking” and added, “It has no basis in science, and it's not compassionate.”

The bill, which makes cloning a crime punishable by up to 10 years in prison, faces uncertain prospects in the Senate, where Sam Brownback, Republican of Kansas, has introduced similar legislation. Mr. Brownback proclaimed

today's vote in the House “a great day for humanity” and said that while he did not have a count of senators who might stand with him, he was working to build a “left-right coalition”. **[MM: An anti-Camp David coalition?]**

That kind of coalition helped the bill pass the House; 63 Democrats joined with 2 independents and 200 Republicans to assure the bill's passage. Some of these lawmakers favor stem cell research on frozen embryos, but have drawn the line at therapeutic cloning.

Some lawmakers say this kind of line-drawing will enable conservatives to support stem cell research without fear of reprisal from abortion opponents. “It gives them the ability to say, ‘I'm a reasonable person, I'm not a crazy, I don't want human cloning,’” said Peter Deutsch, Democrat of Florida and a co-sponsor of the Greenwood bill.

Biotechnology industry officials described today's vote as a step backward for medical research. And abortion opponents saw it as an important victory.

“The House has acted to block the creation of embryo farms,” said Douglas Johnson, a spokesman for the National Right-to-Life Committee. “But the biotech firms will begin this ghoulish industry soon unless the Senate also acts.”

There is broad consensus among lawmakers that human cloning, the creating of babies that are identical genetic copies of adults, is morally repugnant. And many lawmakers today warned that if therapeutic cloning went forward, scientists would step onto a slippery slope that would inevitably [??!] lead to cloning people.

“The world is waiting for the United States to set the moral tone against this experimentation,” said Representative F. James Sensenbrenner Jr., Republican of Wisconsin. “If scientists are permitted to clone embryos, we can look forward to embryo farms where embryos will be stockpiled and mass marketed.”

Backers of Mr. Greenwood's measure, however, argued strongly that banning therapeutic cloning would be akin to denying life-saving therapies to millions of Americans who suffer from diabetes, Alzheimer's disease, Parkinson's disease and a variety of other ailments. **[MM: “Useless eaters” are not permitted to share the spoils of this advanced, four-decades-old technology—Elite only need apply!]**

Even so, health advocacy groups, which have been waging a vocal campaign to persuade Mr. Bush to permit federal financing of embryonic stem cell research, were noticeably quiet on the cloning bill. Some saw the House vote as a foregone conclusion.

“What is unfortunate is that cloning conjures up these images of Frankenstein and horrible science, and it is really just a pejorative term for cell therapy,” said one advocate for patients, who spoke on the condition that she not be named.

She added: “Some of the members of Congress we have worked really hard to get on our side on embryonic stem cell research are either unsure of where they are on cloning, or are against it, and we don't want to alienate those members.”

To clone, technically, means to copy. But cloning was barely on the radar screen of policy makers and scientists until 1997, when scientists in Scotland announced they had cloned a lamb, Dolly, from an adult sheep.

The following year, the Senate considered legislation that would have banned cloning, but Democrats blocked the Republican-backed measure from coming up for a vote.

Cloning challenges the conventional wisdom that embryos must be created from the union of egg and sperm. And so today's debate sounded at times more like a discourse in theology than a political discussion, with lawmakers expounding on matters like whether embryos created through cloning are embryos at all.

“It is not an embryo,” insisted Mr. Deutsch, of Florida. “It is not creating life by any definition of creating life.”

Mr. Weldon replied, “That's like saying Dolly is not alive.”

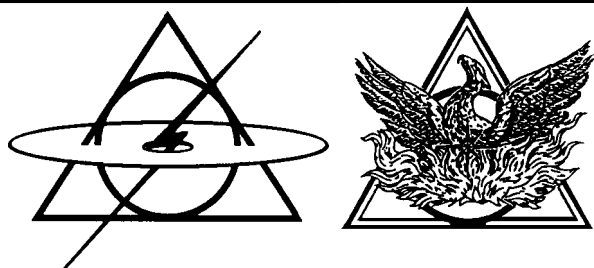
