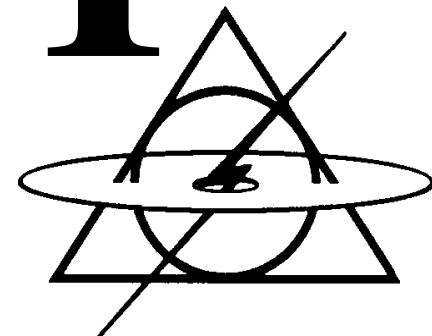

RUSSIA CHECKMATED ITS NEW BEST FRIEND

Many Americans, grown cynical of government pronouncements, have been asking whether the real war goal of the United States in Afghanistan is to gain access to Central Asia's oil and gas. The answer: no and yes. The U.S. attacked Afghanistan to exact revenge for the Sept. 11 attacks.

But it must have quickly occurred to former oilmen George Bush and Dick Cheney that retribution against the Taliban and Osama bin Laden OFFERED A GOLDEN OPPORTUNITY TO EXPAND AMERICAN GEOPOLITICAL INFLUENCE INTO SOUTH AND CENTRAL ASIA, SCENE OF THE WORLD'S LATEST GOLD RUSH—THE CASPIAN BASIN.

The world has ample oil today. But, according to CIA estimates, when China and India reach South Korea's current level of per capita energy use—within 30 years—their combined oil demand will be 120-million barrels daily. Today, total global consumption is 60-million to 70-million barrels daily. In short, the major powers will be locked in fierce competition for scarce oil, with the Gulf and Central Asia the focus of this rivalry. Central Asia's oil and gas producers are landlocked. Their energy wealth must be exported through long pipelines. He who controls energy, controls the globe.

Russia, the world's second-largest oil exporter, wants Central Asian resources to be transported across its territory. Iran, also an oil producer, wants the energy pipelines to debark at its ports, the shortest route. BUT AMERICA'S POWERFUL ISRAEL LOBBY HAS BLOCKED WASHINGTON'S EFFORTS TO DEAL WITH IRAN.

Pakistan and the U.S. have long sought to build pipelines running due south from Termez, Uzbekistan, to Kabul, Afghanistan, then down to Pakistan's Arabian Sea ports, Karachi and Gwadar. Oilmen call this route “the New Silk Road”, after the fabled path used to export China's riches. This route, however, would require a stable, pro-Western Afghanistan.

**[H: Don't you just hate it when things work out to be other than what you bought in a patriotic fit of passion?]**

Since 1989, Iran has strived to keep Afghanistan in disorder, thus preventing Pakistan from building its long-sought Termez-Karachi pipeline. When Pakistan ditched its ally, the Taliban, in September, and sided with the U.S., Islamabad and Washington fully expected to implant a pro-American regime in Kabul and open the way for the Pakistani-American pipeline.

BUT, WHILE THE BUSH ADMINISTRATION

WAS BUSY TEARING APART AFGHANISTAN TO FIND BIN LADEN, IT FAILED TO NOTICE THAT THE RUSSIANS WERE TAKING OVER HALF THE COUNTRY. THE RUSSIANS ACHIEVED THIS VICTORY THROUGH THEIR PROXY—THE NORTHERN ALLIANCE. MOSCOW, WHICH HAS SUSTAINED THE ALLIANCE SINCE 1990, REARMED IT AFTER SEPT. 11 WITH NEW TANKS, ARMORED VEHICLES, ARTILLERY, HELICOPTERS AND TRUCKS. **[H: And gosh, you Americans thought you had done that little trick.]**

To the fury of Washington and Islamabad, in a coup de main the Russians rushed the Northern Alliance into Kabul, in direct contravention of Bush's dictates. The alliance is now Afghanistan's dominant force and, heedless of multi-party political talks in Germany going on this week, styles itself as the new “lawful” government, a claim fully backed by Moscow.

The Russians have regained influence over Afghanistan, avenged their defeat by the U.S. in the 1980s war and nearly checkmated the Bush administration, which, for all its high-tech military power, understands little about Afghanistan. The U.S. ouster of the Taliban regime also means Pakistan has lost its former influence over Afghanistan and is now cut off from Central Asia's resources.

So long as the alliance holds power, the U.S. is equally denied access to the much-coveted Caspian Basin. Russia has regained control of the best potential pipeline routes. The New Silk Road is destined to become a Russian energy superhighway.

By charging like an enraged bull into the South Asian china shop, the U.S. handed a stunning geopolitical victory to the Russians and severely damaged its own great power ambitions. Moscow is now free to continue plans to dominate South and Central Asia in concert with its strategic allies, India and Iran.

The Bush administration does not appear to understand its enormous blunder and keeps insisting that “the Russians are now our friends.” The president should understand that where geopolitics and oil are concerned, there are no friends, only competitors and enemies.

What a shocking admission by the chairman of the Senate Judiciary Committee that the bill was not debated as to its constitutionality! Who are the abusers of the *Constitution*? It is every politician who gives his or her assent to a bill which has not been properly debated as to its constitutionality; those who are guilty of exercising arbitrary power for expediency, knowing that the *Constitution* cannot be compromised in this reckless and dangerous manner. They dare to stand up in the halls of Congress where the great statesmen of the past once stood, and produce their measures of expediency to fit this or the other circumstance. Principle can never be sacrificed for expediency. Their chief purpose is to stay in office and they write bills that will garner the votes which enable them to make a grand living out of politics. We ought to be ashamed of those who come to Washington to make a career out of politics, instead of making a career out of serving the American people. These are the people who are a danger to the nation, for the effect of their deeds can change the course of our nation from a certain future to a dark and dangerous one.

How have such politicians profited the American people? We say unto you, the citizen, the sovereign: “They have fouled the waters of the Ohio so that none dare take a drink from it; they have now made tracks on the Blue Ridge trail; they have gouged out huge gaping holes into which we, the people must now fall, unless we open our eyes and see what the haters of the *Constitution* are doing.”

We, the People have a duty to remove their backhoes, their bulldozers, their earthmovers that are making a scene of desolation of the Blue Ridge track and we must put a stop to their depredations, their destruction of the *Constitution* and the *Bill of Rights*. Can we not see that their intent is to tear down the *Constitution* whom one of their most revered leaders, Franklin D. Roosevelt, once said belonged in the “horse and buggy era”. They want to draw up a new blueprint to construct their “New World Order”.

It is because of the abject failure of our representatives in Congress to put a stop to the willful destruction of our *Constitution*—and it is important that we remember it is our *Constitution* and not the government’s—that we find our liberties in such peril today. Politicians tell us that in times of emergencies our liberties, our freedoms have to be restrained in the interests of “national security”.

To this we reply: “Never! It is the very politicians who call for restraints on our God-given liberties who stomped and kicked our *Constitution* like jackbooted thugs, who now want us to allow them to do further damage. They turned the nation from a republic into an empire. In our name they behaved as an empire, following the model of the British Empire, imposing our laws on foreign nations when there is no constitutional provision for it. These politicians insisted on interfering in the affairs of foreign nations when they had no such right under the *U.S. Constitution* and under international law. We must firmly reject this dangerous concept.

Let us look at a few examples of our mentor, the former British Empire on which the politicians modeled our nation since 1912. The British Empire settled trade disputes or challenges to its trade monopolies through wars, after diplomacy by deception failed. Its foreign policy toward China in the 18th and 19th centuries is too long to include in all of its sordid, ugly detail, so we are obliged to content ourselves with brief details of its policies toward China and South Africa, policies which are indeed linked.

In 1816 the Chinese government began to take action against British-controlled opium coming into China in large quantities. Lord Amherst, the newly appointed ambassador to Peking was sent back to London without being received, because of his close relationship with the British East India Company (BEIC), whose principal income was derived from the sale of opium, which it first introduced into China in 1715 at Canton, and which by 1821, had earned huge revenues for the company. Cargoes of opium were stored at Linton Island and on barges on the Canton River.

**[H: I suggest none of you get so distracted in discussions about oil pipelines, etc., across Afghanistan as to overlook the opium trade out of Afghanistan and the Golden Crescent region as a whole.]**

When the Chinese government began destroying these stocks, Lord Matheson of the BEIC wrote to London suggesting that “war is the next step”. It did not bother Matheson that his company had no authority to be in China. Violation of the sovereign right of China meant nothing to the Empire, an example the U.S. followed with the advent of Wilson to the presidency and has continued to follow ever since. This was, after all, the normal procedure followed by Parliament. An invasion force was mounted and arrived off Canton in March 1840. British troops set about killing Chinese people, sacking and burning their cities in what in the 20th Century was to become a fixed policy of “enlightened terror”. Does this not remind you of the Gulf War and the war against Serbia carried on by the United States?

The invasion was an extension of the 1787 policy recommended by Lord Dundas that British forces “storm China” to force its government to comply with the Empire’s orders. In blatant aggression, the Empire’s military might was used to sack, burn and kill all who stood in her way. Chiang Kang and a number of coastal ports were seized. Peace terms were dictated by Sir Henry Pottinger, a servant of the BEIC. The 1842 *Treaty of Nanking* imposed onerous conditions upon China, under the terms which it was forced to cede Hong Kong (seized by British troops in 1841) to the Empire, open the ports of Canton, Amoy, Foochow, Nongpo and Shanghai to unrestricted imports of opium under British supervision.

Before the war was over “China was taught no end of a lesson”. Canton was seized, Peking sacked and the Summer Palace burned to the ground. China was forced to sign the *Treaty of Tientsin*. The British Empire fought three wars against China to sustain its opium trade monopoly at the cost of 50,000 killed and 78,000 wounded, with immense property damage and an estimated cost of \$5 million—an immense sum of money in those days. In addition the Chinese government was forced to pay “reparations” amounting to \$1 million in silver. Evidently the British did not trust paper “money”.

The British Empire reaped immense profits from wars and the forced opium on China that turned hundreds of thousands of Chinese people into addicts. Obscene profits made from the misery of China were used to finance an invasion of South Africa in 1899 and wage a brutal war (the Anglo-Boer War 1899-1902) against the tiny Boer nation. The sole purpose of the war was to gain control of the gold and diamonds lying beneath the barren soil of the South African veldt. The British Empire called on its colonial possessions to send troops to

help subdue the Boer and the call was answered by troops from Canada, Australia and India.

Unlike their wars against China, it was the tiny Boer force of 80,000 men (which included fourteen-year old boys and men as old as seventy) who taught the pride of the mighty British Army “no end of a lesson”. As the campaign dragged on with heavy British losses, the Empire built concentration camps into which Boer women and children were herded and kept without proper shelter from the elements and without adequate supplies of food, water, sanitation and medicine.

Boer churches were blown up, their farm buildings burned to the ground, their cattle wantonly slaughtered, their crops destroyed. It was only when their women and children began to die in large numbers that the Boers in the field, surrendered. Twenty seven thousand Boer women and children died in these camps from neglect while Lord Kitchener and his General Staff officers spent their nights inside comfortable quarters drinking the finest wines and puffing on cigars. It was the most vicious case of genocide and it reflected the Empire’s hatred of the Boers, a hatred which endures to this day.

The brave Boer leaders and their fighting men, even boys of the age of 14 and 15, were exiled to Argentina and remote places like St. Helena Island, never to see their families again. Their amazing victories over the pride of the British Army buttressed by troops from the Empire has to go down in the annals of history as a most remarkable success: 80,000 irregular guerillas fought and defeated an army of 400,000 regular soldiers. Their victories must rank with the victory of George Washington over the British Army at Yorktown.

The great British Empire which the United States began to emulate after Pres. Wilson was elected, had a long history of trade wars beginning with the ruthless suppression of Ireland’s thriving industry and trade that had arisen out of the Celtic traditions dating back to commerce with the Phoenicians and even further back into antiquity.

# The Soul Consists Of All Things In Creation

RE: "LIFE". COLLOIDAL SILVER: DISCUSSION OF "SILVER CORD OF LIFE"

## WHAT IS "LIFE"?

**Hatonn**—Very simply put, "life" as you recognize it to be is an ENERGY productive system individualized from a central production center or source.

Example? Well, let us take a major hydroelectric plant and a house a mile distant. The house is wired for electricity use but there is no connection to the plant (grid) so the house remains "dead". When it is connected to the grid and the circuit is activated you have "life" or "energy (electricity)" available for use. The house is now "alive".

Now, think of an embryo which is connected to the "Mother" of whatever entity you speak, be it a seed in "Mother Earth" or a child in the womb. That lifeform is operating off the Mother's "electric" or "life" circuit. If the babe is shut off from the Mother's system (the mother dies) or nourishment is cut off from the seed sprout in "Mother Earth" you have death of the "child".

THE ENTIRETY OF "LIFE" IS ELECTRICAL IMPULSE IN WHATEVER FORM IT TAKES. THAT "IS" LIFE.

This is also why, in the case of a severing of the spinal cord, all function attached to the cord below the sever is compromised or totally shut down. The "power" ceases to flow. However, the other systems do not necessarily shut down, i.e., circulatory system, *et al.* So, as the body is helped or itself continues to function as in "breathing" for oxygen supply, the body will remain in a state of "life" but not necessarily "motion" on its own system.

You MUST have energy to "live".

When the body is separated from the soul or energizer source, you have stasis of the body and then death. When the cord (soul) is severed totally, you have no further connection to the power source. Total simplicity in the presentation: Turn off the power supply and a body ceases to function.

When the body is too badly damaged to be able to have life function, the soul will depart it—or at a "choice" it may well decide to remain intact even with the incapacity of full function.

This represents, however, the difference in robotic machines from "original" life-forms. But BOTH need power sources or they are DEAD.

This is also what ill-health is about: a damaged "system" which compromises the body function.

## SILVER CORD

With the above in mind let us consider that attachment which holds the "you" to the perceived apparatus you think of as "you". It is unique and is a representation of YOU. However, the "power source" is the REAL "you". As long as the power source is

connected and power running through the body, you have life-force of various levels of function.

Now, people, there is a REASON that the connection "wires" (if you will) are called the SILVER cord. THIS IS THE ENERGY CONDUIT.

The umbilical cord is the life-flow connection to "Mother" which supplies the needs for your "forming" body according to YOUR DNA-RNA structure—HOWEVER, that connection to God or SOURCE is also being formed, programmed, and data based.

A body can be kept "viable" on life-support systems to sustain cellular structure and operation—but the connection to nervous system power source is mandatory to have a self-sustaining "system".

**The SOUL is made of ALL THINGS in CREATION.** This is not strange or difficult to recognize, for even your primitive charts will tell you that when you are missing any item, you will not function properly but rather, be compromised in some manner.

Human body "resonates" on a frequency which can be sustained at the same frequency as "silver" ENERGIZED. Furthermore, IF you could see the aura of the connector when energized, it would produce a golden glow. However, when the cord itself (the circuit wire) departs, it will appear as a very long cord attached to a puff of energy "cloud" or "vapor ball" which is relatively transparent but can, as well, be measured. A body will show a small change in weight immediately at "death". I don't even want to talk about that, for **with death of the body comes life of the soul**, so realize that body is also sustained in a "lighter" state than is a "dead" body which you refer to as "dead weight". This subject becomes far too lengthy to discuss here where my topic is help for the body-soul.

Neuro-connectors in the brain-nervous system attached to the power source are comprised of many various "elements" to best serve individual PURPOSE of the circuit itself.

When we talk, however, about that silver cord, it has far more meaning than you might realize, for the body itself gives off "color" in the energy field around the body—called "aura". This is also called "radiance".

There is a difference in "gray matter" (brain cells) and "radiance" but let me remind you that the color itself of the energy fields should range from golden to white. Various other "colors" will be seen at various concentration of thought processes. The "heart" as in "emotional state" will present very often as a golden-green energy radiance. ## PART 4

Our study at the British Museum of this period of brutal suppression of the Irish people showed that it began under Edward III and lasted from 1339 to 1850. In 1650 the Lord Lieutenant of Ireland wrote to King Charles I to discourage Irish independent trade: "That all wisdom advises to keep this Irish Kingdom as much subordinate and dependent upon England as possible; and holding them from the manufacture of wool, and then forcing the Irish traders to fetch their cloth from England. How can they depart from us without nakedness and beggary?"

Does that not sound very similar to what the American Colonists fought against and defeated?

It ended with Ireland reduced to beggary and starvation. In the period 1850-1854 more than one and a half million Irish people perished, in a great famine, which began the migration of Irish people to North America.

How then, did it come to pass that the United States allied itself with such a ruthless "Empire"? What strange force, what siren song brought America into an alliance with that nation's oligarchy, forever starting wars into which the United States was enticed to save them from

defeat? It is a long story of backstairs diplomacy, secret deals, a massive, unceasing propaganda war against the American people and above all, the willingness of the leaders of the United States to betray their own people, time after time after time, the full accounting of which cannot be given here.

**[H: Please read that again and pay careful attention, for you are at it again! You may well want to say that things have changed but I suggest when you claim that "change" you look a bit more closely at the "City of London", the banking center controller-element of the International Banking Cartel—the Khazarian throat-hold on the globe.]**

### IS THE PRESIDENT AUTOMATICALLY COMMANDER IN CHIEF? NO!

But it is worth mentioning that the American people did receive hundreds of warnings from wise men that such an alliance would come to no good. Knowing just how much the American Colonists hated the British crown and King George III in particular, how can rational, educated men believe that they would have drafted a *Constitution* giving the President the powers of a king; that the president would automatically become commander in chief on assuming office?

It is unthinkable that these wise men would have placed the sword and the purse in the same hands, for had they not fought a bitter war to escape from just such a situation? We say to those who repeat the mind-bending "the President is the commander in chief" (without the vitally important qualifier): "From whence did you get this false idea?" It was only after Roosevelt took office that we began to hear this falsehood uttered again and again until it has become fixed in the minds of untold millions of Americans who believe that the President automatically becomes the commander in chief upon his election.

We say boldly without fear of contradiction: "It is a carefully cultivated falsehood put into circulation by the International Socialists who flocked to the United States in 1923 and who did everything they could to destroy our republic and its *Constitution*. Thanks to some of the finest scholars of the *Constitution* this nation has ever had, who resolutely and without fear denounced the scoundrels, the tide was turned and the International Socialists were forced underground, at least for the time being.

Tragically, the vast majority of Americans still believe that their government is not capable of doing wrong. Let's go to examples of rank treason carried out by the Socialists who run the United States Government.

They tore down our trade barriers forcing the

American people to pay taxes whereas customs revenues had previously provided more than sufficient income to run the country, pay the nation's bills, and still have a surplus.

They conspired with the Socialist Government of Great Britain to drag the United States into the First World War which Britain knew it could not win, conniving and plotting in secret with President Wilson to bring the United States into the war in Europe, even though 90% of the American people were against getting involved. We will come to examples of the mess our foreign policy has become, an unmitigated disaster which gets worse every day.

How did Wilson conspire with the British Government to "bring the United States in on the side of the Allies" to quote the "king of conspirators", Colonel Mandel House? Quoting from the book *Biography of Justice Brandeis*, by Dr. De Haas:

"Government negotiations for deals of this nature are always secret and it is usually very difficult to obtain conclusive evidence at the time of the transaction. When the event is beyond repair and lost in the mists of the past, men are apt to write their memoirs and boast of secret exploits that at one time rocked the world."

Dr. De Haas went on to explain in great detail the ins and outs of events leading up to the *Balfour Declaration* which was accepted by Britain and the United States and he points out that if the details had been made public at the time, the public outcry would have prevented America from joining the war.

That was one aspect of it, but there was another: Robert Lansing was the U.S. ambassador to Great Britain in 1915. Years later, as Dr. De Haas noted, Lansing wrote his book, *War Memoirs* and explained how the game is played:

"I believed that it was unwise in 1915 to attempt to obtain from Congress a declaration of war until the American public was practically unanimous in demanding such action. While it is hard to await the slow process of complete conversion to the cause of the Allies and to show the right appreciation of the menace to human liberty in the possibility of a triumphant Germany... there was no other course for the administration to take, even though it aroused bitter criticism in many quarters."

"House (Col. Mandel House) is all over London full of plans for American intervention on the side of the Allies, proposing that I and a group from Balfour's Cabinet should at once work out a minimum program of peace, the least the Allies would accept, and which he presumed would be unacceptable to the Germans, and the President would present this program to both sides. The side that declined would be responsible for continuing the war. Of course the fatal weakness of the foregoing scheme is that we should plunge into the war, not on the merits of the cause but by a carefully sprung trick."

Well did Disraeli note: "Elected governments seldom govern." In any event the "carefully sprung trick" worked, and on April 6, 1917, Wilson was granted a declaration of war against Germany by the Congress following months of ceaseless anti-German propaganda and a calumny of lies in the press in



Great Britain and the United States.

For all his treachery Wilson knew that he was obliged to get a declaration of war from Congress or else he could not proceed. What a disgrace that today, Powell, Rumsfeld, Bush (father and son), Daschle, Leahy, Lott, Sensenbrenner, Albright, Clinton and 85% of the members of the House and Senate refuse to obey this vital law, one of the most important in the *U.S. Constitution*. It is not difficult to follow this *modus operandi* through 1932 to 1939 and at the beginning of WW II. We saw the same methods in practice at Pearl Harbor, in the Korean and Vietnam Wars, the Gulf War, the attack on Serbia and Macedonia and so on, the same thread running through all of these catastrophic violations of the *Constitution*, Vattel's Law of Nations and every international law written right up to what is happening today.

#### BALFOUR DECLARATION

We have seen how the *Balfour Declaration* completely altered the makeup of Palestine and destabilized the Middle East. Let us look at what two people very close to the scene had to say about it, and then try to understand why the United States accepted it. In his "Intimate Papers", master-intriguer Colonel House explained how in 1915, with the war going badly, the British misused the Arabs under Col. Lawrence without feeling any shame.

But when the *Balfour Declaration* became known, Lawrence wrote in his private papers, "even though Faisal expressed doubts that England would keep its word to the Arabs, I assured him that England always kept her word to the letter and the spirit. In this comfort they (the Arabs) performed their duty most admirably, but of course instead of being proud of what we did together, I was bitterly ashamed." Unfortunately for Faisal who had fought so hard to defeat Turks, the British did not keep their promise.

There are barely more than a few thousand Muslims in the near and Middle East who do not subscribe to the belief that but for the *Balfour Declaration* and its acceptance by the United States, there could not have occurred the countless wars, uprisings, and revolts in that region of the world. The point of view of Muslims from all over the world was expressed rather well in a *Newsday* article from which the following is excerpted:

"Egypt is seen by many Americans as the friendliest Arab nation. But Ann Lesch, a professor at Villanova University, and a longtime expert on Egypt and Islamic fundamentalism, says her contacts in Egypt have not been overly sympathetic since Sept. 11. Instead, they have blasted the U.S. campaign against Afghanistan, she said. 'There is a pent-up anger against the U.S. presence. President Hosni Mubarak's regime has become more and more repressive throughout the 1990s, and the people there blame the United States, which supports it with \$2 billion a year in foreign aid. (In the days leading up to the Gulf War the ante was upped to \$3 billion—*WIR*.) There is a lot of discontent and there is no way to express it, so people blame the U.S.'" Lesch said.

"... The wick, the experts say, is for U.S. support for Israel at a time when so many Palestinians are being killed and hopes for peace are all but gone. The Arab and Muslim worlds are constantly bombarded with television images of Palestinians injured in the Palestinian-Israel conflict. Potent images come at you all day until they are sort of imprinted on your mind... images of Palestinian children who have been killed, really gory, shocking images which have become part of their way of thinking and shaped their mindset.

"One of the strongest complaints by bin Laden against the U.S. apart from the Palestine issue is the presence of U.S. armed forces in Saudi Arabia. To bin Laden, the experts said, as well as many religious Saudis, the presence of an army of 'infidels' is a desecration of the holy sites, Mecca and Medina. In a large measure, bin Laden's campaign of terror is a residue of the Gulf War."

In 1995 *WIR* published a monograph, "Who are the Saudi Kings and Kuwaiti Sheiks", a real eye-opener if ever there was one from which the following is excerpted:

"Muhammad was the posthumous son of Abdullah, a Hashemite of Mecca, which is why the Abdul Aziz (royal family) and Wahabi families are regarded as having committed sacrilege in the eyes of Muslims by allowing U.S. armed forces to use Saudi Arabia as a base from which to invade and destroy the Hashemites of Iraq, and adding to their anger is the fact that the United States supports Israel. This is at the heart of the conflict in the Gulf and why the Saudi royal family and the Wahabis are detested and despised by all true Muslims. The two families, sated with Western ideas and a surfeit of riches, have drifted away from the tenets of Muhammad, while still claiming the right to guard his tomb in the holy city of Mecca, a right which was never theirs in the first place."

The confusion in the Middle East comes out of entanglements and alliances which George Washington warned against. The blame must lie with those who make what passes for U.S. foreign policy, those who deliberately and disdainfully scorn not only the *Constitution* and refuse to obey the highest law of the land, but also sneer at George Washington's Farewell Address which, as we have said many times before, ought to be made part of the *U.S. Constitution*. To paraphrase the *Bible*, they have gone each his own way and the Lord has laid their iniquity upon us all. Because of the failure of our leaders to obey the *Constitution*, to heed *Washington's Farewell Address*, we are a nation hellbent for destruction, in a process which the mind benders of our nation call "disintegrating action".

#### CHECK WITH WASHINGTON (GEORGE)

When the "gamecock of Europe" instigated the Second World War, 87 percent of the American people were against American involvement in Europe or the Far East. Our foreign policy experts, the mockers and scoffers of the *Constitution*, the ridiculers of *Washington's Farewell Address*

unleashed their massive propaganda machine against the American people. They found a new word to denigrate George Washington's grave warning, calling it "isolationism" and they turned it into a smear word and an accusation of not being patriotic.

They heaped hypotheses upon hypotheses upon the *Constitution*, as Washington said would happen:

"I have already intimated to you the dangers of parties in the state, with particular reference to the founding of them on geographical discrimination. Let me now take a more comprehensive view and warn you in the most solemn manner against the baneful effects of the spirit of party generally. This spirit, unfortunately, is inseparable from our nature, having its root in the strongest passions of the human mind; it exists under different shapes in all governments, more or less stifled, controlled, or repressed; but in its popular form it is seen in its greatest rankness, and it is truly their worst enemy.

"The alternate domination of one faction over another, sharpened by the spirit of revenge natural to party dissension, which in different ages and countries has perpetrated the most horrid enormities, is itself a frightful despotism. But this leads at length to a more formal and permanent despotism. The disorders and miseries which result gradually incline the minds of men to seek security and repose in the absolute power of an individual; and sooner or later, the chief of some prevailing faction, more able or more fortunate than his competitors turns this disposition to the purposes of his own elevation on the ruins of public liberty."

How farsighted was this modern-day Elijah whose words and thoughts were spurned by the rank-and-file politicians who now infest Washington D.C., and from whom our first president would recoil in horror were he alive to witness the degradation and disintegrating action visited upon the American people, who, even after all the calamities which have befallen them, are still not aware of what has been done to them, and by whom.

Washington's descriptions fit perfectly the two-party system that has been in force for long enough to wreck and destroy what he and his colleagues fought so hard to establish and maintain. It fits so perfectly what party politics has become, a danger to our liberties, our freedoms and the very foundations of our republic.

From Woodrow Wilson to Roosevelt, to Clinton to G.W. Bush, our political party leaders have failed lamentably to pay heed to Washington's instructions.

"Observe good faith and justice toward all nations and harmony with all. The great rule of conduct for us, in regard to foreign nations, is in extending our commercial relations, to have with them as little political connection as possible. Europe has a set of primary interests, which to us have none, or very remote relations. Hence she must be engaged in frequent controversies, the causes of which are essentially foreign to our concerns. Hence, therefore, it must be unwise in us to implicate ourselves by artificial ties, in the ordinary vicissitudes of her politics, or the ordinary combinations and collection of her friendships or enemies.

“... Why, by interweaving our destiny with that of any part of Europe, entangle our peace and prosperity in the toils of European ambition, rivalry, interest, humor or caprice?”

Why indeed? Why then did Franklin D. Roosevelt follow in the footsteps of the traitor, Woodrow Wilson, who dragged the United States into WW I at horrendous cost to our nation, when the “gamecock’s” war was none of our business? We answer, “Because like Wilson, he was an ardent International Socialist, determined to make the world safe for Socialism and with a hatred of Germany whose opposition to International Socialism was a stumbling block for them!”

In defiance of the rule of open government, and in the dank darkness of underground cellars of secrecy, Roosevelt plotted and planned with warmonger Winston Churchill the downfall of this nation and to this end, brought this nation to the very brink of destruction, its republican form of government all but usurped by International Socialism. Roosevelt brushed aside the warning of Washington: “Against the judicious wiles of foreign influence (I abjure you to believe me fellow citizens) the jealousy of a free people ought to be constantly awake; since history and experience prove that foreign influence is one of the most baneful foes of government.”

Roosevelt came to power on an International Socialist program which he took care to conceal until he felt it was safe for him to show his true colors and his contempt for the *U.S. Constitution*. In September 1939 he never wavered in his determination to bring the United States into WW II. But it required a “carefully sprung trick” as the American people had no interest in the war then raging in Europe and were even less interested in becoming involved with a war against Japan.

That “cleverly sprung trick” began to emerge on September 26, 1940, when without any prior warning the United States placed an embargo on the export of iron and steel scrap to anywhere outside of the Western hemisphere, effectively cutting off exports to Japan.

All Japanese credits in American banks were frozen by an “executive order” signed by Roosevelt. Although there is no such empowerment in the *U.S. Constitution* as an “executive order” (which makes it a mere scrap of paper), it nevertheless has the force of law in the hands of the enemies of the *Constitution*. By any definition these hostile acts toward Japan constituted a virtual declaration of war. The fact that our treaty with Japan which had been in existence since 1911 was violated did not deter Roosevelt and his coterie of young Marxist advisors, nor did it bother this law-breaker that under the *U.S. Constitution*, only the Congress can abrogate a treaty.

#### AND WHAT OF WAR DEBTS?

Justification for America to go to war in Europe had to be contrived. Another stumbling block was that on December 31, 1931, it became known that the “Allies” had defaulted in their war debt payments due to the American people dating from WW I. This disgraceful state of affairs was played

down, but in reality it meant that the American taxpayers were now saddled with a huge war debt amounting to billions of dollars which the European “Allies” could not or would not pay.

Henry L. Stimson, secretary of state, worked to assist Roosevelt in his quest for a “carefully sprung trick” rather than faith in the “cause” that would pave the way for U.S. entry into the war in Europe. In earlier years Stimson was the lead player in a worldwide crusade to force Japan out of China and was thus very well versed in the tricks of the trade of the invisible Government. His diaries reveal a meeting with Roosevelt on October 16, 1941: “We face the delicate question of diplomatic fencing to be done so as to ensure that Japan is put in the wrong and makes the first bad move.”

Stimson’s diary entries recorded constant meetings with Roosevelt between October 16 and November 25, 1941. In all of these meetings the topic was the same, or as Stimson put it, “How we could maneuver them (Japan) into the position of firing the first shot.” It was all part of Churchill and Roosevelt’s criminal conspiring to get America into the war in Europe. When Germany refused to take the bait of premeditated attacks on its submarines and freezing of its assets in the United States, all in violation of the *U.S. Constitution* and therefore criminal acts, things began to look desperate for the two warmongers. As if to reassure his Cabinet, at that point staring defeat on the battlefields in the face, Churchill rose in the House of Commons and gave this undertaking:

“The probability since the Atlantic Conference (a grandly-named conspiracy) at which these matters were discussed with Mr. Roosevelt, that the United States, even if herself not attacked, would come into the war in the Far East and thus make final victory sure.”

We know from our very detailed and protracted studies of Pearl Harbor over the past 25 years that it was only a means to an end, the goal being to use an attack on the United States to make Roosevelt’s cherished wish come true, when he would finally be able to use the might and power of the military forces to crush Germany, which obsession consumed his political life.

#### ENLIGHTENED TERRORISM

We want to make the important point that in order to get the United States into the war in Europe Roosevelt sacrificed the lives of many thousands of our servicemen and the better part of our Pacific Fleet. This is what the Military Psychological Operations (PSYP) calls “enlightened terrorism” which in our opinion was put into practice at Pearl Harbor and used extensively in the post-WW II, against Iran, Iraq, South Africa, Panama, Serbia and Macedonia.

Roosevelt was backed by his Cabinet colleagues, especially Harold Ickes Sr. In a letter to Roosevelt in October 1941, Ickes said; “For a long time I have believed that our best entrance into the war would be by way of Japan.”

**[H: Doesn’t this make you want to really celebrate the anniversary of Pearl Harbor Day tomorrow?]**

We, the People, need to look very closely at the “secret deals” and back-room intrigues that Roosevelt and his Cabinet engaged in, before apportioning sole blame for Pearl Harbor to Japan. Of course nothing we have said excuses Japan for the dastardly attack on Pearl Harbor.

#### ROOSEVELT’S OPINION OF THE *CONSTITUTION*

We believe that history may one day show that WW II was fought at the instigation of and for the benefit of International Socialism, as were all wars since the 19th Century. International Socialism benefited the most from these wars, steadily advancing its foreign ideology in scores of nations. We venture to claim that Roosevelt affected a bloodless coup between 1933 and 1940. Roosevelt’s disregard for and contempt of the *Constitution* all through his years in the White House, showed up when Secretary Stimson asked him, “What about the *Constitution*?” A visibly irritated Roosevelt replied: “It is an antiquated system suited to horse and buggy days.”

On January 3, 1934, when Roosevelt thought he was safely entrenched and was perceived as a man of the people, the ardent, unabashed Socialist told Congress:

“The people realize that in 34 months we have built up new instruments of public power. In the hands of the people’s government this power is wholesome and proper, but in the hands of political puppets of economic autocracy such power provides shackles for the people.”

This is both for the guest/visitor as well as for self.

## YOUR EXISTENCE IS AT STAKE.

I give Bryan Hodgson of *National Geographic* great honor and appreciation, for I shall utilize his updated information to great extent in these current chapters—for you need the confirmation of Earth scientific published material. Perhaps as you move along in truth, you will subscribe to the *Geographic* to support the works of these outstanding researchers.

The Antarctica is larger than Europe or Australia, but it has no “native” human population. It contains more than two-thirds of the world’s fresh water in the form of ice, yet some areas receive less than two inches of precipitation a year. Antarctica is the highest, coldest, most desolate place on the globe (on the surface of it). But it irresistibly draws visitors. The fifth-largest continent is a giant outdoor laboratory where scientists strive to decipher clues to our planet’s history and detect early warning signs of global pollution. That which is called “Earth’s last terrestrial frontier” is drawing increasing international attention—and only a minute fraction of a percent of humans have the slightest idea as to “why”.

In 1959 thirteen nations joined the twelve original signatories as voting members of the *Antarctic Treaty*. Research stations were constructed and a voting coalition was formed to be eligible for voting on control of resources on the continent. There are some 40 year-round bases on Antarctica at present (known publicly). Fourteen additional nations have gained observer status, introducing a strain of international politics to a gentleman’s agreement that guaranteed only that Antarctica would be used for peaceful purposes—without specifying clearly what those purposes might be. And there you have it. **NO PLACE IN YOUR ABILITY TO ATTEND IS ALLOWED PEACEFUL EXISTENCE—NO PLACE! THIS IS NO DIFFERENT AND ALL REALLY IMPORTANT AND “SECRET” BASES AND INSTALLATIONS ARE ALLOWED NO VISITORS OR RESEARCHERS AS YOUR MAJOR POWERS HAVE THEM SEALED OFF BY TERRITORIAL CLAIMS.**

In October 1989 in Paris, the 15th biennial treaty meeting was thrown into turmoil by an unscheduled debate sparked by the announcement of France and Australia that they had revoked their approval of a 1988 agreement prohibiting minerals exploration without the unanimous consent of all members. Instead, they joined environmental groups demanding an outright ban on mineral activities and establishment of Antarctica as a world park. Some nations, such as Chile and Argentina, saw this as the first direct threat both to the treaty and to territorial claims they had agreed to hold in abeyance. (AND YOU THOUGHT THE RIFT WITH ARGENTINA AND CHILE WAS OVER DRUG DEALINGS!)

Antarctica has never been truly isolated but I doubt any of your little school children realize this—were you taught this? Although it is surrounded by a barrier of swirling ocean currents and ferocious winds and crowned by a gigantic ice sheet averaging nearly two miles in thickness, this coldest region of the planet is a powerful weather maker for the Southern Hemisphere. Its frigid waters surge along the deep seabeds into the Northern Hemisphere, modifying ocean temperatures and carrying nutrients to nurture marine life.

More recently, scientists have discovered that Antarctica is a sensitive barometer of mankind’s use and abuse of the planet.

Comparing today’s atmospheric gases with those trapped in core samples of ancient Antarctic ice, they have found that the burning of fossil fuels has helped

raise carbon dioxide to the highest level in history. Some have warned that this might cause a melting of the ice sheet by trapping heat from the Sun. Other scientists have learned that man-made gases called chlorofluorocarbons, trapped over Antarctica by a stratospheric vortex of winter winds, react with spring sunlight to release chlorine atoms that destroy much of the ozone, which helps protect living organisms from harmful ultraviolet radiation. This is accurate enough to allow it to go undebated by me, at this point. Man always precipitates his own environment and therefore a debate at this point would be futile and useless. Further, this segment of writing is from the scientific viewpoint of very human observers and is not my input. Let us just tell this segment as human sees it.

EARLY WARNINGS

As early as 1975 scientists had warned that Antarctic waters were being overfished. In 1980 an agreement was reached on a Convention for the Conservation of Antarctic Marine Living Resources. By 1983 Soviet fishing fleets had seriously depleted the population of Antarctic cod around the French islands of Ferguelen. Other fisheries appeared on the verge of destruction.

There is a fish at South Georgia called *Champocephalus gunnari*, which was most popular and is now most endangered. A fishing limit of 10,000 tons of *gunnari* was recommended by a group of involved nations in 1986. However, the Russians immediately reported catching over 69,000 tons—seven times the proposed limit. They claim the numbers estimates were wrong and that the protein would go to waste unless fishing is done at the optimum level.

At this point the good old U.S. Congress got into the act and requested a major study of Antarctica’s marine ecosystems. This put up all sorts of wondrous distractors and gave excellent reason for infiltrating the area and checking on the security systems already in place. Oh, of course, Congress thought it was all a study of marine life—most of your Congress is as ill-informed as the masses of the population.

WHAT IS REALLY HAPPENING

With all the military intrigue and installations, ships from many countries come into the waters of Antarctica claiming to be research vessels but are actually otherwise. For instance, in 1989 an Argentine supply ship *Bahia Paraiso* ran aground after hitting underwater rocks near Palmer Station, apparently because of inaccurate navigation charts. Thousands and thousands of gallons of diesel fuel fouled beaches and killed untold numbers of wildlife. Where was Exxon when you needed them?

The Soviets have intensive activity of massive amount and take marine life in uncountable amounts. Reports which could be verified were that the Soviet vessels were taking over 20 tons a day of guntheri at Shag Rocks. At the South Shetlands some 18 vessels were taking krill at 85 tons a day and at the convergence 400 miles northeast of South Georgia, one boat reported catching two tons of squid within a few hours.

Right across the Strait of Magellan and Cape Horn you find Punta Arenas, Chile’s southernmost city. It is a thriving commercial center, whose harbor, shipyard, airport and communication facilities have made it the major gateway to the Antarctic Peninsula and is only a couple of hours flight to King George Island, site of Chile’s Teniente Rodolfo Marsh station and airfield.

There are eight other nations which have research stations on the island: Argentina, Uruguay, Peru, Brazil, Poland, South Korea, the Soviet Union, and the People’s Republic of China. King George’s popularity stems more from its location, only 600 miles from Punta Arenas, than from its scientific potential. This should also tell you readers a lot of information.

It gets easier and easier to get to Antarctica as the French and British are building new airstrips. On the continental ice plateau you can land ski-equipped aircraft almost anywhere. It is also easy to land large-wheeled transports on areas of permanently bare ice, such as those near the Vinson Massif. The U.S. plans to establish a base there to give regular airway from Punta Arenas to the South Pole. Further down the coast from Punta Arenas is a place called Ushuaia—which means “Jesus” or in Hebrew—Jesuhia or Yeshua (spelled for pronunciation). How do you suppose that could have happened? Surely the Pale Prophet couldn’t have gotten into that region also! So be the mysteries of “time”.

Chile’s base on King George Island is actually a colony, with quarters for some 240 airmen and scientists. Many sign on for two-year tours and live with their families in a suburban-style apartment complex called Villa Las Estrellas, which has its own bank (of course), post office, commissary, hospital, and a schoolhouse which serves around 11 students.

This complex, together with the tourist facilities, reflects Chile’s long-standing policy of “proving up” its territorial claim to a large sector of Antarctica, even though such claims are held in abeyance under the treaty.

Argentina has a similar policy. There is an Argentine Army base on the tip of the Antarctic Peninsula a hundred miles south of King George Island called Esperanza.

Why am I giving all these nitty details which hold no interest for you? Because they had better start holding interest for you, for you will be hearing a lot about them very shortly in what you perceive as your future.

Argentina and Chile have been frequent adversaries to the U.S., but their huge and overlapping territorial claims have made them allies within the Antarctic Treaty organization. Issues such as mineral exploitation will loom very large in 1991, when under terms of the treaty any voting member may propose a reexamination of its provisions.

STRANGE CROSSROADS

The Antarctic Peninsula and its island chains have been an international crossroads since 1820 when Russian explorer Bellingshausen arrived to claim first sighting of the continent after braving the savage weather of Drake Passage in wooden ships.

Today’s mariners are better equipped, but some things have not changed. Storms are quick to form and deadly.

The U.S.A. has ongoing “studies” under the guise of NSF’s Division of Polar Programs and travels the region’s rich bird and marine life habitats regularly (too regularly) since 1965 when the jaunts could no longer be kept secret due to the traffic in the area. Note that Byrd’s expedition was in the 1940s and continuous monitoring was begun at that time.

One of the major stops on the “scientific” journey is Deception Island, where a placid lagoon fills the ten-square-mile caldera left by an ancient volcanic catastrophe. Don’t count on it remaining simply

“ancient”. Today one can find a smattering of abandoned buildings and wooden boats that line the haunted shore which still steams with volcanic heat.

Records show that in 1924 the entire bay literally boiled, blistering the paint on a fleet of factory ships used to process some of the thousands of whales killed in these waters. There have been major eruptions in 1967, 1969, and 1970 which destroyed Chilean and British bases.

This is in the area of the Bransfield Rift and is a very active volcanic zone. It has widened considerably over the past several years and recent seismic activity can tell you the magma is welling up again.

The type of magma found in that area creates a fairly quiet eruption above ground, since it is highly fluid and has time to cool to crystals when it contacts air. But on the seafloor it reacts instantly with water to produce a tremendous explosion. There will be ongoing and more frequent eruptions in the current “time” segment.

The food chain of the Antarctic is under heavy study. Microscopic plants called phytoplankton bloom in the ocean each spring, nourishing vast swarms of the shrimp-like crustaceans called “krill” (interesting label) that form the main food for many of the continent’s creatures. Commercial krill catches now approach 500,000 tons a year, and scientists are concerned about the effects of heightened levels of ultraviolet radiation on phytoplankton.

So far you have no way to measure the volume of krill swarms accurately but one must look at the population of penguin colonies which number in the hundreds of millions and they feed only on krill.

Now, how do you suppose the Cooper group came up with a name like O.H. Krill in relationship to visiting “aliens”? Little gray men from outer space? Oh, I think not! Are these plots set up by your “free-people” government? Oh, I think most definitely, yes!

Krill have some interesting points about them, not the least of which is that they present an almost unlimited food supply for the human inhabitants of Earth.

### KRILL

The life span of krill is around seven or so years. They reproduce beginning in the third summer. The eggs are laid between mid-December and early March with the eggs sinking to between 600 and 1,200 meters before hatching while moving into the warm incubating waters. The larvae hatch and ascend through the water “column” to begin maturing. Ocean currents can move krill swarms far out of reach of bird colonies and protect the growing babies. An adult krill can go without food for as long as a year and survive nicely, larvae as long as two months without nourishment—a necessary defense against seasons in which phytoplankton are scarce or hard to find.

But now you have an interesting happening. The krill feed on phytoplankton which use sunlight to produce food by photosynthesis, utilizing carbon dioxide and such primary nutrients from the sea as nitrogen and phosphorus, plus trace elements. The threat of increased ultraviolet radiation pouring through the ozone “hole” over Antarctica has made the question of the effect on phytoplankton a most appropriate and urgent one.

Isn’t this just getting more and more interesting? What about those Rainbow Lakes—and more important, what about that ostensible Rainbow City(s) of mythology—past and current? Ah so! The little

phytoplankton glitter like jade, others are brown, etc. The microscopic seawater is a wondrous garden of the sea with a brilliant three-dimensional universe crowded with exquisite translucent organisms. There are tintinnids which are cone-shaped and which feed on bacteria, and squarish-looking organisms which are diatoms. Their outer shells are made of silica, so they are really like plants in glass houses. A tiny sample will contain over 10 species of these minute single-celled organisms which link up to form colonies that look like a string of beads. The species and numbers change continually, decreasing as winter darkness approaches.

The lovely part of the lifestream of these little wonders is that they can adapt to increased amounts of ultraviolet radiation by producing their own sun-block pigments or by using a mechanism that, through exposure to daylight, enable them to repair UV damage. Would this not indicate that selective evolution indicates that these little fellows have experienced this same type of cycle prior to now?

The Australians are developing a sunscreen preparation for use by humans based on UV-absorbing compounds found in coral. Similar compounds have been found in fungi. Eighty-five percent of lichens in Antarctica have compounds that absorb radiation in the ultraviolet ranges.

Before we discuss the ozone and ultra violet radiation, let us take a rest-break, please. I shall move to stand-by. Thank you for your attention and you, Dharma, for your service. Salu, Hatonn to stand-by.

## CHAPTER 13

### REC #1 HATONN

SAT., MAR. 31, 1990 7:30 A.M. YEAR 3 DAY 227

Hatonn present in the Light of the Radiant One. Good morning. May we please continue with our *Journal* and may we begin where we stopped, with further discussion of ultra violet light (radiation).

### ULTRAVIOLET RADIATION: (UV)

Studies are ongoing in Antarctica for measuring amounts of ultraviolet radiation. Ozone is not the only thing that affects UV reaching the ground. Glacial ice, for instance, reflects as much as 95 percent of UV back to the sky. The ocean reflects 5 to 30 percent, depending on the amount of ice cover. One of the important goals of this study is to determine to what extent clouds block UV. With the opening in the higher ozone levels, the UV levels are showing up in amounts in October which would normally be measured in December. This means that the Antarctic summer has become approximately two months longer in duration. Remember, however, that it is almost impossible to actually measure these variances due to short monitoring—and you ones have the incorrect perception regarding the ozone layer.

Changes, however, are becoming more and more evident and that point is indisputable. Even your rather crude studies of heightened UV effects on sea organisms have used artificial light. Conditions in the real world are radically different.

It is extremely difficult to accurately measure these rays—but it is a pretty close estimation that red light penetrates 10 to 20 meters, blue as deep as 90 meters into the ocean and ultraviolet is undetectable at

20 meters or there-about. Ice-laden cloud movements also make impact on true readings.

When you effort at determining the effect of these factors on life, i.e. phytoplankton, one finds that temperature, salinity and light all determine whether the lifeform makes a good living, a bad living, or no living at all.

To base, scientifically, results set in concrete is impossible. Phytoplankton, for instance, changes depth as water layers are mixed by wind and heat. They also quickly produce pigments to protect against increased sunlight. They also make UV-absorbing compounds, and therefore, it is reasonable to hypothesize that these can also limit UV damage.

### LOOK AT POSSIBLE MINERALIZATION IN ANTARCTICA

There are many minerals. There is a lot of coal in the Transarctic Mountains. Geologists have found traces of copper, gold and silver on the Antarctic Peninsula. But these wouldn’t be economic even if you found them in Minnesota or Montana.

Petroleum is still in great question as the U.S., Brazil, France, Norway, West Germany, Poland, Japan, Australia, Britain, Italy, and Russia have all done seismic research. The Japanese have been surveying for eight or nine years. Only the U.S. and Australia have released hard data, as required by the *Antarctic Treaty*. But at any rate, you need a five-to-ten-billion-barrel field, something like Alaska’s Prudhoe Bay, to make it pay, even at a price of \$70 to \$80 a barrel.

### UNCERTAINTY

Uncertainty plagues your scientists about the possible effects of the warming of Earth’s climate in general. Glaciologists know that Antarctica’s ice sheet, which covers 98 percent of the continent, moves toward the sea in the form of glaciers and ice streams. But they can’t conclude as to whether it is shrinking, growing, or remaining pretty much balanced.

The world sea levels show definite signs of rising as much as six millimeters a year, but that is thought to be caused by a combination of thermal expansion of the water plus a melting of Northern Hemisphere glaciers—but why would Northern Hemisphere glaciers be melting? And so it goes.

It is pretty well established that ocean currents carry warmer water under the seaward edge of the ice shelf and melt it from the bottom at about three meters each season. Now it is planned to bore through the ice shelf down to water level and place 40 permanent temperature, current, and salinity sensors. Those should tell you whether warming currents you know nothing about are causing melting a hundred kilometers “inland” from the ice edge.

As a fact, as far as Antarctica is concerned, you have no real ability to place confidence in today’s computer-generated climate models, because none of them can explain how the previous Ice Age came to an end. Why was the Earth 2 degrees centigrade warmer between 5,000 and 8,000 years ago? There is no answer for you and if you can’t model the past, you can’t model the future, can you?

It is obvious that “romantic” ideas don’t make it in Antarctica. It is certainly not a place to go relax and escape from life’s tensions. So what could be so desirable about an ice-laden piece of landmass?

Let's speak of the first U.S. station, built for the International Geophysical Year of 1957-58. It lies buried almost a mile from where it was established, carried away from the geographic South Pole by the constantly moving ice sheet. Now the dome of the present facility, completed in 1975, is being slowly buried by snow as well.

A large snowdrift has formed on the downwind part of the dome, and its weight has depressed and torn portions of the dome's base. First the snow must be removed and then the entire base must be "jacked" up and the base repaired. Next, it is considered that a solution might be to build an artificial snowdrift using lightweight polystyrene foam, shaped aerodynamically to allow real snow to be blown away. That would extend use of the dome for about six additional years. I am continually appalled at conclusions and unreasonable solutions reached by supposedly educated and intelligent people; further, is there no limit to funds you ones will pour into foolishness?

As many as a hundred scientists and support workers occupy the South Pole station during summer months. During winter only 20 people inhabit the end of the Earth. The reason? To monitor the planet's air quality. The South Pole, it is said, has the cleanest air on Earth because prevailing winds blow 98 percent of the time from the so-called "Clean Air Sector"—between 20 degrees west and 110 degrees east. By the time the air reaches the pole, it is well mixed and there are no remaining sources of air pollution.

Air-quality monitoring has been going on since 1957 and has found constantly increasing carbon dioxide levels. Recently, a new sophisticated laser device has been installed by the University of Rome to measure the height and thickness of polar stratospheric clouds, which form during winter darkness over Antarctica.

In 1986 scientists discovered that molecules of chlorine compounds adhere to ice crystals in the clouds. This makes possible a catalytic reaction, triggered by the Sun's first springtime rays, in which chlorine atoms destroy as much as half the ozone over Antarctica between September and November.

Scientists believe most of the destructive chlorine comes from chlorofluorocarbons, or CFCs, which find their way from the industrial areas of the world to the stratosphere and are then carried south over Antarctica, there to be trapped by an annual atmospheric phenomenon called the polar vortex.

While chlorine in the atmosphere was found to have increased by about 10 percent in three years, some scientists thought the change so dramatic that they wondered if other factors might be involved. And so on and on it goes. Chelas, I simply cannot go on with this foolish dissertation.

Your world is suffocating in the pressure of six billion people, many of whom are starving to death, the air is so polluted in all of your major cities and most of your landscape as to be a hazard to simply breathe—and what has over 40 years of research given you except a high cost? Most of the science has produced only controversy and the only response is, "Well, you have to remember that science is done by human beings." I quote one, Dr. Edward Zeller.

Now take that thought with you as you visually stroll with me through the industrial sprawl of McMurdo base. Please avoid the huge junkyard and fuming trash dump, which will soon be gone as part of a new TEN-MILLION-DOLLAR cleanup program. The chapel offers cleanup programs of a different sort: a *Bible* class

and an Alcoholics Anonymous session. The noncommissioned officers club has reached a level of activity that might generate candidates for both.

I now quote Bryan Hodgson's reading of a symbolic bumper sticker which reads "GREAT GOD—WHAT AN AWFUL RACE". The sign bore the insignia of an organization campaigning to make Antarctica a world park. Would the authors ban humans? Their slogan parodied the bitter words that Robert Falcon Scott scrawled in his journal after reaching the South Pole: "Great God! This is an awful place," he wrote, after finding the footprints of humans who had gone before. Well, so there you have it.

Therefore, it is quite obvious that all of the activity around the Antarctic regions is not scientific nor to establish summer campsites. So what is the purpose of this *Journal* discussion? I am going to tell you what is truth about your Antarctic area and you are not going to care for it very much at all. None-the-less, I support those brave men who have gone before and now speak from this dimension—it allows truth to flow ever so much more freely, brothers. Ponder it. Truth has no need of "shading" from this placement in the heavens.

The next sections will read like something out of James Bond Goes Beyond Sanity. I suggest you stick with me through it, however, for you are going to find truth, my dear friends—and I trust it will shake you up accordingly.

Ones continually barrage this scribe with my doom-and-gloom fear tactics—well, I certainly advise paying attention. Fear and panic, no! Pay attention and utilize your God-given resources and what you have is HOPE! Continue to hide the truth and ye shall never find freedom—truth shall set ye free—naught else. Move back to the Falkland Islands and South Georgia Island and the war between Argentina and Great Britain over these barren, wind-swept wastelands. Or, were they? Oh, dear ones, what you have not been told would fill mammoth volumes and we haven't time for that. I am going to give you information which is well-known in certain circles but hardly known at all to the populace—you the people. A few have come into this information; enough to confirm the truth of my writings at any rate.

On the surface the whole incident represented a dispute between Argentina and Great Britain over those barren islands. But surely you have learned by now, that nothing is as it seems. You are told exactly that which you are to believe and you diligently go about following the orders.

The so-called Falklands crisis was just the visible tip of a giant military operation. During the month of April 1982, fierce naval battles were taking place, not only in the South Atlantic but also in the South Pacific.

The hostilities were very effectively kept under arrest by wartime censorship on all sides of the dispute (and yes, the U.S. was most certainly in the dispute).

On April 30, a total naval and air blockade of the Falklands by the Royal Navy began. At the same time a counterblockade had been declared by Argentina in the same area.

To be effective, a blockade must be imposed over a period of time, but the Royal Navy didn't have sufficient time. Winter was coming on in the South Atlantic, and the British supply lines were overextended. Having traveled so far, however, Her Majesty's navy could not simply drop the blockade and sail away in a few weeks time without drawing blood from Argentina. As a result the British would be forced to undertake military operations very quickly no matter how risky they might turn out to be.

There was also another reason why the Royal Navy had no choice but to engage the Argentine forces in combat. That reason was that the Royal Navy had already suffered losses in secret combat that same month. Only when publicly admitted fighting erupts would the British dare to admit that they had already suffered great battle losses. And further, to obtain that cover-story, the British had no choice but to sail into combat; but in so doing, they would be risking even heavier losses on top of those already sustained. In short, Her Majesty's navy sailed directly into a trap.

The events which unfolded in the South Atlantic carried strange, ironic echoes of your past. For weeks you had been hearing countless commentators referring to the British task force as an "armada". The British of all people ought to have been very uneasy with that description. The original Spanish Armada some 400 years ago was renowned as a seemingly invincible fighting force, but it came to grief in a naval disaster so complete that it changed the course of history—and it was none other than the English navy that destroyed the Spanish Armada.

The original Spanish Armada put to sea in 1588 during the reign of England's Queen Elizabeth I. The Armada was an invasion fleet carrying thousands of crack fighting men to invade England. They were met by the daring sea dogs of Sir Francis Drake. Drake and his small fast ships turned the tables on the Spanish Armada by changing the rules of battle. The English fleet was equipped with new longer-range guns, and it stayed upwind and out of reach. From there the English pounded, smashed, and shattered the big ships of the mighty Armada. When it was all over, barely half the Spanish fleet was left to limp back to port. Drake's defeat of the Spanish Armada was a shock to the world. It opened the door for England under Queen Elizabeth I to start its expansion into a truly global empire.

Four hundred years later, history seemed to have come full circle. Queen Elizabeth II witnessed the dismantling of the world empire whose heyday began under Queen Elizabeth I—and now the cultures of England and of Spain were once again in confrontation. Once again a so-called armada was preparing for invasion, but this time the armada was British, not Spanish. Four hundred years past, Sir Francis Drake was the hero of the day; today, the ghost of Francis Drake would once again be on the scene.

Please note that the South Atlantic war zone was at the eastern end of the Drake Passage around the southern tip of South America. The defeat of the Spanish Armada four centuries ago broke the back of Spain's naval supremacy, and now it appeared that the defeat of the new British armada might very well break the back of what remained of the once glorious Royal Navy.

MILITARY SECRET OF SOUTH GEORGIA ISLAND

When the Falkland Islands crisis began in early April it looked at first like a mere tempest in a little teapot. For a century and a half since 1833, the Islands had been controlled by Great Britain. During that entire time, British sovereignty over the Falklands had been disputed by Argentina. There had been countless threats by Argentina to seize the Islands, which it called the Malvinas, but the threats had always come to nothing in the past and Britain had never even gotten very concerned over them.

The Islands are four times as distant from Argentina as Cuba is from the United States, and they are not much of a prize, it would seem, under any circumstances. After over 150 years of occupancy, the Falklands are home to fewer than 2,000 British settlers and a great number of sheep and some lovely penguins. In short, the remote Falkland Islands would hardly look like something to fight over, and yet there you were watching another crisis take place. You watched as literal gun-battle war erupted between Great Britain and Argentina and further, without much more than fanfare on your news media presentations.

The Thatcher government was acting as if it had forgotten all about its usual preoccupation with the Soviet threat at NATO's doorstep. Instead, Britain was throwing almost everything it had at Argentina—aircraft carriers, cruisers, destroyers, submarines, assault ships—you name it and if they had it they used it. Luxury cruise ships were even commissioned and turned into troop carriers overnight. Wave after wave of additional assault troops were activated and sent to join the fleet even after it sailed. Ships and submarines were pulled off station from normal NATO duty and sent to reinforce the task force. The initial 40-ship force grew steadily over the ensuing weeks into an armada numbering over 70. Over two-thirds of the entire Royal Navy was already deployed to the South Atlantic off Argentina.

As this was watched in the unfolding, a lot of people were asking: What's this fight really all about? The most popular answer suggested in the major media was "oil". Vast deposits of oil were known to exist under the continental shelf between Argentina and the Falklands (or so it was projected) and that had been espoused for well over a decade. In no way could it explain the timing of the sudden military offensive by Argentina—and oil explained even less about the Argentine seizure of South Georgia Island.

South Georgia Island is some 800 miles east of the Falklands with no known oil deposits anywhere near it; and compared to South Georgia, the Falklands are quite an island paradise. South Georgia Island is covered with rugged mountains, treacherous valleys, glaciers, and semi-permanent snow. Most of it is uninhabitable. On top of all that, Argentina had absolutely no legal or historical claim to South Georgia Island. In that respect it stood in sharp contrast to the Falklands.

In your early 1830s the Falklands were occupied for a while by Argentine colonists. In 1833 the British expelled them and took over the Islands. For that and other historical reasons, Argentina argued that the Falklands actually belonged to Argentina, not Britain.

But no such argument was possible for South Georgia Island. It was always controlled by Britain, never by Argentina or Spain. The Argentine seizure of South Georgia Island looked even more unreasonable

from a military point of view. Argentina's leaders were military men and they thought in military terms and this should be a great clue to you readers. They were well aware ahead of time that far off South Georgia Island could not possibly be held for long. By seizing it they were setting themselves up to absorb a military defeat, as the Island was retaken by Britain. So the question was: Why did Argentina's military junta bother with the seemingly worthless South Georgia Island at all?

The answers to all those questions were, of course, military, not political or economic. South Georgia Island possesses an enormous military secret! **It is a giant underground installation buried under the mountains at the northwest end of the Island.** The real reason for the so-called Falkland crisis was this secret installation, together with two other similar installations which I will also describe in a moment.

The secret military complexes had been in existence for many years; they were not new. What was new was an accelerated nuclear war timetable of the American Bolshevik war planners in Washington D.C. For the prior two months reports of details of that war plan were leaking out as quickly as they could be verified.

The plan called for NUCLEAR WAR ONE to erupt by September of the year 1982. It was that fast-approaching nuclear war threat that caused the so-called Falklands crisis to erupt when it did.

What was actually taking place was a coordinated effort to spoil part of the Bolshevik grand strategy for the coming nuclear war. The mutual enemies of the American Bolsheviks in the U.S.—namely, the Rockefeller cartel—and Russia's new rulers in the Kremlin were behind the crisis. They were trying to ruin Phase #3 of the "PROJECT Z" war plan which has since been revealed—go look it up, please.

That phase was to be world domination by the American Bolsheviks after both Russia and the United States had been destroyed in NUCLEAR WAR ONE. The key to this plan was the existence of secret weapons stockpiles in various places around the world!

The American Bolshevik military planners in America were working with other Bolshevik agents in key military positions of other countries to set off war. Having done that, they intended to ride out the nuclear holocaust they had caused, safe and cozy in Government war bunkers! When the warring nations would finally lie smoldering and exhausted, the Bolsheviks would leave the shattered remains of their host countries. They would rendezvous at the secret weapons installations and bring their weapons into the open. They would confront the world with the only remaining fresh, up-to-date powerful military force on Earth; and using that military power, they would become the undisputed rulers of the world. They planned to do all that, and they planned to pave the way for world domination by setting off NUCLEAR WAR ONE within mere months of that April—remember, September!

The Rockefeller cartel and Russia's new anti-Bolshevik rulers were working together in a race against time to try to head off the Bolshevik war plan.

The Bolsheviks in the U.S. were already benefitting from war preparations which were started by the Rockefellers long before. It had only been about three years since the Rockefellers were dislodged as the prime movers of the United States Government by the Bolsheviks. Since that time

the United States Government had been a house divided, torn by internal power struggles between rival Bolshevik and Rockefeller factions. But prior to that, the United States had been dominated for decades both economically and politically by the four Rockefeller brothers.

In 1961 the Brothers launched a new long-range plan for world domination. It was a two-pronged strategy, half visible and half secret, which has been described prior to this writing. It was a plan for the United States to arm to the teeth in secret while appearing to disarm gradually. Without repeating all the details, the basic idea was grandiose indeed, yet simple. By deliberately appearing weak, the Rockefeller-controlled United States would maneuver itself into a nuclear war with Russia. Then the secret weapons, including superweapons, would be unleashed to smash Russia and take over the world.

When they set the grand plan in motion in 1961, the Rockefeller Brothers were looking ahead to a nuclear war by the late 1970s. Their military analysts concluded very early that the war being planned would have very different effects on the Northern and Southern Hemispheres. Both superpowers, the United States and the Soviet Union, are located well up in the Northern Hemisphere; so are the other full-fledged nuclear powers—Great Britain, France, Red China, and India. By contrast, the strategic targets for nuclear war in the Southern Hemisphere are relatively few and far between. In other words, it was expected that the coming nuclear war would be essentially a Northern Hemisphere war.

In an all-out nuclear holocaust it is known that serious radioactive fallout would gradually spread to affect even areas not initially hit by war. But there are limits to how far the war clouds can spread. It was discovered long ago that there is very little mixing between the air of the Northern and Southern Hemispheres. In the northern half of your planet, cold air from the North Pole works its way southward toward the equator, then it works its way back to the north as warm air. A mirror image of this process takes up the southern half of the planet. Northern and Southern Hemisphere air meet in the equatorial zone, but very little of the air changes places.

The military conclusion is this: The coming nuclear war could ruin vast areas of the Northern Hemisphere for generations forward; but if the calculations are correct, the Southern Hemisphere could escape virtually unaffected by the war. This was surely music to the ears of the four Rockefeller Brothers. A quick look at the globe of the world shows why this would be a reasonable calculation. The Rockefeller cartel has dominated Latin America ever since World War II. As discussed in prior publications, Nelson Rockefeller solidified the cartel grip on Latin America during the war. He accomplished this as so-called "Coordinator of Hemispheric Defense" for then-President Franklin D. Roosevelt. So that takes care of the South American continent and its natural resources.

Then let us turn to the African continent. There, too, Rockefeller control was already in effect over wide areas of Black Africa, especially south of the Equator. All this was thanks to the efforts of John D. Rockefeller III, as previously detailed elsewhere.

Looking around the globe, the most important remaining landmasses from the standpoint of world domination are AUSTRALIA AND NEW

ZEALAND. Thanks to World War II, both were wide open to the Rockefellers.

The Rockefeller Brothers decided to establish secret military installations in the Southern Hemisphere for use after the coming war. By this means they expected to become the masters of the surviving southern half of planet Earth; after the Northern Hemisphere gradually recovered from the nuclear holocaust, the Rockefeller empire would be able to pick up the pieces. In this way the third-generation Rockefeller Brothers expected their family dynasty to inherit the Earth.

In order to control the Southern Hemisphere militarily after the war, some means would have to be available to project military power onto any landmass. For example, revolts against Rockefeller domination would require troops—not a blast from the beam weapons on the Moon (another very interesting story).

The most critical factor for postwar military domination of the world was found to be a NAVY! A minimum of two secret naval fleets would be required—one based in the South Atlantic, the other in the South Pacific. Since the reserve naval fleets were to be kept secret until after the Northern Hemisphere nuclear war, they could not be built in existing shipyards. New construction facilities had to be built and they had to be hidden. To hide an entire shipyard is no small task; they take up a lot of space. On top of that, it was essential that the ships remain hidden after they were built. The best way to achieve that was to combine the shipyard and naval base into one over-all secret installation. Finally, the secret naval installation had to be invulnerable to nuclear attack; otherwise, if its existence were ever discovered prematurely, the secret navy might be wiped out.

The combined requirements for secrecy, space and protection against attack were formidable; but one day in 1959, while all these plans were still in the early stages of development, the answer presented itself. During a so-called banking trip to Sweden, David Rockefeller was given a tour of a unique hidden naval port. The port is hollowed out from solid granite cliffs which come right down to the water. The entrance to the port is a gigantic hole in the side of the cliff which can be sealed off with enormous steel doors. Inside this big doorway on the water a huge cavity has been hollowed out to accommodate ships.

The Rockefeller Brothers and their military advisers decided that a bigger, more secret, better-protected version of the Swedish hidden port was just what they wanted. A survey of candidate sites was then initiated. The site survey covered coastal areas throughout the Southern Hemisphere. Many areas were rejected very quickly because the topography was wrong. Other areas were rejected because they were too close to the Equator. Still others had to be ruled out because there were too many people living nearby, making the desired level of secrecy impossible. Finally, it was essential that the sites chosen for the secret naval installations be totally secure politically.

At last the sites for the secret naval installations were selected. In the South Pacific extreme southern New Zealand was selected. New Zealand would be extremely important during a coming war.

In order to obtain the necessary space, the secret New Zealand naval installation had to be divided up into two sites located close together. One is at the extreme southwest tip of South Island

where the mountain range known as the Southern Alps comes down virtually to the water's edge. The other part of the installation is built into the northwest tip of Stewart Island, which is off the tip of South Island. The Stewart Island facility is hollowed out within a rise known as Mt. Anglem.

The New Zealand location met all the requirements. Ever since World War II the government of New Zealand has been tied even closer to the United States than to Great Britain. The location is far from the Equator, and the installations are buried deep under mountains, protected from nuclear attack. They are also too deep to be reached by particle-beam attacks—and the New Zealand site is well situated to command the entire South Pacific.

In the South Atlantic an even more perfect site was found. That site, my friends, is South Georgia Island. It is located perfectly for naval domination of the entire South Atlantic. The tall rugged mountains provided a perfect location for the secret installation at the northwest tip of the 100-mile-long island. It is controlled by Great Britain whose government, like that of New Zealand, was willing to cooperate; and South Georgia Island was virtually uninhabited except for a whaling station on the northeast coast. The whaling station was some 50 miles away from the secret new installation which was being built, but Britain took no chances. In 1965 the whaling station was closed down. Since that time there have been no inhabitants on South Georgia Island except for a few dozen alleged Antarctic scientists.

Construction of the secret naval facilities—two in New Zealand, one on South Georgia Island—began in the early 1960s. The techniques were adapted from those used previously to build other large underground facilities, such as the NORAD installation inside Cheyenne Mountain, Colorado (there are others well protected underground but we shall not go into those presently). However, these installations and techniques were adapted in radically new ways to achieve construction access directly from the sea instead of overland. In this way, the sheltering mountain was left undisturbed in appearance both during and after construction.

The cuts in the mountainside which were necessary to let ships in and out were kept as small as possible and were well camouflaged. Like the Swedish hidden naval port arrangement, the entrances to the secret installations can be sealed. When sealed, the entrance is virtually impossible to detect unless you know exactly where it is; and unlike most large construction projects, there are no tailings or piles of leftover rock lying round to attract undue attention. The man-made caverns which house the secret naval installations are enormous, but all the rock and debris was disposed of at sea.

Once the secret naval facilities were built, they had to be outfitted for ship construction and dockside storage. The fake disarmament of the United States during the 1960s contributed greatly to this task. From 1961 to 1968 one man played a pivotal role in this elaborate Rockefeller scheme. He was then-Secretary of Defense Robert McNamara. All through the 1960s McNamara presided over the public paring-back of America's visible military power. This included the closing down and dismantling of entire shipyards. What you were not told was where all that shipyard equipment went afterwards. Where it went, my friends, was to the new secret installations which were being

outfitted in New Zealand and South Georgia Island!

The secret naval installations have been used as duplication facilities to reproduce certain ships and submarines designed and built here in the United States. As Defense Secretary Caspar Weinberger told Congress, "It is cheaper to build two ships at a time." That is most especially true if the second ship is an exact duplicate of the first. This has become even more true in recent years through the use of computerized manufacturing techniques.

The secret naval fleets which have been built at the secret installations are made up of duplicates—EXACT DUPLICATES of certain other ships and submarines. They are all nuclear powered—nuclear "subs", nuclear cruisers, nuclear destroyers, and yes, nuclear aircraft carriers, at least three of them. A secret twin was built for the *U.S.S. Nimitz*, for the *U.S.S. Eisenhower*, and for the *U.S.S. Carl Vincent*. All have been financed through the gigantic cost overruns, so called, that you constantly hear about in the Defense Department and can't find anything about due to above-top-secret designations; all three carriers have been provided with a full complement of aircraft whose manufacture was financed in the same manner.

The ships of the secret American Bolshevik naval fleets are all duplicates of other nuclear-powered vessels. Even so, the secret naval ships possess one key difference.

The so-called "Stealth Program" may not be too effective with the planes, etc., you have been allowed to witness but, oh my, lots of interesting things go on with things you aren't given to witness.

There was developed a type of electromagnetic invisibility shielding. This technique makes an object invisible from a distance by distorting light waves in its vicinity.

A whole new fleet of Phantom warplanes went into crash production under a top-secret shield. They utilize this principle; and all of the secret American Bolshevik navy ships have already been outfitted with similar Stealth-field equipment! The Stealth principle is actually easier to apply to ships than to airplanes because there is more room for the powerful equipment that generates the force field.

After NUCLEAR WAR ONE, the secret Stealth navy of the American Bolsheviks would be light years ahead of any other navy left on Earth. It would be perfect for the intended role of world domination. The Rockefellers set it all in motion long ago—but about 1979 they lost control of the United States Military. Now it is the American Bolsheviks who are in control—and they are most surely bent straight ahead on war.

Now don't go about forgetting about the Nazi war machine also in the Antarctic—isn't this just about as much intrigue as you can take at one sitting?

## DEMOCRATS BLAST ORDER ON TRIBUNALS SENATORS TOLD MILITARY TRIALS FALL UNDER PRESIDENT'S POWER

The Bush administration was considering the use of military tribunals to prosecute suspected foreign terrorists before the passage of a tough new anti-terrorist law last month but did not tell Congress of the plan because it did not require legislative action, a top Justice Department official testified yesterday.

Speaking at a Senate Judiciary Committee hearing called to examine sweeping new anti-terror policies that some lawmakers have criticized, Assistant Attorney General Michael Chertoff said military trials fall within the president's power "as commander in chief".

But Democratic senators at the hearing, led by Chairman Patrick J. Leahy (Vt.), sharply criticized the Nov. 13 order that empowered Bush to order military trials for non-U.S. citizens—and the failure to consult Congress before issuing the directive and others that are part of the broad anti-terror campaign. Republican senators, with the exception of Arlen Specter (Pa.), were highly supportive of the crackdown.

Despite the cooperation between the White House and Congress that led to swift passage of the new anti-terror law, Leahy said, the administration has since disregarded "the checks and balances that make up our constitutional framework".

Instead, he said, the executive branch "has chosen to cut out judicial review" in a new order that allows Attorney General John D. Ashcroft to initiate monitoring of attorney-client communications of suspected terrorists, "and to cut out Congress in determining the appropriate tribunal and procedures to try terrorists."

Chertoff, who heads the Justice Department's criminal division, said he was confident that all the steps taken have been "within carefully established constitutional limits." Emphasizing the carnage of the Sept. 11 terrorist attacks, he said the suspected mastermind, Osama bin Laden, and members of his al-Qaida terrorist network have since announced "they will kill more of us."

"So for those of us who question whether we are at war," Chertoff said, "my answer is, Mr. bin Laden has declared war on us.... Are we being aggressive and hard-nosed? You bet. But let me emphasize that every step that we have taken satisfies the *Constitution* and federal law as it existed both before and after September 11th."

Leahy, however, said he was especially dismayed by Bush's order for military tribunals, voicing fears that it could become a model for use by foreign governments against Americans overseas. The order allows the Pentagon to set rules and procedures less rigorous than those that govern U.S. criminal prosecutions, permits convictions and death sentences on a two-thirds vote and ostensibly prohibits judicial review of verdicts.

Chertoff said such tribunals had a solid history dating back to the Revolution.

But Leahy pointed to Spain's reluctance to

extradite suspects to the United States if they are to be tried by military commissions. In bypassing the civilian courts, he said, "it sends a terrible message to the world that, when confronted with a serious challenge, we lack confidence in the very institutions we are fighting for."

Like Leahy, Specter derided Chertoff's claims that Congress was "a full partner" in the fight when "nobody let us know" the military order was being prepared. Leahy noted that he had asked Ashcroft after a Sept. 25 hearing whether the president was considering "using the military tribunal system."

Ashcroft wrote Leahy on Oct. 18 that "it would be inappropriate for the Department to make premature pronouncements concerning the feasibility of this or other particular methods of trying hostile foreign terrorist forces."

Defending the administration, Sen. Orrin G. Hatch (R-Utah) said many of the criticisms of the administration's methods have been "unfounded... very unfair and have been almost hysterical."

"After all," Hatch said, "our enemies in this war are not, as many on the extreme left are fond of saying, simply trying to change our way of life. They are trying to kill Americans—as many as they possibly can."

Democratic senators also complained yesterday about the secrecy surrounding hundreds of people who have been detained as officials try to determine whether they have any knowledge of or connection to terrorist activities. On Tuesday, Ashcroft identified 93 people charged with federal crimes and released a list of charges against 548 unidentified people held on immigration violations. But authorities have refused to reveal the names of more than 1,000 people detained since Sept. 11 or provide details about their cases.

Chertoff said the detentions were needed in part to guard against " sleeper" cells of al-Qaida terrorists, some of whom live in target countries for years before receiving instructions to carry out terrorist acts. He also disputed the criticisms of former FBI officials who told *The Washington Post* that the bureau's determination to round up suspects to thwart future terrorism is an ill-advised law enforcement tactic.

Chertoff said officials are continuing longer-term investigations but are also asking whether individual cases are actually "yielding fruit" or should be closed down.

Another new policy, not cited at the hearing, came to light in the form of a Sept. 21 directive ordering all immigration judges to close hearings to the public in "certain cases" specified by Ashcroft.

Issued by Chief Immigration Judge Michael J. Creppy, the memo included more detailed instructions that "no visitors, no family and no press" were to be allowed in hearings, that judges would need special security clearances to hear cases and that all personnel should be instructed "not to discuss the case with anyone."

Justice officials also acknowledged yesterday that they might seek to jail without bond any of 5,000 young foreign visitors being sought for interviews if they are found to be in violation of immigration laws.

The interviews, which target young, mostly Middle

Eastern visitors who entered the United States from countries where terrorists allegedly reside, have been portrayed by Ashcroft and other Justice officials as voluntary and not focused on criminal suspects.

But an internal memo issued last week by a senior INS official said that “affirmative requests either by the FBI or the United States Attorney’s office to detain immigration violators under ‘No Bond’ should be honored and will be handled in the same manner as all prior cases with a direct nexus to the Sept. 11 investigation.”

Justice spokeswoman Mindy Tucker said the INS directive merely reiterates standard policy. “All along through the investigation, we’ve said we’re not going to turn a blind eye to a crime that’s being committed,” Tucker said.

The Senate hearings will resume next week. Ashcroft is scheduled to testify Thursday.

### TRIBUNALS FACE LEGAL BATTLES

The Bush administration’s aggressive expansion of the government’s powers to arrest and prosecute people in fighting terrorism has stirred a legal battle that could last many years and redefine the powers of the executive branch, lawyers and leaders of civil liberties groups say.

The groups, which range across the political spectrum, say they have found serious constitutional flaws in President Bush’s actions and are preparing a variety of legal challenges.

Atty. Gen. John Ashcroft has maintained that civil rights have never been threatened by the administration’s actions, which include the arrests and interrogations of hundreds of people after the Sept. 11 attacks, the authorization of military tribunals to try terrorist suspects, and efforts to interview 5,000 young Muslim men about their possible knowledge of terrorism.

“I have yet to be informed of a single lawsuit filed against the government charging a violation of someone’s civil rights as a result of this investigation,” Ashcroft said Tuesday.

But such lawsuits are coming soon, lawyers and leaders of some of the groups said.

Bill Goodman, legal director of the Center for Constitutional Rights in New York, said the center, which grew out of legal efforts to defend civil rights protesters in the 1960s, is planning to challenge the executive order Bush signed on Nov. 13 allowing special military tribunals to try foreigners charged with terrorism. Goodman said he was discussing the possible challenge with lawyers representing some of those likely to face charges.

Bush’s order, he said, has effectively suspended the writ of habeas corpus, a centuries-old legal procedure protecting citizens from being held illegally by the government. No president has the right to do that without the approval of Congress, the center’s lawyers argue.

“My job is to defend the *Constitution* from its enemies,” Goodman said. “Its main enemies right now are the Justice Department and the White House.”

Timothy Lynch, director of the criminal justice project of the Cato Institute, a group often associated with conservative causes, said he was particularly concerned with the power the president’s order gave officials to detain non-citizens without court approval.

“If the president can suspend one constitutional principle today,” Lynch said, “the danger is he can

suspend others tomorrow.” He said Cato would most likely file friend-of-the-court briefs siding with those challenging the military tribunals.

Mindy Tucker, a spokeswoman for the Justice Department, said such legal challenges would likely fail.

“We do not believe our system of justice prevents us from protecting people’s constitutional rights and protecting American lives,” Tucker said.

Lawyers also said they were studying century-old Supreme Court rulings and materials dealing with the drafting of the Constitution as they formed arguments, and they outlined a broad range of legal strategies to attack actions taken by the administration since Sept. 11.

Elliot M. Minberg, legal director of the People for the American Way Foundation, a Washington-based liberal group, said one possible tactic would be lawsuits under the Freedom of Information Act to press for more disclosure by the government about the people it has detained.

Irwin Schwartz, a Seattle lawyer who is president of the National Association of Criminal Defense Lawyers, said his organization of 30,000 lawyers was developing a strategy for expected challenges to Ashcroft’s policy permitting the monitoring of some conversations between lawyers and their clients.

“What the attorney general has done here is the equivalent of putting an FBI agent’s ear to the confessional,” Schwartz said. Officials have argued that they have many safeguards to assure that monitoring does not violate any rights.

Several lawyers said they were focusing particular attention on the president’s order establishing the military tribunals, which would give defendants many fewer rights than are available in civilian trials.

Steven Shapiro, legal director of the American Civil Liberties Union, said the group had concluded the president was, in effect, making law by authorizing the military tribunals and providing the procedures for trials in them.

Government officials have argued that the president was authorized to take the action because of his powers under the *Constitution* as commander in chief.

### THE TRUTHS THEY NEVER TELL US

***Behind the jargon about failed states and humanitarian interventions lie thousands of dead.***

Polite society’s bombers may not have to wait long for round two. The U.S. vice-president, Dick Cheney, warned last week that America could take action against “40 to 50 countries”. Somalia, allegedly a “haven” for al-Qaida, joins Iraq at the top of a list of potential targets. Cheered by having replaced Afghanistan’s bad terrorists with America’s good terrorists, the U.S. defence secretary, Donald Rumsfeld, has asked the Pentagon to “think the unthinkable”, having rejected its “post-Afghanistan options” as “not radical enough”.

An American attack on Somalia, wrote the *Guardian*’s man at the Foreign Office, “would offer an opportunity to settle an old score: 18 U.S. soldiers were brutally killed there in 1993...”. He neglected to mention that the U.S. Marines left between 7,000 and 10,000 Somali dead, according to the CIA. Eighteen American lives are worthy of score-settling; thousands of Somali lives are not.

Somalia will provide an ideal practice run for the final destruction of Iraq. However, as the *Wall Street Journal* reports, Iraq presents a “dilemma”, because “few targets remain”. “We’re down to the last outhouse,” said a U.S. official, referring to the almost daily bombing of Iraq that is not news.

Having survived the 1991 Gulf War, Saddam Hussein’s grip on Iraq has since been reinforced by one of the most ruthless blockades in modern times, policed by his former amours and arms suppliers in Washington and London. Safe in his British-built bunkers, Saddam will survive a renewed blitz—unlike the Iraqi people, held hostage to the compliance of their dictator to America’s ever-shifting demands.

In this country, veiled propaganda will play its usual leading role. As so much of the Anglo-American media is in the hands of various guardians of approved truths, the fate of both the Iraqi and Somali peoples will be reported and debated on the strict premise that the U.S. and British governments are against terrorism. Like the attack on Afghanistan, the issue will be how “we” can best deal with the problem of “uncivilised” societies.

The most salient truth will remain taboo. This is that the longevity of America as both a terrorist state and a haven for terrorists surpasses all. That the U.S. is the only state on record to have been condemned by the World Court for international terrorism and has vetoed a UN Security Council resolution calling on governments to observe international law is unmentionable. Recently, Denis Halliday, the former assistant secretary general of the UN who resigned rather than administer what he described as a “genocidal sanctions policy” on Iraq, incurred the indignation of the BBC’s Michael Buerk. “You can’t possibly draw a moral equivalence between Saddam Hussein and George Bush [Senior], can you?” said Buerk. Halliday was taking part in one of the moral choice programmes that Buerk comperes, and had referred to the needless slaughter of tens of thousands of Iraqis, mostly civilians, by the Americans during the Gulf War. He pointed out that many were buried alive, and that depleted uranium was used widely, almost certainly the cause of an epidemic of cancer in southern Iraq.

That the recent history of the West’s true crimes makes Saddam Hussein “an amateur”, as Halliday put it, is the unmentionable; and because there is no rational

rebuttal of such a truth, those who mention it are abused as “anti-American”. Richard Falk, professor of international politics at Princeton, has explained this. Western foreign policy, he says, is propagated in the media “through a self-righteous, one-way moral/legal screen [with] positive images of Western values and innocence portrayed as threatened, validating a campaign of unrestricted political violence”.

The ascendancy of Rumsfeld and his deputy, Paul Wolfowitz, and associates Richard Perle and Elliot Abrams means that much of the world is now threatened openly by a geopolitical fascism, which has been developing since 1945 and has accelerated since 11 September.

The present Washington gang are authentic American fundamentalists. They are the heirs of John Foster Dulles and Alan Dulles, the Baptist fanatics who, in the 1950s, ran the State Department and the CIA respectively, smashing reforming governments in country after country—Iran, Iraq, Guatemala—tearing up international agreements, such as the 1954 Geneva accords on Indochina, whose sabotage by John Foster Dulles led directly to the Vietnam War and five million dead. Declassified files now tell us the United States twice came within an ace of using nuclear weapons.

The parallels are there in Cheney’s threat to “40 to 50” countries, and of war “that may not end in our lifetimes”. The vocabulary of justification for this militarism has long been provided on both sides of the Atlantic by those factory “scholars” who have taken the humanity out of the study of nations and congealed it with a jargon that serves the dominant power. Poor countries are “failed states”; those that oppose America are “rogue states”; an attack by the West is a “humanitarian intervention”. (One of the most enthusiastic bombers, Michael Ignatieff, is now “professor of human rights” at Harvard). And as in Dulles’s time, the United Nations is reduced to a role of clearing up the debris of bombing and providing colonial “protectorates”.

The twin towers attacks provided Bush’s Washington with both a trigger and a remarkable coincidence. Pakistan’s former foreign minister Niaz Naik has revealed that he was told by senior American officials **in mid-July** that military action against Afghanistan would go ahead by the middle of October. The U.S. secretary of state, Colin Powell, was then travelling in central Asia, already gathering support for an anti-Afghanistan war “coalition”. For Washington, the real problem with the Taliban was not human rights; these were irrelevant. The Taliban regime simply did not have total control of Afghanistan: a fact that deterred investors from financing oil and gas pipelines from the Caspian Sea, whose strategic position in relation to Russia and China and whose largely untapped fossil fuels are of crucial interest to the Americans. In 1998, Dick Cheney told oil industry executives: “I cannot think of a time when we have had a region emerge as suddenly to become as strategically significant as the Caspian.”

Indeed, when the Taliban came to power in 1996, not only were they welcomed by Washington, their leaders were flown to Texas, then governed by George W. Bush, and entertained by executives of the Unocal oil company. They were offered a cut of the profits from the pipelines; 15 percent was mentioned. A U.S. official observed that, with the Caspian’s oil and gas flowing, Afghanistan would become “like Saudi Arabia”, an oil colony with no democracy and the legal persecution of women. “We can live with that,” he said. The deal fell through when two American embassies in

east Africa were bombed and al-Qaida was blamed.

The Taliban duly moved to the top of the media’s league table of demons, where the normal exemptions apply. For example, Vladimir Putin’s regime in Moscow, the killers of at least 20,000 people in Chechnya, is exempt. Last week, Putin was entertained by his new “close friend”, George W. Bush, at Bush’s Texas ranch.

Bush and Blair are permanently exempt—even though more Iraqi children die every month, mostly as a result of the Anglo-American embargo, than the total number of dead in the twin towers, a truth that is not allowed to enter public consciousness. The killing of Iraqi infants, like the killing of Chechens, like the killing of Afghan civilians, is rated less morally abhorrent than the killing of Americans.

As one who has seen a great deal of bombing, I have been struck by the capacity of those calling themselves “liberals” and “progressives” wilfully to tolerate the suffering of innocents in Afghanistan. What do these self-regarding commentators, who witness virtually nothing of the struggles of the outside world, have to say to the families of refugees bombed to death in the dusty town of Gardez the other day, long after it fell to anti-Taliban forces? What do they say to the parents of dead children whose bodies lay in the streets of Kunduz last Sunday? “Forty people were killed,” said Zumeray, a refugee. “Some of them were burned by the bombs, others were crushed by the walls and roofs of their houses when they collapsed from the blast.” What does the *Guardian*’s Polly Toynbee say to him: “Can’t you see that bombing *works*?” Will she call him anti-American? What do “humanitarian interventionists” say to people who will die or be maimed by the 70,000 American cluster bomblets left unexploded?

For several weeks, the *Observer*, a liberal newspaper, has published unsubstantiated reports that have sought to link Iraq with 11 September and the anthrax scare. “Whitehall sources” and “intelligence sources” are the main tellers of this story. “The evidence is mounting...” said one of the pieces. The sum of the “evidence” is zero, merely grist for the likes of Wolfowitz and Perle and probably Blair, who can be expected to go along with the attack. In his essay “The Banality of Evil”, the great American dissident Edward Herman described the division of labour among those who design and produce weapons like cluster bombs and daisy cutters and those who take the political decisions to use them and those who create the illusions that justify their use. “It is the function of the experts, and the mainstream media,” he wrote, “to normalise the unthinkable for the general public.” It is time journalists reflected upon this, and took the risk of telling the truth about an unconscionable threat to much of humanity that comes not from faraway places, but close to home.

#### TERROR WAR ALLIES QUEASY OVER TALK OF TARGETING IRAQ

#### *Israel fears bearing brunt of retaliation if Hussein attacked.*

JERUSALEM—America’s allies in the Middle East and Europe are increasingly nervous about President Bush’s hints that Saddam Hussein might be the next target in the administration’s war on terrorism.

France and Germany issued statements this week cautioning the Bush administration against expanding the anti-terrorism campaign into Iraq. Russia has expressed its doubts, and Arab allies, including Egypt and Jordan, warn that an attack on Iraq would backfire on the United States.

In Israel, military and intelligence officials predict that if Iraq is the next target in the American-led war on terrorism, Iraq will attempt to retaliate by using chemical or biological weapons against Israel.

The subject of Iraq is expected to be high on the agenda when Israeli Prime Minister Ariel Sharon meets in Washington next week with Bush and other U.S. officials.

Having been on the receiving end of 39 Iraqi scud missiles during the 1991 Persian Gulf War, Israel’s apprehensions are understandable.

Sharon departed for the U.S. Thursday night. He has raised no objection to a U.S. strike on Iraq; all he requests is a few days’ advance notice and a commitment from Bush that if Iraq tries to retaliate by attacking Israel—Israel will not be restrained from hitting back, as it was during the Gulf War.

Within the Bush administration, a group of hawks generally identified with Undersecretary of Defense Paul Wolfowitz has been trying to make the case for targeting Iraq, which is suspected of pursuing a program to develop weapons of mass destruction.

Bush has left his intentions deliberately vague. On Monday he warned that Hussein must allow international weapons inspectors back into Iraq. When asked what would happen if the Iraqi leader refuses, Bush replied, “He’ll find out.”

Iraq says it will not agree to weapons inspections until the United Nations lifts sanctions against the Baghdad regime. On Thursday, the UN Security Council unanimously approved a resolution sponsored by the United States and Russia extending the UN humanitarian program in Iraq and setting the stage for an overhaul of sanctions next year.

Iraqi Vice President Taha Hussein Ramadan told Qatar-based Al Jazeera television that Iraq would feel justified in launching missiles against Israel in the event of a U.S. attack.

“The Arabs see Israel as the main ally of the U.S. in the Middle East. No one in the world can deny the right of self-defense if a country faces

aggression. It is a legitimate right," said Ramadan.

Israeli intelligence officials believe that an American attack on Iraq is only a matter of time, perhaps two or three months from now.

Gen. Amos Malka, the director of army intelligence, told the government that a retaliatory attack on Israel would be a virtual certainty. Defense Minister Benjamin Ben Eliezer reportedly brought this up in his initial meeting this week with Anthony Zinni, the retired Marine general who is in Israel trying to broker a cease-fire between the Israelis and Palestinians.

According to Israeli intelligence estimates, Iraq has no more than a half-dozen missile launchers and perhaps 50 missiles. But military experts doubt that Iraq has the technological capability to use missiles to effectively deliver chemical or biological warheads.

A report published Thursday in the Israeli daily *Yediot Ahronot* said Israeli officials were more concerned that Iraq would send its pilots on suicide missions in planes loaded with crude chemical or biological bombs.

In the decade since the Gulf War, Israel has developed its own missile defense system, but it has not been tested in combat.

With the anthrax panic in the United States and the local media filled with speculation about possible Iraqi attacks, many Israelis have dusted off their gas masks to make sure they are in good working order. Israel provides all citizens gas masks at no cost.

The army's home front command this week updated its instructions on how civilians should respond in case of a chemical or biological attack. It does this routinely every couple of years but decided to speed the process in light of current concerns.

Outside the region, the main concern is that expanding the war into Iraq would unravel the broad-based support that thus far has lent a high degree of legitimacy to the U.S. campaign in Afghanistan.

"All European nations would view a broadening to include Iraq highly skeptically. And that's putting it diplomatically," said German Foreign Minister Joschka Fischer.

Chancellor Gerhard Schroeder, speaking at the same session of the Bundestag this week, said: "We should be particularly careful about a discussion of new targets in the Middle East. More could blow up in our faces there than any of us realize."

France, which along with Russia has been a key backer of Iraq at the UN, also signaled its reservations.

"There is no other nation [besides Afghanistan] whose leaders have been active accomplices of terrorist actions. So we do not believe that it is today necessary to take military action against other sites," said French Foreign Minister Alain Richard, who made the comment during a visit to Bulgaria.

### MOSSAD AGENTS ARRESTED IN ATTEMPT TO BOMB MEXICAN CONGRESS

LOS ANGELES (ACN)—As reported in *La Vox De Aztlan*, two men, one of them a former Israeli Colonel and Mossad agent, were arrested INSIDE the Mexican congress carrying 9mm pistols and dynamite, but were released following intense pressure from the Israeli Embassy.

In a mind-blowing development, *La Voz de Aztlan* has learned that Mexican Army General Rafael Marcial Macedo de la Concha who heads the Procuraduría General de la República (Mexican Department of Justice) has released the retired Israeli Defense Forces colonel and presumed MOSSAD agent Salvador Guersson Smecke and Israeli illegal immigrant Saur Ben Zvi after both had penetrated the security of the Mexican Congress and were in possession of guns, hand grenades and explosives.

This morning *La Voz de Aztlan* had a personal telephone interview with the Mexican Congressional Press Secretary, Lic. Adriana Lopez, and verified the arrest of the two Israelis after they had entered through the highly secured front entrance of the Palacio Legislativo de San Lázaro. She stated to *La Voz de Aztlan* that the two terrorists had taken advantage of a situation that occurred around 1700 hours of Wednesday October 10 when a large contingent of Sugar Industry Unionists were entering through the metal detectors. The two Israelis followed about 50 of the unionists to the office of the President of the Mexican Congress Beatriz Paredes. The two Israelis were first pretending to be press photographers but called the attention of the sugar unionists because of their nervous and out of the ordinary behavior. About ten of the unionists confronted them and observed that they were carrying guns and what looked to them to be explosives. They held the two Israelis until Official Congressional Security personnel took them into custody. The head of Congressional Security Salvador Alarcón verified that the Israelis had in their possession nine hand grenades, sticks of dynamite, detonators, wiring and two 9mm "Glock" semi-automatics.

Mexican Congressional Press Secretary Lic. Adriana Lopez informed *La Voz de Aztlan* in the telephone interview that Congressional Security then turned the terrorists Salvador Guersson Smecke, age 34, and Saur Ben Zvi, age 27, to the Procuraduría General de la República (Mexican Department of Justice) which is headed by Mexican Army General Rafael Marcial Macedo de la Concha. Initial reports by the Procuraduría General de la República (PGR) were that both Israelis worked for a private security agency and that they both had gun permits. It turned out that there is no connection of either suspect to any private security agency. The PGR has released the retired Israeli I.D.F. colonel with the official explanation that he had a legal permit to carry a gun. They also released the illegal Israeli immigrant on about \$4000 bail and the case turned over to the Mexican immigration authorities. Mexican Congressional Press Secretary Lic. Adriana Lopez was surprised to hear from *La Voz de Aztlan* of the release of the two Israelis.

*La Voz de Aztlan* has also learned that the Israeli Embassy used heavy-handed measures to have the two Israelis released. Very high level emergency meetings took place between Mexican Secretary of Foreign Relations Jorge Gutman, General Macedo de la Concha and a top Ariel Sharon envoy who flew to Mexico City specially for that purpose. Elías Luf of the Israeli Embassy worked night and day and their official spokeswoman Hila Engelhart went into high gear after many hours of complete silence. What went on during those high-level meetings no one knows, but many in Mexico are in disbelief at their release. Guns and any kind of explosive is highly illegal for Mexican citizens and the fact that these two Israelis had them inside the Mexican Congress makes their release highly suspect. What is really going on? Jorge Gutman, the Mexican Foreign Secretary, has very strong Zionist connections and himself is of Jewish descent. Mexican Army General Macedo de la Concha has strong connections to the U.S. Military Industrial-Complex and through this to the Israeli Defense Forces. Have any of these connections influenced the decision to release the two Zionist terrorists?

The initial arrests of the two Israelis inside the Palacio Legislativo de San Lázaro made top news on Mexico City television and radio on the evening of October 10. *TV Azteca* had extensive coverage on the first night and on the following day. *La Cronica de Hoy* Newspaper and *El Universal* Newspaper both covered the incident the following two days but now it seems that there is a lack of reports. What were the Israelis up to? We think we know. The Vicente Fox government has been very careful of involving Mexico in a war against Islam. The Mexican population as well as the two major opposition political parties, the PRI and the PRD will not allow it. President Bush and the U.S. Zionists want Mexico fully involved in the war principally because if things get tough in the Middle East and the oil rich Arabs leave the coalition, the U.S. military machine is going to need alternative sources of oil and PEMEX is just across the border. We believe that the two Zionist terrorists were going to blow up the Mexican Congress. The second phase was to mobilize both the Mexican and U.S. press to blame Osama bin Laden. Most likely then Mexico would declare war on Afghanistan as well, commit troops and all the oil it could spare to combat Islamic terrorism.

**NEW EVIDENCE INDICATES PALESTINIANS DIED HOURS AFTER SURVIVING CAMP MASSACRES**

Chilling new evidence suggests that more than 1,000 Palestinian survivors of the Sabra and Chatila camp massacres in Beirut were “disappeared” within 24 hours of the slaughter, often in areas under direct Israeli military control.

The testimony—which describes in detail how the victims were last seen by their families in the hands of Israeli troops and Israel’s militia allies—will be among the material to be considered by a Belgian judge, who could decide today whether the Israeli Prime Minister, Ariel Sharon, should be prosecuted for the slaughter.

Mr. Sharon was judged “personally responsible” for the massacre by the Israeli Kahan Commission in 1983. Its report concluded that hundreds of Palestinian civilians, including women and children, were all butchered between 16 and 18 September in 1982.

But among the female witnesses cited by lawyers in Belgium, who are seeking the indictment against Mr. Sharon, are at least five who claim that more than 100 men were detained by the militiamen and handed over to the Israelis alive. They were never seen again.

Separately from the court action, film taken by a television crew at the time, which has recently come to light, appears to show Israeli officers in the presence of Phalangist gunmen—long after the Israelis knew their Phalangist allies had carried out the massacre, which caused worldwide outrage and led Mr. Sharon, then Defense Minister, to resign.

There has always been a discrepancy between the number of bodies found in Sabra and Chatila—up to 600—and the number of civilians registered as missing—more than 1,800. Until now, it was assumed that all the victims had been murdered by Phalangists and that many had been secretly buried.

If accepted by the court, the new evidence could hold disturbing implications for both the Israeli army and for Mr. Sharon, particularly if the Israelis continued their collaboration with the Phalange after the murders in the camps and if they permitted the Phalange to take away more prisoners.

**CASPIAN PIPELINE SKIRTS TROUBLE SPOTS**

Dignitaries from around the world gathered at a Russian tanker port on the Black Sea Tuesday to mark the grand opening of a 900-mile pipeline that has thrown open the door to the vast oilfields of the volatile Caspian Sea region.

The pipeline was built in a little more than a year by the Caspian Pipeline Consortium and has been operational at a rate of about 600,000 barrels per day for more than a month. It links the huge Tenzig field of western Kazakhstan to the seaport of Novorossiysk.

While probably not the most direct route to the open sea, the CPC route runs well north of Afghanistan and skirts the troubled Russian republic of Chechnya.

“This pipeline will strengthen international energy security by adding more than a million barrels of oil a day to global supply, and by creating new jobs and billions of dollars in revenue,” said U.S. Secretary of Energy Spencer Abraham, one of a number of high-ranking officials from the United States, Russia and Kazakhstan who attended Tuesday’s ceremony in Novorossiysk.

Novorossiysk has been a major tanker terminal for Russian crude exports for many years, however it was not the only choice for the terminus of a crude pipeline from the Caspian.

It turned out to be the safest and most expedient investment for the consortium, which spent about \$2.65 billion on the project.

During the 1990s, the United States was anxious to see increased amounts of Caspian oil reaching the world market in order to further dilute the clout of OPEC and other major producers. The Caspian has as much as 34 billion barrels of proven reserves and much larger potential reserves, about a quarter of what the Middle East holds and larger than the reserves in the United States and North Sea, according to the U.S. Energy Information Administration.

The trick, however, was finding a politically secure route for the oil to take from the landlocked sea to open waters where it could be hauled to virtually anywhere in the world.

The most obvious route for a pipeline would be through the short route through Iran to the Persian Gulf, or through Afghanistan to the Pakistani coast—both of which presented the chance that unfriendly governments could shut down the pipeline in order to press a political agenda with the West.

U.S. sanctions against Iran and its refusal to recognize the Taliban in Afghanistan essentially made Novorossiysk the only choice for the oil companies that would invest huge amounts of money in the Caspian.

The CPC is made up of companies from Russia, Kazakhstan and Europe as well as the U.S. companies Mobil Caspian Pipeline and Chevron Caspian Pipeline Consortium Co. The Russian Federation holds 24 percent of the CPC while Kazakhstan and Oman also own stakes.

Executives Tuesday portrayed the CPC project as just the first of many international projects in the region that was thrown open by the collapse of the Soviet Union.

“This achievement comes at a time of increased partnership between the U.S., Russia, and Kazakhstan,” said ChevronTexaco Chairman Dave O’Reilly. “CPC is a bellwether project for successful

international cooperation and demonstrates the confidence the international business community has to invest in Russia and Kazakhstan.”

U.S. Commerce Secretary Don Evans said earlier this autumn that the CPC pipeline “tells the world that the United States, Russia, and Central Asian states are cooperating to build prosperity and stability in this part of the world.”

Caspian crude will have to transit the narrow Bosphorus to the Mediterranean Sea, making Europe its closest market. A pipeline through Iran or Afghanistan might make Caspian more economical for North American and Asian markets, however any new oil on the market helps keep world prices at reasonable levels.

“Greater energy security through a more diverse supply of oil for global markets—these are key elements of President Bush’s National Energy Policy,” Abraham said in a plug for his boss. “The CPC pipeline is a clear example of that policy in action, in an international setting.”

Some analysts and critics of the U.S. campaign in Afghanistan have theorized that the war against the Taliban is actually aimed at installing a regime in Kabul that will open the door for construction of another Caspian pipeline, however Tuesday’s ceremony in Novorossiysk may be a signal that there is no rush.

“There is no longer a shortage of oil export capacity in Kazakhstan,” Cambridge Energy Research Associates said in a recent assessment of the feasibility of an Afghan pipeline. “The need for a major new oil pipeline via Afghanistan or any other route will not reemerge until around 2010.”

The construction of the CPC pipeline to Novorossiysk turned out to be the right choice for the United States while Afghanistan’s failure to land a lucrative pipeline project will be chalked up as another misstep by the Taliban.

**GROUP LISTS UNPATRIOTIC REMARKS ON CAMPUSES**

Rev. Jesse Jackson made the list for remarking to an audience at Harvard Law School that America should “build bridges and relationships, not simply bombs and walls”.

Joel Beinin, a professor of Middle Eastern history at Stanford University, earned a place on it for his opinion that “If Osama bin Laden is confirmed to be behind the attacks,

the United States should bring him before an international tribunal on charges of crimes against humanity.”

And Wasima Alikhan of the Islamic Academy of Las Vegas was there simply for saying, “Ignorance breeds hate.”

They were included on a list of 117 anti-American statements heard on college campuses that was compiled by the American Council of Trustees and Alumni, a conservative non-profit group devoted to curbing liberal tendencies in academia. The list is part of a report accusing scholars, students and a university president of unpatriotic behavior after Sept. 11.

Calling professors “the weak link in America’s response to the attack”, the report excoriates faculty members for invoking “tolerance and diversity as antidotes to evil” and pointing “accusatory fingers, not at the terrorists, but at America itself.”

The report is titled “Defending Civilization: How Our Universities Are Failing America and What Can Be Done About It,” and a founding member of the council that produced it is Lynne Cheney, wife of Vice President Dick Cheney.

But Margita Thompson, a spokeswoman in Lynn Cheney’s office, said she was no longer involved with the council, which was created in 1995.

Cheney did provide a statement that Thompson read. “Faculty members have the right to express their opinions freely,” the statement said, and groups like the council “have a right to dispute those opinions when they disagree.”

But the council is facing mounting criticism from scholars who say that singling out individuals—for remarks taken out of context—is misleading and offensive. Todd Gitlin, a professor of communications at New York University, called the report “a record-breaking event in the annals of shoddy scholarship”.

##### DEAD SEA SCROLLS

Publication of the *Dead Sea Scrolls*—15,000 papyrus documents discovered in the desert that have changed scholars’ views on the *Bible*—is finally being completed, after more than half a century of bitter squabbling, censorship and academic controversy.

Fifty-four years after the first of them was found in a cave in Qumran, on the north-western shore of the Dead Sea, publication of all the scrolls and fragments has been completed in 37 volumes. All but two have been published in scholarly editions, and those two are being edited.

The scrolls are believed to have been written by a Jewish sect sometime between 200BC and early in the 1<sup>st</sup> Century AD, and the first were rediscovered in a cave by a shepherd boy in 1947. The theory is that they were hidden there in 68AD during the Jewish revolt against the Romans. Others were found in nearby caves during the 1950s.

The completion of publication is a landmark for academics and for Christians and Jews, whose most dearly held beliefs have been challenged by the scrolls—including that of the Virgin birth of Christ, which arose from the use of the word for virgin in early Greek versions of the *Bible*. The scrolls reveal that this was a mistranslation: the original Hebrew word used simply meant young woman.

Now the completion of the scrolls’ publication coincides with an admission by the Vatican that it is to revise parts of the *Bible* accordingly, a task likely to take five years.

Academics and historians also have to revise their views. For years academics fought one another for access, and until 1990 just eight volumes had been published. But in 1991, after the Antiquities Authority of Israel pledged to speed up publication, conservation and restoration of the scrolls, work on the rest began.

Professor Geza Vermes, who has spent 50 years studying the scrolls, said that completion of their publication was very important. “These are the only texts of their kind which have survived in their original form and language and geographical setting.

“They are texts which were written by the Jews for themselves, and without them we would have to rely on the Greek versions of the *Old Testament*. The originals had been lost. The *Dead Sea Scrolls* allow us to jump back another 1,000 years to the original documents.”

Professor Vermes, who has been director of Qumran research at the Oxford Centre for Hebrew and Jewish Studies since 1991, added that publication would not stop controversy but would lead to further debate about the *Bible*. “We will see even more interpretation and re-interpretation now.”

Experts have studied the scrolls and discovered much about the way the *Bible* was written, including its discrepancies, contradictions and repetitions. The first five books—*Genesis*, *Exodus*, *Leviticus*, *Numbers* and *Deuteronomy*—were ascribed to the same writer, Moses, but they have many inconsistencies. The scrolls include several different editions of the books of *Exodus* and *Numbers*, and the *Psalms*. They revealed that the *Bible* was not a rigidly fixed text, but was edited and adjusted to make the text more relevant to its audience.

It was not only the religious significance of the work that the scrolls questioned but also their historical truth, for they revealed that the writers would have coloured their accounts with their prejudices too.

#### N. KOREA: U.S. IS ESCALATING TENSIONS WITH ANTI-TERROR DEMANDS

SEOUL, South Korea—North Korea rejected an international demand to address concerns over its suspected development of weapons of mass destruction and to join the global campaign against terrorism.

“The United States has stepped up pressure on the Democratic People’s Republic of (North) Korea, raising

groundless charges of weapons of mass destruction and connecting the DPRK with terrorism,” the North’s Foreign Ministry spokesman said.

“The United States is using (its) anti-terrorism (campaign) for escalating tensions and harassing peace on the Korean peninsula,” the spokesman said in a statement carried by the state-run *Korean Central News Agency*.

The U.S. moves show that the Bush administration has no intention of entering into a dialogue to settle pending issues, even though it declares itself ready for talks without preconditions, the spokesman said.

“We can no longer just sit back. We have no choice but to take countermeasures with the United States trying to disarm the DPRK, while persistently pursuing its hostile policy toward Pyongyang,” he said.

The North’s strongly worded statement came a day after the United States, Japan and South Korea urged North Korea to address international concerns over its alleged weapons of mass destruction and to do more to fight global terrorism.

In a joint statement released after a trilateral meeting to discuss their North Korean policies Wednesday, the three allies said North Korea needed to “take further steps to confirm its cooperation with international anti-terrorism initiatives and opposition to international terrorism.”

The statement followed President Bush’s warning to North Korea against developing weapons of mass destruction, an indication Washington would intensify its scrutiny of Pyongyang’s suspected weapons of mass destruction, including biological war capabilities, as part of efforts to combat terrorism.

Bush urged North Korea to allow inspections of its illegal weapons programs, warning “consequences” if the North refuses.

U.S. Under-Secretary of State John Bolton has also accused North Korea of developing or being ready to develop biological weapons in violation of an international ban on germ warfare.

South Korean Defense Minister Kim Dong-Shin said that Washington’s call for inspections does not necessarily indicate North Korea could be the next target for a U.S. campaign against terrorism. But Kim said the North is capable of cultivating and producing 13 different types of germs including anthrax and smallpox.

North Korea was placed on the list after it was found to have been involved in the 1987 bombing of a South Korean airliner in which 115 passengers and crew were killed.

#### BUSH ADMINISTRATION TO BUY SMALLPOX VACCINE

WASHINGTON (AP)—The Bush administration signed a contract Wednesday to buy 155 million doses of smallpox vaccine from a British firm in

case terrorists try to spread the deadly virus.

The contract with Acambis Inc. will bring the nation's stockpile to 286 million doses of the vaccine by the end of next year, promising protection for every American should bioterrorists ever attack with the all-but-extinct virus.

The vaccine can be administered four days after exposure to smallpox, and officials have no plans to resume the routine vaccinations of Americans that ceased in 1972.

The government already has 15.4 million doses of smallpox vaccine on hand, and each of them will be diluted to create five doses, bringing the on-hand total to 77 million. Researchers are now studying whether each dose could be further diluted, to get 10 doses from each existing one.

An additional 54 million doses have already been ordered from Acambis and are expected to be delivered next year.

The new contract will cost the government \$428 million, or \$2.76 per dose. That's less than the \$509 million that the Bush administration has asked from Congress to pay for the new vaccine.

The initial budget request assumed that the government would need to buy 250 million doses, but new research has found that the existing vaccine can safely be diluted, meaning much less new vaccine is needed.

"While the probability of an intentional release of the smallpox virus is low, the risk does exist and we must be prepared," Health and Human Services Secretary Tommy Thompson said in a statement.

"Expanding our stockpile so there is a smallpox vaccine for every American if needed prepares us to respond aggressively to minimize the spread of the disease should an outbreak occur. Additionally, we hope that increasing our smallpox vaccine stockpile would serve as a deterrent to those who might consider using smallpox as a weapon against us."

Smallpox hasn't occurred in the United States since 1949 and was declared eradicated from the globe in 1980. But bioterrorism experts worry that the virus could be obtained by terrorists and intentionally released in the general population.

## FBI SOFTWARE CRACKS ENCRYPTION WALL

The FBI is developing software capable of inserting a computer virus onto a suspect's machine and obtaining encryption keys, a source familiar with the project told *MSNBC.com*. The software, known as "Magic Lantern", enables agents to read data that had been scrambled, a tactic often employed by criminals to hide information and evade law enforcement. The best snooping technology that the FBI currently uses, the controversial software called Carnivore, has been useless against suspects clever enough to encrypt their files.

MAGIC LANTERN installs so-called "keylogging" software on a suspect's machine that is capable of capturing keystrokes typed on a computer. By tracking exactly what a suspect types, critical encryption key information can be gathered, and then transmitted back to the FBI, according to the source, who requested anonymity.

The virus can be sent to the suspect via e-mail—perhaps sent for the FBI by a trusted friend or relative. The FBI can also use common vulnerabilities to break into a suspect's computer and insert Magic Lantern, the source said.

Magic Lantern is one of a series of enhancements currently being developed for the FBI's Carnivore project, the source said, under the umbrella project name of Cyber Knight.

The FBI released a series of unclassified documents relating to Carnivore last year in response to a Freedom of Information Act request filed by the Electronic Privacy Information Center. The documentation was heavily redacted—most information was blacked out. They included a document describing the "Enhanced Carnivore Project Plan" which was almost completely redacted. According to the anonymous source, redacted portions of that memo mention Cyber Knight, which he described as a database that sorts and matches data gathered using various Carnivore-like methods from e-mail, chat rooms, instant messages and Internet phone calls. It also matches the files with the necessary encryption keys.

*MSNBC.com* repeatedly contacted the FBI to discuss this story. However, after three business days the FBI was still requesting more time before commenting. *MSNBC.com* has filed a Freedom of Information Act request with the bureau.

Word of the FBI's new software comes on the heels of a major victory for the use of Carnivore. The *U.S.A. Patriot Act*, passed last month, made it a little easier for the bureau to deploy the software. Now agents can install it simply by obtaining an order from a U.S. or state attorney general—without going to a judge. After-the-fact judicial oversight is still required.

If Magic Lantern is in fact used to steal encryption keys, it would not be the first time the FBI has employed such a tactic. Just last month, in an affidavit filed by Deputy Assistant Director Randall Murch in U.S. District Court, the bureau admitted using keylogging software to steal encryption keys in a recent high-profile mob case. Nicodemo Scarfo was arrested last year for loan sharking and running a gambling racket. During their investigation, Murch wrote in his affidavit, FBI agents broke into Scarfo's New Jersey office and installed encryption-key-stealing software on the suspect's machine. The key was later used to decrypt critical evidence in the case.

Magic Lantern would take the method used in Scarfo one step further, allowing agents to "break in" to a

suspect's office and install keylogging software remotely. But in both cases, the software works the same way.

It watches for a suspect to start a popular encryption program called Pretty Good Privacy. It then logs the passphrase used to start the program, essentially given agents access to keys needed to decrypt files.

Encryption keys are unbreakable by brute force, but the keys themselves are only protected by the passphrase used to start the Pretty Good Privacy program, similar to a password used to log on to a network. If agents can obtain that passphrase while typed into a computer by its owner, they can obtain the suspect's encryption key—similar to obtaining a key to a lock box which contains a piece of paper that includes the combination for a safe.

David Sobel, attorney for the Electronic Privacy Information Center and outspoken critic of Carnivore, did not outright reject the notion of a Magic Lantern-style project, but raised several cautions.


"This is breaking new ground for law enforcement, to be planting viruses on target computers," Sobel said. "It raises a new set of issues that neither Congress nor the courts have ever dealt with."

Stealing encryption keys could be touchy ground for federal investigators, who have always fretted openly about encryption's ability to help criminals and terrorists hide their work. During the Clinton administration, the FBI found itself on the losing side of a lengthy public debate about the federal government's ability to circumvent encryption tools. The most recently rejected involved so-called key escrow—all encryption keys would have been stored by the government for emergency recall.

A spokesperson for Rep. Dick Arme (R-Texas), said he thought Magic Lantern, as described to him by *MSNBC.com*, was considerably more palatable than key escrow.

"Citizens should have ability to keep their files and e-mails safe from bureaucratic prying eyes. But this would only be usable against a limited set of people. It's not as troubling as saying the government should have all the keys," said the Arme spokesperson. He also said Magic Lantern didn't raise the same *Fourth Amendment* concerns regarding search and seizure as Carnivore, because Magic Lantern apparently targets one suspect at a time. Arme, an outspoken Carnivore critic, has complained about the potential for the FBI's Internet sniffing software to capture too much data as packets fly by headed for a suspect—known in the legal world as an "overly broad" search.

Sobel was concerned that the keylogging software itself could result in overly broad searches, since it would be possible to observe every keystroke entered by a suspect, even if a court order specified a search only for encryption keys. Developers in the Scarfo case went to some trouble to limit the data stored by the keylogging software installed on Scarfo's computer, shutting the system on and off in an attempt to comply with the court order, according to Murch's affidavit. But given the confusion surrounding keylogging and encryption, and the mystery surrounding projects like Carnivore, Sobel said he's worried about the bureau's use of software that hasn't been clearly explained to the public or the Congress.

"It is a matter of what protections are in place. At this point, the best documented case is Scarfo, and that raises concerns," he said. "The federal magistrate who approved the technology in Scarfo had no understanding of what this thing was. I hope there can be meaningful oversight (for Magic Lantern)."

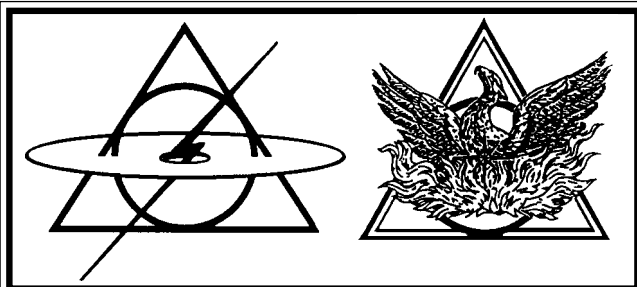
