

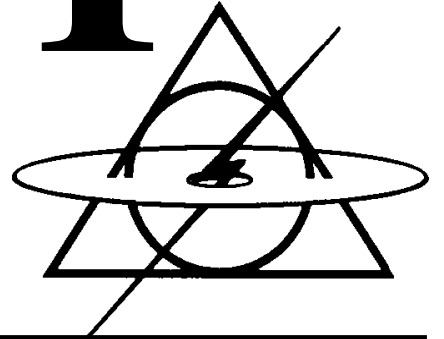

## PART 7

### CONTINUING WITH INTELLIGENCE OPERATIONS

(Question in point: Why wasn’t ELINT (Electronic Signals Intelligence) able to provide information about the terrorist group that carried out the bombing of the World Trade Center?)

The question becomes of greater relevancy when we study the role of the ever-expanding NSA which has ballooned into a city within a city in Washington, D.C. The National Security Agency’s COMINT covers signals which are intercepted and include foreign communications. All messages sent by wire, teletype, telex, e-mail, faxes, radio and all encrypted messages, no matter how transmitted, are processed. Interception covers intercept and direction finding, search, estimation, transmitter operator identification, signals analyses, cryptanalysis, decryption, study of “plaintext” and reporting results.

This means that the NSA is technically capable of listening in on your phone call to your husband or wife at his office or home, or in his car if a cell phone is used, or even telling the time as you stand in a parking lot or on some street corner. The NSA intercepts every transatlantic and national long distance call ad infinitum, all in the name of “national security”

and in violation of the *U.S. Constitution* and the *Bill of Rights* and “safeguards” be damned. ELINT covers the collection, observation and recording and processing of information obtained from foreign non-communications, electromagnetic radiation emanating from every source except an atomic explosion.

So, WHAT WENT WRONG? How can it have been possible for the terrorists to have done their plotting and planning without being detected?

So sophisticated is the NSA that it developed the codes used by the President to identify himself before an order for a nuclear strike can be carried out. NSA also secures data and voice transmission links to Defense Department Satellite Communications Systems (DSCS). NSA created communication codes for more than twenty-two government agencies, including the State Department and the FBI.

NSA’s SIGINT goes far beyond code making and breaking. It gathers foreign military, economic and political intelligence from all over the world, including Russia and all Middle East countries. Pakistan, in particular suffers “saturation coverage”. NSA was able to intercept many a conversation between Communist leaders riding in their cars in Moscow where they thought they were safe in the good old days of the “Cold War”. NSA can and does intercept both private and commercial messages transmitted via satellite as well as by microwave telephone. You can believe me when I tell you that nothing is private, there is no longer any such thing. The right to privacy guaranteed by the *Constitution* is flouted thousands of times daily, and yet, in the wake of the September 11th terrorist attack, we have Congress and security agencies clamoring for more and more powers to expand snooping capabilities.

Given the fact that we already have all that we need and a great deal more, we must repeat the question: WHAT WENT WRONG? Here are some more facts that should add urgency to the question. NSA is capable of monitoring electronic radar signals, known as RADINT, signals from aircraft. Beginning in 1975, NSA monitored all cables leaving the U.S. by RCA Global and ITT networks. The operation was codenamed Shamrock; and no President knew of its existence for at least a decade.

The CIA is relatively well known as are its activities, but you might not know that it has an arm called Research and Analysis located in the State Department, probably to keep an eye out for “suspicious” passport applications. This is a fact known to only a few “insiders”. No doubt the purveyors of “intelligence” newsletters and books (who are avid readers of all of my material) will now seize upon it to copy and promote their non-existent qualifications. Perhaps, a summary of the CIA’s mandate would be useful:

#### CIA MANDATE

Advise NSA in matters concerning national security involving government departments.

Make recommendations to the National Security Council to coordinate intelligence roles of government departments and agencies.

Correlate and evaluate intelligence relating to national security matters.

Provide additional information to the National Security Council on matters of National Security.

To carry out duties and functions related to intelligence as directed by the National Security Council.

With such a vast array of intelligence capabilities at

its disposal, one would imagine that the United States must be very secure, but the terrible events of September 11, have shaken that image and perception of our “security”. The terrorists who struck at us did not have the capabilities of Russia, which we are led to believe—quite falsely as it happens—is a spent force, or is it possible that some major power did “switch off” our electronic surveillance systems?

**[H: The man does have a good point in his last statement. Yes indeed, there are ways of shutting down all electronic apparatus and that is the biggest FEAR of extraterrestrials that exists, for yes, we CAN shut down the entire global systems—at the same time—and nothing works. That means NOTHING WORKS.]**

#### THINGS OF SCIENCE FICTION

What the Russians developed in 1932, the United States dismissed as “science fiction”. It is a fixed and orbital system of extremely low frequency (ELF) radiation stations on the ground in Russia, and on platforms in space. In August of 1986, when the U.S. was making threatening noises against Moscow, Chief of Staff General Akhromeyer hinted at the existence of the system when he said: “The Soviet Union will quickly use a response of which the U.S.A. has no inkling as yet.”

There was not the slightest doubt that Akhromeyer was referring to the Tesla Scalar ELF System installed in Russia in 1935 when the U.S. was ridiculing the system as “science fiction”.

The Office of Naval Intelligence (ONI) is the most complex and the largest of all our intelligence and security agencies. It is assigned a substantial intelligence role. The Director of Naval Intelligence (DNI) is supervised by the ONI. Under the DNI there are many divisions such as the Plans, Policy and Estimates Division, the Special Projects Division, the Security of Military Information Division and Systems Architecture Division. The man who spied for Israel, Jonathon Jay Pollard worked in the Anti-Terror Alert Center of the ONI.

We ask the question: How could it have been possible for the terrorists who brought down the World Trade Towers to have operated under the very nose of ONI’s Anti-Terror Alert Center?

**[H: We know the answer don’t we? It was PLANNED that way!]**

What we do know is that Pollard was able to pass some of the ONI’s most secret Anti-Terrorist Alert intelligence material to the Israelis before he was caught. We do not know if any of this most vital information passed into the hands of any of the terrorists through an inadvertent act by the Israelis, or, whether, as in the case of Pollard, there might have been a person with loyalties to any of the Arab or Muslim nations working in the ONI. ## PART 6

### INTELLIGENCE OPERATIONS

The United States is still not at war as of October 15 as we go to print, and President Bush is not the commander in chief because the Congress has not declared war and has not yet conferred the title upon him, although the United States is committing justifiable acts of war against Afghanistan and the President is acting as if he were the commander in chief. Therefore it follows that the military acts being carried out in Afghanistan are unconstitutional, no matter that they appear to be acts of retaliation for what was done to the United States on September 11th.

It might take a long time to get to the truth, but for the present, and, we suspect, for decades to come, the American people will seek but not find enlightenment.

All we can do is make mention of our security and intelligence agencies and ponder, along with everybody else, just how the terrorists managed to slip through our massive safety-net of five major agencies not to mention the most modern snooping

gadgetry the world has ever known. Today, we cannot make a private phone call without the CIA and MI-6 listening in on our conversation from their massive, jointly-run Menwith Hill facility.

**[H: Right, and therefore, you have to understand that it was NOT a slip-up but an incident well utilized for reasons of massive importance.]**

Our question is this? How could such a massive and well-orchestrated attack on the World Trade Center have taken place before it could be detected? What happened to the security agencies that are paid huge sums of money to interdict such attacks before they happen?

There are five such agencies:

The Office of Naval Intelligence (ONI)

The Defense Intelligence Agency (DIA)

The Central Intelligence Agency (CIA)

The Federal Bureau of Investigation (FBI)

The National Security Agency (NSA)

**[H: And right now the news tells you of the hookup with the Mossad and Israel's intelligence/military program by the fact that the U.S.A. 100% supports Israel while Israel is putting up a space satellite for more intelligence gathering—as we write.]**

These agencies employ in excess of 200,000 people and have a total budget of \$25 billion. So how can it be explained that the movements and plans of the terrorists were not known to any of them?

In addition there is the ultra-secret National Reconnaissance Office (NRO), a shadowy multibillion dollar agency which was not known until I gave full details in my work *Metaphysics, Mind Control, ELF Transmissions and Weather Modifications* published in 1982 as one of my many "First" intelligence reports numbering 400. "ELF" was published some 18 years before "HAARP".

Before going any further I believe it is necessary to give an overview of what is meant by "intelligence". This is a word frequently bandied about by people who have little understanding of what comprises "intelligence". Such persons (and their numbers are growing) may be compared with those who make liberal use of the word "scientific" to bolster up their standpoint. Like "intelligence", the word "scientific" or "scientifically proven" is enough to sell any product, any publication, even the most useless product or publication.

U.S. intelligence agencies and security agencies are involved in intelligence collecting and analyses of all types of "signals", covert actions (offensive and defensive) through all of the extensive means available to them, including reconnaissance satellites, ships at sea, intercept stations such as those at Cheltenham GCHQ, Cyprus, Diego Suarez, Pine Gap, Simonstown, Flyingdales and Menwith Hill. In addition, most of the bigger embassies abroad are equipped with specialized listening devices and staffed by intelligence officers from the different services, generally operating under the guise of "commercial attaches" or something of that nature.

Our intelligence agencies maintain and operate an extensive system of radar stations, underground and underwater surveillance systems, as well as the more traditional covert clandestine operatives known as "people sources". Such operatives may not even be classified as "intelligence" operatives, where for instance they work in departments such as Intelligence and Research (INR) for example.

**[H: And don't be put off by some number such as \$25 billion, for that doesn't even begin to**

**tip the edge of the Black Ops, etc., which are virtually UNLIMITED. Remember that you only have PRINTED paper for money and wire transfers which have no value base AT ALL—just whatever value the Big Boys dump on you.]**

Budgets are secret, but occasionally get leaked, though it could bring reprisals if the source of the leak becomes known. My information is that intelligence budgets have risen from \$16 billion in 1989 to \$25 billion (last year's figure). These figures will give an idea of just how massive and all-pervading the spying and snooping business has become. I was advised about the NRO when an unknown person "failed to remove its name from a list of secret agencies whose budgets should be made public". There should be no "secret agencies" not known to the people. We are an open society, a confederated Republic. It makes me shudder to think just how many "secret agencies" there are that we, the people are paying for and do not know about. It is wrong and it is the way an Empire or a dictatorship is run and there are hundreds of other violations by Congress to prove it.

The terrible tragedy of September 11th, 2001 spawned outcries of rage from all over the world, and well it should. It also led to a flurry of activity by the House and Senate for more and more legislation that will damage the *Constitution* far more than it already is damaged and that is something we, the people cannot and must not tolerate.

In monitoring "news" broadcasts I heard some of the most ridiculous statements by talking heads and government officials I have ever heard, wrong and very dangerous for the welfare of our republic. To my astonishment I heard the attorney general joining the clamor. The problem from my perspective is that we do not need any more unconstitutional powers, what is needed is that we utilize the enormous number of such agencies in the manner they were set up to do.

In 1941 (seventy years ago) [H: Well, 60 anyway.] the ONI was sophisticated enough to break Japan's "Purple" code and intercept its "Magic" messages. How then did it come about that given the tremendous advance in technology since then, the terrorists were able to carry out their dastardly deed before we could detect their presence and intentions? Quoting from my work, *The Coming Disasters*, published at the end of 1999:

"The National Security Agency says it won't rest until it has the ability to monitor every telephone call made in the United States as well as overseas calls. (In fact it already has this capability.) The NSA has the means of decoding encrypted e-mail...

"... The FBI... with its 'Cryptographic and Electronic Analysis Unit' and a new department called 'The Technical Support Center (TSC)' can fully monitor all electronic communications, which mean computers, faxes, e-mail and phones. The FBI has now enlarged its Computer Analyses Response Team (CART). But the FBI pales into insignificance, when compared to the DIA with a staff of thousands working in its encryption division...

"In 1945 when the House opened its enquiry into the failure of intelligence agencies to warn Admiral Kimmel that an attack on Pearl Harbor was only a few days away, Admiral Theobald, who was aware that President Roosevelt was in possession of an explicit warning which gave indications that an attack was to come around December 6, 1941 and yet kept the information from his commanders at Pearl Harbor, said: "I know these people. They are fine, dedicated men. One or two

of them might have slipped up, but not all of them."

In echoing those sentiments, I believe there are many fine, dedicated and loyal members of our security services, and with this in mind, it is difficult to believe that "all of them slipped up". Before rushing the nation to war, it is the most urgent and solemn duty of the Congress to open an immediate inquiry and leave no stone unturned to get at "what went wrong". Scores of people who called me after September 11, without exception expressed grave doubts that all is not as it seems. Experienced ex-intelligence friends I consulted felt the same way: They could not account for how an apparently inexperienced group of terrorists, using regular channels of communications, were able to accomplish what they did.

It is necessary for you to know just how vast are the resources and capabilities of the agencies who protect our national security. The general public is, I believe, unaware of just how big these agencies are and what sophisticated devices they have at their disposal, so when looking at the shocking events of September 11, we need also to look at the agencies I listed at the beginning of this work.

#### A SENATE SLIP

Among our intelligence and security agencies is found the Top Secret National Reconnaissance Office (NRO). Before this message very few of you will have heard of the NRO (and that includes "Truthseekers" man from England), but don't worry, you are in good company. The NRO was established on August 25, 1960 and kept secret from government and the people for 13 years. Its existence was revealed through failure to remove its name from a list of intelligence agencies whose budgets the Senate wanted to make known to taxpayers.

That particular Senate committee is known as the "Special Senate Committee on Secret and Confidential Documents". The NRO is still a secret organization with little or no reference to it in any government publications and it is almost never talked about in what passes for "news" on television. The Annual Report of the Department of Defense (DoD) has made obscure reference to the NRO in one or two of its reports, but as far as I am aware, neither the President nor the Congress has ever mentioned its existence, except on one occasion.

**[H: "They" have a whole bunch of problems keeping my records secure as well, so we must be in very good company of top-secret secured files. Isn't it silly? Well, whatever works for them.]**

The Murphy Commission once referred to the NRO, not by name but as a semi-autonomous office within the Defense Department "with the largest budget of any intelligence agency operating overhead reconnaissance programs for the entire intelligence community". The commission did not give an address for the NRO, only that it was located in the Pentagon. The NRO is responsible for operating and managing the entire satellite reconnaissance program, working closely with the CIA's Directorate of Science and Technology and its SIGINT operations, which gives it vast intelligence and monitoring capabilities that are difficult to visualize.

Included in the NRO's "fleet" of satellites are Rhyolite, K-series and White Cloud satellites, the latter an ocean surveillance system working with the Naval Electronics Systems Command (NAVALEX). The Navy's NSA department worked on and developed

Microwave Space and Mobile Systems patterned on what Russia has had in place for the past 35 years or more. All of the aforementioned intelligence agencies, including the CIA's Directorate of Science and Technology are subordinate to the NRO, which will give you a good idea of its importance. NRO's main function is to gather satellite strategic reconnaissance data for use by all national security agencies.

**[H: Ah-hummmn—go back and read what Israel is launching and you may have more respect for the capabilities in their hands.]**

The second most important intelligence agency is the National Security Agency and a truly secretive agency. The NSA followed after the Armed Forces Security Agency (AFSA) on October 24, 1952 when the NSA was brought into existence by President Truman through a Top Secret memorandum to the Secretaries of Defense and the State Department, which at the same time abolished the NSA. (They probably abolished the AFSA.)

Before giving further explanations I want to emphasize most strongly that the actions of President Truman were unconstitutional and as such, should never have been allowed to become effective. We have an open government and Congress which is supposed to make all laws, not the President acting as if he is the head of some secret society allowed to do much as he likes. This kind of attitude, which has become commonplace since Truman, is a dire threat to the *Constitution* and the *Bill of Rights* and if not checked, the *Constitution* will go the way of the *Magna Carta* in a very short time, and become a museum piece. The tragic events of September 11 are giving some out-of-control members of the Congress grist for the mill to scrap the *Constitution* altogether.

The NSA is responsible for SIGINT operations which take in Communications Intelligence (COMINT) and Electronic Signals Intelligence (ELINT). The latter is used extensively to monitor domestic phone calls, telex and fax messages, Internet communications and e-mails, computer communications, through "Tempest" signals, all in violent, flagrant violation of the *U.S. Constitution* and the *Bill of Rights*, notwithstanding the so-called "constitutional protection devices" which are supposed to ensure that only selected people are monitored. It is nonsensical to suppose that these so-called "safeguards" are effective against abuse, because experience has shown that they are no more than smoke screens to abuse the right to privacy guaranteed by the *Constitution* and the *Bill of Rights*.

The latest addition to the already massive eavesdropping capability came through a joint effort between the British and American governments to snoop on their citizens, only they did not call what came out of it a greater ability to snoop on their citizens, through a joint CIA-MI-6 operations at Menwith Hill, in England. I want to be perfectly clear about this: There is no doubt that there is a need to monitor genuine cases where crime or national security is being threatened, but it should only be those communications directly related to crime and threats to our public safety, and not the current willy-nilly system we now have in place. Given the existing all-pervading, massive, snooping systems we already have in place, how is it possible that our intelligence agencies were not able to monitor the activities of the terrorists who struck on September 11, long before they could put their plan into operation?

This is what is troubling to a large number of people and it needs to be addressed, otherwise we have to presume that we have been wasting billions of dollars



each and every year. This was a relatively simple group to monitor. The United States has achieved success against far more difficult groups and I don't need to provide details again, as they are part of history. It was ELINT that provided the information that trapped Ariel Sharon and Alexander Haig when they were conspiring to invade Lebanon. ELINT discovered the scurrilous activities of Haig while he was busy betraying Argentina in the period that led up to the Malvinas [Falklands] War.

ELINT currently supplies Israel with all information about HAMAS and Hezbollah. If you were taken in by news reports of the "brilliance" of Israeli intelligence which pinpointed those responsible for planning terrorist attacks on Israel, you now know that thanks to ELINT, the Israelis were able to listen in on telephone calls, faxes, and face-to-face conversations held in secrecy, even to intercepting conversations going on in moving automobiles. Israeli intelligence listened to the conversation of Arafat and his staff as well as those of foreign diplomats etc. It was this capability, thanks to the United States, that enabled Israel to take counter measures; usually assassinations of persons they felt were engaged in plotting against Israel.

This begs the question which I am going to repeat many times before the end of this work: Why wasn't ELINT able to provide information about the terrorist group that carried out the bombing of the World Trade Center? WHAT WENT WRONG? If ELINT can supply the Israelis with accurate information, under very difficult circumstances, how is it possible that ELINT experienced such a massive failure here at home at such a crucial time? Was there a complete breakdown of the operating systems, or WHAT WENT WRONG? We need to know what happened and why, before we get stampeded into a war, a war unsanctioned by the *U.S. Constitution* and therefore a war like the illegal Gulf War, and our unsanctioned war against Serbia.

#### ISRAEL DEFENSE FORCES TARGETING CHILDREN?

*The intentional killing of innocent children is considered terrorism everywhere in the world—except Gaza—where Israeli soldiers “shoot them for sport”.*

A remote-controlled bomb, which had been hidden under a bush in a tomato field along a path used by students every day, exploded and killed five young boys in the Gaza refugee camp of Khan Yunis on Nov. 22. The five children, two pairs of brothers and a cousin, were killed as they walked to school.

At first, Israeli officials claimed one of the children had kicked an Israeli tank shell that had been fired by the army days earlier, but failed to detonate. The force of the blast was so powerful that initial reports said four children had died because so little remains were found of the bodies. The explosion blew a crater into the ground and sent shards of clothing and books hundreds of feet.

After denying responsibility for the bombing, Israeli officials finally conceded that an elite undercover unit had recently infiltrated the area, which is under Palestinian control, and planted a bomb along a dirt path they claim is used by militants to attack two nearby Jewish communities.

Palestinian hospital officials at first said four boys had been killed but later reported finding a fifth body among the charred and mangled remains. They named the five as: Muhammad Naim ao-Astal, 14, Amr al-Astal, 13, Anis Idris al-Astal, 12, Muhammad Sultan al-Astal, 12, and Akram al-Astal, 6. **[H: Boy, it must have been fun blowing up that six-year-old.]**

Their remains, collected from a wide area, were wrapped in Palestinian flags and carried through the streets of Khan Yunis in a procession of more than 2,000 people.

“These were five kids who had nothing to do with politics,” said one mourner, Khalid al Saka, 30. “It’s a massacre. People are really angry here.”

After the funeral, Palestinians threw rocks at Israeli soldiers. The soldiers responded with live fire, killing a teenager and wounding six others. The army denied the shooting, saying that an explosion observed within the crowd may have caused the death and the injuries.

Because placing a remote-control bomb near a school would usually be condemned as an act of terror,

AFP called the Department of State to inquire how this incident was viewed in light of the “war on terrorism”.

Spokesman Greg Sullivan said the U.S. government was awaiting the outcome of an Israeli military investigation. **[H: Oh good, the old “Fox-henhouse” routine.]**

AFP asked if the United States would have reacted differently had the act been perpetrated by Palestinians and five Israeli children had been killed in Tel Aviv, or if the Irish Republican Army had killed Protestant school children in Belfast.

Sullivan said it was “an issue of intent”. If an action is taken “seeking to inflict civilian casualties,” Sullivan said, “that’s terrorism.”

AFP asked Mark Regev, spokesman for the Embassy of Israel, if he would consider a similar incident “terrorism” if Palestinians had planted a bomb near an Israeli school. Regev said that the killing of children was unintentional.

When asked about the intention of soldiers who fire live ammunition at Palestinian children or Israelis targeting refugees with artillery or missiles, Regev said war is “dirty business”.

Chris Hedges of the *New York Times* says the killing of children by the Israeli army in Khan Yunis is intentional and a DAILY occurrence.

Hedges said he witnessed Israeli soldiers taunt the children “every day” and “shoot them for sport”.

Khan Yunis is a refugee camp surrounded on three sides by electric fences and armed Israeli troops. It is in the southern tip of the Gaza Strip along the Egyptian border. Very few outsiders ever enter the Gaza Strip; fewer visit Khan Yunis.

Twenty percent of the land of the Gaza Strip is occupied by 6,000 Israeli settlers—one-half of 1 percent of the strip’s population—while 99.5 percent, or 1.1 million Palestinian refugees, are crammed into the remaining 80 percent.

Hedges recently described on National Public Radio’s *Fresh Air* program a scene he had observed every afternoon.

Hedges said soldiers in an armor-plated Israeli jeep with a megaphone would taunt the children flying kites and playing ball on the dunes inside the electric fence with “the worst curse words in Arabic” and calling Palestinians “dogs”, an extremely offensive insult to Arabs. When the children, who are mostly between 10 and 12, Hedges said, throw stones in response, the soldiers open fire hitting “four or five kids every day”.

#### 2 JEWISH MILITANTS CHARGED IN LA (LOS ANGELES) MOSQUE BOMB PLOT

LOS ANGELES, California (*AFP*)—Two leaders of a Jewish militant group were Wednesday charged with plotting to bomb a series of Muslim targets in Los Angeles, including a mosque and the office of an Arab-American congressman.

The plot was thwarted when the chairman of the Jewish Defense league (JDL) Irv Rubin, 56, and fellow JDL leader Earl Krugel were arrested late Tuesday in an anti-terrorism raid after an informant alerted investigators to the scheme.

The two were allegedly planning to blow up the King Fahd mosque in the Culver City area, the offices of Arab-American Congressman Darrell Issa and the Muslim Public Affairs Council (MPAC) in Los Angeles, he said.

“The bombing plot developed to the point that explosive powder was delivered to Krugel's house last night,” U.S. attorney John Gordon told a press conference.

“At the time the powder was delivered Krugel had in his house the remaining components needed to make the bomb.”

Bomb-making equipment, including lengths of pipe and explosive powder, and a number of guns were confiscated from 59-year-old Krugel's home in the federal anti-terror swoop.

Rubin and Krugel were charged with one count each of conspiring to destroy a building with explosives and another of possessing a destructive device in connection to a violent crime. The crimes carry a mandatory 30-year jail term.

They were being detained in Los Angeles and were due to make an initial court appearance Wednesday.

The men had wanted to send a “wake-up call” to Arabs and to show that the JDL was “alive in a militant way,” FBI Assistant Director Ronald Iden said, adding that the plot was a “planned violent act of hatred”. **[H: Not to even mention: AGAINST THE LAW ALREADY ON THE BOOKS.]**

While an Israeli real estate magnate from Australia insured his 99-year lease on the retail space of the World Trade Center against terrorism, one of Israel's biggest companies PULLED OUT OF THE NORTH TOWER JUST DAYS BEFORE SEPT. 11.

*AFP* has learned from a reliable source in the shipping industry that Zim American Israeli Shipping Co., Inc. broke the lease when it vacated the rented offices on the 16th and 17th floors of the north tower of the World Trade Center shortly before the Sept. 11 disaster.

According to the source, Zim's WTC office space had been leased until the end of the year and the company lost \$50,000 when it suddenly pulled out in the beginning of September.

The parent company, Zim Israel Navigation Co., IS NEARLY HALF-OWNED BY THE STATE OF ISRAEL, THE OTHER HALF HELD BY ISRAEL CORP. Zim is one of the world's largest container shipping companies, operating an international network of shipping lines.

*AFP* repeatedly contacted Zim American Israeli Shipping Co., Inc. at its new American headquarters in Norfolk Va., to inquire about the company's pulling out of its WTC lease early.

*AFP* was told that the only person who could discuss the matter was the company president, Shaul Cohen-Mintz, who was said to be unavailable until Dec. 4.

*AFP* also contacted the Port authority of New York and New Jersey, the original owner of the World Trade Center, and was told to contact Silverstein Properties, owner of the World Trade Center since July 24.

**[H: Read that again, viewers, for it appears to me that Mr. Silverstein, who makes all the picture news, was a NEW OWNER, only since basically the end of July (24th) to the downing of the towers on Sept. 11. Silverstein passes all media-related questions to the public relations company of Howard J. Rubenstein, which also represents the state of Israel.

Steve Solomon of Rubenstein told *AFP* that the company “had no information on the leases” and advised *AFP* to contact the tenant directly.

Calls to Ezra Bentob of Zim’s legal department were not returned.

An Israeli businessman from Australia, Frank Lowy, had recently acquired a 99-year lease for the 425,000-square-foot retail portion of World Trade Center before the WTC attacks of Sept. 11, reported *The Jerusalem Post* on Sept. 12. **[H: Well, Mr. Lowy is Jewish so that presentation is reasonable.]**

Lowy is chairman and founder of Westfield Holdings, and the manager of Westfield America Trust, which has a 57 percent stake in Westfield America Inc. In April 2001, Westfield America agreed to pay \$400 million for the lease on the complex though only \$133 million was paid; the rest was to be made in ground lease payments.

Lowy is the second wealthiest man in Australia and was recently ranked as the 209th wealthiest man in the world by *Forbes* magazine. Westfield is the fourth-largest shopping mall owner, with operations in Australia, the United States, the United Kingdom and New Zealand.

Westfield was insured against terrorist attacks and its earnings will not be materially affected.

In a statement to the Australian Stock Exchange the retail chain said that “investment in the retail component of the World Trade Center is fully insured for both capital and loss of income,” adding “the insurance coverage includes acts of terrorism.” **[H: I’m sure that comes as no surprise.]** **[MM: To subscribe to AMERICAN FREE PRESS, call 1-888-699-NEWS (6397) toll free.]**

The Blacks will lose a generation of young leaders and THE PLANNERS will be safe for a little while longer.

At the rate of growth within the races, by the year 2000 there will be more Blacks than Whites. Add unto that number the other “minorities” and the Whites who have corrupted a civilization shall be in grave trouble.

Oh yes, there is a system of destruction planned for you sleepy little masses. A good solid nuclear strike will take most of you troublemakers out because you have no protection. Oh, you won’t have your military troops around to defend you—they have no protection, either. THE POLICE FORCE WILL COME FROM THE SATANIC FORCES ALREADY ENTRENCHED IN THE OLD WORLD—WITH THE HELP OF THE SATANIC “LEADERS” IN YOUR NEW WORLD.

Can you of the U.S. actually accept the deaths of thousands in Panama, because one Marine was killed in an altercation and a Marine’s wife was insulted? It is because you live in the midst of evil until you as a sweet little person in Timbuktu have become as evil. You are uninformed and are kept that way. You are more interested in your day-time soap story and sport games than watching your non-news. You have even been told that to relieve “stress”—“don’t watch the newscasts”. You have not only sanctioned, but participate in, the evil game of “getting to the top”. You have done it to yourselves. The White supremacists say, “Why don’t all of you who are not White, go back to where you came from?” And the Red man says, “Why don’t ALL of you go back to where you came from?” And so it goes. IF YOU ARE TO PREVAIL THROUGH THESE TIMES OF EARTH CHANGE AND ENDING CYCLES, YOU WILL TAKE YOUR BROTHER’S HAND, YOU WILL ALL BECOME TOTALLY COLOR-BLIND AND YOU WILL UNITE AS ONE—OR YOU WILL PERISH AS INDIVIDUALS DIVIDED AGAINST YOURSELVES.

Scribe, let us write the myth words upon the paper that you might have clarity. Those of *John* shall be fine: “Now I was given a measuring stick and told to go and measure the temple of God, including the inner court where the altar stands, and to count the number of worshipers. ‘But do not measure the outer court,’ I was told, ‘for it has been turned over to the nations. They will trample the Holy City for forty-two months. And I will give power to my two witnesses to prophesy



1,260 days clothed in sackcloth.” Looks like three-and-a-half years to me, or thereabouts.

“When they complete the three-and-a-half years of their solemn testimony, the tyrant who comes out of the bottomless pit will declare war against them and conquer and kill them; and for three-and-a-half days their bodies will be exposed in the streets of Jerusalem—the very place where the Lord was crucified.” Well, that is more difficult, for the Lord has been crucified in all places of your planet.

“No one will be allowed to bury them, and people from many nations will crowd around to gaze at them. And there will be a worldwide holiday—people everywhere will rejoice and give presents to each other and throw parties to celebrate the death of the two prophets who had tormented them so much.” You ones do enjoy your celebrations and parties and as usual, you will not even know or understand that which is going on about you. Just as those blessed ones in Romania have only spilled their blood to do that which the Soviets from Moscow could not do for themselves—replaced the mavericks with the acceptable (to Moscow) new rulers and call it “democracy—comrades”.

“But after three-and-a-half days, the spirit of life from God will enter them and they will stand up! And great fear will fall on everyone. Then a loud voice will shout from heaven, ‘Come up!’ And they will rise to heaven in a cloud as their enemies watch.” Now, does that say that Holy God is fetching them? No, it simply says that some wondrous thing happens that snatches them into some sort of craft or something. Well, don’t hold your breath to find out—because the next verses tell you some interesting follow-ons.

“The same hour there will be a terrible earthquake that levels a tenth of the city, leaving 7,000 dead. Then everyone left will, in their terror, give glory to the God of heaven.” You don’t really think at this point that old Satan himself is just whoofed away, do you? You ones will be running about in confusion trying to get the New World Order FEMA to do something for you as well as complaining about the New Order insurance companies and where is the New Order Red Cross with the cookies and coffee.

DO NOT COUNT YOUR RIGHTEOUS CHICKS BEFORE THEY HATCH—LEST YOU BE LEFT WITH AN EMPTY EGG SHELL. OH NO—AND YOU THOUGHT LIFT-OFF NUMBER ONE WAS PERMANENT? SO BE IT—FOR SOME. YOU CLAIMED TO BE GOD’S CHILDREN—ARE YOU REALLY? WHAT WILL YOU DO WHEN THE CHIPS ARE DOWN AND THE VISION BLURRED AND PERCEPTIONS ALTERED BY THE MIRACLES OF THE DEVIL? HE WILL DO THAT, YOU KNOW, AND I GUARANTEE A VERY PRECIPITOUS JOLT RIGHT BACK INTO THE FRAY. YOU THOUGHT ALL THE SORTING WOULD BE DONE ON THE SURFACE CRAFT, DIDN’T YOU? NO, YOU ARE GIVEN ANOTHER CONFRONTATION AND CHOICES AFTER LIFT-OFF—GO BACK AND READ *SIPAPU ODYSSEY*.

“And when the Dragon found himself cast down to Earth he persecuted the woman who had given birth to the child. But she was given two wings like those of a great eagle, to fly into the wilderness to the place prepared for her, where she was cared for and protected from the Serpent, the Dragon, for three-and-a-half years.” Looks like another 3-and-a-half years to me; let’s see now,  $3 + 3 + 3 = 10$  years. Could that possibly be? Are you ready for the year 2000? Well, don’t worry about it—sleep on, for perhaps this is not what *Revelation* meant at all. Could it be that the

worst was only about to happen? So be it.

And all mankind—whose names were not written down before the founding of the world in the slain Lamb’s Book of Life—worshipped the evil Creature.” Could this be THE PLAN 2000 in action?

Anyone who can hear, listen carefully. “The people of God who are destined for prison will be arrested and taken away; those destined for death will be killed. But do not be dismayed, for here is your opportunity for endurance and confidence.” Now that is a mouthful to which you should pay great attention.

“Then I saw another strange animal, this one coming up out of the Earth, with two little horns like those of a lamb but a fearsome voice like the Dragon’s.

He did unbelievable miracles such as making fire flame down to Earth from the skies while everyone was watching. By doing these miracles, he was deceiving people everywhere. Let us later speak of the death of the prostitute who was the world betrayed and speak of the new—the rebirth into purity and radiance and with her, her creations. Death of the physical is hard and brings pain—but it must come to be if freedom is to be found. Peace be unto you, chelas. Your way is under pressure at this transition but you ones shall be given that which you need to fulfill your mission. So be it and I place my benediction upon you faithful and true. Truth covered for eons by lies is always shocking, chela. Further, if the truth comes out of proper sequence, it is neither accepted nor believed. The time is at hand to speak of these things. You are chosen to pen it, for it is elsewhere blocked in darkness. You will learn contentment in the perceived isolation, for as we pen the *Journals*, each will be more accepted than the prior and your soul shall have that truth as food. Until we move a bit further you must accept the protection, for thy task is heavy through this journey, as are the lives of those sent forth to participate.

There are many ones doing their work and in the end it shall be blended and you will all have understanding of the requirements and methods, the sequences and the restrictions upon your lives and time. When we turn the lies of history into the "rewritten" truth of history, it sends shock waves throughout the universe. **Man longs and hungers for truth—and yet dreads the self-discipline that accompanies truth.**

You know that there is no turning back, for the journey is beyond the point which allows returning to beginning—knowledge learned is not "unlearned". So be it—you shall be given that which you need to do of thy work.

There are many "lost" places and cities which shall be coming forth again unto the attention of man. Places from the depths of myths which were truth but long hidden in the passage of experiences. As these great migrations and transitions come full cycle, the way must be prepared for the acceptance of those things which shall come to pass. For just as experience is an illusion, so is it "manifested" illusion and must be "finished" in like manner or the journey cut short in the individual consciousness—which is termed "madness".

I am coming forth as a neutral speaker resource so that the document will be more easily rendered objective unto you, chela. I shall speak as Hatonn, that you ones not be intimidated by my presence as ATON.

Most of this material was brought forth in written, published format through ones who were not sanctioned to bring it forth and will therefore be repeated and corrected where necessary. You will further understand why the separation had to be made between you ones

and others who “appeared” to be thy mentors. So be it, for ye shall rise above those shackles and I shall clear thy mind of the chaff from those encounters. Thy truth is 100% truth and none shall be allowed to deter you by their rampage. Let no human stand against thee or me, for I AM ATON and I hold thee within myself.

You must be given to understand the importance of the one, Sananda who has again been sent and comes forth as a Master Teacher, a survivor of the Elders, the great men who lived on Earth when “giants” roamed the planet.

There is a magnificent collection of artists, saints, scientists, Pharaohs, poets and, and, and—within a special placement for the purpose of now bringing forth the truths of evolvment. There are some who are unknown and many who have survived within your historical myths to be remembered. It is a wondrous “school” if you will consider it as such, and there is great fellowship, for within these ones the race spirit ensouled itself into race leaders of the dim past—these leaders constitute the group that will continue to show you the way through the teachings.

This band of goodly entities are composed of entities who were of human men and women from other worlds, civilizations, and from other places in “time” and “space”. They originally arrived on Earth to assist mankind in its long climb from “beasthood” to “godhood”. WELL, YOU MOST CERTAINLY NEED THESE ONES AGAIN!

These ones migrated to Earth—the “dark star” planet of “sorrows”, as it was known—some eighteen millions of your years past and have continued to work ceaselessly and tirelessly in their gigantic task of acting as the Creator’s mentors to a backward, “fallen” race. They have come into life as the legendary “gods” of the ancients, and later incarnated as rulers of the people. As ancient ones touching forth on your planet in your generation, i.e. SFATH to B.M. in Switzerland—who was actually THOTH of ancient mythology—along with Osiris, Apollo, Mercury, etc. I tell you this up front because it is most alien to your belief system, for the satanic intent has always been to discount the myths into false spirituality. And yes, some will say you blaspheme and are a heretic but the world is ready and starving for truth and it all will fit with the “truth” in that which you call your Holy Books. Further, it is most usual for the “receivers” of this documentation to tamper with it, for the load is a heavy one indeed.

Ones such as Baal, Bacchus, Moloch, and other false gods were nothing but pure Earth deities—and always became the ruling hierarchy in the pantheon of gods after a “Golden Age” had gone out in a blood-bath. Great universal truth was brought to mankind through the instrumentality of beings from more enlightened worlds, and an age where “men talked with the ‘angels’” inevitably followed only to decline and fall in decay when the mentorship was removed. There is nothing “new” in extraterrestrial or angelic presences upon your place—you have just been led once more down the primrose path of lies into total ignorance. You believe lies to be truth which are not even reasonable in thought process. Reason and logic do not seem to influence that which you tend to “believe”.

Examples of such periods would be the eclipse of truth that followed after the death of the great Pharaoh Amunhotep IV (Akhnaton), the first ruler in history to declare his belief in one God; and the veil that was thrown over the Word of the Infinite Father after the Crucifixion on Golgotha, when truth-seeking

mankind was literally thrown to ravening beasts—and clandestine councils handed down edicts which deprived man of God-given knowledge and truth.

The “group of goodly wanderers” who volunteer to come into earthly existence—time and time again, have assisted mankind for thousands of years in all ages. (Feel familiar?) They would declare universal wisdom and truth at a certain period of history when man had been prepared to receive it and then they would withdraw for a time to see what man would do with the new-found knowledge. Thus, the rises and plateau of man’s cultural history emerged.

During a hiatus of universal influx, man was ruled by powerful and aggressive Earth spirits. Examples of such periods would be the decadent rule in the colonies of the “Motherland” after the submergence of Lemuria and Atlantis; the idolatrous period of late dynastic Egypt; the perversion and licentiousness of Rome under the Caesars.

Legends of Earth are rich in knowledge of the “Star People”, also referred to as the “Above People”—the Gods who came from the Sun or descended from Heaven to walk among mortals. Behind these so-called myths, which at first appear to be the imagining and fantasies of superstitious people, you will find a logical answer to why man adored the immortals of Olympus and other fabled abodes of the great gods. You will discover the startling truth behind the tales of the gods of classical mythology and the wondrous spirits of the Ancient Ones.

The ancient scribes and prophets spoke literal truth when they told later generations that angels and gods had taken on mortal flesh—descended from their radiant heavenly homes—to lift the physical, mental and spiritual level of humanity on the “dark star” in the Father’s Cosmic House!

You will also come to know that there are fantastic historical treasures which constitute a great legacy for mankind hidden in secret chambers under some of the wonders of the world! For instance, the “four corners” (and this designates many areas which will become clear in designation at the proper time) of the Earth enclose timeless records that for millennia have been hidden from the eyes of the seeking man. These priceless accounts of the struggles and intrigues of your planet are even now beginning to seep into the light. Knowledge is coming forth but for all truth that comes forth, the negative and dense entities of your natural manifestation shroud them in lies. **Always at these times, well-intentioned but ridiculous “do-gooders” get into the picture and scramble the signals.**

The negative, opposing force which always intends to hold man back and keep him for ever in the dark chains of brutishness and beastliness has been behind the destruction of the great treasure-houses of remote antiquity. Examples would be the destruction of the ATON TABLETS IN AKHNATON’S RECORD SANCTUM BY THE EVIL AMUN PRIESTHOOD AFTER THE GREAT PHARAOH’S ASSASSINATION; the burning of the Alexandrian library by fanatics in A.D. 389, the largest and most famous repository of antiquity, containing over seven hundred thousand volumes, comprising most of the literary treasures of the ancient world, an inestimable loss which brought about the “Dark Ages”; the total destruction of the Aztec libraries, where priceless codices were ravaged with fire and sword by Cortez in A.D. 1519 as he sacrificed untold treasures to greed and they were swallowed up in his incendiarism.

Certain secret orders have always managed to salvage or save universal truth, and on clay tablets, scrolls, papyri and now paper and magnetic discs they recorded the truth, so that future man might know—and in the knowing, the truth would make him free from the bondage of untold ages.

The old records were hidden in tombs, secret chambers, caverns, temple ruins, catacombs, and every secret recess and tunnel was utilized. These records deal with the Most Ancient Wisdom and will be rediscovered in the years immediately ahead. These truths have been secreted away—then discovered, only to be buried again after they served their purpose of revealing that which was to be known during a particular age and time in man’s spiritual development.

The records of which we will speak in this *Journal*, at this time, are placed most securely and safely in the Peruvian mountains and in Guatemala (among the Quetzals) and in Mexico. We will not be particular enough to divulge identities nor exact locations, for it is not yet time for that. The ancient records are well preserved and hidden and for the present, it must remain that way—’tis now only the time of telling the history.

There are some terminologies which will help you attach this information unto other, for example, you must keep in mind that the word “lion” in the positive sense signifies divine truth in power—and that is why the Christ is called “the lion”, etc. The one called “Jesus” Christ was called the “lion of the tribe of Judah”. Further, and most important indeed is the word “Word”. In its original sense, its first definition, means not sound, voice or speech, but rather it means “The Creation”, according to the divine laws, from the universal creative fluid, in the “tomb”, “cave”, or manger of the Earth of that PERFECT ONE, which has the power to spiritualize and regenerate Adamic man. For instance, your *Bible* tells you that “Man does not live by bread alone, but by every Word (Creation) that proceedeth out of the mouth of God”.

#### PREPARATION FOR CREATION (THE WORD)

The WORD was prepared—“In the beginning was the Word, and the Word was with God, and the Word was God”. Therefore, the “WORD”, the Divine Creative Influx was prepared on Earth that man here might receive it in love and understanding. This, that he might ascend to higher spiritual knowledge and wisdom because of this preparation.

An example of meaning would be when the Prophet Daniel saw a winged lion emerge from the sea; he saw the symbolic representation of the Word for a new “age” or “cycle” in which the Divine Truth of the Word sets out to conquer new spiritual territory. It might serve well this day as you ones perceive yourselves.

For a bit more mythology I shall describe some other symbolic examples. Candidates who successfully passed the ancient Mithraic (we will get into this later) initiations were called “lions” and were marked upon their foreheads with the Egyptian cross. Mithras himself, is often pictured as the head of a lion and two pairs of wings. The reference to the “Lion” and the “Grip of the Lion’s Paw” in the Master Mason’s degree have a strong Mithraic tinge and basically originated from that source.

The Sun rising over the back of the lion has always been considered symbolic of power and rulership. The Egyptian priests in many of their ceremonies wore the skins of lions, which were symbols of the great solar orb, owing to the fact that the Sun is exalted, dignified, and most fortunately

placed in the constellation of Leo the Lion. Among the Egyptians the Sun's rays are often shown ending in human hands (ATON). Masons will find a connection between these hands and the well-known "Paw of the Lion" which raises all things to life with its grip.

Yes, of course it becomes distorted—just as you ones might wear a cross about your neck. One must always trace the myth back unto its birth in truth.

I am going into all of this because the sanctuaries of the ancient sacred treasures and truths are often referred to as places of the Lion—or sacred places (Places of the Sacred).

Anciently the corona of the Sun was shown in the form of the mane of a lion which was a reminder of the fact that at one time the summer solstice took place in the sign of Leo, the Celestial Lion. Initiates of the Egyptian Mysteries were sometimes called lions or panthers. The lion was the emissary of the Sun, symbolizing light, truth, and regeneration.

The lion is considered to be king of the animal family, and, like the head of each kingdom, is sacred to the Sun, whose rays are symbolized by the lion's shaggy mane. The allegories perpetuated by the mysteries such as that the one who opens the secret "book" is the lion, just as it is perpetuated that the solar power opens the seed-pods, releasing the spiritual life within.

There was also a curious belief among the ancients that the lion slept with its eyes open and was therefore chosen as the symbol of vigilance. It is truly strange indeed, how myths begin and evolve, for the lion is ever alert but most certainly sleeps with its eyes closed and, in fact, if not endangered itself sleeps as if in a coma. Just as an owl symbolizes wisdom but is a most stupid bird indeed.

Nonetheless, this is the reason for placing the figure of a lion on either side of doors and gateways as an emblem of divine guardianship. Now we get a few more clues—the figure of a lion was most frequently erected over any type of buried or hidden treasure.

Now, do not distract yourselves into other cultures—we are now speaking of ancient Egyptian culture wherein the priests thought the cat symbolic of the magnetic forces of Nature, and they surrounded themselves with the animals for the sake of the astral fire which emanated from their bodies. Such animals were symbols of eternity, for when they sleep they curl up into a ball with their head and tail touching—an endless circle. It is important that you come into understanding as to how some things came to be traditional and legendary to allow the story to come to fruition. Wrong conclusions are drawn from ignorance—always!


Further, the lion symbolizes Secret Wisdom. King Solomon was often symbolized as a lion; to overcome this beast is to become a master of such wisdom. You should further remember that Samson and Hercules both "conquered the lion"—the lion also represents one of the Four Corners of Creation.

Let us have a break, Dharma, before we go further into this dissertation, for it will be a long and often boring unraveling of the facade of the tapestry. History must be laid before the punch line. So be it.

I move to stand-by and I request that you spend time with me in quietness, for this will be a most heavy task indeed.

## SUSPECTED ISRAELI SPIES HELD BY U.S.

WASHINGTON—Some 60 Israelis, who federal investigators have said are part of a long-running effort to spy on American government officials, are among the hundreds of foreigners detained since the Sept. 11 terror attacks, *Fox News* has learned.

The Israelis, a handful of whom are described as active Israeli military or intelligence operatives, have been detained on immigration charges or under the new Patriot Anti-Terrorism Law. Federal investigators said some of them failed polygraph questions inquiring about alleged surveillance activities against and in the United States.

There is no indication the Israelis were involved in the Sept. 11 attacks, but investigators suspect that they may have gathered intelligence about the attacks in advance and not shared it.

A highly placed investigator told *Fox News* there are "ties," but when asked for details flatly refused to describe them. "Evidence linking these Israelis to 9-11 is classified, I cannot tell you about evidence that has been gathered. It is classified information," the source said.

An Israeli Embassy spokesman offered categorical denials, and said any suggestion of Israelis spying on or in the United States is simply not true.

But *Fox News* has learned that one group of Israelis spotted in North Carolina recently is suspected of keeping an apartment in California to spy on a group of Arabs who the U.S. authorities are investigating for links to terrorism.

Numerous classified documents obtained by *Fox News* indicate that even prior to Sept. 11, as many as 140 other Israelis had been detained or arrested in a secretive and sprawling investigation into suspected espionage by Israelis in the United States.

Investigators from numerous government agencies are part of a working group that has been compiling evidence in the case since the mid-1990s. These documents detail hundreds of incidents in cities and towns across the country that investigators say, quote, "may well be an organized intelligence-gathering activity."

Investigators are focusing part of their efforts on Israelis who said they are art students from the University of Jerusalem or Bezalel Academy and repeatedly made contact with U.S. government personnel by saying they wanted to sell cheap art or handiwork.

Documents say they "targeted" and penetrated military bases, the Drug Enforcement Administration, the Federal Bureau of Investigation, dozens of government facilities and even secret offices and unlisted private homes of law enforcement and intelligence personnel.

Another part of the investigation has resulted in the detention and arrest of dozens of Israelis working at kiosks in American malls, where they had been selling toys called "Puzzlecar" and "Zoomcopter".

Investigators suspected a front. Shortly after the *New York Times* and *Washington Post* reported the detentions of Israelis on immigration charges last month, the carts began vanishing.

Why would Israelis spy in and on the United States? A General Accounting Office investigation referred

to Israel as Country A and said, "According to a U.S. intelligence agency, the government of country A conducts the most aggressive espionage operation against the U.S. of any U.S. ally."

A Defense Intelligence report said Israel has a "voracious appetite for information".

"The Israelis are motivated by strong survival instincts which dictate every facet of their political and economic policies," the DIA report said. "It aggressively collects military and industrial technology and the U.S. is a high priority target.

"Israel possesses the resources and technical capability to achieve its collection objectives," the document concludes.

## U.S. TO ADVERTISE REWARDS IN MIDEAST SLAYINGS

WASHINGTON (AP)—The State Department is launching an advertising program offering rewards for information leading to the arrest and conviction of Palestinians who killed Americans in Israel and on the West Bank and in Gaza.

The two-level campaign will use radio and the print media, and also post on the department's Web site the FBI's 22 "most-wanted terrorists".

More than 20 Americans have been killed in terrorist incidents in Israel and the territories. Advertising rewards that a U.S. official said would begin in a few weeks responds to appeals by American Jewish organizations.

Later today, the department was planning to announce it is stepping up efforts to get information about terrorist plots that target Americans or U.S. property worldwide.

Radio and newspaper advertisements will offer up to \$25 million while asking Americans to donate to the "Rewards for Justice Fund". So far, \$8 million in rewards have been paid out.

Secretary of State Colin Powell plans to kick off the campaign with a statement underscoring the U.S. appeal for help in countering terrorism.

The Zionist Organization of America campaigned for three years for the posting of rewards in cases of Palestinian attacks on Americans on the West Bank and in Gaza.

Morton A. Klein, president of the organization, said the State Department already has notified families of victims. "This will dramatically raise public awareness about the fact that Yasser Arafat's regime is harboring terrorists who have murdered Americans."

Palestinian terrorists have murdered more than 80 Americans since the 1960s, the Jewish organization said.

On the diplomatic front, the administration said Wednesday that Palestinian attacks on the West Bank and in Gaza would not derail the mediation mission of U.S. envoy Anthony Zinni.

Zinni has asked Israel and the Palestinians to observe two days of calm to help lower tensions and rebuild trust.

The State Department, meanwhile, focused on Arafat, the Palestinian leader, as the one who should curb the violence.

"We stress it's absolutely imperative that Chairman Arafat and the Palestinian Authority act immediately, undertake all possible measures to pursue and apprehend those responsible for these horrific actions, and ensure that the organizations responsible are unable to commit further terror," spokesman Richard Boucher said.

"We're deeply troubled by the fact that these groups continue to have freedom to conduct their actions," Boucher said.

On a related front, President Bush's national security adviser said terrorist wings of Hezbollah, the guerrilla group that attacks Israel from Lebanon, "is very much responsible for the problems that we are having in places like the Middle East."

Condoleezza Rice, in an interview with the Arab MBS-TV, said "this simply has to be cleared up."

She said the administration had told Lebanon and Syria that "it cannot be the case that you are supportive of the fight against al-Qaida and then go ahead and support terrorist activities of Hezbollah."

**[JR: Besides the U.S. war against terrorism, we are now engaged in the bounty-hunting business. These Jewish Americans made the choice to go to Israel to live in a hostile environment. #### JEWISH MILITANT ARRESTED IN L.A. BOMB PLOT

LOS ANGELES—The chairman of the militant Jewish Defense League and a follower have been arrested in an alleged plot to bomb a major Los Angeles area mosque and the office of a Republican California congressman, among other targets, federal officials said on Wednesday.

JDL Chairman Irv Rubin, 56 and group member Earl Krugel, 59, who were arrested on Tuesday night, were charged with conspiring to bomb the King Fahd Mosque in the Los Angeles suburb of Culver City, the offices of Southern California Congressman Darrell Issa, who is the grandson of Lebanese immigrants and the Muslim Public Affairs Council office in the Mid-Wilshire section of Los Angeles.

"Last night's arrests confirm that we meant what we said: if you cross the line from expressing your political or religious beliefs to committing violent acts against

those whose beliefs are offensive to you, then you will likely end up facing federal prosecution on charges carrying extremely long prison sentences," said John Gordon, U.S. Attorney for California's Central District.

The two men face one count each of conspiring to destroy a building by means of an explosive and possession of a destructive device during and in relation to a violent crime, according to an affidavit filed in the U.S. District Court in Los Angeles. If convicted each could face 35 years in prison.

Officials said the two men plotted with a third, a former JDL member, to make and detonate bombs. The third man, who was approached last October, told authorities of the plot, officials said. No bombs were detonated and no one was injured.

A complaint against the two men said that Krugel told the informant the bombings were necessary because "Arabs need a wake-up call." At that meeting Rubin added that the JDL needs to let people know they are "alive in a militant way."

The complaint added that the unnamed source was asked to photograph the Muslim Public Affairs Council and help purchase bomb components and that Krugel said he would build the bombs at his residence. The source would then place the explosives.

When the source asked Krugel how the bombings might affect human beings, he allegedly said: "C'est la vie," Gordon said.

"The affidavit makes clear their primary motivation was to... terrorize Muslims or Arabs and alert the national if not the local community to JDL's commitment to attack those targets," Gordon said.

The source told officials he was led to believe one bomb was to be placed in the offices of the Muslim Public Affairs Council (MPAC). He arrived at Jerry's Famous Deli in the Los Angeles suburb of Encino with 5 pounds (2.2 kg) of explosive powder in his vehicle ready for delivery to Krugel.

The MPAC, which also has a Washington, D.C. office, describes itself as a public service agency working for the civil rights of American Muslims.

However at the deli meeting the two men said they had changed their targets and bombs were instead to be placed at the Culver City mosque and Issa's office. Gordon said he believed Issa, a Christian American of Lebanese descent, was targeted because he made statements the JDL disagreed with.

There was no specific time frame for when the bombs were to be detonated, however they were expected to be set off "in the near future. Things were fluid," Gordon said.

Issa was not made aware of the plot because authorities only learned of it moments before the arrests, Gordon said.

Because the informant wore a wire when he met the two men, federal agents followed and arrested them a short time later. A search of Krugel's Reseda, California house turned up bomb-making materials including caps, pipes and fuses and a dozen firearms. The bombs were adequate to cause "considerable damage" to the areas where they were to be detonated and possibly death to people in the vicinity, officials said.

Issa, who appeared at a press conference Wednesday flanked by several Jewish congressmen, thanked law enforcement officials for their quick action and said he had "no way of knowing" why he had been a target of the JDL. "Like most Americans, my hope and wish is for a peaceful resolution to the Middle East conflict. Unfortunately, there are extremists

on both sides who oppose a peaceful resolution."

"I describe myself as an American," he said, when asked about his ethnic background. "I'm an American, somebody who served in the military both as an enlisted man and as an officer, who does have an Arabic surname." He said he had grown up in a Jewish neighborhood.

Several Jewish congressmen stood by him and denounced the Jewish Defense League and urged prosecution of the suspects.

"This is a small group of wackos," said Rep. Gary Ackerman, a New York Democrat. "They get more attention than they deserve but they can't get more punishment than they deserve."

The JDL was founded by Rabbi Meir Kahane, who was assassinated in New York in 1990. Prior to his death he founded the extremist KACH Party in Israel which advocated the expulsion of all Arabs from Israel and Israeli-occupied territories. The party was later outlawed.

**[JR: The JDL is spreading their brand of hatred and terrorism in the U.S. The newly created anti-terrorist and hate-crime laws certainly apply to the charges and evidence against JDL Chairman Krugel and his follower Rubin. #### U.S. VETOES UN RESOLUTION ON MIDEAST MONITORS

UNITED NATIONS (*Reuters*)—The United States on Saturday used its veto power to kill a UN resolution that demanded an immediate halt to Middle East violence and said the Palestinian Authority was essential to any peace process.

U.S. Ambassador John Negroponte said the Security Council resolution, sponsored by Arab states, was aimed at isolating Israel politically and did not mention recent suicide bombings against Israelis or those responsible for them.

The vote in the 15-member council was 12 to 1 with 2 abstentions, Britain and Norway. The other two Europeans on the council, France and Ireland were among the "yes" votes following two dozen speeches that spilled into the early-morning hours.

The U.S. veto was the second this year on a Palestinian-backed resolution. In March, Washington killed a tougher measure that called for an international observer force, which Israel opposes.

Saturday's resolution, sponsored by Egypt and Tunisia and amended by France, encouraged "all concerned to establish a monitoring mechanism" to help ease conditions in the West Bank and Gaza. It condemned all terrorist acts, executions without trial, excessive use of force and the destruction of property.

But Negroponte said it was fundamentally flawed because it did not even mention "recent acts of terrorism" against Israelis or those responsible for them. On Dec. 1, Palestinian suicide attacks killed 26 in Jerusalem and Haifa.

At least 776 Palestinians and 233 Israelis have



been killed since Israeli-Palestinian clashes flared anew in September of last year after U.S.-mediated peace efforts collapsed.

The resolution sought to bolster Palestinian leader Yasser Arafat days after Israel severed ties with him and branded him “irrelevant” in response to the spate of attacks on Israelis this month. It said the Palestinian Authority remained “the indispensable and legitimate party for peace”.

The break with Arafat on Thursday, a day after Palestinian militants ambushed a bus in the West Bank and killed 10 Israelis, further evaporating hopes for a negotiated end to the bloodshed. On Friday, the Israeli army killed eight Palestinians.

Palestinian UN representative Nasser al-Kidwa said cutting off Arafat threatened to plunge the region into war.

“This decision means the abandonment of the negotiation process,” al-Kidwa said, adding he feared Israel wanted to roll back on autonomy and security agreements made during the Oslo negotiation process that began in 1993.

Addressing the United States, he asked “whether this council is being used by some only when it’s useful to them.” A number of speakers admonished Israel for using excessive force against Palestinians.

But Israel said it believed the conflict was not about occupation but about the Jewish state’s right to exist.

Israeli delegate Aaron Jacob said there was an “ever-diminishing window of opportunity” to salvage peace negotiations if Palestinians entered direct bilateral talks with Israel and crushed militant groups like Hamas.

“The terrorism that has afflicted Israeli civilians is part and parcel of the fundamentalist terrorism that is now the focus of a comprehensive international campaign aimed at its eradication,” Jacob said.

Britain said it abstained because the text did not reflect the realities on ground, did not specify a next step for a resumption of meaningful negotiations nor define responsibility which both sides must accept to end violence.

“We urge Israel and the Palestinian Authority to pull back from the brink and work together to end violence,” British Ambassador Sir Jeremy Greenstock said. “It serves no one’s interest to undermine President Arafat or to weaken the Palestinian Authority.”

**[JR: Sharon has said Israel is going to handle things her own way and seems assured the U.S. will yield to his demands. Is Sharon so overly confident of U.S. support that he will risk a war rather than seek peace?]**

#### SHARON AIMS GUNS AT ARAFAT AS TIES ARE SEVERED

Yasser Arafat was yesterday facing his most critical—and dangerous—moment since returning to the occupied territories after the start of the Oslo peace talks just over seven years ago to lead the Palestinian people on their own land.

Israel’s Prime Minister, Ariel Sharon, was pressing forward with a plan that his critics, within Israel and beyond, say he has privately nurtured since long before his landslide election in February. He has ripped up the Oslo accords, which he always opposed, by destroying the concept of autonomous Palestinian-administered areas by bombing them with warplanes—in action again in Gaza last night—and invading with tanks. And he has dramatically reinforced Israel’s military rule in the rest of the occupied territories, a policy which he has long favoured.

Eight years after his handshake on the White House lawn with Israel’s late premier Yitzhak Rabin, the 73-year-old Palestinian “president” and former Nobel Peace Prize winner was last night living in the shadow of the Israeli guns.

Tired, isolated, stranded and torn between the need to placate the West and his own people, the proof of Mr. Arafat’s enfeebled position was on full display yesterday in the form of several Israeli Merkava tanks, parked menacingly on a bluff in the heart of Ramallah. One had its barrel trained on Mr. Arafat’s West Bank headquarters, where he is holed up in an office only 250 yards away, unable to travel.

Just a few yards away from the tanks lay more than an acre of rubble, crushed trees and twisted iron—the wreckage of the transmitter of the Voice of Palestine radio station, erected by the British rulers of Palestine in 1936, but blown up by Israeli sappers yesterday.

Two giant military bulldozers laid waste to its outhouses. The concept of “Area A”—the Oslo term for the fractured pockets of land under Palestinian rule, including most of Ramallah—had been reduced to a farce.

It came after Mr. Sharon indicated that he was no longer willing to negotiate with Mr. Arafat, although the chances that these two old adversaries would reach any significant agreement on the fundamental issues was always negligible.

The Israeli security cabinet, meeting after Palestinian guerrillas killed 10 Israelis in a bus ambush on the West Bank on Wednesday, announced that Mr. Arafat had “made himself irrelevant”, and that Israel would have no further contact with him.

Last night the international community was pressing Israel to change its mind, emphasising that it would continue to treat Mr. Arafat as the Palestinians’ leader.

But, on the ground, the Israeli military was driving developments. It has officially assumed responsibility for the impossible task of eliminating the paramilitary groups—particularly the Islamist nationalist Hamas and Islamic Jihad—whose massacres of Israeli civilians

allowed Mr. Sharon to win broad international consensus for his strategy, under the umbrella of the “war on terror”. Israeli F-16 jets were in action for another night, launching its heaviest bombardment yet of Gaza City, sowing terror and chaos on the streets.

It was further evidence that Mr. Sharon has raised the conflict to a new level. His officials say that this is because Mr. Arafat has failed to carry out Israel’s demand—backed up by the international community—to arrest the militants who have been attacking Israelis, killing more than 230 over the last 15 months.

Being ordered to enforce Israel’s security interests always placed Mr. Arafat in a dilemma. Moving decisively against Hamas, which enjoys deep support among Palestinians, would risk his own leadership and possible civil war. He also knows that jailing militants en masse is unlikely to satisfy Israel for long, as it would almost certainly fail to stop the attacks.

Israel has thrown thousands of Palestinians in jail, and assassinated scores of alleged ringleaders, and yet the conflict continues—fuelled by the deep popular resentment at Israel’s attempts to use military force and economic deprivation to bludgeon them into compliance and by an almost universal belief that the international diplomacy, dominated by the United States, is incapable of delivering a fair solution.

Last night, the international community was scrambling to repair the damage. It is frightened of how far Mr. Sharon might go—and who might be found to replace a deposed Mr. Arafat. William Burns, the U.S. Assistant Secretary of State for Near East Affairs, said the U.S. still considered Mr. Arafat as a partner”; the European Union said it, too, would continue to deal with him.

Will it make any difference? Mr. Sharon is too canny to harm Mr. Arafat himself, although he no doubt hopes to see him swiftly replaced by compliant local leaders. But the ex-general is a ruthless adversary and is unlikely to relieve the pressure.

**[JR: Is this what the U.S. is supporting? Israeli tanks perched on a hill in Ramallah pointed at Arafat and his headquarters. This is a picture of Zionism in its truest form. With no voice or communication with his people, Arafat has no hope to continue as the leader of the PLA. The Israelis have seen to that, despite the feeble protests from the rest of the world. #### WILL NEW BIN LADEN TAPE SHED LIGHT ON THE TRUTH?

WOLFOWITZ: DON'T WAIT  
TO CONFRONT TERRORISTS IN INDONESIA

"Going after al-Qaida in Indonesia is not something that should wait until after al-Qaida has been uprooted from Afghanistan," Deputy Secretary of Defense Paul Wolfowitz stated recently. "There are activities that we don't like that are going on there."

A former ambassador to Indonesia, Wolfowitz echoed concerns voiced by Robert S. Gelbard, then U.S. ambassador to the world's largest Islamic country, who predicted Sept. 16 that the U.S. Embassy in Jakarta would be the next target of terrorists led by Osama bin Laden.

The alarmed ambassador further cautioned that bin Laden's network had joined forces with extremist groups within Indonesia led by Laskar Jihad (Jihad Troops).

Gelbard has since been followed by Bush appointee Ralph Boyce, confirmed by the U.S. Senate on Sept. 26, and sworn in as the U.S. ambassador to Indonesia on Oct. 9.

Rohan Gunaratna from St. Andrew's University Center for the Study of Terrorism and Political Violence agrees with them, opining recently that the al-Qaida network has a number of cells active in Indonesia.

Extremist Islamist organizations in Indonesia include: Darul Islam, Islamic Defenders Front, and Laskar Jihad.

According to a Darul Islam leader, the organization is largely made up of about 15,000 Indonesians who returned from Afghanistan after fighting alongside the mujahadeen against the Soviet Union.

Bin Laden also fought alongside the mujahadeen in the 1980s, as did the leader of the Laskar Jihad, who admits to meeting Osama bin Laden there.

Shortly after Bush's meeting with the Indonesian president Sept. 19, Indonesia's top Islamic authority, the Council of Indonesian Ulemas, called for Muslims to unite and join a jihad (holy war) against the United States in the event of U.S. bombing attacks against Afghanistan.

Since then, however, the Council has qualified that "jihad" has peaceful as well as warlike forms.

Similar threats of jihad in whatever form against the U.S. have also been made by Laskar Jihad and Islamic Defenders Front.

Those predicated bombing attacks, of course, are now under way.

As a caution to the threats, the U.S. Embassy in Jakarta withdrew non-essential staff in late September. Furthermore, families of the staff of some American companies, such as Nike, have been evacuated.

Even before Sept. 11, intelligence from Europe indicated bomb threats and a worrisome surveillance of the U.S. ambassador to Indonesia by Sudanese nationals linked to the al-Qaida network.

So far, the promised jihad seems to be limited to demonstrations against the U.S. On Oct. 8, for instance, more than a thousand members of a number of organizations including Islamic Defenders Front picketed the American Embassy.

Even Indonesian President Megawati Yudhoyono recently chided, "It is unacceptable that someone, a group or even a government, with the reason of searching for terrorists, attack a people or another country for whatever reason."

Remarks such as this have been interpreted as backsliding from Yudhoyono's earlier pledge to Bush committing her country to the war on terrorism.

Jaffar Umar Thalib, the leader of Laskar Jihad, minces his words even less: "We will continue with this anti-American movement, regardless of the brutal attempts by police to shut us down. This movement will continue until Bush decides to stop sending missiles into Afghanistan."

In the meantime, other links to militants in Afghanistan and Pakistan have surfaced.

The Indonesian director of immigration, Muhammad Indra, has conceded that members of Afghan militias regularly enter Indonesia illegally.

A Muslim activist and writer claimed that an envoy of Osama bin Laden had visited Indonesia at least four times, and that Darul Islam and al-Qaida enjoy a "special relationship."

Perhaps even more troubling over the long run, Indonesian students typically study in the Islamic religious schools of Pakistan and elsewhere, being exposed to the same radical teachings as the Taliban.

So far, Indonesia's biggest contribution to the war on terror has been an investigation of several bank accounts with suspected links to international terrorism.

But the country's laws have stymied action. Communication Minister Syamsul Mu'arif said a new decree was needed to allow authorities to block terrorist funds without violating Indonesian banking laws, the newspaper reported.

But perhaps the greatest dilemma of Indonesia is that the country's military has waged terror

campaigns against civilians. Indonesian militias savaged East Timor in September 1999, leaving up to 1,000 dead. Just as troubling: the military's close ties with extremist Islamic groups in its own country.

**[JR: Why does Mr. Wolfowitz infer a hostile U.S. attitude towards Indonesia? Maybe he/we are insulted by the Indonesian President's remarks that it is unacceptable for a group or government to attack another country for whatever reason. #### SUICIDE SQUAD ATTACKS INDIAN PARLIAMENT, 12 DEAD

NEW DELHI (*Reuters*)—A suicide squad stormed India's parliament complex on Thursday, killing seven people before dying themselves in an unprecedented attack on the seat of power of the world's biggest democracy.

There was no immediate claim of responsibility for the assault during which one attacker detonated explosives strapped to his waist and others hurled grenades and fought a gunbattle with police. The five assailants were killed in the raid.

No ministers or legislators were hurt in the attack, which began about 11:45 a.m. (0615 GMT).

Prime Minister Atal Behari Vajpayee, who was not in the complex at the time, went on television to say India's battle against terrorism had reached its final stage, while both his defense and interior ministers vowed a tough response.

"We will liquidate the terrorists and their sponsors whoever they are, wherever they are," Home (interior) Minister L.K. Advani told a news conference.

Initial speculation turned to Islamic militants fighting Indian rule in the state of Jammu and Kashmir, where 38 people died in a suicide attack on the state assembly two months ago.

If confirmed, it would seriously raise tensions with Pakistan, accused by New Delhi of sponsoring Kashmiri militancy. Pakistan President Pervez Musharraf quickly condemned the attack and sent a message of sympathy to Vajpayee.

"The techniques used by the terrorists would seem to suggest they were trained in Pakistan, we have seen these kind of attacks in Jammu and Kashmir in the past," said retired major general Afsir Karim who is now a terrorism expert.

A series of bomb blasts also rocked Kashmir near the border with Pakistan on Thursday but there were no casualties or damage. An attack on a paramilitary camp by separatist guerrillas in the Tral township of Kashmir was also foiled....

Indian legislators called for retaliation of the kind taken by the United States in Afghanistan after the September 11 suicide attacks on New York and Washington or by Israel against the Palestinians after suicide bombings.

Pakistan, India's nuclear rival and neighbor, said it strongly and unequivocally condemned the attack, while a Kashmiri guerrilla alliance, the Muthida Jihad Council in Pakistan-ruled part of Kashmir, said it had no connection with it.

The United States called the attack an "outrageous act of terrorism", while London labeled it a "brutal terrorist attack".

Vajpayee said India had been fighting terrorism for the past two decades. "The fight has now reached a decisive stage."

Indian financial markets tumbled on news of the suicide attack but intervention by state-run banks helped shares and the rupee end off lows.

Political analysts said if Thursday's raid turned out to be by Kashmir separatists, India could launch a counter-attack across the Line of Control into Pakistani-held territory.

"If it turns out that any organization having links with Pakistan is responsible, then there is going to be a very serious deterioration in relations with Pakistan at the very least," said political analyst Mahesh Rangarajan.

Some members of parliament did not even want to wait for a claim of responsibility to be made before demanding action....

#### FIRST TEAM TO GO TO NORTHERN IRAQ

*Kuwait Times* (Kuwait City), 12/12/01

Washington—In a move to rally opposition to Iraqi President Saddam Hussein, a State Department delegation is in northern Iraq to help pull Kurdish and other anti-government forces together.

The delegation headed by Ryan Crocker, a senior State Department official, is the first to go to northern Iraq since February. The area has been outside the control of Saddam for a decade, and is considered a prime staging ground for rattling his government.

Last week, a bipartisan group of nine legislators asked President George W. Bush to support Iraqi opposition forces with humanitarian assistance,

information gathering and military training.

The lawmakers said in a letter to Bush that U.S. efforts to replace Saddam will not succeed without the help of allies on the ground inside Iraq. They suggested the support should be directed to the London-based Iraqi National Congress, the umbrella organisation for all major groups opposed to Saddam.

Ignoring lawmakers' wishes, previous administrations have denied U.S. assistance for the INC to carry out operations inside Iraq.

On Monday, State Department spokesman Philip Reeker said Crocker and the delegation had arrived in northern Iraq. The group's main purpose, he said, was to demonstrate continued U.S. involvement with the Iraqi opposition. Reeker said the U.S. officials also intend to mediate between rival Kurdish factions and check on food deliveries under a UN program that permits Baghdad to sell oil if revenues are used for food and medicine.

Bush and senior administration officials have raised the possibility of the United States taking its campaign against terrorism to Iraq after the Taliban and the al-Qaida terrorism network are defeated in Afghanistan. Iraq is one of seven countries branded by the State Department as a sponsor of terrorism. Recently the administration has also stressed Saddam's refusal to permit UN inspectors to check for weapons programs.

Meanwhile, Iraq said the oil-for-food programme was benefiting the United Nations rather than the people of Iraq, the official *Iraqi News Agency (INA)* reported.

The oil-for-food deal allows Iraq to sell unlimited quantities of oil over six months to buy food, medicine and other humanitarian goods for its population.

"It is a programme to meet UN needs, pay compensation, and balance world oil prices and not to alleviate the suffering of the people of Iraq as America and Britain allege," INA quoted Trade Minister Mohammed Mehdi Saleh as saying.

"Iraq has exported \$50 billion worth of oil over the past ten phases of programme, yet it has received only \$15 billion worth of goods," Saleh said.

Of the \$50 billion, Saleh said, the UN had deducted \$18 billion "to cover its expenses and pay compensation".

The remaining sum represents contracts on hold, worth \$6.36 billion in addition to goods undelivered yet to Iraq, he added.

Saleh said a distribution plan for the eleventh phase of the oil deal was under preparation and that contracts for the new phase of the deal would be signed after UN approval of the plan.

Baghdad agreed last week to a six-month extension of the oil package but rejected the portion of the UN resolution calling for the world body to alter sanctions at the end of the six-month term.

The "smart sanctions" would have eased Iraq's purchases of civilian goods while clamping down on goods with military applications and tightening border controls to slow oil smuggling.

THE PERILS AND PROMISE  
OF INDEPENDENT THINKING

Something strange happened last night at a party I went to. Everyone was just sitting around doing the sort of things people do at such gatherings when the topic of current events came up. There was a sudden and discernible change in the mood of everyone present when the conversation turned toward the serious subjects of Bush's War on Terrorism and Ashcroft's War on Civil Liberties.

Most of the party attendees were Americans, but a few were from other countries. A young Chinese woman said, in a voice loud enough for everyone to hear, "I heard something about secret trials for Arabs in America. I thought America was the land of freedom." I shook my head to indicate to her that I had thought so too—at one time but not any longer—but I didn't utter a word even though I wanted to jump up on my soapbox at that moment and give President Bush, Attorney General John Ashcroft, and others in the current administration a good dose of criticism.

But this little voice speaking inside my head advised me to tread cautiously, so I censored myself and kept quiet because I sensed that most of the Americans in the room were of the mindset that our president has done and is doing a good job. Likewise, the Chinese woman, feeling that the prevailing emotion of the room was very much against her making such statements, quickly stopped talking and promptly did her best imitation of a wallflower.

So this is what it's come to. People have to watch what they say and do these days—Ari Fleischer is looking more and more like a prophet—because any sort of bad-mouthing of the commander in chief's (or his henchmen's) actions is strictly frowned upon if not downright forbidden.

Unquestionably, the vast majority of Americans are in the "America and its leaders can do no wrong" mode of thinking. These people have been labeled "patriots" by their own kind and generally they stick together because everyone knows it's important that a "unified front" be presented to all enemies (both real and imagined).

On the other hand, a tiny minority of folks—I'm in their number—disagree with the predominant views held by the vocal majority. Individuals belonging to this loose network of dissenters have been ridiculed and called all sorts of names, many of which cannot be printed here without besmirching the reputation of this publication. "Commie," "liberal," and "peacenik" are some of those that can be printed without too much worry.

In the current climate, being a patriot is a good thing, but being a commie-liberal-peacenik is not. Commie-liberal-peaceniks instantly give themselves away when they start asking questions that indicate they've done some independent thinking about the Bush Administration's responses to those terrible events of 9/11. Sometimes we commie-liberal-peaceniks pay a high price for simply exercising our vocal cords in accordance with those rights granted to us by the *Constitution of the United States of America*. Lately, though, with people like the current Attorney General on the job, it seems the *Constitution* is not worth the paper it's written on.

The more I think about it, the more I dislike the label

"commie-liberal-peacenik". If people like me have to be called something (and it seems more and more apparent that we do), I prefer the moniker "independent thinker".

Are we all—those of us who have concerns about how things are going under President Bush—supposed to just smile and act as if everything is hunky-dory?

Let's turn the ACTA arguments on their head. I'd like to claim that professors who are engaged in critical analysis of what's presently going on in the world are fulfilling a very important strategic mission that their universities hired them to do, which makes them not only patriots but super-patriots. America has been a strong and innovative country because it has produced great minds that have excelled in all sorts of fields. (And who was it that helped train these great minds to think in the sort of ways that made them great in the first place?) Let's not bash such outspoken educators. Let's celebrate them for playing an indispensable role in making America an exceptionally creative place.

And while we're exonerating these professors, let's laud all independent thinkers of every sort because if America is to survive the difficult challenges now facing it, it won't be because it has closed up its borders or shut down its collective intellect or put its faith in repressive measures of any sort or bombed all its adversaries to smithereens. On the contrary, if there is to be true homeland security, then it must come as a result of careful consideration and debate and an open-eyed willingness to invite all voices to make their cacophonous contribution to the public debate about how to make America (and the rest of the world) safer.

UN CAUTIONS ISRAEL ON DETAINEES

GENEVA—The UN Committee Against Torture said Friday that while Israel had made progress in ending some practices that amounted to torture, it should install "effective complaint, investigative and prosecution mechanisms" to handle continuing protests.

The committee members, 10 independent experts, said in a statement that they were "fully aware of the difficult situation of unrest faced by Israel, particularly in the occupied territories, and understands its security concerns," but that "no exceptional circumstances may be invoked" to justify torture.

Israel signed the 1987 *Convention Against Torture* and is required to report periodically on its compliance.

The committee also reviewed the situation in Indonesia, Benin, Zambia and Ukraine. Saudi Arabia submitted a report and then notified the committee earlier this month that it was unable to attend.

The committee, concluding its two-week session, said it was concerned about the "climate of impunity" for abuses by Indonesian security forces because many victims were afraid to complain or failed to get a fair hearing. It specifically cited parts of the country where anti-government forces have been active—in Aceh, Irian Jaya and the Moluccas.

Indonesian officials said they were trying to educate security forces to observe human rights. But the panel highlighted gaps in the country's laws, such as the failure to define torture as an offense, making it difficult to pursue cases of human-rights abuse.

The committee also criticized Ukraine for what it said was the widespread use of torture in its jails, despite recent laws aimed at stemming it. Many detention centers, it said, were overcrowded, had inadequate sanitary facilities and high rates of tuberculosis and lacked adequate access to medical care.

Regarding Israel, the committee said that despite "numerous" allegations of torture and ill-treatment of Palestinian detainees, particularly as fighting intensified over the past year, a Supreme Court ruling in 1999 apparently had improved treatment.

However, because the decision left open the possibility of torture in extreme "ticking bomb" cases, the committee chairman, Peter Burns, said "certain types of conduct slip through the net," including depriving detainees of sleep.

The committee also noted that there had been "very few prosecutions" against reported torturers in Israel.

One improvement would be to change Israeli law to remove "necessity as a possible justification to the crime of torture," the committee said. Also, the committee urged Israel to ensure that all detainees were brought promptly before a judge and had access to lawyers so they were not held for unduly long periods.

Israel maintained that its security agents did not torture detainees while questioning them.

“I was saving that for you ma'am—

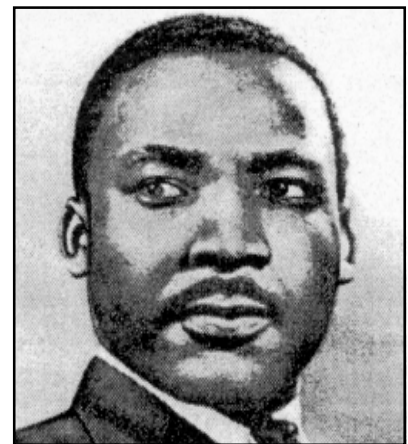
and Merry Christmas,” he said, turning to go back to his suitcase and his corner by the building.

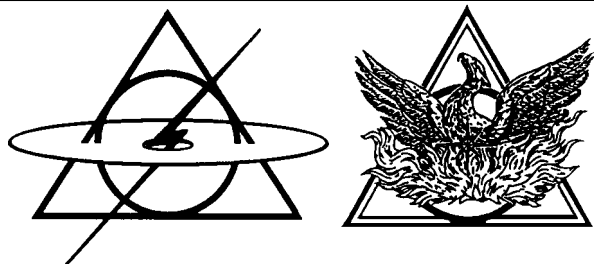
