#### **OBSERVATIONS**

From where we stand, it looks as though the Arroyo government is fast losing the "propaganda war" regarding the hosting of the controversial RP-U.S. Balikatan exercises in war-torn Mindanao, as the majority of the nation's broadcast journalists rally behind the political opposition, which includes communist front organizations. This is no longer surprising, considering the number of media practitioners Dante Ang has alienated.

Some of those we talked to, swear that Ang, a longtime confidant of President Gloria Macapagal-Arroyo (PGMA), deliberately antagonized quite a number of "friendly" media practitioners by covertly operating a media outfit called SUMMIT COMMUNICATIONS with Ricardo "Dong" Puno, an Erap crony, as his business partner. Confidentialities, therefore, are no longer practiced as the Erap camp becomes privy to sensitive data thanks to leakages coming from Ang's PR office.

Already, the metropolis is buzzing with whispers regarding an "executive agreement" signed by U.S. President George W. Bush and PGMA, DURING THE LATTER'S AMERICAN VISIT AFTER THE 9-11 DEBACLE. SOURCES ALSO SAY THAT THE TOP-SECRET DOCUMENT WAS INKED IN THE PRESENCE OF CONDOLEEZA RICE OF THE U.S. AND J. ROILO GOILEZ OF THE PHILIPPINES. [Emphasis ours.]

The problem, however, lies in the fact that too much vital information is being kept away from the public. For example, Vice-President Tito Guingona was made to believe that under the U.S. Constitution, its armed forces could not be placed under a foreign military commander. Nothing can be farther from the truth. [Please read the next carefully, Americans.]

Today, tens of thousands of U.S. troops are serving the UN, despite not wearing the UN uniform. A March 1997 Pentagon document states that 68,790 U.S. troops were involved in UN-authorized or international peacekeeping activities. This figure includes U.S. "bluehelmeted" personnel in Macedonia (said to be 511), as well as 1,052 personnel involved in "non-Un Peace Operations" in the Middle East and Latin America. It also includes 67,200 troops "supporting enforcement" of UN Security Council resolutions in Bosnia, Iraq, and Korea. In other words, according to the Pentagon itself, approximately 68,000 "green-helmeted" troops served the UN that year alone.

The UN's World Army has, therefore, arrived, and the American soldiers are the front-line troops. This was clearly shown when UN Secretary-General Kofi Annan, after returning from Iraq with a "deal" to allow limited inspections of Saddam Hussein's weapons sites, declared that "Together we are the ultimate power," an endorsement of the UN becoming a world government, in which the once-great United States plays the role of bit player (and financier), while American interests are subservient to whatever power runs the UN.

Erick will also refer to "money" as in "the dollar" and that U.S. special operations forces had "established military ties in at least 110 countries". It said these involved many UN-style "training exercises" with countries as Kazakhstan, Madagascar, Mongolia, Russia and Uzbekistan. In Africa, the POST reported that U.S. forces had trained the militaries of 31 out of 54 African countries. Six of these countries—Ghana, Melawi, Senegal, Uganda, Mali, and Ethiopia—received training to participate in a State Department-led "African Crisis Response Initiative", a regional peacekeeping force.

> In July 1998, the U.S. Air National Guard hosted a training exercise involving European forces that went under the bizarre title, "Global Patriot". More than 15,000 service members from the Air National Guard, Air Force, U.S. Army, Navy and Marines, including the Reserve Corps, were joined by Dutch, British, Paraguayan, and Canadian forces.

> Nothing, therefore, can stop the U.S. from deploying between 2,000-5,000 troops in the Philippines, since this is well in accordance with the MDT (Mutual Defense Treaty) signed by AFP chief-of-staff General Diomedio Villanueva and U.S. CINCPAC head, Admiral Dennis Blair. The pact is said to have U.S. Charges d'Affaires Robert Fitts as witness to this agreement of brothers and sisters as possible live targets!

> Everything, of course, will depend on how PGMA will handle criticisms and mass actions directed against her and her alliance with U.S. forces. Keen political observers are now saying that if U.S. President Bush skips the Philippines on his way to China, PGMA will be in serious trouble. Others believe that should CIA Director George Tenet reach the Philippines ahead of U.S. Ambassador-designate Ricciardone, we may see some changes in the political landscape.

> Another event to watch will be the "war of nerves" between China and the U.S. during President Bush's official visit to Beijing. Any diplomatic miscalculations might lead into a shooting war in the region, with the Spratleys and Paracels as starting points. Already, China has reportedly occupied Panganiban Reef, which is clearly Philippine territory.

> Hovering above all this, like the proverbial sword of Damocles, is the impending collapse of the almighty U.S. dollar, made even more imminent by Bush's stubborn pursuit of Thatcher's "expanded NATO doctrine", designed to impose Anglo-American world domination. It may yet be overshadowed by the Euro, which Europeans have sworn to protect economically, even militarily. Only recently, European nations have agreed on the development and deployment of the Western European forces, a military force apart from the U.S.-led NATO forces, and independent of America altogether.

> Here in the Philippines, the dollar's collapse will plunge us into a new Dark Age, along with the rest of the dollarized foreign economies. When that happens, PGMA will have to play a requiem for her "con game" in the south, even as a combined army of communists and Islamists confront the AFP for a final showdown.

> **[OUOTING NEW U.S. AMBASSADOR TO THE** PHILIPPINES, FRANCIS J. RICCIARDONE JR. By Max Soliven, The Philippine STAR, Feb. 11, 2001:]

> Mr. Ricciardone Jr. will be arriving within the next two weeks, I'm informed. The delay in his confirmation was occasioned by the U.S. Senate being preoccupied with other matters, plus a period of recess, but he's finally coming.

> The question in administration circles is whether Ricciardone will get here in time to help President GMA "push" for U.S. President George W. Bush to include Manila—even at the tail-end—in his slated three-nation swing through north Asia. Bush will visit Japan on Feb. 17, South Korea on Feb. 19, and China on Feb. 21 and 22. Will he skip Manila, even on his way back to the U.S.? Unless GMA's back-channeling efforts are successful, he probably will—but who knows? Aren't they supposed to be phone pals?

[The media and press continue to say "No visit" but recognizing the futility of attention to ANYTHING, we have to say that the efforts are hosting several Balikatan exercises, with our Muslim still wiggling in the can. And, moreover, things are really getting nasty here in drama-land.]

> One reason for hesitation might be an unwillingness on the part of the American President or his staff to jump into the eye of the controversy (even if it may be dying down) over U.S. participation in the anti-Abu Sayyaf campaign in Mindanao, under whatever Terms of Reference (TOR) will be unveiled on February 14. (Why did they choose Valentine's Day as the date? To demonstrate that the U.S. is still our Valentine, or vice-versa?)

> In any event, the incoming U.S. envoy—who, by the way speaks Turkish, Italian, French, Arabic and even English—is an expert on the Middle and Near East, and Muslim affairs. His last position was that of Special Representative for Transition in Iraq. That was probably long before Georgie Bush in his State of the Union address testily proclaimed Iraq as one of the three states belonging to his so-called "axis of evil", along with Iran and North Korea. [Or, possibly, the "transition" meant was that of overthrowing Iraq's strongman Saddam Insane—er, Hussein.]

> The new Ambassador is a native of Boston and graduated from Dartmouth College in 1973. After a Fulbright scholarship in Trieste, Italy (which is on the border, incidentally of Croatia and the former Yugoslavia of Marshal Tito's time), he taught in international schools in Italy from 1974 to 1976 and in Iran from 1976 to 1978. [Is this tour in the Philippines a punishment, exile, or what?]

> Ricciardone began his career in foreign service in 1978, with his first postings in Ankara (the Turkish capital) and Adana, also in Turkey. Returning to Washington, D.C. in 1981, he worked as special assistant to the Director of the Bureau of Intelligence and Research, and as an analyst on Turkey, Greece and Cyprus.

From 1982 to 1985, he served as country officer for Iraq, and won a meritorious honor award in 1983 for "normalizing" U.S.-Iraqi relations. (Since the Gulf War, of course, U.S. relations with Baghdad have been in tatters—and grew even worse after the recent Bush condemnation). Ricciardone then served as political officer in Cairo, Egypt, from 1986 to 1989 [Interesting years!], winning what's known as the "Director General's Award for Political Reporting" in 1988. He was seconded from the U.S. government to head the

Civilian Observer Unit of the Multinational Force and was elected in November, 2001. Observers in the Sinai Desert of Egypt (1989-91), winning another citation.

Returning to the U.S. foreign service, he was appointed Deputy Chief of Mission for the embassy in Baghdad, but by that time the U.S. embassy there was already "closed down", so he served in that capacity in a sort of exile posting, in Amman, Jordan, and London, United Kingdom (1991-93). After serving further as political adviser to the Turkish and American cocommanders of Operation Provide Comfort, a multinational operation based at Incirlik Air Force Base in Turkey for relief and "humanitarian" operations in Northern Iraq (to help the Kurds?), he returned to Washington as Director of the Office of Policy coordination for the Director General of the Foreign Service and of Personnel.

From 1995 to January 1999, he was posted as Deputy Chief of Mission and Charge d' Affaires at the U.S. Embassy in Ankara, Turkey. He was designated by former U.S. Secretary of State Madeleine Albright (Bill Clinton's time)—Special Representative for Transition in Iraq. It still sounds like a planning committee for the ouster of Saddam.

And now, Ricciardone will soon have to deal with what some diplomats have described as "the ultimate terrorist group", namely the Philippine media.

#### ADMIRAL BLAIR'S NOT REALLY "HIDDEN" AGENDA

The critics who have been accusing President Macapagal-Arroyo of hatching hidden deals with U.S. President George W. Bush have not been keeping an eye on the recent travels of Admiral Dennis C. Blair, the (CINCPAC), under whose overall command the U.S. troops sent to Mindanao are classified.

Blair returned to his headquarters in Hawaii only a few days ago, after a four-nation swing through Asia in which he conferred with the Defense ministers and ranking officers of Singapore, Vietnam, Japan and the Republic of Korea (South Korea). It seems that the theme of this unpublicized but not really "hidden" expedition was to firm up cooperation with those countries and "access" to their facilities for U.S. forces in case of any emergency.

The Admiral—who this writer first met in Honolulu a couple of years ago but has visited Manila recently (and on several other trips)—spelled out his policy as early as August 8, 2000 in a well-disseminated speech. He stated then that "capable U.S. military forces operating in the Asian-Pacific region have been a foundation of regional security. One pillar of this foundation is the role that American armed forces play in reassuring allies and security partners by deterring actual armed aggression and intimidation.

That was expressed by the CINCPAC chief long before his current commander-in-chief, U.S.

From his just-completed journey, I can see that Blair continues to adhere to that concept. Significantly, he commands 300,000 of America's active personnel, including two Marine Expeditionary Forces in Japan and Fleet (based in Yokosuka, Japan) and the Third Fleet (in San Diego, California), four U.S. air forces—i.e., the Fifth Air Force (Japan), the Seventh Air Force (Korea), the Eleventh Air Force (Alaska) and the Thirteenth Air Force (Guam, after the Americans were booted out of Clark Field), and all Army units from Hawaii to Alaska, Japan, Korea and Guam (including the Eighth Army in Yongsan, Seoul) as well as the Joint Interagency Task Force based in Alameda, California.

I really don't understand why some of us are so het up about the "possibility" that 660 U.S. troops, spearheaded by U.S. Special Forces personnel as "trainors", will take over the Philippines and grab the U.S. bases (shut down by our government in 1991) back from us.

What for? The Americans have 47,000 U.S. military personnel in Japan, belonging to U.S. Navy, Army and Air Force units in place there far more than half a century. In fact, the Japanese government subsidizes those bases and personnel at an average cost to the Japanese taxpayer of about \$5 billion per year.

In South Korea, the U.S. maintains 38,000 troops from the DMZ (the border with North Korea) down to Taejon and other southern and western areas.

As a matter of fact, one of the objectives of the CINCPAC chief's just-completed trip, according to my sources, was to urge the Japanese to use their own Self-Defense Forces, while only 250,000 to 280,000 in numbers but the most modern and best-equipped in Asia, in more undertakings abroad, such as "peacekeeping" and other international roles. The Japanese have always been reluctant to expand any military presence, citing the restrictions of their constitution, as well as being wary of criticisms from countries like China and Korea, which felt the Japanese Imperial bootheel during the Pacific War. (In contrast, we Filipinos who lost one million dead during the war and Japanese Occupation—seem to have forgiven them.)

Article 9 of their postwar constitution (which had Commander-in-Chief of U.S. Forces in the Pacific literally been dictated by Gen. Douglas MacArthur and his own Occupation group) declares that "the Japanese people, forever, renounce war as a sovereign right of the nation, or threat or use of force...".

> The same clause promises that "land, sea, and air forces, as well as other war potential, will never be maintained".

Aside from their bank troubles and their own unique type of recession (which should, perhaps, be called stagnation), I noticed from my latest trip there in May last year that the Japanese may soon be ready to play a more "active" role. But how can they circumvent their own constitution (there is no "chacha" movement in evidence)?

"Forever," as Article 9 asserted, is, alas, a very, very long time.

Yet, nationalism stirs, fueled by popular and heroic Samurai-glorifying manga comic books and dramatic novels about Japan's wartime exploits, and movies, etc. Every year, I've seen Japanese selfesteem rejuvenating itself and escalating, coupled with self-induced history book amnesia about the seamy side of their past aggression and transgression. Every year, there's a white paper, an annual book actually,

defense budget keeps on growing and growing.

Perhaps Admiral Blair senses and hopes, for his own military purposes, that Japan is ready.

In any event, his stop-over in Tokyo last week California, the U.S. Pacific Fleet, meaning the Seventh included a pilgrimage to the U.S. naval base in Yokosuka, in Yokohama, an hour and a half's train ride from Tokyo itself.

> His mission there was to hand out commendations and thank the pilots and crew of the aircraft carrier USS Kitty Hawk which had just returned with its Battle Group to its home base in Yokosuka from service in the Arabian Sea, during the still-ongoing Afghanistan campaign. From the Kitty Hawk's decks had come many of the jets and missile-launching aircraft which participated in the Afghan air strikes.

> Incidentally, if you're confused by the name "Arabian Sea", the area used to be called the "Persian Gulf", but this is no longer politically correct in U.S. military maps.

> As for the U.S. Marines, there are 15,000 of them still based in Okinawa (a rapid reaction force, I'm told by insiders, just in case South Korea gets attacked). When I went there to participate in an information technology conference in March 2001, my Okinawan hosts quipped when I remarked about the presence of the U.S. Marines, plus the U.S. airfields (U.S. bases occupy possibly 30 percent of the island), "The U.S. Marines conquered Okinawa in World War II-and never left." Yet, American military spending remains the biggest factor in the agriculturally-poor Okinawan budget.

> If you want to know, while they only grumble about it under their breath, many Okinawans continue to fret about being classified as "Japanese".

The first part of Admiral Blair's odyssey saw him going to Singapore to tour the U.S. bases there. Yes, thanks to the invitation of the Singaporeans after they lost their bases in the Philippines, the U.S. has a navy base and repair facility in Sembawang, and a newer one in Changi, where the government supportively dredged the sea bottom to enable U.S. aircraft carriers to bellyup straight to the pier as they used to do in Subic.

The limitation, of course, is that Singapore doesn't have enough space, even for the Singaporeans themselves.

Blair then went on to Hanoi, [V.K. said Hanoi is in China but quickly corrected to Vietnam (baiting D.J.E., she said). But then who can tell the Marshall Plan vs. the *Monroe Doctrine*? as presented by V.K. through Bellringer?] where he conferenced with the Defense Minister there. The Americans, in consensus-building efforts in our region, have become very cozy with their former enemies.

Blair even discussed the U.S. military possibly having "access" to their former base complex (Navy and Air Force) in Camh Rang Bay, later "leased" by the Soviet military from their Vietnamese allies. Apparently, not only the Vietnamese but the Russians are open to the Americans sharing access to Camh Rang Bay. History, perhaps has come full cycle for those former foeswho now appear to be moving towards alliance in replacement of previous hostility.

Before he left Hanoi on Friday last week, Blair even paid a courtesy call on the legendary Vietnamese General Vo Nguyen Giap, the man who had masterminded the defeat of the French and later the defeat of the Americans in Vietnam.

Giap's last position had been as Minister of Defense President "Axis of Evil-Basher" George W. Bush on The Defense of Japan—and in it the published and a member of the ruling politburo in the People's Republic of Vietnam, until his retirement was precipitated by policy disagreements with his colleagues at the time.

When the American CINCPAC Admiral saw him at his home, Giap was in plain military uniform, without his decorations, but was (one of those who attended said) surprisingly erect and in good health for a man 98 years of age.

In his peregrinations, which concluded with a tour of U.S. bases in South Korea what "mischief" has Blair been up to? Why are the Americans, for instance, so interested in Basilan and Mindanao?

They're concerned not just with the Abu Sayyaf, in my reckoning, (Aha! the "hidden agenda"? Not so hidden if you "visit" the CINCPAC Blair's Website—yes, Virginia, he puts almost everything on his Website, would you believe?) Blair has been referring to the waters around Mindanao, from Palawan to the Sulu Sea and onwards through Malaysian Sabah and Indonesia to the Straits of Malacca as the passage through which "the sea of evil" passes.

I'm told that he's not even as much worried about the ideological or "religious" evil as the flow of contraband weapons, smuggled in to provide weaponry for Islamic rebellion and other insurgencies, but drugs and other contraband as well. In the same area, piracy is also rampant. It is CINCPAC's complaint. By the same token, the same sea passageway must be kept open since most of the oil supplies and the world's commerce between Asia and the West pass through here.

So, the Abus are small cheese in the grand context. Except to us, who're bedeviled by them and their kidnapping antics—and their continuing humiliation of our valiant armed forces—they're the big target.

#### **MALAYSIAN PM** ACCUSES U.S. OF INTOLERANCE

TEHRAN—Malaysian Prime Minister Mahathir bin Mohamad on Sunday appealed to the international community frustration and accused the United States of intolerance.

But Mahathir was also harshly critical of groups within Islam who distort its message to advance their own political causes.

He also warned that if the United States extends its campaign against terrorism by attacking other Islamic countries "you're going to alienate the entire Muslim world".

Mahathir did not spare Islamic extremists who have deliberately "interpreted Islam to support their own political views".

"There is nothing wrong with the religion of Islam," he said.

But as a result of politically motivated distortions by "people who pretend they are learned in Islam"... "People are doing things that are contrary to Islam."

Mahathir stressed that Islam in fact prohibits violence against innocent people and teaches that Muslims can only go to war when they are attacked....

#### FRENCH ANGER AT U.S. POLICY ON ISRAEL

The gulf between the U.S. and Europe over Washington's foreign policy widened yesterday when France's foreign minister delivered an outspoken attack on America's support for Israel.

In the hardest-hitting European assault yet on Washington's world view, Hubert Védrine said U.S. support for the hardline Israeli prime minister, Ariel Sharon, was "mistaken" and "dangerously simplistic".

Mr. Védrine said Europeans were "unanimous in not supporting the Middle East policy of the White House" and thought it was a "mistake to blindly accept the policy of pure repression" conducted by Mr. Sharon.

President George Bush, who is to receive Mr. Sharon in Washington today, has said it is up to the Palestinian leader, Yasser Arafat, to do "a better job" to end what he calls the terror being inflicted on Israel.

Mr. Védrine said France was instead backing a proposal with its EU allies for a formal Israeli acknowledgement of the need for a Palestinian state and elections in the Palestinian territories that would give the to keep pressure on Mr. Arafat to convince him that he winner a mandate to negotiate peace.

The minister's attack comes amid a chorus of dismay in Europe at Mr. Bush's state of the union speech last week in which he named Iran, Iraq and North Korea as sponsors of terrorism in an "axis of evil".

Mr. Védrine said that Europeans "are friends of the United States and will remain so". But, he added: "We are threatened today by a new simplism which consists in reducing everything to the war on terrorism. We cannot accept that idea. You have got to tackle the root causes, the situations, poverty, injustice."

He said U.S. rhetoric was confirmation that the Bush administration approached foreign policy "unilaterally, without consulting anyone, based on their interpretation and on their interests".

The EU's foreign policy chief, Javier Solana, has conceded that there was a possible link between Iran and the Palestinian Authority in the form of a shipload of weapons intercepted by Israel last month in the Red sea.

But EU officials say they will resist any U.S. attempt to make an enemy of Iran in the widening war on terrorism. Europe believes trade, cooperation and support for the reform process and opposition moderates is the best way forward for Iran.

Diplomats said that while the EU broadly shared U.S. concerns about Iran acquiring nuclear weapons and about its support for anti-Israel groups including Hizbollah, Hamas and Islamic Jihad, it remains dubious about Washington's charges that Iran exports global terror or has links with Osama bin Laden's al-Qaida network.

Yesterday the U.S. secretary of state, Colin Powell, accused Tehran of trying to destabilise the new Afghan government and of "unhelpful activities" in the area.

"We can demonstrate to them that it is not in their the United States developed its war on terrorism in the interest to destabilise the government that they helped to create," he said. But he was convinced talks with Iranian leaders were still possible.

#### ARAFAT STILL A PLAYER, BUSH TELLS SHARON

WASHINGTON—Rebuffing Israeli Prime Minister Ariel Sharon's request that the United States cut ties with Palestinian leader Yasser Arafat, President Bush on Thursday instead emphasized his concern over the plight of Palestinian civilians suffering under Israel's security crackdown.

Bush did not relent in his criticism of Arafat during a 45-minute White House meeting with Sharon. He again called on Arafat to "do everything in his power" to stop Palestinian militants from attacking Israeli civilians.

"I assured the Prime Minister that we will continue must take serious, concrete, real steps to reduce terrorist activity in the Middle East," Bush said after the meeting.

But the president's emphasis on Palestinian hardship reflected the message he has been hearing from Arab and European leaders in recent weeks: That the U.S. must address Palestinian grievances if it wants to continue its role as an honest broker in the search for Middle East peace.

The Palestinians have complained bitterly about tactics Israel has used in response to the violence Palestinian militants have unleashed during the 16month-old uprising. More than 900 Palestinians and 260 Israelis have perished during the period, according to a tally by The Associated Press.

Those Israeli tactics include targeted killings of Palestinian "militants", military incursions into Palestinian areas, the bulldozing of Palestinian homes and several security checkpoints Palestinians must negotiate to travel in and out of their territories.

"I am deeply concerned about the plight of the average Palestinian," Bush said, noting that his budget provides \$300 million in humanitarian aid for the Palestinians.

"I worry about stories and pictures I see of and deep concerns etched on the faces of moms and dads who happen to be Palestinian," Bush said.

Sharon acknowledged that he and Bush improve the life conditions of those Palestinians that are not involved in terror".

"That's my intention. That was always my intention," Sharon said. "And of course, we'll try and see what can be done."

Meeting Bush for the fourth time in the past year, beyond Arafat, whom the Israeli army has confined to his Ramallah headquarters, and begin dealing with new Palestinian leaders. Sharon met privately last week with three senior Palestinians to begin to do just that.

"Arafat has chosen [a] strategy of terror and have an alternative leadership in the future.'

White House aides in the hours before Sharon arrived relevant to the Middle East peace process and would pursue discussions with leaders of the Palestinian Authority other than Arafat.

Israeli diplomats said Sharon also was pressing the Bush administration to list the militias and security forces under Arafat's control, such as the Al Aqsa Brigades, as terrorist organizations alongside the Palestinian militant groups Hamas, Hezbollah and Palestinian Islamic Jihad. There was no word of the president's response.

Nevertheless, Sharon struck a conciliatory tone toward the Palestinians. He said that once there is "a full cessation of terror, violence and incitement", and the Palestinian Authority arrests and disarms militants, the Israeli government is prepared to resume peace talks intended to lead to the establishment of a Palestinian state.

"Once they will take serious preventive steps and stop completely incitement, then we will start negotiations," Sharon said.

"I believe that one day, we'll be reaching a peace. Israel is committed to peace. And at the end of the process, I believe that a Palestinian state, of course, will be-we would see a Palestinian state."

But, Sharon added, "it cannot be done under terror." At home, the Likud leader finds himself in a delicate political situation. His approval rating is high, but not because he is greatly loved. Rather, polls indicate that many Israelis, traumatized by the surge in Palestinian violence, see no way out of the current crisis and despair over the collapse of the peace process.

In most recent polls, two-thirds of the Israeli population support Sharon's crackdown on the Palestinians. But the same number also want to see peace talks resumed, although with guarantees that the Palestinians would not threaten Israel's existence.

Rather than humiliating Arafat, Sharon's crackdown has produced a surge of support. Sharon's desire to deal with alternative Palestinian leaders is a fantasy, many Palestinians argue, because anyone who dared to step forward in Arafat's place would be considered a traitor and an Israeli lackey.

That is not how Sharon's Cabinet sees the situation.

#### NATIONAL ID IDEA COLLIDES WITH RIGHT TO PRIVACY

Maybe you remember the quaint old days, early in 2001, when privacy still mattered.

That was before big business used its clout to sweep aside or neuter an assortment of legislative and regulatory proposals that might have given us a modicum of control over how our most personal information could be traded and sold.

That was before Sept. 11, when so many Americans decided that liberty mattered far less than safety. Since then, Big Brother has reasserted his increasingly absolute right to snoop and pry and invade the deepest recesses of our bank accounts and private lives.

unelected officials who run state motor-vehicle departments started pushing to create a national identification card based on driver's licenses.

These are the worst of times for your right to be left alone. Governments are carving away fundamental liberties, seeking to know where we go, what we buy and what we say. Business desperately wants the first two of those.

Both kinds of surveillance freaks want, in effect, a real-time dossier on every one of us. The national ID is just their ticket, or at least one of them. (Another can be imagined in Microsoft's wish to create a cyber "Passport" for all of us, a foot in the door to continuous online surveillance.)

For a national ID to make any sense to law enforcement, it needs to be a smarter card than the one we use today. It would have to include biometric information, such as fingerprints or a retina scan. It ignorance will proudly wave their flags while

#### CHARGES OF COLLUSION WITH ENRON, **BIG LOSSES RAISE QUESTIONS** ABOUT J.P. MORGAN'S JUDGMENT

In the rubble of recent financial collapses, one prestigious institution seems especially vulnerable: J.P. Morgan Chase & Co., the nation's second-largest bank.

J.P. Morgan fares badly in comparison with big competitors such as Citigroup Inc., the largest U.S. banking concern, and Bank of America Inc., the third largest. Despite their huge losses in Argentina, Enron and other corporate collapses, Citigroup earned \$4 billion and BofA posted a profit of \$2 billion in the fourth quarter, bolstered in part by robust consumer lending.

Morgan, by contrast, lost \$332 million in the fourth quarter, compared with a \$708 million profit a year earlier. For the year, the company still earned \$1.6 billion.

Wall Street's skittishness over projected losses at J.P. Morgan has been apparent in the steady stock selloff in recent weeks after a "parade of train wrecks", in the words of analyst E. Reilly Tierney at Fox-Pitt Kelton in New York.

The stock, which traded above \$40 early in December, hovered near \$32 this week before closing Thursday at \$34.05, up 99 cents a share, on the New York Stock Exchange.

Some analysts remain bullish on Morgan, saying the institution is fundamentally sound and the financial setbacks are only temporary. And by some industry measures, J.P. Morgan's financials look sturdy. A key ratio of nonperforming assets to total assets, for example, was just 0.87 percent as of Dec. 31, well below the 2 percent figure regarded as a sign of potential trouble.

Investors' concerns surfaced in December after Enron's bankruptcy, when J.P. Morgan, which had a reputation for usually disclosing bad news promptly and completely, suddenly tripled its estimate of its potential Enron losses, to \$2.6 billion.

Nearly \$1 billion of the total stemmed from insurers' refusals to pay Enron-related claims on unfulfilled energy contracts. The insurers contended in a lawsuit filed in federal court in New York that the losses resulted from J.P. Morgan's setting up "sham" offshore energy trading concerns to do business with Enron.

J.P. Morgan contends its energy trading companies were above-board, adding that—unlike Enron—it included the results on its balance sheets.

The bank also says the hefty loan losses from the mammoth bankruptcies are a result of J.P. Morgan's position as the leading arranger of the biggest credit lines to the biggest businesses. These so-called syndicated loans are carved up and shared by dozens of banks.

"We're handling 40 percent of the syndicated loans,

and when companies go down we tend to be exposed," said J.P. Morgan spokeswoman Kristin Lemkau.

But other banks in the syndicates typically take on responsibility for more than 90 percent of the amounts lent. Though J.P. Morgan arranged \$1.6 billion in credit lines for Kmart, for example, it had just \$117 million in unsecured loans when the retailer filed for bankruptcy last month. Likewise, though J.P. Morgan had helped arrange \$2.25 billion in loans for Global Crossing, it's The New York company, a lead lender to Enron now owed less than \$100 million by the telecom firm, according to people close to the situation. "They're taking some hits, but they're a big company with a \$41-billion equity base. It's not like they're going out of business," she said.

#### ALL THAT GLITTERS IS NOT GOLD

Even though Enron employees and the company's accounting firm, Arthur Andersen, have destroyed mountains of documents, enough information remains in the ruins of the nation's largest corporate bankruptcy to provide a clear picture of what happened to wreck what once was the seventh-largest U.S. corporation.

Obfuscation, secrecy and accounting tricks appear to have catapulted the Houston-based trader of oil and gas to the top of the Fortune 100, only to be brought down by the same corporate chicanery. Meanwhile, Wall Street analysts and the federal government's top bean counters struggle to convince the nation that the Enron crash is an isolated case, not in the least reflective of how business is done in corporate America. But there are many in the world of high finance who aren't buying the official line and warn that Enron is just the first to fall from a shaky house of cards.

Many analysts believe that this problem is nowhere more evident than at the nation's bullion banks, and particularly at the House of Morgan (J.P. Morgan Chase). One of the world's leading banking institutions and a major international bullion bank, Morgan Chase has received heavy media attention in Still, there's no denying the bank's missteps, which recent weeks both for its financial relationships with bankrupts Enron and Global Crossing Ltd. as well as the financial collapse of Argentina.

One financial analyst, who asked not to be identified, explained the situation this way: "Gold is borrowed by Morgan Chase from the Bank of England at 1 percent interest and then Morgan Chase sells the gold on the open market, then reinvests the proceeds into interest-bearing vehicles at maybe 6 percent. At some point, though, Morgan Chase must return the borrowed gold to the Bank of England, and if the price of gold were significantly to increase during any point in this process, it would make it prohibitive and potentially ruinous to repay the gold."


