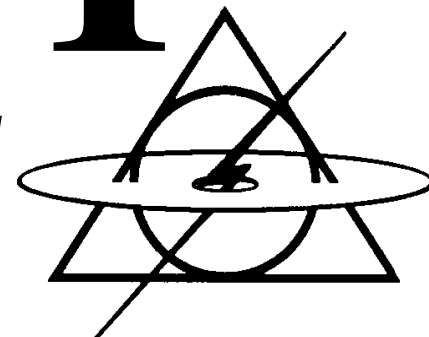

you present? Is there ability to depend on you—or not? That is the question exactly as in “to be or not to be”.

**Hatonn**—I will speak in generalities, for you now have plenty of information to draw a sound conclusion in this matter of signatures, timing and fatal flaws in V.K. Durham's paperwork. And yes, there are enough intentionally fraudulent actions to literally demand judicial investigation.

Are we going to cause that to happen? Certainly at this time, no. If, however, this rapacity of international disinformation does not cease and corrections be made to the charges, yes indeed. That will have to include Bellringer as well and so too will be named *Spectrum* staff who have not only stolen the *CONTACT* directly and continue to advertise "their holdings as valid" for the most damaging one issue they presented, also of the lie, will of necessity be involved because their false presentations have been published and advertised even to a Philippine paper in Mindanao printing total hogwash gathered from them. Mr. Young's editorial with the Mindanao article not only proves it but praises the publication of KNOWN lies. No, I do NOT call a lie a prevarication or spurious (legal use of definition) to be politically somehow "more correct".

I won't ask you to invest in legal counsel or to go to Illinois and Iowa to research Records files. There is no need. Neither will I ask you to waste money in Clark County, Nevada for more accurate files and which will be totally current within a couple of weeks as we add the most recent Public Notice to the official records of OUR documentation. However, if you feel strongly enough about it to do so, please do.

We have no intention of shipping many pounds of paper home to clutter deeper and deeper the remaining people who have to tend the files, to do more at this time as to backup material.

seems necessary. A world waits while V.K. calls us, internationally, dirty names and "dark tainted" from "dark side" energy forms. Hogwash. If you have wish to play in such nonsense, then I suggest you check out those nice energies around V.K. Durham, Bellringer and yes, the *Spectrum* staff. They have literally performed CRIMINAL acts. She has claimed, internationally, that first Doris, then Rick and then you name it, forged Herman's name to the assignment paper. Remember the date: August 5, 1993.

Russell died August 29, 1994.

It is said by V.K. that the ownership was turned over and basically she would have total ownership of Russell Herman's full portion of any holding as from December 2, 1989. But, the document claiming same is so legally unsound as to be discounted as a fraudulent document. Moreover, it was filed "under the shelter" of a Warranty Deed on August 1, 1994.

All of these documents were run in *CONTACT* in the January 30, 2002 edition. Please refer to that so we do not need run it all again. These particular documents are pictured on pages 2, 3, and 4 of that issue.

We have gone over the many things amiss in the documents so will not take time other than to focus on the most deciding one piece of evidence which tells us in V.K.'s own writing that she forged Russell Herman's name to the Transfer of Ownership and did it at the time of filing under the umbrella of the Warranty Deed just named on August 1, 1994.

form itself: "... for and in consideration of *Cosmos Seafood Energy Mkt, Ltd, Nominal DOLLARS in hand paid, CONVEY\_\_AND WARRANT\_\_to [H: Now watch closely.] V.K. Durham, Signatory, & Russell Herman (POA).*"

Without even considering the Russell Herrmann FORGERY, there is now in V.K.'s own writing on that Warranty Deed stating that she has signed "Russell Herman" to "that" particular document in point—the Transfer of Ownership document. And, she did it for filing on August 1, 1994.

Now, readers, that "(POA)" is on both copies. The one she gave us as partners (with information removed) AND on the one with information as to address, etc., intact from Washington County's Recorder Thomas Ganz.

So, please consider here for just a minute. Would Rick Martin, or anyone else, even in a careless moment four years after Russell's death CHOOSE TO COPY A FORGED SIGNATURE ONTO THAT ASSIGNMENT PAPER? It is purely without logic or reason.

V.K. has shouted "dirty tricks" and "fraud" because she knew exactly what she was doing in an effort to discount the assignment. She has just been uncovered—for she, herself, has now stated under oath, before a notary and to be recorded that she used the excuse of a (Power of Attorney [POA]) to enter Russell Herman's signature to that paper transferring, allegedly, Bonus 3392-181 into her ownership.

Moreover, she had to have the name "Russell HERMAN" on the document to legalize use of "COSMOS SEAFOOD ENERGY MARKETING LTD."—for that is the signature and name spelling of "Russell Herman" on his legal documents and at founding of CSEML.

She "thought" she could also simply cry "fraud" and "forgery" on the Assignment by some assumption of a 1989 document (which is a totally fraudulently-drawn document from beginning to end).

There is not so much as a "Notarized" witness or anything similar on that one-page document—transferring the largest holding in the history of the world.

Other clues? Well, for one, in 1989 both V.K. and Russell were in California. [The 60-Day List (of Officers, Directors and Agent) of CSEML signed by V.K. as Secretary, dated February 7, 1990 and received by Secretary of State, Nevada (SOS-NV) February 9, 1990, showed both Russell's and V.K.'s addresses as San Jacinto, California. The 60-Day Lists filed and received by SOS-NV March 29, 1991 and April 3, 1992 both show Russell's address as San Jacinto and V.K.'s as Belleville.] Then when they did move to Illinois (V.K. moved first to Belleville), they moved to the East St. Louis area which is recognized as Belleville—BEFORE going to Okawville. So, the Okawville address ADDED to the Transfer document was added, also, at the time of filing on or about August 1, 1994. Those entries are also undated or witnessed just as the "witnesses" are undated or authenticated in any way whatsoever.

**So, the bottom line? V.K. Durham has, obviously, no ostensible holding as to ownership, half or otherwise, for the document of Transfer is counterfeit at best—totally phony at least.**

**Neither does V.K. Durham have any holding whatsoever in Cosmos Seafood Energy Marketing Ltd. corporation. Furthermore, she was listed as an officer on the records but never as a "Director".**

**She so fouled the paperwork as to the State Officers and Directors listing as to be considered entering a fraudulent document with the State of Nevada. You can have nominees quite legally and nicely in Nevada—you cannot render fraud on the Secretary of State, however. So, V.K. Durham has no registration as claimed of Bonus 2292-181 in either CSEML or with any State. She, further, has no valid "holding trust" which houses either of these things.**

**She claims that writing in the Bonus information WITH the filing of the CSEML annual list of Officers and Directors—gives legality to the claim. No, it proves intentional FRAUD. WE have had control of that corporation, as documented, since at the least 1993 and recognized now as full control since 1985.**

Does V.K. have corporate documents? Probably but that means nothing, for it is known what holdings were actually in holding by CSEML and anything Ms. Durham chooses to destroy only strengthens the case against her as in destroying corporation documents and refusing to turn them over to proper officers and directors—and gives full proof of their existence but our inability to produce same. They exist, for we have copies recorded in the State of Nevada from legal opinions to Peruvian certification and the FED calculations on the value of the interest accrued as established in 1990.

We have authenticated our position and our holdings, duly recorded. And, readers, we did NOTHING except support V.K. Durham even unto her table while she provided us with fraudulent documents to present to the world as valid. Work with her again? No. She has done everything in her power to destroy, damage and even get our people imprisoned. No, we have no intention of even recognizing the party further—except to continue to rebut the lies and criminal actions of same—and her colleagues in her collective.

“ELECTED OFFICIALS WHO FOLLOW CHRIST”

Follow Christ—do you mean in the typical manner in which Christians of today function? It is simply too broad a question to fully interpret; it is not my intention to evade a response, it is simply that I do not recognize the type of “Christian following” and the true “following of the ‘Christed’ path”. Good morning, Dharma. Let us speak of subject material prior to continuing on the *Journal*. I wish to devote a segment in discussion regarding the material sent to GG by Billy Meier. Hello GG

Thank you for your letter as well as for the books.

My material has been used to produce horror stories and to lead the mankind into more confusion.

My comment: The Americans are deceivers, frauds, swindlers, and the first and the last scoundrels in the whole universe.

Look at the enclosed copies.—Eduard A. Meier (BILLY)

The attached materials are both heartbreaking and filled with truth. There are some misinterpretations in the message from a Pleiadian but you must give Billy gracious compassion, for he was having to do much interpretation, for he took notes and then did his writing. It is not as simple for him as for Dharma, for instance, for she simply allows us to utilize her keyboard—undoubtedly the original *JOURNALS* will be somewhat altered as they are translated from one language into that of another. So be it. I shall point out discrepancies. I shall first simply copy the portion:

Onehundredninetythird contact

Tuesday, May 29, 1984 1:44 p.m.

Quetzal: After our last conversation and after inspection of your... Eduard “BILLY” Meier explains:

The real contact person, Mr. Eduard “BILLY” Meier, who has contact with the Pleiadians—SEMJASE-QUETZAL-PTAAH-PLEJA-TALJDA—and others separates himself expressly from association with Dr. Fred Bell and his machinations and pretendings that he, Dr. Fred Bell would have had contacts with the Pleiadian, SEMJASE.

The pretendings of Dr. Bell that he would have had contacts with the Pleiadians and the information that he claims to have gained from them has been classified by the Pleiadians as deceptive and untrue and that he has claimed as his own; information from the contact notes of BILLY.

In reference to the excerpt of translated retyped 193rd contact of Tuesday the 29th of May, 1984, 1:44 p.m. contact between the station Commander of the Pleiadians, Quetzal, and BILLY Meier... following given orders. The first steps concerning our orders have already been taken and we have withdrawn all of our connected groups out of the U.S.A. and Asia, because it doesn’t make sense that fanatics, con men and swindlers use us for the purpose of their own profits. We know this already happened with B. Chriswell and a Dr. Fred Bell (from the USA: noted by Billy), as well as several others, which you have been informed in our last conversations. At that time you mentioned that both Dr. Bell and B. Chriswell have pretended and declared to the public that they have had contacts with SEMJASE, PTAAH and with others of our group in Europe which doesn’t correspond with the truth because we have never had

contacts of any kind with Earth people outside of Europe. Our contacts in Europe now refer to only 4 people, one of them you, two of the other persons are in the meantime deceased, and one other remains. At this time only two contacts are of a conscious form. With you we reserve the physical contact and with the other person only telepathic. That is to say pure telepathic in moderation of impulse. Any other contacts are of the unconscious kind as the connected-to person has no awareness what is happening and the considered Earth person will not have known anything about the contact. As a result of this no Earth people are having conscious contact with either our European, Asian or our group in America. Any person who pretends this must be named a deceiver and swindler. You know very well for yourself why this is and why you are the only “speaking trumpet”, and out of which reasons only you can be our contact person in this given form. In any case we have withdrawn our groups from the U.S.A. and Asia until further notice and until such time as the waves become calm and the truth will penetrate. This will also have some disadvantages of development for these countries and can have some unpleasant political consequences. But never the less we will refrain until the truth will be able to penetrate before we will renew ourselves with the thought to once more base ourselves to aid in the development of the countries of U.S.A. and ASIA....

8th Question: You have many enemies, also particularly in UFO circles. What do they have against you?

Answer: The circles of today’s so-called UFOlogists and contact persons consist mostly of people who do not wish to concern themselves with UFOlogy and truth on a responsible level. Instead, many pursue a bogus study of UFOlogy, bragging and lying about phony contacts, because they want to feed and satisfy their lust for sensationalism, their sectarianism, petty jealousies, know-it-all attitudes and pompousness, their inferiority complexes, and often enough their ego trips. In addition to these others are the alleged “blessed ones”; the god/saints/Jesus delegates; apostles; god and angel messengers; “chosen few”; channellers, and others with supposed extrasensory talents; enlightened ones; seers, revelators, and healers by their own grace, etc. These people are part of the world’s population who manage to charm, exploit, and lie to the gullible and easily-swayed individuals all over the Earth. Truthfully, 99.979% of all of the allegations by these charlatans are based on deliberate fraud, lies, and deceit, including those purportedly contacted by UFOs, ETs, by those on the “other” side, and from other dimensions. These fabrications may also originate from chronic or sporadic schizophrenia or similar mental illnesses. Indeed, of 1 million claims concerning contacts, enlightenment, being the chosen ones, transmittance of messages, and so forth, only 203 (!) are communications of truth and reality, while 999,797 of 1 million claims are deceptions and lies of some sort or another. My enemies are jealous of my contacts with the Pleiadians and feel they would have been a far superior contact person in comparison to me. However, generally are they not only poorly informed about me and my contacts, they really do not have a clue as to the related mission and the

existence and functioning of spiritual levels, energies, laws and commandments, as well as to their truth and mode of action. Not to mention, that they do not have the vaguest idea regarding the existence of Creation, its laws and commandments, or the correlation between Creation, the spirit, and the various levels and life have not only entailed fame (for which they are lusting with all their egos) but also serious problems, e.g., altogether 11 assassination attempts, which had been led against me. Furthermore, these people do not consider that they would be treated with the same hostility they are now showing me.

Most of all, they neglect to even contemplate that I have not only been connected with the mission and its fulfillment for many decades, but for numerous earlier lives; that I have been previously instructed in the elements of strict discipline; that I have had to educate myself in years of toil, with outside help; and that I have had to be able to take over this mission at the designated time, to carry it forward, and to fulfill it. My enemies see only that they cannot play a role in this mission no matter how hard they try. This stirs their envy and hatred on one hand, their frustrations on the other, for they themselves cannot publicize their crazy and wild speculations and sectarian whims on a grand scale. It should be noted, however, that I have no enemies whatsoever in all those many groups of seriously interested people who, with honest and enthusiastic intent, deal with UFO matters and teachings.

Furthermore, they envy my UFO photographs of beamships (verified to be the best in the world), films, slides, metal and crystal samples, etc., and call them fakes. This is consistently the case with pseudo-scientists, dishonest critics, and all those who do not want to accept the truth, for sectarian, religious, political, pseudo-scientific, or other reasons.

A further cause for animosity toward me is the fact that I uncover frauds, liars, schizophrenics, psychopaths, and cheats when they discuss UFOs, contacts with extraterrestrials, contacts with those on the "other side" and in other dimensions. Animosity also occurs with channellers who are considered "blessed", and other superfreaks, etc. I distance myself from these people, and am not afraid to talk with frankness about my knowledge and experiences with them. Of course, all of the frauds, liars, and cheats now maintain that they are part of those 203 of 1 million who are telling the truth, but they do not realize, that they are digging themselves even deeper into their lies.

In second thinking, I believe I will not make comments on the above. I think you ones must come into the discernment and perhaps if enough question, I shall then respond. I urge you to not get yourselves hung up on defensive or offensive strategy but on possible truth involved herein.

AT ANY RATE—WE ARE GOING TO GIVE EDUARD (BILLY) MEIER A FORUM TO BRING HIS TRUTH PUBLIC IN THIS LAND WHICH HAS STOLEN HIS TRUTH, USED HIS PHOTOGRAPHS (AT THE SELF-SAME MOMENT THEY ARE DISCREDITING HIM) AND, IF HE WILL ACCEPT THE FORUM, WE SHALL DO WHAT IS REQUIRED TO BRING HIS TRUTH PUBLIC IN HONESTY.

When we speak of stolen material we speak of almost all of his photographs which were made with our consent and staging and the notes which have been distorted and then projected as if conjured-up lies. There has been a widespread effort to discount his work as I pointedly told you in *SPACE-GATE* and the ones who have deliberately caused slander upon this man shall have their lies discounted.

Yes, it is sad that a man must endure 11 assassination attempts—but so do all who bring truth; Dharma has had more and with actual success on three occasions. ## CIA MET WITH IRAQI OPPOSITION

WASHINGTON—A CIA team visited northern Iraq last month for meetings over three days with Kurdish officials opposed to President Saddam Hussein, U.S.-backed Iraqi dissidents here said yesterday.

The team included the CIA's station chief in Turkey and three other agents, who visited leaders of the two main Kurdish factions in the northern town of Suleimaniyya and a second town near Erbil, the dissidents said.

They described the visit, which followed a trip in December by a State Department team led by diplomat Ryan Crocker, as different from past forays because it was designed to gauge the Kurds' willingness to take part in specific U.S.-backed efforts to oust Hussein.

"This was a different visit," one Iraqi opposition leader said on condition of anonymity. "They were asking under what conditions they would cooperate in the overthrow of Saddam."

The London-based Arabic newspaper *Al-Hayat* yesterday quoted unidentified sources as saying another team of seven CIA officers and military intelligence staff is currently in northern Iraq. The Hague-dated report said the team is scouting three bases that could land aircraft in Kurdish-controlled territory with an eye toward creating a staging point for future U.S. opposition to the Iraqi leader—much as the United States did with the Northern Alliance in Afghanistan.

The CIA refused to comment on either reported visit, but Iraqi officials in Washington said they doubted reports of the current visit detailed in *Al-Hayat*. "The Americans know these bases inside out. They don't need to visit them," one said.

The Iraqi opposition maintains contacts inside Iraq and is often one of the few conduits for information that comes out of one of the world's most repressed countries. Opposition leaders have said they fear the United States is not serious in toppling Hussein, but most support U.S. intervention as the only way to topple a leader who is zealous in countering any domestic dissent...

One plan backed by some members of Congress and staff in the Pentagon envisions a scenario that draws heavily on the experience in Afghanistan. Under that plan, U.S. bombing would target Iraqi command centers, tanks, and the Republican Guard, while opposition forces would attack Iraqi forces in the Kurdish-controlled north and the south, which is dominated by Shiite Muslims.

The State Department has long dismissed the capability of the Iraqi opposition, particularly the Iraqi National Congress. That group acts as an umbrella group that technically includes the Kurds and all opposition forces and has received more than \$12 million in U.S. funds since 1998....

In part to address that concern, the INC announced yesterday that it would bring more than 200 former Iraqi military officers to a meeting in Washington next month in what it envisions as a high-profile sign that it can field an effective opposition to Hussein....

For years, the opposition has been driven by disputes that fall along ethnic and sectarian lines.

The majority in Iraq is Shiite Muslim, the dominant group in the south. But the main Shiite opposition group is allied with Iran, and has distanced itself from the INC, citing the U.S. support it receives.

The Kurds exercise autonomy in the north along the Turkish border, but are wary of getting too involved in U.S. efforts that, if unsuccessful, will inevitably expose them to Hussein's wrath. The two main groups—the Kurdistan Democratic Party and the Patriotic Union of Kurdistan—eye each other warily in competition that occasionally turns bloody....

The *New York Times*, quoting State Department officials, reported today that the Bush administration is prepared to finance the construction of a radio transmitter in the Kurdish enclave in Iraq or in neighboring Iran so that the Iraqi opposition can begin broadcasts to encourage opposition to Hussein.

"We have given tentative approval to the concept of putting a transmitter in Iraq or Iran, but we cannot support it unless the Kurds or Iranians agree," the *Times* quoted one State Department official as saying. **[JR: The U.S.'s well-advanced plans to extend the "war on terrorism" to Iraq are in total disregard to the world's concerns and opinions against it. The U.S.'s war to finish off Iraq has entered stage II. Now all these plans just didn't come together yesterday but have continued since the Gulf War ended. We Americans should be outraged that we are constantly being lied to and information is being withheld from us by the President, the military and the media. ## BLAIR AND BUSH TO PLOT WAR ON IRAQ

Tony Blair and the United States President George Bush are to hold a specially convened summit in April to finalise details of military action to overthrow Saddam Hussein.

Blair will travel to Washington in six weeks' time in a clear signal that Downing Street fully backs Bush's plans to launch a war against Iraq if Saddam does not agree to deadlines to destroy his arsenal of weapons of mass destruction.

"The meeting will be to finalise Phase Two of the war against terrorism," a senior Number 10 official said. "Action against Iraq will be at the top of the agenda."

With evidence growing of a Labour Party backlash over American action against Saddam, the Government is now planning to publish for the first time detailed evidence of Iraq's nuclear capabilities. The document will reveal that Saddam is attempting to amass rudimentary nuclear capabilities and is also investigating a way to launch "dirty" nuclear bombs—unsophisticated devices which would nevertheless wreak havoc if ever used.

Western intelligence services also believe Saddam is developing biological and chemical devices which could kill and maim tens of thousands of people.

The Number 10 official said that, as with Osama bin Laden and the war in Afghanistan, it is necessary to maintain public and international

support for military action against Saddam.

It was a "public persuasion" issue and would be tackled in the same way as the unprecedented "indictment" against bin Laden published by Downing Street last year with the agreement of the White House.

Bush has been under increasing attack from Europe over his desire to see Saddam removed from power. His "axis of evil" speech earlier this year, when he named Iraq, Iran and North Korea as international pariah states, has been attacked by both the French Prime Minister, Lionel Jospin, and the European Union commissioner for external affairs, Chris Patten. The Foreign Office in particular is irritated by the bellicose language, which officials said revealed that hawkish elements in Washington had won over the President's mind.

But *The Observer* can reveal that Blair has told his inner circle that he believes the attacks on the President are misplaced and that it is only by the threat of action that reformist elements within Iraq will be encouraged to rise up against Saddam.

In a series of long telephone conversation over the past two months, Bush has kept Blair aware of his plans for military action. Although there is no evidence of any link between Iraq and the attacks of 11 September, both leaders will make it clear that "weapons of mass destruction" are a legitimate target for military action. "The alliance with the United States is strong, it will remain strong," Blair said yesterday at a meeting of European leaders in Stockholm. ...

In an interview to be broadcast by the BBC's *On the Record* programme today, U.S. Assistant Secretary of State, Beth Jones, admitted that "nothing was off the table" when it came to Iraq. ...

The April summit will significantly increase world tension on the issue as Middle East nations watch warily for any signal that Bush will act precipitately against Saddam.

Many Muslim leaders fear a leadership vacuum and political chaos in Iraq, which could affect the standing of neighbouring countries in the region.

It now seems likely that Saddam will be set a deadline to allow in weapons inspectors who will oversee the destruction of Iraq's weaponry or face military consequences.

The Prime Minister is aware of a growing revolt within his own party and some elements of the British military against action in Iraq.

Intelligence officials in Britain have told *The Observer* that there is concern about over-committing in Iraq and of making military promises that cannot be kept. ...

### ANTI-TERROR ASSISTANCE IN GEORGIA

The Pentagon has begun providing combat helicopters to the former Soviet republic of Georgia and will soon begin training several Georgian battalions to counter what defense officials believe is a growing terrorist threat in the country's mountainous Pankisi Gorge region, senior U.S. officials said yesterday.

The move to train and equip the Georgian military opens a new front in the Bush administration's war on terrorism and is fueled by a belief shared by the United States and Georgia that al-Qaida members and other Islamic extremists from Chechnya have taken refuge in northern Georgia along the Chechen border.

The mission also represents a belief by the Bush administration that Arab fighters connected to al-Qaida have joined Chechen rebel forces to battle the Russian army, an assertion long made by Russia's president, Vladimir Putin, but publicly doubted until now in Washington. "We have a clear connection between Chechens and al-Qaida. They clearly fall under the potential targets of the global war on terrorism," said a U.S. defense official.

About 40 U.S. military personnel, including Special Forces troops, visited Georgia this month to assess Georgia's security needs, according to Lt. Col. Ed Loomis, a spokesman for the U.S. military's European Command near Stuttgart, Germany. The assessment team has filed its report, which is now the basis of the Pentagon's deliberations, he said.

The Pentagon has already provided the Georgian government with 10 UH-1H Huey helicopters, six for operations and four for spare parts, Loomis said. A U.S. military trainer and six contractors are in Tbilisi, the Georgian capital, training Georgian personnel in how to operate the aircraft.

In taking its war on terrorism to Georgia, the administration is also seeking to bolster the standing of Eduard Shevardnadze, Georgia's president, and build stability in the volatile Caucasus region. Georgia, a transit point for Caspian oil and an aspiring member of NATO, has been considered a U.S. ally since it won independence from the Soviet Union in 1991.

"We're only beginning down this path," said an administration official, discussing the Pentagon's reconnaissance trip. "What we've decided to do is think more creatively. That requires a harder look at the real situation on the ground. And doing this in a way that ensures that the Georgians and the Russians are consulted fully—and that in the end, it's a cooperative effort..."

U.S. officials said there is not an explicit goal of training Georgian forces to capture suspected terrorists, but one policymaker said the potential to question fighters in the Pankisi Gorge is "an element" of the administration's thinking.

Russian reaction to the U.S. mission in Georgia has ranged from fear that the United States is seeking a fresh foothold in the Caucasus to satisfaction that the U.S. government is acknowledging that some fighters in Chechnya and others in Georgia are connected to international terrorism. Russian troops have battled Chechen rebels in the region since 1994 in an effort to put down a separatist movement. The Russian military's tactics—and Moscow's heavy-handed rule—have been sharply criticized by international human rights groups....

The Bush administration, which already supports the Georgian government with millions of dollars in assistance each year, has urged Russia to back off. U.S. officials concluded they would have a stronger argument if they were helping Georgia to exert control over the Pankisi Gorge....

#### SENATOR, RUSSIA BALK OVER TROOPS IN CAUCASUS

WASHINGTON—Reports that the Bush administration is preparing to expand its fight against terrorism by sending U.S. troops to the former Soviet republic of Georgia provoked concern Wednesday from Capitol Hill to Moscow.

Russian Foreign Minister Igor Ivanov said such a move "could further aggravate the situation in the region, which is difficult as it is."

At a hearing in Washington, meanwhile, Senate Appropriations Committee Chairman Robert Byrd (D-W. Va.) warned that the administration should not expect "blank checks" to expand anti-terrorist operations indefinitely.

"If we expect to kill every terrorist in the world," Byrd said, "that's going to keep us going beyond doomsday."

The U.S. forces reportedly would number in the low hundreds. They would train and equip the Georgian military and not directly engage in combat, officials said.

The target would be Islamic militants in Georgia's Pankisi Gorge, which borders the breakaway Russian republic of Chechnya. American and Georgian officials say al-Qaida fighters have moved into the remote and mountainous region, where Chechen rebels fighting Russian rule also take refuge.

The administration hastened on several fronts to downplay the significance of the Georgia proposal. They pointed out that the U.S. military has been cooperating with Georgia for much of the last decade since the Soviet Union broke up and Georgia became one of 15 independent states to emerge from the USSR. They also said no final agreement had been reached on deployment.

Marine Corps Gen. Peter Pace, vice chairman of the Joint Chiefs of Staff, said the U.S. military presence in Georgia amounts so far to seven technical advisers. They are helping the Georgians maintain and operate 10 unarmed Huey helicopters provided by the U.S., Pace said.

After a speech in Charlotte, President Bush said that American assistance to the Georgian military amounted to "mainly equipment and technical advice" and that any cooperative military effort is contingent on the Georgian government's requesting U.S. help.

But Bush was adamant that he intends to carry his anti-terrorist campaign to wherever terrorists are found. He also hinted there may be other U.S. military operations the public doesn't know about.

"When this war started, I told the American people that there would be a variety of fronts on the war against terrorism, some of which would be very visible, some of which we wouldn't see much about," Bush said.

State Department spokesman Richard Boucher said the U.S. has no plans for its troops to be used in combat....

He said U.S. involvement in the Caucasus region would serve Russia's best interests.

"We are working for the stability and the security of the Caucasus," he said. "We believe that Georgia's ability to handle these types of problems on its own is also in Russia's interests."

But the Russians made clear their displeasure to what would be a fresh American military deployment in their back yard. Russian generals have been pushing for a joint Russian-Georgian military operation, a suggestion routinely brushed aside by officials in Tbilisi.

Georgia's inability or unwillingness to block Chechen rebels from using the rugged Pankisi Gorge as a haven from Russian offensives is an increasing irritant to the Russian military.

Gen. Pace said it is still early in the planning process.

"So the number of trainers and the duration, those kinds of things, are all part of what would eventually come forward," Pace said. He said arrangements for the 10 helicopters were made months ago and were intended to help the Georgian military with mobility.

#### RUSSIAN PARLIAMENT MAY PUSH FOR RECOGNIZING INDEPENDENCE OF GEORGIAN PROVINCES

MOSCOW (AP)—Signaling Russia's alarm over a possible U.S. military deployment in Georgia, a senior lawmaker said Thursday that the parliament might call on the government to recognize the independence of Georgia's breakaway provinces.

Dmitry Rogozin, the head of the State Duma's foreign affairs committee with close links to the Kremlin, said his committee has scheduled hearings on the issue next week....

Georgia's decision to invite U.S. troops to train its security forces to battle gunmen with possible links to the al-Qaida network terrorist network has drawn widespread concern in Russia.

U.S. and Georgian officials insist no U.S. troops would be involved in combatting rebels holed up in the Pankisi Gorge bordering Russia's breakaway republic of Chechnya.

But Russian officials are especially vexed that Georgia asked for American assistance while refusing to let Russian troops sweep the gorge, about 180 miles east of Abkhazia and some 50 miles east of South Ossetia.

Russian Foreign Minister Igor Ivanov told Secretary of State Colin Powell on Wednesday that Washington should "take into account" Russia's "well-founded concerns that the direct involvement of American troops

in anti-terrorist activities on Georgian territory could further complicate the situation in the region,” the Russian Foreign Ministry reported.

Georgian President Eduard Shevardnadze said Thursday that the plan for U.S. military experts to train one or two military units “as the standard” for the rest of Georgia’s armed forces had provoked “true hysteria, and it’s hard for a self-respecting person to reconcile himself with this.”

“I think that partnership and cooperation with the United States is a good shield for Georgian security,” Shevardnadze told reporters.

**[JR: Pres. Shevardnadze is vulnerable because of the poverty and economic problems under his leadership and the issue of rampant corruption in his government. Shevardnadze’s agreement to allow U.S. troops in Georgia is payback time for eight years of planning and U.S. aid. If the breakaway provinces are persuaded to go along with Russia, Georgia won’t be left to its own fate.]**

#### SHADOW GOVERNMENT IS AT WORK IN SECRET

President Bush has dispatched a shadow government of about 100 senior civilian managers to live and work secretly outside Washington, activating for the first time long-standing plans to ensure survival of federal rule after catastrophic attack on the nation’s capital.

Execution of the classified “Continuity of Operations Plan” resulted not from the Cold War threat of intercontinental missiles, the scenario rehearsed for decades, but from heightened fears that the al-Qaida terrorist network might somehow obtain a portable nuclear weapon, according to three officials with firsthand knowledge. U.S. intelligence has no specific knowledge of such a weapon, they said, but the risk is thought great enough to justify the shadow government’s disruption and expense.

Deployed “on the fly” in the first hours of turmoil on Sept. 11, one participant said, the shadow government has evolved into an indefinite precaution. For that reason, the high-ranking officials representing their departments have begun rotating in and out of the assignment at one of two fortified locations along the East Coast. Rotation is among several changes made in late October or early November, sources said, to the standing directive Bush inherited from a line of presidents reaching back to Dwight D. Eisenhower....

Known internally as the COG, for “continuity of government”, the administration-in-waiting is an unannounced complement to the acknowledged absence of Vice President Cheney from Washington for much of the past five months. Cheney’s survival ensures constitutional succession, one official said, but “he can’t run the country by himself.” With a core group of federal managers alongside him, Cheney—or President Bush, if available—has the means to give effect to his orders....

The Washington Post agreed to a White House

request not to name any of those deployed or identify the two principal locations of the shadow government. **[JR: Anyone in the need of more detailed information read Journal # 3, *Space-Gate, The Veil Removed*, pages 55-63 written by GCH August 20, 1989! Call 1-800-800-5565 for ordering information.]**

Only the executive branch is represented in the full-time shadow administration. The other branches of constitutional government, Congress and the judiciary, have separate continuity plans but do not maintain a 24-hour presence in fortified facilities....

Many departments, including Justice and Treasury, have completed plans to delegate statutory powers to officials who would not normally exercise them. Others do not need to make such legal transfers, or are holding them in reserve.

Deployed civilians are not permitted to take their families, and under penalty of prosecution they may not tell anyone where they are going or why. “They’re on a ‘business trip’, that’s all,” said one official involved in the effort.

The two sites of the shadow government make use of local geological features to render them highly secure. They are well stocked with food, water, medicine and other consumable supplies, and are capable of generating their own power....

Last Oct. 8, the day after bombing began in Afghanistan, Bush created the Office of Homeland Security with Executive Order 13228. Among the responsibilities he gave its first director, former Pennsylvania governor Tom Ridge, was to “review plans and preparations for ensuring the continuity of the Federal Government in the event of a terrorist attack that threatens the safety and security of the United States Government or its leadership.”

#### CONGRESS NOT ADVISED OF SHADOW GOVERNMENT

Key congressional leaders said yesterday the White House did not tell them that President Bush has moved a cadre of senior civilian managers to secret underground sites outside Washington to ensure that the federal government could survive a devastating terrorist attack on the nation’s capital.

Senate Majority Leader Thomas A. Daschle (D-S.D.) said he had not been informed about the role, location or even the existence of the shadow government that the administration began to deploy the morning of the Sept. 11 hijackings. An aide to House Minority Leader Richard A. Gephardt (D-Mo.) said he similarly was unaware of the administration’s move.

Among Congress’s GOP leadership, aides to House Speaker J. Dennis Hastert (Ill.), second in line to succeed the president if he became incapacitated, and to Senate Minority Leader Trent Lott (Miss.) **said they were not sure whether they knew. [JR: Are they really that stupid?]**

Aides to Sen. Robert C. Byrd (D-W. Va.) said he had not been told. As Senate president pro tempore, he is in line to become president after the House speaker.

Bush acknowledged yesterday that the administration had taken extensive measures to guarantee “the continuity of government”, after it was revealed that about 100 top officials, spanning every executive branch department, have been sent to live and work in two fortified locations on the East Coast. This system, in which high-ranking administrators are rotating in and out of the two sites, represents the first time a president has activated the contingency plan, which was devised during the Cold War of the 1950s so that federal rule could continue if Washington were struck by a catastrophic attack.

It was unclear yesterday whether any federal documents—prepared either by the current White House or by Bush’s predecessors dating to Dwight D. Eisenhower—specify whether congressional leaders should be told if the plan is put into effect. At least one relatively general document, a 1988 executive order entitled “Assignment of Emergency Preparedness Responsibilities”, said the White House’s National Security Council “shall arrange for Executive branch liaison with, and assistance to, the Congress and the federal judiciary on national security-emergency preparedness matters.”

The executive order, signed by President Ronald Reagan, is a precursor to documents outlining the contingency plans in greater detail, which have not been made public. Regardless of whether Bush had an obligation to notify legislative leaders, the congressional leaders’ ignorance of the plan he set in motion could raise the question of how this shadow administration would establish its legitimacy with Congress in the event it needed to step in for a crippled White House.

At least some members of Congress suggested yesterday that the administration should have conferred about its plans, which were first reported in the *Washington Post* yesterday.

“There are two other branches of government that are central to the functioning of our democracy,” said Rep. William Delahunt (D-Mass.), a member of the House Judiciary Committee. “I would hope the speaker and the minority leader would at least pose the question, ‘What about us?’”

Other lawmakers said they believe the federal government lacks adequate plans to be certain that all three of its branches could function if terrorists disabled Washington.

White House officials did not elaborate on why the president did not consult with congressional leaders. “The president addressed this earlier today, and I will have to refer you to his comments,” spokesman Taylor Gross said.

Speaking yesterday on a trip to Des Moines, Bush did not describe the deployment in detail. He said he had “an obligation

as the president [to] put measures in place that, should somebody be successful in attacking Washington, D.C., [would guarantee] there's an ongoing government."

"This is serious business," the president said. "I still take the threats that we receive from al-Qaida killers and terrorists very seriously." He made clear the extent to which he believes that terrorism poses a lingering threat to the U.S. government. "That's one reason why the vice president was going to undisclosed locations," Bush told reporters.

"And I will tell you, there are people still in this world who want to harm America," the president said, vowing that "we're doing everything in our power to protect the American people."

At the Pentagon, which routinely rotates top military officials to secure locations, spokeswoman Victoria Clarke said: "It is absolute common sense, absolutely appropriate that the government should have all the parts and all the pieces in place so in case of a crisis, in case of an emergency, the government can and will continue to function."

The House and Senate each has a contingency plan. "Precautions have been taken and arrangements have been made to move the work of Congress to another location," Daschle said....

#### U.S. WON'T STAY ON TOP, SAYS CLINTON

SYDNEY (AAP)—Acknowledging the United States would not be the world's most powerful nation forever might lead to a better approach in its current international relations, former U.S. president Bill Clinton said today.

Speaking at the 2002 World Congress on the Peaceful Reunification of China and World Peace in Sydney, Mr. Clinton said this "brief moment in history" when the U.S. had pre-eminent military, economic and political power would not last.

"This is just a period, a few decades this will last, and I think that all of us who are Americans should think about this and ask ourselves how do we wish this moment to be judged 50 years from now," he said.

"And how would we like to be treated when we no longer have this pre-eminent position and we have to work in a cooperative fashion with others to a far greater extent than we have to do today.

"It seems to me if we would think about it like that it would be much more likely to lead all Americans, without regard of their party, to making the right decisions about how we should approach a lot of these problems that we face."

The former president said he did not want to be critical of the current U.S. Administration.

"I feel that I should be careful in what I say [but] I believe that the [current U.S.] President has been much more interested in international cooperation since September 11<sup>th</sup>, and I take that to be a very positive sign," Mr. Clinton said.

He also said he hoped President George W. Bush's recent visit to Korea would have a positive outcome.

"I certainly have no illusions about the North Korean Government," he said.

"... But the fact is they ended their nuclear program in '94, in '98 they ended testing of long-range missiles and in 2000 we had the elements of an agreement with them to end their entire missile program."

Mr. Clinton's comments come after Mr. Bush named North Korea as one country in its "axis of evil" along with Iraq and Iran last month.

#### ACTIVIST WARNS OF BORDER WAR

A border war between the United States and Mexico "could happen any day," a California activist warned at a weekend conference in Virginia.

"We have on our hands a Mexican border civil war that could happen tomorrow," said Glenn Spencer of Voices of Citizens Together, a Los Angeles-based group that supports stronger enforcement of immigration laws. "I think it's a matter of time."

Detailing statements by Mexican-American leaders advocating "reconquista"—the reclaiming by Mexico of territory that the United States captured in the 1800s—Mr. Spencer said millions of illegal immigrants flooding into California and other states in the Southwest are the foot soldiers of this movement. ...

The flood of illegal Mexican immigrants has transformed southern California, Mr. Spencer said. He cited the San Fernando Valley area near Los Angeles, which was 24 percent Hispanic in 1992, but is now 52 percent Hispanic.

While the U.S. Hispanic population is growing, so is anti-American sentiment in Mexico, where Mr. Spencer said "I love Osama bin Laden" T-shirts were popular after the September 11 attacks.

Southern California's powerful labor unions, Mr. Spencer said in his Saturday speech, are now controlled by Mexican-American leaders who have hinted at a general strike if Washington does not meet their demands for amnesty for illegal immigrants. Hispanic activists turned out more than 100,000 marchers to protest Proposition 187, the California ballot initiative limiting benefits for illegals that passed in 1994.

With hundreds of Mexicans illegally crossing the United States' southwest border daily, Mr. Spencer said, conflict between the U.S. Border Patrol and Mexican authorities could touch off

strikes, protests and riots by Hispanic militants in the United States—a combination border war and civil war that "could happen any day," he said. ...

"Illegal immigration is essentially creating a Third World nation in Southern California," he said. Los Angeles has been called "the nation's poverty capital" and California has "the worst public schools in the nation," Mr. Spencer said, adding that the state is facing a \$20 billion budget deficit.

But the responses of Mexican-American militants to Proposition 187, including their claims to California as "Aztlán"—an independent Hispanic territory—alarmed Mr. Spencer. "I was stunned by what they were saying. ... We weren't just importing poverty, we were importing revolution." ...

President Bush, however, is reportedly considering granting legal residency to Mexicans residing here illegally.

"It is stunning to me that the president of the United States could propose amnesty for 11 million illegal immigrants," Mr. Spencer said.

**[JR: The issue to create an Aztlán is not a fantasy and is becoming a critical issue in the Southwest states that border Mexico. We need to increase patrolling our borders because of the influx of immigrants and the control that the reconquista political activists have over them over this issue. When Pres. Bush and Pres. #### SENATOR SAYS NATIONAL GUARD TROOPS WILL BE GUARDING NATION'S BORDERS SOON

WASHINGTON—National Guard troops could be helping police the U.S. border within three weeks, Homeland Security Director Tom Ridge told a senator Friday.

In a phone call to Sen. Patty Murray, D-Wash., Ridge said processing and deployment of the Guard troops will begin immediately.

The Justice Department, which oversees the Immigration and Naturalization Service, signed off on an agreement to use the troops this week. The Treasury Department, parent agency of the Customs Service, is expected to do the same Tuesday.

"There are two things that are important," Murray said. "One, that we get these people trained, and they get on the border; and secondly, that we replace them as quickly as possible with INS agents and Border Patrol, because this should not be a permanent solution."

She said Ridge told her the troops will be in place in three weeks "at the latest", sooner if states have troops identified for the assignment. Ridge's office could not be reached for comment.

The government will pay for the Guard troops and keep them under federal authority, taking command from the governors.

More than 1,500 troops could help with security at ports of entry, intelligence operations and cargo or vehicle inspections, among other tasks.

Just who will be in charge of the troops has been in question since Attorney General John Ashcroft announced in December that they would be placed at key crossings nationwide to provide extra support after the Sept. 11 terrorist attacks.

The National Guard Bureau, some members of

Congress and others were opposed to keeping the troops under federal control, because they argued it would slow down the deployment and be more costly.

#### IRANIAN LEADER ACCUSES U.S. OF SEEKING WORLD DOMINATION

TEHRAN, Iran (AP)—The Bush administration’s claim of fighting terrorism and promoting peace in the Middle East is a cover for its goal of dominating and controlling the wealth of other nations, Iran’s supreme leader Ayatollah Ali Khamenei said, state-run Iranian radio reported Thursday.

“The rhetoric of the U.S. administration in fighting against terrorism and defending the peace process in the Middle East are only a cover for the hegemonistic plans of the United States to dominate and control the wealth and vital resources of other nations,” Khamenei said....

“It is a shame that a country with a long record of sponsoring terrorist operations, a country that planned and undertook military coups in many parts of the world, a country with the largest arsenal of weapons of mass destruction, and a country that continues to support the most dangerous terrorists of the world is now going to take the lead in the war against terrorism,” Khamenei said, referring to the United States.

Early in the U.S. war on terrorism, American officials spoke of better cooperation with Iran after it tacitly approved their campaign to topple the Taliban rulers of Afghanistan. But recently, U.S. officials have accused Tehran of trying to undermine Afghanistan’s new government and of smuggling weapons to the Palestinians. Iran denies the charges.

Last month, President Bush said in his State of the Union address that Iran was part of an “axis of evil”—along with Iraq and North Korea—because it seeks weapons of mass destruction, an allegation Iran denies.

“Our Islamic country is accused by the White House rulers of trying to undermine the Middle East peace process. They can never realize that the violation of the inalienable rights of the Palestinian people, and occupation of their land can never be called peace,” Khamenei said.

#### FORMER LIBYAN PM ON “THE U.S. AND THE COMPLEXITIES OF THE ARAB MIND”

In a recent article in the London Arabic daily *Al-Hayat*, former Libyan prime minister Abd Al-Hamid Al-Bakkoush criticized anti-U.S. sentiment among Arabs. Following are excerpts from the article “The Arab Propaganda Battle Against the U.S. is a Failure”:

“To begin with, I would say that the U.S. has policies that have damaged, and continue to damage, some Arab interests. I have no intention of defending these policies. However, while we are entitled to criticize this great modern American power—even to hate her—denying the might of the U.S. only damages us.”

“The U.S. is a country of power and means, with the greatest capability in the modern age. It influences policy across the world. Therefore, it would be wise to regard [the U.S.] as an international reality, to learn its policies, and to demonstrate the required realism in our relationship with her.”

“Have we done this? Absolutely not! Since the days of Abd Al-Nasser, in the early 1950s, we have waged an amazingly fierce propaganda war against America. This leader [Nasser] made the war of words against America a reason for revolutions and rebellions against any monarchic regime with any connection whatsoever to America.”

“[Nasser] made fighting America a major element of Arab foreign policy. Many governments used the media to implant in our minds hostility towards all things American—to the point where we became suspicious of the patriotism of anyone less than enthusiastic about hating Americans.”

“Naturally, there was a reason for the rivalry with this leader of the West [the U.S.], as it was America who aided in the establishment of the state of the Jews in Palestine, and then never ceased strengthening it. This American behavior, in and of itself, justifies opposition to American policy on this matter. But our zealous behavior and our broadening of the disagreements with the U.S. were never a successful policy.”

“Yes, America was our opponent on the Palestine issue, but as a people ruled by social fragmentation, weakness, and confusion—it would have been better had we not declared an all-out war on everything Americans represent—as we have.”

“Our extremely naïve leaders have waged wars against America, while brandishing media swords and shooting from the cannon of speeches. Obviously, political battles with words lead to failure and confusion, and nothing more. Thus, we spent a fair amount of time voicing blazing slogans against America. We turned to anyone with a quarrel with [the U.S.], from the U.S.S.R. to the Dominican [Republic]. We were, all the time, doing our best to clear our minds of any realistic policy. We reached a point where we portrayed countries that were [nothing more than] gangs as Paradise and despots such as Castro and Idi Amin as heroes of liberation and the struggle against colonialism.”

“We indulged in the fantasy—and perhaps still do—that hostility towards America heads our list of priorities. We defined an Arab citizen as either loyal or traitorous according to his outward hostility to the Americans.”

“We did all this while ignoring the fact that America, which we hate, is an international and powerful reality, whose influence over many of our vital interests we cannot escape. We ignored the fact that it would be wise to view America with a realism that can protect our interests.”

#### Anti-U.S. Incitement Has Caused Us (Arabs) Damage

“Osama bin Laden was not the first to threaten to destroy America. Many among us preceded him, threatening to bring disaster upon it to the cheering of the masses. Ideological and religious leaders, and not only rulers, still use their tongues and their pens to destroy and humiliate America—even though this naïve anti-American policy has caused us only damage.”

“Perhaps it is time we realized that wisdom dictates that we treat the leader of the West realistically.”

“Realism does not mean submission to the goals of another, rather, it means treating it in a way compatible with our means so as to minimize damage. America has many interests in our region that it needs to protect... It is a country with a right to protect its interests just as we have. Although the U.S. is an elusive power, it is not a despotic power that cannot be influenced. Perhaps most of the things we complain of... stem from our own flaws.”

#### We Must Rid Ourselves From Our Fanaticism

“It is the Arab policy that sowed strife amongst Arab countries. It was Iraq’s invasion of Kuwait that created the need for direct American protection.”

“This is the Arab political reality that began the day some leaders instilled within us the intoxication of victory, and the fantasies of brotherhood with the U.S.S.R. and of leadership of the nonaligned states bloc.”

“We should not have joined the anti-American groups when we excel at nothing. Confronting the U.S. when we do not have the means for confrontation cannot be called wise. We must rid ourselves, as much as possible, from our [present] political thought, from our fanaticism...”

**[JR: Libyan Prime Minister Al-Bakkoush seems to present a conciliatory attitude towards the U.S. in order to defuse Arab hostilities. Arab leaders have long taken an expedient approach regarding the U.S.’s influence and power. They have dealt in abstracts of idealism backed with a war of words that has done little in attaining a peace for them in the Middle East. #### THE STRATEGIC FUNCTIONS OF U.S. AID TO ISRAEL

Since 1992, the U.S. has offered Israel an additional \$2 billion annually in loan guarantees. Congressional

researchers have disclosed that between 1974 and 1989, \$16.4 billion in U.S. military loans were converted to grants and that this was the understanding from the beginning. Indeed, all past U.S. loans to Israel have eventually been forgiven by Congress, which has undoubtedly helped Israel's often-touted claim that they have never defaulted on a U.S. government loan. U.S. policy since 1984 has been that economic assistance to Israel must equal or exceed Israel's annual debt repayment to the United States. Unlike other countries, which receive aid in quarterly installments, aid to Israel since 1982 has been given in a lump sum at the beginning of the fiscal year, leaving the U.S. government to borrow from future revenues. Israel even lends some of this money back through U.S. treasury bills and collects the additional interest. In addition, there is the more than \$1.5 billion in private U.S. funds that go to Israel annually in the form of \$1 billion in private tax-deductible donations and \$500 million in Israeli bonds. The ability of Americans to make what amounts to tax-deductible contributions to a foreign government, made possible through a number of Jewish charities, does not exist with any other country. Nor do these figures include short- and long-term commercial loans from U.S. banks, which have been as high as \$1 billion annually in recent years.

Total U.S. aid to Israel is approximately one-third of the American foreign-aid budget, even though Israel comprises just .001 percent of the world's population and already has one of the world's higher per capita incomes. Indeed, Israel's GNP is higher than the combined GNP of Egypt, Lebanon, Syria, Jordan, the West Bank and Gaza. With a per capita income of about \$14,000, Israel ranks as the sixteenth wealthiest country in the world; Israelis enjoy a higher per capita income than oil-rich Saudi Arabia and are only slightly less well-off than most Western European countries. AID does not term economic aid to Israel as development assistance, but instead uses the term "economic support funding". Given Israel's relative prosperity, U.S. aid to Israel is becoming increasingly controversial. In 1994, Yossi Beilen, deputy foreign minister of Israel and a Knesset member, told the Women's International Zionist Organization, "If our economic situation is better than in many of your countries, how can we go on asking for your charity?"

**[JR: Most Americans, especially the Christian right, have been brainwashed to believe that Israel is a small vulnerable state surrounded by enemies. #### SPECULATION OVER GREENSPAN'S FUTURE

WASHINGTON (AP)—Alan Greenspan has held what is often called the second most powerful job in the country for more than 14 years and under four presidents.

Wall Street is beginning to wonder, however, whether the chairman of the Federal Reserve will stick around until his current term ends in June 2004.

"There has been all sorts of speculation that Greenspan is going to resign early," said David Jones, chief economist at Aubrey G. Lanston & Co. in New York.

The Blue Chip Economic Indicators forecasting newsletter even polled its 52 top economic forecasters this month for their picks of who should succeed Greenspan.

Those who believe the chairman may be contemplating an early exit note that Greenspan will turn 76 next week and would be 78 at the end of his current term.

They contend this would be the perfect time for Greenspan to bow out gracefully, with Fed interest rate policy expected to be on hold for much of this year after its aggressive rate cuts last year aimed at pulling the country out of recession.

Greenspan delivered the central bank's assessment of the state of the economy Wednesday, which he does twice a year, before the House Financial Services Committee.

In advance of those remarks, many analysts were betting that Greenspan would strike an upbeat tone, especially in light of a number of recent statistics that have flashed strong signals that the country's first recession in a decade is over.

But analysts believe he will also stress that the recovery, at least in its initial stages, is likely to be fragile. That would mean the central bank will not feel a need to move quickly toward reversing its rate cuts of last year with interest rate increases.

All of this should be good news to financial markets.

Because of the widespread view that the economy is on the mend, many analysts think Greenspan might choose this year or next to bow out. They also say the presidential election calendar could play a role in his decision.

If Greenspan should wait until his term ends in 2004, it would mean Bush would have to win approval of Greenspan's successor in the middle of his campaign for re-election, presuming he intends to seek re-election. Senate Democrats might well balk at filling such an important job in 2004, preferring to wait until 2005 when a Democrat might occupy the White House.

At the White House, Bush's top economic adviser said he puts no credence in speculation that Greenspan might not finish his term.

"This is at least the 20th time in the last 10 years that there have been rumors in the financial market that Alan is going to retire," Lawrence Lindsey told reporters last week. "I had lunch with him yesterday. ... He has no intention of going anywhere."

Lindsey is a former Federal Reserve [employee] who served with Greenspan before returning to private economic consulting in advance of joining the Bush administration. His view also has supporters among private economists who think Greenspan enjoys the job too much to step aside early and would do so only if his health started to fail. That is not evident in Greenspan's still-vigorous tennis game.

"Greenspan's hobby is crunching economic numbers. There is no better place for him to be," said Sung Won Sohn, chief economist at Wells Fargo in Minneapolis. "Personally, professionally, socially and politically, I don't see any reason he would want to step down."

New York economist Jones also supports the view that Greenspan will stay on the job despite the persistent market rumors. He said there is no indication that the Bush team is laying groundwork for a new Fed chairman by planting newspaper stories about possible successors.

"Clearly, the administration will have to prepare the markets for Greenspan's successor given how important the job is for the economy," Jones said.

In 1987, Greenspan was Wall Street's clear choice to succeed Paul Volcker.

The top choice of the 37 economists who responded to the Blue Chip survey? Treasury Undersecretary John Taylor, the administration's point man on international economic matters.

#### GOLD IS BEGINNING TO SPARKLE AGAIN AS INVESTORS SEEK STABLE INVESTMENTS

Abandoned for years by all but a loyal group of investment curmudgeons, Wall Street has got gold fingers again.

The precious metal recently rose above \$300 an ounce, its highest level in nearly two years, and mutual funds that invest in gold mining companies have been star performers against a backdrop of dismal performance in other areas of the stock market.

The rise stems largely from increased demand in the U.S., where low interest rates have made bond and money-market yields unattractive and fears of war in the Middle East have people looking for safer investments. Also giving the price a boost is renewed interest by Japanese investors who are looking to guard against the falling value of the yen. Many Japanese, worried about the health of commercial banks amid a prolonged economic crisis, also have been shifting money out of savings accounts into gold as their government prepares to end blanket deposit-insurance.

To some, the minigolden age has been a long time coming. Indeed, to a group of hardy investors known as gold bugs, the rise in gold price isn't so much a profit opportunity as vindication. "Gold has been a currency for 3000 years and it's only in the past 20 that people have forgotten about its importance," says Henry Bingham, a strategist at Van Eck Global, a New York investment firm that specializes in natural-resources stocks and commodities. Mr. Bingham says he has invested in gold since 1967. "What we are seeing now is a secular revaluation of gold, back to somewhere close to where it belongs," he says. The gold rally has helped the Van Eck International Gold Fund rise by 51% in the past 12 months, close to the 54% rise posted by the American Stock Exchange Gold Bugs Index. During that same period, the Standard & Poor's 500-stock index is down 10.5%.

But before saddling your horse to get in on the action, consider this: Ever since gold peaked at more than \$800 an ounce in 1980, every few years prices have spiked, tempting investors into thinking a new gold rush was about to happen. Indeed, some money managers caution that recent gains might be just another tease. For example, gold prices rallied in 1998 after the Russian government defaulted on its



debt and the Federal Reserve had to orchestrate a bailout of hedge fund Long-Term Capital Management (LTCM). But gold quickly fell back as investors became infatuated with technology stocks.

For gold prices to rise or even maintain their current levels, experts say, two things must happen: Interest rates must remain low and the U.S. dollar must weaken. Clearly, short-term interest rates are low now, but many economists believe they aren't likely to fall further, and indeed could start to rise if the economy improves. Their argument was reinforced somewhat Wednesday by Fed Chairman Alan Greenspan, who told Congress that he sees signs the recession is winding down. And the dollar remains strong, compared to the yen or euro, and shows little sign of weakening.

The strong dollar is bad news because as other currencies weaken, the amount of gold foreign buyers can afford goes down, thus depressing demand. Also, if gold prices remain high for a year or two, mining companies may well boost capacity, which eventually would boost supply.

Because the equation for a sustained rally in gold prices is incomplete, Bill Martin, co-manager of the American Century Global Gold Fund, which is up 60% in the past year, says now may not be the time to start dabbling in gold and gold-related stocks. "Some gold stocks are up 70% and the price of gold is only up 10%, so something has got to give," he says.

Gold is the ultimate in defensive investing. It can be worth putting a small portion of your portfolio in it, but it's unwise to put a lot of money into gold unless you subscribe to the following: 1) You think stocks are overvalued. 2) You believe corporations are going to default more often on bonds and other debt obligations. 3) Deflationary pressures, or a weak economic recovery, will erode corporate earnings. 4) The U.S. dollar will fall and banks will be weakened by their lending and derivatives exposure to parties like Enron.

Because many gold bugs take some or all of these views, they stand apart from Wall Street's bulls. Indeed, rather than pore through balance sheets or examine corporate trends, as many portfolio managers do, gold bugs tend to be well-versed in such things as the history of central banks' monetary policies. Such histories are useful for gold investors to know because central banks are big owners of gold and frequently sell it or lend it to short sellers, both of which serve to help lower gold's price. "There's a lot more to our kind of investing than figuring out how much toothpaste some consumer-oriented company is going to sell," says Gregory Orrell, manager of the Monterey OCM Gold Fund, who started following gold after his father invested in several mining businesses.

Indeed, the price of gold dipped to around \$290 last week after the German central bank hinted it would sell gold—though prices stabilized after investors realized those sales wouldn't occur until 2005 at the earliest. Such gyrations are signs of novices in the gold market these days, some investors say.

And while the Enron debacle might make gold seem like a relatively safe investment, the sector is filled with its own horror stories of dubious management teams touting phony Mother Lodes. In 1997, for example, a Canadian company called Bre-X Minerals burned scores of investors who bid up its stock after company officials told of a huge strike in Indonesia that proved bogus. "Gold is about the most illiquid of all the major sectors that people invest in," says David Gillespie, manager of the Rydex Precious Metals Fund. "It's not a place to play."

That said, there are plenty of legitimate gold-mining companies in which to invest. Mr. Martin, the American Century money-manager says people seeking to invest in the sector should consider Newmont Mining and Barrick Gold. Neither can be considered cheap by conventional measures—shares of Newmont, which is based in Denver and trades on the New York Stock Exchange, have risen 54% in the past year and fetch a hefty 61-times anticipated earnings. Barrick, based in Toronto, fetches 32-times expected earnings and its stock has risen 27% on the Big Board in the past year. Indeed, most gold stocks are relatively expensive these days, fetching on average 37-times earnings, compared to 31 for the entire Standard & Poor's 500, according to Multex.com, an investment research company.

Newmont recently completed its acquisition of Canada's Franco-Nevada Mining and has acquired control of Australia's Normandy Mining, so it could benefit from squeezing out costs, Mr. Martin says. And Barrick, he says, is the lowest-cost producer in the business and also is less vulnerable to market fluctuations because it sells gold in advance at set prices, which protects shareholders if the price of gold falls.

But while the rise in gold reflects a new sense of caution by investors in a world that looks considerably more dangerous than it did a year ago, Mr. Martin says he doesn't sense it will regain its status as the last, best place for investors to park their money. **"We live in a paper economy now," he says. "I don't think the demand for hard assets that gold bugs favor is coming back."** [MM: ?????!!!!]

#### WHAT CAN GOVERNMENT DO?

President Bush was recently in Japan. He offered homilies to the Japanese, and his best wishes, but this will have no effect in the dreadful depression that now engulfs them. The Japanese look to *government* for help, to escape their economic miseries. Americans look to government. The Germans looked to Hitler, and the Japanese looked to Tojo and Hirohito for help in World War II. Victims look to the police, even though they usually show up, after the fact, to fill out the reports. (Protect yourself with guns and security devices. Don't depend on the cops.) The Germans, after World War I, had their surplus assets stored in Reichsmarks, which eventually went millions to the dollar. They lost everything they had, as have a lot of Japanese. Americans have lost trillions in the stock market, but few think beyond that.

A fan of mine, just forwarded to me an article by a noted economist (urp) who works for one of Chicago's most prestigious banks. The article is rife with graphs, statistics, and his opinion about the Japanese yen. He loves paper 'money,' and cannot understand why the Japanese are buying so much gold, and not trusting the yen. He says, "After all, the Japanese yen is much easier to store than gold." They surely are. Eventually a wheelbarrow full of them might buy a cup of coffee in Tokyo, Mr. Economist. Everyone has their own set of hatreds. Mine are "economists".

No matter where one may look: The boob tube, the financial pages of the most revered newspapers, or advice from advisors, it's all the same. One advisor got some friends of mine to invest \$100,000 of hard-earned dollars in a scheme that promised 10% a month interest. After a few months, it failed, of course, and they lost

most of what they put in. There are advisors by the bushel. Degrees in economics by the hundreds are awarded each year from the sacred halls of academia. Why don't professors and teachers realize that the entire world's system of paper money is fatally flawed? It is like a building with a poor foundation. You can build a magnificent building with a poor foundation, and the first time a little quake or flood comes along, it will all come tumbling down.

Economics doesn't take a college course to understand. Von Mises defined it in two words: "People Act". Another one might be: "Governments always self-destruct, and take their citizens with them".

Almost everyone in the world places faith in paper money, financial figures and statistics based upon the various currencies of their particular nation. Watch Louis Rukeyser, Friday evenings on PBS, and amidst the hokey formality, everyone talks about stocks and dollars as if they were the Rock of Gibraltar. The good old days of dollar stability are long gone. When I was a kid, the small decline had escalated with WW II, and by the war's end, the dollar's purchasing power was half of what it had been 4 years before. My Dad bought a new '49 Ford for \$1989, in October, 1948. His new Plymouth had cost less than \$700 in 1940. The Ford had overdrive, a V-8, radio, etc, whereas the Plymouth had neither, but the price comparisons are startling, to put it mildly. People continually speak about how they bought their house for \$35,000, and now it is worth \$100,000, as if they had scored a huge bonanza. They have gotten nowhere. It is the same house. Only the "money" has lost its value.

Most think the government is wonderful. All those bureaucracies to 'protect' the people. Nonsense! The various bureaucracies protect themselves, enlarge their bases, hire more buffoons, and spend more dollars. Are we better off, with the huge government we have now, or the small one we had before FDR? If we are so much better off, why has crime escalated through the roof, as has illegitimacy, racial hatreds, destroyed cities, filthy air, virtual illiteracy, and a host of other ills we didn't have before enormous government, and debased currency. Hundred-dollar bills are as common now, as dollar bills of 60 years ago. When governments run amok, as they have all around the world, the victims are its subjects, who have to pay and pay and pay for all the "benefits". The higher prices go in currencies, the higher wages go also, and the higher tax brackets the victims are placed. A double whammy. The morons who think government is so wonderful, now espouse One World Government. If we have one government over everyone, we will have arrived at Shangri-La, they honestly believe. More like the gates of hell. If a national thing is bad, how is a worldwide, all-powerful one, better?


The poor Japanese look to government, but what can it do? Nationalize the banks? What for? Is a government-run bank better than a private one? If it prints even more money, it will become worth less and less. If it bails out the banks for all their loans, which seemed prudent at the time they were made, the same result will happen... total debasement of the currency. If the Japanese pass laws forbidding withdrawals of yen, nothing would be accomplished, other than further mistrust, and lack of confidence. After WWI, the German government kept the presses running night and day, because there was a 'shortage of currency'. Of course there was a shortage! The more they printed, the shorter the currency supply became, because the more they printed, the more it took to buy stuff!

American dollars are being printed faster and faster, as are all the world's currencies. There are far too few physical dollars around, and banks are always short. Try to get a large cash withdrawal without notice, and you will see. The more they print, the more they need, because the more they print, the less they are worth, and the more it takes to buy things. It is an endless problem, under an inflationary economy, and the entire world is inflating.

The inflation is not the fault of you or me. During the Carter Presidency, slogans were rife about "fighting inflation". Posters and ads everywhere, urging the citizens to "fight inflation". How absurd! We have no control over inflation. Inflation, resulting in the continual increase in prices, is purely the fault of government. I don't print money, do you? Inflating the money supply, is one of the oldest historic tricks of governments to save themselves from improvidence and bankruptcy. The politicians spend and spend and spend, in order to get re-elected. Budgets are continually out of balance. Every bond or T-Bill sold, increases the currency supply by that much, and decreases the value of the currency a bit more. In a sane situation, no government would be able to sell ANYTHING, because they could not spend more than they took in, and the presses would only run as often as the paper currency wore out, or the amount of gold or silver increased in government vaults. IN A NON-INFLATIONARY ECONOMIC SITUATION, THERE COULD BE NO GOVERNMENT PAPER FOR SALE. When government sells debt, it is a flashing warning sign. Japan can sell debt to bail out the banks, or take them over, but the problem cannot be solved by government.

It's high time we stopped looking to any government for anything other than as a gigantic roadblock to freedom and happiness. Giving, spending, and printing, are destroying the economic base of savers, retirees... and everyone else... for than matter. Bush is trying to beat Clinton in forming new bureaucracies and spending. Do we need sky marshals, or armed pilots and stewards? Do we need the ATF, or elimination of gun laws? Do we need the INS or just seal the borders? Do we need an additional \$48 billion for the military, or to become neutral and bring the troops home, and station them on the Mexican border? We are seriously ill people. Seriously. We are on death's door, economically, and all the manipulations to keep the precious metals low, and the paper acceptable, will soon fail completely. I'll collect my \$50 bet when the Dow goes to 5,000. Any one want to bet me on how high in funny money, gold and silver will go? Someone else forwarded me a piece on how to protect America's gold reserves. What reserves? Another myth.

Just protect yourself, because you must realize government isn't in the protecting business. Get out of their cash trash.

# When Is An Owner NOT A Stockholder?

**Budget's "Tip of the Week" #3:**

***NRS 78.197—Rights of persons holding obligations of corporation***

If you own part (or all) of a corporation, you're a stockholder, right? In Nevada, the answer to that question is, "Not necessarily." Let's look at another unique provision of Nevada corporate law:

***NRS 78.197 Rights of persons holding obligations of corporation.***

*A corporation may provide in its articles of incorporation that the holder of a bond, debenture or other obligation of the corporation may have any of the rights of a stockholder in the corporation.*

With this provision written into your Articles of Incorporation, you "may have any of the rights of a stockholder"—without owning stock! Thus, the holder of a note COULD own the corporation and could even be afforded the same VOTING RIGHTS as a stockholder—without being a stockholder. And in the absence of stockholders—in cases where no stock has been issued—presumably, the holder of a promissory note of the corporation could have 100% of the voting rights at any meeting.

If such a provision related to *NRS 78.197* is NOT in your current Articles of Incorporation, check and see if the following standard clause exists under an Article relating to Amendments:

*Except with respect to amending the non-assessability of shares per Article IV, this corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation or its Bylaws in the manner now or hereafter prescribed by statute or by these Articles of Incorporation or by the corporation's Bylaws, and all rights conferred upon the stockholders are granted subject to this reservation.*

If so, the corporation may "amend... these Articles of Incorporation... in the manner prescribed by... the corporation's Bylaws". In other words, the Articles of Incorporation are modified by the Bylaws. If such a provision exists in your Articles of Incorporation, we suggest that you amend the Bylaws to reflect wording such as *NRS 78.197* suggests for the Articles of Incorporation.

If neither of these provisions exists in your corporation's Articles, you might want to file an Amendment of the Articles of Incorporation. We can handle such a filing with the Secretary of State for you, just ask.

Next week, we'll look at what might be called a "turnip" or "prickly pear" clause in the *Nevada Revised Statutes: NRS 78.7502*.

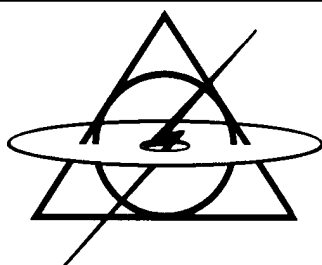
