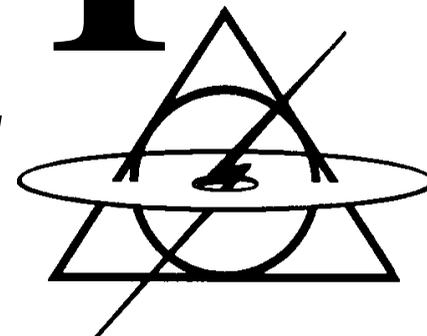

CHRISTIANITY’S GLOBALISM INCITES INTERFAITH CONFLICT

Did journalists, pundits and historians miss one of the 20th-Century’s biggest social trends in writing all those backward looks at New Year’s 2000? PHILIP JENKINS, professor of history and religious studies at Penn State University, thinks so.

While Fascism and Nazism have vanished and Communism is dying, he observes, “perhaps the most successful social movement of the past century” is Pentecostalism, which started with a handful of believers and now encompasses hundreds of millions. And that’s only part of the picture, since there are far more Roman Catholics than Pentecostals.

What many have missed, Jenkins says, is Christianity’s strong expansion in the “south”—Latin America, Africa and parts of Asia—while in the “North” it merely holds steady in the United States and shrinks in Western Europe.

That scenario is spelled out in Jenkins’ book *The Next Christendom; The Coming of Global Christianity* (Oxford University Press). There’s statistical support in the two-volume *World Christian Encyclopedia* from the same publisher.

Jenkins says southern Christians read the *Bible* quite differently from Western liberals. The rising Christendom is drenched in supernaturalism, both biblical and present-day, he reports. So it resonates with the world of the literal *New Testament* as a faith for the poor, despised, diseased and persecuted.

Unlike declining liberal churches to the north, Jenkins says, southern Christianity gives the *Bible* “authenticity and immediacy”. Scriptural messages to the oppressed are drenched with meaning, and pessimism about the secular world is widespread. Churches preach evangelism, moral conservatism, mysticism, miracles of healing, exorcism and strength under persecution.

Westerners can understand the sufferings of God’s people in the *Bible* as “an intellectual exercise”. But in many lands, martyrdom and oppression are current realities and churches cherish “visions of a coming world in which God will rule, persecutors will perish and the righteous be vindicated.”

Jenkins believes communism’s death and the declining credibility of many nation-states makes religious identity perhaps the most powerful force in global affairs. This has a potential nightmare aspect, since Christianity and Islam are the two main competitors and each is massive and expansion-minded.

That differs from Samuel Huntington’s much-mulled *Clash of Civilizations* (1996), which depicted Islam’s growth and militancy but downplayed Christian expansion. Jenkins is convinced that into the foreseeable future, Christianity will maintain its numerical “massive lead” over Islam.

By 2050, many major nations “could be profoundly divided between Islam and Christianity and, judging by present trends, any or all of them could be the scene of serious interfaith conflict,” he writes.

Dangerous types of countries:

- * Predominantly Muslim with significant Christian minority (for example, Indonesia, Egypt, Sudan).
- * Predominantly Christian with significant Muslim minority (Philippines, Congo, Germany, Uganda).
- * Muslims and Christians roughly equal (Nigeria, Ethiopia, Tanzania).

Though Christianity usually “atrophy among the rich and secure”, he says, the United States is a huge exception. So are professional and high-tech groups within Pacific Rim nations.

Regarding the United States, he notes a 2000 piece by a *New York Times* editorial writer who described emptying pews and aging memberships as though American Christianity was dying. That’s true in some situations. But overall, the numbers remain constant, and churches are growing among Pentecostals, Charismatics, evangelicals, Roman Catholics, Blacks and immigrants.

By Jenkins’ projections, the United States will still have the world’s biggest Christian population in 2050, and by then will be the only nation in the “North” with more than 100 million Christians.

THE BIBLE FRAUD

THE ANOINTED LEADER OF THE ESSENES: JUST WHO WERE THE ESSENES?

In an attempt to clarify the story of the Judas and Jesus twins, a link must be made between narratives in the *Dead Sea Scrolls* and the Gospels of the *New Testament*. In the presentation of this evidence, *The Bible Fraud* confines its hypothesis to a framework of known historical documents and the probabilities and possibilities of information contained in them. The adopted and general ancient beliefs are the chief sources and have been applied to the

broad facts of what is currently accepted, and the minor day-to-day details are a lesser consideration.

What must be remembered is that, in correlating this evidence, Gospel information is the primary source on Judas and Jesus, but once “the true name of Jesus Christ” is known, other documentation can be accessed. Much of the Gospel material shall be shown to be riddled with uncertainty, but some narratives contain elements of a well-known tradition.

The *Dead Sea Scrolls* make no mention of Jesus Christ or the early Christian Church. At the time of their discovery, the Professor of Archaeology at the Hebrew University of Jerusalem, Dr. Yigal Yadin, said the omission was “strange”. It has long been known there is information in the *Dead Sea Scrolls* that is damning to Christian beliefs, and the Church’s high-level involvement with interpreting the *Scrolls* fostered a grave element of suspicion. Since the *Scrolls* were found some six decades ago, close associates of the Vatican were placed in dominant positions in every phase of the investigation and translation of the *Scrolls*. The priests regulated the flow of information and controlled its release. Michael Baigent and Richard Leigh discovered during research for their work *The Dead Sea Scroll Deception* (Corgi, 1992) just “how fiercely the world of orthodox biblical scholarship was prepared to fight to retain its monopoly of available information”. J. Edgar Hoover, of the U.S. Federal Bureau of Investigation (FBI), summed up the Church attitude when he once said, “it can be held certain that information that is withheld or suppressed contains truths that are detrimental to the persons involved in the suppression”.

To provide conclusions on the lives of Judas and Jesus ben Panthera, the highly regarded and comprehensive work of Professor Robert Eisenman was drawn upon. Professor Eisenman has devoted his life to the specific study of Palestinian history and has analyzed and lectured extensively upon the *Dead Sea Scrolls* and various aspects of Christian origins at the Hebrew University in Jerusalem. It was Professor Eisenman who provided the now-accepted and spectacular connection between the *Dead Sea Scrolls* and James, the Gospel brother of Judas and Jesus. This connection established that crucial information had been painstakingly concealed from the public by a small enclave of Catholic priests who controlled the release of the material. Unlike a number of personalities in the *New Testament*, James was a historical person—one who played a more prominent role in the affairs of his time than is generally acknowledged.

At the time of the lives of the ben Panthera twins, the now-called Essenes were one of three religious sects in the Roman provinces, the other two being the Pharisees and Sadducees. The Sadducees were a Jewish sect of the time, opposed to the Pharisees. They denied the resurrection of the dead and the validity of oral tradition. Old records say that Pharez, who developed a School of Predestination, founded the Pharisees. It seems that the Sadducees were founded by Sadoc, a disciple of Antigonus Scohaeus, the person said to have been associated with the development of an institute called the School of Infidels. Sadducees are mentioned fourteen times in the *New Testament*; the Pharisees ninety-eight times, mostly in the Gospels. The weight of scholarship heavily supports the argument that the *Dead Sea Scrolls* found in the caves at Qumran were produced by the Essenes, although this is debated by Christian apologists. It is possible that these writings

were compiled (or stored) in various settlements and moved to the Dead Sea caves from other areas for protection and preservation. It is not improbable to suggest the manuscripts were deposited in the Dead Sea area as late as 132 by the Jewish leader Simeon bar Cochba, but the general opinion is that the oldest and largest of the three separate discoveries was hidden for safekeeping when the destruction of the Qumran settlement seemed imminent sometime shortly before the beginning of the Jewish War in A.D. 66.

Nowhere in the *Dead Sea Scrolls* collection is the term “Essene” found. The Qumran community never referred to themselves as “Essenes”, but they did use a number of other Aramaic terms. From these terms, it is clear the Community did not have a single definite name for themselves, although the term “Ebronites” (“Ebionites” in some translations) was used within the later-dated scroll discoveries. These particular writings were found in the ruins of a Byzantine monastery further up the hills from the oldest and largest collection of Qumran. In academic circles, it is generally believed that a high priest of the early Essene community wrote the *Book of Enoch* in order to fulfill an *Old Testament* “prophecy” in *Jeremiah 31:31-34*: “... the days are coming when I [the Lord] will make a New Covenant”. The authors of the *Dead Sea Scrolls* constantly referred to a New Covenant and regularly called themselves the “Keepers of the New Covenant” and the “Community of the New Covenant”.

The First-Century classical writers Josephus, Philo and Pliny indicated that in their time these people were known as the “Essenoi” or “Essaioi” in Greek, but a variety of opinion exists among scholars and researchers as to the origin of the name. Some explain the Greek name for Essenes as meaning “Silent Ones” and others are signifying “Healers”. Some assert the term means “Pious”, while others call them “Seers”, “Performers of the Law”, “Retired Ones”, “Stout Ones”, “Mysterious Ones”, “Daily Baptists” or “Apron-Wearers”. In the latter respect, echoes of the Essene beliefs can be found in the rituals of the Masons. Josephus recorded that they “don a white apron” before their ceremonies, after which they “then take off their white aprons, which they consider sacred clothes”.

The writings of the early Church extend another opinion about the identity of the body of monks now called the Essenes. St. Epiphanius of Salamis (315-403) left behind some extraordinary records about Jesus, Mary and the Gospel stories. The modern-day Church has claimed that these records “exhibit a marvelous mixture of valuable traditions”, but many of those ancient traditions oppose the canonical writings of today. Lipsius, in his article on this interesting early churchman, said he was:

“... *honest, but credulous, a narrow-minded zealot for Church orthodoxy... His frequent journeys and exhaustive readings enable him to collect a large but ill-arranged store of historical information, and this he used with much ingenuity in defending the Church orthodoxy of his time and opposing every kind of heresy... The accounts he gives of the Jewish Christian and Gnostic sects... exhibit a marvelous mixture of valuable traditions... and [he] collects a rich abundance of genuine traditions from what seemed a worthless mass.*”

Some of his “genuine traditions” are recorded throughout this book. When St. Epiphanius wrote of allegedly “heretical” sects once existing in occupied Roman territories, he called them the “Men of Yesu”.

The term “Yesu” was taught in Druidism as one of the three aspects of the Druidic trinity, the other two being Beli and Taran. St. Epiphanius went on to say the Men of Yesu were sometimes called “Yesseans”, after Jesus of the Gospels. Epiphanius sought to justify this startling connection with the Yesseans and Jesus by asserting that in Hebrew the name “Jesus” means “physician”, and the Men of Yesu were highly regarded herbal healers supporting the same doctrines as those applied to Jesus in the *New Testament*. The assertion that Jesus and the Men of Yesu were in some way connected was a documented Church fact during the very earliest years of recorded Christian history.

The historian Josephus believed that the Essenes were formed shortly after the Maccabean period (168 B.C.) by an exiled High Priest named Mattathias, the father of the military king Judas Maccabaeus. A very obscure tradition held that Mattathias, in search of truth and true righteousness, traveled to India and having studied there for many years, returned to his brethren and founded the first body of monks. In *Dead Sea Scrolls* tradition, this man was afterwards called by his disciples “the Master” or, in some translations, “the Orthodox Teacher”. He was never portrayed as a divinity, so he cannot in any way be equated with the Gospel Jesus, as some recent authors have tried to do. In fact, it is said in one of the *Dead Sea Scrolls* (Zadokite) that he was “gathered in”—an expression used in the *Old Testament* to describe natural death.

ESSENES LINKED WITH THE DRUIDS

Some modern researchers give the Essenes a much earlier origin and again connect them with the Druids of Gaul, circa 250 B.C. Druidism was a mystical profession, and in the earliest of times mystery and magic were always confounded. The association between the Essenes and the Druids developed from the similarities between the two groups, which both formed a class apart and kept the people who were culturally inferior to them in subjection.

Both the Essenic and Druidic high priests were regarded as the most just of men, of a priestly class with secret writings, sacred songs, special clothing, strict rules of divination, hidden instruction and a human skull displayed in certain initiatory ceremonies. Both fraternities taught esoterically the existence of a Supreme Being, a future state of rewards and punishment and immortality of the soul. It was not lawful to commit their doctrines to writing, and “secret ciphers” were used to conceal their “innermost mysteries”. Julius Caesar (d. 44 B.C.), who came into contact with the Druids, was probably the oldest authority on the mysterious ways of the Gaulish clergy.

The remarkable coincidence between the chief features of the Druidic and the Essenic fraternities can be accounted for only by referring them to the same origin. The truth appears to be that the Druids and Essenes derived their similarity from the spirit of brotherhood which had prevailed in all ages of the civilized world. The inherent principles they adopted seem to be that all members were engaged in the same pursuit and assented to the similar religious creed, that being a belief in life after death, and it was their secrecy in that knowledge that gave them their exclusiveness.

Archival records indicate that the Essenes may have been of very early origin. Theophilus Gale, who wrote a work called *The Court of the Gentiles*, said:

“Now the origination or rise of these Essenes I conceive by the best conjectures I can make from antiquity to be in or immediately after the Babylonian captivity [circa 397 B.C.], though some made them later.”

Johyn Yarker, author of the book *The Arcane Schools*, linked the common ancient brotherhoods together and also associated the Essenes with the ending of the Babylonian exile.

“It is possible... that Chaldean, whence Culdeean, was as appropriate to the Druids as to the Babylonians, and that as the Essenes were Babylonians, the Culdees were Essenes, as held by Bede [English Church historian, 673-735], and thus the Essenes were Culdees and the Culdees were Druids.”

With what was known about the Essenes, any of the names given to them could be successfully applied. The oldest research papers variously called them “Therapeutes”, “Ascetics”, “Monks” or “Ecclesiastics”, which are but different names for one and the selfsame sect.

The best-qualified researchers explain that the word “Essene” is nothing more than the Egyptian word for the Greek Therapeute, signifying the character of the ascetic sect of ecclesiastic monks as professing to the practice of healing. The “ascetic” aspect of their existence indicates severe discipline, long fasting and the willingness of many of them to become eunuchs. The name “monks” indicates their contemplative life and their abstraction from the world. “Ecclesiastics” is of the same sense and indicates their being called out, elected and set apart to the more immediate services and honor of God.

“They had a flourishing university, or corporate body, established on these principles, at Alexandria in Egypt, long before the period assigned for the birth of Jesus Christ. From this body they sent out missionaries, and had established colonies, auxiliary branches and affiliated communities in various cities of Asia Minor, which colonies were in a flourishing condition before the preaching of Paul. They also resided in monasteries on the lake of Parembole [or Maria], also in Egypt.”

The Fourth-Century writings of the Church confirm that the Essenes abounded in Egypt, especially around Alexandria. Their missionaries established stations or colonies in Rome, Corinth, Galatia, Philippi, Colosse and Thessalonica. At Ephesus they had a well-established College of Essenes. They also established and maintained at least one settlement in the Qumran area by the Dead Sea, and others in Jerusalem, Antioch, Bethlehem, Damascus and Mount Carmel. They gained their recruits in two ways: They adopted children and reared them into the way of the principles and practices of their Order, and they took in people in trouble or homeless, wandering ascetics. They were generally celibates, although Josephus indicated that the Essenes were quite divided within themselves, and there was one particular sect that accepted a kind of marriage between men and women.

The central aspect of Essenic literature is its pre-occupation with prophecy, and it is recorded that they had an uncanny ability to successfully predict future events. Philo compared them not only with the Persian Magi but also with the Indian Yogis. Later researchers also connected the Druids with “the Magi of the old Persians”.

The etymology of the word “Essenoi” or “Essaioi” has not been settled. In the 16th Century, the name

“Essene” was generally applied retrospectively to every ascetic religious sect living throughout Europe during the last two centuries B.C. and the First Century or so of the Christian era. Among the contending opinions today, the preferable title seems still to be “Essenes”—and, to avoid confusion, that name has been adopted for this work. In using this title, however, it should be remembered that the early church called them the “Men of Yesu”, and the origin of that title shall become clear in later chapters.

THE SPECIAL NAME OF JOHN THE BAPTIST

The Dead Sea is the saltiest body of water in the world and is located at the mouth of the River Jordan, the place where John the Baptist, according to the Gospels, baptized Jesus. The Gospels also record that John the Baptist’s mother, Elizabeth, was the sister of Jesus’ mother, Mariamne Herod. This reference makes John the Baptist the cousin of Jesus and thus Judas, and the Gospels say he was six months older than the twins. Aunt Elizabeth was married to a priest, and this has been interpreted in some quarters as giving John the Baptist and his family Sadducee (far-right) connections. **[H: It might be noted here that in a prior offering excerpted from this book in point that Jesus had a twin. I suggest you get this book if you have interest in a bit of factual research on these topics. I apologize for my lack of interest in the older texts because we have been there and done a lot of that—and our tasks are very much oriented to TODAY in the lands of Chaos.]**

The constant references in the *Dead Sea Scrolls* to a “New Covenant” are directly linked to the *New Testament* letters (today called “epistles”) that are attributed by the Church to the disciple Paul. The *Bible*, however, records that there were many authors associated with the epistles (they are named in a later chapter). The two authors of the Second Letter to the Corinthians (2 Cor. 3:6) state that they were “ministers of a New Covenant”, which connected them with the “Keepers of the New Covenant” or the “Community of the New Covenant”. In other words, they were members of one of the various Essene communities of the time.

The “New Covenant” basically entailed a belief in certain of the Essene Master’s religious writings and included a formal oath of obedience totally and eternally to the Law of Moses. As part of this understanding, candidates for Essene leadership had to pass through a strenuous training program for three years before being granted permission for entry into the higher ranks. “The ceremonies were numerous; the physical proofs painful; and the mental trials appalling.” The Essene elders would then impart special secret teachings, special titles and knowledge given under strict vows of secrecy. Josephus recorded that the Essenes “considered it a grave sin to reveal their secret knowledge to outsiders, with death preferable by comparison”.

To further establish that much of what the *New Testament* contains is directly related to the doctrines of the Essenes, Paul, for example, mentioned his Essene community in *Hebrews* 8:7, where he said, “For if that first Covenant had been faultless, there would be no occasion for a second”. This narrative indicates that new religious documents had been written. Paul also quoted from the *Old Testament Book of Jeremiah* (31:31-34), relating to the “prophecy” of the creation of

a “New Covenant”. From this and other *New Testament* verses, it can be ascertained that the now-called Christian authors were firm supporters of the Essene New Covenant idea, and this can be confirmed in many other places throughout the writings attributed to Paul. The Church agreed, for the introductory page of the *Revised Standard Version of the King James Bible* (1971) describes the Christian writings of today as “The New Covenant, commonly called the *New Testament*”.

The publication and subsequent interpretation of most of the *Dead Sea Scrolls* has established direct and close relationships between the sect of the *Scrolls*, the Epistles and the entire substance of the Gospels.

A close study of those documents has resulted in a growing consensus that Judas and Jesus’ cousin, John the Baptist, was also directly associated with the sect of the *Dead Sea Scrolls*. The Gospels say that John was of priestly stock and lived in the Judean wilderness facing the Dead Sea “until the day of his manifestation” (*Luke* 1:80). From this Gospel information, John the Baptist is now generally recognized, like Paul, as an Essene. Dr. Franz Hartmann added further information, saying in his book *The Life of Jehoshua* that John the Baptist “was of a noble family and had many influential friends”. The discovery in 1929 by Hugh J. Schonfield of the lost *Book of the Navity of John* (the Baptist) revealed that originally:

“John the Baptist [as a baby] was considered by the early Church as the infant messiah. Its loss [of this document] at a very early date is not to be wondered at, as the Church had the best possible reasons for suppressing it. The fact that John the Baptist was regarded as the messiah by a numerous following may be a new one to many people.”

Schonfield then set out a chapter outlining the features of the Baptist’s messianic mission and traced the fortunes of the sect which accepted him as their leader. The *Dead Sea Scrolls* record that the “Community of the New Covenant” possessed a hierarchy, an inner circle of initiated members, and their leader was known as “the anointed one”. The practice of greasing or smearing with oil is supposed by many to be an exclusive Christian ceremony, but was actually in vogue in pre-Christian oriental nations. A statement in the *New American Cyclopedia* confirms that:

“... anointing with perfumed oil was in common use among the Greeks and the Romans as a mark of hospitality to guests. Anointing was an ancient custom throughout the East, by pouring aromatic oils on persons as a token of honor ... it was also employed in consecrating priests, prophets and kings, and the places and instruments appointed for worship.”

Obelisks, images and statues had long been consecrated by the devotees of the earlier oriental systems. The *Old Testament* records the anointing of ten stones set up by Joshua, and also the stone upon which Jacob slept at the time of his vision. Aaron, Saul, David and Solomon were anointed with oil in the same way as the sick were anointed on the Sabbath. It would seem that in ancient Palestinian tradition, kings, political and military chiefs, village heads and, in fact, any claimants to high office were anointed and hence called “anointed ones”, leaders or messiahs in the true sense of the word. Interestingly enough, some leaders and village heads, after anointing, were then called “lord” (as in “landlord” or “lord mayor”).

Origen (185-251), one of the shining lights of the early Church, said on the matter, “There are some who

said of John [the Baptist] that he was anointed." St. Epiphanius also said John the Baptist was "one of the anointed", confirming there was more than just one "anointed" man in the Gospel story. Roman Emperor Julian (361-363), in his book *The Arguments of the Emperor Julian*, supported the opinion and introduced an extraordinary word by stating:

"At any rate, neither Paul nor Matthew nor Mark dared to say that Jesus is God, but only the Krist John, they adventured to assert this."

THE "KRIST" FIGURES

The Krist John... Origen, Epiphanius and Julian the Emperor all clearly recorded that John the Baptist, the cousin of Judas and Jesus, was a "Krist" figure, but made no reference to Jesus himself attaining that status. Bishop Theodoret, writing in the Fifth Century, provided further confirmation that Jesus was not one of the "Krist" personalities, although many others of his time were.

But what was a "Krist" figure? The word "Krist" seems to have had its origin in ancient Egypt and was the name of a highly regarded early god. **[H: Wow, no kidding?]** This ancient name was found extensively inscribed into the Palermo Stone, the largest and best preserved of six basalt stones uncovered in Egypt. The ancient hieroglyphic inscriptions helped archaeologists to date the early pharaohs up to the Fifth Dynasty. The original Egyptian records were carved into tablets of stone and deposited in the tomb of a pharaoh more than one thousand years before the *New Testament* was written. In these old records, now in the Palermo Museum, Horus, the Egyptian god of Light was called "Krist" or "Krst". **[H: Also, not to upset V.K., was known as old Aton.]** His mother was the goddess Isis, who conceived him as a virgin. **[H: Gosh that story just keeps popping up doesn't it? Oh well...!]**

"Krist", according to St. Epiphanius, was the spiritual Self in each and every living person. [H: GO BACK AND RE-READ THAT HALF A DOZEN TIMES.] This explains why Epiphanius was baffled when he said he could find no writings to confirm his own later orthodox views concerning "Jesus Christ" as an actual living person. He was naturally puzzled at the unhistorical nature of his Christian god. Bishop Epiphanius added to the concept of the Krist figures. He frankly recorded that Alexander of 100 B.C. was "one of the anointed"—a statement which clearly establishes a long history of Krist figures preceding the canonical date of Judas and Jesus. In fact, the "anointed" or Krist figures actually preceded the writing of the *Old Testament* in the story of Krishna. The *Old Testament* priest and author Ezra subsequently made references to anointing (c. 397 B.C.), providing two separate examples in just one narrative.

Many of the Essene manuscripts refer to "Kristo", "Krst" or "Krist", a divine internal figure in Essenic minds and set forth primarily in the *Book of Enoch* as "One eternal with God". The *Book of Enoch* was written some time around 150-120 B.C. Krist was also established in the doctrine of the Gnostics, who held Kristo to be the personal and immortal Spirit of man. The son of Poseidon and Medusa was called "Khryst" and the priests of Apollo were known as "Khrystes". **In fact, the word "Kristo", or its derivations "Krst", "Krist", "Kriso", "Khryst" and "Krishna", appears in every ancient religious system and shows that the original**

Kristo was believed to be the personal and invisible mediator and guide between God and everything spiritual in man. The Krist concept has been an ancient religious tradition continually suppressed by the Catholic Church through the centuries. [H: Same instruction as above, please—six times through, please.]

MANY ANOINTED ONES

In a document called *Dialogue with Trypho*, written by St. Justin Martyr some time around 160, Trypho, a Jewish gentleman, claimed that the Church "invented a Kristo". Trypho was intimating that a Kristo-type figure similar in concept to the Hindu Krishna was purposely devised by Justin Martyr and his associates. Trypho's comments, around 130 years after the canonical date of the death of Jesus Christ, clearly show that the Jesus Christ promoted today was actually "unknown" among the general populace, but the Krist concept from the *Book of Enoch* and Kristo, the Hindu name of the Sun, were.

Adding further depth to the story, Trypho, again in the writings of Justin Martyr, said the word "Krist" was really a substitute for a very ancient divine name, and its power was known to the "Elect" alone of the fully initiated Rabbis. In other words, the most advanced Rabbis were initiates of secret knowledge and knew the substance of an ancient mystery.

Both Judas and Jesus said on several occasions in the canonical Gospels and on more occasions in the apocryphal Gospels, particularly the Gospel of Thomas, that they knew the "secret of the Kingdom of God". Jesus later learnt the ultimate secret in Egypt, which exceeded the secrets of the Lesser Mysteries of the anointed Essenes. That great secret, as an inner circle of Rabbis know today, is still preserved in the *Bible*.

The Gospels do not record the anointing of Krist John, the Baptist, but they do record the anointing of Jesus. Judas was also anointed, probably before Jesus, because he was the "first-born son" (*Luke 2:7*). Simon Peter called Judas "a Krist", whereupon Judas commanded his followers to "tell no man that secret thing".

Though it is now impossible from the imperfect record to ascertain the exact state of the earliest Christian texts, the salient fact dwelt upon by the Church today is that Jesus was the only person anointed in the Gospels and therefore, in their opinion, that made him the messiah—not just one of many, as there were.

RABBI JESUS ELECTED TO BE ANOINTED

Christian tradition has preserved the "good principle" of the Krist as the ideal of all their aspirations, and this is apparent in the writings of the early presbyters. Hippolytus (d. 236), for example, said the sect of Ebronites/Ebionites felt Jesus had been justified by his perfected practice of the Law of Moses. In other words, he had excelled in the preaching of the *Torah*, the first five books of the *Old Testament*, and had qualified as a Rabbi.

Amazingly, St. Justin Martyr, in his *Dialogue with Trypho*, put the following argument into the mouth of his learned Jewish opponent:

"Those who affirm him [Jesus] to have been a man, and to have been anointed by election, and then to have become a Krist [anointed], appear to me to speak more plausibly than you... [Trypho responding to Justin Martyr]."

Summarized, Justin Martyr, who maintained the virgin birth dogma, had in the previous chapter of his *Dialogue with Trypho* actually confessed:

"... even if I cannot demonstrate so much of this [namely, evidence that Jesus was God incarnate in a virgin's womb], you will at least admit that Jesus is the anointed of God; in any case, he can be shown to have been born as a man of a man, and proved to be raised by election to the dignity of messiahship [anointed], for there are some of our persuasion [early presbyters] who think that he is a messiah but declare him to have been a man of a man."

St. Justin again referred to "anointed by election", but what exactly was "election"?

The academic opinion was that certain persons who had been initiated into the Lesser Mysteries were elected by a body of priests to be anointed, and then called Kristos. This was an established "Essene tradition" and the "election" was consummated at "baptism" which, in Rabbi Jesus' case, was "at about the age of thirty years". This highly valued ancient religious Krist tradition had been relentlessly crushed by the Catholic Church as heresy throughout the centuries.

The early Christian presbyters thought of and used the term "Krist" with a significance at considerable variance with that of the later Nicene belief, which actually personified this long and mysterious Krist concept going back as far as Horus.

THE "STAR" FIGURE

A key factor in determining the significance of the *Dead Sea Scrolls* in relation to the ben Panther twins relates to the leader of the "Community of the New Covenant". *The Bible Fraud* proposes that John the Baptist, being Krist, the anointed one, was the messianic leader of the Essenes. As such, he would have been called "the Star". In old writings available, four anointed leaders (messiahs) are recorded in association with the Essene community. In this regard, Josephus said some Essenes were "involuntarily anointed".

[H: I would interject right here because of the topic in point that "Immanuel" (Jesus as you refer to him) did NOT become the Essene Krist or Christos. He was offered but declined and left the location altogether. Oh indeed it is well documented but hardly the kind of information which is allowed wide circulation when Satan is otherwise about to capture the world.]

Of extreme interest is the knowledge that a phial of oil was found in the Qumran caves with the *Dead Sea Scrolls*. It was wrapped and sealed in a protective manner, indicating it was very precious to those who preserved it. One could be excused for thinking it was safely stored for the anointing of their future Kristos/messiahs.

One of the *Dead Sea Scrolls*, called "The Book of the Community Rule", outlines the instructions for specific use of the Star, the head of the Order. It states that he shall:

"... admit into the Covenant of grace all those who have freely devoted themselves to the observance of God's precepts, that they may be joined to the Council of God. He will cleanse him of all wicked deeds and the spirit of holiness, like purifying the waters he will shed upon him the spirit of truth, and when his flesh is sprinkled with water, it shall be made clean by the humble submission of his soul to all the precepts of God."

This verse shows that the head of the Essene community had the authority to admit new general members into the Order after baptizing them. Baptism was most certainly not part of the orthodox Jewish tradition, so John the Baptist was at some time the head of the Order. Most likely he had been a leader excelling in his position and surpassed the other members by being proclaimed a prophet by a large number of people. He was declared to be “more than a prophet” by Rabbi Jesus (*Matt. 11:9*).

“STAR OF BETHLEHEM” MYSTERY SOLVED

Nothing was recorded about the earlier life of Judas or Rabbi Jesus in the Essene community. Being anointed seemed to indicate both Judas and Rabbi Jesus had previously undergone the required three years of strenuous training required for entry into the hierarchy of the Essene Order, and anointing was their “token of honor” before full admission into the “inner circle of initiates”. That both Judas and Rabbi Jesus knew certain “secrets” was made manifest from the *Gospel of Mark*, and they knew too much of the secret rituals of the Essenes to have been outsiders.

The Gospels narrate that as a result of John the Baptist’s fanatical dedication to the Law of Moses, his career came to a sudden and dramatic end when he was supposedly beheaded for condemning the marriage of Herod Agrippa I to his sister-in-law and niece, Herodias—because “it is against the Law [The Law of Moses] for you to have your brother’s wife” (*Mark 6:18*). “There is no historical foundation” to the beheading of John the Baptist and the story “has been doubted”, but it seems certain that he was executed by the Romans.

By way of comment, the execution of John the Baptist was not carried out under Herod the Great. Herod Antipas, son of Herod the Great (who went to live in Gaul in A.D. 39) married Herodias, the wife of his half-brother Herod, who was the other son of Herod the Great. Herod Antipas was the Tetrarch of Galilee and Peraea and styled himself as “friend of the Romans”. It was Herod Antipas who ordered the death of John the Baptist.

After the death of John the Baptist, Judas inherited the leadership of the Essenes because of family bloodline and the status of the tradition of the first born. Because he was now Judas the “anointed” initiate, he was called “Judas the Krist” (or “Krist Judas”), which developed to “Judas Khrestus” in subsequent Latin translations. He became the Star, the head of the Essenes at their Bethlehem community—the town in which, two of the Gospels later recorded, he and his twin brother Rabbi Jesus were born.

As professor Eisenman has stressed, this documentation linking the messiah figure with the word “Star” occurs elsewhere in the *Dead Sea Scrolls* and is of crucial importance. Significantly, the Star reference has been cited by sources independent of both the *Dead Sea Scrolls* and the *New Testament*, including historians and chroniclers of First-Century Rome such as Josephus, Tacitus and Suetonius. According to Josephus, the arrival of a “Star” character was a major factor in the revolt of A.D. 66.

Some 220 years or more after the Church claimed that Jesus Christ died for our sins, the “star of Bethlehem” found its way into the second gospel to be written, that of Matthew (*Matt. 2:2*). Here it was

retrospectively made to herald the arrival of a messiah, “a governor who shall rule the people” (*Matt. 2:6*), and was presented in the usual glamorized fashion of the early presbyters’ writings. Just as important was the presence of Simeon bar Cochba and his troops in the Qumran area between A.D. 132 and 136. Simeon bar Cochba, a Jewish army leader, claimed to be and was accepted as a very popular messiah. Even more remarkable is that bar Chochba means “son of a Star” in Aramaic and is the name commonly used to describe him.

Simeon bar Cochba was just another in the succession of the many Jewish messiahs who had come and gone, but only those people who study Jewish history knew anything of them. That some of bar Cochba’s own documents were found in the Qumran caves clearly suggests he was himself an Essene leader. It would be very interesting to know who Simeon bar Cochba’s father and grandfather were, for it appears obvious the “Star” figures were all successive (related) members of one family.

TWO MESSIAHS EXPECTED

“The Book of the Community Rule” from the *Dead Sea Scrolls* collection introduced the Essene belief that they live in expectation of two important messiahs. This was strikingly similar to the two messiahs recorded in the Acts of Thomas. One would be of the priestly caste, and the other would be a warrior who would restore the kingdom of his people, a military commander. With the birth of the “royal” ben Panthera twins and their education in the Essene community, it was highly probable they were regarded as the two anticipated messiahs.

In the context of the tradition of the time, “messiah” did not signify what it later and incorrectly came to signify in Christian preaching. It simply meant a leader, “an anointed one”, and, in Essenic belief, one who was expected to deliver them from Roman bondage.

[H: Once again—re-read that definition.]

The Essenes were not the only community to believe in the coming of special leaders. Du Perron, in his *Life of Zoroaster*, gave an account of certain prophecies to be found in the sacred books of the Persians. One was to the effect that at successive periods of time there would appear on Earth certain “sons of Zoroaster” who would “redeem mankind”. Among the Greeks, the same prophecy was found. *The Oracle of Delphi* was the depository, according to Plato, of an ancient and secret prophecy of the birth of a “son of Apollo” who was to restore and reign justice on Earth.

Among the Essene community’s then-secret doctrines was the belief that one of their messiahs would eventually lead them to victory over their Roman oppressors. This was to be the first born, Judas Khrestus, and the Essene hierarchy acclaimed him as the restorer of the Kingdom of God. One section of one of the *Dead Sea Scrolls* was written in readiness for the blessing to be extended before the (hopefully) successful outcome of the radical events expected to happen when their oppressors were challenged. This outline is carried in a scroll called “The Messianic Rule”:

“When they shall gather for the common table, the priest shall bless the first fruits of bread and wine; thereafter the messiah of Israel shall extend his hand over the bread, and all the congregation of the community shall utter a blessing.”

This is the blueprint of the Last Supper found recorded in the *New Testament*, and it establishes that Judas Khrestus was the messianic leader of the Essenes. The *New Testament* records in several places that he raised the “cup of the New Covenant” in true Essenic fashion. The word “New” has now been dropped from modern *Bibles*, but appears in all ancient *Bibles*.

From *Old Testament* time, Jewish meals included a blessing over bread and wine (*Gen. 14:18*) and over the centuries assumed special importance, as can be seen in many sections of the *Dead Sea Scrolls*. Josephus said of the Essenes, “They consider it a grave sin to rest or touch food before praying”.

The *Old Testament* changeover from simply reciting a short prayer over the bread and wine (Grace) into the symbolic ritual of eating the body and drinking the blood of a god had a long, previous history and came to be introduced “officially” into Christian practice during the latter part of the Fourth Century.

[H: How many of you STILL THINK that the Bible was untouched by human hands?]

GAS PROJECT

HAS WEST PAPUANS SKEPTICAL

JAKARTA—Indonesia’s bid to supply China with liquefied natural gas (LNG) from West Papua province promises to be among the biggest money earners for this cash-strapped country, but it excites few in the poverty-stricken province.

[H: Please realize that West Papua is NOT Papua New Guinea as such, for this province under discussions is truly still a province of Indonesia. Just realize that the biggest game in PNG, however, is GAS and planned pipelines even, yea, to Australia from PNG. Everything is connected to everything and more especially if you are “border” neighbors. Best described is perhaps Mexico using Texas’ oil and shipping it out.]

In fact, distrust and fear is the reaction of many in resource-rich West Papua, which lies at the eastern end of the Indonesian archipelago.

In late April, Indonesia submitted its final tender to the Chinese government to win the

U.S.\$2 billion contract [**H: Re-read.**] for natural-gas production in West Papua’s Bintuni Bay, a project between the world’s third-largest oil group, British Petroleum (BP), and Indonesia’s state-owned oil and gas company Pertamina.

A number of high-ranking Indonesian officials, including President Megawatti Sukarnoputri, have been to China and assured Beijing that Jakarta supports the so-called Tangguh LNG project.

Exploration has shown that the supply of liquefied gas in the bay could last 15-20 years, with an annual supply of up to 3 million tonnes. Plant construction by BP is to be completed by 2006.

This project would bring huge income to the central Indonesian government, adding to the \$3 billion sent to Jakarta annually from the provinces. But many West Papuans feel that real benefit from the project is likely to go, as in the past, to Jakarta instead of their province, which remains among the poorest despite being home to many multinational investments. [**H: And there you have it, business as usual.**]

“No investments in Papua are for us Papuans. All the dollars go to the pocket of people in the government, not us. The only thing we have in return is violence,” says a Papuan student in Jakarta, referring to military efforts to quell a long-running separatist campaign.

Indeed, many activists have security and environmental fears about the natural gas project, given bitter experiences with past foreign investments drawn to the island of New Guinea, the western half of which is West Papua and has one of the largest tracts of tropical rain forest left in the world. West Papua’s forests cover some 24 percent of Indonesia’s total forested area. The province has huge supplies of oil, gas and copper underground and under the sea.

“This BP project has a high risk of repeating what Freeport has been doing,” said Nur Hidayati, mining campaigner of Jakarta-based non-government organization (NGO) Indonesian Forum for Environment (WALHI). “BP has made a lot of promises. Freeport did the same thing, but they never come true,” she added, referring to the large copper-mining project of the U.S.-based Freeport MacMoRan Copper & Gold Inc., [**H: U.S.-based??**] which began in West Papua in the ‘60s. Rights activists have long alleged that the firm has moral responsibility for several cases of kidnapping and murders of locals by the military guards hired to protect the operation areas. The firm, the biggest taxpayer in Indonesia, denies these charges.

BP has announced its intention to involve the community in its security measures to avoid the same problem as Freeport, but critics say this is unrealistic. In its report, the British-based environmental group Down to Earth expresses doubt about this, saying that company protection has long generated lucrative income for the Indonesian military, so it is difficult to stop its involvement. It also questions the record of BP’s main partner Pertamina, which is in partnership with U.S. gas and oil company Exxon Mobil in

restive Aceh province. There, conflicts between the Acehnese community and Exxon Mobil emerged partly because Indonesian troops paid to guard the installations committed rights abuses, many of them recorded and published by rights groups. Last year, Exxon Mobil had to suspend operations at the Arun gas site for four days because of attacks allegedly by the separatist Free Aceh Movement (FAM). Since the security arrangements will depend on external factors outside company control, it will be difficult for BP to keep its promise to involve the community in its work, the Down to Earth report says.

So far, BP has hired military and security advisers to work on a “community-based security” program that will prevent future confrontations between soldiers and armed rebels in West Papua. “There is great concern that the Indonesian military will initiate conflict in nearby areas in order to justify the need for a strong security presence at the site,” the report says. “Villagers have expressed fear about the military in various meetings with BP staff.”

A human-rights activist in Irian Jaya said that BP is unlikely to be able to completely prevent the military from taking part in the project: “When it comes to operations on the ground of both the corporations and the military, information is always sealed from the outside world.”

Troop presence can be seen in every level of business in West Papua. For example, most logging companies, many with military links, have notorious reputations for using force against locals. Troops are now paid to guard several logging operations, including sawmills, throughout the province. Tensions could also rise if more logging interests go to Papua, especially now that the forests in Kalimantan are in decline. According to the Jakarta-based *Tempo* magazine, no fewer than 50 companies operate and collectively control 11.8 million hectares of forest in West Papua, while the equivalent figure in Kalimantan is 10 million hectares.

Environmentalists are also worried that, like the Freeport project, the BP undertaking will displace tribal people from their traditional land. Around 500 villagers living around Bintuni Bay BP’s project will be moved from their homes in Tanah Merah to a newly created village 3.5 kilometers to the west.

“We fear local conflict from the moving as well,” said Hidaryati. “As we know, Papuans live on tribal customary laws in which traditional territory is taken seriously. If a tribal group is moved to the territory of another, there is tendency to conflict between the two.”

“But when the government creates a development project, they just look at the map but forget that there are people living there too,” she explains, adding that more consultation by BP with the locals could help.

Already, frustration among villagers is rising because they have not even been told about when [they] are moving, the mining network Jatam stated. As well, compensation for their land is based on a 1997 survey of land prices by local government, and is artificially low.

HERE’S A U.S. SECRET REVEALED:
THE *FOURTH AMENDMENT* IS DEAD

Not enough people know about it, but in our country now a secret court can order you to turn over documents, records and other tangible items to the FBI and force you to remain silent about both the seizure and the court order.

You cannot challenge the order by appearing before the court prior to the order being issued. And after the order is issued, your attorney—if you have one—will not be successful in stopping it.

In 1978, Congress passed the Foreign Intelligence Surveillance Act (FISA), which created a secret federal court of seven judges who are appointed by

the chief justice of the U.S. Supreme Court. The FISA court had its powers expanded in 1995 by President Clinton’s Executive Order 12949, which authorizes the court to allow physical searches for the purpose of collecting foreign intelligence information.

According to the *Covert Action Quarterly*, in the 15-year period from 1978 to 1993, the FISA court authorized all but one of more than 7,560 requests for electronic surveillance of citizens in the name of national security.

Each decision to grant a wiretap or seizure order is reached in secret. The court keeps no records of its orders or opinions—except if a judge denies an application for an order authorizing a wiretap or search. When a judge denies an order, he must, according to federal law, “provide immediately... a written statement for each reason of his decision”, which then goes to a court of review.

In contrast, there is no opportunity for a legal or public review of the court’s actions when it authorizes an order.

The USA Patriot Act, which Congress passed this past year, amends FISA so that the FBI can secretly conduct a wiretap or physical search to obtain evidence of a crime without a prior showing of probable cause for such invasions of privacy. **[H: SOUND FAMILIAR TO ANYONE?]** A search or wiretap can be authorized by the FISA court simply because a person is suspected of “clandestine activities”.

The *Fourth Amendment* guarantee of the “right of the people to be secure in their persons, houses, papers and effects against unreasonable searches and seizures” has been totally abandoned.

John Whitehead, president of the conservative Rutherford Institute, called the Patriot Act, which was passed without meaningful debate about its provisions, “the bureaucrat’s dream in terms of what can be done under it”. In an understatement, he said the act “unnecessarily impinges” on citizens’ rights under the *Fourth Amendment*.

The Patriot Act expands the definition of terrorism to include any “acts dangerous to human life that are a violation of the criminal laws of the United States or of any State” or acts that “appear to be intended to intimidate or coerce a civilian population or to influence the policy of a government...”.

Under this definition, any demonstrators or protesters involved in a march which turns violent could be classified as terrorists. A Rutherford Institute study points out that “diverse domestic political groups which have been accused of acts of intimidation or property damages such as Act Up, PETA, Operation Rescue, and the Vieques demonstrators” could be targeted as terrorist organization.

The definition of terrorism as “acts that appear to be intended to... coerce a civilian population or influence the policy of a government” could certainly include writing a book, making speeches, teaching or even buying or reading a book with the intent to spread its ideas to the public.

The Patriot Act could easily be used to squelch public debate on public issues. The act is a threat to freedom of speech and freedom of the press.

But in the double-speak of these times, the Patriot Act contends an investigation of book-purchasing or book-borrowing records does not violate the *First Amendment*.

Would reading the *Declaration of Independence* aloud to a crowd be an act intended to coerce a civilian population?

“When, in the course of human events, it becomes necessary for people to dissolve the political bands which have connected them with another, and to assume, among the powers of the Earth, the separate and equal station to which the Laws of Nature and Nature’s God entitle them...”

Secret court procedures, secret orders, secret searches and wiretaps are being done in the name of a vague and sweeping definition of terrorism. They are an assault on America’s long tradition of freedom.

It may be appropriate and right to declare war on terrorists after the events of Sept. 11. However, it is terribly misguided and wrong to declare war on our liberties.

The latest briefing paper released by the Texas-based Strategic Forecasting Inc. or Stratfor, stating that “Ultimately, U.S. operations in the southern Philippines are directed less at defeating the Abu Sayyaf and more at establishing a forward operation base in Southeast Asia—with an eye on Indonesia as a likely first target,” is typical CIA psy-ops directed against the Filipino people, and was timed to coincide with the arrival of the highest-ranking officer in the world’s most powerful military (General Richard Myers).

Gen. Richard Myers’ visit to Manila is described by observers as a “quick swing to the top U.S. allies in Asia (Philippines, South Korea and Japan)” and is considered as a strong signal of “resurgent military relations” between the Philippines and the United States.

Three years ago, the Asian Studies Center of the Heritage Foundation, an organization that “uses rightwing ideas to impose leftwing radical principles upon the U.S.,” recommended the rebuilding of the U.S.-Philippine Alliance which the pro-China Clinton Administration completely ignored, but is now given importance by President George W. Bush.

In his thesis, Richard D. Fisher stressed the Philippines’ need in reequipping its defenses, while the U.S. “needs access to Philippine bases in order to respond to potential threats in Asia and the Persian Gulf.” Thus, it is imperative for the U.S. to assemble a military package of surplus combat aircraft, surveillance aircraft, ships, and radar to offer the Philippines, in response to China’s “grab and talk” policy.

Fisher’s recommendation includes F-16 or F/A-18 fighters or less-capable but still useful aircraft like the F-58 and T-38. As for naval systems, he included the FFG 7-class frigate, excess Coast Guard cutters, and reconnaissance aircraft like the long-range, radar-equipped HU-25 Guardian surveillance jet. Fisher also called on Washington to offer the Philippines surplus helicopters, radar and missiles for air-defense, air-to-air and anti-ship

missions, in exchange for a “forward base”.

Fisher also called for “commonality with U.S. military equipment to facilitate better joint operations”, something which we are now seeing under the RP-U.S. Balikatan exercises. But what is becoming clear is, as Stratfor correctly surmised, that China is not the “immediate enemy” but Indonesia, a close RP ally and ASEAN partner.

Filipino Islamists have long recognized this deception on the part of the U.S., and are now retaliating against what they feel is a treasonous act committed by PGMA (President Arroyo), by bombing General Santos City and killing innocent civilians, most of whom are peace-loving Christians.

Geopolitical experts agree with the above observation, adding that despite the “huff and puff” of the bad American wolf, the Abu Sayyaf continue to haunt the collective Little Red Riding Hood, chiefly represented by Deborah Yap, the Burnhams, and countless others. In those days after the war, the Noble Family found two men who could be entrusted to bring back the gold from the Vatican. They had miraculously survived the war as the trusted men of both the American and the Japanese High Command. They had the treasure maps and had successfully, the year was 1949, shipped treasure gold to Macao and Europe and they had a first deposit of 12,000 metric tons (MT) in Credit Suisse, Zurich, Switzerland (that was Yamashita gold already).

For a commission of 30%, Severino Sta. Romana alias Father Antonio Diaz and his brilliant young lawyer Ferdinand Marcos accepted the job to bring back 617,500 MT of gold from the Vatican to Manila. Well, not all. They opened their own deposit of 200,000 MT in Swiss Bank Corporation (SBC), Bahnhofstrasse, Zurich, in the name of Antonio Diaz. Until today, ERB-RZ-DIAZ is still there minus what

they sold, in 21 sales transactions that are recorded in SBC, during the first oil crisis in the year 1973.

For those 21 sales, there are twenty-one dollar accounts in New York, all in the name of Severino Garcia Sta. Romana. No small accounts, none smaller than Bill Gates, when the Dow hits a new record. It's all still there, all legitimate. Why? Some lady president of the Philippines did not like that Marcos is not a crook, because she claimed he was.

RECENT HISTORY

Until today, the world does not know that there is so much gold in the world. A regular figure that you would find in the encyclopedia is 32,000 metric tons of gold as the total of all existing gold. First question therefore would be: Where do they get that number? But second question must be: Who would have an interest to downplay that number? And third question, of course: Who are those who know?

One factual answer would be that the luster and secret of gold has killed more people than has the Catholic Church, more people than AIDS will ever kill, or even the poor cigarette. Gold has always been for the rich and it has always been a convenient way of hiding how rich are the rich. It is possible that gold was the reason for World War I. We don't know. Actually, very few people would know why there was a World War I in the first place. We know that gold was the reason for World War II. We should.

At the time you read this, some people are busy in a 500-year-old shipwreck some 30 miles off Brunei. They find evidence that there was, long time, a rich kingdom with some mighty Sultans who were given rich tributes in the form of gold by the emperors of China. The Royal Family of the Philippines was a vibrant power player long before Magellan "discovered" this archipelago of 7,100 islands. The Spanish Armada and the British Fleet conquered all far-flung lands of the globe and they controlled each other, but they did not have to tell what they knew, and they alone knew, about islands so far out in the Pacific Ocean that even the Chinese could not conquer them.

There is a saga of Atlantis, the sunken golden city, and its rise as Lemuria. Ferdinand Marcos was the richest man on Earth, when he became President of this country in 1965. He was in control of 600,000-plus tons of gold owned by the Noble House and he inherited the World War II loot consisting of 950,000 tons of gold listed in 1946 as missing by the London banks, now believed to be buried as the famous "Yamashita Treasure" all over the Philippine Islands. When it was buried here in the early 1940s, the Imperial Japanese Army was told that these islands were "forever Japanese territory". For Marcos, this was Lemuria.

He had no one to talk to. Maybe he did, maybe to Cesar Virata, his Prime Minister. But he did not tell the world that practically all the gold of the world was here in the Philippines. In hindsight, it is debatable whether he was correct or not. He was a brilliant lawyer. He had made himself an absolute expert on international law; he was sure that all claims must end after 30 years. He had time to wait, until 1976 would come and pass.

And he got ready to settle other problems first. Like the issue of land ownership in the Philippines that had gone out of hand, before it could even be settled in court. When it was settled in the **DECISION WITH COMPROMISE AGREEMENT** of Judge Enrique Agana

in 1972, the law could not be enforced. Too many claimants, too many issues! Marcos decided to make an end to all of this and asked anybody with a claim to present his land title during a time period of 6 months and was decreed in Presidential Decree **P.D. 892** to be the prerequisite for any future claims. Only one such land title was presented on February 23, 1976, by Dona Lourdes Rodriguez Yaneza, and that title was in the name of Hermogenes and Don Mariano Rodriguez. That title was a fraud.

Marcos did two things. In **P.D. 1143**, he declared that the Philippines had/has a severe problem in land registration. He ordered that even legitimate occupants of land should first consent with the original owners, the Tallano Family. Then he ordered Judge Agana in the new Regional Trial Court of Pasay City to appoint **Prince Julian Morden Tallano** as the court-appointed judicial administrator for the entire archipelago that was registered under two land titles: the TCT No. 408 for the South and the TCT No. 498 for the North.

Unfortunately, the media, especially the international media, misunderstood or wanted to misunderstand and misrepresented the real facts. Marcos was actually described as a greedy land grabber. That served the vested interests of some insiders who had created land titles over vast tracts of land, so-called "prime land" in and near Manila. Marcos did underestimate the power of media, not only in that instance.

On the other hand, he overestimated his chances in the gamble over the hidden gold. 1976 was exactly 30 years after **the Original Claimants of World War II Loot** had registered their claims with the **International Court of Justice in Den Haag, Holland**. The Claimants and the Court chose to remain silent. Nobody knew, or nearly nobody.

The **Vatican** had accepted the **617,500 MT in March 1939** from the Noble Family of the Philippines and had given safety and hospitality to the two old men who represented that wealth. Unfortunately, the two died there during the war. Anyhow, assuming that that was not a one-day affair, but had been planned a long time before, the question looms whether or not that had anything to do with the unsolved question of who had financed Adolf Hitler. The arrangements between Mussolini and the Pope on one side and Hitler on the other side could be seen in a different light now.

Beautiful minds did ask what the world would have looked like if Hitler had won the War. In the same mold, a question comes up: How would the world have been today if Marcos had been right with his theory on 30-years forfeiture? What would he have done with the gold under his control?

He was not allowed to be right. In the end of 1976, there was an extension of 10 years until 1986. We all know what happened in 1986, or don't we? Chances are that we don't. They said, "Marcos has fled." The Filipino people, until today, do not know how he had fled. Chances are that we have to ask the question, whether or not the International Court of Justice has become an International Court of Injustice and to what extent there had been a conspiracy against Marcos.

Otherwise, how do we explain that in the **GUINNESS BOOK OF RECORDS** Ferdinand Marcos is listed as the "biggest robber of all time", when the highest court in New York, in the famous case against Imelda Marcos, ruled with finality in 1991 that "there was no fraud and no malversation of public funds in the case of Ferdinand and Imelda Marcos"?

Can we ask the *GUINNESS BOOK OF RECORDS* now, how much he stole so he could qualify for that “honorable mention”, and where they got that information? Because, if they cannot tell us, where they got that information, then we have to sue them in court, maybe even in the International Court of Justice. Maybe then we find out whether they are part of a grand conspiracy or not.

ACTUAL STATUS

Adding to the awkward silence of the past is the unseen but on-going global turf-war between the powers that own the Federal Reserve System, the IMF, the World Bank, and the political powers topped by the G-7 leaders, none other than the democratically elected leaders of the rich industrialized nations, where they get out of balance.

Imagine Chancellor Helmut Kohl, leader of the Christian Democratic Union, the political party of the conservatives in the Federal Republic of Germany, sitting in a G-7 meeting next to Iron Lady Margaret Thatcher of the British Conservatives in Toronto in 1983 and listening together with Ronald Reagan and Monsieur Francois Mitterand from France to Ferdinand Marcos. Marcos was called to shed light on the huge sales of gold that had stopped and reverted the high flying gold rush in 1981 and 1982, when international speculators paid \$700 and even \$800 per troy ounce.

Shock! He was the one! He did sell so much gold that the gold price is now hobbling more or less a hundred dollars below production cost since then. Why cannot Helmut Kohl or Margaret Thatcher speak out? Ronald Reagan is senile. He cannot, neither can Mitterand. He is long dead. The other three don't count. That's how it is in this world of celebrities. How then could Marcos ask for membership in such a celebrity club as G-8?

What about Henry Kissinger? He is such a good talker. Or is it his wife Nancy? Why do they not tell the world that it was Maggie T. who told Ronny R. then and there in Toronto in 1983 in no uncertain terms to kick his ass (Henry's that is) and put James Baker in his position? James Baker had, indeed, much better credentials (CIA) to do that delicate job of doing away with the yellow danger on the opposite side of the world.

Admittedly, he did a good job. Three years later, **on May 5, 1986**, the U.S. House of Representatives approved the **“costs of removing Ferdinand Marcos from office”**. That was a real generous amount, including some remarkable amounts in millions of dollars for media and PR work in the Philippines to defame and discredit Ferdinand Marcos and give the new ruling class in the Philippines (mostly former communists together with a few landed super-rich families) the moral and ethical support to rob everything under the label of “sequestration”. Forever yours, Uncle Sam!

The Big Banks have their own bank secrecy laws. In the case of Marcos, they might even have the right to remain silent, as the claim of the Philippine government that Marcos stole his wealth from the Philippine people has turned out to be a false claim. And the client is king. Especially Ferdinand Marcos was king client.

The Philippine government is in limbo, deep limbo. Since Cory Aquino was, miraculously, carried to power without being elected (the votes in that celebrated snap election were never counted) and Ramos was, miraculously also, made President eight weeks after a total election disaster where he got less than 4 percent of the votes, the Philippines is now proudly flaunting a

third president not elected by the people. The only president who had the overwhelming vote of the people is “sitting” in a hospital. They cannot put him in jail, because there is no case other than conspiracy against him.

In limbo means that the incumbent president has no way of securing a longer mandate and the real president has no chance to ever get a fair trial. Too strong is the alliance of the rich elite, the land grabbers, and the Catholic Church that has always been suppressing any opposition. And opposition can only come from the poor, even if they don't know. “Blessed are the poor...”. That's one of the reasons why intelligent people say, “Religion is opium for the poor.”

Here now comes the law that has become **the law of the Philippines** against the rich land grabbers and against the government. As recently as **October 8, 2001**, the motion for reconsideration filed by the Office of the Solicitor General for this incumbent administration of Gloria Macapagal-Arroyo was denied with the order to quiet all other land titles and to issue corresponding two land titles that shall forthwith be the basis of all other land titles.

The juicy part of this is that the petition for **Decision with Compromise Agreement** was originally filed during the Administration of Diasdado Macapagal, the father of the incumbent president, and that it became final and executory in February 1972 under the administration of Ferdinand Marcos. Ferdinand Marcos, though, was not able to implement that law against the rich land grabbers. Writ of execution after writ of execution was ordered under every president since then, but to no avail. Now, these are different times with new technologies of knowledge and information. Time will tell the difference. In the case of the Filipino poor people, justice delayed is justice denied. Too many die every day of hunger and sickness, while the rich live in luxury.

THE FUTURE

Life in the Philippines is concentrated in and around Metro Manila. With respect to real estate transactions, 98% of mortgage loans in the banking sector are on the basis of “appraised” prime properties in an area that covers only 2% of the total land area of the country. Prices are forbiddingly high here.

In a ridiculous race for prestige, the predictions of “Big Brother is watching you” in George Orwell's futuristic book *1984* or in Aldous Huxley's *Animal Farm* have become true. In the midst of new developments in technology and telecommunication, mankind has reached a hitherto unseen level of blindness and stupidity with a near total loss of personality and individuality, from the poorest of the poor to the ruling hypocrites among the rich and shameless. Free of charge: Extreme self-centeredness and self-righteousness.

On the other hand, that leaves some 98% of the country's land resources open for developments to projects other than those for instant profit. Let it be said here that the treacherous activities of land grabbers are not so much on the level of stealing land from fellow Filipinos but rather on the level of selling those same stolen lands at high prices and thereby “stealing” money from the capital markets. The newest gag is mortgage-backed securitization. They steal the money before it is even due-and-payable and invest it in greener pastures like dollar-salting or California mansions.

As there is no more capital in this country, there are also no jobs. Filipinos have to seek “job opportunities”,

underpaid work, in other countries like in the desert of Saudi, where nobody else wants to work. The desperate no-conditions-attached domestic helper is already known all over the world as “Filipina”.

That is in total contrast to one of the repeated orders of the court in LRC/Civil Case 3957-P, the order addressed to the Governor of the Central Bank to relocate the “remaining balance of 400,000 metric tons of gold in the vaults of the Central Bank” (quote from the Agana Decision with Compromise Agreement) in Manila, or in Quezon City for that matter.

This is the richest country pretending to be poor. Imelda Marcos was the one who said so first. And she would never know how right she was. The incumbent president is living up to it. She is bent on being president, because she knows since her sweet childhood, which she spent with her father, the President then, in the Palace by the murky river. And remember, she is a “classmate of Bill Clinton”! Around her are all those corrupt officials who are “in the know”, celebrating and salivating in their unforgiving greed. No wonder that the Philippines is now fast rising in the rankings for most corrupt country in the world. At least in this category, the Philippines has the chance to be the undisputed number one.

What they in the Palace do not know and will not understand, because they are “so busy”, is the odd fact that the legal owners of the land, or at least of the 98% of the land, can do as they deem fit as long as they do not interfere with government politics. They can plan big projects with the best companies in the world, even from Germany, supervising the biggest projects yet on Earth. They can even give away parcels of land to needing families or to every Filipino family, as long as they don't ask for money from the government.

The task of the Court Appointed Judicial Administrator of the **Tallano Estate** is clear and simple in one sense: **“for the benefit of the Filipino people”**. That is repeated all over the many court documents. 3,000 kilometers of railway and highway from the North to the South will be the first and biggest such project for the benefit of the Filipino people, creating millions of jobs and billions in tax money for the government.

Many other projects are in the pipeline waiting, though, for the Filipino people to wake up to reality. While the incumbent president is distributing fake land certificates in resettlement areas that are already overcrowded with squatters and second-hand, fish-ball carts in public markets to endear herself to the poor, the late president has billions and **trillions of dollars waiting in the big banks for his people** with the order to follow the **“Marcos Instructions”**. Not frozen money, not stolen money, just big money and the gold of the Royal Family of the Philippines. Just salute to him, that's all that is needed! 16 years ago, the new lady president made a mistake in judging her predecessor in office. He did not steal. **It's still there, waiting.**

Thanks to the great JUDGES **ENRIQUE AGANA**, **SOFRONIO SAYO**, and finally **ERNESTO REYES**, we do have a law in the Philippines that will provide **justice for the Filipino people!** It is now up to us to see to it that the law will be respected and followed.

From the first sentence the information is projected in incorrectness. The symbol of the phoenix on the covers is secondary to the *PHOENIX JOURNALS*. The phoenix, quetzal, thunderbird, etc., is THE symbol of your cycle of evolution. You are truly coming into death in the fire and will arise again from the ashes thereof. THAT is the meaning of the symbol of the phoenix on the cover.

I, further, most appreciate that it is noted that 10 (ten) full documents were produced in the fall of '89 with practically no research material available (our intent) to distract our scribe from her appointed work. There is now, however, abundance of backup material available for her confirmation. I ask each of you who have studied the material in the *Journals*—COULD YOU HAVE WRITTEN TEN BOOKS IN TOTAL ACCURACY, CHOOSING OF THE RIGHT SEQUENCE OF PRESENTATION AND CONTENT, CHOOSING OF THE CORRECT AUTHORS (HAVE YOU WALKED INTO A LIBRARY AND WITNESSED THE

“1. This material did not originate from A.S.S.K., nor do we at A.S.S.K. have any connection in the publishing or distribution of this material. We at A.S.S.K. do not endorse this material in any manner.”

It seems strange indeed to note that almost every taped meeting and writing since this scribe began to come into awakening was forwarded to the very ones (including Sister) since September of 1987 through mid-October of 1989. It is further most strange indeed that not only did A.S.S.K. endorse the material but Sister, did in fact, fully intend to write a second portion to *AND THEY CALLED HIS NAME IMMANUEL*. There was further agreement for publication wherein A.S.S.K. would receive 55% of all proceeds, should there be any. Dharma simply “gave” the information to Sister and at my insistence, I required an agreement—which, although verbal, was nonetheless understood by ALL involved.

From the journal entitled *The Rainbow Masters* = This journal, for the most part, is copied word for word from a booklet released by Sister Thedra over twenty five years ago entitled *The transcripts of the Masters*. These transcripts were later released in a book entitled *Secret of the Andes*. In either case, this material was not channeled in Sept. of 1989, as the journal would have you believe, but has been in print for over twenty years.

"d. From the journal entitled *Cry Of The Phoenix* = Chapter 6 of this journal was not received on Dec. 17 1989 as the author would have you believe, but rather most of this material was copied word from word from a book which was recorded by Sister Thedra over 30 years ago, entitled *Prophecies for Tiahunaco*."

Dharma, chela, you MUST look at this—do not turn away from me; you must see it for exactly that which it is. Further, how can you single out a Jonathan May when his material was taken from dozens and dozens of others from far, far back in time. What about the Skull and Bones series from Dr. Sutton? What about the *NONE DARE CALL IT CONSPIRACY* from Gary Allen in 1971? What about the great, great contributions by Gary North, Arthur Robinson, Ron Paul, John King, Walter Russell, Hal Lindsey, Lyndon LaRouche, and hundreds of others? What about Wendelle Stevens from whom, indirectly, the MJ-12 material first came into the attention of these ones?

What about Gabriel Green, *Crash at Aztec, Above Top Secret*, and the MJ-12 documents hand delivered to these ones by Virginia Essene? You want to quarrel over information property, A.S.S.K.? I suggest you reconsider the structure of your lawsuit and I further suggest that Sister listen carefully to this document and confront her group about her as to exactly WHAT THEY ARE DOING!!!!

THE RAINBOW MASTERS

Yes, this one is going to hurt the worst, Dharma, so pay attention.

You do not know about any such book released by Sister Thedra over twenty-five years ago. When Sister was in your home a year ago and told her story, I believe all present will remember that Oberli quite sharply told you to stop talking in order to hear Sister's discussion. Well, precious, it was regarding the work in question.

I shall take you farther back in time: At the writing of *SIPAPU ODYSSEY* in Jan. 1987, information was put into that story against this very day. Do you not recall that Rick pointed out to you the fact that one of the projections was the same as Sister's work—and this some three years after the fact?

As the "fantasy" of *SIPAPU ODYSSEY* was pulled from the typewriter, before editing, it was sent to Sister, whom you had met on one occasion only and knew her not. The truth was enough, at that time, from what you perceived to be a nice little movie treatment fantasy, to cause Sister to not have her annual Gathering in Mt. Shasta and come almost secretly to meet at your place. IT IS MOST STRANGE INDEED THAT WORD COMES BACK NOW (FROM LAST SATURDAY IN SEDONA) THAT IT IS CLAIMED DHARMA HAS STOLEN MATERIAL FOR *SIPAPU ODYSSEY* ALSO—THIS FROM A MEETING OF OUR FRIENDS AT THE GATEHOUSE ON SATURDAY LAST.

Further, materials "given forth in the name of Sananda" were produced and offered as countering evidence against this scribe—"secret", non-public writings. Why? Well, we too, have those documents and will be most happy to make them public. GOD IS NOT KEEPING SECRETS NOR TRUTH FROM YOU—ALL OF YOU! IT IS TIME TO THROW OFF THIS EVIL AND GET TRUTH INTO THE OPEN. I WILL OFFER ANY WRITINGS OF THIS SCRIBE TO ALL—I PLEAD CONSTANTLY WITH ALL OF YOU ONES TO SPREAD THEM AROUND AS QUICKLY AND WIDELY AS POSSIBLE.

Yes, I requested copies—some four to six months ago—that the *Prophecies for Tiahunaco* be gathered into this place, also against this day when this scribe would be totally bewildered, for we have not opened them. Three copies were ordered, paid for, and sent to this place by Zita, Rick's mother. All three still sit as a unit in the pile of entropy. The only real access Dharma would have had to Sister's work was from a paper regarding visits from Space Brothers and a handful of old newsletters. At the beginning of the *JOURNAL* writings, she was made privy to Sister's latest publications and a Cosmic Council meeting write-up from Tuieta. HOW MUCH TIME DO YOU ONES THINK DHARMA HAS FOR SPARE-TIME READING WHILE WRITING ALMOST THIRTEEN *JOURNALS* AND A WEEKLY *EXPRESS*? HOW MUCH TIME DO YOU BELIEVE SHE HAS FOR

"PILFERING" MATERIAL? SO BE IT.

As she digs around in this pile of clutter, she does find something Rick brought and shared called "Sons of God Speak".

Now back to *THE RAINBOW MASTERS*. Interestingly enough, we plan quite well, indeed. You will find that most of the book is taken up by the visits of the Seven Cohans—almost verbatim to Mark Prophet's work. I do not sanction all of Prophet's works, however, so do not rush out and claim I have endorsed it. All things have truth—**THE THINGS OF SATAN HAVE 99% TRUTH AND THEN DROWN YOU IN THE 1% LIE—IT IS HIS TRADEMARK.**

Now, let me tell you why certain ones are so very upset. It is not the use of the material that would concern anyone—especially if it were put forth in TRUTH. It is that we take the 1% lie and correct it. MOST OF *SECRET OF THE ANDES* IS ERRONEOUS AND HOGWASH. MR. COOPER'S WORK UTILIZES EVERYONE'S RESEARCH WHO CAME BEFORE HIM, INCLUDING THAT WHICH IS FALSE, AND HIS CONCLUSIONS ARE WRONG—I OFFER DOCUMENTS TO PROVE IT. I WILL NEVER SANCTION UNTRUTH NOR GIVE GREAT CREDIT TO THOSE WHO DELIBERATELY COUNTER TRUTH AND SET ABOUT WITH LAWSUITS AGAINST THE BROTHERS WHO OFFER ALL THEY HAVE.

Dharma and Oberli know nothing of *The Transcripts of the Masters*. They are familiar with *Secret of the Andes*. Fact: In the winter of 1987 Hatonn did in fact, borrow from Ranos, a copy of *SECRET OF THE ANDES* by one, Brother Philip. He, further, as a first-time experience, read it aloud in major portion onto audio tapes—discounting those portions which were erroneous. The book was returned to Ranos and has since been re-borrowed to give insight into these accusations.

Now, we have paused here and I have had Dharma thoroughly examine the copy of this book. There is no reference to Sister Thedra. The author is shown as Brother Philip—whom in actuality is George Hunt Williamson. Further, all ones at that place of A.S.S.K. keep insisting that certain things were not "channeled" on such and such. RIGHT! DHARMA IS NOT A "CHANNEL". SHE IS A TRANSCIEVER AND SCRIBE AND SHE PUTS TO PAPER EXACTLY THAT WHICH WE INSTRUCT HER TO WRITE—BE IT FROM A DOCUMENT, A NEWSLETTER, THE *HOLY BIBLE* AND/OR DIRECTLY FROM US. 99% OF ALL THE *JOURNALS* ARE TOTALLY "RECEIVED" AND NO, WE DO NOT NEED BACK-UP "PILFERED" MATERIAL AND WE DON'T USE IT—BUT YOU ONES NEED SOURCES OF INFORMATION TO CONFIRM TRUTH. IF WE MISQUOTE, WE ARE ACCUSED OF BEING PHONEYS AND WE WILL NEVER LEAVE OUR WORKERS WITHOUT RESOURCES TO COUNTER THIS VERY TYPE OF INSULT.

DHARMA, IN THE BEGINNING WAS SO DISTRESSED TO HAVE THESE INFORMATIONS AND ENERGIES COME INTO HER SPACE THAT THE FIRST ONES SHE WENT TO WERE SISTER AND TUIETA—FOR SHE DIDN'T TRUST IT, DENOUNCED "CHANNELS" IN GENERAL, THOUGHT SPACE COMMANDERS SOMETHING "FROM OUTER SPACE" AND RIDICULOUS AND WAS SCARED HALF TO DEATH. IT WAS, IN FACT, THROUGH TUIETA THAT FIRST CONTACT WAS MADE FROM HATONN AND ASHTAR. SHE HAD NEVER HEARD THE NAME "SANANDA" UNTIL 1986—FROM SISTER. SHE

WAS TOTALLY INCLINED TO ABSURDITY BY THE LABEL ASSOCIATION OF SANANDA AND SANAT KUMARA. NOT UNTIL YEAR BEFORE LAST, PER SISTER, DID SHE HOOK UP HER OLD FRIEND, GRANDFATHER, WITH THE SILVER RAY AND SANAT KUMARA. HER REACTION TO ALL OF THIS? SHE IS EMBARRASSED TO “KNOW SO LITTLE”.

Ones constantly barrage these ones with, “you know so and so”, “well, you know who Mafu, Lazarus, etc., etc., etc., is.” No, they do not. They were not interested in Metaphysics, Space-men, New Age (in fact, completely turned off by same) nor orthodox religion. They are not studied in any related material and we do not bring it into their consciousness except for confirmation—AFTER THE FACT.

YOU ONES MUST HEAR ME WELL—TO HAVE HAD SOMETHING IN PRINT FOR “OVER TWENTY YEARS” OR 2000—DOES NOT MAKE OF IT TOTAL TRUTH. IF THIS WERE NOT EVEN SISTER’S BOOK, WHY WOULD THERE BE OBJECTION? MIGHT THERE BE SOMETHING QUITE STRANGE IN ALL THIS PROJECTED “DENOUNCEMENT” OF MY SCRIBE?

At any rate, I challenge you ones to take the books in question and compare them carefully indeed. I wish the ones at the Gatehouse had been so careful and they would not be so splattered with egg and mud about the face. EVERY WORD OF THESE DOCUMENTS—EXCEPT FOR TYPOGRAPHICAL AND GRAMMATICAL ERRORS (WE DO NOT CARE FOR YOUR LANGUAGES)—HAS BEEN COMPILED EXACTLY AS STATED IN THE JOURNALS. ONES AT THESE CENTERS WHO THROW STONES, HAVE PLACED THEIR TRUST IN THE WRONG ASSISTANTS AND IT NOW CLOUDS 40 YEARS OF HUMBLE SERVICE. IT CAN HAPPEN TO ANY OF YOU AND HAS HAPPENED TO MANY, MANY OF YOU WHO FAIL TO CLEAR YOUR SPACE—THIS IS THE ENDING OF AN AGE AND THERE ARE NO BOUNDARIES BEYOND WHICH SATAN WILL NOT MOVE IF HE IS NOT STOPPED—YOU MAY NOT THINK YOU ARE DIFFERENT AND CAN STAND AGAINST HIS WORKERS—NAY, THEY WILL DESTROY YOU.

Yesterday, Dharma was in tears and overwhelmed to have been so attacked by such a supportive one who always wrote and even sent gifts to “my beloved co-worker”, and she said, “I feel like a sieve, I have so many stab holes in my back.” Ones do not realize what pain they can inflict. Bear with me friends, for I, ATON, have worked with this chela in life-stream following life-stream and I shall shore her up now. And we shall not move on with the next *Journal* until I can rebalance this energy, for these ones have been knocked down and the kicking continues.

Now for #d: Where might *CRY OF THE PHOENIX* have gotten into the message? It is not yet even published. No information regarding this *Journal* was sent to the Gatehouse—to anyone there. This *Journal* is about the “Death Rattle of Freedom”, how could very much of it have been “pilfered” from thirty-year-old prophecies from Tiahunaco? DOES ANYONE IN THAT PLACE EVEN SEE HOW TOTALLY RIDICULOUS YOU BECOME IN YOUR THRUSTING AND ACCUSATIONS? HAVE YE NOT HEARD OF COUNTER-SUITS? OR DO YOU THINK BECAUSE THESE ONES ARE SO ATTUNED UNTO ME THAT THEY WILL NOT DEFEND OF THEMSELVES? IT IS NOT THEM WHO IS BEING ACCUSED AND OFFENDED—YOU ONES

DENOUNCE THE HIGHER BROTHERHOOD OF EMMANUEL SANANDA, THE COHANS, THE ANGELIC BROTHERS AND GOD, MYSELF! BUT IN YOUR SATANIC THRUSTING YOU DESTROY A TINY, FRAIL 90-YEAR-OLD LADY AND MAKE YOURSELVES RIDICULOUS AND THINK YOU THAT I WOULD REMAIN SILENT—I AM THE WORD AND I SHALL NOT STAND SILENT. NEITHER WILL I SIT IN THE SHADOWS AND THROW STONES FROM BEHIND THE SKIRTS OF A FRAIL LITTLE OLD LADY—I STAND AND CONFRONT YOU AND YOUR EVIL TEACHER AND IT SHALL NOT BE I WHO WILL LOSE MY LITTLE BRAVE CHILDREN. I DENOUNCE YOU ONES IN THAT GATEHOUSE THAT DARE DESTROY MINE CHELA IN HER GOLDEN DAYS. THE WRATH OF GOD? “GOD IS AN ANGRY GOD?” PUSH ME AND MAKE MY DAY! FOR YOU BLACKEN THE REPUTATION OF A BELOVED FRIEND WHO WORKED FOR FORTY YEARS IN WHAT SHE SAW AS TRUTH AND I EXPECT PERFECTION AND TOTAL KNOWLEDGE OF NO HUMAN MORTAL. YOU THINK YOU ARE WISE AND SMART INDEED TO DARE GOD? PITIFUL ARE YOU IN YOUR SMUGNESS, FOR YOU BUT PROJECT YOUR STUPIDITY.

How is it that you ones do not understand? You plead with us on bended knee to send you knowledge and solutions to your puny Earth problems—your brothers come forth and give you tangible, workable insight for TODAY, and you ridicule and denounce it as “ungodly”. Shame is upon you for your blackening insults!

I stand between you and this scribe—where is your teacher as you read this? Prodding you into anger and foolish rage? Or, is he gone, leaving you to your weak defenses or totally defenseless? Pity unto you ones who wallow in the dark places—for the light of MY TRUTH shall ferret thee out!

Dharma, a break please, for you are most distressed. When we continue we will take these William Cooper accusations in minute detail. This man is being sorely used indeed and he was an honorable man—but that too is the way of Satan—USE AND DESTROY! I KEEP YOU, MY CHILD, BUT IT MUST BE THUS.

ATON to continue. Please make this a “timed” continuation of the prior document.

“3. When William Cooper [see a. above] realized that his report was being copied with the insinuation that it had been ‘channeled’ from ‘hatonn’, he simply asked that they stop. In response ‘Hatonn’ through ‘Dharma’ began to attack William Cooper in the next journals as a dark brother that was trying to keep the truth from coming out. In the transcript of Dharma’s channeling dated Jan. 04, 1990, 8:00 a.m., ‘Hatonn says:

“‘This scribe or anyone in her association of persons, did not recognize the name William Cooper and had no knowledge of his writings or lectures, etc. This was a totally unknown entity to these ones.’

“We at A.S.S.K. would like you to know that this is a lie. We, personally, sent a copy of william cooper’s report (operation Majority - MJ 12) to ‘Dharma’ and company approx 8 weeks before they came out with *Space gate*.”

HOW ABOUT SOME LIGHT!

In reverse order of outlay above, I shall respond.

As far prior to writing of *SPACE-GATE* as May 1989 and perhaps before (check out dates in the book), preliminary writings were being compiled for this *Journal*. Since Sister was receiving every document being written by this scribe it was well known that this document was in preparation and the actual type-copy ready to be set. On about August 17th came into this place a document (you will note the body of the *Journal* began in full force on August 18th) from Sister at A.S.S.K. with a note and \$2.00 in cash to cover cost of return of the document. The note requested return of the document. Dharma assumes that was accomplished, for their habit is to honor all requests.

The document enclosed was a compiled and stapled set of papers called “The Secret Government” by one, Milton William Cooper. (To this date these ones in this place have never heard of a document of Mr. Cooper’s by the label of *Operation Majority - MJ 12*. In fact—I repeat—until that date they had never heard of Mr. William Cooper.

I think whoever wrote this disclaimer is foolish indeed. How could Dharma “pilfer” all of Mr. Cooper’s “stuff” and go through two publishers and get the book to the public in the eight weeks to which they refer? There was, and has not ever been a copy of *Operation Majority - MJ 12* received in this place from anyone on any date whatsoever (refer to above). THERE WAS NO KNOWLEDGE OF A MILTON WILLIAM COOPER NOR HIS WRITINGS, HIS LECTURES OR ANYTHING ABOUT THE PERSON, NOT ONLY BY DHARMA AND OBERLI, BUT BY ANYONE AT THIS LOCATION—ALL INCLUSIVE.

After taking responsibility to publish the *SPACE-GATE JOURNAL*, arrangements were worked out among Ted, Sister and Oberli. They were going to use one, O’Rian (forgive me if I have misspelled the label) for the formatting and printing of the document. She in turn noted similarities and informed Ted. Ted sent a copy of the *Journal* to Mr. Cooper who immediately flew into a rage and said he would sue if the book were put to print. (Hardly, “he simply asked that they stop.”)

The response of Sananda was a request that the material be returned without further investment in time or expense. Then it came to light that Mr. Cooper was going to do a seminar toward the end of September, set up somehow through the efforts of O’Rian and she was most disappointed, for she had hoped to distribute the finished books at that very meeting, as well as promoting Mr. Cooper.

After much discussion, Oberli presented Ted with at least a dozen sources of the material. At this same time Sister and Ted went on a trip toward the East regarding Sister’s books.

The second day, by phone, it was stated that Sister had decided to move forward and publish the work anyway. When Mr. Cooper was informed he said then, that he would not appear for the lectures. (Well, he did—so I guess he must not have been so really “put-off” as to carry through with that particular threat.)

SPACE-GATE was to have been finished and back from the bindery by the date of that lecture (I believe approximately September 28, 1989). Hatonn nor Dharma ever attacked Mr. Cooper. Commander Hatonn simply stated that Mr. Cooper’s conclusions were incorrect and that as an example of invalid information was reference to “His Omnipotent Highness Krlll” and “Original Hostage Krlll”. Hatonn stated that was fabrication and asked the creator of Mr. Krlll to please inform America West. Mr. Lear did that and his letter

of birthing of O.H. Krill is documented and available. Commander Hatonn, at that time, extended Mr. Cooper opportunity to not only join us but he would be most pleased to have him on our team but, would not sanction further misinformation regarding the Space Command and any enslaving “little grey men”. Further, you ones on that Earth plane must realize—we do not “attack”; however, we refuse to perpetuate lies. If the error is accidental, we will meet you beyond the half-way—if uncorrected, we do not bend.

Mr. Cooper has denounced these works in every forum possible, perpetuating his own errors. That is his free-will decision and so be it. There was nothing original in his projections, as the MJ-12 material has been public for some years now and Mr. Cooper had to be long in line to write his document.

As the time has passed, Mr. Cooper called America West in almost irrational anger and said he was going to sue, and that he was going to put a stop to this “channel”. Hatonn, rightfully so, accepted this as a direct threat against the being of this scribe—you ones forget, we have the ability to see within the intention.

Now, for you, Dharma, I am going to quote a portion of a beautiful letter from one, S.M.K. as received by America West.

“Thank you very much for promptly processing my order. Your customer service is as good and fantastic as the information and truth contained in the *Phoenix Journals*.

“I tremendously enjoy and value acquiring the amazing information in your books. Humanity should be highly indebted to our Space brothers for coming forth to raise our consciousness.

“I am doing my part here by spreading the message in your *Phoenix Journals* to as many people as possible.

***** “A few days ago I spoke to Milton Cooper on the phone and I sensed instantly he is lying about how you people at America West publishers stole his material. He also said he’s suing you for copyright infringement. In fact he is the one who has to be sued, not you good folks at America West Publishers. I knew immediately the moment I read his unbound book on our Space brothers, etc., etc., to be a stolen work. How could an ordinary mortal utter so much truth and information (as yours have)? I am on your side! *****

“Pass my love and deep respect to Receiver Dharma, Son Sananda, Commander Hatonn and the entire crew of Pleiades Space Ship.

“Enclosed my check for \$20.00 for 13 weekly issues of your *Phoenix Journal Express*. Send me a list of past issues of the *Phoenix Journal Express*.

“In a few days time I may visit you good folks at Carlsbad.

“Love to you all., Your friend—S.M.K.”

Blessings unto you son, for this is the only food upon which these ones have to survive. This energy is originated in the Far East and the message is thusly far more gracious and sincere that you receivers understand.

I do not mean to leave any of you wondrous supporters out of recognition—for the letters of support, joy and appreciation come from all parts of this world. And—your co-workers out here are humble in their appreciation to each and every one of you. It is not an easy job—IT IS THE HARDEST JOB SINCE THE CREATION OF YOUR PLANET. SO BE IT AND BLESSINGS. The love and help are clutched unto these ones, for their journey has been long and difficult and Son Sananda faces the most horrendous confrontation

of a God, indeed. The brothers from Space within the Command have been on constant alert for well over three of your years of counting and hundreds of years away from their homes to fulfill their missions. So be it.

Suffice it to say, these ones have nothing to pick with William Cooper, George Hunt Williamson or Sister Thedra, although they perceive great injury and pain from them. Rest in the knowledge that it can only benefit truth in the ending. We have most carefully insulated you and he who wishes to “sue” had better think quite carefully indeed.

It was said, on Saturday last, that these ones are riding on the success of A.S.S.K. to live in their abundance and in a high manner. Well, let us look at that. These ones have had basically no income for over 4 years. They have been reduced to two bankruptcies, they now owe about \$100,000 in legal fees over legal problems related to their property, the rental amount and legal fees also borrowed so they are in debt some \$300,000 in order to continue their work in MY service. Others in this place have given as much according to that with which they started.

Yes, abundance is coming from the fruits of their labors—but not from these *JOURNALS*. They have projects under financing to build of a city and funding is imminent. They will not have anything personally. All proceeds of these *JOURNALS* are given away—some for the treatment apparatus for AIDS, survival shelters, building and research.

On the weekend prior to the departure of Ted and Sister Thedra on their trip to the Eastern U.S. last September, one, G.B. came to Sedona (G.B. having been previously with the Gatehouse) and brought with him a substance called Ecstasy (Adam). A highly illegal drug. He visited with unnamed parties in which the parties involved participated in the enjoyment thereof.

This is not second-hand—THIS IS FROM ME, ATON. This person did take Sister and gave her a dose of the substance from which (whether or not anyone in that place realized it—did in fact physically kill her). WHY EUROPE MAY DELIVER U.S. MAIL

The *Washington Times* recently reported, "The European Union is demanding that foreign companies be allowed to compete with the U.S. Postal Service as part of World Trade Organization talks that began last year."...

Reportedly, Europe also wants access to American markets for municipal water and waste services. It also will call for foreign companies to be given access to Small Business Administration loans. Gosh, oh, gee golly—what took them so long?

This overreaching inevitability is going to be formally presented to the U.S. government by the end of June. It is Phase 1 of an incremental jihad in WTO negotiations on trade in services. We can expect the probing attacks to include industries from energy and finance to telecommunications. This is just the beginning.

This is *exactly* what an eclectic collection of dissonant pundits were warning of a decade ago when WTO was established as a global "dispute resolution" tool....

At the time of the doomed debate I sent out thousands of talking-point sheets, which included seven key points on the WTO. I have resurrected that list (originally developed by Dr. Pat Choate) and added it to my Website.

The first two items note:

1. *The WTO will have the same status as the UN, IMF, and World Bank.* Article VIII of the Agreement... states the WTO "shall have legal personality and shall be accorded by each of its members such privileges and immunities as are necessary for the exercise of its functions." The existing GATT organization will disappear.

2. *Under WTO, Congress agrees to change U.S. laws to meet WTO obligations.* Article XVI, paragraph four... states, "Each Member shall ensure the conformity of its laws, regulations, and administrative procedures with its obligations as provided in the annexed Agreements."

NAFTA and GATT were approved by Congress 10 years ago *not* as treaties but as "agreements", a distinction without discernible procedural differences but with one major legal difference: A treaty would have required a supermajority approval by the Senate. The globalist bastards knew they couldn't get that dog to hunt, so they created the legal fiction of the "agreements". There are plenty of euphemisms for excrement; none of the labels changes the character of the substance.

What did this legal fiction accomplish? The WTO will be the global Supreme Court of trade disputes. As per Section 2 of the Dispute Settlement Understanding, the WTO will adjudicate global trade disputes, monitor national responses, and compel enforcement of its decisions. *WTO rulings are final.*

The WTO can impose trade sanctions and fines on the U.S. if we do not abide by its decisions. The WTO can authorize cross-sector retaliation. If the U.S. loses a WTO dispute panel decision, for example, the World Trade Organization can give the plaintiff nation(s) authority to select which U.S. industries, or combination of U.S. industries, must bear the burden of the WTO trade sanctions. Under WTO, innocent bystander industries can be drawn into any trade fight....

EU WANTS TO BID ON U.S. MAIL

The European Union is demanding that foreign companies be allowed to compete with the U.S. Postal Service as part of World Trade Organization talks that began last year.

According to a draft copy of its demands obtained by the *Washington Times*, Europe also wants access to American markets for municipal water and waste services. It also will call for foreign companies to be given access to Small Business Administration loans.

The European demands, which will be formally presented to the U.S. government by the end of June, mark the opening salvo in WTO negotiations on trade in services, an area that includes industries from finance to telecommunications to energy. The talks began in earnest when the organization agreed at a November meeting in Doha, Qatar, to make a new attempt to remove barriers to international commerce....

A European official, who asked not to be identified, said the document is "not final and official" but conceded that it gives a clear look at the demands the United States will hear from its trading partners in the new negotiations.

The Office of the U.S. Trade Representative, which will present a list of U.S. demands to Europe later this year, had no comment on the document.

Europe is renewing a long-standing demand that the United States allow foreign-owned ships to ferry lucrative cargo between U.S. ports, something that is prohibited by the Jones Act. The law requires these ships be built, owned and operated by Americans. A coalition of shippers, shipbuilders and maritime-state legislators has always frustrated efforts to change the law.

The suggestion that foreign companies be allowed to deliver U.S. letters seems certain to face equally tough opposition....

World negotiations on services are governed by General Agreement on Trade in Services, created in the early 1990s. It lays down rules for regulating services that affect such agencies as the Securities and Exchange Commission, the Federal Communications Commission and state insurance regulators.

Also, countries must hash out among themselves promises to allow foreign companies to deliver mail or provide transportation services....

But business groups scoff at the notion that the WTO negotiations will destroy government monopolies.

"The foundation of the WTO is not discriminating against foreign companies," said Bill Reinsch, president of the National Foreign Trade Council. "If we don't let American companies do it, we don't have to let European ones in."

ISRAEL BLOCKS UN INQUIRY

TEL AVIV, Israel—Israel on Tuesday continued to block the UN "fact-finding committee" probing the incursion into the Palestinian refugee camp in Jenin.

After a meeting of the Israeli inner security Cabinet, a government statement said the committee could not come to Israel to begin the investigation yet because of "issues vital for a fair examination".

"As long as these conditions are not fulfilled, it is impossible to begin the examination."

The UN team, led by former Finnish President Martti Ahtisaari, has been waiting in Geneva since Wednesday for permission to enter Israel.

Under strong pressure from the Bush administration, Israel agreed in principle to an independent international inquiry into its massive military operation in the Jenin camp, but has since raised objections about the composition and the scope of the UN-appointed committee.

The committee's first rebuff came when Israel tried, with limited success, to expand its membership and ensure the United Nations examine Palestinian activities in the camp.

But a fundamental problem is Israel's long-standing suspicion of the United Nations and its fears the committee will ignore Palestinian actions at the expense of the Israelis.

Israel insisted the politicians and "human rights specialists" who made up the initial committee were not qualified to assess the security threat Israel faced, and the effort it used to counter that threat. It asked for military and anti-terror experts be added to the group. Ahtisaari then took on military and counter-terror specialists as advisers but not committee members.

Israeli Foreign Minister Shimon Peres said Tuesday the government still had six conditions. Foreign Ministry officials would not list Israel's demands, but Peres said the United Nations "more or less" knew them. Sources said they include the government's insistence on the right to determine who will testify before the committee.

Peres said the government did not want Israeli soldiers to be "questioned, not even testify as witnesses, unless the army decides it is vital."

Peres' media adviser, Yoram Dori, told *United Press International* Peres said the United Nations should adhere to the Security Council's original decision to send a committee to gather information without drawing conclusions.

The team was formed after Palestinian allegations of a massacre of hundreds of refugees in Jenin during the Israeli occupation. Israel maintains the camp was "the capital of the suicide bombers" and says no massacre took place.

Peres said that according to his information seven civilians and 45 Palestinian fighters were killed. The Israelis lost 23 soldiers.

Israel is facing criticism for extensive demolition in the center of the camp. Intelligence Col. Miri Eisin said Israel destroyed 100 of the 1,100 houses in a bobby-trapped area. Israeli officials argue the level of fighting justified calling in air or artillery support, but it sent bulldozers in to let people flee and save lives.

International organizations have criticized Israel for denying access to ambulances and water even after the fighting ended, a charge the army denies.

Sunday, the government of Prime Minister Ariel Sharon accepted a U.S. proposal designed to lift the siege on Palestinian leader Yasser Arafat's headquarters in Ramallah, and ministers said this was done to gain U.S. support in the Jenin issue.

[JR: Israel didn't make an appeal, but more than likely demanded the U.S. delay the UN's fact finding mission to investigate the devastation at the Jenin refugee camp. The Israeli's lament or excuse is that they won't receive a fair inspection because of certain "vital issues". Those vital issues of concern have to be the means and methods that were used by the Israeli military to fight the terrorists that resulted in the deaths of Palestinian civilians. They are also finding it difficult to explain how bulldozers are a more humane method of killing than artillery fire. UN WILL DISBAND JENIN TEAM RATHER THAN YIELD TO ISRAEL

Kofi Annan, the United Nations secretary general, signalled last night that he would be willing to disband the UN mission to investigate atrocities in Jenin rather than yield to Israeli pressure to change its make-up and mission.

The news, which came after Israel's security cabinet said it would refuse to co-operate until its terms were met, was greeted with anger behind the scenes by the Palestinian leadership, which believes Israel is attempting a cover-up.

Faced with Israel's continued refusal to budge on the issue, Mr. Annan's office said he was "minded to disband" the team, which was approved by a UN Security Council resolution unanimously passed after the scale of the

devastation in Jenin became known...

What was unclear was whether Mr. Annan's words were a manoeuvre intended to satisfy protests from the Europeans and Arabs and add to the pressure on Israel, or whether he genuinely means to end the mission. Until now, the signs have been that he was committed to the mission. But his words were likely to add to suspicions among the Arabs and Palestinians that America has quietly agreed not to pressure Israel over the mission, if Mr. Sharon's government agrees to a U.S. and British initiative to end Yasser Arafat's confinement in Ramallah.

Late last night, Israeli tank shells killed a two-year-old Palestinian girl in Rafah, near the Gaza Strip's border with Egypt, Palestinian witnesses said. Israel said it had fired a shell at a group of "terrorists".

[JR: It was expected that the UN would back off and cave under U.S./Israeli pressure to allow observers into Jenin. Israel has made it clear it does not have to answer or explain its actions to the world nor any other higher authority... God.]

GAZANS PREPARE FOR A REPLAY OF JENIN

GAZA—They are coming. That's what most Gazans tell you. The Israelis are coming. But the sand barricades are pathetic. Even a mile from the Erez "Safe Crossing" point constructed during the early days of the mad dream of Oslo, the best that Arafat's legions can do is erect a 15-foot high rampart of earth and sandbags with a 12-foot wide gap for local cars—and for Israeli Merkava tanks when Ariel Sharon decides to drive in.

But the cops go on waving the donkey-carts past the traffic lights and the Palestinian Authority guards slumber with their Kalashnikov rifles in their tin shack, ready for Part Two of the Sharon War on Terror.

The odd thing is that if the Israeli prime minister really wants to dismantle the "network of terror" of which he speaks so frequently, Gaza—the one place in which the Israeli Army has not yet dared to re-occupy—should perhaps have been his first target. For here are militias aplenty, Palestinians who know how to destroy Merkava-3 battle tanks, who can manufacture short-range rockets and mortars and know the principles of booby traps better than the refugee gunmen of Jenin. As one local put it Thursday, "This place is wired."

Its people are certainly preparing for the worst. The banks report massive withdrawals. Human rights groups are duplicating their files. Everyone knows what happened to the computerized archives of the Palestinian ministries in Ramallah and Nablus and Jenin; they were stolen by the Israeli soldiers because—in the imperishable words of one Israeli officer: "Documents have a very important value." But this is 'Palestine'. "They say they've copied all their papers," a Western human rights worker put it succinctly. "But I don't think they've finished making CD's of all the files in our office and the paper archives are too large to photocopy now. They simply haven't started to get the work done." Yet there is a grim determination to accept the future. Raja Sourani, a human rights lawyer with the most eloquent if pessimistic view of the coming weeks—or days—has few illusions. "I think it's going to be bleak, black and bloody and I can see the blood that will be shed will be Israeli as well as Palestinian. The Palestinians are not ready to be good victims any more. They have nothing to lose. The Israelis have opened Pandora's Box. I never in my life have felt our morale and determination to be as high as it is now. I'm very proud—and I'm scared to death..."

He reckoned he would lose the money when he was searched. But when he came back, the rice was overturned and the money had gone. The graffiti warn of re-occupation. A hand-grenade on one wall, a drawing of a wired bomb on another predict the doom of occupiers.

Homes I entered were stuffed with food, water, blankets, in some cases sandbags. As the sea flopped onto the Gaza beach in the sultry afternoon, a few fishing boats glided over the water. But the catch doesn't count for much when four-hour power cuts—unannounced as usual, by the Palestinian Authority—cut off deep freeze and fridges.

As one Palestinian remarked: "How easily one falls into these categories to avoid identifying someone who may soon be in a prison cage—an Israeli assault is 'as certain as I am seeing you'. It was a matter of time," he said.

"I don't trust the Arabic news. I listen to the news in Hebrew from Israel. Gaza sets the tone there—the Israelis can't complete their objectives without Gaza. It's here that Palestinian history has been decided for the past 54 years." True, up to a point. The Palestine National Council first proclaimed Palestinian independence in Gaza on Oct. 1, 1948, adopting the old green, white, black and red banner of the Arab Revolt as the flag of Palestine.

But then the Gaza Strip became a slum backyard of Egypt while the mayor of Hebron handed over the West Bank to the Jordanian monarchy at a ceremony in Jericho. If Gaza is the last bit of unoccupied 'Palestine' left, it's a midden*. **(JR: *Dunghill or refuse heap).**

"I think everything depends on three things." Sourani says. "It's about what's going on back in Washington. It's about how far the Europeans will involve themselves.

And it's about how soon some dramatic event will take place on the ground against the Israelis that will give them an excuse to move. I know all about what is called "looting and wanton destruction" in the West Bank. This is not new to us. We dealt with hundreds of such cases in the past and won cases of looting against the Israeli Army in the Israeli courts."

Sourani has completed the duplication of all his human rights records. "And when the Israelis come, we shall keep on working here for human rights. We will not allow ourselves to be panicked or become paranoid. We learned something from the Israeli occupation in the past—to be professional and to be strategic. They made our bones strong." In the coming days—or weeks—Sourani's words may well be put to the test.

[JR: Israel on 4/29 did make an incursion into Hebron and then backed off. Did Sharon get a call from Bush or Powell saying not yet... the timing isn't right? CONGRESS PASSES PRO-ISRAEL RESOLUTIONS

WASHINGTON—A week after the White House asked Congress to avoid action that could "inflamm" the situation in the Middle East, the Senate Thursday approved resolution with pro-Israel sentiments.

The vote was 94-2, with Sens. Fritz Hollings, R-South Carolina, and Robert Byrd, D-West Virginia, voting against it. Minutes later the House approved its version 352-21, with 29 representatives voting "present".

The White House said it would have preferred Congress not take up the resolutions at all, but spokesman Ari Fleischer said the timing is "much better" now than a week ago because of encouraging developments in Israel.

Rep. Tom DeLay, R-Texas, a sponsor of the House bill, worked with White House officials as late as Thursday morning to finalize language that would satisfy both the White House's desire to protect its diplomatic efforts and DeLay's desire to hold Palestinian leader Yasser Arafat accountable for allowing terrorist attacks to continue against Israeli citizens.

For instance, an earlier draft of the DeLay resolution condemned Arafat's "support and coordination" of terror. At the White House's request, that language was softened by dropping the word "coordination", an aide to the majority whip said.

Also, a paragraph was added that "encourages the international community to take action to alleviate the humanitarian needs of the Palestinian people." The White House wanted the language added to reflect that not all Palestinians are responsible for the suicide attacks, the Delay aide said.

The Senate bill, written by Sen. Joseph Lieberman, D-Connecticut, was considered milder by the White House and it did not ask for any changes in language.

The resolution states clear support for Israel's actions in the past month, even though the White House's repeated calls on Israel Prime Minister Ariel Sharon to withdraw were generally ignored.

"The Senate stands in solidarity with Israel, a front-line state in the war against terrorism, as it takes necessary steps to provide security to its people by dismantling the terrorist infrastructure in the Palestinian areas," says the resolution.

It also "demands that the Palestinian Authority fulfill its commitment to dismantle the terrorist infrastructure in the Palestinian areas."

House Republicans had planned to move the DeLay resolution earlier this week. But they put it off after Secretary of State Colin Powell warned the language could "inflamm" the situation because the original language directly linked Arafat to terrorism.

They quickly put the House resolution back in play after Lieberman announced his intention to move his resolution this week.

Senate Majority Leader Tom Daschle said he wanted to act before Sharon comes to Washington next week.

"I think it's important for us to express our solidarity with Israel as they are under attack with the suicide bombers that have so plagued their country over the last many months," Daschle said. "So, that is the intention. To simply restate our solidarity with the people of Israel."

[JR: Perez told Sharon to be careful how he antagonizes the Americans as they might cut off their aid to Israel. Sharon's response was right when he told Perez: "Don't worry about the U.S.—we control them!" This pro-Israel resolution certainly confirms that! Need we say more?]

U.S. GAVE GREEN LIGHT TO TERRORISTS IN BOSNIA

The Dutch government has released a report that details the alliance between the United States and the Islamic effort to help Bosnian Muslims. The report determined that the United States provided a green light to groups on the State Department list of terrorist organizations to operate in Bosnia. This included the Lebanese-based Hezbollah. For the European Union, the U.S. effort marks a stain that calls into question Washington's war on terrorism.

For nearly a decade, the Clinton administration helped Islamic insurgents aligned with Chechnya, Iran and Saudi Arabia destabilize the former Yugoslavia. The insurgents were allowed to bring weapons and explosives to Bosnia-Herzegovina and fight Serbs and their allies. The insurgents also were allowed to move further east to Kosovo.

The United States was helped by a range of Muslim countries—from Iran and Saudi Arabia to Turkey. In short, the Clinton administration thought that the stronger the Muslims in Bosnia, the weaker the Serbian hold over Yugoslavia.

Today, there are tens of thousands of Islamic insurgents throughout such countries as Bosnia, Croatia and Kosovo, and many of them are moving west to Austria, Hungary, Germany and Switzerland.

The U.S. Defense Department, which helped run the Islamic weapons smuggling operation in Bosnia, now faces a huge blowback problem as many Hezbollah operatives have moved to greener pastures in Western Europe. Over the last decade, Islamic extremism has increased its strength in such countries as Britain, France, Germany and Sweden to the point where their foreign policy is hampered.

The Islamic blowback is believed to be vast. These days, Bosnia—under heavy Iranian influence—is regarded as too dangerous for senior U.S. officials to visit. Both Bosnia and Kosovo also serve as launching pads for terrorist attacks both in the West and in the Middle East.

More than a few European countries, consequently, have turned their nose up at the Bush administration's appeal to take Islamic terrorism seriously.

[JR: Did the U.S. set up this alliance with the Bosnian Muslims 10 years ago to jump start a plan to keep the EU and the Middle East in line in order to insure the plans to expand a U.S. presence worldwide? Should the Middle East or Europe challenge our initiative they might experience a 911-type terrorist act. It was also ten years ago that the planners in D.C. were busy plotting the war in Afghanistan in order to gain control of the region for the oil cartels. What a perfect plan, born out of evil, for continuing indefinitely our "war on terrorism" and to grab all for the secret Elite.]

U.S. SEEKS TO CALM AFGHAN WARLORD

KABUL—U.S. officers held talks with rival commanders in the eastern Afghan border province of Paktia yesterday in an attempt to end clashes that have left more than 100 people dead or wounded.

Troops loyal to Padsha Khan, the ousted governor, have been shelling the centre of Gardez, the provincial capital, since Saturday morning in an effort to regain control of the city.

U.S. troops have set up a forward base in the city as they hunt down al-Qaida and Taliban fighters hiding in the mountain ranges and passes that straddle three Afghan provinces and friendly Pashtun tribal areas in Pakistan.

U.S. troops came under attack in Gardez from suspected al-Qaida and Taliban forces two weeks ago. There were no casualties.

"We are in conversation with some of the leaders to try to calm down the situation," said Major Bryan Hilferty, the U.S. military spokesman.

Hamid Karzai, leader of the interim Afghan government, removed Padsha Khan as governor after fierce fighting with a rival local commander erupted in January. Padsha Khan has been mustering forces since.

For several months, Mr. Karzai has been pleading with U.S. and European leaders to expand the British-led international security beyond the capital, Kabul.

He has asked for up to 20,000 foreign troops to control regional rivalries and subdue the ambitions of warlords who are re-asserting themselves following the fall of the Taliban regime.

On a flying visit to the country on Saturday, Donald Rumsfeld, the U.S. Defence Secretary, promised funds for the training of the fledgling Afghan national army but made no mention of expanding it.

The new Afghan army has finished training its first 600 recruits but, even if all promises of international assistance materialize, it will not have sufficient numbers to handle internal security properly for several years.

A reminder of the size of the task of training and modernizing the new force was provided yesterday at a military parade in Kabul to commemorate the tenth anniversary of the end of Soviet-backed rule.

Platoons of soldiers in ill-fitting uniforms struggled to march in time to an off-key brass band. Ageing Russian tanks—most left behind by the retreating Red Army in 1989—clanked along, belching fumes.

On Saturday, one of the air force's nine fighter jets crashed in a practice run for the parade, killing the pilot. In a flypast yesterday, a helicopter gunship almost took the top off a mosque's minaret.

Rather than being festive, the atmosphere was thick with the tensions bedeviling the interim authority. Fahim Khan, the Defence Minister, who has been promoted to marshal, controls most of the forces on display.

For all the proclamations of solidarity and heroic resistance blaring from the loudspeakers, the day was essentially a show of strength by the ethnic Tajiks of the Northern Alliance forces, which dominate the interim government and a warning to the Minister's rivals sitting alongside him in the grandstand.

Most of them, resplendent in ceremonial turbans and flowing beards, led factions that fought the Russian invasion together but turned on each other in the ruinous civil war that followed the removal of a Soviet puppet regime in 1992.

Their rivalries still run deep, and almost all still command significant forces.

Most Afghans believe without the steadying influence of foreign troops their country could soon blunder into civil war again.

[JR: Afghan civilians and the Afghan fighters are the ones who get hurt or are killed but our U.S. troops never seem to suffer casualties or losses except through "accidents". Should we be suspicious that our media aren't allowed to report anything about U.S. losses or setbacks in our war in Afghanistan? They do not need our assistance as they have the power in the regions they control. That is a conundrum for us, and one that won't easily be solved except through brutal force. FRAUD CLAIMS TAINT MUSHARRAF VICTORY

ISLAMABAD, Pakistan—Pakistani President Pervez Musharraf's landslide victory in a referendum that will extend his rule for five years is being marred by allegations of widespread fraud.

Election officials say Musharraf got 97.7 percent of all votes cast and put the turnout at over 50 percent, but critics say Tuesday's poll was a fraud, questioning both the results and the way the vote was carried out.

Musharraf, the country's top general, seized power in a bloodless coup in 1999 and risked national outrage by siding with the United States in its war on terror against the al-Qaida network.

The referendum was designed to give him a mandate to bolster economic and political reforms, and to remain in power after parliamentary elections due in October.

Information Minister Nisar Memon described the vote as "a massive victory for the people of Pakistan".

But human rights groups have slammed the vote, saying the machinery of the state was used to ensure victory. They accused organizers of tolerating widespread cheating, including allowing people to vote several times and coercing voters.

Representative of the independent Human Rights Commission of Pakistan, Asma Jehangir, said teams from her organization visited about 150 polling stations throughout the country.

They videotaped people voting several times, casting ballots without showing identification and not getting stamped with the indelible ink that was supposed to prevent voting more than once.

Among those she said were "coerced" into voting were prisoners, civil servants and employees of businesses close to the government.

While the country of 140 million would typically have 70 million eligible voters, the electoral commission lowered the voting age from 21 to 18, giving millions of youths normally supportive of Musharraf a vote.

It also set up thousands of polling stations in hospitals, prisons, gas stations and other unorthodox places, in a bid to counter opposition efforts to lower turnout by calling for boycotts.

"The whole thing has been a humiliating fraud," Jengahir said.

Pakistani opposition forces accused the government of stuffing the ballot box, with Musharraf supporters allegedly stamping stacks of ballot papers to ensure his success, while analysts complained about a lack of process.

"There was no voters list, no polling agents, no question of verifying eligibility to vote," said Arif Nizami, editor of the independent national daily *The Nation*.

Independent observers also questioned the government's turnout figures, saying polling stations were largely quiet in country's two biggest cities, Karachi and Lahore....

Opposition political parties and Islamic groups, which called for a boycott of the referendum and dismissed it as undemocratic, estimated a turnout of just 5 to 7 percent.

"Tuesday's referendum was a fraud and the real turnout was the lowest in history," Amirul Azeem, spokesman for Pakistan's largest Islamic group Jamaat-e-Islami, told the *Associated Press*....

Pakistan's information minister Memon said reports of low turnout and irregularities had not been verified and were in any case exaggerated.

The United States has refrained from criticizing the referendum, with a State Department spokesman in Washington saying it's up to the Pakistani people to decide its value.

But Commonwealth Secretary-General Don McKinnon said Pakistan would be monitored and discussed at the next Commonwealth Ministerial Action Group meeting.

Pakistan was suspended from the Commonwealth, a grouping of former British colonies, after Musharraf's coup.

Musharraf's victory was widely expected, since the leaders of the main opposition parties—both charged with corruption—are outside Pakistan. Their parties boycotted the vote, demanding Musharraf step down and return the country to democracy.

[JR: The Musharraf victory reeks of fraud. The government is disregarding and ignoring the charges of flagrant abuses in the electoral process. Despite objections from political leaders, opponents and lawyer groups the Pakistani Supreme Court allowed the referendum to be voted on. The appointed heads of all world governments are in the business to bypass their constitutions and to rewrite or interpret the laws to suit their plans and agendas. It seems that in promoting the U.S. brand of democracy we are also building and creating dictatorships around the world. Musharraf might have won this victory but there is a rocky road ahead for him even with U.S. support. RUSSIAN GEN. LEBED WARNED OF SUITCASE NUKES, DIES IN CRASH

Former top Russian security official Gen. Aleksandr Lebed, who warned the U.S. Congress five years ago that at least 80 suitcase-sized nukes from the old Soviet Union's weapons arsenal had gone missing, was killed Sunday in a helicopter crash.

At the time of his death, Lebed was governor of the huge Krasnoyarsk region of Russia, and was considered a key regional leader, the *Associated Press* said.

A national hero, Lebed was a battalion commander in 1981 during the Soviet war in Afghanistan, where he won top military honors. But his popularity went far beyond military circles, with a career that had earned him a national reputation as someone who was willing to confront the Russian establishment.

For the U.S., however, Lebed's most significant legacy may turn out to be the information he imparted to Rep. Curt Weldon, R-Pa., during a 1997 fact-finding trip to Russia.

Weldon recounted Lebed's bombshell revelation during a March appearance on *Fox News Channel's "Hannity & Colmes"*:

"This goes back to May of 1997 when I took one of my delegations to meet with General Lebed, who had just stepped down as Yeltsin's top security adviser.

"He was talking about the state of the Russian military and how generals and admirals were selling off technology they used to control because they felt betrayed by the motherland.

"It was then that he related a story to myself and six of my colleagues that he was assigned by Yeltsin to account for 132 small atomic demolition munitions. These are commonly referred to as suitcase nukes."

Weldon continued:

"He said, 'Congressman, I used all the leverage I have as the president's adviser. We could only locate 48.' Which meant that there were over 80 small atomic demolition devices with the capacity of one to 10 kilotons that they just could not locate.

"I came back and briefed the CIA and they said, 'Basically, we have no way of knowing [if that's true]," Weldon recalled.

Russian officials subsequently denied Lebed's claim. But U.S. government officials remain concerned that rogue elements in the Mideast—terrorists Osama bin Laden or Saddam Hussein—may have gotten their hands on some of the missing Russian suitcase nukes.

In September, Rep. Chris Shays, R-Ct., chairman of the House Subcommittee on National Security, said "We don't really have a straight answer from our own government" on whether Lebed's report was accurate.

In 1992, former senior KGB intelligence officer Stanislav Lunev defected to the U.S. and revealed KGB plans to plant dozens of suitcase-sized nukes throughout the U.S. He documented his account in his 1992 book, *Through the Eyes of the Enemy*.

Lunev is now a contributing writer for *NewsMax.com*.

In 1999, a second KGB intelligence officer, Vasili Mitrokhin, defected to Great Britain and corroborated many of Lunev's claims. **[JR: Gen. Lebed's warning to the U.S. about the missing suitcase nukes was of a concern to him as well as the Russian military. His information was credible because the Russian government under Yeltsin's leadership had become corrupt and very unstable. The Russian officers and military personnel were not paid and were discharged from service to face a failing economy and unemployment. The selling of military equipment and technology was well publicized in the Western press. No one in U.S. intelligence (??) has admitted to an investigation of Lebed's allegations. The situation today is such that a suitcase bomb threat is all too much a reality, whether the Russians sold the bombs or that the Taliban or al-Qaida bought them. Homeland Security admits that there is no way to defend**

ADL FOUND GUILTY OF SPYING
BY CALIFORNIA COURT

WASHINGTON—The San Francisco Superior Court has awarded former Congressman Pete McCloskey, R-California, a \$150,000 court judgment against the Anti-Defamation League (ADL).

McCloskey, the attorney in the case, represented one of three civil lawsuits filed in San Francisco against the ADL in 1993. The lawsuit came after raids were made by the San Francisco Police Department and the FBI on offices of the ADL in both San Francisco and Los Angeles, which found that the ADL was engaged in extensive domestic spying operations on a vast number of individuals and institutions around the country.

During the course of the inquiry in San Francisco, the SFPD and FBI determined the ADL had computerized files on nearly 10,000 people across the country, and that more than 75 percent of the information had been illegally obtained from police, FBI files and state drivers' license data banks.

Much of the stolen information had been provided by Tom Gerard of the San Francisco Police Department, who sold, or gave, the information to Ray Bullock, ADL's top undercover operative.

The investigation also determined that the ADL conduit, Gerard, was also working with the CIA.

Two other similar suits against ADL were settled some years ago, and the ADL was found guilty in both cases, but the McCloskey suit continued to drag through the courts until last month.

In the McCloskey case, the ADL agreed to pay (from its annual multi-million budget) \$50,000 to each of the three plaintiffs—Jeffrey Blankfort, Steve Zeltzer and Anne Poirier—who continued to press charges against the ADL, despite a continuing series of judicial roadblocks that forced 14 of the original defendants to withdraw. Another two died during the proceedings.

The ADL, which calls itself a civil rights group, continued to claim it did nothing wrong in monitoring their activities. Although the ADL presents itself as a group that defends the interests of Jews, two of three ADL victims are Jewish.

Blankfort and Zeltzer were targeted by the ADL because they were critical of Israel's policies toward the Palestinians.

The third ADL victim in the McCloskey case, Poirier, was not involved in any activities related to Israel or the Middle East. Poirier ran a scholarship program for South African exiles who were fighting the apartheid system in South Africa.

At the time, the ADL worked closely with the then anti-apartheid government of South Africa, and ADL's operative Bullock provided ADL with illegally obtained data on Poirier and her associates to the South African government.

But the conclusion of McCloskey's case does not mean the end to the ADL's legal problems.

On March 31, 2001, U.S. District Judge Edward Nottingham of Denver, Colorado, upheld most of a \$10.5 million defamation judgment that a federal jury in Denver had levied against the ADL in April of 2000.

The jury hit the ADL with the massive judgment after finding it had falsely labeled Evergreen, Colorado residents—William and Dorothy Quigley—as “anti-Semites”. The ADL is appealing the judgment.

[JR: One small monetary victory for those victims targeted by Israeli-operated ADL. What would be a major victory is when the courts rule that the ADL has gone beyond reasonable bounds to “defend Jewish interest”. The courts

have failed to reign in the ADL and to order the monitoring of the ADL's illegal and clandestine activities. All the courts have succeeded in doing is stirring the vipers' nest but not getting rid of the vipers and their venom.]

MONTANA LAB MAY LEAD BIOTERROR DEFENSE

HAMILTON, Montana (AP)—A laboratory in Montana's Bitterroot Mountains is on track to become the federal government's fourth Biosafety Level 4 research facility, handling the world's most dangerous microbes to help develop defenses against bioterrorism.

Rocky Mountain Laboratories, a part of the National Institutes of Health, pioneered research into Rocky Mountain spotted fever and Lyme disease. It now has been approved for a \$66 million expansion for bioterrorism research, including upgrades to the maximum-security level. It will be the only Level 4 lab in the West.

James Musser, a biomedical researcher and a chief of one of the Rocky Mountain labs, said specifics of the expanded research in Hamilton have not been decided.

“Because of the limited space in a Biosafety Level 4 facility, one has to carefully choose exactly what kind of pathogens we're going to study,” he said.

BioLevel 4 labs are the highest-level security labs which, among other things, require workers to wear “spacesuit”-style contamination jumpers. The government currently has Level 4 labs at Fort Dietrich, Md., Bethesda, Md., and Atlanta. The nonprofit Southwest Foundation for Biomedical Research operates one in San Antonio. Another Level 4 lab is planned at the University of Texas Medical Branch in Galveston.

The new lab was planned before Sept. 11 and the string of anthrax attacks that followed, administrator Pat Stewart said. Rocky Mountain already was studying organisms that could be used in biological attacks, and Stewart said existing expertise at the Rocky Mountain complex is the main reason for building the new lab there.

Rocky Mountain Laboratories, in a neighborhood of well-kept homes at the foot of the Bitterroot Mountains, began early in the 20th Century. It now employs about 230 people and provides some of the best pay in Hamilton, a onetime timber town that is rapidly growing as a wilderness gateway and mountain retreat.

Officials have just begun conferring with architects and others involved in developing the new lab. For the community, information about the expansion came during a town meeting lab officials held in February.

“You have to view it as a positive thing,” said pharmacist Wayne Hedman at Bitterroot Drug. “That is clean industry and a lot of the jobs are high-paying jobs.”

The new lab may add 50 to 65 positions, Stewart said.

Hedman said that besides the economic impact of lab employees, he likes the intellectual enhancement that worldclass scientists and their associates bring to this community of 3,700 people.

The hazardous nature of the new research does not concern him.

“There's enough redundancy, enough backup, in that whole process that I feel very secure,” Hedman said.

But bookseller Cyndy Gardner said that while she appreciates the Rocky Mountain employees' impact on community life, she questions why the new lab must be built in the “warm, friendly, family-oriented neighborhood” where she is restoring a century-old home.

“They need to build it away from town,” said Gardner, worried the lab could become a target for terrorists.

Stewart said there will be strengthened external security for all of the Rocky Mountain labs, with additional security features for the new building. Measures for dealing with hazards inside it will include airlock buffer zones, chemical decontamination and microfiltration of air.

Rocky Mountain Laboratories began during a much simpler time.

In 1910, a Bitterroot Valley camp served as the lab for researchers who found that ticks transmitted the disease now known as Rocky Mountain spotted fever. In the 1920s, ticks were ground up at an abandoned school near Hamilton to make vaccine against the disease.

Some 20 years later, workers in the buildings that are part of today's lab complex, which is on the National Register of Historic Places, made vaccines that protected troops against typhus and yellow fever during World War II.

The agent that causes Lyme disease, another disorder transmitted by ticks, was identified at Rocky Mountain Laboratories in 1982.

Following the anthrax attacks last fall, the Bush Administration agreed to spend \$100 million to renovate the 35-year-old Fort Collins, Colo., lab belonging to the Centers for Disease Control and Prevention by 2006.

The enhanced Level 3 lab, which also operates near residential neighborhoods, conducts research on vector-borne infectious diseases, such as Bubonic plague, dengue fever, yellow fever, West Nile virus, encephalitis, tularemia and Lyme Disease, many of which could be used as biological weapons. They all are diseases spread by arthropods, or mosquitoes, ticks, fleas, lice and flies.

[JR: It seems that most of these “Biosafety research facilities” are too often nestled within a residential neighborhood. Could that be to imply that the high level research being carried out is “safe” enough to be in the middle of populated areas? With the recent history of our government research labs, including the FBI's own labs, are being compromised or infiltrated it has to make the residents around these facilities a bit nervous. Yet if anyone questions the government's ability to protect American citizens they label you paranoid or anti-government. Remember what our President has repeated time and again, You are either with us in this fight against terrorism, or you are with the al-Qaida. There is no middle ground and U.S. actions are never to be questioned. Too many of these Biosafety labs mutate normal strains of diseases into weapons-grade infectious diseases that can spread thousands of times faster and easier. Where do you suppose these “terrorists” might acquire such powerful weapons of mass destruction? Certainly not from their private Level 4 Biosafety research facility. Then again one never knows. It depends on who is the real terrorist. If you can't trust your government, then who can you trust?]

THE “KOSHER NOSTRA SCAM”
ON THE AMERICAN CONSUMER

La Voz de Aztlan receives quite a few “news tips” per week from our many subscribers and readers. Some we dismiss immediately but a few catch our attention. Last week we receive an e-mail asking us if we knew the significance of the small encircled letter “U” or letter “K” that can be found printed on many food cans, food packages and on other kitchen products. The message gave us some clues and suggested that we do some research into the subject. What we found certainly was “news” to us and it both shocked and angered us.

On arriving at my residence, I immediately went to the pantry to verify that what I had just learned was actually true. Sure enough, most of the packaged and canned foods from major companies, like Proctor & Gamble and others, did have the (U), the (K) or other similar markings. The Arrowhead water bottle, the instant Folgers Coffee, the Kellogg's box, the Jiff Peanut Butter, the Pepper container, the Trader Joe's tea box and even the Glads plastic sandwich bags carton had the (U) or (K) mark on them.

We needed a little more verification so we called two

major companies to asked some questions. We chose Proctor & Gamble that markets the Folgers Coffee and the Clorox Company that manufactures the Glads plastic zip lock sandwich bags. Each of the two companies, as well as most others, have 1-800 telephone numbers printed on their packages for consumers to call in case they have any questions about their products. When we asked the Proctor & Gamble representative what the (U) meant on their Folgers Coffee container, she asked us to wait until she consulted with her supervisor. She came back and informed us that the mark meant that the coffee was “certified kosher”.

We then asked her how and who certified the coffee to be “kosher” and whether it cost any money to do so. She refused to answer these and other questions. She suggested that we write to their Corporate Public Affairs Department. We then called the Clorox Corporation to ask what the (U) meant on the package of their Glads plastic sandwich bags and she also said that the (U) meant that the plastic bags were “kosher” but refused to answer questions concerning payments the Clorox Corporation has to make in order to be able to print the (U) on their products.

What we learned next, pretty much floored me personally. I learned that major food companies throughout America actually pay a Jewish Tax amounting to hundreds of million of dollars per year in order to receive protection. This hidden tax gets passed, of course, to all non-Jewish consumers of the products. The scam is to coerce the companies to pay up or suffer the consequences of a Jewish boycott. Jewish consumers have learned not to buy any kitchen product that does not have the (U) the (K) and other similar markings.

Another shocker was learning who is actually behind these sophisticated “Kosher Nostra Scams”. It turns out that the perpetrators of these elaborate extortion schemes are actually Rabbinical Councils that are set up, not just in the U.S. but in other Western countries as well. For example, the largest payola operation in the U.S. is run by those who license the (U) symbol. The (U) symbol provides protection for many products sold here in Aztlan and in the United States. This (U) symbol is managed by The Union of Orthodox Jewish Congregations, with headquarters at 333 Seventh Avenue in New York City.

The scam works like a well oiled machine and is now generating vast amounts of funds, some of which are being utilized by the Union of Orthodox Rabbis to support the Ariel Sharon Zionist government in Israel. The Website of the Union of Orthodox Jewish Congregations is full of pro-Israel and anti-Palestinian propaganda.

The “Kosher Nostra” protection racket starts when an Orthodox Rabbi approaches a company to warn the owners that unless their product is certified as kosher, or “fit for a Jew to eat”, they will face a boycott by every Jew in America. Most, if not all of the food companies, succumb to the blackmail because of fear of the Jewish-dominated media and a boycott that may eventually culminate in bankruptcy. Also, the food companies know that the cost can be passed on to the consumer anyway. The food companies have kept secret from the general consumer the meaning of the (U) and the amount of money they have to pay the Jewish Rabbis.

It is estimated that the Union of Orthodox Jewish Congregations, which manages the (U) symbol protection racket, controls about 85% of the “Kosher Nostra” certification business.

They now employ about 1200 Rabbi agents that are spread throughout the U.S. Food companies must first pay an exorbitant application fee and then a large annual fee for the use of the (U) copyright symbol. Secondly, the companies must pay separate fees each time a team of Rabbis shows up to “inspect” the company’s operations. Certain food companies are required to hire Rabbis full time at very lucrative salaries.

The amount of money that the non-Jewish consumer has paid the food companies to make up for the hidden

Jewish Tax is unknown, but it is estimated to be in the billions since the scam first started. The Orthodox Jewish Councils as well as the food companies keep the amount of the fees very secret. The Jewish-owned *Wall Street Journal* wrote about the problem many years ago, but they have stopped writing about it now.

Only public awareness concerning the “Kosher Nostra Scam” will eventually help stop this swindle of the American consumer. Public education of the scam may lead to an eventual non-Jewish boycott of all products with the (U), (K) or other Jewish protection symbols.

I certainly do not need to pay extra for “kosher water”, “kosher coffee” or “kosher plastic sandwich bags”. In fact, I demand my money back for all the money I had to pay over the years for the hidden and illegal Jewish Tax. Are there any bright attorneys out there that could bring a class action suit against the Union of Orthodox Jewish Congregations on behalf of the citizens of America and other non-Jewish people?

Even Jesse Jackson and his Rainbow Coalition have learned from these Rabbis and uses a similar but smaller threatened extortion practice against companies that are also afraid of a Black boycott, but in too many cases it seems Jesse and his “family” are the major beneficiary of his scam.]

FINANCIAL CRISIS CALLED A WATERSHED FOR IMF POLICY MASSIVE BAILOUTS MAY END

In a country where economic chaos has become the norm, two astonishing events in Argentina last week received barely a flicker of interest from international financial markets.

Argentina lost its fifth Economy Minister in a little over a year and President Eduardo Duhalde openly mulled repegging the submerging peso to the U.S. dollar, the very policy that was widely blamed for sending the economy into the crippling recession that has gripped the country for the past four years.

Roberto Lavagna, Argentina’s new Economy Minister, yesterday said the peso exchange rate would float, trying to calm fears of a total economic collapse.

Meanwhile Argentines trawl ATMs for what little cash is left in struggling banks, wondering where they are going to get the money for their next meal amid a new freeze on withdrawals.

As the government lurches from one crisis to the next, a shift in how the world deals with delinquent economies is starting to gather steam.

Some economists say Argentina may be the last country to receive the kind of massive financial bailouts that the International Monetary Fund has doled out through the last decade, starting with the Mexican crisis in 1995, through the Asian and Russian meltdowns in the late 1990s and culminating in the \$48-billion package for Argentina last year.

The IMF itself, at least as a lender of last resort, may be the final casualty.

“I am a believer that the IMF has outlived its purpose,” Anna Schwartz, the 87-year-old doyenne of American economics said in an interview. “When the IMF was created, there was no capital market and emerging market countries couldn’t borrow. Nowadays, there are plenty of lenders on the international credit markets and any lender that is creditworthy will find a lender. The IMF no longer has a real function.”

Ms. Schwartz, a researcher and writer at the National Bureau of Economics in Cambridge, Mass. for the past 50 years, was around when the IMF was created to provide temporary financing facilities under the fixed exchange rate system established at Bretton Woods in 1944.

“We were then under the Bretton Woods system and in order to maintain your pegged rate you had to provide funds for countries that were temporarily in balance of payment difficulties,” she said.

When Bretton Woods fell apart in 1971 and the world switched to floating exchange rates, the IMF found itself offering advice rather than aid—at least until the late 1990s when one crisis after another engulfed emerging markets. The IMF began spearheading increasingly larger bailouts and standstill agreements, gaining Mexico, Thailand, Indonesia and Russia as its clients.

But by December last year, after leading the bailout of Argentina, which did not prevent the country from effectively defaulting on its debt, even the IMF had had enough. It has remained silent, even as social unrest sweeps the country.

“The Argentine crisis is as much a crisis for the IMF as it is for Argentina,” said Ian Vasquez, director of the Project on Global Economic Liberty at the Cato Institute in Washington. “It really has shown the failure of the bailout doctrine.”

The problem with IMF bailouts, its critics argue, is that instead of providing financial relief while countries sort out their difficulties, they create “moral hazard”. The countries know they will be bailed out, so they spend recklessly. Borrowers—usually private international investors—know they will be bailed out, so they borrow recklessly, reaping the rewards of sky-high interest rates on the debt of risky countries in the process. Meanwhile the citizens of these countries suffer.

“It goes back to the enormous Mexican rescue package of 1995,” Ms. Schwartz said. “Mexico paid off its foreign creditors and Mexico itself got nothing. Why should the IMF be engaged in this kind of activity?”

The trouble is the IMF does not have the authority to enforce the strings it attaches to its aid, reigning in spending or opening markets for example.

This has been particularly galling in Argentina and Russia, Mr. Vasquez said. “What you saw was a dance between the IMF and Russia over the years where Russia would promise something in return for IMF money, the IMF would provide money then after a while when it was clear that Russia was not complying, they would suspend the aid,” he said.

All the IMF aid in the world did not prevent Russia from defaulting but since that cathartic event it has found its feet and has slowly been rebuilding its economy.

One of the reasons the IMF packages had become so commonplace in the 1990s was because of the fear of contagion, particularly in the Asian crisis as first Thailand, then Malaysia, Indonesia and all South Korea fell.

But many economists, including Ms. Schwartz and Tom Velk, chairman of the North American studies program at McGill University in Montreal, believe contagion did not exist in Asia.

“What we had was a number of countries which were behaving irrationally, but the ones that were not behaving irrationally—Hong Kong and Taiwan—survived perfectly well,” Mr. Velk said. “The ones that went down or were in trouble needed to go down.”

In the end, it is debatable whether IMF intervention helped those countries, Mr. Vasquez at the Cato Institute said.

“You have Indonesia, which is still a basketcase, Thailand somewhere in-between and you have Korea, which has performed much better. But even there, what we’re seeing is the bounce-back effects of devaluation and after 1997 low interest rates,” he said. “There really hasn’t been in the region much in the way of structural reform, so much so that people have said they wouldn’t be surprised if Asia goes into another crisis.”

Argentina is certainly no poster boy for IMF success.

But analysts say Argentina may mark a turning point. Group of Seven Finance Ministers agreed at their meeting last weekend to pursue an action plan to incorporate new clauses into debt contracts. The contracts would describe as precisely as possible what would happen in the event of a sovereign debt restructuring. It would also allow a majority of creditors to decide on a plan, thereby removing the potential that a minority of holdout creditors could threaten litigation to avoid concessions. It would also include a standstill or cooling off period and a description of how creditors would engage with borrowers.

The idea is to limit public sector aid through the IMF and to "bail in" the private sector by making restructuring terms clear and defaults orderly.

Canada and Britain, which have been spearheading the push, already have such debt clauses in their bond contracts, but the United States has been reluctant. But the plan got a big boost last week when Paul O'Neill, U.S. Treasury Secretary, endorsed the market-based approach.

Meanwhile, the IMF is coming up with its own plan, complete with an international legal framework to guarantee majority rights.

But Mr. Vasquez said it may be time for the IMF to bow out gracefully from settling debt crises.

Bond contracts should be sufficient for settling disputes. As in the past, bond holding councils or other creditor committees should get together to work out their problems, and without the IMF they have every incentive to do so.

1. Nevada has **minimal reporting and disclosure requirements**. The only public records of a Nevada corporation mandated by statute are its articles of incorporation and its annual lists of officers and directors. It is not necessary in either of those cases for a corporation's real operator(s) to be disclosed.
2. Nevada is the only state that maintains a policy of **no reciprocity with the IRS**. In all other states, information is shared freely and without question. It's simply built-in to the system, elsewhere.
3. In Nevada, **ONE PERSON** may be ALL of a corporation's officers and its sole director. You do not need to work together with a group of friends in order to establish this shelter for yourself.
4. Stockholders, directors and officers need not live or hold meetings in Nevada, or even be U.S. citizens. **Such meetings may be held anywhere in the world**. And of course any such meetings are a tax-deductible expense to the corporation, at the IRS-approved *per diem* rate or as actual expenses, whichever is greater.
5. **Directors need not be stockholders**. It is possible to act with the full power and authority of the position of director without having to disclose ownership, if any, in the corporation for which the director acts.
6. A Nevada corporation may purchase, hold, sell or transfer shares of its own stock. Stock that has been issued and repurchased may be held within the corporation as "**treasury shares**".
7. Nevada corporations may issue stock for capital, **services**, personal property (presumably not excluding "intellectual property") or real estate, including leases and options. **The directors may determine the value of any of these transactions and their decision is final**.
8. **Nevada law allows Bylaws to be changed by the directors**. If at any time the corporation's best interests would be served by slightly different Bylaws—just change them to suit the purpose.
9. Initial or minimum capitalization is not required. **A Nevada corporation can be capitalized with "sweat equity"**. Keep in mind that stock may be issued "for services rendered".


