WILL THE U.S. WAGE WAR AGAINST IRAQ?

After attending a conference of geopolitical experts in Singapore, sharing their valuable insights on the matter, the question has become academic.

There will definitely be war, simply because U.S. foreign policy has, in recent months, become the exclusive domain of "hawks" led by Defense Secretary Donald Rumsfeld, NSA Condoleeza Rice, and Andrew Marshall, head of the Pentagon's Office of Net Assessment. Despite Iraq's recent pronouncement allowing the return of UN arms inspectors, U.S. officials have little hope that the Iraqi regime would allow unrestricted inspections, thus rendering the process worthless.

Since Sept. 11, the U.S. has increased satellite surveillance of suspected Iraqi weapons-production sites. Even erstwhile "dove" State Secretary Colin Powell has displayed a new hawkish stance toward Iraq in his Feb. 6 testimony before the House International Relations Committee.

America's NATO allies, except for Britain, have refused to join the United States in this most recent Gulf crisis. No longer are they easily swayed by slogans like "making the world safe for democracy" or "preserving our way of life". In fact, experience showed that it was not his way of life that the Allied soldier fought for, but FDR's way of life: socialism, liberalism, communism, [Zionism] the corruption of morals, one-world government, abortion, New Age, environmentalism and globalism.

Germany, for one, is convinced that socialism is a part of the general scheme of the new World Order and, therefore, does not truly conflict with the aims of the "liberal democracies". This belief in a so-called U.S.-USSR collusion is proven by the following considerations:

(1) There was never any real opposition between the United States and the Soviet Union. For they failed to clash when they should have, if they had been true enemies. Examples are the Korean War, the 1956 Hungarian Uprising, the 1962 Cuban Crisis, the Vietnam War, the 1968 Czech Uprising, Afghanistan, and the shooting down of Korean Airlines Flight 007, to mention only a few instances.

(2) The fact that communism was 'dismantled' virtually without a shot, and that the same people who

were once the leaders of Soviet Russia are now the leaders of "liberal democratic" Russia.

All this gave credence to the longtime suspicion of Western observers that their efforts during WWII went to naught, since the territorial integrity of Poland was a big joke in the minds of Roosevelt, Churchill and Stalin, when at Yalta, Poland and the rest of Eastern Europe, were handed over on a silver platter to the communists. Poland was obviously an expendable entity, and was not a motive for war.

The same, they surmise, is true of Iraq. It is not Iraq's alleged ability to produce weapons of mass destruction that makes it the world's No. 1 "terrorists" in the globalists' eyes. Rather, it is the Iraqi oilfields which are a severe economic threat to the Trilateralists and the Russians. Peace in the Persian Gulf may elevate Iraq as the new petroleum powerhouse, keeping a lid on oil prices in the short term and possibly reshaping political alliances in the Arab block over the long term.

U.S. policymakers have always paid close attention to Iran and Iraq, the second—and third—largest oil producers in the Gulf. Because of this, Washington will continue to seek the emergence of friendly, cooperative governments in Baghdad and Teheran. If these efforts fail, America is fully prepared to counter any aggressive moves they might make with the full weight of its military power.

[H: And did anyone notice that the OIL PIPELINE—about which is all this excursion against humanity in and around Afghanistan—BROKE GROUND YESTERDAY?]

"Regime Change is something the United States might have to do alone," Powell said. At a time when Western Europe is hopelessly bankrupt (The only possibility of reviving the economy of Western Europe from absolute bankruptcy would be a recovery of Germany as a leader of a general export drive of high-technology production into Asia.), when there is a revolt against supranational institutions like the World Bank-IMF going on in Asia, the hegemonist temptation becomes all the more hard to resist as far as the Republican neo-conservative establishment is concerned.

So far, everything the Bush administration made as a major decision is self-destructive as well as being wrong. Bush is openly pushing for a Middle East WAR, as well as conflict between Taiwan and the Mainland China. These things have caused a "great depression" among highly industrialized countries, and a "great disruption" among Third World nations who are trying their best to earn a living.

The Elite behind Bush believes that America should exploit its hour of power to impose a Pax Americana. This Elite believes that the great lesson of history was Munich in 1938, that the way to deal with dictators and disturbers of the peace is ruthlessly and early, that while it is best to act in concert with other nations, it is often necessary to act alone.

Yes, there will be war, which may lead to World War III, because America is no longer the "balancer of last resort", but an "intervener of first resort".

One last thing: We could not have possibly acquired a clearer perspective of the situation had we not attended the conference. The Singaporeans are simply awesome in their analyses because they have been maintaining a well-funded study group exclusively dealing with strategic studies. We should set up a similar group here. It will certainly be valuable to our foreign policy initiatives and intelligence network.

PUTTING THE MOMENT ON HUMAN TERMS

WEST BANK, ISRAEL—First, I wish to convey my sincerest condolences to the bereaved families of the victims of the atrocious crimes of September 11, and my solidarity with all of you. I share your sense of loss, for I studied, worked, married and was blessed with my first child in New York. In this letter, please allow me to humbly provide my own perspective on the context of that horrific and utterly unjustifiable attack.

Dear Fellow Humans:

I address you as such for two reasons: a) “human” is the universal component of your identity that you share with the rest of us; and b) you are human by necessity and American only by chance, to borrow the insightful distinction of the French thinker, Montesquieu. Furthermore, regarding you as predominantly “American”, with all that term has stood for in the eyes of much of the world in the last few decades, would render you directly or indirectly responsible for some of the most cruel forms of oppression since the Roman Empire.

Plainly put, your ancestors are responsible for the genocide of Native Americans and for the wicked slavery enterprise. Your democratically elected governments are accountable for unspeakable crimes worldwide, from Hiroshima and Vietnam to Palestine, Iraq and Afghanistan. This is why your national flag is the most popular combustible item in rallies around the world. It has nothing to do with hating you as a people, or even envying your “way of life”. It has everything to do with the fact that your representatives have systematically plundered other nations’ wealth, destroyed their ways of life—killing and injuring masses in the process—and reduced them to little more than pathetically subservient nations.

None of this could have persevered without your approval, or at least your apathy toward those essentially non-Western nations. This regrettable apathy is both cause and effect. It is a prime cause of your leaders’ freedom to be bellicose and dictating in international affairs. But this apathy has been cultivated and internalized over decades, mainly, but not exclusively, through media manipulation, omission and disinformation. One of the most consistent themes in that process has always been the view of the world as “us” vs. “them”.

A quick look at your mainstream papers’ headlines and editorials immediately after September 11 can demonstrate how we, Arabs and/or Muslims, have replaced the former demons, the “Reds”, in being the reviled “them” nowadays.

A *New York Post* editorial bellowed: “Forget justice: we want revenge!” “Justice,” it said, “should not take precedence over vengeance... we should turn their country into a glowing desert.” Sen. Zell Miller, D-Georgia, said: “I say bomb the hell out of

them. If there’s collateral damage, so be it. They certainly found our civilians to be expendable.” [Emphases are mine.] The “them” referred to are stripped of their fundamental human attribute, justifying the calls for their annihilation. It is precisely this dehumanization that has accompanied your entrenched “us” vs. “them” dichotomy.

In plain terms, dehumanization to me means that our victims are regarded as mere numbers, waste, things unworthy of respectful mention, even in their miserable deaths. When our houses are gratuitously razed by American-made bulldozers, or indiscriminately bombed by American-made helicopters and missiles, most of you do not notice, or if you do, you do not lose sleep over it. Even whales trapped in Alaska, Pandas suffering from loneliness in China, or little elephants stranded in Kenya solicit more attention, more human compassion, from you. Why? This is the “why?” that you must answer before you ask your own “why?” No answer to the former, though, can ever provide justification for the latter.

As a Palestinian—and as a human being who seeks justice rather than revenge, and who strives to uphold a consistent ethical perspective—I cannot address you as a monolithic entity responsible for all the injustices inflicted by the U.S. government throughout the world. I emphatically reject perceiving all of you solely as citizens of the new Rome. Despite being a member of a dehumanized nation labeled by your elected representatives as “terrorist”, perhaps because of that, I cannot accept simplistic—and, in my view, immoral—definitions of identity. I prefer to view nations and cultures more as domains of shades of colors, interacting and mutually influencing one another, never absolutely separate from the rest, nor independent of them.

Hence, I choose to make the crucial distinction between you, the people, and your government, with its longstanding collusion with, and protection of, the systematic crimes and violations of international law committed against the Palestinian people by Israel during and since its creation on top of the ruins of Palestinian-Arab society. And I am not alone in this. Soon after September 11, a statement issued by prominent Palestinian intellectuals reflected on the crime, saying: “Nothing, nothing can justify this terrorism that kneads human flesh with iron, cement and dust... and nothing can justify dividing the world into two camps that can never meet: one of absolute good and another of absolute evil.” The signers of this statement and I may not have suffered to the extent that we would see the world so starkly; but, unfortunately, many others have.

Asked by a TV interviewer for his reaction to September 11, a young Palestinian boy from a refugee camp in Gaza, holding shrapnel from a missile fired near his shack by an Israeli Apache—both missile and gunship manufactured and generously supplied by the U.S.—said, in a typical reaction: “Look what America is sending us every day; how can I sympathize with them?” Perhaps sympathy would be too much to ask for from this kid whose life was shattered partly because of you.

It is my deep conviction that as U.S. citizens you carry an incumbent civic responsibility to at least attempt to change your leaders’ policies that victimize us and many other weak nations like us across the globe. As humans, you assume an ever-more fundamental duty in opposing oppression wherever it might occur, especially if buttressed and nourished by your country, by your tax money.

The “us” vs. “them” dichotomy overemphasizes group identity, and makes it much easier to demonize and target nations, races and individuals. Hence the concept of collective responsibility emerges. In its extreme, this concept leads to collective punishment, which is immoral and condemned by international law. Killing thousands of guiltless Afghans, or Palestinian civilians, or Iraqis, or innocent Americans in the World Trade Center, all fall under this category, despite the obvious differences.


Since you are currently the superpower, you carry most of the responsibility to change the unjust world order. But even we, the predominantly oppressed peoples of the world, have a crucial obligation as well: to struggle for justice and the application of international law, rather than revenge; to focus on the human dimension that unites, more than all the attributes that divide; to seek an end to all oppression, rather than merely reversing the roles of oppressor and oppressed. As the prominent late Brazilian educator, Paulo Freire, prophetically argued, “... the oppressed must not, in seeking to regain their humanity (which is a way to create it), become in turn oppressors of the oppressors, but rather restorers of the humanity of both.”

In the spirit of Freire’s words, I shall leave you with the following real story.

Three days after heavily armed Israeli soldiers occupied our apartment building earlier this year, my 5-year-old daughter, Nai, overcame her initial trepidation and went out to the balcony to sing her favorite Arabic song. She stood in view of a throng of nervous occupation soldiers sitting in and around three tanks and five armored personnel carriers parked underneath. Her voice cracked at first, but soon enough she regained her typically higher pitch and confident notes, and beautifully—yet defiantly—sang: “Tomorrow the feast will come, it will come, it will come. Tomorrow the feast will come and we will celebrate. We shall have no masters then. No one will have a master. We shall all celebrate the feast.”

For those who wish to verify that which we will now write: *SEXUALLY TRANSMITTED DISEASES IN HOMOSEXUAL MEN*, Plenum Books; *THE ACQUIRED IMMUNE DEFICIENCY SYNDROME AND INFECTIONS OF HOMOSEXUAL MEN*, Pearl Ma and Donald

Armstrong; *THE AIDS COVER-UP?*, Gene Antonio, Ignatius Press, San Francisco; *GAY MEN'S HEALTH: A GUIDE TO THE AIDS SYNDROME AND OTHER SEXUALLY TRANSMITTED DISEASES*, Jeanne Kassler (Harper and Row), and at least a dozen more which I will not take time to list. Again, I take no exception to same-gender preference of “company”—but the following is what is destroying the humans who participate in this kind of *behavior*.

HOW THE EPIDEMIC SPREADS

In May 1985 in *The Advocate*, Paul Diamond, a homosexual activist diagnosed with Kaposi's Sarcoma said: “Don't call us AIDS victims. AIDS is not my weakness. AIDS is my strength.” So be it!

PRIMARY GROUP AFFECTED

In the United States, male homosexuals have comprised over three-fourths of all AIDS cases. The percentage of homosexuals among the total of all AIDS patients has remained relatively constant. In Europe, male homosexuals comprise over 85 percent of all AIDS cases. The enormous prevalence of AIDS, along with several other grave communicable disease endemic in this group, is not mere inexplicable chance, and we shall go into a few of the other health risks. There are numerous major biological and social factors which have been distinctly linked with their spread. Of course it is not the major numbers in the groups which indulge in these extreme behaviors—but it only takes a few to affect the multitudes. Ponder it.

HAZARDS OF SODOMY AND BIOLOGICAL FACTORS

DANGERS TO THE PASSIVE RECIPIENT:

Among male homosexuals, sodomy or anal intercourse is the act substituted for heterosexual penile-vaginal coitus. This damaging practice provides ready access for the transmission of AIDS and other virulent infections.

Physiologically, the rectum is designed for the expulsion of feces. When sodomy is performed, the peculiar forced inward expansion of the anal canal results in a tearing of the lining as well as bleeding anal fissures.

Violent spasms of the bowel wall may occur as a reaction to the bodily intrusion. Colitis, a severe inflammation of the mucous membrane of the colon, often develops as sodomy is repeatedly engaged in. This disorder causes fever, malaise, painful wrenching cramps in the lower abdomen and eruptive diarrhea and commonly contains blood or leukocytes. Along with anal fissure and syphilitic chancre, mucosal ulceration of the rectal area is common in homosexual males.

The prevalence of colitis and rectal lesions among homosexuals is such that they may mask the symptoms of intestinal lesions resulting from Kaposi's Sarcoma.

The trauma of sodomy also produces a unique form of inflammatory psoriasis in previously unaffected areas. This psoriasis extends from the rectum to the pubic area, penis and scrotum. This is known as Kobner's phenomenon. During sexual activity, the thin silvery scales which have formed on the inflamed areas are rubbed off, leaving the skin raw, bleeding and

exposed to infection. The friction against existing hemorrhoids also leaves their surface vulnerable.

Written before the discovery of HTLV-III/LAV as the AIDS agent, a national case study found: “Blood from rectal mucosal lesions which are known to be common in homosexual males who engage in rectal intercourse, could contain the infectious agent responsible for this epidemic.”

Note that this important study detailing the correlation between homosexual behavior/diseases and the prevalence of AIDS was published by the American College of Physicians in August of 1983—so don't go about saying Hatonn is a bigot. There has only been occasional mention of the relationship between homosexual acts/diseases and AIDS transmission in the national media or press. Usually it is in the context of stressing the susceptibility of heterosexuals through IV drug abuse. One major article doing reasonable justice to this correlation was finally published in the December 1985 issue of *Discover*. However, it unwisely downplays the potential of heterosexual transmission of AIDS. Once present it is walking dynamite.

The damage to the rectal wall facilitates access to the bloodstream of AIDS-infected sperm and other disease-causing organisms. Anal receptive sodomy has been definitely linked to AIDS transmission. Do you see that especially at the time of a female menstrual cycle (when birth control devices would not be used) the infected sperm could cause infection in the already compromised inner uterus which is sloughing off attached material and already bleeding?

Again, anal receptive sodomy has been definitely linked to AIDS transmission. In studying the depressed immune systems of practicing male homosexuals in New York City it was found that receptive anal intercourse was the specific sexual activity which correlated most strongly with reduced levels of helper T-cells resulting in immune dysregulation. Do you further see that condoms would be chancy even if employed?

ACTIVE-PARTNER DANGERS

The opening of the urethra, along with penile abrasions and lesions resulting from sexual activity and disease, permit infected bloody secretions seeping out of the damaged rectal tissues to enter the bloodstream of the active partner.

DANGER TO OTHERS

The weakening of the sphincter through repeated sodomy results in fecal incontinence and the dribbling of blood-stained contaminated stool. The involuntary depositing of AIDS-virus-infected fecal secretions on the benches in locker rooms, toilet seats and elsewhere also creates a potential for spread by this route. Oh, they never told you these things? Well, too late is too late, isn't it? These are things no one wishes to even speak of [MM: **Just how scary is the prospect—after stating the obvious facts concerning the potentially deadly consequences of the irresponsible behavior associated with this “alternative lifestyle”—of being labeled “homophobic”?**], much less draw pictures for the modest masses of people who use all sexual activities as means of control and vengeance instead of love and then call it love. Then, you refer to it as “human rights”! So be it.

SODOMY SUPPRESSES THE IMMUNE SYSTEM— EVEN WITHOUT AIDS

Sodomy has proven debilitating to the immune systems of passive recipients apart from AIDS infection. During sodomy, the naturally aggressive properties of sperm combined with damage to the rectal wall enable spermatozoa to penetrate the mucosal lining.

A report in the April 1984 (27th), issue of *Science* by researchers at the Department of Obstetrics and Gynecology, Cornell Medical Center, New York, stated that occurrence of AIDS among homosexuals, “may have some relation to circulating antibodies evoked as a result of semen deposition in the alimentary canal. Human seminal fluid apparently contains components that potentially can suppress the immune response.”

A few weeks later other researchers reported in *Lancet*, a most respected medical journal, “A homosexual individual is repeatedly exposed to viral antigens such as herpes and sperm antigens which can be absorbed through the intact intestine or through mucosal lesions. Bleeding lesions are not necessary for absorption of spermatozoa and harmful infectious agents during sodomy, but they do facilitate it.

“Host immune responses can be modified by exposure to sperm, with the subsequent formation of anti-sperm antibodies.”

During normal heterosexual intercourse, the dynamic qualities of sperm enable penetration and fertilization of the female ovum, resulting in impregnation. The walls of the vagina are elastic and several layers thick, and they have glands which provide natural lubrication during sexual relations. This prevents large quantities of sperm from entering the bloodstream.

In 1984 a study in the *Journal of the American Medical Association* noted that the association of sperm-induced immune dysregulation with the practice of anal intercourse “underscores the critical structural differences between the rectum and the vagina. While the lining of the vaginal mucosa comprises a squamous multilayer epithelium capable of protecting against any abrasive effect during intercourse, the lining of the rectum is made of a single layer of columnar epithelium. The latter, unlike the vaginal epithelium, is not only incapable of protecting against any abrasive effect, but also promotes the absorption of an array of sperm antigens, thus enhancing their exposure to the immune apparatus in the lymphatic and blood circulation. The high immunogenicity possessed by spermatozoa, coupled with the microbiological flora of the rectum, can work in synergism to generate a state of chronic antigenic stimulation.

“In this connection, four of seven immunodeficient female sexual partners of male patients with acquired immune deficiency syndrome (AIDS) also engaged in anal intercourse. An analogous phenomenon can be extracted from the strong association between the high frequency of seroconversion for Hepatitis B virus and the routine practice of ‘passive anal-genital intercourse.’”

Do you begin to understand the horrible damage the sex therapists such as Dr. Ruth and others, do to an unsuspecting public? In the name of “sexual freedom” ones are taught that all is fine and the more bizarre between consenting adults the more wondrous will be the marriage and/or relationship? They become tools of the “spreaders” of the poison and are most unwittingly utilized.

However, the unsuspecting partners seeking the

illusory fulfillment of the relationship touted to be the “all in all”—and can’t find the incredible experience portrayed in all your media—will try anything to “save their marriage” or “keep the flame alive” and all that drivel of lies. Man was created to find his ultimate joy in the emotional soul fulfillment—not in a waterbed with intrusion of protrusions—those things were designed for procreation of a species.

During sodomy, the biological design of the rectum combined with the aggressive properties of sperm expedite their substantial entrance into the bloodstream. When this occurs repeatedly, antibodies to sperm develop which circulate and impair the immune system. This happens both apart from and along with infection by the AIDS virus. It likely is a co-factor in HTLV-III infection.

In addition to suppressing the immune system per se, the introduction of sperm containing the AIDS agent has been cited as providing a “Trojan Horse” (no pun intended) mechanism for the transmission of the HTLV-III/LAV lentivirus.

Leukocytes in the seminal fluid, also present in colitis-induced diarrhea, carry the AIDS virus directly to the lymphoid organs of homosexual partners, thus achieving a highly efficient transfer of the infection to most lymphoid cells.

MONOGAMOUS SODOMY IS NOT A SAFE ALTERNATIVE

You will find that in monogamously-paired homosexual males, three quarters of the passive partners manifest sperm-induced immune dysregulation. Rectal insemination also alters immune responses in rabbits and other lab animals.

The immune dysregulation induced by sperm debilitates the system quite apart from infection by an AIDS virus. Although AIDS development per se must involve the transmission of the HTLV-III/LAV lentivirus (except in cases of bestiality which we will speak of later) the development of sperm-induced immune dysregulation predisposes the anal-sperm-recipient homosexual males to the more severe phenomena of opportunistic infections and Kaposi’s Sarcoma. Immune responses to semen provide a background of immune suppression, not only promoting repeated CMV (cytomegalovirus) infection, but also exacerbating the resulting immunologic disorders.

Although AIDS is not what we can consider a “sexually transmitted disease” in the usual vernacular, it is most certainly transmitted by sexual misuse and/or abuse in a compromised recipient. HTLV-III is most certainly a sexually-transmitted disease through the rectal mucosa and is usually vulnerable to passage of the AIDS agent as well, in a compromised vaginal passage. From a purely biological perspective sodomy, even apart from the transmission of AIDS, is an intrinsically unsanitary and pathological act. In addition, the practice of sodomy has been a primary reason why AIDS has been so readily transmitted and fostered among homosexuals.

ORAL COPULATION

Oral-penile copulation is also a frequently employed form of homosexual gratification. It is also touted as to be the ultimate pleasure in heterosexual coupling. Well, if you want every vaginal/penile yeast infection and random viral (herpes and/or warts) introduced into thine

mouths—I suppose. Is a moment of pleasure worth the rest of your life with a mouth yeast infection or mucosal warts and lifelong herpes? So be it.

Infected semen received into the mouth provides a source of infection through abrasions or lesions on the gums, tongue and/or roof of the mouth.

Venereal diseases affecting the mouth and throat are especially problematic among homosexuals. Often going unrecognized for a period of time, the resulting lesions provide ports of entry and exit for the AIDS virus; AIDS-infected saliva also is a potential danger involved in oral copulation.

Studies have yet to determine whether or not the gastric juices in the stomach prevent absorption of the potent AIDS virus into the bloodstream after being ingested. Since the eating of AIDS-infected meat is a possible factor in the spread of AIDS among humans (oops! No one told you about that one? I thought not!), consumption of infected semen may also play a role in transmission.

OTHER MEDICAL FACTORS INVOLVED

SADOMASOCHISTIC (S & M) ACTIVITIES AND THE SPREAD OF AIDS:

Activities involving severe bodily abuse and personal degradation are an integral part of the repertoire of homosexual behavior. Regardless of what ye in the general public perceive, the above statement is TRUE!

The damaging practice of sodomy itself can be classified as a sadomasochistic act. The bloodletting and exchange of contaminated secretions involved in other traumatic homosexual acts further facilitate the spread of AIDS and other diseases. A brief overview of these follows, for if you don’t confront the facts, you will not eradicate the problem.

MANUAL/ANAL INTERCOURSE—“FISTING”:

How can God speak of these things? Because you didn’t pay attention to the “thou shalt nots”. Ye are a “liberated” society with “human rights” are ye not? Then pay attention and perhaps the truth may set you free! God will tell you exactly how it is, for your very soul is at stake herein, not to mention your physical lives destined for annihilation—and—no! God is not doing it unto you. **YOU, WITH THE HELP OF SATANISTIC INPUT, ARE DOING IT UNTO YOU.**

You will herein also find out why a condom is useless in these practices—bare facts, my beloved friends.

The practice of “fisting” involves the insertion of the hand, fist and forearm into the rectum and lower colon. In the jargon of participants, it is called “fisting”—I did not make up such terminology. Fisting causes bleeding lacerations of the intestine and tearing of the sphincter muscle as you might suspect. These internal wounds provide enormous opportunity for the entrance and spread of AIDS virus and other infections. Fisting has been cited as a contributing factor in AIDS cases for years now.

Mechanical devices, dildos, vibrators, etc., inserted during fisting have punctured the intestinal wall causing dangerous seepage of fecal matter into the abdomen. If surgery is not performed promptly enough, this can result in death—and you no longer have to concern yourself with AIDS.

In some cases, the damage from fisting is so extensive that a sphincterectomy or colostomy must be performed. Some individuals have then continued to

have sodomy performed through the colostomy opening, causing further damage. In San Francisco, where a percentage of murders reportedly are linked to homosexual sadomasochism, a workshop has been offered for instructing homosexuals in how to engage in sex torture without killing each other. Nay, I do not jest—check it out! Just like teaching grade school babies the art of sex and condoms. You are a troubled society.

BONDAGE AND DISCIPLINE:

Acts in which a dominant partner ties up and tortures the submissive “slave” are also part of the homosexual sadomasochism scene. Those involved are voluntarily bound in painfully tight leather or rubber apparel, whipped, violently sodomized and beaten. Lighted cigarettes are used to burn sensitive parts of the body, especially the genitals, causing ulcers of the penis and scrotum.

Urination into the mouth and over the bleeding body of the participant (called by you ones, “golden showers”, “water sports”) is also a most common practice. These are commonly used rituals of the Satanists at every good old regular meeting.

Urine contains the infectious agents for a number of various diseases including AIDS virus infection; this type of behavior is both unhygienic and hazardous. The sores and blisters left on the sex organs also facilitate the entrance of infectious agents into the bloodstream.

“Water sports” are also generally engaged in apart from brutal sadomasochistic behavior. Perhaps that is why a recent “safe sex” guideline from the Gay Men’s Health Center published in the October 21-27, 1985, issue of the homosexual tabloid *New York Native* reassuringly advises: “‘Water sports’ are considered safe so long as urine does not enter the body.”

Some homosexual clubs have “slave-auctions” in which those who prefer being abused are sold to the highest bidder. Now therein must lie double jeopardy, I would surmise.

BEASTIALITY:

Sexual relations with animals has also occurred among a certain segment of the homosexual population and rampantly among the Satan practices.

It has a major connection with AIDS spread and becomes obviously such because Visna virus is endemic in some flocks of sheep—especially noted in Europe, where it is called maedi-visna, and causes a neurodegenerative disease not unlike that seen in the late stages of AIDS in many patients.

Cases of AIDS have been reported from certain urban areas in Northwestern Europe known for their lax sexual mores. There are many jokes regarding men and sheep, etc., but the last laugh is no longer with the joke tellers. In a homosexual community in such an area, playing with the animals, ONE member’s having had sexual contact with a diseased sheep can pull down the entire group. Further, once a homosexual community with international connections has become infected, spread of AIDS becomes inevitable. The practice in the Satanic community is usually with goats who represent the Devil, but sheep are usually substituted due to the ease of procurement.

DISEASES:

The occurrence of AIDS among heterosexuals in Africa has been frequently stressed as proving that the AIDS virus has no special affinity for homosexuals. One of your medical pundits recently suggested, “The virus has no intrinsic attraction for gays, and gays have no mysterious susceptibility to infection.” Absurd, because the rest of what you are told about AIDS is filled with lies.

What is not being said is that there are a number of diseases and infections common among the African patients with AIDS, especially those with Kaposi’s Sarcoma, and homosexuals in the United States which are uniquely endemic to both groups but are not generally found among Western heterosexuals.

The African villager at risk for Kaposi’s Sarcoma and the homosexual male at risk from AIDS share evidence of past exposure to an identical range of viral and protozoal infections, especially CMV, EBV, HSVI and II, HBV and *Entamoeba histolytica*. No, you look them up.

Among those in developing nations, these disorders are frequently a result of extreme poverty: lack of adequate sanitation resulting in sewage-contaminated food and water supplies and unhealthy living conditions.

Among Western male homosexuals, the prevalence of these diseases is distinctly related to unhygienic sexual practices which facilitate the spread of infectious agents.

It is true that AIDS has developed in persons who previously had their immune systems intact. It is also true that the rapidity and severity with which the AIDS virus conquers the immune system varies among those infected. When the immune system has been disrupted by certain infections and diseases prior to exposure to HTLV-III, this enhances the destructive effect of the virus.

T-4 helper cells in the immune system are most susceptible to infection when they have been stimulated and their numbers increased by chronic parasitic or viral infections. In other words, ones compromised by herpes are greatly at increased risk.

Among practicing male homosexuals in the United States, there are a number of grave infections and disease prior exposure to which has been strongly correlated with the prevalence of AIDS.

There are several epidemics running loose and not all of them are permanently confined to the homosexual subculture and, in fact, gave the very opportunity to intentionally infect the homosexual gay community, i.e.—

HEPATITIS B:

Hepatitis B virus infection (HBV) is a major cause of acute and chronic hepatitis, cirrhosis and liver cancer. Among practicing male homosexuals in the United States, hepatitis B infection has been pandemic for years prior to AIDS. Homosexual practices, notably sodomy and oral/anal contact, have been key factors. Trauma to the rectum and penis as a result of sodomy and oral lesions from venereal disease provide ports of entry and exit for the virus.

Unlike Hepatitis A infection, fecal-oral spread was not considered an important route of transmission. Instead, HBV was thought to be transferred from acute or chronic carriers to other susceptible persons through shared toothbrushes, razors, or fomites. Quite the opposite now is proven to be true in homosexual men. Oral-oral transmission may also occur if HBV gains entry through minute lesions in mucosal surfaces.

Between 50 and 75 percent of gay men have or have had hepatitis B and the percentage is growing daily. In the light of the fact that 90% of homosexually active men demonstrate chronic or recurrent viral infections with herpesvirus, cytomegalovirus and hepatitis B, these recurrent or chronic infections are triggering factors for the development of acquired immunodeficiency.

In your United States, homosexual men have a higher prevalence of hepatitis B infection than any other group. More than 10 percent of homosexual males are chronic

carriers of hepatitis B. This is fifty to one hundred times higher, friends, than the national average of 0.1 percent.

Homosexuals have been proven to have an HBsAg (Hepatitis B surface antigen detectable in large quantities in serum) positivity rate anywhere from 40 to 60 or more times higher than the general population.

Considering the early age at time of infection and the high attack rates, one can expect all sexually active men to eventually become infected with Hepatitis B virus.

Since the routes and prevalence of AIDS transmission bear a striking resemblance to those of hepatitis B, this has enormous implication in terms of the level of AIDS infection in this group as well. It should be further noted that rectal mucosal lesions, usually including punctate bleeding points, have been noted to prevalently occur in homosexual men with persistent hepatitis B virus infection.

Hepatitis B induces bleeding lesions and provides ports of entry and exit for the AIDS virus. IV drug abusers also frequently contact hepatitis B through the use of contaminated needles. Their estimated rate of seropositivity is over 65%.

Let us hear what *Lancet* had to say about this and we will give you research data.

LETTER TO THE EDITOR: Sir, over a decade SWISSAIR crews will typically spend 300-400 nights in tropical countries, most of which are high risk for viral hepatitis. A perennial question has been—should such personnel regularly receive passive immune prophylaxis or, more recently, hepatitis B vaccine? We have studied the risk for hepatitis virus infections in cockpit and cabin staff...

The most outstanding feature of this study was that male flight attendants, employees and candidates, significantly more often had anti-HBs and/or anti-HBc antibodies (20-33%) than did either flying personnel (1.4-5.6%) or Swiss blood donors (4-8%).

During the year, 13 of the total of 2664 flying personnel had manifest hepatitis, an incidence of 5 cases per 1000 per year. The estimated incidence of acute hepatitis in the Swiss population is 0.5-0.8 cases per 1000 per year. This high incidence of hepatitis amongst flying personnel was mainly accounted for by male flight attendants, who represented only 19% of all flying personnel but among whom 7 of the 13 hepatitis cases arose. Five cases were of the hepatitis B type (HBsAg positive), and of these 4 occurred amongst the male flight attendants. Thus, the observed high frequency of HBV infections in this occupational group probably have little to do with being a flying airline employee—since candidates already showed signs of increased HBV infections. It rather reflects a different HBV exposure due to a lifestyle outside professional duties. Amongst the many explanations, homosexuality might be the most realistic. Worldwide, male cabin attendants are often homosexual, and we have hints that this might not be different in SWISSAIR.

Cockpit personnel and female flight attendants are not at a special risk for HBV or HAV infections, despite exposure in high-risk areas, and so they do not need active or passive immunization against viral hepatitis infection. However, for male cabin attendants, as for other individuals with high-risk lifestyle, active or passive immunization could be warranted.

A more detailed report will be published in *Aviation, Space, and Environmental Medicine*.

DELTA HEPATITIS:

The spread of acute delta infection is endemic in the homosexual community. This particular infection is particularly associated with an Italian background, IV drug use, and multiple transfusions but it is now becoming most prevalent in the non-drug-abusing homosexuals. I love Italians so don't suggest that now Hatonn is after the Italians.

Let us just touch on additional problems and disease because this has become a most lengthy writing.

**INTESTINAL PARASITES AND HEPATITIS A:
"THE GAY BOWEL SYNDROME"**

"The gay bowel syndrome" is a term used as far back as your mid-70s to describe the prevalence of a group of rare bowel diseases, previously considered "tropical", among male homosexuals in the U.S.

AMEBIASIS: a disease of the colon caused by parasites (*Entamoeba histolytica*). Causes dysentery and sometimes live abscesses. Can result in diffuse inflammation and ulceration of the distal colon and can be mistaken for Crohn's colitis. Usually picked up from contaminated foods and residual in the mouth.

GIARDIASIS: a parasitic (*Giardia lamblia*) bowel disease causing diarrhea. Can result in severe enteritis (inflammation of the intestinal tract), producing symptoms ranging from acute diarrhea to chronic malabsorption. Spread in similar manner to amebiasis.

SHIGELLOSIS: a bacterial bowel disease which can cause severe dysentery. Can be fatal, especially in children. Contaminated food is the usual cause.

HEPATITIS A: a viral liver disease spread by fecal contamination, e.g., food, water and close person-to-person contact.

Dissemination of these diseases can run rampant through poor fecal disposal as well as through homosexual practices. From the time of Moses, chelas, there has been concomitant consciousness of the benefits to the public health of careful fecal disposal. Although man's technical ingenuity has achieved remarkable strides in the purification of your immediate domestic environment, the recent increase in transmission of intestinal infections among homosexual males offers new challenges in preventive medicine for physicians caring for these patients and requires caution and most extended testing of water supplies for presence of contaminants.

AIDS can be spread through the very tools to increase sanitation, i.e. enema nozzles used for rectal douching. The evil contaminant lurks in ever present and in ever increasing numbers of infection sites and carriers.

VENEREAL DISEASES:

SYPHILIS: Over 50 percent of reported cases (and who knows about the unreported) of syphilis in the U.S. occur in homosexual men. Primary syphilis in this group commonly occurs in the rectal area. A history of syphilis has been associated with development of AIDS—and I told you in *AIDS, THE LAST GREAT PLAGUE* that AIDS is a tertiary syphilis with the spirochete being isolated from almost all Kaposi's Sarcoma lesions.

INCURABLE GENITAL HERPES: This incurable disease is almost ubiquitous among practicing male homosexuals. Infections can occur concurrently in the rectum, penis and mouth. Among homosexuals, infection with herpes has been associated with squamous

cancer of the tongue and cancer of the rectum. It is also associated with nasopharyngeal cancer, cancer of the cervix and lymphoma (Burkitt's).

Herpes-type viruses are known to suppress specifically t-lymphocyte function aimed at recognizing and mounting an immune response toward the viral antigens.

Perianal herpes virus infection and herpes proctitis are common in homosexual men. In the acquired immuno-deficiency syndrome, patients seem especially predisposed to more intractable and progressive forms of this infection.

CYTOMEGALOVIRUS: CMV is found in semen, and the repeated exposure of the rectal mucosa to the virus has resulted in high frequency of CMV infections among homosexuals.

VENEREAL WARTS: Anal warts are a common disorder among practicing male homosexuals. They cause intense itching, and produce a fetid discharge which is highly offensive to others and embarrassing to the sufferer. They are extremely resistant to treatment. These warts appear in large cauliflower-like masses in and around the anus in addition to infecting the penis. Anal coitus and elimination of the stool become excruciating and result in further rectal trauma. Various homosexual periodicals contain numerous advertisements by physicians offering specialized treatment for these and other related maladies.

Some of the diseases I have outlined suppress immune function prior to exposure to the AIDS VIRUS and others, with their recurring sores and lesions, provide ports of entry which facilitate transmission of the AIDS virus.

Both male and female prostitutes are also frequently afflicted with various simultaneous venereal diseases because of their high number of sexual partners. And, of course, as the hapless infections can occur and then spread to unsuspecting lovers, these will very, very often be found infecting devoted and loving marriage partners. Many of these viruses lay dormant for years without outbreak. This is not to panic, but rather to inform.

As the AIDS virus suppresses the immune system, preexisting infections like CMV and herpes run amok through the body. CMV may invade the heart, lungs and other vital organs. Large blackened herpetic boils, up to several inches in diameter, can form across the mouth and rectum. Fulminant herpes is one of the most gruesome aspects of progressive AIDS infection. Entire sections of the face can be rendered unrecognizable by the explosive, bloody hemorrhaging of the skin.

From a biological perspective, therefore, there are many objective reasons why homosexual acts per se have proven to be such an effective means of transmitting AIDS and other debilitating diseases.

1. Sodomy, fisting, the use of mechanical devices and other practices produce tears, fissures and lacerations of the rectum. This trauma facilitates the entrance of infected sperm and pathogenic organisms into the blood stream.

2. Infected bloody secretions leaking through the damaged walls of the rectum transmit the disease to the active partner through the urethral opening and through open sores and abrasions of the penis produced as a result of bodily abuse and disease. Fellatio, manual-genital and anal-oral sexual practices involving the

ingestion of infected semen, blood-streaked fecal matter and secretions facilitate transmission of pathogens.

3. Incessant, oftentimes simultaneous sperm-induced immune dysregulation, liver damage, intestinal parasites and venereal diseases all abet debilitation of the immune system prior to and along with infection by the AIDS virus.

So be it for this writing. Obviously, we shall have to carry this dissertation much further, for you ones don't seem to understand—**HOMOSEXUAL BEHAVIOR AND LOVE BETWEEN TWO BEINGS ARE NOT THE LEAST BIT THE SAME. THE REAL GOAL IS THE SEIZURE OF SAUDI OIL

I keep listening to the words coming from the Bush administration about Iraq and I become increasingly alarmed. There seems to be such confusion, but through it all a grim determination that they are, at some point, going to launch a military attack. The response of the British government seems equally confused, but I just hope that the determination to ultimately attack Iraq does not form the bedrock of their policy. It is hard now to see how George Bush can withdraw his bellicose words and also save face, but I hope that that is possible. Otherwise I fear greatly for the Middle East, but also for the rest of the world.

What is most chilling is that the hawks in the Bush administration must know the risks involved. They must be aware of the anti-American feeling throughout the Middle East. They must be aware of the fear in Egypt and Saudi Arabia that a war against Iraq could unleash revolutions, disposing of pro-Western governments, and replacing them with populist anti-American Islamist fundamentalist regimes. We should all remember the Islamist revolution in Iran. The Shah was backed by the Americans—but he couldn't stand against the will of the people. And it is because I am sure that they fully understand the consequences of their actions, that I am most afraid. I am drawn to the conclusion that they must want to create such mayhem.

The many words that are uttered about Saddam Hussein having weapons of mass destruction, which are never substantiated with any hard evidence, seem to mean very little. Even if Saddam had such weapons, why would he wish to use them? He knows that if he moves to seize the oilfields in neighbouring countries the full might of the Western world will be ranged against him. He knows that if he attacks Israel, the same fate awaits him. Comparisons with Hitler are silly—Hitler thought he could win; Saddam knows he cannot. Even if he has nuclear weapons, he cannot win a war against America. The United States can easily contain him. They do not need to try and force him to irrationality.

But that is what Bush seems to want to do. Why is he so determined to take the risk? The key country in the Middle East, as far as the Americans are concerned, is Saudi Arabia: the country with the largest oil reserves in the world, the country that has been prepared to calm the oil markets, producing more when prices are too high and less when there is a glut. The Saudi royal family has been rewarded with best-friend status by the West for its cooperation. There has been little concern that the government is undemocratic and breaches human rights, nor that it is in the grip of an extreme form of Islam. With American support it has been believed that the regime can be protected and will do what is necessary to secure a supply of oil to the West at reasonably stable prices.

Since September 11, however, it has become increasingly apparent to the U.S. administration that the Saudi regime is vulnerable. Both on the streets and in the leading families, including the royal family,

there are increasingly anti-Western voices. Osama bin Laden is just one prominent example. The love affair with America is ending. Reports of the removal of billions of dollars of Saudi investment from the United States may be difficult to quantify, but they are true. The possibility of the world's largest oil reserves falling into the hands of an anti-American, militant Islamist government is becoming ever more likely—and this is unacceptable.

The Americans know they cannot stop such a revolution. They must therefore hope that they can control the Saudi oil fields, if not the government. And what better way to do that than to have a large military force in the field at the time of such disruption. In the name of saving the West, these vital assets could be seized and controlled. No longer would the U.S. have to depend on a corrupt and unpopular royal family to keep it supplied with cheap oil. If there is chaos in the region, the U.S. armed forces could be seen as a global saviour. Under cover of the war on terrorism, the war to secure oil supplies could be waged.

This whole affair has nothing to do with a threat from Iraq—there isn't one. It has nothing to do with the war against terrorism or with morality. Saddam Hussein is obviously an evil man, but when we were selling arms to him to keep the Iranians in check he was the same evil man he is today. He was a pawn then and is a pawn now. In the same way he served Western interests then, he is now the distraction for the sleight of hand to protect the West's supply of oil. And where does this leave the British government? Are they in on the plan or just part of the smokescreen? The government speaks of morality and the threat posed by weapons of mass destruction, but can they really believe it?

SYMPATHY HAS TURNED INTO HOSTILITY POST-9/11 POLICIES ERODING GOODWILL

On the morning after Sept. 11, the United States took comfort in the world's compassion and sympathy. One year later, the warmth has faded.

Fear and loathing of America has re-emerged across much of the world. Oddly enough, the hostility seems deepest among America's closest allies, like the West Europeans, and its closest neighbors, like the Mexicans. It flourishes even in places where governmental relations are better than ever, such as Russia.

Many Arabs and other Muslims, like Third World residents of Latin America and Africa, honor the American victims of terror but insist that the Sept. 11 attacks were payback for the damage that U.S. government policies have done to their countries.

"The real U.S. is more ordinary, more normal and more sensible—and getting more so every day," said a commentary in South Africa's *Mail and Guardian* newspaper. "The problem with the U.S. is its government.

What they, and we, need is regime change."

Anti-Americanism is far from universal. The United States remains wildly popular in Afghanistan, where it ousted the hated Taliban, and in places such as Kosovo, where U.S. and NATO bombs helped end Serb rule. Eastern Europe, dominated by the Soviet superpower for 40 years, prefers its ties to the American superpower.

The conflicting attitudes were visible in memorials and demonstrations in several cities. At a service at St. Paul's Cathedral in London, a cellist played a Bach suite as 3,000 white rose petals fluttered down from the dome; in Paris, two powerful beams of light projected into the sky; in Belgrade, Mozart's *Requiem* was performed at the National Theater, and in Bangkok and Manila, protesters railed against U.S. government policy.

"We've moved a year from Sept. 11," said Mairtin O'Muelleoir, manager-editor of the *Andersontown News* in Northern Ireland, "and it seems the U.S. has somehow conspired to lose all of the sympathy and goodwill and support that it had."

"Anti-American sentiment in Russia has reached a level not seen since the days of the Cold War," said Moscow sociologist Boris Kagarlitsky. "This hostility is not the product of a political confrontation, as was the case during the Soviet era. It has arisen during a period of unprecedented political partnership between Russia and the United States in the war on terrorism."

The proposed war on Iraq is mentioned by many critics of America. So is American power, both military and economic, and the way it is used or perceived. In Europe, critics accused the United States of "unilateralism" and destructive policies toward the environment, international justice and peacekeeping efforts.

Many commentators accuse Washington of an arrogant self-centeredness that does not oppose the world so much as ignore it. To these non-Americans, for whom the overwhelmingly powerful United States is a preoccupation, there is a feeling that the U.S. doesn't care what they want and isn't listening to what they say.

"Can an independent nation be a friend of the U.S. if the U.S. doesn't take into account any opinion that is not its own?" Mexican novelist Carlos Fuentes wrote this week. "Is the Bush government aware that the scorn it has for rights and international organizations, as well as diplomacy and the governments that dissent and criticize it, can carry it toward—is carrying it toward—the extreme danger of isolation that would convert the U.S. into the easiest target and temptation for the terrorists that Bush says he is combating?"

Michael Howard, president of the International Institute for Strategic Studies in London, delivered a backhanded compliment to the Bush administration for its handling of the war on terrorism.

"As anti-terrorist campaigns go, this one deserves very high marks indeed, and the Bush administration deserves the thanks and congratulations of the entire world for its skill in conducting it," Howard wrote. "But thanks and congratulations are not what it is getting. Instead, a year after Sept. 11, the United States finds itself more unpopular than perhaps it has ever been in its history."

Around the world, people of many countries tried to explain this unpopularity.

In Rio de Janeiro, Pedro Monteiro, a 28-year-old Brazilian architect, mourned the "innocent victims" of the World Trade Center but said, "We also have to consider the number of innocents who were killed by

the U.S. in Afghanistan and those that will be killed in Iraq... Many people see this as Bush's personal war."

British commentator Martin Woolcott said, "Making the world safe for the United States is not the same as making it safe for the rest of us."

"I'm awfully sorry for the people who died," said Alexei Chernov, general director of the Moscow-based Vitus Investment Co. "But honestly, I'm not sorry for America as a state."

Some Arabs continued to celebrate the 9/11 attacks. Israeli customs seized a shipment of cigarette lighters depicting a plane slamming into one of the Trade Center towers, being shipped for sale in the Gaza Strip. Others still cling to conspiracy theories that blame Jews or the U.S. government for staging the attacks to demonize Arabs. ...

Russia and China have used the U.S. war on terror to improve relations with Washington and to carry out their own anti-Muslim campaigns in Chechnya and far western China. But a poll in Russia found that 70 percent of Russians consider America a hostile country, while the United States appears more popular in China, where the state-controlled press has printed rare stories presenting Bush in a sympathetic light. ...

[JR: I am gratified that world opinion and criticisms are being directed to where they should be—which is against our government and its misguided policies, and not against us as a people. BUSH VOWS TO UPHOLD CONSTITUTION

WASHINGTON (AP)—President Bush defended new limits on legal rights imposed by his administration in the war on terror, declaring that "the Constitution is sacred" and will not be undermined in the effort to improve Americans' security.

In an interview on CBS's *60 Minutes II*, Bush said he is pleased with the job being done by the Justice Department, despite criticism from civil liberties groups that Americans' individual freedoms are being eroded.

Among the Bush administration moves that have come under criticism are new authority in terror cases to imprison Americans indefinitely, allowing federal agents to monitor attorney-client conversations in federal prisons, the detention of thousands of Middle Eastern men who entered the United States since 2000 and immigration hearings that are no longer public.

Bush said that questioning and court review of those actions is healthy. "We will protect America," he said. "But we will do so within the guidelines of the Constitution, confines of the Constitution. ... But the

American people have got to understand that the Constitution is sacred as far as I am concerned."

'MOONLIGHT' IN RAMALLAH

In a conflict as bitter and bloody as that between the Israelis and the Palestinians, inevitably each side tends to dehumanize the other. Rather than flesh and blood, the enemy starts to turn into a nameless threat, a specter.

That's why Daniel Barenboim's impromptu master class Tuesday for Palestinian children in Ramallah, in the heart of the embattled West Bank, was a significant event. For a few moments, the Palestinian terrorist turned into a giggling and excited kid, and the heartless and implacable Israeli became a gray-haired and famous musician who, at some risk to himself, shared his gifts with Palestinian music students.

Barenboim, who is music director of both the Chicago Symphony Orchestra and Berlin's Staatsoper, and a world-renowned pianist, is a Jew born in Argentina, raised in Israel and an Israeli citizen. For the past couple of years he has been polishing what seems like a second career—free-lance peace activist and musical provocateur. In Ramallah, he played a portion of Beethoven's *Moonlight Sonata*, and then listened to three giggly Palestinian girls play on the school's tired Steinway grand. One was so excited by Barenboim's appearance—more like an apparition—that she forgot the name of the piece she played.

To those wondering about Barenboim's solo mission to Ramallah, he explained, "The lesson we have to learn from the 20th Century is that every human being—small, young as you or older like I—has to think of his responsibility as a human being, and not depend on the politicians and the governments."

Not surprisingly, some in the Israeli government are not amused by Barenboim's free-lance peace mission to Ramallah, not his first one. For the past three years he has run music workshops in Germany and the U.S. for Israeli and Arab students, and he has condemned the Israeli forces' operations in the West Bank. About three weeks ago, he performed at Beir Zeit University, a Palestinian institution near Ramallah. Before a performance Sunday at a music festival in Jerusalem, security was tight because of death threats, presumably by an ultra-Orthodox faction, according to *Ha'aretz* news service in Israel.

Barenboim had been denied permission by the Israeli government to visit Ramallah earlier this year, supposedly because it could not guarantee his security. So this time he got a ride in a German embassy car that somehow sneaked through the Israeli checkpoints that separate Israel from the West Bank.

The concert in Ramallah was but the latest event in Barenboim's personal campaign for peace in the Mideast and for artistic integrity. He has proven not only a towering musical figure, but a man of conviction and guts. Bravo. Shalom. **[JR: HOPE THROUGH PEACE!]**

FROM JOSEPHUS TO SHARON A WITNESS FROM THE PAST

A person who died 1900 years ago was summoned this week by Ariel Sharon to appear before his verbal kangaroo court.

That, in itself, is not surprising. In Jewish consciousness, there is no clear borderline between past and present, as there is none between history and myth. This may be the result of living outside history for thousands of years. Anyhow, in all debates about the future, Jews are used to involving figures from the remote past.

Joseph ben-Mattathias, better known by his Roman name Josephus Flavius, was the scion of a priestly family in Jerusalem. With the outbreak of the Jewish Rebellion against Rome, 66 AD, he was appointed commander of the Galilee. When the Romans reconquered the region, he was holed up in the fortified town Jotapata (Jodpat), but saved himself by resorting to a clever device. The defenders of the town decided to kill each other (as the defenders of Massada did later) and fixed by lot who would kill whom. Joseph managed to be the last one left alive, went over to the Romans and became a court historian of the Emperor.

His book *The Jewish War* is the most important report on the fall of Jerusalem and the destruction of the Jewish Temple—a traumatic event, that has left a deep imprint on Jewish consciousness to this very day. Every year, on the ninth day of the month Av, Jews are bound to mourn the destruction of the Temple and Israeli law forbids opening places of amusement. The claim for Israeli sovereignty over the Temple Mount is even now a major obstacle to Israeli-Palestinian peace.

A few days ago, on the first day of the Jewish New Year, Ariel Sharon invited himself to a solemn interview by two handpicked interviewers of the state-owned Kol Israel radio. **That was not difficult, because Sharon is now the direct boss of all state-owned media.**

(He achieved this by a small putsch: the Labor minister who was in charge of these media was persuaded to resign and accept a huge salary as the director of a bank, which collapsed the next day. Contrary to the coalition agreement, Sharon took the portfolio for himself. Now he controls the state media the way Stalin controlled his, with the same results.)

In the course of the interview, Sharon was asked about the Gush Shalom activists who, as put by the interviewer, are collecting material about IDF soldiers with the intention of submitting it to the international war-crimes court at The Hague.

This was obviously an invited question, since Sharon had brought with him to the interview a testimony for the prosecution: a quotation from Josephus Flavius.

First, Sharon accused the Gush activists (including myself) of treason and espionage in times of war. According to him, we are collecting the names of IDF officers and soldiers, in order to denounce them to the "enemies of Israel", namely the judges of the International Criminal Court at The Hague. "No act is more despicable than that," he pronounced.

After claiming that the Gush activists want to sow discord within our ranks, he read the long passage from Josephus that he had brought with him: “They (the defenders of Jerusalem) fought against each other, and their actions delighted the besiegers. Indeed, the evil that the Romans brought upon the city, was not worse than the evil the defenders brought on each other. After that, the fall of the city could not add to the disaster. The calamities that befell the city before its fall were so terrible, that one may say that the quarrel conquered the city, and the Romans conquered the quarrel, which was stronger than its besieged walls.” (My translation.)

The trouble with this quotation is that it is quite irrelevant, to say the least. The assistants who prepared it for Sharon are, it seems, ignorant of history.

First, nobody is besieging us. We are besieging the Palestinians. In this story, we are the Romans and the Palestinians are the Jews.

Second, the terrible civil war that broke out inside the besieged city was not between those who supported the rebellion and those who objected to it, between extremists and moderates, or, in today’s terms, between right and left. It broke out between the Zealots themselves, or, to use today’s language again, between the extreme right (Sharon) and the even-more-extreme right (Effi Eitam and his ilk). The moderates, those who argued that a war against the Roman Empire was hopeless, were liquidated by the Zealots long before that. The Rabins of those days were murdered, one by one.

Third, the crazy Zealots did indeed kill each other inside the besieged city, they destroyed the remaining foodstuffs and demoralized the starving population. But the city did not fall because of the quarrels inside it. Even if the defenders had behaved in an exemplary way and united like one man behind Sharon and Ben-Eliezer (sorry, behind Jochanan of Giscala and Shimon Bar-Giora), the Romans would have breached the walls. Nobody was able to stop their immense military might for long.

It was the Rebellion itself that was an act of madness. The end of the Jewish commonwealth in Palestine became inevitable when the Zealots took control of it. The more so, since the Jews outside Palestine—already numbering at that time two thirds of the Jewish people—turned their backs on the rebels.

By the way, Sharon’s attack on Gush Shalom was so important to his minions, they saw to it that it was announced in five consecutive news broadcasts throughout that morning. All his other statements in the interview, such as the scoop about his forthcoming visit to India and the session of the Palestinian parliament, were ignored.

That may be a hint of what’s to come. Sharon plans a full-fledged attack on Gush Shalom and all the serious peace camp, in order to silence all criticism and frighten other opponents into silence. His words are not only designed to pressure the state prosecution into putting the Gush activists on trial, but are also a simple incitement to murder, very much like his speeches on the eve of Rabin’s assassination.

What frightens Sharon so much? It seems that the Gush Shalom activity causes many soldiers to think, for the first time, about the possibility that certain actions are not only immoral and sabotage all chances for peace, but also violate Israeli and international law and might constitute war crimes. After all, the great majority of the soldiers are reasonable persons. Sharon hears the echo. In order to silence the message, he chooses to silence the messenger. I believe that even Josephus Flavius will not help him to achieve that.

[JR: Talk about parallel universes! Israel and the U.S. today are like Siamese twins as to similarities

in governments, how they function, their method of operations, as well as their inter-actions with other countries. It is enlightening to read how what happened in 66AD is being improvised to conform to Sharon’s political agenda and strategies today. What happened then is being twisted to have an entirely different meaning with just a few simple changes in words and phrasing. What a different picture it paints for us who want to know why things are the way they are today or aren’t.]

ARAFAT MISSED WARNING SIGNS IN SHOWDOWN

JERUSALEM—Palestinian leader Yasser Arafat this week heard a surprising sound from the people he thought he firmly ruled. In a word, they said, “No.”

No to the old order. No to the old revolutionary who refused or failed to fathom that another kind of revolution was brewing.

Arafat lost a showdown with the Palestinian parliament Wednesday, forcing him to fold his Cabinet and start forming a new one. The clash had been months in the making, boiling up from the thwarted democratic aspirations of the Palestinian people and growing sharper over the last six months amid an Israeli military lockdown of the West Bank.

The depth and integrity of this challenge to Arafat is still to be measured. Israel’s response will be critical, and some analysts suggest that Prime Minister Ariel Sharon, on war footing, may attempt to undermine the democratic initiative, keeping the Palestinians on the defensive. Still, it cannot be denied that something remarkable happened this week in the Palestinian territories. ...

No one would dare call Arafat washed up. As a revolutionary and a survivor, Arafat has no match in this political arena. Still, the Nobel Peace Prize winner, who has led his people into one of the bloodiest cycles of the Middle East conflict, has been weakened in the last few months.

The change is perceptible in the street, in the refugee camps that once supported Arafat unconditionally and among the struggling pockets of civil society that have eked out an existence in the past few months of Israeli occupation.

Militants throughout the West Bank have as much as acknowledged in the past months that Arafat and the Palestinian Authority never grasped the anger and despair of the Palestinian street. Arafat meant to use street anger as a bargaining chip within confines of international negotiation.

It was Arafat’s loss, they said, that he failed to realize that a new generation of fighters, who grew up during the first intifada, were eager for their own revolution.

“The intifada quickly got away from him,” said one member of the Popular Front for the Liberation of Palestine. “It’s almost as if he didn’t understand what was happening.”

Palestinian politicians, too, have said that Arafat missed the warning signs that the Palestinian Authority, troubled by allegations of corruption and malfeasance, was steadily losing credibility. Three years ago, Palestinian civil society began lobbying for new elections to change the cadre of political characters. The previous election was held in 1996.

Instead, Arafat stalled the electoral process to protest what he said were Israeli violations of the peace accord. That, activists said, was bad

judgment, another missed opportunity by Arafat who, throughout his career, often has been criticized for missing opportunities in the peace process.

His speech before the Palestinian Legislative Council this week was another example, analysts said.

“He had a golden opportunity to make his case to the people. There were hundreds of people, there were hundreds of cameras waiting for him to say something about democratic reforms. And he gave a nonsense speech,” said Hisham Ahmed, a political science professor at Bir Zeit University. ...

Arafat faced two stormy days of debate. He first tried to cajole his way out of the mess. Then he set an election date to try to pressure people to compromise on the vote. When he realized the breadth of the opposition, he and his longtime political advisers angled to have Fatah, the political faction that Arafat founded and heads, bail him out of the crisis and prevent a looming no-confidence vote. ...

Some of the biggest critics of the foundering Palestinian Authority came from Fatah itself. Some, such as onetime Cabinet member Nabil Amr, harbor political ambitions of their own.

Amr, once considered close to Arafat, quit the Cabinet four months ago. Last week, he wrote critically in the Arab press about Arafat’s peace efforts. This week, Amr openly began to champion a reform pushed by the Americans: the inclusion of a prime minister in the Palestinian government structure.

Amr said he was sincere in his search for reforms, no matter how they were generated. Observers said Amr’s decisions showed that the challenge to Arafat was born of a host of ambitions, personal and otherwise.

“For some people, this was just early campaigning, a way for them to help form their personality before the Palestinian people,” said Squeirat, the human-rights attorney and political hopeful. “But there was also a larger message.”

“People were empowered. We want representation. We won’t accept a ruler. We want something different.”

[JR: Arafat and his P.A. leadership may have become a little too tolerant and comfortable with Israeli dictates. They never turned around to see that their followers were dropping off one by one and were no longer marching in step behind them. GROUP OUTLINES PLAN TO OUST ALL PALESTINIANS

A draconian plan to forcibly eject all Palestinians and remove them to a new state possibly in Iraq or Saudi Arabia has been disclosed by Gamla, a group that includes former Israeli military officers and settlers.

Gamla receives tax-deductible contributions from a New York-based charity that says its mission is to promote greater Arab-Jewish tolerance.

The dramatic recommendations were just published on the organization's Website under the deceptively benign title, "The Logistics of Transfer".

Included is an outline for the "complete elimination of the Arab demographic threat to Israel" by forcibly removing *all* Palestinians, including those in the occupied territories and the area between the Jordan River and the Mediterranean Sea.

The cleansing timeline calls for the completion of the removal program within a 3-5 year period. However, there is some room for maneuver. According to the plan, "Israeli Arabs can be given one more option—to convert to Judaism if they prefer to stay put."

The plan is touted on the Website as "the only possible solution" to the Palestinian-Israeli conflict and is "substantiated by the *Torah*".

As a kickoff to the expulsion campaign, the plan calls for Palestinian citizens of Israel to suffer a kind of apartheid hallmarked by the passage of a law that "will stipulate in some form that non-Jewish citizens of the state, while retaining full and irrevocable civil rights, will have no ability to participate in Israeli political life."

To encourage Palestinians to leave "voluntarily," the plan calls for the total economic strangulation of Palestinians in the occupied West Bank and Gaza Strip. Included would be measures to deprive Palestinians of employment, giving them a choice of either leaving or starving.

Recognizing a sliver of reality, the article concedes that Israel will never win widespread support for the dramatic expulsion plan. "Only a modicum of support from its closest ally—the United States," is needed to enjoy success of the plan, the author concludes.

[JR: A majority of the Palestinians who were once employed by their Jewish masters have already lost their jobs to needy workers who have been imported from other Third World countries. The Diaspora of the Palestinians is the last stage of the Zionists' plan to create their Greater Israel. No surprise that Iraq is being considered as a place of exile for displaced Palestinians. MONEY LAUNDERING SCHEME BETWEEN FRANCE AND ISRAEL CONTINUES

PARIS—French magistrate Isabelle Prevost-Desprez has admitted in exasperation that the more indictments she issues with regard to a major money-laundering scheme between France and Israel that she is in charge of investigating, the more the scheme seems to continue practically unabated.

And this in spite of the measures supposedly taken by the French Government which has repeatedly said it wants to put a halt to the practice which has been robbing French banks, companies and individuals of thousands of millions of dollars.

Although indictments have regularly been handed down since 1998 by Judge Prevost-Desprez and her predecessors, and although such major banks as Societe Generale, Barclays France, Israeli Discount Bank and Leumi have been accused of taking part in the scheme, the French magistrate was forced to admit in recent days that there seems very little that she can do to bring any of the major actors to justice, indeed control the flows in illegal transactions that have hardly slowed down since the first indictments were handed down on August 3rd 1998.

The most recent indictments date from this summer—they were handed down July 4th—and concern French-based companies theoretically selling advertising space, but who serve as nothing less than fronts, say French judicial sources, for companies that take the money they receive from other French companies, naturally in the form of cheques, then rather than deposit them in French banks, send them directly to Israel where they are turned into cash at change bureaux which take a commission on the transaction, and then return the cheques to France, usually to the same French banks where they were originally issued.

But, as the cheques when originally issued were made out to bogus destinees whose names are easily transformed—for example one of the ad-selling companies named itself SEB, a name that got transformed into Sebbag by the time the cheque had returned to Paris—they inevitably find their way to the French banks where they are always honored for payment.

After more than one hundred indictments handed down by Prevost-Desprez and other judges taking part in the investigation, the only change that seems to have taken place—this according to French judicial sources—seems to be the way in which the laundering scheme seems to function.

When representatives of French banks like Societe Generale and Barclays France were indicted for their alleged role in the scheme, they immediately let it be known they had taken measures designed to halt the practice, at least as far as they were concerned, a decision which usually took the form of a refusal to accept for deposit any cheques emanating from Israel and notably from the banks already indicted for having taken part in the scheme.

But, notes a source in Prevost-Desprez's entourage, there still remain banks in France ready and willing to accept the cheques for deposit once they return from Israel.

Then too, the launderers have been able to make use of the banking facilities of third countries—notably in Belgium and Switzerland—facilities which make the laundering scheme all the more difficult to control as the third-country banking establishments in question—usually located in Brussels and Zurich—bear a certain prestige that make the cheques difficult to refuse once they eventually make their way back to France.

And every time that happens, says a source close to Prevost-Desprez, the French magistrate seems that much closer to giving up a fight that increasingly—and inexorably—takes on the dimensions of a losing battle.

[JR: It seems that if you want to circumvent money-laundering laws, or any laws for that matter, team up with Israeli, Zionist businesses or banks as

PUTIN THREATENS TO INVADE GEORGIA ULTIMATUM DEMANDS PURGE OF CHECHENS HOLED UP IN CAUCASUS

President Vladimir Putin has told world leaders that Russian forces might invade or bomb Georgia unless the authorities there acted promptly to "destroy" Chechen "terrorists" holed up in the Caucasus mountains, the Kremlin said yesterday.

After an ultimatum from Mr. Putin to Georgia's President Eduard Shevardnadze threatening Russian incursions into Georgia, the Russian president informed Kofi Annan, the UN secretary general, U.S., Chinese, British, and French leaders, and the member states of the Organisation for Security and Cooperation in Europe that Russian patience was running out.

While Russian sources said no actions were expected immediately, newspapers suggested that Mr. Shevardnadze had been given a month to root out the Chechen rebel fighters who control the Pankisi gorge, north-east of the Georgian capital, Tbilisi. If he failed, Russian special forces and helicopter gunships would go in.

"As regards terrorism, we've got more claims on Shevardnadze than on Saddam Hussein," the Russian defence minister, Sergei Ivanov, told a closed session of the Russian parliament, according to MPs present.

The sabre-rattling represents the strongest threats toward Georgia to date and was deliberately timed to coincide with the September 11 anniversary.

Mr. Putin's language echoed President George Bush's rhetoric on terrorism and Iraq, although he pointedly remarked that he was not seeking "regime change" in Tbilisi.

"It's extremely serious when the president of such a country [Russia] uses the language of threat," Mr. Shevardnadze said. Russia has repeatedly accused the Georgians of harbouring terrorists, refusing to extradite suspects, and indirectly facilitating attacks on Russia.

"If the Georgian authorities do not undertake concrete actions aimed at destroying terrorists, and if militants continue their raids into Russia from Georgia, Russia will undertake appropriate measures to counter this terrorist threat," Mr. Putin declared.

Critics said that if the Russians acted on their threats, they could become bogged down in a widening

war in the Caucasus on the kind of difficult terrain ideally suited to hit-and-run guerrilla tactics.

Amid the escalating tension between Russia and Georgia, a flurry of emergency meetings were held in Tbilisi and Moscow. Mr. Shevardnadze requested a phone conversation with Mr. Putin, but was rebuffed by the Kremlin.

At his Black Sea holiday retreat in Sochi on Wednesday, Mr. Putin held a session with the defence minister, army chief of staff, and security service chief, and ordered the military to draw up a hit-list of Chechen bases in Georgia.

The defence ministry said yesterday that the list would be finalised this week. Moscow and Tbilisi have long been at odds over Chechnya, whose mountainous southern border abuts on Georgia.

A prominent Chechen warlord, Ruslan Gelayev, regularly uses Georgia as a base and source of supplies.

The Pankisi is home to thousands of indigenous Chechens as well as guerrilla fighters and refugees fleeing the war. ...

Mr. Putin invoked the UN anti-terrorism resolution triggered by the September 11 attacks and the *UN Charter's* article 51 on self-defence to justify his threat.

Washington usually responds toughly to Russian threats against Georgia, but in this case Mr. Putin may be calculating that he will be given carte blanche in return for not blocking any U.S. military action against Iraq.

Islamist fighters are present in the Chechen rebel ranks, and the U.S. and Russia contend that al-Qaida fugitives from Afghanistan have found shelter in the gorge. ...

The Russian elite is viscerally contemptuous of Mr. Shevardnadze, whom they blame for the loss of the Soviet Union.

But since his glory days as Mikhail Gorbachev's foreign minister, Mr. Shevardnadze has presided over a failing, fractured, and corrupt state.

[JR: Putin is not accepting Shevardnadze's calls which indicates that Moscow is intent to step in and get rid of the terrorists that are sheltered in Georgia. Putin like Bush is using the terrorist threat as a carte blanche political tool to settle old scores, to adjust attitudes and to reclaim the control that Russia once held in the Caucasus. Like the U.S. Russia is motivated by an urgent necessity to establish a strategic advantage vital for the protection of the oil as well as the profits flowing out of the region. The U.S. may have underestimated Moscow's good will when U.S. troops were allowed to establish a base in Georgia by corrupt officials to help "train" the militia and to reap their generous rewards/payoffs in U.S. dollars. CASE AGAINST MILOSEVIC WEAKENING

THE HAGUE—With time running out before a court-imposed deadline, war crimes prosecutors have yet to produce the "smoking gun" that directly ties former Yugoslav leader Slobodan Milosevic to atrocities committed in Kosovo.

The judges of the international war crimes tribunal had instructed the prosecution to wrap up the Kosovo segment of its case next month and move on to crimes committed in Bosnia-Herzegovina and Croatia.

Since the beginning of the trial six months ago, prosecutors have called scores of ethnic Albanian witnesses who have recounted in gruesome detail how Serb police and army units mounted a campaign of terror and murder that forced some 800,000 civilians to flee their homes in Kosovo during the 1999 NATO bombing campaign.

But for the most part, none of these witnesses had ever laid eyes on Milosevic before facing him in the courtroom. They have no direct knowledge of who drew up the "ethnic cleansing" campaign or who gave the orders to carry it out. ...

In February, at the outset of the trial, prosecutors promised they would present "insider" witnesses—mid- to high-level officials in the Yugoslav government—who would tie the crime to Milosevic. Thus far the prosecutors have failed to deliver.

Rade Markovic, a once-powerful figure who headed Milosevic's security apparatus and now resides in a Belgrade jail cell, was one such insider witness. But when he was compelled to testify last month, his loyalties were clearly with Milosevic, and he did little damage to his former boss. ...

It also appears increasingly unlikely that one of the most knowledgeable American witnesses, former Balkans envoy Richard Holbrooke, will testify during the Kosovo portion of the trial, although Holbrooke is expected to give his testimony at some point.

The U.S. government has been reluctant to allow former officials to appear at the trial and face cross-examination by Milosevic. It softened its position last week, and State Department lawyers are negotiating the terms under which Washington will allow Holbrooke and retired Gen. Wesley Clark, the NATO commander during the Kosovo war, to testify.

The lack of insider witnesses underscores one of the tribunal's main problems. Although the Milosevic case has been billed as "the most important war crimes trial since Nuremberg", the tribunal has failed to generate much credibility for itself in Yugoslavia. Even Milosevic's political enemies in Belgrade now disparage the prosecution's shortcomings.

Western officials had hoped that the tribunal, by focusing on the criminal culpability of top officials, would dispel the notion of collective guilt and help the various ethnic groups of the former Yugoslavia come to terms with crimes committed in their names. But Milosevic, acting as his own lawyer, has effectively portrayed himself as the defender of Serbia's national honor, a theme that still plays well in Belgrade.

"The way things have gone so far, the trial is not being seen in Belgrade as something that many former or current officials want to support or be associated with," said Richard Dicker, an international law expert who has been monitoring the trial for Human Rights Watch.

The new regime in Belgrade agreed to hand over Milosevic, but not much else. Prosecutors appear to lack key pieces of documentary evidence from government archives, and their subpoena power to obtain this evidence is limited. ...

Milosevic, meanwhile, appears to have unfettered access to all sorts of government documents and intelligence files that he uses to challenge the credibility of witnesses, or simply to badger them. ...

Two schools of thought have emerged on what it will take to convict Milosevic.

One is that the prosecution has to demonstrate only that Milosevic knew what was happening in Kosovo and had the authority to stop it, but didn't.

"The case is circumstantial in some ways, but Milosevic was the head of a totalitarian state. An operation [Kosovo] that vast, on that kind of scale, does not happen without his knowledge and approval," said Judith Armatta, a lawyer who has been monitoring the trial for the Coalition for International Justice, a U.S.-based human-rights organization.

But Northwestern's D'Amato believes it is highly unlikely that the tribunal's judges would vote to convict on a charge as serious as genocide "simply because he was in command".

"You have to prove that he has dirty hands," said D'Amato. "You have to have the evidence."

'SUSPECT'? NO, JUST 'PERSON OF INTEREST'

Officially, biodefense expert Steven J. Hatfill is a "person of interest" in the FBI's anthrax probe.

But precisely what that means is a topic of interest within the legal world.

Legal analysts say the phrase, used by Attorney General John Ashcroft in Newark last week to describe Hatfill, is found nowhere in the federal code of conduct that guides the Department of Justice.

A department spokesman acknowledged that "person of interest" is an unofficial term with no legal definition.

"The attorney general's words speak for themselves," said spokesman Brian Sierra. "It's simply a way of responding to a question" from the media.

But Hatfill's supporters contend that "person of interest" is jargon for "twisting in the wind", and underscores the FBI's desperation to pin last year's deadly attacks on somebody.

"I think it is an inappropriate appellation, unknown to American jurisprudence," said Victor Glasberg, Hatfill's Virginia-based lawyer.

"It's an invitation to an open season on the so-called 'person of interest', who then becomes a person of interest to the irresponsible press," said Glasberg, who has lodged complaints with authorities about their handling of the investigation.

Hatfill, 48, has accused the government of a smear campaign that got him suspended from his \$150,000 job as a biodefense instructor. Louisiana State University is expected to decide within days whether to fire Hatfill from the federally funded post.

Glasberg has suggested that authorities broke Justice Department rules by tipping the media to recent

searches of Hatfill's Maryland apartment, and by leaking a bioattack novel confiscated from the doctor's personal computer. Sierra declined to discuss any aspect of the investigation. FBI officials also declined to comment. ...

A Justice Department manual describes "subjects" and "targets" of investigations. Prosecutors sometimes inform defense attorneys when their clients are targets—either to encourage a target's cooperation or to see if he trips up. But "persons of interest" is not codified.

"The Ashcroft Justice Department has coined its own phrases to account for a lot of what they do in the wake of Sept. 11," said Lawrence Lustberg, past president of the Association of Criminal Defense Lawyers of New Jersey.

A veteran investigator said he never encountered the term before the anthrax case. But a quick online search of news stories found "person of interest" used at least as far back as 1992, by arson investigators in Seattle.

The next year, Virginia authorities so described a man under investigation in connection with shootings outside the headquarters of the Central Intelligence Agency. ...

Some experts also have questioned FBI tactics in Princeton, where traces of anthrax were found this month in a mailbox near the Ivy League university.

People in that community said federal agents showed them a photo of Hatfill and asked if they had ever seen him.

In 1999, a panel led by Professor Gary Wells of Iowa State University proposed strict new guidelines for photo lineups.

To minimize false identifications, the panel urged that witnesses be shown a random sequence of photos that includes nonsubjects of the investigation.

New Jersey last year became the first state to adopt the new procedures. But Wells said the FBI is not obligated to follow his panel's recommendations. ...

Hatfill is a former scientist at the Army's Fort Detrick biodefense lab, where he studied Ebola and other deadly viruses.

Twice this month, he has vigorously denied ever working with the anthrax bacteria or having any involvement in the anthrax-by-mail attacks that killed five persons last fall. ...

Hatfill's colorful past includes medical studies and claims of covert military duty in Rhodesia, during the civil war that preceded the creation of Zimbabwe in 1980. Around that time, the region experienced history's largest recorded outbreak of anthrax.

More recently, Hatfill has warned of America's vulnerability to biological attack. Working for a defense contractor in 1999, he authorized a study on how an anthrax attack might be delivered by mail.

Hatfill has released time sheets from that contractor, Science Applications International Corp., purporting to show he was working in Virginia last Sept. 18 and Oct. 8 and 9, when anthrax-laced letters presumably were being mailed near Trenton. He also has offered the FBI blood and writing samples, which he asserts will clear him.

"He's a warm, lovable, humorous human being, one of the finest guys you'll ever meet, a wisecracker and damned good company," Clawson said.

"It's not up to this guy to prove his innocence. That's not the American way. It's up to the government to prove something's wrong. If the guy had a colorful past, so be it. That doesn't mean he had anything to do with the anthrax attacks. It's a red herring."

[JR: If anything, Hatfill might be guilty of "selective memory" and that would be a point of

interest for us all. He certainly knows more than he is able to remember consciously. His background highlights a career in biotech research as well as his involvement in covert government activities overseas. His presence in Africa when Zimbabwe was created and the outbreak of anthrax that followed afterward is more than a coincidence. Hatfill's research at the Army's bio-defense lab at Fort Detrick was probably not to cure the ills of mankind but to create them, to help reduce the world's populations. Mr. Hatfill, because of his past connections, is now caught in a catch-22 and that does make him a person of interest... and one we should know more about.]

PANEL: ALTERED ANIMALS
A THREAT TO ENVIRONMENT

WASHINGTON—Genetic manipulation of animals poses serious risks to the environment and potentially to human health, and federal efforts to manage those risks are disorganized and probably inadequate, a panel of the National Academy of Sciences said Tuesday.

In a long-awaited report, the nation's premier scientific body identified several concerns relating to the biotechnology industry's efforts to clone animals and to manipulate their genes.

The escape of such animals into the wild could alter species or even wipe them out, the report said, adding that the introduction of gene-altered meat, milk or eggs into the food supply could harm people unless managed carefully.

Despite those concerns, the report didn't call for a wholesale rejection of cloning or genetic manipulation. Committee members noted many potential benefits of animal biotechnology, including cheaper, healthier food and new drugs and medical treatments that could save human lives.

The report, which identified many of the theoretical risks and pointed toward ways of minimizing them, is an effort by the nation's scientific establishment to help regulators and the public catch up with a fast-moving technology.

A handful of cloned animals have already been transferred to American farmsteads, and products derived from them or their offspring have been held out of the food supply only because companies and farmers are complying with informal government requests. **[JR: Are they sure?]**

Companies have created animals that make human drugs in their milk, and they're working on pigs whose hearts or livers could be transplanted into human patients to replace failing organs. Thousands of other research projects along these lines are under way.

Though the committee identified various risks to people from animal biotechnology, those were generally **perceived** as mild to moderate, the report said. It called for renewed efforts to ensure that gene-altered foods don't create allergic reactions that could sicken or kill people, for instance.

The committee said assiduous efforts must be undertaken to ensure that milk or eggs containing human drugs don't wind up in the food supply.

On one of the most-discussed issues of the day—whether meat or milk from cloned animals and their offspring should be allowed into the food supply—the committee found almost no cause for alarm and said such food was highly likely to be

safe. It did urge studies to be sure such meat and milk don't differ markedly from normal food.

The committee's most serious concerns were environmental, and they focused particularly on genetically-altered fish and insects, which can escape easily, are highly mobile and can set up breeding populations in the wild. Fast-growing gene-altered fish that escape might easily dominate their wild cousins and drive them to extinction, the committee said.

The committee cited insects as another example. Researchers are trying to create a mosquito that can't transmit malaria to people, for instance. But the malaria parasite helps hold mosquito populations in check, and replacing wild mosquitoes with malaria-resistant strains might actually lead to more mosquitoes and greater transmission of mosquito-borne ailments other than malaria, the committee noted. **[JR: Like the proliferation of the West Nile Virus.]**

This kind of research has provoked fear, controversy, and—at times—wild investor enthusiasm. Both sides in the debate over animal biotechnology welcomed the report Tuesday. ...

Biotech advocates said the report showed that the potential problems, though real, aren't sufficient grounds to halt their research, and they predicted it would become the basis for new federal policies. ...

[JR: As in any research, vying for government funding and attracting investors causes all researchers to promote only the good benefits of their biotechnology research and avoid any negative undertones. For centuries, man has messed with Nature and transplanted both plants and animals into other regions, which has caused damaging imbalances in many an area's ecosystem. Then the "Greenies" come in with government agents and dictate the non-use of, or confiscation of private lands for the protection of some endangered species, of which the researchers were responsible for their demise to begin with. Biotechnology research overall may be good but there just isn't adequate or responsible oversight available to curtail the radical, fanatical or obsessed researcher or companies looking for prestige or great profits. In some cases, it's not nice to fool with Mother Nature!]

BUBBLE TALK GROWS WITH DEBT

First, there was the tech stock bubble.

Then came fears about a real estate bubble, although the jury is still out on that one.

Now, economists and stock market experts are floating the idea of a debt bubble, in which swelled levels of household and corporate borrowing force an already squishy economy into a longer-lasting, and more punishing, downturn.

Burgeoning household debt is a familiar story, closely watched by economists because they fear it will dampen consumer spending, which has been a vital bulwark against a deeper recession.

But as Federal Reserve Chairman Alan Greenspan and others point to revived business investment as a key to a sustained recovery, those growing corporate debt levels are receiving increased scrutiny: More money devoted to servicing debt means that much less for investment, and more debt overall means more skittish lenders.

"I've been saying there was a debt bubble for about two years," said Jane D'Arista, director of

programs at the Fed-watching Financial Markets Center think tank outside Washington, who said the Fed has made the situation worse by fixating on inflation as debt swelled to unprecedented heights.

"The Fed has paid no attention to credit," she said. "This is as bad as having inflation, in terms of what it's doing to the economy."

There's no disputing that, in sheer dollar terms, debt has ballooned. Household debt, including mortgages, has more than doubled since 1991, reaching nearly \$7.9 trillion at the end of the first quarter, according to the most recent Fed data. Corporate debt has mushroomed almost as fast, topping \$4.8 trillion. Add in the debt from other businesses and nearly \$10 trillion in debt from the financial sector, and the total exceeds \$24 trillion.

That, of course, is more than twice the annual gross domestic product of roughly \$10.3 trillion, and dwarfs the ever-popular federal debt, which checked in at a paltry \$3.4 trillion at the end of the first quarter. ...

But D'Arista is concerned about what the future holds.

"The problem is, how are you going to repay that debt? It has to be rolled over, refunded or repaid," she said.

She said there's no guarantee that companies can maintain their cash flow. Huge debt loads restrict money for new investment, which retards growth in jobs and personal income. Facing heavy debt loads themselves, consumers are less likely to increase their own spending, which further crimps corporate revenue and profit growth.

"It is a self-fulfilling cycle," she said.

Paradoxically, growing concern about corporate debt comes at the same time many economists are encouraging Greenspan and the Fed to cut interest rates even further to encourage more borrowing.

The economic slowdown has done little to curb companies' debt accumulation—overall levels actually shrank during and after the last recession, the Fed data show, but have continued to swell this time around. The \$4.8 trillion corporate debt outstanding at the end of the first quarter is up 4 percent from the year-earlier quarter, and up 12 percent from the 2000 first quarter.

In recent years, companies have increasingly turned to the bond market rather than bankers for loans. As the Fed cut rates, new corporate debt issuance jumped last year, according to the Fitch rating service, topping \$1 trillion.

But defaults also have soared—reaching 10 percent on speculative-grade debt, according to Standard & Poor's, up from less than 2 percent for much of the just-ended record economic expansion. Although Fitch reported late last week that the pace slowed in July, the rising defaults mean the Fed rate cuts haven't been fully passed on to borrowers, with spreads between government interest rates and bond yields rising sharply.

It's clear that growth in corporate debt has been spread unevenly. Despite all the incentives and rock-bottom rates for the best clients, some companies are finding it all but impossible to borrow, and some CEOs have no interest in boosting spending in such a dicey economic climate. ...

Indeed, although a Federal Deposit Insurance Corp. study earlier this year found that business credit overall was more available last year than in previous recessions, a National Association of Manufacturers survey at the same time found that a third of small and medium-size manufacturers said credit had grown more difficult to obtain. ...

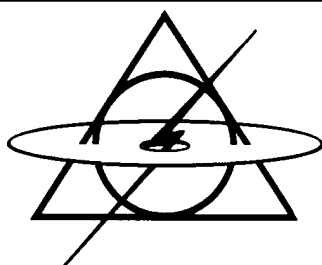
