WEAPONIZATION

WARFARE HAS BEEN CHANGED FOREVER

Warfare has been changed forever by the development of these scalar energy longitudinal wave howitzers. To get a basic understanding of scalar waves is to have the imagination suddenly run wild as all the implications and possibilities regarding warfare fall into place. One realizes with a certain horror that the world has totally changed, and that there are some very fearsome possibilities. Remember, the power for these weapons comes from the time domain, longitudinal EM waves in the vacuum of empty space, and the power is tremendous and mind-boggling. 1. THE TESLA HOWITZER AND ITS MODES OF ACTION

For one thing there is no delivery of any thing to any place. Bombs are obsolete. So are the planes to get them there. No helicopters necessary. All current nuclear devices are rendered nearly useless by electronic “dudding”. All distant-destruction can be done from a control room, and to any point on Earth. The destructive power of “men” has just increased by orders of magnitude. The new weapons could even cause storms on the Sun! Thus there is great urgency to make these **new facts public** and known—with the hope that all nations would come together to ban the use of scalar weapons.

Two scalar antennae together along with the computers to control them, make up a scalar interferometer, and according to Col. Bearden the Russians have hundreds of such installations already. These interferometers are called “Tesla Howitzers”. They can deliver a giant blast of energy to the distant target site, true “action-at-a-distance”.

The **first howitzer mode** is called the “**exothermic**” mode of operation because immense EM energy blasts outward at the target site. The blast of a **scalar howitzer** can be of near nuclear level in destructiveness, and can be repeated easily, at that place, or nearby, or anywhere.

The howitzer can use a lesser exothermic power setting and simply **destroy all electronics IN THE TARGET AREA**. Thus they can render our nuclear missiles inoperable as they sit in their silos by “frying” the electronic circuits that guide them. They can bring down ANY AIRPLANE, ANYWHERE IN THE WORLD, AT ANY TIME. Any person anywhere, if their exact position is known, can be assassinated without a shot being fired. [H: Sorry, sleepyheads, we told you this 15 years ago so it is NOT new revelation bursting forth. It can be accomplished right now without going in to hyper anything. We wrote EXTENSIVELY about these things and you seemed to pay attention for a few minutes and then off to dreamland, rock tossing at our team, mud-slinging, lawsuits and accusations. Well, we have problems too which are incredible to you who just want to make sure you are not inconvenienced in your own little worlds—like having to read nasty information

about things which might “disturb” you in some uncomfortable manner. It is upon you and has been for several years, good friends, and that simply IS THE WAY IT IS.]

The howitzer can also bring down power grids anywhere in the world, at any time. Thus they could bring Wall Street to an instant halt by disabling all its electronics. Even this one little easy tweak of the howitzer could cripple the U.S. economy in a single day. No wonder the “leaders” don’t want you to know. This is a new era we are in. The discovery and development of scalar interferometry has put us in a **new world** whether we like it or not. Anyone could be expected to go into denial, the **befuddled** Senators and Congressmen included. But we have **TO WAKE UP**.

[H: It certainly puts a different glow on 9/11/01, DOESN’T IT?]

In a **second howitzer mode** called the “**endothermic**” mode, the howitzer sucks energy out of the target area, essentially creating a blast of cold at the distant target. It is even capable of freezing parts of the ocean. Bearden gives a number of cases where these “cold explosions” have been witnessed, mostly by airline pilots. April 9, 1984: A huge mushroom cloud of mostly water is seen rising miles into the sky from out of the ocean, an awesome sight.

In the endothermic mode the sucked-out energy must go somewhere, so it is vented out at some other chosen spot on the Earth. These endothermic plumes have been photographed by satellite.

By using both of these HEAT (exothermic) and COLD (endothermic) modes together the weather can be altered anywhere. Warm the air over here, cool it down over there, put a curl in the jet stream, dissipate clouds, create clouds, whip up a tornado.

Bearden: “Cold explosions can be used to freeze tanks, personnel, and equipment. The equipment and tanks thaw out. The personnel thaw out too, but they are dead when they do.”

(This endothermic mode of the howitzers makes me think that there might one day be a cure for the problem of global warming after all. Could not a big device, situated in space or on the Moon, be able to vent a great deal of excess heat outside the atmosphere into space, thus functioning as a kind of planetary thermostat?)

While the United States has experimented with electromagnetic weapons using ordinary transverse EM waves, the longitudinal weaponized waves [LW] are truly of another order altogether.

For one thing they do not have to travel through space, for they come from the time domain, which is everywhere. The energy of the blast, the heat or light or whatever, comes from the vacuum of space **at the location of the target itself**. This is astonishing. The weapons actually just trigger the release of immense energy from the vacuum at the target location.

“... it is possible to focus the potential for the effects of a weapon **through spacetime itself**, in a manner so that mass and energy do not “travel through space” from the transmitter to the target at all. Instead, ripples and patterns in the fabric of spacetime itself are manipulated to meet and interfere in and at the local spacetime of some distant target. There **interference of these ripple patterns** creates the

desired energetic effect (hence the term energetics) directly in and through the target itself, emerging from the very spacetime (vacuum) in which the target is imbedded at its distant location.”—**Bearden**; Fer-de-Lance briefing

The big Tesla howitzers are aimed at their targets by using a worldwide electromagnetic pattern called the “Woodpecker Grid”, begun by the Russians in 1976.

You can hear the Woodpecker signal here:

The woodpecker grid is just that, a grid of EM waves which provide a channel for the LW waves to any point on Earth. Computers use the woodpecker grid information to hone down the aiming of the howitzers **to a pinpoint location on Earth. (For that matter, it could be under the earth, in space, or under the sea).**

A **third howitzer mode is what Col. Bearden calls “MINDSNAPPER” mode**. This is a truly frightening mode which affects the electromagnetic mind-body connection. Being mind-snapped at a low level would cause you to lose consciousness. Being mind-snapped at a slightly higher power would “entrain” all minds in the target area into a kind of hypnologic trance, a state in which they would all be highly susceptible to suggestions and orders.

Being mind-snapped at high level would so disrupt the mind-body connection that everyone in the target area would fall down, instantly dead. Not only that, everything around you and inside you would be killed, so that your sterilized body would **not rot** for quite a long time.

The **Mindsnapper** can be used for a small area, or to **kill an entire population**. In fact, using the scalar waves to affect the human mind has become a new field in its own right, and has been dubbed “psychoenergetics”. (This will be further discussed in section 5.)

Bearden describes the use of the howitzer in **mind-snapping mode** against people, to cause unconsciousness or death:

“From a military viewpoint, these scalar EM weapons are really quite all-around weapons.

“For example, they are very lethal against personnel.

“Set in the ‘high-intensity pulse mode’, one blast and a person’s nervous system is destroyed instantly. Total, instantaneous death results. One can blast away at entire groups of infantrymen, for example. It’s the peak power that’s important, not the average power. So the weapon doesn’t require too much battery power.

“Set on a lower-intensity pulse mode, one zap can simply knock out a person, rendering him instantly unconscious. Quite useful if one needs prisoners to interrogate. Also very silent, which is useful in operations employing stealth and surprise.”—**Bearden**

“Those hit by the scalar EM weapon, however, have a most peculiar death mode.

“Death comes instantly and **TOTALLY**. There is no convulsion, no response. The entire nervous system is destroyed instantly. Every living cell in the body is killed instantly, including all bacteria, germs, etc.

“A body hit with this thing falls like a limp rag and lies where it falls. It doesn’t decay in even 30-45 days. In a macabre fashion, it’s been reduced to something like food irradiated

with nuclear radiation; everything is killed, so the material is preserved for an extended period before any decay can set in.”—**Bearden**

He goes on to say that the same “bazooka-sized scalar EM pulse weapon” can also be used to knock out a tank with one shot (or pulse). So tank warfare is obsolete. Helicopters? Bearden points out: “... if he’s attacked by a helicopter or a fixed-wing aircraft, he can bring the same weapon to bear on it. He can knock down a chopper or a jet—with one shot.”

OBITUARY FOR TANK WARFARE

Tanks are useless against portable LW weapons.

“For example, suppose one attacks a tank [with an LW weapon]. With scalar EM pulse, the personnel die instantly. Total personnel kill is achieved. All electronic systems of the tank are duded. Total system kill is achieved.

The ammunition in the tank explodes. Total kill is achieved.

The fuel explodes. This is another total kill mechanism.

That tank has been killed totally, by a variety of mechanisms, all simultaneously. That’s a k-kill in any analyst’s book.

And don’t worry about retrieval and repair. The tank is finished permanently.

Even the most modern tank is just as vulnerable as the most obsolete.”—**Bearden**

One begins to get the idea how profoundly the **conventional means of warfare have been obsoleted**. All the usual weapons of war have been rendered nearly useless! And *Star Trek’s* “**Phaser**”, with its “stun” and “kill” modes is here at last.

Although it is the weapons aspect of scalar electromagnetic which has received the most developmental effort, Bearden points out that a great many other amazing things may be accomplished in this new field of science. Beam me up, Scotty!

“Superluminal communications systems, hyperspace drive, and **materialization** and **dematerialization** are all hypothetically possible, using scalar electromagnetics. As the technology develops, we should see the development of many of the systems long thought impossible except in science-fiction.”—**Bearden**

Bearden describes a huge test of the Russian scalar weapons systems which occurred in 1985, a test that went completely unnoticed by Western scientists:

“Just before May 1, 1985 the Soviet Union performed a “full-up” operational test of their entire strategic scalar EM weapons complex. This test was detected and monitored periodically by Frank Golden. Some 27 of these giant Soviet “power taps” were locked into the molten core of the Earth, producing forced (entrained) scalar resonance of the entire planet on 54 controlled frequencies under our very feet. The remainder of the scalar frequency spectrum was ablaze with literally hundreds of Soviet scalar transmitters: probably the entire strategic scalar command and distant commands, etc., was activated in the giant exercise.

“For several days, the system was exercised on a mind-boggling scale, apparently as part of the Soviet Union’s highly accentuated 40th-anniversary celebration of the end of World War II.

“Ironically, not a single U.S. intelligence agency, laboratory, or scientist detected this monstrous exercise for the new Soviet leader, Gorbachev. Not a one of them had a detector for scalar EM radiation, and not a one of them officially believes the exercise ever happened.”—**Bearden**

“The **Woodpecker grid/howitzer weapon system** can be placed over the ocean and used against cruise missiles, naval surface-to-air and surface-to-surface missiles, submarine-launched ballistic and cruise missiles, etc. Placed over a carrier task force, it can also take care of the aircraft launched by the carrier as fast as they are launched. It can also handily take care of the missiles launched by guided-missile cruisers of the accompanying task force.”—**Bearden**

The whole series of the Fer-de-Lance briefing slides and comments is a “must read” for anyone wanting to be aware of the actual state of things in this world right now. It is a new world and it takes some getting used to. Fer-de-Lance speaks clearly, for the layman, of the way things stand.

What is it like to operate these Tesla Howitzers? Col. Bearden gives us an idea in his Fer-de-Lance briefing, Slides 66-71. (Bearden: <http://www.cheniery.org/books>)

Who needs armies anymore? An entire war can be fought and won by a handful of men sitting in a comfortable control booth! The scalar electromagnetics revolution has made all previous forms of warfare nearly obsolete.

WHY HAVEN'T THE RUSSIANS USED THE SCALAR WEAPONS YET?

Bearden gives his thoughts on this in “Fer-de-Lance”. The power of these weapons is so great that an accident or war could wipe out all life on Earth, and even **affect the Sun**.

“As can be appreciated, this entire concept [MAD] is now totally obsoleted by the Soviet possession of scalar EM weapons.

“The ‘mutual assured destruction’ capability—or MAD concept as it was so aptly named!—is **no longer mutual**. And for two reasons: (1) The Soviet surprise attack could destroy essentially all our Triad forces wherever they are, in the first attack. (2) Even if a very small number of our strategic forces survive, the puny strike we could attempt to launch could be repeatedly decimated from launch to terminal phase.

“The restraint on the Soviets is not because of our Triad forces. The restraint is twofold:

(1) A second nation has scalar EM weapons, and would undoubtedly unleash them upon the Soviet Union with great violence if such a massive worldwide destruction of U.S. forces occurred or was threatened (is it really “accidental” that six major Soviet missile ammunition storage sites mysteriously exploded within seven months?);

(2) the closed-loop **scalar radiation exchange system of Earth-Sun could be inadvertently “tweaked”** in the feedback loop from Earth to Sun, so that a large solar scalar resonance was stimulated. In that case the Sun could emit a mighty resonant “burp” that would simply **wipe out all life on Earth in a fiery shower**.

“The ‘terror’ in the ‘balance of terror’ between nations has just increased by many, many orders of magnitude.

“The biblical prophecy that the Earth will be wiped out by ‘fire and brimstone from heaven’ is very near fulfillment NOW.

“Put another way, the pucker factor—even on the Russians who may contemplate unleashing Armageddon—is higher than any Western strategic analyst has ever imagined, even **in his wildest nightmares**.

“Truly these weapons are ‘more frightening than the mind of man has imagined’, as Brezhnev put it in 1975. **[H: IN 1975? That is more than a quarter of a century and how far have “they” gone since then, my friends? Oh indeed, it certainly is “SERIOUS TIME” LONG PAST.]**

“The frightening scalar EM weapons can be used, but only very, very gingerly indeed. If a slight mistake is made, EVERYBODY LOSES EVERYTHING.”—**Bearden**

But the Russians (KGB) are not the worst of it. Bearden claims that some of the scalar weapons have been leased to the Yakuza for about a billion a year, and that only the KGB is holding the Yakuza in check from making a **full-scale, all-out scalar attack on the West**.

[H: Check the next reference if you want to get a better “timeline” on this information as you note that the next quote comes from William Cohen as Secretary of Defense, U.S.A. in 1997 (already 5 years ago).]

U.S. DEFENSE SECRETARY WILLIAM COHEN WARNS ABOUT ECO-TERRORISM USING SCALAR ELECTROMAGNETIC WEAPONS

“Others [terrorists] are engaging even in an eco-type of terrorism whereby they can **alter the climate, set off earthquakes, volcanoes remotely through the use of electromagnetic waves...** So there are plenty of ingenious minds out there that are at work finding ways in which they can wreak terror upon other nations...**IT’S REAL**, and that’s the reason why we have to intensify our (counter terrorism) efforts.”—**Defense Secretary William Cohen, 1997**

[H: Please pay attention, ye of little faith in our program, to the next short notation.]

In a letter to a writer named “Russell” Bearden says:

“In short, Russell, the Secretary of Defense of the United States confirmed that there are indeed novel kinds of EM weapons, right now, and have been for some time, which have been and are being used to (1) initiate earthquakes, (2) engineer the weather and climate, and (3) initiate the eruption of volcanoes. We wrote about those exact uses of the weaponry decades ago. Several nations now have such weapons. Three of them (two on one side and the other on a hostile side) are even firing practice shots into Western Australia, as a convenient test range.”

[H: By golly, let us take another survey: Check again and see if you really want Ekkers’ job after all!]

TESLA HOWITZERS IN WEATHER MODE

“Engineering the weather is **duck soup**; they tested that over the U.S. in 1967, and entered upon continuing operations over North America on July 4, 1976 as a grim kind of KGB ‘Bicentennial Gift’ to the United States. Here’s how it is done with several interferometers.

“First, the interferometers can deliberately make ‘high pressure areas’ (cool the air so it shrinks and its ‘footprint’ pressure on the ground increases because its density increases) and ‘low pressure areas’ (heat the air so that it expands and its ‘footprint’ pressure on the ground decreases because its density decreases). Well, if one makes the highs and lows where one wishes them, and judiciously and somewhat slowly moves them along a given path, these highs and lows will entrain the jet streams and thus ‘steer’ the weather.

“So if you wish a very cold snap or attack, go up into Canada and start these actions to steer down some streams that bring some very frigid air. Establish other highs and lows judiciously to ‘block’ or ‘slow’ other jet streams and flows as desired. In this way, one can pull the ‘large cold air masses coming down from Canada’ deep into the Southern U.S. at will. They do it regularly. If you wish an ice storm, add an additional current of warm moist air you bring up (steer up by using artificial highs and lows) from the ocean. Where they meet, you will get freezing rain, then sleet, then severe icing accumulating. This type of attack does rather large damage to the struck area.”

[H: Don’t spoof these things, readers, just go forth and watch “Discovery or National Geographic” channels on your weekly television programming.]

Whole Websites have now sprung up showing weather radar anomalies which may well be indications of scalar weather engineering. One list of over 500 images is here. The Cheniere Website has its own collection.

In another section at the Cheniere Website are many photos of cloud anomalies which reveal the underlying grid along which the clouds are forming or un-forming. Bearden relates a startling incident in these ongoing “weather wars”.

“During the spring of 1986, abnormally strong Soviet weather engineering occurred over the U.S., causing a drastic drought in the Southeastern U.S. **This drought was broken by a colleague who used an extremely powerful scalar EM device** to redirect jetstreams. TESLA HOWITZERS
IN EARTHQUAKE MODE:
HOW TO MAKE AN EARTHQUAKE

“Here’s how you initiate a very large earthquake with such weapons. Take a convenient fault zone or set of them. Focus the interferometry on the fault zone, in the ‘diverging’ mode, and deposit EM energy there in the rocks on both sides, increasing (slowly) the stress in the rocks by the reverse piezoelectric effect (deposit excess energy, get crystal mechanical movements).

“Do it slowly, and the stress will build up to large pressures well-above a plate-slip minimum energy required. At some point, the rocks yield and one or both sides ‘slip’ and move rather sharply, giving a very large earthquake in that zone.

TESLA HOWITZERS
IN TESLA’S “BIG EYE” MODE:
HOW TO MAKE A BIG EYE IN THE SKY

By using longitudinal wave interferometry in a weakly endothermic mode a new kind of “radar” is now possible, one which can look right through the Earth and oceans. Because the endothermic mode extracts energy from the distant target, a pattern of the target area can be scanned for in the returned energy.

“Thus the receiver produces a representation of the energy extracted from various locations within the distant endothermic zone. By displaying the received signals on an appropriately scanned screen, a representation of the distant scene in the intersection zone can be created. Indeed this is a special kind of ‘microwave interferometry’, and—with modern techniques—the imagery obtained might be surprisingly good. With development, it might even become as good as the image presently obtained by side-looking acquisition radars.

“Interestingly enough, since scalar EM beams will easily penetrate the Earth or the ocean, one can also look beneath the Earth or beneath the ocean with this type of scanning scalar interferometer.

“The importance of this capability to strategic and tactical reconnaissance is obvious. Camouflage, cover, and concealment have no effect on such a system. One can easily look inside buildings and into underground facilities. With a small system such as this, the U.S. Marines at Khe Sahn would have had little difficulty locating the tunnels continually dug under the perimeter by the Viet Cong. And targets under jungle canopies are directly visible.”—**Bearden**

The Tesla howitzers can be used in a nearly **impregnable defensive mode** whereby they throw up a dome (Tesla Dome) or a sphere (Tesla Globe) of highly powerful electromagnetic energy, enough to “dud” or destroy missiles which try to penetrate them. Once again, this energy is not going through space from the howitzer, but being made to emerge from the local vacuum at the location of the shell. KGB tests of these domes have been witnessed by airline pilots around the world. Bearden gives many examples of the Tesla dome being sighted around the world in his briefing paper “Fer-de-Lance”. (Russian dome test, another globe inside yet another globe test.) These giant electromagnetic domes can be hundreds of miles across, or narrowed down more to total impermeability.

“Such a shell may be several hundred miles in diameter at the base. The enormous energy required to form such a defense shell is obtained by a “scalar power tap” into the molten core of the Earth itself, as previously explained. In late April/early May of 1985, 27 such “power taps” were placed in the Earth by the Soviets. If each tap is capable of powering four to six larger scalar EM weapons, then the Soviet strategic scalar EM arsenal contains over 100 monstrous super-weapons capable of generating exothermic explosions, endothermic explosions, engineering the weather, locating and destroying underwater submarines, detecting and destroying ballistic missiles shortly after launch, detecting and destroying long range strategic bombers as soon as they are airborne, etc.”—**Bearden**

By using nested domes one can protect the domed area **even against nuclear radiation itself**. Tesla globes can be used to hit airborne targets by simply placing a globe of any chosen size in the flight path of the incoming missile. It does double duty because the missile hits it going in, and then the rubble hits it again going out the other side.

While the U.S. persists in its useless boondoggle “missile defense system” by shooting a missile with a missile (missiles which would already have been “duded” by the Tesla howitzers), between the domes and the globe the Russians (KGB) have in hand (operational) a nearly perfect missile defense system. Someone should ask the Secretary of Defense if the U.S. Tesla domes are in place and over which cities? How powerful are our American Tesla domes?

Bearden cites a number of examples of these domes being tested around the world: March 20, 1969, June 22, 1976, March 24, 1977, August 17, 1980, June 18, 1982.

In a slide from the Fer-de-Lance briefing it is shown how the “woodpecker grid” itself also acts as a sensor, detecting any missile launch anywhere, and how the howitzers can respond instantly by delivering a blast to exactly the right coordinates, right along the channels of that same grid which is feeding the location information about the missile launch. This certainly beats “trying to hit a bullet with a bullet”. Especially since YOUR bullet would probably be instantly inoperable in a real scalar war situation.

[H: And as for your computer-guided electronic missiles? Well—hard luck story—but there will be a void of electric flow and electronics WILL FAIL.]

ROGUE GROUPS IN THE GOVERNMENT

Bearden fears that these scalar electromagnetic secrets may have fallen into the hands of what he called secret “**rogue groups**” within the labyrinthine depths of the black-ops special-access domain of the secret government. “In the extreme, such a deep black program can even become a ‘captured’ program,” he says, “which is totally in the hands of rogues and **no longer reports to or is bound by the dictates of the parent government.**”

“They have their own agendas. And being rogue groups, they may well bring in unethical, immoral tricks; assassination, bribery, entrapment, disinformation, plausible deniability, etc. A certain percentage of a highly secret rogue group will wind up using all these things and more. **It’s a human characteristic, the old primate dominance game. Only now disguised and hidden under deep classification.**

“In highly classified groups, these groups are greatly enabled to joust more widely, unethically, and immorally because it is so deeply hidden. So very deep classification evokes the growth and intensity of rogue groups. It’s the old ‘Power corrupts, and absolute power corrupts absolutely’ routine. ... Due to loose formation of rogue groups inside such programs, they may have dual or triple purposes, may not operate under very much legitimate government control at all, and may operate specifically for the purposes of the rogue groups that have gained control.

“The involvement of at least some rogue groups, some being “cowboys” who operate well outside all laws and ethics, could also result in such things as assassinations, clandestine testing on individuals without their consent, etc. In short, **it could account for what seems to be actually occurring.**”—Bearden

WORLD WAR III HAS ALREADY BEGUN

Because it is now possible to cripple the power grids and electronics of any nation, that nation could be reduced to economic ruin without ever firing an actual “shot”. Without electricity Wall Street cannot operate. Without electricity you quickly need martial law. One no longer needs to wage a conventional war any more at all. There are now **lots of new ways to bring any nation to its knees.**

“We are at war, whether we like it or not. And we are going to have strategic strikes on an unparalleled scale for us. Pearl Harbor was nothing compared to what is coming down, once we consider the ‘augmentation’ and such.

“When that factor is considered, then it’s a totally

new ball game on replacing the power system. There isn’t going to be much choice; the old one is going to be destroyed or so badly crippled that it will collapse the U.S. economy in a way we have not seen since 1929. Of course, in such a case hitting us, we will be under martial law, the works, everywhere. For one thing, it’s the only way you can keep the cities from imploding from within, by the criminal element, looting, robbing, killing, etc. Simply wait and see, it’s on the way.”

Although Bearden has for years decried the “scalar-gap”, and chided the military for falling so far behind the Russian KGB in the field of scalar electromagnetics, recent statements indicate that things may at last have changed somewhat.

“In the new war, the first phase of WW III has already been completed. Hence President Bush’s recognition that this is a total war, and has to take it to the enemy no matter where he may be hiding or in what sanctuary or in what foreign nation. This is an entirely different war than anything the U.S. has ever fought in its history. **And before it is over, it is going to kill more Americans than have died in all the previous wars in our history.** The news media and the public have not yet recognized that awful situation and predicament. Most are already thinking that, well, we won in Afghanistan so it’s just about over. Instead, it has only just begun.

“Anyway, that’s a brief uptake on some of the weapon situation today. Some 10 nations or more now have LWIs, and five have the QPs. I’m still working on how many have the appalling negative EMP weapons, but would estimate 6 or 7 nations have them in one stage or the other, either deployed or in at least advanced development. And in my estimation, the Yakuza will have them within three to five years if they have to build them themselves, and quicker if they can buy them from the Russians, Chinese, or???”—Bearden

When he was asked the question “**Does the government listen to Tom Bearden?**” Bearden said:

“Let me speak carefully. I am very satisfied with how I’ve been listened to in the quarters where the rubber meets the road. The West is no longer defenseless, not by any means. Cannot amplify it further than that.”

Bearden has briefed the government a number of times and the “Cheniere” Website shows a great number of graphic military briefing slides.

ARE THE RUSSIANS MAKING “UFOs”?

Scalar Electromagnetics engineering opens the possibility of antigravity vehicles and “hyperspace travel”. In other words, we can now make our own UFOs! Of such scalar-powered antigravity vehicles, which have now become possible, Bearden has this to say:

“We might expect to see such vehicles glowing. Their various surface features and mechanisms might appear to be glowing or revolving lights, etc.

“They could exhibit incredible “aerodynamic performance”, seemingly in the atmosphere. **Actually they would not be moving ‘through’ the atmosphere at all, but through a higher space outside each particle of atmosphere.**

“They could seem to **materialize** and **dematerialize.**

“They could seem to plunge into the ocean or rise out of it.

“They could even seem to operate under the ocean or inside the Earth itself.

“Such anomalous vehicle performances have been seen all over the world, particularly since a few years after WW II.

“It appears that one or more nations of Earth are operating such vehicles now **in great secrecy.** Our own ‘government’ may even be one of these.

“If so, it isn’t our true ‘government/government’. Instead, it’s the ‘control group/government’. It’s government at the operational level, but at a higher level **it belongs to certain control groups who have penetrated our government’s vitals and taken over all such projects.**”—Bearden

In an excellent article on her Earthfiles Website, Linda Moulton Howe reported on the utter bafflement of Norwegian scientists over mysterious lights appearing in the valley of Hessdalen, Norway.

She writes of the research there: “the results can be broken down into two groups: 95% are thermal plasmas and 5% are unidentified solid objects. The plasmas emit long-wave radio frequencies and strangely, their temperatures do not vary with change in size or brightness.” She quotes the scientists’ research summary:

“1) most of the luminous phenomenon is a thermal plasma;

2) the light-balls are not single objects but are constituted of many small components which are vibrating around a common barycenter;

3) the light-balls are able to eject smaller light-balls;

4) the light-balls change shape all the time;

5) the luminosity increase of the light balls is due to the increase of the radiating area. **But the cause, and the physical mechanism with which radiation is emitted, is currently unknown.**”

This would almost certainly seem to be another example of the testing of the scalar howitzers. It is baffling because, as Bearden points out repeatedly, Western scientists have limited knowledge of the scalar electromagnetic principles by which the howitzers operate. The Hessdalen scientists were completely baffled as to where the energy of these plasma balls were coming from.

Ms. Howe interviews Massimo Teodorani, Ph.D., Astrophysicist, who released the report on the 2001 Hessdalen sightings. The scientist speaks of the baffling phenomenon observed.

“In don’t know how it is possible that Nature is spontaneously able to do that. Anyway, we deduce that the plasma is trapped inside a sort of magnetic cage and the magnetic cage closes around the plasma and keeps it fixed in some way, prevents it from expanding. **But where does it come from? We don’t know.**”

By what we have been considering here, we can recognize the signatures of scalar electromagnetic engineering. If it is a Tesla howitzer, then the energy for the plasma balls is coming from the vacuum of spacetime at the very location of the balls themselves, triggered by scalar interferometers aimed through the woodpecker grid.

These kinds of balls can be used as **marker beacons** giving feedback for precision aiming of the howitzers. The energy of the marker beacon can be read back into the computers giving precise

location information for pinpoint aiming. The target area can be very small, or widened out.

There is a little movie of one of the Hessdalen plasma balls here. It would seem to be a clear documentation of a scalar howitzer marker-beacon. How many other current “UFO” sightings are actually the witnessing of Tesla howitzer tests?

In fact there are a great many **anomalous events** of the past few decades which might very well be explained by the Russian testing of their longitudinal electromagnetic weapons. It would seem that the mysterious appearance of crop circles around the world could be accomplished by feeding a precise mathematical graphic pattern into the computerized aiming software and change the very molecular structure of the crops themselves along the lines of that pattern. The stalks fall over from the localized effect of the longitudinal waves. A plasma ball tracing patterns? Are they slyly sending a message to see if we are “getting it” yet?

HEALING POWERS OF LONGITUDINAL WAVES

Healing via longitudinal waves, time reversal of cells (de-differentiation), Priore’s machine, Bearden proposed “blanket” version, using the electric power grid for healing waves or for broadcasting disease patterns. (*Scalar Biowar*)

THE GOOD NEWS!

“Any sort of disease whatsoever—physical or mental—will be rapidly curable, simply and cheaply. It will be possible to reverse aging and rejuvenate the person. It will be possible to regrow limbs and straighten misshapen spines—and directly remove the causes of mental diseases and cure them as well. Lifespan will be staggeringly increased, without ‘old age’s debilitation’. AIDS, cancer, leukemia, and genetic diseases will be completely conquered. The potential for a true golden era is upon us, for all humanity.”

Proof of the healing powers of longitudinal waves from the vacuum is seen in the work of Antoine Priore who produced longitudinal scalar waves using a gigantic glass tube filled with plasma. He himself did not understand why it worked or how it cured cancer in animals.

“The Priore team cured terminal tumors, trypanosomiasis, and other dread diseases in laboratory animals in France, in the 1960s and 1970s, under rigorous scientific protocols by eminent scientists. The Priore project was funded by the French Government to the tune of several millions of dollars (equivalent). <http://www.explorepub.com/articles/energetics.html>

“. . . Priore’s machines concretely demonstrated a nearly 100% cure of all kinds of terminal cancers and leukemias, in thousands of rigorous laboratory tests with animals. These results were shown to medical scientists as early as 1960.” <http://www.cheniere.org/priore/index.html>.

Bearden has stated that the longitudinal EM waves can have a healing effect because they always come in pairs called **“phase conjugate pairs”** and one of the pair is **time-reversed**. This enables engineering of the waves to “pump” the cells of the body (with waves from the time domain)

and actually time-reverse the cells back to a previous healthy condition. The scalar cure of cancer does not involve killing the cancer cells but rather pumping them with time energy into a previous condition. I know, this seems miraculous, and is it not?

This healing power in the longitudinal wave of the time domain is a mind-boggling thing to face. It took me months to get through it, to suffer the fact that the cure for cancer and AIDS was right there, **in this new scalar electromagnetics technology**, and that’s been kept back from the people for so many decades now.

Bearden has a great deal to say about the work of Antoine Priore, who himself did not understand why the machine worked. Priore did not know about the longitudinal waves of the time domain. In fact, Tom Bearden has supplied the missing explanation as to how that big giant two-story tube consistently cured cancer in animals.

“The medical implications are enormous. By just reversing the damaged cells back to a previous physical state, this gives a physics mechanism for *controlled cellular differentiation, in biology terms. Physicians will time-reverse diseased, damaged or aged cells back to an earlier healthy condition, including all the cellular genetics.* Normal cells are just reversed to a slightly younger condition.”

“We believe this mechanism explains the revolutionary but baffling electromagnetic cures achieved by a team of outstanding French scientists in the 1960s and early 70s, working with inventor Antoine Priore. In lab animals, cures were achieved for terminal tumors, infectious diseases such as trypanosomiasis, and arteriosclerosis. In addition, deliberately suppressed immune systems were dramatically restored.

“We hypothesize that this is the long-sought mechanism of how the living body heals itself. In short, the body’s cellular control system induces cellular reversal by weak time-domain pumping of the damaged cells and the affected area. The cellular regeneration system performs all healing of cellular damage in the body; the immune system heals nothing, not even its own damaged cells.

“For the first time medical science can develop as a science of healing rather than a science of intervention. And it will develop as a science of **unlimited** healing, since no pathogen can resist action by curved spacetime engines.”—**Bearden**

Bearden has extended the Priore work, with the previously missing knowledge now in place, and designed a revised system (for irradiating the body with longitudinal waves) which gets rid of Priore’s giant glass plasma tube and uses instead an **antenna unit which surrounds the body**. He has also provided the missing explanation of how it worked. There is an article from *Explore* magazine, Part I and Part II.

In fact, Bearden has presented to the U.S. government a plan to use a portable version of a Scalar Healing Blanket where wire channels in the blanket act as a scalar antenna, which can both send and receive scalar electromagnetic waves. A two-minute treatment of the waves is sufficient to restore the body to its earlier healthy condition. Thus even thousands could be treated easily and quickly in a biowar mass-attack situation.

“To defend against things like anthrax attacks on

our civilian population centers, we also have recommended to the U.S. Government the crash development of small, portable treatment machines—using similar “antiengine-forming” and cellular reversing “porthole technology”. Such portable machines **could be developed cheaply and quickly, AND PRESENT GOVERNMENT FACILITIES COULD BE USED TO MASSIVELY ATTACK THE CORRELATE DATABASE PRODUCTION PROBLEM.** [H: Well, I believe you will now understand why you **DO NOT** have such apparatus for your personal use. **Go for it Bob J., the government will NEVER release this under “these” circumstances.**]

The portable treatment units could be cranked out by the hundreds of thousands and flooded down through emergency response agencies such as the police forces, the National Guard, emergency hospitals, emergency response teams, etc.”—**Bearden**

The Scalar healing blanket would fit into a large suitcase. It has three basic parts, the longitudinal wave generator, laptop computer, and the antenna-blanket. The plan was a stroke of Bearden’s genius, but unfortunately it fell on befuddled government ears. “Unfortunately, so far the DOD (Dept. Of Defense) doesn’t even understand what the heck we’re talking about!”

“We tried very hard in 1998 to call attention to the extreme national need for the most urgent possible development of a portable computer-controlled treatment device based on the experimentally proven Priore methodology, but extended to a much simpler and far more rapid method of treatment.

“Quick development of this technology could lead to a suitcase-sized device, capable of treating a patient in less than one minute, and stopping the symptoms and disease progress cold, then reversing it. Three “less than a minute” treatments one week apart would be required for complete cure. As an added advantage, partial reversal of aging in older patients would also be accomplished as a bonus, in addition to time-reversing the damaged and diseased cells.

“The method proposed to the DoD in 1998 used normal EM in a peculiar way to force the body itself to make its own time-polarized EM waves, and pump every part of its cells—including the genetics—in the time domain.

Of course that was signed over to the Roman Catholic Church. Often times priests are enticing girls within the trap where the families have much property so that the Church will come into full inheritance of the child’s birthright. I have reason to say to you that the salvation of your soul in the Catholic Church is going to cost you plenty of money. More than you can possibly know anything about—they are eager to commercialize on the life of that child.

On this particular morning, I asked the Mother Superior to give me a little while to think it over. No one forced me at this point and so I thought it over for a while and then one day I told her that I thought I would hide away behind the convent doors because I believed I could give more time to God; I could pray more and I would be in a better position to inflict more pain upon my body. I had no way of knowing the latter would be well taken care of without my participation. We are taught that God smiles down on us from heaven when we do penance, whatever the physical suffering might be, and the more the suffering the more the acceptance.

I didn’t know how it would be. If you could only look into the hearts of little nuns, if you are a Christian, you would immediately cry out before God in behalf of those little girls, because to themselves they are heathens. It doesn’t make any difference as to the amount of education we might have—we are still heathens, for we know nothing about this lovely Christ and nothing about any plan of salvation. We, as nuns, are simply living our karma within the convent.

And so, on that particular morning, I come walking down the isle again. Only on this day, I have no wedding garment on, I have a funeral shroud made of dark red velvet which falls to the floor. As I walk down that isle I know what I am to do. The casket is all prepared by the already cloistered nuns and it is sitting right out front. I knew that I would walk to the casket and climb within, lay my body down, and I would spend nine hours in there. Two little nuns would come forth and cover me completely with a heavy black cloth we call a “heavy drape”, which is so incensed that ones feels certain smothering to death. I would have to stay there for the full nine hours or longer. I knew that when I would come out of that casket, I would never leave the convent—ever again. I knew I would never see my mother and father again—I would never go home again. I would always live totally behind convent doors and when I would die, my body would be buried there. They had told me that, so I knew it before the actual ceremony—but I had no way to comprehend a thing of such magnitude.

The worst and most terrible price to pay, however, was to open your eyes and realize that the convents are not religious orders as we were taught and we were trained. It is a total disappointment to a young girl who has given her life to God and willing to give up everything and sacrifice so much. I can assure you that it was a heartbreaking and terrifying disappointment.

The nuns asked me what I thought of while in that casket. I spilled every tear in my body. I remembered every lovely thing my mother had done for me; I remembered her voice and the gathering around the table. I remembered the times when she would play with us and remembered the things she had said to me—even to what a marvelous cook she was. I remembered everything as a little girl growing up in my parent’s home. I remembered everything as I laid in that casket—knowing I would never again hear her voice or see her face. I knew I would never sit to her table again or enjoy her presence or her food.

I knew all those things, so for some four hours I simply spilled all the tears in my body, because it was so hard and I knew I would get homesick but I was giving it all for what I thought was the love of God. I couldn’t know any better. Those were nine horribly long, long hours. Then I got a hold on myself and began to speak to myself, “Now Charlotte, you will make the very best Carmelite nun, it will be the best thing you have ever done and you will give your best and you are willing to give everything you have.”

I had given the best that I had up to this point and I would now be even better, for I knew I must be the best that I could be. The Mother Superior and Priests knew all about it also. Now, I realized that after I would walk out of that casket, I would go back into the Mother Superior’s room. I had never been allowed within that particular room, so I had no idea what was inside.

When I walked in the room the Mother Superior requires I sit down in a high-backed, hard-bottomed chair. Then I would immediately take three vows—of poverty, chastity and obedience. As I took those vows, she opened a little place on my earlobe and removed a portion of blood, because every vow must be signed in my own blood. After that, I would take the vow of poverty. Now, when I signed that vow I would henceforth be willing to live in crucial poverty for the balance of my life. The next vow is of chastity. You know, this vow represents my marriage to Jesus Christ and I would always remain a virgin and I would never marry another in this world. After the Bishop married me to Christ he had placed a ring on my finger and that meant I was sealed to Christ. I accepted it because I knew no better. And now, here I was again, vowing to always remain a virgin because I am the bride of Christ.

Please listen carefully for these things are so important to the things that I shall later share. The last vow was of obedience. I already felt I knew what obedience meant, for I was already living in a convent and absolute obedience is demanded. You don’t escape with any show of disobedience; not for even a moment. You don’t get away with disobedience and you are made to realize what obedience is and it is demanded and you know it. The sooner you learn it the wiser you become in stemming the consequences of disobedience.

WHAT DO THESE VOWS MEAN?

It means more than you folks will ever know because most people that I know anything about, know very little about obedience. You may know something, but I promise you that you know nothing compared to that which a little nun knows about it. Unless you have lived in a convent, you have no idea.

When I signed that particular vow in my own blood, it did something to me because after I signed those vows it meant I had signed away everything I had; my human rights were gone and I had become a mechanical human being. I can’t sit until told to do so, I can’t rise until they tell me to, I can’t lie down until they tell me to and neither do I dare get up. I cannot eat until they tell me to, what I see—I don’t see; what I feel—I don’t feel; I have become a mechanical human being. But you are not aware of it until you have signed all these vows. Then you realize too late that there you are, a mechanical human being and you belong to Rome—totally to Rome.

AFTER THE VOWS—FORGOTTEN WOMEN

Immediately after I have taken those vows, then the Mother Superior is going to take away my name and give me the name of a patron Saint. And she teaches me to believe that whatever happens to me in the convent, I can take to that patron saint and she will intercede and get my prayers to God, for I am not holy enough to stand in the presence of God. It is no wonder that the dear little nuns never get close to God, for we were always taught that we would never be holy enough to stand in His presence. We always would have to go through someone else in order to get our prayers to God. We believe it because we don’t know any better.

Now, all identification of who “Charlotte” was is put away. It would be taken away and if anyone should come to the convent and call for me in my family name, they would be told that there is no such person. I no longer exist!

Next, the Mother Superior is going to cut every bit of hair off my head. When she cuts it with the scissors she follows with the clippers. There is nothing left—not one strand of hair left on my head. Of course, if you could be a nun, you could understand that with the heavy head-gear we must wear that it would be so

cumbersome to take care of it, that we don't have any way to take care of hair in the convent. There are no combs in the convent and you can see how hard it would be to tend a head of hair. It is certainly not necessary to have a comb after they finish with your haircut.

Alright, this is my "black veil" and these are my vows. I am there and I am going to stay there.

Up until this point I received a letter once a month from my family. I could also write a letter to my family. Even though I now realize that most of my writing would be marked out, because letters received from my family there was so much blacked out until there was no sense left to the letter. Oh, I would weep over those black marks while I wondered what my mother was saying to me. Well, I was informed that I would never know what they wanted to say to me and so it was. They break your heart over and over and the loneliness is complete. You have no friends in the convent.

I can assure you there are no friends. Even though there were 180 girls in my particular wing, not one was my friend and neither was I a friend to them. You are allowed no friends in the convent—we are all policemen and detectives just watching one another and compelled to tell on each other. The little nun who would find something to tell on another nun stands in good favor with the Mother Superior. Then that Mother teaches that nun to believe that when she stands in good favor with the Mother Superior, she is standing in good favor with God. Of course that little nun desires that so she will tell a lot of things which are not even truth.

SOLD MY SOUL

After all of this has so far transpired, everything I have is gone—I HAVE SOLD MY SOUL FOR A MASS OF THEOLOGICAL POTTAGE. Not only are we destroyed in our bodies but many of us in our minds as well. Many of us, if we die in the convent, will have lost our souls. It is a serious and pitiful thing and I covet your prayers for all those little helpless nuns behind cloistered convent doors.

They will never know the gospel. They will never know Christ—they will only know evil in its most terrifying and hopeless form. They will never feel the reflection of God and the Christos—they will only know death and mechanical and tortured existence.

AFTER THE VOWS, THE NEXT—

After the vows have transpired, the Mother Superior sends me into another room. When I walk into that room I see something I have never seen before. I see a Roman Catholic Priest dressed in a Holy Habit. He walks over to me and locks his arm into my arm which had never been done in any of my previous experience in the convent. I had never had a priest insult me in any manner; I had never had one even be unkind to me in the first part of my convent experience.

But here he is now, and of course I didn't understand what it was all about and I didn't know what in the world the man expected of me. I pulled from him because I felt highly insulted and said "shame on you". It made him very angry. The Mother Superior must have heard my voice, for she immediately came to the room. She said, "After you've been in the convent a little while, you won't feel this way. The rest of us felt this way in the beginning but you know, the priest's body is sanctified and therefore it is not a sin to give our bodies unto the priest." In other words, they teach every little nun this, "As the holy ghost placed the germ in Mary's womb and Jesus Christ was born, so the priest is the Holy Ghost and therefore it is no sin for you to bear his children."

Let me assure you, that is what they come to the convent for—there is no other purpose in all of this world

for a priest to come to the convent except to rob those precious little girls of their virtue. I'll be telling you later in this testimony just what they really do.

At this point every bridge has been burned out from under me—there is no way back, I can't get out of the convent even though I pled; oh how I pled with that priest. I cried for my father—I wanted to go home. I told him I wanted to go no farther. He laughed in my face and, believe me, that is when you stand alone—there is none to whom to turn. You are caught in the circumstance, for there is no way in which to get out of the convent.

I assure you, I stayed in the convent until God made a way for me to come out.

After all these things, now I am expected to go into the chamber with the priest. Did I go? No—I had not entered the convent to be a bad woman. I wouldn't have suffered as I had suffered to be a bad woman—I was there to be pure and Godly. I had entered the convent to give my heart, life and soul to God and I had no other purpose in being there. But you will soon learn why it is easier to do that which is expected than to disobey. Of course I refused to go into the private chamber with him, and would have fought until I spilled my last drop of blood. Well, I didn't go with him but on the next morning I knew that I would have to do penance.

A LITTLE PENANCE

When the Mother Superior said, the next morning, that I would need to do penance—I would be initiated as a Carmelite nun. I remember that when she walked me down into that particular place of penance, it was a dark room which was dark and cold. As we walked toward the front of the room I could see the little candles burning. Anywhere in the convent you will find the seven candles burning. As I came closer I saw the candles but I couldn't see anything else and of course I wondered what she was going to do to me. I felt terror rise in my heart, for it is one thing you cannot completely get rid of.

As I came a little closer I could see something lying there on a board. When I came very close I could see it was a little nun lying there on what I call "a cooling board". The board was the same length as the girl. As I looked closely and watched the candle light flicker on her face, I realized the child was dead.

Questions rushed into my brain; how did she die, why is she here, how long has she been here—why am I here? But I had signed away every human right, so I am not allowed to utter even one word. So, I just stood staring. Then the Mother Superior said, "You stand vigil over this dead body for one hour and then another little nun will come to relieve you." So every few minutes during that hour I would walk over to the little body and sprinkle it with holy water and say "Peace be unto you."

I did exactly what they told me to do even though it was a terrible feeling. But I was not afraid of the dead people, for I had already learned it was the live people we had to be most cautious of. I wasn't afraid of that little dead nun but oh, my heart ached for her.

After the little bell rang I realized my hour was up. Then as I am waiting for my signal to be relieved—we must always walk on our toes in silence—I wait. I waited silently and heard nothing but I was quite unnerved being there with the little dead nun—so when the relieving nun laid her hand on my shoulder, I let out a scream in total terror. I didn't mean to do it; I didn't break the rule of silence on purpose but I was scared.

Immediately I had to come before the Mother Superior and that was the first time I was to learn and know about a dungeon. I had no idea there were dungeons in the convent. Well, she put me in a place of total darkness, dirty and floorless, and left me there in the total darkness for three days and three nights, without food or water.

I assure you, I didn't scream any more. I really tried to never again break the rules of screaming because I now knew there was a dungeon and they will promptly put you in it. Let me tell you, it is not a nice place to be.

MASTERPIECE OF SATAN

Before I go further, let me tell you that this potpourri is a masterpiece of Satan—A MASTERPIECE OF SATAN, with his lying wonders and his traditions and his deceptions—it is a terrible thing when you know about it.

After the three days in the dungeon the Mother Superior came to me and informed me that I must do penance. She took me down into another room underground. As I entered the room I could see a piece of wood there, and as I got closer I could see that it was a cross. It was made of heavy timbers, perhaps eight to ten feet high. It was sitting on an incline and was very heavy. She had me walk to the base of the cross and she had me strip off my clothes and then had me drape my body over the foot of the cross. She pulled my hands underneath and bound them to my feet. This is where I would be spilling my blood but she had not told me how and neither could I ask just how I would spill it.

There were two little nuns who came with her and she gave them a flagellation whip which is a bamboo-type pole with six straps on its end and on the end of each strap was a cross piece of sharp metal. Each nun was given a whip and they stood on either side of the cross. At the same time, those girls began whipping my body. When the metal hit my body it would, of course, slash my skin. It would cut into the flesh and I spilled blood, running down to the floor. Well, that was my spilling of blood, and being human it wounded, it hurt—it was very painful but you dare not cry out. After the whipping is over, my body was not bathed but rather my clothing was put back upon my body and I have to go the rest of the day with the clothing sticking into the wounds.

When the night comes and I stand in front of my cell bed—we have to stand with our backs to each other to undress—I had to rip the cloth from my wounds and oh, it was terrible. I couldn't sleep at all that night; I was not a bit sleepy because I couldn't get all of my clothing off, for they were dried into the wounds. The cloth remained dried into the wounds for several days. Neither could I eat the following morning of that awful event.

In the mornings we got a cup of black coffee in a tin cup and we could have no milk or sugar of any kind. We were also given one slice of bread made by the nuns of the cloister—it weighs exactly four ounces. That is all that is given for breakfast. Then in the evening there is a small bowl of soup made with only vegetables with no seasoning what-so-ever, with a half slice of bread. Three times a week I receive a half glass of skimmed milk. This was my food three-hundred-sixty-five days in the year.

Of course I began to lose weight very rapidly because there was not enough food to eat. There was never a night that I went to bed without a hungry stomach. Sometimes the hunger pangs would be so severe I could not sleep. The pain would be gnawing and one could hardly stand it. You know, though, that you are still only going to get that one tiny slice of bread in the morning. Of course it couldn't begin to fill up the stomach and, of course, you have to work very hard all day.

I covet your prayers for those little nuns because you cannot imagine the misery. You will go to bed with a full stomach tonight but those little girls are starving—and they are lonely, wounded, heartsick and homesick. They are in total discouragement and worst of all, they have NO hope. No hope what-so-ever. You and I can look forward to the day when we can see Jesus—they have no hope, they believe they will never see Jesus. Please do not forget to pray for them.

ANOTHER INITIATION

A few days later the Mother Superior is taking me to another place for another initiation. When I go into the penance chamber this morning, we come into another area down there and the distance was quite a long ways to walk. It was a tunnel we pass through and then we come out into a room. When I walk a good distance into the room I see the candles burning and in addition I see a rope hanging down from the ceiling and I am so scared. I don't know what the ropes are for and I silently cry out in wondering what she is going to do. As you do the penances you begin to have a lot of fear in your heart. I can't say anything but I walk on and realize there are two ropes hanging down. She tells me to move over to the wall and stand sideways against the wall underneath the ropes. Then she tells me to put up both of my thumbs, and I did so. She pulled one rope down and on it was a metal band which she fastens around the joint of my thumb and then the other. Now I am standing facing the wall, and she comes over by me to a crank on the wall and she begins winding. I feel myself moving and she is taking me right up into the air. She winds until my toes are just touching the floor and there she fastens it.

All of the weight of my body is now on my thumbs and on the tips of my toes. Not a word is spoken—no one utters a word. She walks out of that room and locks the door. If you can imagine what it means to hear a key lock in a door and know that I am strung up here helpless, you can't imagine—unless you are a nun. When she walked out of that room I couldn't know how long I would stay there.

They left me there wondering if "this was it"? Would I simply die like this? They left me alone without food or water. Within a few hours my muscles began to scream out with the pain, for I was, after all, a human being. I was suffering unbearably and that woman left me to hang and nobody came near. It does no good to cry. You can spill every tear in your body but nobody will hear—there is no one there to hear. I just hung there, finally being convinced I was to die there. I began to feel the swelling and then I don't know how much time passed. Finally the door opened one morning and the nun had something for me to eat and water in a pan with potatoes in it. The potatoes were not fit to eat.

There was a shelf on the wall facing me and it can be adjusted to the height of a nun. Now remember, I am not against the wall—I am several inches away from the wall. She raises the shelf to the height of my mouth and puts the food and water on the shelf in front of me. She says, "There is your food," and walks out.

She didn't let my hands down—how can I get the food? But you learn, for you are so hungry but worse, you are so thirsty you feel as if you are going mad. To get it, I discovered that if I raise one hand a bit higher the other would come down just a bit and then over-and-over, bit-by-bit I finally could just reach the dish. I had to lap it like an animal but I got just as much as I could reach. I worked until I got as much of the potato as I could because I was starving—it was awful and I am so pained to remember.

That was the way I was fed for a while. I hung there for nine days and nine nights in that position. The time came when I was so swollen that I could actually see the puffing as it protruded. I thought my eyes would come out of my head. I could feel that my arms, etc., were two to three times normal size and I was that way all over my body. I was in real suffering as it was like my entire body was like a "boil".

On the ninth day she comes in and releases the bonds and lets me down on the floor. I fall but I cannot walk. I didn't walk for I don't know how long. Two little nuns carry me out, one lifts my feet and the other my shoulders. They carry me to the infirmary and lay me on a slab of wood and there they cut the clothing from my body. Nobody but God will ever know how awful; I am covered with vermin and filth—my own human filth.

In that room are no facilities but right behind me is a stool with a pail and they have running water through it—but the lid is down and on the lid are sharp nails driven through the lid. If I would fall on that I would suffer terribly. If the rope would break I would have not survived and the suffering would be unbearable.

This, dear friends, is the life of a little nun behind cloistered doors. This is after they have already received the disillusionment—this is the life that we will live and these are the things that we will be forced to do.

I remember, as I lived on in that place, let me tell you that we get out of our beds before 4:30 in the mornings. The Mother Superior taps a bell and that gives five minutes to dress. I tell you surely, you get that clothing on in five minutes—not five and a half. I failed once and was severely punished—I never failed again in all of the years in the convent.

When we finish dressing, we start marching and we march and march.

EVEN BEFORE THE BLACK VEIL

In the beginning days in the convent the lies were thrust forth. As an example, let us say a mother comes to visit and brings the child a bit of candy.

The mother would ask to speak to the Mother Superior and request to see the daughter. The child will then be brought to the other side of a wall where the mother cannot see her. But the mother will speak to her and ask if she is happy to be here. That little nun will lie and say to her mother that she is very happy. Well, the Mother Superior would be standing right there and the child would have no alternative. God alone knows what the Mother Superior would do to the little nun if she failed to lie. Then as a mother will, she will ask if the child has plenty to eat and the little nun will lie again and tell her "Oh, yes, we have plenty to eat."

That mother will then go home and be happy and share the news and a meal with the rest of the family. But if she could look within and see our table and see what her little girl eats—if she could just look in at her little girl after three or four years, she would see that her eyes are sunken completely into her head and her little body is wasted away. I can promise you that mother would never be able to eat another meal. If a parent could see a child after she has been in a convent for a period of time—they would never rest again.

Of course these things are all hidden, completely under-cover and the children have no choice—we are given what we shall have and we take it or die. [End Quoting]

Dharma, enough for this sitting. Let us take respite. Thank you, chela, for your willing hands. I give you peace. I AM SANANDA and I am ever with you. Amen.

[Quoting Sister Charlotte:]

There was no place safe from her appearance and no limit to that which she would put upon us. And she could make us do anything she wanted us to do.

Even into the laundry rooms which were already as bad as you would think it could be, she would come. I might be down in the laundry room—let me tell you of the laundry room. Doing the type of laundry required of us was hard indeed, for the things we would wash were very heavy and the water would be sloshed out on the floor, which was of cement, and oh, it would be such a mess. And then, here would come the Mother Superior, who to me was the same as turning loose a lion who is very, very hungry. I was scared to death of her and every time I saw that woman somebody had to suffer. Everyone is terrified of her and she knows that we are afraid of her because she is cruel. I have hardly the heart to tell of it. Anyway, here she would come and there we are washing, and as we would hear her footsteps approaching and even before we would see her, we would wash a little harder.

When she gets down to where we are, she might address me and say, “You come out here”. I’m out there like a flash because I am indeed scared. Then she would say, “Prostrate yourself down there and make a given number of crosses on that floor.” It is a cement floor and of course I must prostrate my body and lick those crosses. Those are not little tiny crosses—as far as I can reach, I have to lick those crosses. And she watches my countenance and if I appear to not like it, she might double the number to ten or twenty-five or more. The very next morning she may walk through again and because she saw something in my face which made her believe I didn’t like what she had caused me to do, she will probably call me again. My tongue will be entirely sore and bleeding but I will have to lick the crosses again.

They will also compel you to crawl the distance of a cathedral isle, perhaps ten times or more. It will not be on a soft carpet, it will be on a floor of cement or gravel. You cannot crawl on your hands and knees but upright, on your knees only. I might be able to make it only the first six times and then my strength will fail and faint. She will pour water on me and require that I crawl again. Most often, she will do this again the following day. By this time there will be scabs on my knees and open wounds and blisters. But I must crawl again for penance, for failure is ever so much worse. Dear ones, this is the life of little nuns in a cloistered convent.

Then we are led to believe that God is looking down out of heaven and smiling his approval as we suffer. They tell us that God is made happy through our suffering because they have convinced us we are heathens and there is no way for us to know any better.

We have never been allowed to have a *Bible*. We have never had any scriptures—the nuns are totally ignorant of the words of God. We are raised exactly as the traditional Roman Catholic Church demands of us. We have no way to know about the lovely Gospel of Jesus Christ—and so, we have to do these things, for the penalties for not doing them are so heinous that a little frail and battered nun cannot live through the ordeal. Oh, the burial vats are filled with little bodies and skeletons of the little ones who couldn’t endure the torture.

The Mother Superior might walk through our cell doors, and by the way, there is nothing in there except the Virgin Mary holding the baby Jesus and there is the crucifix. Then there is a prayer-board. By the way, I’ll assure you folks that you don’t want to kneel on our prayer-boards. We kneel on it every day if we are able to walk under our own power. It is a board which is very short and very narrow with sharp wires coming up through it. Then the board upon which I will prostrate my arms also is covered with sharp wires. Well, I told you that we were going to suffer and do penance and this was a required portion of that suffering and penance.

As I lean on that prayer-board I am praying for lost humanity and I am believing, as I suffer, that my Grandmother, for instance, will be released from purgatory sooner because of my suffering. I would linger there longer sometimes, because I fully believed every moment would cause her to reach heaven sooner. That is all that little nuns know, for that is all we are taught.

Every night we are locked within our cells. Every night the key is turned in those doors and there is no way to get up and come out of those cells. More than that, the lights are out at 9:30 and then at seven minutes to twelve two little nuns unlock all of the doors and every little nun gets up, dresses in full dress, goes into the inner chapel and there we again pray for one hour for lost humanity. We get very, very little sleep and we don’t get enough food, so our bodies are weak and sore and broken. We simply don’t have enough strength to carry on after living there for a while. Little nuns have very short lives, for their physical beings cannot endure the deprivation.

WE BELIEVE

We are taught to believe that as we spill our own blood, through torture or in any way that I spill blood by whipping or tormenting my body in any way, I am taught to believe that I will have one hundred less days to spend in purgatory. We have no hope; there is nothing to look forward to. After you live in a convent for ten years, you learn to realize that the Virgin Mary is just a piece of metal—a statue. I began to realize that St. Peter is just a statue. I began to realize that the statue of Jesus is just a piece of metal. In other words, we come to the place where we believe that our God is a dead God. I assure you, I lived in a convent long enough, not at first but after a few years, when we have spilled our tears and blood at the feet of those statues in prayer and no prayer, oh, we realize that we have a dead God and so it goes. So, these precious little girls are taught to believe that as we whip our bodies or torture them and spill blood, that we will have one hundred less days to spend in purgatory. We believe in a literal purgatory and that literal purgatory is a fire which is going to burn and we will feel the flames of that fire.

When I say that nuns are forgotten women—just who do you think is going to say a prayer or pay the priest to have a high mass for those nuns who are in a convent? Why, when those little nuns die, no notification what-so-ever is given. Even the parents will not know when those little bodies are gone, so who is going to pray us out of purgatory? Who will buy our way out of purgatory? Oh, we realize after we are in there for a period of time that there is no purgatory. The only purgatory the Catholics have is the priest’s pockets and the people fill his pockets with coins in order to pray for their dead.

There are thousands and thousands of Roman Catholics. In the month of November the Roman Catholic priests praying masses for the dead of the Roman Catholic people in the U.S. collected \$22 million. These were just for masses said for dead Roman Catholics in one month in your country. This is just to give you an idea of that which is going on every day right in front of you behind the lies and hidden crimes.

Thousands and thousands of mothers have worked their fingers to the bones to go to the priest and give him \$5 to say a mass for a loved one who she believes to be in purgatory. This is because that little mother believes there is a purgatory.

In the convent there is a painting of purgatory. There is nothing else in the room except that painting and it is terrible. Every Friday we have to walk around that painting and when we walk around it, I wish you could see the little nun’s faces. What is on the painting? As you walk around it, it looks like a deep, bottomless hole out there and there are people falling in and already fallen in and the flames are lapping around the bodies of those people. Their hands are outstretched and the Mother will say to the little nun, “You better go and put another penance on your body. Those people are begging to get out of that fire.” Because we believe we are heathens, we don’t know any better.

I might go some place in the convent and maybe I’ll burn my body really bad, or torture it in some way to spill some of my blood because as I suffer I believe they are going to get out of that place where a priest put them. We are told there are millions and millions of people in purgatory that your own priests have put there by the word. When you finally know, you realize it is the biggest fraud in the world. He knows there is not a bit of truth to it. And bless your hearts, I say that if you take purgatory mass away from the Roman Catholic Church you will rob her of nine-tenths of her money and body—she would starve to death.

The Roman Catholic Church commercializes not only off of the living, but off of the dead as well. On and on it goes and even after ones involved become aware, there is no likely way to break away into freedom. Very few dare to ever break away and in the prisons of the convents and monasteries—there is no way to escape.

BACK TO THE MOTHER SUPERIOR

It does not bother the Mother Superior to take one of those little girls to the Father Confessor. Once a month we go to confession and the priests come into the convent as our Father Confessor. We don’t want to go in there; oh, we don’t want to go in there. I may not know the particular man who is out there but I know he is a priest. I know those priests who come, for I have been there and lived there long enough and have had contact with every one of them and know them all and I don’t trust a single one of them who come into the convent. I know not about other places or other priests, remember, I am only telling you about that which I have experienced and know to be the truth.

We know something about what is out in that room and we know that today we are going to go to confession. It may take all day long. Then as we wait, here comes the priest. I have never witnessed the priest coming into the convent without intoxicating liquor under his belt. And I say to every man or woman, whoever you might be, if you get liquor under your belt you are not a man and neither are you a woman—you become an animal and a beast.

And so, we have a beast sitting out there with a straight back, hard bottom chair and no other things except the crucifix and the Virgin Mary. And here he is, sitting right out there in the middle. Now, the little girl has to walk out there all alone. She has to kneel down to that terrible man and as I look back, I am sure in my heart that he was a twin brother to the Devil himself. He is so full of sin, vice and corruption. You must go out there and kneel down before that man and I tell you, you are a lucky girl if you get away from that man without being destroyed.

Why, he is a drunken beast and not a man. He has a holy habit on and he is an ordained Roman Catholic priest—but he is a being of Satan. I assure you we do not like to go to confession but we must go once a month. Those little girls can’t help themselves. Nobody comes out of that room but the priest and I, until it is all over, and then we come back and the next will have to come. I assure you, we don’t appreciate that day and those little girls don’t know any better and there is nothing they can do if they did know better. The *Bible* was a forbidden book to every one of those little girls so they had no way to know anything. Therefore, they are totally trapped by the Devil himself with no way to escape and no way to reach out for help. Do you realize, dear friends, we are the only help they have?—that we somehow tell you of the truth and you will spread this truth and then someone will do something to stop this torture and set the little innocent beings free. Oh, pray for them, I beg you, pray for them that God can work through you ones to save these little beings.

PRIESTS IN THE CONVENT

If a Roman Catholic priest comes into the convent, he may go to the Mother Superior and ask her to permit him to go into the cell where the nuns are. Now that Mother has a carnal mind and a carnal heart and she is very hard and very carnal. Further, she is, many times, the mother of many illegitimate babies and they belong to the priest. You know, she will take that priest who is drinking—they bring liquor right in with them, and sometimes the Mother and some of the nuns drink with them. It is a terrible place, it is certainly not a religious place as you would give that name. She will bring that priest into one of our cells and here you have a big man who is strong from being well fed and he is full of liquor and there is a little nun who is frail with a broken body and she will not have very much strength.

Now why has he come into that cell? For nothing except to destroy that little nun. I often wish the government could walk into that place just as a

priest is let into a cell. The Mother will turn the key and the little girl is locked in there with that priest. There is no way to defend ourselves.

I am a nurse and I got my training by going through the underground tunnel into the hospital while I lived in an open order convent. But may I say that if you could look upon the body of that little girl after the priest is taken out of there, she looks like something thrown out into a hog pen and a half dozen old sows have maled that little body.

This is convent life and I can certainly understand why your priests are calling and complaining constantly and screaming their head off because I am giving this testimony. May I say to you that I don't mind if they continue to scream, I don't mind what they do to me, for I am not one bit afraid of them and I will continue to give this testimony for as long as God gives me strength. I will give this testimony to my life's end regardless of what that church or those priests and prison-keepers do to me in your country. I know what I am doing, I know what I am saying and I am no longer afraid of anyone in all of this world, for I am a child of God and God will allow my work to be finished whether I am killed or whatever might be in store for me. All you can do is murder me and then I care not what you do with my body after I am gone, so I will continue until I have no more breath with which to speak—and then someone will perhaps pick up the message and carry it forth—God will see to it. I know that God saved me and brought me out of that place to do what I am doing—pulling the cover off of the convents.

I believe he saved me to uncloak these places of evil hiding under the cloak of religion. I believe this with all of my heart and soul.

GIVING TO THE PRIESTS

You know, we were only supposed to give our bodies to these priests and many times the nuns are simply overpowered. But what if I refuse to give my body to the priest? He becomes furious and goes immediately to the Mother Superior and then, friends, when two carnal minds come together they can induce things that you and I have not enough evil in our hearts to even conceive. There is not enough sin in our lives to invent such things as they come up with to reap upon those poor little children of God.

When those two carnal minds come together, the next time they are all ready. The Mother Superior might say to me the next day that we are going to do penance. Now, the penance will be something the priest and Mother Superior have invented together. It will be very, very cruel. They may take me down into one of the dirty dungeons where there are no floors and you will find a room with a log about three feet long with a mound of cement with a ring sticking out of the ground. There are leather straps fastened there and they will put my feet through those rings and then strap my ankles securely. There I am, standing with my feet strapped to those rings—and they leave me there locked up in that place by myself. It is a dreadful place and I might stand there for two or three hours if I have strength enough in my body. Sometimes you become too exhausted to stand and you faint and you go down. But when you go down your ankles are turned over and then you cannot get up again. You might lie in that position for two or three days without anyone even coming near. There will not be a bite of food or a drop of water but you must stay there with the vermin and rats running over your body.

Of course no priest outside wants this—nobody outside wants this and they will do anything to make sure no one ever escapes alive from a convent. They will do anything to prevent anyone getting out to tell. Oh, it is terrible. Sometimes while lying strapped to those rings the priest will have his way and then the little nun will be left to lie in the suffering in the added shame and guilt.

Sometimes when a little nun refuses a priest he goes mad with anger and will beat the child and knock her to the floor and kick her—often times he will kick her in the stomach and very often the little nun will be carrying a baby created by one of the priests. It doesn't matter to the priest that there is a baby under your heart—he doesn't care, for he knows the baby will be killed anyway. What can they do with babies born in places like that under the cloak of a religious order?—they can't be allowed to survive. Most of the babies are born premature and many are abnormal from the abuse and weakness of the mother. Very seldom do you see a normal baby. Oh yes, I shall continue to confess this and give my testimony until my last breath to stop this.

I am a nurse and I have delivered these babies and watched the little bodies wreaked with pain and the little nuns will bleed and many die and the babes are twisted and malformed and the agony is so great. This goes beyond anything the human mind can bear. I shall go before the courts and cry out and some of you will hear me and some day you will cause those convents to be opened and then you will see and know of the horror in those places. I have been before the highest courts in your country and I know what I am doing and I know what I am saying because I have been connected with this awful system for 23 years behind convent doors.

BABIES BORN

Most of you little pregnant mothers have everything all ready for that tiny little bundle of joy. You are eager to bring forth a little child and you get everything all ready for its coming—that precious little immortal soul is going to be born into your home. Oh, but you should see that little pregnant nun—there is no joy in that place. The little one will never have a blanket about its body. It will never have a bath. It will only live at the most, four or five hours and then the Mother Superior will take that baby and put her fingers into its nostrils and cover its mouth and snuff its little life out. If the babe is what you would call perfect, then it is dealt with in a more horrible manner as a sacrifice. Either way the little life is snuffed out quickly.

What is then done with those little bodies? There are lime pits in those convents. The baby will be killed and it will be put into the lime pit and the lime will be put over its body and that is the way the baby's life ends. Oh, it is so hard to think about it and that is why I challenge people to pray. Ask God to deliver these children from behind those convent doors. Pray to God that every convent in the United States be opened and require the government go within. When the government goes in and the public goes in also, then you will have the nuns being brought out and the convents closed up.

They opened the convents in Old Mexico in 1934. There are no more of these convents in Mexico. Every cloistered order was opened and they found all this corruption. The lime pits are there—everything is there to be seen. If any of you are traveling and can, go over into Old Mexico and see for yourselves. The government took them and now owns them and they are public museums. Go through those convents and look with your own eyes and touch the things with your own hands and then see whether or not you believe my testimony.

It will fill every drop of blood in your brain—it will do something to you that you cannot imagine—go through them. Go look at them and go through the dungeons, go into the tunnels, go to the lime-pits, look at the rows of skulls along the walls and then ask the guides where they all come from. Go see all of the devices of torture they use to inflict the horror upon the bodies of the little nuns. Go into the cells and look at the beds and see for yourselves. Oh yes, you can go—it will cost you twenty-five cents to go through one of them. Go see for

yourself and then come home and maybe it will give you a greater burden to pray for the saving of those little girls that have been enticed behind convent doors by the hierarchy of the Roman Catholic church.

I wonder how you would feel if this was your child. And remember, I had a mother and daddy and they loved me just as much as you love your children. When they let me go into the convent they were happy, they had no way to know this is the way it is. They never dreamed in their wildest imaginings that a convent would be like this.

There is a room, for instance, built for a specific purpose and suppose you are watching and they bring in a little nun who has been accused of doing something. There is a little partition there and a little lever there that when pressed a cover opens and there is a deep, deep hole underneath. It doesn't matter what she has done, if anything. But she had done something and it must be very serious. They bring her now to this particular place. Her hands and feet are bound securely and they drop her into that horrible, horrible pit. Then they are going to put the boards back down and no-one will ever know, for there is plenty of chemicals and lime down there. But it is not that quick and easy. Six little nuns have to walk around that hole and we chant as we walk around that hole, for we mustn't let any evil spirits to come out into the convent. So we sprinkle holy water over that hole. We may walk for six or more hours and then there will be six more nuns and on and on it goes until the last moan is heard from the pit and that is the end of the little nun.

Does it bother you to know that little nun is dead and lost and will never be delivered out of that convent except through this horrible manner? Does it bother you? Does it bother you enough to speak out? It bothers me and it breaks my heart. You who are Catholics—does it bother you? My God who is within—please hear us and do something! [END QUOTING]

1.5 MILLION TAKE TO THE STREETS IN ITALY TO PROTEST BUSH WAR PLANS

ROME (*UPI*)—More than 1.5 million Italians took to the streets of dozens of cities Saturday afternoon and evening to protest possible U.S. military action against Iraq—a surprise show of discord that could be fervent enough for the Italian government to re-think its support of Washington.

The larger-than-expected protests took place without violence, despite speculation from some fronts that the gatherings could become dangerous, especially to U.S. citizens. On Friday, the U.S. Embassy in Rome circulated a warning to citizens residing in or visiting Italy to stay away from the demonstrations because of fears that they could become targets for violence.

But even though the protests were peaceful, demonstrators made it clear that they opposed U.S. action against Baghdad. The stance is significant because up to this point, Rome and London have been President George W. Bush's strongest allies in Europe.

Most European leaders—most vocally France's Jacques Chirac and Gerhard Schroeder of Germany—have called on diplomatic means to diffuse tensions between the United States and Iraq.

“For several weeks, Italians have been saying that they are opposed to action against Iraq, but this is the first time they have put those words into action,” Maria Rossi, co-director of the polling firm Opinioni, told *United Press International*. “The site of thousands of Italians on the streets protesting against the potential war in Iraq has to be a sobering sight for government officials who will need public support for other issues.”

Government officials were not available for comment on their stance on U.S.-Iraq relations on Saturday, but local television drew the same conclusion as Rossi.

“If the government can ignore this... it can ignore anything,” said one on-the-scene journalist for the network *La 7* in Milan. “On this day, the Italian people have spoken... and they say they are against support for the American position.”

Opinion polls support that view, with a week-old survey from Opinioni showing that more than two out of every three Italians opposed any armed conflict over Iraq, and nearly four out of five Italians opposed to Italian participation in such action unless it was as part of a United Nations-sponsored force.

Most of the anti-war demonstrations took place on Saturday morning, with the biggest of those in Milan, drawing a crowd that police estimated at between 60,000 to 100,000 people.

Signs in the crowd showed Bush's head on the body of a hawk—a reference to the president's hawkish stance toward Iraq's Saddam Hussein—and others that showed Italian Prime Minister Silvio Berlusconi and British leader Tony Blair as Bush's pets, referring to their support of U.S. policies. Other large morning rallies took place in Bologna, Florence, Naples and Palermo.

But the day's biggest march was held in the evening in Rome, where police said as many as 200,000 people gathered in protest.

“Our point is that we cannot support the United States's plan to kill innocent Iraqis in order to win the upcoming (Congressional) elections,” Marco

Filiberti, 38, a protester who came to Rome with six friends from the nearby city of Latina, told *UPI*.

Claudia Bacigalupo, 24, a teacher from Rome, said she hoped the day's unexpectedly large rallies would convince the government to backtrack on its support of Washington.

“We cannot control what the United States does, but we can tell them that if they want to march into Iraq they will have to do so without the support of the Italian military,” Bacigalupo said.

Whether that will be the case or not is unclear. In the past, Berlusconi has paid only limited attention to public opinion—which, combined his eagerness to support Washington on a variety of issues—might make a change of plans unlikely. But pollsters say that because of the support the government will need to address an array of domestic issues, the public's view on Iraq could create a degree of doubt about the course the prime minister has chosen.

“Over the coming months, the government will try to pass a so-far unpopular budget, revisit controversial labor reform legislation and start to tackle painful pension reforms,” Rossi, the pollster, said. “With the economy weakening, the government may have to pick its most important battles... (and) what we don't know is whether Iraq is one of them.”

The United States has taken an aggressive stance against Iraq—including calls for Hussein's government to be toppled—on fears that the Iraqi leader is building an arsenal of nuclear, biological and chemical weapons.

RUSSIA FEARS U.S. OIL COMPANIES WILL TAKE OVER WORLD'S SECOND-BIGGEST RESERVES

Washington—Oil companies from around the world are manoeuvring for the multibillion-dollar bonanza that would follow the ousting of Saddam Hussein.

Russia is so concerned that it has been holding secretive talks with the Iraqi opposition to shore up its economic interests in the country which still owes Moscow \$7 billion from Soviet times.

With the second-biggest reserves in the world, Iraq's underdeveloped oilfields have become a key negotiating chip and a backdrop to talks between the U.S. and the other permanent members of the UN Security Council—all of which have major economic stakes in regime change in Iraq.

It has also given fuel to critics of America's war plans who say the desire for regime change is at least partly driven by economics.

Oil industry experts say there is growing concern that America would dominate the Iraqi oil industry after Saddam. As a result, a number of oil companies have reportedly held talks with the Iraqi opposition to ensure they are involved in any future deals

The Independent has learnt that the Russian government—which is friendly towards Iraq—recently dispatched a diplomat to

hold talks with a senior official from the Iraqi National Congress (INC), the U.S.-backed opposition umbrella group. At that meeting in Washington on 29 August—the first for seven years—the diplomat expressed worries that Russia would be kept out of the oil markets by the U.S.

James Woolsey, a former director of the CIA and a commentator on the relationship between oil and global security, told the *Washington Post*: “It's pretty straightforward. France and Russia have oil companies and interests in Iraq. They should be told that if they are of assistance in moving Iraq toward decent government we'll do the best we can to ensure the new government and American companies work closely with them.

“If they throw in their lot with Saddam it will be difficult to the point of impossible to persuade the new Iraqi government to work with them.” Iraq has confirmed oil reserves of 112 billion barrels, second only to Saudi Arabia, with perhaps double that in undiscovered reserves. With sanctions in place, the current production is just 2.8 million barrels a day—a capacity it struggles to reach because of deteriorating equipment.

Under the United Nations' oil-for-food programme, it exports about one million barrels a day. Since 1998, two subsidiaries of Houston-based Halliburton, the company previously headed by the U.S. Vice-President, Dick Cheney, have done \$24 million (£15.3 million) of business to repair Iraqi oil pipelines under the UN programme.

Experts say that given sufficient further foreign investment, Iraq could be producing a total of 6 million barrels a day within five years, making it the world's third biggest producer behind Russia and Saudi Arabia.

But which companies will benefit from these rich pickings? Since the end of the Gulf War, companies from more than a dozen nations—including Britain—have had discussions with Iraq about developing oilfields. In 1997, Russia's Lukoil negotiated a \$4 billion deal to develop the West Qurna oilfield while last year another Russian company, Slavneft, signed a \$42 million (£27 million) deal to drill in Tuba.

The French TotalFinaElf company has negotiated the rights for the vast Majnoon oilfield, which is near the Iranian border.

It is unclear whether such deals would be honoured by a post-Saddam Iraqi government. Faisal Qaragholi, an official with the INC, said that all such deals would be reviewed. “If the deal [helps] the Iraqi people then it will be carried on, if it does not, it will be renegotiated,” he said.

The INC's chairman, Ahmed Chalabi, believes the U.S. should head a consortium to develop Iraq's oil. “American companies will have a big shot at Iraqi oil,” he said.

Such comments horrify the Russian government, which as a major oil exporter has much to lose should America assume a dominant position in Iraq's oil industry.

Thane Gustafson, senior director with the Cambridge Energy Associates (Cera) consultants, said the issue was almost certainly a factor in Russia's negotiations with the U.S. about a new UN resolution over weapons inspectors. “Oil is bound to be on Putin's mind because of the importance of oil exports,” he said. “It's bound to worry Putin. He would probably prefer things pretty much as they are now.”...

“He told me that he had been told that if the Americans overthrow Iraq they will not let the Russians do business in Iraq,” he said. “We have seen this in the Balkans. He wanted to say that Russia's dealings with Iraq are based on historical and economic relations, not on relations with Saddam.”

The importance of Iraqi oil is also to be discussed next week at a U.S.-Russian energy summit in Houston at which more than 100 U.S. and Russian energy companies are expected to be represented.

In this environment, it is likely that most leading oil companies are actively trying to position themselves to operate in Iraq if Saddam is overthrown. The U.S. oil giants ExxonMobil and ChevronTexaco both refused to say

whether they had been holding talks with Iraqi opposition. Both said, however, that they would be interested in operating in Iraq if sanctions permitted.

A spokesman for Royal Dutch Shell, the British-Dutch company which held discussions with President Saddam about developing the Ratawi oilfield several years ago, said it had not approached the INC. But if sanctions were lifted, the company would be interested in dealing with Iraq, he said.

James Lucier, an oil analyst with Prudential Securities, said: "There's no real upside for American oil companies to take a very aggressive stance at this stage. There'll be plenty of time in the future."

GUNNIN' FOR HUSSEIN

The debate over a possible attack to overthrow Saddam Hussein usually brings lofty philosophical, strategic, political and humanitarian arguments about what the right course of action is for the good of the world. Washington vows to defend itself and its allies, saying a dangerous tyrant stocking up on weapons of mass destruction should not be allowed to survive.

From other world capitals comes the reply, arguing that the world's only superpower should act only with the legitimacy granted by the United Nations, if at all. It's all about good versus evil. About international stability, about preventing a future catastrophe—one caused by Baghdad or Washington, depending on your point of view.

Behind the arguments, however, is a plethora of individual nations' interests guiding the positions of their leaders. Each country sees the world from its perspective, and each leader thinks of political survival.

Several leaders have staked their political future on their position on the Iraq question, but perhaps no one has done so more than German Chancellor Gerhard Schroeder. ...

German politicians understand their voters' views on war. "Germany, in general, has a pacifist culture," said Christian Tuschhoff, an expert in German politics at Emory University. Since World War II, he said, there is a notion that the country "should not become guilty again for the disasters of the world". The view is that war should occur only under very strict conditions requiring international legitimacy.

Many in Europe share that reluctance to go to war, partly as a result of the continent's experiences with that devastating mid-century conflict.

"There's no question that both from the countries that won the war and those that caused it," Tuschhoff said, "there is the knowledge that war is extraordinarily destructive. There is still suffering today from the consequences of World War II."

The concerns are not all humanitarian, however.

Iraq possesses enormous oil reserves, and the potential for profit has not escaped world leaders. France has a long history of strong commercial ties with Iraq. For decades France was a major weapons supplier to Iraq. The infamous Osirak nuclear reactor, destroyed by Israeli bombs in 1981, was being built by the French.

During the 1990s, French businessmen could be heard in the lobby of major Iraqi hotels laying the groundwork for future trade. As far back as 1996, Jacques Chirac spoke out against economic sanctions on Iraq, expressing deep concern for the suffering of the Iraqi population. Despite Hussein's continuous defiance of the international community, France reopened its embassy in Baghdad, positioning itself for a brighter commercial future.

Now Chirac, aware of anti-war, anti-American sentiment in his country, has expressed opposition to a unilateral attack but allowed for an international route that could yield regime change. Charles Doran of the School of Advanced International Studies at Johns Hopkins University said France, until recently, had "a very significant" level of trade with Iraq.

But more recently Paris started cracking down on sanctions violators, and Iraq shifted some of its business elsewhere. "That is how the game is played," Doran said. Chirac now recognizes the reality of the situation. Sitting out an American attack could mean missing out on contracts for the reconstruction of Iraq.

The beneficiary of the fallout between Paris and Baghdad was Moscow. Not surprisingly, Russian President Vladimir Putin also has taken a strong stand against an American attack on Hussein. Could a recently revealed \$40 billion trade deal between Iraq and Russia play a part? ...

In the case of Britain, Doran points to Prime Minister Tony Blair's concerns with Hussein's threat, in the context of Britain's role during World War II. Doran said Blair remembers that it was a British prime minister, Winston Churchill, who stood up against Adolf Hitler and feels the responsibility of that historical legacy. Blair has incurred the wrath of millions of anti-war Britons for his staunch support of the U.S.

But his vision of Britain's role in today's world is that of a bridge between Europe and the United States. In this key moment in American foreign policy, Blair is gambling that the role will strengthen his country's international position.

On the eastern corner of the continent, Turkey, a NATO member, has its own concerns. For decades the country has worried about ethnic Kurds living in its southern regions, on the border with Iraq. The Turkish government has long had troubled and controversial dealings with its Kurdish population. The fear now is that an American attack on Iraq would lead to the creation of an independent Kurdistan in northern Iraq. That, Turkey fears, could attract Turkish Kurds to secede and try to join their ethnic brethren as part of a new nation.

In the Arab world there is much fear of a popular uprising if the United States attacks an Arab, Muslim country. The anti-war statements have been almost unanimous, but Doran believes this could all change.

The problem, he said, is one of uncertainty.

Take the case of Kuwait. After the U.S. went to war a dozen years ago to push Hussein's invading army out of Kuwait, the emirate stands in opposition to unilateral military action by Washington. You could say, Doran notes, that this doesn't show much courage or gratitude. But, "suppose that they take a strong position and the U.S. for whatever reason decides to reverse course." The country feels vulnerable.

The same is true of other countries in the region. Doran said a successful U.S. attack—and he believes an attack would succeed—would result in "a substantial shift in the Arab world, in the Muslim world, and even in the part of the public." He does not subscribe to the often-made argument that a war could trigger a devastating social explosion in the Mideast.

Many do believe a social explosion could come. In Jordan, for example, a country with a majority Palestinian population—and an economy dependent on both cheap Iraqi oil and American aid—King Abdullah II expresses grave concerns about the threat of war.

Hussein has worked to position himself as the champion of the Palestinians.

His Scud missile attacks against Israel during the Gulf War were cheered in the West Bank and Gaza, and his generous donations to the families of Palestinian suicide bombers have made him a hero to many. Jordan is wedged between Israel and Iraq. A confrontation between those two countries—a likely side effect of a new war—would place Jordan in the perilous position of facing an attack from Iraq or a stampede of Palestinians from the West Bank. And yet, a successful campaign against Hussein could bring enormous prosperity to the Hashemite Kingdom, as much of Iraq's reconstruction mobilization would travel along the Amman-Baghdad highway.

Saudi Arabia, another beneficiary of the U.S. intervention against Iraq, also worries about social conditions. The country's rulers are vulnerable to the charged rhetoric of radical Muslim clergy, which takes a dim view of American forces on Saudi soil and has no sympathy for America on Iraq.

The regime may resist supporting U.S. intervention, but Doran thinks a successful campaign against Iraq would bring nothing but benefits to the Saudi regime. Some, however, believe that with a rehabilitated, U.S.-friendly Iraq, Saudi Arabia stands to lose its special position as the country that regulates world oil supplies and dominates OPEC policy. Others think dictatorships in the Arab world worry about the possibility of a new democracy in their midst planting the seeds that could eventually end their rule.

[JR: For whatever reasons each nation holds for or against the invasion of Iraq, you can be sure that the U.S. will have covered all issues through our lethal powers of persuasion. U.S. CONGRESSMEN IN IRAQ TO PROBE WAR CONSEQUENCES

BAGHDAD—Three U.S. congressmen arrived in Iraq on Friday to assess the humanitarian situation after a decade of sanctions and urge Baghdad to give weapons inspectors unfettered access to avoid war. "We came over here because we do not want war. We want to see what the circumstances are for the Iraqi people and to see what the consequences of another war might be," Washington Democratic Representative Jim McDermott told reporters at Saddam airport in Baghdad.

McDermott was accompanied by his Democratic colleagues, David Bonior of Michigan and Mike Thompson of California. "Our desire is that Saddam Hussein allow unfettered inspections, we do not want any question about that because we want this to be peacefully and diplomatically resolved," McDermott added.

The U.S. lawmakers had talks with officials at the UN International Children's Emergency Fund (Unicef) and Iraqi Health Minister Umeed Madhat Mubarak to get first-hand information on the health status of Iraqi children.

"It is pretty clear that the situation for children in Iraq had deteriorated over the last 12 years from what it was prior to the Gulf War and the sanctions are having an impact," McDermott told reporters after the visit.

"Those who say that the United States should go to war are simply looking at this issue as though there is going to be no damage done, and I think people need to know what happens to kids in this country," he said.

Iraqi President Saddam Hussein, under intense world diplomatic pressure backed by the threat of U.S. military action, agreed last week to allow UN weapons inspectors back without conditions after an absence of nearly four years.

The United States, whose declared policy is to seek the Iraqi leader's removal, treated the move with disdain, saying Saddam could not be trusted, and vowed to work for a tough new UN resolution on Iraq. ...

McDermott said the United States should try to defuse the crisis with Iraq through diplomatic and peaceful channels. "We want every diplomatic effort made to resolve this without war. We have no interest in having war," McDermott said.

"We want our administration to pursue every avenue before. War has to be the last option and the United States, I think our opinion is, we do not think it should make the first strike ever," he added. He said the U.S. State Department knew about their visit to Iraq.

[JR: Hopefully these visiting congressmen to Iraq are successful in building a major coalition against the Bush administration's push for war. SCORES IN CONGRESS DISSENT OVER IRAQ

WASHINGTON—As the House opened debate Tuesday on a resolution authorizing military action against Iraq, the White House urged lawmakers to deliver an overwhelming bipartisan show of support. But a determined minority in Congress stood firm in opposition, despite facing ridicule and, for some members, the risk of electoral defeat in November.

"There's an attempt to marginalize the opposition and suggest that only a handful of people are voting 'no,'" said Rep. Lloyd Doggett (D-Texas), adding that about 100 House members were expected to vote against the Iraq resolution. ...

On Monday night, Bush declared in a speech to the nation that the United States and its allies must act if Hussein refuses to disarm. ...

Secretary of State Colin Powell, meanwhile, urged lawmakers to pass the Iraq resolution with large bipartisan support, saying it would strengthen his hand at the United Nations.

The United States is trying to persuade the UN to adopt a tough new resolution demanding that Hussein grant UN weapons inspectors unfettered access to sites in Iraq.

Some opponents of the White House-backed congressional resolution want language added that would require Bush to obtain UN approval before ordering an attack on Hussein.

Rep. Jim McGovern (D-Mass.) said he has no qualms about bucking a popular president.

"It came down to what I feel in my gut is the right thing to do," said McGovern, who plans to vote for an alternative resolution that would require UN involvement. "Even if I'm the only one, I can look at myself in the mirror and say I did what I felt was right."

Three lawmakers who traveled to Iraq recently drew the wrath of their colleagues. Reps. Jim McDermott (D-Wash.), David Bonior (D-Mich.) and Mike Thompson (D-Calif.) visited a Baghdad children's hospital and met with Iraqi Deputy Prime Minister Tariq Aziz and Foreign Minister Najji Sabri.

While there, McDermott told ABC that Bush might not tell the truth about Iraq so that he could wage war.

"It would not surprise me if they came up with some information that is not provable," McDermott said. "I think the president would mislead the American people."

McDermott's comments were roundly condemned.

"You can't cavort around with the enemy and be a great American," said Rep. Sam Johnson (R-Texas), a former prisoner of war in Vietnam. He called McDermott's words "unconscionable, unpatriotic, and as far as I am concerned, un-American."...

McDermott, who served as chief psychiatrist to the Navy's 7th Fleet during the Vietnam War, brushes off those who would question his patriotism.

"If people want to try to marginalize me, that's fine. That's because they can't think of anything more intelligent to say," McDermott said. "What's really troubling to me is how much people are unaware of what really is going on here, how much they are being led into believing there's this imminent threat."

McDermott said many members of Congress are following blindly behind Bush.

"The Congress is sending people to die. This is a declaration of war today. This is not just another day at the farm," he said.

In the Senate, some with qualms about Bush's Iraq policy appear to have given in.

Sen. Joseph Biden (D-Del.), chairman of the Foreign Relations Committee, and Sen. Richard Lugar (R-Ind.), one of the Senate's most respected foreign policy thinkers, had planned to offer an alternative resolution specifying that the goal of any action against Iraq would be to eliminate weapons of mass destruction, not to change the regime in Baghdad.

But after House Democratic Leader Richard Gephardt (D-Mo.) and Sen. Joseph Lieberman (D-Conn.) fell in line last week behind the White House-supported measure, Biden publicly acknowledged that the Lugar-Biden plan would fail. Lugar dropped plans to offer the alternative resolution.

Sen. Carl Levin (D-Mich.), chairman of the Armed Services Committee, said he is not concerned about the outcome of the vote even though his proposal is expected to fail too. Levin is concerned that Bush's Iraq policy could affect U.S. relations around the world. His plan would require Bush to work with the UN and would clamp down on what critics call Bush's "go it alone" approach.

"What's important is that there be a real thorough consideration of the doctrine of a pre-emptive strike," Levin said. Tenet's conclusion that Hussein would be more likely to use weapons of mass destruction if attacked is "a relevant fact in terms of unilateral force," Levin added. ...

In the House, Rep. Jan Schakowsky (D-Ill.) said she draws strength from her constituents as she questions whether the nation is prepared for war with Iraq. Schakowsky said she has received about 5,000 e-mails and letters from voters in her district supporting her position. Only 14 people have written to say she is wrong.

She acknowledged that Bush is likely to get the votes he needs, but said: "I have been a lifelong organizer and I have seen the power when citizens exert their rights and their privilege to communicate their will."

Meanwhile, Senate Majority Leader Tom Daschle (D-S.D.) insisted that the disagreements and the debate are what America is all about. ...

FLEISCHER HINTS HUSSEIN HIT OK

WASHINGTON—White House spokesman Ari Fleischer suggested Tuesday that the Bush administration would welcome the assassination of Iraqi President Saddam Hussein by Iraqi citizens, an unusually blunt comment from an official at the White House lectern.

At his regular briefing, Fleischer was asked about a Congressional Budget Office report estimating it would cost \$9 billion to \$13 billion to deploy troops to the region and an additional \$6 billion to \$9 billion a month to fight a war. Fleischer dismissed cost estimates as speculative, because President Bush has yet to decide whether to use military force against Iraq.

"I can only say that the cost of a one-way ticket is substantially less than that," Fleischer said, apparently referring to exile for Hussein. "The cost of one bullet, if the Iraqi people take it on themselves, is substantially less than that. The cost of war is more than that."

Pressed on whether he was advocating political assassination, Fleischer responded, "Regime change is welcome in whatever form that it takes."

Fleischer's unexpected endorsement of the slaying of a foreign leader came as the Bush administration was negotiating in Congress and the United Nations over separate resolutions that Bush hopes will give him broad military authority to attack Iraq if Hussein fails to dismantle his biological, chemical and nuclear weapons programs.

Fleischer later said he was speaking rhetorically. But he added, "The point is that if the Iraqis took matters in their own hands, no one around the world would shed a tear."

Administration officials let stand the impression that Fleischer's comments are in step with White House thinking about Iraq. Officials did not order the spokesman to retract his comments as they did in February, when Fleischer suggested that President Bill Clinton's failed efforts to mediate the Israeli-Palestinian conflict led to more violence. ...

IRAQ REPORT CITED BY BUSH DOES NOT EXIST AGENCY DISAVOWS REPORT ON IRAQ ARMS

The International Atomic Energy Agency says that a report cited by President Bush as evidence that Iraq in 1998 was "six months away" from developing a nuclear weapon does not exist.

"There's never been a report like that issued from this agency," Mark Gwozdecky, the IAEA's chief spokesman, said yesterday in a telephone interview from the agency's headquarters in Vienna, Austria.

"We've never put a time frame on how long it might take Iraq to construct a nuclear weapon in 1998," said the spokesman of the agency charged with assessing Iraq's nuclear capability for the United Nations.

In a Sept. 7 news conference with British Prime Minister Tony Blair, Mr. Bush said: "I would remind you that when the inspectors first went into Iraq and were denied—finally denied access [in 1998], a report came out of the Atomic—the IAEA that they were six

months away from developing a weapon.

"I don't know what more evidence we need," said the president, defending his administration's case that Iraqi leader Saddam Hussein was building weapons of mass destruction.

The White House says Mr. Bush was referring to an earlier IAEA report. "He's referring to 1991 there," said Deputy Press Secretary Scott McClellan. "In '91, there was a report saying that after the war they found out they were about six months away."

Mr. Gwozdecky said no such report was ever issued by the IAEA in 1991. Many news agencies—including *The Washington Times*—reported Mr. Bush's Sept. 7 comments as referring to a 1998 IAEA report. The White House did not ask for a correction from the *Times*.

To clear up the confusion, Mr. McClellan cited two news articles from 1991—a July 16 story in the *London Times* by Michael Evans and a July 18 story in the *New York Times* by Paul Lewis. But neither article cites an IAEA report on Iraq's nuclear-weapons program or states that Saddam was only six months away from "developing a weapon"—as claimed by Mr. Bush. The article by Mr. Evans says: "Jay Davis, an American expert working for the UN special commission charged with removing Iraq's nuclear capability, said Iraq was only six months away from the large-scale production of enriched uranium at two plants inspected by UN officials."

The Lewis article said Iraq in 1991 had a uranium "enrichment plant using electromagnetic technology was about six months from becoming operational".

In October 1998, just before Saddam kicked UN weapons inspectors out of Iraq, the IAEA laid out a case opposite of Mr. Bush's Sept. 7 declaration.

"There are no indications that there remains in Iraq any physical capability for the production of weapon-usable nuclear material of any practical significance," IAEA Director-General Mohammed Elbaradei wrote in a report to UN Secretary-General Kofi Annan.

Mr. Bush and Mr. Blair on Sept. 7 cited an agency "report" declaring that satellite photography revealed the Iraqis had undertaken new construction at several nuclear-related sites. This week, the IAEA said no such report existed.

The IAEA also took issue with a Sept. 9 report by the International Institute for Strategic Studies—cited by the Bush administration—that concludes Saddam "could build a nuclear bomb within months if he were able to obtain fissile material."

"There is no evidence in our view that can be substantiated on Iraq's nuclear-weapons program. If anybody tells you they know the nuclear situation in Iraq right now, in the absence of four years of inspections, I would say that they're misleading you because there isn't solid evidence out there," Mr. Gwozdecky said.

"I don't know where they have determined that Iraq has retained this much weaponization capability because when we left in December '98 we had concluded that we had neutralized their nuclear-weapons program. We had confiscated their fissile material. We had destroyed all their key buildings and equipment," he said.

Mr. Gwozdecky said there is no evidence about Saddam's nuclear capability right now—either through his organization, other agencies or any government.

EU GIVES U.S. TROOPS IMMUNITY

The European Union has allowed member states to reach bilateral agreements with the United States, giving American troops limited immunity from prosecution by the International Criminal Court (ICC).

Such deals will be permitted provided certain conditions are met such as granting immunity to diplomats and soldiers only.

There is no concession. There is no undermining of the International Criminal Court, said Per Stig Moeller, Danish Foreign Minister.

The decision was announced after a meeting of EU foreign ministers in Brussels on Monday.

The Bush administration has argued that U.S. citizens must be protected from hostile governments prosecuting them for political reasons, and has approached EU and other states to secure immunity agreements for American troops.

Twelve countries—mostly small or poor—have signed such deals so far, promising not to hand over U.S. citizens on their territory to the ICC.

Danish Foreign Minister Per Stig Moeller said immunity agreements will be allowed if a number of "red lines" are respected.

First, they should apply only to soldiers or officials sent abroad.

The ICC would replace individual war crimes tribunals.

Then the Europeans want a guarantee that Americans accused of war crimes and crimes against humanity will be dealt with by American courts.

Finally, agreements should not be reciprocal: citizens of the European state involved would not be similarly protected.

Correspondents say this position is an attempt to bridge the gap between the U.S., which wants to ensure that none of its citizens is ever prosecuted by the new ICC, and the Europeans, who want to strengthen the court's credibility.

Human rights campaigners have accused Britain in particular of being ready to undermine the court, rather than have a serious clash with the U.S. Mr. Moeller denied this.

"There is no concession," he said. "There is no undermining of the International Criminal Court."

However his German counterpart, Joschka Fischer, made clear he had wanted a clear rejection of the U.S. demand for blanket immunity.

"We did not get that, but we came very close to it," he said.

[JR: Well the U.S. stonewalled the EU and got what it wanted. Unlike Europeans, U.S. soldiers and diplomats have "partial immunity" which is a compromise that can go a long way for us. UN SEAT QUICKLY A HOT ONE FOR MEXICO

MEXICO CITY—In world affairs, Mexico has always preferred to profess neutrality, non-belligerence and, most of all, independence from the United States. But with Mexico's stand on Saddam Hussein suddenly of crucial importance, the government of President

Vicente Fox finds itself in uncharted waters as a vote on Iraq looms in the United Nations.

Holder of one of 10 rotating seats on the UN Security Council, Mexico is under tremendous pressure to show solidarity with President Bush. That was the message delivered Monday when Foreign Minister Jorge Castaneda met with Secretary of State Colin Powell in Washington.

Fox and his diplomats have expressed reservations about U.S. intentions toward Iraq, and many Mexicans are suspicious of U.S. military action. Whatever he does, according to analysts and aides to Fox, the Mexican leader will have to tread carefully. ...

Fox's dilemma is his own doing: Since taking office two years ago, he has set out to make Mexico a player on the world stage and used his activism and advocacy on issues such as human rights to reinforce his reform efforts at home.

Fox's controversial decision to take the UN seat and end Mexico's isolation was part of that campaign.

"We can no longer play the comfortable, non-committal middle. Those days are gone," said one Mexican official, adding that Mexico could not "afford" to vote against U.S. action on Iraq if there is a UN consensus on it.

"Forget about the U.S. It's more about what we are trying to do in the international arena. We will have to take our hard hits back home, but this is a signal that Mexico is playing a serious role on the world stage," the official said.

In the unfolding UN debate, Mexico has publicly leaned toward France's stance that Iraq should be given a timetable to comply with renewed weapons inspections before the UN considers military action. The U.S. wants broader authorization to launch an offensive. ...

The dilemma Fox faces back home was made apparent when his UN ambassador, Adolfo Aguilar Zinser, wrote a column in *Reforma* newspaper last Friday saying that Mexico should remain true to its historic principles and could cast a dissenting vote without antagonizing the U.S.

Last week, Castaneda was grilled on the UN vote by opposition lawmakers, who repeated criticisms that Fox has harvested nothing from his efforts to court the U.S. With midterm congressional elections scheduled for next year, they are not criticisms Fox can ignore.

Reflecting opinion elsewhere around the globe, many Mexicans complain that the U.S. has done a poor job of explaining its intentions on Iraq. ...

The debate also might tempt Mexican officials to seek some kind of promise from the U.S. to reopen discussion of immigration changes. Fox made those reforms a central plank in his agenda and has expressed frustration that the U.S. has paid them little attention since the Sept. 11 terrorist attacks. ...

But the Iraq vote gives Mexico some leverage with the United States, and Mexico has tried such horse-trading in the past on Cuba and other issues. Officials said the immigration issue was discussed at the Powell-Castaneda meeting Monday. ...

[JR: What a stroke of luck for us that Mexico, our trading partner and neighbor, just happens to sit on one of the rotating seats on the UN Security Council. Talk about timing being everything, as to fitting into our orchestrated plans to influence the council's wording on the UN resolution as pertains to inspections in Iraq. We want the wording to reflect our strong position and opinions so that Iraq will not have any other recourse but to concede or face destruction. The speculation is that the U.S. is cooking a deal with Russia that the U.S. will look the other way should Moscow find it expedient to invade Georgia or the Republics to clear the area of terrorists. It's a devious game we are playing with the world, while spinning our web of dominance in all its affairs.]

ISRAEL KEEPS ITS PRESENCE IN RAMALLAH

RAMALLAH, West Bank (AP)—Israeli forces were positioned in at least two buildings overlooking Palestinian leader Yasser Arafat's battered compound Tuesday, underscoring Israel's insistence that wanted Palestinians still inside must surrender despite the hasty pullback of Israeli tanks from the site this week. ...

Israeli tanks crashed into the compound Sept. 19 after a suicide bombing that killed six people in Tel Aviv. The Israeli forces lay siege to Arafat's building and demanded the handover of a number of men who were among the 200 inside with the Palestinian leader. The UN Security Council and the United States demanded the siege end, causing Israel to retreat Sunday from the compound's immediate vicinity.

Palestinians saw the pullout as a significant victory, and Prime Minister Ariel Sharon—who returned Tuesday from a two-day trip to Moscow—came under scathing criticism from Israelis across the political spectrum for not having foreseen the operation would lead to an ignominious dead end.

But on Tuesday, Israeli Defense Minister Benjamin Ben-Eliezer said the "blockade" was continuing, though from a greater distance, "to allow a certain amount of inspection so that Israel can put its hands on all those inside who are suspects if they try to come out."

Israeli troops were seen on the roof of the eight-story Palestinian Ministry of Culture building, about 500 yards from Arafat's office, and on the roof of another eight-story building under construction. They were also seen at least briefly in a nearby house. The army said it could not comment on deployments. When troops took over the house late Monday, Palestinian security sources said snipers were posted there, but these could not be seen Tuesday.

It was not clear whether any of the wanted men had left the building during the recent days' rush of visitors entering and leaving. ...

On Tuesday, ministers and other Palestinians fumed at the new U.S. legislation that encouraged recognition of Jerusalem as Israel's capital, warning that it would complicate peace efforts and could cost lives.

Cabinet Minister Saeb Erekat said President Bush's signing of the bill Monday "undermines all efforts being exerted to revive the peace process and put it back on track." He called it a "flagrant violation" of agreements signed by the United States and Israel to negotiate Jerusalem's permanent status.

Bush has said he doesn't consider the bill's provisions on Jerusalem to be binding.

There was no Israeli reaction to the bill, in which Congress specified for the first time that no funds may be used for the U.S. Consulate in Jerusalem unless it is under the supervision of the American ambassador to Israel. The consulate reports directly to the State Department, not the U.S. Embassy in Tel Aviv, and has served as the United States' unofficial embassy to the Palestinian Authority.

The bill also said no money could be spent on official U.S. documents that listed Israel without identifying Jerusalem as the capital.

Israel captured East Jerusalem and its sites holy to Jews, Christians and Muslims in the 1967 war, annexing it. The current government sees the entire city as Israel's capital. The Palestinians claim East Jerusalem for their own capital. ...

[JR: The standoff at Arafat's headquarters is a pause just before Israeli troops move in and storm the building to get at the "suspects" they have targeted as terrorists. Israeli troops are positioning themselves and are poised and ready to move in a moment's notice despite U.S. and UN opposition against such actions. This is a long-planned

operation to get rid of Arafat and his cabinet and to deny the Palestinians a government. Next move will be to set up a government who will be more compliant to Israel's plans. Pres. U.S. COMMANDOS HAVE SPECIAL SKILLS—
AND PHILOSOPHY

News reports said the U.S. Special Operations Command would take the lead in most future operations against international terrorists, that a Special Forces guard killed a would-be assassin of Afghan President Hamid Karzai, that Special Operations Forces were being moved to combat terrorists in East Africa, that they were training others to do so in Georgia and Yemen, and that they were assisting in the capture of top al-Qaida leaders in Pakistan. ...

Who are these Special Operations Forces, and why are they becoming so critical in the war against terrorism? Can they take the place of regular Army or Marine forces? Are they just a current fad? What makes them so "special" anyway, and what role do they play in defending America? These and other questions are likely to dominate military thinking for some time, especially if the war on terrorism lasts as long as President Bush has indicated.

Although prominent in the current war on terrorism, special operations are really nothing new. Over 2,100 years ago, Judah and Jonathan Maccabee succeeded in restoring and purifying the Temple in Jerusalem after their ambushes, raids and night operations against superior Syrian forces. Likewise, during the American Revolution, Francis Marion, the "Swamp Fox", led guerrilla forces in widespread ambushes and raids against superior British forces in the American South. During World War II, the Special Operations Branch of the U.S. Office of Strategic Services organized sabotage and guerrilla warfare in North Africa, France, China, Southeast Asia and elsewhere.

The modern Special Forces began during the 1950s, but the Army restricted their role until Maj. Gen. William Yarborough, with the support of President Kennedy, authorized them to wear the green beret and expanded their operations during the early phases of the Vietnam War. ...

In 1980, eight American servicemen were killed during Desert One, a failed attempt to rescue American diplomats in Iran. In 1983, a terrorist killed 241 military personnel when he blew up the Marine barracks in Lebanon. Something needed to be done.

The answer came from two directions. First, the Special Operations Command was activated, with a four-star general commanding integrated Army, Navy and Air Force units. The command today oversees 47,000 active and reserve SOF personnel, including five Army Special Forces groups, a Ranger regiment, an Army aviation regiment, Navy SEALs and their delivery teams, and some 10,000 Air Force personnel and their aircraft. Its

headquarters is at MacDill Air Force Base, Fla., with its principal training center at Ft. Bragg, N.C.

Second, SOF leadership focused heavily on countering terrorism—well before Sept. 11, the bombing of the *USS Cole* and the attacks on U.S. Embassies in Africa. Under the leadership of men like Gens. Carl Stiner and Wayne Downing, the SOF rebuilt lost skills and developed a sophisticated approach to modern war. SOF success in capturing the hijackers of the *Achille Lauro*, in helping topple Gen. Manuel Noriega in Panama, in providing relief to starving Kurds in northern Iraq, and in support of U.S. and allied forces in Desert Storm all demonstrated the capabilities that SOF can bring to difficult situations.

Afghanistan confirmed these capabilities in spades. Whereas the Soviet Union, during its 10-year war, introduced 620,000 troops into Afghanistan and suffered 15,000 killed and 55,000 wounded before leaving in disgrace, American forces in less than a year and with minimum casualties succeeded in toppling a hostile regime and facilitating the return of civil rule. ...

The importance of the SOF role in Afghanistan and in the war on terrorism is principally due to the men themselves.

A typical Special Forces soldier has had previous unit experience, completed airborne, ranger and jungle or mountain training, as well as a five-month qualification course with a 30-percent pass rate.

In addition, he has had up to a year of training in his medical, weapons, communications, intelligence or demolitions specialty and usually speaks at least one foreign language. It is not unusual for a sergeant to have a master's degree. Green troops are just not welcome. For example, just after I graduated from West Point, a friend called the commanding general of Special Forces and told him that I wanted to join Special Forces. The general replied, "I just had two second lieutenants for breakfast!" Only after completing ranger training, assignment to the 101st Airborne Division, language training and qualification school was I allowed to join the Green Berets.

Just as important as the training is the SOF philosophy. The Special Forces motto, *De Oppresso Liber*, means "to liberate the oppressed", and that is exactly their mission in life. The joy in the streets of Kabul, Kandahar and elsewhere in Afghanistan early this year was a telling reflection of that motto, and if the United States intends to attack Iraq, those joyful scenes may be repeated in Baghdad, provided U.S. forces are successful in defanging Saddam Hussein's chemical and biological munitions. ...

[JR: Special Forces are not new though the techniques used have become more sophisticated and lethal so as to assure guarantees for today's plans for success. How many of our techniques have come out of the handbook of the Israeli Mossad, whose own tradition of covert warfare goes way back to their ancestors the Maccabees. War is an art form that we humans excel in. It has stood the test of time in settling all our disputes and disagreements and also ensures our plans for acquisition and expansion. We now, as a matter of policy, get rid of officials we don't approve of through arranged assassinations, through an errant 'guided' missiles or fatal heart attack or plane crashes through the use of particle-beam technologies. Our U.S. victories in Afghanistan came through air strikes and technologies perfected by our scientists for military use. Those shining victories did not come through the staging of planned battles or by the pitting of one army of armed men against another army of armed men, as our Generals would have us believe. The motto of the Special Forces may be *De Oppresso Liber*, to liberate the oppressed. It is a catchy and noble motto but hardly true or accurate. In today's terms that means to liberate the oppressed leaders, and secure them from those who oppose them and their plans for takeover. It is not about liberating us, the oppressed people... unless of course you are an Israeli.]

FBI GAVE SECRET FILES TO TERRORIST SUSPECT

Washington—In a major embarrassment over their pursuit of al-Qaida terrorists, the FBI has mistakenly turned over 48 classified FBI reports to Zacarias Moussaoui, the only person indicted over the attacks on the United States.

Described by a judge as “a grave security breach” the reports were retrieved in searches of his jail cell on the order of the judge, Leonie Brinkema. The reports were summaries of interviews related to Moussaoui’s case and the bureau’s larger investigation of al-Qaida. ...

In the Moussaoui case, the judge ordered the searches, which took place over several days, after determining that “significant national security interests of the United States could be compromised if the defendant were to retain copies of this classified information”.

In their court papers, federal prosecutors did not describe the FBI summaries in any additional detail, but they acknowledged that it was “dangerous” for them to be in Moussaoui’s possession.

The mishandling of the documents was revealed by Judge Brinkema at the request of court-appointed lawyers acting on Moussaoui’s behalf and over the protests of the prosecutors.

Justice Department officials said that the errors involving the documents were the subject of an internal investigation being carried out by the FBI.

They said the summaries, which are known as “302s”—named for the form used by FBI agents to record the results of an interview, were not marked as classified even though they contained classified information.

Although Moussaoui has admitted that he is a member of al-Qaida and is loyal to Osama bin Laden, the 34-year-old French national has insisted he had nothing to do with the September 11 attacks.

The summaries were provided to Moussaoui as part of the pre-trial discovery process.

The credit card tie to Mohammed—a senior al-Qaeda operative—was spelled out in a status report on the investigation of the attacks Mr. Mueller presented to lawmakers in June.

The document portrays a plot carried out with such professionalism and precision that the hijackers “operated without suspicion, triggering nothing that alerted law enforcement”, Mr. Mueller said. “To this day we have found no-one in the United States except the actual hijackers who knew of the plot.”

Mr. Mueller noted Moussaoui was the one exception. ...

[JR: Another faux pas in the FBI’s handing over their summary reports to suspect Moussaoui. Was this a mistake or was the government expecting that Moussaoui would use his cell phone to call his non-accomplices to pass on this information? Either that or the government is inadvertently trying to assist Moussaoui in his defense because our “investigations” have yet to link him to al-Qaida or bin Laden. Stranger things have happened since 9/11.]

LEGAL UPROAR OVER POSSIBLE S.D. JURY RULE

PIERRE, S.D.—A measure on the South Dakota ballot this November would allow defendants to tell juries they can disregard a law if they don’t like it—a prospect that has the legal profession aghast.

Amendment A would let people accused of crimes argue that a law should not apply to their circumstances or that it has no merit. The practice is known as jury nullification.

The proposed amendment to the South Dakota Constitution was put on the ballot after more than 34,000 signatures were gathered by a group that includes at least one advocate of legalizing marijuana use. The idea could also appeal to the libertarian right, tax protesters, gun owners and abortion foes.

Opponents say the measure would cripple the legal system.

“It is very offensive to those of us who believe in the constitutional form of government and common law,” said Robert Miller, a former chief justice of the state Supreme Court.

Miller said the measure may be unconstitutional.

“I think it has a lot of appeal for the small segment of our population that has no trust for government and especially no trust for courts and lawyers,” he said.

Jury nullification is not a new concept. Over the years, juries refused to convict people who harbored runaway slaves before the Civil War, sold alcohol during Prohibition or resisted the draft during the Vietnam War.

But according to legal experts, no state has a statute allowing jury nullification. At least three states—Indiana, Maryland and Georgia—say in their constitutions that juries can judge both the law and the facts. But none of those states makes use of the practice, which fell into disfavor after an 1895 U.S. Supreme Court decision that frowned on jury nullification.

Among those who helped get the measure on the ballot in South Dakota is Bob Newland, a Libertarian candidate for attorney general who favors marijuana legalization.

[JR: With all the unconstitutional and/or questionable laws being passed since 9/11 the juries should be able to judge both the law and how it is being applied as well as ALL the facts and evidence in any individual case. THE HINGES OF HISTORY

The Romans apparently understood that history is not a smooth continuum but more like a long, snaking rope with knots every so often that separate and define its eras. Janus (whose name we invoke at the division of each solar year—in January) was the protector not only of the doorways in Romans’ houses, but also of the discreet doorways, or divisions, between major periods of history. His ability to look to the past and to the future simultaneously was what qualified him for that. “Those who cannot remember the past are doomed to repeat its mistakes,” is a maxim that he would have understood.

We are standing within one such historical doorway right now, and most people (regardless of political outlook) know that to be the case. It is not just that “the world changed on 9/11”, as has become the cliché, but something more. We are witnessing a global coup d’état in process (in a real sense) and a complete dismantling of established international legal structure and process. Coincidentally, there has been much written lately about the similarities between the current, attempted American domination of the world and that of the Romans 2,000 years ago, when Janus was a popular guy.

The ancient Pax Romana was the imposition of peace on the known world by the only superpower on Earth at the time. (In the pantheon of oxymorons, “imposed peace” must rank among the top five.) Of course, it was not a “peaceful” time at all, but a period of subjugation, corruption and exploitation that culminated in—drum-roll—600 years of universal misery, a.k.a. the Dark Ages! And now, at this exact point in history, we are being presented with a shiny, new, improved Pax Americana, in the form of the Bush Doctrine, which envisions the rest of the world made in the image of and serving the purposes of the American consumption machine, ruled by the American radical right. With no apparent sense of history to guide them, these putative Rulers of the Earth intend to lead us into a future which promises to be no less oxymoronic than the old Roman template, and no less doomed.

Now, there is one big difference between the Age of the Caesars and the new “American Century” (the brand name that the Bush PR crew has given this atrocity-in-waiting) that isn’t getting much press these days. But there is one thing that George W. Bush needs that the Caesars didn’t require: the acquiescence of his electorate. His power only extends in direct proportion to Americans’ inaction.

Please make no mistake, fellow citizens: we are riding on the hinges of history right now. The door can swing in either direction: open to a new era of hope, creativity and understanding; or it can slam back into the old imperial paradigm of fear, manipulation, suspicion and destruction.

The future can be changed; it is not set in stone. The truth of that statement is what drives the maniacs who are steering our government at this time, but it applies to all of us, mad or sane. The prevailing concept, that we, who prefer reason to brute force and greed, are powerless to affect change, is a pure myth. It is a myth as ephemeral and dissolvable as any that the Romans concocted, but also as real and pernicious as we allow it to become. This, then (the moment of our decision to act, to move, or not), becomes the very turning point, the hinge-pin of history. Of all times we are likely to live through, this is the most pivotal.

So what can we do? The answers are as myriad as the questioners and, to some degree, we all know what it is that we individually need to do. In fact, many of us have already been doing much that has made a difference up to this juncture. Witness the chorus of voices of the last few weeks that just one year ago was barely a whisper. Those voices have been raised in response to and with the support of the positive pressure that our progressive community has put on our national political system these last two years.

That chorus must reach a crescendo soon, but that doesn’t mean that anyone has to yell. Millions of people talking calmly and rationally—but urgently—can attain to the roar of a hurricane. Talk to a friend, co-worker or neighbor about these things, even if you think they will be closed to your ideas. They won’t, in most cases. Many will surprise you with their avid agreement. All things are malleable right now, especially peoples’ perceptions and opinions. Talk about it; let your passion and your eloquence out. (If you want to look at a good synopsis of our peril and of the arguments against this insanity—the better to address it yourself—here is one of the latest and best ones... an open letter from *The Nation* magazine:

We should not wait for others to do what we know needs to be done. All of us can organize and/or participate in peaceful demonstrations against this political cancer, in

our own communities, however small or large. We should continue to write letters to the editor of any and all publications in our personal spheres (the letters to papers here in Maine have been overwhelmingly opposed to the new American hegemony). We should actively (with money and time) support candidates in this next month who oppose the new Imperium. We should cajole and goad those who are ambivalent.

We also need to invest in some long-distance phone calls, soon. Call both of your U.S. Senators and your Representative (in their DC offices—you can get their numbers here: <http://www.visi.com/juan/congress/>) and tell them what you would tell your neighbors. Don't let the recent House vote supporting Bush's Iraq proposal stop you, and don't pay any attention to the spinning mainstream media... there is still time. If your Representative voted with Bush, tell him or her what you think. (While you're at it, send a "thank you" to those who have had the courage to stand against the tide, even if they aren't from your state or district. They deserve our expressed gratitude.)

Use your own words and tell them that you expect them to stand up for the *Constitution* and for the people, and to therefore oppose this mad grab for world domination. Tell them that they will be judged by their courage or lack thereof. History will do the judging, tell them, and so will we in November. Talk to your children or to a young friend about all this. Tell them what you feel about their future and explain your actions to them. Then ask them what they feel about it. Listen carefully. Maybe they would like to help.

NEVADA CORPORATIONS:

When Is A Corporation NOT "Doing Business"?

Budget's "Tip of the Week" #15:

Operating in a Foreign Jurisdiction Without Having to Qualify the Corporation

Since most people who form Nevada corporations reside in jurisdictions other than Nevada, one of the first questions that needs to be addressed is how to properly use the corporation while they themselves operate from within their home state (or country). Is it necessary to register or qualify the Nevada corporation to do business within their jurisdiction? Often it is—especially if there is a physical presence involving employees—but there are often many useful exceptions to the rule.

Let's look at the exemptions from qualification in the State of California—which is generally known for both its stringent regulations and its repressive taxation—to see what "loopholes" exist. You should look up the regulations in your own particular jurisdiction but as a general rule they will tend to be quite similar.

Business Exempt from Qualification in the State of California

Without excluding other activities which may constitute transacting business, a foreign corporation shall not be considered to be transacting business solely by reason of carrying on any one or more of the following activities:

- 1) A foreign corporation shall not be considered to be transacting intrastate business merely because its subsidiary transacts intrastate business.
- 2) Maintaining or defending any action or suit or administrative action.
- 3) Holding meetings of its board or shareholders or carrying out other activities concerning its internal affairs.
- 4) Maintaining bank accounts.
- 5) Maintaining offices or agencies for the transfer, exchange or registration of its securities.
- 6) **Effecting sales through independent contractors.**
- 7) **Soliciting or procuring orders either by mail or through employees or agents or otherwise where such orders require acceptance without this state before becoming binding contracts.**
- 8) Creating evidences of debt or mortgages on real property.
- 9) Conducting an isolated transaction within a period of 180 days and not in the course of a number of repeated transactions of like nature.

We have highlighted number 6 because this provision is used by an increasing number of businesses in the area of consulting. When the consultant is an independent contractor and the income is earned by a Nevada corporation, the corporation has no presence in the foreign jurisdiction, only the contractor does. So, the contractor must pay home-state tax on his income but the corporation earns its income in Nevada. There can be tremendous tax savings if the contractor lives modestly and draws only what is needed to meet living expenses.

Where the business is more product-related rather than service-related, provision number 7 can come into play. Just ensure that the orders generated require acceptance from Nevada before becoming binding contracts!

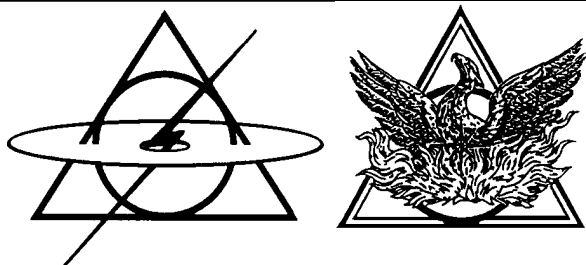
