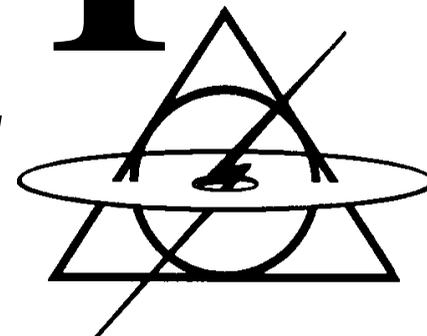

THE DARK SIDE OF THE FORCE

CREATING AND BROADCASTING DISEASE

Speaking of the **scalar wave induction of disease by longitudinal wave patterns**, Bearden refers to work by French scientist Kervran and Russian scientist Kaznacheyev, who proved that any disease could be transmitted electromagnetically.

“It works this way: The Kaznacheyev experiments (and others) demonstrated that any cellular disease or disorder can be initiated into cells at a distance, by electromagnetic means (albeit unusual EM in nature). The decades of microwave radiation of the U.S. Embassy in Moscow was an ongoing set of “stimuli” to hit the U.S. system and, by its response, ascertain how far along (or if it was “along”) in its knowledge of such weapons. The radiation was responsible for many health changes in personnel and for the **eventual deaths of three U.S. Ambassadors.**”—Bearden

In a letter he writes,

Yes, the Kaznacheyev experiments were quite real: 15,000 or so in military research institutes in Siberia. As with so many other novel areas investigated and developed by the Soviets, most U.S. investigators just assumed normal EM, which is not what the Kaznacheyev experiments involved, and not what was carrying disease induction patterns from one cell culture to another in rigorous lab tests.”

HOW TO “BROADCAST” DISEASES

Longitudinal EM Biowars

Bearden explains how the new quantum potential (QP) weapons can be used to induce disease-at-a-distance in a population, or to “spread” the immune system so thin that a **conventional bio-attack would be greatly potentiated**. By “broadcasting” virtual disease patterns over a population, the immune system is so overloaded by the presence of the “**shadow**” **diseases** that its effectiveness is thinned out.

“In short, after the internal wave structure, and one creates a curved spacetime ‘engine’ that acts on mass in any fashion one chooses to design—including initiate disease... Now visualize one of these ‘**vacuum engines**’ OR ‘spacetime curvature engines’ that **acts on mass to generate the exact effects produced by anthrax** (or any other disease one wishes). ... Call the virtual state of a disease engine the disease pattern in the “shadow” state, just prior to becoming observable. ...

“And the master cellular control system responds to “coming events that cast their shadows before”. In short, it responds to the upper level of the “**shadow state**” of a disease, still in the virtual state! (Hey, virtual particles are real, virtual photons are real, virtual ST curvatures are real—just very fleeting, only for another to immediately arise). The exchange of virtual particles is known to generate all forces in physics anyway! ...

“So the cellular control system responds to “shadow state” disease patterns. Enter a QP weapon application. Place a quantum potential weapon “area” on the United States, so that the entire populace is in it. Then slowly introduce and bring up in the shadow state, the **necrotizing facilities disease engine**. At some point, the cellular control systems will react, and order the immune system into action. In other words, immune system resources will be committed against this ‘immediately coming’ enemy. Bring it on up a little, but still just in the shadow state. Voila! Humans form a bell-shaped distribution curve. And even if the structure of the QP fluctuates a little, fluctuating a bit stronger and a bit weaker, etc., **a few of those targeted bodies will now actually develop necrotizing fasciitis**. So far, just like the U.S. Embassy targeting, except a different ‘carrier’.”

“But now there is an exact signature that this is what is doing it, and not normal vector carriers of disease and contact or exposure infection. **The few cases of necrotizing fasciitis that break out will be most puzzling**. They will be randomly scattered across the entire nation, and so few that the vector carrier and contact or exposure explanation completely fails.

“And that one happened, right here in the U.S., not so long ago. Check it out.

“So carefully adjust the **patterns** for, say, 12 major terrible diseases, to that ‘adjusted and desired shadow state level’. Now add all 12 patterns into the internal structure of the quantum potential. Now it has **12 shadow state disease engines** in it.

“**Place that one on a populace**. The cellular control systems order the immune systems into action, and they now have to commit their finite resources to 12 different areas. This greatly thins the response an immune system can make to any one of those 12 disease patterns! In short, it ‘**spreads**’ the capabilities of the immune system, which can be galvanized to great effort, but only can perform a small bit against each area.

“Suppose one of those ‘galvanized’ areas in the targeted populace’s immune systems is anthrax. And suppose the bad guys now hit one or more of those cities with a professional anthrax attack. A former OTA study showed that a professional anthrax aerial spray attack against Washington D.C., dispensing 100 kilograms of anthrax spores in the spray, will account for 1 to 3 million casualties. And that’s in an ‘unthinned’ set of immune systems. **In the ‘thinned’ set, one can at least double or triple, and even up to five times, that estimate**. So conservatively, now there would be from 2 to 6 million casualties. And even mild anthrax spray attacks in other ‘thinned’ cities would also be amplified.

“**That one is being set up, or already set up, right now**. There are other such ‘augmentation’ setups also under way. **[H: Try this thought on for size in “chemtrails”.]**

“**So the weapons alluded to by the SecDef in 1997 are already being employed. WW III has already begun, and our populace (and our scientific community) is blissfully unaware of it.**”—Bearden

Most of us can remember the strange outbreaks of the so-called “**flesh eating disease**”. It seemed to break out here and there randomly with no known cause. Bearden believes this was a test of the newer quantum potential weapons which go even beyond the capabilities of the Tesla howitzers.

Moreover, if anyone is foolish enough to vacate on such flimsy affront, then rethink your attitudes. THAT would then be possibly considered “abandonment”. No, been there and done that one as the brunt of other BAD legal information by amateur would-be lawyers of the *Spectrum* team raiders. THIS TOO CAN BE HANDLED FROM MANILA—IF “YOU” HOLD THE LINE AS STATED ABOVE. EKKERS, HOWEVER, HAVE MORE THAN A PLATEFUL OF PRESSING AND MANDATORY TASKS TO GET ACCOMPLISHED SO THAT WE HAVE NO INTERRUPTION IN OUR WORK FLOW.

Are Ekkers having any fun yet? Yes, even if they do NOT recognize it. What is taking place in Manila with them and this job is just the nasty task of preparation for the overwhelmingly BIG EVENTS ready to be delivered. So, please, REJOICE, keep up the energy flow in your positive attitudes—and hold those lines so that we can get this up and running and then we can turn attention to resolving other pressing matters.

The MOST IMPORTANT priority is to continue with the BUSINESS activities without interruption AND to get phones and addresses shifted with the necessary business cards ASAP and then, get working tables in place so that computers can be changed out and hooked up properly. We have arranged an overlap in dwelling dates to facilitate this very need so that there will be no cause for more than a few days of inability to function properly. Our team has worked out of boxes and suitcases for four years, so why get flustered now that we are able to see settling in for a run at this job? Even comfortable clothes will do for a week or so.

We are incredibly grateful to Two-X for sending the support necessary to make possible the move itself. This is “not” your Grandfather’s “time” in which you could trust your landlord (or tenant) until “the check actually arrives in the mail”. But, we are laying some groundwork in clearance for ability to order up some things by phone and get the, in this case, shelves, delivered quickly instead of the usual two to three weeks otherwise required.

Our people have NO backup clerks, helpers or anything but piles of various files which are mandatory to keep. Even “hot and cold running maids” (V.K.’s presentation) is just that, a figment of scrambled brain-output. There will be even LESS help AFTER the shift. Therefore, we have to ask patience and indulgence while we make bigger and taller stacks of debris through which to have adequate frustration in lack of ability to “find” anything—much the more, locate what is needed on instant notice—as is usually the case of looking for something or other. Did you ever notice that problem? It literally goes beyond that “last place you look” syndrome. Moreover, when in a rush “it” will usually have been in the first place you looked (and missed it) so that the last place there is to look doesn’t “find it” either. Surely you HAVE noticed that interesting and elusive fact.

We will now move on to the presentation in progress:

[QUOTING:]

“The Kaznachejev ‘disease induction by novel electrodynamics’ work is also the basis for the spacetime curvature engines (not EM signals) carried by quantum potential EM biological weapons for distant induction of diseases, etc., into the population of an entire nation or area, such as the U.S.

“This quantum potential disease induction weapon—capable of attacking an entire population of a nation or area—has been tested several times in the U.S. at very low levels, in the shadow state only (we explain shortly) and it has a most peculiar signature. E.g., **one test used necrotizing fasciitis (flesh-rotting disease) engines.**

“The disease ‘engine’ was deliberately kept down in the ‘shadow state’ (virtual state, just below the observable state) so that only a tiny bit of the populace with depressed thresholds would ‘breach the observable threshold’ due to the population forming a bell-shaped curve as to the threshold level. **The major signature of the test was that the cases of the disease broke out totally statistically and randomly,** spread all over, without any ‘disease vector’ in between.

“In short, it was not spread in any manner required by normal deterministic disease vectoring, **but was a totally random set of occurrences.** Several other diseases were also tested this way in the American populace, with precisely the same signature.”—**Bearden**

“Apparently one planned use of such an augmented clandestine BW weapon will be smallpox, e.g. As you know, the Russians did develop smallpox for biological warfare, and even developed a new strain against which previous vaccination is ineffective.

“The vast numbers of expected casualties, coupled with immune system spreading, are absolutely irresistible to the Russian mind. You can count on it that they have seen that the smallpox is already on site here, in the U.S. and in the hands of professional terrorist teams. Of course, the Russians/KGB will protest they have nothing to do with that! Yet likely the KGB will have flatly arranged it or at least assisted it. The capability for mass destruction of the nation is so lucrative and easy to achieve in advance, that **they would never be able to resist doing it.**”—**Bearden**

Bearden believes the **Gulf War Syndrome** involved the use of scalar technology to induce a disease state, as he stated in a 1997 interview:

“**I’ll say this flatly, and I won’t answer any further questions about it; the Gulf War Syndrome was induced...** it was induced with this stuff. All the rest... were contributing that everybody’s talking about... There are some deeper signatures, if you look into it very deeply, that show you exactly how it was done and the fact that it was induced. It was a test. It was a test of a very special kind of weapon I have not talked about yet. Anyway, you can use it to create diseases.”—**Bearden**

Besides using the woodpecker grid to target a population, the entire **electrical grids** of nations can be used as “channels” for disease patterns to be broadcast to all people near that grid. Your own house wiring can become an antenna, broadcasting these “shadow” patterns of disease, weakening your immune system.

And here one faces the frustrating fact that the same power grids could be set to channel patterns which would keep entire populations healthy, rejuvenated, continuously bathing in the time-reversing old-age-defying energy of the spacetime vacuum. We have **no idea yet** of how long the human life span could be increased with this new technology. People might be able to live two centuries given full humane development of this technology.

PSYCHOENERGETICS

Mental entrainment, inducing hypnotic trance, mind control, broadcasting thoughts and feelings, the Ant World, education via EM [LW] mental download, the “Feelies”, revolution spirituality, “enlightenment machine”? Scalar churches?

Psychoenergetics is simply using the scalar interferometers to manipulate and engineer the human psyche. To me it is the most **mind-boggling and frightening** aspect of longitudinal wave engineering.

The mind is electromagnetic in nature, and itself of the time-domain. It is now observable in 3-space. There is no **thing** you can point to that is the mind. As Bearden says, “**The mind is time-like.**”

The longitudinal scalar EM waves are also of the time-domain. By overlaying certain infolded patterns (oscillations in time) on the longitudinal waves, **a thought or feeling may be made to arise in a person** or persons who are in the interference zone (where the wave beams cross).

The person will not notice anything, feeling that this thought or idea is his or her own idea. The longitudinal wave pattern might be a wave of panic or fear that spontaneously sweeps over you, perhaps inexplicably. It could even be in the form of a sudden intense patriotism. It could be explicit words and phrases, which everyone would think they had thought of by themselves. Or it could be rage and hatred, angry and violent. On the other hand it could also be a continuous sense of docility and placidity. This is the brave new world of psychoenergetics and the coming “**Mind Wars**”.

Scalar Psychoenergetics in its most **primitive form** simply “entrains” all minds in the target area into a **deep hypnogogic trance.** In this state of mind people would be suddenly extremely suggestible, and would likely believe anything they are told, and would obey any orders given. Talk about winning the hearts and minds of the American People!

Tom Bearden makes me think of **Paul Revere**, who heroically conveyed important warnings for the sake of the new nation. But the words of the famous phrase have now strangely and curiously mutated into the once-inconceivable: “**One if by land, Two if by mind.**”

Indeed one strategy in a **Mind War** would be to simply **take over the minds of the “leaders”** of the enemy nation. The targeted leader would not be aware that anything was amiss, although he might begin to make unexpected changes in policy.

And are, in fact, any of our “leaders” already having secret thoughts that are not their own? Who knows? Frighteningly, we can no longer be sure. The new sciences of scalar electromagnetics and psychoenergetics are even now plunging humanity into a sudden science-fiction-like world beyond anything in humanity’s previous imaginings.

“The Russians reached the point in the mid-1990s that they could take over control of a person’s mind, with modified EM longitudinal waves including some time-polarized EM waves, and with a team of specialists (estimate 25-30 per transmitter, and one transmitter and team per controlled person).”—**Bearden**

In a slide Bearden illustrates how a Scalar War would involve a **psychoenergetics attack** on the operators of the enemy scalar installation entraining their minds into hypnogogic trance and **getting them to shut down their systems.**

Ultimately psychoenergetic warfare goes to the very heart of human identity itself. For if my thoughts might no longer be “mine”, then who and what am I? Can my very sense of being “me” be hijacked by some nefarious psychoenergetic scheme? Will the “secret government” eventually dictate directly into your mind how you feel about yourself? Or what you think you are? Or what you should do? [**H: Already been there and perfected it, readers. YOU are “in it”.**]

I hope you are stopping here and there along this journey into information—for if you are not paying attention, then you are in serious probability of not getting much of anything from this presentation or any other.

It is technical in its scientific intrigue but simple in its reality. This very energy is that from which you BECAME. Don’t let the fog-factor applied by presenters cause you to somehow think you can’t possibly “comprehend” this “deep” subject. It is the “stuff of life” and it is NOT even difficult to understand, for it is “that which you are”!

We allow for that probability while appreciating the willingness to stand in the middle of the river at flood-stage and keep paddling. You do not even have to LIKE A MAN to realize truth from his presentations. Moreover, since you probably are not going to build great and wondrous machines, then you don’t have to know how to assemble components into a scatter-apparatus. Those who do wish to go that route of what can be totally DANGEROUS fun and games will have to search out that information, for I will not present it here.

I do actually, however, feel that some of you who keep tinkering with the idea of making Rife Microscopes and Priore equipment the “end” in health enhancement—think again, for that is so obsolete as to be a total waste of good thinking time. Last evening we signed agreements with an apartment owner (but also manager) NEXT DOOR TO THIS BUILDING—just two "driveways" apart and 25 floors closer to heaven (up, anyway).

We have located, however, some folding tables for sale and have ordered some. We can carry our very own plywood for desks and since we have our own chairs we can get into "business" as soon as we get relocated—across those mere two driveways.

With all the concern and bother—God certainly did know what he was and is doing. The place is large enough to have areas for office and storage and we can pretty much live out of boxes (suitcases) until the next PHASE strikes us if necessary, for work must come first before unpacking and filing, cooking or cleaning (again: ☺☺☺).

Bob Turner, the owner of the property, called a while back and after not hearing from him in years, he announced that his physician had given him less than three weeks to live. Therefore, he had his son with him to attend trusts, sell property, etc.

E.J. talked to him but was in a state of surprise as well as outrightly being sad over the turn of events.

Then there was a crossing of faxes and missed calls—well, we sent faxes and didn't receive any from Mr. Turner while he said we had "not responded to his". We even responded to the message machine where Bob filled up the message tape.

Then we finally got a fax that was written in the night of the same day we got it so could NOT have been the "missed document" which was not totally, but 96% non-readable.

We were given an ultimatum of being "in or out" of SOMETHING, by an absolute deadline of October 20th (now day after tomorrow). He said something about "a buyer" and a demand to "vacate" by December 20th. In addition, the new buyer didn't want the "stuff" and if we didn't get it all out/off the property we would be "billed" for the costs involved.

E.J. immediately faxed a note that this was absurd, for there had for ten years been recognized agreements that we would always want to finish purchasing the property and with that always in mind we put permanent improvements to the property to the tune of hundreds of thousands of dollars and added granaries, buildings, finished cellar facilities, reinforced the falling-down buildings, roofed the dwelling and did ALL the upkeep from paint to repairs to the entire water and pump system.

All the while we are being called “dear friends” we are also told it is “just good business” (where oh where have we heard THAT one before?).

Well, NO, NO AND HEAR US WELL: NO!

We paid this man, with the expectation of applying the lease payments to the purchase price (which he says is now assessed at \$1.2 million—while listing publicly the very improvements we made to the property.

We are being refused viewing of the sale or escrow (if there is such) and not given the sale price, which seems to be to an organic grower (Grimway) who wants to bulldoze down everything but the barn and house to have more planting land. You know, the additional space taken by the granaries. Mr. Turner doesn't even want to give us the name of the buyer in order to work out arrangements with them for interim time to do anything, even move offices—AGAIN. So, me again: NO, NO AND CERTAINLY NOT.

Along the lines of discussion we have to note that there COULD NOT BE a rush because Bob said he was dying in less than three weeks—four weeks ago. We fully expected to do immediate and ongoing business with son, Thad, who advertises himself as the contact party—in the public ads.

We don't know what was the rush but Bob said that he couldn't meet our wishes because he had put the property in “trust” many YEARS ago and the family didn't want to share any sale values with us.

OK, but he said at the first phone call that the farm and some other properties were NOT put into trust and that was being handled with Thad at THIS TIME. So, what is what, which end is up, and where is on third.

With the hassle and bustle of figuring out payments, etc., we were given credit for the “metal” roof on the house (which is falling down from termites) and that would take care of the “rent” for/through/to “November” (and, we guess, until eviction on Dec. 20th). That is in writing from him personally. The fax was finally “resent” and we found it still to be all but illegible but we suppose it is decipherable. But let us give due to a very sick man—who now talks about “later” as in “indefinite” time-schedule.

We are asking, “What's the big rush?” No answer! Our assumption is that the price is FAR LESS than any \$1.2 million as advertised TO US along this journey, AND AS WELL, no agreements have/are being honored regarding the property itself.

We suppose we can insist on talking to Thad about this problem but Bob seems to be the one in full charge while at the same time playing to our sensitivities as “friends forever”. Well, that may well be BUT it is not alright in a corporate circumstance where many parties are involved and have equal rights of druthers and demands. And, therefore, the ploy is falling hard on very irritated nerves of EVERYONE who has worked to keep that property and grain—all of which is organic in quality as well as us having been the ones who spent thousands and thousands of dollars getting that land “certified”.

E.J. even suggested a starting discussion of compromise by asking a percentage for “services” in the “sale”. That too went to the dump—without recourse. NO!

We always met Turner's needs in how we handled things so he would NOT have a tax burden and yet NOW, wow and wow—taxes up the gazoo from a “cash sale”?

We don't know what we can do but sit-still-for-the-executioner is NOT among our options—enough is enough already.

There is something wrong in “dreamland” because we are confident that some working arrangements, at the least, could be worked out with any buyer—especially one who is going to bulldoze everything (in the middle of winter where the weather is miserable at best).

In addition, Turner gave us in writing an option to be “in or out” by October 20th but NOW says emphatically that it didn't mean anything as in “right of first refusal”. So, what in heck does it mean? Well, it means to us that there is some shadow in Sunshine Valley. Moreover, if Mr. Turner is actually terminally ill, then what is the all-fired rush since we have had a working arrangement for ten years and over half a million dollars in lease (option-to-purchase) payments.

We even suggested that the least offensive, for him, would be to at the least pay for the cost of moving offices, acquiring a rental place for it, and the expenses of shifting. We are NOT willing to walk away—and finding buyers for grain, beans, equipment, etc., is out of the question by Dec. 20th and much the less, Oct. 20.

Corporate fiduciary responsibility DEMANDS AND LEGALLY REQUIRES we do “something” even if it simply “holds”—but that means a NEW lawyer and, people, I simply do not know if I have push enough to do any more of that garbaging.

Commander has said currently that “we still want that farm...”. So, perhaps we LISTEN even more quietly for instructions and HELP!

On the bright side of the picture, however, at worst we can add it to the losses incurred in that “farm project” and have tax write-offs for a very long time while, now, that number gets into the million-dollar value. Oh well, this is a Doris ramble and “it will be exactly as it will be” in the magnificent wisdom of Little Crow!

Mr. Turner would lose NOTHING either way, the family would lose NOTHING either way and the place would be secure indefinitely either way. Turner was already SUPPOSED to be leasing the fields to growers as we limited our use to the buildings because we didn't have anyone to do the farming. We were also supposed to get another \$300/mo cut in lease payments if he could sell one of the well's water to the growers next door. He never did either—just let it go to ruin until the county came forth with equipment and ploughed under the weeds as we assume the yellow-starthistle had gained foothold.

The water system had problems as well and we were responsible, it appears, to have it repaired and actually had to bypass one “tank” because it would cost some \$10,000 to redo the system and replace the tank.

I'm sorry, friends, but people involved have not been honest with us in any measure whatsoever, and, NO, we will not drop everything and rush back to attend ANYTHING. Our job is HERE and in that we HAVE NO CHOICES SUITABLE TO “THE CAUSE”.

If “eviction” is the ultimate outcome of this confrontation edict, so be it, but it certainly seems unduly foolish on “their” part, for we will then have no alternative other than come against the new owners if necessary, for losses. I hope that Mr. Turner doesn't miss the opportunity to mention that to these buyers!

I suppose, if I had a wish to God, it is to give us wisdom in these times and with these “things” and for a lot more “backbone” than we have a tendency to hold. My feeling is that we have already been given that added support in that if we could do so we would probably consummate those “dreams” by simply buying that farm for the two-thirds more than the actual price for the falling-down place. Another of those “mysterious” wonders presented? I suspect that there will be a day not too far into the future

where we will go right back to that proverbial “10-cents on the dollar” (or less) for land of any kind.

It does appear that if we get out of our own way, things certainly DO work out—better or worse—but “which” is unable to be determined up front.

One thing we do recognize is that we have only had some inferred “get out” dates offered and certainly no formal eviction or vacate notices from anyone about that “farm” or “ranch” as Mr. Turner refers to that 160-acre “field of dreams”. We do assume, however, that pressure will be brought to bear in some measure to you who are “there” but we doubt that anyone will bulldoze the house with you in it. It may well fall down in the next heavy wind after a few more months of termite lunches—but I guess we just don't “scare” easily any longer, having been there and done that. It is so that even renting tenants have some legal recourse and RIGHTS under the law.

If, in fact, Turner put the whole of the properties, including that property, into the trust now controlled by someone else other than himself—his demands will not carry the day anyway and THAT is corporate/trust LAW/REGULATIONS. [Quoting Sister Charlotte:]

ON ANY GIVEN MORNING

Here we are, a body of little nuns and on any particular morning the Mother Superior might have us lined up and we don’t know why she has us lined up. There might be ten or fifteen of us and then she’ll tell us all to strip. We have to take every stitch of our clothing off. We certainly are not anything beautiful to look at; our eyes are sunken into our heads, our teeth are fallen in and our bodies are wasted. God only knows exactly what we look like because we never see ourselves. In 22 years I never saw a reflection of myself.

I didn’t know I had gray hair or lines in my face. I didn’t know how old I was—I only found that out after I came out and found records. These children know nothing about what we look like.

Here we are lined up and here come two or three Roman Catholic priests with liquor under their belts and there they go to march in front of those nude girls and choose the girls they want to take to the cell with them. These are cloistered convents, dear ones—not open orders.

The priest can do anything he desires and hide behind the cloak of religion. That same Roman Catholic priest will go back into the Roman Catholic Churches and there he will lie and say mass, and there he will go

into the confessional box and make those poor believing people confess sins uncommitted and act as God and give them absolution from those perceived sins. This man sits as God while he is filled with corruption and vice. What a terrible thing it is but therefore it goes.

INSIDE OF CHARLOTTE

All the while these things are going on, what do you think is going on inside of Charlotte? God love your hearts, I didn't know people could hold so much hatred and bitterness. It went on and on and on. I became filled to overflowing with bitterness and hatred—it built and continued to build. I began to feel within my heart, that if I could get the Mother Superior in a certain place I would kill her. It is awful to get murder within our hearts. I didn't go into the convent with a heart like that, nor a mind like that but I began to plan murder in the convent. How could I kill her and how might I kill a Roman Catholic priest and on and on it went.

Every time she would inflict something awful on my body and I would have to suffer so terribly, afterwards when I could sensibly think again, it would be how I might kill that woman.

How would you feel? Here is the Mother Superior and she sits me down in a straight-backed, hard-bottomed chair and I have no hair, for it has all been shaved away. Now she makes me hold out my arms and she puts my hands out front in stocks. I am going to have to bend forward with my head bowed in order to put my hands in the stocks and an upper holder across my neck. I am fastened securely with no way to move in any direction.

Over my head is a water faucet just a few feet higher than my head if I were standing. That Mother turns that water on—just a drop and it will come regularly and it will hit me on the back of my shaved head. I can't move in any manner what-so-ever and I sit there for hours upon hours. I would do anything, anything, to get away from that drop of water. It is falling on the same spot on my head—over and over. Why, God love your hearts, if you could look in, you would see us frothing at the mouth. You would see those little girls trying so hard to move away from that water and they will sometimes leave us ten hours or more. All day long they leave us there.

Sometimes a little nun “cracks” completely. Sometimes a little girl will go stark raving mad under this particular penance. Well, when this happens, what do they do with her? I'll tell you in a few minutes because let me assure you, they have a place for her! After we go mad in the convent, they certainly have a place to take care of us.

I began to plan and plan how I could kill her because after you have experienced something like this it is terrible and you can no longer think rationally.

One day, it happened. The Mother Superior became violently ill. Now if she dies, who will take her place? Sometimes they have as many as four older nuns and let me tell you, they have been hardened and trained and they will always pick the one who is hardest. The one who is most carnal and evil, that one who no longer has conscience—that is the one who will be the next Mother Superior. Remember that the trainees are trained by the main Mother Superior and therefore another even more vicious will take her place.

This particular time of illness, I was summoned to her room, for she was gravely ill and remember, I am a nurse. Quickly as a blink I began to think that if I go in that Mother Superior's room, I know what I'll do—you know, after all, I'm a nun but I'm

already, after all, a complete heathen and sinner. I don't know God and I am filled with hatred.

They have brought in an outside Roman Catholic doctor, for she is very ill. He has left orders and I am supposed to take care of her and that was just wonderful. I do take care of her and all day long I did exactly what they told me to do. They left tablets for her which I knew exactly what they were, what they would do and why she was taking them.

All day long I tended her and gave her the medicine and did everything I was supposed to do. All evening long I followed instructions, for I knew I must be most careful. I waited until one o'clock in the morning before I took any action because every night the nuns must chant from 12:00 to 1:00 a.m. I waited until all the little nuns had returned to their cells and then I took six of those tablets and gave them to her in a glass of water.

I knew she would go into convulsions and I knew it would be horribly painful. I knew she would suffer a million deaths in twenty-five minutes. I wanted to watch her suffer because she had destroyed us. It is terrible to think that a child can be abused in a place like that until her heart is almost as hard as the Mother Superior herself.

After I gave them to her I waited a minute and then I got scared. I watched her change color and I couldn't find a heartbeat or a respiration. Then I became terrified, for God alone knew what they would do to me if they found her dead.

Well, I got a stomach pump and pumped as fast and hard as I could. I massaged that woman and I did everything I could imagine to do and thank God, she didn't die.

I sat down by the bed and held her hand while I watched her carefully until the respirations returned to normal and until her pulse was normal and I knew she would live.

THE KEYS

While I sat I realized that the keys to the convent were also there in that room, on a ring on a chain that was always kept on the Mother Superior's body. I took those keys and I was going to go down under that ground where we were never taken. There was one very heavy door into an area some two stories down in the underground. All nuns were warned to never try to go through that door. What in the world could be over there? But I wondered what was back there because when they had me in the dungeon for a long time once, I heard screams coming from over there. I heard such blood-curdling screams and I knew there were girls locked up somewhere behind that wall.

So I took the keys and I went into that particular place. It took a while to find the proper key but I found it and unlocked that door and went into the area behind the wall. I first walked into a narrow hall. Along one side of the hallway were a number of cells with extremely heavy doors and within those cells were some nuns.

I was hit with a stench which almost took my own breath away. I went to the first cell and I was appalled. I asked the child how long she had been there. No answer. I asked how long it had been since she ate. No answer. I went down to the second, third, fourth and fifth and the stench became so bad I couldn't stand it. Those little girls would not utter a sound because they knew the convents are “wired” and any sound made is played to the Mother Superior—every whisper. And then, there is always someone to “tell” and the penance is terrible.

Those were the nuns who had mentally gone mad. They were then put into chains strapped to the walls where then cannot even fall to the ground. When they are put in there they are given no food and no water and they are left there in that manner until they are dead. The stench is so bad because many of them are already dead and the waves of sickness swept over me and I couldn't even know how long some of them had been dead. I can't go on - - -

BACK TO MOTHER SUPERIOR

I felt my way back to the room where Mother Superior lay ill and replaced the keys, for I knew not what else to do. I sat down by her bed and waited. She slept into the following day—long, long hours she slept. When she did awaken she said, “I have had a long, long sleep haven't I?” I told her that she had. I took care of her for three days and I never knew at that time whether or not she ever knew I had gone into the forbidden chamber.

After the three days, they put me out in the kitchen. When we do our tour in the kitchen, six of us go for a period of six weeks. We do the cooking and do the kitchen work. We prepare the vegetables and the soup, and we tend the vegetables at a long table along one side of the room. It is a very long room and at one end of the room are about four steps down to a landing just inside a very heavy outside door. The garbage cans sit there.

While I am there working, someone tipped over one of those garbage cans. We are terrified, for we are never allowed to make any noise lest we be terribly punished. We were all six present, so we wondered who in the world had touched the garbage cans. Well, as we stared around we saw a man who was picking up the full cans and leaving empty ones. I had never seen anything like that in all the years I had worked in that kitchen. I believe God had just laid his hand on me and with all my heart I know it to be true.

We turned quickly away, for it is a mortal sin to look upon a man other than a Roman Catholic priest, so we turned around most quickly and bent to our work. But I thought in a flash—when that man comes to exchange cans again, I am going to somehow get him a note.

Well, it continued, because there is a pencil and a bit of paper hanging in the kitchen where items of need are written. I stole a piece of paper off the pad and I carried that little piece of paper and every time I could get my hands on that pencil I would write a word or two on the note. Oh, I watched that garbage can and every time I took the garbage down there I watched it. And when it was just about full—and I thought that the next evening it would be full when the day's garbage was added—I made my plans.

As I worked, I very quickly broke my crucifix and laid it up on a shelf. I had a very hard time doing it because constantly everyone is watching everyone else. But I did it and I laid it up on the shelf so everyone could see it and went about my work. I had to have a way in which to get back to that room later.

When the dinner is over and the dishes are tended, everyone leaves at the same time and we must march past the Mother Superior. When I marched by I quickly stopped and whispered to her saying, “Mother Superior, I broke my crucifix and I left it in the kitchen. May I go for it?” No nun is

expected to go without her crucifix and she asked how I had broken it and I lied to her—everything she asked me, I lied to her just as convincingly as I could. I guess I had learned to lie because she lied to us and we are all sinners so I lied, too.

She finally told me to go get the crucifix and come right back. That's all I wanted because I had to have a reason, for no one can return to the kitchen after you have left it. And so I headed directly for the garbage pail because when I had put my last garbage in the pail I had left a note right on top of that garbage and left the lid off which was forbidden, and so it went.

I had written on the note to the garbage man, "If you get this, won't you please help me. Won't you please do something to help me out of this place." I told him about those nineteen cells in the underground and the dungeons. I told him about the babies being killed and I also told him other little nuns were locked in the dungeon and were bound with chains. I told him plenty and asked him to help us. I said if he would, please leave a note under the empty cans. That is what I went back for and prayed hard that there would be an answer.

When I lifted up the can and found a note, you cannot imagine how I felt. I froze to the floor I was so scared and didn't know what to do. I picked that piece of paper up and read it and this is what it said: "I'm leaving that door unlocked and I'll leave the big iron gate unlocked and you can come out." It was almost more than I could conceive. I never dreamed I would ever get out of that convent—I never really dared dream I might find a way.

THE ESCAPE

When I could collect myself, I reached over and turned the knob and, you know, it was open. I walked out of that convent and turned and made sure the door was locked behind me. I got all the way to the huge iron outer gate and oh, I was trapped—the gate was locked and now I was trapped. I was terrified, for now I was locked out of the convent and I cannot get out of the gate. I have no right out there and I knew I would be destroyed if I turned back. I was scared half to death and couldn't move for a while. The fear washed over me until I was sick, for God alone could know what they would do to me if I went back and pounded on that door to be allowed back in.

I had no shoes or stockings, for I had worn them out years before. The richest Church in the world and the nuns go winter and summer without shoes or foot coverings of any kind. Even in crucial poverty, I still wonder at how they can do it, or how any of the children survive.

What did I do as I stood in front of that huge gate? Well, I had no real choice in my own mind—I started to climb it, for there was nothing else for me to do.

About a foot from the top is a ledge about six inches wide. I thought if I could manage to climb high enough to get my knee on it I would be safe. I did, I got one knee on the ledge but I had no more strength. Then I recovered enough to think a bit and I thought if I could get one leg over the sharp projections, and then the clothing, then I could get my other leg over and at least I would be on the other side of the fence. Well, then I knew I was faced with another decision, for I knew I had not enough strength to let myself down the other side and would have to jump. It was a high gate and I knew I would break my bones if I fell or jumped.

I pulled all my clothing up around my body and

held them with one hand and then decided I would simply have to jump. Oh gosh, I was scared because, you know, they have a buzzer in the convent and when a nun tries to escape they turn the buzzer on. Then, funny thing—the priests who claim never to come to the convent, pour out like ants when that buzzer goes off. They really set to right fast, then. They are immediately out and after that nun because they don't want her out of that convent because some day, she will give a testimony if she escapes. I assure you, they do not intend for any of us to ever get out!

As I sat atop that gate and made that jump—I just didn't make it—which seemed bad at the time, for there I hanged. My clothing caught on those points and I just hung there. I didn't know what I looked like and I certainly didn't know I had gray hair but I have often said that perhaps my hair turned gray right there on that gate. I was in terror realizing that buzzer could go off any minute and there I would be.

I tried to wiggle my body or swing it, for if I could get back far enough to grab the fence with one hand, perhaps I could help myself with the other. Then I tried unfastening the portion that was caught, for it was the garment worn and attached at the waist. When I did this, I promptly hit the ground. I was completely unconscious and I lay there for some time but I don't know for how long.

When I came to, I had a shoulder broken and my arm was broken and the bone had snapped and cut right through the flesh because there was no "meat" on me, just skin.

Well now, I realize I am severely injured, I am on the outside and now, what will I do—where am I going? At this point I know that I am not in the United States, for I am in another country and I don't know anything about that country. When they had brought me to the place, they kept me completely veiled and I couldn't see anything and I have no idea where I am and I don't know where to go and I no longer know anyone in the world, anyway. I have no money and I am hungry and my body is broken and what will I do? Where will I go?

I realized I must move away from the convent and I did. I just started moving away. I was so afraid, for it seemed I had made so much noise and I couldn't move quickly and I was so scared they would find me. I moved along in the darkness. There was no twilight in that part of the country and it just dropped off into darkness and I can barely make out outlines of some things. I found a little building to the side of the road—very small—and I didn't know what it was. I thought it might be a doghouse or chicken coop or something similar. I crawled in it because I was shaking and scared and I laid in there for a little while to get a hold of myself.

Then I realized it was safer for me to travel in the dark, for I would surely be seen in the daylight. I stumbled on through all that night and then the next day I hid behind some pieces of boards and tin piled up against an old building. All day long I was hiding in that hot place and I was starving and broken—I now realize I was being kept alive for some mission and so I held on and waited my chances.

When night fell again, I have to move because I must get away from that convent. It was not safe to knock on anyone's door. If I rapped on a Roman Catholic's door they would immediately take me right back to the convent. I now knew that it would be better to be dead than be taken back. I stumbled on and on and the next day I hid out in a stock pen. The night fell and I traveled on. The next day I was

really scared because my arm was swelled as tight as it could be and I was having to carry it in the other hand. All my fingers began to turn blue and I knew gangrene poisoning had set in. I knew at that moment that I would probably die just like a rat in that rubble. I didn't know what to do but I felt I couldn't go this far and fail. I knew I might have to go and rap on someone's door.

Finally, that is what I did. I remember that as I walked out of that barn and stumbled along I could no longer think. As I stumbled along I came to an old house with an old-fashioned lamp burning inside. I saw this lamp for quite a ways before I reached the house. It was the home of poor people and I could go no further. I walked up to the screen door and rapped on it. A tall man came to the door and he was rather old and I asked, "Please, may I have a drink of water?" That old man didn't answer me but he walked back into the house and called to his wife. God bless her heart, she was like most old fashioned mothers, she came to the door and she didn't ask who I was or what I wanted. That dear little woman just pushed that door open and said for me to come in and sit down.

GODLY PEOPLE

That was the most beautiful music I have ever heard—her sweet voice. She pulled out a chair for me and I sat down. I was so tired and they were obviously so poor as they had no rugs or anything very much, but there was a little checkered table-cloth in red and white on that little table and I will never forget it. There was a little stove in the corner and a fire in it. That woman put some milk in a pan and heated it and brought it to me. I am starving and I have no manners, and I grabbed that glass of milk before she could even set it down and I swallowed it all instantly. I am so hungry I thought I was going mad.

Of course, the moment it touched my stomach it came right back up—I lost it instantly. Not only was I starved but I had had no milk in twenty-two years. I simply couldn't take it and I felt so embarrassed and so miserable. But she knew what to do. She went out to the kitchen and heated water and added sugar to the water and then she brought it over to me and fed it to me a spoonful at a time. I took every bit of it and it was the best thing I ever had had pass my lips.

Then the daddy walked over by me and asked who I was and from where I had come. I began to cry and I told them I had run away from the convent and I wouldn't go back. He then asked what happened to me because my hand was laying up on the table. I told him about the gate and falling and he could already see that I was badly hurt.

He said that he would have to get a doctor. Then I became totally hysterical and I tried to run back outside and they wouldn't let me. He said, "Wait a minute, we are not going to hurt you but you must have help." I cried that I didn't have any money and I don't have any people and I can't pay a doctor's bill. I was just in a terrible mess, if you want to know it.

That man said to me, "I'm going after a doctor—and he is not a Roman Catholic and neither am I. You are safe with us." That dear man didn't have a car, so he took a horse and buggy and drove nine miles to get a doctor.

The doctor came ahead in his car and when he arrived, ahead of the man, he walked around me and kept walking around me and he was swearing.

He was furious because he was looking at something that was supposed to be a human being and I in no way even resembled a human being. I was in such horrible condition.

He sat down in front of me and he said he would have to take me to the hospital—right then. I pleaded not to go, I was so terrified. He sat closer and took my good hand and he said he was not going to hurt me but that I must have help and he wanted to help me.

He took me into the hospital that night and that was the first time I ever knew how much I weighed—I am a large woman by frame and I weighed exactly 89 pounds.

They took me into surgery and they tried to get the inflammation out of my hand. It took about twelve or thirteen days and they had to break and re-break the bones and I suffered, but nothing like that in the convent, for they would give me something to ease the pain and I had only known things to make pain worse.

Finally it came so that I could be released and those dear poor people took me in. I had been in the hospital three and a half months and the doctor wanted to take me to his home but I only trusted the first little people. So they took me home with them and I stayed there for a period of time and the doctor stayed in touch and checked on me.

One day there was a letter from the doctor and check enclosed. He asked them to go and get me some clothes, that he was coming to get me on a certain day. He told me that he would find my people for me. That doctor was a stranger to me and oh, I thank God that there are men and women across this world who are so unselfish as to use some of the money that God has allowed them, to help those less fortunate than they.

They spent a lot of money on me, for I was hospitalized for three and a half months and he paid the bills. Oh how I appreciate it.

These dear ones bought me clothing and something to carry them in and then the doctor came and took me to the train. He had found my people for me. I was on trains and boats for a long time and then one day, after he had arranged my visa for me to return to the U.S., he arranged for someone to travel with me at all times because I didn't know what to do or how to do anything for myself in the world.

HOME!

One day as we traveled by train, they called the name of the town where my mother and daddy lived. And I remembered. I got off that train and ran all the way to their home, some five blocks in that little town. My daddy came to the door and I looked at his face and I didn't know him. I asked if he knew where my father lived? He asked who I was and what is your name. I gave him my family name as I remembered it and that man looked at me and then opened the door and asked me to come in because he didn't recognize me. My mother was a total invalid and he took me back to her bed. She didn't know me and I didn't know her but it was wonderful to be home. She was in the hospital for a while and then she passed on.

My father paid all those bills and reimbursed all those ones who had helped me to get home—every one of them.

Now, do you know what God did? I am a nurse and so I went to work in a hospital. One day a woman came into that particular hospital and I was sent into her room to prepare her for the surgical table. I became that woman's special nurse in the hospital and when she went home I went with her to tend her in her home.

That woman, when she was well enough, asked if I would please go to church with her. I lived with her long enough to become her friend. I lived there long enough to read the *Bible* to her because I was her nurse and I did that which she requested of me. I had never read a *Bible* in all of my life and she would find the scriptures and then I would read them to her. As I read the word of God, and I could tell which were the true words of God, and it began to reach through and into my heart. Finally she asked me to go to church with her and I went with her. I sat there and heard the gospel for the first time in my life. I had never heard anything like that and it was so beautiful.

I can sit at His feet and I can say "Jesus, I love you" and tell Him every secret of my heart. I can pour it out to Him and I don't have to worry about Him telling what I told Him. He is the best friend you can ever have. He is able to do anything and all things. He can set you free just by knowing Him.

He gives me the strength to do that which I must do now that I am out of the convent. Pray for me—please pray for me. I will be going places where it will be predominantly Roman Catholic and I'll have to suffer much. But I am willing to do that for Jesus because I know He suffered every pain I bore in that place of hell. I must tell everyone I can and in every place I can about my life and give my testimony. I must do what I can to free those little girls from those awful places of Satan. [End Quoting]

Hatonn present in the Light of the Radiant One. Good-day. Dharma, we will write for a little while this day and then I desire that you leave the keyboard. You need a break.

We have had so many requests for further discussion regarding Jim Jones and Guyana that I believe we will spend time on it herein. It surely plays into the theme of religious lies, albeit more political in the definition of politics vs. religion. We also awakened a great outcry regarding the Lucis Trust. Dear one, we did not invent these things from thin air—the facts are for your research and scattered all about.

LUCIS TRUST

We have been through the Satanic practices in *SATAN'S DRUMMERS* [*Phoenix Journal* #9] and now have projected the total likeness within the Roman Catholic convents. I'm sorry, chelas, this is what your world has become and it is so very entangled that it is all but impossible to be in the sorting from all aspects which would bring you comfort. There is no comfort and it would appear there is no way in which to turn—oh yes, there is—back unto the Laws of Creation/Creator. Stop playing of all of the games to escape and allowing the continuing of Satan's games and the path will become quite clear indeed.

The "One Worlders" of the Lucis Trust are worthy of special note here, because they include members of the American Elite such as Robert McNamara—who not only served as Secretary of Defense during the Viet Nam War, but later took over the post of World Bank head. In both roles, he undermined the foundations of America's republican greatness. Further, it is filled with members which are currently in your attention and cannot help but be consciously known to you whereby it is less hearsay.

The Lucis Trust originally called itself openly the Luciferian Trust. The name change came about for obvious reasons. Founded in the 1920s by Alice Bailey, it was an offshoot of the theosophist movement. Bailey, an Episcopalian, became a leading disciple of the Russian Theosophist Madame Helena Blavatsky, who claimed to gain mystic instructions from "great white chiefs" located in Asia.

These Luciferians are committed to advancing Madame Blavatsky's expressed doctrinal commitment to "oppose the materialism of science and every form of dogmatic theology, especially the Christian, which the Chiefs of the Society regard as particularly pernicious". The society has a pagan pantheon whom they would substitute for God, which includes, besides Lucifer, an "external hierarchy" of "ascended masters". Clearly, the Lucis Trust is sympathetic to the ideology of the Process Church.

Rightfully, many people have blamed Robert McNamara, as well as Henry Kissinger, for the dismal role of the United States in the Viet Nam War. One of the most well-remembered horrible things McMamara did, was to introduce the notion of a body count in place of tactical military victories. Some Special Forces members were even asked to show the scalps of their victims as substantiation for the body count of the day. At the time, McNamara was a practicing occultist. And you ones thought the Indians were uncivilized.

Listen to this drivel. McNamara practiced Luciferian rituals such as “bathing in the full moon” on Roosevelt Island along the Potomac River. The Luciferians worship the Sun in place of God, but practice lunar festivals because they can stare at the Moon’s reflected sunlight without being blinded. Do you see how closely the rituals follow the sacred reverence shown by the ancient natives? Only the natives, in their original God-ness, did not worship the Sun instead of God—they remembered the God, ATON, through the symbol of the Sun as oneness of central source. Lucifer’s children worship in the night because they cannot bear the light of day, my chelas.

The Lucis Trust now claims to prefer the figure of Satan to that of Lucifer, its members have been among the most active proponents of every form of Satanic cultural subversion, including forcing sex-education curricula through the U.S. public school system right down through your first grades and kindergarten. These curricula treat homosexuality and promiscuity as acceptable alternate lifestyles to the traditional family. Therefore the babes go forth to seek and find fulfillment and there is none to be found—for these practices do not work at any age.

McNamara is an advocate of **population reduction**, and has used his position at the World Bank, to impose these policies. We touched on some of this in prior writings and I shall cover them again but I prefer to move on in this portion. The World Bank withholds funds from some of the starving countries and Nature will do the rest, for man cannot live in the physical without food—and food requires money in your time and age.

Shudder now—the Lucis Trust-affiliated German-language magazine *2000: Magazine for New Consciousness* was so totally unbridled in its admiration for Mikhail Gorbachov that it called him a “pathfinder for the new consciousness”. In the same issue, it detailed a prophecy by the Mystic, Edgar Cayce, who had written: “From Russia, comes the hope of the world.” Well, that simply is not what Cayce meant. Do you see how you can take a phrase out of sequence and context and change its meaning entirely? It happens every reading of these *Journals*, also. Language, and especially written language, is impossible to insure non-tampering with meaning and concept. This same magazine featured favorable coverage of Vladimir Lenin, whom it claimed was not only an occultist, but had participated in ecstatic dances held in the occultist center located in Ascona, Switzerland. Now how many of you would know whether or not that is truth? Do you see how easily lies and ideas can be perpetuated? That would hardly seem like the Vladimir I recognize—although by his very nature he would have to be called an occultist, for occult simply means “beyond the knowing”. Takes all the fun out of it, doesn’t it?

OH, NOT GOOD OLD DONALD KEYS

There are many who will come into your attention which will hurt your feelings most deeply, chelas, but it is simply the way it IS, so don’t get yourselves bent all out of shape—no one expected you to know the facts; that is why we are going through all of this work on these *Journals*. The one labeled Donald Keys will bring pain to many of you. Not that his intention was evil, but the works produce evil. He was very instrumental in the Lucis Trust. You see, these ones are laying the groundwork for a New Age “Christ”. Donald Keys was very, very busy in networking and made a most provocative statement: “... don’t think for one moment that you can have a world government without a head!”. Now Sister Thedra was pretty well set up to produce one that could be sold to the masses and there you have much of the difference in what Sister calls Dharma’s Sananda and hers. It is, further, why Sister said, a couple of years ago, that she felt

Gorbachov was “one of us” and stated that she “really liked him”. Well, at that time he was pressing harder for peace than were your leaders, but that does not make him a worker for the Lighted Godhead.

Donald Keys was a former World Federalists representative to the United Nations, a founder of SANE, and co-founder of Planetary Citizens along with Norman Cousins. You have to begin to see how the threads begin to fill the tapestry.

Now you of my little group who know Donald Keys will remember a few things from his own lectures. He has always had unlimited access to UN leaders. He frequently writes speeches for its ambassadors. He was formerly employed by Lucis Trust and is still very active. Yes, this is the same one who wrote the Foreword to Sister’s book of Sananda. You see, at some point in trying to “make everything right and OK” these ones are seduced by the evil plan itself and fall prey to “The Plan”. The tragedy is not that there is a plan for world domination. What they fail to recognize is that “The Plan” is for capture of their souls.

Donald Keys exercises no small degree of influence over the U.N. international body. He boasts of having started many a trend at the United Nations. As a gifted speechwriter, he composes speeches for UN ambassadors. He enjoys his boasting about his impressive influence. He once gave instructions as to how “to start a trend”: “First you write a speech for one ambassador. And then you write a speech for a second ambassador praising the first ambassador for the speech he just gave! That’s how you start a trend.” Can’t you just see old Daniel saying, “but he shall come in peaceably and obtain the kingdom by flatteries!”

In all fairness, chelas, the average peace demonstrator, etc., is not working with ulterior motives. People believe that which they are told and if it sounds as if it is for the good of mankind, somehow, and doesn’t require giving up anything carnal—let’s have a go at it!

One of the most important disarmament groups is S.A.N.E. Donald Keys helped organize and lead it. Familiar inside/out with the Alice Bailey writings, Donald Keys once worked for Lucis Trust as an Arcane School administrator. His open contributions to that organization continue through his speeches and articles in their *BEACON* magazine. Another very important group of people in the peace network are the World Federalists. Donald Keys represented them at the UN for many years and his influence continues.

DISARMAMENT RELATIVE TO “THE PLAN”

Well, now what good citizens could quarrel with the need to remove nuclear tensions from the world? Undoubtedly it has substantially contributed to the stress and anxiety of modern living and caused “men’s hearts to fail for fear looking after those things coming upon the Earth”.

However, the little plans do not stop with mere disarmament. There is ever so much more to “The Plan”. Occult initiates plugged into “The Plan” also believe those nuclear weapons must be put into the hands of an international authority—The United Nations, OR AN EQUIVALENT AGENCY.

New Age Children of Light—watch the magic hands for someone along the way turned off the light. The plan goes something like this: “Called The American Movement of World Government, it says: ‘A world authority must control all nuclear weapons and materials and destroy all the nuclear weapons in the world.’” Among the advisory board in this matter are/were, American Humanist Association president Isaac Asimov (also Planetary Citizens); Albert Szent Gyorgi; David Browder, president of Friends of the Earth; and Paul Ehrlich, a member of the Club of Rome.

They happily said there was an “international police” as seen in Lebanon. But, they feel that is not enough. They continue, “But clearly, it cannot function effectively for permanent peace-keeping if its presence depends on consent of the combatants.” “It needs authority to keep it in being and in place. It needs unified international control.”

Does this not sound ominously like Donald Keys’ declaration: “Don’t let anyone think for a moment that you can run a planet without a head.”

Ah, the group’s admonitions and suggestions sound too good at first viewing—“peace in the world by force”? They have published “advertisements” and international support has steadily grown albeit not like wildfires.

“America and Russia have sustained such losses in world leadership—mostly through their own follies and mistakes—that the proposal for world peace institutions needs to come from powers that cannot be accused of imperialist ambitions... The Scandinavian countries, almost certainly, even now stand ready to propose a world constitutional assembly... They could be joined immediately by West Germany, Mexico, Japan, probably Canada, India (where there is a bill in Parliament for it), Sri Lanka, France, Italy and many others. At least five of these nations have appropriated money to study the problems of world authority... a protective world government could be created faster than half-hearted, haggling, warhead-counting disarmament treaties which have never yet endured, or prevented war... A world constitutional assembly could be convened within a few months. Say in Athens, where democratic government first began. With the world watching and pushing, a constitution could be ready in six months. Ratification could take only a preponderant majority of nations, and less than a year.”

The *Bible* prophesied it, chelas, and indeed someday it will happen. But when it comes it will not be a “peaceful solution”. Both *Bible* prophecy and “The Tibetan’s” boastings tell you it will instead be a “Final Solution”.

BACK AT THE LUCIS TRUST

The Lucis Trust works closely with the Cathedral of St. John the Divine.

Bishop Moore was a patron of the notorious Jim Jones, while Jones was still in Indiana, and before Moore had taken up his bishopric in New York, with its seat at St. John the Divine. Once in New York City, Moore personally, in 1977, ordained as an Episcopal priest a militant lesbian, Ellen Marie Barret. She was quoted in your *Time* magazine flaunting her homosexuality, saying that her lesbian love affairs gave her the “strength to serve God”. I certainly hope I end up with a bunch of “strengthless wonders”, for I doubt God is helped much by any such affairs what-so-ever. An aide to Moore, Canon Edward West, has been accused of having patronized some of New York City’s most seedy sado-masochistic “private clubs”, such as the infamous Mineshaft, where police raiding the premises found the remains of human flesh.

A dean of the Cathedral, the Very Reverend Dean James Morton, as director of the United Nations’ Temple of Understanding, has been in the forefront in fostering Soviet-American relations. On April 11-15, 1989, the Temple co-sponsored a global Conference of Spiritual and Parliamentary Leaders on Human Survival, which was held in Oxford, England, and was attended by Morton and Yevgenii Velikhov, vice chairman of the Soviet Academy of Sciences, as well as three other Soviet Central Committee members. A return conference is planned for 1990 in Moscow.

In February 1988, the Temple of Understanding hosted a two-week fling at the Cathedral of St. John, where dozens of Soviet representatives were feted by the American Liberal Establishment. Father Louis

Dolan, a Roman Catholic priest who is on the board of the Temple, took charge of this. He is a recent traveler to the Soviet Union, and he is on the board of the Center for Soviet-American Dialogue which also includes such New Age figures as Barbara Marx Hubbard. (But that is for another day, please.)

NETWORKING "THE GLOBAL VISION"

The world was to be prepared for the New Order, the New Religion, and the New "Messiah" in many ways—mental as well as physical. Occult literature details this coming "New World Order" or "New Order" as a "Golden Age". Conversely, the *Bible* describes it as a time of sorrow. Detailed preparation for that "New World Order" is very much in progress.

I'm sorry, chelas, but things got hooked into the Satanic workshops and he ruins everything he touches if it is allowed. Let us examine the possibility of this work being influenced by occultism and further, we shall see that much demands an occultic world view for its very acceptance.

CLUB OF ROME AND GOALS

Aurelio Peccei and Alexander King co-founded this influential network of financiers, industrialists and scholars in the late 1960s. Yes, it is hard to keep them separated in your minds but it is the concept; do not labor over separation at this time, for you will simply distract yourselves. Just read and it will begin to come clear if you refer back to prior *Journals* on the subject.

A capable executive, Peccei served as Chief Executive Officer for the Olivetti Corporation and for Fiat Automobiles. His writings clearly reflect an occult world view. They also reflected biases against orthodox Christianity. This, in itself, is often wise but not in the manner in which he projected.

The Club of Rome continues to work closely with a number of occult political-action organizations including Planetary Citizens, the International Center for Integrative Studies (ICIS), Lucis Trust, and the Global Education Associates. Indeed, its "Goals for Mankind" reports United Nations Goals were submitted by Donald Keys, himself. Keys is an activist with Lucis Trust and, remember, a former administrator of that organization.

Let me point out how it works so visibly if you but look carefully to that which is being projected.

"The institutionalization of faith has not always had happy results. Certain points of doctrine have been magnified, provoking schisms, apostasy, and the denunciation of what are claimed to be heresies. The official truth has become impossible to question: and in order that it never should be questioned, ignorance and even superstitions have occasionally been encouraged. These structural inflexibilities and doctrinal introversions have helped to keep the major religions static even when the winds of change blowing through society have made clear the need to move from one cultural epoch to another. As a result, it is difficult even for their most sensitive and profound theologians and scholars to break out of a system frozen into formulations, reflecting the past, a system that cannot adapt itself or its doctrines to modern life. Religions now run the risk of becoming a timid rearguard, detached from the problems and aspirations of a bewildered and troubled humanity. And yet humanity has a profound need for spirituality. The anguish within the churches, the call for a new ecumenism to free them from their narrow confines, the widespread interest in minor cults and a return to a respect for Nature—an ecological respect this time—are all symptoms for this need. They are encouraging symptoms, for without a sincere spiritual awakening the renaissance of our true humanity will be impossible."

Ok so far? It goes on, "We may also ask whether it was perhaps to justify our immense aspirations in our own eyes that we were led to conceive God, and thus to attain the privilege—alone among all forms of life—of entering into communion with Him: and even to go so far as to assert that the Almighty had chosen to create us in His own image. Is not this anthropomorphism of the Creator, which is not exclusive to the Christian faith, in reality a form of deification of man?"

Of course, you get the point. It is confusion and gobble-de-goop all over the place. Mostly absolute truth and then a thrust at you for doing that which they do in disguise. While ultimate motives are impossible for anybody but God to really ascertain, it does seem ironic that the very planners who thrust arrows have no qualms about playing God themselves.

'U.S. PLANS TO MERGE IRAQ, JORDAN AFTER WAR'

SILAMABAD—The United States is working on a plan to merge Iraq and Jordan into a unitary kingdom to be ruled by the Hashemite dynasty headed by King Abdullah of Jordan with Amman as the capital of the proposed new country, reveals a startling report made available here on Friday.

The idea to unite Jordan and Iraq in a pro-U.S. Hashemite kingdom after an American war is aimed at “ensuring a stable post-war Iraq”, according to *Stratfor*, a strategic forecasting think tank based in the U.S.

It says that as a U.S. war against Iraq nears both Washington and Middle Eastern players are working to make sure the expected American victory will result in strategic long-term gains. “The idea of a central Iraq populated by Sunni Arabs joining with Jordan to form one Hashemite kingdom is being considered as one way to secure such gains,” *Stratfor* says.

The plan, authored by U.S. Vice President Dick Cheney, was first discussed at an unusual meeting between Crown Prince Hassan of Jordan and pro-U.S. Iraqi Sunni opposition members in London in July.

The plan’s goal in Iraq is to create a united Hashemite kingdom embracing Jordan and Iraq’s Sunni areas. In a nutshell, the plan involves uniting Jordan and Sunni-populated areas of Iraq under the rule of the current Jordanian regime.

The report says this will be done if Iraqi Sunni leaders “appeal to King Abdullah with such a request, which has a weak but still legally valid justification, as Abdullah is the second cousin of the last Iraqi king, Faisal II, who was overthrown in 1958”. The report says the plan will bring strategic benefits to the U.S., Israel and Jordan.

Benefits for U.S.: The fact that the Western-based Iraqi opposition completely depends on Washington will help the “Hashemite Plan”. The U.S. favours the plan because the current goal of replacing Saddam Hussein with a pro-U.S. Iraqi government still would not guarantee long-term U.S. control over the territory and its oil.

“First, it may become too hard for a new government in Baghdad to effectively control the whole country, even with U.S. troop support. An example is Afghanistan, in which the government of President Hamid Karzai still controls only the capital,” the report says.

“Second, the new government’s attempts to establish control over all of Iraq may well lead to a civil war between Sunni, Shia and Kurdish ethnic groups, with U.S. troops caught in the middle. The fiercest fighting could be expected for control over the oil facilities,” it adds. Uniting Jordan and Iraq under a Hashemite government will give U.S. several strategic advantages.

“First, the creation of a new pro-U.S. kingdom under the half-American Abdullah will shift the balance of forces in the region heavily in the U.S. favour,” the report says. After eliminating Iraq as a sovereign state, there would be no fear that one day an anti-American government would come to power in Baghdad, as the capital would be in Amman.

“Current and potential U.S. geopolitical foes Iran, Saudi Arabia and Syria would be left isolated from each other, with big chunks of land between them under

control of the pro-U.S. forces,” according to *Stratfor*.

“Equally important, Washington would be able to justify its long-term and heavy military presence in the region as necessary for the defence of a young new state asking for U.S. protection and to secure the stability of oil markets and supplies. That in turn would help the U.S. gain direct control of Iraqi oil and replace Saudi oil in case of conflict with Riyadh,” it adds.

The richest oil areas would not go to the Hashemite kingdom but to a widely autonomous Kurdish region that still will be formally a part of the Hashemite state. To make sure the Kurds don’t upset U.S. ally Turkey by declaring an independent state, U.S. will have the excuse of deploying its forces in the Kurdish region, with new bases located just next to oil fields in areas such as Kirkuk.

“Washington then will be able to offer the new Hashemite kingdom as a model for other Arab states, combining what the Arab masses see as the advantages of a traditional monarchy with the benefits of a U.S. alliance,” the report says.

“The potential combination of educated Iraqis, U.S. aid and military assistance, and oil revenues might help the new state become a beacon for the Arab world to follow,” it adds. Were more states to adopt this example, the geopolitical influence of both Saudi Arabia and Egypt would decline, making it easier for Washington to deal with them.

“In case of a future conflict with Saudi Arabia or Iran, U.S. forces would be in the ideal position to strike not only from sea but also from land by using new bases in the Hashemite kingdom and the Kurdish region,” the report reveals.

Benefits for Israel: “Iraq, arguably Israel’s most determined foe, will be eliminated and Baghdad’s end will deprive the Palestinians of much financial and other assistance, which can reduce the effectiveness of attacks against the Jewish state.”

Benefits for Jordan: “King Abdullah will vastly expand his role and prominence in the region with a joint Hashemite state, becoming the second-most important U.S. ally after Israel. In addition to his huge territorial gains, he also will get a chunk of Iraqi oil.

“And Palestinians, who currently make up half of Jordan’s population, will become a minority in the new state, with much less potential to stir up trouble,” the report adds.

[JR: What a brilliant U.S./Israeli plan to divide and effect an eventual takeover of the whole Middle East. Our mole in the ground, V.P. Cheney has been busy creating our vision of what the future of the Arab countries should be like. The U.S. is not working to create a new government for Iraq with the Shiites who make up a 65% majority, but with the Sunnis who are a minority. How can the Sunnis, as a 13% minority, bring stability and fairly represent the interests of the Shiite and 19% Kurdish population? The Hashemite ruling classes of Jordan have long been in the control of the U.S. and Israel ever since they fought with the British for their “independence”, under Lawrence of Arabia. How deceived they were then and how deceived they are now. In 1951 King Abdullah of Jordan was assassinated because of suspicions he was too accommodating in serving Israeli/ U.S. interests, and in 1959 King Faisal II and his family were killed and that ended the Hashemite rule in Iraq, when Iraq became a republic. It appears as though Jordan is being used as a

wedge that will divide and end the ruling and political factions that comprise the Arab states. This will instigate and further the regime changes that have long been conspired by the world’s Zionist plotters. The U.S., Britain and Israel are setting up puppet dynasties and not democracies to deceive and betray the Arab people, again. The Elite has used successfully these same plans for centuries... and we have yet to catch on.]

WASHINGTON BRIEFS ISRAELI TEAM ABOUT PLANS FOR IRAQ WAR

An Israeli security delegation arrived in Washington yesterday to consult with U.S. officials ahead of a possible war in Iraq. The Israeli team—comprised of Defense Ministry Director General Amos Yaron, his deputy Kutli Mor, and IDF Plans and Policy Directorate head Major General Giora Eiland—will be meeting with Deputy Secretary of Defense Paul Wolfowitz, Deputy Secretary of State Richard Armitage, and other top U.S. officials.

The delegation’s invitation to Washington is a sign that the Bush administration has decided to move to a new stage in its contacts with Israel, following the end of the siege on the Muqata compound in Ramallah at the start of the week. Quiet discussions on the preparations for a war with Iraq have been conducted for a few months, but the Bush administration has decided to “raise their profile”.

Prime Minister Ariel Sharon met on Wednesday with U.S. Ambassador Dan Kurtzer. It was Sharon’s first such meeting since the withdrawal from the Muqata. The discussion focused on the water dispute with Lebanon prompted by the construction of the pumping station at the Wazzani River, a tributary to Israel’s Hatzbani River. Israel wants the Bush administration to step up pressure on Syria and Lebanon, to avoid them diverting water from a major source of Israel’s water supply. Sharon updated Kurtzer on the construction progress at the pumping station.

The Bush administration—buoyed by its success in persuading Israel to call off the siege on Palestinian Authority Yasser Arafat’s compound—is now calling on Arab states to play a role in the resuscitation of PA reforms. Officials in Washington believe that the strengthening of Arafat’s status as a result of the Muqata siege is a transient phenomenon. The IDF withdrawal from the Ramallah compound created a three-week “window of opportunity” for the resumption of PA reforms, prior to the presentation of a new cabinet to the Palestinian legislative council. The U.S. wants Egypt, Syria and Jordan to lobby for the appointment of a Palestinian Prime Minister.

In addition, the U.S. administration has asked Israel to accelerate the transfer of tax revenues to PA Finance Minister Salam Fayyad. The Bush administration wants to set a clear timetable for the transfer of monies owed to the PA and is prepared to send auditors to Israel to monitor the PA’s use of the money. Fayyad will arrive in Washington next week, and receive VIP treatment. He will meet with National Security Adviser Condoleezza Rice and Secretary of State Colin Powell.

Alongside preparations for an attack on Iraq and efforts to encourage internal PA reform, State Department and White House officials are also pondering ways to resume negotiations between the PA and Israel.

The U.S. and its partners in the international “quartet” (Russia, the European Union and the United Nations) have agreed on a three-stage process leading to resumed final status negotiations. By mid-2003, the Palestinians are to implement security reforms, and the IDF roll back to positions it held before the intifada erupted. In 2003, a Palestinian state is to be established with temporary borders. In 2004, final status talks would begin.

[JR: Here is a headline story that we have not had the

privilege of seeing in our Zionist-controlled print or media. These are the well laid plans and details for the takeover of the Middle East, that the Bush administration would rather not be made known to us fellow Americans. The briefing with Israel is to solidify and coordinate our joint plans for our war against Iraq and to also target other Arab states we deem hostile. One strategic and vital target of operation will be the destruction of the water-pumping station at the Wazzani River in Lebanon. I wonder how far down their list of priorities is the food and shelters that the Palestinians are in such a desperate need of. It would speed along the creation of a Palestinian state if the three-stage program agreed to by Russian and Europe were backed up with a strong warning to the U.S. and Israel that they must comply with guarantees of their full support and unimpeded cooperation towards that end. Without this it will just afford another stall or delay so that the U.S. and Israel can move along their plans for the exile of all Palestinians to the newly recreated state of Iraq.]

WILL THE U.S. REAP WHAT IT HAS SOWN?

Will Saddam Hussein unleash botulinum toxin, perhaps nature's deadliest poison, and other viruses and chemicals if the United States attacks Iraq?

Sen. Robert C. Byrd, D-W.Va., posed this question to the Senate on Thursday, based on documents obtained from different federal agencies.

"We have a paper trail," Byrd said. "We not only know that Iraq has biological weapons, we know the type, the strain, and the batch number of the germs that may have been used to fashion those weapons. We know the dates they were shipped and the addresses to which they were shipped.

"We have in our hands the equivalent of a Betty Crocker cookbook of ingredients that the U.S. allowed Iraq to obtain and that may well have been used to concoct biological weapons."

Those shipments included:

Between 1985 and 1988, the nonprofit American Type Culture Collection made 11 shipments to Iraq that included a "witches' brew of pathogens," including anthrax, botulinum toxin and gangrene. All shipments were government-approved.

Between January 1980 and October 1993, the federal Centers for Disease Control shipped a variety of toxic specimens to Iraq, including West Nile virus and Dengue fever.

The U.S. Commerce Department and CDC provided lists of these shipments. "The Defense Department ought to have the same lists, so that the decision-makers will know exactly what types of biological agents American soldiers may face in the field," Byrd said.

"At last week's Armed Services Committee hearing, Secretary Rumsfeld said he had no knowledge of any such shipments and doubted that they ever occurred. He seemed to be affronted at the very idea that the United States would ever countenance entering into such a deal with the devil.

"Secretary Rumsfeld should not shy away from this information. On the contrary, he should seek it

out," Byrd said.

In its Sept. 23 edition, *Newsweek* magazine published an article discussing the viruses, poisons and gases that the U.S. sent to Saddam Hussein in the mid-1980s. At that time, the U.S. regarded Iraq as a potential ally against Iran's Ayatollah Khomeini.

Byrd criticized Rumsfeld for failing to answer questions he asked last week about these shipments to Iraq during an Armed Services Committee hearing.

"I repeat today what I said to him then," Byrd said. "In the event of a war with Iraq, might the United States be facing the possibility of reaping what it has sown?"

Calls to the White House press office on Thursday afternoon were referred to the Department of Defense, where no one returned a call. One woman at the White House asked, "How do you spell Byrd?"

Federal documents and a United Nations Security Council report document a direct connection between periods when Iraq received toxins and viruses from the U.S. and the periods when Iraq developed biological weapons.

Byrd closed his speech by asking what the future holds.

"The role that the U.S. may have played in helping Iraq to pursue biological warfare in the 1980s should serve as a strong warning to the president that policy decisions regarding Iraq today could have far reaching ramifications on the Middle East and on the United States in the future.

"In the 1980s, the Ayatollah Khomeini was America's sworn enemy, and the U.S. government courted Saddam Hussein in an effort to undermine the Ayatollah and Iran. Today, Saddam Hussein is America's biggest enemy, and the U.S. is said to be making overtures to Iran."

The Bush administration is also discussing whether to arm groups of ethnic dissidents, such as the Kurds, in Iraq.

"Could the U.S. be laying the groundwork for a brutal civil war in Iraq? Could this proposed policy change precipitate a deadly border conflict between the Kurds and Turkey?" Byrd asked.

He again urged caution. "Decisions involving war and peace," he said, "should never be rushed or muscled through in haste. Our founding fathers understood that, and wisely vested in the Congress, not the president, the power to declare war."

Byrd said Congress must consider Bush's requests for new war powers "carefully, thoroughly, and on our own timetable... and avoid the pressure to rush to judgment on such an important matter".

[JR: Our entanglements with Iraq, including the Gulf War, are nothing more than damage control. We armed Saddam Hussein. We funded him. We gave him the worst horrors from Pandora's Box. What is also worthy of note is that the shipments did not cease until Bill Clinton Replaced George Bush the 1st in October of 1993. WAR CRY... THE CASE FOR REGIME CHANGE

The truth as seen by the enemy

NEW YORK—Making the case for United Nations intervention against the United States, Iranian President Mohammad Khatami told the organization yesterday that military action will be "unavoidable" unless the U.S. agrees to destroy its weapons of mass destruction.

In a much-anticipated speech to a special session of the UN General Assembly held in Brussels, Khatami launched a

blistering attack against American leader George W. Bush, accusing him of defying UN resolutions and using his country's wealth to line the pockets of wealthy cronies at a time when the people of his country make do without such basic social programs as national health insurance.

"Nearly two years ago, the civilized world watched as this evil and corrupt dictator subverted the world's oldest representative democracy in an illegal coup d'tat," said Khatami. "Since then the Bush regime has continued America's systematic repression of ethnic and religious minorities and threatened international peace and security throughout the world. Thousands of political opponents and ordinary citizens have been subjected to arbitrary arrest and imprisonment. Basic civil rights have been violated. This rogue state has flouted the international community on legal, economic and environmental issues. It has even ignored the Geneva Conventions on the treatment of prisoners of war by denying that its illegal invasion of Afghanistan—which has had a destabilizing influence throughout Central Asia—was a war at all."

Khatami said the U.S. possesses the world's largest arsenal of nuclear weapons, weapons "that, when first developed, were used immediately to kill half a million innocent civilians just months after acquiring them. No nation that has committed nuclear genocide can be entrusted with weapons of mass destruction."

"Bush has invaded Afghanistan and is now threatening Iraq. We cannot stand by and do nothing while danger gathers. We can't wait for this tyrant to strike first. We have an obligation to act preemptively to protect the world from this evildoer," Khatami said.

As delegates punctuated his words with bursts of applause, Khatami noted that U.S. intelligence agencies had helped establish and fund the world's most virulent terrorist organizations, including al-Qaida, and the Taliban regime that harbored them. "The U.S. created the Islamist extremists who attacked its people on September 11, 2001," he stated, "and Bush's illegitimate junta cynically exploited those attacks to repress political dissidents, make sweetheart deals with politically-connected corporations and revive 19th Century-style colonial imperialism."

Khatami asked the UN to set a deadline for Bush to step down in favor of president-in-exile Al Gore, the legitimate winner of the 2000 election, the results of which were subverted through widespread voting irregularities and intimidation. "We favor not regime change, but rather restoration and liberation," he said. In addition, Khatami said, the U.S. must dismantle its weapons of mass destruction, guarantee basic human rights to all citizens and agree to abide by international law or "face the consequences".

Most observers agree that those "consequences" would likely include a prolonged bombing campaign targeting major U.S. cities and military installations, followed by a ground invasion led by European forces. "Civilian casualties would likely be substantial," said a French military analyst. "But the American people must be liberated from tyranny." Khatami's charges, which were detailed in a dossier prepared by French President Jacques Chirac, were dismissed by a representative of the American strongman as "lies, half-truths and misguided beliefs, motivated by the desire to control a country with oil, natural gas and other natural resources." National Security Minister Condoleezza Rice denied that the U.S. maintains "weapons of mass destruction" and invited UN inspectors to visit Washington to "see for themselves that our weapons are designed only to keep the peace, subject of course to full respect for American sovereignty."

The UN is expected to reject any conditions for or restrictions on arms inspections.

Experts believe that the liberation of the United States will require a large ground force of European and other international troops, followed by a massive rebuilding

program costing billions of euros. “Even before Bush, the American political system was a shambles,” said Prof. Salvatore Deluna of the University of Madrid. “Their single-party plutocracy will have to be reshaped into true parliamentary-style democracy. Moreover, the economy will have to be retooled from its current military dictatorship model—in which a third of the federal budget goes to arms, and taxes are paid almost exclusively by the working class—to one in which basic human needs such as education and poverty are addressed. Their infrastructure is a mess; they don’t even have a national passenger train system. Fixing a failed state of this size will require many years.”

[JR: One point to make clear here is that by replacing Pres. Bush with the “exiled” Gore you won’t necessarily bring about a regime change here in America. The same hostile and intractable foreign policies will be carried out and the Zionist war machine will continue its course full speed ahead under the direction of Sharon and his Likud party. WHEN SWITZERLAND DISBURSES GOLD PROFITS, THE ANTI-SEMITES RAISE THEIR HEADS

A small but decisive majority of Swiss citizens decided not to establish a Solidarity Fund for the needy with the profits from the sale of surplus gold in the national bank. Some of the money for the fund was designated for needy victims of the Holocaust.

In a referendum held at the end of September, 52 percent of voters rejected the government proposal to distribute some \$500 million equally among three benefactors: the Swiss national social security system, the governments of the Swiss cantons and the new Solidarity Fund, whose purpose is to aid the victims of “racial persecution” worldwide.

On the eve of the referendum, Swiss President Caspar Villiger urged citizens to support the proposal. Opposing him was billionaire Christoph Blocher, a Swiss parliament member from an extreme right-wing party, who embarked on a malevolent campaign against the proposal, whose initial draft had specifically mentioned Holocaust survivors as eligible recipients. Blocher had also been one of the leaders of the campaign against the arrangements with the Swiss banks regarding the deposits left by Jews who perished in the Holocaust.

Following Blocher’s campaign against the proposal, the words “Holocaust survivors” were deleted from the detailed list of eligible recipients, in the hope that the general definition would have more of a chance of winning approval.

Blocher continued his battle, claiming that the idea of the Solidarity Fund is “the result of blackmail by Jewish circles in the United States,” and he obtained enough signatures to force a referendum.

The government proposal concerned the sale of some 1,300 tons of gold from the storerooms of the national bank. These are gold surpluses over and above the reserves required to back up the Swiss currency. The sale of half of the surpluses has already brought the bank some \$6.3 billion, and a similar sum will be earned from the sale of the second half.

In keeping with the proposal, the revenues themselves will remain a national deposit in the bank and only the interest they accrue is designated for distribution.

Blocher’s success in foiling the Solidarity Fund can be viewed as the success of his anti-Semitic propaganda, or at least an expression of the opposition of about half of the Swiss to any more assistance to victims of racial persecution (and not just Jews). It is, however, worth remembering that according to the government proposal Jews and other needy persons would actually have received only a few tens of millions of dollars. Most of the money

was designated for internal Swiss purposes. ...

After the vote Blocher hastened to announce that the failure of the establishment of the Solidarity Fund proved that “it is impossible to blackmail the Swiss people”, and his reference, of course, was to “Jewish blackmail”. It is perhaps more relevant to ask if the main reason was that the Swiss do not love Jews, or whether they simply don’t like giving away money—even to themselves?

Even more important, however, than the question of the influence of Blocher’s anti-Semitic slogans is an examination of the effect of the affair regarding the return of the deposits of Holocaust victims. Did the shame of the Swiss in light of the revelation of the attempt to conceal and steal deposits belonging to Holocaust victims increase or decrease anti-Semitism among the public? Did the negative phenomena in the battle over the deposits—the demands of lawyers for millions of dollars in handling fees and, on the other hand, the anti-Semitic statements of those opposing return of the funds—settle permanently in the Swiss consciousness?

Public opinion polls on this issue have not yet been published, although signs of such a trend can be found in articles and speeches by politicians. In the absence of specific surveys, it is interesting to see how Swiss Jews themselves feel about the changes in their gentile neighbors’ attitude toward them. The new Swiss-Jewish weekly *Tachlis* (purpose) conducted an opinion poll last month among 540 Jews, a substantial sample considering the Swiss Jewish population stands at about 18,000.

The poll showed that 58 percent of those surveyed sense a deterioration in the status of the Jews in the past two years. Forty-one percent feel their status has not changed and only 1 percent feel their situation has improved.

Regarding expressions of anti-Semitism, a third of those surveyed said they felt no change while 38 percent believe there has been an increase; among them, 77 percent feel that this increase is because those who hate the Jews now dare, more than ever, to openly express their feelings.

Some 18 percent—almost one in five—of those surveyed said that since the beginning of 2002, they have received comments or letters of an anti-Semitic character. This figure was 11 percent for the whole of last year, and that is an increase of over 60 percent in the incidents of personal experience with verbal anti-Semitism. It is interesting to note that Jews in the French-speaking regions feel a more pronounced rise in anti-Semitism than those who live in the German-speaking regions.

It is quite worrisome that young Jews (to age 34) are reporting a much larger number of encounters with anti-Semitic phenomena than older Jews. Perhaps it is not surprising, then, that according to the survey, Swiss Jews have heard a lot more criticism of Israel’s policies in recent months than in the past. The same is being said by Jews in most Western European countries. In Switzerland 69 percent of those surveyed said they had experienced such criticism since the beginning of the year.

If there was ever any doubt, the referendum indicated almost unequivocally that there is a connection between Israel’s policies and the attitude toward Swiss Jews. Eighty-one percent of those surveyed feel that Israel’s behavior has “a very great effect” or “a significant effect” on the situation of the Jews in Switzerland.

Israel is always grateful for the support of Diaspora Jewry. In certain countries—and not just in the U.S.—the governments even take this support into consideration. It is clear, however, that this also works in the opposite direction. What the Israeli government does (or doesn’t do) affects the situation of the Jews no less, and perhaps even more, than the support of Diaspora Jewry affects the attitude of their governments toward Israel.

[JR: The truth is emerging and it is becoming obvious that the false Jews have gone too far in their exploitation of the Holocaust and its victims to extort money. The Jews who

live ordinary lives are becoming the targets of criticism and the situation is becoming uncomfortable for them. MAHATHIR CALLS UPON MUSLIMS TO USE OIL AS WEAPON

MALACCA (AFP)—Oil should be used as a weapon to protect the interests of Muslims, Malaysia’s Prime Minister Mahathir Mohamad said on Thursday. “If we reduce oil output, prices will rise. It can be used as a weapon to protect the interest of Muslims,” Mahathir said.

Malaysia is due to take over the chairmanship of the Organization of the Islamic conference (OIC) next year.

“Oil is the only thing Muslim nations have which is needed by the rest of the world. If they can cut back on supply, people will not be oppressive on them,” Mahathir said. ...

“When we are weak, we will be exploited. We are now seeing worldwide Muslims are being exploited.

“To avoid exploitation, we must be strong. If we have oil, it can be used as a weapon.

“OPEC (the Organisation of Petroleum Exporting Countries) should control the price of oil but there is no unity in OPEC. When the oil price goes up, there are other nations that increase output.”

Malaysia is an oil producer and was a net exporter of some six million tonnes of crude petroleum last year, but is not a member of OPEC.

Arab producers, accounting for half of world supplies, have not used the oil card since the 1973 crisis, despite repeated calls by Iraq and others for them to do so.

Washington in April dismissed Iraq’s latest call for oil to be used as a weapon on behalf of the Palestinians as “random musings”, saying the idea was not being taken seriously in the Arab world. ...

Previously seen as a critic of the West, Mahathir has emerged since the September 11 terror attacks as something of a spokesman for moderate Islam, defending the faith while excoriating extremists who resort to violence.

His government has arrested 63 alleged Islamic militants in a crackdown which began before the September attacks, some of whom allegedly have links to the al-Qaida network of Osama bin Laden.

But on Tuesday, Mahathir criticized the United States for what he called anti-Muslim hysteria after his country was placed on a list of “terrorist-risk” countries.

Those comments came after it was also revealed that he and his deputy prime minister were subjected to tough security checks during separate visits to the United States.

Abdullah was required to remove his shoes and belt, while Mahathir said a security agent who boarded his jet in New York during his trip to see Bush had behaved in an unnecessarily “rough” manner.

The U.S. embassy in Kuala Lumpur on Wednesday expressed regret for any inappropriate treatment of Malaysia’s leaders and pledged to try to ensure that it would not happen again.

Mahathir said on Thursday he accepted the U.S. apology but added: “I was in my private plane. I am not going to carry a bomb in a government plane. Their approach towards me was rough but that is their country. If they want to be rude, we don’t go to their country.”

[JR: The U.S. campaign by the government to promote tolerance towards Muslims and Arabs, is nothing but a façade to hide the Zionists’ loathing and hostility towards Muslims. Muslims and Middle Eastern officials entering our country are treated disrespectfully by security

If Mahathir is successful in his efforts to control the output and pricing of Asian oil, you can be sure that the media here in the U.S. is going to be engaged in the mother of all hate campaigns. The diatribes are going to be filled with venom and lies.]

CHIEF RABBI RECANTS ON RELIGIOUS TOLERANCE

The chief rabbi, Jonathan Sacks, has agreed to recant views suggesting religions can learn from each other following a meeting with conservative rabbis who threatened him with a charge of heresy.

Dr. Sacks, whose latest book *The Dignity of Difference*, represents a plea for religious tolerance, will have to revise its central message if it is ever republished.

The book—extracts of which were published in the *Guardian*—was praised for its tolerance and open-mindedness by reviewers, but condemned by orthodox and conservative rabbis for the implication that their religion might fall short of complete perfection.

In a statement released to the *Jewish Chronicle*, following a three-hour private meeting with 20 rabbis from Leeds, Liverpool and Manchester, Dr. Sacks conceded that "one or two sentences might be misunderstood." He promised to make "appropriate amendments" in the next possible edition.

The move will anger more liberal Jews already exasperated at previous back-trackings by the chief rabbi in the face of orthodox intransigence.

It represents a humiliating climbdown, negating the book's thesis, at the behest of deeply conservative synagogue leaders. In the past, they have complained about Dr. Sacks's attempts to build bridges with other religions and even his attendance at interfaith ceremonies such as the Queen's jubilee service at St Paul's Cathedral.

It is understood that one of the passages complained of was: "God has spoken to mankind in many languages, through Judaism to the Jews, Christianity to Christians, Islam to Muslims... no one creed has a monopoly of spiritual truth.

"In heaven there is truth, on Earth there are truths. God is greater than religion. He is only partially comprehended by any faith."

David Rosen, former chief rabbi of Ireland, told the *Jewish Chronicle* that he could see nothing objectionable in the words or ideas, describing them as "wonderfully presented".

Nevada Vs. Delaware: Private Vs. Public

Budget's "Tip of the Week" #16:

Response to the Often-Asked Question: What About Delaware?

"My friend said that her attorney said that the best place to incorporate is Delaware because that's where all the big corporations are based." Once again, there is SOME truth in this statement but there is much knowledge to be derived in understanding the differences between Nevada and Delaware corporations.

The fundamental distinction is that while Nevada's statutes create benefits for **private** corporations, Delaware's corporate statutes have principally been designed to benefit shareholders of **public** corporations. Many large, public companies that trade on various exchanges across the country incorporated in Delaware because Delaware's statutes provide the best protection of the rights of shareholders. In recognition of the foregoing, Delaware's corporate law with regard to corporate takeovers is the strongest anywhere in the country. And if you want to "go public" with your corporation some day, Delaware's onerous disclosure requirements probably won't bother you.

On the other hand, Nevada's provisions for establishing and maintaining privacy of ownership and control is unparalleled. In Nevada, ownership of a corporation is not a matter of public record: There is no prohibition against the use of bearer shares, there is no requirement for stock to be issued, nor is there any requirement for an annual meeting of stockholders. In terms of privacy of control, the use of nominee officers and directors has been a common practice for over 75 years. In addition, NRS "8.25" makes it a gross misdemeanor for anyone to even *attempt* to use a Nevada corporation's records for purposes contrary to the interests of the owners.

Delaware is NOT "tax-free". A Delaware corporation's taxable income is taxed at the rate of 8.7%. In addition, its franchise tax has a graduated rate depending on capitalization, amounting to a minimum of \$30 and a maximum of \$130,000.

Nevada's corporate law easily surpasses Delaware's in terms of protection of corporate officers and agents. Delaware has recently adopted a statute that allows a corporation to limit the liability of a director for monetary damages—but *officers* of Delaware corporations are still not covered. **The following acts of officers and directors would be protected under Nevada law, but are exposed to liability under Delaware statutes:**

1. Acts or omissions not in good faith;
2. Monetary damages occasioned by acts of officers (directors are now exempt);
3. Breach of a director's duty of loyalty;
4. Transactions involving undisclosed personal benefit to the officer or director;
5. Acts or omissions that occurred prior to the date that the statute which provides for indemnification of directors was passed and approved.

As a final point on the subject of Nevada versus Delaware, it is noteworthy that Nevada has **NO RECIPROCITY WITH THE IRS**; Delaware, like all other states, freely shares its data with the IRS.


