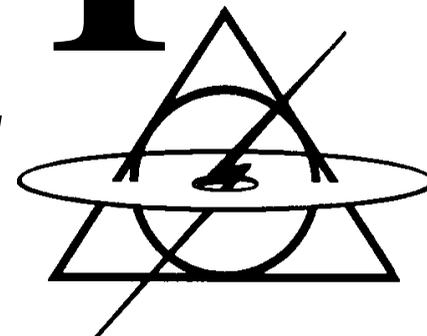

Most Of World's Gold Is In The Philippines

PHILIPPINE ACTIVISM AND THE VATICAN

The social unrest in the Philippines in the 70s and 80s was largely planned, funded and implemented by foreign and Filipino Roman Catholic churchmen and Cardinals from the **CITY OF SEVEN HILLS**, the Vatican City in Rome. Taking advantage of the much-publicized human-rights violations during the Marcos Administration, the Roman Catholic Church, with 2,000 years of experience on how to **MANIPULATE MAN** and his **DESTINY**, promoted **ideological subversion and fomented political unrest** in the remote barrios, in Catholic schools, convents, seminaries and right on the city streets.

Countless seminarians, nuns and priests left the security of their convent walls to give teach-ins, distributed subversive materials, marched on the streets, rallied and demonstrated in front of government offices and many, tragically, went to

the mountains to join the militant armed struggle. Some of them were killed during encounters with government forces.

All this idealism and sacrifice by “sincere” people was inspired by the Roman Catholic Church to bring **justice and relief** to the **SUFFERING POOR** of the Philippines, putting the blame on the government. What unwitting pawns to a **FOREIGN POWER**: the **VATICAN CHURCH**, still obsessed in playing the oldest game in the world called **DOMINATION!**

If the Vatican indeed shed tears over the sufferings of the Filipino people, they were nothing but crocodile tears. As boldly exposed throughout this book, it was the **HOLY ROMAN CATHOLIC CHURCH** that, for 1,500 years, **perpetrated injustice, oppression and exploitation** on those people it **LORDED OVER** with unequalled banditry and thievery, and how it squeezed and drained their wealth, dignity and future.

Observe what happened in the **Latin American** countries we quoted earlier. “The Indians always offered their labor without any payment whatsoever, as part of their contribution. This was not confined to the construction of church buildings; it became the rule in the Church’s vast tracts of land. The result was that the Church, in the long run, became one of the main instruments through which the impoverishment of the native races continued, until these were **reduced to complete destitution**... By the end of the colonial period, the Church owned an estimated **one half of the total wealth of Mexico, Peru, Colombia, Paraguay and Ecuador, and almost that proportion in ALL the other Latin American countries, while most of the remaining half** (of their wealth) **was ‘controlled by the clergy through mortgages’.**”

Is it any wonder, then, that those countries “evangelized” and colonized for centuries by the Roman Catholic Spain and Portugal, after having ravaged them, like young maidens, have **evolved into unjust societies and poverty-stricken nations?**

After the tractors and chainsaws of greedy and irresponsible loggers have gone through virgin forests, what do we see? Eroded forests, swollen rivers and flooded valleys! When the **TWO SWORDS OF POPE BONIFACE VIII**, brought here (Philippines) by the Spanish conquistadors, accomplished their centuries-long spiritual, cultural and material “rape” of the Philippine islands, (exactly as was wreaked upon all the Latin American countries) **the ROMAN CATHOLIC CHURCH left the Filipinos nothing but a desolate economy, a desolate society, a desolate system of worship, a desolate self-image and a desolate spirit.**

As a **THIRD WORLD** country today, brought by **this Church** to the wretched status of **beggars**, knocking at the doors of affluent nations for measly morsels of food and other amenities. Thanks, but no thanks, to the **HOLY Roman Catholic Church** with its ‘Liberation Theology’.

WHAT IS THEOLOGY

The Roman Catholic Church’s preaching of the Liberation Theology was supposed to redeem downtrodden Filipinos from poverty and oppression caused by the ‘unjust and oppressive Marcos dictatorship’. The ills of this country during the Marcos regime were not all caused by him. He merely inherited those same ills that were inflicted here by the Roman Catholic Church during the 377 years of lease to Spain for so much ‘pound of flesh’ by Pope Leo X. And even as this country celebrated its 100 years of independence from Spain (the **LESSEE**), Filipinos are still dependent on the Vatican (the **LESSOR**) as evidenced by the manipulation of the country by the Roman Catholic Church’s leftist indoctrination of the 70’s and 80’s. With that many blind followers (Romano Katoliko Sarado), the Liberation Theology gospel spread fast, far and wide.

If the Roman Catholic Church really means what it teaches in its Liberation Theology, this is what it should do. Instead of just making the suffering poor aware of their miserable condition (they called this “conscientization”) and organizing them to put pressure on the rich to distribute its wealth, this new theology should **first** acknowledge, confess and apologize that it was this Roman Church that put them in this pitiful condition in the first place. **Second**, it should rehabilitate the psychologically damaged Filipinos much like a traumatized child before a psychiatrist. In this case, it will be the offender (Roman Catholic Church) rehabilitating the victim (Filipino people) by promising to make amends. **Third**, this church, as an example to the rich, should dig into its overflowing coffers and distribute its enormous surplus wealth to the poor, thereby empowering them to start a new and dignified life.

This is the decent thing to do. **THIS IS TRUE LIBERATION THEOLOGY.** It is liberating to the church that confesses its sins and makes amends for them. It is liberating as well to the poor who will benefit from the honesty of that church.

Instead, what the Roman Church does today is to give pittance from its coffers to help the poor and drumbeat the rich to give to its charitable programs. A perfect example is here in Manila. Everyday on television a plea is heard showing street children and scavengers in the garbage dumps and asking generous souls to give to **CARITAS**. This program belongs to the billionaire Archdiocese of Manila and the announcer belongs to one of the super, super rich religious congregations in the world.

THE VATICAN POLITICS AND INTRIGUES

In the early 1930s, Europe was in a depression and Germany was financially bankrupt. An unknown party leader promised the German people that he could create jobs and boost its economy. The Germans dared him and put him in power. His name was Adolf Hitler. In June of 1933 the Vatican and

Roman Catholic Hitler signed a concordat for mutual protection and enhancement. Shortly after that, Hitler was loaded with money. He built a massive army and manufactured weapons for war. Then Hitler took Poland. Before 1918 there was no Poland. That land was a buffer zone to separate Germany from Russia. But when Hitler reclaimed it, England declared war on Germany.

In 1934 under Pope Pius XII, the Vatican, negotiated with a member of the Royal Family of the now defunct Madjapahit Empire, the Moslem-Christian Tallano clan in the Philippines. An agreement was reached that 617,500 metric tons of gold would be lent to the Pope. This was the same gold accumulated by the Southeast Asian Srivijayan and Madjapahit Empires during their glorious reign for 900 years that we treated in chapter IV of this book. In 1939 John Hay, accompanied by two members of the Tallano family and a certain Antonio Diaz, brought the gold to the Vatican.

Antonio Diaz, a man from Cabanatuan, was the 'alter ego' and trusted man of the Papal Nuncio in Manila. After World War II, in 1949, Diaz facilitated the safe return of 400,000 metric tons of that gold to the Philippines. It was received by Manuel Roxas, a certain Mrs. Camacho and a priest from La Union, Fr. Sobrepena.

A lease agreement was made between the Tallano clan and the Philippine government. The Central Bank of the Philippines became the HOLDER of that gold. That lease agreement will end in 2005.

For this purpose Diaz hired the services of Ferdinand E. Marcos. He was then a highly recommended brilliant young lawyer having attained notoriety when he successfully defended himself in the "Nalundasan Case" in 1939. For being Diaz's lawyer, Marcos was paid 5% from the principal. This was a hefty U.S.\$23 billion. Marcos also facilitated and arranged for the 217,500 metric tons of the Tallano gold to be deposited outside the Philippines. They are now in the various banks of Southeast Asia, U.S.A., the Bahamas, London, Switzerland and the Middle East.

[H: PAY ATTENTION! (!!)]

In Kuwait Marcos deposited 16,000 metric tons of the Philippine gold. Kuwait used to be part of Iraq but was made a separate and independent country by the English. In 1990 Saddam Hussein invaded Kuwait and carted away all the 16,000 tons of gold that belonged to the Philippines. The Americans came to the rescue of Kuwait in the Operation Desert Storm. President Bush, short of finishing the war and declaring victory over Iraq, withdrew his army. **That was because Saddam Hussein gave Bush 4,000 metric tons of the Philippine gold.** The American Hollywood movie about that war, *The Three Kings*, and its drama over the gold is not far from the truth.

In the future the remaining 12,000 metric tons of gold in Iraq will have to be wrested away from Saddam Hussein. This will need to be done by intimidation, blackmail or even war. But one thing is sure. This will not be done by Filipinos. They have a million more

where those came from. **[H: Perhaps it will now make more sense why Bush needed Russell Herman's signature on the papers for the funds represented by all THAT gold! Moreover, there was that substantial need for over \$35 TRILLION to cover the little transfer.]**

The 400,000 metric tons of TALLANO gold, and 950,000 tons of the Japanese loot around Southeast were all brought to the Philippines. This country then became the holder of 1.8 million tons of gold bars, including the 217,500 tons deposited abroad. Some of the "Yamashita" gold buried in the Philippines has been found. But the bulk of it is still buried to this day.

Marcos reminted all these gold bars in the Central Bank Minting Plant in East Ave., Quezon City. In the 3rd-floor basement of the Minting Plant there are 400,000 metric tons of reminted gold bullion, 170,000 metric tons under the swimming pool of a hotel in Manila and 50,000 metric tons in front of a building in the Ortigas Center.

Twenty years ago, a New York journal wrote that **two thirds of all the gold in the world is in the Philippines.** The one third is divided among the rest of the countries in the world.

When Marcos took over the government in 1965, the Philippines had a foreign debt of U.S.\$13.5 billion. In 1986, when the Americans FORCIBLY BROUGHT Marcos TO Hawaii, President Aquino inherited a foreign debt of U.S.\$24 billion. But, of these, U.S.\$7 billion was incurred by the private sector. At his ouster, Marcos left U.S.\$2.5 billion IN THE Central Bank reserve. This means that Pres. Marcos during his **20 years** of absolute rule only incurred a measly U.S.\$1 billion foreign debt to build up this nation with its fast growing population and numerous infrastructure projects.

How did President Marcos manage this government financially? Besides the annual national budget of P35 billion from the national treasury, he had all this gold at his disposal for building the infrastructure projects that today stand unequaled by all the four succeeding presidents put together. Today, this country has a foreign debt of around U.S.\$75 billion. From 1986 to 2000, the Philippine government under three presidents incurred a debt of U.S.\$51 billion on top of its original U.S.\$24 billion—in just **14 years!**

In 1953, there developed a whirlwind romance between Marcos and the daughter of Antonio Diaz by Remedios Trinidad. Her name was Miss Imelda Romualdez. In 1954 she became Mrs. Imelda R. Marcos. In 1974, Antonio Diaz, who had changed his name to Colonel Severino Sta. Romana, died at the San Juan de Dios Hospital. He left behind a wife, Luz Romano.

THE AFTERMATH: EDSA REVOLUTION

In the restive 70s and 80s, "blood money" from the Roman Catholic Church, channeled into the Philippines via the Vatican Bank (and another foreign power) fueled the flames of dissension in

the countryside and on the streets of Manila. All of that gold in the hands of one man like Marcos gave the chill to those who have been so long used to so much money and power.

A concerted church and foreign civil destabilization campaign against Marcos was intensified in the second half of 1983. To make things worse for Marcos, in June that year he appeared before the First World leaders in Toronto. There he announced his grand plan of boosting the economy of the Southeast Asian region by creating the ASIAN DOLLAR, backed by the 400,000 metric tons of gold in the Central Bank of the Philippines. This was his vision to raise Southeast Asia to be at par with the rest of the First world countries. Next, the U.S. Secretary of State, Henry Kissinger, was replaced by James Baker III, the head of the CIA. **[H: WONDERS JUST NEVER SEEM TO CEASE.]**

Two months later in August 21, Sen. Ninoy Aquino, who was given by his U.S. doctors three weeks to live because of cancer, came back to the Philippines and was "assassinated" (with consent) by a **foreign agent** at the Manila International airport. The blame was placed on Marcos.

It reached the climax on the eve of February 22, 1986 when the Roman Catholic Cardinal told the people to come out of their homes to rally at EDSA. Priests, nuns and seminarians in their clerical robes could be seen everywhere. Radio Veritas, the Roman Catholic radio station, controlled by another foreign civil power, monitored and encouraged the people, without any letup, to continue rallying against the 'corrupt' regime of Marcos. On the third day, the ailing President Marcos was drugged and dragged to Hawaii by the U.S. Marines.

In 64 A.D., Emperor Nero played [fiddled perhaps?] with his harp while he watched Rome go up in flames that he himself set ablaze. The blame was placed on the Christians. Intense persecution of Christians ensued. It seems history repeats itself.

THE GOLD AND THE GREEDY

To this day, the 400,000 metric tons of Philippine gold are still in East Avenue, Quezon City. But the Philippine government does not acknowledge their existence. The agents of the International Monetary Fund are watching that gold now so nobody could move them. **[H: The author obviously refers to this gold as "these" or "them" because of the fact that they are in bars of various sizes. It is cause for debate as to whether or not all the gold is STILL available at the address given. To us it matters not, for gold ANYWHERE is suitable for our purposes no matter where the idiots have stashed it—especially the IMF/WB/Fed Reserve.]**

In 1993 President Fidel Ramos abolished and privatized the Central Bank of the Philippines. It is now KNOWN as the Bangko Sentral ng Pilipinas (BSP). Its present owner is unknown. There is no record of it at the Securities and Exchange Commission. Definitely, the Philippine government

does not anymore own it. Except for Rafael Buenaventura, whose present tenure as puppet governor of the bank is confirmed by a foreign power, nobody can poke his nose into the affairs of the BSP. Not even the President of the Philippines can touch him. That would be interference and trespassing in a foreign-controlled bank, the BSP.

The American magazine, *WEEKLY WORLD NEWS*, June 12, 2001 issue, printed this: "FORT KNOX, KY.—America's current financial crisis is far more dire than President Bush has been telling us, says a leading economist—who charges that Fort Knox is empty and the country has gone bankrupt! Insiders in the U.S. Treasury warn that a complete collapse of the U.S. economy, which is already sinking into a recession, could be just weeks or even days away. 'There isn't a nickel's worth of gold in Fort Knox anymore—what you see now are **lead bricks painted gold** to fool visitors,' claims Harold Goldbloom, a highly respected professor of economics. 'That's because our treasury is utterly depleted and the situation is so desperate we've had to tap into our gold reserve—the nation's emergency 'nest egg'—as a last resort.'

"President Nixon took America off the gold standard in 1971, but even so, U.S. citizens have rested secure in the knowledge that we had about 147 million ounces of gold in the heavily guarded depository to fall back on in the event of a national emergency. But that sense of security is false, the D.C.-based economist warns. 'The reality is that over the decades our leaders have dipped into this 'piggy bank' from time to time, whenever they needed fast cash for pet projects,' says Goldbloom. 'In their minds, all that gold was just sitting there and the temptation was impossible to resist.' The missing gold has been quietly sold off over the years to oil-rich nations such as Saudi Arabia.

"During the Clinton years, the gold sell-off accelerated, the expert reveals. 'Didn't you ever wonder how we 'miraculously' went from a budget deficit to a budget surplus overnight?' Goldbloom asks. 'But that surplus is only an illusion. 'the truth is, our economy has been in a downward spiral for many months now.' President George W. Bush, in a desperate, last-ditch bid to save the economy, has sold off the rest of the nation's gold supply 'at fire-sale prices' to fund his \$1 trillion-plus tax cut, Goldbloom says. This has left us with no way to pay the monstrous national debt.

"Now our nation is buried under a mountain of \$5.7 trillion in debt. It's like when you've maxed out all your credit cards and pawned off all your jewelry," says the expert. 'You can only keep faking it for so long—the wolves are at our door now. Our foreign creditors are concerned that we won't be able to pay them back and they're lining up to call in their loans so they don't get stuck holding the tab.' When that happens, he says, the major U.S. banks will collapse, then the smaller ones. According to insiders, Federal Reserve Board Chairman Alan Greenspan is urging President Bush to 'declare a national emergency now'."—By Mike Foster.

FORT KNOX IS EMPTY! But the U.S.A. still keeps on printing dollars. In every dollar bill it says, "This note is legal tender for all debts, public and private." As a guarantee to that promise, the U.S. government uses the Filipinos' 400,000 metric tons of gold in East Avenue, Quezon City to back up the printing of more U.S. dollars. This would make one wonder 'Who is now the real owner of that gold in the Minting Plant of the BSP?'

Marcos, who descended from the Madjapahit Royal Family, wanted to establish a Maharlika for the region of Southeast Asia and one strong currency backed up by the gold bullions in the Philippines. But some Church and First World countries did not want this.

Dr. Jose Rizal said, "There are no masters where there are no slaves." For the First World countries to stay in power and continue dominating the majority of the population of the world, the Third World countries must stay as they are. The masters cannot be masters unless there are slaves they could dominate and exploit.

To the fiendish satisfaction of the Vatican, her millions of subversive dollars for the Philippines were well spent. NERO in the past—the VATICAN in the present—and both ROMANS! Their style is the same, yesterday and today. Create an embarrassing and uncompromising situation and blame it on the unwitting intended victim. In this case the victim was Marcos. They flex their muscles and deliver the message: "We are a power to contend with. We can do or undo governments. We can do or undo peoples." Thus says the 'VICAR OF CHRIST', who is well entrenched and perched in splendor atop the CITY OF SEVEN HILLS, Rome.

How is it now that the demand is to vacate, walk away from everything done to and for the farm property and the presence of major storage of grain, beans, etc.

Thousands of dollars were spent in making that farm a “certified” ORGANIC farm! Now it would be that “we” should just walk away, leaving everything to new owners—without remuneration? I don’t think so, friends. You can do that but then, IF YOU DO THAT, you surely are not going to be responsible for stewarding what comes next in the order of major funding management.

In addition to the farm on Dale Road being the permanent dwelling address of Ekkers it is also the

local address of both CONTACT and the contact address for several corporations. The latter doesn’t have much impact other than the lease is certainly NOT just some agreement between an E.J. Ekker and a Bob Turner. It is entangled with at least two corporations which I certainly will leave unnamed here.

This is NOT new news, friends. One of the names was used by Mr. Turner to advertise for sale, using the very improvements as selling points. The other was noted although without meaning because it was incorrect.

Now, even after stating in writing to Ekker that even the rent would be covered through November at the very minimum because of “the new metal roof” for which Turner says Ence charged “double” for material (the work, supplies AND material were supplied) at NO COST to Mr. Turner, he now demands vacating the premises by around the 20th of November to salvage his “sale”. NO THANK YOU! Once you capitulate to vacating the property—YOU LOSE, BIG TIME!

John Lloyd LIVES in the house AT THE LOCATION (where have we suffered this indignity before?) and others are DAILY living and working there with that location as permanent address for several entities they manage.

No, we are NOT in need of some power of attorney forced through for the convenience of Mr. Turner. MR. TURNER USED FALSE PRETENSES TO GIVE DISADVANTAGE TO MR. EKKER.

The facts are that there are good communications systems, even if some delays are encountered in this Third World nation, BUT, there is no problem except in finding Mr. Ekker OUT doing his job most of the time. Furthermore, Mr. Ekker responded to Mr. Turner EVEN FROM THE MESSAGE MACHINE!

Do we need a lawyer? NO, at this time there is no need for the expense to EITHER party of legal counsel who will simply charge mightily and still have no solution—so what we need is “backbone” and a strong stand in holding the line. But, for the past 13 centuries, the same trapezoidal tract has also been Islam’s holiest site after Mecca and Medina: Its Al Aqsa Mosque and Dome of the Rock honor the spot whence the Prophet Muhammad is said to have ascended to the Seventh Heaven. Christians, too, hold in awe this place where Jesus walked. Now a controversy has arisen over whether, and when, a new Jewish Temple should be built.

Temple reconstruction was no issue until 1967, when Israel captured the Mount and the Old City. Eager to preserve peace, Israel continues to allow Muslims to administer the site. They permit no Jew or Christian to pray openly on the holy ground, nor will they consider allowing even the simplest synagogue or church. The merest hint of rebuilding the Temple is considered an outrage by the Prophet’s followers, who, in the words of an official at Al Aqsa, “will defend the Islamic holy places to the last drop of their blood.”

Jewish sensitivities also hinder reconstruction. Israel’s Chief Rabbis forbid Jews to set foot on the Mount lest they accidentally step on the site of the ancient Holy of Holies, where only the high priest entered, once a year. In addition, there are various views over how and when a new Temple could or should be raised. The Babylonian *Talmud* offers conflicting opinions, but Rashi, the great medieval sage, insisted that the Temple must descend directly from heaven when the Messiah comes. On the other hand, tradition holds that God’s biblical command to build the Temple is irrevocable, and the Jerusalem *Talmud* says Jews may construct an intermediate edifice before the Messianic era. A 1983 newspaper poll showed that a surprising 18.3% of Israelis thought it was time to rebuild; a mere 3% wanted to wait for the Messiah.

Next week Israel’s Ministry of Religious Affairs will sponsor a first ever Conference of Temple Research to discuss whether contemporary Jews are obligated to rebuild. However, several small organizations in Jerusalem believe the question is settled. They are zealously making preparations for the new Temple in spite of the doctrinal obstacles and

the certainty of provoking Muslim fury.

These groups eschew violence but offer no explanation of what should be done about the Muslim shrines that now occupy the holy ground. They point out that animal sacrifices and other aspects of Temple worship are so ingrained in Judaism that they take up a third of the 613 biblical commandments, plus major portions of the *Talmud* and the daily ritual. Temple restoration is also a fixation for literal-minded Protestants, who deem a new Temple the precondition for Christ’s Second Coming.

Two Talmudic schools located near the Western (Wailing) Wall are teaching nearly 200 students the elaborate details of Temple service. Other groups are researching the family lines of Jewish priests who alone may conduct sacrifices. Next year an organizing convention will be held for those who believe themselves to be of priestly descent. Former Chief Rabbi Shlomo Goren, who heads another Temple Mount organization, believes his research has fixed the location of the ancient Holy of Holies so that Jews can enter the Mount without sacrilege. He insists, “I cannot leave this world without assuring that Jews will once again pray on the Mount.”

No group is more zealous than the Temple Institute, whose spiritual leader, 50-year-old Rabbi Israel Ariel, was one of the first Israeli paratroopers to reach the Mount in 1967. “Our task,” states the institute’s American-born director, Zev Golan, “is to advance the cause of the Temple and to prepare for its establishment, not just talk about it.”

During six years of research, the institute has reconstructed 38 of the ritual implements that will be required when Temple sacrifices are restored; it will complete the other 65 items as funds permit. A museum of the completed pieces has drawn 10,000 visitors during the current holy days. In addition to such items as trumpets, lyres and lots, the institute is preparing vestments for the priests-in-waiting. According to Scripture, the clothing must be painstakingly made with flax spun by hand into six-stranded threads.

One difficulty is the requirement (as in *Numbers 19:1-10*) that priests purify their bodies with the cremated ashes of an unblemished red heifer before they enter the Temple. Following a go-ahead from the Chief Rabbinate, institute operatives spent two weeks in August scouting Europe for heifer embryos that will shortly be implanted into cows at an Israeli cattle ranch.

As for rebuilding, none of the groups are believed to be stockpiling limestone and marble just yet. For years, however, a miniature Temple model has lured tourists to Jerusalem’s Holyland Hotel, and the institute is preparing blueprints for a more authentic replica that will cost \$1 million. All money for the various projects will come from Jews; Christian well-wishers are not allowed to contribute.

To rabbis like Jerusalem’s Pesach Schindler, such efforts are historically interesting but spiritually superfluous. A member of Judaism’s Conservative branch, which shuns Orthodox literalism regarding the Temple, Schindler contends that “religion evolves. We have respect for the past, but it has no operational significance. With the establishment of the state of Israel, we have all our spiritual centers within us. That is where the Temples should be built.”

But historian David Solomon insists that a new Temple is essential: "It was the essence of our Jewish being, the unifying force of our people." The Temple Institute's Golan admits it may be a long time before the building rises. "No one can say how, and no one wants to do it by force. But sooner or later, in a week or a century, it will be done. And we will be ready for it." He adds with quiet urgency, "Every day's delay is a stain on the nation."—Reported by Martin Levin/Jerusalem. [END QUOTING]

Do you believe those verses? Do you believe the *Bible*? Do you believe the *Old Testament*?—the *New Testament*? Do you not believe any of the projections? If you claim to believe none of it; why do you continue to measure your cycles against the prophecies?

WHY THE WORLD IS AGAINST US ON IRAQ

Every nation has to cope with adversaries, and the United States has always had its share. But as the Bush administration prepares to go to war against Saddam Hussein, we're finding an entirely new set of enemies: our friends. ...

For weeks, the administration has been pressing the United Nations Security Council to approve a resolution authorizing immediate, automatic military action if Hussein doesn't comply with a strict new inspection regime. But two members of the Security Council, France and Russia, have been lobbying strenuously against the U.S. proposal. ...

They're not the only friends who are shunning us. The German people recently re-elected Chancellor Gerhard Schroeder, mainly because of his unequivocal rejection of a U.S. attack on Iraq. Turkey was a crucial partner in the Gulf War, but Prime Minister Bulent Ecevit has strongly urged Bush to "abandon the idea" of invading Iraq, and public sentiment is overwhelmingly against us. Iran, the only country to be attacked with Hussein's weapons of mass destruction, has vehemently denounced Bush's war plans.

At least we've got the backing of our faithful North American neighbors. Don't we? Actually, no. A Canadian newspaper reports that "not since the Vietnam War has an American administration's handling of a foreign policy issue triggered such an outpouring of outspoken criticism from so many Canadian parliamentarians." More than half of Canadians think that if a war comes, Saddam Hussein and George W. Bush would be equally to blame.

South of the border, the story is similar. Vicente Fox, probably the most pro-American president in Mexico's history, parted ways with his old friend George W. Bush by siding with France in the Security Council fight.

Maybe all the leaders we thought were good guys have gone bad. The hawkish editorialists at the *Wall Street Journal* were so infuriated that they accused President Fox—a free-market conservative whose election they applauded—of a "reversion to Mexico's previous 70 years of solidarity with the global left".

Of course that's possible—just as it's possible that Osama bin Laden has been given refuge at Al Gore's family farm. But it's not likely. The rest of the world has several good reasons to question our entire policy toward Iraq.

The first is that even Hussein's closest neighbors no longer regard him as a military threat. If he's so bent on conquest and destruction, why isn't anyone nervous in Riyadh or Tehran or Ankara?

Most of our fellow inhabitants of planet Earth think Hussein can be kept in check. What they fear is that the U.S. can't be. To a lot of people, President Bush brings to mind *Titanic* director James Cameron after he won an Oscar: "I'm king of the world!"

Recently, the administration issued a new policy statement baldly asserting its readiness to use military force, unilaterally and pre-emptively, whenever it sniffs danger. That document only sharpened the image of America as a hyperactive bully. Many people abroad don't understand why the mightiest country in history is so prone to feelings of vulnerability—feelings it can banish only by going to war.

The idea that we're entitled to overthrow unfriendly governments also sticks in the craw of many foreigners. The Saudis, the Iranians, the Egyptians and others doubtless wonder who will wind up in our cross hairs once we've disposed of Hussein. It's clear from our recent history that after we've finished one military mission, we start looking for a new one.

Getting rid of Hussein won't make the Bush administration feel that we're finally secure. It will merely transfer U.S. anxiety from Iraq to Iran or North Korea or some other troublesome nation.

It's a dangerous delusion to think, as many conservatives do, that our Iraq policy is unpopular abroad only because everyone else in the world is cowardly, knavish or blind. The Bush administration ought to realize that if even your friends disapprove of what you're doing, maybe you're doing something wrong.

[JR: Our "friends" would do the world a very BIG FAVOR if they were less evasive and more forthright as to the true reasons why they see us as an evolving world threat. The U.S. has adopted and imposed Israeli/Zionist policies towards Arab countries and in particular Iraq. RALLY IN WASHINGTON IS SAID TO INVIGORATE THE ANTIWAR MOVEMENT

Emboldened by a weekend antiwar protest in Washington that organizers called the biggest since the days of the Vietnam War, groups opposed to military action in Iraq said they were preparing a wave of new demonstrations across the country in the next few weeks.

The demonstration on Saturday in Washington drew 100,000 by police estimates and 200,000 by organizers', forming a two-mile wall of marchers around the White House. The turnout startled even organizers, who had taken out permits for 20,000 marchers. They expected 30 buses, and were surprised by about 650, coming from as far as Nebraska and Florida.

A companion demonstration in San Francisco attracted 42,000 protesters, city police there said, and smaller groups demonstrated in other cities, including about 800 in Austin, Tex., and 2,500 in Augusta, Me.

"The rally was like a huge gust of wind into the sails of the antiwar movement," said Brian Becker, an organizer of the Washington protest. "Our goal was not simply to have a big demonstration, but to give the movement confidence that it could prevail. The massive turnout showed it's legitimate, and it's big."

Building on those demonstrations, a coalition of groups called International Answer—short for Act Now to Stop War and End Racism—is asking people to vote in a referendum called VoteNoWar.org, which organizers hope will serve as a countervote to the Congressional resolution in support of military action in Iraq.

The coalition, which has absorbed several smaller groups around the country, is also planning another protest on Jan. 18 and 19 in Washington, to coincide with the commemoration of the Rev. Dr. Martin Luther

King Jr.'s birthday and the 12th-year anniversary of the Persian Gulf war. Organizers are also planning what they call a Grass Roots Peoples' Congress to publicize the results of the referendum.

Smaller groups that attended the demonstrations in San Francisco and Washington said they were planning their own protests back home. Protesters plan to march in New Orleans and Tampa, Fla., this weekend; in Charleston, S.C., in mid-November; and again in San Francisco on Nov. 22. A group in Louisiana is planning a peace walk between Baton Rouge and New Orleans at the end of November, and the National Council of Churches is discussing another rally in Washington for Nov. 24.

MoveOn.org is conducting an online petition drive, and has raised about \$2 million for candidates, including the late Senator Paul Wellstone, who opposed a war in Iraq.

In California, college students are leading teach-ins against the war at high schools. Richard Becker, an organizer with Answer in San Francisco, said the group was setting up an emergency response plan to accommodate a mass protest—complete with sound systems, placards, the requisite permits and even portable toilets—on the day United States troops enter Iraq.

"There is not going to be one speech or one demonstration, after which everyone goes home," said Barbara Lubin, the founder of the Middle East Children's Organization in Berkeley, Calif. "This is a movement against war and it's building momentum."

Those who have been organizing and attending demonstrations for several months said the swelling size of the protests showed how much antiwar sentiment had increased as the threat of war intensified.

In San Francisco, a march on Sept. 6 drew 2,500 people, one two weeks later, 6,000, and one on Oct. 6, 10,000.

"People are very emboldened right now," said Mike Zmolek, an organizer with the National Network to Stop the War in Iraq. "We've been in a financial crunch since we started—suddenly people are sending checks out of nowhere."

Mr. Zmolek said his organization had attracted 100 new antiwar groups across the country in the last three months.

The march in Washington was planned by International Answer, with coordinators of local chapters working in more than two dozen cities around the country. It attracted homemakers as well as college students, seasoned activists and those who had never attended any kind of political rally before.

"It was beautiful," said Merrill Chapman, 35, who called herself "just a housewife" in Charleston, S.C. "I'm in a very conservative town, and I feel like the lone voice. Being in Washington energized me, by seeing I was not alone."

Ms. Chapman had never been to a protest before the demonstration in Washington, but got involved after organizing a group called Thinking People in Charleston. She is planning a rally for Nov. 16 in her city.

In Houston, Lois Wright, a 46-year-old saleswoman in a drapery workroom, said she felt compelled to take the two-day bus ride to Washington, because the Bush administration seemed "hellbent on going to war".

"It's O.K. to do stuff in Houston, but nobody gets to hear about it," she said. "I felt if we were right in their faces, they couldn't ignore us."

Polls show that about 50 percent of Americans support sending ground troops to Iraq to remove Saddam Hussein from power. Antiwar organizers acknowledge some public support for military action, but said that until now, the voices of those who do not support the policy have not been heard.

"I think the president has considerable support," Mr. Zmolek said, "but I think the nation is pretty divided on this."

Certainly, there is still debate. In Austin, the University of Texas student government passed a resolution on Oct.

22 opposing an attack, by a vote of 20 to 17. Some students seek to have that vote overturned, saying it does not reflect the sentiment of the campus's 50,000 students. **[JR: This directly contradicted the Times' October 27 report, which noted that the "thousands" of demonstrators were "fewer people... than organizers had said they hoped for". The newspaper trade magazine Editor & Publisher (10/30/02) suggested that the October 30 Times' piece was a "make-up article" that may have been written "in response to many thousands of organized protest letters sent to the Times (as well as NPR) since the paper's weak, and inaccurate, initial article about the march on Sunday." National Public Radio, another targeted bias report has also offered a correction of its misleading coverage of the D.C. protest. The following message is now posted on NPR's Website: "On Saturday, October 26, in a story on the protest in Washington, D.C. against a U.S. war with Iraq, we erroneously reported on All Things Considered that the size of the crowd was "fewer than 10,000." While Park Service employees gave no official estimate, it is clear that the crowd was substantially larger than that. On Sunday, October 27, we reported on Weekend Edition that the crowd estimated by protest organizers was 100,000. We apologize for the error." This is typical of our controlled media to negate anything that is contrary to THEIR viewpoint. As more people speak out and make their opinions known, our controlled media will have to respond and report more accurately and give us the honesty the people demand. U.S. TROOPS IN BAGHDAD FOR CHRISTMAS?
POSSIBLE "TWO WEEK" INVASION?

The U.S. may launch its anticipated attack against Iraq "before Christmas", with U.S. troops deployed in the region by December fifth, according to a recent article in the online version of the German news magazine, *Focus*.

The fifth of December marks the end of Ramadan, Islam's holy month of ritual fasting.

Focus reported on the possible U.S. attack scenario while citing a report in Turkish newspaper *Sabah*, describing ongoing discussions concerning the stationing of American troops and aircraft in Turkey.

Turkey remains adamant in its requirement of "guarantees concerning the future of the region after a war", reported *Focus*.

Turkey's primary concern involves an absolute assurance that the United States will not permit Iraqi Kurds in Northern Iraq to declare independence.

Turkey fears the establishment of an independent Kurdish in northern Iraq would lead to ethnic Kurds in Turkey joining their kinsmen in Iraq.

"Most of the fighting will be over in two weeks," after the U.S. launches its attack against Iraq, according to U.S. General Wesley Clark, interviewed in a separate *Focus* report.

Clark is a former head of NATO forces, and commanded the 78-day war against Yugoslavia in 1999.

The number of troops "actually involved in fighting"—not including support personnel—would number from 75,000 to 100,000, Clark declared.

The estimates of troops needed in the Iraqi invasion, and the length of time before the end of major fighting, are based upon U.S. policymakers' assessment that Iraqi forces will quickly surrender to the overwhelming superiority of U.S. firepower.

Clark, however, warned against an overly aggressive use of U.S. military force and possible "worldwide resentment and opposition" as a result of the unwise use

of American power. He sharply criticized Washington policymakers regarding the possible use of U.S. forces as peacekeepers in a post-Saddam Iraq.

"The saber-rattlers must realize that an instrument may break if it is used in a way other than that which it is intended," declared Clark.

Recent reports have stated that General Tommy Franks, U.S. commander in the Persian Gulf region and former commander of U.S. operations in Afghanistan, will become the postwar governor of Iraq, occupying a post similar to General Douglas MacArthur in postwar Japan, with U.S. troops performing occupation force duties.

Sharp differences, however, would exist between the defeated island nation of Japan in WWII and the anticipated regime change in a post-Saddam Iraq.

MacArthur joined with the Japanese emperor and the Japanese business class to rebuild Japan, a nation already familiar and accepting of many Western methodologies.

Iraq, however, is plagued by deep political and ethnic divisions, and many groups opposed to Saddam's rule are as hostile to the West, especially the United States. ...

[JR: General Clark's victory in Yugoslavia was brought about by 79 days of non-stop and unrelenting bombing raids over Belgrade with the specific targeting of roads, bridges, infrastructures, utilities and communications. Clark's sole objective was to bomb Belgrade into the Stone Age and he succeeded in doing just that, because Belgrade today is still a pile of rubble and survival is a daily reality for the Serbs. The same fate awaits Iraqi citizens if Clark's aim is to conquer Iraq in two weeks with only 100,000 U.S. troops. To insure such a success Clark would have to rely heavily on massive bombing raids to soften up the enemy. What the military brass is not saying is just how many British and Israeli troops are already poised and ready to move into Iraq to annihilate any Iraqi opposition. I don't think the military planners really expect that Iraqi forces will put down their arms and surrender to U.S. troops and risk being buried alive, like what befell Iraqi troops during the "Gulf War". That's the Bush Cartel's dirty little secret they would not like to have made known among their loyal friends and supporters, but would certainly pique the interest of the World Court.]

DUBAI (*Reuters*)—Saudi Arabia, a key U.S. ally in the Middle East, said Sunday it would not allow the United States to use facilities in the country to attack neighboring Iraq, even if a strike was sanctioned by the United Nations.

"We will abide by the decision of the United Nations Security Council and we will cooperate with the Security Council. But as to entering the conflict or using facilities... that is something else," Foreign Minister Saud al-Faisal said.

"Our policy is that if the United Nations takes a decision on Chapter 7, it is obligatory on all signatories to cooperate but that is not to the extent of using facilities in the country or the military forces of the country," he told *CNN*.

Chapter 7 of the *UN Charter* makes it mandatory for member states to implement any measure immediately as part of international law.

The remarks were the strongest rejection by Saudi Arabia—which was a launchpad for the U.S.-led 1991 Gulf War that drove Iraqi troops out of Kuwait after a seven-month occupation—of any assistance to a possible U.S. attack on Iraq.

The rejection comes in the midst of strained relations between the strategic allies over last year's Sept. 11 attacks on the United States, in which 15 of the 19 men believed to be the suicide attackers were Saudis, and Saudi anger at what it sees as U.S. bias toward Israel in the Middle East conflict.

Saud said there was no crisis in ties between the U.S. and the kingdom, the largest oil exporter to the United States.

Washington could launch an attack on Iraq without using bases inside Saudi Arabia, but the air campaign would be more difficult if it could not use Saudi air space. ...

Faced with Riyadh's possible refusal to be a launch pad for strikes on Iraq, the United States has spent \$1.4 billion to expand Qatar's Al Udeid facility into a major air base and military staging ground.

Washington has several Gulf bases, mainly in Bahrain, Kuwait and Saudi Arabia, and Qatar is increasingly becoming a key base for U.S. military operations in the region. The U.S. used Udeid base last year after Riyadh refused to let U.S. planes and troops heading to Afghanistan use its Prince Sultan base.

Gulf power Saudi Arabia and its tiny neighbor Qatar are currently locked in a diplomatic row over several issues, including Doha's decision to allow U.S. access to Udeid base.

Western diplomats say Riyadh, which recalled its ambassador from Doha in September, was incensed at what it saw as Qatar's efforts to present itself as Washington's main regional ally, a role Saudi Arabia has had for decades. ...

Saud said the Iraqi people should decide the fate of their president and warned against a long-term U.S. military presence in Iraq in the event of an attack. "You can never make a permanent change through occupation by foreign forces," he said.

U.S. WINS FRENCH OK ON UN IRAQ RESOLUTION

NEW YORK—Setting the stage for a final vote by the United Nations Security Council, the United States won French support Thursday for a new resolution giving Iraq a final chance to disarm, while President Bush issued a stern warning that he was prepared to take military action if the Iraqis failed to comply. ...

The president said the resolution would show that the international community was united in its demand that Iraqi President Saddam Hussein dismantle his chemical, biological and nuclear-weapons facilities. ...

The deal between Paris and Washington, which boiled down to changing "or" to "and" in a key paragraph of the resolution, closed what French diplomats viewed as a loophole they say might have allowed the U.S. to take military action and claim that it had Security Council endorsement.

"We got complete satisfaction," said French spokeswoman Ginette de Matha.

The compromise, reached through negotiations at the UN and in telephone calls between President Bush and French President Jacques Chirac over the last several days, revolved around a key provision that would declare Iraq in "material breach" of its UN obligations if it balked at further inspections.

The reworded resolution now means that only the Security Council can decide whether Iraq is in material breach, according to one diplomat. ...

Since the end of the 1991 Persian Gulf War, the council has passed 16 resolutions dealing with Iraqi disarmament, the president noted.

"This will be the 17th time that we expect Saddam to disarm," Bush said. "This time we mean it."

The revised U.S. text—the third after eight weeks of protracted negotiations—gives the Security Council a limited role before any military attack, a concession from earlier drafts. If Iraq does not comply with weapons inspections, a new round of Security Council deliberations would take place. The council then could authorize the use

of force, but the resolution does not require it.

That would leave Washington free to strike Iraq.

The deal that broke the council's eight-week logjam came down to a change in wording, from "or" to "and." The change, in a paragraph dealing with how Iraq would be found in "further material breach" if it interfered with weapons inspectors, removed any concern that the U.S. would be free to determine on its own whether Iraq was complying with inspections, French diplomats said.

Before the change in wording, Hans Blix, head of the UN inspection team for chemical and biological weapons, and Mohamed ElBaradei, director of the International Atomic Energy Agency, could be directed to determine whether Iraq was in breach of its obligations under the resolution—or the Security Council could immediately consider whether there had been a breach.

Now that determination will be left up to Blix and ElBaradei. Only after they make a determination can the Security Council weigh in.

France and Russia wanted to make sure there were no "hidden triggers" to allow Washington to attack Iraq at its own discretion and claim the UN had authorized it.

But U.S. officials, seeking to play down the controversy, emphasized that any council member could report a material breach.

"On any issue, any member of the council can report anything it wants and ask the council to look at it and decide what action is appropriate," State Department spokesman Richard Boucher said.

Twice in his news conference, Bush spoke directly to the Iraqi people, reassuring citizens that the U.S. does not intend to occupy their nation and warning Hussein's generals that they would face consequences—war crimes tribunals have been discussed—should they follow Hussein's orders to attack Iraqi Kurds, Israel or another Arab nation.

"This country never has any intention to conquer anybody," Bush said. "That's not the intention of the American people or our government."

Turning to the Iraqi military, Bush added: "The generals in Iraq must understand clearly there will be consequences for their behavior. Should they choose, if force is necessary, to behave in a way that endangers the lives of their own citizens, as well as citizens in the neighborhood, there will be a consequence. They will be held to account."

Blix, the chief weapons inspector, said an advance team would be ready to leave for Baghdad within 10 days after approval of the resolution.

The resolution gives inspectors 45 days to begin work, with a report to the Security Council on Iraq's compliance due 60 days after that.

Libya-Egypt, Politics—Following his meeting yesterday with the Egyptian President Hosni Mubarak in Tripoli, Libya's Leader of the Revolution Colonel Muammar al Qathafi adhered to the decision of Libya's pullout from the Arab League, "considering that this decision is grave, but we are obliged to do so."

Qathafi questioned, "why should we stay in the membership of a futile, ineffective league?" Al-Qathafi's assertion was made despite the announcement made by Mubarak who expressed during the meeting his "great regret" over the request submitted by Libya, that they have agreed to "continue work in order to revitalize Arab working establishments to be able to withstand challenges facing the Arabs," and his saying "should every country pullout from the AL this League will come to nothing."

Qathafi said in a statement prior to Mubarak's leaving back to Cairo "Nothing new has happened after I applied for pullout." He added: "the withdrawal decision is serious but we are obliged to do so." He questioned "why should we stay as members in an ineffective league," stressing the need of "implementing the joint Arab charters and joint Arab defense and the economic Arab unity."

Mubarak said in a statement to the press before leaving Libya, which was his last leg in conclusion of a tour which took him to Morocco and Tunisia "should every country pull out from the Arab League this AL will end." Mubarak indicated that he had discussed with the Arab leaders "the Arab position and the grave condition in the Arab territories and the threat to launch an aggression against Iraq". He stressed that all Arabs understand the situation and all of us are proceeding into one direction.

[JR: The Arab League and Saudi Arabia has, since its inception, been under the influence if not control of the U.S., Britain and France. The league as an alliance has not been very effective or innovative when it comes to voicing their objections or concerns. Each member state seems to have its own concept of what the goals or objectives should be and therein lies their weakness. They do not lead but follow the commands of their Western overseers. SHARON CALLS EARLY ELECTIONS IN ISRAEL

JERUSALEM—Israeli Prime Minister Ariel Sharon, stymied in a bid to find right-wing political partners to save his minority government, dissolved the Knesset on Tuesday and called for early elections on Jan. 28.

Coming after last week's collapse of a 19-month-old coalition with the left-of-center Labor Party, Sharon's move opens the door to three months of political turmoil and uncertainty in Israel as the Middle East braces for a possible U.S.-led war on Iraq.

Sharon had argued that Israel could not afford elections now because of economic and security problems. But Tuesday he said he had chosen the "lesser of evils", rather than surrender to the "irresponsible demands" of small far-right parties.

"Israel is facing some of the most difficult situations we have ever faced," said the 74-year-old former military leader.

Israel's two major parties, Likud and Labor, will be thrown into intense campaigning as they prepare for their own leadership elections. Labor will vote later this month; Likud has yet to set a date for internal elections.

Former Prime Minister Benjamin Netanyahu, who is expected to challenge Sharon for the Likud leadership, accepted Sharon's offer to serve as foreign minister. A few days ago Netanyahu had said he would take the job only if early elections were held.

Israeli analysts viewed Netanyahu's action as a gesture of party unity but also as a move to gain attention in coming months.

A critic of Sharon's failure to oust Palestinian leader Yasser Arafat from the West Bank, Netanyahu is expected to seek even tougher measures against Palestinian violence. ...

Already troubled by Sharon's choice this week of Shaul Mofaz, a hawkish former Israeli military leader, as defense minister, Palestinians greeted with unease the government's dissolution and Netanyahu's appointment.

"Palestinians were having major problems with the government before Labor left it," said Ziyad Abu Amr, a

member of the Palestinian Council. "Now things are going to be worse. Palestinians are anxious and alarmed."

Israelis also feel on edge after more than two years of unrelenting conflict with the Palestinians, fears of being drawn into a war with Iraq and one of the worst economic downturns in their nation's short history.

Labor Party leaders signaled Tuesday that their key themes in the election would be ending the confrontation with the Palestinians and restoring stability to a broken economy where 1 in 10 Israeli workers is jobless. ...

More than 1,600 Arabs and 600 Israelis have been killed and thousands injured in the renewed conflict. Two Palestinians were killed and 16 injured in clashes Tuesday in the Gaza Strip, Palestinian officials said. ...

"No matter whom Labor elects as its leader, they are going to lose and lose handily because the public doesn't trust the leftist leaders," said Efraim Yaar, a Tel Aviv University sociologist and pollster.

Most Israelis want peace with the Palestinians, but the dismal results of the peace process so far have convinced them that only someone on the right can deliver peace, Yaar said. ...

[JR: Things won't change much for the Palestinian people no matter what regime changes supposedly take place in Israel, or in the U.S. for that matter. It doesn't matter whether Netanyahu or Sharon is sitting in the revolving seat of power or if Labor or the Likud control the Knesset. ISLAMISTS CLAIM VICTORY IN TURKEY LEADER VOWS TO KEEP SECULAR RULE

ISTANBUL—The Justice and Development Party claimed a commanding victory Sunday night as Turkish voters defeated a generation of politicians at the ballot box and pinned their hopes on the year-old party with Islamist roots.

With 99 percent of the ballots counted, the upstart known as the AK Party had won 34 percent of the vote.

The party appeared to be within reach of winning an outright majority of the 550 seats in parliament, making it the first time in 15 years that Turkey would have a single-party government.

The results had been evident for weeks, but the United States and its NATO allies now face the reality of dealing with a key partner led by a party that some Western diplomats have treated warily because of its ties to political Islam.

In an effort to calm those fears, party leader Recep Tayyip Erdogan, 48, said at party headquarters in Istanbul on Sunday night that "secularism is very clearly defined in our 1982 constitution, and our management will clearly prove that."

Erdogan also said he is opposed to a U.S. military strike against neighboring Iraq, unless it is approved by the United Nations.

"We do not want war, blood, tears and dead in our region," Erdogan said. ...

Erdogan, a charismatic former mayor of Istanbul, created the AK Party from the reformist wing of a pro-Islamic party that was banned last year because of anti-secular activities.

Erdogan (pronounced AIR-doh-ahn) remained at his party's helm, despite being banned from running for election because of a 1998 conviction for inciting

SUICIDE ATTACKS ARE 'WAR CRIMES'By Tracy Wilkinson, *LA Times*, 11/01/02

JERUSALEM—A leading human rights organization charged today that Palestinians who order and dispatch suicide bombers, including senior leaders, are guilty of war crimes and should be brought to justice.

In a comprehensive, 170-page report, the New York-based Human Rights Watch also says that Palestinian Authority President Yasser Arafat bears “significant political responsibility” for the “repeated deliberate killing” of Israeli civilians in the last two years of blood-soaked conflict.

“The scale and systematic nature of these attacks in 2001 and 2002 meet the definition of a crime against humanity,” the report states. “When these suicide bombings take place in the context of violence that amounts to armed conflict, they are also war crimes.”

The report is a departure from most human rights investigations into Israeli-Palestinian violence that focus on the Israeli army, including the killing of civilians, demolition of houses and other forms of collective punishment.

Israel is a member state of the United Nations and signatory to a number of international conventions and as such can be held accountable for its army’s actions.

Human Rights Watch asserts that although Arafat’s Palestinian Authority is not a state, it has aspirations to become one, has made international commitments and therefore cannot evade similar responsibilities.

Instead, the scathing report says, Arafat and the Palestinian leadership have failed to prevent suicide bombings, refused to arrest terrorists and declined to defuse the radicalized political and social climate that encourages attacks targeting Israeli civilians.

Blaming Israel’s harsh occupation of Palestinian territory, the leadership has, to the contrary, allowed justification for the attacks to flourish, the report charges. ...

In all, about 2,200 people have been killed, about three-quarters of them Palestinians, since the intifada, or uprising, erupted 25 months ago.

Three of the factions cited by Human Rights Watch—the militant Islamic movement Hamas, the Palestinian Islamic Jihad and the secular but radical Popular Front for the Liberation of Palestine—have an adversarial relationship with Arafat.

But the fourth, the Al Aqsa Martyrs Brigade, professes loyalty to the aging leader while operating with a great deal of local discretion, the report says.

Hamas founder Sheik Ahmed Yassin is among the senior leaders who could be investigated on war crimes charges, said the report’s author, Joe Stork, director in Washington of Human Rights Watch’s Middle East and North Africa division.

Hamas and Islamic Jihad defend and celebrate the use of suicide bombers, boast of the method’s efficacy and make no distinction between Israeli civilians and combatants, according to the report—all of which supports an allegation of crimes against humanity.

Arafat, however, has little command responsibility over the bombings carried out by the Al Aqsa brigade, the report concludes, and consequently does not bear criminal liability. Yet he is responsible nevertheless, Stork charged.

“The greatest failure of President Arafat and the PA [Palestinian Authority] leadership—a failure for which they must bear heavy responsibility—is their unwillingness to deploy the criminal justice system decisively to stop the suicide bombings, particularly in 2001, when the PA was most capable of doing so,” the report said.

“The lack of command responsibility in no way diminishes Arafat’s and the PA’s significant political responsibility for the repeated deliberate killing of civilians.”

There was no immediate comment from Palestinian Authority officials.

[JR: This report from a Human Rights Watch group coming out of N.Y. is confusing as well as contradictory. Mr. Stork, the author of this report is the head of a Washington rights group for the Middle East and North Africa, so that explains his bias. Mr. Stork takes to task Arafat and his P.A. and charges them with not being responsible in the execution of their political duties by not reining in the violence and for not putting a stop to the suicide bombers. The Israeli leadership is censured for its hostile occupation in the territories but then is condemned because of its tolerance in allowing such attacks to continue. BRITISH LAWYER FILES WAR CRIMES SUIT AGAINST ISRAEL’S NEW DEFENSE MINISTER*Islam Online*, 10/31/02***Mofaz is accused of violations of the Geneva Conventions***

LONDON (*IslamOnline*)—A prominent British human rights lawyer has urged his country to press war crimes charges against Israel’s hardline ex-army chief, General Shaul Mofaz, officials said, as Mofaz accepted the post of Defense Minister in hardline Prime Minister Ariel Sharon’s new government Thursday, October 31.

Lawyer Imran Kahn, a British national of Pakistani origin, filed his request Tuesday, October 29, as Mofaz was in Britain on a fund-raising visit, *Agence France-Presse (AFP)* reported.

He was responding to a British Muslim group who accused Mofaz of responsibility as commander for violations of the Geneva Conventions. The Israeli army is accused of using Palestinians as human shields, assassinating activists, torturing prisoners, and destroying civilian homes, the British daily newspaper, the *Independent*, reported.

Khan sent a 17-page dossier to the Director of Public Prosecutions, who passed it to Scotland Yard’s crimes against humanity unit, said the *Independent*. Khan, who is representing families of Palestinian victims, says the case can be investigated and tried in Britain because all Geneva Convention signatories are obliged to enforce them, wherever breaches are committed.

“It is a mandatory obligation on the British police as signatory to the Convention, that they search for people who are alleged to have committed those breaches, and effectively bring them to justice,” Kahn told *AFP*.

In his dossier, Khan accused Mofaz of breaching the Geneva Convention banning the use of torture while he was head of the Israeli occupation army.

Many accusations relate to the Israeli attack on Jenin in April 2002, a deadly incursion which provoked a plea from the Human Rights Watch organization for a war crimes investigation, the British paper added.

Other allegations relate to Israeli offensives across the occupied West Bank and Gaza Strip during Mofaz’s time as Chief of Staff. The Israeli military regularly assassinates Palestinian resistance activists in what it calls “targeted killings,” the *Independent* reported.

But throughout the campaign, Ecevit had accused the AK Party of having a “secret Islamic agenda”.

Erdogan sought during the campaign to reassure Western governments and secular Turks that the “Islamic” label was applied unfairly to him and the party.

Erdogan said Turkey’s bid for European Union membership would be his party’s “first priority”. He also vowed to strengthen integration with the global economy and pledged loyalty to Turkey’s \$31 billion IMF-backed recovery program, but said some changes may be needed. He promised to continue to pursue human-rights reforms.

The elections were watched closely by the United States. Turkey houses U.S. warplanes at its southern Incirlik air base, which was a staging point for attacks on Iraq during the gulf war. Western diplomats contend that Turkey’s position would not change, although the question of how much additional support Turkey might provide remained unclear.

With Erdogan unable to join parliament, his party’s victory brought with it an air of uncertainty. Most analysts said the law allows President Ahmet Necmet Sezer to select the prime minister. While custom dictates that the prime minister be selected from the majority party, some analysts said Sezer could choose from another party with seats in parliament. ...

[JR: Erdogan’s victory in Turkey might pave the way for other Islamic countries to form governments that will reflect their true Islamic beliefs and ideals, yet retain a secular form of governing. Afghanistan is a perfect example of how badly things can become when the Western powers intervened and involved themselves in its affairs and in the formation of its government. If Erdogan remains his own man and is not seen as a puppet of the West, he could unite the rival political factions and in doing so build a broad coalition to share the responsibilities of government. Should Erdogan succeed in balancing his powers as a “modern” fundamentalist, countries like the U.S. would have to re-adjust their thinking and reign in their intolerance towards the more moderate fundamentalist movements growing in the Middle East. The younger Muslims want to address the needs of their people by replacing the old, imposed European system of “democracy” with a system of their own making. It will be interesting to see how well Erdogan can balance Turkey’s impending membership in the EU and resolve Turkey’s financial and unemployment problems while trying to pay the debts owed to the IMF parasites. Turkey could become a model form of government (minus bribes as inducements), that other Muslim countries could work towards emulating.]

Mofaz had further advocated kicking elected Palestinian President Yasser Arafat out of the Palestinian territories. Israel TV showed him urging Sharon to expel Arafat.

During a joint visit to an occupation army base in the West Bank, Mofaz was seen telling Sharon: "We should kick him out." Sharon—apparently unaware his comments were being recorded—replied, "I know." Mofaz continued: "This is an opportunity now that won't return."

Mofaz has now left Britain, but Kahn insisted he intends to pursue the matter regardless, saying: "That doesn't prevent Scotland Yard from doing the investigation."...

PUTIN VOWS NO SURRENDER TO TERROR

MOSCOW (AP)—President Vladimir Putin led a national day of mourning Monday and pledged Russia would not surrender to terrorist "blackmail". Relatives and friends grieved for 118 captives who died in the siege at a Moscow theater, all but two from the paralyzing gas used to rescue them.

Using words remarkably similar to those of President Bush after the Sept. 11 attacks in the United States, Putin pledged in televised comments to give the military broader powers to move against suspected terrorists and their sponsors.

"Russia will answer with measures adequate to the threat to the Russian Federation in all places where the terrorists, the organizers of these crimes or their ideological or financial sponsors are located," Putin said. "I emphasize—wherever they may be."

Putin has said the theater raid was planned abroad, and the Russian Foreign Ministry on Monday claimed, without offering evidence, that Osama bin Laden's al-Qaida terrorist organization was involved.

Officials said 405 of the freed captives remained hospitalized, 45 of them in grave condition. Deputy Prime Minister Valentina Matviyenko said 239 people had been released.

Russian medical officials said 116 of the hostages held by Chechen rebels in a Moscow theater had succumbed to the gas, the exact composition of which remained a secret—even to medical personnel treating the victims.

Russian authorities provided the U.S. Embassy with some information about the effects of the gas, but have not told them the name of the agent despite repeated requests, an embassy spokesman said.

Doctors from a Western embassy have examined some of the former hostages and concluded "the agent they were exposed to appears consistent with an opiate rather than a nerve agent," the embassy spokesman said, speaking on condition of anonymity. Opiates, including morphine and heroin, are derivatives of the opium poppy. ...

Russian officials said 50 rebels were killed during the storming of the building early Saturday. Many of the insurgents were women who claimed to be Chechen war widows.

As pressure grew on Russian authorities to identify the gas used in the raid, some lawmakers and commentators criticized the government.

Boris Nemtsov, a leader of the liberal Union of Right Forces party, criticized authorities for failing to treat the hostages promptly after pumping the gas into the theater.

"Why after special services brilliantly carried out the operation were there not enough ambulances, doctors and intensive care equipment? Why was medical aid not given on the spot?" he said on Russian television, referring to the fact that many victims were carried and dragged out of the building and put on buses to local hospitals.

At a Moscow hospital where many of the freed hostages were taken, a crowd of relatives waited to visit loved ones. Every time guards opened the black gates for ambulances or departing patients, the crowd rushed the entrance, pleading to be next. ...

Some mourners said they felt authorities had done all they could to protect lives.

"There was no other way," said retiree Lyudmila Yemelyanova, expressing the sentiments of many who came to pay respects. "If the explosives inside the building had gone off, then not only the theater but all the neighboring buildings would have been destroyed."...

Russian forces pulled out of Chechnya after a devastating 1994-1996 war that left separatists in charge but returned after rebels attacked a neighboring region and were held responsible for apartment bombings that killed about 300 people.

In 1995 and 1996, rebels seized hundreds of hostages in two raids in near Chechnya that were similar in scale to the theater assault but far from Russia's capital. Dozens of people died in both—many killed when Russian forces attacked the hostage-takers.

RUSSIA LINKS TURKEY, QATAR TO CHECHEN REBELS

MOSCOW—Russia charged Thursday that Turkey and Qatar are giving sanctuary to Chechen rebels, as officials released taped excerpts that they said linked militants who took over a Moscow theater to ousted Chechen President Aslan Maskhadov.

Pressing a diplomatic offensive to brand Chechen separatists as terrorists worldwide in the wake of the Oct. 23-26 theater takeover that led to at least 119 deaths among the hostages, Russia already has persuaded Denmark to detain a former Chechen deputy prime minister close to Maskhadov on allegations of terrorist activity.

Until recently, Maskhadov was the most likely negotiating partner for Russia in any talks to end the three-year war in the separatist Russian republic. President Vladimir V. Putin has virtually ruled out negotiations.

Putin spokesman Sergei Yastrzhembsky used a news conference Thursday to put the spotlight not only on Maskhadov but also on Qatar, which he said is sheltering another top Chechen figure, Zelimkhan Yanderbiyev, and on Turkey, which he said is allowing Chechen rebel groups to openly raise funds.

According to an excerpt of a taped phone conversation played at the news conference, the leader of the hostage-takers, Movsar Barayev, spoke to Yanderbiyev in Qatar. In the conversation, Barayev said that "Aslan" knew about the plans to seize the theater. Only three brief excerpts were played, however, and there was no way to verify the government's interpretations, including that Barayev was referring to Maskhadov.

The Chechen detained Wednesday in Copenhagen, Ahmed Zakayev, was in Denmark to attend a congress on Chechnya that had infuriated the Kremlin. The Danish government agreed to hold him on an Interpol warrant as Russia initiated a formal extradition request Thursday.

Interviewed by the *Times* last week before his arrest, Zakayev denied any link to the hostage-takers: "Neither President Maskhadov nor any of our official representatives are in any way connected," he said at the time. Rather, he blamed Russian policy in Chechnya: "Every day of war, every day of punitive measures leaves dozens of lone avengers who cannot be controlled by Maskhadov or anyone else."...

Col. Vladimir Yeryomin said hostage-takers had explosives equivalent to 250 pounds of TNT, including two large devices containing an artillery shell within a metal container packed with ball bearings; 25 devices of about 5 pounds each; and more than 100 grenades. If exploded, there would have been "absolute destruction," he said.

His evidence seemed aimed at bolstering Russia's position that it had no choice but to storm the theater after first pumping in an opiate-based anesthetic aerosol, fentanyl, that knocked out most of the Chechen militants and the hostages.

Although officials admit that the drug caused the deaths of 117 of the 119 hostages killed, Moscow Mayor Yuri M. Luzhkov disputed a suggestion that emergency personnel were not informed about the drug in time or prepared to deal with its effects. ...

"The physicians knew what to do," he insisted

[JR: Why is the finger of blame being pointed at ousted Chechen President Maskhadov when the real culprits are close to Putin in Moscow? Maskhadov when elected was considered a moderate whose goal was to bring Chechnya into the world community. As president Maskhadov had no power outside the capitol and as in Afghanistan the warlords had the control over the tribes and extremists that ran the countryside. After the Moscow apartment bombing in 1999 Pres. Maskhadov was quoted as saying that "Chechnya was being used as a playing field in the game of politics, and that fundamentalism, extremism and terrorism had been artificially created." He intimated oligarch Berezovsky and the Russian secret service were involved in terrorist activity, and that Berezovsky along with members in Yeltsin's inner circle had a secret relationship and close ties with Chechen rebels. Governments like to manufacture scapegoats like Maskhadov to hide their own duplicity. Under the 1935 *Nuremberg Laws*, only two flags were permitted in Nazi Germany. One was the swastika. The other was the blue and white banner of Zionism.

According to Lenni Brenner's online book *Zionism in the Age of Dictators* (Ch.7), the Zionist party was the only other political party in Nazi Germany that enjoyed a measure of freedom, and could publish a newspaper. History is not always what you'd expect.

There are more shocking examples in Brenner's book (Chapters 24 & 25).

For instance, in November 1942, Rabbi Michael Dov-Ber Weismandel, a Jewish activist in Slovakia approached Adolph Eichmann's representative, Dieter Wisliceny: "How much money would be needed for all the European Jews to be saved?" Wisliceny went to Berlin and returned with an answer. For a mere \$2 million they could have all the Jews in Western Europe and the Balkans. Weismandel sent a courier to the World Zionist Organization in Switzerland. His request was refused. The official, Nathan Schwab sent enough money to save only Weismandel and his cadre. He wrote:

"About the cries coming from your country, we should know that all the Allied nations are spilling much of their blood, and if we do not sacrifice any blood, by what right shall we merit coming before the **bargaining** table when they divide nations and lands at the war's end?... for only with blood shall we get the land." (p.237)

Brenner writes that Zionism had come full turn. "Instead of Zionism being the hope of the Jews, their blood was to be the political salvation of Zionism." (p.238)

In Chapter 25, Brenner relates how Zionist leader Rezsó Kasztner made a deal with Adolph Eichmann to save a few thousand hand-picked Zionists and wealthy Jews in return for deceiving and leading more than 750,000 Hungarian Jews to their doom. In 1954, when Kasztner was accused of collaborating, the Israeli government sprang to his defense.

Brenner documents how the Zionist and World Jewish leadership prevaricated and obstructed all efforts to save the Jews of Europe who apparently were worth more to them dead than alive.

I am Jewish and my family suffered from Nazi persecution. When I first heard this information, I immediately rejected it. It boggles the mind. However, as I learned more about the Illuminati's ancient plan for world domination with its satanic overtones and Masonic plan for rebuilding Solomon's Temple, I became more receptive.

Calls from the U.S. government to cancel the program on the grounds that it stokes hatred and bigotry were rebuffed by Cairo. So too were appeals

to Arab leaders to condemn the anti-Semitism rife in the Egyptian media. A protest demonstration by Jewish organizations took place outside the Egyptian embassy in Washington on Monday, November 4.

An Arab League spokesman rejected Israeli charges that the series is a violation of Cairo's commitment under the peace accord to shun anti-Israel incitement. Egyptian Information Minister Safwat el-Sherif declared that he could not see what the fuss was about. He denied that *Rider* had any anti-Semitic content at all. "Our media policy," he says, "is to respect all monotheistic religions."

We are de-capitalizing ourselves on a daily basis with a continuous siphon of our dollars for merchandise made and sold to us by foreign producers. These dollars will go down in value as their number is increased. Printing press "money" isn't wealth. If it were, the whole world would be rich, as anyone can do it.

American factories that produce Japanese cars are no answer, as profits go straight to Tokyo. This is merely making the rope to hang ourselves, as Karl Marx prophesied. "Only two things are infinite: The universe and human stupidity, and I am not sure about the former."—Einstein

I cannot stand to hold dollars. I have no savings account. Never had one. My checking account has just enough in it to operate my business correctly and pay the bills as they come in. For you who say I write this because I am a gold and silver dealer... I never used the words except in this sentence. You want to loan your dollars to people for long terms? Go to it. You want to have savings accounts that pay 1.5% interest while the dollar volume goes up and their value goes down? Do whatever you like. I am not God. You want to pay taxes on your 1.5%? Have at it. Keep those paper dollars. Buy government bonds or whole-life policies. Store them under your mattress—and by all means keep them safe. Watch their value disappear right before your eyes, as have all paper monies in history. Forget shiny tangibles. The question I have for you is: Why do you read *GOLD-EAGLE.com*? You are like the sinner that goes to confession every Friday, is drunk all the next week, and confesses every Friday. Maybe you are waiting for gold to go to \$200 and silver to \$2. I'll wait with you—and also till the sky falls, pigs fly, the federal budget is balanced and the "full faith and credit of the federal government" comes true. NEVADA CORPORATIONS:

Another Privacy Measure: "Uncertificated" Stock

Budget's "Tip of the Week" #19:

NRS 78.235: "Issuing Stock" Without a Certificate

Another special provision of Nevada's corporate laws is the ability to use what the statutes refer to as "uncertificated" stock. That's right, here in Nevada it is perfectly permissible to have "phantom" stock certificates. And now you know why our Budget kit leaves out the stock certificates, which are not needed to operate your corporation fully within the law.

As a general rule of good Nevada corporation management (maintaining privacy of ownership), it is often better to not issue stock, relying on *NRS 78.197* (which specifies that debt holders may have the rights of stockholders). But when stock must be issued, why not issue phantom certificates? Note that Section 5 of *NRS 78.235* (excerpts below) requires that the corporation "shall send the stockholder a written statement containing the information required on the certificates". This provision is obviously intended to protect the interests of the stockholders for other than one-person corporations and it is hard to imagine running into any problems for failing to notify yourself in writing once a year. Note that the corporation's bylaws could be written to waive any penalty for failure of notification.

NRS 78.235 Stock certificates: Validation; facsimile signatures; uncertificated shares and informational statements; replacement.

....4. Unless otherwise provided in the articles of incorporation or bylaws, the board of directors may authorize the issuance of uncertificated shares of some or all of the shares of any or all of its classes or series. The issuance of uncertificated shares has no effect on existing certificates for shares until surrendered to the corporation, or on the respective rights and obligations of the stockholders. Unless otherwise provided by a specific statute, the rights and obligations of stockholders are identical whether or not their shares of stock are represented by certificates.

5. Within a reasonable time after the issuance or transfer of shares without certificates, the corporation shall send the stockholder a written statement containing the information required on the certificates pursuant to subsection 1. At least annually thereafter, the corporation shall provide to its stockholders of record, a written statement confirming the information contained in the informational statement previously sent pursuant to this subsection....

When added to the mix of other privacy-of-ownership provisions available in Nevada, it is easy to see why it is impossible for anyone on the outside of the corporation to know who owns it—unless the owner tells them. Combining "uncertificated" stock with the concept of bearer shares, it is fully understandable how ownership of a Nevada corporation can change hands merely through entries made in its stock ledger, without any need for recourse to stock certificates.


