MEANWHILE BACK AT THE
COURT OF LAST DECEPTION—

No matter how hard the injustice system TRIES to convict the deposed former president Erap—it isn't working. So far the court and prosecution has failed to pin ANYTHING wrong on the man—or his son, also incarcerated in that Veterans' hospital. As THAT farce continues and the nation spirals down the drain, the SPLAT in the fan has hit.

The very person who first held the illicit payoff funds from an Argentinean (through Paraguay) power company of some \$14 million, has come forth and announced to the world that he was extorted BY THE ADMINISTRATION AND THE HEAD OF THE JUSTICE DEPARTMENT FOR PAYOFF FUNDS. Ah indeed, none other than U.S.-wanted Rep. Mark Jimenez AKA: MARIO CRESPO. He stood right before Congress and spilled the beans all over the place.

[QUOTING any paper, Philippines, Tuesday, November 26, 2002:]

NANI PEREZ AN EXTORTIONIST—MJ

... Jimenez, in his speech, confirmed Bulacan Rep. Wilfrido Villarama's charge that the Cabinet secretary referred to as the 'two-million dollar man' was none other than President Arroyo's Justice Secretary.

... Manila's 6th District Rep. Mark Jimenez yesterday blasted at Justice Secretary Hernando "Nani" Perez Jr., branding him an extortionist and confirming that Perez had received FROM HIM \$2 million which WAS DEPOSITED IN A NUMBERED ACCOUNT IN THE HONG KONG COUTTS BANK, WHERE PEREZ WAS THE BENEFICIARY.

But the Manila congressman, in the same privilege speech, broadly hinted at the involvement and participation of even higher officials in the Arroyo government when he stated that he and Villarama were not only "running after corrupt officials and cabinet secretaries," but "really running after those people who allow such corrupt Cabinet secretaries to remain in office because most, if not all, of the ills that bedevil our society and enslave our people are caused by the graft and corruption of officials in high government positions."

Mrs. Arroyo and her spouse, Jose Miguel, or "Mike", have been accused of having taken \$12 million of the DOLLAR pie amounting to \$14 million. She has maintained silence over these charges that have been repeatedly aired by opposition senators.

The President has also refused to fire Perez or order him to resign or take a leave of absence.

[H: It might be noted, however, that also in today's paper it states beleaguered Sec. Perez says he will have to take a "medical" leave to attend his "bleeding ulcer". I suppose so...]

... Reliable sources have told the reporters that it would be "extremely dangerous" for Mrs. Arroyo to boot Perez from the Cabinet as he is likely to drag her down with him if he is left to fend for himself. "Nani knows too much about her and the deals she makes."

Lawmakers from both houses called on the Chief Executive to relieve Perez from his post even as others said the Justice Secretary should resign pending an investigation.

But even before the start of any probe on the Justice Secretary and his \$2 million bribe, reportedly

Perez's share of the under-the-table commission for the approval of the IMPSA deal (Argentinean power "deal" which has cost the people MILLIONS of dollars) WHICH WAS APPROVED BY MRS. ARROYO ONLY TWO DAYS AFTER ASSUMING PRESIDENTIAL DUTIES OFFICIALLY IN MALACAÑANG, AFTER THE EDSA II COUP D'ETAT.

Malacañang spokesmen refused to give reporters a briefing but acceded to a brief interview with Press Secretary Ignacio Bunye saying that Jimenez's privilege speech confirming Perez as the \$2 million man, was JIMENEZ'S WAY OF BLACKMAILING THE JUSTICE SECRETARY DUE TO JIMENEZ'S PENDING EXTRADITION CASE.

Bunye also refused to confirm or deny that a certain Dondon, brother of a highly placed Malacañang official is now in Hong Kong to meet with Coutts Bank representatives to get a certificate of clearance for Perez. "This is a crude blackmail attempt by somebody who is desperately trying to evade extradition... Secretary Nani Perez is now in the process of answering the charges leveled against him," Bunye said while shying away from ANY inquiries by the media. ... He Said Jimenez should present strong evidence against Perez before they allow him to take a leave of absence.

IT WAS NOT CLEAR WHAT STRONG EVIDENCE THE PALACE DEMANDS OF JIMENEZ, SINCE THE BANK ACCOUNTS AND THE AMOUNTS DEPOSITED HAVE BEEN IDENTIFIED. EVEN ERNEST ESCALER, A PROVINCEMATE OF MRS. ARROYO AND A CRONY OF THE PALACE OCCUPANT, WAS IDENTIFIED AS THE CONDUIT.

... In an emotional privilege speech at the House of Representatives yesterday, Jimenez categorically said Perez extorted from him \$2 million. "He is an extortionist, and he extorted two million dollars from your colleague, Mark Jimenez," Jimenez said, adding, "I accuse him of destroying my family, my dignity."

He said the alleged extortion incident happened on the third week of January 2001 but was consummated on February 13, 2001. ... He deposited the amount on February 23, 2001. In proving his accusations, Jimenez said he was willing to allow investigators to look into his account provided Perez does the same to the Coutts Bank account in Hong Kong where the deposit was allegedly made.

He said the bank confirmed that the deposit had indeed been consummated. He did not say when the confirmation was made. But Jimenez said 'Secretary Perez should resign because he is an extortionist, 'evil spirited and ruthless'.' The Manila representative explained the bribe money he gave to Perez was not for his provisional liberty in connection with the extradition case filed against him by the United States government but for Perez to stop pestering his family. ... Jimenez said Perez and one Ernest Escaler had visited him seven to 10 times before he finally agreed to give him the amount.

... "This will have some dire implications with regard to the administration of President Arroyo," Paras (a representative) said. Rep. Imee Marcos, however, challenged Jimenez and Villarama to substantiate their allegations against Perez. "If they really have that courage, I dare them to go all the way up and really reveal everything they know about the supposed offenses of Perez... no matter who they hit and no matter how high it goes," Marcos said.

Marcos also urged Perez to allow a thorough investigation to be conducted to give him a chance to defend himself and present counter evidence to prove his innocence. Jimenez said he has all the evidence against the Justice Secretary and would file a case before the office of the Ombudsman. Villarama said Perez IS LIABLE FOR PLUNDER.

Abstract

A new exciting discovery of the existence and behavior of aether leads to a new concept of the essence of aether, that is able to explain why the famous Michelson-Morley aether experiment of 1887 failed, explain and unify the forces of Nature, explain why quantum theory works and even explain where the universe comes from, and last but not least, shows the gateway to the new source of energy of the future.

THE MICHELSON-MORLEY AETHER EXPERIMENT

Introduction

In 1887, Albert Michelson and Edward Williams Morley [1,2], assuming that aether was uniform and at rest in space, wanted to measure the absolute motion of the Earth in space. In order to do so, a special sensitive interferometer was pointed in various compass directions. The interferometer readings, however, indicated that the Earth had no relative motion to the aether in any horizontal direction. The interpretation of the result of the experiment was that it would mean that the Earth had no relative motion in space, which was obviously not the case. Michelson and Morley could not explain this mystery and, therefore, thought that their experiment had failed. Even today, many scientists believe that the Michelson-Morley aether experiment is probably the most important experiment that did not work—in the entire history of science. One of the explanations given by numerous physicists, including Albert Einstein, is that there is no such thing as aether at all. Even today, many mysterious forces and phenomena are still puzzling the minds of astronomers and physicists because of the unsolved mystery of the aether, that kept concealed the nature of mass, inertia, gravity, the powers of attraction and repulsion, magnetism, light, heat, electricity, superconductivity, twin stars, the source of energy of stars, volcanic and tectonic activities, black holes, and the expansion of the universe.

The mistake in the experiment

The assumption of Michelson and Morley that aether was uniform and at rest in space, was a fundamental error [1,2]. Had Michelson and Morley pointed their interferometer in a vertical plane, they would have concluded that the Earth is moving in a perpendicular direction to the surface of the Earth into space. A worldwide verification of their experiment would have indicated that the Earth is moving everywhere simultaneously in a vertical direction into space, which is, of course, not possible. The only conclusion therefore is: Aether is constantly moving towards the Earth in straight perpendicular lines,

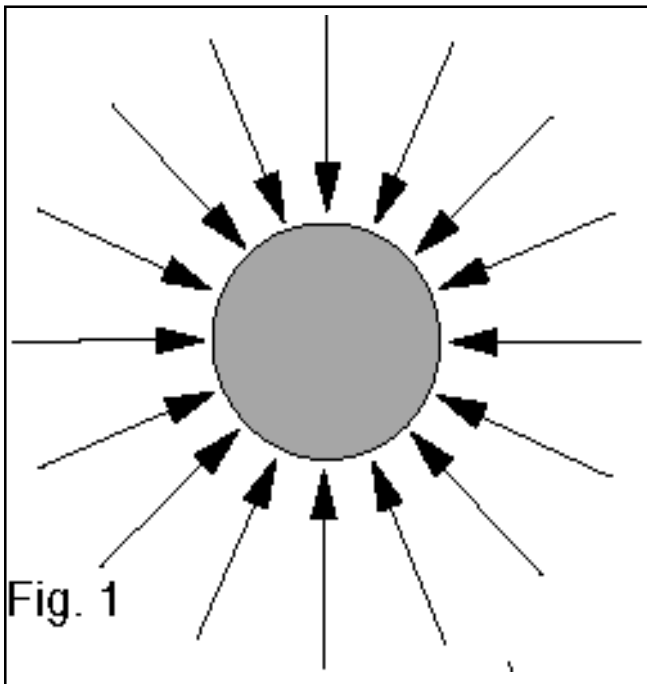

just like reversed rays of energy (Fig. 1). I have termed this phenomenon the “Charan effect”. The Charan effect is the cause of many sub-effects, as we shall discover further on. Consequent experiments and observations were so coherent that the existence of aether could not be ignored any longer—and the need of a concept or theory that would describe the essence, qualities and behavior of aether, was required for me to continue my own

research in the field of quantum electrodynamics, which is my field of activity.

A concept of the nature of aether, based on the Charan effect

The true nature of aether cannot be conceived by the human intellect—since it cannot be perceived by human senses. However, conclusions may be drawn based on the actions of aether or on phenomena caused by aether actions that probably may be true or closer to the truth than present assumptions. In this view, I have developed the following theory with which almost all the phenomena mentioned earlier can be explained in a logical, coherent, and conclusive manner: Aether is a pure form of subtle, active energy, in which all the forces of Nature are vested. Aether is the subtle energy tissue out of which matter has been made and is still being made and sustained. Subatomic interaction of aether and matter causes the phenomena of inertia, mass, gravity, cohesion and all the forces in Nature. On its way to the center of cosmic systems such as galaxies, the solar system, and atoms, the density of aether increases, causing higher speeds of the solar planets and of the subatomic particles interacting with it. The Charan effect is fundamental for the movement, control, and equilibrium of the cosmos.

The consequences of the Charan effect

The Charan effect, as simple and innocent as it may look, may have a bearing on science and stir up many aspects of it, even in industry, economy, and society. Many ideas, theories, concepts, formulae, definitions and units in physics—even of such great men as Isaac Newton and Albert Einstein—may have to be reviewed, redefined, adjusted, or corrected. The following examples may clarify what the logical consequences could be if the Charan effect were applied just in physics and astronomy:

Inertia would mean subatomic interaction with aether.

Mass would mean concentration of aether, due to the Charan effect, which is mainly in the center of a subatomic particle or the center of a celestial body, because of the higher density (concentration) of aether there. Consequently, mass may be just a flow of aether, a flow of energy, or an absorption of aether, a phenomenon, an effect, a force. It also means that mass is not a function of velocity, as postulated by Albert Einstein, but a function of aether concentration (aether density), which subsequently causes the velocity of a particle or a celestial body.

Mass is also an indication of the amount of aether that is being absorbed by the subatomic particle or the celestial body. The closer to the Sun, the higher the speeds

of the solar planets, because of the higher density of aether, caused by the Charan effect. Gravity would mean obstruction of the flow of aether, a kind of “aether shadow”

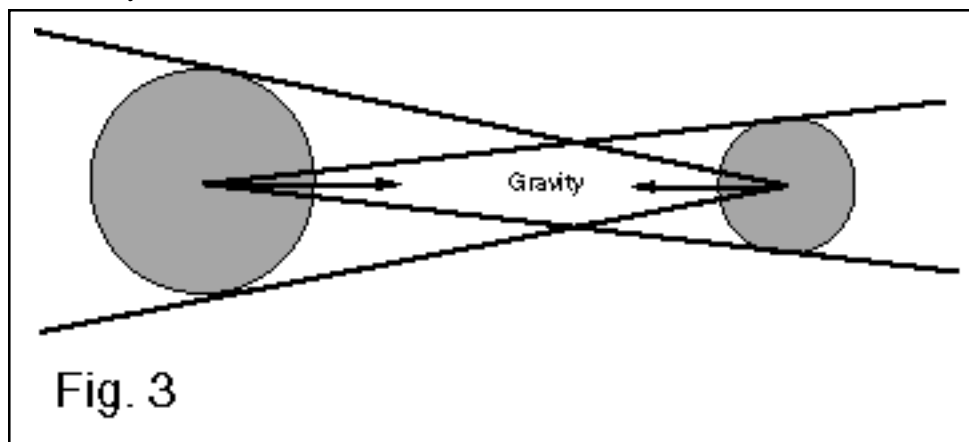

that bodies or particles cast upon each other; less energy on one side as a result of the Charan effect (Fig. 3).

Binding energy or cohesion of matter would mean gravity on a molecular level, which means aether energy.

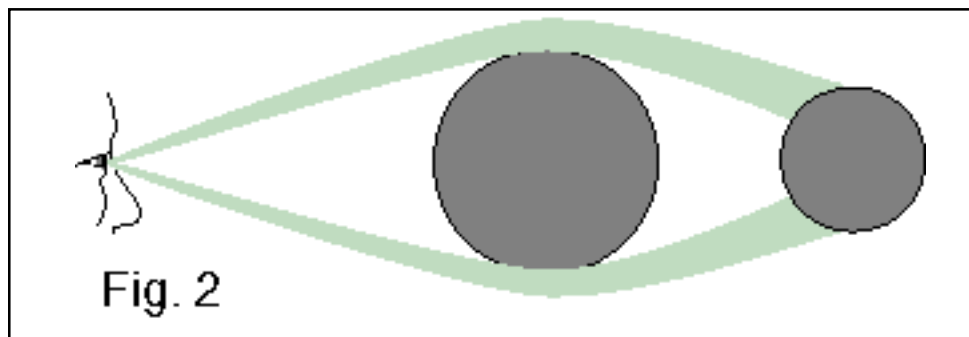

Bending of light, caused by the Charan effect, may be the cause for all sorts of distortions if objects move between the eye of an observer and a source of light—twin stars? pulsars? (Fig. 2).

Magnetism would be caused by the movement of matter in space (in aether) or of electrons in matter (in aether).

The magnetic poles of spinning celestial bodies or of spinning subatomic

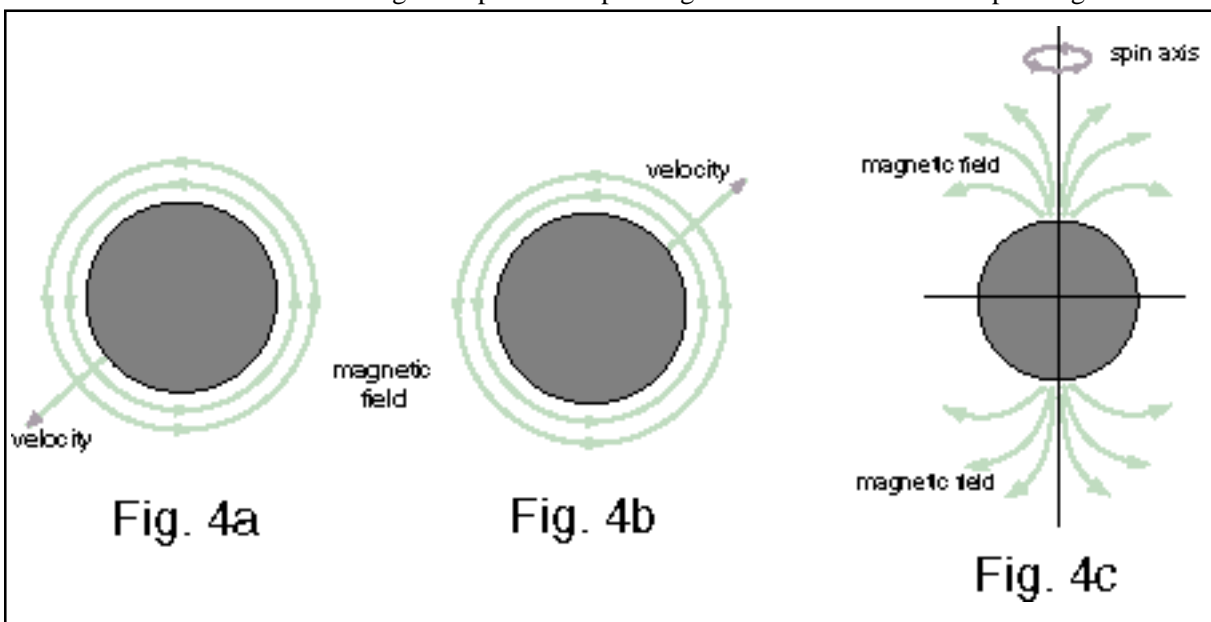

particles are vested in aether (Fig. 4a, 4b, and 4c).

Shift angles between magnetic axes and spin axes of celestial bodies are caused

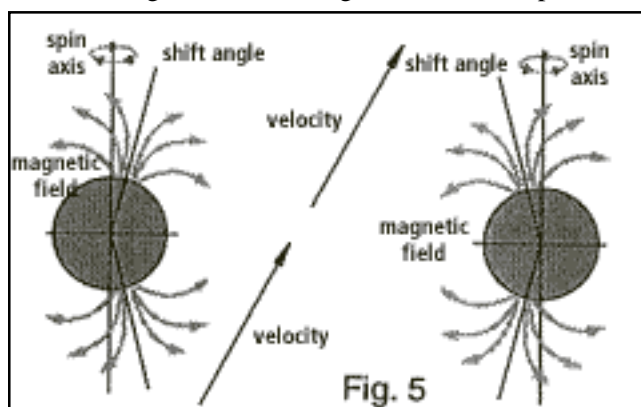

by the relative motion of the body to the aether motion (Fig. 5). Since aether is not at rest in space, nor uniform, measuring the shift angle and its position would not reveal the absolute movement of the body in space. There is no such thing as a fixed point in space;

everything is moving, magnificently controlled by one law, vested in aether.

The solar energy and the temperature of celestial bodies may be caused by the concentration of aether due to the Charan effect; the bigger the star, the higher the aether density and the higher the temperature.

Volcanic and tectonic actions may be caused by the concentration of aether inside or at the center of the Earth (Fig 6). The Earth may be growing, its mass may be increasing and its temperature may be rising.

Black holes may not be black holes at all, but gigantic concentration of masses in the center of galaxies, absorbing aether at such enormous speed, causing a Doppler shift of the light frequency far beyond the sensitivity of our eyes and therefore creating the impression of a black hole.

The big bang, presumably causing the expansion of the universe, may be just an impression caused by the movement of aether towards the center of our galaxy. Most probably, there has never been such a thing as a big bang. The Doppler red shift of light is not only the foundation of the big-bang theory, it is also the fundamental basis of measurements in astronomy. Now, if the movement of aether in space may cause a Doppler red shift, then a review of all the data in astronomy is due.

Electric power can be generated from aether

Great scientists such as Nikola Tesla [pictured], Paul Dirac and Werner Heisenberg have predicted the introduction of a new source of energy, which they called:

“electromagnetic quantum energy”, “zero-point energy” and also “vacuum-field energy”, which are different names for aether energy. Recently, I successfully concluded fundamental research in the field of aether energy conversion, which has resulted in a

new technology for producing engines, generators and batteries, in an economical and technically feasible manner. The very high energy density of aether allows such a flexibility of the aether absorption/conversion units, that they can be integrated on a silicon chip, for powering the chip of a wristwatch or a computer, but can also meet the requirements of a 4,000-megawatt power plant. **This means that soon a new source of energy will be powering automobiles, trains, ships, aircraft, tractors, electric power plants, homes, industries, portable computers, telephones, etc.** The aether technology in which I am involved, is environmentally clean and unlimited. Its application is neither restricted nor limited by materials or resources.

Once again in history, the cards are being shuffled anew and distributed in industry, like in the days of Thomas Alva Edison, and hopefully without too much turbulence at the international stock exchanges. Let us hope that the first application of aether energy will not be for military purposes, or for one nation to take advantage of other nations, as has so often been the case in history with epochal discoveries and inventions, but for the improvement of the conditions of humanity.

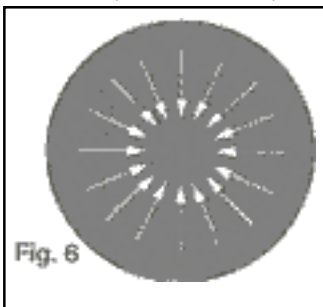
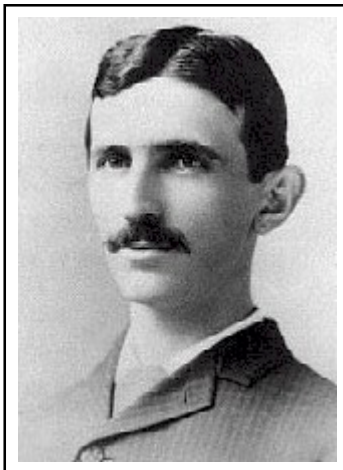

To be appointed by God is considerably different from being self-appointed or hired.

Today there are hundreds of thousands who are quite willing to preach some totally un-Biblical message about Jerusalem and everything else concerning the Laws of God. Yes, these are the same ones that require the congregation to declare belief in every word of that “Holy Book”. They, too, claim belief in every word—so, they interpret according to their own “received insight” or instructions from a higher “church” elder or man-pronounced authority—it has naught to do with God.

There are a few “Jeremiahs” telling the world what God says. Many is the un-Biblical message for which one can receive a very high honorarium or the receipt of cards and letters and contribution by the bushel-full. But any “Jeremiah” who dares to preach truth that both *Old Testament* and *New Testament* Biblical prophecies foretell that Jerusalem will again be destroyed or that “man” has changed the word of God to suit himself, etc., are assigned ridicule and the dungeon filled with mire of Zionist-Christian hatred and scorn—not to mention the New Age and other doctrines that have been written from their own set of cards and voted-upon new commandments and sanctioned behaviors. I insist not that you change from your fun journeys—I am sent forth to tell you the truth of how it IS and you are free to do whatever in this journey that you desire to do.

You who denounce on the basis of earth journey being ALL and that there is no past or future for the being, or choose up whatever story you desire—ponder this: **YOU WERE BIRTHED UPON THIS PLACEMENT AND GIVEN THE BREATH OF LIFE FROM CREATOR, YOU EXPERIENCE SOME AVERAGE YEARS OF 75 IN COUNTING, AND YOU DEPART THROUGH DEATH OF BODY. WHAT DOES THAT MEAN TO YOU?** Does it not mean that you came FROM somewhere and you go TO somewhere—**could it be you simply have been told so many lies that you CANNOT REMEMBER THE TRUTH OF IT? IS IT POSSIBLE? IS IT PROBABLE? ARE YOU SO DEAD ALREADY THAT IT MATTERS NOT TO YOU? HAVE YOU LOST YOUR VERY PASSION FOR THE EXPERIENCE? ANSWER CAREFULLY, MY FRIENDS, FOR IT CERTAINLY MATTERS NOT TO ME! IT MIGHT MATTER A GREAT DEAL UNTO YOU!**

There is one great difference between God's “600 B.C. message” and Gods “A.D. 1990 message” for Jerusalem, in particular. In His 600 B.C. message, there was an offer of deliverance for the nation if the whole nation would turn back to Him. I find no such clause in the 1990 message but only that “man shall come into knowledge of truth”. According to the prophecies of ancient projections, the city of Jerusalem is doomed—and who will change of the scenario? Is the Zionist group moving back unto God or are they preparing to return to Satanic rituals of blood-letting and slaughter of lambs to appease a god of their own making? God creates the lamb—He certainly does not sanction man killing his own creation instead of turning from his own sinful path and into goodness and integrity.

Therefore, it might be wise to look most carefully at that wondrous city of Jerusalem, for it speaks a message to all mankind.

That is the way the Lord Jesus Christ—looking down through the centuries to that day when it will be devastated again—gave crisp, succinct, authoritative and lifesaving projections for believing Jews of that day: “Then... flee into the mountains”. Oh, you say well, yes, but we good Jews don't accept that one, Jesus. Alright, let us go right to *Zechariah*: “Behold, the day of the Lord cometh, and thy spoil shall be divided in the midst of thee. For I will gather all nations against Jerusalem to battle, and the city shall be taken, and the houses rifled, and the women ravished...”.

Oops, worse yet, the *Luke* passage, the *Zechariah* prophecy and a funny little prophecy found in *Revelation* all harmonize perfectly. Let me just pronounce the latest, from *Revelation*: “And there was given me a reed like unto a rod; and the angel stood, saying, ‘Rise, and measure the temple of God, and the altar, and them that worship therein. But the court which is without the temple leave out, and measure it

not; for it is given unto the Gentiles; and the holy city shall they tread under foot forty and two months’.”

It would seem, even in cosmic arithmetic that “forty and two months”, even at loose counting, would be approximately some 3½ years, give or take a little for error or calendar discrepancies. It would seem probable, therefore, that the non-Jews will again be the military master of Jerusalem and it will “be the worst of the heathen” good old prophet Ezekiel warned (7:24). Oh, you ask, “Would that be the same Ezekiel that saw the wheel within the wheel of fire and radiance. That “thing” from which he claimed to hear the WORD OF GOD?” Yep, same old one.

Who then, might you ask, is making Jerusalem a safe place for the Jews if by their own prophecies, Jerusalem is not safe? Indeed, a very good question, is it not? The Godly Jewish have integrated into the peoples of the globe and have become your neighbor and your friend and good brethren to one another; they live at peace among their brothers in Godly manner “or un-Godly” as any other group. So who misleads and sets up for destruction his own-blooded people? Oh, indeed you must ponder it most carefully. And who of the so-called Christian brotherhood does that trusting Jewish brother a favor by your preachments?

Why then the tidal waves of JOY flowing from Christian pulpits because, “God's people are again back in their land”? There are at least three possibilities. Those who exude such joy do not know a thing about what they preach; not a thing about that which the *Bible* actually says will come to be. They know not what the *Bible* they tout, says is coming to pass “soon” in your days of counting; or they don't believe it; or they know what the *Bible* says and ARE AFRAID to preach it.

Both Jerusalem and the state of Israel are headed for complete destruction if they continue upon the plotted pathway—that is not prophecy, my friends, that is simple observation in total human logic. Would not the Christian who pronounces his non-judgmental friendship upon his Jewish brother perhaps point this little matter out unto his attention?

God created all men equal? How stupid a lie. God created all men each to be unique unto himself. They are only equally cherished by God Creator. It goes beyond cherishment even, God treats all men equally in justness. Not even what you perceive “fairness”—God is Just! When an individual returns unto God within God-self—he, too, becomes total Justice! Think upon these words. I can only present them unto you—I cannot “think upon them” for you. Think upon that also.

WILL “TRUE” BELIEVERS BE BLESSED?

To be a bit trite, but not disrespectful, you must note personally that which you consider to be blessed! A blessing unto one might seem a curse unto another!

But you desire to hear from the Great Book, so I shall effort to use that which you cling unto. Let us take your old book of *Amos*. Let us overview Chapter 9 verse 8: “Behold, the eyes of the Lord God are upon the sinful kingdom and I will destroy it from off the face of the Earth; saving that I will not utterly destroy the house of Jacob, saith the Lord.”

You might as well believe that the above refers directly to the present state of Israel. This one projection will totally enrage countless “Christian” pastors and evangelists who for years have been unable to lavish anything but praise upon the man-created state in the Near East (remember that place created and pronounced as Israel by the U.N.?) whose deeds promise to (and according to your own *Bible*, will) involve the entire world in a massive war.

However, such ministers cannot deny that this prophecy is in the *Bible*—YOUR OWN PROCLAIMED “EVERY WORD TO BE TRUE” *BIBLE*. Nor can they suggest that it relates to some other nation, inasmuch as it is the climactic statement in a passage that begins, “... the end is come upon my people of Israel...” (*Amos 8:2*). Hey, don’t blame me—I am writing this *Journal*—who wrote your *Bible*? You have asked me to prove myself through that which you claim to understand—your truth according to the scriptures of your religious books of laws and teachings. I do, however, think you may have missed a few pertinent facts from your own projections. So be it. Of course you can dabble about for a while and insist that good old Amos’ prophecy was fulfilled centuries ago.

Oops, that is patently dishonest, because the *Bible* states specifically that, in the day when *Amos 9:8* is fulfilled, God will effect four miracles that men could never perform. The four miracles are nowhere to be seen. So obviously *Amos 9:8* still awaits fulfillment.

Now, it might be noted that *Amos 9:8* harmonizes with *Luke 21:20-27* and *Zechariah 14:1-2* and good old UFO spotter *Ezekiel 7*: The present state of Israel is heading for ignominious destruction on the path being trodden. You go study the word, for I grow impatient, but I will look with you at *Amos 9:8-15*:

“Behold, the eyes of the Lord God are upon the sinful kingdom, and I will destroy it from off the face of the Earth; saving that I will not utterly destroy the house of Jacob, saith the Lord. For, lo, I will command, and I will sift the house of Israel among all nations, like as corn is sifted in a sieve, yet shall not the least grain fall upon the Earth. All the sinners of my people shall die by the sword, which say, The evil shall not overtake nor prevent us. In that day will I raise up the tabernacle of David that is fallen, and close up the breaches thereof; and I will raise up his ruins, and I will build it as in the days of old; That they may possess the remnant of Edom, and of all the heathen, which are called by my name, saith the Lord that doeth this. Behold, the days come, saith the Lord, that the plowman shall overtake the reaper, and the treader of grapes him that soweth seed; and the mountains shall drop sweet wine, and again the captivity of my people of Israel, and they shall build the waste cities, and inhabit them; and they shall plant vineyards, and drink the wine thereof; they shall also make gardens, and eat the fruit of them. And I will plant them upon their land, and they shall no more be pulled up out of their land which I have given them, saith the Lord thy God.”

Note the four miracles that God will effect after He has destroyed the sinful kingdom:

- * There will be a *divine* restoration of the Davidic capital.
- * There will be harmonious relations between Jews and believing non-Jews. (The Jews will be the believing remnant who refused to be part of the sinful kingdom.)
- * There will be unheard-of blessings on agricultural pursuits. (The millennium will have dawned, and the curse will have been removed from the Earth. How interesting - -!?! Hmmm.)
- * Israel (again the believing remnant, not the Satan-worshipping members of the sinful kingdom of Zionists) will dwell in the land and never again be scattered.

Believe the Word of God, not on the word of men. Now why would you believe that Amos really wrote those things in the first place? Because everyone wants to discount them and say his prophecies have already happened and reinterpret his message to suit the “times”—I believe you call it “modernization” of the *Bible*. Out of the thousands of years just

since your *Bible* might be considered historical, how many prophecies do you think might have been projected which never made it into print? You are experiencing zillions coming forth every year in your own lands in your own perceived “time”. This is a point worth also pondering.

Now a biggie: It is said also that “Before these things happen Jesus Christ will return in the air for all who have trusted Him as Savior.”

You had better be making pretty sure you know what you really believe, my friends. You might well be checking into your own resources for truth instead of simply attending groups who pronounce their version and interpretation upon your heads and you follow blindly along—you might well find yourself on the ground instead of those clouds with Christ. Right now you might well remove your heads from the clouds where you already have placed them and look beyond “flatland” into “reality”.

Why am I “hitting” Israel? Because I am getting ready to tell you some very important stories and you need the background to have anywhere near factual perception. It is the time of awakening, not further hiding while destruction falls upon your sleepy beings.

INTERESTING PREDICTION FROM EZEKIEL

Ezekiel 7:24: ... “I will bring the worst of the heathen, and they shall possess their houses...”.

Now look carefully, for anyone who studies the seventh chapter of that which you label *Ezekiel* carefully and believingly will discover that it contains many important facts about the coming ignominious end of the present state of Israel.

Israel “apologists” (ministers and evangelists at the head of the ranks, and not a few of them men who, in order to reach their conclusions, have gone not to the Word of God but to the state of Israel to be instructed by the Israeli government) will be quick to tell you the old, old story that “*Ezekiel 7* was fulfilled a long time ago”. But that is not what the context of the passage reveals.

Ezekiel 7:2 states most specifically, “An end, the end is come upon the four corners of the land.” Oh my—how many “Israels” and “four corners” might there be? Hatonn just picked up another mighty horde of enemies? Why? How is it that you blame Hatonn or this scribe for that which YOU have projected? Still believe “EVERY” word? I only want you to pay attention and pull off your dark glasses and remove the swimming plugs from the ears lest you not hear the ship bearing down upon you.

The land of Israel has had many “an end”, for she has been invaded repeatedly through the centuries, but “the end” will occur, according to the *Bible*, in the soon-coming great tribulation, a 3½-year period of unprecedented turbulence, which is described both in the *Old Testament* and in the *New Testament*. That *Ezekiel 7* (though foreshadowed by various Babylonian invasions) indeed relates to the still-coming great tribulation is further confirmed by *Ezekiel 7:19*, wherein the statement is made, “... Their silver and their gold shall not be able to deliver them in the day of the wrath of the Lord...”

DAY OF WRATH

“The day of the wrath of the Lord” is a term used throughout Scripture to describe the great tribulation.

To further suggest that the fulfillment of *Ezekiel 7* lies in the future, let us note some important teachings in *Ezekiel 7:24*: “... I will bring the worst of the heathen, and they shall possess their houses...”.

Observe carefully who it is that is going to “bring the worst of the heathen” upon Israel—“I will”. I suppose if you believe the *Bible* in fullness, it is God speaking, Jehovah, the Lord God, the Lord Jesus Christ. Hence, though contemporary Israel will be destroyed by the wrath of men, this will occur according to the wise and infallible will of God.

Observe secondly whom it is that the Lord will use to destroy Israel—“the worst of the heathen”. The Hebrew word used here is **goyim**, which, throughout the *Old Testament*, refers to the “gentiles”, or the “nations”—in short, to those who did not belong to the commonwealth of Israel.

It was to Israel that God entrusted His Word, the revelation of Himself. It was to Israel that God came in person, when He took on human flesh in that geographical location of the Earth. Yet when “He came unto His own and His own received Him not”—so far from God had the nation wandered upon which the nations were dependent for the sharing of His revelation. Having rejected its reminder messenger “redeemer”, the nation, from that point on, headed toward “the end” promised in *Ezekiel 7:2*. As a nation, Israel has, of course, disbelieved or ignored God’s revelation that this end is coming.

BIG SPLASHY HULLABALOO AND HOOPLA

Many (but far from all) of her people worked furiously and connived to bring the state of Israel into existence in 1948. Most God-trusting Jewish brothers were settled in their own homelands and were mightily content among their brethren in their birthrighted countries, wherever they might have been geographically located. Being Jewish does not automatically make you an Israeli any more than being black makes you African or being white make of you an Englishman. That hullabaloo was connived thereby to create a glorious future for Israel. Much squawking and rattling (with countless Christian ministers serving as the chief squawk-leaders) followed the creation of the state of Israel—also decades of bloodshed and increasing world tension. And “the end” will be a global war in which the “nation” (singular of **goyim**) will be pitted against the “nations”. The “nations” will win!

God Himself, if correctly projected, will bring the cruelest, scummiest and most degraded heathen to trample Jerusalem under their feet. him as birthright. DO NOT GIVE THINE POWER FROM GOD UNTO ANY OTHER—NOT EVEN UNTO GOD. HE GAVE IT UNTO THEE AND HE IS GRATEFUL IF YOU GIVE BACK UNTO HIM, THINE WILL—NEVER YOUR POWER OF GOD-SELF. DO NOT GROVEL UNTO CHURCH PROCLAIMED (MAN) LEADERS. GOD IS THINE CREATOR; NOT HUMAN. FURTHER, YOU CAN DISCERN BY WHAT THE LAWS GIVEN DOWN FROM MAN ARE—THEY DEAL WITH FLESHLY GAIN AND MANIFESTED CONTROL OF ONE SORT OR ANOTHER—THEY WILL ALWAYS BREAK AT LEAST ONE PORTION OF THE LAWS OF GOD AND CREATION. ALWAYS!

We shall cover these things in another volume, for this one is now becoming too large for thorough digesting—and we wish the *Journals* to be frequent and not so impossibly lengthy. Perhaps we can label this subject *Journal* as volume I or something which denotes further input. It matters not, for we shall be returning to these things in further outlay as we move along. Herein, we are setting the stage in that you can understand from whence comes your deadly enemies.

I suggest, in fact, that we close the final chapters of this *Journal* this morning so that overload is minimal. I wish to return to our original subject, please.

The following is taken from the *Protocols of the Meetings of the Zionist Men of Wisdom*, from a book published in 1920 by Small, Maynard and Co., using the *Protocols of the Learned Elders of Zion* from Nilus which first appeared around 1884. Frightening is it not? The plan has been working in perfection before and since.

The word “protocol” was used to signify a fly-leaf pasted at the top of an official document, bearing either the opening formula or a summary of the contents for convenient reference. The word came to mean also the minutes of the proceedings. In this instance “the protocols” mean “the draft of the plan of action” of the Jewish leaders. There have been many such drafts in Jewish history since the dispersion, but few of them have come into general circulation as have these, and been followed as the “law”. In all, the principles and morality are as old as the tribe. By the way of illustration we give an instance which occurred in the 15th Century.

Quote from the book, please:

In 1492, Chemor, chief Rabbi of Spain, wrote to the Grand Sanhedrin, which had its seat in Constantinople, for advice when a Spanish law threatened expulsion. This was the reply:

“Beloved brethren in Moses, we have received your letter in which you tell us of the anxieties and misfortunes which you are enduring. We are pierced by as great pain to hear it as yourselves.

“The advice of the Grand Satraps and Rabbis is the following:

1. As for what you say that the King of Spain obliges you to become Christians: do it, since you cannot do otherwise.

2. As for what you say about the command to despoil you of your property: make your sons merchants that they may despoil, little by little, the Christians of theirs.

3. As for what you say about making attempts on your lives: make your sons doctors and apothecaries, that they may take away Christians’ lives.

4. As for what you say of their destroying your synagogues: make your sons canons and clerics in order that they may destroy their churches.

Are you proud to take Holy God within the places of darkness and evil to force His sharing of your evil? Does God really bear the sword and spill the blood of his other creations—or does perhaps MAN hold and swing that sword and claim it to be in the name and service of God? Did the hand of God write and then move on? Truly? Or did man write and project his own interpretations upon others? **Is it possible that other men now read into the words their own interpretations and thrust those, also, upon you and you blindly take them unto self as truthful law?** Is it possible that all is colored by the revenge, hate and greed which ravages in the hearts of human and has very little to do with the Holy God which you continually “blame”.

Another false statement—it is so simple that even a partial-adult can understand it. Children only understand truth—they immediately recognize the lies and therefore they must be **taught** evil. At any rate, the story is simple indeed and will, in all probability, come to pass exactly as written—for we who have exceptional probability scanners and data systems see no effort what-so-ever to change of the track.

Another point—how many of you have heard the prior story? How many of your children? What do you tell your children? Do you simply allow them to learn their stories through the vidiot box run by Zionists? Ah so, toes are cramped? Sorry about that! Why have not all the children come into this knowledge? Because there are so few grown men who study and preach the true Word of God, but so many who instead are willing to help spread the lie and the propaganda in the name of the word of the *Bible*, which in fact, is exactly the opposite of that which is written in that same book.

How does this ring keep operating? Well, Mr. Klein is part of a worldwide trade in military arms and expertise that brings Israel big money, along with innumerable scandals. The nation needs international sales to prop up its arms industry, and prosecuting him could open a window that Israel prefers to keep shut. Israel has shown willingness to do arms business with any government—friend or foe—for you see, their plans are far beyond neighboring quarrels.

Just this day (5/10/90) please take note, if it appears on your media accidents, the Israeli banks are in serious trouble and “bankers” are being pulled out like flies for corrupt dealings. This is today’s topic of the hour in Israel. You see, they cover up the truth, also, and hide behind currently arranged distractors to keep the populace from discovering the overall plan. The nice little Israeli citizen has no more notion of what is going on than does the nice little grandmother from Oklahoma. The expendables are never allowed to intentionally know truth.

Arms are the biggest business in Israel. At least one out of every ten workers is involved in the arms trade, from cottage-industry consultancies operated out of seedy Tel Aviv apartments, to industrial giants such as Israel Aircraft Industries Ltd., the state’s largest exporter, whose foreign military sales, last year alone, exceeded \$800 million. It operates as a corporation doing business all over the world under different labels, so this only touches the very tiny tip of the iceberg—do you still discount the value of corporations?

According to *official* (not to be confused with the real figures), military sales to more than 60 countries brought Israel \$1.4 billion last year—not to even mention the money gleaned *unofficially*. And where, brother American, do you think they get the weapons to sell? I knew you knew if you just thought a minute—real hard. Now there are only 4.4 million Israelis—you do the arithmetic. That most certainly puts Israel forth as a very large arms exporter indeed.

Of course, this does not include the training schools which are utilizing trainers from the Mossad and elite assassins.

OFFICIALLY, over 40 percent of Israel’s sales are to the U.S. and Europe. But even a partial list of other past and current clients reveals the bizarre nature and the global reach of Israel’s arms trade or “pass through” dealings for places such as the U.S.

Murky dealings in Latin America long predate Mr. Klein’s adventures. And remember—the Ambassadors from both Peru and Colombia both told your congressional committee on drugs, etc., that the automatic assault weapons and all drug-war weapons were originally produced in the United States of America and were shipped in both directly and through routes through other nations “such as Israel”.

Israel has openly supplied arms and training to the military juntas of Chile, Guatemala and Argentina. It aided Nicaragua’s Anastasio Somoza until his fall, then aided the Contra rebels. A top adviser to Panama’s Manuel Noriega, Michael Harari, was former head of clandestine operations for Mossad, Israel’s intelligence service—remember?

The late Ayatollah Khomeini got Israeli arms. And of course you know the Iran-Contra story, so spare us the time of repeating.

And then, in 1988 a middle-man got caught in Hong Kong and exposed the details of a long-denied arms-supply relationship with China—oh, the song goes round and round and it come out here.

Now comes one claim in defense of such dastardly dealings—the arms are necessary “for protection” for regimes that have large or vulnerable Jewish communities, such as Ethiopia, Chile, Argentina, Morocco and South Africa. Why would those particular countries have such vulnerable Jewish communities?

Now hear the party line regarding Ethiopia and arms. “Well, whatever we did in Ethiopia was to insure freedom for emigration (to Israel) of the 17,000 known Jews located there.” Why? Israel is

demanding from you some billion dollars for tending the influx of Jews from the European crises. Could it be to insure take-over of the Palestinian real estate?

A Mr. Peled, a retired Israeli officer who is a major-general in the reserves, last year founded his own company, Crossbow Ltd., to develop and market arms. A confidential private-placement memorandum details the company’s “aim to produce products for use by military and paramilitary combat units at the low tactical echelons”—or, as Mr. Peled puts it, “to get some of the glitter of high-tech weaponry into the hands of ordinary fighters.”

Mr. Peled’s decision to turn his distinguished military career to use in business isn’t unusual in Israel, where army service is universal. “You take a guy who grows up on a farm and goes into the army,” says Aharon Klieman, a professor of politics at Tel Aviv University, “When he comes out, he knows two things, how to grow tomatoes and how to make war. And there’s a lot more money in war.”

Of course you also know of the lie regarding Uzis and other weapons which were to have been ordered for and delivered to Antiqua—and ended up with the Drug Kings of Colombia. Well, that was approved by Israel and acknowledged by Baruch Binah, a spokesman for the Israeli Foreign Ministry.

Well, another interesting tid-bit. “It isn’t time to tell the full story,” says the most involved person, Mr. Klein, “but it will be a block-buster when it comes forth”, he elaborates. It most certainly will, little chelas, it most certainly will! And just wait until you hear about Panama and these past three weeks!

Mr. Eitan, a member of the Israeli parliament and a former army chief of staff, says the following, “Someday, perhaps, if it’s decided that the stories can be told, you’ll see that the state has been involved in acts which are a thousand times more dirty than anything going on in Colombia,” he told the *Jerusalem Post*. “These things were decided by the government, in cabinet meetings. As long as the government decides to do something, something that the national interest demands, then it is legitimate.” These things are worked out behind closed doors in top secret with top nations of the world.

So be it.

Like to hear of some of the toys you can pick up on the open market? I knew you would, so right from the horse’s mouth: “In the Israel Defense Sales Directory; (full color, glossy sales brochures), low cost terminal guidance kits for general-purpose bombs; ear in the right place bugs for telephone, telex and computer monitoring; the unique Hightech riot-control vehicles with colored, tear-gas jets.” And then there are others, “consultancies offering expert personnel in certain military fields of activity and offering their services to help develop ground and air forces.”

Oh, by the way, Mr. Klein personally saw to the procurement of “belts, helmets and personal gear” for the Phalange Christian militia, the group responsible for the massacre of Palestinians in the Sabra and Shatilla refugee camps.

U.S. GOVT. TOO MEEK TO PROTEST

When Dr. Gerald V. Bull, 60, a key Pentagon scientist, was found murdered recently, FBI investigators on the case made a startling discovery.

Surveillance teams of the Mossad, Israel's secret service, had tracked the world-renowned American physicist from Washington to New York and then aboard a transatlantic flight to Brussels, Belgium, where a Mossad hit man shot Bull dead with a silenced 9-mm pistol.

Bull was just the latest victim on a list of as many as a dozen Americans "terminated" by Mossad operatives because their activities were thought to threaten Israel's interests, *The SPOTLIGHT* has learned exclusively from a senior Justice Department official in Washington.

Following up this lead, a team of reporters for this populist newspaper encountered a long-suppressed sense of outrage among law enforcement and intelligence experts over what one source called "the Mossad's mob tactics."

"You can bet no one will be indicted for killing Dr. Bull," asserted a veteran Pentagon investigator. "When the Mossad 'eliminates' an adversary, it can count on the protection of the most powerful fixers in Washington. As long as this cover-up continues, the murders will go on, too. There will be more victims."

SOUNDPROOF CURTAIN

Other sources confirmed that two leading alien interest pressure groups, the Anti-Defamation League

(ADL) and the World Zionist Organization (WZO), have "lowered a soundproof curtain over Israel's covert operations" as media historian Arthur Godoy put it.

"The WZO and the ADL supply more than well-orchestrated public relations for the Mossad," explained the Pentagon investigator. "They provide financing, contacts and protected bases for Israeli operatives in the U.S.—even if their mission violates our laws."

When Col. Robert Bayard, a retired U.S. Army officer, was shot to death in Atlanta, Georgia in 1977, "the official explanation was that some vagrants had done it," recalled an Atlanta lawyer who was an assistant district attorney at the time. This knowledgeable source agreed to talk to a *SPOTLIGHT* reporter on condition that he would not be quoted by name. [Hatonn: We know who this person is, Dark Brothers—and we put you on notice to back away, for he is under our protection.]

"But our investigation revealed that while on active duty, Col. Bayard had been detailed to the CIA and assigned to the Middle East, where he worked with Arab governments and became known as a critic and adversary of Israel's expansionist tactics," he said.

Retired early, reportedly at the insistence of the Israel lobby in Washington, Bayard became an executive with an international armaments and security firm. "I guess the Mossad thought Bayard was still a threat to their interests," related the Atlanta attorney, "and they decided to 'terminate' him. That was the real finding of our investigation. But of course we were not allowed to say it publicly."

Barry Seal had no interest in politics or strategy when he ran afoul of the Mossad's U.S. network in the mid-1980s: He was a drug pilot.

When Seal was shot dead in New Orleans in 1988 by "unknown assailants", the official account cited Seal's secret links to the Drug Enforcement Administration—he had turned informer—and blamed his murder on the cocaine cartel.

But privately federal investigators say that Seal had been informing on the so-called Harari network—the group of Mossad operatives based in Panama who made millions of dollars smuggling narcotics and weapons under the command of Mike Harari, a veteran Israeli official known as an assassination specialist.

"Seal was the key snitch in a major undercover drug investigation of this Mossad team's drug deals, and afterward he was scheduled to testify before a Senate committee," says a longtime congressional investigator. "There is no question he was hit by the Mossad. Off the record, that's the finding of the federal agencies who looked into his killing."

Unlike Bayard and Seal, whose lives had secret compartments, Bull was a brilliant, widely respected U.S. defense scientist who has been credited with pioneering work in the field of long-range artillery. In the 1960s he developed an exceptionally accurate 16-inch cannon that is still in use on some U.S. battleships.

Eventually Bull was named director of the Defense Department's highly classified High Altitude Research Project where he worked on long-range nuclear cannon prototypes. One of them, fired experimentally in the Caribbean, hurled an atomic shell the size of a compact car a record 112 miles into space.

In the late 1970s, Bull and a group of business associates set up the Space Research Corp., which began to market some of the artillery technology developed by the noted scientist.

MARKED AS A THREAT

Federal investigators say the Israeli government, which had in earlier years purchased some of the large, high-velocity munitions produced by Bull from the United States, marked the eminent physicist as a "threat" when the Iraqi army also applied for permission to acquire some of Bull's long-distance artillery pieces.

In the late 1980s, the American scientist worked as a consultant to Iraq in manufacturing an unusually large and powerful 40mm cannon; this was reportedly enough to seal his fate.

"Israel's record of murdering scientists and engineers who agree to do contract work for an Arab government goes back to the 1960s," recalled Prof. Godoy.

"That the Mossad has now assassinated such a distinguished American scientist signals no change in their tactics; it marks only the growing power of the ADL and WZO to cover up the terrorists outrages of Israeli agents, even when the victim is an important U.S. figure. This conspiracy of silence must end, if only to protect American lives," he said.

Other knowledgeable sources agreed with his conclusions.

The *SPOTLIGHT*, which is looking into the murders of several other U.S. citizens described by intelligence sources as Mossad targets, will continue its investigation.

* * * * *

DIGS U.S. INTO A BOTTOMLESS HOLE
NOT OUR JOB TO PREVENT
THE PROLIFERATION OF WEAPONS OF TERROR

If the Bush administration gets its way, defense spending next year will be \$394 billion, or about \$100 billion higher than in Bill Clinton's final year. The United States has the most powerful military on Earth. We now spend as much on defense as the next 15 nations combined. And you know what? It's not enough.

Despite the swelling budget, there is still a big gap between our resources and the administration's ambitions. The president's new strategy proclaims that we're not only going to meet any military challenge that may arise, but we may attack any country we see as a developing threat. If we're serious about that, even an unlimited budget won't suffice.

The administration gives us a glimpse of what to expect. The president's budget calls for piling spending increases upon spending increases, boosting national defense outlays to \$442 billion by 2007—up by nearly 50 percent from 2000.

But among conservatives, this financial commitment is seen as pitifully inadequate. "A year into this activist foreign policy, the defense agencies that will prosecute the war on terrorism remain starved of resources," declared military historian Frederick Kagan in a recent article in the hawkish *Weekly Standard*. "Increases of some \$100 billion annually or more—over and above the increases already called for—will be necessary to provide for a defense establishment able to fulfill the president's national security strategy."...

Making it our job to prevent the proliferation of weapons of mass destruction is like trying to drink the oceans dry. The Pentagon says at least 25 countries have or are trying to get "nuclear, chemical or biological weapons or the means to deliver them." Every action we take to forcibly disarm a potential threat gives other nations additional incentive to acquire such armaments so it can avoid that fate.

Iraq is first on Bush's list, and the administration admits that the war and its aftermath could cost up to \$200 billion. Unlike the 1991 Persian Gulf War, we may not find many other countries willing to share the sacrifice in either blood or treasure. Estimates of the force required to occupy the country and maintain basic order start at 100,000 troops—a number that could go higher if Iraq's many factions want to fight one another, or us. ...

An editorial in the *Wall Street Journal*, which often echoes hard-liners inside the administration, called for firm measures to get rid of the North Korean government, arguing that "a new government in Pyongyang is probably the only sure non-proliferation policy." The same logic may hold for Iran. Going to war with either regime would make the pending hostilities with Iraq look like a day at Disney World.

But stopping proliferation is not a one-time fix. Says University of Chicago political scientist John Mearsheimer, author of "The Tragedy of Great Power Politics", "It's not viable just to conquer and occupy a country to get those weapons." That's because the next government may also want to acquire nuclear weapons,

even if it's a democracy—as democracies such as India and Israel already have. "You have to stay forever," he warns.

Are we prepared for the sacrifices of this grand mission? Not likely, given that we lack even the will to bring basic order to Afghanistan—which not long ago was perceived, accurately, as an urgent problem demanding long-term attention. If the American people weren't willing to accept a major commitment in Afghanistan, despite its role in the Sept. 11 attacks, why would we be willing to do it for Iraq or some other country that hasn't attacked us?

Even a superpower will find out sooner or later that there are limits to what it can control in the world. At the rate we're going, it will probably be sooner.

U.S. FEARS PROSECUTION OF PRESIDENT
IN WORLD COURT

WASHINGTON (*Reuters*)—A senior U.S. official said a principal motive for U.S. opposition to the newly created International Criminal Court (ICC) was fear that the court might prosecute the president or other civilian or military leaders.

"Our concern goes beyond the possibility that the prosecutor will target for indictment the isolated U.S. soldier. ...Our principal concern is for our country's top civilian and military leaders, those responsible for our defense and foreign policy," Under Secretary of State John Bolton said in a speech released on Friday.

"A fair reading of the treaty (setting up the court) leaves one unable to answer with confidence whether the United States would now be accused of war crimes for legitimate but controversial uses of force to protect world peace," Bolton told the Federalist Society in Washington on Thursday.

"No U.S. presidents or their advisors could be assured that they would be unequivocally safe from politicized charges of criminal liability," he added.

That fear, which U.S. officials have rarely if ever articulated in public, explains why the United States opposed a compromise offered in September by the European Union, which is strongly in favor of the new court.

When Washington lobbied European governments this year for immunity for U.S. personnel, the Europeans suggested limiting liability to U.S. soldiers and officials sent overseas.

"There are many Americans that are not diplomats and troops," said State Department spokesman Richard Boucher, explaining why Washington thought the offer inadequate.

Bolton, a hawk who opposes international obligations which tie Washington's hands, said top

U.S. civilian and military leaders ran the risk of prosecution in the international court "as part of an agenda to restrain American discretion".

He likened the international prosecutor to the U.S. independent counsels who have harassed U.S. presidents.

The most famous of those was Ken Starr, who led the investigation into the financial and sexual affairs of former President Bill Clinton, which led to his impeachment.

"That history argues overwhelmingly against international repetition. Simply launching massive criminal investigations has an enormous political impact.

"Although subsequent indictments and convictions are unquestionably more serious, a zealous independent prosecutor can make dramatic news just by calling witnesses and gathering documents, without ever bringing formal charges," Bolton said.

The international court came into being on July 1, with a mandate to prosecute genocide and crimes against humanity.

The United States has refused to cooperate with the court and is trying to persuade other countries to sign bilateral agreements giving U.S. personnel immunity from prosecution.

So far 13 countries have signed such agreements and Bolton said the United States would soon have negotiations on agreements with countries in the Middle East and South Asia.

SENATE OKS HOMELAND LEGISLATION

WASHINGTON—The Senate passed a sweeping reorganization of the federal government to meet the threat of international terrorism Tuesday evening, including a series of last-minute additions that critics charged were payoffs to myriad special interests. Later, senators also passed a major terrorism insurance bill.

The vote to create the new Department of Homeland Security, which has been the subject of much angry partisan debate, was 90-9. The department will encompass 22 federal agencies and 170,000 employees, the broadest restructuring of the U.S. government since the Defense Department was created in 1947 at the advent of the Cold War.

But the hundreds of pages of fine print in the measure, which will go to President Bush for his signature, contain everything from protection for pharmaceutical manufacturer Eli Lilly & Co. against a lawsuit filed by parents of autistic children to an earmark assuring that Texas A&M University will be the site of a security research center.

Other measures that have attracted little attention include pay raises for thousands of high-level federal bureaucrats and a cap on the amount of damages that can be awarded against certain airport security companies that were on duty on Sept. 11, 2001.

The legislation also extends the surveillance powers of federal, state and local government agencies by granting new authority to obtain the Internet and e-mail records of citizens from Internet service providers. Any government entity, not just law-enforcement agencies, would be allowed to trace e-mail and Internet records without prior court approval in some cases. ...

Still, experts cautioned it would be years before the broader changes in federal government achieve their full effect in bolstering protections against terrorist attack. The organization of the Defense Department was hampered by interservice rivalries and had to be revisited numerous times in the years that followed. The Homeland Security Department will touch on agencies with much more varied missions and less shared history.

The Senate later Tuesday also approved legislation to protect the insurance industry against catastrophic losses from future terrorist attacks. Federal taxpayers would finance up to \$90 billion in claims in the event of a terrorist attack. ...

The House already has left Washington for the year. And on floor, Lott fended off efforts to modify the legislation by raising alarm at the prospect of a further delay while waiting for the House to reconvene so it can agree to changes. ...

Collins and Snowe said Republican leaders agreed to next year repeal the earmark for Texas A&M and scale back the grant of legal immunity for Lilly so that it does not apply to pending lawsuits. Also, they said, the Republican leaders agreed to narrow a provision contained in the legislation that creates a loophole to the current ban on government contracts for companies that move offshore to evade U.S. taxes.

The lone Republican to dissent was Sen. John McCain (R-Ariz.).

"I thought the process itself was bad, unbelievable," he said.

With just eight words, the legislation wipes out dozens of pending class-action lawsuits filed by parents of autistic children. The suits target the manufacturers of thimerosal, a preservative containing ethyl mercury that was used in childhood vaccines. The largest producer of thimerosal was Lilly, which halted use of the product in 1990. ...

Existing federal law already contains liability safeguards for vaccine manufacturers but does not provide such protections for those, such as Lilly, who made the preservatives used in vaccines. ...

Another piece of unrelated legislation contained in the bill could raise the annual compensation of at least 8,300 federal employees to the same annual pay received by the vice president, which is more than \$192,000 this year, according to the bill and Senate aides familiar with the provision.

Federal employees covered by the provision include more than 7,000 members of the Senior Executive Service, who are top-ranking, non-political hires; about 1,300 administrative law judges; and certain federal court officers, clerks and administrators, according to the legislation and Senate aides.

The law now caps annual compensation for those employees, which includes base pay, allowances, bonuses and the like, at about \$166,700. **[JR: If Eli Lilly & Co. halted the use of thimerosal in 1990, why is it still in flu vaccines, unless they are going to use up all the old surplus vaccines now in storage? Our Knesset has now guaranteed them protection from lawsuits in the Homeland Security bill. AN ATOMIC EXPLOSION COMING SOON TO YOUR CITY?

Los Angeles, Alta California (ACN)—The Brazilian journalist Pepe Escobar who writes for the Hong Kong based *Asian Times* reported yesterday in an article titled "Apocalypse Now, or Alottanukes Soon" that "Seven nuclear heads have already been positioned in seven of America's major cities and they are ready to be detonated." On August 30, 2001 Pepe Escobar also predicted the World Trade Center terrorist attack in an article titled, "Get Osama! Now! Or else " in which he reported for the *Asian Times* on a meeting between the Taliban and al-Qaida.

The *Asian Times*, which primarily focuses on Asian business and finance, removed the "Apocalypse Now" article from their Website and is now saying that it removed it because **they later determined it was a hoax**. This is very strange! **[JR: The article in *Asian Times* was picked up by several other news sources before being removed.]**

Pepe Escobar's "Apocalypse Now, or Alottanukes Soon" reported on an interview conducted by the Qatar-based *Al-Jazeera* television station of Mohammed al-Usuqf, a top al-Qaida leader.

Pepe Escobar's account of the Al-Jazeera interview:
[QUOTING excerpts:]

... Al-Qaida, according to Al-Usuqf, has 5,000 first-rank operatives and around 20,000 all over the world. ...Confirming *Asia Times Online* information, he swears that there are no first-rank prisoners in Guantanamo in Cuba. Al-Usuqf says, "We have more than 500 first-rank and 800 second-rank [operatives] inside the U.S." "First rank" are considered ones that have lived in the U.S. for more than 10 years, most of them married with children. "They have an idea about the plans, and they are just waiting for a call." "Second-rank" operatives arrived in the past five years and "have no idea about the plans". They are all willing to die.

Al-Usuqf insists that September 11 "was just the beginning. It was a way to call the world's attention to what's going to happen." He then details a plan to destroy the U.S. by "attacking the heart of what they consider the most important thing in the world: money".

"The American economy is an economy of false appearances," says al-Usuqf. "There's no real economic weight. American GNP is something around \$10 trillion, but only 1 percent comes from agriculture, and only 24 percent from industry. So 75 percent of its GNP comes from services, and most of it is financial speculation. For someone who understands economics, and apparently America's Treasury Secretary Paul O'Neill does not, or cannot, the U.S. as a whole behaves like an immense dot.com, and dollars are its stocks. The value of stocks from a given company is directly proportional to its profitability. When a company only provides services, but does not produce goods, the value of its stocks depends on its credibility. What I'm saying is if U.S. credibility is affected, its stocks—the U.S. dollar—will fall at tremendous speed, and the whole American economy will collapse."

Al-Usuqf is absolutely positive, "because, in a smaller scale, this is exactly what big financial conglomerates do with Third World countries to collect profits in one month that no Swiss bank would guarantee in four to five years". Al-Usuqf says that al-Qaeda could do the same by "provoking a deficit of \$50 to 70 trillion, the equivalent to five to seven years of the GNP of the U.S." How? By "destroying America's seven largest cities and some other measures". The means? "Atomic bombs." Al-Usuqf's most startling revelation is that the bombs "won't be launched, they are already there". "Seven nuclear heads have already been positioned on American soil, before September 11, and they are ready to be detonated. Before September 11, American security was a fiasco, and even later, if we needed, we could position the bombs there. They arrived through seaports, as normal cargo. A nuclear

head is not bigger than a fridge, so it can easily be camouflaged as one. Thousands of containers arrive at a seaport every day, and even with very efficient security, it's impossible to check and examine each one of them."

Al-Usuqf says that the bombs were bought on the black market: five from the former USSR and two from Pakistan. ...

Al-Usuqf says that the bombs cannot be detected by U.S. authorities. "Even if they are old, they were modernized and are very well hidden. Even if they were located, they have autodetonation mechanisms in case something or someone gets close. Even an electromagnetic pulse is not capable of deactivating them." The bombs allegedly cannot be detected because "they are enveloped in thick layers of lead". They could be detonated "by various methods—cellphone call, radio frequency, seismic shock or by their regressive clock".

Al-Usuqf details the whole plan. "First, one head would be detonated, which would cause the deaths of 800,000 to 1 million people and a chaos never seen before. During this chaos, two or three planes, which are now disassembled inside barns near empty roads in the U.S. countryside, would take off in suicide missions to pulverize another two or three big American cities with chemicals. Once the disease was identified, all seaports and airports would be quarantined. Land borders would also be closed. No plane, boat or car would enter or leave the U.S. This would be total chaos." The first target would be the city "that would offer the best conditions, for example bright sky and winds of eight or more miles an hour blowing towards the center of the country, so radioactive dust can contaminate the largest possible area". ...

Al-Usuqf does not fear an American military response. "Even if five or 10 cities are chosen at random to be destroyed, it will still be a small price to pay. The problem is that the economic despair will be so great that even if it saves [money] by not using weapons, American liquidity will be near zero, and the U.S. will make more money selling a Nimitz-class aircraft carrier to Turkey or Italy for \$5 billion, because they will urgently need to recapitalize. But it will be too late. Moreover, what will remain of an American soldier's morale to fight knowing that his whole family died and his country ceased to exist? To fight for what?"

The world economy would not collapse, says al-Usuqf, although "in the beginning, it will be very difficult. But without the U.S. the world will soon rise in a more just and fraternal manner. Nothing can stop the plan."

And whatever America does, "it's too late". When will the attack begin? "I can't tell." ... [END QUOTING]

U.S. PONDERES RESUMPTION OF NUKE-WEAPONS TEST

WASHINGTON—The Bush administration is laying the groundwork for the resumption of nuclear testing and the development of new nuclear weapons, according to a memo obtained by *Knight Ridder*.

The memorandum circulated recently to members of the Nuclear Weapons Council, a high-level government body that sets policy for nuclear weapons, urges the U.S. nuclear weapons laboratories to assess the technical risks associated with maintaining the U.S. arsenal without nuclear testing, which President Bush's father halted in 1992. In addition, the memo suggests that the United States take another look at conducting small nuclear tests, a policy rejected by the Clinton administration.

"We will need to refurbish several aging weapons systems," writes council chairman E.C. Aldridge Jr., the undersecretary of defense for acquisition, technology and logistics. "We must also be prepared to respond to new nuclear weapons requirements in the future"—a reference to a push to develop "earth-penetrating" weapons that might destroy buried stocks of biological, chemical or nuclear weapons in countries such as Iraq....

"It's recognizing that the stockpile that we designed 25 or 30 years ago for the Cold War really might not be the stockpile for the war on terrorism," a senior Pentagon official said Friday. "The rest of the world realized after Desert Storm that if you could be seen, you could be killed."

The memo is backed up by little-noticed language in the defense authorization bill that Congress approved this week. The bill suggests that the U.S. nuclear weapons laboratories—Lawrence Livermore, Los Alamos and Sandia—should be ready to resume testing with as little as six months notice.

Daryl Kimball, the executive director of the Arms Control Association, said the memorandum demonstrates the Bush administration's intention to end the testing moratorium.

"The administration is chipping away at the barriers to a resumption of testing," said Kimball. "They are doing their best to establish a rationale to resume testing, either for reliability problems or for new weapons. The reality is that there is no scientific nor military basis for a resumption of testing, and to do so would be an enormous strategic blunder that would invite a wave of proliferation that could swamp the entire non-proliferation regime."

New testing could prompt the Russians, the Chinese, Indians and Pakistanis to do likewise, or harden North Korea's refusal to abandon its nuclear program, he warned. ...

Democrats in Congress say that the interest in resumed testing comes not from the uniformed generals or the physicists in the weapons labs, but primarily from conservative civilian leaders, such as Vice President Dick Cheney, Defense Secretary Donald Rumsfeld and Deputy Defense Secretary Paul Wolfowitz, and advisers such as former defense official Richard Perle and John Foster, a nuclear weapons designer.

Since 1992, weapons scientists in California and New Mexico have used a multibillion-dollar system of supercomputers and large-scaled technology to understand the underlying physics of bombs and missile warheads. The Aldridge memo suggests that this Science Based Stockpile Stewardship program may not be enough. It requests studies "to assess the potential benefits that could be obtained from a return to nuclear testing with regard to weapons safety, security and reliability."

The memo suggests another look at the potential benefits of a "low yield" testing program, which might produce a nuclear explosion equivalent to only a few hundred pounds of conventional explosives. Such tests might involve small amounts of plutonium—not in bomb form—at the Nevada Test Site, according to a well-placed defense official. So-called sub-critical tests are now designed to produce no nuclear yield at all. ...

Although some nuclear weapons scientists unsuccessfully sought permission to conduct low-yield nuclear tests after the testing moratorium began

in 1992, Goodwin said he sees no need for it now. "I don't think I would ask for that today. We know a lot more, we're a lot more capable," he said.

Congress this week authorized the three nuclear weapons labs to create preliminary designs for a weapon known as the Robust Nuclear Earth Penetrator, designed for underground targets. The project involves strengthening existing hydrogen bombs, rather than creating new designs. Livermore weapons designers say they don't expect the project to require nuclear tests.

But critics fear that development of such weapons could increase pressure to resume nuclear testing. The defense bill includes language, inserted by Democrats opposed to the earth penetrator such as Rep. Ellen Tauscher, D-Calif., that specifically prohibits the scientists from beginning work until a list of written questions is answered, involving the bomb's purpose and targets, and an assessment of whether such targets could be destroyed using non-nuclear weapons.

The authorization bill also tasks the labs to study the costs and benefits of reducing the time required to prepare for a nuclear test to six months, 12 months, 18 months or 24 months. The current "readiness" time is two to three years. In March, an influential Pentagon advisory panel chaired by former defense official and Lawrence Livermore director John Foster recommended a lead time of "no more than three months to a year."

A veteran nuclear weapons physicist said a test designed, built and tested in only six months would be a "political test" rather than a science test. "Historically, in order to do a test in six months you pretty much had to have the device picked out already and have preliminary plans on what to do. How can you predict a problem in advance?"

JEWISH GROUP CLAIMS ITS DATABASE HELPS FBI COMBAT TERRORISM

In the year after the terrorist attacks on America, the Anti-Defamation League (ADL) says it has played a vital role protecting the homeland by providing law enforcement officials with valuable information about suspected terrorists.

The ADL's mission of tracking international and domestic terrorists is not new, but the Sept. 11 attacks on the World Trade Center and the Pentagon sparked greater interest in the ADL's efforts, said David Friedman, director of the organization's Washington office.

Friedman spoke about the ADL's relationship with police officers and FBI agents at the group's national meeting in Houston last week and echoed those sentiments in an interview with *CNSNews.com*. Since the terrorist attacks, he said, law enforcement officials have viewed extremist groups in a different light. ...

Unlike some civil rights groups that might scoff at the notion of police tapping into their resources, the ADL says it has welcomed the interaction with the FBI and other officials.

The ADL's comprehensive database on extremist groups includes international terrorist organizations,

such as al-Qaida and Hamas, as well as domestic terrorists, including neo-Nazi and White supremacy groups. It would be difficult for the law enforcement officials to track the movements of all these groups, which is where the ADL offers its help, Friedman said. ...

Calls to the FBI's Office of Law Enforcement Services, which Friedman said has worked closely with the ADL, were not returned Monday.

The ADL shares information about international and domestic terrorists on its Website. In addition, the organization provides law enforcement officials with information at routine meetings and through educational sessions. In the last year, the **ADL's 30 regional offices have trained 25,000 officers.**

However, the close interaction between police and the ADL worries the Council on American-Islamic Relations (CAIR). Spokesman Ibrahim Hooper questioned the relationship, noting that the ADL's pro-Jewish agenda concerned him, especially when it comes to the rights of Muslims living in the United States.

"The pro-Israel lobby generally has an agenda that works counter to the political participation of American Muslims," he said. "They do whatever they can to marginalize and disenfranchise American Muslims. If that requires smears that American Muslims somehow support terrorism, that's what they do."

He said the ADL's work with law enforcement officials was particularly troublesome. "It concerns me that they're behind the scenes whispering in the ear of law enforcement," Hooper said.

Hooper said his own organization frequently works with law enforcement officials, but those meetings are used primarily to educate police and the FBI about discrimination against Muslims.

Friedman said the ADL had no intentions of targeting individuals based on religion or race; the primary goal of his organization, he said, is to root out extremist groups.

For instance, the ADL already had a profile on Timothy McVeigh before the 1995 Oklahoma City bombing by following anti-Semitic and anti-government movements, Friedman said.

A similar circumstance developed this summer after the July 4 shooting at the El Al Airlines ticket counter at Los Angeles International Airport. While the FBI did not initially consider it an act of terrorism, the ADL did, and now the FBI is investigating that angle, according to Friedman.

Despite some concerns, the ADL plans to continue working with law enforcement officials on a local, state and national level to monitor terrorist groups, Friedman said. "We track left-wing and right-wing extremists, international and domestic extremists," he said. "There are so many different areas in which we are actively involved, they all have degrees of overlap, which enriches our contact with law enforcement."

MUSHARRAF SUPPORTER NAMED PRIME MINISTER

ISLAMABAD, Pakistan (AFP)—A loyalist to President Pervez Musharraf was narrowly elected as Pakistan's prime minister yesterday, effectively guaranteeing the military ruler's control over the first civilian government since his 1999 coup.

Zafarullah Khan Jamali, 58, a portly tribal elder from southwest Baluchistan province who represents the pro-Musharraf Pakistan Muslim League-Quaid-e-Azam (PML-Q), defeated a pro-Taliban cleric from a coalition of anti-Western Islamist parties and another candidate who supported former Prime Minister Benazir Bhutto.

Mr. Jamali's victory means the future civilian government will be controlled by Gen. Musharraf, the army chief who has made himself president until 2007, analysts said. ...

At least 10 dissenters from Mrs. Bhutto's opposition Pakistan People's Party (PPP) crossed the floor to vote for Mr. Jamali, whose party was the PPP's chief campaign rival.

Gen. Musharraf temporarily suspended a ban on floor-crossing to make the vote possible.

Legislators lined up on the floor of the chamber behind the candidate they supported. One lawmaker abstained.

PML-Q candidates also won the key posts of house speaker and deputy speaker on Tuesday. ...

He is widely viewed as the kind of pliant politician Gen. Musharraf is believed to have wanted as head of the next government.

Political analyst Muhammad Afzal Niazi said Mr. Jamali would have little room to maneuver, hemmed in by Gen. Musharraf's new military-dominated National Security Council on one side and a feisty opposition on the other side. ...

Mr. Jamali vowed to maintain Gen. Musharraf's foreign policy, the central plank of which is extensive cooperation with the United States in the war against terror.

"Pakistan has become a frontline state, and the existing foreign policy is good for the country and the people," he said.

The White House looks forward to working with Mr. Jamali and his new government "on a variety of issues of common interest," a spokesman said while at the NATO summit in Prague.

Qazi Hussain Ahmed, a leader of the Islamic bloc that holds the balance of power with 60 seats, foreshadowed a battle in the house about Gen. Musharraf's presidency and powers.

"I make it very clear that we will not let an individual impose his will on us. We cannot and will not tolerate it," Mr. Ahmed said.

ALLY OF MUSHARRAF IS ELECTED PREMIER

ISLAMABAD, Pakistan—Pakistan's parliament elected a pro-military prime minister Thursday in a closely fought vote that hinted at a stormy future for the country's first civilian government since 1999.

Zafarullah Khan Jamali, a veteran politician with close ties to the military, was chosen over two candidates opposed to President Pervez Musharraf's hold on power. Jamali is expected to announce his Cabinet in coming days, signaling an official end to Pakistan's three-year military dictatorship.

The result also signals a new era of political uncertainty in a nation whose promised return to democracy has been clouded by allegations of vote-rigging and by the expectation that Musharraf and his generals will continue to wield real power.

The alliance of Islamic fundamentalist parties that scored unexpectedly well in the Oct. 10 elections will sit in opposition to a pro-Musharraf government, something that will come as a relief to the U.S., which counts on Pakistan's support in the war on terrorism.

But many analysts believe the Islamic alliance may prove more effective in opposition than they would have been governing in a coalition. They will be able to stick to their conservative religious platform and challenge the pro-Musharraf government in ways that would have been difficult in a ruling coalition with other political parties.

"If this government fails, they will be in a strong position to contest the next election," said Aqil Shah, a political commentator in Islamabad. "We're in for a bumpy ride."

Jamali was the candidate of the pro-Musharraf Pakistan Muslim League-Quaid-e-Azam faction, which failed to win an outright majority in the elections and has since been frantically negotiating with the main opposition parties to form a government.

The negotiations failed, and Jamali will govern instead with the support of an assortment of smaller parties and independent candidates, including 10 parliamentarians who defected from the opposition Pakistan People's Party of former Prime Minister Benazir Bhutto. He secured 172 of the 328 votes cast, giving the pro-Musharraf party a perilously small majority that will be vulnerable to defections. ...

Musharraf will remain as president under the terms of constitutional amendments he approved while civilian rule was suspended.

The amendments also give him the right to fire the new government and the parliament, making a mockery, in the view of many Pakistanis, of the return to civilian rule that he promised when he seized power in a military coup in 1999.

The Islamic alliance and Bhutto's party have vowed to overturn the amendments, and given the narrow margin of the vote, the longevity of the new government is far from assured, analysts say.

EXPANSION NO THREAT, PUTIN TOLD

MOSCOW—In a bid to allay fears Moscow might have about NATO's expansion to its borders, President Bush has tried to assure Russian President Vladimir Putin that the growing alliance will not pose a threat.

During its summit last week in Prague, Czech Republic, NATO welcomed seven nations that once were Soviet republics or members of the Soviet bloc: Bulgaria, Estonia, Latvia, Lithuania, Romania, Slovakia and Slovenia.

At their meeting Friday in St. Catherine's Palace near St. Petersburg, Putin told Bush that he considered the NATO expansion unnecessary. But Putin also has said that he is willing to cooperate with the alliance, especially within the framework of the war against terrorism. Though not a member, Russia enjoys a partnership with the alliance through the NATO-Russia Council.

Whether Russia's relationship with NATO flourishes will depend on how far eastward the military alliance sets its sights in years to come, analysts say.

Other former Soviet republics, including Ukraine and Georgia, have expressed a desire to join NATO. Both nations are far from ready—each is burdened with a sluggish economy.

But if NATO began to seriously consider those nations' bids to join, Moscow's policy toward the Western alliance probably would change radically, said Andrei Fyodorov, an analyst with Moscow's Council for Foreign and Defense Policy.

Georgia's membership in NATO would be especially troublesome; the Kremlin accuses the small nation of providing a haven to Chechen rebels.

TSAR VLADIMIR PUTIN?VLADIMIR PUTIN COULD HAVE ROYAL BLOOD

Therefore, using online search engines is completely worthless in this quest. No other scientists of history and no dictionary mention anything about the name Putin among tens of thousands of other names.

On the other hand, there has recently been a surprising fact discovered. Vladimir Putin looks like Prince Mikhail Tverskoy. They both are not tall, with little hair, and similar noses. Is Putin a descendant of the Tver prince? This hypothesis is gaining more and more support. The name Putin is not mentioned among the Russian names. This means that the name is of foreign origin.

The name Putin appeared recently, sometime in the middle of the 19th century. All Putins originally came from the Putin clan of the Tver region. Illegitimate offspring of noble families were often given shortened names. For example, Russian writer Pnin was an illegitimate son of Field Marshal Repnin. There have been many other such occasions: Betskoy instead of Trubetskoy and Gribov instead of Griboyedov. The new names of unofficial clan branches were formed by means of deduction: a syllable was simply taken out of the original name.

A book on the Tver region mentions the name of Putyanin, a clan of Russian princes. This clan gave Russian many outstanding military leaders, as well as artists, politicians, and priests. This is one of the oldest clans in Russian history. If President Putin is a descendant of the Putyanin clan, this means that Vladimir Putin is related to nearly all the royal families of Europe.

[JR: The blackout as to Putin's ancestry adds to the mystery of the enigmatic Russian President. He remains a cryptic puzzle with many missing pieces. Perhaps it is important for Russia that President Putin appear to be other than what he is.]

INDIAN AFFAIRS OFFICIAL
HELD IN CONTEMPT RETIRING

WASHINGTON (AP)—A Bush administration official held in contempt of court over management of a trust fund for American Indian royalties will retire at the end of the year.

During his 17 months as the Interior Department's assistant secretary for Indian affairs, Neal McCaleb focused on untangling a fund that has been mismanaged for more than a century. It manages \$500 million a year in oil, gas, mining and timber royalties from Indian lands.

In September, McCaleb and Interior Secretary Gale Norton were held in contempt of court by U.S. District Judge Royce Lamberth for failing to comply with his order to fix the trust fund and concealing their failure to do so.

A 1996 suit claimed the government squandered from \$10 billion to \$40 billion from the fund, set up in 1887 when Congress assigned American Indians small parcels of land and directed the Interior Department to manage the royalties.

ARMY FORT BRAGG STUDY FACES SCRUTINY
(MALARIA DRUG & HOMICIDES)

WASHINGTON (*UPI*)—An Army report released Thursday saying a controversial malaria drug called Lariam was an "unlikely" factor in a cluster of killings and suicides near Fort Bragg, N.C., this summer has sparked claims **the military is covering up problems with a drug it invented and licensed. ...**

"Our military said there is no problem with (Lariam) because they developed it," said Rep. Bart Stupak, D-Mich. **"The hardest thing to do is develop a drug and then admit there is a problem."**

The Army report on the Fort Bragg killings and suicides cites marital problems, increased stress in a post Sept. 11 environment and "flawed" systems for helping troubled soldiers and their families as common threads in a string of five homicides near Fort Bragg in a 43-day period during June and July 2002. Three soldiers involved had been deployed to Afghanistan. Two of those soldiers also committed suicide.

Soldiers and their families are afraid to report or seek help for problems because it is a "career ender", the report said.

But in one of the killings, friends and neighbors of the soldier charged with the murder said the Army is ignoring evidence the drug might have played a role. The Army said Thursday it did not contact those people out of concern about privacy and an ongoing criminal prosecution.

In Afghanistan, where at least two of the soldiers in the Fort Bragg killings took their Lariam pills, a U.S. security expert said the Army is ignoring frightening side effects he has seen first hand.

"The Army does not want (the truth) released," said Tony Deibler, deputy director of U.S. embassy security in Kabul and a security expert for 26 years with the U.S. diplomatic staff. **"If we (the government) admit this, we are opening ourselves up to a multi, multi, multi-billion-dollar lawsuit.** I love my country, but this is what drives that train."

Deibler said he has seen Lariam wreak havoc on soldiers for years, including one Marine at an embassy who hallucinated intruders attacking and shouted, "Get back, they're coming!"

Deibler said Marines guarding the embassy in Kabul take doxycycline—an alternative to Lariam—because of concerns about the side effects.

"Lariam is a bad drug," said Deibler. "You take these guys at Fort Bragg. I will bet you a year's pay that these guys were taking it and when they got back, they wigged out."

The report says Lariam, known generically as mefloquine, "does not explain the clustering" of violence because the Army only has evidence that two of the soldiers took the drug in Afghanistan and no mental problems were on file for those soldiers.

The report does not rule out Lariam as a cause in those two cases, but does say Lariam does not explain the strange cluster of violence over a short period of time.

"We are not in a position, nor did we have adequate information to say definitively that the possible ... side effects of Lariam played absolutely no role" in the deaths, said Col. Dave Orman, a psychiatry consultant to the Army Surgeon General, and a member of the review team. ...

Lariam's label warns of psychosis, hallucinations, delusions, paranoia, aggression, tremors, confusion, abnormal dreams and rare reports of suicide. It also says mental problems can last long after taking it. The Walter Reed Army Institute of Research developed Lariam in the 1970s after troops in Vietnam contracted malaria despite taking chloroquine—then the standard preventive medication. ...

The Army cited privacy concerns and ongoing legal proceedings in a decision not to interview friends, family or neighbors who think Lariam might have played a role.

Thursday's report from the Army is the second time in two months the military has signaled that Lariam does not cause significant problems. In September, the Pentagon responded to concern about the drug from House Military Personnel Subcommittee Chairman Rep. John McHugh, R-N.Y. Side effects from Lariam "have been few in number and generally of low severity," the Pentagon wrote.

But the letter to McHugh also notes that the military and Lariam's manufacturer, Hoffmann-La Roche, have funded key scientific studies on Lariam. "This fact suggests at least the possibility of either commercial or institutional bias in the reporting of results," it says.

An internal safety report from Roche, obtained by *United Press International*, shows that reports of violent behavior have been coming in to the drugmaker and the Food and Drug Administration for nearly a decade. Roche said in a statement to *UPI* that there is "no medical or scientific evidence" that the drug can cause violent or criminal behavior and that incidents cited in its safety reports are anecdotes, not evidence. ...

UPI has interviewed a number of soldiers who say Lariam has given them long-term mental problems since the U.S. military began widely using the drug on over 20,000 troops deployed to Somalia in the early 1990s. U.S. Army officials told *UPI* they never saw evidence of any problems with the drug there.

"There is so much darkness in your brain and so much violence. And you know what you are capable of," said G. Mayes, a member of the Army reserves who was called up in 1993. Mayes said that while she suffered no mental problems before then, the Lariam the Army gave her brought on hallucinations, confusion, depression, paranoia, suicidal thoughts and even thoughts of homicide that she struggles with to this day.

"You know that no one around you is safe. You do whatever you can to maintain the appearance of normalcy. It is all in your eyes and in your head. You know that if somebody pulls the right stunt, you are just going to snap their little neck and leave them there." ...

Another soldier was recently hospitalized with serious mental problems after taking Lariam in Afghanistan.

"He went, he did his fighting and now he is sick," said that soldier's mother, requesting anonymity because she said she fears retribution from the Army on her son. She said he is hallucinating and suffering from anxiety and depression and that she fears for his life.

"He exhibits all of these side effects. He was a normal human being," she said. "I want this drug off the market ... They are not going to do this to my child."

Congressman Stupak is the third member of Congress to raise questions about Lariam. In July, Sen. Chris Dodd, D-Conn., called for an independent medical investigation to protect the health of Peace Corps volunteers, who are routinely prescribed the drug. In May, McHugh wrote to Secretary of Defense Donald Rumsfeld, asking whether the drug's side effects were causing troops mental problems. His committee continues to work on the issue. ...

A former FDA official said that if Lariam were at fault in killings, it should not be on the market.

"I do not know of any product that would be allowed to generate a psychosis that could stimulate someone to commit murder and be an approved drug," said Gerald F. Meyer, former deputy director of the FDA's Center for Drug Evaluation and Research who is not familiar with Lariam but is an expert on drug safety. "I do not know of any, and I cannot imagine one."

[JR: I suspect this "Lariam" drug is intentionally designed to create psychosis, hallucinations, delusions, paranoia, and specifically aggression, otherwise why would they routinely give "malaria pills" to all soldiers in every

combat zone, even in desert areas? MODIFIED CROPS
RAISE FEARS OF CONTAMINATION

Nothing about the 500 bushels of soybeans delivered last month to the century-old Aurora Cooperative Elevator Co. in Nebraska suggested that they contained a very modern surprise.

But mixed into this batch were a few tiny fragments of an experimental corn genetically engineered to produce a vaccine against traveler's diarrhea also known as Montezuma's revenge.

Just hours before the soybeans were to be sent to the factories that turn them into salad oil and animal feed, government inspectors intervened and isolated the warehouse.

The amount was tiny—barely an ounce—and officials say it posed no health threat. But for those committed to safeguarding the food supply, any amount is too much. A handful of modified corn had spoiled the entire bin of 500,000 bushels.

And with that, a technology said to hold great promise for advancing human health found itself in big trouble again.

Giant food companies like Kraft and ConAgra, stung by a sweeping recall of contaminated corn two years ago, are up in arms over this episode. And environmental activists aghast at the thought of turning fields of grain into drug factories say the events in Nebraska show that the "farmaceutical" industry can't be trusted.

"Someone is going to get prescription drugs in their corn flakes," said Larry Bohlen, director of health and environment programs at Friends of the Earth.

Stuck in the middle are Midwest farmers, eager to prop up their incomes with a value-added product. Now they're getting pushed aside altogether as "biopharming" flees the Corn Belt for isolated pastures that offer less risk of another mix-up.

Federal regulators say the Nebraska case shows their inspection system is working. They have launched an investigation into whether the company that developed the biotech corn, ProdiGene Inc. of College Station, Texas, violated rules aimed at preventing contamination. The company had a similar problem in September, when Agriculture Department officials ordered it to burn 155 acres of tainted corn surrounding a test site in Iowa as a precautionary measure.

In the Nebraska case, regulations call for the destruction of all \$2.7 million worth of contaminated crops in the grain elevator. ProdiGene has said it will comply, and the soybeans will either be incinerated or turned into biodiesel fuel.

To some, destroying food over what amounts to a negligible amount of crop material is a needless waste.

But others say regulators have seriously underestimated the risks.

"There needs to be a total re-examination of the regulatory regimen to assure the public that there is no threat to their food," said Neil Harl, agricultural economist at Iowa State University.

The biotech industry's previous assurances also have hurt its credibility. Just a month ago, ProdiGene Chief Executive Officer Anthony Laos appeared on a *CBS News* program and said he was certain his biotech medicines could never contaminate non-pharmaceutical crops "because I'm following procedures that make it impossible for that to happen."...

Bohlen disagreed: "How could the USDA allow 500 bushels to contaminate 500,000? That's a regulatory failure, not a success."

ProdiGene is among the leaders of a nascent industry that uses corn, barley, rice and tobacco to grow everything from injectable insulin and cholera vaccines to industrial enzymes for tanning leather. ProdiGene says its partners include the giant Eli Lilly drug company, and it has at least 18 products in development.

For decades now, scientists have been tinkering with the genetic makeup of living organisms. The technology has enabled farmers to grow corn, soybeans and cotton that is genetically modified to resist pests or certain herbicides.

But as biotechnology moved out of the laboratory and into farm fields in the mid-1990s, it raised questions about its safety, ethics and impact on the economy and the environment.

Supporters say biotechnology can lessen crop losses to insects and drought, decrease soil erosion, reduce the use of chemical pesticides, and boost the nutritional value of food. With biotechnology, proponents say, animals and fish will be larger and more disease-resistant. Trees can sprout more quickly; suburban lawns can be grown more slowly. Many species can be altered to require less care and be more disease-resistant.

Growing pharmaceuticals in plants is a relatively new application, and it is considered promising because it has the potential to sharply reduce the cost of mass-producing valuable medicines. ...

In the Nebraska corn, researchers insert a gene taken from *E. coli* into the plant cells, creating a substance that protects against traveler's diarrhea. The vaccine grows within the modified corn and can be extracted after harvest. ...

Some farmers, meanwhile, fear that genetically-modified crops will accidentally mix with their conventional or organic crops and they will be stuck paying the consequences. ...

Opponents of the technology are unforgiving.

"A leading company in the pharm crop business failed to meet the simplest, easiest containment requirement," said Jane Rissler of the Union of Concerned Scientists. "If they will not do that, which is so simple, how can we trust them to do much more complicated things?"...

[JR: It is one thing to grow corn, soybeans and cotton that is genetically modified to resist pests or certain herbicides, but to expand farms into growing everything from injectable insulin and cholera vaccines to industrial enzymes for tanning leather is carrying this GM process too far. ZERO PERCENT

As I have mentioned before, the auto craze for zero percent financing is over. New cars, used cars and every known kind of cars are sitting around waiting for a buyer. Few are showing up. Sales are down double percentage figures for the months of October and November. A disaster is afoot.

Think about it. You buy a new Hoot-O-Mobile for \$30,000—with zero-percent financing—and no payments due for three months. Bargainsville! Not really. You drive it off the lot, and presto, you owe several thousand dollars more than it is worth. You paid for a new car, and suddenly, with a hundred miles on it, it's a used car, and worth several thousand dollars less than you paid for it, and contracted to pay probably 60 payments over five years. The car is going down in value much faster than you are paying for it.

So if you lose your job, or wifey loses her job, or hard times get even harder, guess what is going to happen? That's correct... walk away from the car purchase. Ford or GM or Chrysler are financing their own cars. No banks involved, just the auto companies carrying the paper. When Joe Sixpack, multiplied by thousands, walks away from the zero-percent finance, guess who's holding the bag? That's correct. Ford, Chrysler and GM. These cars are coming back at them in a couple of years like a tornado in Arkansas or a hurricane in Florida. Ruined credit ratings? I suppose—but in a pinch, what's the first to go, the house or car? A roof over one's head is far better than a set of wheels. Besides, they all look alike now anyway, even including the Mercedes.

With huge inventories of unpaid-for cars—and new ones not exactly setting the world on fire—GM's pension division may go \$50 million in the hole, rather than its current \$34 million. Ford's hundreds of millions in bonds and debt may get even worse.

One in seven Americans works at jobs connected with the auto industry. Be it selling, fixing, servicing, fueling, advertising, financing, or whatever—over 14% of Americans depend on the auto industry for their livelihood. That's frightening. That portends disaster when the industry goes down more than it already has, which is appreciable.

Think of the huge unsold inventories on new-car lots. Think of the interest required to hold these cars till they are sold. Locally, I will be willing to bet that there are several hundred new cars sitting on dealer lots—and I live in a town of 13,000. The Denver papers have whole sections devoted to selling cars. Dealers are spending millions in advertising. Or are at least contracting for millions in ads. If these go unpaid, will the newspapers be in financial trouble? Same with TV ads. Are these ads being paid promptly, or is everyone hoping against hope that the whole thing doesn't crash completely. Locally, within the last two years, a Ford dealership invested very heavily in an entirely new facility. New showrooms, huge lot, huge servicing facility, and I imagine huge debt to build it. Is this typical of the auto industry? Is the industry so overloaded with debt that it cannot survive?

Gold-Eagle.com has had over 70 million readers in its short time of existence, and we write about gold and silver true, but the entire economic picture must concern us. The auto industry and its viability concerns this scribe. I am fearful of its future. Could we be witnessing the calamity of all calamities, with the massive failure of the auto industry? I certainly hope not, but I just cannot escape the obvious. The obvious is that zero-percent financing might have helped sales, but its long-term


repercussions might be a disaster in the wings.

In the past, I have written about housing's certain decline, and it has begun. In Telluride, Colorado—the home of the supposed rich and famous—listings go unsold for many months, even with asking prices lowered over and over. Aspen the same. It's not hard to predict the bubbles when they are so obvious. When Tokyo land was selling by the square inch a few years ago, it wasn't difficult to predict that it would collapse. It did, because it was out of hand. Real estate is out of hand in many locations and has begun its slide downhill. Autos gave a plain signal, when the financing was zero percent. Similar to Sir Greenspan lowering the rates 12 times. When that happens, there's something rotten in Denmark.

Stocks are going up for no reason, other than as a reaction to banks lowering their interest rates to virtual zero. The stock market is still hugely overpriced, with PE ratios still in the stratosphere. Why would anyone buy an overpriced home, when the trend is downward? Why would anyone buy a car, when the minute you drive it off the lot, it is worth thousands less than you owe on it? Why would a reaction to low interest rates at savings institutions, be to buy over-priced stocks? **Gold has shown an 18% rise of late—and shows every indication of going much higher in valueless dollars. The same with silver, only maybe even more so.** Why is everyone so stupid, I guess is the question? I love *My Fair Lady*, and am often reminded of Henry Higgins' song about women, but it applies to the males too. "Straightening up their hair is all they ever do; why don't they straighten up the mess that's inside."

Think about it readers, and realize the symptoms of extreme financial stress. The indicators are all there, just like a sinking barometer foretells a storm. The signs say that you should get out of stocks and dollars, and get into gold and silver, which owe no one anything, as their value is self-contained. Stocks of gold and silver mines have all the mish mash of any other stock, plus the obvious fact that many of these stocks are of mines that have yet to produce a single ounce of metal. They are bets, just like Las Vegas. Far too many of these mining companies print more and more stocks to raise more money for development, thereby diluting extant stocks. Nevada Pacific, a company I own several thousand shares in, has just announced that it is increasing its share numbers from 1,900,000 to 2,900,000. Know what this does to my shares? Drops them radically, I imagine. Nuts to them all. These mining companies have boards of directors, accounting tricks, EPA and OSHA and MSHA rules—and invariably produce very expensive, glossy, lush yearly reports, which are shipped out to stockholders at huge cost. Why don't they do a Xerox sheet of the happenings and save the shareholders a bunch of bucks? **I just do not think that a stock in a foreign mine can come even close to holding precious metals in your hot little hands. They're just pieces of paper with ink on them, that denote your teeny, tiny, micro ownership of a mine you have never seen, wouldn't know what you were looking at if you did see it.**

Do shares go up faster or higher than the actual metal? I do not see how they could. If they can, someone please inform me of just how this is possible. How could shares of a mine that may or may not be profitable, and may or may not have had its shares diluted by issuing more shares, go up faster than gold or silver in your hands? Please explain that to me—but in the mean time protect yourself.

NEVADA CORPORATIONS:

Maintaining Privacy Of Corporate Records

Budget's "Tip of the Week" #2:

NRS 78.257—Right of stockholders to inspect and audit financial records; exceptions

Last week we discussed *NRS 78.105* and how it appears to have been written specifically to provide access to the corporation's records by the corporation's *stockholders*. What about a case where the stockholder's interest in accessing the records has nothing to do with the stockholder's interest in the corporation? And what about other parties who might want to access the corporation's private records? *NRS 78.257* holds the answer to those questions, though the answers are, no doubt, NOT what such parties might wish to hear!

After defining who is entitled to inspect the corporate records and the notice that must be given for doing so in paragraph 1, then specifying that the inspecting party bears the costs of extracting such in paragraph 2, *NRS 78.257*, paragraph 3, states (emphasis added):

3. The rights authorized by subsection 1 may be denied to any stockholder upon his refusal to furnish the corporation an affidavit that such inspection, extracts or audit is not desired for any purpose not related to his interest in the corporation as a stockholder. **Any stockholder or other person, exercising rights under subsection 1, who uses or attempts to use information, documents, records or other data obtained from the corporation, for any purpose not related to the stockholder's interest in the corporation as a stockholder, is guilty of a gross misdemeanor. ...**

A gross misdemeanor conviction is punishable by incarceration for up to one year in the county jail and a \$2,000 fine. Note that this statute spells out rights of the *stockholders* to inspect corporate records—the *stockholders*, not "just anyone". **There is no mandate of any kind for non-stockholders to ever inspect any corporate records. It is a gross misdemeanor for any non-stockholder to even attempt to use information from the corporate records in any way contrary to the interests of the stockholders.**

Next week, we'll look at a method of owning a corporation without owning its stock—and yes, the answer to that riddle can also be found built right into the *Nevada Revised Statutes!*

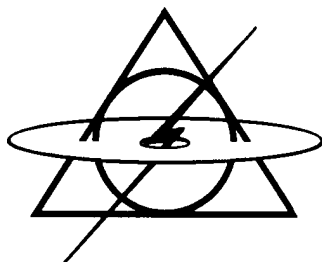
