U.S. ‘MOLE’ AT BSP  
‘RESIDENT ADVISOR’ TO WORK WITH A.M.L.C.

SEN. Joker Arroyo on Friday bared a previously undisclosed memorandum of agreement that allowed the U.S. government-funded AGILE group to put a virtual “resident mole” at the Bangko Sentral, the chief enforcer of the antimoney laundering law.

Arroyo said the MOA for technical assistance signed by BSP Governor Rafael Buenaventura and U.S. Ambassador Francis Ricciardone on May 22, 2002, provides for the posting of a “Resident Advisor” with eight staff members at the BSP-led Anti-Money-Laundering Council (AMLC).

“The U.S., in effect, has established a mole in the BSP because of this agreement between the BSP and the USAID [U.S. Agency for International Development],” Arroyo told his colleagues after submitting copies of the MOA at the resumption of the Senate inquiry into AGILE’s alleged massive penetration of the Philippine bureaucracy under less-than-transparent circumstances.

The discovery was made as Congress is under pressure to pass amendments to the dirty-money law that would among other, empower the AMLC to pry into private bank accounts without a court order, the present requirement for looking into bank deposits.

The amendments passed by a bicameral conference committee last month listed three “predicate crimes” for which accounts suspected of having been used as laundry machines may be opened without a court order: transnational hijacking, terrorism and drug dealing. The bicameral panel, especially the senators, insisted that these are the only main crimes which had sparked concern of the Paris-based watchdog, the Financial Action Task Force. (FATF).

But the AGILE consultants who had sat in on all hearings claimed that the task force wants blanket clearance—meaning, no court order—FOR ALL 14 LISTED PREDICATE CRIMES, AMONG OTHER DEMANDS.

At the same hearing, Sen. Sergio Osmeña III confronted AGILE officers with a two-page internal memorandum claiming that the team had “successfully halted implementation” of a Presidential Executive Order on port modernization issued during the Estrada administration.

Osmeña and Arroyo said that while they do not agree with a number of government policies, AGILE, as a foreign-funded group, has no business countermending presidential policy.

“How can you go against a Presidential Executive Order? It shows you have a different agenda different from the president’s,” Osmeña added.

**[H: Well, the poor dears don’t seem to understand that the CENTRAL BANK is but a PRIVATELY OWNED IBC institution and thus they have authority to CONTROL EVERYTHING TO THE PRESIDENCY ITSELF.]**

Going back to the BSP-USAID agreement, Arroyo said: “From the time we had a banking system, we adhered to a bank secrecy law; supposing we agree to the amendments, now there is a mole in the BSP who gets to see these bank accounts.”

Arroyo added: “Now, AGILE will also be able to access the opened accounts.”

Under the MOA, the BSP and USAID agreed to cooperate in the establishment of an effective anti-money-laundering regime in the Philippines through the proper implementation of AMLA.

Moreover, the USAID, through AGILE, will provide a long-term consultant, called the “Resident Advisor”, FOR 14 MONTHS TO COORDINATE TRAINING AND POLICY ADVISORY SERVICES. The Advisor will hold office at the BSP and will work “in coordination” with the staff of the BSP-Supervision and Examination Sector and the Anti-Money-Laundering Council.

“The resident advisor is the mole: [she] is an appointee of the USAID-AGILE and funded by the U.S. government,” Arroyo said, referring to AGILE executive Francesca Baniqued.

Baniqued, the Bank Supervision Advisor at the “AGILE-BSP Satellite Office”, admitted at the Senate hearing that she is an American citizen. But she added she still has close family ties in the Philippines.

Ramon Clarete, who holds the title of AGILE chief of party, told Senate investigators that AGILE is not a lobby group but a technical assistance group under the pay of Development

Alternatives Inc., the Maryland-based contractor hired by USAID for the AGILE project. **[H: Sure and they probably also have a “Holding Trust” (TIAS 12087) headed by a two-inch Dragon-fly.]**

Clarete, Baniqued and six other ranking AGILE officers, including three Americans, showed up at yesterday’s hearing, avoiding arrest warrants if they snubbed the Senate summons a second time.

Testifying under oath, Clarete confirmed that besides the BSP, AGILE also holds offices in at least 14 other key government agencies but answers to a steering committee composed of the Department of Finance as chairman; and the National Economic and Development Authority, USAID and two private sector representatives, as members. **[H: Can’t get any higher, readers, in control of a nation or its financial business.]**

Clarete’s admission prompted Sen. Manuel Villar to demand the identities of 99 consultants working for the U.S.-funded AGILE lobby group that Villar said has also “influenced some of the workings of Congress”.

Villar complained that AGILE consultants disguised themselves as technical experts and then influence committee secretaries in inviting resource persons who would espouse positions on national policies.

Sen. Teresa Oreta, for her part, said Finance Secretary Isidro Camacho, should be held accountable for the activities of AGILE, being the chief of the department heading the steering committee that presides over the U.S.-funded initiative.

Oreta observed that contrary to Camacho’s claim that AGILE officers were merely rendering “technical expertise” to government agencies, “They could be at the helm of advocacy work for foreign companies and agencies that clash with the national interest.”

“Camacho should be held accountable for the activities of AGILE agents operating in the country. He cannot escape responsibility for what these representatives are doing here,” Oreta added.

#### INC CLEARS SIDE ON GMA’S PRESENCE AT PRAYER RALLY

The powerful religious group Iglesia Ni Cristo (INC) has made clear that its reported opposition to President Arroyo’s attendance during the prayer rally it held with El Shaddai charismatic movement last Sunday was not meant to disrespect her.

In a statement, Bienvenido Santiago, spokesman of the INC, yesterday said Mrs. Arroyo, although uninvited to the affair for being a political leader, had shown disrespect in a prayer which its members consider as holy.

“We do not deny that the president should be respected. As early as Feb. 20, 2003, the organizers of the peace rally had made it sufficiently clear that the gathering would have no political color. Bro. Mike Velarde (leader of the charismatic group) was reported by *The Daily Tribune* last Feb. 20 to have said the stage would be off-limits to politicians to maintain the purity of the event.

“It was further reported the El Shaddai leader said the event is an open invitation to Mrs. Arroyo to the lowest government employees but (that) there would be no speeches for politicians and government officials who would be expected to be sitting down with the crowd,” he added.

The INC spokesman stressed the occasion was convened in order to pray for peace.

“But the President’s prayer was nothing but a litany of justifications for the impending attack by the United States on Iraq if it did not cooperate with the United Nations inspectors,” the spokesman said.

Santiago added Mrs. Arroyo intentionally ignored the feelings of the people who had gathered for the peace rally.

“If you remember, the Iglesia Ni Cristo and the El Shaddai came out with a joint statement appealing to the President not to take sides in the looming conflict because of the danger that this might pose for the security and economy of our country; also to stop coming with statements in favor of America but last Sunday, right in the face of the very people asking her to refrain from issuing more statements supporting the U.S. she again recited her hawkish position on the conflict.

“Hence, she not only did not respect the sanctity of prayer but she also did not respect the feelings of all those who had gathered and who called for her to say neutral with regard to the clash between the U.S. and Iraq,” he noted.

At press time, Malacañang remained tightlipped on the influential INC supreme, Bishop Erano Manalo’s strongly-worded press statement lambasting the President for turning a prayer for peace rally at the Quirino Grandstand last Sunday into a “political circus” and calling her speech “uncalled for” and a “parody of prayer”.

Bunye, in a radio interview, claimed “the President has no immediate reaction,” even as he stressed Mrs. Arroyo knew beforehand that Sunday’s event was to be a religious, not a political gathering of the Lakas-NUCK nor the People Power Coalition.


“It was a religious event and the President was knowledgeable of that fact,” he said.

"Elements of the crime are that the principal committed and completed the felony alleged, that the defendant had full knowledge of the fact, that the defendant failed to notify the authorities, and that defendant took an affirmative step to conceal the crime.

"Whoever, having knowledge of the actual commission of a felony recognizable by a court of the United States conceals and does not as soon as possible make known the same to some judge or other person in civil or military authority under the United States is guilty of the federal offense of misprision of felony."

NOW, let us consider: MISREPRESENTATION AS RELATES TO FRAUD (A CRIMINAL (FELONY) ACT).

"MISREPRESENTATION: Any manifestation by words or other conduct by one person to another that, under the circumstances, amounts to an assertion not in accordance with the facts. An untrue statement of fact. An incorrect or false representation. That which, if accepted leads the mind to an apprehension of a condition other and different from that which exists. Colloquially it is understood to mean a statement made to deceive or mislead.

"As amounting to actual legal fraud consists of material representation of presently existing or past fact, made with knowledge of its falsity and with intention that other party rely

thereon, resulting in reliance by that party to his detriment.

"In a limited sense, an intentional false statement respecting a matter of fact, made by one of the parties to a contract, which is material to the contract and influential in producing it. A "misrepresentation," which leads to a belief of a substantive fact material to proper understanding of the matter in hand, made with intent to deceive or mislead.

"In INSURANCE LAW: A statement of something as a fact which is untrue and material to the risk, and which assured states knowing it to be untrue and with intent to deceive, or which insured states positively as true, not knowing it to be true, and which has a tendency to mislead One that would influence a prudent insurer in determining whether or not to accept the risk, or in fixing the amount of the premium in the event of such acceptance."

We could go on and right through all the "MATERIAL" matters referenced in the book but we don't need to quote the whole of *Black's* because we have causes of action—MANDATORILY REQUIRED ACTIONS—(counted in the dozens) against V.K. This is in response to your recent Internet correspondence to the Office of the Comptroller of the Currency (OCC), Customer Assistance Group (CAG). The OCC is responsible for the regulation and supervision of national banks. National banks have the words, National, National Association, or the letters, N.A., in their official names.

The Office of the Comptroller of the Currency (OCC) examines national banks to assure their safe and sound condition and to ensure their compliance with banking laws, rules, and regulations that are applicable to nationally chartered banks. The OCC's consumer complaint process was established to ensure that bank customer's legal rights are protected.

In reviewing your complaint, we must first advise you that our office does not have the authority to transfer customer funds nor do we have access to customer accounts or any information which pertains to said accounts.

If you decide to file a formal complaint, it will necessary for you to provide documentation to our office to show that you have the legal authority to represent the account in question. In addition, you should provide copies of all correspondence between the bank and yourself regarding this issue. We recommend that you include copies of any documentation, which support your complaint.

This office requires all complaints filed with the office contain the original signature of the consumer. The Right to Financial Privacy Act (RFPA) governs the disclosure of financial records of individual bank customers to agencies of the federal government. In general, a federal agency can obtain a customer's financial records from a financial institution only when the customer has authorized the disclosure or the disclosure is in response to a judicial or administrative subpoena, search warrant or formal written request by a federal agency. In enacting this statute, Congress intended to protect customers of financial institutions, including national banks, from unwarranted intrusion into their financial records by government agencies.

Your complaint letter should be sent by U.S. Mail or fax along, with any attachments or supporting documentation. The required information is 1) your complete name and mailing address as used by the bank; 2) the full name and location (city, state) of the bank; 3) your account number(s); 4) a more detailed explanation of the complaint; and 5) your signature, as the account holder.

The head of the U.S.-funded lobby group, Accelerating, Growth, Investment and Liberalization with Equity (AGILE or Agile), one Ed Campos, who holds office at the fourth floor of the Bureau of Internal Revenue, was also said to have his computers and terminals directly linked to the BIR central records, having full access to BIR records, BIR insiders informed the *Tribune* yesterday.

Virata, along with central bank officials, has been pushing the strict adherence to the conditions imposed by the Paris-based Financial Action Task Force (FATF) on the Anti-Money Laundering Act (AMLA).

But the Agile agents and others linked to this group again earned the ire of senators for their no-show in yesterday’s hearing on their alleged suspicious activities and operations in various sensitive offices of government. [END OF QUOTING]

The next article we would like to share comes right out of the paper, *Philippine DAILY INQUIRER*, “Opinion”, Neal H. Cruz “As I See It”, re: AGILE. It needs no introductory comment. [QUOTING:]

#### THE ‘SMOKING GUNS’ AGAINST AGILE

Officials of the pro-American Macapagal administration are trying to portray AGILE, the American lobby group, as a benign bunch of “consultants” and “advisers” helping government agencies. Secret documents I found show otherwise. They prove that AGILE is a dangerous group with a smiling face but with a dagger tucked in its belt. In a memorandum to Dr. Joseph Ryan, CTD, AGILE, asking for approval of a request to hire, again, the services of PRISM, a public relations outfit, Dr. David Tardif-Douglin, managing director of Development Alternatives Inc. (DAI), boasted that his “team successfully halted the implementation of (the President’s) E.O. 59 and is beginning to establish direct competition to the government port monopoly.”

The smoking gun also showed that the supposedly independent industry groups lobbying for open skies and port modernization are actually dummies of AGILE. “A key ingredient in the success of (the port and air transport) teams is the role of external pressure groups through the Freedom to Fly Coalition (FFC) and the Coalition for Shipping and Ports modernization (CSPM),” said the memorandum. “From March 15 to July 31, 2001, PRISM designed, managed and implemented all media efforts for these Coalitions. PRISM produced all weekly press releases, drafted coalition statements, and managed and coordinated press conferences and media briefings... For this contract, PRISM will develop a new strategy in light of recent developments...”

What could this new strategy be? Maybe, just maybe, black propaganda.

Another smoking gun, a “strictly confidential” internal memo of PRISM, outlined just such a plan against members of Congress and a group of Filipino businessmen. The PRISM memo dated Feb. 18, 2003, said:

**“As per info I gave you on the phone, various dailies will be coming out tomorrow with stories quoting Senators Recto, Arroyo, Osmena, Representative Saludo and others denouncing AGILE, DAI, and USAID for their interference in policymaking decisions in finance, energy, education, BIR, Customs, DAR, DA, NEDA, DOTC, etc.**

**“I met with Mon Clarete and Dave Douglin last night and they suggested that we launch immediately a counter propa designed to ridicule and deflect the issue, using our existing files on Lucio Tan, Lucio Jr., Harry Tan, General Mison, Joseph Chua (these are people behind macro-Asia and Basic Holdings), and their lackeys in the Senate and House with emphasis that they are the ones orchestrating and financing the anti-U.S. sentiments of the country.**

**“They told me the ambassador has the same info and he’s very worried.**

**“I’ll prepare tomorrow three sets of stories for your approval. Please give me a call right away as soon as you give the green light for implementation and the USUAL release of funds.”**

It is not only the “ambassador” who is worried. Malacañang also is. Press Secretary Hernani Braganza called the public relations staff of the BIR and other agencies to a meeting to coordinate a counter-propaganda plan. Last Feb. 13, a certain person purportedly from the Malacañang Press Office, so I was told, distributed press releases and envelopes to the media.

A memorandum for the president from the Cabinet Secretary has this entry:

“Secretary Camacho noted that they are hiring a PR consultant to prepare a campaign plan for three bills: Securitization Act, the Nara bill (which will abolish the BIR and privatize it) and the Indexation of

Sin Taxes. Said plan will be submitted to the office of the Executive Secretary for approval. Romulo requested Secretary Camacho to coordinate with the OPS in the preparation of the campaign plan.”

Media should watch out and guard against stories planted by these pro-American, anti-Filipino groups. Don’t believe the line that AGILE is only helping the government. Come on, it is not doing all this manipulating out of the goodness of its heart. It is doing these things to favor American interests.

Here’s more bad news. The National Electrification Administration (NEA) badly needs new leadership. “Malaysian Prime Minister Mahathir Mohamad welcomed national leaders to a two-day summit of the 116-nation Non-Aligned Movement, which wants its voice heard in the U.S. confrontations with Iraq and North Korea—two member countries accused of having weapons of mass destruction.

“The group wants Iraq to meet UN demands to disarm, but opposes any unilateral U.S. invasion to force Baghdad to comply.

“Mahathir, an influential Muslim statesman, warned that war was “the most important threat” facing the non-aligned block of mostly developing nations, which represents 55 percent of the world’s population and holds nearly two-thirds of the UN General Assembly seats.

“War must be outlawed—that will have to be our struggle for now,” Mahathir, the group’s incoming chair, said at the summit’s opening.

“Following the Sept. 11 terror attacks, powerful countries were spearheading “a revival of the old European trait of wanting to dominate the world,” which Mahathir said, “invariably involves injustice and oppression of people of other ethnic origins and colors.”

“It is no longer just a war against terrorism. It is in fact a war to dominate the world, i.e., the chromatically-different world.”

Is this enough to accomplish anything? Probably not but with Dr. Mahathir there is enough world-respect to make it very clear that resistance “will NOT be futile”.

#### IRAQ: THE GREAT GAMBLE

**In the run up to a seemingly inevitable second Gulf war, the stakes are frighteningly high. JID has asked its regional specialists to assess the possible consequences of conflict with Iraq and the even less predictable implications of a post-Saddam Hussein scenario.**

The Pentagon's basic strategy for war with Iraq is predicted on the **assumption** that a massive air assault will result in the swift 'degrading' of Iraqi military defenses; by widespread desertion from the armed forces and a collapse of centralized command. This would be followed by a U.S.-led ground invasion, a swift capitulation by the government and a relatively easy occupation of the country whose citizens will be delighted at the ousting of the dictator and his Ba'ath Party cronies.

Unsurprisingly, many well-informed regional specialists are warning that this neat scenario—which may play well on computer screens during military exercises in neighbouring countries—is even less likely than Saddam suddenly deciding that discretion is the better part of valour before he heads off to a dishonourable exile and is replaced with someone more to the West's liking.

What is missing, they caution, is the prospect that ordinary Iraqis, many of whom have no reason to rally to the Ba'ath regime's defense, will take an active part in repelling any foreign invasion that is widely being seen as a 'crusade' against the Islamic world and Iraq in particular. As one Western analyst who has recently returned from Iraq put it: "There is a very widespread view among ordinary Iraqis that war is now inevitable, but there is an equally strong determination not to submit quietly to yet another foreign occupation.

"Remember, the overthrow of King Faisal in 1958 was part of a popular reaction to what was perceived as the royal government's dependence on the West—and Britain in particular. Saddam is a particularly ruthless dictator, but at least he is an Iraqi and any foreign occupation force is likely to be under constant attack. Think Afghanistan, but far, far worse."

If there is major resistance to a U.S.-led ground invasion, then troops are likely to face the prospect of urban warfare—a very different proposition to the type of combat which was experienced during the 1991 Gulf War. If so, then there are likely to be significant casualty figures involved in the capture of major cities such as Baghdad and Basra, where pro-Saddam forces are expected to be well dug-in.

The alternative—which could play extremely badly with international opinion—would be the encirclement of key towns and cities, with the use of armour and artillery. This was the method used by Russian forces in Chechnya—the so-called 'Grozny tactic'—which effectively reduced a city that once had 400,000 inhabitants to rubble back in early 1995. However, this would open up U.S. forces to the charge of "indiscriminate attack", a crime under the Geneva conventions. Another major difference between a prospective conflict with Iraq and the Afghan campaign is that a fair proportion of the

fiercest combat in the latter was undertaken by anti-Taliban forces which were already armed and organized within Afghanistan.

In effect the local Northern Alliance forces did much of the high-risk work, substantially reducing the number of allied casualties. There are no comparable anti-Saddam forces at present, although it is just possible that some Kurdish groups might be used. However, in view of the ethnic rivalries that exist between the various groups in Iraq—Sunni Muslims, Shi'a and Kurds—the use of local forces is likely to prove a liability. Turkey would also oppose any U.S.-led move to arm Kurdish factions.

Then there is the risk that Saddam will decide to go down fighting and institute a scorched-earth policy. Having previously demonstrated the costly damage he was prepared to inflict on Kuwait and its oil industry in 1991, there is a very real chance that Iraq's oil sector will be targeted in the same way, creating a major regional environmental disaster, as well as having a devastating impact on the country's oil production for years to come. Clouds of dense smoke also provide cover from air attack for retreating forces.

So far, all the indications suggest that the Pentagon is hoping for a military campaign lasting a matter of weeks, rather than months, followed by a stabilization operation to eliminate remnants of the Iraqi forces still loyal to Saddam's regime. There is also talk of a peace-keeping mission, modeled on the UN administration in Kosovo, which might last for several years.

However, the example of Kosovo is inappropriate for a number of reasons. The first is that KFOR deployed after an agreement had been concluded with the Yugoslav authorities in June 1999. Second, Yugoslav forces withdrew peacefully as KFOR moved in. Third, the vast majority of the population of Kosovo (the ethnic Albanians) welcomed KFOR as liberators. None of the above will apply in the case of occupied Iraq.

A further complication is that there is no credible alternative Iraqi government-in-waiting, unlike both Afghanistan and Kosovo. The deeply divided Iraqi opposition in exile has little or no following inside the country and any administration would be a group of outsiders imposed by the occupying forces. In many respects, the most accurate historical parallel will be with occupied Germany in 1945, where there was no functioning national government, a shattered infrastructure and a defeated army. It took years and enormous investment to reconstruct the country as a democracy.

War with Iraq will prove a major—and costly—gamble for U.S. President George W. Bush and his allies. A long and bloody conflict will have the potential to damage Western interests in the Middle East for generations.

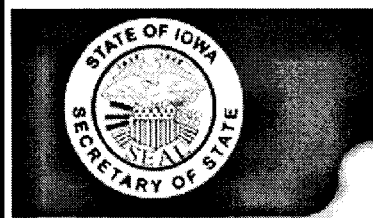

## WIN-WIN FOR THE PHILIPPINES

### INTRODUCTION

Conditions in the Philippines are rapidly approaching a juncture at which a slight course correction can make a huge improvement in the standard of living of all Filipinos, rich and poor alike. In most situations, for someone to win, someone else has to lose. That is called "Zero Sum". Filipinos have an option to avoid that trap and win-win instead.

Filipinos, along with most of the other peoples of the world, have been deliberately infected with a disease best characterized as "crab mentality", which has been used for centuries by colonial powers to control their colonies. It is also known as "divide and conquer". As long as this "me first" philosophy rules in a nation, that nation can easily be controlled by the so-called "financial oligarchs", Internationalists, Zionists, or our favorite term because it is the most accurate, International Banking Cartel (IBC).

As long as a nation's money is based upon "its promise to pay", i.e., fiat paper money, it can never escape the control of the IBC imposed through its "foreign exchange" mechanism, nor can the nation avoid the manipulations of the relative value of its own currency by the IBC. Only by building its gold reserves sufficiently to base its currency on gold can a nation break away from its need for foreign exchange and achieve stability for the value of its currency.

The benefits of having a currency that is acceptable in lieu of foreign exchange are so enormous that we should enumerate at least the major ones. The nation no longer needs to establish, keep track of, and publish its "foreign exchange reserves"—all of its money qualifies as foreign exchange. It no longer needs foreign "investors or loans"—all of the money needed can be generated internally. It need not "compete" with its neighbors for money or tourists and it need not send out its people as overseas workers to send home foreign exchange. Just as important, it is no longer in a "race" to produce and sell enough exports to balance its imports plus the interest on all foreign loans that had to be paid in foreign exchange.

Privatization becomes unnecessary and, in fact, can be reversed to reduce or eliminate foreign ownership of utilities, mines and petroleum reserves. "Money Laundering" laws, needed or desired, can be tailored to fit the culture, not dictated by a Paris-based Financial Action Task Force.

Tariffs can be designed to protect local producers and, even though export income is not necessary, it will be useful to contract directly with "trading partners" in a semi-barter arrangement with settlements in currencies once, or in some cases, a few times each year. This also takes care of another headache: "Balance of payments".

"Balancing the budget", at best a phony exercise-in-futility, is best done through an entirely different, value-oriented method not to be disclosed in this paper. The usual methods of both confiscating more money from the taxpayers, individual and corporate, and "austerity measures" such as reducing salaries and wages, pensions and other earned benefits, cutting back on needed infrastructure spending as

well as equipment needed for schools, hospitals, police, fire, coast guard and military, always place the government in conflict with the people.

There is a way to have a benign government that serves its people without having to tax their incomes. It was practiced in the U.S.A. until the "victory" tax of 1942 was needed to pay the interest on the debt to the Federal Reserve System, the privately owned "central bank" allowed by the Federal Reserve Act of 1913. The Republic of the Philippines is perfectly situated to use the "old" U.S.A. system (not to be confused with the current U.S.A. system, which has brought the U.S.A. close to ruin).

In 1964 an agreement was entered into between the government of the Philippines and the "Royal Family" (also known as the Tagean-Tallano clan—part of the Sultanate of Sulu), to permit the government to "rent" the use of some 400,000 metric tons of gold owned by the Royal Family to be used as banking reserves upon which to base the Philippine currency. The document formalizing that agreement is styled: **DECISION WITH COMPROMISE AGREEMENT** and was issued by Judge Enrique A. Agana February 4, 1972. The exact language at page 18 paragraph 3 is:

That the gold bullion lent by the Royal Family to the Republic of the Philippines, consisting of 650,000 metric tons now, thru Reverend Father Jose Antonio Diaz by arrangement of the young brilliant lawyer, Atty. Ferdinand E. Marcos in the year 1949, for the establishment of the required gold reserves of the newly installed Central Bank of the Philippines should be maintained to the Central Bank vaults toward maintenance of the countr's (sic) gold reserves and the same should be withdrawable fifty years thereafter with five years moratorium to stabilize the Philippine peso value, while the clans, the Royal family should only be entitled for five percent (5%) of the one percent (1%) of the appraised value of the commodities as Royalty fee, and should be paid by the government in cash equivalent to the surviving beneficiaries, the heir of the late Prince Lacan Acuña Tagean Tallano..."

On page 120 of the same document the numbers are changed a bit, presumably because additional information came to light. Paragraph 9 says:

Ordering the National Government, Office of the President of the Philippines and his staffs, the National Treasurer and his staffs, the Solicitor General and his staffs and the Governor of the Central Bank to relocate the remaining inventory balance of 400,000 metric tons of gold nuggets own by the Royal Family, the Tagean-Tallano family, and, when relocated, return the same to the vaults of the Central Bank for the interest of the Filipino people to serve as U.S. dollar reserves required by the IMF and the World banks, while that 5% of that 1% of the required royalty fee which was unpaid starting in the year 1969 to the present and to its succeeding years until the precious metals has been withdrawn based on the prevailing market price should be paid directly to the authorized Heir, Prince Julian Morden Tallano.

The gold price at year-end 1970 (the first year for which interest on the unpaid Royalty was due) was \$38.90 per ounce. If we multiply the number of ounces in a metric ton of gold (31,103) X 1% (.01) X 5% (.05) X 400,000 metric tons, we will have a "constant" of 6,220,800 to use. If we multiply the constant times the price in a given year we get the Royalty due for that year. In 1970 the number rounded to the nearest million dollars was \$242 M. That Royalty was not paid.

At that time the interest rate mentioned in some of the court documents was given at 7%. 242 million dollars at 7% to the end of 2002 (33 years) is 2,256 billion dollars. When all of the Royalties are added up they come to \$62,496B. When their earned interest is added the total is \$200.172B. The value of 400,000 metric tons of gold is more than 4 trillion dollars (more than 200 trillion pesos).

These are large numbers so we need to put them into a reasonable perspective. The "money supply" (M3) in the U.S. is almost \$7 trillion; in the Philippines it is P1.15 T or about \$30B. The debt (public and private) of the Philippines is somewhat less than \$100B; in the U.S. it probably exceeds \$60T. Realizing that there are only some 4 times as many people in the U.S. as in the Philippines, we can see that these numbers are not so outrageous as they at first might seem.

It would be easy for the government to shrug and say, "We can't pay the Royalty. Anyway, we have not used the gold so there should be no Royalty due." The Court Appointed Administrator of the Royal Family Estate, however, could rejoin, "Since we have not been permitted to withdraw our gold, and it is not our fault that the government has not availed of its use, the Royalty is due. And, according to the Agreement, any time after 1998, we have the right to withdraw the gold."

These kinds of dialogue have resulted in escalating litigation and acrimony between the two parties and will continue to do so until an objective third party (that does not benefit from the continuing conflict) can be introduced. The goals of the Global Alliance Investment Association, the reestablishment of sovereignty of nations and thus the prosperity of their peoples, are in harmony with the amicable and mutually beneficial settlement of these matters, just as was envisioned and written by Judge Agana in his several Decisions and Orders.

**In his CLARIFICATORY DECISION dated January 19, 1976, Judge Agana wrote:**

"Ordering the Administrator, Julian M. Tallano to do the following acts and function for and in behalf of the Land owners, here to wit:

"1) Organize and establish Foundation in the name of Don Esteban Benitez Tallano and Don Gregorio Madrigal Acop to pursue the objectives of the Land owners to preserve the estate for and in the interest of Filipino farmers, poor families and their children, either Christian or Muslim especially those who became victims of martial law, and to uplift economic, social and health condition of those families living under poverty line by providing employment with use of the proceeds of the sale of the estate which the administrator is authorized to do so."

Julian M. Tallano has established the Foundation and appointed Officers and a Board of Directors. The objectives of the Foundation are clearly enunciated and are properly aligned with the Order of the Court. There should be no further reluctance on the part of the government to perform its duties under the law.

Being "reluctant" and lacking the "wherewithal" are two very different conditions. In this instance, the excuse of lacking the "wherewithal" has become such a habit on the part of government that it has damaged itself and its people, whom it is mandated to serve, for more than thirty years rather than adopt an attitude more conducive to solutions. At this time, it is not productive to point fingers of blame; it is time to open our minds to the potential for solving the problem for the benefit of the nation and all of its people, because ALL will benefit.

There is no need to fear private ownership of land. That is the normal condition in most countries. What might be considered "abnormal" or "dangerous" to the welfare of the people is for the POWER to be perceived to reside in one person. That problem has

ATHENS, Thursday 27 February 2003

Dear Mr. Secretary:

I am writing you to submit my resignation from the Foreign Service of the United States and from my position as Political Counselor in U.S. Embassy Athens, effective March 7. I do so with a heavy heart. The baggage of my upbringing included a felt obligation to give something back to my country. Service as a U.S. diplomat was a dream job. I was paid to understand foreign languages and cultures, to seek out diplomats, politicians, scholars and journalists, and to persuade them that U.S. interests and theirs fundamentally coincided. My faith in my country and its values was the most powerful weapon in my diplomatic arsenal.

It is inevitable that during twenty years with the State Department I would become more sophisticated and cynical about the narrow and selfish bureaucratic motives that sometimes shaped our policies. Human nature is what it is, and I was rewarded and promoted for understanding human nature. But until this Administration it had been possible to believe that by upholding the policies of my president I was also upholding the interests of the American people and the world. I believe it no longer.

The policies we are now asked to advance are incompatible not only with American values but also with American interests. Our fervent pursuit of war with Iraq is driving us to squander the international legitimacy that has been America's most potent weapon of both offense and defense since the days of Woodrow Wilson. We have begun to dismantle the largest and most effective web of international relationships the world has ever known. Our current course will bring instability and danger, not security.

The sacrifice of global interests to domestic politics and to bureaucratic self-interest is nothing new, and it is certainly not a uniquely American problem. Still, we have not seen such systematic distortion of intelligence, such systematic manipulation of American opinion, since the war in Vietnam. The September 11 tragedy left us stronger than before, rallying around us a vast international coalition to cooperate for the first time in a systematic way against the threat of terrorism. But rather than take credit for those successes and build on them, this Administration has chosen to make terrorism a domestic political tool, enlisting a scattered and largely defeated al-Qaida as its bureaucratic ally. We spread disproportionate terror and confusion in the public mind, arbitrarily linking the unrelated problems of terrorism and Iraq. The result, and perhaps the motive, is to justify a vast misallocation of shrinking public wealth to the military and to weaken the safeguards that protect American citizens from the heavy hand of government. September 11 did not do as much damage to the fabric of American society as we seem determined to do so to ourselves. Is the Russia of the late Romanovs really our model, a selfish, superstitious empire thrashing toward self-destruction in the name of a doomed status quo?

We should ask ourselves why we have failed to persuade more of the world that a war with Iraq is necessary. We have over the past two years done too much to assert to our world partners that narrow and mercenary U.S. interests override the cherished values of our partners. Even where our aims were not in question, our consistency is at issue. The model of Afghanistan is little comfort to allies wondering on what basis we plan to rebuild the Middle East, and in whose image and interests. Have we indeed become blind, as Russia is blind in Chechnya, as Israel is blind in the Occupied Territories, to our own advice, that overwhelming military power is not the answer to terrorism? After the shambles of post-war Iraq joins the shambles in Grozny and Ramallah, it will be a brave foreigner who forms ranks with Micronesia to follow where we lead.

We have a coalition still, a good one. The loyalty of many of our friends is impressive, a tribute to American moral capital built up over a century. But our closest allies are persuaded less that war is justified than that it would be perilous to allow the U.S. to drift into complete solipsism. Loyalty should be reciprocal. Why does our President condone the swaggering and contemptuous approach to our friends and allies this Administration is fostering, including among its most senior officials. Has "oderint dum metuant" really become our motto?

I urge you to listen to America's friends around the world. Even here in Greece, purported hotbed of European anti-Americanism, we have more and closer friends than the American newspaper reader can possibly imagine. Even when they complain about American arrogance, Greeks know that the world is a difficult and dangerous place, and they want a strong international system, with the U.S. and EU in close partnership. When our friends are afraid of us rather than for us, it is time to worry. And now they are afraid. Who will tell them convincingly that the United States is as it was, a beacon of liberty, security, and justice for the planet?

Mr. Secretary, I have enormous respect for your character and ability. You have preserved more international credibility for us than our policy deserves, and salvaged something positive from the excesses of an ideological and self-serving Administration. But your loyalty to the President goes too far. We are straining beyond its limits an international system we built with such toil and treasure, a web of laws, treaties, organizations, and shared values that sets limits on our foes far more effectively than it ever constrained America's ability to defend its interests.

I am resigning because I have tried and failed to reconcile my conscience with my ability to represent the current U.S. Administration. I have confidence that our democratic process is ultimately self-correcting, and hope that in a small way I can contribute from outside to shaping policies that better serve the security and prosperity of the American people and the world we share.—John Brady Kiesling

been solved with the establishment of the Foundation, as required by Judge Agana. The problem of the death, abduction, or bribery of the Administrator has also been solved with the same action.

What about the millions of "fake" land titles that have been issued, leaving practically no one with a legitimate title? Working together, those problems can be solved—at the expense of those who profited therefrom. If we do not all work together, and we include Global Alliance Investment Association (GAIA), there would not be enough courts and attorneys in the world to unravel the mess.

When we say, "Working together", we should define who would be required. At the first level would be the Foundation, the government, and GAIA—GAIA is needed to underwrite the transactions because they will be too large for the government. At the second level should be three sultanates of Mindanao plus the three or four Sultans of Sulu. We would suggest inviting representatives from Indonesia, Malaysia, and Brunei as observers so that the process is transparent and understood from the very beginning.

Our first objective should be to mobilize the use of the gold. To do that, all we need at this time is to locate and inventory it. In most instances, GAIA will be able to establish a lien on the deposit so that it may be held for the use of the National Treasury of the owner nation upon which to base its currency. Leases or loans of gold among the nations can allow everyone to benefit, especially in the beginning.

As an example, let us suppose we find that the 400,000 metric tons is in the BSP vaults in Quezon City. The value of the gold would be more than USD 4 trillion (\$4T). While the transaction can, and probably should, be handled in a series of smaller transactions, for purposes of illustration let us assume it is all done at one time. GAIA would issue two DEEDS OF ASSIGNMENT FOR CONSIDERATION in the amount of \$4T, one to the Foundation and one to the National Treasury of the Republic of the Philippines. At the same time the National Treasury and GAIA would enter into a Joint Venture Memorandum of Agreement to purchase the gold from the Foundation. The first would insure the Foundation of payment while the second would provide the RESERVES upon which to issue the new currency/credit with which to pay the Foundation. The ownership of the gold is then divided 50/50 between the National Treasury and GAIA.

The Global Alliance Investment Association portion then becomes the RESERVES upon which it can lease or loan RESERVES to other nations so as to get them started to base their currencies on gold, as well as serve as an emergency fund for the worldwide deployment of support for all member nations in the event of earthquake, typhoon, or other disaster.

Going back at least to the event of its Independence, the Republic of the Philippines is owed real estate taxes. As the National Treasury creates the money to pay the Foundation, the Foundation can pay its real estate taxes, instantly putting millions of pesos into the municipalities that can contract for improvements, cleanup, infrastructure, as well as improved salaries for teachers, police, firemen, health care givers, and so on, thus providing full employment in the Provinces that can draw home their citizens from the overcrowded cities. Will Manila become a "ghost town"? Of course not, but its traffic and pollution problems will soon go away due to less population pressure and the completion of its infrastructure projects.

There are ways to handle all of the government debt to the Estate so that it can all be cleaned up. When that is finished, the foreign debt can be paid and sovereignty regained.

It all begins, and ends, with the "agreement to agree" and to follow the law—**God's Law—Do Unto Others As You Would Have Them Do Unto You.**

U.S. DIPLOMAT RESIGNS,  
PROTESTING 'OUR FERVENT PURSUIT OF WAR'

UNITED NATIONS—A career diplomat who has served in United States embassies from Tel Aviv to Casablanca to Yerevan resigned this week in protest against the country's policies on Iraq.

The diplomat, John Brady Kiesling, the political counselor at the United States Embassy in Athens, said in his resignation letter, "Our fervent pursuit of war with Iraq is driving us to squander the international legitimacy that has been America's most potent weapon of both offense and defense since the days of Woodrow Wilson."

Mr. Kiesling, 45, who has been a diplomat for about 20 years, said in a telephone interview tonight that he faxed the letter to Secretary of State Colin L. Powell on Monday after informing Thomas Miller, the ambassador in Athens, of his decision.

He said he had acted alone, but "I've been comforted by the expressions of support I've gotten afterward" from colleagues.

"No one has any illusions that the policy will be changed," he said. "Too much has been invested in the war."

Louis Fintor, a State Department spokesman, said he had no information on Mr. Kiesling's decision and it was department policy not to comment on personnel matters.

In his letter, a copy of which was provided to the *New York Times* by a friend of Mr. Kiesling's, the diplomat wrote Mr. Powell: "We should ask ourselves why we have failed to persuade more of the world that a war with Iraq is necessary. We have over the past two years done too much to assert to our world partners that narrow and mercenary U.S. interests override the cherished values of our partners."

His letter continued: "Even where our aims were not in question, our consistency is at issue. The model of Afghanistan is little comfort to allies wondering on what basis we plan to rebuild the Middle East, and in whose image and interests."

It is rare but not unheard-of for a diplomat, immersed in the State Department's culture of public support for policy, regardless of private feelings, to resign with this kind of public blast. From 1992 to 1994, five State Department officials quit out of frustration with the Clinton administration's Balkans policy.

Asked if his views were widely shared among his diplomatic colleagues, Mr. Kiesling said: "No one of my colleagues is comfortable with our policy. Everyone is moving ahead with it as good and loyal. The State Department is loaded with people who want to play the team game — we have a very strong premium on loyalty."

BUSH SPEECH ON MIDDLE EAST:  
IGNORANCE, ARROGANCE, IMPERIALISM

President George Bush of the United States of America is either an idiot, or a liar. His declarations on the Middle East in his speech on Wednesday in Washington spelt a telling story of a man wholly incompetent to be in his position who is either unable to understand the issues at stake or else manipulates the evidence to suit his discourse. In short, he is either an idiot or a liar.

In a delirious speech, which harped back to the Second World War, George W. Bush compared the current international situation to that of 1945, when the U.S.A. rebuilt Germany and Japan in a scenario of sweeping democratic change, stating that a regime change in Iraq would be "a dramatic and inspiring example of freedom" for the world.

This regime change, he believes, will be a "road map to peace" in the Middle East. Washington's policy to solve the Middle East crisis does not start with Tel Aviv, where the new coalition government includes parties which want to expel the Palestinians from their territories and build new colonies, but with Baghdad. In short, the policy is to remove what Washington refers to as "the greatest obstacle to peace".

Washington is gearing up towards war. The hype is there, the demonology is there but unfortunately, the cause is not. Last time around, Saddam Hussein's forces invaded Kuwait (albeit after this country had systematically violated international law by cross-drilling, stealing the oil from Iraq's wells).

In the hysterical attempt to create a *causus belli* where there is so obviously none, George Bush followed the ludicrous and totally unfounded path begun by Britain's Prime Minister Blair and the U.S. Secretary of State Colin Powell, that Saddam Hussein has contacts with international terrorist regimes, describing Saddam Hussein as "a wealthy patron who offers rewards to the families of suicide bombers". What he offers is a pension for the families of those who have lost their main breadwinner, an act of social solidarity that the U.S.A. would do well to copy, given the millions of its citizens who do not have access to healthcare because the "regime" provides them with nothing.

Sentences such as "The passing of Saddam Hussein's regime" and "Palestinians that long for democracy will be in a better position to choose new leaders for a state that abandons forever the use of terror" demonstrate a total failure to grasp the basic issues at stake in the region or to understand the fundamental principles of international law.

The *United Nations Charter* states clearly that any act of war outside the auspices of the organisation must be based on a principle of self-defence, which explains the references to international terrorism levelled against Baghdad by Washington, a puerile and idiotic attempt to indict a regime for a crime which it so obviously did not commit.

The cherry on the cake was the phrase that an Iraq without Saddam Hussein "will contribute greatly to the long-term safety and stability of our world. America's interests in security, and America's belief in liberty, both lead in the same direction: to a free and peaceful Iraq".

Or rather, the U.S.A.'s vision for this region is an occupation of its resources so as to control the world economy. It is a blatant attempt to steal the resources of a sovereign nation, it is an imperialistic policy which is as anachronistic as it is illegal and it is a very sorry comment on the state of development of mankind, that powerful lobbies can be allowed to dictate policy which affects millions of people around the world, directly or indirectly remote-controlling governments which wield awesome power.

Such regimes are authoritarian, fascist, imperialistic, reactionary and totally anachronistic in a world whose engine is its people, in a scenario of multi-lateralism, equal rights, collaboration and friendship between all the nations of the planet.

The U.S.A. and its poodle, Blair (not the UK) have managed to ostracise themselves from the mainstay of world public opinion. The rules of diplomacy dictate that when such a position has been reached, the regime faces a certain death.

BUSH SEES WIDE POSTWAR PEACE  
IRAQ DEFEAT WOULD OPEN DOOR TO DEMOCRACY  
IN REGION, HE SAYS

WASHINGTON—Building his case for a war against Iraq, President Bush on Wednesday predicted that Saddam Hussein's regime would be replaced by a disarmed, democratic government that would ultimately inspire other representative governments to sprout throughout the largely autocratic Middle East.

Moreover, Bush asserted that eliminating Hussein would usher in a lasting peace in the Middle East and serve as a catalyst to the creation of a democratic Palestinian state coexisting side by side with Israel. ...

Bush said nothing about the cost of the war or reconstruction. But administration officials indicated Wednesday that it could cost nearly \$100 billion to fight and briefly occupy Iraq. That would come from a 2004 federal budget that is already projecting a deficit of more than \$300 billion. ...

Middle East experts say Bush's vision of a democratic Iraq, let alone the spreading of democracy throughout the Middle East, is unlikely to come to pass any time soon.

**"I don't believe that we are going to transform Iraq," Anthony Cordesman of the Center for Strategic and International Studies told a Senate committee. "We may start that process. There is no chance in hell that we will finish it. It takes too long to change a society and a country of 22 million people."...**

Bush confronted his critics directly, saying it was "presumptuous and insulting" to suggest that Arab Muslims of the Middle East can't create democratic institutions. He also sought to reassure Arabs that there is a limit to how much influence the U.S. intends to exert on Iraq's new government.

"The United States has no intention of determining the precise form of Iraq's new government. That choice belongs to the Iraqi people," Bush said. "Yet, we will ensure that one brutal dictator is not replaced by another."

Bush attempted to broaden the appeal of a war in Iraq by saying the road to peace in Israel and the Palestinian territories runs through Baghdad. Once Hussein was dethroned, Bush said, Palestinian terrorists would lose an important financial sponsor, and the Palestinian Authority would move toward new leadership and democracy. ...

"We're not coming in to punish or to occupy Iraq," said Joseph Collins, a deputy assistant secretary of defense. "We're coming in to liberate the country and create the conditions where the Iraqis can create a highly functioning democracy on their own."

Undersecretary of State Marc Grossman told senators that Iraq would be transformed in three phases, ending with the institution of an Iraqi Constitution and open elections.

Yet Undersecretary of Defense Douglas Feith told lawmakers, "It is very hard to tell you precisely what we plan to do because so much... depends on how events unfold."

HUSSEIN A TARGET IN WAR, U.S. SAYS*Newsday, 02/26/03*

WASHINGTON (AP)—Saddam Hussein and other Iraqi leaders would be legitimate targets for U.S. military forces in a war, the White House said Tuesday.

“If we go to war in Iraq and hostilities result, command and control and top generals, people who are in charge of fighting the war to kill the United States’ troops, cannot assume that they will be safe,” said spokesman Ari Fleischer, elaborating on comments by Sen. Peter Fitzgerald (R-Ill). “If you go to war, command and control are legitimate targets under international law.”

President Bush told Fitzgerald he likely would order the assassination of Saddam Hussein “if we had a clear shot” at the Iraqi leader, Fitzgerald said Monday in an interview with the suburban Chicago newspaper the *Daily Herald*. He was asked how the United States could capture and remove Hussein from power without killing thousands of Iraqi citizens.

“That’s a really good question because the administration—I have personally talked to the president about this—and if we had intelligence on where he was now, and we had a clear shot to assassinate him, we would probably do that,” Fitzgerald said. “President Bush would probably sign an executive order repealing the executive order put in place by President Ford that forbids the assassination of foreign leaders.”

Asked to clarify his remarks, Fitzgerald reiterated that Bush told him he would authorize changing U.S. policy to kill Hussein.

On Tuesday, Fitzgerald refused to discuss the matter further.

Fleischer said Bush did not recall the conversation with Fitzgerald.

U.S. TWISTS ARMS IN EFFORT TO END STAND-OFF

There has been lots of talk of “mutual respect” but behind the scenes there has been arm-twisting and what one regional diplomat calls “primitive” diplomacy as the U.S. presses its two Latin American allies on the Security Council to vote in favour of war.

Mexico, whose economy has become increasingly integrated with its U.S. neighbour over the past 10 years, appears most vulnerable to U.S. pressure. But Chile, whose free trade agreement with the U.S. has

still to be approved by the U.S. Congress, could also pay a heavy price if it rejects U.S. plans.

“We all know about the consequences of taking one or the other position,” said President Ricardo Lagos of Chile this week.

President Vicente Fox of Mexico, a radical conservative, and Mr. Lagos, a socialist, may come from different political traditions but they appear to share similar views on the Iraqi crisis and are inclined to support efforts to give more time to UN arms inspectors.

For Mr. Fox, a devout Catholic, the issue is a moral one. Close associates say it is hard to see his sanctioning a vote in favour of military action.

Both men also face strong domestic political pressures. With the Mexican public overwhelmingly opposed to war, backing a new UN resolution could damage the prospects of Mr. Fox’s right-wing National Action Party in mid-term congressional elections in July and weaken his two-year-old presidency.

And home politicians are unanimously behind Mr. Fox. Over the weekend a meeting of state governors, the majority of whom are from opposition parties, unanimously supported Mr. Fox’s anti-war stance.

Mr. Lagos was due to meet opposition leaders on Tuesday but Chile’s rightwing parties share the left’s opposition to war.

The pressure from the U.S. and its allies has been growing. President George W. Bush has telephoned both Mr. Fox and Mr. Lagos.

José María Aznar, the prime minister of Spain, one of three U.S. allies on the Security Council, met Mr. Fox last week. At least two U.S. State Department officials have visited Mexico City to deliver apparently tough messages in the past three weeks. ...

Mexican officials are also worried that a scheme allowing Mexican consulates in the U.S. to grant identity cards that have helped regularise life for undocumented labourers could be at risk. The cards have been accepted as identification papers by banks and legal authorities in most U.S. cities with large Mexican populations, enabling immigrants to open bank accounts.

5000 IRANIAN TROOPS DEPLOY TO DEFEND IRAQ

WASHINGTON—Iranian-backed Iraqi opposition forces have crossed into northern Iraq from Iran with the aim of securing the frontier in the event of war, according to senior Iranian officials.

The forces, numbering up to 5,000 troops, with some heavy equipment, are nominally under the command of Ayatollah Mohammad Baqir al-Hakim, a prominent

Iraqi Shia Muslim opposition leader who has been based in Iran since 1980 and lives in Tehran.

A U.S. State Department official said he was aware of reports that part of Ayatollah Hakim’s Badr brigade had crossed into northern Iraq but declined further comment. Analysts close to the administration of President George W. Bush said the U.S. was concerned about the intentions of this new element in an increasingly complicated patchwork of forces in northern Iraq.

Turkey has long had a limited military presence in northern Iraq, and U.S. special forces began moving into the region several months ago. The Badr brigade has been trained and equipped by Iran’s Revolutionary Guards and could be regarded as a proxy force of the Iranian government.

Iranian officials insist that force’s role in the north is defensive but its presence will exacerbate the concerns of the U.S. and especially the Arab world that military intervention in Iraq will lead to a permanent disintegration of the country. Through inserting a proxy force, Iran is underlining that it cannot be ignored in future discussions over Iraq’s make-up. ...

A senior Iranian official, who asked not to be named, said the presence of Ayatollah Hakim’s troops was defensive and aimed at countering a possible attack on Iran by the People’s Mujahideen Organisation (MKO), an Iranian opposition group based in Iraq and strongly supported by President Saddam Hussein.

Another official said the Badr force had moved into an area near Darbandikhan, a depopulated and rugged stretch of hills and ravines about 15 miles from the closest point on the Iranian border.

The MKO used Iraqi territory to mount attacks on Iran during the 1980-88 war between Iran and Iraq. The Kurdish parties controlling northern Iraq have also expressed fears that Mr. Hussein would try to use the MKO against them in the event of a US-led invasion of Iraq. ...

IRAN SUES U.S. IN WORLD COURT FOR HELPING SADDAM KILL IRANIANS

A strange spectacle in court: As the USA prepares for a war against Iraq. The U.S. is being sued by Iran for its previous close relationship to Saddam Hussein. At the International Court of Justice, Teheran is accusing the United States of delivering dangerous chemicals and deadly viruses to Baghdad during the eighties. ...

Teheran accuses Washington of the destruction of three oil platforms in the Persian Gulf. The U.S. argues that the attack was in retaliation of Iranian attacks on ships sailing under the American flag. The court has scheduled three weeks to hear arguments from both sides.

The Iranian representatives accuse the U.S.A. of having provided Iraq with raw materials for chemical and biological weapons at the end of the 80s. The U.S. government had delivered dangerous chemicals and deadly viruses to the Iraqi government for its war.

Washington had provided aid to Iraq in this, and other ways, in its war against Iran, said Iran’s representative at the start of the oral depositions.

Mohamat Zahedin-Labbaf, as the spokesman of the Iranian delegation, emphasized that the U.S. could not dispute the destruction of the platforms. The U.S. version, that it had been a matter of defense against Iranian missile attacks of ships under the U.S. flag doesn’t hold water, he said.

In any case, the USA had violated the Friendship Treaty which both countries had signed in 1955. It is this Treaty which constitutes the legal basis for these proceedings, according to a 1996 decision by the highest court of the United Nations. Both delegations will be able to argue their positions in detail during the next three weeks.

Professor Bruno Summa, a German expert on international law, was sworn in as the new judge at the beginning of the proceedings on Monday. The longtime University Professor at the University of Munich was elected as one of the 15 regular judges of the Supreme Court in the Hague Peace Palace.

#### SOME U.S., U.K. MEDIA RESORT TO FRANCE-BASHING

Who says jingoistic journalism is passé? Rupert Murdoch's media empire is leading a charge against the enemy.

But no, not Iraq. ... France.

First, News Corp.'s *New York Post* labeled France and Germany "the Axis of Weasel". Then, dispatches from Normandy and Paris by *Post* agent provocateur Steve Dunleavy accused France of cowardice for its opposition to U.S. war plans. "Vive les wimps," he wrote in a page-one story. Inside, the paper featured a photo of him with a toy weasel and a copy of the *Post*'s "Weasel" front page.

The *London Sun*, another tabloid owned by News Corp., sent a man dressed as a chicken to deliver white feathers of surrender to the French Embassy. The paper also ran a photo of "le poulet du soleil" (the sun chicken), a fake picture of Saddam Hussein standing in front of the Eiffel Tower and 10 French jokes. (The piece de resistance: How did the French advertise surplus World War II rifles? Answer: Never fired, only dropped once.)

As war becomes increasingly a fait accompli and as the French ramp up their opposition, bashing the home of the Enlightenment has become a cottage industry among some members of the U.S. and British media. Jonah Goldberg, a National Review Online editor-at-large and syndicated columnist, made his career writing editorials poking fun at France, using a phrase popularized by *The Simpsons* TV show—"cheese-eating surrender monkeys"—to describe the country's citizens. These days, he complains, "I'm a market leader, and now it's a free-for-all."

Columnist George Will recently called French Foreign Minister Dominique de Villepin "oleaginous". *New York Times* columnist Thomas Friedman suggested replacing France on the United Nations Security Council with India. An editorial in the *Wall Street Journal* last month asked, "Can the French read?" as it took the nation to task for what it called failure to back a UN resolution on Iraq that France had earlier approved.

Some of the current missives recall the tactics of William Randolph Hearst when he was fighting a bitter circulation war with Joseph Pulitzer. Hearst's *New York Journal* bolstered war feelings against the Spanish after the sinking of the *USS Maine* in 1898 with such slogans as "Remember the *Maine*, to hell with Spain!"

Caught in fierce circulation battles of their own, News

Corp.'s tabloids have become France's *bete noire*. Col Allan, the *Post*'s editor in chief, says his paper has taken its stand because it feels the French are trying to bolster "a position of influence that frankly no longer exists", and because they are being disloyal. "We know how to spell the word ally," says Mr. Allan, an Australian. A News Corp. spokesman, asked about the reports on France in all its outlets, says, "The coverage speaks for itself."

Criticizing the French is nothing new. Shakespeare's Henry V, bemoaning the ill health of his troops, proclaims, "Those few I have almost no better than so many French."

These days, attacking the French may be one of the last acceptable forms of political incorrectness. "It would be difficult to say the same things about Mexico," says Gordon Dillow, a columnist with the *Orange County Register* in California who says he once started a column, "I hate France. I really hate France."

In addition to News Corp.'s newspapers, its *Fox News* cable-television channel has developed its own critique. On a show hosted by Neil Cavuto, U.S. Rep. Peter King, a New York Republican, said the U.S. should "not allow a second- or third-rate country, a has-been country like France to hold us back." Mr. King said his family canceled a planned trip to France in protest. Another *Fox News* host, **Bill O'Reilly, told a guest, "But I don't understand why the French are so seemingly anti-Semitic."**

Bob Simon, a correspondent for the CBS television network, proposed doing a French-bashing piece several years ago but never found the right characters to tell the story, he says. Now he wishes he had the piece to run. "The only people you can get away being nasty to are the WASPs and the French," says Mr. Simon, whose wife is French.

Such talk is, of course, not de rigueur in France, but it isn't entirely clear how many people get the joke. *Le Monde* translated "Axis of Weasel" as "Axe des faux jetons," which put back into English means something like "axis of hypocrites." "Cheese-eating surrender monkeys" also lost some of its rhetorical punch after being translated by *Le Monde* as "primates capitulars et toujours en quete de fromages." That translates back as "primates who capitulate and who are always in search of cheese."

"Obviously, French-bashing is a trend that helps sell some newspapers to some people," says a diplomat at the French Embassy in Washington. "We regret it, but we don't overreact."

#### BACKING U.S. ON IRAQ DIVIDES AUSTRALIANS

SYDNEY—When Prime Minister John Howard added Australia to President Bush's "coalition of the willing," he became wedded to a group of leaders whose support for Washington's policy on Iraq is having repercussions for their own political futures.

Like Silvio Berlusconi in Italy and Tony Blair in Britain, Howard has watched solid approval ratings erode amid an

electorate split between pro- and anti-war sentiments. ...

Global analysts warn that if the war is prolonged and casualties are high, the political backlash could see the fall of pro-American governments across the world, from Canberra to London to Ankara.

Public backlash could topple regimes in the Middle East that already are under pressure from Islamic militants. Pakistan and Indonesia could face further turmoil, complicating efforts to deal with extremist religious groups that thrive on anti-U.S. passions.

Howard's decision to send 2,000 troops to join the U.S. forces in the Persian Gulf region has become a watershed in Australian politics for the furor it has sparked and the scorn it has brought Bush.

Politicians have subjected Bush to ridicule and ribald rants, with one opposition legislator describing Bush as "the most incompetent, flaky and dangerous president in living memory". Another said Bush was acting like "a Texas Ranger in a B-grade Hollywood movie."...

This month, parliamentary debates resembled barroom verbal slugfests.

When U.S. Ambassador Tom Schieffer complained about the tone of the anti-Bush diatribes, he was bluntly told by legislators to mind his own business.

"Schieffer is a close business mate of George W. Bush, masquerading as an American diplomat," protested Labor member Harry Quick.

Quick told the House, "The dilemma facing the world is that America has a caricature of a Wild-West, gun-toting Texan bounty hunter masquerading as a U.S. president and desperate for a rerun of the Gulf War."

Prime Minister Howard, an astute politician, has been telling his nation Australia had not yet fully committed itself to an Iraq war. His explanation is ridiculed because of the forces Canberra has already dispatched to the gulf region.

Howard's soft sell was flattened this month during his visit to the White House. At a press conference Bush was asked if he considered Australia a member of "the coalition of the willing."

"Yes, I do," replied Bush.

The opposition gloated.

#### VENEZUELAN CAPITAL HIT BY 2 BIG BOMB ATTACKS

CARACAS, Venezuela—Powerful explosions just minutes apart devastated the Spanish and Colombian diplomatic missions Tuesday, injuring four people.

The attacks in Caracas came two days after President Hugo Chavez denounced Colombia and Spain, among other nations, for allegedly interfering in Venezuelan affairs. No one immediately claimed responsibility for the blasts.

Leaflets supporting Chavez's "Bolivarian Revolution," a political movement loosely based on the writings of 19th century independence hero Simon Bolivar, were found outside both missions. But Chavez's government dismissed the papers as a "ridiculous" plant.

Vice President Jose Vicente Rangel repudiated the attacks as "a form of terrorism never seen in Venezuela", and suggested Chavez opponents may have been involved.

The explosions—at 2 a.m. at the Spanish Embassy and 2:15 a.m. at the Colombian consulate—shattered windows and damaged facades. Four people were slightly injured.

The U.S. Embassy said the "cowardly" attacks "make more difficult the search for a peaceful, democratic, electoral solution to the problems faced by the people of Venezuela."

Colombia condemned the "act of savage terrorism." It used the incident to urge Venezuela to increase cooperation in fighting leftist Colombian rebels.

Spanish Ambassador Manuel Viturro de la Torre refused to speculate on who was responsible for the blasts and insisted his nation's ties to Venezuela were "excellent".

Colombian Interior Minister Fernando Londoño accused Venezuela last week of refusing to condemn the Revolutionary Armed Forces of Colombia and National Liberation Army as terrorists for a series of bombings.

Colombian President Alvaro Uribe disavowed Londoño's remarks, saying he alone spoke for Colombia. But Uribe and Spain's government urged Chavez to respect the rule of law after a Venezuelan opposition leader was arrested last week.

ARE LESS DEADLY THAN SCARY  
FACTUAL INSTRUCTIONS ABOUT WHAT TO DO  
DURING ATTACKS

The object of terrorism is panic, more so than actual injury.

Since the media has decided to scare everyone with predictions of chemical, biological, or nuclear warfare on our turf, I decided to write a paper and keep things in their proper perspective. I am a retired military weapons, munitions, and training expert.

Lesson number one: In the mid 1990s there were a series of nerve gas attacks on crowded Japanese subway stations. Given perfect conditions for an attack, less than 10% of the people there were injured (the injured were better in a few hours) and only one percent of the injured died. *60 Minutes* once had a fellow telling us that one drop of nerve gas could kill a thousand people. Well, he didn't tell you the thousand dead people per drop was theoretical.

Drill Sergeants exaggerate how terrible this stuff was to keep the recruits awake in class (I know this because I was a Drill Sergeant, too). Forget everything you've ever seen on TV, in the movies, or read in a novel about this stuff, it was all a lie (read this sentence again out loud!). These weapons are about terror. If you remain calm, you will probably not die. This is far less scary than the media and their "experts" make it sound.

CHEMICAL WEAPONS are categorized as NERVE, BLOOD, BLISTER, and INCAPACITATING AGENTS.

Contrary to the hype of reporters and politicians, they are not weapons of mass destruction. They are "area denial" and terror weapons that don't destroy anything. When you leave the area, you almost always leave the risk. That's the difference; you can leave the area and the risk; soldiers may have to stay put and sit through it and that's why they need all that spiffy gear.

These are not gasses, they are vapors and/or airborne particles. The agent must be delivered in sufficient quantity to injure, and that defines when/how it's used. Every day we have a morning and evening inversion where "stuff" suspended in the air gets pushed down. This inversion is why allergies (pollen) and air pollution are worst at these times of the day.

So, a chemical attack will have its best effect an hour or so either side of sunrise/sunset. Also, being vapors and airborne particles, they are heavier than air so they will seek low places like ditches, basements and underground garages. This stuff won't work when it's freezing, it doesn't last when it's hot, and wind spreads it too thin too fast.

They've got to get this stuff on you, or, get you to inhale it for it to work. They also have to get the concentration of chemicals high enough to kill or wound you. Too little and it's nothing, too much and it's wasted.

What I hope you've gathered by this point is that a chemical weapons attack that kills a lot of people is incredibly hard to do with military-grade agents and equipment, so you can imagine how hard it will be for terrorists. The more you know about this stuff the more you realize how hard it is to use.

We'll start by talking about NERVE agents. You have these in your house. Plain old bug killer (like Raid) is nerve agent. All nerve agents work the same way. They are cholinesterase inhibitors that mess up the signals your nervous system uses to make your body function. It can harm you if you get it on your skin, but it works best if they can get you to inhale it. If you don't die in the first minute and you can leave the area, you're probably gonna live.

The military's antidote for all nerve agents is atropine and pralidoxime chloride. Neither one of these does anything to cure the nerve agent. They send your body into overdrive to keep you alive for five minutes. After that the agent is used up. Your best protection is fresh air and staying calm.

Listed here are the symptoms for nerve agent poisoning: Sudden headache, Dimness of vision (someone you're looking at will have pinpointed pupils), Runny nose, Excessive saliva or drooling, Difficulty breathing, Tightness in chest, Nausea, Stomach cramps, Twitching of exposed skin where a liquid just got on you.

If you are in public and you start experiencing these symptoms, first ask yourself, did anything out of the ordinary just happen—a loud pop, did someone spray something on the crowd? Are other people getting sick, too? Is there an odor of new mown hay, green corn, something fruity, or camphor where it shouldn't be?

If the answer is yes, then calmly (if you panic you breathe faster and inhale more air/poison) leave the area and head up wind, or, outside. Fresh air is the best "right now antidote". If you have a blob of liquid that looks like molasses or Karo syrup on you, blot it or scrape it off and away from yourself with anything disposable. This stuff works based on your body weight. What a crop duster uses to kill bugs won't hurt you unless you stand there and breathe it in real deep, then lick the residue off the ground for while.

Remember, they have to do all the work, they have to get the concentration up and keep it up for several minutes while all you have to do is quit getting it on you/quit breathing it by putting space between you and the attack.

BLOOD agents are cyanide or arsine, which effect your blood's ability to provide oxygen to your tissue. The scenario for attack would be the same as nerve agent. Look for a pop or someone splashing/spraying something and folks around there getting woozy/falling down. The telltale smells are bitter almonds or garlic where it shouldn't be. The symptoms are blue lips, blue under the fingernails, rapid breathing. The military antidote is amyl nitride, and just like nerve agent antidote, it just keeps your body working for five minutes till the toxins are used up. Fresh air is your best individual chance.

BLISTER agents (distilled mustard) are so nasty that nobody wants to even handle it, let alone use it. It's almost impossible to handle safely and may have delayed effect of up to 12 hours. The attack scenario is also limited to the things you'd see from other chemicals. If you do get large, painful blisters for no apparent reason, don't pop them. If you must, don't let the liquid from the blister get on any other area. The stuff just keeps on spreading. It's just as likely to harm the user as the target. Soap, water, sunshine, and fresh air are this stuff's enemy.

Bottom line on chemical weapons (it's the same if they use industrial chemical spills), they are intended to make you panic, to terrorize you, to herd you like sheep to the wolves. If there is an attack, leave the area and go upwind, or to the sides of the wind stream. They have to get the stuff to you, and on you. You're more likely to be hurt by a drunk driver on any given day than be hurt by one of these attacks. Your odds get better if you leave the area. Soap, water, time, and fresh air really deal this stuff a knock-out-punch. Don't let fear of an isolated attack rule your life. The odds are really on your side.

NUCLEAR BOMBS are the only weapons of mass destruction on Earth. The effects of a nuclear bomb are heat, blast, EMP, and radiation. If you see a bright flash of light like the Sun where the Sun isn't, fall to the ground! The heat will be over in a second. Then there will be two blast waves, one out going, and one on its way back. Don't stand up to see what happened after the first wave; anything that's going to happen will have happened in two full minutes.

These will be low-yield devices and will not level whole cities. If you live through the heat, blast, and initial burst of radiation, you'll probably live for a very, very long time. Radiation will not create fifty-foot tall women, or giant ants and grasshoppers the size of tanks. These will be at the most 1-kiloton bombs; that's the equivalent of 1,000 tons of TNT.

Here's the real deal. Flying debris and radiation will kill a lot of exposed (not all!) people within a half mile of the blast. Under perfect conditions this is about a half-mile circle of death and destruction, but, when it's done it's done.

EMP stands for Electro Magnetic Pulse, and it will fry every electronic device for a good distance. It's impossible to say what and how far, but probably not over a couple of miles from ground zero is a good guess. Cars, cell phones, computers, ATMs, you name it, all will be out of order.

There are lots of kinds of radiation. You only need to worry about three. The others you have lived with for years. You need to worry about "Ionizing radiation". These are little sub-atomic particles that go whizzing along at the speed of light. They hit individual cells in your body, kill the nucleus and keep on going. That's how you get radiation poisoning. You have so many dead cells in your body that the decaying cells poison you. It's the same as people getting radiation treatments for cancer, only a bigger area gets radiated.

The good news is that you don't have to just sit there and take it, and there's lots you can do rather than panic. First, your skin will stop alpha particles. A page

of a newspaper or your clothing will stop beta particles. You just gotta try and avoid inhaling dust that's contaminated with atoms that are emitting these things and you'll be generally safe from them.

Gamma rays are particles that travel like rays (quantum physics makes my brain hurt) and they create the same damage as alpha and beta particles—only they keep going and kill lots of cells as they go all the way through your body. It takes a lot to stop these things, lots of dense material. On the other hand, it takes a lot of this to kill you.

Your defense is as always to not panic. Basic hygiene and normal preparation are your friends. All canned or frozen food is safe to eat. The radiation poisoning will not effect plants, so fruits and vegetables are OK if there's no dust on them (rinse them off if there is). If you don't have running water and you need to collect rainwater or use water from wherever, just let it sit for thirty minutes and skim off the water gently from the top. The dust with the bad stuff in it will settle and the remaining water can be used for the toilet, which will still work if you have a bucket of water to pour in the tank.

Finally there's BIOLOGICAL WARFARE. There's not much to cover here. Basic personal hygiene and sanitation will take you further than a million doctors. Wash your hands often, don't share drinks, food, sloppy kisses, etc., with strangers. Keep your garbage can with a tight lid on it. Don't have standing water (like old buckets, ditches, or kiddie pools) laying around to allow mosquitoes breeding room. This stuff is carried by vectors, that is: bugs, rodents, and contaminated material.


If biological warfare is as easy as the TV makes it sound, why has Saddam Hussein spent twenty years, millions, and millions of dollars trying to get it right? If you're clean of person and home, you eat well and are active, you're gonna live.

Overall preparation for any terrorist attack is the same as you'd take for a big storm. If you want a gas mask, fine, go get one. I know this stuff and I'm not getting one and I told my Mom not to bother with one either (how's that for confidence). We have a week's worth of cash, several days worth of canned goods, and plenty of soap and water. We don't leave stuff out to attract bugs or rodents so we don't have them.

These people can't conceive a nation this big with this much resources. These weapons are made to cause panic, terror, and to demoralize. If we don't run around like sheep, they won't use this stuff after they find out it's no fun. The government is going nuts over this stuff because they have to protect every inch of America. You've only gotta protect yourself, and by doing that, you help the country.

Finally, there are millions of caveats to everything I wrote here and you can think up specific scenarios where my advice isn't the best. This letter is supposed to help the greatest number of people under the greatest number of situations. If you don't like my work, don't nit-pick, just sit down and explain chemical, nuclear, and biological warfare in a document around three pages long yourself. This is how we the people of the United States can rob these people of their most desired goal, your terror.—SFC Red Thomas (Ret.), Armor Master Gunner, Mesa, Arizona

# Respect Your Corporation And Others Will Have To

**Budget's "Tip of the Week" #14:**

**Maintaining Separation Between the Corporation and Yourself**

When properly handled, a corporation is a legal "person", separate, distinct and totally apart from you. The key to keeping things that way is to ensure that the corporation is indeed properly treated. The quickest way to lose the protection afforded by your corporate shelter is for you to treat it with disrespect.

One simple thing that many people fail to do on a regular basis—and which can tear down the walls of separation between themselves and a corporation—occurs when they sign documents in behalf of their "brainless child" (corporation). All it takes to do things right is to follow the signature with an indication that you are acting as an agent or officer of the corporation rather than in a personal capacity. If you are acting as a particular officer, as the vice president, for example—follow your signature with, "Vice President" or "VP". In cases where you would rather not disclose any particular position held within the corporation you may sign as "John Doe, Agent", which simply means that you are acting as an agent for the corporation and NOT in a personal capacity.

The above advice applies to ALL situations where you might sign for the corporation, including checks, of course, but also when signing such mundane things as invoices for goods received or services performed. And it certainly applies to any kind of agreement—a lease, purchase or rental agreement, for instance—as well as corporate resolutions. After a while you will find that you do this automatically and thus automatically uphold the fundamental protective insulation of your separateness from the corporate entity.

Failure to adhere to this basic corporate formality "could" allow a prospective litigant to assert that the corporation is nothing more than a "straw man" and that it actually functions only as your "alter ego". We have put the word "could" in parentheses because in Nevada there actually exists only one case in the last quarter-century where a prospective litigant managed to "pierce the corporate veil" and cause liability to be assessed against the corporation's owner/manager—and that was a case of outright and unabashed fraud. It's great to have that measure of protection but you can easily bolster it by developing the good habit of following your signature with a title.

The next essential step in maintaining separation between the corporation and yourself is to always document key decisions made for the corporation in the form of corporate resolutions. If you do not know how to construct a resolution, give us a call and we will be pleased to help out. Menawhile, if all you do is put a simple memo into the "resolutions" section of your corporate records, you will have taken a MAJOR step toward maintaining your Nevada corporation's unequaled liability protection.

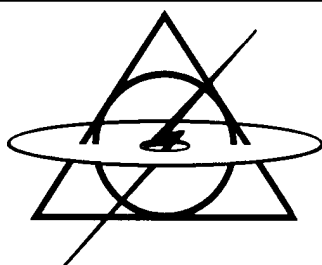
