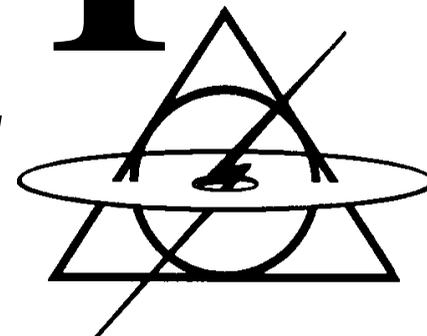

will hold its ionization strength. We will first feed our Gaiandriana with a bit of the mixture. One of the most interesting topics in historical discussion in both Philippine history of important events is, for instance and example, the Plaza Miranda bombing (August 21, 1971). while the other party involved, i.e., the U.S., was able then to actually kidnap Marcos and whisk him away by air and directly to U.S. territory in Hawaii. These plots and fancies run all the way directly to such as the Club of Rome. Even the asset of Global Alliance is steeped in clandestine manipulations by those Elite still in power.

I won't bother to discuss the actual Plaza Miranda bombing because Erick lays out the tale very well in his book and therefore we will just move right on to the next segment.

PLAZA MIRANDA: TRUTHS & MYTHS
WHO IS REALLY BEHIND THE BOMBING?

In February 1971, Communist Party of the Philippines (CPP) Chairperson Jose Ma Sison, together with three trusted comrades from the Central Committee, presented a plan to disrupt a Liberal Party (LP) rally at Plaza Miranda. Sison's strategy was no original. The mechanics of the plan revealed its source model: It was a variation of conspiracies designed by known minions of globalism. In Cambodia, for example, Pol Pot's genocidal plans which transformed the Khmer countryside into killing fields were drawn up in the United States by "a research foundation of the Club of Rome". (*Committee of 300*, p. 235)

"By forcing Marcos to be tyrannical, we could in fact push the Left as well as the numerous moderate forces over to the side of the revolution. If the moderates were pushed over to our side, that would solve our problem of manpower to match the thousands of firearms coming from China," Sison explained. The group then commissioned Danilo Cordero to carry out the now infamous Plaza Miranda Bombing Operation. **[H: These types of incidents are still taking place to this very day and not even the names are changed.]**

Several minutes after nine o'clock in the evening of August 21, 1971, two grenades exploded in succession at the stage where the LP's *Miting de Avance*, attended by top party leaders, was being held. The explosion, which shocked the entire nation, decimated the party's hierarchy. Only one top LP honcho survived unscathed—Ninoy Aquino, who was not around when all hell broke loose.

"Blood flowed from Senators Salonga (who lost part of his fingers and was hit in the eye and body by shrapnel), Roxas, Kalaw and Magsaysay, Rep. John H. Osmena, Councilors Martin Isidro (vice-mayorality candidate), Mel Lopez and Pablo Lorenzo. Mrs. Rosario Villacorta's leg was fractured," reads Eric Giron's glaring report for the *Mirror* magazine. *Manila Times* photographer Ben Roxas, severely wounded, was taken to the hospital where he died on arrival... The stage turned into an abattoir as nine persons were killed and 95 others were wounded." (*We Forum*, August 28-29, 1989)

After the bombing, President Marcos suspended the writ of *habeas corpus* and accused the Communists of perpetrating the heinous crime. The super-efficient intelligence apparatus of Marcos had been closely monitoring the activities of red agents long before the bombing occurred and had informed the strongman of Sison's destabilization moves. But Malacañang did not know when the plan would be put in effect. Marcos

succeeded in planting a deep penetration agent inside the camp of Senator Benigno Aquino, Jr., whose support for the CPP-NPA's undertakings in Central Luzon was an open secret. In fact, the same agent informed the government about the arrival of *MV Karagatan*, which was filled to the rafters with assorted Chinese-made war weapons. (Marcos did not know that the same agent, his DPA, had sold these arms to Ninoy and Joma Sison.)

As expected, the Communists denied the charges and pointed to Marcos as the "brain" behind the bombing. The CPP-NPA claimed that this was one of Marcos' ways of eliminating his political rivals.

Sison's propaganda ploy, together with religious liberation ideas exported to the Philippines by Latin American Jesuits, greatly helped the Left in its quantum leap. It is the same Liberation Theology which has wreaked havoc in El Salvador, Costa Rica and Honduras. Definitely, it is the same Liberation Theology which eventually toppled Marcos from the corridors of power.

A great number of unwitting Catholics and Protestants were organized and herded like cattle by Marxist churchmen operating under the banner of Christians for National Liberation (CNL), Sison's religious front, to bring about the 1986 People Power Revolt.

The truth behind the bombing was to surface several years later. *Washington Post's* Greg Jones, author of *The Red Revolution* cleared Marcos of all the charges hurled against him by Sison and his fellow travelers: "While it is true that the bombing triggered a chain of events that led to the Marcos 1972 declaration of martial law, Marcos had nothing to do with the bombing of Plaza Miranda."

Ruben Guevarra, in the prologue of his book *The Story Behind the Plaza Miranda Bombing*, AGREES WITH Jones. The 1971 incident was indeed a Communist initiative which "marked the beginning of more than a decade of rapid growth for the Communist Party of the Philippines-New People's Army (CPP-NPA)." He writes:

"The bombing of the *Miting de Avance* of the Liberal Party at Plaza Miranda was only part of a larger conspiracy of the CPP-NPA in 1971. This step was aimed to achieve a quantum leap in the so-called national democratic revolution it was launching...

"The grand plan... was comprised of four inter-related major steps: the bombing of the *Miting de Avance*...or the sowing of a bloody intrigue within the ranks of the ruling class; the show of force of the CPP-NPA; the sending of the official delegation of the CPP's Central Committee to the Chinese Communist Party; and the planned smuggling of high-powered automatic rifles, heavy weapons, ammunition and communications into the country.

"The bloody intrigue within the ranks of the ruling class was undertaken to worsen the factional fight between the Liberal Party and the Nacionalista Party; weaken the class rule of these political parties in order to create the most favorable condition for the rapid advancement of the revolutionary movement; propel the ruling class to undertake drastic actions against the revolutionaries and radical mass organization in order to increase the size of the revolutionary movement; give substance to the issue of fascism against the government; and rationalize the correctness of necessity of the armed struggle. These developments would further heighten the political condition and create a revolutionary situation."

Sison accused Jones of being a "clever intelligence and psywar expert of the Central Intelligence Agency." (*Manila Chronicle*, August 6, 1989). But Jones stood his ground. He showed proofs that four members of the CPP's Central Committee acknowledged that the bombing was indeed the handiwork of operatives acting on Sison's orders.

On August 23, 1989, the *Philippine Daily Inquirer* published a press statement issued by the NPA's Northern Luzon Command regarding the exposé of former comrades-in-arms Ariel Almendral, Victor Corpus, Ruben Guevarra, and Pablo Araneta. Part of the communiqué reads:

"Who are Almendral, Corpus, Araneta, Guevarra, and other traitors of the revolution? Who are being vaunted as witnesses as to the role of the CPP-NPA in the Plaza Miranda bombing? Answer: They are the ones on the payroll of the U.S.-Aquino Regime."

The CPP's ploy to damage the credibility of the "Gang of Four" who spilled the beans regarding the Plaza Miranda bombing proved ineffective. In Isabela, the military court conducted the trial of Cordero for allegedly betraying the secrets of the Plaza Miranda operation.

Ruben Guevarra (Ka Peter) headed the court that tried Cordero (Ka Cris). He, therefore, was in the best position to testify regarding Cordero's trial. During his litigation, Cordero admitted in the presence of about 30 party cadres and members that he was "given orders by the highest leader of the CPP to hurl grenades at the *Miting de Avance* of the Liberal Party".

Pablo Araneta (Ka Dino), then a political officer of a squad under the Northern Isabela platoon, was one of those undergoing trial at the same military court. He, too, was privy to all the proceedings.

Victor Corpus, erstwhile NPA trainer, also claims that he knew of the bombing plan. The details are expounded in his book *Silent War* but the spokesman of the CPP Reformist Underground Cell issued a signed press statement published by the *Manila Chronicle*. It contained additional information regarding the people behind the bombing. According to Ricarte, Ninoy Aquino, secretary-general of the Liberal Party, knew of Sison's plan to bomb Plaza Miranda. Ricarte named a certain Ruben Tuazon as the man who informed Senator Aquino.

Guevarra identified Tuazon as "one of two old-farmer cadres from Tarlac whom Commander Dante (Bernabe Buscayno) recommended for inclusion into the Central Committee membership during the First Plenum of the CPP-CC held February to March 1989."

"The attempt to implicate former Senator Aquino in the Plaza Miranda bombing is an attempt that has a basis in varied and several circumstantial evidences that may be further validated and corroborated by new results of research and investigations, analysis of facts, and testimonies by directly involved personalities," says Guevarra.

Inquirer's editor-in-chief, Letty J. Magsanoc, counters with her own version of the story. According to her, Ninoy's cousin, Dr. Agapito de Castro (an E.E.N.T. specialist), advised Ninoy to stay away from Plaza Miranda because he was suffering from laryngitis and had a low-grade fever. "He was coughing. I examined his throat. It was infected. I told him to rest his voice because he could develop complications," de Castro diagnosed. (*Inquirer*, September 6, 1989)

In the end, however, Aquino's laryngitis was

Whatever community is, we yearn for it anywhere and somehow. One definition of community is: “It’s a space, or place, where you work with people you don’t necessarily like or always agree with, to make *IT* better.” Hoary as the advice may seem, it’s never too late to try nonviolence, cooperation, compassion for all beings, lives outwardly simple and inwardly rich. In community we may find our myriad ways out of chaos.

The ways and means, the art of community, has been defined in the last decades. Many practically tested souls are eager to share their knowledge and a lively sense of renewed possibility. Great hopes occupy real ground in these small groups. Conflict, rightly joined, can bring clarity, not carnage.

Where community life is dissolved and the only remaining sense of social identity is with vast societies, such as great nations, serious-minded young people who wish to be socially effective often measure their small powers against national or world movements and develop a feeling of frustration and futility. On the other hand, where there are members of small communities, they have opportunities to deal with problems within their grasp. They can be realists and can be effective within the community and so can have a feeling of validity denied them when their primary relations are to vast social aggregations.

Our society is now pioneering new forms of community, more innovative and diverse than either traditional neighborhoods and small-town communities or the idealistic communities of the sixties and seventies.

As one author put it, "...a grander and more dynamic whole emerges when a group of people participate in common practices, depend upon one another, make decisions together, identify themselves as part of something larger than the sum of their individual relationships and commit themselves for the long term to their own, one another's and the group's well-being."

Floods, earthquakes, volcanoes, wildfires, tornados, hurricanes—*acts of God* to courts of Law and insurance underwriters—can devastate communities (and whole nations). They can also inspire the highest levels of human cooperation, courage and selflessness. Particular disasters often strike with little warning, but the fact of disaster somewhere, some time, is assured. Readiness is all.

Restoration, like any art, seeks a greater understanding of existence, which tends to deepen our appreciation, gratitude and humility; salubrious states of mind that are less fringe benefits than compelling requisites for further work. Moreover, the art of restoration is finely balanced between mind and body, thought and sweat. The work is heads-up and hands-on: figuring out by guess, gut, experience and calculation what will be needed. We've made a mess of creation—and now we need to clean it up.

Shared purpose is the only reason for having a community. Shared purpose is important before anything else (except God). This purpose must be strong, and shared truly from deep within. This purpose must be able to survive difficult times, times of doubt, times of careful examination. Shared purpose is so important that we are compelled to express it as clearly as possible to each other and to know, not assume, agreement.

GAIA was formed based upon the concept of *giving and regiving*—and GAIA will be regiving generously to the Native Americans who have been so sorely treated for generations. The Native Americans will figure prominently, when substantially financially backed by GAIA, in the growth and development within the borders of the United States of America.

The New World Order has come a long way since the start of the present banking system, the creation of Freemasonry, the United States and the French Revolution.

Among the Native American people, the elders were listened to in a way that's hard to explain. In modern America, we learn to listen shallowly, enough to memorize facts, or to detect points we want to refute, or enough to make someone feel respected, as duty requires. So often we listen to the words but not the message. We hear the notes but not the music, see the lines but not the art. It is truly our loss that we cannot see anew through the eyes of another.

There are two kinds of listening that are essential in a community: listening to the voice of spirit; and listening to the voice of individual and collective need within the community. When community members learn to listen, both they and the community experience miraculous growth.

No one community can be all things to all people. Learning what we reasonably can and cannot do is essential and difficult.

Human apathy and naiveté are the greatest weapons of the Elite. Opening ourselves spiritually and realizing the full glory of Creation is wonderful. But if people float around in some spiritual mist, their feet dangling from the ceiling, they are copping out—and the complacency in so many areas of spiritual movements is staggering in the light of world events.

Knowledge is never disempowering. But ignoring it is. What is more negative and disempowering than being manipulated every day towards a

global fascist dictatorship while having no idea that it is even happening? What is more negative than having thoughts placed into our minds which we believe to be our own? These precious people are having to live through their only savings having been taken from someone who has worked within their very household. Gosh, many of us have "BEEN THERE AND EXPERIENCED THAT!" That, however, does not make it any easier with which to cope. Somehow the betrayal by ones who have "fooled" you is more painful than any other kind of "hit".

I guess we, as much as anyone, needed the lessons on discerning "truth", for it certainly is very difficult to "just keep going". Sometimes, however, we just have to stop and wonder if any of this is "worth it".

One brother does, from time to time, work in a fish cannery but a load was dropped on him by a "loader" and he is incapacitated, without assistance.

Ludy is one of those lovely ladies you would be pleased to have in your family. She is extremely bright, compassionate, giving and gracious. When I really feel sorry for myself it helps to think about Ludy.

This is because we knew she was raising the child and we assumed it was simply that "Dad" had moved out or whatever—not wanting to pry. Not so, the drama is ever so much better than just that simple but sad tale.

There was a girl that came to the family place, pregnant. She already had a couple of illegitimate children off in another province being raised by family. She could not afford any kind of medical care and had no food and no place to stay and of course, had no idea who the father would be. Ludy took care of her, bought her meds and saw her through the birthing. Then wham, the girl took off—vanished into the night.

So, Ludy has a child—now without birth certificate or any resources to even get legal documentation.

This seemed to be the outstanding circumstances when we came along. The child, Celinda Joy (badly misspelled) was just barely three.

Years went by and we never knew otherwise or anything about the circumstance although we did meet the child a few times when Ludy had to bring her to work because there was no one to tend her.

Then one day, the sadness erupted. The mother had come back into the picture—pregnant again on a second child since Celine and having a bad case of rather terminal cancer. She didn't exactly want the child back but did want to see her. Ludy took her out to the province to meet and evaluate the circumstances. The visit was over a weekend and the mother sent the child back with Ludy. But, nobody had any funds to transfer papers or anything. Moreover, this is the "norm", not the unusual.

The child is beautiful! She is in school now and comes to visit us occasionally. My own heart wants to

tend the world so it is difficult—but nobody asks or expects anything and that is almost as sad as any part of this tale.

Ludy works at the Gilarmi but there are a few things required to have done in this place so Ludy comes about once a week. For instance, the building regulations require bug spraying, etc.

A job here is priceless and just with Ludy it takes a couple of hours on a Jeepney just to get here. There are no complaints and that in itself is sad indeed.

Families in this place are large—like 3 to 5 children is the norm and up to 8 is quite expected. Pregnancy is worn like a medal of honor of some kind and yet most of the husbands have no job at all. Makes "Mother's Day" a bit more meaningful—for the poor Mother.

Our own children often ask as they experience their own children: "How in the world did you do it?" Come to think of it, I don't know. We simply have to get our job done because anything lesser for these children is totally unacceptable from every aspect I can discern. I have to believe that when we get this done it will be far, far better than a part-time baby sitter unable to afford ourselves and much the less ability to be much in the line of grandparents.

Perhaps the hardest "storms" of a personal nature have hit and we have survived and certainly we have to look at our program as having come "the distance" in spite of all those big odds against it. Moreover, YOU have made it possible and therein lies the SECRET of keeping us on duty. We will not "just" stop—because of YOU. We have to make it work. The plan is laid, the asset PROVEN and the program should work, especially with the Royal Family as joint-venture partners.

ON BLOODIED GROUND
THE CHALLENGE: PEACE IN THE MIDDLE EAST

How can the U.S. plant the seeds of democratic government in a region so full of turmoil? As an occupying force, can the Americans succeed where so many others have failed?

The weaponry and technology that won the American war in Iraq will be of little use in the task that looms: winning the peace.

Orchestrating cooperation among Iraq’s many ethnic groups within a democratic framework will be formidable. But that task will be considerably more difficult if the U.S. fails to show Iraqis of all stripes that the American occupation of their country is not *deja vu* all over again.

It has been only a few weeks since the occupation began, but already Iraqis and other Arabs are likening it to Israel’s occupation of the Palestinians Palestinian territories.

Events last week in Fallujah, in which U.S. forces killed 15 Iraqis at least 17 Iraqis in two days of anti-American protests, brought the comparison into sharp focus. Iraqis claim that they were unarmed and the Americans shot first; U.S. soldiers claim that it was they who were fired upon.

Whatever sparked the confrontation, themes of occupation resonated: The side with greater firepower used it to lethal advantage while incurring no casualties. Afterward, the U.S. Central Command invoked American troops’ right to self-defense while expressing regret over “any innocent casualties if they did occur”. ...

The occupation parallels are compounded by the political fortunes of Saddam Hussein and Yasser Arafat, both of whom have experienced varying degrees of regime change. Moreover, under American aegis, new leaders for both peoples have emerged.

Without elections, the new Palestinian prime minister, Mahmoud Abbas, has joined Afghan President Hamid Karzai as a leader who bears the Bush administration’s stamp of approval. In Iraq, the similarly sanctioned Ahmed Chalabi awaits his turn.

Israel’s destruction of Palestinian Authority infrastructure in the West Bank last year is seen in some Arab quarters as a template for the looting of Iraqi ministries, hospitals, and the national museum and library that went unchecked by U.S. forces in Baghdad.

“Establishing the ‘temporary’ or ‘transitional’ Iraqi government will be more complicated and difficult than forming the Palestinian government,” Abd al-Wahab Badr Khan observed last week in the London-based Arab daily *al-Hayat*. “But the two governments face a similar situation: the necessity of starting from zero.”

For millions of Arabs and Muslims who consume locally produced, satellite-enabled media, televised images emanating from Iraq are virtual replays of those that occur in the West Bank and Gaza Strip.

“Israeli soldiers search citizens and treat them like criminals, and this is what the American forces are doing on the streets and at checkpoints,” Muhammad Salih wrote in the Egyptian newspaper *Al-Shaab* in mid-April.

However, we do not expect YOU to solve the problems in this particular matter because at upstart of solving the overall problem it begins with the family sorting the mess and a “wrongful” death.

It certainly seems God dumps all the lessons on top of one another so we learn how to better handle a similar circumstance when it rolls over us in a more meaningful way. We have not wasted even one bit of EXPERIENCE along these lines of experience being the best teacher around.

I’ll leave this now lest I get nostalgic and run the ink. On Mother’s Day I was given to recognize that distance is painful and yet in some ways easier to allow us to manage. I thought back to Paul, my son, now gone for about 18 years and remembered when he was a child he made me a Mother’s Day card decorated with string under foil and actually was a real work of art. The gem, however, was the message inside: “I don’t got a present because I don’t got any money—but I love you, Mom”. Funny what we treasure a lifetime later, isn’t it?

So, friends, I don’t got a present cause I don’t got any money—but I love you, and that’s the TRUTH.

Love and the best in wishes and deeds. And, may that best just get better and better. Old people in Manila need friends too and just to share a visit is appreciated here.—E-E 

“Bombardment and destruction of civilian targets in Palestine by Israel is being repeated in Iraq by the Americans.”

These events and images may be the stuff of ephemeral headlines in the United States, but their underlying message remains fixed for many in the Middle East. Just as the Palestinians have been occupied and slowly stripped of their only natural resource—land—so, too, are the Iraqis about to see control of their great oil resources pass to foreign hands.

U.S. pronouncements about liberating Iraqis and rebuilding their country are further cast in doubt by American inaction elsewhere. Despite the U.S. military presence in Afghanistan, there are scant signs of stability and rebuilding outside the capital city, Kabul, 18 months after the American war that ousted the Taliban.

Moreover, the Bush administration has done little in the past 2½ years to mediate the worst Israeli-Palestinian violence in the history of that conflict, which has claimed nearly 3,000 lives.

It remains to be seen if the administration is ready to put real teeth into the newly released “road map” for Middle East peace it authored with the UN, the European Union and Russia. Abbas accepted the document as immediately and simultaneously binding on the Palestinians and Israel; the Sharon government wants to negotiate many points and implement the plan in stages.

The international community’s role in postwar Iraq also is in question. Having rejected a wider international presence in postwar Afghanistan, the Bush administration now wants to limit the UN role in Iraq—keeping political and economic aspects of rebuilding the country, and even the search for weapons of mass destruction, an American province.

How Iraqis will react to a sustained American tenure in their country remains to be seen. During the first week of the war, Defense Secretary Donald Rumsfeld was asked at a news briefing whether he had miscalculated the desire of the Iraqi people to be liberated by an outside force—and whether out of nationalism they would continue to resist, even in the face of a U.S. military victory.

Rumsfeld said it was “self-evident” to him that “there is not an Iraqi people. There are Iraqi individual people,” he said, “and they’re going to be all across the spectrum.”

Even as an ad-libbed, unfortunate choice of words, Rumsfeld’s reply was nevertheless a statement of classic colonial mentality—and it was a clear echo of the infamous utterance by then-Israeli Prime Minister Golda Meir that “There is no such thing as a Palestinian people.”

Thousands of Palestinians, Israelis and Lebanese have perished over the last 36 years because of that mistaken notion. Writing last week in the Palestinian daily *Al-Quds*, Attallah Mansour compared the celebratory thinking among Israelis after their conquest of the West Bank and Gaza in 1967 to Americans touting their liberation of Iraqis today. He described as false in both cases “the illusion that freedom of movement and religion could compensate for the loss of national sovereignty and the right of self-determination.”

If the U.S. restores Iraqi sovereignty within an acceptably brief transition period and returns control of the country and its resources to its people, then the number of U.S. casualties incurred thus far may remain low—and the United States may win some much-needed goodwill in the region.

But if Iraqis see U.S. troops dug in on their soil while their oil flows out for an indefinite period—and more Fallujahs—then the story is likely to be quite different. U.S. soldiers may encounter in the land of the Tigris and Euphrates the deadly resistance that those wearing American military uniforms have met in Beirut, Dhahran and the waters off the Yemeni coast. ...

**SHARON: NO RIGHT OF RETURN FOR ARABS
PALESTINIANS MUST DROP QUEST, HE SAYS**

JERUSALEM—Israeli Prime Minister Ariel Sharon threw a U.S.-backed peace plan into doubt Tuesday, saying the Palestinians must drop their demand for Arab refugees’ “right of return” to Israel if negotiations are to proceed.

Israel has always objected to the right of return for about 4 million Arabs who fled the war that followed Israel’s creation in 1948 but it has never before made renouncing the demand a condition for peace talks.

The new Mideast plan unveiled by Washington last week says the fate of the refugees will be negotiated in the third and final stage of the so-called road map. The right of return is a cornerstone of Palestinian policy.

But Sharon told Israel Radio that the renunciation by Palestinians “is something Israel insists on and sees it as a condition for continuing the process.” The interview marked Israel’s Independence Day celebrations.

Israeli officials said the renunciation would have to come before creation of a provisional Palestinian state in the second of the plan’s three phases.

Israel refuses to take the blame for the consequences of the two-year war after its creation, when Arab armies invaded the nascent Jewish state and about 700,000 Palestinians fled or were expelled from their homes.

Sharon called the right of return “a recipe for the destruction of Israel”, because it would flood Israel with Arabs. Palestinian Cabinet Minister Saeb Erekat said Sharon is stalling and trying to kill the plan.

“I think the endgame here of Mr. Sharon is trying to extend the time until the American election in order to avoid implementation of any the provisions of the road map,” Erekat said. ...

[JR: Sharon’s stall tactics will succeed in restraining a Road Map for an Israeli/Palestinian peace accord. Sharon is in effect rendering null and void any such future initiatives. How silly of us to think Sharon would give back one inch of the lands he has succeeded in confiscating for the past two years. **ANGER GROWS AFTER BAGHDAD ACADEMY LOOTED
U.S. HAD REPORTEDLY PROMISED SECURITY**

BAGHDAD—Early in the last century, the British placed their imperial stamp next to the 800-year-old Abbasid Palace along the Tigris River: an elegant government complex of graceful archways, long vaulted corridors, lush gardens and a fine view of the river.

Later the buildings would serve as Iraq’s first parliament building and King Faisal I’s offices.

After the monarchy was toppled in 1958, the offices were converted into courtrooms. In recent years, much of the complex was taken over by the Beit al-Hikma—House of Wisdom—a kind of academy for Iraq’s most distinguished academics.

On Friday it was looted in broad daylight, apparently under the noses of U.S. troops.

On Saturday, some members of Beit al-Hikma wept as they stood in the rubble of what once was their fine library.

The incident underscores the deepening resentment of many Baghdad residents toward their new American masters and their bewilderment at how an army that so easily swept aside the regime can have such difficulty in restoring some semblance of order to their society.

“You Americans haven’t declared martial law. You haven’t declared a curfew. You are the only power in Baghdad, yet you refuse to use that power. Why? Why?” demanded Shakir Al-Serrif, an engineering professor.

“We feel like the Americans have a plan to leave a civil war in Iraq,” another man said.

The parliament chamber and part of the Abbasid Palace were looted during the first spasm of violence after the fall of the regime of Saddam Hussein, but Beit al-Hikma had escaped unscathed.

Last Tuesday, Amal Shlash and other members of Beit al-Hikma said they met with several senior U.S. officials in Baghdad, including Jay Garner, the retired U.S. lieutenant general in charge of setting up an interim government.

“We told Gen. Garner and the others of the importance of this building. They promised to send security within 24 hours,” said Shlash, a senior economist at Beit al-Hikma.

The security never came.

Three days later, the looters did.

They arrived at 10 a.m. Friday, about 30 of them, armed with assault rifles and grenades.

“They told us to leave the building or they would throw the grenades at us,” said Salam Tuma, one of four maintenance workers attempting to guard the building. One of the maintenance workers had a pistol.

U.S. troops stationed at the nearby Defense Ministry building heard the commotion and came running. The looters scattered.

The troops stayed about 15 minutes and then left, according to Tuma.

At noon, the looters came back. This time there were more than 100 of them. No U.S. soldiers came to the rescue, and Tuma and the three other guards fled.

The looters finished their work quickly. They hauled out furniture, office equipment, carpets, plumbing fixtures and chandeliers. Anything they couldn’t carry they destroyed, including wall murals and three small presses.

Then they ransacked the library. As the distraught academics rummaged through the rubble Saturday morning, the anger and bitterness grew. ...

EVANGELICAL LEADERS:
'WE MUST TEMPER OUR SPEECH' ON ISLAM

WASHINGTON (AP)—In an unusual public rebuke, leading evangelical Christians condemned derogatory statements about Islam by Rev. Franklin Graham and others among their fellow religious conservatives. They also pledged to improve relations with Muslims.

The evangelicals meeting Wednesday said the derisive comments endanger Christian missionaries in the Muslim world, further strain interfaith relations, and feed the perception in the Mideast and beyond that the war on terrorism is a Christian crusade against Islam.

"We must temper our speech," said Rev. Ted Haggard, president of the National Association of Evangelicals, which represents more than 43,000 congregations and helped organize the meeting. "There has to be a way to do good works without raising alarms."

Paul Marshall, senior fellow at the Center for Religious Freedom, a human-rights group, said anti-Islam comments serve only to antagonize people. "Exactly what is to be achieved by that except boosting the ego of who said it?" he asked.

Graham was in San Diego on Wednesday for a mission led by his father, Rev. Billy Graham, and could not be reached for comment, said his spokesman **Jeremy Blume**.

Hodan Hassan, a spokeswoman for the Council on American-Islamic Relations, which is among Graham's strongest critics, said she was encouraged by Wednesday's meeting. About 50 representatives attended from evangelical churches, schools and mission groups.

"We can understand theological differences, but what's important is that the dialogue is one of respect, not demonization," Hassan said.

No Muslims participated in the event, although a local mosque director was invited.

Muslims were outraged when Franklin Graham called Islam "a very evil and wicked religion" after the Sept. 11 attacks and, last summer, when Rev. Jerry Vines, a former president of the Southern Baptist Convention, called the Prophet Muhammad "a demon-possessed pedophile".

Revs. Jerry Falwell and Pat Robertson also have criticized Islam.

Clive Calver, president of World Relief, the humanitarian relief arm of the evangelical association, said all of the statements have "placed lives and livelihoods at risk" overseas, where missionaries have become targets of Muslim extremists.

At one point in the meeting, Michael Cromartie, vice president of the Ethics and Public Policy Center, a Washington think tank, asked if anyone wanted to defend the comments made by Graham, Robertson and Falwell. No one did, though participants also avoided personally criticizing the religious leaders.

To repair the damage to relations with Muslims, the evangelical group and the Institute on Religion and Democracy, a conservative Christian organization, are drafting guidelines to begin interfaith dialogue with Islamic leaders. While Muslim leaders have been meeting

regularly with liberal Protestants, no such national dialogue has taken place with evangelical Christians.

Evangelicals at the meeting acknowledged they have an arduous task ahead to overcome grievances among members of both faiths.

Conservative Christians have been struggling to end abuse of minority Christians in Muslim countries, while Muslims resent Christian proselytizing in their communities.

Evangelicals also will not participate in interfaith talks that require them to play down their beliefs—a concession they believe liberal Christians have wrongly made to befriend Muslims. And for some conservative Christians, Islam has replaced communism as the "modern-day equivalent of the evil empire," said Rich Cizik, a spokesman for the National Association of Evangelicals.

Haggard suggested holding a meeting with Falwell, Robertson and other high-profile evangelicals to explain the damage their comments have caused.

"We've got to have an attitude of how can we serve, how can we help," said Calver. "Saying Islam is evil isn't going to help any of us."

BRIBERY ALLEGED IN KAZAKH OIL DEALS
CHARGES STRAIN TIES TO KEY ALLY
IN WAR ON TERROR

WASHINGTON—A little-noticed prosecution in a New York courtroom threatens to throw a harsh spotlight on a key U.S. partner in the war on terrorism and provide an unflattering view of the multibillion-dollar global oil industry.

The indictment last month of American businessman James Giffen alleges a vast corporate bribery scheme in which millions of dollars used to secure oil and gas rights in an authoritarian land were channeled through a maze of shell companies, foundations and Swiss bank accounts.

The bribes—at least \$78 million, according to prosecutors—went to two top officials in Kazakhstan, a former Soviet republic brimming with petroleum and a key ally in President Bush's war on terrorism, to secure rights for four U.S. oil companies: Mobil, Amoco, Texaco and Phillips Petroleum. The companies have since merged with others and their names have changed.

This is the largest and most significant case alleging the bribery of foreign officials by U.S. businessmen since the practice became a federal crime 26 years ago, according to experts. It also is deeply embarrassing to the strategically important Central Asian nation of Kazakhstan and has strained diplomatic relations with the United States.

The prosecution opens a window on the practices of the U.S. oil industry, which often does business in rough places thanks to the geographical and geological accidents of fossil fuel deposits.

Giffen, a private banker paid as a middleman in the deals, is accused of channeling bribes to the Kazakh leaders from his "success fees" or from escrow accounts filled by the oil companies. None of the oil companies has been charged; each has denied wrongdoing and said it is cooperating with investigators. ...

For the oil companies, the investigation at a minimum raises serious questions about the oversight they exercise when big deals overseas are on the line.

J. Bryan Williams, a former top Mobil executive who was the key negotiator on the largest contract under investigation, was indicted in a related case on charges he failed to pay taxes on a \$2 million kickback he allegedly received from Giffen. The kickback came from fees Mobil paid Giffen after Williams secured rights for the company to tap a sprawling Kazakh oil field, prosecutors say. ...

The biggest recipient of the bribes allegedly funneled by Giffen—at least \$51.7 million, including interest earned—is a man identified in court papers only as "KO-2" or "Kazakh Official No. 2". But separate court records in Switzerland show that the official is Kazakh President Nursultan Nazarbayev, who has been praised frequently by the Bush administration for his cooperation in the war on terrorism. ...

Although the bribes allegedly were paid from 1995 to 2000, the story began before the breakup of the Soviet Union in December 1991, when Kazakhstan, the largest Soviet republic after Russia, gained independence. ...

According to the Center for Strategic and International Studies, a Washington think tank, Giffen became an "indispensable adviser" to Nazarbayev after independence, serving as a "gatekeeper" for potential investors. ...

By the end of 1994, prosecutors say, Giffen won a deal from the Kazakh government allowing him to coordinate "numerous oil and gas transactions with foreign partners".

Giffen and Balgimbayev were eager to sell a piece of Kazakhstan's Tengiz oil field and quickly identified Mobil as a potential buyer, according to the indictment. Tengiz, along the shores of the Caspian Sea, holds an estimated 6 billion barrels of oil, 1 billion barrels of natural-gas liquids and 14 trillion cubic feet of gas. ...

Giffen is accused of siphoning \$22 million from the Tengiz deal alone and channeling it through a maze of accounts to Balgimbayev and Nazarbayev. ...

Still, Nazarbayev faces little possibility of being charged. The Foreign Corrupt Practices Act allows the U.S. to indict only those paying bribes, not foreign officials receiving them, said Lisa Landmeier, a Washington lawyer who is an expert on the statute.

In his country, Nazarbayev got a law passed granting himself and his family lifetime immunity from prosecution. ...

Sources familiar with the 3-year-old investigation say a prominent lawyer representing Kazakhstan, Reid Weingarten, sent a blunt letter to a top Justice Department official warning of the potential harm that prosecution could cause U.S.-Kazakh relations during the war on terrorism. Justice Department spokesman Bryan Sierra declined to discuss the letter, and Weingarten did not return numerous calls.

Although it is not as crucial as some of its Central Asian neighbors, there is little doubt that Nazarbayev's government has become more important to the U.S. since the Sept. 11, 2001, terrorist attacks and the U.S.-led assault on nearby Afghanistan.

Nazarbayev allowed one of his airports to be used as an alternative airfield for U.S. forces in Afghanistan and approved more than 800 overflights during the war. ...

Olcott, the Kazakhstan scholar, said Nazarbayev's diplomats have constantly pressed the U.S. to back off its investigation and

likely believed the “war on terror would make him more immune” from embarrassing disclosures in the case.

At home, the alleged efforts of Nazarbayev’s supporters to quell the embarrassment apparently have been more blunt. ...

[JR: The triad of world corruption is business, governments and shady deals accompanied with bribes. This cozy deal, with the big oil companies and the government in Kazakhstan, was made right after 9/11. ARMY BRASS ON NOTICE: RUMSFELD TAKING AIM

WASHINGTON—With the war in Iraq effectively over, Defense Secretary Donald Rumsfeld is shaking up the Army, believing its generals have not taken to heart his goal of creating a more lethal and mobile force for the 21st Century.

But the exit of the Army’s top leadership, with no replacements named yet, has left many top officers angry, defensive and deeply concerned.

Rumsfeld, who recently fired Army Secretary Thomas White, is pressing Gen. Tommy Franks, the victorious commander of U.S.-led forces in Iraq, to take the place of retiring Gen. Eric Shinseki as Army chief of staff. ...

The retirement of Shinseki, the Army’s top officer, takes effect June 11. Shinseki has tangled repeatedly with Pentagon officials, disagreeing on how many U.S. troops would be needed to maintain order in Iraq in the months ahead. Shinseki’s deputy, Gen. John Keane, also is retiring soon.

Rumsfeld dismissed White as Army secretary two weeks ago and on the same day chose Air Force Secretary James Roche to replace him. Roche’s nomination is awaiting President Bush’s approval, officials said.

Rumsfeld praises the management skills of Roche, a former executive with **Northrop Grumman Corp.**, officials said. He wants Roche to get busy converting the heavily armored, Cold War-style Army into a leaner, more responsive force. **[JR: Roche will be a nice contact for Northrup to gain government contracts for all those planned future wars.]**

Some Army officials say their branch has been transforming for the 21st Century and wonder whether they find themselves at the forefront of Rumsfeld’s ire largely for personal reasons, pointing to a number of acrimonious disputes. ...

Some Army officers say the self-effacing Shinseki has been too unwilling to trumpet his transformation efforts. They note the development of the Future Combat Systems, the centerpiece of the Army’s shift away from heavy tanks and artillery by 2010. The FCS

is a collection of integrated systems—from armored vehicles and sensors to drones and robotics—designed to help the Army dominate future battlefields. ...

GINGRICH ATTACKS POWELL’S POLICIES WHITE HOUSE SAYS NO DISCORD WITH STATE DEPARTMENT

WASHINGTON—Flush with victory in an Iraq war they had advocated for years, neoconservative Republicans took their long-standing complaints against Secretary of State Colin Powell public on Tuesday with a scathing critique by former House Speaker Newt Gingrich, who accused Powell’s State Department of sabotaging the foreign policies of President Bush.

In blunt words rarely heard in a capital that prefers its complaints aired “on background”, Gingrich, now an adviser to Defense Secretary Donald Rumsfeld, blamed the State Department for alienating American allies, endangering Israel’s security and backing Arab dictators.

“The last seven months have involved six months of diplomatic failure and one month of military success,” Gingrich said in a speech at the American Enterprise Institute, a conservative think tank that has been influential in the Bush administration. “... Now the State Department is back at work pursuing policies that will clearly throw away all the fruits of hard-won victory.”

The unusual public broadside laid bare growing ideological schisms within both the Republican Party and the administration over how assertively Washington should exercise its unrivaled military power around the world and how best to pursue the delicate project of rebuilding Iraq.

The divisions have been playing out during months of bitter backroom skirmishing between the Pentagon’s civilian leaders and the State Department’s diplomats over the direction of Bush’s foreign policy after the Sept. 11 attacks.

The Pentagon officials, strongly backed by Vice President Dick Cheney and inspired by the arguments of neoconservative strategists in and around the Bush administration, have generally favored robust, pre-emptive assertions of U.S. military power as the best way to ensure American security and oust dictatorships.

The State Department, by contrast, has pressed the need to assemble allies and seek multilateral cooperation in facing down international terrorist threats. Diplomats are also less confident about the ease of quickly transforming economically moribund autocracies into thriving capitalist democracies.

The conflict came to a head in the weeks leading up to Bush’s decision to invade Iraq when the State Department failed to win explicit United Nations Security Council endorsement for the war. Instead, Washington ended up estranged from longtime allies such as France, Germany and Turkey. ...

Administration officials quickly sought to publicly play down the impact of Gingrich’s comments. White House spokesman Ari Fleischer insisted there was no disagreement between the president and his secretary of state over the decision to take the Iraq issue to the UN. ...

But tensions are mounting between the Pentagon and the State Department over Iraq, Syria, North Korea and the Israeli-Palestinian dispute.

Rumsfeld and his deputies have attempted in recent weeks to keep control of Iraqi reconstruction by blocking participation of some State Department diplomats. The

Pentagon also airlifted its preferred candidate to lead a future Iraqi government, longtime exile leader Ahmed Chalabi, into Iraq over the vehement objections of State Department officials, who do not trust Chalabi.

Stymied in Iraq, the State Department countered by preparing to open negotiations with North Korea over its nuclear weapons programs, despite strong Pentagon skepticism. Powell also declared his intention to visit Syria in coming weeks, after Rumsfeld aired the administration’s concerns that Damascus had been aiding remnants of the collapsed Saddam Hussein regime and allowing former regime officials to escape across the border into Syria. ...

Gingrich was withering in his criticism of Powell’s travel plans.

“The concept of the American secretary of state going to Damascus to meet with a terrorist-supporting, secret-police-wielding dictator is ludicrous,” Gingrich said. “... This is a time for America to demand changes in Damascus before a visit is even considered.”

State Department spokesman Richard Boucher said Powell’s plan to visit Syria was entirely consistent with the president’s declaration Sunday that the Syrian government had appeared to heed Washington’s warnings to seal its border with Iraq.

“I don’t know why [Gingrich is] particularly looking in our direction if we’re implementing the president’s policy on Syria,” Boucher said.

Gingrich also assailed as “a clear disaster for American diplomacy” Powell’s approach to Middle East peace negotiations—particularly Powell’s willingness to invite Russia, the European Union and the United Nations to participate with Washington in a “Quartet” to jointly oversee the peace process. Israel and its strong backers in Congress and the neoconservative movement are deeply suspicious that Russia, the Europeans and the UN all favor the Palestinian cause at Israel’s expense.

Boucher replied that Bush had endorsed the Quartet’s “road map” for negotiations leading to the creation of an independent Palestinian state.

“How can we undermine the president’s position when the president’s position is the one that he describes: that we should work with the international community, we should work with the Quartet?” Boucher said.

Gingrich insisted that, despite his sharp comments, he was not calling on Powell to resign.

Powell did not respond to Gingrich’s speech Tuesday. He has been asked in interviews in recent months whether he was thinking of resigning. He has consistently denied any such intention.

CHAVEZ, URIBE VOW TO SECURE BORDER
TALKS ADDRESS SPILLOVER
FROM COLOMBIAN WAR

PUERTO ORDAZ, Venezuela (*Reuters*)—Colombian President Alvaro Uribe said Wednesday that Venezuela promised to help stop Colombian guerrillas and paramilitaries from carrying out cross-border raids from Venezuelan territory.

Uribe and his Venezuelan counterpart, Hugo Chavez, held talks in this southeast Venezuelan city to improve security along the nations' 1,270-mile border, where the violent spillover from Colombia's war has strained ties between the Andean neighbors.

Before Wednesday's meeting, both governments repeatedly had accused the other of not doing enough to counter the cross-border activities of Colombia's Marxist rebels and their rightist paramilitary foes.

"We are going to make every possible effort so that neither guerrillas nor paramilitaries will be able to penetrate that frontier," Uribe said at a news conference after several hours of talks with the Venezuelan leader.

Uribe, a conservative who has vowed to defeat the guerrilla enemies of his government, and Chavez, a leftist former paratrooper, had appeared to be uneasy neighbors.

But looking relaxed, they took pains Wednesday to stress that they wanted to improve relations and leave behind past recriminations over frontier security.

They also announced a series of cooperation projects, in areas such as energy, transportation, infrastructure and forestry, and an agreement for Venezuelan importers to pay about \$300 million owed to Colombian exporters. The payment has been blocked by tight currency controls in Venezuela.

Chavez said the governments had decided to deal with the sensitive border issue privately in the future and avoid what he called "microphone diplomacy". He described Wednesday's talks as "frank, warm and friendly".

In the weeks before the meeting, Uribe's government, the United States' closest ally in Latin America, repeatedly had accused Chavez, who is portrayed by critics as an anti-U.S. maverick, of providing a haven for Colombian Marxist rebels.

Bogota had been investigating complaints by border residents that Venezuelan military aircraft bombed a Colombian frontier hamlet March 21, killing and wounding several people. Local residents said the aircraft supported Colombian rebels who were fighting rightist paramilitary groups.

Chavez's government fiercely denied those charges. It had in turn accused Colombia's army of collaborating with the paramilitaries on the rugged frontier, a patchwork of mountain, jungle and savanna where killings and kidnappings are rife.

Uribe and Chavez stressed the importance of preserving their countries' traditionally strong trading links.

The proposed cooperation projects they mentioned included one to provide Venezuelan electricity to Colombia and another for a pipeline that would carry Colombian gas to refineries and power stations in Venezuela.

Other proposals focused on cross-border river transport and joint hydroelectric and forestry projects.

Both governments also signed an agreement to improve the treatment of refugees displaced by the war in Colombia.

The two leaders agreed to meet again July 22 in Medellin, Colombia, to review progress made in relations.

[JR: Colombia and Venezuela are demonstrating that two countries can resolve their differences without interference from the U.S. with its unfriendly Zionist powers of persuasion. President Chavez and President Uribe have succeeded in paving the way for

PROBE: BRITISH FORCES AIDED BELFAST SLAYINGS

BELFAST (AP)—Intelligence agents of the British army and police helped Protestant extremists kill Catholics in the late 1980s, a four-year official investigation concluded Thursday.

One of those killed was a lawyer known for defending Irish Republican Army suspects.

Sir John Stevens, commander of London's Metropolitan Police, said he documented widespread collusion in Belfast between the outlawed Ulster Defense Association and officers from the police Special Branch and the army's Force Research Unit.

Both units had agents within all of Northern Ireland's outlawed paramilitary groups in hopes of preventing some killings, Stevens said. But in what he called "a disaster" for the rule of law, they encouraged other attacks to go ahead.

Stevens' findings proved shocking and divisive as the British and Irish governments press for a breakthrough in Northern Ireland peacemaking.

But his report confirmed for many Catholics their long-held suspicions that law-enforcement agencies had directed Protestant killers. His 30-person team of detectives investigated suspected collusion in 26 murders, most of them in the late 1980s.

Stevens said moles within the UDA had been encouraged "to commit criminal acts and get involved in murders", among them the killing of attorney Pat Finucane.

The security forces' knowledge of plans to attack Finucane meant it "could have been prevented," Stevens said.

Finucane, 38, who had three brothers in the IRA and specialized in defending IRA members, was shot by two UDA gunmen as he sat down to dinner with his wife and children in February 1989.

He was the first lawyer slain in the 35-year conflict over this British territory that has claimed more than 3,600 lives.

UDA members "were given information and equipped with weapons and directed toward targets that the British government wanted out of the way," said Michael Finucane, one of the victim's sons.

Stevens, who has led three probes of collusion in Northern Ireland since 1989, told reporters that the collusion with terrorists "was systemic" in the late 1980s within the army's Force Research Unit.

Stevens' 20-page summary didn't name any collusion suspects.

DEAL CREATES ENERGY GIANT IN RUSSIA
MERGER MAY HALT INVASION BY WEST

MOSCOW—Two of Russia's biggest oil companies plan to merge, creating an energy giant with enough heft to compete with Western oil heavyweights.

The landmark acquisition of Sibneft by Russia's largest oil company, Yukos Oil Co., is easily Russia's biggest merger ever, establishing a \$35 billion firm with 18.4 billion barrels in oil reserves.

At a news conference Tuesday, executives for Yukos and Sibneft said the deal puts the new company, YukosSibneft Oil Co., on the same playing field with Western giants Exxon Mobil Corp. and BP PLC.

"The projects that we see in the near future are major and challenging projects," said Yukos Chief Executive Mikhail Khodorkovsky. "We need international diversification, we need to break into new, difficult regions such as eastern Siberia and the Far East. This requires a pooling and concentration of efforts."

Some analysts, however, said the deal may have been driven more by Yukos' desire to fend off another major invasion into the Russian oil market by major oil firms.

Earlier this year, BP spent \$6.75 billion on a 50-percent stake in a joint venture with the owners of Russian oil group TNK.

The deal marked the largest foreign investment in Russia since the Soviet collapse in 1991.

Sibneft, regarded as one of Russia's most well-run oil firms, was being eyed closely as an acquisition target by Western oil giants, analysts said.

"The idea was that Western oil companies were going to pay a premium for well-run Russian oil companies," said James Fenkner, chief strategist at Troika Dialog, a Moscow brokerage. "With this merger, [Sibneft] will be too big to swallow."

The deal brings together Russia's two fastest-growing oil producers.

As a single entity, the new company is expected to produce 2.3 million barrels daily and represent 29 percent of Russia's total crude output.

Yukos and Sibneft first began discussing a merger in 1998, but talks between Khodorkovsky and the deal's other engineer, carmaker tycoon Boris Berezovsky, ran aground five months later.

Under the terms of the deal, Khodorkovsky, 39, will become the company's chief executive, and Sibneft President Eugene Shvidler will serve as chairman.

How well two of Russia's most driven, high-profile executives work together under the same roof remains to be seen, Fenkner said.

"Both are guys who've run their own shops," he said. "I'm not saying they'll become serial divorcees, but they've stepped in this river once before."

The merger is expected to be completed by year's end.

Yukos will buy an initial 20 percent stake in Sibneft for \$3 billion. Later, Sibneft shareholders will swap their ownership for Yukos-Sibneft shares at a ratio of 0.36 percent of Yukos-Sibneft for every 1 percent of Sibneft.

If it succeeds, the merger could open the door for Yukos-Sibneft to grow even larger through acquisitions in Russia's regional oil markets, said Grigori Vygon, an analyst with the Moscow-based Institute for Financial Studies. That runs against the grain of Kremlin policy, Vygon said, but Russia's anti-monopoly laws are too weak to stop such acquisitions.

"The danger is that this deal will be followed by other mergers," Vygon said. "Sibneft and Yukos will buy other companies. And in Russia, where anti-monopoly laws are so inefficient, that can have very negative consequences." **[JR: Define what a monopoly is in Russia. The masters of the monopolist system were the Jewish oligarchs Berezovsky and his rival Gusinsky. Since Richard Perle of the Pentagon Advisory Council implied that "all previous**

deals between Russia and Iraq will be declared meaningless" then that would include Russia's claim to recover her \$12 billion oil investment with Saddam's regime. It would appear that the merger of the two oil giants came out of necessity...like survival. Khodorkovsky, the head of Yurkos and Shvidler of Sibneft are very astute as to the dealings of the U.S. and British oil cartels. Oil companies like Exxon, Mobil and British Petroleum are maneuvering to muscle out competitors like Russia, Saudi Arabia and yes, Venezuela. This deal was reported overseas several months ago but is just now being reported in our press. It was not a newsworthy item then but it has gotten the attention of the business world here. Does this put a crimp in the Bush family's own expansionist plans? Did the Russian moguls checkmate the Bushites?]

CHINA PIPELINE GIVEN THE GREEN LIGHT

MOSCOW (AP)—Prime Minister Mikhail Kasyanov said Tuesday that Russia has opted to build an oil pipeline to China and will leave open the possibility of constructing a pipeline to transport oil to Japan and beyond, local news agencies reported.

Kasyanov told reporters that at present there was enough oil available to fill a planned pipeline leading to the Chinese city of Daqing, with an estimated construction cost of some \$2.5 billion. However, it is unclear whether there was a sufficient amount to fill a further planned segment that would lead to the Russian port of Nakhodka, on the Sea of Japan, for transport to Japan, South Korea, China and the Pacific coast of the United States.

"The decision on building a pipeline to Nakhodka will be made when it is determined what amount of oil is needed to fill this pipeline," *Interfax* quoted Kasyanov as saying.

Both China and Japan have been vying for oil from around the Siberian town of Angarsk, and Moscow was to make a final decision after a series of national holidays in early May. In March, Kasyanov said the pipeline to Nakhodka would be built first, and a spur to China would be added later.

Last month, the president of Japan National Oil Corp., Yoshiro Kamata, said Tokyo was prepared to invest \$1 billion in the Far East if the Nakhodka pipeline were built, *Itar-Tass* reported from the Pacific port of Vladivostok. Kamata said Japan would fund construction of an oil sea terminal and refinery over four years, and that it was interested in participating in Siberian oil production consortia.

Interfax and *Itar-Tass* on Tuesday quoted an unnamed source in the Russian government as saying that Tokyo was prepared to provide a loan for construction of the Nakhodka pipeline, estimated to cost some \$5.2 billion, but only on condition of Russian government guarantees. The source said the condition was unacceptable.

The source also said that it was unclear whether Moscow would accept Japanese investment in the pipeline in any case, saying "the question is whether we need such foreign property," the news agencies reported.

Kasyanov also said that he would soon sign an order to develop a plan for building a pipeline from western Siberia to the Arctic port of Murmansk, *Itar-Tass* reported. The project has the strong backing of many of the country's biggest oil companies, which are interested in expanding export potential and have said they want to build the line by 2007.

[JR: Russia is making moves to play a prominent role in the Asian oil markets and could expand into other world markets. She is centrally located geographically between Europe and Asia and could easily expand into the European markets. Russia could bring a competitive balance into the oil markets where the Western powers have held that dominance for far too long. \$10 MILLION AWARD UPHELD IN ADL FEUD

A federal appeals court on Tuesday upheld a jury's \$10 million award to a former Evergreen couple denounced as anti-Semites by the Anti-Defamation League after their Jewish neighbors secretly recorded their telephone conversations.

The 2-1 ruling by a panel of the 10th U.S. Circuit Court of Appeals likely will be appealed by the ADL, which faces spending a fourth of its annual budget to pay the award to William and Dorothy "Dee" Quigley.

The ruling also increases the worries of other advocacy groups and lawyers who help them. The nationally publicized case drew three friend-of-the-court briefs in support of the ADL from other groups and lawyers, contending the danger of huge legal liabilities threatened their ability to work for good causes.

The Quigleys sued the ADL and the then-director of its Denver office, Saul Rosenthal, for defamation, violations of federal wiretap law and invasion of privacy.

The 10th Circuit panel threw out the invasion of privacy claims Tuesday, but left other claims and the jury's total damages award intact.

The Quigleys' attorney, Jay Horowitz, said the ruling may not end the legal dispute.

"The Quigleys have been involved in difficult and extraordinarily expensive litigation for the preceding 8½ years," he said. They are extremely gratified by the United States Court of Appeals decision.

"They are aware, however, that proceedings may continue. For that reason, they must restrict their comments, other than to say that they are committed to continue this battle as long as it takes, and to vindicate their name, their reputation and their rights of privacy."

Tom Kelley, attorney for the ADL and Rosenthal, said no final decision had been made about whether to appeal the ruling.

"We're disappointed that a majority of the panel did not agree with our position," Kelley said. "We will be studying the decision and analyzing it, and then making a decision on where we go from here."

"We feel that the dissent was very strong and well reasoned, and very likely will lead us to petition for rehearing by all of the active judges of the court," Kelley said.

Seeking a rehearing is the next step in the appeals process.

The Quigleys' Jewish neighbors, Mitchell and Candice Aronson, consulted the ADL in 1994 after overhearing the Quigleys' telephone remarks on their Radio Shack police scanner. They said they heard the Quigleys discuss a campaign to drive them from the neighborhood with Nazi scare tactics: tossing lampshades and soap on their lawn; putting pictures of Holocaust ovens on their house; dousing an Aronson child with flammable liquid.

The Aronsons were advised to record the conversations. Based on the recordings, they sued the Quigleys in federal court; Jefferson County prosecutors charged the Quigleys with hate crimes; and Rosenthal denounced the Quigleys as anti-Semites in a press conference.

The Quigleys got death threats and hate mail, including a box of dog feces. Their own Catholic priest denounced them from the pulpit.

Later, everyone found out that the recordings became illegal just five days after they began, when President Bill Clinton signed a new federal wiretap restriction into law.

The hate charges were dropped, and Jefferson County paid the Quigleys \$75,000 after prosecutors concluded Dee Quigley's remarks to a friend were only in jest. Two lawyers on the ADL's volunteer board, who had advised the Aronsons, paid the Quigleys \$350,000 to settle a lawsuit.

The Quigleys and Aronsons dropped their legal attacks on each other, and neither family paid the other anything. The Aronsons divorced. The Quigleys now live in another state.

For the 10th Circuit, Judge Mary Beck Briscoe of Kansas wrote the majority ruling in which Judge Bobby Baldock of New Mexico joined. Judge Harris Hartz of New Mexico dissented.

The case drew friend-of-the-court briefs in support of the ADL from a wide variety of advocacy organizations and lawyers interested in helping them, to whom they commonly refer people needing help.

Citing the danger of huge financial liability, the groups and the lawyers contended their ability to work for good causes was threatened unless the judges overturned the Quigley verdict.

[JR: You just know who is helping and assisting the ADL and are filing their briefs as "friends of the court". LEAKED DOCUMENT EXPOSES PRO-LOBBY'S MANIPULATION OF U.S. PUBLIC

The *Electronic Intifada* has obtained, and today publishes in full, a document prepared for pro-Israel activists by the public relations firm The Luntz Research Companies and The Israel Project. The document spells out the tactics that Israel and its U.S. advocates should use to maintain support for Israel and its hardline policies.

The document, entitled "Wexner Analysis: Israeli Communication Priorities 2003," counsels pro-Israel advocates to keep invoking the name of Saddam Hussein, and to stress that Israel "was always behind American efforts to rid the world of this ruthless dictator and liberate their people." Despite his solid support for Israel and Ariel Sharon, the document warns pro-Israel advocates not to compliment or praise President Bush. At the same time it acknowledges that Yasser Arafat has been a great asset to Israel because "he looks the part" of a "terrorist". The installation of Mahmoud Abbas as Palestinian prime minister, and potential replacement for Arafat, comes "at the wrong time", because he has the potential to improve the image of the Palestinians, and that could put the onus on Israel to return to negotiations. The document advises supporters of Israel to appear to affect a "balanced" tone, but admits that in arguing for Israel's policies, the illegal "settlements are our Achilles heel", for which there is no good defense.

The document was commissioned by the Wexner Foundation, a private foundation that funds, among other pro-Israel initiatives, "Birthright Israel", a program that pays for young American Jews to take free trips to Israel. The Israel Project is an initiative of pro-Israel organizations, political consultants and businesspeople. The Luntz Research Companies is a leading public relations and opinion research firm.

Here is some of the key advice the document provides to Israel and its advocates:

* "Iraq colors all. Saddam is your best defense, even if he is dead. The worldview [of] Americans is entirely dominated by developments in Iraq. This is a unique opportunity for Israelis to deliver a message of support and unity at a time of great international

anxiety and opposition from some of our European 'allies'. For a year— a SOLID YEAR—you should be invoking the name of Saddam Hussein and how Israel was always behind American efforts to rid the world of this ruthless dictator and liberate their people.”

* “The fact that Israel has remained relatively silent for the three months preceding the war and for the three weeks of the war was absolutely the correct strategy—and according to all the polling done, it worked. But as the military conflict comes to a close, it is now time for Israel to lay out its own ‘road map’ for the future which includes unqualified support for America and unqualified commitment to an ongoing war against terrorism.”

* “It DOES NOT HELP when you compliment President Bush. When you want to identify with and align yourself with America, just say it. Don’t use George Bush as a synonym for the United States. Even with the destruction of the Hussein regime and all the positive reactions from the Iraqi people, there still remains about 20% of America that opposes the Iraqi war, and they are overwhelmingly Democrat. That leaves about half the Democrats who support the war even if they don’t support George Bush. You antagonize the latter half unnecessarily every time you compliment the President. Don’t do it.”

* “‘SECURITY’ sells. Security has become the key fundamental principle for all Americans. Security is the context by which you should explain Israeli need for loan guarantees and military aid, as well as why Israel can’t just give up land. The settlements are our Achilles heel, and the best response (which is still quite weak) is the need for security that this buffer creates.”

NEVADA CORPORATIONS:

Built-In War Chest For NV Corporations

Budget's "Tip of the Week" #4:

NRS 78.752—Insurance and other financial arrangements against liability of directors, officers, employees and agents

In this very litigious society, anyone can sue anyone for almost any reason at any time. Corporations are not exempt from being sued but anyone suing a Nevada corporation could be surprised at just how resistant to attack Nevada corporate structures can be. (Important side note: To avail your Nevada corporation of the protection inherent in Nevada's statutes, you should always ensure that the other party to any contract agrees that the contract is made in Nevada and any disputes are to be resolved according to the laws of Nevada.)

Let's look at a provision of Nevada law that affords a Nevada-based C corporation amazing defensive capabilities: NRS 78.752, which was added in 1987. Here's how it begins (emphasis added):

1. A corporation may purchase and maintain insurance or make other financial arrangements on behalf of any person who is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise for any liability asserted against him and liability and expenses incurred by him... or arising out of his status as such, whether or not the corporation has the authority to indemnify him against such liability and expenses....

Paragraph 2 states that “other financial arrangements” may include the creation of a trust fund; the establishment of a program of self-insurance; the securing of its obligation of indemnification by granting a security interest or other lien on any assets of the corporation; and/or the establishment of a letter of credit, guaranty or surety. Specifically excluded from this protection are “...intentional misconduct, fraud or a knowing violation of law...”. In paragraph 4, we find that “In the absence of fraud... the decision of the board of directors... is conclusive...”.

Thus, when a Nevada corporation is sued and the litigant names as co-defendants any of the officers, directors, employees or agents of the corporation, the corporation is entitled by NRS 78.752 to set aside funds for the liability asserted. Since many suits “go for broke”, quite literally, a Nevada corporation can often set aside ALL of its assets so that they may be used to defend itself. At best, the attacker is likely to end up with a “mouthful of dirt”, as the Nevada corporation defends itself to its utmost.

Sometimes it is just as important what the statutes do NOT say. Next week, we'll examine some key provisions NOT included in Nevada's corporate statutes, which greatly enhance PRIVACY aspects.


