IRAQ QUERIES STIFLE PRESIDENT'S AGENDA IN AFRICA

PRETORIA, South Africa—President Bush came to Africa hoping to show that despite launching wars in Afghanistan and Iraq and talking tough to other nations, he understands America's superpower responsibilities to aid the world's sick and impoverished.

"I believe it's very important for the United States to not only show its muscle to the world but also its heart," Bush said before flying to Africa to tout his programs to fight AIDS and poverty and spur economic development.

But by Wednesday, the second day of his five-nation trip, the president was finding it difficult to talk about America's heart when his hosts and the media remained focused on its muscle.

In an appearance with South African President Thabo Mbeki, Bush sought to deflect questions about whether he exaggerated the threat from Iraq to justify an invasion that South Africa and much of the rest of the world opposed. ...

Administration officials joined Bush's defense, saying that information collected on Hussein's weapons programs was solid even though the White House admitted this week that at least one claim of illegal nuclear activity was based on forged documents and should not have been made.

"I don't think the fact that there's an instance where something was inaccurate ought to in any way paint a broad brush on the intelligence that we get and suggest that that's a pattern or something. It's not," said Defense Secretary Donald Rumsfeld. ...

He also made a point Wednesday of talking about alternative ways the U.S. could help in situations like Liberia, such as training troops from other nations to handle peacekeeping duties.

If questions about American might continue to overshadow Bush's humanitarian agenda, it could prove detrimental to the administration's foreign policy, analysts said. ...

Ahead of Bush's Africa trip, the president and his aides went to lengths to emphasize the humanitarian agenda as a top priority at the White House, which is often accused abroad of resorting too quickly to military force.

National Security Adviser Condoleezza Rice told reporters that "American power has always had two parts.

"It does try to make the world more secure, and we're trying to do that in a number of ways. But it also has always been committed to values and to trying to make the world better," Rice said.

"These initiatives, plus trade and the words that we use about values, are the core of reminding the world that America is a country that is also devoted to the betterment of people," Rice said.

Bush and Mbeki, an opponent of the Iraqi war, met privately Wednesday to discuss a variety of issues, including trade and the situation in Liberia. A senior administration official who was in the meeting said the two leaders avoided any discussion of Iraq. ...

**[JR: President Bush's African "visit" is a reflection of the two faces America wants to project to the world. One is grim and hostile and the other is smiling and benign. One starts wars at a whim and the other is an image of concern of those we'd like to retain as our needy allies. Bush is only the third President to visit Africa and so our so-called commitment for aid and assistance is short-lived and therefore fleeting.]**

WOLFOWITZ COMMITTEE INSTRUCTED WHITE HOUSE TO USE IRAQ/URANIUM REFERENCE IN BUSH'S SPEECH

WASHINGTON, D.C.—A Pentagon committee led by Paul Wolfowitz, the Deputy Secretary of Defense, advised President Bush to include a reference in his January State of the Union address about Iraq trying to purchase 500 tons of uranium from Niger to bolster the case for war in Iraq, despite the fact that the CIA warned Wolfowitz's committee that the information was unreliable, according to a CIA intelligence official and four members of the Senate's intelligence committee who have been investigating the issue.

The Senators and the CIA official said they could be forced out of government and brought up on criminal charges for leaking the information to this reporter and as a result requested anonymity. The Senators said they plan to question CIA Director George Tenet Wednesday morning in a closed-door hearing to find out whether Wolfowitz and members of a committee he headed misled Bush and if the President knew about the erroneous information prior to his State of the Union address. **[JR: A "closed-door hearing" means WE will never really know what was said at this meeting.]**

Spokespeople for Wolfowitz and Tenet vehemently denied the accusations. Dan Bartlett, the White House communications director, would not return repeated calls for comment.

The revelations by the CIA official and the senators, if true, would prove that Tenet, who last week said he erred by allowing the uranium reference to be included in the State of the Union address, took the blame for an intelligence failure that he was not responsible for. The lawmakers said it could also lead to a widespread probe of prewar intelligence.

**At issue is a secret committee set up in 2001 by Defense Secretary Donald Rumsfeld called the Office of Special Plans, which was headed by Wolfowitz, Abram Shulsky and Douglas Feith, Under Secretary of Defense for Policy.** This was set up to probe allegations links between Iraq and the terrorist organization al-Qaida and whether the country was stockpiling a cache of weapons of mass destruction. The Special Plans committee disbanded in March after the start of the war in Iraq. **[JR: Because their job of selling the war was accomplished.]**

**The committee's job, according to published reports, was to gather intelligence information on the Iraqi threat that the CIA and FBI could not uncover and present it to the White House to build a case for war in Iraq.** The committee relied heavily on information provided by Iraqi defector Ahmad Chalabi, who has provided the White House with reams of intelligence on Saddam Hussein's weapons programs that has been disputed. Chalabi heads the Iraqi National Congress, a group of Iraqi exiles who have pushed for regime change in Iraq.

The Office of Special Plans, according to the CIA official and the senators, routinely provided Bush, Rumsfeld, Vice President Dick Cheney and National Security Adviser Condoleezza Rice with questionable intelligence information on the Iraqi threat, much of which was included in various speeches by Bush and Cheney and some of which was called into question by the CIA.

became increasingly frustrated that the CIA could not find any evidence of Iraq's chemical, biological and nuclear weapons program, evidence that would have helped the White House build a solid case for war in Iraq.

In an article in the *New York Times* last October, the paper reported that Rumsfeld had ordered the Office of Special Plans "to search for information on Iraq's hostile intentions or links to terrorists" that might have been overlooked by the CIA.

The CIA official and the senators said that's when Wolfowitz and his committee instructed the White House to have Bush use the now disputed line about Iraq's attempts to purchase 500 tons of uranium from Niger in a speech the President was set to give in Cincinnati. But Tenet quickly intervened and informed Stephen Hadley, an aide to National Security Adviser Rice, that the information was unreliable.

Patrick Lang, a former director of Middle East analysis at the Defense Intelligence Agency, said in an interview with the *New Yorker* magazine in May that the Office of Special Plans "started picking out things that supported their thesis and stringing them into arguments that they could use with the President. **It's not intelligence. It's political propaganda.**"

Lang said the CIA and Office of Special Plans often clashed on the accuracy of intelligence information provided to the White House by Wolfowitz.

Investigative reporter Seymour Hersh, the author of a May *New Yorker* story on the Office of Special Plans, reported, "former CIA officers and analysts described the agency as increasingly demoralized. George knows he's being beaten up," one former officer said of George Tenet, the CIA director. "And his analysts are terrified. George used to protect his people, but he's been forced to do things *their way*." Because the CIA's analysts are now on the defensive, "they write reports justifying their intelligence rather than saying what's going on. **The Defense Department and the Office of the Vice-President write their own pieces, based on their own ideology. We collect so much stuff that you can find anything you want.**"

"They see themselves as outsiders," a former CIA expert who spent the past decade immersed in Iraqi-exile affairs said of the Special Plans people, told Hersh. He added, "There's a high degree of paranoia. They've convinced themselves that they're on the side of angels, and everybody else in the government is a fool."

By last fall, the White House had virtually dismissed all of the intelligence on Iraq provided by the CIA, which failed to find any evidence of Iraq's weapons programs, in favor of the more critical information provided to the Bush administration by the Office of Special Plans

Hersh reported that the Special Plans Office "developed a close working relationship with the (Iraqi National Congress), and this strengthened its position in disputes with the CIA and gave the Pentagon's pro-war leadership added leverage in its constant disputes with the State Department. Special Plans also became a conduit for intelligence reports from the I.N.C. to officials in the White House."

In a rare Pentagon briefing recently, Office of Special Plans co-director Douglas Feith, said the committee was not an "intelligence project" but rather a group of 18 people that looked at intelligence information from a different point of view.

Feith said when the group had new "thoughts" on intelligence information it was given; they shared it with CIA director Tenet.

"It was a matter of digesting other people's intelligence," Feith said of the main duties of his group. "Its job was to review this intelligence to help digest it for me and other policy makers, to help us develop Defense Department strategy for the war on terrorism."

#### HELPING AFRICA UP, OR HOLDING IT DOWN?

Americans generally agree that if giving someone a fish is good, teaching him how to catch fish is far better. We believe that self-reliance is preferable to dependency and work is better than welfare. But when it comes to the neediest continent on the planet, the main use we make of these principles is to shred them.

President Bush surprised everyone in this year's State of the Union address by proposing big increases in humanitarian aid to Africa, particularly to fight AIDS. This week, he became only the third U.S. president to visit Africa in the last 25 years. He asserts, "**It's in our interest to make Africa a prosperous place.**" [JR: In what century?]

Yet that interest goes only so far. As a result, he may find on his trip that African gratitude is surpassed by African resentment. Take Mali, for example. Though it got \$37 million in assistance from the United States in 2001, Mali's finance minister recently denounced us and other wealthy countries as "hypocrites".

The problem is that, as everyone knows by now, the surest remedy for poverty is trade, not aid. Countries that have learned to compete in world commerce have far outdistanced countries that are forced to rely on international handouts. But the trade policies of the U.S. and other industrialized countries have closed off the best escape route.

Africa, with 13 percent of the world's people, accounts for only 2 percent of global trade. Why? One reason is that it has been deprived of access to the most lucrative customers. As the international aid group Oxfam pointed out last year, "When developing countries export to rich country markets, they face tariff barriers that are four times higher than those encountered by rich countries."

This was supposed to change when the U.S. enacted the African Growth and Opportunity Act three years ago. The law, signed by President Clinton, allows duty-free imports from nations meeting certain conditions. It was intended to boost Africa's sales in the U.S., and to some extent, it has worked: Imports from countries covered by the new law rose to \$9 billion in 2002 from \$8.2 billion in 2001.

But that's a pretty unimpressive increase. The Washington Office on Africa says that 16 of the 38 eligible countries shipped nothing to the U.S. under the new rules, and only six have significantly increased their exports. Some 75 percent of what we buy from Africa consists of oil, platinum and diamonds. Yanking raw materials out of the ground doesn't exactly provide the foundation of an entrepreneurial economy and a thriving middle class.

For that, you need to give ordinary people the chance to do productive work and be rewarded for it. But the world trading system, of which the U.S. makes up a huge part, is rigged against Africans. We're more intent on protecting a few American producers than on helping the vast mass of the world's poor.

Cotton, for example, is a major crop in many African countries, where it can be grown much cheaper than in most places. But cotton prices have

plunged in the last decade—mainly because the U.S. and other countries pay our farmers to grow it. The more we subsidize cotton farmers, the more cotton there is on the world market, and the lower the price.

Our growers don't feel the pain so much because of all their federal aid—they each get an average of \$50,000 a year in subsidies. But African dirt farmers, who are poor to begin with, don't enjoy such protection. They get the full brunt of the artificially low prices. American cotton subsidies cost Africans some \$300 million annually. And \$300 million is real money to people accustomed to living on less than \$1 a day.

The African Growth and Opportunity Act has also turned out to be less than meets the eye. It was supposed to have a big impact on apparel and farm products, which generally faced high tariffs. But the effect has been modest, partly because hundreds of items were excluded, and partly because the law has onerous rules to qualify for open access to the U.S. market. A study by the International Monetary Fund found the benefits to Africa were only one-fifth what they would have been under a genuine free-trade regime.

Americans are not crazy about funding foreign aid, and Africans are not crazy about needing it. We'd all be better off if the people of Africa were able to provide for themselves. But it's hard to stand on your own two feet when you've been cut off at the knees.

**[JR: It is ironic that an IMF study says that Africa doesn't benefit in trade because the trade rules bar their products from the world markets. Duh! That is what they are supposed to do! It is the IMF policies that have prevented developing nations from growing or manufacturing their own products, to expand their economies, to create jobs and to gain their independence from the western powers. America pours its money into corrupt regimes that sustain our interests and hamper progress and suppress reforms. Africa and other developing nations would thrive if we just got out of their way and allow for their success to happen. Humanitarian we are not and Condoleezza Rice knows very well that our policies and "values" are not for the betterment of the poor of this world but for the elite classes she serves.]**

#### NATIONAL COUNCIL FALLING INTO PLACE

BAGHDAD—Members of Iraq's major political parties met with American officials Saturday to hammer out what they hoped were the final touches on a new Iraqi Governing Council, the first step toward broad democratic reforms, Iraqi political leaders said. ...

The Iraqis had hoped that within months after the fall of Saddam Hussein, the U.S.-led occupation force would create conditions for a provisional government to form. Those hopes were dashed last month, and the Iraqis are now settling for what civil administrator Paul Bremer calls a "governing council".

Iyad Alawi, head of the Iraqi National Accord, said Saturday that the Iraqis were pleasantly surprised by the American outline. Political leaders had been ready to reject the plan outright if there had not been enough authority for Iraqis to decide how the nation should move toward democracy, he said.

The continuing security problems in Baghdad are evidence of the desire for Iraqi-style authority, he said.

The governing council will have the authority "to arrest people, take them to court, make them face justice," said Alawi, whose group consists primarily of military and security officers who defected from Hussein's regime. ...

Under the proposed terms, the governing council would have extensive powers, although it would still be answerable to the U.S.-led coalition. Council members would take charge of military and financial reforms, choose ministers and draw up the constitution.

A day after the crucial meeting Thursday, Alawi said he suggested to the Americans that the council quickly set about putting together a small security force.

The biggest mistake the American team made in the first month, Alawi said, was dissolving the military and police forces. Instead, it should have selectively culled people from the ranks to protect the major cities in Iraq, he said. ...

**[JR: The Pentagon, namely Rumsfeld and WOLFowitz, blundered when they excluded Iraqi participation in post-war Iraq. #### IRAQI SCHOOL CURRICULA WITHOUT SADDAM

BAGHDAD—Iraqi education ministry has abolished the national education curriculum, any mention of the deposed president Saddam Hussein and the scholarships granted to those favored by Saddam; yet, religion curriculum has remained unchanged.

Supervisor of the ministry of education under occupation Dorthy Mazaika has underlined that following the collapse of Saddam's regime, the U.S. administration took over and approved a number of laws and procedures, known as "educational reforms".

The U.S. administration abolished all privileges granted to some families that supported the former regime, as the Iraqi leader had ordered to grant additional marks to any student, whose parents had obtained a medal of bravery or merits.

"The UN Security Council has approved Friday, June 27, 2003, to fund the program of revising and rewriting school curricula and amalgamating such process into oil-for-food program," Mazaika told *IslamOnline.net*.

Speaking to *IOL*, head of revision ad hoc committee Dr. Fouad Hussein said, "due to the exploitation of education curricula by Saddam's regime, the ministry has decided in collaboration with coalition authority and the UNSC to revise such curricula to be in conformity with today's education worldwide."

"A sum of \$97 million has been allocated by the UNSC to be at the disposal of the concerned committee, formed by Mrs. Mazaika under my chairmanship and the membership of 37 professors for revising all curricula. We will finish with this process before the end of this week," Hussein said.

**Hussein denied rumors that the new curricula had been prepared in the U.S. and that a committee of Iraqis living in the U.S. was responsible for drawing up such curricula.**

An extensive program for reconstruction of 6300 primary schools is expected to start in August in coordination between the ministry of education and the UNICEF.

"It has been a big challenge to fulfill such a mammoth task within such a record time. We have also managed to provide excellent atmosphere for examinations despite all surrounding circumstances," Mohammed El-kanany, a member of the revising committee, said.

A well-informed source with the ministry of education,

who refused to be named, told *IOL* that teachers who were supporting the former Iraqi regime could return to their jobs, provided that they "make audio-video pledge not to support Baath Party any longer" and "declare their repentance".

Some teachers, however, dismissed the demand as "blackmail and a derogatory means to make a living". ...

#### POWELL HINTS AT POOR RESPONSE TO U.S. PLEA FOR FOREIGN TROOP ASSISTANCE

WASHINGTON (AFP)—U.S. Secretary of States Colin Powell admitted on Thursday there was no certainty how many foreign troops were going to Iraq to help U.S. and British forces, in an indication that U.S. efforts to enlist international assistance in pacifying the country may have hit a snag. ...

The statement starkly contrasted with recent upbeat assessments by top Defence Department officials, who have insisted that foreign aid to battle-weary American soldiers was well on the way.

Undersecretary of Defense for Policy Douglas Feith told a think tank here on Monday that more than 45 nations had made offers of military support "for security and stability operations in Iraq".

He said 18 countries currently had military capabilities on the ground in the occupied nation, ranging from full combat divisions to field hospitals.

Britain and Poland have formally agreed to lead multinational divisions that will help the United States establish security in Iraq, and according to Feith, other countries are considering joining them. "And still other countries have indicated their willingness to participate in peacekeeping, in some cases by contributing units from their national police forces, such as Italy's 'carabinieri'", the defense under secretary boasted in a speech before the Center for Strategic and International Studies. ...

"The guts of the work will still have to be done by the United States, Great Britain and the original members of the coalition," conceded the secretary of state.

The discordant notes came as the number of U.S. soldiers killed in hostile action in Iraq since May 1, when Bush declared an end to major combat operations, reached 31, and calls for foreign help in the U.S. Congress were brought to a fever pitch.

Earlier Thursday, the U.S. Senate unanimously passed an amendment to a foreign aid bill containing an appeal to the White House to "formally and expeditiously" consider requesting a NATO peacekeeping force for Iraq. ...

It said India, Pakistan and Portugal, which the Pentagon had hoped would deliver between 25,000 and 30,000 soldiers, were now insisting that the United Nations approve a UN mandate for the force first.

In the meantime, Portugal was ready to send just 120 paramilitary police rather than regular soldiers, according to the report.

Asked to comment on the account, Powell issued no denial, saying instead, "Well, we are working with a number of allies who have made commitments."

A number of countries approached by the United States have also expressed reservations about their troops serving under U.S. command, according to defense officials. **[JR: It seems as though Uncle Sammy has stepped into quicksand and is yelling for help but the world doesn't seem to be listening. We were so gung-ho to go it alone to invade Iraq, supposedly to bring freedom to the Iraqi people—and they aren't cooperating either. We've asked for support to restore order from our coalition of the few and all they have shown U.S. is their skepticism. #### ISRAEL WANTS FULL EU MEMBERSHIP

BRUSSELS—Tel Aviv has sent several signals to the European Union conveying that Israel wants full EU membership.

Israeli government has officially told the EU that Israel is expediting its endeavours to resolve all its outstanding disputes with its neighbouring states which is a prerequisite under the EU rules for acceptance of any country's candidature, a reliable source in Brussels told the News.

The European Union is faced with a new dilemma of handling the fresh diplomatic initiative by Israel seeking a full EU membership with the support of the current EU presidency, while other major EU member states remain divided on the issue.

The European Union was first startled when Israeli Foreign Minister Silver Shalom recently told an EU delegation in Washington that his government was weighing an application to join the EU. The foreign minister was quoted as saying: "possibility, in principle, exists for Israel to join the EU since **Israel and Europe share similar economies and democratic values.**" **[JR: Clue number one.]**

Italy holds the current EU presidency. Italian Prime Minister Silvio Berlusconi supports Israel's inclusion in the EU, and his views on this issue have triggered another crucial debate at the European Union. "My country insists on the vision of expanded Europe that will include Turkey, Romania, Bulgaria, Moldavia, the Ukraine, Russia, Belorussia and, of course, Israel. If Europe wants to compete with the United States, it must find a way to speak in one voice," the prime minister was quoted as saying.

Germany is the first to express deep reservations over the new EU presidency's propensity to support the campaign launched by Israel asking for a full membership of the EU. Germany has reacted coolly to the calls by the Italian prime minister to include Israel, Russia and Ukraine as new members in the European Union.

Despite very close relations with Israel and Russia, Germany is publicly opposing the move aimed at granting EU membership to these countries.

"There are no plans to include these countries into the European Union," German Foreign Ministry spokesman Walter Lindner said in a briefing.

The supporters of Israel's inclusion in the European Union argue that there should be no trepidation in accepting Israel's candidature for the EU, as Turkey, a strategic Middle East player and an Islamic country, has already been officially accepted as a candidate for the EU.

Knowing that under the prevalent EU rules, a country in dispute with its neighbours is not entitled to apply for candidature of the European Union, **Israel's sympathisers**

**in the EU are advising the government of Ariel Sharon to keep on expediting official efforts to implement the Middle East “roadmap” besides achieving peace with Syria and Jordan. Israel has already concluded peace treaties with Egypt and Jordan. [JR: Clue number two.]**

The European Union is a major actor in the Middle East, playing a vital role as a member of the “Quartet” of the United States, EU, Russia and the United Nations that have jointly drawn up the roadmap to settle the Middle East crisis. **[JR: Of course Israel and the EU share similar economies and democratic values because the false Jews have played a major role in European histories, wars and revolutions. **SHARON, THE SETTLERS AND THE THREAT OF RADICAL JEWISH TERRORISM IN ISRAEL**

Israeli military clearance of Jewish settlements in the West Bank is now well underway as part of Prime Minister Ariel Sharon's commitment to the international ‘road map’ for an Arab-Israeli peace agreement. While clashes between troops and settlers have occurred on several of the smaller, isolated sites, to date the violence has not been serious. However, Israeli security services have privately expressed concern that as the clearance programme pushes on toward larger settlements, Jewish right-wing extremists might resort to armed resistance or terrorism.

Many of the newer West Bank settlements are manned by small groups of ultra-radical Jews often dubbed ‘hilltop youth’. Mainly young, second-generation settlers, this so far little known faction has been the focus of a recent study funded by the Research & Development Centre Samaria & Jordan Rift and the Faculty of Jewish Studies at the Bar Ilan University School of Education. This and other studies have concluded that the ‘hilltop youth’ movement could be key in Israel's internal political struggle over the implementation of the international road map. Israeli authorities harbour concerns that clandestine networks within this movement may resort to terrorism in response to further settlement clearances.

Meanwhile, Israeli security services continue to monitor the threat from existing Jewish radical groups such as Kach and Kahan Chai, who may also conduct major terrorist attacks aimed at completely wrecking the road map. The U.S. State Department lists both of these groups as foreign terrorist organisations.

Although Prime Minister Ariel Sharon has met with leaders of the settler movement in efforts to convince them to reach an agreement in which they would voluntarily evacuate certain outposts, these attempts have proven unsuccessful. While opposing any compromise, most leaders have promised that any protests over settlement clearance will be non-violent. However, they have warned that confrontations over ‘inhabited’ outposts on sensitive locations could ‘get out of hand’, and stated that they could not be held responsible for the actions of what they called ‘irresponsible fringe elements’.

The Israeli security forces do have some experience of settlement clearance in the West Bank. Last October, soldiers clashed with large mobs of enraged settlers for days at Havat Gilad, near the Palestinian town of Nablus. Fortunately the clashes did not escalate to the use of

firearms, though settlers were spotted at the scene holding assault rifles. This time, however, the situation may be different. Sharon's pledge at the Aqaba summit to dismantle what he termed “unauthorised” outposts would involve between 20 and 100 settlement clearances, about half of which are occupied by uncompromising young settlers.

However, it was Sharon's statement at Aqaba on “understanding the importance of territorial contiguity in the West Bank for a viable Palestinian state” which held the truly explosive element. Establishing such contiguity would almost certainly involve the clearance of several highly sensitive settlements inhabited by, until recently, hundreds of Sharon's most ardent supporters. This goes some way to explaining the concerns within the Israel Security Agency over the personal safety of the Prime Minister and his entourage.

**[JR: Is the concern here that these “ultra-radical hilltop youth” sponsored by Sharon and his Likud will turn to acts of terrorism against innocent Jews or will they come off as Zionist partisans defending Israel's right to exist? UNITED NATIONS—With the vote for the next five non-permanent members of the Security Council still a few months away, Libya has taken itself out of the running and has agreed to let Algeria serve in its place for the 2004-05 term, diplomats said Thursday.

The decision was a victory for the United States, which in anticipation of Libya's candidacy had encouraged the introduction of rival African candidates to scuttle Libya's chances of success, the diplomats said.

This was Washington's third successful attempt in recent years to derail planned council membership by North African states that it considers hostile. In the late 1990s, Sudan's membership was successfully blocked. A few years earlier, Libya again changed its place in the rotation, which is set by the North African states and the overall African group to ensure that all African member states have an opportunity to fill Africa's designated spots on the council.

Asked about the outcome, a State Department official said Thursday, “We worked hard behind the scenes to discourage a Libyan candidacy.” The official added, “The issue is: How can a country that's under Security Council sanctions become a member of the Security Council?”

The council imposed sanctions on Libya a decade ago after a U.S. investigation found that officials of its government were responsible for the 1988 downing of Pan Am Flight 103 over Lockerbie, Scotland, in which 270 people died. The sanctions were suspended, but not lifted, in 1999 after Libya turned over a key suspect in the case. **[JR: The U.S. worked behind the scenes “to discourage” and thwart Libya's chances of having a seat on the UN Security Council and it had nothing to do with the existing suspended sanctions as stated by officials in Sir Powell's State Department. It was and is to get back at Qadhafi because of his successes in uniting the states in Northern Africa, which we consider hostile and a threat to U.S. and certainly British interests long held in southern Africa. We evidently still have the power to exert our influence over certain UN members to see things our way and to avert changes that do not serve our self-serving interests.]**

**DEFENSE LAWYERS BALK AT MILITARY TRIBUNAL RESTRICTIONS**

WASHINGTON—U.S. officials say that when military tribunals begin for prisoners charged with terrorism, they want the trials to be seen as fair, by both the nation and the world.

But as the Pentagon prepares for the first such proceedings in more than 50 years, it is encountering a potent criticism: Many lawyers and professional groups say the conditions for civilian defense lawyers are so restrictive that they might not agree to participate in the process.

The issue of whether lawyers should agree to defend prisoners in proceedings at the U.S. naval base at Guantanamo Bay, Cuba, has been raised most forcefully by Lawrence Goldman, president of the National Association of Criminal Defense Lawyers. His group has 11,000 members and includes many of the nation's prominent defense lawyers.

Goldman said his concern was that lawyers could be “lending their legitimacy to what would otherwise be a sham proceeding”.

The restrictions that have troubled Goldman, as well as officials of the American Bar Association, include a requirement that defense lawyers acknowledge that their conversations with defendants may be monitored by the military.

However, the Pentagon says none of the information collected that way may be used in the prosecution. It also has been sensitive to some of the criticisms and has modified two regulations in recent days.

Whit Cobb Jr., the deputy general counsel at the Defense Department, said that the restraints were largely “driven by the ongoing war on terrorism and the need to protect intelligence.” But Cobb said civilian defense lawyers should feel comfortable with the procedures, which he describe as only slightly different from the usual civilian criminal proceeding or court-martial.

Nonetheless, many do feel uncomfortable. Neal Sonnett, a Florida lawyer and chairman of the American Bar Association's task force on treatment of enemy combatants, said that even with the changes in the rules, “I find them extremely troubling.”

**Other issues that have raised concerns include a requirement that lawyers inform military officials of anything they learn that could signal a future crime— infringing on lawyer-client privileges. In addition, the defense would have to tell the prosecution a week before the trial about all of its evidence, a stark departure from a civilian trial. [JR: How can this even remotely help the defendant in getting a fair hearing?]**

The regulations also require defense lawyers to be responsible for their transportation to and from Guantanamo. And the cost for security clearance for any lawyers participating can be as much as \$2,800 for the kind of top-secret classification that would entitle them to see much of the material. ...

**[JR: Conducting military tribunals will effectively protect the government's position regarding its actions against other countries. If the lawyers and the ABA have misgivings about their abilities to present their cases why have the trials? The defendants have no rights and have basically been judged guilty by the military that holds them. Who will pay for the expenses of these lawyers to travel to and from Guantanamo and the fees for their security clearance to have access to supposedly top secret files? Realistically the government already has files on these individuals so why the charges? Most of the accused were captured in Afghanistan or are Muslims so it stands to reason that the U.S. taxpayer will have to pay for these sham trials. What a showcase for the Bushkovites to prove and defend America's fight against terrorism. Timing is everything when your plan is to stay on top as the world ruler.]**

U.S. URGED TO MODIFY MILITARY TRIBUNALS

Britain is trying to persuade the U.S. to change the proposed procedures of the military tribunals faced by the Guantanamo Bay detainees to accord with international law, the UK government said on Thursday.

Such a move would alleviate the mounting political pressure on Tony Blair, the prime minister, to repatriate the two British detainees—Moazzam Begg and Feroz Abbasi—facing trial. More than 200 members of parliament, most of them from Mr. Blair's Labour party, have called on the government to press for the men to be brought back to Britain.

The premier's office at Downing Street on Thursday night said repatriation was among "various options" being discussed with the Americans. But Mr. Blair's official spokesman cautioned commentators not to "leap from discussion to decision—there are difficulties".

One of those difficulties is the UK inability to give the U.S. any guarantee that the two men would stand trial. A decision on this would rest with the Crown Prosecution Service, which is independent of government.

The UK Foreign Office on Thursday said it hoped to persuade the U.S. to hold the tribunals under rules that accorded with "universal principles" of justice, such as the presumption of innocence and a defendant's right to see evidence.

"The position at the moment is that the Americans as the detaining power have decided they want to try them within the American jurisdiction," the Foreign Office said. "We want a fair trial—a fair trial within American jurisdiction would be a satisfactory outcome."

Downing Street on Thursday emphasised its "strong reservations" about the U.S. proposals. In particular, Britain continues to stress its fundamental opposition to the threatened use of the death penalty if the detainees were found guilty.

A U.S. official said the UK had not requested any specific changes to the rules, and that the discussions between the two governments had so far been limited to "broad principles". "I'm not sure if what they're seeking is changes to the process or just more clarity about how it would unfold," he said, adding that the UK had not sought repatriation, but that the U.S. would consider seriously any request.

Downing Street stopped short of an outright condemnation of the U.S. approach. "The information flowing from Guantanamo Bay is important in terms of the war against terrorism and we can't overlook that," Mr. Blair's spokesman said.

BUSH LISTS 6 FOR TERROR TRIBUNALS

WASHINGTON—President Bush on Thursday declared six suspected terrorists eligible to be tried by military tribunals, which the United States has not used since World War II.

Officials would not identify the men or provide many other details. But the six were described as members of al-Qaida or linked to terrorism against the United States. Under the rules established for the tribunals, only non-U.S. citizens can be brought before them.

Some of the suspects attended terrorist training camps, officials said, and helped seek money or new members for terrorist groups. Some are said to be detained at the U.S. naval base in Guantanamo Bay, Cuba, where officials say some trials could be held.

The tribunals, which the Pentagon now calls military commissions, provide sharply diminished rights for defendants compared to civilian courts. The ability to question witnesses, for example, is limited.

Many groups also have challenged the tribunals' power of secrecy, arguing that the government would use the tribunals to avoid revealing a weak case.

"The State Department issues a report every year in which it criticizes those nations that conduct trials before secret military tribunals," Neal Sonnett, chairman of the American Bar Association's task force on the treatment of detainees in the war on terrorism, told the *Associated Press*.

"What I'm hearing sounds alarmingly like something similar," he noted.

"If they're going to be charged by military tribunals, then they have a right to full due process, and the public has a right to know who's being tried and what the charges are and the government has an obligation to run these tribunals in a fair and transparent way," Sonnett said.

The defendants would be assigned military lawyers and would have no automatic right to appeal to a civilian court. They could also seek civilian lawyers, who would have to receive clearance to examine trial documents.

No trials will be scheduled until a chief prosecutor drafts charges against one or more of the suspects and until Deputy Defense Secretary Paul Wolfowitz determines which, if any of them, should go before a tribunal.

Because the six men have been designated as enemy combatants, they might be held indefinitely by the U.S. government even if acquitted of criminal charges by a military tribunal, officials acknowledged Thursday.

The Bush administration said last year it might hold those captured in the war against terrorism until it determined that the conflict had ended.

Officials said they intend to withhold the names of the six suspects until any formal charges are filed, and they held open the possibility that some might never be publicly identified. ...

But the Justice Department has not ruled out the possibility of a military tribunal for Zacarias Moussaoui, a French-born Moroccan who is the only person charged in the United States with involvement in the Sept. 11 hijacking attacks in New York and suburban Washington that killed more than 3,000 people. **[JR: Is this the final and absolutely official death toll for 9/11?] [JR: How precarious can life get for these six unlucky detainees, who will be declared as being the prime suspects plotting terror against the U.S. by our very own Genghis Khan, George Dubya Bush. HONG KONG RETREATS ON ANTI-SUBVERSION LAW

Hong Kong's leader, Tung Chee-hwa, has said a controversial anti-subversion bill will be amended, following a huge protest rally earlier this week.

Pressure has been mounting for Mr. Tung to address citizens' concerns over the bill—known as Article 23—since 500,000 people marched through the territory's streets on Tuesday.

Religious groups, human rights organisations and journalists say the bill would give the government power to suppress their activities.

The authorities in Beijing have said they approve of Mr. Tung's changes. But his critics say the concessions do not go far enough.

**On Saturday Mr. Tung said he would:**

**- scrap a provision that allowed some groups to be banned**

**- add protections for journalists who publish classified information**

**- delete a provision that would let police conduct searches without warrants. [JR: Any of these laws sound familiar?]**

He also wants to modify provisions that would allow organisations linked to outlawed groups in the mainland to be banned in Hong Kong.

This could involve the Falun Gong spiritual group, which is legal in Hong Kong but has been banned in China as an "evil cult".

Mr. Tung acknowledged that the massive outpouring of public sentiment had forced an embarrassing retreat from parts of the national security law and said "my colleagues and myself have to do better".

"After repeated and detailed discussions, we have decided to make amendments to further allay people's fears," Mr. Tung told a news conference.

Article 23 is part of Hong Kong's mini-constitution—the Basic Law—which was negotiated on its handover from Britain to China in 1997.

The amended bill will be submitted to Hong Kong's legislative council for a final vote on Wednesday.

The BBC's Francis Markus, in Shanghai, says Mr. Tung has been in the throes of political crisis over the last few days and now seems to have decided that something had to give.

The law has not been the only focus of widespread public discontent—there has been widespread criticism of the government's handling of various issues.

Our correspondent says the debate over the bill was likely to be stormy but even if the amendments allowed the bill to pass, critics were likely to sense Mr. Tung's increasing weakness and continue pressing their calls for him to step down.

UNEMPLOYED? WORRIED? READ THIS

Now that at least 6% of you are unemployed in the United States and have more free time to read, perhaps you'd like to know why you no longer have a job, why your job-finding prospects are bleak, why our trade deficit is off the charts (**over \$45 billion and counting just since January**) and even more importantly, who did this to you.

## ALL IS WELL

The Mormons have a wonderful hymn, titled, *Come, Come, Ye Saints*. At the end of some phrases, are the words "All is Well, All is Well." I am not a Mormon, but that is a lovely, stirring hymn. Makes me think of Sir Alan, CNBC, *et al.*, and their continual telling us that "All is Well". For three years now, the same refrain has been spoken, in various phraseology, but the theme is, "All is Well". The facts do not bear that out: Consider:

The S&P P/E ratios sit at 32, meaning that stocks are selling at 32 times their earnings. Good stocks are considered to have a P/E ratio of ten or under. Corporate earnings are dismal. Alcoa (Aluminum Corporation of America) cut costs by \$1 billion, but still has a 7% decline in income. IBM makes a bit more profit, but only because of laying off thousands and cutting costs to the bone. Trillions have been lost in the stock market—and trillions more are going to be lost... in my opinion.

The U.S. trade deficit will be over \$500 billion this year. This means that \$500 billion more will leave America, than comes in; an all-time high, and growing. Remember, I mentioned the siphon? How long before there is no capital left to siphon? The "experts" don't seem to worry. How come?

It was also announced that the red ink the federal government will run up next year is estimated to be \$455 billion. It was "estimated" to be half that a few months ago. Of course, the off-budget items and black-budget stuff is not mentioned. It would be much worse except they have been stealing the Social Security funds for years to help out with the deficits—and the Baby Boomers are now applying, so there won't be a surplus much longer. The deficit does not include Iraq, Afghanistan and homeland defense either, so will it be \$600 billion in the hole? \$750 billion? Since D.C. rarely tells the truth, no one knows. and I am sure the others are similar. Corporate retirement funds have been robbed to pay bills, and they are hundreds of billions in arrears, with no known way to repay what is owed future retirees. "All is Well"?

Sir Alan says he will keep interest rates as low as they now are, till recovery is complete, and even lower them more, if necessary. Japan did the exact same thing, but it didn't help much, did it? Japanese real estate is selling for about half of what it was at its peak—and the Nikkei is more than 30,000 points lower than its peak. In 1987, when the stock market crashed, it lost 22% of its value in a single day. This, at today's Dow level, is 2,000 points in a single day. Richard Russell thinks gold and the Dow will cross at 3000. Is this what is in store for America? "All is Well"?

American Airlines has mortgaged every single plane they fly, and United should have declared official bankruptcy months ago. The layoffs continue. "Officially" the unemployment rate is 6.4%. The retail trade lost 13,000 jobs in June, professional and technical services 33,000, and manufacturing gave up 56,000 jobs... just in June. Unemployment claims are at record highs and have been over 400,000 per week for the last 22 weeks. "All is Well"?

A client of mine called his mortgage company about an error they had made, and the call was picked up in India. The IRS is having returns examined in India, and the firm of A.T. Kearney predicts that 500,000 jobs in the financial sector will be sent overseas in the next five years. A Forrester Research study estimates that in the next 15 years, 3.3 million service-industry jobs and \$136 billion in wages will go overseas. A college graduate in India with a BA in accounting will earn \$5,000 per year, and an MBA will make \$12,000. At home, a graduate of the Harvard Business School will get over \$100,000. "Heigh Ho, Heigh Ho, it's off to India they go." "All is Well"?

In August of 2002 natural gas prices were \$2.64 per million BTUs (British Thermal Units), and according to the Dept. of Energy, by January of 2004, the price will be more than \$9.00 for the same amount, tripling in a year and a half. The Iraq debacle is costing \$4 billion a month—and no end is in sight. How much is Afghanistan costing? Are the figures true? "All is Well"?

What simply amazes me is that most Americans seem to think if the polls are correct, that "we are on the road to recovery". How can they actually believe that? Over and over again financial advisors tell their clients that "gold is going nowhere". Sure, only up 35% in two years. Does your savings account pay 35% over a two-year period? Or does it pay 1%? Does your CD pay 35% over a two-year period? Or is it maybe 2%? With the money supply increasing "officially" at close to 8%, doesn't this mean we are having 8% inflation, rather than the 1.2% the government reiterates over and over again? Three tractor-trailer loads of \$100 bills were found in Iraq, headed for the Syrian border. Billions of dollars. Were they counterfeit? Does it really matter? Real or counterfeit, all add to the currency supply. In wartime, opposing governments always counterfeit the enemy's currency, so as to make it worthless [MM: not necessary with the fiat U.S. "dollar"]. Real, or counterfeit, it all adds to the money supply. We are doing it to ourselves now, with the printing press and limitless check writing by the bureaucrats.

It is sort of like painting yourself into a corner. The economic situation in America—and the entire world—is extremely shaky. Comparing the Yen, Euro, Dollar, Pound, Peso and Franc to each other is like watching six ships sink. The ship with the best pump may last longer, catch up occasionally and even repair the breach. The hulls are thin and rusty though, and trusting in any of the ships is a fool's bet. No currency is backed by anything, and all are merely pieces of paper that are not redeemable in anything other than more paper "money".

An *Associated Press* story on July 12th says this: (A long story, but I'll quote only part of it.) "Washington—Agriculture Department employees used government credit cards to pay tuition for bartender school, to buy Ozzy Osbourne tickets, lingerie and tattoos, and to make a down payment on a car. A random audit by the department's inspector general, of just 300 of the 55,000 department employees who carry the government credit cards, showed they had charged \$7.7 million in personal purchases in a six-month period from Oct 1, 2001 to March 31, 2002. The cardholders took out \$196,000 in cash, used them to pay off personal debts and used them at adult clubs, brothels, sporting events and to buy jewelry." Note this is for only 300 cards of 55,000 in one bureaucracy! Where is the public outrage over this story? Where are the fulminating Senators? Imagine the fraud committed by the entire government employee pool, with probably hundreds of thousands of cards. Just in credit card fraud, the fed employees may be running up the red ink by a hundred billion a year. "Money", as the dollar is called, cannot continue to buy next month, what it will buy today, due to their extreme proliferation. This is a simple economic fact—and not open to argument. It is as impossible for the dollar to retain its purchasing power, as it is for water to run uphill.

"Gold will never go anywhere," is absurd. 35% ain't hay, it seems to me. Gold doesn't change. It's the same gold and silver. Only their prices change—and are even manipulated. Governments and banks manipulating gold and silver—by selling, leasing, futures trading and other obfuscation—merely postpones the inevitable. They've got to do it, in a vain attempt to save themselves. An old simile might be, "rearranging the deck chairs on the *Titanic*". Tangible, physical things will always outlive pieces of paper with ink on them. Paper with nothing backing it, is just paper. In the end, it has always been used to take to the bathroom or to start fires. I am so sick of the persiflage and stupidity of the media and public that it makes me want to retch. Is all well? Hell No!!! ## SILVER AND WHAT I LOOK FOR IN CONTRARIAN INVESTING

Some outstanding points are made in the Puplava article.

Just want to mention a few before my brief thoughts on contrarian investing:

Dow/Silver ratio bottomed in 1980 at 18 to 1 which means that it took 18 ounces of silver to buy one share of the Dow. At the peak recently in silver it took an unbelievable 2,526 ounces of silver to buy one share of the Dow!!!

The Dow/Silver ratio has clearly turned down in favor of silver, but still stands at an incredible 1,938 to 1.

The average ratio over 100-plus years at the bottom was around 80 to 1, so for silver investors this indicates tremendous upside and this is what Russell was referring to recently in his commentaries on silver!!!

Another ratio is the Gold/Silver ratio. It is currently at 73 to 1, meaning it takes 73 ounces of silver to purchase an ounce of gold.

This ratio bottomed in 1980 at 16 to 1. **Richard Russell has stated publicly many, many times that he believes the price of gold is headed to \$3,000/ounce.** You can do the math, but one subscriber sent an e-mail to RR which was published indicating that **gold at \$3,000 and a Gold/Silver ratio of 16 to 1 would put silver at \$187.50/ounce!!!**

**The Gold/Silver ratio historically has been at a ratio for many thousands of years of around 12-to-15 to one.**

The United States had literally billions of ounces of silver stockpiled after World War II. As the Chairman and CEO of Pan American Silver wrote to RR the other day (which was published) the massive "strategic stockpile" which the United States possessed after World War II is now completely gone and stands at "ZERO".

COMEX inventories which stood at about 330 million ounces in 1980 are now down to 106 million of which over 60 million ounces are already spoken for by investors.

Above-ground stockpiles which were around 2.5 to 3 billion ounces in 1980 have been reduced according to all documented sources (which RR mentioned) to only 500 million ounces of above-ground stockpiles.

We have been running documented deficits for over 14 years—and this is why these stockpiles have been disappearing and are near crisis levels.

Richard Russell was correct in saying the world will run out of above-ground silver in 5 years or less, as the average deficit has averaged well over 100 million ounces/year.

This silver is consumed and lost forever. Just one example of this is when your computer keyboard ends up in the dump eventually, the 12 cents or so of silver are not economically feasible to retrieve, so it is lost forever and will never be recovered. There are many, many other examples which I will not go into—you get the idea.

Another ratio is the Housing/Silver ratio which over the last 100-plus years peaks at around 20,000 and bottoms at an average of 5,000 (3,000 in 1980).

What that means is that at the peaks it typically takes 20,000 ounces to purchase a "median"-priced home. Today the average home purchased in silver stands at an amazing level of around 50,000, meaning it takes around 50,000 ounces of silver to purchase the "median"-priced home!!!

A final point is that the lag-time on new mining for silver is around 5 years—so it won't matter if the price spikes significantly, because it takes an enormous amount of time to get new mining projects under way. Any increase of silver mining on existing projects would be negligible and not worth discussing in my opinion.

Those are the facts and those are the types of things I have always looked at as a professional investor/trader in order to make profit.

In summary it is quite obvious to me that those ratios are way out of whack and will cycle back down the other way (where they have typically bottomed) and I will be moving capital allocated to silver investing out of silver at that time and into some other type of investment which will be unloved (out of favor) and which the ratios will favor at that time (such as real estate and stocks).

On a final note I remember when I was buying up substantial chunks of oil stocks (primarily drillers) back at the end of 1999, early 2000.

One of the things that fascinated me was the way all of the insiders I talked to seemed to think the price of oil was going lower. I remember at about \$11/barrel for oil the Venezuelan Oil Minister was in Florida at the time telling people he saw \$2 to \$3/barrel in the future for oil.

As I said, I was talking to insiders at major oil companies who knew I was investing very heavily in their stocks and they were asking me, "Where do you think the price of oil is headed?"

I would answer them by saying, "I am not an oil trader, but it looks to me—looking at 100-year charts for the price of oil—that it is headed for \$35 to \$40/barrel of oil."

There were many other bullish factors which I will not get into which later revealed themselves.

I'll never forget the CFO who was with the #2 land-driller for 28 years responding by saying, "You are alone on an island with that prediction."

Within 12 months of that conversation in early 2000, oil skyrocketed in price (faster than I expected) to the \$35 to \$40 area. [MM: Also, of course, following the economic advice of "experts" like Alan Greenspan will lead to bankruptcy!]

That particular stock, PTEN, eventually traded from 2 5/8 to around \$43/share.

Others I had loaded up on such as OIL (now merged) went from a low 5 1/4 (yes, I was filled there for some of my purchases) to about \$50.

There were many others I had, but the point I am trying to illustrate is those are the types of contrarian plays which have been successful for me and greatly increased my net worth.

For the record I always sell too early, sometimes way too early (smile).

People don't have to follow me on silver, I just wanted to give some of the types of things which I look for when investing/trading (because I will also trade while holding my core positions).

There are so many ways for investors to make money in the world markets—but I have repeatedly mentioned silver on this board because it seems so very obvious to me.

I don't know where the price of silver is headed, but rather will look at the ratios to determine my sell points, as well as fundamentals.

For what it is worth it is generally always worth while to go against the herd (smile).—Courtesy of www.silver-investor.com

# Keeping Shields Up In A Foreign Jurisdiction

**Budget's "Tip of the Week" #11:**

**Maintaining a Nevada Corporation's Liability Protection in a Foreign Jurisdiction**

When using your Nevada corporation in a foreign jurisdiction, what can you do to maintain the strong liability protection afforded under Nevada's statutes?

So-called "long arm" laws have been used to claim jurisdiction over "foreign" corporations, stripping away the benefits that would otherwise accrue to them based on the statutes prevailing in their home jurisdiction. These "long arm" laws have been used to great effect in California, for example, ostensibly to protect that state's citizens from encroachments and predatory practices by "outsiders". **Nevada corporations are not immune from this potentially devastating application of the law that would deny them the liability protection inherent in Nevada's Revised Statutes—BUT IT WOULD APPEAR THAT THEY CAN BE.**

Article I, section 10, clause 1 of the U.S. Constitution prohibits the states from passing any "law impairing the obligation of contracts". The test for determining a violation of this "contract clause" in the Constitution was stated in *Allied Structural Steel Co. v. Spannaus*, 438 U.S. 234 (1978):

**"The first inquiry must be whether the state law has, in fact, operated as a substantial impairment of a contractual relationship. The severity of the impairment measures the height of the hurdle the state legislation must clear. Minimal alteration of contractual obligations may end the inquiry at its first stage. Severe impairment, on the other hand, will push the inquiry to a careful examination of the nature and purpose of the state legislation."**

The solution to retaining the superior liability protection made inherent to Nevada corporations in the *Nevada Revised Statutes* thus appears to be fairly simple:

**AS A PART OF ANY CONTRACT (and remember that a contract does not have to be in writing) WITH ANY ENTITY OR ENTITIES IN A FOREIGN JURISDICTION, ENSURE A CLEAR UNDERSTANDING THAT THE CONTRACT IS TRANSACTED IN NEVADA, AND THAT ANY DISPUTE SHALL BE RESOLVED IN NEVADA.**

You might also want to consider liberal use of the suffix, "a Nevada corporation", which can be appended to your corporation's name to add a measure of protection. In legal terms, there is a "rebuttable presumption" that Nevada law applies to any contract between a Nevada "person" (yes, a corporation IS a "person", by legal definition) and any other entity, so long as the second party is aware of the fact that they are dealing with a Nevada corporation. For this reason alone it can be wise to ensure that the Nevada corporation is identified as such while operating within a foreign jurisdiction.

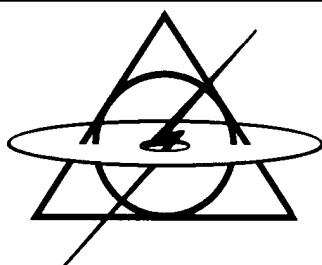
