INDUSTRIAL DIAGRAMS

An ideal industry is defined as a device which receives value from other industries in several forms and converts it into one specific product for sales and distribution to other industries. It has several inputs and one output. What the public normally thinks of as one industry is really an industrial complex where several industries under one roof produce one or more products.

The flow of product from industry #1 (supply) to industry #2 (demand) is denoted by 112. The total flow out of industry 'K' is denoted by 1 k (sales, etc.).

A node is a symbol of collection and distribution of flow. Node #3 receives from industry #3 and distributes to industries #1 through #3. If industry #3 manufactures chairs, then a flow from Industry #3 back to industry #3 simply indicates that industry #3 is using part of its own output product, for example, as office furniture. Therefore, the flow may be summarized by the equations:

THREE INDUSTRIAL CLASSES

Industries fell into three categories or class by type of output.

Class #1—Capital (resources)

Class #2—Goods (commodities or use—dissipative)

Class #3—Services (action of population)

Class #1 Industries exist at three levels

(1) Nature—sources of energy and raw materials.

(2) Government—printing

of currency equal to gross national product (GNP), and extension of currency in excess of GNP.

(3) Banking—loaning of money for interest, and extension (counterfeiting) of economic value through deposit loan account—inflation.

Class #2 industries exist as producers of tangible or consumer (dissipated) products. This sort of activity is usually recognized and labeled by the public as an 'industry'.

Class #3 industries are those which have service rather than a tangible product as their output. These industries are called (1) capital, (2) goods, and (3) services. The problem with this representation is that it would not show the influence of, say, the textile industry on the ferrous metal industry. This is because both the textile industry and the ferrous metal industry would be contained within a single classification called the 'goods industry' and by this process of combining or aggregating these two industries under one system block, they would lose their economic individuality.

AGGREGATION

The whole economic system can be represented by a three-industry model if one allows the names of the outputs to be (1) capital, (2) goods, and (3) services. The problem with this representation is that it would not show the influence of, say, the textile industry on the ferrous metal industry. This is because both the textile industry and the ferrous metal industry would be contained within a single classification called the 'goods industry' and by this process of combining or aggregating these two industries under one system block, they would lose their economic individuality.

THE E-MODEL

A national economy consists of simultaneous flows of production, distribution, consumption, and investment. If all of these elements including labor and human functions are assigned a numerical value in like units of measure, say, 1939 dollars, this flow can be further represented by a current flow in an electronic circuit, and its behavior can be predicted and manipulated with useful precision.

The three ideal passive energy components of electronics, the capacitor, the resistor, and the inductor correspond to the three ideal passive energy components of economics called the pure industries of capital, goods, and services.

Economic capacitance represents the shortage of capital in one form or another.

Economic conductance represents the level of conductance of materials for the production of goods.

Economic inductance represents the inertia of economic value in motion. This is a population phenomenon known as services.

ECONOMIC INDUCTANCE

An electrical inductor (e.g., a coil of wire) has an electric current as its primary phenomenon and a magnetic field as its secondary phenomenon (inertia). Corresponding to this, an economic inductor has a flow of economic value as its primary phenomenon and a population field as its secondary phenomenon of inertia. When the flow of economic value (e.g., money) diminishes, the human population field collapses in order to keep the economic value (money) flowing (extreme case—war).

The public inertia is a result of consumer buying habits, expected standard of living, etc., and is generally a phenomenon of self-preservation.

INDUCTIVE FACTORS TO CONSIDER

- (1) Population
- (2) Magnitude of the economic activities of government.
- (3) The method of financing these government activities (see Peter-Paul Principle—inflation of the currency).

TRANSLATION

(A few examples will be given.)

CHARGE—coulombs—dollars (1939).

FLOW/CURRENT—amperes (coulombs per second)—dollars of flow per year.

MOTIVATING FORCE—volts—dollars (output) demand.

CONDUCTANCE—amperes per volt—dollars of flow per year per dollar demand.

CAPACITANCE—coulombs per volt.—dollars of production inventory/stock per dollar demand.

TIME-FLOW RELATIONSHIPS
AND SELF-DESTRUCTIVE OSCILLATIONS

An ideal industry may be symbolized electronically in various ways. The simplest way is to represent a demand by a voltage and supply by a current. When this is done, the relationship between the two becomes what is called an admittance, which can result from three economic factors: (1) hindsight flow, (2) present flow, and (3) foresight flow. **[H: This describes the flow of LIFE pretty well, doesn't it? When you have learned that the same principle applies to ALL facets of expression, you have moved a long way toward graduation.]**

Foresight flow is the result of that property of living entities to cause energy (food) to be stored for a period of low energy (e.g., a winter season). It consists of demands made upon an economic system for that period of low energy (winter season). In a productive industry it takes several forms, one of which is known as production stock or inventory. In electronic symbology this specific industry demand (a pure capital industry) is represented by capacitance and the stock or resource is represented by a stored charge. Satisfaction of an industry demand suffers a lag because of the loading effect of inventory priorities.

Present flow ideally involves no delays. It is, so to speak, input today for output today, a 'hand to mouth' flow. In electronic symbology, this specific industry demand (a pure use industry) is represented by a conductance which is then a simple economic value (a dissipative element).

Hindsight flow is known as habit or inertia. In electronics, this phenomenon is the characteristic of an inductor (economic analog = a pure service industry) in which a current flow (economic analog = flow of money) creates a magnetic field (economic analog = active human population) which, if the current (money flow) begins to diminish, collapses (war) to maintain the current (flow of money—energy).

Other large alternatives to war as economic inductors or economic flywheels are an open-ended social welfare program, or enormous (but fruitful) open-ended space program.

The problem with stabilizing the economic system is that there is too much demand on account of (1) too much greed and (2) too much population.

This creates excessive economic inductance which can only be balanced with economic capacitance (true resources or value - e.g. in goods or services). The social welfare program is nothing more than an open-ended credit balance system which creates a false capital industry to give non-productive people a roof over their heads and food in their stomachs. This can be useful, however, because the recipients become state property, in return for the 'gift', a standing army for the elite. For he who pays the piper, picks the tune. Those who get hooked on the economic drug must go to the elite for a fix. In this, the method of introducing large amounts of stabilizing capacitance is by borrowing on the future 'credit' of the world. This a fourth law of motion—onset, and consists of performing an action and

leaving the system before the reflected reaction returns to the point of action—a delayed reaction. The means of surviving the reaction is by changing the system before the reaction can return. By this means, politicians become popular in their own time and the public pays for it later. In fact the measure of such a politician is the delay time. The same thing is achieved by a government by printing money beyond the limit of the gross national product, an economic process called inflation. This puts a large quantity of money into the hands of the public and maintains a balance against their greed, creates a false self-confidence in them and, for a while, stays the wolf from the door.

They must eventually resort to war to balance the account, because war ultimately is merely the act to keep the responsibility and blood off the public conscience. (See section on consent factors and social-economic structuring.)

If the people really cared about their fellow man, they would control their appetites (greed, procreation, etc.) so that they would not have to operate on a credit or welfare social system which steals from the worker to satisfy the bum.

Since most of the general public will not exercise restraint, there are only two alternatives to reduce the economic inductance of the system.

(1) Let the populace bludgeon each other to death in war, which will only result in a total destruction of the living Earth.

(2) Take control of the world by the use of economic 'silent weapons' in a form of 'quiet warfare', and reduce the economic inductance of the world to a safe level by a process of benevolent slavery and genocide.

The latter option has been taken as the obviously better option. At this point it should be crystal clear to the reader why absolute secrecy about the silent weapons is necessary. The general public refuses to improve its own mentality and its faith in its fellow man. It has become a herd of proliferating barbarians, and, so-to-speak, a blight upon the face of the Earth. They do not care enough about economic science to learn why they have not been able to avoid war despite religious morality, and their religious or self-gratifying refusal to deal with earthly problems renders the solution of the earthly problem unreachable by them. It is left to those few who are truly willing to think and survive as the fittest to survive, to solve the problem for themselves as the few who really care. Otherwise, exposure of the silent weapon would destroy our only hope of preserving the seed of future true humanity.

THE HOUSEHOLD INDUSTRY

The industries of finance (banking), manufacturing, and government, real counterparts of the pure industries of capital, goods, and services, are easily defined because they are generally logically structured. Because of this their processes can be described mathematically and their technical coefficients can be easily deduced. This, however, is not the case with the service industry known as the household industry.

HOUSEHOLD MODELS

When the industry flow diagram is represented by a 2-block system of households on the right and all other industries on the left, the following results.

[H: Here it must be noted that this document was the presentation of a lecture for the diagrams are missing. This has to be more disquieting in recognition because it brings the ideas beyond the “theory”-on-paper stage and into actual training sessions.]

The arrows from left to right labeled A, B, C, etc., denote flow of economic value from the industries on the left to the industry on the right called ‘households’. These may be thought of as the monthly consumer flows of the following commodities. A—alcoholic beverages, B—beef, C—coffee,... U—unknown, etc.

The problem which a theoretical economist faces is that the consumer preferences of any household is not easily predictable and the technical coefficients of any one household tend to be a non-linear, very complex, and variable function of income, prices, etc.

Computer information derived from the use of the Universal Product Code (UPC) in conjunction with credit card purchase as an individual household identifier could change this state of affairs. But the UPC method is not yet available on a national or even a significant regional scale. To compensate for this data deficiency, an alternate indirect approach of analysis has been adopted known as economic shock testing. This method, widely used in the aircraft manufacturing industry develops an aggregate statistical sort of data.

Applied to economics, this means that all of the households in one region or in the whole nation are studied as a group or class rather than individually, and the mass behavior rather than individual behavior is used to discover useful estimates of the technical coefficients governing the economic structure of the hypothetical single-household industry.

Notice in the industry flow diagram that the values for the flows A,B,C, etc., are accessible to measurement in terms of selling prices and total sales of commodities.

One method of evaluating the technical coefficients of the household industry depends upon shocking the prices of a commodity and noting the changes in the sales of all of the commodities.

[H: Is anyone recognizing ordinary practices NOW IN FULL OPERATION, ESPECIALLY YOU ECONOMISTS? Have you been “had” or what? Well, BOTH, “had” and “what”!]

In recent times, the application of Operations Research to the study of the public economy has been obvious for anyone who understands the principles of shock testing.

In the shock testing of an aircraft airframe, the recoil impulse of firing a gun mounted on that airframe causes shock waves in that structure which tell aviation engineers the conditions under which parts of the airplane or the whole airplane or its wings will start to vibrate or flutter like a guitar string, a flute reed, or a tuning fork, and disintegrate or fall apart in flight.

Economic engineers achieve the same result in studying the behavior of the economy and the consumer public by carefully selecting a staple commodity such as beef, coffee, gasoline, or sugar and then causing a sudden change or shock in its price or availability, thus kicking everybody’s budget and buying habits out of shape.

They then observe the shock waves which result by monitoring the changes in advertising, prices, and sales of that and other commodities.

[H: Something might be missed here if you don’t fully pay attention because there are some more current practices which are thrust on you people today. These come in the form of

manipulation of such as basic food items (in Asia—rice), transportation and shipping fuels, even to a few centavos up or down, with studied response of the public masses. It can be in the food “protein” business, i.e., take out large portions of the supply and watch the terror and response, killing off of fowl, i.e. Hong Kong bird virus response—CURRENCY MANIPULATION. You are going through the final phases of total control through these STUDIED cause-and-effect manipulations. The main presentation is one of total CONFUSION. Example: You have a circumstance in the Philippines whereby it is noted that little microfinance units are very productive. This allows cottage industries to establish and continue. The payback ratio is outstanding.

So, gets into the act a bunch of people acting as individual industries or banks and THEY start little microfinancing BANKS. So far, perhaps, so good. Then comes the hook: THE WHOLE PROGRAM IS UNDER SOME OBSCURE SET OF INITIALS (ABCD)—BUT IT IS FOUND THAT ABCD IS “AN ARM ESTABLISHED FOR THE PURPOSE BY THE WORLD BANK/IMF”. ADVISORS? Oh, the Rothschild Bank(s). Are the people Jesuits as suggested by Mr. Rick Martin’s contacts? Oh, I don’t really think so—but what difference could it possibly make? Manipulators and Elite come from all/any religion(s), races, claimed creeds and colors. You must get beyond the foolishness of what the adversary wishes to call himself for his different phases of “getcha”. By the way, who might this Mr. Phelps, touted as an authority by *Spectrum*, be? Never heard of him? I didn’t think so.]

The objective of such studies is to acquire know-how to set the public economy into a predictable state of motion or change, even a controlled self-destructive state of motion, which will convince the public that certain “expert” people should take control of the money system and reestablish security (rather than liberty and justice) for all. When the subject citizens are rendered unable to control their financial affairs, they of course, become totally enslaved, a source of cheap labor. **[H: READ IT AGAIN!]**

Not only the prices of commodities, but also the availability of labor can be used as the means of shock testing. Labor strikes deliver excellent test shocks to an economy, especially in the critical service areas of trucking (transportation), communication, public utilities (energy, water, garbage, collection), etc.

By shock testing, it is found that there is a direct relationship between the availability of money flowing in an economy and the psychological outlook and response of masses of people dependent upon that availability.

For example, there is measurable, quantitative relationship between the price of gasoline and the probability that a person would experience a headache, feel a need to watch a violent movie, smoke a cigarette, or go to a tavern for a mug of beer.

It is most interesting that, by observing and measuring the economic modes by which the public tries to run from their problems and escape from reality, and by applying the mathematical theory of Operations Research, it is possible to program computers to **predict the most probable combination of created events (shocks) which will bring about a complete control and subjugation of the public through a subversion of the public economy (by shaking the plum tree).**

INTRODUCTION TO THE THEORY OF ECONOMIC SHOCK TESTING

Let the prices and total sales of commodities be given and symbolized as follows.

Let us assume a simple economic model in which the total number of important (staple) commodities are represented as beef, gasoline, and an aggregate of all other staple commodities which we will call the hypothetical miscellaneous staple commodity ‘M’ (e.g., M is an aggregate of C,S,T,U, etc.).

INTRODUCTION TO ECONOMIC AMPLIFIERS

Economic amplifiers are the active components of economic engineering. The basic characteristic of any amplifier, (mechanical, electrical, or economic) is that it receives an input control signal and delivers energy from an independent energy source to a specified output terminal in a predictable relationship to that input control signal.

The simplest form of economic amplifier is a device called advertising.

If a person is spoken to by a TV advertiser as if he were a twelve year old, then, due to suggestibility, he will, with a certain probability, respond or react to that suggestion with the uncritical response of a twelve year old and will reach into his economic reservoir and deliver its energy to buy that product on impulse when he passes it in the store.

An economic amplifier may have several inputs and outputs. Its response might be instantaneous or delayed. Its circuit symbol might be a rotary switch if its options are exclusive, qualitative, ‘go’ or ‘no go’, or it might have its parametric input/output relationships specified by a matrix with internal energy sources represented.

Whatever its form might be, its purpose is to govern the flow of energy from a source to an output sink in direct relationship to an input control signal. For this reason, it is called an active circuit element or component.

Economic Amplifiers fall into classes called strategies, and in comparison with electronic amplifiers, the specific internal functions of an economic amplifier are called logistical instead of electrical.

Therefore, economic amplifiers not only deliver power gain, but also, in effect, are used to cause changes in the economic circuitry.

In the design of an economic amplifier we must have some idea of at least five functions, which are:

- (1) the available input signals,
- (2) the desired output control objectives,
- (3) the strategic objective,
- (4) the available economic power sources,
- (5) the logistical options.

The process of defining and evaluating these factors and incorporating the economic amplifier into an economic system has been popularly called game theory.

The design of an economic amplifier begins with a specification of the power level of the output, which can range from personal to national. The second condition is accuracy of response, i.e., how accurately the output action is a function of the input commands. High gain combined with strong feedback helps to deliver the required precision. Most of the error will be in the input data signal.

Personal input data tends to be specific, while national input data tends to be statistical.

DIVERSION, THE PRIMARY STRATEGY

[H: PAY CLOSE ATTENTION BECAUSE HERE COMES THE M.O.]

Experience has proven that the simplest method of securing a silent weapon and gaining control of the public is to keep the public undisciplined and ignorant of basic systems principles on the one hand, while keeping them confused, disorganized, and distracted with matters of no real importance on the other hand.

This is achieved by:

(1) Disengaging their minds, sabotaging their mental activities, by providing a low-quality program of public education in mathematics, logic, systems design, and economics, and by discouraging technical creativity.

(2) Engaging their emotions, increasing their self-indulgence and their indulgence in emotional and physical activities, by:

(a) unrelenting emotional affrontations and attacks (mental and emotional rape) by way of a constant barrage of sex, violence, and wars in the media—especially the TV and the newspapers.

(b) giving them what they desire—in excess—"junk food for thought" and depriving them of what they really need.

(3) Rewriting history and law and subjecting the public to the deviant creation, thus being able to shift their thinking from personal needs to highly fabricated outside priorities.

These preclude their interest in and discovery of the silent weapons of social automation technology.

The general rule is that there is profit in confusion; the more confusion, the more profit. **Therefore, the best approach is to create problems—and then offer the solutions.**

DIVERSION SUMMARY

MEDIA: Keep the adult public attention diverted away from the real social issues, and captivated by matters of no real importance.

SCHOOLS: Keep the young public ignorant of real mathematics, real economics, real law, and real history.

ENTERTAINMENT: Keep the public entertainment below a sixth grade level.

WORK: Keep the public busy, busy, busy, with no time to think; back on the farm with the other animals.

CONSENT, THE PRIMARY VICTORY

A silent weapon system operates upon data obtained from a docile public by legal (but not always lawful) force. Much information is made available to silent weapon systems programmers through the Internal Revenue Service. (See “Studies in the Structure of the American Economy” for an IRS source list.) This information consists of the enforced delivery of well organized data contained in federal and state tax forms collected, assembled, and submitted by slave labor provided by taxpayers and employers. Furthermore, the number of such forms submitted to the IRS is a useful indicator of public consent, an important factor in strategic decision making. Other data sources are given in the “Short List of Inputs”.

Consent Coefficients: numerical feedback indicating victory status. Psychological basis;

When the government is able to collect tax and seize private property without just compensation, it is an indication that the public is ripe for surrender and is consenting to enslavement and legal encroachment. A good and easily quantified indicator of harvest time is the number of public citizens who pay income tax.

[H: It sure does look like they plan to have “harvest time” pretty soon.]

AMPLIFICATION ENERGY SOURCES

The next step in the process of designing an economic amplifier is discovering the energy sources. The energy sources which support any primitive economic system are, of course, a supply of raw materials, and the consent of the people to labor and consequently assume a certain rank, position, level, or class in the social structure; i.e., to provide labor at various levels in the pecking order.

Each class, in guaranteeing its own level of income, controls the class immediately below it, hence preserves the class structure. This provides stability and security, but also government from the top.

As time goes on and communications and education improve, the lower-class elements of the social labor structure become knowledgeable and envious of the good things that the upper-class members have. They also being to attain a knowledge of energy systems and the ability to enforce their rise through the class structure.

This threatens the sovereignty of the elite.

If this rise of the lower classes can be postponed long enough, the elite can achieve energy dominance, and labor by consent no longer will hold a position of an essential economic energy source.

Until such energy dominance is absolutely established, the consent of people to labor and let others handle their affairs must be taken into consideration, since failure to do so could cause the people to interfere in the final transfer of energy sources to the control of the elite.

It is essential to recognize that, at this time, public consent is still an essential key to the release of energy to the process of economic amplification.

Therefore, consent as an energy release mechanism will now be considered.

LOGISTICS

The successful application of a strategy requires a careful study of inputs, outputs, the strategy connecting the inputs and the outputs, and the available energy sources to fuel the strategy. This study is called logistics.

A logistical problem is studied at the elementary level first, and then levels of greater complexity are studied as a synthesis of elementary factors.

This means that a given system is analyzed, i.e., broken down into its sub-systems, and these in turn are analyzed, until, by this process, one arrives at the logistical ‘atom’, the individual.

This is where the process of syntheses properly begins, at the time of the birth of the individual.

THE ARTIFICIAL WOMB

From the time a person leaves its mother’s womb, its every effort is directed toward building, maintaining, and withdrawing into artificial wombs, various sorts of substitute protective devices or shells.

The objective of these artificial wombs is to provide a stable environment for both stable and unstable activity; to provide a shelter for the evolutionary processes of growth, and maturity—i.e., survival; to provide security for freedom and to provide defensive protection for offensive activity.

THE POLITICAL STRUCTURE OF A NATION—DEPENDENCY

The primary reason why the individual citizens of a country create a political structure is a subconscious wish or desire to perpetuate their own dependency relationship of childhood.

Simply put, they want a human god to eliminate all risk from their life, pat them on the head, kiss their bruises, put a chicken on every dinner table, clothe their bodies, tuck them into bed at night, and tell them that everything will be alright when they wake up in the morning.

This public demand is incredible, so the human god, the political, meets incredibility with incredibility by promising the world and delivering nothing. So who is the bigger liar?, the public?, or the ‘godfather’?

This public behavior is surrender born of fear, laziness and expediency. It is the basis of the welfare state as a strategic weapon, useful against a disgusting public.

ACTION/OFFENSE

Most people want to be able to subdue and/or kill other human beings which disturb their daily lives, but they do not want to have to cope with the moral and religious issues which such an overt act on their part might raise. Therefore, they assign the dirty work to others (including their own children) so as to keep the blood off their own hands. They rave about the humane treatment of animals and then sit down to a delicious hamburger from a whitewashed slaughterhouse down the street and out of sight. But even more hypocritical, they pay taxes to finance a professional association of hit men collectively called politicians, and then complain about corruption in government.

[H: READ IT AGAIN, PLEASE!]

RESPONSIBILITY

Again, most people want to be free to do things (to explore, etc.) but they are afraid to fail.

The fear of failure is manifested in irresponsibility, and especially in delegating those personal responsibilities to others where success is uncertain or carries possible or created liabilities (law) which the person is not prepared to accept.

They want authority (root word: ‘author’), but they will not accept responsibility or liability. They hire politicians to face reality for them.

SUMMARY

The people hire the politicians so that the people can:

1. obtain security without managing it,
2. obtain action without thinking about it,
3. inflict theft, injury, and death upon others without having to contemplate either life or death,
4. avoid responsibility for their own intentions,
5. obtain the benefits of reality and science without exerting themselves in the discipline of facing or learning of these things.

They give the politicians the power to create and manage a war machine to:

1. provide for the survival of the NATION/WOMB,
2. prevent encroachment of anything upon the NATION/WOMB,
3. destroy the enemy who threatens the NATION/WOMB, and
4. destroy those citizens of their own country who do not conform for the sake of stability of the NATION/WOMB.

Politicians hold many quasi-military jobs, the lowest being the police which are soldiers, the attorneys and the CPAs next who are spies and saboteurs (licensed), and the judges who shout the orders and run the closed union military shop for whatever the market will bear. The generals are industrialists. The ‘presidential’ level of commander-in-chief is shared by the international bankers. The people know that they have created this farce and financed it with their own taxes (consent), but they would rather knuckle under than be the hypocrite.

Thus a nation becomes divided into two very distinct parts, a DOCILE SUB-NATION and a POLITICAL SUB-NATION. The political sub-nation remains attached to the docile sub-nation, tolerates it, and leaches its substance until it grows strong enough to detach itself and devour its parent.

SYSTEMS ANALYSIS

In order to make meaningful computerized economic decisions about war, the primary economic flywheel, it is necessary to assign concrete logistical values to each element of the war structure—personnel and material alike.

This process begins with a clear and candid description of the sub-systems of such a structure.

THE DRAFT (As military service)

Few efforts of human behavior modification are more remarkable or more effective than that of the socio-military institution known as the draft. A primary purpose of a draft or other such institution is to instill, by intimidation, in the young males of a society the uncritical conviction that the government is omnipotent. He is soon taught that a prayer is slow to reverse what a bullet can do in an instant. Thus, a man trained in a religious environment for eighteen years of his life can, by this instrument of the government, be broken down, be purged of his fantasies and delusions in a matter of mere months. Once that conviction is instilled, all else becomes easy to instill.

Even more interesting is the process by which a young man's parents, who purportedly love him, can be induced to send him off to war to his death. Although the scope of this work will not allow this matter to be expanded in full detail, nevertheless, a course overview will be possible and can serve to reveal those factors which must be included in some numerical form in a computer analysis of social and war systems.

We begin with a tentative definition of the draft.

The draft: (selective service, etc.) is an institution of compulsory collective sacrifice and slavery, devised by the middle aged and the elderly for the purpose of pressing the young into doing the public dirty work. It further serves to make the youth as guilty as the elders, thus making criticism of the elders by the youth less likely (Generational Stabilizer). It is marketed and sold to the public under the label of "patriotic national" service.

Once a candid economic definition of the draft is achieved, that definition is used to outline the boundaries of a structure called a Human Value System, which in turn is translated into the terms of game theory. The value of such a slave laborer is given in a Table of Human Values, a table broken down into categories by intellect, experience, post-service job demand, etc.

Some of these categories are ordinary and can be tentatively evaluated in terms of the value of certain jobs for which a known fee exists. Some jobs are harder to value because they are unique to the demands of social subversion, for an extreme example: The value of a mother's instruction to her daughter to put certain behavioral demands upon a future husband, ten to fifteen years hence, thus, by suppressing his resistance to a perversion of a government, making it easier for a banking cartel to buy the State of New York in, say, twenty years.

Such a problem leans heavily upon the observations and the data of wartime espionage and many types of psychological testing. But crude mathematical models (algorithms, etc.) can be

devised, if not to predict, at least to predetermine theme events with maximum certainty. What does not exist by natural cooperation is thus enhanced by calculated compulsion. Human beings are machines, levers which may be grasped and turned, and there is little real difference between automating a society and automating a shoe factory.

These derived values are variable. (It is necessary to use a current Table of Human Values for computer analysis.) These values are given in true measure rather than U.S. dollars, since the latter is unstable, being presently inflated beyond the production of national goods and services so as to give the economy a false kinetic energy ('paper' inductance).

The silver value is stable, it being possible to buy the same amount with a gram of silver today as could be bought in 1920. Human value measured in silver units changes slightly due to changes in production technology.

ENFORCEMENT

FACTOR I

As in every social system approach, stability is achieved only by understanding and accounting for human nature (action/reaction patterns). A failure to do so can be, and usually is, disastrous. As in other human social schemes, one form or another of intimidation (or incentive) is essential to the success of the draft. Physical principles of action and reaction must be applied to both internal and external sub-systems. To secure the draft, individual brainwashing/programming and both the family unit and the peer group must be engaged and brought under control.

[H: In this instance a good example is to make sure all soldiers feel themselves to be national HEROES. Perchance the damage to the very soldier himself/herself is treated as a badge of being that HERO. His very life is forever changed and in some way or another the individual becomes a cripple, even if just from the experience and LIE itself. If he has butchered a brother and wiped out lives, he knows it and it is not heroism that he feels but the regrets of pure murder. Therefore, it is mandatory to DEFINE the ENEMY so that delineations can be drawn between murder and heroism. In wars such as Viet Nam, however, pure insanity ruled the day and in the chaos, since there was NO enemy as such with threat to the, especially, U.S. homeland, all the brainwashing in the world could not wash clean the minds of the experiencing soldiers. In some instances, in fact MANY instances, the soldiers themselves actually were crippled by the very weapons used to maim and control the so-called "enemy" such as babies and mothers. You have come too far, people, without taking a long and hard look at this and seeing WHO is used as this gun-fodder for the pleasure of the Elite grabbers.]

FACTOR II—FATHER

The man of the household must be housebroken to ensure that junior will grow up with the right social training and attitudes. The advertising media, etc., are engaged to see to it that father-to-be is pussy-whipped before or by the time he is married. He is taught that

he either conforms to the social notch set out for him or his sex life will be hobbled and his tender companionship will be zero. He is made to see that women demand security more than logical, principled, or honorable behavior. By the time his son must go to war, father (with jelly for a backbone) will slam a gun into junior's hand before father will risk the censure of his peers, or make a hypocrite of himself by crossing the investment he has in his own personal opinion or self-esteem. Junior will go to war or father will be embarrassed. So junior will go to war, the true purpose of the war notwithstanding.

FACTOR III—MOTHER

The female element of human society is ruled by emotion first and logic second. In the battle between logic and imagination, imagination always wins, fantasy prevails, maternal instinct dominates so that the child comes first and the future comes second. A woman with a newborn baby is too stary-eyed to see a wealthy man's cannon fodder or a cheap source of slave labor. A woman must, however, be conditioned to accept the transition to "reality" when it comes, or sooner.

As the transition becomes more difficult to manage, the family unit must be carefully disintegrated, and state-controlled public education and state-operated child-care centers must become more common and legally enforced so as to begin the detachment of the child from the mother and the father at an earlier age. Inoculation of behavioral drugs can speed the transition for the child (mandatory). CAUTION: A woman's impulsive anger can override her fear. An irate woman's power must never be underestimated, and her power over a pussy-whipped husband must likewise never be underestimated. It got women the vote in 1920.

FACTOR IV—JUNIOR

The emotional pressure for self-preservation during time of war and the self-serving attitude of the common herd that have an option to avoid the battlefield—if junior can be persuaded to go—is all of the pressure finally necessary to propel Johnny off to war. Their quiet black-mailings of him are the threats: "No sacrifice, no friends; no glory, no girlfriends..."

FACTOR V—SISTER

And what about junior's sister? She is given all the good things of life by her father, and taught to expect the same from her future husband regardless of the price.

FACTOR VI—CATTLE

[H: Try: "Me Khazarian—You cattle." Or even, "Me important 'chosen one'—you a goyim.]"

Those who will not use their brains are not better off than those who have no brains, and so this mindless school of jellyfish, father, mother, son, and daughter, become useful beasts of burden or trainers of the same. **[H: Try: chattel, as in herded cattle or SLAVES.]**

THIS CONCLUDES WHAT IS AVAILABLE (AND WHAT WAS FOUND) OF THIS GOVERNMENT DOCUMENT. [END QUOTING]

Since the statement conflicts with information gleaned from court records and previously published on April 9, 2003 in *CONTACT*, we are obliged to keep the record straight.

So that our readers can discern what is going on here, we will quote the first and second-to-last paragraphs of the short article: "Malacañang yesterday announced it is redoubling its efforts to address the grant of ancestral domain to members of the Moro Islamic Liberation Front for peace talks scheduled next month to succeed," and 'There is nothing greater that I wish for than a complete and lasting peace for Mindanao... A peace that respects the rights and tradition of our diverse ethnic communities in our multi-ethnic society...we shall uphold the Bangsamoro cultural rights and way of life as well as the rights to socio-economic development and ancestral domain,' Mrs. Arroyo said."

Now let us quote from the court record in the section on "Annotations to OCT 01-4". (Annotations are made and attached to the original Deed only upon completion of the legal requirements for the transfer of the subject property.)

Annotation No. PLA-061, S-6-1' 1903. Deed of Assignment absolutely conveyed to Sultanate of Sulu on their Jamalul Kiram heirs, relative of Don

Esteban Benitez Tallano, the whole lands of the Province of Sulu, Lanao, Cotabato, and Zamboanga in favor of the Filipino Muslim brothers and sisters to prevent escalation of hostilities in Mindanao, in compliance to the order of Philippine Commission headed by William Howard Taft.

Other historical records seem to indicate that the suggestion of giving those lands to the "Filipino Muslim brothers and sisters" originated with the Tagean-Tallano owners in which gift the Commission was concurring. Of course, like Mrs. Arroyo, William Howard Taft was not above accepting credit for having given away something that belonged to someone else. We must lament the fact that the Bangsamoro people have fought war after war for more than 100 years—not to "claim" their ancestral lands—but in an effort to keep what was already rightfully theirs. They have been denied the use of their own properties for so long that most of them have forgotten that they already own their land and surely do not need "the grant of ancestral domain" from the Philippine government.

We will take this opportunity to point out an additional circumstance that could also serve to reduce tension and conflict. 

All interested parties have failed to rebut any given allegation or matter of law addressed herein. The position will be construed as adequate to requirements of judicial notice, thus preserving fundamental law. A true and correct copy of this Public Notice is on file with and available for inspection at the newspaper CONTACT which is responsible for publishing the instrument as a legal notice.

September 9, 1996 the Officers and Directors of the Assignee of 50% of the value of PERUVIAN BONUS CERTIFICATE 3392-181 reached an agreement with certain officers of the U.S. Treasury, among whom were Russell Munk and Lawrence Summers (the current Secretary of the Treasury). When those officers refused to sign the agreement, pleading that to do so would not only jeopardize the U.S. Treasury but also the Federal Reserve System, the Assignee converted the agreement to a Public Notice and published it. No objection or rebuttal was ever received from Treasury, or from the FED.

The fourth paragraph of that Agreement/Public Notice reads as follows: *"As a consideration of National Security (as well as Global Security), transactions WITHIN these guidelines will not be interfered with or blocked by the U.S. or its assigns. The consideration for such noninterference is that none of the contracts will be lodged for collection until such time as there is an additional agreement as to the lodging and honoring, through payoff, of the contracts."*

This Public Notice, however, presents the knowledge of ongoing interference from our counterparts to the agreements and the breaking of each and all of those said agreements to varying degrees of diversion tactics of manipulation, delays and actual stone-wall operations. We acknowledge, however, that we find no outright DENIALS of said program or document value, only delays and refusal to provide information regarding same. We have also noted the utilization of such organizations as the World Bank and IMF to effect the rejection of the use of the collateral through intimidation and bribes of central bank personnel. It is our position, therefore, that we are no longer bound by those agreements as published September 9, 1996.

Because they are sensible, however, two of the requirements will continue to be met: the first being the limit of \$5 Trillion per year (beginning in 1996 and thus aggregating \$30 Trillion by January 1, 2001) (this restriction will not apply, however, to project funding within the U.S.A.), and the second being the prohibition of any use of "high yield" or "rollover" trading programs, which we believe are being used to grossly inflate the supply of U.S. dollars in an effort to destabilize the financial system of the U.S.A., and thus the world.

We offer this Public Notice as a status report to the current U.S. Administration, and to the parties who will be moving into the U.S. Government Administration, and to other involved persons in charge of governmental affairs in January 2001. While we realize that most involved persons are very cognizant of current conditions, it is proper that we make an effort to consolidate the record for the sake of accuracy and brevity.

The asset, which is the debt of the U.S. Treasury, guaranteed by the FED, and payable in gold, as valued and established by Messieurs Bush, Herman, Baker, Bentsen and Greenspan, was assigned to Global Alliance Investment Association (GAIA) April 28, 1998. The Uniform Commercial Code procedure for confirmation of the debt was undertaken and the proper notices to all potential interested parties given, and their receipts noted and published. There was no opposition of any kind made to the procedure, which became final and incontestable as of February 16, 1999. (The signatures at the end of this document shall be construed as a Certificate of Non-Response to the UCC notices.) Researchers have been able to easily establish that the original bearer bond, 3392-181, was reconfirmed, then reconformed and reissued as a jurat/contract of identifiable ownership to Cosmos Seafood Energy Marketing Ltd., a corporation set up by its owner and Chairman, Russell Herman. It may be helpful to researchers to know that the owners, officers and directors of Cosmos

are the same as those of GAIA, obviating the need for concern as to the legitimacy of those transfers from Cosmos to GAIA. The asset has been affirmed, albeit by default, as the property of GAIA and is available for use.

To facilitate the distribution of the asset to deserving end-users, it has been determined, upon advice of counsel, to issue portions of the accrued interest in the form of DEEDs OF ASSIGNMENT FOR CONSIDERATION. Such DEEDs are specifically designed to be banking reserves and, for ease of bankers' understanding, are to be treated exactly as is other U.S. Treasury debt, since such debt is widely used as reserves by banks everywhere.

GAIA has issued some 1,200 DEEDs, worldwide, with a total value of several trillion U.S. dollars. Honoring our agreement, none (to our knowledge) have been issued to U.S. entities. That can be changed; GAIA would be willing and able to support such a program in the U.S., given the cooperation of the U.S. Such a program would offer ability for the U.S. to reclaim gold which has been moved out of the country and upon which the value of the dollar can have established and authentic VALUE affixed. As it is, allowing derivative-based, so-called "high yield" trading programs is creating dollars in ever-increasing and uncontrollable amounts. If Alan Greenspan has any claim to managing the "prosperity" of the U.S., it is only that he has held the regulators at bay and prevented them from controlling, or eliminating, the proliferation of derivatives. It is the rapidly expanding money supply that makes such prosperity possible, but without basis it must one day implode. The use of the GAIA asset and the return to a gold standard for the currency would prevent such a catastrophe if implemented in time.

As its name implies, Global Alliance Investment Association intends to become an Association of Allied nations willing to Invest their time and resources, Globally, to achieve financial stability and complete sovereignty. In 1945 the Bretton Woods Agreement established the World Bank and IMF with, ostensibly, similar intentions. Unfortunately, those noble goals have been perverted and the institutions have become instruments of control and collection for the major international banks. While GAIA has no desire to "compete" with the IMF/WB, because it has become so clear that their former beneficiaries became debtors and are now victims to be bled dry, GAIA will have to defend itself from being denigrated for its preference for non-usurious "Islamic-type" banking, or for its recommendation of basing currencies upon gold so that inflation is eliminated and interest rates can be brought to 2-4% as they were in the 1800s and, in the U.S., until the 1940s. High interest rates kill business, put home ownership out of the reach of the masses, and enrich only the already rich.

GAIA intends to offer its collateral as the basis for the creation of many regional "monetary funds" to be maintained under local control, although the overall GAIA program will soon obviate the need for such funds, once the nations taste and feel sovereignty. Such regional funds could be used to free nations from the IMF/WB debt trap by "purchasing" the debt. However, by far the majority of GAIA DEEDs will be issued to all sorts of entities that need additional collateral to enable them to finance peaceful, beneficial projects.

Because the debt to GAIA is payable in gold, and the GAIA program requires that at least 50% of the value of the DEEDs issued be used to purchase gold, and that gold held in the funding bank for the Alliance, the effect is to create substantial reserves that can be drawn upon in emergencies, especially natural disasters. The money would be immediately available, not like the current situation wherein organizations like the UN must beg for the funds.

Crooks Heist Billions From Eviscerated Iraq

CIA ACCUSED OF BANK HEIST

Shortly before U.S. forces began streaming across the Iraqi border, commencing Persian Gulf War II, the CIA and the Department of Defense, with a little help from Israel and some Europeans, pulled off a massive bank heist in Iraq to the tune of several billion dollars.

The CIA and the Defense Intelligence Agency (DIA) are accused by *International Currency Review*, the London-based journal, of mounting a joint ultra-secret operation to electronically remove an estimated \$10 billion out of the Iraqi Central Bank hours before the start of Persian Gulf War II. The whereabouts of the money is not known.

“We believe it is in a secret CIA fund which will be used to mount further special services operations, such as tracking down Saddam Hussein,” said the *Review’s* publisher, Christopher Story.

Story is a former financial advisor to Lady Thatcher when she was Britain’s prime minister. In the past 10 years, he has testified before several congressional committees dealing with financial scandals.

DIA coordinates all intelligence for the Joint Chiefs of Staff. It is headquartered in the Pentagon.

The report is titled “The Great Robbery of the Central Bank of Iraq”. It has been sent to finance ministers of leading nations, the World Bank, the Bank of England and heads of all other major banks.

The report is bound to cause huge embarrassment to President Bush after he signed an executive order on March 23, ordering a worldwide hunt for the hidden assets of Saddam Hussein and his family.

The *Review* claims that using skilled hackers recruited by the DIA and key Iraqi bank officials who had been bribed to provide secret access codes to the Central Bank’s accounts for Saddam Hussein and his family, the money was transferred out of the bank in a high-tech operation.

According to the General Accounting Office (GAO), the investigative agency of Congress, Saddam was estimated to have accumulated “\$6.6 billion between 1997 and 2000 from illegal oil smuggling and from illicit deals connected with the United Nations oil-for-food program.”

But a substantial portion of that money may have been lifted by the secret CIA/DIA operation.

The operation, claims the *Review*, was masterminded by the CIA/DIA out of a military facility, Redstone Arsenal, in Alabama. It is the base for U.S. Special Services.

“The money was laundered through a number of CIA-controlled accounts, including some held in the Discount Bank of Israel, Credit Suisse in Switzerland and the Dresdner Bank in Germany,” said Story.

He confirmed that Germany’s secret service Bundesnachrichtendienst (BND) is checking with the major German banks on electronic transfers, which could match the \$10 billion.

The *Review* states in its 25-page report that it had questioned a key member of the operation. She is identified as “Nelda Rogers, a debriefing officer with the Defense Intelligence Agency”.

“She was in Germany last year when American intelligence officials were devising covert operations ahead of the long-planned conflict. She has revealed that a covert operation targeting the Central Bank of Iraq took place prior to and during the war. The operatives involved were military ‘black operations’ personnel brought into service for this purpose,” said Story.

The *Review* claims that Rogers and a team of ten DIA operatives were financed through the U.S. Department of Agriculture. They were supported by CIA agents in Iraq.

“In all, 100 people were involved in the operation,” says the report. “The Department of Agriculture has been consistently used to hide payments for U.S. covert operations,” claimed Story, whose headquarters are close to Whitehall.

The *Review* states: “The U.S. Department of Agriculture is used as a paymaster for certain DIA ‘black operations’ because it has traditionally remained unscrutinized.”

“Like the Federal Reserve Board and the U.S. Treasury’s secret Exchange Stabilization Fund, the Department of Agriculture is yet another federal agency which benefits from a special exemption from rigorous auditing by the General Accounting Office.”

The *Review* also states it has testimony from Rogers that the operation was designed to “purloin the Iraq Central Bank’s assets ahead of the arrival of U.S. troops in Baghdad. This suggests that the operation was designed for a nefarious purpose, rather than to help use it for the rebuilding of Iraq.”

After interviewing Rogers and “a number of U.S. intelligence operatives”, Story confirmed he received three warnings to stop his investigation.

“I was told that 19 people are very dead as a result of trying to cover what you are exposing,” Story wrote in an editorial in the *Review*.

The *Review* costs \$475 a copy and is one of a small group of titles that Story publishes on financial intelligence for the world banking community.

During the five-hour flight from London, Roland “Tiny” Rowland spooned beluga caviar into his rattrap mouth and sipped vintage Krug champagne. That was

his regular diet on a business trip in his Lear jet. But the delicacies had been sent from Baghdad by the tyrant Rowland was on his way to meet—Saddam Hussein.

And this was no ordinary journey even for the 68-year-old financier with a fearsome reputation as a predator in the city of London, Wall Street and the stock markets of Europe. Rowland was going to cement a deal which would ensure that today—if he is still alive—Saddam is the richest criminal on Earth.

Sitting in his hand-tooled tan leather armchair on board his customized jet, feet resting on a 100-pounds-sterling-a-square-foot carpet, Roland W. Rowland—the name on his gold-embossed business cards—had come a long way from where he had been born in 1917 in a British prison camp in India.

He was the son of a German trader called Fritz Furhop, and his mother was the daughter of a pillar of the English raj who had followed her husband into internment.

Following their release after the end of the “Great War”, Rowland’s Indian nanny had called him “Tiny” even though he was six feet tall. The nickname stuck. Now, it was the only link with his past—those days when he had dug latrines for the British Army in World War II and later was a porter at Paddington railway station.

Those humble beginnings had fed his determination to join the ranks of the rich and powerful. He sold second-hand cars and refrigerators in postwar London. By the time he was 30, he was a millionaire. He began to trade in gold in South Africa.

His fortune grew. He was hired to “sort out” an ailing company called the London and Rhodesia Mining and Land Corporation—Lonhro.

Rowland made it the single most powerful trading company in all Africa. His deals in copper, tin and other metals made him the darling of Lonhro stockholders.

They did not suspect how Rowland had paid off Lord Duncan Sandys, Winston Churchill’s son-in-law and a Tory grandee. Using a secret account in the Cayman Islands, Rowland had given the peer one-half million pounds for helping to buy the largest gold mine in Ghana. When Sandys became mired in a sexual scandal, the prudish Rowland cut him off—refusing to send “even a bunch of flowers” to his funeral in 1987.

Another top Tory, Sir Edward Du Cann—once chairman of the Conservative Party and head of a powerful committee in Parliament—was another victim of Rowland’s ruthlessness.

At the time Du Cann was chairman of Lonhro. Widely tipped to be the next Tory party leader, Du Cann was also a director of a mortgage company—Homes Assured—specializing in lending money to tenants to buy their council houses. The company collapsed. The Department of Trade and Industry branded Du Cann as unfit to be a company director.

Rowland sacked him in hours. He described Du Cann as another “bauble on my Christmas tree”.

No one—however rich and well-connected—was allowed to implicate Rowland. He treasured his image as the quintessential Englishman. Only in the confines of a small circle of right-wing friends did he reveal his anti-Jewish sentiments and contempt for the way Britain was being run.

Already a multimillionaire, Rowland allowed his hatred for socialism to surface during the British crisis with Rhodesia over its determination to challenge the Wilson government regarding Rhodesian self-rule.

Sanctions were introduced against what Prime Minister Harold Wilson called “this pariah state”. It later emerged Rowland broke them. But by then Margaret Thatcher was in Downing Street, and the matter was not pursued.

Rowland looked for new fields to conquer. He bought *The Observer*, a London Sunday newspaper—and tried to use it to support his business interests in Africa. Next he enlisted the notorious arms dealer, Adnan Khashoggi, to broker a deal with Col. Muammar Qaddafi to buy the Metropole hotel chain for 100 million pounds.

Rowland’s ability to use anybody to further his own interests had earlier led to British Prime Minister Ted Heath castigating him as the “unacceptable face of Capitalism”.

Rowland shrugged that off—the same imperious way he dismissed other financiers who came to him with deals. He preferred to work alone, to share with no one his profits—except with his Siamese cats. Every day he fed them the same finest caviar that he ate on his Lear jet as it headed for Iraq on that June day in 1985.

They had curled up at his feet as he worked at his desk preparing his greatest coup yet: securing a slice of Saddam’s vast personal fortune. It had been acquired with the same skill and cunning that Rowland had used to build his own fortune.

SADDAM COMES TO POWER

When Saddam came to power, his pro-West sympathies were welcomed in London and Washington. Their governments, along with those of France and Germany, saw the need to reinforce Iraq’s infrastructure against the looming threat posed by Iran.

Baghdad became a vast bazaar. Massive bribes to secure contracts were common. They were siphoned into Saddam’s accounts. More money flowed there for his cut on deals to build superhighways, hospitals and schools.

Saddam’s relationship with Rowland stemmed from the breathtaking theft of the Shah of Iran’s personal fortune of 2 billion pounds.

In 1979, with the ayatollah about to seize power in Iran, the Shah’s most trusted aides had held secret meetings with the director of the Central Bank of Iraq. Rowland had acted as the go-between.

The Shah agreed to transfer his fortune to Baghdad—beyond the reach of the ayatollahs. Rowland received a “handling fee” of 1.5 percent.

But Saddam, then barely a year in power, transferred the money out of Iraq’s Central Bank to his own numbered accounts with Credit Suisse in Switzerland and a Cayman Island bank. Rowland arranged this, pocketing another handling fee.

Deposed and dying, the Shah ended up in Washington. He asked the U.S. government to help recover his stolen fortune. His plea fell on deaf ears. The road map in the Middle East had once more changed. Washington was openly backing Iraq against Iran.

Rowland had established the ground rules for how Saddam could protect his ill-gotten money. These formed the master plan Rowland was bringing to Baghdad on his Learjet.

On previous flights he had brought Lord Sandys to meet Saddam. Those were the days when Du Cann publicly eulogized Rowland as “the man whose judgment I trust, the man who I love”.

“The presence of Sandys undoubtedly had boosted Rowland’s image in Saddam’s eyes,” an MI-6 agent said.

Du Cann, now 78 years old, lives today outside Paphos on Cyprus. All he has left are his bittersweet memories of his days as a power broker.

“I’ve been out of public life for a long time,” was all he would say as he tended his garden under the blistering midday sun.

Intelligence officers in London, Washington and Tel Aviv have described documents that hint at the extent of the secret network Rowland set up.

One document shows how Rowland used one of his London banks to provide a facility for Iraqi arms dealer, Ibsan Barbouti, to lodge \$500 million of Saddam’s money.

From London, Barbouti helped Libya to build a chemical-warfare plant. When he suddenly died—widely believed to be a victim of one of Saddam’s hit men—the money was transferred from the London bank to the Central Bank of Libya.

Another British intelligence document details how Saddam’s son, Uday, went to Geneva in 1998 to “iron out some financial problems” with Swiss banks who were part of the money-laundering network Rowland had created.

On the eve of the war with Iraq, accompanied by Iraq’s finance minister, Hikmat Misban al-Azzawi—now in American custody—and Saddam’s personal assistant, Abid al-Haimd Mahmood, another of Saddam’s sons, Qusay, produced a handwritten letter from his father saying he was authorized to remove \$1 billion from the bank vaults.

The money was loaded onto a convoy of trucks. U.S. satellite photographs show the convoy heading for the Syrian border.

U.S. troops found \$656 million in dollar bills stuffed inside 164 aluminum boxes in the grounds of one of Saddam’s palaces, along with 100 million euros in an armored car.

Barzan al-Tikrit, Saddam’s half-brother, had tipped off U.S. investigators following the money trail in Baghdad of the whereabouts of 2,000 gold bars worth 500 million pounds. They were confiscated close to the Syrian border.

But these finds are only the tip of Saddam’s secret financial empire.

New York lawyer John Fawcett, who is compiling a report for the Coalition of International Justice, believes the cash was destined for the network of secret accounts Rowland set up for Saddam.

Fawcett has already established some of the links in the network including Russia, Australia and Vietnam.

A U.S. intelligence source said this “could take years to unravel. Rowland was the master of deception. It feels like we have just opened a monstrous financial can of worms.”

TREASURE HUNT

The search for Saddam’s billions has become the greatest treasure hunt since the post-World War II search for Nazi gold.

Intelligence services—led by Israel’s Mossad, MI-6 and the CIA—have deployed scores of agents and financial experts to try and discover the vast fortune Rowland’s master plan enabled Saddam to hide around the world.

A Mossad document, signed by its director-general, Meir Dagan, estimates Saddam’s personal fortune at a staggering \$60 billion.

Over 70 banks are named in the document detailing a money-laundering trail which electronically sped out of Iraq to London, Europe, through Gibraltar, down to South Africa, across the Pacific to Hong Kong on to Japan, up into Russia and back down to the Balkans.

But the specialists—spies, bankers and brokers—trying to follow the trail have all found that Rowland’s built-in safeguards have stood the test of time.

“He used surrogates and cutouts, people in the international banking world. Banks in Eastern Europe, which serviced the KGB and were used to not asking questions, were also used,” confirmed an MI-6 source.

In a memo prepared for the FBI shortly before he died in the World Trade Center attack in September 2001, John P. O’Neill, the FBI executive-agent-in-charge in New York, wrote that Saddam’s money “is almost certainly being laundered through international criminal corporations run by South American drug cartels and the Russian mafia.”

The memo identified Edmund Safra, the billionaire banker who then owned the National Republic Bank in New York, as a “money-laundering conduit for the funds”.

Safra had been a close friend of Rowland who had brought him to Baghdad on at least two occasions. Safra died mysteriously in a fire in his Monaco penthouse in December 1999.

Investigators had found that others who could have helped them follow along the money trail are also mysteriously dead.

One was Janos Pasztor, a Wall Street analyst. He had worked for Rowland. He died on Oct. 15, 2000 of a previously undiagnosed cancer. The week before, his doctor had given him a clean bill of health.

Another conduit through which Saddam’s fortune flowed was the Bank of Credit and Commerce International (BCCI).

Based in London, the now-dissolved bank provided funds for terrorist groups Saddam already supported. It was closed down after City of London regulators discovered its activities.

MI-5 has a fat file on another of the middlemen Rowland used. His name was Cyrus Hashemi. Ostensibly an Arab millionaire playboy, who would spend \$100,000 on the turn of a card at a Mayfair casino and would give doormen Rolex watches for parking his Ferrari, Hashemi allowed his BCCI bank accounts to be used to send Saddam’s money on down the money trail.

The MI-5 intelligence file on Hashemi also says that he was trying to broker a better deal for his services.

On July 16, 1986, Hashemi suddenly collapsed at his Belgravia home and was rushed to a private clinic owned by BCCI. Two days later he was dead.

Scotland Yard’s Serious Crimes Squad investigated. They called in forensic pathologist Dr. Ian West. He said, “Hashemi’s death was one of the strangest I have investigated.”

West sent tissue samples to Porton Down for its scientists to decide if Hashemi had been poisoned. The result of their findings remains unknown to this day.

The location of Saddam’s billions may also remain undiscovered in the foreseeable future. Rowland himself died in 1998, aged 80, after a long fight with cancer.

BREAKING OPEN THE LOCK BOX TO PAY FOR THE WAR IN IRAQ

If Americans wonder whether their country is diving into another Vietnam, the answer is yes—economically if not militarily.

The Johnson and Nixon administrations fought the war in Vietnam with deficit spending. Rather than raise taxes to pay for the war, they paid for it out of federal budget deficits. The result, which lasted long after the war ended, was double-digit inflation, **[JR: Imagine what inflation really is today now that the Feds no longer factor in the cost of gasoline, food and utilities?]** sky high interest rates, a lost decade for investors and a good, stiff recession.

We're doing it again. The Bush administration and its allies in Congress, having already turned the biggest surplus in U.S. history into the biggest deficit, are fighting an increasingly expensive war-after-the-war in Iraq by dipping into government funds that aren't there, making the deficit even bigger.

Whatever happens in Iraq, Americans will be paying for this policy for decades to come. ...

The long-run economic fallout is even worse.

If we're going to be running \$400 billion deficits for years to come, the money has to come from somewhere. It comes, of course from borrowing. The government sells bonds, more and more each year, to foreigners and to Americans. With borrowing to finance about one fourth of all of government spending, that's a lot of bonds.

Will foreigners keep lending? Well, so far so good. During the '90s and into the 2000s, the U.S. economy remained the strongest in the world and the best place to invest. Even as deficits piled up, the foreign money kept coming in.

But foreigners are already financing another American deficit—the trade deficit—to the tune of an additional \$500 billion per year. In economics, nothing lasts forever. Sooner or later, the rest of the world economy will pick up, or the U.S. economy will turn down, or foreigners will just decide they don't want to risk still more American debt. Then they will stop lending. At some point, this is sure to happen; it always does, when a country's debt—even America's—becomes too great.

But the debt will still be there, so we'll still need their money. To get it, we'll have to pay more for it, perhaps a lot more. The price of borrowing, of course, is the interest rate. When lenders want to lend, the interest rate can be low. When they don't want to lend, the rate has to go up.

But it has to go up for everybody—for American businesses and homeowners as well as for foreign lenders. Businesses will have to pay more when they borrow to invest, which means they will invest less. This means slower growth, less expansion, and fewer jobs. **[JR: We are at that point right now.]** It means a stagnant stock market. It could mean a recession.

It also means that mortgage rates will go up, which means fewer people will be buying homes. **[JR: Rates are already going up and home sales are down.]** A strong housing market is the main thing keeping the U.S. economy afloat right now; take that away and this too could mean a recession. ...

Obviously the more the government borrows, the less there is for private business. This is called "crowding out", which means that money that would normally go to business gets crowded out by government borrowing. **[JR: I don't think this is a problem because businesses aren't expanding and the tax cuts are going to investors.]** Once again, business borrow less and invest less and hires fewer people, who buy fewer goods.

Of course business can still borrow. But the money will be scarce and more expensive—those interest rates again. This always happens when there are too many borrowers competing for too little money. When money is more expensive, business becomes more expensive, so less of it gets done. ...

The administration said it got caught in the perfect storm of recession and war, and that accounts for all the sharp turn around from surplus to deficit.

But this isn't true. Most of this pain is self-inflicted.

Apart from the recession, the war on terrorism and other post-Sept. 11 spending have added about \$90 billion to the budget, the CBO figures. **[JR: The CBO evidently has very lax accounting procedures because they have failed to put out the warning flags and reign in government spending.]** Other increased governmental spending has also gone up, by about \$80 billion, **but much of that has gone to the Pentagon.**

The lion's share of the turn around—\$375 billion this year, \$515 billion next year—is the result of Bush's tax cuts.

These cuts have been justified as the best and quickest way to stimulate the economy and create jobs, but this isn't true either. Some 80% to 90% of the cuts benefit the wealthiest 10% who are more likely to save the money, while the bottom 60%, who are likely to spend it, got only 7% of the benefit. ...

Certainly, the cuts haven't done much for jobs. The unemployment rate has climbed from 4.1% to 6.2% in the past two years. As things stand now, Bush will be the first president since Herbert Hoover to preside over a net loss in private sector jobs. **[JR: At least then, American jobs weren't sent overseas.]**...

But the real pain lies down the road, when the deficits begin crippling the nation's economy. The Nobel Prize-winning economist Robert Solow has warned that at some point, the deficits may even force the U.S. government to do something it has never done—default on its loans.

This can't go on. ...

This is the time bomb beneath the U.S. economy. Like most time bombs, it will go off sooner or later.

[JR: The hordes from the Federal Reserve and the IRS make it their business to know what is left in your wallets and bank accounts. Maybe when Americans are made as poor as the U.S. and the Elite banksters have made the rest of the world, they might sit up and take notice.]

BREMER: IRAQ EFFORT TO COST TENS OF BILLIONS

Iraq will need "several tens of billions" of dollars from abroad in the next year to rebuild its rickety infrastructure and revive its moribund economy, and American taxpayers and foreign governments will be asked to contribute substantial sums, U.S. occupation coordinator L. Paul Bremer said yesterday.

Bremer said Iraqi revenue will not nearly cover the bill for economic needs "almost impossible to exaggerate". Just to meet current electrical demand will cost \$2 billion, Bremer said, while a national system to deliver clean water will cost an estimated \$16 billion over four years.

The figures, which must be added to the \$4 billion the Pentagon spends each month on military operations in Iraq, offer the latest evidence that the price of the Iraqi occupation is growing substantially. A State Department official said the Bush administration is preparing to seek a "huge" supplemental spending bill from Congress. Administration sources also said the U.S.-controlled Coalition Provisional Authority is running so low on funds that the White House is considering seeking an emergency infusion next month to cover the organization's bills. ...

To tap one source of cash, a "very intense dialogue" is underway with Iraq's 25-member governing council about the need to open the country to foreign investment, Bremer said. That includes deciding the fate of 192 state-owned enterprises—most significantly the oil industry, which Bremer believes should remain in Iraqi hands. ...

Covering a range of topics, Bremer described a "massive undertaking" to get Iraq functioning again. He said the project will take years and countless billions of dollars, but he described conditions in Iraq as better and more hopeful than the media often suggest. "I keep reading stories about it's a country in chaos. This is simply not true Bremer said," "It is not a country in chaos, and Baghdad is not a city in chaos." **[JR: Is Bremer admitting what we all know: that the media lies to us—and that the news is based on fabrications and has no basis in truth? WOWEEEE!]**

Bremer said it will take until next summer for the Coalition Provisional Authority to meet Iraq's daily 6,000-megawatt electricity demand—longer, if sabotage continues on the country's 19,000 kilometers of power lines. He said the country is producing about 3,300 megawatts, less than the 4,000-megawatt prewar average.

Calling electric power "in many ways the key to reconstruction", he said authorities have ordered a 400-megawatt generator for Baghdad, plus 1.5-megawatt emergency generators for 36 water pumping stations. Engineers have told him Iraq should spend \$13 billion over five years to put the aged system in good order.

Oil revenue is lower than U.S. planners had hoped, afflicted by antiquated facilities, power shortages and severe looting. Bremer said Iraq produced 1.7 million barrels on Monday, down from a prewar range of 2.5 million to 3 million barrels a day. His goal is to return production to prewar levels by October 2004.

Even when Iraqi deliveries return to 2002 levels, the industry will not produce enough revenue for reconstruction, Bremer said. The Bush administration is preparing for a donors conference in Madrid in October, where it hopes to raise significant sums from around the world.

Some potential contributors have said they are uncomfortable with the amount of control exercised over Iraq by the United States. Bremer maintained, however, that his office plays an effective coordinating role and delivers help where it is needed. He said 15 countries have representatives on the Baghdad-based Council for International Coordination, which reports to him. ...

On other matters, Bremer said the United States is prepared to deliver 37 former Iraqi leaders in U.S. custody to a new government once a court has been established and charges filed. He said Iraqis are drafting a proposal for a special five-judge court staffed by Iraqis. ...

"We're anxious for them to be seen trying their own people," Bremer said.

"We have a noble task before us," Bremer said. "It's difficult, it's costly, but it's absolutely achievable. I wouldn't be there if I didn't believe that we could succeed. I'm optimistic about the future of Iraq."

[JR: Bremer is putting his own (Kol Nidre) spin in defense

U.S. SUSPECTS IT RECEIVED FALSE IRAQ ARMS TIPS

WASHINGTON—Frustrated at the failure to find Saddam Hussein's suspected stockpiles of chemical and biological weapons, U.S. and allied intelligence agencies have launched a major effort to determine if they were victims of bogus Iraqi defectors who planted disinformation to mislead the West before the war.

The goal, according to a senior U.S. intelligence official, "is to see if false information was put out there and got into legitimate channels and we were totally duped on it." He added, "We're reinterviewing all our sources of information on this. This is the entire intelligence community, not just the U.S." [JR: Instead of using the term "intelligence" they should be calling it ignorance.]

The far-reaching review was started after a political firestorm erupted this summer over revelations that President Bush's claim in his State of the Union speech that Iraq had sought to import uranium from Niger was based on forged documents.

Although senior CIA officials insist that defectors were only partly responsible for the intelligence that triggered the decision to invade Iraq in March, other intelligence officials now fear that key portions of the prewar information may have been flawed. The issue raises fresh doubts as to whether illicit weapons will be found in Iraq.

As evidence, officials say former Iraqi operatives have confirmed since the war that Hussein's regime sent "double agents" disguised as defectors to the West to plant fabricated intelligence. In other cases, Baghdad apparently tricked legitimate defectors into funneling phony tips about weapons production and storage sites.

"They were shown bits of information and led to believe there was an active weapons program, only to be turned loose to make their way to Western intelligence sources," said the senior intelligence official. "Then, because they believe it, they pass polygraph tests... and the planted information becomes true to the West, even if it was all made up to deceive us."

Critics had charged that the Bush administration exaggerated intelligence on Iraq to bolster support for the war. The broader question now is whether some of the actual intelligence was fabricated and U.S. officials failed to detect it.

One U.S. intelligence official said analysts may have been too eager to find evidence to support the White House's claims. As a result, he said, defectors "were just telling us what we wanted to hear".

Hussein's motives for such a deliberate disinformation scheme may have been to bluff his enemies abroad, from Washington to Tehran, by sending false signals of his military might. Experts also say the dictator's defiance of the West, and its fear of his purported weapons of mass destruction, boosted his prestige at home and was a critical part of his power base in the Arab world.

Hussein also may have gambled that the failure of United Nations weapons inspectors to find specific evidence identified by bogus defectors ultimately would force the Security Council to lift sanctions imposed after the 1991 Persian Gulf War. U.S. officials now believe Hussein hoped to then covertly reconstitute his weapons programs. ...

The current focus on Iraqi defectors reflects a new skepticism within the Iraq Survey Group, the 1,400-member team responsible for finding any illicit arms. In interviews, several current and former members expressed growing disappointment over the inconclusive results of the search so far.

"We were prisoners of our own beliefs," said a senior U.S. weapons expert who recently returned from a stint with the survey group. "We said Saddam Hussein was a master of denial and deception. Then when we couldn't find anything, we said that proved it, instead of questioning our own assumptions."

The survey group is jointly led by David Kay, a former UN nuclear inspector who was named a CIA special advisor in June, and Army Maj. Gen. Keith Dayton, who headed the "human intelligence" service at the Defense Intelligence Agency. Kay has said he will issue a preliminary report next month. ... [JR: So this David Kay was a CIA agent while he was on the UN nuclear inspection team. Evidently Saddam was right when he accused the U.S. of having embedded spies on the UN inspection teams.]

Secretary of State Colin L. Powell quoted several defector accounts in February, when he presented U.S. findings to the United Nations Security Council in an unsuccessful bid to win broad backing for military action in Iraq. But Powell also cited spy satellites, electronic intercepts of telephone and other communications, reports from UN inspectors and other intelligence sources.

Some defectors have come under fire previously. U.S. experts have long questioned the value of informants provided by pro-invasion Iraqi opposition groups in exile, saying they routinely padded their resumes or exaggerated their knowledge in exchange for asylum, visas or money. [JR: This whole scheme of Iraqi WMD was orchestrated by the exiled renegade Iraqi National Congress to convince the U.S. to invade Iraq and install Chalabi and his National Congress as the new Iraqi government.]

The CIA and the State Department, in particular, distanced themselves from Iraqi defectors handed over by the Iraqi National Congress, a London-based umbrella group headed by Ahmad Chalabi. CIA and State Department officials repeatedly warned that the group's intelligence network had proved unreliable in the past. [JR: But neither Bush nor Blair heeded that warning because this bogus "intelligence" fit their invasion agenda.]

Senior Pentagon officials, however, supported the former Iraqi banker's bid as a possible successor to Hussein. Chalabi, who now sits on the U.S.-appointed Iraqi Governing Council in Baghdad, has said his group provided the Defense Intelligence Agency with three defectors who had personal knowledge of Hussein's illicit weapons programs.

One, an Iraqi engineer, told the DIA in 2001 that he knew the location of biological weapons. However, no bioweapons have been found at the sites he named. ...

[JR: Had the U.S. given these sites to the UN inspection teams, they would have been proven false back in 2001. Instead the U.S. claimed "intelligence security" and it wasn't proven wrong until after the invasion of Iraq, the

unjustified deaths of thousands, the massive destruction of Iraq's infrastructure and the surge of animosity and massive additional hatred against the U.S. throughout the world.]

The CIA launched its own internal review of intelligence in February before the war but did not re-interview defectors. The four-member panel, headed by Richard Kerr, former CIA deputy director, has only reviewed "finished" intelligence, not the "raw" reports that form their basis. The panel is awaiting the Iraq Survey Group report before judging whether CIA assessments were on target. ...

With the Iraq Survey Group still at work, CIA and Pentagon officials declined to make Kay or Dayton, its leaders, available for interviews. But other survey group members, who spoke on condition of anonymity because of security clearances they are required to sign, said the evidence reviewed so far—including more than 30-million pages of documents—still doesn't support charges that Hussein secretly built chemical and biological weapons after UN inspectors were forced out of Iraq in 1998, as the Bush administration repeatedly warned.

"I haven't heard anyone run into the SOC [Survey Operations Center] saying, 'Eureka! We found the smoking gun,'" said a senior survey group member. "It's all still murky as hell."...

DUST AND DECEPTION

Last week a quietly scathing report by the inspector general of the Environmental Protection Agency confirmed what some have long suspected: in the aftermath of the World Trade Center's collapse, the agency systematically misled New Yorkers about the risks the resulting air pollution posed to their health. And it did so under pressure from the White House.

The Bush administration has misled the public on many issues, from the budget outlook to the Iraqi threat. But this particular deception seems, at first sight, not just callous but gratuitous. It's only when you look back at budget politics in 2001 that you see the method in the administration's mendacity.

A draft EPA report released last December conceded that 9/11 had led to huge emissions of pollutants. In particular, releases of dioxins—which are carcinogens and can also damage the nervous system and cause birth defects—created "likely the highest ambient concentrations that have ever been reported"—up to **1,500 times normal levels**. But the report concluded that because the outdoor air cleared after a couple of months, little harm had been done.

In fact, the main danger comes from toxic dust that seeped into buildings and remains in carpets, furniture and air ducts. According to a recent report in *Salon*, businesses that did environmental assessments of their own premises found alarming levels not just of dioxins but also of asbestos and other dangerous pollutants. So the most shocking revelation from the new report is that under White

House direction, the EPA suppressed warnings about indoor pollution. Scattered evidence suggests that as a result, hundreds of cleaning workers and thousands of residents may be suffering chronic health problems.

Why was crucial information withheld from the public? The report mentions “the desire to reopen Wall Street [**JR: Right on target!**] and national security concerns”. [**JR: How is that even remotely related to suppressing hazardous pollution levels?**] Maybe—though the national security benefits of failing to remove toxic dust escape me. I suspect that there was another reason: budget politics.

Immediately after 9/11 there was a great national outpouring of sympathy for New York, and a natural inclination to provide generous help. President Bush quickly promised \$20 billion, and everyone expected the federal government to assume the burden of additional security. Yet hard-line Republicans never wanted to help the stricken city. Indeed, according to an article by Michael Tomasky in *New York magazine*, Senators Phil Gramm and Don Nickles attempted to slash aid to New York within hours of Mr. Bush’s promise.

Matters were patched up sufficiently so Mr. Bush could make his triumphant appearance at ground zero the next day. But then the backtracking began. By February 2002, only a fraction of the promised funds had been allocated—and Mitch Daniels, the White House budget director, accused New York’s lawmakers of playing “money-grubbing games”. ...

What does all this have to do with toxic dust? Think how much harder it would have been to stiff New York if the public had understood the extent to which Lower Manhattan had become a hazardous waste site. I can’t prove that was what administration officials were thinking, but otherwise their efforts to play down the risks seem incomprehensible.

In the end, New York seems to have gotten its \$20 billion—barely. As for the additional help everyone expected: Don’t get me started. There wasn’t a penny of federal aid for “first responders”—like those firefighters and police officers who cheered Mr. Bush at ground zero—until a few months ago, and much of it went to sparsely populated states. The federal government spends much more protecting the average resident of Wyoming from terrorists than it spends protecting the average resident of New York City. [**JR: That is open to a really BIG debate. The Middle states aren’t even on their maps.**]

All in all, the people running Washington, while eager to invoke 9/11 on behalf of whatever they feel like doing, have treated the city that bore the brunt of the actual attack very shabbily. In September 2004 the Republicans will hold their nominating convention in New York. Will New Yorkers take the occasion to remind them about how the city was lied to and shortchanged? [**JR: Well if New York “got stiffed” by Bush, then Mr. Silverstein the owner of the Twin Towers has to be the major beneficiary. Mr. Silverstein is now in a position to build two sets of Twin Towers (if he so chooses), with his settlement from the insurance companies and all the homeowners across America, who have seen increases in their insurance premiums. The homeowners also got assessed for the insurance company’s investment losses when Wall Street imploded. The rescue workers and cleanup crews who worked at ground zero are paying a heavy price for their valiant efforts. After two years 48% have been experiencing prolonged health problems, 56% psychological problems and 30% pulmonary problems. What really matters is that the tourist industry and the Broadway theatre district have made a comeback and are making a profit. The bottom line is that MONEY is the engine that drives New York City and not the contributions of the dedicated heroes of 9/11, or the sacrifices of the families of the victims. This is how it appears to those of us who haven’t taken a bite out of the Big Apple.**]

ISRAEL CRACKS DOWN ON FOREIGN WORKERS

With unemployment figures set to soar to more than 300,000, Israel’s finance ministry is pushing through plans for a massive crackdown on foreign workers.

Yellow flyers are breathing fear into many of Tel Aviv’s poorer neighborhoods, as they warn immigrant workers to leave Israel or face the wrath of the deportation police.

“Dear families. Do not let us arrest you... Please go to the Immigration Administration and arrange the date of your flight without delay,” reads one flyer.

Failure to have done so before the 1 September deadline would result in “law enforcement activities and arrests against families”, it warned.

A brief extension of the deadline now gives family members until 10 September to register.

The move has provoked outrage among human rights workers who say the arrest and deportation of women and children is illegal and will tear families apart.

But the Immigration Administration (IA), a body set up in June 2002 and tasked with rounding up and expelling illegal workers, said the government wanted to encourage families “to leave the country with dignity”.

“Dealing with women, little children and babies is very complicated,” IA spokeswoman Orit Friedman said.

“It will be very hard to take these people to prison [**JR: Why a prison?**], so we’re trying to get them to voluntarily leave the country with dignity.”

Last week Finance Minister Benjamin Netanyahu told parliament: “It is not true there are no jobs. There are 300,000. They just need to be vacated for Israelis.” Official figures estimate there are 300,000 foreign workers in Israel, of whom 60% are thought to be illegal.

Half are from China, Thailand and the Philippines, 45% are from Eastern Europe, and the rest are from Africa and Latin America.

Most do jobs which Israelis refuse to do, such as work in construction or agriculture, and around a fifth work as careers for the elderly. ...

Despite the 10 September deadline, Friedman says the IA may still extend the registration period.

“After that, we may extend it again or move to stage two: arresting the fathers and forcing them to register the mothers and children,” she said.

“If that doesn’t work, we are going to arrest families.”... [**JR: Now where have we heard that familiar phrase?**]

Threats of a crackdown have provoked a slew of outraged editorials in the Israeli press.

“How did a people who virtually invented the concept of labour fairness come to be so exploitative,” the conservative *Jerusalem Post* said, citing a Biblical command to treat foreign workers with respect.

But even families who have registered with the IA are finding themselves under renewed threat of arrest as they cannot afford to pay their way home.

“They’re now threatening to arrest those who did register but who don’t have the money to pay their way home,” said Rosen. [**JR: That is not the Zionists’ problem, is it?**]

The trade in foreign workers remains a lucrative business which lines the pockets of many of Israel’s biggest agriculture and construction companies.

Figures published last week by the International Federation for Human Rights and the Euro-Mediterranean Human Rights Network show that a Chinese construction worker seeking work in Israel pays between 6000 and 10,000 dollars.

That sum would be divided between a Chinese agency, the Israeli employers or their agency, the Israeli government (for visa fees) and the travel company.

[**JR: When a country develops problems—whether they**

evolve from an economic or military situation—those with temporary status are the first to feel the stings of change caused by the government’s failed policies. The expulsion of these foreigners is a short-term fix for what may become a long-term problem. How many Israelis will stand in line to fill the jobs done by the exiting foreign workers? Maybe the Israeli government has a Patriot Act to force unwilling Israelis into compliance. Desperate times call for desperate measures and all governments know when to lower their hammer of power.]

CHENEY’S EX-FIRM GIVEN \$1.7 BILLION FOR SERVICES

WASHINGTON—Halliburton, the company formerly headed by Vice President Dick Cheney, has won contracts worth more than \$1.7 billion in connection with the war in Iraq and stands to make hundreds of millions more dollars under a no-bid contract awarded by the U.S. Army Corps of Engineers, according to newly available documents.

The size and scope of the government contracts awarded to Halliburton are significantly greater than previously disclosed and demonstrate the U.S. military’s increasing reliance on for-profit corporations to run its logistical operations. Independent experts estimate that up to one-third of the monthly \$3.9 billion cost of keeping U.S. troops in Iraq is going to independent contractors.

Services performed by Halliburton, through its Brown and Root subsidiary, include building and managing military bases, **logistical support for the 1,200 intelligence officers hunting for Iraqi weapons of mass destruction, [JR: How intelligent can they be? They have yet to find any WMD even with our supposedly verifiable sites and bogus piles of evidence.]** delivering mail and producing millions of hot meals. [**JR: Are these the hot meals for the VIPs in Baghdad and Kuwait? Our military troops in Iraq are lucky if they get water to drink and decent quarters to sleep in.]**

Spreadsheets drawn up by the Army Joint Munitions Command show that about \$1 billion had been allocated to Brown and Root Services through mid-August for contracts associated with the war in Iraq. In addition, the company has earned about \$705 million for an initial round of oil field rehabilitation work for the Army Corps of Engineers, a corps spokesman said.

Specific work orders assigned to the Halliburton subsidiary include \$142 million for base camp operations in Kuwait, \$170 million for logistical support for the Iraqi reconstruction effort and \$28 million for the construction of enemy prisoner of war camps, the Army spreadsheet shows. The company also was allocated \$39 million for building and operating U.S. base camps in Jordan, the existence of which the Pentagon never publicly acknowledged.

Halliburton has emerged as the biggest single government contractor in Iraq, followed by Bechtel, a California-based engineering firm that has won hundreds of millions of dollars in U.S. Agency for International Development reconstruction contracts, and Virginia-based DynCorp, which is training the new Iraqi police force.

BOEING CO.: \$2.5 BILLION DEAL
TO DELIVER SMALL BOMBS OVER 15 YEARS

WASHINGTON (*Reuters*)—Boeing Co. beat out Lockheed Martin Corp. to develop and build a new 250-pound bomb for the U.S. military in a deal worth \$2.5 billion over 15 years, the U.S. Air Force said Thursday.

Marvin Sambur, chief of acquisitions for the Air Force, said Chicago-based Boeing would receive an initial contract for development and demonstration of the new small-diameter bomb later this year.

“You can fit more internally or externally, so it’s more cost efficient, more lethal—the whole package,” Boeing spokesman Bill Barksdale said. “What it really does is help the war fighter pick a weapon that is very versatile.”

Sambur said the contract still needed to be approved by the Pentagon’s Defense Acquisition Board, which is scheduled to review the matter in October.

“During the next 15 years, **the Air Force intends to procure 24,000 weapons [JR: Is this part of our goal to bring peace and order to the world?]** and 2,000 carriage systems at a total cost of approximately \$2.5 billion,” the service said.

Boeing said work on the new bomb would be carried out at its production facility in St. Charles, Mo., with the first delivery scheduled in October 2005. The bomb will be carried first on the F-15E and subsequently on the F/A-22 or F-35. **[JR: Military spending was a major factor in boosting up the profits for the second quarter on Wall Street. Spending for national defense is up a whopping 45.9%, and is the biggest gain for war-related industries since 1951! War is deficit spending—and the only companies raking in the profits and enjoying the good times are those close to Bush, Cheney and the war mongrels at the Pentagon. EUROPE TAKES STEP FOR A JOINT MILITARY

PARIS—Four European countries announced plans Tuesday to establish a European Union military planning center that does not involve NATO. A controversial mini-defense summit in Brussels brought together representatives from France, Germany, Luxembourg and Belgium.

Besides plans for building the new European military center, the four countries outlined proposals to create a joint rapid reaction unit, and a European command center for strategic air transport. They also made plans, among other things, to cooperate in fighting chemical and biological threats, in responding to disasters, and in coordinating arms purchases.

At a news conference following the summit, the four leaders stressed those plans were not designed to rival or to undermine European cooperation or the NATO alliance.

The four leaders insisted that NATO remains a cornerstone of European defense policy.

Though not all E-U countries were invited to the Brussels summit, Belgian Prime Minister Guy Verhofstadt said he expected the other 11 European Union members would welcome the seven proposals outlined at the summit. ...

But critics have already attacked the closed-invitation mini-summit—which did not include key European countries like Britain. Observers say the summit’s proposal to create a new security and defense union for Europe may actually hinder efforts to create a united European approach to defense.

British Prime Minister Tony Blair recently warned against proposals that might hinder efforts to create a common European defense, or undermine military relations with the United States. ...

Three of the summit’s participants—Belgium, Luxembourg and Germany—are among the smallest military spenders in NATO. France, however, is second only to Britain in European military expenditures, earmarking about two-point-five percent of its gross domestic income on the military last year. **[JR: This new initiative to build an additional European military presents some puzzlement. Is this Brussels’ way of protecting the continent from future U.S. hostilities? Does part of Europe have doubts about NATO and the UN because of the undue influence that Britain and the U.S. exercise in deciding future endeavors? Maybe Brussels is putting the rest of Europe on notice that it must gain its own independence from the American and British Empire builders—or risk becoming one of their satellite nation states.]**

RUSSIA SEEKS TO EXPAND
ECON/POLITICAL PRESENCE IN SAUDI ARABIA

MOSCOW—Russia is interested in expanding its economic and political presence in Saudi Arabia, Russian Energy Minister Igor Yusufov said.

He said Russia “is very interested in expanding its economic and political presence in Saudi Arabia.”

Speaking at a joint press conference with Saudi Arabian Oil Minister Ali ibn Ibrahim al-Nuaimi on Wednesday, the Russian minister said now the companies of the two countries are preparing several projects.

Yusufov, who is leading an intergovernmental commission on cooperation, said Russian companies show greater interest in a project to build a railway linking Riyadh to Jiddah. “We have much experience in working out such projects. Today we’ve agreed with the leadership of the Saudi Arabian delegation that the interested agencies will hold talks on this issue,” Yusufov said.

In addition, the minister said Russia is seeking to join Saudi Arabia’s gas initiative. According to Yusufov, “It includes projects of gas extraction, prospecting of new fields and construction of petrochemical complexes.”...

The Saudi oil minister pointed out that the two countries concluded a framework agreement on cooperation in the gas and oil sector. He stressed that this document should ease the activity of Russian companies on the Saudi Arabian market.

A Russian-Saudi consortium will be one of the first projects in this field, the minister added.

[JR: Russia and Saudi Arabia have already signed onto an oil agreement when Crown Prince Abdullah met with President Putin in Moscow. This is evidently just one of several joint business ventures between Russia and the Saudis. This special occasion also marked the first visit of a Saudi ruler to Russia since 1932. The Saudis are venturing to establish agreements outside the U.S. sphere of influence to strengthen their own position and for their own survival and protection. The U.S. has a tendency to become rather contentious when its allies balk at supporting our wars. You never know when our own neo-terrorists Rumsfeld or WOLFowitz will place the Saudis at the top of their terrorist hit list for supposedly hiding Saddam, bin Laden or supporting the Taliban.]

U.S. TO POLICE HIGH SEAS FOR WMD

The United States is firming up plans to intercept ships suspected of carrying weapons of mass destruction, overriding concerns voiced by China.

A top Washington arms control official said that the United States together with Australia, Japan and France will send ships to the Western Pacific next week for an exercise simulating an interception.

Next week’s “Pacific Protector” exercise is the first of 10 planned in coming months.

But the official rejected concerns that the initiative breached international law and said the participating states **[JR: Note NWO term for countries and nations.]** had agreed on a set of guidelines on how they would carry out interceptions of ships.

“What we intend to do is consistent with national and international authorities,” John Bolton, the U.S. Under Secretary for arms control and international security said. **[JR: Is the implication here that the U.S. is now in charge of some yet-undefined international security on the high seas?]**

“Where we think we may have gaps in that authority, we are willing to consider seeking additional authorisation,” he said. **[JR: If not, the U.S. can make up new rules as it goes along.]**

But China remained sceptical of the U.S.-initiative to police the high seas and attacked the plan as legally dubious.

“The best way to prevent proliferation of weapons of mass destruction is through dialogue,” Chinese Foreign Ministry spokesman Kong Quan said.

“We understand the concerns of some countries about the proliferation of weapons of mass destruction ... but many countries still question the efficiency and legitimacy of adopting this kind of measure,” he added.

Though not aimed specifically against North Korea, there is little doubt that the reclusive [state] is the prime target of the U.S. plan.

In a high-profile incident last December, Spain had intercepted a North Korean ship in the Arabian Sea carrying Scud missiles for Yemen. The seized vehicle was handed over to the U.S.

Washington later allowed the ship to continue its voyage after concluding the missile shipment did not break any laws.

[JR: These joint high-seas “exercises” are being used as a form of harassment to goad countries like Korea and China whom we regard as being uncompromising and uncooperative. I wonder how many of our U.S. ships are cruising in the South China Sea carrying our WMD? What would happen if China and Russia decided to form their own international security and carry out their own maritime “exercises” to inspect our ships?]

FED CHIEF DEFENDS FLEXIBLE-RATE VIEW

JACKSON HOLE, Wyoming—Federal Reserve Chairman Alan Greenspan made it clear Friday that human judgment should reign in the central bank’s interest rate decisions if it is to act swiftly against potential economic risks.

In a speech at a Fed conference here, Greenspan argued against proposals that would force the Fed to use a hard-and-fast rule, such as changes in a specific inflation rate, to decide when and how much to change interest rates.

Greenspan said the Fed has deliberately shied away from a specific rule to set interest rates because one couldn’t adequately respond to economic uncertainties.

For example, he said, the central bank now is seeking to control deflation even though most conventional economic models on which a rule might be based “would not project such an event.”

Many critics of Greenspan’s 16-year career at the central bank would like to see a less personalized

decision-making process by the Fed after he leaves, arguing that the chairman has erred at critical points in raising interest rates that harmed the economy.

Greenspan has, in fact, become an economic leader of so much celebrity that the market's fortunes are at times affected by his every utterance. [That's because of the confusion generated by his "utterances" that most market gurus misinterpret as to what he actually meant. Perhaps his intended purpose is to confuse—and many don't like to feel ignorant by having to ask him what he actually meant.]

The support for a formal inflation target to guide Fed policy is gaining support, said Lyle Gramley, a former member of the central bank. But he said that as long as Greenspan is chairman, it is not likely to happen. After he leaves, it could be adopted, he added. ...

An inflation rule would work something like this: The Fed would announce a specific inflation figure that it wanted to maintain over the long run—say 1.5 percent to 2.5 percent. When official inflation figures moved too low, the central bank would cut interest rates. When they rose above the target, the Fed would raise interest rates.

Adoption of a formal rule would fundamentally change the nature of Fed monetary policy, which has been largely flexible for much of its 90-year history. Indeed, the Fed chairman is viewed as the second most powerful official in Washington and is widely seen as both an economic and political figure who must answer for the economy's broad performance. ...

But Greenspan said he wanted nothing of a mechanical, mathematical approach linked to changes in monetary policy, which has a broad impact in the economy and around the world. He said it was "highly doubtful" that such an approach would lead to better economic performance, since some economic indicators are often replete with error.

In effect, he said, making monetary policy is an art, not a science.

He said he favored the current flexibility and discretion of Fed members in which they "draw from broader, though less-mathematically precise, hypotheses of how the world works" and can deal with the remote, though extremely dangerous, prospect of deflation, or falling prices.

The central bank has no real restrictions on its interest-rate policies, which are often hotly debated by Federal Reserve members.

The Fed currently conducts its policies by setting a target for the overnight lending rate that banks charge each other for loans. It then pumps money into the economy to ensure the interest rate remains at that target. [JR: In simple layman's terms—this is obviously manipulation of the economy.]

Though the issue over a hard-and-fast rule seems arcane, it carries weight in financial markets where many analysts now say that they are having a hard time figuring out Fed policy with interest rates so low.

Indeed, when the Fed last cut short-term interest rates, long-term bond rates rose because many in the market felt that inflation might kick up as a result. Silvia said markets now want to see the Fed name some specific inflation rate that it would consider to be too low.

Fred Breimyer, chief economist at State Street Bank in Boston, said Greenspan made clear that "he had no ability to adopt a rule-based monetary policy because the economic conditions are constantly changing."

[JR: The reason Greenspan deliberately shied away from a specific rule to set interest rates is because he wants to be able to manipulate interest rates and therefore the economy, at any given moment. If there were specific rules, then anyone following those rules could probably do better than him... it's called job security. Greenspan may have said, "... making monetary policy is an art, not a science," but his real talent is his ability to confuse and keep his critics off balance or even off the books.]

NEVADA CORPORATIONS:

Another Privacy Measure: "Uncertificated" Stock

Budget's "Tip of the Week" #19:

NRS 78.235: "Issuing Stock" Without a Certificate

Another special provision of Nevada's corporate laws is the ability to use what the statutes refer to as "uncertificated" stock. That's right, here in Nevada it is perfectly permissible to have "phantom" stock certificates. And now you know why our Budget kit leaves out the stock certificates, which are not needed to operate your corporation fully within the law.

As a general rule of good Nevada corporation management (maintaining privacy of ownership), it is often better to not issue stock, relying on NRS 78.197 (which specifies that debt holders may have the rights of stockholders). But when stock must be issued, why not issue phantom certificates? Note that Section 5 of NRS 78.235 (excerpts below) requires that the corporation "shall send the stockholder a written statement containing the information required on the certificates". This provision is obviously intended to protect the interests of the stockholders for other than one-person corporations and it is hard to imagine running into any problems for failing to notify yourself in writing once a year. Note that the corporation's bylaws could be written to waive any penalty for failure of notification.

NRS 78.235 Stock certificates: Validation; facsimile signatures; uncertificated shares and informational statements; replacement.

....4. Unless otherwise provided in the articles of incorporation or bylaws, the board of directors may authorize the issuance of uncertificated shares of some or all of the shares of any or all of its classes or series. The issuance of uncertificated shares has no effect on existing certificates for shares until surrendered to the corporation, or on the respective rights and obligations of the stockholders. Unless otherwise provided by a specific statute, the rights and obligations of stockholders are identical whether or not their shares of stock are represented by certificates.

5. Within a reasonable time after the issuance or transfer of shares without certificates, the corporation shall send the stockholder a written statement containing the information required on the certificates pursuant to subsection 1. At least annually thereafter, the corporation shall provide to its stockholders of record, a written statement confirming the information contained in the informational statement previously sent pursuant to this subsection....

When added to the mix of other privacy-of-ownership provisions available in Nevada, it is easy to see why it is impossible for anyone on the outside of the corporation to know who owns it—unless the owner tells them. Combining "uncertificated" stock with the concept of bearer shares, it is fully understandable how ownership of a Nevada corporation can change hands merely through entries made in its stock ledger, without any need for recourse to stock certificates.

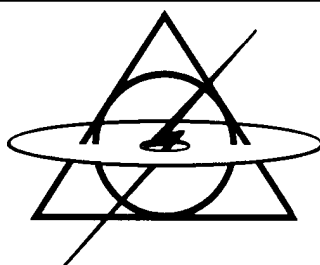
