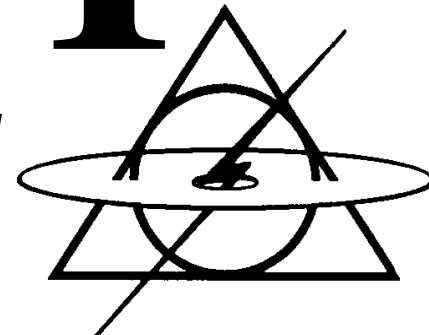

elsewhere to attend a meeting with the OIC (Organization of Islamic Cooperation). ONLY A NATIONALIST REVOLUTIONARY GOV’T CAN SAVE US NOW

It is difficult to imagine how either the administration or the opposition can possibly survive the ticking bomb behind the latest statistics on unemployment released by the Department of Labor and Employment (DoLE). Whoever wins the elections will have to face the explosive repercussions of the massive unemployment caused by the massive closure of factories that has plagued the economy over the last several years, and the latest figures on that give us an idea of the dimensions of the problem.

According to the *Tribune’s* issue of Oct. 11: “The unemployment rate has risen to 12.7 percent and records at the DoLE showed more than 8,000 firms have ceased their operations since President Arroyo grabbed the presidency from Joseph Estrada in 2001.”

To give you an idea of how bad those figures are, in America scourged by an economic crisis—that now threatens the very viability of the Bush administration—the unemployment rate is only 6.2 percent, or half of ours.

The problem is that there is no sign that the epidemic of industry closures will abate or be contained. The situation has definitely gone from bad to worse because in year 2000, also according to the *Tribune* story citing DoLE figures, 2,258 factories had closed shop.

These figures recall a prediction made by business tycoon John Gokongwei in an *Asiaweek* interview four years ago that “nearly all our industries will die”. (See issue of Feb. 19, 1999) Gokongwei was responding to a question posed by *Asiaweek* on the impact of globalization on the Philippine economy. And his answer was that we were not prepared for it even as he cited the death then of the textile, steel, shoe and paper industries.

To a people already stricken by the mass poverty inherited from colonial rule and the prohibitive prices caused by a never-ending round of devaluations, these latest figures on the unemployment trend point to only one thing: That whoever assumes power after the elections next year will be hugging a social dynamite, and the remark being made with increasing frequency today is, whoever wants to be President certainly has a dozen holes in his head.

The point to stress is that these figures are a searing indictment not only of the GMA administration but of all administrations before GMA—from Aquino to Ramos to Estrada and now GMA. Why? Because the unemployment crisis is a direct consequence of the import liberalization policy which started with the Aquino administration, flowered into General Agreement on Tariffs and Trade (GATT) under Fidel Ramos and continued without letup under the administrations of Estrada and GMA. All of them accepted globalization as the nation’s economic ideology.

The labor situation today is the collective responsibility of all administrations since 1986. Every administration had been warned repeatedly by the private sector—and that included even the American Chamber of Commerce which was among the first to have sounded the alarm bell against import lib as early as 1986—on the criminal imprudence of prematurely exposing the economy to global competition, but all to no avail.

One point should now be blindingly clear to all presidential aspirants—none of whom seems to have an idea of how the unemployment crisis came about, much less of how it should be attacked. That point is under the pattern of economic prescriptions to which we have been accustomed—and to which every political party and presidential aspirant have subscribed—there can’t possibly be any hope of recovery. There can only be the certainty

that the matter will continue from bad to worse and that we have reached a point where elections, particularly presidential elections, no longer function as the safety valve which has provided hope for a people who, otherwise would have taken to revolution a long time ago. This, of course, is one way of saying it is actually a lose-lose situation for both the administration and the opposition and that the best thing they can both do is to acknowledge that the nation is in dire and desperate need of a nationalist revolutionary solution to the historic problem of poverty—at the core of which are unemployment and high prices—because no other solution is capable of arresting the momentum of the slide toward the abyss.

There's only one possible way out, and that is for the administration and the opposition to admit they have done this nation an irreparable disservice through the mortally flawed policies that they have pursued or consented to and the mortally flawed political system they represent; and jointly announce that they are prepared to relinquish political power to those elements in the Armed Forces disposed to carry out a program of government that is both nationalistic and revolutionary.

Nationalistic, because any incoming government should be prepared to wrest the nation's economic sovereignty from the International Monetary Fund (IMF), the World Bank (WB) and the World Trade Organization (WTO)—international agencies to which every administration since 1986 has, in manifest high treason, relinquished the nation's economic sovereignty. Since People Power I, every administration has yielded to the demands of those agencies—which Malaysia's Mahathir has denounced as the agents of the new colonialism—that government abstain from its sovereign right and responsibility to protect the nation's domestic industries from import invasion and the national currency from international currency speculators. The result of that abdication has been massive unemployment and ceaseless devaluation, which accounts for the extortionate prices of goods and services today.

Revolutionary, because any incoming government should be prepared to adopt solutions to the problems of poverty and social inequity in ways that radically depart from the usual capitalist prescriptions, even if that means taking to the ideology of democratic socialism which Ninoy Aquino had advocated and which Asian statesmen like Jawaharlal Nehru of India and Col. Nasser of Egypt had pressed for their countries.

Capitalism, as we know it and as preached by the IMF, WB and WTO, is as dead as a dead horse. There's absolutely no point in riding it. But only a nationalist revolutionary junta is in a position at this point to replace a dead system with a new one.

Otherwise, whatever political party wins the elections next year faces an impossible task as well as the prospect of a violent coup, if that coup does not come earlier. And that is not a threat either. The political system is dead—and everyone knows that except the politicians. It is time they acknowledged that fact graciously and bow out voluntarily. Otherwise, they will have to bow out forcibly because the nation fights for naked survival.

PING LINKS GMA, PANCHO TO FRAPORT EXTORT TRY

LACSON: PCSO FUNDS WENT INTO GLORIA'S CAMPAIGN

Corruption in government, including "tens of millions" of dollars in an extortion attempt on a German investor leads directly to the doorstep of President Arroyo and not just the First Gentleman [The "Incredible Hulk"].

This was the gist of the third chapter of the Jose Pidal exposé delivered in a privilege speech yesterday by opposition Sen. Panfilo Lacson.

He challenged the President to prove him and his allegations wrong by calling for a full-dress investigation of the charges he raised if she is not into cover-up herself.

The senator said extradited Mark Jimenez who had met with him and Lacson's lawyer, told him he had handed over directly to Mrs. Arroyo HERSELF, in her father's home in Forbes Park, with witnesses present, checks that amount to some P38 million, some of which went into the Jose Pidal account.

Lacson directly linked Mrs. Arroyo to corruption charges as he disclosed German investor Fraport AG's complaint lodged before the International Center For Settlement of Investment Disputes in Washington, D.C. against the Philippines involving the voiding of the Philippine International Air Terminal Co. Inc. (PIATCO) Terminal 3 project.

"This government is so corrupt, it has been sued by Fraport AG.... In the suit, Fraport accuses the Arroyo government of forcing them to "engage the services of the politically-connected F. Arthur 'Pancho' Villaraza," otherwise "...the successful commercial operation of NAIA Terminal 3 would not be allowed to occur," Lacson said, quoting the Fraport charges.

"Mr. Villaraza would be able to achieve this result upon payment for unspecified purposes of several tens of millions of U.S. dollars."

He added that because Fraport refused to cooperate with the Arroyo administration, the airport project was stopped, saying today, the name of the Philippines is now mud. Investors refuse to invest in the country.

The senator also alleged that Mrs. Arroyo's campaign for the presidency is being funded by the Philippine Charity Sweepstakes Office (PCSO).

"Run, Gloria, Run" posters were sponsored by "Gawin Natin-Lakas Pinoy" which was approved by Mrs. Arroyo after only a week.

The P2 million did not go to any feeding program. Instead, the money was spent on the Gloria campaign streamers.

He pointed to another request from "Gawin Natin-Lakas Pinoy" to PCSO for an ambulance and medical staff for a motorcade in aid of presidential election.

"Medical facilities that should have been given to charity cases were wasted on a motorcade. This was again approved by Mrs. Arroyo: One ambulance, purchase of medicines, supplies, reimbursement of gasoline, incidental expenses, allowable allowance for... One physician, 2 nurses, 1 driver, 1 paramedic!" Lacson explained. **[Moreover, he had documents to back every item and every word.]**

He noted that "Gawin Natin-Lakas Pinoy" gets practically anything from PCSO because of the Raul Nestor Ancheta-Rosario Uriarte connection.

Rosario Uriarte is the general manager of PCSO and has been with Mrs. Arroyo since their GTEB days at DTI, and consultant when the President was then a senator and Vice President. She then became the appointments secretary when Mrs. Arroyo assumed the presidency.

"The paper trail ends in Malacañang. Mrs. President, why are public funds being used for your campaign this early? Where are the originals?" Lacson asked, parroting the response of the President in connection with Lacson's Jose Pidal exposé.

The senator demanded the independent audit of PCSO's records, saying of special concern is PCSO's unaudited balance amounting to over P385 million as of December 2002.

He also bared that Ephraim Genuino, chairman of the Philippine Amusement and Gaming Corp. (PAGCOR) is one of the largest contributors to the Jose Pidal fund, delivering cash to the LTA building at least twice a week, placed in a big bag delivered by one Ryan Cordeta, a trusted Genuino aide.

It was also noted by Lacson that Genuino, a pest-control expert and who ran Trace Computer, a small school, was a regular recipient of money from the "pork barrel" of Gloria Macapagal-Arroyo when she was still a senator, hinting broadly at the alleged money-laundering activities of Mrs. Arroyo herself, from the pork barrel funds.

He also brought out the fact that he has submitted to the Senate at least 23 pieces of evidence, most of these, originals, stressing that even as these pieces of evidence have been presented, Malacañang, the presidential spouse and his lawyers keep on claiming that there is no evidence and has asked for evidence.

[I believe we can get that list of "evidence" and if so, I'll copy it into this document.]

In unleashing his exposé, complete with a computer-aided visual presentation, Lacson said documents and testimonies of Jimenez himself would show that indeed Mrs. Arroyo is privy to the alleged Pidal accounts.

He reiterated this in a press conference after his speech as well as a challenge to peers, particularly the investigating panels—Blue Ribbon, Constitutional Amendments and Banks—handling the case, to seriously consider carrying out a deposition-taking of the congressman in the United States.

"I was with a Filipino lawyer, by the way, and he (Jimenez) told me exactly what I divulged in my privilege speech and that he's willing to execute an affidavit or even testify to the veracity or to the truth of what he told me.

"All in all P38 million (was given by Jimenez) but this went not only to President Arroyo or Jose Pidal (accounts) but would include contributions to the foundations... out of P8 million, P5 million went to Pidal accounts... P38 million is the total amount that he contributed to either foundation or Pidal accounts... what he very clearly told me was that he gave personally the checks or at least one check to Mrs. Arroyo herself in their Forbes Park residence and there were witnesses," he told reporters.

"In due time, that deposition and those checks will be bared before the Filipino people," Lacson said.

"You asked, what is the crime? What is the corruption involving public funds? We feel sorry for your lack of discernment, Mrs. President.... Even if they already have copies of (my) evidence... they kept on shouting. "There is no evidence; where's the evidence?" Okay, to Mr. Arroyo and your collection of lawyers and liars, bring out your calculators and review (and count the evidence you know we have). If the President is watching, join the fun," the senator said as he unveiled his 23 pieces of evidence.

Malacañang yesterday lashed at Lacson, saying all allegations he hurled against the presidential couple in his third privilege speech were not only rehash of undocumented charges but were all unsubstantiated. In a statement, presidential spokesman Ignacio Bunye said the senator's allegations that Mrs. Arroyo engaged in extortion of private individuals were untrue.

"Allegations of extortion by some people supposedly close to the President are unsubstantiated. The others are a rehash of undocumented charges in his (Lacson) Chapters One and Two speeches," Bunye said.

The WB yesterday accepted the arbitration complaint from Fraport, which complaint detailed the extortion try by the aides and lawyer of Mrs. Arroyo. Bunye stressed that Lacson's allegations that some persons supposedly frequented the LTA building show the sinister character of the senator.

"By his own admission, he has been spying on others and invading their privacy," he said.

The President's aide said Lacson allegations that Jimenez has given the President P38 million is not only hearsay but a brazen lie. "The President categorically denies this. Mr. Jimenez had all the opportunity while he was here and facing deportation proceedings. Why did he not say so at that time?" he asked.

[Well, facts are: HE DID!]

Bunye said Bulacan Rep. Wilfrido Villarama will issue a separate statement belying the allegations. **[Villarama is alleged to be one of "the President's men (paramour)]."**

But on the issue of Lacson's serious allegations of anomalies in the Government Service Insurance System (GSIS) and the PCSO, the Palace apparently found difficulty to give an explanation.

"The GSIS and the PCSO will come up separately with their explanations of transactions questioned in the speech. The records are public records and can be made available. PCSO advised us that request mentioned in the speech was never released," Bunye said.

On Lacson's exposé that Mrs. Arroyo had pressured and influenced her godson Eugenio "Udong" Mahusay Jr. to recant statements he earlier provided to the senator, Bunye responded by saying Lacson is "trying to take a case impugning the retractions of Udong Mahusay. According to him, the first affidavit should be given more credence. The recantation is of no value," he said.

The President's spokesman also lambasted Lacson for attacking the Supreme Court on its decision reviving the latter's Kuratong Baleleng case.

"The opening statement against the Supreme Court shows Mr. Lacson's utter lack of respect for the rule of law and the institution that has been tasked to be the final arbiter on questions of law. It does not speak well of a senator of the republic," Bunye said.

He added [that] Lacson's taking note of the standing of the Philippines in the international community where the country ranked in the Transparency International Survey as among the most corrupt nations in the world is wrong. Bunye said the Philippines' negative standing should not all be blamed on Mrs. Arroyo's leadership.

"The ranking was based on a sliding three-year period. What it shows for 2003 actually reflects conditions in 2000 which coincided with the impeachment trial of President Estrada," he added.—

Therefore, our heart needs all the energy it can get to keep going. *Aside from maintaining a healthy lifestyle, researchers report that one can keep one's heart energized with L-carnitine, an important substance in the body's metabolism which guides the fat toward the mitochondria, known as the furnace center of the cell, where it is burned and converted into energy.*

L-carnitine is a derivative of the amino acid lysine. It was first isolated from meat (carnus), which is where its name was also derived. Because of its functions, L-carnitine is most concentrated in tissues that use fat as their source of fuel or energy, such as the skeletal and cardiac muscle. Under certain conditions, the demand for L-carnitine may exceed an individual's capacity to synthesize it, making it a conditionally essential nutrient.

Since 60-80 percent of our heart's energy requirements are derived from the breakdown of fat, it is the one which is most likely to suffer from L-carnitine deficiency. Studies show that by stimulating the energy supply to the heart, **L-carnitine may increase the performance of the heart and improve heart muscle function, thus preventing fatigue, poor circulation and breathlessness.** *[H: Seems to me quite a few of you need to re-read that paragraph about a dozen times and the last sentence at least two dozen times.]*

L-carnitine is an especially important nutrient especially for today's society, which thrives on fat-rich food and sedentary lifestyle. By helping burn fat, *L-carnitine has been proven to lower health risks caused by inefficient fat metabolism associated with unhealthy life-style practices and disease such as diabetes.*

L-carnitine has also been reported to lessen the risk of heart disorders by preventing the build-up of fat especially in the muscles, liver and the heart.

Reliable scientific data and studies have proven L-carnitine's actions that are especially beneficial to the heart. In a preliminary study conducted by Digiesi V, *et al.*, patients with diabetes and high blood pressure were given four grams of L-carnitine per day. After 45 weeks, arrhythmia (irregular heartbeat) and other parameters of heart dysfunction decreased significantly.

L-carnitine is also a necessary nutrient for people who have just suffered a heart attack. According to a study done by Davini, *et al.*, taking four grams of L-carnitine a day will influence a heart attack patient's chance of survival by limiting the damage extended to their heart. Therefore, the death can be prevented and the need for regular medication can be reduced.

Now, if you wish to be able to put into better context a couple of points, I will ask that we run an additional article—supposedly non-related but we KNOW that everything is connected to everything else—so have a go at an intelligence review.

Excerpt: From a local Medical specialist's lecture:

"Early treatment of type-2 diabetes is crucial in preventing the deterioration of B-cell and the conversion of impaired glucose tolerance to frank diabetes.

"This was underscored by Dr. Araceli Panelo, executive director of the Institute for Studies on Diabetes Foundation Inc. and concurrent professor of the University of East Ramon Magsaysay Memorial Medical Center (UERMMM), in her lecture during the Aventis Diabetes Academy Reunion held recently at the Mandarin Oriental Hotel in Makati.

"Panelo noted that type-2 diabetes is a 'progressive disease with relentless deterioration of B-cell function'.

"Type-2 diabetes was previously called non-insulin-dependent diabetes mellitus and may account for about 90 to 95 percent of all diagnosed cases of diabetes. It usually occurs in people who are over the age of 45 and overweight. Lately, however, the disease is seen to affect younger individuals who in the past, because of age of onset, will be thought of as type 1.

"Type-2 diabetes is associated with increasing age, obesity, family history of diabetes, prior history of gestational diabetes, impaired glucose tolerance, physical inactivity and race/ethnicity. According to Panelo, aggressive treatment of type-2 diabetes is necessary on the basis of the following:

- Convincing evidence exists for a relationship between micro-vascular disease and hyperglycemia.
- Important to reduce the risk of retinopathy, neuropathy and nephropathy.
- A similar relationship may also exist for macro-vascular disease.
- Important to reduce the risk of CAD, stroke peripheral vascular disease (PVD)

"She cited the United Kingdom Prospective Diabetes Study (UKPDS) which concluded that intensive therapy to reduce glycemia and control blood pressure reduces the risk of complications. The same study showed that neither insulin nor sulfonylurea therapy increases the risk of cardiovascular complications.

"At the end of 10 years, the study found out that people with the best control of blood glucose and blood pressure had a 32 percent decreased risk of all diabetes-related deaths, a 44 percent decreased risk of stroke, a 56 percent decreased risk of heart failure, and a 37 percent decreased risk of micro-vascular (small blood vessel) complications.

"Using the UKPDS, Panelo recommended a combination therapy for type-2 diabetes which produces the greater lowering in fasting and post-prandial glucose."

You will note that there is care not to share anything really valuable with you readers—to protect themselves. Moreover, I do not believe that the use of either is prevented by the Medical Association or the Bar Association.

GERMANY'S REACTION AGAINST THE JEW

Humanity has become wise enough to discuss those forms of physical sickness over which it formerly drew the veil of shame and secrecy, but political hygiene is not so far advanced. The main source of the sickness of the German national body is charged to be the influence of the Jews, and although this was apparent to acute minds years ago, it is now said to have gone so far as to be apparent to the least observing. **[H: Well, it certainly faded again before it got to today in 1998. I remind you of the U.S. and Canada (and other British Empire slaves—err-a—subjects), THIS IS THE ANTICHRIST DESTROYING YOU—NOT THOSE OTHER FACTIONS I MENTION ABOVE.]** The eruption has broken out on the surface of the body politic, and no further concealment of this fact is possible. It is the belief of all classes of the German people that the collapse which has come since the armistice, and the revolution from which they are being prevented a recovery, are the result of Jewish intrigue and purpose. They declare it with assurance; they offer a mass of facts to confirm it; they believe that history will provide the fullest proof.

The Jew in Germany is regarded as only a guest of the people; he has offended by trying to turn himself into the host. **[H: Sound like America, sheepleheads? Do I offend? I didn't think you COULD BE OFFENDED!]** There is no stronger contrast in the world than the pure Germanic and the pure Semitic races; therefore, there has been no harmony between the two in Germany; the German has regarded the Jew strictly as a guest, while the Jew, indignant at not being given the privileges of the nation-family, has cherished animosity against his host. In other countries the Jew is permitted to mix more readily with the people, he can amass his control unchallenged; but in Germany the case was different. Therefore, the Jew hated the German people; therefore, the countries of the world which were most dominated by the Jews showed the

greatest hatred of Germany during the recent regrettable war. Jewish hands were in almost exclusive control of the engines of publicity by which public opinion concerning the German people was molded. The sole winners of the war were Jews.

But Assertion is not enough; proof is wanted; therefore, consider the evidence. What occurred immediately upon the change from the old regime to the new? The cabinet composed of six men, which substituted the Minister of State, was dominated by the Jews Haase and Landsberg. Haase had control of foreign affairs; his assistant was the Jew Kautsky, a Czech, who in 1918 was not even a German citizen. Also associated with Haase were the Jews Cohn and Herzfeld. The Jew Schiffer was Financial Minister of State, assisted by the Jew Bernstein. The Secretary of the Interior was the Jew Preuss, with the Jew Dr. Freund for his assistant. The Jew Fritz Max Cohen, who was correspondent of the *Frankfurter Zeitung* in Copenhagen, was made government publicity agent.

The kingdom of Prussia duplicated this condition of affairs. The Jews Hirsch and Rosenfeld dominated the cabinet, with Rosenfeld controlling the Department of Justice, and Hirsch in the Department of the Interior. The Jew Simon was in charge of the Treasury Department. The Prussian Department of Justice was wholly manned and operated by Jews. The Director of Education was the Jew Furtran with the assistance of the Jew Arndt. The Director of the Colonial Office was the Jew Meyer-Gerhard. The Jew Kastenber was director of the Department of Art. The War Food Supply Department was directed by the Jew Wurm, while in the State Food Department were the Jews Prof. Dr. Hirsch and the Geheimrat Dr. Stadthagen. The Soldiers' and the Workmen's Committee was directed by the Jew Cohen, with the Jews Stern, Herz, Lowenberg, Frankel, Israelowcz, Laubenheim, Seligsohn, Katzenstein, Laufenberg, Heimann, Schlesinger, Merz and Weyl having control of various activities of that committee.

The Jew Ernst is chief of police at Berlin; in the same office at Frankfurt is the Jew Sinzheimer; in Munich the Jew Steiner; in Essen the Jew Levy. It will be remembered that the Jew Eisner was President of Bavaria, his financial minister being the Jew Jaffe. Bavaria's trade, commerce and industry were in control of the half-Jew Bretano. The Jews Lipsinsky and Schwarz were active in the government of Saxony; the Jews Thallheimer and Heiman in Wurtemberg; the Jew Fulda in Hessen.

Two delegates sent to the Peace Conference were Jews and a third was notoriously the tool of Jewish purposes. In addition Jews swarmed through the German delegation as experts and advisors—Max Warburg, Dr. Von Strauss, Merton, Oskar Oppenheimer, Dr. Jaffe, Deutsch, Bretano, Bernstein, Struck, Rathenau, Wassermann and Mendelsohn-Bartholdi.

As to the part which Jews from other countries had in the Peace Conference, German observers declare that any candid student may discover by reading the accounts of impartial non-Jewish recorders of that event. Only the non-Jewish historians seem to have been struck by the fact; the multitude of Jewish writers apparently judged it wise to conceal it.

Jewish influence in German affairs came strongly to the front during the war. It came with all the directness and attack of a flying wedge, as if previously prepared. The Jews of Germany were not German patriots during the war, and although this will not appear a crime in the eyes of the nations who were opposed to Germany, it may throw some light on the Jew's assertion of patriotic loyalty to the land where he lives. Thoughtful Germans hold that it is impossible for the Jew to be a patriot, for reasons which will presently be given.

The point to be considered is the general claim that the persons already named would not have obtained the positions in which they were found had it not been for the Revolution, and the Revolution would not have come had they not brought it. It is true that there were unsatisfactory conditions in Germany, but they could and would have been adjusted by the people themselves; the conditions which destroyed the people's morale and were made impossible to reform were in the control of the Jews.

The principal Jewish influences which are charged with bringing about the downfall of German order may be named under three heads: (a) the spirit of Bolshevism which masqueraded under the name of German Socialism; (b) Jewish ownership and control of the Press; (c) Jewish control of the food supply and the industrial machinery of the country. There was a fourth, "higher up", but these worked upon the German people directly.

[H: Can't happen in America? It already HAS HAPPENED IN AMERICA. Does anybody remember Archer Daniels Midland Co.? This is the GRAIN CARTEL OF THE GLOBE AND THEY HAVE NOT ONLY "CONTROL" BUT HAVE GOTTEN RID OF ALL RESERVES WHICH WOULD FEED SOME OF THE PEOPLE SOME OF THE TIME—IN THE U.S. THE U.S. DOES NOT HAVE EVEN ONE WEEK'S SUPPLY OF RESERVES. Oh yes, and your favorite Jewish commentator, David Brinkley, is now employed by this company while Gorbachev and the ex-prime minister of Canada are also major players with that corporation.]

As it is possible that German conclusions upon this matter may be received doubtfully by peoples whose public opinion has been shaped by Jewish influence, it may help to quote George Pitter-Wilson, of the *London Globe*, who wrote in April 1919, "Bolshevism is the dispossession of the Christian nations of the world to such an extent that no capital will remain in the hands of the Christians, that all Jews may jointly hold the world in their hands and reign wherever they choose." As early as the second year of the war, German Jews were preaching that Germany's defeat was necessary to the rise of the proletariat, at which time Strobel declared, "I openly admit that a full victory of the country would not be in the interest of the Social Democrats." Everywhere it was preached that "The exaltation of the proletariat after a won victory is an impossibility."

These instances, out of many, are cited not to reopen the military question but to show how the so-called German Jew forgot loyalty to the country in which he lived and joined the outside Jews in accomplishing the collapse of Germany, and not merely, as we shall see, to rid Germany of militarism, which every thoughtful German desired, but to throw the country in such confusion as to permit them to seize control.

The press of Germany echoed this plan of the Jewish spokesmen, at first faintly, then boldly. The Berliner *Tageblatt* and the Municher *Neuster Nachrichten* were, during the whole war, official and semi-official organs of the government. They were owned and controlled by Jews, as was also the Frankfurter *Zeitung* and a host of smaller papers that were their spiritual dependents. These papers, it is charged, were really German editions of the Jew-controlled press of the Allied countries, and their purpose was the same. One of the great pieces of research that ought to be undertaken for the purpose of showing the world how its thought is manufactured for it every day—and for what ulterior purposes—is this union of the Jewish press, which passes for the Public Press, throughout the world. **[H: Anybody want to argue that it isn't STILL THE SAME?]**

The food and supplies of the people quickly passed into Jewish hands as soon as the war emergency came, and then began a period of dishonesty which destroyed the confidence of the bravest. Like all other patriotic people, the German people knew that war meant sacrifice and suffering, and like other people they were willing to share the common lot. But they found themselves preyed upon by a class of Jews who had prepared everything to make profit out of the common distress. **[MM: Carpetbaggers—always willing to “bargain”!]** Immediately Jews appeared in banks, war companies, distribution societies, and the ministries of supplies—wherever the life of the people could be speculated in or taxed. Articles that were plentiful disappeared, only to reappear again at high prices. The war companies were exclusively Jewish, and although the government attempted to regulate the outgo of food in the interests of all the people, it became notorious that those with money could get all of anything they wanted, regardless of the food cards. The Jews simply trebled the price of the goods they let go without the cards, and so kept a stream of the nation's gold flowing into their private treasuries. None of the Government's estimates of the food stocks could be depended on because of the hidden hoards on which these speculators drew. This began to disturb the morale of the people, and complaints were made and prosecutions started; but as soon as the cases came up it was discovered that the prosecutor appointed to charge and the commissioner appointed to judge were also Jews, and so the cases usually wore themselves out without results. When, however, a German merchant was caught, great noise was made about it, and the penalty placed upon him was equal to what all the others should have had. Go the length and breadth of Germany today, say the reports, study the temper of the people—and you will discover that the abuse of power by the Jews has burned across Germany's memory like a hot iron.

While these influences were undermining the mass of the people, higher influences of Jewish origin were operating upon the government. The advisers of the Bethmann-Hollweg government were the great ship magnate, Ballin, a Jew; Theodor Wolff, of the Berliner *Tageblatt* and member of the Pan-Jewish press; Von Gwinner, director of the German Bank who is connected by marriage with the great Jew bankers, the Speyers; and Rathenau, the leader of Jewish industrial-financial activities. These men were at the source of things and were bending the government as the other influences were bending the people.

The rich German Jew could buy the recognition he desired by acquiring financial power over those interests which most directly affected the ruling class of Germany, but how was the poor Jew to gain the recognition he desired?—for all Jews are actuated by the same desire; it is in them; they feel the spur to mastery. Having explored the conquest of the higher circles by Jewish money-power, there is yet to explore the conquest of the body of the nation by Jews who had no money except what they could seize in the disorder which they caused. The analysis that is given, follows:

The Jew is not an anarchist. He is not a destructionist. All this is true, notwithstanding he is the world's Bolshevik and preeminently Germany's revolutionist. His anarchy is not ingrained, it is a device which he uses for a purpose. The rich Jew is not an anarchist, because he can achieve what he desires by more subtle methods. The poor Jew has no other recourse. But rich and poor go jointly for a long stretch; the bond of sympathy between them never breaks; for if the anarchy is successful, then the poor Jew shall take his place with the rich Jew; and if the anarchy is not successful, it has nevertheless served to break up new fields in which the rich Jew may operate.

[H: Perhaps I can make this a bit more clearly understood. The point, readers, is certainly not to destroy the U.S. as in “retaliation” by the Mideastern countries or China. The point is to get the war going OUT OF TOWN, so to speak, so that the U.S. mainland is more surely maintained in one piece. The perpetrators don't want to give up the luxurious lifestyle of what America has come to represent, so don't lose sight of the wish to CONTROL, OWN, MONOPOLIZE AND RULE by this New World Order where you-the-people PAY AND SERVE. The real “rub” comes as to whether or not the other parts and religious people of the world will allow you to go unscathed in your dictatorship of horror.]

In Germany it was possible for the poor Jew to thrust himself up through the wall of Germanism above him only by breaking it up. In Russia the same was true. The social system had encrusted around the Jew, keeping him in a position where, as the nations knew by experience, he would be less harmful. As Nature encysts the harmful foreign element in the flesh, building a wall around it, so nations have found it expedient to do with the Jew. In modern times, however, the Jew has found a means of knocking down the walls and throwing the whole national house into confusion, and in the darkness and riot that follows, seize the place he has long coveted. When Russia broke, who came first to light?

Kerensky, who is a Jew. But his plans were not radical enough, and then came Trotsky, another Jew. Trotsky found the system too strong for him to break in America—he broke through the weak spot in Russia and would extend that weakness round the world. Every commissar in Russia today is a Jew. Publicists are accustomed to speak of Russia as if it were in disorder. It may be that Russia is, but the Jewish government of Russia is not. From a mass of underlings, the Jews of Russia came up a perfect phalanx, a flying wedge through the super-induced disorder, as if every man's place had been previously prepared for him.

That also is the way it was in Germany. The German ceiling had to be broken, as it were, before the poor Jews could realize their ambition. When the break was made they swarmed through and settled in places of control above the nation.

This may explain why Jews the world over—supply the energy of disruptive movements. It is understood that the young Jews of the United States are propagandists of an ideal that would practically abolish the United States. The attack is aimed, of course, against “capitalism”, which means the present government of the world by the Gentile. The true capitalists of the world are Jews, who are capitalists for capital's sake. It is hard to believe that they wish to destroy capital; they wish to obtain sole control of it, and their wish has long been in fair way to fulfillment.

In Germany, therefore, as in Russia, distinction is made between the methods of the rich and of the poor Jews—because one method affects the government and the other the morale of the people—but both converge on the same objective. It is not only desire to escape oppression that actuates the lower classes of Jews, but desire to gain control—for the spirit of mastery pulses strong within them. German convictions on this question have reached the place where they may be expressed thus: Revolution is the expression of the Jews' will to power. Parties such as the socialists, democrats and freethinkers are but tools for the Jewish plan to power. The so-called “dictatorship of the proletariat” is really and practically the dictatorship of Jews.

So suddenly have German eyes been opened, so stormfully wrathful has been the reaction that the word has gone out through German Judaism to retire to the second trench. There has been a sudden and concerted abandonment of office wherever the office made direct contact with the public; there has, however, been no abandonment of power. What will happen in Germany is not now known. Some regrettable things have already happened. But the Germans will doubtless prove themselves equal to the situation by devising methods of control at once unobjectionable and effective. But as to Russia, it is hardly doubtful any longer what will happen there. When Russia turns, a shudder will run through the Earth. **[H: And this, you had best believe, then and NOW.]**

How Gentile Germany and Russia look at the entire question may be summarized as follows:

Judaism is the most closely organized power on Earth, even more than the British Empire. It forms a State whose citizens are unconditionally loyal wherever they may be and whether rich or poor.

The name which is given in Germany to this State which circulates among all the states is "All-Judaan".

The means of power of the State of All-Judaan are capital and journalism, or money and propaganda.

All-Judaan is the only State that exercises world government; all the other States can and may exercise national government only.

The principal culture of All-Judaan is journalistic; the technical, scientific, literary performances of the modern Jew are throughout journalistic performances. They are due to the marvelous talent of the Jews for receptivity of others' ideas. Capital and Journalism are joined in the Press to create a political and spiritual medium of Jewish power.

The government of this state of All-Judaan is wonderfully organized. Paris was its first seat, but has now been moved to third place. Before the war London was its first, and New York its second capital. It remains to be seen whether New York will now supplant London—the drift is toward America.

As All-Judaan is not in a position to have a standing army and navy, other states supply these for it. Its fleet is the British fleet which guards from hindrance the progress of an all-Jewish world economy, or that part of it which depends on the sea. In return, All-Judaan assures Britain an undisturbed political and territorial world rule. All-Judaan has added Palestine to British control. Wherever there was an All-Judaan land force (whatever national uniform it might wear), it worked with the British navy.

All-Judaan is willing to entrust the government of various strips of the world to the nationalistic governments; it only asks to control the governments. Judaism is passionately in favor of perpetuating nationalistic divisions for the Gentile world. For themselves, Jews never become assimilated with any nation. They are a separate people, always were and always will be.

All-Judaan's only quarrel with any nation occurs when the nation makes it impossible for All-Judaan to control that nation's industrial and financial profits. It can make war; it can make peace; it can command anarchy in stubborn cases; it can restore order. It holds the sinews of world power in its hand and it apportions them among the nations in such ways as will best support All-Judaan's plan.

Controlling the world's sources of news, All-Judaan can always prepare the minds of the people for its next move. The greatest exposure yet to be made is the way that news is manufactured and the way in which the mind of whole nations is molded for a purpose. When the powerful Jew is at last traced and his hand revealed, then comes the ready cry of persecution and it echoes through the world press. The real causes of the persecution (which is the oppression of the people by the financial practices of the Jews) are never given publicity.

All-Judaan has its vice-governments in London and New York. Having wreaked its revenge on Germany it will now go forth to conquer other nations. Britain it already has. Russia it is struggling for, but the chances are against it. The United States, with its good-natured tolerance of all races, offers a promising field. The scene of operations changes—but the Jew is the same throughout the centuries.—Issue of May 29, 1920.

JEWISH HISTORY IN THE UNITED STATES

“At first sight it would seem as if the economic system of North America was the very one that developed independently of the Jews... Nevertheless I uphold my assertion that the United States (perhaps more than any other land) are filled to the brim with the Jewish spirit. This is recognized in many quarters, above all in those best capable of forming a judgment on the subject...”

*“In the face of this fact, is there not some justification for the opinion that the United States owe their very existence to the Jews? And if this be so, how much more can it be asserted that Jewish influence made the United States just what they are—that is, American? For what we call Americanism is nothing else, if we may say so, than the Jewish spirit distilled.”—Werner Sombart, *The Jews and Modern Capital*, pp. 38, 43.*

The story of the Jews in America begins with Christopher Columbus. On August 2, 1492, more than 300,000 Jews were expelled from Spain, with which event Spain’s prestige began its long decline, and on August 3, the next day, Columbus set sail for the West, taking a group of Jews with him. They were not, however, refugees, for the prophetic navigator’s plans had aroused the sympathy of influential Jews for a long period previously. Columbus himself tells us that he consorted much with Jews. The first letter he wrote detailing his discoveries was to a Jew. Indeed, the eventful voyage itself which added to men’s knowledge and wealth “the other half of the Earth” was made possible by Jews.

The pleasant story that it was Queen Isabella’s jewels which financed the voyage ***has disappeared under cool research***. There were three Maranos or “secret Jews” who wielded great influence at the Spanish court: Luis de Santagel, who was an important merchant of Valencia and who was “farmer” of the royal taxes; his relative, Gabriel Sanchez, who was the royal treasurer; and their friend, the royal chamberlain, Juan Cabrero. **[H: Bet you didn’t know all this!]** These worked unceasingly on Queen Isabella’s imagination, picturing to her the depletion of the royal treasury and the likelihood of Columbus discovering the fabulous gold of the Indies, until the Queen was ready to offer her jewels in pawn for the funds. But Santagel craved permission to advance the money himself, which he did, 17,000 ducats in all, about \$20,000, perhaps equal to \$160,000 today (1920). It is probable that the loan exceeded the expedition’s cost.

Associated with Columbus in the voyage were at least five Jews: Luis de Torres, interpreter; Marco, the surgeon; Bernal, the physician; Alonzo de la Calle, and Gabriel Sanchez. The astronomical instruments and maps which the navigators used were of Jewish origin. Luis de Torres was the first man ashore, the first to discover the use of tobacco; he settled in Cuba and may be said to be the father of Jewish control of the tobacco business as it exists today.

[H: I am reminded here of the foolish play on the tobacco industry to meet the obligations of your “balanced budget”. Isn’t there something wrong with this picture today? Are you really going to have a shut-down of smoking and still have the tobacco industry pay for your deficits with that “fine” levied or agreed to or whatever—none of it makes any sense at all.

Now turn to the Lewinsky-Billy Zipper problem and see if you can make a connection. No, none other than Grandpa Lewinsky making a lot, LOT, of Democratic contributions? Why? Well, look a bit deeper and then go read Gary Wean’s material [2/17/98 CONTACT, pages 36-44] from just topical investigation. Monica’s FATHER is a leading Oncologist (cancer specialist). The leading Jewish male disease is COLON CANCER—which is not yet covered by Medicare or any other assistance program. The effort is to get “colon cancer” covered by Government Medical coverage and there will be specified Oncologists on a list for approved treatment physicians and clinics. Not a shabby effort! Sounds silly? No, sorry, it is both real and is working. I find it quite appropriate.]

Columbus’ old patrons, Luis de Santagel and Gabriel Sanchez, received many privileges for the part they played in the work, but Columbus himself became the victim of a conspiracy fostered by Bernal, the ship’s doctor, and suffered injustice and imprisonment as his reward.

From the beginning, Jews looked more and more to America as a fruitful field, and immigration set in strongly toward South America, principally Brazil. But because of military participation in a disagreement between the Brazilians and the Dutch, the Jews of Brazil found it necessary to emigrate, which they did in the direction of the Dutch colony of what is now New York. Peter Stuyvesant, the Dutch governor, did not entirely approve of their settling among his people and ordered them to leave, but the Jews had evidently taken the precaution to assure their being received even if not welcomed, because upon revoking the order of Stuyvesant, the Directors gave as one of the reasons for the Jews being received, “the large amount of capital which they have invested in the shares of the Company”. Nevertheless they were forbidden to enter public service and to open retail shops, which had the effect of driving them into foreign trade in which they were soon exercising all but a monopoly because of their European connections.

This is only one of the thousand illustrations which can be given of the resourcefulness of the Jew. Forbid him in one direction, he will excel in another. **[H: You could all take lessons. It seems like God’s team works best and loss in one direction means QUIT.]** When he was forbidden to deal in new clothes, he sold old clothes—that was the beginning of organized traffic in secondhand clothing. When he was forbidden to deal in merchandise, he dealt in waste—the Jew is the originator of the waste product businesses of the world; he was the originator of the salvage system; he found wealth in the debris of civilization. He taught people how to use old rags,

how to clean old feathers, how to use gall nuts and rabbit skins. He has always had a taste for the furrier trade, which he now controls, and to him is due the multitude of common skins which now pass under various alluring trade names as furs of high origin. The idea of renovation gained commercial value through the Jew. In the “rag men” who blow tin horns through our cities and save the old iron, old bottles, old paper and old fabrics, we have the commercial descendants of those earlier Jews who turned adversity into success by converting the rubbish of the Earth into material of value.

Unwittingly, old Peter Stuyvescant compelled the Jew to make New York the principal port of America, and though a majority of New York Jews had fled to Philadelphia at the time of the American Revolution, most of them returned to New York at the earliest opportunity, instinct seeming to make them aware that in New York was to be their principal paradise of gain. And so it has proved. New York is the greatest center of Jewish population in the world. It is the gateway where the bulk of American imports and exports are taxed, and where practically all the business done in America pays tribute to the masters of money. The very land of the city is practically the holdings of the Jews. A list of the property owners of the metropolis reveals only at rare intervals a Gentile name. No wonder that Jewish writers, viewing this unprecedented prosperity, this unchecked growth in wealth and power, exclaim enthusiastically that the United States is the Promised Land foretold by the prophets and New York the New Jerusalem. **[H: And THE place for the New World Order and United Nations! Don't you feel a bit insecure for these Jewish people in the large “taken-over” cities and industries when the big bang comes from THEIR OPPOSITION? THESE ARE THE PLACES ON THE GEOGRAPHICAL GLOBE WHICH WILL BE BLOWN AWAY. THIS IS WHAT TERRIFIES, COMING FROM SUCH AS SADDAM HUSSEIN—HE DOESN'T CARE ABOUT LITTLE ISRAEL EXCEPT AS A NASTY FLAW IN THE MIDDLE EASTERN COMMUNITY—HE WILL USE WEAPONS OF MASS DESTRUCTION ON BRITAIN AND THE U.S. THE FIRST CHANCE THAT COMES—THESE ARE HIS ENEMIES. WE, OF LITTLE CHRIST-IANDOM ARE NOT THE ENEMY—WE ONLY “INFORM”. WE DON'T BLOW UP THINGS OR EVEN DENY THE BUSINESS TO THESE BROKERS—WE OFFER THEM MORE. BUT THE RELIGIOUS FANATIC IN REVENGE FOR WRONG-DOING WILL GO TO THE HEART OF THE PROBLEM—AND READERS, THAT IS THE UNITED STATES OF AMERICA, GREAT BRITAIN AND ALLIES. NEW YORK IS THE NEW JERUSALEM TARGETED FOR THE BIGGEST BLAST OF ALL, AND THEN OTHERS OF YOUR JEWISH CITIES.**

Saddam doesn't dislike the Americans—he simply CAN'T FIND ANY OF THEM. I wonder if YOU can?] Some have gone even further and described the peaks of the Rockies as “the mountains of Zion”, and with reason, too, if the mining and coastal wealth of the Jews is considered.

The new waterways proposal—which will make an ocean port of practically every great city on the Great Lakes and take from New York the prestige she has maintained by being the gateway toward which the principal railways narrowed—is being strongly protested at this time. And the strongest motive in opposing the most obvious betterment is that so much wealth counted in New York is not wealth at all, but fictitious values depending solely on New York remaining New York. When anything comes which will make New York merely a city on the coast—and not the city where the great taxers sit to levy their tribute—much Jewish wealth will decrease. It was fabulous before the war. What it is now the statisticians will hardly undertake to say.

In fifty years the increase in the Jewish population of the United States has been from 50,000 to more than 3,300,000. In the British Isles there are only 300,000, in Palestine only 100,000. It is fortunate for the Jew himself that in Great Britain his numbers are not greater, for the large and evident control he exercises in great matters would sometimes make it inconvenient for the poorer Jew, if he were abroad in England in large numbers. **[H: He already controls the whole of Great Britain, so numbers here don't mean anything other than an effort to HIDE TRUTH.]** An unusually well-informed Briton says that anti-Semitism is always ready to break out in England upon sufficient cause, but it cannot break out against the inaccessible rich Jews who control in politics and international finance. It is probably true that the commonest real cause of anti-Semitism is the action of the international Jew who is often unknown and always secure, but the innocent victim of it is the poor Jew. Anti-Semitism, however, will be considered in the next article.

The figures representing Jewish population in Great Britain and the United States indicate that the colossal power wielded by international Jewish financiers is neither consequent nor dependent upon their number. The arresting fact about the Jew is his worldwide unchallenged power, coupled with comparative numerical inferiority. There are only about 14,000,000 Jews in the world; they are about as numerous as the Koreans. This comparison of their numbers with the Koreans will illustrate still more vividly the phenomenon of their power.

In the time of George Washington there were about 4,000 Jews in the country, most of them well-to-do traders. For the most part they favored the American side. Haym Salomon helped the Colonies out with the loan of his entire fortune at a critical moment. But they never assimilated, they did not take up the usual employments nor farming, they never seemed to care for the worry of manufacturing things, but only for the selling them after they were made.

[H: Doesn't that sound like just about everybody who prances through your place wanting to be a “manager” or a “trouble shooter” or “organizer”, etc.? FEW want to work to make a thing possible—just SUPERVISE at another's EXPENSE. This is now such a wide-ranging attitude that “Jew”

WILSON SEES WIFE'S 'OUTING' AS RETALIATION

WASHINGTON—When I first met and spoke with former ambassador to Iraq Joseph Wilson late last July, we ruminated over the strange “outing” of his wife as an agent of the CIA by a prominent American journalist. He was angry about the revelation, which seemed natural under the circumstances; but I was downright confused. ...

Wilson had, of course, heartily irritated the Bush administration by revealing, albeit at a respectfully late time, that the administration’s claims that Hussein had sought uranium in Africa to build a nuclear bomb were totally false. In fact, his findings that no such substance went from Niger to Baghdad still stand today.

But soon after his revelations came a bewildering response, which is now shaking this capital with scandal on a scale that threatens to approach Watergate proportions. On July 14, syndicated columnist Robert Novak wrote his now-famous column linking Wilson’s findings about the war with the profession of his wife. That column, with information that Novak insists came to him accidentally in conversations with two administration officials, simply said she was an agent of the CIA.

Then, long silence.

You’d be right to ask, “And then, what?” Or, “So what?” But there are no answers to those key questions. Even if she were a CIA agent, I asked Wilson last July, what exactly did that have to do with his war findings? “I don’t know,” he told me then—but he does now.

“Why did they do it?” he asked this week. “Because a crime has been committed and you try to deflect attention from the crime. What they are doing is to keep others from coming forward, as I did. But more and more, it is just revenge.” Other observers and analysts on his side are saying of this embarrassing and threatening case for the Bush administration, “It’s meant to intimidate others from speaking out against the war,” or, “The story is gratuitous; it doesn’t lend anything to the story,” or, “It’s a political smear of an innocent person, and it’s just plain dirty.” All of those comments are likely true. **[WRP: The wife of Joseph Wilson, Valerie Plame, was an extraordinary person doing an extraordinary job. In the lexicon of the intelligence business, she was a CIA agent with a “non-official cover”, otherwise known as a “Noc”. An Associated Press report about Plame described Noc status as, “the most difficult kind of false identity for the agency to create, often involving especially dangerous jobs”. In Plame’s case, her Noc status was created so she could covertly work to keep weapons of mass destruction out of the hands of terrorists.]**

It is a crime to reveal the identity of an American undercover agent, which Wilson’s wife, we now know, is. In fact, it is a deadly serious crime because it almost certainly leads to the end of the agent’s effectiveness and, most probably, career, as well as putting into danger all of the contacts the agent has built up around the world. Indeed, under the 1982 Intelligence Identities Protection Act, a person with access to classified information who intentionally identifies a covert agent of the United States faces up to 10 years in prison and as much as \$50,000 in fines. **[JR: Rumsfeld will declare immunity and escape justice.]**

So where does that put us? Well, Ambassador Wilson, along with other serious observers, has come forward with information that at least six journalists were deliberately called by White House officials to plant the story, probably in order to intimidate Wilson and others. If this is true, it should not be very hard for the Department of Justice, which has been called in by President Bush to investigate, to discover the truth behind this matter.

But the damning elements for the administration are all of its own making. From day one of this presidency, there has been no place in the White House for anyone who disagrees; journalists who question White House officials are never invited in; you are with the little “bund” of true believers or you are not. And if you are not, there is a price to pay. ...

Which is all kind of funny, since it is the neo-cons who constantly make fun of the State Department diplomats, saying they’re without spirit, guts or fight. Clearly, they have met their match—and the bout is only beginning.

[JR: President Bush and his handlers will have to tread very carefully through the minefields of public scrutiny to give up one of their own culprits in espionage. My bet is that the trail leads to the backdoors of the Pentagon—right down to Rumsfeld’s offices. It will be fascinating to see how long it will take Bush’s chum, the ever righteous Ashcroft, to do his due diligence and charge those administration criminals with violation of the 1982 Intelligence Identities Protection Act. They should also be held libel for the character assassination of ex-Ambassador Wilson and his now retired CIA wife, Valerie Plame. With the election drawing nearer, Dubya Bush’s troubles are multiplying and so obvious—even for our own media to ignore. LEAK PROBE MAY FAIL, BUSH SAYS

WASHINGTON—The White House declared Tuesday that three senior aides were not involved in illegally leaking the name of an undercover CIA operative even as President Bush said the Justice Department investigation may never uncover the guilty party.

“I have no idea whether we’ll find out who the leaker is,” Bush told reporters after a Cabinet meeting, citing the determination of reporters to protect their sources. “I’d like to. I want to know the truth.” **[JR: His Camp David programming is holding.]**

These comments prompted some legal experts to question the independence of the investigation as well as the propriety of trying to clear top aides before the Justice Department has seen and heard all evidence. **[JR: The purpose is to maintain a strong line of defense and if that breaks down, claim reasons of National Security.]**

Press secretary Scott McClellan ruled out senior political aide Karl Rove, vice presidential chief of staff Lewis Libby and National Security Council senior director Elliott Abrams as being involved in the leak. Each denied they had anything to do with disclosing the name of the CIA operative to several reporters, McClellan said. The operative is married to

Ambassador Joseph Wilson, who questioned the administration’s claim that Iraqi dictator Saddam Hussein sought to buy uranium in Africa.

“They were not involved in leaking classified information, nor did they condone it,” McClellan said. **[JR: How credible is he? He gets paid to be the White House’s main fabricator of the facts.]**

Mary Cheh, a Georgetown University law professor, called such statements “quite irregular” and said they could have a chilling effect on the investigation. “It will take someone of considerable fortitude [in the Justice Department] to look past such statements” and investigate any of the three men, she said. ...

Jeralyn Merritt, a criminal defense lawyer in Denver, said that if Bush does not know the name of the leaker, his White House certainly could not categorically rule out involvement by Rove, Libby or Abrams. “I think a special counsel would be an excellent idea,” she said. ...

Under intense questioning at his daily briefing, McClellan said it was premature to conclude that the White House may seek to shield some of the documents by claiming executive privilege. The chief reason for screening the material is to determine whether it is “responsive” to the Justice Department’s request for information, the press secretary said. ...

Bush raised doubts about the outcome of the investigation after first saying the Justice Department will “come to the bottom of this, and we’ll find out the truth.” He said he wanted to see “truth prevail”. **[JR: When? In the next Millennium?]**

But when asked if he was confident the probe would find the person responsible for the leaks, Bush said, “This town is a town full of people who like to leak information. And I don’t know if we’re going to find out the ‘senior administration official’” who disclosed the CIA operative’s name.

While the president touted the ability of Justice Department professionals to conduct a fair and independent investigation, professor Cheh said the key is making sure that investigators are “walled off” from political considerations. ...

[JR: Bush and his handlers are having a hard time keeping the lid on their Pandora’s Box of scandals, lies and insider deals. BLEAK REPORT DISPUTES WHITE HOUSE OUTLOOK ON IRAQI OIL

WASHINGTON—The Bush administration’s optimistic statements earlier this year that Iraq’s oil wealth—not American taxpayers—would cover most of the cost of rebuilding the country were at odds with a bleak assessment by a government task force, according to public records and government officials.

The task force, secretly established last fall and based at the Pentagon, produced a report that described the Iraqi oil industry as so badly damaged by a decade of trade embargoes that production capacity had fallen more than 25 percent, panel members have said.

The Pentagon now plays down that report, but Deputy Defense Secretary Paul Wolfowitz told Congress during the war that “we are dealing with a country that can really finance its own reconstruction, and relatively soon.” **[JR: What Zionist-induced fog is Wolfie lost in?]**

Moreover, Vice President Dick Cheney said in April, on the day Baghdad fell to U.S. troops, that oil production could hit 3 million barrels a day by the end of the year, even though the task force determined that Iraq was generating less than 2.4 million barrels a day before the war.

Senior administration officials said Cheney, Wolfowitz and Defense Secretary Donald Rumsfeld were aware of the task force’s mission. But the officials could not say whether the three knew of its findings.

The Energy Infrastructure Planning Group, whose existence has not been previously disclosed, **[JR: Must have been classified information for National Security purposes.]** drew on the expertise of government specialists, including some in the CIA, and retired senior energy executives.

It concluded that although Iraq’s stated capacity was slightly more than 3 million barrels a day, the system was producing 2.1 million to 2.4 million barrels, panel members said.

The public revenue estimates made in the spring were in line with the very top range of projections made by the task force.

According to a Pentagon official who served on the panel, the review group projected yearly oil revenues at \$25 billion to \$30 billion “in the very best case, no sabotage and little or no battle damage,” and about \$16 billion in the “worse than best case”.

The worst case was no revenue for a few years, if there were “major sabotage and some significant battle damage”.

The Bush administration earlier this year projected the oil revenue would be \$20 billion to \$30 billion a year. **[JR: With all the lies and spin gushing out of the cesspools at the Pentagon and the White House, it’s a wonder that Washington isn’t declared an ecological disaster and unfit for human habitation. Those who are of conscience are on the endangered species list and by the next election the few who are left may soon be declared an extinct species.]**

TURKEY MARCHES BOLDLY INTO IRAQ

As expected, the Turkish parliament voted 358 votes to 183 Tuesday to authorize the dispatch of troops into Iraq. The ruling Justice and Development party (AKP), with Islamic antecedents, passed the motion at the request of its NATO ally the United States.

Parliament did not specify how many Turkish troops would be sent, but in the past it was discussed that up to 10,000 soldiers would be dispatched, which would make it the largest contingent after the U.S. and the British forces.

The U.S. recently granted Turkey, which is undergoing an economic crisis, a loan of US\$8.5 billion, **[JR: Cheap price to send men to war. The payoff is in the form of a LOAN. The money will go right back into U.S. Zionist coffers.]** but has made it clear that the loan is conditional on cooperation over Iraq. In its motion seeking parliamentary approval, the Turkish government made no mention of persistent U.S. demands for Turkish troops, and stressed its

own national interests lie in preventing the establishment of an independent Kurdish state in northern Iraq that could embolden its own Kurds—some 20 percent of the population. U.S. counter-terrorism experts met Turkish officials last week and agreed on joint efforts to tackle the some 5,000 Kurdish rebels believed to be holed up in the mountains in northern Iraq. ... **[JR: We are doing the same thing in Afghanistan...getting rid of the defenders.]**

Apart from the Kurds in north Iraq, who have made their opposition to the dispatch of Turkish troops clear ever since U.S. planned to invade Iraq, the PUK is even opposed to Turkish troops passing through Kurdish Iraq. Turkey had invited some tribal leaders from Iraq, but their response to the presence of its troops in Iraq was not very positive. **[JR: What powers of persuasion could change their minds?]**

Naturally, the U.S. has welcomed the Turkish decision and it has been working hard for months to get **[JR: MUSLIM]** troops from a major country culturally similar to Iraq. Attempts were made to win troops from India and Pakistan, but with elections announced on October 6 in its five states, India has already declined and is unlikely to change its position. Even the position of sending troops from Pakistan remains a confusing enigma, however with India’s refusal Pakistan is unlikely to agree as President General Pervez Musharraf has enough problems to deal with in his own backyard. ...

With the disputes between the U.S. and NATO allies France and Germany still raw and differences persisting over another UN resolution on Iraq, even with Russia and China, there appears to be little chance of other nations contributing troops. ...

Turkish government spokesman Cemil Cicek said on October 6, “Turkish soldiers will remain there for one year, that is, the validity of the motion we are sending to parliament has been limited to one year.” He added, “We will not remain there permanently. Hopefully, peace and serenity will be restored [in Iraq] as quickly as possible, thus allowing us to leave even earlier.” **[JR: Miracles do happen!]**

The U.S. government assured Turkey that it will do more to combat Kurdistan Workers’ Party (PKK) rebels, **[JR: Like targeting them for an air missile attack?]** the Turkish separatist movement that has waged a bloody decades-long struggle in Turkey. Prime Minister Recep Tayyip Erdogan has argued that sending troops would improve relations with the U.S. and give Turkey a say in the future of Iraq. Details of the deployment will be decided by Erdogan and his ministers. ...

[JR: The Turkish government has made a pact with the devil in agreeing to send its troops into volatile Kurdish territories. Getting involved in a war with the U.S. is the worst solution to solve Turkey’s long-term economic problems. If I am not mistaken, it was a Muslim majority that put Erdogan into power. No mention here as to how all this sets with the Turkish people. This might also be a plot to draw Iran into the conflict, as the U.S. knows Iran is adamantly opposed to Turkish troops, especially in Northern Iraq. Is the Turkish government’s selling point to its people that they get to eliminate their Kurdish enemies and in doing that become America’s most favored ally in the region? Adding to this mystery is why the Iraqi Governing Council backed off from its objections to having Turkish troops in Iraq? The AP spin is that “the key council members wanted to avoid a showdown with the U.S.” and that their differences with the Turks were reconcilable differences. Appeasing one’s oppressors comes easy to those who don’t know the difference between loyalty and betrayal. Maybe it’s the U.S. programming too.]

AS BOSNIA HEALS, U.S. ACCEPTS SERBIAN HELP

SARAJEVO, Bosnia—Several weeks ago, an astonishing memorial event took place in the haunted valleys near this still-graceful city savaged by the Serbs in the Balkans wars of the 1990s.

In the undulating hills around the village of Srebrenica, a monument that will be home to dozens of graves was commemorated to the 7,000 Bosnian men and boys who were slaughtered here in July 1995 by Serb military and irregular forces. Former President Bill Clinton spoke, using the emotion-laden word “genocide” to describe those days, and 30,000 people attended the ceremony. A special musical cantata, *Srebrenica Inferno*, was composed to mark the day, especially for the many mothers, daughters and sisters of the victims. ...

Incredibly, the American administration announced this week that it has accepted the offer of the Serb government in Belgrade to send 1,000 or more Serb soldiers and gendarmes to fight alongside American troops in Afghanistan. By next winter the United States will be working alongside Serbs from a still-unreconstructed Serb military and gendarmerie—and, once again, against Muslims in a Muslim country. **[JR: Does the U.S. know how to make a coalition of paid mercenaries, or what?]**

True, some progress has been made in Belgrade by the new defense minister, Boris Tadic, in beginning to reform the atrocity-haunted security forces. Across the Balkans and Europe, though, I found nothing but continued Serb recalcitrance about recognizing war crimes guilt, turning over war criminals, or helping move regions such as Kosovo or new independent countries such as Bosnia on to a new era.

But there is something this Serb government does want: It wants immediate membership in the Partnership for Peace, eventual membership in NATO and the entire European Union, and community and Western rewards for anything it agrees to give up. **[JR: It is always good to set goals to get what you want.]**

The idea of sending Serb troops to Afghanistan came up in Washington last August when the Serbian prime minister and foreign minister came to the White House. These Serbs understood that the Americans 1) wanted almost any way out of the Balkans, and 2) were so desperate for foreign troops in Afghanistan and Iraq that they would have taken the Mongol Khan’s legions. **[JR: If and when they are made available to us.]** The White House agreed to their proposal.

Meanwhile, my sources here and in Belgrade say essentially this: “The Serbs are trying to get into America’s favor, but they want to do it their way—not to reform, but to get Kosovo back. The way they do it is to depict the Kosovars as Islamic terrorists, like the ones in Afghanistan. Serving in Afghanistan is merely a way of showing the Americans they’re on their side so they can get what they want.” **[JR: We have made sure that every country now has their own Muslim terrorists to fight.]**

The official idea is that the Serb contingent would be a mixture of army and gendarmerie. But the gendarmerie in Serbia is not a police corps; it is a highly armed militia, with more combat experience in the ’90s than the army, and it has body armor, camouflage suits and Hummers. **[JR: The CIA and Mossad probably trained them. We paid to equip this unit with weapons and armor—the Hummers are the clue.]** The general the Serbs first put forward as the leader for Afghanistan is Goran Radosavljevic, who has been cited by numerous human rights groups for war crimes in Kosovo, including massacres of civilians.

The situation here could be quite simple. The U.S. and Europe have overwhelming power after the 1999 NATO campaign that destroyed the Serbian war power machine.

But instead of actually using that power to force reform, Washington is caught in its self-imposed need to get others—anyone—to support it in its many new wars across the globe. **[JR: Makes you wonder here if NATO isn't our silent partner behind the scenes.]**

As one journalist familiar with the area told me: "It will be a field day for *Al Jazeera*. They'll be showing films of the Serb atrocities in the Balkans all across the Arab world—only now, they're fighting alongside Americans." **[JR: America is setting up the Middle East for a battle ... or coups for a silent invasion. We are building a "coalition of the willing" with leaders who are either very needy or very greedy. Instead of an arms race America is building up armies and setting up governments and systems for Zionist takeover. We do the nation-building and Israel gets to become the pseudo messianic King David Alroy, who is symbolized by the Blue six-pointed star that is prominent on the Israeli flag. How is that for not being just a mere coincidence?]**

WASHINGTON INSIDERS' NEW FIRM
CONSULTS ON CONTACTS IN IRAQ

A group of businessmen linked by their close ties to President Bush, his family and his administration have set up a consulting firm to advise companies that want to do business in Iraq, including those seeking pieces of taxpayer-financed reconstruction projects.

The firm, New Bridge Strategies, is headed by Joe M. Allbaugh, Mr. Bush's campaign manager in 2000 and the director of the Federal Emergency Management Agency until March. Other directors include Edward M. Rogers Jr., vice chairman, and Lanny Griffith, lobbyists who were assistants to the first President George Bush and now have close ties to the White House.

At a time when the administration seeks Congressional approval for \$20.3 billion to rebuild Iraq, part of an \$87 billion package for military and other spending in Iraq and Afghanistan, the company's Website, www.newbridgestrategies.com, says, "The opportunities evolving in Iraq today are of such an unprecedented nature and scope that no other existing firm has the necessary skills and experience to be effective both in Washington, D.C., and on the ground in Iraq."

The site calls attention to the links between the company's directors and the two Bush administrations by noting, for example, that Mr. Allbaugh, the chairman, was "chief of staff to then-Gov. Bush of Texas and was the national campaign manager for the Bush-Cheney 2000 presidential campaign."

The president of the company, John Howland, said in a telephone interview that it did not intend to seek any United States government contracts itself, but might be a middleman to advise other companies that seek taxpayer-financed business. The main focus, Mr. Howland said, would be to advise companies that seek opportunities in the private sector in Iraq, including licenses to market products there. The existence of the company was first reported in *The Hill*, a congressional newspaper. **[JR: Looks like this "company" has set itself up as the U.S. government's business agent for redevelopment of Iraq, with a little help from their friends in the Bush administration.]**

Mr. Howland said the company was not trying to promote its political connections. He said that although Mr. Allbaugh, for example, had spent most of his career "in the political arena, there's a lot of cross-pollination between that world and the one that exists in Iraq today".

As part of the administration's postwar work in Iraq, the government has awarded hundreds of millions of dollars in contracts to American businesses. Those contracts, some without competitive bidding, have included more than \$500 million to support troops and extinguish oil

field fires for Kellogg, Brown & Root, a subsidiary of Halliburton, which Vice President Dick Cheney led from 1995 until 2000. **[JR: Yes there were a lot of "sweetheart deals" if you have the right connections.]**

Of the \$3.9 billion a month that the administration is spending on military operations in Iraq, up to one-third may go to contractors who provide food, housing and other services, some military budget experts said. A spokesman for the Pentagon said today that the military could not provide an estimate of the breakdown. **[JR: Of course they can't, or won't.]**

Administration officials, including L. Paul Bremer III, the top American official in Iraq, have said all future contracts will be issued only as a result of competitive bidding. Already, the Web site for the Coalition Provisional Authority, <http://cpa-iraq.org/> lists 36 recent solicitations, including those for contractors who might sell new AK-47 assault rifles, nine-millimeter ammunition and other goods for new army and security forces.

New Bridge Strategies was established in May and recently began full-fledged operations, including opening an office in Iraq, its officials said. They added that a decision by the Governing Council of Iraq to allow foreign companies to establish 100 percent ownership of businesses in Iraq, an unusual arrangement in the Mideast, had added to the attractiveness of the market.

Mr. Howland is a principal of Crest Investment in Houston and was president of American Rice, once a major exporter to Iraq. Richard Burt, ambassador to Germany in the Reagan administration and a former assistant secretary of state, and Lord Powell, a member of the British House of Lords and an important military and foreign-policy adviser to Prime Minister Margaret Thatcher, are among the 10 principals.

Mr. Allbaugh, the chairman, spent most of his career in Texas politics before Mr. Bush appointed him to head the federal disaster agency. Mr. Allbaugh, who now heads his own consulting firm here, did not return calls to his office today.

Mr. Rogers, the vice chairman who was a deputy assistant to the first President Bush and an executive assistant to the White House chief of staff, is also vice chairman of Barbour Griffith & Rogers, one of the best-connected Republican lobbying firms in the capital. Mr. Rogers founded it in 1991 with Haley Barbour, who became chairman of the Republican National Committee and is now running for governor of Mississippi.

Shortly after leaving the White House, Mr. Rogers was publicly rebuked by the first President Bush after he signed a \$600,000 contract to represent a Saudi, Sheik Kamal Adham, who was a main figure under scrutiny in a case that involved the Bank of Commerce and Credit International. Mr. Rogers canceled his contract to represent the sheik, former head of Saudi intelligence.

Mr. Griffith, a director of the new company, is chief operating officer of Barbour Griffith & Rogers, which he joined in 1993. He was special assistant for intergovernmental affairs to the first President Bush and later worked under him as an assistant secretary of education.

Until November, Mr. Rogers's wife, Edwina, was associate director of the National Economic Council at the White House. Reached by telephone today, Mr. Rogers said he did not want to speak for the record and referred a reporter to Mr. Howland.

The company Website says the company was "created specifically with the aim of assisting clients to evaluate and take advantage of business opportunities in the Middle East following the conclusion of the U.S.-led war in Iraq."

[JR: As you can see, just with the references in this article, once someone gains a political appointment or is hired by the administration in Washington—they will most likely be fixed for life because political connections are very valuable and garner a substantial reward if you play their games. The bottom line is, it's not how good you are, it's how well connected you are.]

IMF CAN'T SQUEEZE BLOOD FROM A STONE

ARGENTINA—Eduardo Galeano, the Uruguayan writer, ironically defined "foreign debt" as "the commitment that each Latin American inherits when he is born. This modest amount of \$2,000 will some day finance the club that will be used to strike him."

Who is responsible for the economic crisis of the Third World countries? International corporations and their financial institutions, such as the International Monetary Fund and the World Bank. These institutions, together with compliant local governments, have masterminded the theft and rip-off of the entire region for decades through drawing the countries into debt.

The negotiations that decide how these loans are to be repaid are never held up to public scrutiny and debate, but rather are decided behind closed doors by way of threats and bribes. Once the deal is made, the workers, especially the most vulnerable, must suffer the austerity measures that are sure to follow.

At the beginning of the 1970s, the United States started to impose on Latin America what is called the neo-liberal economic model. In Argentina, it led directly to a bloody military coup by the murderous general Jorge Rafael Videla. At that time the foreign debt of this South American country was \$9.7 million.

In May 2003, when Nestor Kirchner took office as president of Argentina, the debt had risen to \$160 billion. Among other things, during his inaugural address, Kirchner promised, "The international financial agencies have to understand that the external debt cannot be paid at the cost of the Argentine people's suffering." **[JR: I hope he can stand by what he says and doesn't fold under the pressure from the IMF, WB and the U.S.]**

The people's hope that Kirchner would not pay the foreign debt dissipated in mid-September, however, when he negotiated an agreement with the International Monetary Fund just a day after Argentina defaulted on a \$2.9-billion debt payment. In the three-year pact, the country will pay only the interest due on the \$13 billion it owes the IMF. For some of the blood-sucking officials of the Group of Seven imperialist countries, this was attacked as a "cave-in" by the fund.

One of the reasons the IMF had to take a "soft" approach with Argentina is because the workers and poor are still in motion and are watching very closely every move of Kirchner's administration. At this point his popularity remains high, because he has taken measures that for years have been the central demands of many Argentines.

When he became president, Kirchner almost immediately removed the upper command levels of the armed forces and announced that top commanders of the federal police would also be replaced. He took aim at the Supreme Court and asked Congress to impeach some justices on corruption charges. He also declared the "Full Stop" and "Due Obedience" laws null and void. Also known as amnesty laws, these have for many years kept victims of the brutal military leaders from obtaining truth and justice. Groups such as the Association of Mothers of the Plaza de Mayo, whose children were "disappeared" by the military rulers, welcomed and applauded Kirchner's move. But all of that could change quickly, as the economic burden on the masses increases.

The IMF demands that Argentina compensate the banks for last year's collapse in the value of the peso, and that it raise utility prices. This would turn basic necessities like electricity, water and gas into luxuries for many Argentines. But no date has been set to carry this out. **[JR: As you can see, the IMF is not concerned with the lives of the people, just that their policy demands are met.]**

On Sept. 9, while negotiations were taking place, many people took to the streets to protest the presence of the IMF negotiator. **The IMF knows that if the government of Argentina decides not to pay on the foreign debt, it would set an example with unpredictable consequences for the region.**

But paying the foreign debt is not the only alternative open to Latin America. Venezuelan President Hugo Chávez recently called for a continental referendum on the question of whether South American countries should pay their external debt.

The people of Latin America owe nothing to any imperialist financial institution. They have never benefited from these loans. The capitalist myth that Argentina was a great economic model for Latin America has evaporated and hard reality has set in.

The elections of “Lula” da Silva in Brazil, Chávez in Venezuela and Kirchner in Argentina have brought some hope to the workers and poor. Cosmetic changes to reform capitalism or make it more humane are taking place in the region. But if the U.S. neo-liberal model continues intact, nothing will solve the problem of the masses. Real changes will come only when the workers can finally take control of their own destiny.

[JR: A people’s revolution by all of the South America countries at the same time is needed to force a stop to the outside pressures of the capitalists. They can’t win as individual states because money from outside agents will procure any greedy official or figurehead that will sell out their people. The masses have to act in mass to be effective, as singular action would be utter suicide.]

ARROGANT U.S. AMBASSADOR TO VENEZUELA
CHARLES S. SHAPIRO SAYS
IT’S NOT A CRIME TO KILL A PRESIDENT...

In an *Associated Press* (AP) dispatch the United States government has said it will open up an investigation into allegations made by Venezuela’s President Hugo Chavez Frias relative to a conspiracy to assassinate him. Chavez Frias has said that “terrorist groups” in southern Florida have allied with Miami-based anti-Castro radicals.

Amazingly U.S. Ambassador to Venezuela, Charles S. Shapiro says “it is not necessarily a crime... [JR: Spoken like the unwavering Zionist that he is.] but we are in the full process of collecting information and we must follow all legal procedures... if there is anyone to blame, our government knows what to do!” **[JR: You Bet!]**

With typical Washington cover-up rhetoric, Shapiro shakily **[JR: Shakily maybe, but not stirred.]** admits that he has received information that “some Venezuelans have been receiving military training in the United States”. **[JR: This is how the U.S. gains its dominance and control in other countries’ affairs. The blueprint for these types of operations is called the Andes Plan and is the brainchild of Henry Kissinger.]** He further admits that the information was also published in a Miami newspaper a year ago... but remains remarkably silent as to why no action was taken by proper authorities Stateside. “We’re not going to take action against anybody... we haven’t been able to make any headway!”

President Chavez Frias was forced to cancel his scheduled trip to the United Nations in New York on September 24 after intelligence agencies revealed a CIA-backed plot against the President’s plane en route to the General Assembly. Chavez asked the United States to investigate his allegations, at the same time reiterating earlier requests that President George W. Bush should stop interfering in Venezuela’s affairs.

“They are conspiring against Venezuela in the United States,” Chavez Frias said in a national television broadcast ... “the peoples of this continent need to know that their (U.S.A.) terrorists are preparing an attack against Venezuela!”

DA SILVA VISITS CASTRO:
TRADE, POLITICS ON AGENDA

CUBA—Brazilian President Luiz Inácio Lula da Silva and a 100-member entourage arrived in Havana on Friday to a red-carpet greeting by Cuban President Fidel Castro, an old friend and supporter.

Da Silva was expected to discuss regional trade, aid and political integration with Castro and sign several agreements with Cuba before leaving Havana today.

Among the most important items on his agenda is a credit line of up to \$400 million by Brazil’s National Development Bank to finance Cuban imports of Brazilian machinery, farm equipment and food, the *Associated Press* reported. **[JR: No mention is made here of the Brazilian businessmen putting up \$150 million to build four beachfront hotels for the expected surge in tourism that will help the Cuban economy.]**

As expected, da Silva kept at least publicly mum on Cuba’s internal affairs, including the island’s crackdown on government opponents that have received worldwide condemnation.

Da Silva received several requests from dissidents and relatives to intervene on behalf of the 75 government opponents jailed six months ago and serving terms of up to 28 years. ...

Diplomats told the *Agence France-Press* news service that da Silva wanted to “push forward Latin American integration and is convinced of the importance of not excluding Cuba from the concert of nations”, especially at a time of pressure “not only from the United States but also from the European Union”.

Da Silva, a leftist-turned pragmatist, **[JR: Our media labeling.]** received a warm welcome when he arrived at Havana’s Jose Martí Airport on a midday flight from Mexico and was greeted by Castro, dressed in his traditional military fatigues.

The Brazilian delegation, comprised of about 20 Cabinet members, 50 business executives and 30 lower-ranking government officials, is interested in several sectors of Cuba’s economy including sugar, fishing, generic medicines and vaccines, tourism, and offshore oil exploration.

Representatives of Brazil’s national oil company, Petrobras, also are examining the restructuring of Cuban oil refineries including the Cienfuegos plant in central Cuba, as well as the modernization of equipment, according to media reports from Havana.

Trade between the two countries totaled about \$88 million in 2002, *AFP* reported.

[JR: The slant here is not to focus on the spirit of trade between two counties but to put the spin on the fact that da Silva is a “leftist” leader making trade agreements with

leftist Cuba and Castro. Should these trade agreements be viewed as another Cuban/Brazilian Missile crisis with the U.S.? Why did the *Miami Herald* omit the comment by President da Silva (AP report) when he stated: “In a globalized world, we must join together...so we can compete one-on-one with developed nations.” Weren’t these inequities the main reason for the demonstrations in Cancun during the recent WTO meetings? The bigger trading countries have ignored inclusion of the smaller nations that are now taking matters into their own hands by forming their own trading alliances to survive in the competitive global market. CRITICS STALL REVISION OF CITIZENSHIP OATH

WASHINGTON (AP)—An attempt to revise the citizenship oath to make it more meaningful for new Americans has been stalled after conservatives complained it weakened a pledge to serve in the military and eliminated a promise to bear arms.

The planned Wednesday debut of the new oath was postponed as immigration officials scrambled for another rewrite.

Earlier this month, immigration officials said they were revising the oath for the first time in 50 years.

The revision removed a line pledging to “renounce and abjure all allegiance and fidelity to any foreign prince, potentate, state or sovereignty”. It also eliminated a vow to “bear arms on behalf of the United States when required by the law”, and rewrote a section pledging to serve in the armed forces when required by law.

That rewritten section said: “Where and if lawfully required, I further commit myself to defend the *Constitution* and laws of the United States against all enemies, foreign and domestic, either by military, non-combatant or civilian service.”

Critics said the rewrite would create a legal loophole for serving in the military. Edwin Meese, the Reagan administration attorney general who now works for The Heritage Foundation, asked the Bush administration to reconsider the changes.

“The real reason for the shift is that the old oath was an absolute commitment,” said Matthew Spalding, director of the Hudson Institute’s Center for American Studies.

Disagreeing was Tim Edger of the American Civil Liberties Union. “I think some are confused about this new oath, maybe trying to invent controversy for the purpose of casting doubt on the loyalty of new Americans and on the dedication of the immigration service, and I think that’s a shame,” Edgar said.

Current text of allegiance oath

I hereby declare, on oath,

That I absolutely and entirely renounce and abjure all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, of whom or which I have heretofore been a subject or citizen;

That I will support and defend the *Constitution* and the laws of the United States of America against all enemies, foreign and domestic;

That I will bear true faith and allegiance to the same;

That I will bear arms on behalf of the United States when required by the law;

That I will perform non-combatant service in the Armed Forces of the United States when required by the law;

That I will perform work of national importance under civilian direction when required by the law; and

That I take this obligation freely, without any mental reservation or purpose of evasion; so help me God.—Bureau of Citizenship and Immigration Services

[JR: This intended revision seems to be designed to be

“politically correct” and make the oath ambiguous to allow for misinterpretation by those with dual citizenship like the Zionists. The present need for more military personnel has initiated a movement to recruit Mexican immigrants both legal and illegal into the U.S. military. 1.7 MILLION MORE LIVING IN POVERTY
BY REGIONS, MIDWEST IS HARDEST HIT

WASHINGTON—Another 1.7 million people slid into poverty last year, the Census Bureau reported Friday, likely raising anxiety in homes across the nation, including the White House. **[JR: The White House has no such concerns but to stay in power.]**

The report, which came as pressure builds on the Bush administration over what has been called a jobless economic recovery, indicated that the national poverty rate rose for the second straight year—from 11.7 percent in 2001 to 12.1 percent in 2002. The Midwest, where manufacturing industries have been hard hit in recent years, was the only region to see its poverty rate increase significantly last year, according to the report.

Meanwhile, U.S. median household income fell 1.1 percent to \$42,409 in 2002 from the previous year, the agency said. Once more, the Midwest was the only region to see a statistically significant deterioration in household income, the Census Bureau said. ...

The data showed that 34.6 million people were living in poverty in the U.S. last year out of a population approaching 290 million. Daniel Weinberg, chief of the Census Bureau unit that produced the data, said poverty and income data often show weakness at this stage of an economic recovery. Economists say the recession ended in November 2001. ... **[JR: The more realistic ones still allude to being in a recession.]**

But experts on poverty, while acknowledging problems with the economy, also blamed policymakers.

“I would argue that misplaced priorities by our policymakers are making the increase in poverty somewhat larger than it needs to be,” said Robert Greenstein, executive director of the Center on Budget and Policy Priorities, a Washington-based organization that researches economic issues affecting poor and middle-income Americans.

“In 2002,” Greenstein said, “the number of unemployed workers who ran out of unemployment benefits before finding work and thus got neither a paycheck nor unemployment benefits was double the number in the comparable period of the recession of the early ’90s.

“This occurred in significant part because Congress and the administration have made federal unemployment for long-term unemployed workers more limited in the current slump than in previous downturns,” he said. ... **[JR: That’s because the Bushkovites have very costly wars to pay for.]**

Other experts said, however, that they expect the poverty rate for 2003 to increase from 2002, partly because the number of long-term unemployed has increased markedly. ...

“The story is that despite having economic growth from ’01 to ’02, families are feeling it in their incomes because of a weak labor market,” said Jeff Chapman, an analyst at the Economic Policy Institute, a liberal Washington think tank. “Growth hasn’t been sufficient to produce jobs. Especially in Illinois and Michigan and other states like that, the rapid decline of manufacturing has really hit people hard.”

2 MORE NOBELS FOR ILLINOISAN SRESEARCHERS
AT ARGONNE, U. OF I. SHARE PRIZE

Two Illinois researchers shared the Nobel Prize in physics Tuesday for their work explaining the strange behavior of electricity and fluids at extremely low temperatures, bringing to four the number of Illinois-based scholars who have won a Nobel in the last week.

It was the ultimate vindication for Alexei A. Abrikosov of Argonne National Laboratory near Lemont, whose ideas about a new class of resistance-free, superconducting electric current met with disbelief and dismissal when he first published them in the former Soviet Union in 1952.

Abrikosov shared the prize with Russian colleague Vitaly Ginzburg and physicist Anthony J. Leggett of the University of Illinois at Urbana-Champaign, who explained in the 1970s why a type of liquid helium becomes “superfluid” at low temperatures, flowing with so little friction that it can climb up the sides of a laboratory beaker.

The common link is their explanations of the way the physical world changes at low temperatures, producing effects that have only begun to be exploited for their practical value. The applications include an array of new technologies that rely on superconductivity—including magnetic resonance imaging, cellular-phone base stations and particle accelerators that probe the basic forces of the universe.

The influence of Abrikosov’s 50-year-old discoveries has only increased since the 1980s, as researchers have raced to understand a new group of superconducting materials that work at relatively high temperatures.

“He’s really one of the heroes of the field,” said George W. Crabtree, director of Argonne’s material science division.

Although Leggett’s work on superfluid helium has no direct applications yet, the effect is similar to how electrons move in a superconducting material—superconductivity being one of Leggett’s prime research interests.

Experts said Leggett’s work also has influenced the study of quantum mechanics and the quirky rules governing the bizarre behavior of subatomic structures. ...

Leggett, who studied philosophy as an undergraduate until physics entranced him at Oxford University, tackled notions in a growing field of physics that few could understand and linked them to the world at large.

Prior to his work at the University of Sussex in England, quantum mechanics could be explained only on paper. His theories linked what happened at the subatomic level to phenomena that could be observed in the laboratory. ...

Superconductivity has been known since the early 20th Century, when scientists realized that near absolute zero—around minus 459 degrees Fahrenheit—certain metals could conduct electricity without losing current to resistance. **[JR: This is technology created by the genius of Nikola Tesla which provides cheap electricity and does not require wires, just a little black box.]**

The effect occurs when electrons lose their tendency to repel each other and move smoothly in pairs. That explanation was first proposed at the U. of I. in 1957 by physicists John Bardeen, Leon Cooper and John Schrieffer, who won the Nobel Prize in 1972 for their work.

Physicists describe the motion of superconductivity as a kind of dance or “electronic liquid,” in which the normal loss of energy to resistance and heat ceases.

Leggett used the discovery of paired electrons as inspiration for understanding a similar phenomenon—the frictionless movement of a form of helium at extremely low temperatures. ...

Abrikosov was recognized by the Royal Swedish Academy of Sciences for his work in the early 1950s that has shaped the burgeoning field of superconductivity.

Abrikosov proposed that in some superconducting materials there should be vortices that allow magnetic fields to move through the substance. It was an unfamiliar concept at the time because most known superconductors behaved differently.

“There was general incredulity that this could ever happen,” said U. of C. physicist Kathryn Levin, a superconductivity researcher.

“I think one of the strengths of Abrikosov’s character as a scientist was to stick to his guns and believe in himself, despite the fact that no one had ever thought in these terms,” she said.

As it turns out, most of the superconducting materials discovered since the early 1960s have been of the type that Abrikosov described a decade earlier. Among other attributes, the materials can carry more electricity than the previously known superconductors. ...

The vortices that Abrikosov predicted are now a staple of work on superconductivity and are known as “Abrikosov vortices”. Some experts said it was only a matter of time before he received a Nobel Prize for the pivotal contribution. ...

[JR: Does the granting of this Nobel Prize in physics finally open the door for scientists to fully “explore” these types of technology that governments have known about but have suppressed since the turn of the last century? The Elite have use of these advanced technologies in their secret hideaways yet won’t allow it for the general public because it would provide cheap energy for the world and the poor, struggling nations. KEY ISSUE: PALACE CORRUPTION

From all indications, the Fraport complaint lodged before the World Bank arbitration body has shaken Malacañang and its occupants, and more, since at the root of the complaint is the corrupt and unlawful practices that is alleged to have been engaged in by the Palace occupants, their aides and their cronies.

The Palace propagandists, in their usual unthinking fashion, quickly laughed off this Fraport complaint, only to realize the big blunder they committed, as the corruption issue took the spotlight and they couldn’t quite shake it off, which was why, two days after this was re-exposed by opposition Sen. Panfilo Lacson in the Senate, President Arroyo belatedly claimed to be

“shocked”, while at the same time clearing her aides by saying the charges were “ridiculous”.

Today, however, the same Palace propagandists went into high gear, claiming the key issue in the Fraport complaint is not corruption, but compensation.

They intentionally miss the point. From the complaint, it was clear that the German investor brought this up before the arbitration body in Washington precisely because Fraport refused to meet the demands of an alleged payoff of “tens of millions” to the presidential aides and the personal lawyer of Mrs. Arroyo, who was described in the complaint as her confidant and fundraiser. And it was Fraport’s rejection of these Malacañang demands which led to the contract being voided by the President herself—and later, the Davide Court, which is perceived to do the presidential bidding and is also seen to be mired in corruption. The case for compensation rests on the corruption charges, and well do the Malacañang occupants and their aides know it.

In their usual spin fashion, the Palace propagandists focused on the line that the Fraport complaint was done to humiliate and embarrass Mrs. Arroyo and timed for the visit of U.S. President George W. Bush today. But this complaint was lodged a month ago, and the Palace certainly knew of it last month, but kept this under wraps, precisely because of the stink it would raise at home once this was exposed.

Surely Malacañang doesn’t believe that Bush or the U.S. government and its embassy here would only be made aware of these charges of corruption because of his visit? These have already been aired by the U.S. ambassador publicly and through a foreign media forum.

The Palace intention was clearly to protect those who stand accused of corrupt and illegal practices that accompanied the voiding of a perfected contract, even more than fending off the reality of shaken investors’ confidence in dealing with their big-ticket investments in the country.

At the same time, faced with the explosive Fraport complaint, another case, this time by the Philippine International Air Terminals Inc. Co. consortium, has been lodged before the Paris-based International Arbitration Court, which asked for just compensation, Malacañang quickly screamed “forum shopping”, little realizing that precisely, the Arroyo administration all throughout the Piatco controversy, insisted on dealing only with Fraport, ignoring the other Piatco shareholders such as the Cheng family, the Singapore-based SB Airport and Nissho-Iwai, all of which also demand just compensation.

There is sufficient evidence to prove that the Arroyo team, led by Trade Secretary Manuel Roxas II, which was negotiating the takeover of the airport terminal project, hardly bothered with the other Piatco stockholders, concentrating only on their German partner, Fraport, for compensation that was much less than the investment money it had poured into the project.

The other spin being done by the Palace is that the international courts’ decision is meaningless, as Malacañang claims the final arbiter is the Philippine Supreme Court, not the Washington or Paris arbitration bodies.

This position taken by the Palace merely shows the world of business and world governments that the Philippine Republic, even as a signatory to international treaties and agreements, does not honor these agreements. Who then would want to deal with such a corrupt government that moreover, has a corrupt judiciary?

But if the Arroyo administration thinks it can get away without any sanctions from big-time creditors by ignoring the international arbitration courts and rely simply on the Davide Court’s voiding of the contract, it has another think coming.

Not only will the economic faucet dry up quickly: The country’s name will be mud among big-ticket investors who won’t touch the Philippines with a hundred-foot pole.

NEVADA CORPORATIONS:

What They Don’t Say Can Really Help You

Budget’s “Tip of the Week” #5:

Key provisions NOT included in Nevada’s corporate statutes

In the first four installments of “Tip of the Week” we took a close look at several very interesting provisions of Nevada’s corporate statutes. Sometimes, however, what is NOT mentioned in the statutes is just as important.

In Nevada, as many readers may be aware, there is no statute mandating the issuance of stock. (Nevada is not unique in this regard; several other states’ corporate statutes similarly ignore this key issue. What makes Nevada unique is the combination of statutory provisions, non-addressed key issues and actual practices, all of which add up to make Nevada the ONLY state that allows for privacy of ownership and control of a corporation.)

As if to underscore the non-necessity of stock issuance, there is no requirement to hold an annual meeting of stockholders. Yes, there are many references to the stockholders’ meeting but nowhere is it stated that any such meeting must be held.

Similarly, Nevada is one of a few states that does not nullify the use of “bearer” shares. It is not that there is a statutory provision endorsing the use of bearer shares or even addressing the issue; it is that the issue goes entirely unmentioned, whereas in most other states the use of bearer shares is statutorily denied.

A major, major issue that is not addressed anywhere in the *Nevada Revised Statutes* is that of nominee officers and directors. The use of nominee officers and directors has been common in practice in Nevada for more than 75 years and yet this issue, which is the key to privacy of control of a Nevada corporation, is simply not mentioned. Doesn’t that make you wonder why not?

Other states (Wyoming comes to mind) have directly addressed the issue of nominee stockholders. In Nevada, however, there seems to be more power granted by not restricting the use of this technique even by defining it.

Nevada only requires a corporation’s primary officers to be listed annually but does not abridge the key roles that can be afforded to secondary officers, such as a vice president, who may exercise all of the powers of the president in the president’s absence; an assistant treasurer, who may be empowered to sign checks and otherwise fulfill the role of treasurer; or an assistant secretary, who may perform all of the duties of the secretary. When nominee service is used, the primary officers are assuredly absent, empowering these secondary officers, who are never listed in the public records with the Secretary of State.

Finally, since only an annual list of officers needs to be filed, a corporation may change its officers and directors at any time through a proper resolution (a PROTECTED “internal” record of the corporation) without notifying the state to modify the public record.

This listing is, of course, by no means all-inclusive. We trust, however, that it provides the reader with a lot of serious “food for thought” as to possibilities for private control and ownership of Nevada corporations.

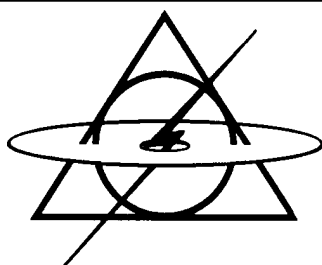
