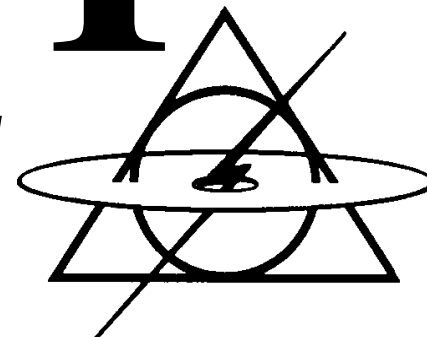

DM'S 'REMEDIES AGAINST POVERTY' AND HOW GMA BETRAYED HER FATHER

Former President Diosdado Macapagal (DM for short) was one public figure consumed by the obsession to eliminate poverty and to free the mass of his countrymen from that scourge. That obsession was apparently nurtured in him by his impoverished beginnings and would hound him from the time he entered politics in the 1950s until he passed away in the late 1990s—after serving as a member of Congress, as Vice President and subsequently as President of the Republic and president of the 1971 Constitutional Convention. His life was consumed in public service.

No figure in Philippine politics can approximate his dedication to the poverty problem. He earned that dedication with him long after he had retired from public office and it is an apt commentary on his enduring obsession that among the last, if not the last, public demonstrations of his concern was an article he wrote for the *Manila Bulletin* in May 25, 1995, titled "Remedies Against Poverty". That article might well be considered his last political

will and testament on where he stood on the poverty question and how that question should be disposed of by the Filipino people and their government.

His *Bulletin* article outlined five points but for reasons of space this piece will focus on the two most relevant in the context of our times. Those points were (1) that the Philippines should strive to be a truly independent state; and (2) that the nation should lose no time becoming a newly industrialized country (NIC). That prescription may be summed up in two commands: Be independent and industrialize.

On the first, namely, to be independent, these were his precise words: "The Philippines and its government should become truly independent so as to adopt policies and decisions on the overriding basis of the national interest. It is only if our government and its leaders are free to decide and act in the highest interest of our people that we can solve our vital problems, particularly the redemption of the poor from poverty."

On the second, namely, industrialize, these were his precise words: "The Philippines should hasten its becoming an NIC. The Filipinos must labor with unity and dedication to consummate this aspiration because

it is the key that will open the gates to economic and political justice. Without neglecting the need for an ever increasing productivity in agriculture, the nation must gear its energy mainly to becoming industrialized.”

DM's daughter, Gloria Macapagal-Arroyo, has done exactly the opposite. She has made it a point to preserve the nation's status as a dependency and she has consciously shunned the idea of transforming the Philippines into a NIC. You can search her 10-point program in vain for any hint that she intends to see this nation independent and industrialized.

We have paid a heavy price for that dependency. Because of that dependency on the U.S. and the global agencies it controls, namely the International Monetary Fund, World Bank and World Trade Organization, we have remained an essentially raw material-service economy even as every country around us has transformed into an NIC, or is fast transforming into one.

The latest sample of the price that we have had to pay for that dependency is the tragedy of our Filipino brothers in Iraq. True to our status of dependency, we have on call from Washington sent military personnel to Iraq and thereby gotten involved in a war that is not of our making and which in fact is a war of colonial aggression by the United States on a nation that is acknowledged to be the “cradle of civilization”. The current hostage crisis won't be the last. There will be more Filipinos in Iraq who will be captured and threatened with beheading as long as we maintain troops in that country in violation of international law and the sovereignty of an Arab state.

But back to the poverty question. DM, by his long experience in politics and public service, which cannot possibly be matched by his daughter, reminded this nation, which he had served for a lifetime that the way out of the poverty trap is through independence and industrialization—but that's exactly the path which his daughter has spurned. She has spurned her late father's advice, turned her back on his last political will and testament, and has opted to do exactly the opposite of what her father had wished and willed.

One can justly speculate how DM must be feeling in the world beyond as he watches over the course of national events presided by his daughter. If spirits can weep, then DM's spirit must be profusely in tears, not so much for his daughter but for the people he had served long and hard, and who must continue to suffer the living hell which DM himself had experienced in his youth and from which he had hoped to redeem his people.

GMA's economic formula is a sure formula for more disaster and if she has a grain of intelligence, which she has, she should know that it is surely a formula for more disaster. But that doesn't matter to her because, all that matters to her is that she be perceived by the U.S. government as a true and faithful friend, so true and so faithful that she is willing and prepared to see her own people suffer and die as long as that's what America calls for, whether here or in Iraq.

And what happens should this country suffer a terror attack of the magnitude of 9/11 because of our government's persistence to stay the course in Iraq, as Washington demands?

America is expected to experience another 9/11, and our government has already been warned that the Philippines is also programmed to experience one unless we pull out of Iraq. But GMA appears bent on risking a Philippine 9/11 just so to be perceived as being on George W's side.

It's bad enough to betray one's father, but must one betray one's nation, too? And betray both for someone like George W?

I can now blend my consciousness with the cells of yours in order to provide you with some of the more specific information that I relate, but I do this as little as possible for you are gifted with free-will choices upon which I must not tread. My primary function is to show you how to tap these systems of data retention and revelation for self. With tutoring and experiencing with my presence or that of your spiritual teacher OF TRUTH—(dear ones, beware—all

spiritual beings do not bring truth!)—you will learn to release your definitions of who you think you are, open your self up to the experience of a much greater reality than you presently believe possible, and return to a level of consciousness whereby you will be enabled to communicate with those such as me, “us”, not through cumbersome words and concepts, but directly, through communion with all that is.

What do you want? Do you want to know more about extraterrestrials? Do you want a definition of angels? What difference does it make—if we tell you that we are the same as you, until you recognize who YOU are. Then you have a basis upon which to found understanding. If we be but you as you were, would have been and still are, had you not fallen from your original state of grace then you would recognize of us now or later in the proper sequence of the unfoldment. We exist in a parallel universe of non-form, and some in form not unlike your own only differing in vibrational manifestation with higher knowledge. You can know that we who come have higher knowledge in our present manifestation for we are here and you have not yet gleaned that ability. This is also how you can know we come only in peace and love and not to harm for we are higher learning and with higher learning comes the truth of the falseness of physical actions—WE LIVE BY THE LAWS AND WITHIN THE LAWS OF GOD AND THE CREATION.

I am here to enter your consciousness, here to awaken you unto truth.

As I blend with you now in this communication that is also communion, I can sense a forthcoming period of union—one which you also sense but cannot comprehend. I sense its strange and awesome realities. I feel much like an explorer in a vast and uncharted land but with knowledge of all the pitfalls and rocks upon which a ship of passage might become grounded. You become my counterpart in the physical and just as you become responsible for that which you push forth so do I accept responsibility for the truth, which is given unto you through me. This requires discipline on the part of both parties that we can become one in intent and purpose without individual “opinions” of ego clouding and churning up the waters of clarity in truth projection.

Are you aware of the uniqueness of physical reality? I watch as you ones drift hither and yon on a sea of efforting to ascend, meditate into another dimension, experience astral travels in the conscious beingness (mutually exclusive terms and therefore, impossible in your state of experience) and doing all possible to separate from your chosen dimension by moving into another. You must come into understanding why you chose the present dimension and cease your efforting to escape the experience for you miss the point entirely by so-doing.

I am met with anger and joy, pleasure and pain at my entry into your events and consciousness. We are lied about and construed in all manner of erroneous fashions. I recognize pain at the potential I see

wasted and at my own commission to verbalize. But I sense pleasure at what I am experiencing through your senses, for though your sensory channels are, in your exclusive dependence on them, your great limitation, they are also marvelous instruments of perception. They are truly your crowning virtue as well as your tragic flaw. This is my first exact experience in this exact manner with you ones in this particular sequence of manifestation. I witness time and space reduced to such intricate and beautiful patterns and I rejoice when I see that you, too, can experience this wonderment. I experience in your presence by looking out through your eyes for a while and take in the colors and the room and the plants outside your window; I delight in the curious way you perceive light—as illumination! A day will come, after all has been set to right again, when we can spend some time together just enjoying the wonders of Creation. I delight in the expected opportunity to travel about with you, seeing what you would show me out of your eyes, hearing what you hear with your ears, feeling the touch of Earth on that wonderful substance that is at once both Sun and stone. I will rejoice in the sharing of my experience through me that you can have the joyous experience of touching that which is ethereal—ah, even the silken skin of a ship or the magic of a song played upon naught but the currents of air.

But now, chelas, there is work to be done. You have placed yourselves into bondage and moreover, most of the most heinous bondage comes from that which you have had hidden from your consciousness. We must forge the conceptual tools that will give you freedom before we can show the keys unto the masses that all might be free. So let us not tarry in our work lest a brother be lost to the path and fail to regain his footing.

WHAT OF THE “OTHER” REALITY?

Actually the “other” reality is the only real reality. In your natural state of being, you have no sense of identity distinct from the Creator, except when you are engaged in a relationship. On this level of being, identity comes into focus only in the context of a relationship with some other aspect of being that has become objectified, much as my identity as an “angelic” messenger comes into being through my relationship with you, albeit through this routing utilized at present. When such a relationship is not taking place, that particular expression of you simply does not exist; you float effortlessly in the potential of God. You are not annihilated, but all definitions of you are, and you are released from their restraining influence, allowed to expand into a state of love and perfection.

By and by, if it would happen that you are needed for a particular function, you will still be there, for your form identity is a specific cell in a specific organ of a larger being. Remember the fact of quantum physics: The macro is different while the micro is sameness in every detail. When the next energizing impulse comes, it also brings your definition and instruction. You come into the necessary degree of focus for whatever is required.

Throughout the course of your existence, you continually oscillate, like the wave function that you essentially are, in and out of focus, in and out of definition, always moving back and forth, like the pendulum on a clock or the heart of an atom, out of the unity of being with God, into a finite expression of God's infinite potential, and then back into unity once more, back and forth, back and forth. This is the natural rhythm of your existence, just as it is mine. It is the song of God, the rhythm of Life itself.

WHEN SERVICE CALLS

Whenever the divine impulse calls upon your services and brings you into form, you encounter other beings of infinite variety, on errands and excursions in worlds of love and light that are impossible to describe. As this happens, you experience, for the duration of your contact, both an identity and a linear time world; but, in the course of your encounter, you are still aware of your unity with the Creator. You do not lose the certainty of your oneness with God. You are aware of your form identity and of the motion of time, yet you oscillate, faster than the speed of light, back and forth between your pre-manifest state, and your species-role form.

This is nothing more or less than what every atom of physical creation is doing all the time. Before the "Fall" if you will, you had the ability to shift the center of your awareness from deity to identity, from form to meta-form at will. You were free, as it were, to come and go as you pleased, free to emphasize whatever aspect of yourself suited the situation. It is of such that all creatures are made.

In a healthy state, you are functioning in two realities at once. Half of the time you are focused on your form identity, and the other half on your identity with the Totality of What Is. In the fallen state of consciousness, you find yourself trapped with your awareness on one side only, while the actual substance of your being continues to function on both sides. This is what unconsciousness is all about. You still exist in that other reality, but you are asleep. In the reality you now think to be the only reality, you are fragmented; the human race seems to be composed of a multitude of beings. In the other reality, there is only you. We are here to awaken you—therefore, there is actually only ONE of you who needs to hear this message.

It is important that you return to a consciousness of your true self. For, though you still exist in both realities, unconsciousness of your identity with the Creator is cutting off the flow of Life-giving information to the part of you that exists in form. Your existence in identity with God is the reality from which all Life springs. Focusing your attention exclusively on form greatly restricts, and eventually curtails, the flow of Life currents.

As I search your symbol storage systems for a word with which to express something of the reality in which you exist as one with your Creator, I come upon an Indian word "*nagual*". It is a term which you understand to mean "everything that cannot be named". You have no such word in the other languages as suitable. This is a good word for the region of being, the region of unity. I will use this

word to emphasize a point I wish to make herein.

In the pre-Fall state of awareness, you existed in the *nagual*, the all, the everything, the nothing, the primal void where all exists in a state of potential. This is the Creator that surrounds Creation like the sea surrounds a fish. Out of this *nagual* you are called many times to dwell, for the space of a relationship, in its opposite, the "tonal". The tonal is everything that can be named. It is the imaginary world of God in which all apparent differences exist. It is the playground of What Is. The tonal draws all of its sustenance from the *nagual*. It cannot exist apart from the *nagual*. While the *nagual* is a dynamic, yet steady state of rest, the tonal, or manifest physical universe, is continuously flashing on and off. This oscillation occurs in all things manifest, from the smallest sub-atomic particle to the greatest galaxy.

All of us, angels, humans, anything that can be named, are only in form one half of the time. The other half of the time we exist in the Totality of Being. This Totality of Being that we have been calling the *nagual*, has also been called God the Father among other things. It is the Life of God the Father that animates all Creation. It is this reality that all healthy creatures oscillate back and forth to, and exist in, half the time. In this reality, we do not exist in time or space, for we can name these; they are both features of the manifest universe. From this spaceless, timeless state we derive all energy, blessing and nourishment. This always holds true, even for you in the fallen condition. The difference is that in the fallen state you are not aware of this process and therefore unable to participate in it consciously.

By forfeiting your ability to oscillate in consciousness between the two realities in which you dwell, you are restricted to an awareness of just the tonal, just the material, conceptual world. You still receive your nourishment from the light of the *nagual*, but no longer directly, only through animals, plants and minerals. You are unconscious of being and conscious only of form.

How did you lose the ability to shift your awareness from deity to identity, from form to meta-form? How did you lose God-consciousness? How did you "fall" into the illusion of separation? Let's look at it for a moment and I will effort at explanation.

SHIFTING AWARENESS

It was through a simple lack of faith that you lost the ability to shift awareness.

It was through a loss of confidence in the absolute perfection of the universal design. This was brought about by the entry of a single factor into your existence: fear, the serpent in the Garden so to speak; the Devil in history. Through a subtle process of reasoning, this being encouraged you to move in a pattern of activity that has come to be called "Original Sin", an absolutely absurd term but suffices for the purpose of explanation. It was a pattern of activity that you were never designed to move in. With a clever and subtle lie, you were convinced to not exactly stop trusting God, but to stop trusting exclusively in God.

The moment you did this, your consciousness began to shift from God-centeredness to self-centeredness, and for the first time, you became more aware of your identity in form than of your identity in God. This shift in awareness was minimal at first, but enough to begin what was to become a long spiral downward through denser and denser levels of energy-bondage and restraint. For Satan,

your tempter, is the materializing influence who in its right place is responsible for the bonding of energy in the creation of matter.

As you began to focus more and more upon your identity in form, you began thinking in terms of defending that form with unnecessary and cumbersome ego structures. It became harder for you to avoid identifying with your experience. You began to carry over past patterns of behavioral response into new relationships. This made you less effective in those relationships because you were no longer fully present, no longer using the fullness of your potential. You were beginning to build up around yourself energized thought structures that imprisoned you. You were drawn, by simple gravitational attraction, to those realms of space where energy was in the process of being bonded, where matter was being created. Particles of physical substance began to gather along the magnetic lines of your thought structures, and you began to identify with denser and denser levels of physical expression.

This process went on for a long while before you actually found yourself in any kind of physical "Garden". When you did, you had already fallen a long way from your original state of grace, but you were still functioning on a level of awareness far enough above and beyond your present condition to give rise to all the myths and legends of a physical paradise. The physical Garden of Eden lasted for many centuries of Earth time before the momentum of the materializing processes caused you to rely so much upon the physical senses that you became cut off from the direct nourishment of divine light.

In reality, you have never been cut off from this nourishment, but as your sense of identity became almost exclusively wedded to your physical bodies, their growing density began demanding more and more Earth substance for their support. You finally reached a point where you could no longer meet the demands of your physical bodies without "work". It is at this point that your chronicles state that you were "driven from the Garden". In truth, you were never driven from the Garden or anywhere else. The Garden is still there, surrounding you even now—you have simply ceased to be aware of its presence.

Language is only capable of communicating on one level at a time yet the Fall was a simultaneous multi-leveled occurrence. While you were clothing yourself with increasing layers of material identification, you were also becoming more and more fragmented within yourself. As you began to bring into your relationships a sense of identity based on previous relationships, you were not only lessening your own presence and effectiveness in current relationships, you were also creating separation within yourself. None of your past experiences were comprehensive enough to fully identify with in the present moment, yet you began to rely on them for your understanding of and approach to the present moment. Thus, the whole process of the Fall was accompanied by a corresponding fragmentation of your sense of identity, your very sense of self.

By the time of the physical Garden of Eden, you were already perceiving yourself to be more than one. The sexual process came into play in order to produce physical projections within which these apparently separate entities you had split yourself into could take form. Even to this day, these apparently separate beings are but your own fragmented reflections. In the fallen state, you perceive them as separate and distinct.

Yet, despite all this talk of a Fall and Original Sin, etc., you are not held prisoner by events that transpired in the dim reaches of your collective memory. You are not born into sin. You are born

daily into the Presence of God, yet daily you re-enact the original foolishness that is recorded in all your ancient chronicles. Daily you commit "Original Sin"; daily you eat of the forbidden fruit, and it is from moment to moment that you keep yourself imprisoned by allowing a dubious rational thought process to come between you and your immediate sensing of God's will. This was the hesitation that led to your initial fall from grace, and it is the same hesitation that keeps you now in a fallen state. There should rightly be no interval between the determination of the need to take action and the implementation of that action. This rational interference is what caused you to stumble in your primal dance of trust with God.

You are now, in effect, sleeping under the influence of what could almost be seen as a spell, an illusion that prevents you from experiencing the clarity of perception that is your natural birthright. Our mission to this planet is to awaken you from sleep by whatever means necessary and so it shall be.

As I speak of these things I speak often as if we were separate, for in your illusion, you would have it be so. But I tell you, there is only ONE. Therefore it must be YOU, must it not? Yet you dream still in the spell of matter. Do not allow matter to dictate your future any longer. Go gently in these last days of unconsciousness. I suggest you reread that sentence. Listen to the voices among your dreams. Listen to the whisperings within your heart. We speak of a new way of being which is as old as Creation itself. We speak of a new reality, which IS—nothing more and nothing less—then, now or ever shall be. Does this not make sense to you? Somewhere under all your conceptions and rational convictions, is there not a child at sleep? There is a part of you that lies like a thin wisp of certainty, a forgotten shred of simplicity, behind all your sorrow and beyond all your confusion. Be still—for a moment, just be still. Let it expand and fill you with yourself. You know these things in your heart.

As I speak you are beginning to remember—the Earth as you approach. You can feel her wrap you in her matter. Are your life forms not sufficiently prepared now to receive the blessing-definitions that will terminate their larval period? You have told them to multiply and fill the Earth, and behold: They walk the entire face of the planet and dominate every habitable landscape. As I look out across the sleeping sea of humanity and I whisper these words into the silence of your mind, I know that I address a great being sleeping still in ignorance of itself—its wondrous self. I know that if the wild Winter winds of your communication systems send tatters or fragments of these messages echoing in the darkness, it will still be to the unconscious that I speak—but not much longer, dear ones, not much longer. For the conscious have seen the sky start to brighten in the East and have felt the warming Spring of eternal life begin to thaw the hardness of their preconceptions—the time is at hand to accept the understanding.

Forget all but the song I am singing in your soul. Be in this moment here with me. Open to the life that I am. I bring the burning fire of purification information revelation. Open to all that you are. I bring the annunciation of your birth. It could be now, this very moment. Let everything that you imagine yourself to be drift to a state of rest, and feel me rise up within. I am rising, you know, like a spring from the depth of your being, my being, and we are one. But you must come into the realization and I can only tell you how it IS.

Response To Letter From M.A. Ramadan Of The UN

TODAY'S WATCH

Hatonn present in service unto God and Man—within the Light of Truth. So be it.

We are always pressed and crushed into the time limitations of Earth limitations, therefore, I must ask patience from ones who correspond and/or ask input, for you have not enough hours in your days to accomplish all our work and allow the Journals to flow, also. I do have some inquiries which need response to the general group of readers. I shall be brief for the material in the Journals and Expresses is too urgent and timely to allow distractions, but I shall refer to queries regarding information within the books to clarify some points for all readers.

Dharma, as time consuming as it is, I must ask for expressions presented by the letter from M.A. Ramadan, of the UN. He has given phone contact information but all need to have this information, not only the one.

We will please reprint the letter portions and I shall respond to segments. The letter was not to Hatonn, but rather to George (Green) at America West but I have asked to respond for perceptions and opinions cloud the issues.

Dear George,

Although it is extremely difficult to read the mind of God, it seems He does not put all the eggs in one basket. For some reason, He gives different people different pieces of the cosmic puzzle. This is all the more likely at those transitional times where the ultimate unity of mankind will be preceded by vast decentralization and fragmentation to facilitate the dismantling of the present outdated world system and create a far more enlightened one.

Yet, in order to go higher, man has to use his mind less in high tech and more in understanding cosmic design. Your publications are a great challenge in this respect: They force us to use discernment. Fortunately, they caution us, from the very beginning in the first book (I Am Sananda, p.128), that "man shall never force truth onto another. For it would be worthless." We, therefore, have to use all the understanding and self-discipline upon entering the minefield that God has planted to test us. The different messages given to us by the more recent "masters" are no exception. Let me explain.

In a letter entitled "Red Alert" and circulated in January this year or shortly before, you mentioned that your Journals are "transmitted directly from Fourth Dimensional Extraterrestrials who call themselves 'Space Brothers'". As you know, anyone who comes from less than the Fifth Dimension is terrestrial or human.

And to err is human. In other words, those brothers, like us, are not infallible.

In fact, the transmitters or the messengers imply that. For example, in the August Journal Express issue entitled "Psychic Guru" (Vol. III, No. 4), you quote Hatonn as saying that "My computer system rarely reflects errors," which means that he does make mistakes sometimes. This is in sharp contrast with your recurrent statement that "the materials are 100 percent correct".

Adding the conflicting statements of the several Rainbow Masters, inter alie, the major pitfalls of the Journals include the following:

I shall ask interruption before going further to make comment about the preceding statements:

I ask that you all be gracious and patient with our contacts and publishers. Brave, indeed, are the ones who stand forth against Earth forces to bring truth. Please know that in January (ref. above), George and Desiree' (who wrote "Red Alert") had met the receiver and had access to any of our writings for less than three months. Please note that much of the above observation is correct in concept where man, fourth dimensional downward in the counting if you like, is subject to err. Moreso, however, it is differing in "perception" and/or "opinion" and "interpretation" of intent. Just as M.A.R. has erred typographically in the printing of his letter—so too, are errors committed in non-intent. I use this as example only in that all can relate to the subject in point through this example. The "CONCEPT" of the letter is 100% (whatever); the errors impact not the "concept". Further, you must understand that we speak a "Universal Language" or no language at all. Language (audible) is a very primitive mode of communication and transfers errors in perception—especially through a "written" page.

I, Hatonn, can clarify further the reference to fourth dimension, etc. I personally come from an etheric dimension much higher than fourth. I function in the capacity of a fourth dimensional being in "command" expression. Many, many of the crewmembers aboard craft are only a bit higher frequency than are you Earth persons and function mostly in the third dimension with only relative higher frequency and greater insight into time/space perspective.

As communications vary from language to language there will be errors in the chosen "word" of use and/or typographical errors. Short of God is not PERFECTION either in expression or reception.

Everything must be taken most carefully indeed, with great discernment for each reader will read with differing perspective according to experience, geographic tradition, etc. It is with humble gratitude when a student will carefully study the contents as closely as has M.A.R. and take time to express these inquiries and observations so respectfully and comparatively and with obvious effort at total discernment.

I, further, ask that all readers keep in mind that we write through this scribe—in the U.S.A., her only reference point, as she is not a student of any

literature, religious history, language, etc. She cannot tamper with input for she has no background to either contradict or confirm. To find only ten points to ponder and question after penning 21 Books within the past year, is getting pretty close to accuracy by any standards. Furthermore, the subject under discussion is the most controversial of all information of all time inclusive—religious information and disinformation. I am most grateful to have opportunity to respond to questions or observations so well studied and compared and presented in such clarified format. Thank you.

We are in the commission of “awakening” a sleeping people who are, in fact, at great crossroads on human cycles. We must present truth in a manner which can be received and best understood and we must ask that the more advanced student of “one” subject be patient while we deal with the myriad subjects in order to touch “all”. If we can cause mankind to “see”, we shall have touched on some type of miracle in itself.

We each—you and I—come from varying dimensions in experience and expression, to express as we are experiencing at the current perceived “time” sequence—for specific purposes, yet elusive to most individuals. We of the higher dimensional plane of experience recognize our purpose as do “some” of Earth compression—but yet “few” in relative numbers. But, on to the subjects as presented:

I. The Nature of Sananda

1. In the Red Alert letter, you mention that from the aforementioned Fourth-Dimensional Masters who call themselves Space Brothers like “Hatonn, Ashtar and Sananda, comes the shocking truth...” Are we talking about the same Sananda who will be our Messiah?

Yes and no. It is incorrect to place Sananda into the category of a “Space” man as referenced in the above “assumption”. This entity, Sananda, is a Christed being having served Earth man in several capacities and identities. He (if you will) is “overall” “Commander” of this project. There is no way to limit his intent, stature or abilities. There is such misunderstanding of factual truth regarding God and life, perception, illusion and reality that it would take ten Journals to outlay it all. But, the greatest misperception of mankind is to categorize the “Masters”, “Teachers”, “God” and thus and so. This entity known as Sananda is a “designation” of identification (as I gather you already recognize from your intelligent factual information). It is now time for the readying of the planet for the perfection of truth to return—first “WITHIN” man. Just as the myth goes that he “went forth to prepare a place for you...”, so we now ready a reception for Him in God “growth”. The English language simply has not the proper definitive words for total clarity to express my full intent.

I, Hatonn, am expressing in the capacity of “Commander”—I, however, come from a dimension of totality of expression and/or manifestation: Aton. We do not “rank” in the higher dimensions and yet, it is the only measure I perceive you recognize.

Yes, to respond to your last question: It is the return of God, by whatever name you have called him. Actually, it is a return to consciousness. The awareness of God in that manifestation of “God-ness” can be returned into that consciousness. God dwells within his creations so—without contradiction—God is already with you! Keep in mind the question which bore no misunderstanding on your part but might very well among the lay reader—“Messiah” meaning a professed “teacher”, “messenger”, marked by mystical idealism in behalf of a cherished cause or sense of historic mission devoted to perfection in belief in the

absolute rightness of truth. To attach this entity to any one “religious” doctrine is to err indeed.

2. *Ashtar himself distinguished in the letter between Space People and the spiritual people, who start from the Fifth Dimension. If your Sananda is only a 4th-dimension being, fine. But in this case he cannot put “The seal of Truth” after almost every other transmission in the Journals by equally-ranking brothers.*

True! We have efforted to define categories as clearly as possible while knowing that man cannot conceive of that which we proffer. Allow me to note that Sananda is from the highest dimension and has all qualifications to place His seal upon the WORD! It was not our intent to indicate equality as such, although we allow some ignorance on the part of mankind into the higher truth of “unlimited” existence. We have ability to “manifest the expression of our thoughts” and it is very hard, indeed, to describe this quality unto ones who have nothing against which to relate in any manner, in consciousness. The reason for any such reference as to “seal” is to allow knowledge that statements are carefully considered as to content by council of higher energies that none overstep the boundaries of command of another in purpose and direction.

3. *But let’s assume that your Sananda is higher than the 4th dimension. If this is the case, why does he hardly refer, if at all, to other high-ranking Masters like his assistant Kuthumi or to Sai Baba, when several books were written about them and their miracles?*

This is going to be harder for you to understand, for I am not sure I can answer without confusion. You have simply not had access to all the materials presented and that which has not yet been given into print. There are thousands of hours of audio tapes wherein this subject is covered most carefully in detail. Babajee has come forth on many occasions—to witness thereof through this scribe, as has Lord Kuthumi.

This scribe has no recollection of any “contact” prior to mid-September of 1987. *SIPAPU ODYSSEY* was written as a “fantasy” in 1986. She was not exposed in any manner to Space Command nor to higher energies prior to that time—in fact, she had very negative opinions of the entire operation of same. Dear ones, it is a time “of remembering”, now. I further urge you ones to not err in perception of assuming, for instance, Sai Baba to be an identical energy form of Babajee. You must be most careful for it has been told to you of physical format to beware of bringers of great miracles in the closing cycle for they will most often be of evil. All will not be of evil and I certainly infer no such thing—I JUST WARN YOU TO BE DISCERNING AND KNOW THAT THAT WHICH CAN BE DONE BY THESE “MIRACLE DOERS” CAN BE DONE BY YOU IF YOU BUT ACCEPT YOUR CREATIVE GODNESS WITHIN. HE OF LIGHT WILL ALWAYS TELL YOU SUCH AND THE “TEACHERS” COME FORTH TO PREPARE THE WAY—YOU WILL BE THE DISCERNER, FOR GOD HAS CREATED YOU WITH FREE-WILL CHOICE AND YOU WILL STAND RESPONSIBLE FOR DISCERNMENT—i.e., the “minefield”.

I apologize to the sender of this letter for the document has been separated in the faxing thereof, and we may have these numbered queries out of order. I will, however, effort to respond properly.

II. The Nature of Jesus

4. *In the green book “I Am Sananda” we are told by Judas Iscarioth (another*

Master) that Thomas complained to Jesus Christ that “Your disciples have falsified your teachings. They say you are the Son of God... and have pronounced that you are equal to the Creation” (page 131). Yet, in the Rainbow Masters (p.58), Serapis Bey, who claims he is often referred to as the Commander Hatonn, equally claims “I Am That I Am: Christ, the only begotten Son.”

Semantics can be the downfall if we are not indeed careful. Firstly, allow me to be in the reminding of something: Judas Iscarioth was “translating” his own scribing from Arabic and into English for understanding and revealing of truth from the erroneous documents of mistranslation by the German scholars who chose the “gospels”. Judas Iscarioth was erroneously blamed with the betrayal of the one known as Immanuel (Emmanuel) (Immanuel) (Jesus) (etc.). (For clarification, “Jesus” came through Paul the Apostle much later as a label as Paul traveled in ancient Greece. The facts are that to be the “Son of God” and “equal to Creation” are mutually exclusive and contradictory statements. The “man” as such, whether by manifested extension of God’s thought (begotten) would need travel the path of life into the perfection of God to be as God fulfilled. This becomes the status of a “Sananda” as relative to the term “Christ”—a level of acquired knowledge and perfection. Intent is that this entity could only be “begotten” of God-ness and not the “ONLY” one. The seed, if you will, was brought forth by the Archangelic energy, Gabriel. The book *AND THEY CALLED HIS NAME IMMANUEL, I AM SANANDA* is a transcription basically unchanged from the original scribing of Iscarioth and might very well bear some misperceptions in choice of vocabulary. I urge you all to read with conceptual truth of the whole, lest you not only miss of the lifeboat sent to save you from the floods, but the helicopter as well!

5. *In many other locations, Judas refers to God as the Father of Christ, who, still, claims “I am Esu Jesus Sananda, I am the Lord Thy God, Manifest and Incarnate. One with God and The Creation. I Am and ye can be as I Am.” (p.7). However, how can I be like Him if I cannot be even the second son of God?*

Firstly, why think ye that ye cannot be the second son of God—OR, THE FIRST, FOR THAT MATTER? Do you not refer to God as “Father”? Most Earth men do so. The Indians of the native tribes go further—Tunkonshila (Grandfather)/Creator. You are each and every one a manifestation directly from God, which causes you to be the child, son/daughter, of God just as you might call your own idea or thought manifested, your “child”, “brainchild”, etc. How, sir, would you get this concept across to 6-7 billion earth humans?

I suggest you do not get “hung-up” on names. If you be speaking unto God, it matters not what you call Him, even unto Satan—for He hears thine intent of heart and hears not the sounds from the opening on thine lower face! The Christ came forth to tell you that all (each) can be exactly as he, and more! No more and no lesser.

6. *...but, let’s suppose for argument’s sake, that spiritual entities are “interchangeable” and could become anything, from God to Jesus and Sananda. To make it easier, let’s also accept Jesus’ claim in the Bible that God is “My Father and yours”, implying that he is not God, or better, he is not the only son. In this case, why should Thomas complain to Jesus that*

his disciples had falsified his teaching, for merely saying that he was the Son of God? The question here, therefore, is not one of interchangeability but of falsehood.

Yes, exactly, and so it is a lie. Further, that was not the only false teaching projected by the disciples. Moreover, in the retelling and selective translations, more was lost from the truth and intent for power and control placed within the covers of the *Bible*. Immanuel (Jesus, to you ones) never claimed to be The Creation but only “OF” and/or one with/within The Creation. The PURPOSE of a visit from the “Great Teacher Masters” has always been to bring truth of the need for living within the Laws of God Creator and within the Laws of The Creation. God Creator might well be the creator of The Creation but “He” is WITHIN THE CREATION, becoming the “whole”. Remember—in all things, it comes back always—to ONE, (1), UNO!

III. The Nature of Mohammad

7. *Although Hatonn and most of the Rainbow Masters are against the Church or organized religion, they staunchly, but subtly, side with Jesus at the expense of the other two monotheistic religions, i.e., Judaism and Islam. There is hardly any mention of Moses, the only prophet who spoke to God, and of Mohammad, who was “the only man in history who was supremely successful on both the religious and secular level”, according to Michael Hart, in his book “The 100: a Ranking of the Most Influential Persons in History”. Nevertheless, “none of the great figures of history is so poorly appreciated in the West as Mohammad”, to quote British professor W. Montgomery. For that reason his case needs more detail.*

Quite frankly, my thrust is to awaken mankind to his plight in his physical state—right now. You will note through the continuing series of books (Journals) we deal with that which is! I have not now, nor ever, had intent to relate all the world’s religions or their leaders, as such. There is great misperception regarding Esu, Issa, Immanuel, Jesus, Mohammad, Buddha, Pale Prophet, Quetzal Coatl, Wakan Tanka, etc., etc., etc. YOU OF EARTH TRY TO SEPARATE THESE GREAT CHRISTED ENERGIES AND THEREIN LIES YOUR MOST HEINOUS ERRORS—“DIVIDE AND CONQUER”. The Satanic energies never miss a trick, dearly beloved ones, and they haven’t missed this one! Further, to quote from “experts” on your placement bears little influence for if their projections be in truth they are valid—if not, they are not valid. No more and no less. If man already was apprised of truth there would be no need for the enlightenment of Journals or other forthcoming documents of higher understanding. I hope we can reach a point wherein we find “time” to further detail many of the “great” teachers; Mohammad is only one such.

As you will note from my current Journals, we are deeply into the subject of Judaism. This world has stumbled a long way into the abyss. You ones now equate the Khazar Zionists with Jews/Judaism. NOT SO!! Herein lies the key to the truth of the fall of the kingdoms. JEWS AND ZIONISTS are no more factual than is BLACK AND AFRICAN. It is through these incorrect and habitual “assumptions” that man loses his path.

8. *While the nature of Jesus and Sananda is perplexing, this is not the case with Mohammad. He made it clear that “I am only human like you.” The Quran also mentions that this prophet is only a mortal*

messenger. It seems that the very simplicity of Muslim teachings was behind its quick spread from the Himalayas to the Pyrenees and, naturally, behind the strong counter-attack by the threatened Church with “the legend of fanatical Muslims sweeping through the world and forcing Islam at the point of the sword”, which De Lacy O’leary describes in his book Islam at the Crossroads as “the most fantastically absurd myths that historians have ever repeated”.

Correction, friend: Jesus, by any name, did not claim to be other than human “like you”. Those ridiculous teachings were projected after his passing. Just as this man’s teachings were corrupted, may I suggest that Mohammad did not espouse murder, Holy wars, killing or maiming of brothers and thus and so. These are the things projected by man “IN THE NAME OF THE TEACHERS”. Let us be most careful in our projections or quotations from writers who suggest otherwise. The truly divinely sent great teachers and Christed energies always espoused and taught the LAWS and the need for man to live within and according to those LAWS (OF GOD WITHIN CREATION). You must look carefully at the birthing of “ISLAM” for few, indeed, realize that it is an “interbreeding” of two, and yet, being all one in truth—are they not one in the same? In the green book And They Called His name Immanuel, My Name is Sananda, Judas Iscarioth quotes Sananda as warning his killers: “Verily, verily I say to you, his name will be written with blood and his hatred against your kind will be endless. But since he will be a false prophet,” (referring to Mohammad) “and bring you a false doctrine, so will his cult eventually be finished, when your kind and his kind will put down the foundation for a bloody ending for this world” (p. 118). It is interesting that this statement is not confirmed by the seal of Sananda at the end of the reading, yet still bears his name in the title (REC.#3...ISCARIOTH/JMANNUEL SANANDA, Thursday, August 10, 1989).*

Last, first, please. The portion above (in parentheses) is identification for the ones handling the writings. Dharma sits to the keyboard and identifies the speakers—nothing more or less and labels the writings for further reference. “REC. # 3 means the third writing on that date. “ISCARIOTH/JMANNUEL SANANDA” means the “subject”, “speakers” and reference for placement. Sometimes there are three or four separate documents in receiving at a given date. There will always be reflected a “time” which you have not noted, which may indicate that Dharma forgot to note the time or perhaps you omitted it. This is for information when documentation is required in “time sequence” of instructions and/or

happenings upon your placement to allow actual reference “timing”. Then, of course, the remainder indicates the day, date and year. The other indication of Yr: 2 day: 359, indicates the sequence of days since the onset of the new calendar of counting from August 17, 1987 at which time you entered the new calendar of sequence.

I have no wish to pick problems with the *Quran* as such. Please understand that I care not one whit what it says. Islam, for instance, is a cross between the teachings of Jesus and Mohammad, etc. It is incorrectly translated at the very best for as I have stated, Jesus as a label was incorrect, therefore, the translation is incorrect. The overzealous nature of using “Mary” as a Holy Deity is incorrect in all instances and was begun and expounded by the Holy Church of Rome. I, Hatonn, detest no “church club” above that of another—I detest any group that projects lies upon believing people—I care not where they are or who they are. If a lie be a lie, the telling of it by great numbers of liars does not make it truth!

Regarding the quotation of “Sananda” by Iscarioth regarding the warning: Please realize you have left out the circumstances under which the statement was made. Also, you must realize several different facts herein, which I will attempt to delineate. Sananda (the one you call Jesus) was before the council and Pilote at His condemnation. He warned the crowd and people present that one would come forth (Mohammad) who would write his name in blood and the hatred would last endlessly. COUP D'ETAT:

The Real Reason Tenet and Pavitt Resigned from the CIA on June 3rd and 4th

Bush, Cheney Indictments in Plame Case Looming

Why did DCI George Tenet suddenly resign on June 3rd, only to be followed a day later by James Pavitt, the CIA's Deputy Director of Operations (DDO)?

The real reasons, contrary to the saturation spin being put out by major news outlets, have nothing to do with Tenet's role as taking the fall for alleged 9/11 and Iraqi intelligence "failures" before the upcoming presidential election.

Both resignations, perhaps soon to be followed by resignations from Colin Powell and his deputy Richard Armitage, are about the imminent and extremely messy demise of George W. Bush and his Neocon administration in a *coup d'etat* being executed by the Central Intelligence Agency. The coup, in the planning for at least two years, has apparently become an urgent priority as a number of deepening crises threaten a global meltdown.

Based upon recent developments, it appears that long-standing plans and preparations leading to indictments and impeachment of Bush, Cheney and even some senior cabinet members have been accelerated, possibly with the intent of removing or replacing the entire Bush regime prior to the Republican National Convention this August.

FTW has been documenting this Watergate-like coup for more than fifteen months and almost everything we will discuss about recent events was predicted by us in the following pages: Please see our stories "The Perfect Storm - Part I" (March 2003); "Blood in the Water" (July 2003); "Beyond Bush—Part I" (July 2003); "Waxman Ties Evidentiary Noose Around Rice and Cheney" (July 2003); and "Beyond Bush—Part II" (October 2003).

There were two things we didn't get right. One was the timing. We predicted the developments taking place now as likely to happen after the November election, not before. Secondly, we did not foresee the sudden resignations of Tenet and Pavitt. Understanding the resignations is the key to understanding a deteriorating world scene and that America is on the precipice of a presidential and constitutional crisis that will ultimately dwarf the removal of Richard Nixon in 1974.

So why did Tenet and Pavitt resign? We'll explain why and we will provide many clues along the way as we make our case.

HIGH CRIMES AND REALLY STUPID MOVES

Shortly after the "surprise" Tenet-Pavitt resignations, current and former senior members of the U.S. intelligence community and the Justice Department told journalist Wayne Madsen, a former Naval Intelligence officer, that they were directly connected to the criminal investigation of a 2003 White House leak that openly exposed Valerie Plame as an undercover CIA officer. What received less attention was that the leak also destroyed a long-term CIA proprietary intelligence gathering operation which, as we will see, was of immense importance to U.S. strategic interests at a critical moment.

The leak was a vindictive retaliation for statements, reports and actions taken by Plame's husband, former Ambassador Joseph Wilson, which had deeply embarrassed the Bush administration and exposed it to possible charges for impeachable offenses, including lying to the American people about an alleged (and totally unfounded) nuclear threat posed by Iraq's Saddam Hussein. Conservative columnist Robert Novak, the beneficiary of the leak, immediately published it on July

14, 2003 and Valerie Plame's career (at least the covert part) instantly ended. The actual damage caused by that leak has never been fully appreciated.

Wilson deeply embarrassed almost every senior member of the Bush junta by proving to the world that they were consciously lying about one of their most important justifications for invading Iraq: namely, their claim to have had certain knowledge, based on "good and reliable" intelligence, that Hussein was on the brink of deploying a nuclear weapon, possibly inside the United States. It was eventually disclosed that the "intelligence" possessed by the administration was a set of poorly forged documents on letterhead from the government of Niger, which described attempts by Iraq to purchase yellowcake uranium for a nuclear weapons program.

It has since been established by Scott Ritter and others that Iraq's nuclear weapons program had been dead in the water and non-functioning since the first Iraq war.

Wilson was secretly dispatched in February 2002, on instructions from Dick Cheney to the CIA, to go to Niger and look for anything that might support the material in the documents. They had already been dismissed as forgeries by the International Atomic Energy Agency, the CIA and apparently everyone else who had seen them. The CIA cautioned the administration, more than once, against using them. Shortly thereafter, Wilson returned and gave his report stating clearly that the allegations were pure bunk and unsupportable.

In spite of this, unaware of the booby traps laid all around them, the entire power core of the Bush administration jumped on the Niger documents as on a battle horse and charged off into in a massive public relations blitz. Bush, Cheney, Rice, Rumsfeld, Powell, Wolfowitz and others—to varying degrees—insisted, testified, and swore that they knew, and had reliable, credible and verified intelligence that Saddam was about to deploy an actual nuclear device built from the Niger yellowcake.

It was full court media press and they successfully scared the pants off of most Americans who believed that Saddam was going to nuke them any second.

George Bush made the charge and actually cited the documents in his 2003 State-of-the-Union address, even after he had been cautioned by George Tenet not to rely on them. In a major speech at the United Nations, Colin Powell charged that Iraq was on the verge of deploying a nuke and had been trying to acquire uranium. Dick Cheney charged in several speeches that Saddam was capable of nuclear terror. And shortly before the invasion, when asked in a television interview whether there was sufficient proof and advance warning of the Iraqi nuclear threat, a smug and confident Condoleezza Rice quipped, "If we wait for a smoking gun, that smoking gun may be a mushroom cloud over an American city." Rice was lying through her teeth.

By July of 2003, as the Iraqi invasion was proving to be a protracted and ill-conceived debacle, executed in spite of massive resistance from within military, political, diplomatic and economic cadres, there was growing disgust within many government circles about the way the Bush administration was running things. The mention of Wilson's report came in July though his name was not disclosed. It suggested corroborative evidence of criminal, rather than stupid, behavior by the administration. *The San Francisco Chronicle* reported:

"A senior CIA official, who spoke on condition of anonymity, said the intelligence agency informed the White House on March 9, 2002—10 months before Bush's nationally televised speech—that an agency source who had traveled to Niger could not confirm European intelligence reports that Iraq was attempting to buy uranium from the West African country."

Note the reference to an Agency source.

It was inevitable that Wilson would move from no

comment, to statements given on condition of anonymity, and finally into the public spotlight. That he did, in a July 6th *New York Times* Editorial titled "What I Didn't Find in Africa". Soon he was giving interviews everywhere.

On July 14th Novak published the column outing Wilson's wife, Valerie Plame. As a result, any criminal investigation of the Plame leak will also go into the Niger documents and any crimes committed which are materially related to Plame's exposure.

Instead of retreating, Wilson advanced. In September he went public, writing editorials and granting interviews which thoroughly exposed the Bush administration's criminal use of the documents, Cheney's lies about the mission and all the other lies used to deceive the American people into war.

At the moment he went on the record, Wilson became another legally admissible, corroborative evidentiary source; a witness available for subpoena and deposition, ready to give testimony to the high crimes and misdemeanors he has witnessed.

First Clue: James Pavitt was Valerie Plame's boss. So was George Tenet.

HOW THE TRAP WAS SET

Conflicting news reports suggest that perhaps several sets of the documents were delivered simultaneously to several recipients. I could find only one news story (out of almost 60 I have reviewed) which indicated just when the Niger papers were first put into play. One of the most fundamental questions in journalism, "when?" was omitted from every major press organization's coverage except for a single story from the *Associated Press* on July 13th.

"...[T]he forged Niger government documents, showing attempts by Iraq to purchase yellowcake, were delivered by unknown sources to a journalist working for Italy's *Corriere della Sera* which then gave them to the Italian intelligence service. She then reportedly gave them to Italian intelligence agents who gave them to the U.S. embassy. Seymour Hersh of the *New Yorker* also offered this version indicating that the documents had surfaced in Italy in the fall of 2001."

The fall of 2001. That means that the documents were created no more than three and a half months after September 11th.

The earliest press report mentioning the documents was a March 7, 2003 story in *The Financial Times*. On that day, Mohammed El Baradei, head of the International Atomic Energy Agency reported to the UN Security Council that the documents were forgeries. The story contained a revealing paragraph.

"The allegation about the uranium purchase first surfaced in a UK government dossier published on September 24 last year about Iraq's alleged weapons programmes, though it did not name Niger. Niger was first named when the U.S. State Department elaborated on the allegations on December 19 [2002]."

Canada's *Globe and Mail* reported on March 8, 2003:

"...[T]he forgeries were sold to an Italian intelligence agent by a con man some time ago and passed on to French authorities, but the scam was uncovered by the IAEA [International Atomic Energy Agency] only recently, according to United Nations sources familiar with the investigation. The documents were turned over to the IAEA several weeks ago.

"In fact, the IAEA says, there is no credible evidence that Iraq tried to import uranium ore from the Central African country in violation of UN resolutions.

"Based on thorough analysis, the IAEA has concluded, with the concurrence of outside experts, that these documents, which formed the basis for the reports of these uranium transactions between Iraq and Niger, are, in fact, not authentic," Mr. El Baradei told the UN Security Council Friday...."

The *Chicago Tribune* reported on March 13, 2003, "Forged documents that the United States used to build its case against Iraq were likely written by someone in Niger's embassy in Rome who hoped to make quick money, a source close to the United Nations investigation said.

The *Washington Post* gave yet a different story, also on March 8, 2003:

“...Knowledgeable sources familiar with the forgery investigation described the faked evidence as a series of letters between Iraqi agents and officials in the central African nation of Niger. The documents had been given to the UN inspectors by Britain and reviewed extensively by U.S. intelligence. The forgers had made relatively crude errors that eventually gave them away—including names and titles that did not match up with the individuals who held office at the time the letters were purportedly written, the officials said...”

The CIA, which had also obtained the documents, had questions about “whether they were accurate”, said one intelligence official, and it decided not to include them in its file on Iraq’s program to procure weapons of mass destruction.

In a follow-up story on March 13th the *Post* reported:

“It’s something we’re just beginning to look at,” a senior law enforcement official said yesterday. Officials are trying to determine whether the documents were forged to try to influence U.S. policy, or whether they may have been created as part of a disinformation campaign directed by a foreign intelligence service...

“...The phony documents—a series of letters between Iraqi and Niger officials showing Iraq’s interest in equipment that could be used to make nuclear weapons—came to British and U.S. intelligence officials from a third country. The identity of the third country could not be learned yesterday.”

What if it wasn’t a foreign intelligence service? I had been suspicious that a Watergate-like coup was forming immediately after reading the first few stories about the documents. I was convinced when the *AP* reported on March 14, 2003 (just days before the Iraqi invasion) that the ranking Democrat on the Senate Intelligence Committee had called for an FBI investigation of the documents’ origins. The *Boston Globe* reported two days later that the Senator was specifically seeking to determine whether administration officials had forged the documents themselves to marshal support for the invasion.

The request was not nearly as significant to me as who it had come from—Jay Rockefeller of the Standard Oil Rockefellers. An oil dynasty was calling for an investigation of a bunch of oil men. Somebody was screwing up big time.

Seymour Hersh dropped a major bombshell that went virtually unnoticed, 54 paragraphs deep into an October 27, 2003 story for the *New Yorker* titled “The Stovepipe”:

“Who produced the fake Niger papers? There is nothing approaching a consensus on this question within the intelligence community. There has been published speculation about the intelligence services of several different countries. One theory, favored by some journalists in Rome, is that [the Italian intelligence service] *Sismi* produced the false documents and passed them to Panorama for publication.

“Another explanation was provided by a former senior CIA officer. He had begun talking to me about the Niger papers in March, when I first wrote about the forgery, and said, ‘Somebody deliberately let something false get in there.’ He became more forthcoming in subsequent months, eventually saying that **a small group of disgruntled retired CIA clandestine operators had banded together in the late summer of last year and drafted the fraudulent documents themselves.**” [FTW: emphasis added.]

Hersh’s revelation provided corroboration for something I and others, like the renowned political historian Peter Dale Scott, had been suspecting for a long time. The CIA was fighting back. This was a well orchestrated, long-term covert operation—exactly what the CIA does all over the world.

POINT OF NO RETURN

Willing disclosure of the identity of a covert operative is a serious felony under Federal law, punishable by fine and/or imprisonment. The *Intelligence Identities Protection Act* of 1982 makes it

a crime for anyone with access to classified information to intentionally disclose information identifying a covert operative. The penalties get worse for doing it to a deep cover Directorate of Operations (DO) case officer (as opposed to an undercover DEA Agent).

After John Ashcroft was forced to recuse himself from the case, Patrick Fitzgerald, the U.S. Attorney in Chicago, was transferred to Washington and appointed special prosecutor in the Plame case.

Robert Novak, rightly standing by the journalistic code of ethics, has steadfastly refused to identify his White House source. We would do the same thing in his shoes. The investigation is nearing a climax with pending issuance of criminal indictments. Press reports citing sources close to the investigation have directly and indirectly pointed fingers at Dick Cheney and his Chief of Staff, Lewis “Scooter” Libby, as suspects.

Second clue: The criminal investigation of the Plame leak was investigated after a September 2003 formal request from the CIA, approved by George Tenet.

Not only was Plame’s cover blown, so was that of her cover company, Brewster, Jennings & Associates. With the public exposure of Plame, intelligence agencies all over the world started searching data bases for any references to her (*TIME* Magazine). Damage control was immediate, as the CIA asserted that her mission had been connected to weapons of mass destruction.

However, it was not long before stories from the *Washington Post* and the *Wall Street Journal* tied Brewster, Jennings & Associates to energy, oil and the Saudi-owned Arabian American Oil Company, or ARAMCO. Brewster Jennings had been a founder of Mobil Oil company, one of Aramco’s principal founders.

According to additional sources interviewed by Wayne Madsen, Brewster Jennings was, in fact, a well-established CIA proprietary company, linked for many years to ARAMCO. The demise of Brewster Jennings was also guaranteed the moment Plame was outed.

It takes years for Non-Official Covers or NOCs, as they are known, to become really effective. Over time, they become gradually more trusted; they work their way into deeper information access from more sensitive sources. NOCs are generally regarded in the community as among the best and most valuable of all CIA operations officers and the agency goes to great lengths to protect them in what are frequently very risky missions.

By definition, Valerie Plame was a NOC. Yet unlike all other NOCs who fear exposure and torture or death from hostile governments and individual targets who have been judged threats to the United States, she got done in by her own President, whom we also judge to be a domestic enemy of the United States.

Moreover, as we will see below, Valerie Plame may have been one of the most important NOCs the CIA had in the current climate. Let’s look at just how valuable she was.

ARAMCO

According to an April 29, 2002 report in Britain’s *Guardian*, ARAMCO constitutes 12% of the world’s total oil production; a figure which has certainly increased as other countries have progressed deeper into irreversible decline.

ARAMCO is the largest oil group in the world, a state-owned Saudi company in partnership with four major U.S. oil companies. Another one of Aramco’s partners is Chevron-Texaco which gave up one of its board members, Condoleezza Rice, when she became the National Security Advisor to George Bush. All of ARAMCO’s key decisions are made by the Saudi royal family while U.S. oil expertise, personnel and technology keeps the cash coming in and the oil going out. ARAMCO operates, manages, and maintains virtually all Saudi oil fields—25% of all the oil on the planet.

It gets better.

According to a *New York Times* report on March 8th of this year, ARAMCO is planning to make a 25% investment in a new and badly needed refinery to produce gasoline. The remaining 75% ownership of the

refinery will go to the only nation that is quickly becoming America’s major world competitor for ever-diminishing supplies of oil: China.

Almost the entire Bush administration has an interest in ARAMCO.

The *Boston Globe* reported that in 2001 ARAMCO had signed a \$140 million multi-year contract with Halliburton, then chaired by Dick Cheney, to develop a new oil field. Halliburton does a lot of business in Saudi Arabia. Current estimates of Halliburton contracts or joint ventures in the country run into the tens of billions of dollars.

So do the fortunes of some shady figures from the Bush family’s past.

As recently as 1991 ARAMCO had Khalid bin Mahfouz sitting on its Supreme Council or board of directors. Mahfouz, Saudi Arabia’s former treasurer and the nation’s largest banker, has been reported in several places to be Osama bin Laden’s brother-in-law. However, he has denied this and brought intense legal pressure to bear demanding retractions of these allegations. He has major partnership investments with the multi-billion dollar BinLadin Group of companies and he is a former director of BCCI, the infamous criminal drug-money laundering bank which performed a number of very useful services for the CIA before its 1991 collapse under criminal investigation by a whole lot of countries.

As Saudi Arabia’s largest banker he handles the accounts of the royal family and—no doubt—ARAMCO, while at the same time he is a named defendant in a \$1 trillion lawsuit filed by 9/11 victim families against the Saudi government and prominent Saudi officials who, the suit alleges, were complicit in the 9/11 attacks.

Both BCCI and Mahfouz have historical connections to the Bush family dating back to the 1980s. Another bank (one of many) connected to Mahfouz—the InterMaritime Bank—bailed out a cash-starved Harken Energy in 1987 with \$25 million. After the rejuvenated Harken got a no-bid oil lease in 1991, CEO George W. Bush promptly sold his shares in a pump-and-dump scheme and made a whole lot of money.

Knowing all of this, there’s really no good reason why the CIA should be too upset, is there? It was only a long-term proprietary and deep-cover NOC—well established and consistently producing “take” from ARAMCO (and who knows what else in Saudi Arabia). It was destroyed with a motive of personal vengeance (there may have been other motives) by someone inside the White House.

From the CIA’s point of view, at a time when Saudi Arabia is one of the three or four countries of highest interest to the U.S., the Plame operation was irreplaceable.

Third clue: Tenet’s resignation, which occurred at night, was the first “evening resignation” of a Cabinet-level official since October 1973 when Attorney General Elliott Richardson and his deputy, William French Smith, resigned in protest of Richard Nixon’s firing of Watergate special prosecutor Archibald Cox. Many regard this as the watershed moment when the Nixon administration was doomed.

SAUDI ARABIA

Given that energy is becoming the most important issue on the planet today, if you were the CIA, you might be a little pissed off at the Plame leak. But there may be justification to do more than be angry. Anger happens all the time in Washington. This is something else.

One of the most important intelligence prizes today—especially after recent stories in major outlets like the *New York Times* reporting that Saudi oil production has peaked and gone into irreversible decline—would be to know of a certainty whether those reports are correct. The Saudis are denying it vehemently but they are being strongly refuted by an increasing amount of hard data. The truth remains unproven. But the mere possibility has set the world’s financial markets on edge. Saudi Oil Minister Ali Naimi came to Washington on April 27th to put out the fires. It was imperative that he calm everybody’s nerves as the markets were screaming,

“Say it ain’t so!”

Naimi said emphatically that there was nothing to worry about concerning either Saudi reserves or ARAMCO’s ability to increase production. There was plenty of oil and no need for concern.

FTW covered and reported on that event. Writer and energy expert Julian Darley noted that there were some very important ears in the room, listening very closely. He also noted that Naimi’s “scientific” data and promises of large future discoveries did not sit well many who are well versed in oil production and delivery.

[FTW: See FTW’s June 2nd story, “Saudi’s Missing Barrels” and our May 2003 story, “Paris Peak Oil Conference Reveals Deepening Crisis.” In that story FTW editor Mike Ruppert was the first to report on credible new information that Saudi Arabia had possibly peaked.]

If anybody has the real data on Saudi fields it is either ARAMCO or the highest levels of the Saudi royal family.

The answer to the Saudi peak question will determine whether Saudi Arabia really can increase production quickly, as promised. If they can’t, then the U.S. economy is going to suffer bitterly, and it is certain that the Saudi monarchy will collapse into chaos. Then the nearby U.S. military will occupy the oilfields and the U.S. will ultimately Balkanize the country by carving off the oil fields—which occupy only a small area near the East coast. That U.S. enclave would then provide sanctuary to the leading members of the royal family who will have agreed to keep their trillions invested in Wall Street so the U.S. economy doesn’t collapse.

So far the Saudis haven’t had to prove that they could increase production due to convenient terror attacks at oil fields, and more “debates” within OPEC.

Fourth clue: Bush and Cheney have both hired or consulted private criminal defense attorneys in anticipation of possible indictments of them and/or their top assistants in the Plame investigation. On June 3, just hours before Tenet suddenly resigned, President Bush consulted with and may have retained a criminal defense attorney to represent him in the Plame case.

According to various press reports Bush has either retained or consulted with powerhouse attorney Jim Sharp, who represented Iran-contra figure retired Air Force Major General Richard Secord; Enron’s Ken Lay; and Watergate co-conspirator Jeb Stuart Magruder. All three were facing criminal rather than civil charges. Either way, a clear signal has been sent that Bush expects to be either called to testify (which was a precursor in Watergate to a criminal indictment of Richard Nixon) or be named as a defendant. Either way, the President’s men are falling faster than their counterparts fell in Watergate, and the initial targets are much higher up the food chain.

Cheney’s attorney is Terrence O’Donnell, a partner of the Williams and Connolly law firm. O’Donnell worked for then White House chief of staff Cheney in the Ford administration and as General Counsel for the Pentagon when Cheney was Defense Secretary under the first President Bush. He has been representing the Vice President in criminal and civil cases involving Cheney’s chairmanship of Halliburton. These include a Justice Department investigation of Halliburton for alleged payment of bribes to Nigerian political leaders and a stockholders’ fraud law suit against Halliburton. O’Donnell also represented former CIA director John Deutch when he was accused of violating national security by taking his CIA computer home and surfing the Internet while it contained hundreds of highly-classified intelligence documents.

SPRINGING THE TRAP

Now, seemingly all of a sudden, Bush and Cheney are in the crosshairs. Cheney has been questioned by Fitzgerald within the last week.

The CIA Director’s job by definition, whether others like it or not, is to be able to go to his President and advise him of the real scientific data on foreign resources (especially oil); to warn him of pending instability in a country closely linked to the U.S. economy; and to tell him what to plan for and what to

promise politically in his foreign policy. In light of her position in the CIA’s relationship with Saudi Aramco, the outing of Valerie Plame made much of this impossible. In short, the Bush leak threatened National Security.

Former White House Counsel and Watergate figure John Dean, writing for the prestigious legal website findlaw.com on June 4th made some very ominous observations that appear to have gone unnoticed by most:

“This action by Bush is a rather stunning and extraordinary development. **The President of the United States is potentially hiring a private criminal defense lawyer.** Unsurprisingly, the White House is doing all it can to bury the story, providing precious little detail or context for the President’s action...

“...But from what I have learned from those who have been quizzed by the Fitzgerald investigators it seems unlikely that they are interviewing the President merely as a matter of completeness, or in order to be able to defend their actions in front of the public. Asking a President to testify—or even be interviewed—remains a serious, sensitive and rare occasion. It is not done lightly. Doing so raises separation of powers concerns that continue to worry many...

“...If so—and if the person revealed the leaker’s identity to the President, or if the President decided he preferred not to know the leaker’s identity—then this fact could conflict with Bush’s remarkably broad public statements on the issue. He has said that he did not know of ‘anybody in [his] administration who leaked classified information’. He has also said that he wanted ‘to know the truth’ about this leak.

“If Bush is called before the grand jury, it is likely because Fitzgerald believes that he knows much more about this leak than he has stated publicly.

“Perhaps Bush may have knowledge not only of the leaker, but also of efforts to make this issue go away—if indeed there have been any. It is remarkably easy to obstruct justice, and this matter has been under various phases of an investigation by the Justice Department since it was referred by the CIA last summer...

“...On this subject, I spoke with an experienced former federal prosecutor who works in Washington, specializing in white collar criminal defense (but who does not know Sharp). That attorney told me that he is baffled by Bush’s move—unless Bush has knowledge of the leak. ‘It would not seem that the President needs to consult personal counsel, thereby preserving the attorney-client privilege, if he has no knowledge about the leak,’ he told me.

“What advice might Bush get from a private defense counsel? The lawyer I consulted opined that, ‘If he does have knowledge about the leak and does not plan to disclose it, the only good legal advice would be to take the Fifth, rather than lie. The political fallout is a separate issue.’

“I raised the issue of whether the President might be able to invoke executive privilege as to this information. But the attorney I consulted—who is well versed in this area of law—opined that ‘Neither ‘outing’ Plame, nor covering for the perpetrators would seem to fall within the scope of any executive privilege that I am aware of.’

“That may not stop Bush from trying to invoke executive privilege, however—or at least from talking to his attorney about the option. As I have discussed in one of my prior columns, Vice President Dick Cheney has tried to avoid invoking it in implausible circumstances—in the case that is now before the U.S. Supreme Court. **Rather he claims he is beyond the need for the privilege, and simply cannot be sued.**” [FTW: Emphasis added.]

Suffice it to say that whatever the meaning of Bush’s decision to talk with private counsel about the Valerie Plame leak, the matter has taken a more ominous turn with Bush’s action. It has only become more portentous because now Dick Cheney has also hired a lawyer for himself, suggesting both men may have known more than they let on. Clearly, the investigation is heading toward a culmination of some sort. And it should be interesting.

Last and final clue: Under Executive Privilege, a principle intended to protect the constitutional separation

of powers, officials in the Executive Branch cannot give testimony in a legal case against a sitting President. The Bush administration has invoked or threatened to invoke the privilege several times. Dick did it over the secret records of his energy task force and George Bush tried to use it to prevent Condoleezza Rice from testifying before the “Independent” Commission investigating September 11th.

Former officials of the Executive Branch are, however, free to testify if they are no longer holding a government office when subpoenaed or when the charges are brought.

The Bush administration has proved itself to be an insular group of inept, dishonest and dangerous CEOs of the corporation known as America. They have become very bad for business and the Board of Directors is now taking action. Make no mistake, the CIA works for “The Board”—Wall Street and big money. The long-term (very corrupt and unethical) agenda of the Board, in the face of multiple worsening global crises, was intended to proceed far beyond the initially destructive war in Iraq, toward an effective reconstruction and a strategic response to Peak Oil. THE SWARM

There are a multitude of signs that the Bush administration is being “swarmed” in what is becoming a feeding frenzy as opposition is surfacing from many places inside the government, including the military. The signs are not hard to find.

The June 3rd issue of Capitol Hill Blue, the newspaper published for members of Congress, bore the headline: “Bush Knew About Leak of CIA Operative’s Name”. That article virtually guaranteed that the Plame investigation had enough to pursue Bush criminally. The story’s lead sentence described a criminal, prosecutable offense: “Witnesses told a federal grand jury President George W. Bush knew about, and took no action to stop, the release of a covert CIA operative’s name to a journalist in an attempt to discredit her husband, a critic of administration policy in Iraq.”

A day later, on June 4th Capitol Hill Blue took another hard shot at the administration. Titled, “Bush’s Erratic Behavior Worries White House Aides”, the story’s first four paragraphs say everything:

“President George W. Bush’s increasingly erratic behavior and wide mood swings has the halls of the West Wing buzzing lately as aides privately express growing concern over their leader’s state of mind.

“In meetings with top aides and administration officials, the President goes from quoting the *Bible* in one breath to obscene tantrums against the media, Democrats and others that he classifies as ‘enemies of the state’.

“Worried White House aides paint a portrait of a

man on the edge, increasingly wary of those who disagree with him and paranoid of a public that no longer trusts his policies in Iraq or at home.

“‘It reminds me of the Nixon days,’ says a longtime GOP political consultant with contacts in the White House. ‘Everybody is an enemy; everybody is out to get him. That’s the mood over there.’”

The attacks have not stopped. On June 8th, the same paper followed with another story headlined, “‘Lawyers Told Bush He Could Order Suspects Tortured’”.

Journalist Wayne Madsen, a Washington veteran with excellent access to many sources has indicated for this story that the Neocons have few remaining friends anywhere. All of this is consistent with a CIA-led coup.

AHMED CHALABI

Madsen reported that the Plame probe comes amid another high-level probe of Pentagon officials for leaking classified National Security Agency cryptologic information to Iran via Iraqi National Congress head Ahmed Chalabi. FBI agents have polygraphed and interviewed a number of civilian political appointees in the Pentagon in relation to the intelligence leak, said to have severely disrupted the National Security Agency’s ability to listen in on encrypted Iranian diplomatic and intelligence communications.

Chalabi’s leak has once again forced Iran to change equipment, resulting in impaired U.S. intelligence gathering of Iran’s sensitive communications. The probe into the Chalabi leak is centering on Pentagon officials who have been close to Chalabi, including Office of Net Assessment official Harold Rhode, Director of Policy and Plans officials Douglas Feith and William Luti, Undersecretary for Intelligence Stephen Cambone, and Deputy Defense Secretary Paul Wolfowitz. In addition, some former Pentagon advisers are also targeted in the probe.

Many press reports throughout 2003 indicated that Chalabi, distrusted and virtually discarded by the CIA, had been resurrected and inserted into the Iraqi political mix on the orders of Donald Rumsfeld, Paul Wolfowitz and the other Neocons listed above.

ABU GHRAIB AND TORTURE

A former CIA official told Madsen that between the Plame leak and the Abu Ghraib torture affair, the Bush administration is facing something that will be “worse than Watergate.”

PLANNING FOR SUCCESSION

If both Bush and Cheney are removed or resign, what happens? Madsen reported that lobbyists and political consultants in Washington are dusting off their copies of the *Constitution* and checking the line of presidential succession.

One lobbyist said he will soon pay a call on Alaska Republican Senator Ted Stevens, who, as President *pro tem* of the Senate, is second in line to House Speaker Dennis Hastert to become President in the event Bush and Cheney both go.

It is one of the greatest ironies of the Plame affair that the Bush administration, spawned and nurtured by oil, might have committed suicide by vindictively, cruelly and unthinkingly exacting personal retribution on an intelligence officer who had committed no offense, and who was, quite possibly, providing the administration with critical oil-related intelligence which the President needed to manage our shaky economy and affairs of state for a while longer to squeak through to re-election. In our opinion, nothing better epitomizes the true nature of the Neocons.

That being said, they have to go. *FTW* wishes that it was as certain that what will come after them will be better.

BIG OIL AND THE WAR ON DRUGS AND TERRORISM

BLOOD, TOIL AND OIL

The year 1859 saw the publication of *The Origin of the Species* by Charles Darwin as well as the founding of the Red Cross by Henry Dunant...

Strange things were happening in a world where artificial lighting had turned night into day and where man extended his effective life-span by some 30 per cent. The first oil-well near Titusville in Pennsylvania had been drilled; John Davison Rockefeller and Maurice Clark formed a trading company which would soon become Standard Oil, forming a huge monopoly by concentrating 96 per cent of the refining capacity of the USA in the one hand. In the beginning they profited from provisioning troops in the War of Union against the Confederates, then later from outfitting (arming) “pioneers” in their war against nature and humanity.

...When in 1863 the carnage due to modern weapons had taken a huge toll on the largely volunteer forces of both combatants in the *American War of Secession*, conscription was introduced (first by the Confederates)...

It is now hardly ever commented on, but the American Civil War “happened” while the oil industry was being established. Some 600,000 lives were ruthlessly wasted between 1861 and 1865 for “ideals” which, when viewed today, were phoney (at best) and to no material effect (as in the betterment of people’s lives). What had really happened was that a very few people had laid the foundations for very great wealth and dominance.

ROCKEFELLERS AND ROTHSCHILDS

John D. Rockefeller was born in Richford, New York, on 8 July 1839 (d. 1937) and educated in the public schools of Cleveland, Ohio. He became a bookkeeper in Cleveland at the age of sixteen. In 1862, he went into business with entrepreneur Henry Flagler and Samuel Andrews, the inventor of an inexpensive process for the “refining” of crude petroleum. In 1870, their company was renamed as Standard Oil (of Ohio) Company. In 1872, J. D. Rockefeller founded the South Improvement Co., which by 1887 had amalgamated all but a few per cent of America’s refining capacity in one hand and became a corporate giant of such vast might that it was, in effect, “running” America. The USA was fighting another brutal “*War of Independence*” (this time from Standard Oil), which it won in 1911 when the Rockefeller monopoly was dismantled. Just as in the case of the other *War of Independence*, victory was an elusive concept.

The rest of the 20th century has been called by many in very simple terms as “Rockefeller’s revenge”. To all intents and purposes, this was a “re-revolution”, as it effectively re-established the dominance of the oil industry over American politics and the American people. What has changed is that not only have the American people been pushed around the chessboard,

but most of mankind has been made into pawns in the game of “Big Oil”.

...The House of Rothschild, through its various branches established in London, Paris and Vienna by the sons of Amschel Mayer (named “Rothschild” after the “red shield” sign on his house in the Frankfurt ghetto), financed:

- the Rockefeller oil empire in America;
- the emerging alliance (soon to be named Royal Dutch Shell) of the Dutch and English royal houses to take control over the oilfields in the Far East; and
- the Russian oilfield operations controlled by the Nobel family.

As always, the third player got mangled up in the tussle between the two stronger ones. After oil was discovered in the Persian Gulf region and the British secured control of it, the Nobel family was forced by a “no holds barred” price war between Rockefeller and Deterding to “sell out”. In order to win this fight, Deterding teamed up with Lord Samuels of London, who had established the oil shipping industry.

While it would be too cumbersome to detail this epic struggle here, just one fact should make the attentive reader sit up: Josef Stalin spent his early political life as organiser of the Oil Workers Union in and around Baku! Another fact to ponder: The *Russian Revolution* kept Russian oil off the world market for quite some time.

OIL, WAR AND TERRORISM

In the early 20th Century, the British Empire began to fray around the edges and First Lord of the Admiralty Captain (later Lord) Fisher argued for (re-)fitting the Royal Navy with oil-powered engines to give these ships a definite speed advantage over coal-powered steamships. With the closest supply then being in the Persian Gulf, the British meddling in Middle Eastern affairs becomes understandable. This sounded the death knell for the Ottoman Empire, which was in control of this region until the end of *World War I*.

That virtually all the oil supplies for the German Empire came from the Mosul field in present-day Iraq explains the fighting in the Dardanelles (Gallipoli) during *World War I*. The German oil supplies had to be disrupted. When you look at the geography of the region and follow the railroad line from Mosul to Berlin, you will notice that, with the exception of a stretch of less than 100 kilometres, this line ran entirely in Entente territory. The little piece of land missing was Serbia! The assassination of the Austrian Crown Prince, Archduke Franz Ferdinand, on 28 June 1914 in Sarajevo (the capital of Serbia), takes on an entirely different “flavour”. The rest is “bloody history”, as Kronberger so bluntly puts it in *Blood for Oil*.

After *World War I*, the domestic oil industry in America swamped the country with cheap oil. After the discovery of oil in Venezuela, the *Smoot-Hartley Act* enacted by the American Congress was ostensibly designed to keep oil from Venezuela destroying the price of this abundant commodity. However, what it did in effect was it exported American recession globally. The rest is—yet again—bloody history.

One of the (other) remarkable results of *World War II* was that the American oil industry got involved in the exploitation of the Persian Gulf region. From that time on, the Middle East was racked with one after the other war that sent the oil price spiralling skywards.

At the end of the 20th Century, the American war machine had become so awesome that in the absence of a credible opponent a “replacement monster” had to be found. This is where the perpetual “side show” of 20th Century history comes in: the systematic terrorism with which Israel perpetrates genocide among the Palestinian

owners of the land promised (but not given) to World Jewry by the British Empire causes symptomatic terrorism. The entire situation, caused by the *Balfour Declaration*, is unsolvable by peaceful means, as no amount of goodwill (from either side) will ever overcome the need for instability in the region to “justify” inflated oil prices and provide “use” for over 50 per cent of industrial production, which is arms related.

This is where “terrorism”, yet again, rears its ugly head. Alexandre de Tocqueville described *régime de la terreur* as a methodology to make the masses familiar with the realities created by elites...

EUROPEAN COLONIALISM AND THE “OPIUM WARS”

From 1757, the British had a trade agreement with the Chinese Qing Dynasty which limited all trade between the two nations to the harbour of Canton (Guangzhou). In the early 19th Century, British ships were carrying millions of kilograms of Chinese tea to England, while bringing as return freight only silver bullion.

When declining to open the Chinese market to British industrial products, Emperor Qianlong declared in the classic statement to King George III: “We possess all things. I set no value on objects strange or ingenious, and have no use for your country’s manufactures.”

Opium had long been known as an intoxicating drug in China, but its use was forbidden by imperial decree dating back to 1729. The English East India Company (EEIC) was cultivating huge poppy-fields in India and selling the drug illegally to China... In late 1838, Emperor Qianlong sent his emissary Lin Zexu to Canton to stop the opium trade. This audacious man simply held the foreign traders hostage and demanded their departure under threat of their lives.

The British Trade Commissioner Charles Elliott collected all the opium from the (British) traders and handed it over to Lin Zexu, who proceeded to wash nine million Mexican silver dollars (the international currency of the time) worth of opium into the sea. The British despatched an expeditionary force, which easily won (due to modern arms and strategy) against a vastly superior number of ill-equipped soldiers, led by generals who had no idea of what modern warfare was all about.

With the signing of the *Treaty of Nanjing* (Nanking) on 29 August 1842, Great Britain’s original goals were fulfilled: The *cohong* (the Chinese trading association through which foreigners—effectively, British traders—had to work) was abolished, four more Chinese ports were opened to trade (Fuzhou, Ningbo, Shanghai and Xiamen), and the island of Hong Kong was ceded to the British.

Just as *World War II* effectively had its roots in the insidious *Versailles Peace Treaty*, the *Second Opium War* was an inevitable outcome of the *Nanjing* agreement. When in 1856 the *Arrow*, a ship owned by a Hong Kong resident, was searched by a party of Chinese officials looking for a notorious criminal, the British flag was taken down and this escalated from a shouting match into a shooting war. This is when the French joined the fray and together British and French expeditionary forces threatened the capital, Peking (Beijing).

In the dictated *Peace Treaty of Tianjin*, trading rights and the rights to establish diplomatic representations in Peking were granted. When this treaty was to be ratified the next year, the British delegation (some 400 men on three ships) was routed and this then resulted in the forceful ingress of British and French forces into Peking in 1860. The Qing Dynasty lingered on until 1911, when it finally broke up under Western pressure. What Voltaire had once called the most advanced and enlightened form of government had been reduced by “Western” *dum possum volo* (“because I can, I want”) to an ineffective puppet regime.

This is one facet of the evil game which was played in the 19th Century in East Asia. Another was the occupation of Vietnam by French forces in 1862.

As France had no strategic interests in that part of the world at that time, this venture had to finance itself.

...In order to raise the money required to establish a multinational crime syndicate, the new colonial power

began to regulate the drug trade in the country. Until 1954, when the French were unceremoniously “kicked out” of Vietnam, elements of the French Secret Service were controlling the French military presence in Vietnam (French Indo-China). An (effectively private) army of up to 40,000 troops and some 350 French officers (Foreign Legion) had to be financed by the drug trade.

The entire French “colonial” enterprise in that part of the world was a largely private enterprise based on organised crime sanctioned at the highest political levels.

AMERICAN COLONIALISM & THE “HEROIN WARS”

It now seems very strange that out of a French private adventure (which had made a few French entrepreneurs very rich) could develop the American nightmare of the Vietnam War. The old colonial powers had been running the colonial charade for centuries: Entire nations were pressed into service to generate vast wealth for a very small number of people who were the froth on the sociologically fermenting vats that the “mother nations” to the colonial states had become.

America had to learn that one cannot break a deal with one of the oldest civilised nations, Russia, for the simple reason that one was able to (the USA used nuclear bombs to shock Japan into surrender, and the deal that Stalin and Roosevelt had made regarding the sharing of the territorial spoils after *World War II* was “off”). The *Korean War* was the outcome of this broken promise...

...To the average American citizen (especially in those days), the “developing” situation in Vietnam seemed to be a continuation of the clash of ideologies that had gone on a decade earlier on the “other peninsula over there”.

Plotinus, the Alexandrian philosopher of the second century AD, cautioned that every evolution had to be preceded by an “involution”. So what wound the clock in Vietnam?

In 1954, when French General Navarre lost the strategic, fortified city of Dien Bien Phu to the Vietcong under the brilliant leadership of General Giap, the colonial adventure of the French in the Far East became an orphan in need of a generous “uncle”. Always happy to prop up a repressive regime which provided the “freedom” for corporate economy to wreak havoc, the USA was drawn into the next vortex of military conflict. What started as a loan of military “advisers” developed into a full-blown military conflict of epic proportions.

The sociopolitical effect of this scenario on the entire world was incredibly hefty. All of South East Asia was turned into a brothel for American soldiers on R&R, and again this war was largely “run” by the American Secret Service. Air America, the aviation wing of the CIA, was for a long time the biggest airline in the world. While the military was fighting a war in accordance with political doctrine and within the framework of international law, the CIA financed the destruction of much of South East Asia and American (Western) society by drug running.

Only few ever saw that the arrow was also the target: ...Blum points out that over the two decades of (official) American military presence in South East Asia, the region was turned into the (clandestine) producer of some 70 per cent of the heroin and opium supply that is consumed in the USA...

It is interesting to note that while in the 19th Century the British used China as their playground and sold drugs there which had been produced in India (using the military power of the Empire in order to do so), the USA used a phoney war (financed by the American taxpayer) to set up the logistics needed to produce the drugs required to turn the American people into zombies. In both instances the “social cost” was immeasurable, the beneficiaries were an extremely small number of “personalities”, and neither of the two episodes had been possible without the knowledge, condoning and complicity of the highest levels of government (and “high society”).

Who can be surprised to learn that the Israeli Secret Service, the Mossad, “runs” a similar operation in

Lebanon? Local opposition to this illicit drug industry is (as Robert Fisk pointed out in the *Independent* of 11 December 2002) the major drive behind the Hizbollah “terrorism”. In early 2003, the newspapers and TV news channels were having a jolly good time “informing” the world how Israeli-based operations were swamping the yuppie scene with the drug ecstasy. That the largely Jewish-owned media was reporting on such antisocial Jewish activities hinted at a more important agenda.

...The *Iran–Contra* *Affair* overshadowed much of the Reagan administration, and the shady “activities” at the Mena Air Field in Arkansas (while Bill Clinton acted as Governor of the state) led up to the G. H. W. Bush presidency. All this will surely be followed by disclosures of similar “activities” in the meantime (if and when the present stranglehold over the media is broken)...

CORPORATISM VERSUS DEMOCRACY

The New Political Order which comes hand in glove with the merging of Communism and Capitalism into globalist practices is a house of cards without any real sustainability. It is a sombre fact that some 200 multinational (transnational) corporations control and their shareholders own over 95 per cent of all “private” business which is not owned by individual privateers and are reaping most of the benefit. The flipside of this coin is the fact that all of this economic activity employs only some 0.3 per cent of the global workforce.

...During the 1980s when the term “globalisation” became a catchword, many began to talk of the “two-thirds society”. Martin and Schumann spoke at the turn of the millennium of the 80:20 society. How much longer until “democratic” societies decay into a 90:10 or—as has to be feared with ever more reason—even a 99:1 “society”?

...In Venezuela, a country which for the better part of a century has not been permitted stable government by an oil industry which thrives on instability, a former military officer is fighting a pretty hopeless war against American Secret Services. Army General Melvin Lopez said in an interview with the Venezuelan state-owned radio station on 21 April 2002 that American agents were behind the attempted *coup d’état* against President Chavez on 11 April 2002. Official American denials abound and have to be weighed against the “noises” from the White House: U.S. President G. W. Bush, himself an appointed “Fuehrer”, has been heard to demand the replacement of Chavez (who has been elected twice by overwhelming popular vote) with a “democratic” leader. It is not so much the intellectual level of the person that is permitted to make such idiotic statements, but rather that of his audience, which is cause for great concern.

AMERICA TERRORISES THE WORLD

...Former Treasury Secretary Paul O’Neill has written a book on his time in government. Most elucidating is that he mentions that President G. W. Bush issued orders to his government almost immediately after taking office (more than half a year prior to 9-11!) for actions which were later “sold” to the public of America (and the world) as retaliation for 9-11. In a *60 Minutes* interview on 11 January 2004, O’Neill talked to *CBS News* correspondent Lesley Stahl about this remarkable situation. This lets all the doubts which surround the entire situation disappear.

It is high time for the thinking people of the world to take notice. The actions of “Big Oil”, the “War on Drugs” and the “War on Terrorism” are turning our little blue planet into what German scientist and philosopher P. J. Beumer already recognised in his 1858 *Naturgeschichte* (“Natural History”): “a graveyard within which higher developed life will exist in the future”—presupposing that “present” life will prepare this “graveyard”...

NEVADA CORPORATIONS:

When Is An Owner NOT A Stockholder?

Budget's "Tip of the Week" #3:

NRS 78.197—Rights of persons holding obligations of corporation

If you own part (or all) of a corporation, you're a stockholder, right? In Nevada, the answer to that question is, "Not necessarily." Let's look at another unique provision of Nevada corporate law:

NRS 78.197 Rights of persons holding obligations of corporation.

A corporation may provide in its articles of incorporation that the holder of a bond, debenture or other obligation of the corporation may have any of the rights of a stockholder in the corporation.

With this provision written into your Articles of Incorporation, you "may have any of the rights of a stockholder"—without owning stock! Thus, the holder of a note COULD own the corporation and could even be afforded the same VOTING RIGHTS as a stockholder—without being a stockholder. And in the absence of stockholders—in cases where no stock has been issued—presumably, the holder of a promissory note of the corporation could have 100% of the voting rights at any meeting.

If such a provision related to NRS 78.197 is NOT in your current Articles of Incorporation, check and see if the following standard clause exists under an Article relating to Amendments:

Except with respect to amending the non-assessability of shares per Article IV, this corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation or its Bylaws in the manner now or hereafter prescribed by statute or by these Articles of Incorporation or by the corporation's Bylaws, and all rights conferred upon the stockholders are granted subject to this reservation.

If so, the corporation may "amend... these Articles of Incorporation... in the manner prescribed by... the corporation's Bylaws". In other words, the Articles of Incorporation are modified by the Bylaws. If such a provision exists in your Articles of Incorporation, we suggest that you amend the Bylaws to reflect wording such as NRS 78.197 suggests for the Articles of Incorporation.

If neither of these provisions exists in your corporation's Articles, you might want to file an Amendment of the Articles of Incorporation. We can handle such a filing with the Secretary of State for you, just ask.

Next week, we'll look at what might be called a "turnip" or "prickly pear" clause in the Nevada Revised Statutes: NRS 78.7502.

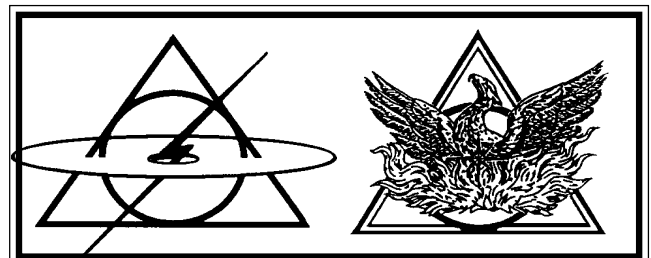
