Filipino Prostitution Sign Of A Dying Nation

“Something’s got to give” in the “Republic” of the Philippines as the situation has become simply unbearable for the masa. A recent survey shows that eight out of ten families are now going hungry. GMA’s “boogie”, meanwhile, shows only disdain for the suffering of “her” people. Money spent on “winning” the “election” is not available to put a chicken in anyone’s pot.

People do strange things when they are so very desperately hungry. As you will read in this issue, neither impounded dogs nor even wedding guests can be dismissed as food sources when hunger becomes this acute. Add these dark and disturbing items to the image of selling one’s own internal organs out of desperation to simply EAT and you start to get an idea of how bad things really are.

In such an environment it is hard to judge harshly those who ply “the oldest profession” to feed themselves and their families. It’s much easier to blame upholders of this system, who obviously have money to spend far beyond their living needs.

Who are prostitutes?

Answer: Essentially, they are those who lease out their human dignity for a living. There are two kinds. The first is voluntary; the second is involuntary. The first is the really vicious kind. Those who fall under this classification have the reasonable option to maintain their dignity and survive. Those who fall under the second classification have no such reasonable option. They, and their loved ones who depend on them for support, will not survive unless they lease out their ultimate capital which is their human bodies. In this sense, their kind of prostitution is not really vicious, because they are actually victims of the prevailing economic system. On the other hand, the patrons of prostitution are necessarily the human vultures who prey on the hapless victims.

Who are the human vultures in our society?

They are those who are responsible for the prevailing economic system. They are the decision makers in the government, big business and the church.

They are also the principal beneficiaries of the oppressive system, which tilts heavily against the majority of the Filipino people who are poor.

The economic conditions in our society are the consequences of the decisions made by the leaders in the government. Who are they? They are: (1) the senators and congressmen who make laws which are anti-Filipino people; (2) the President and the Cabinet secretaries who enforce the anti-Filipino people laws; (3) the justices or judicial officers who fail to protect the best interest of the Filipino people in any given case; (4) the Ombudsman and other graft and corruption investigators who discriminate between respondents who: (a) have political connections and (b) have no political connections.

The decision makers in big business are just as liable to the Filipino people as their counterparts in the government. Unreasonable profits are earned by them at the expense of the Filipino people. They regularly raise the margin of their profits, but they refuse to grant their employees a corresponding wage increase.

The church leaders are also accountable for their failure to raise any effective objection to the immorality of systemic oppression of the Filipino people.

So we see many prostitutes lining the sides of Quezon Boulevard in Quezon City, or some other street in Metro Manila, or some other town or city in the country, or even outside our country. What comes to our mind when we see them? Do we call them immoral? Do we look down on them? Do we see them as the dregs and scum of our society? Do we see them as economic failures? Do we see them as consequences of broken homes or failed marriages? Do we see them as shameless persons? Do we give them the benefit of doubt that, perhaps, they were merely forced into their low status by a system which was not of their own making in the first place?

They need our help. And we must help them to keep their human dignity.

The way we see it, we should see them as our brother and sister Filipinos. They are members of the great Filipino people who boast of ancestors like Lapu-Lapu, Bonifacio, Mabini, Rizal, the Katipuneros, Claro M. Recto and Jorge Bocobo. They belong to a great Malay race. Their ancestors were staunchly proud of their heritage, themselves, and us, the current generation, whom they had no qualms laying down their lives for.

But what have we done to ourselves and our society? We have allowed prostitution to exist and grow its evil horns in our national community. We have allowed it to devour our men and women, including many of our children. We have allowed it to distort our sense of right and wrong, or good and bad. We have allowed it to corrupt those among us who act as prostitution patrons, or even as pimps. We have allowed it to become the termite that will eventually tear down the delicate fabric of the Filipino family.

We must arrest the growing tide of prostitution in our country. Its evil consequences are nothing less than a social holocaust. No less than the future of the Filipino people is at stake. The price of failure would be our loss of our true Filipino identity. We cannot afford that loss, because the future belongs to the future generation of Filipinos. We are only their trustees. We must make ourselves worthy of that trust. We owe it to them to pass on the legacy of greatness left to us by our ancestors. We must make certain the Filipino people will continue to deserve its respected status as a member of the family of nations.

The real problem, however, is the first kind of prostitutes. They voluntarily prostitute themselves, even if they could otherwise earn a decent living. These are the individuals whose wants far outweigh their needs. They generally confuse their needs with their wants or vice versa. They want political power because they think it is a need on their part. So, they act as if they will die, if they lose political power when in fact, they will not. Consequently, they lose their sense of right and wrong and do everything to preserve it, regardless of any prejudice to the Filipino people.

They include leaders from the administration, big business and the church. They believe, they will not survive without political power. And they are probably correct. Is there anything wrong with that? Yes. The decent survival of the Filipino people should be the primary consideration of any survival issue. The survival of the administration, big business and the church should be secondary. The first is the cause while the second is the effect. It is obvious the effect cannot precede the cause.

If prostitution is growing in the Philippines, let us

not forget the most vicious kind, which is the prostitution of the *Constitution* and the rule of law by political prostitutes in the administration, big business and the church—all at the unjustifiable expense of the Filipino people.

THE FACE OF JUSTICE

What is the face of justice like?

Is it like the face of Chief Justice Hilario Davide, Jr. or any justice of the Supreme Court (SC)? It would not seem so, especially in the light of their political partisanship during Edsa II, and in their biased ruling in *Estrada vs Arroyo*.

Is it like the face of Mrs. Gloria Arroyo or any of her alter egos in the current administration? It would not seem so, considering her willingness to play the role of unconstitutional president on the bases of her Edsa II proclamation and the unconstitutional May 10 presidential elections.

Is it like the face of Senate President Franklin Drilon or any incumbent senator? It would not seem so, considering those who have given apparent recognition to Mrs. Arroyo's unconstitutional regime.

Is it like the face of House of Representative Speaker Jose de Venecia or any of his colleagues? It would not seem so, considering those who have given active support in favor of Mrs. Arroyo's unconstitutional administration.

Is it like the face of Ombudsman Simeon Marcelo or any of his fellow graft investigators and prosecutors? It would not seem so, considering their failure to investigate and prosecute those who may be criminally liable for the P1.3 trillion total indebtedness of the National Power Corporation (Napocor).

Is it like the face of Cardinal Jaime Sin or any of his fellow leaders in the Catholic and other churches in the Philippines? It would not seem so. They appear to have given their blessings to the unconstitutional Arroyo administration.

Is it like the face of Jaime Zobel de Ayala or any of his fellow Spanish *mestizo* big business players in the Makati Business Club? It would not seem so, considering they have been raking in unreasonably high margins of net profit at the expense of the majority of the Filipino people.

Is it like the faces of Lucio Tan, Henry Sy, Goerge Ty, John Gokongwei and their fellow Chinese big business taipans in the Chinese Business Club? It would not seem so. What has been said about the Spanish *mestizos* appears to be equally applicable to the Chinese taipans, as well as their Filipino sidekicks.

Is it like the face of whoever is the head of the Lopez family who controls the Manila Electric Company and the *ABS-CBN* media network? It would not seem so. Their electric and entertainment corporations have virtually electrified the entertained Filipino people.

Is it like the face of former President Corazon Aquino, who has not found out up to now who had actually killed or masterminded the assassination of her husband, Ninoy Aquino? It would not seem so. If, as Commander-in-Chief with all the resources of government at her disposal, she was not able to solve the crime committed against her husband, how could she have been reasonably expected to do justice to the crimes committed against the Filipino people? Obviously not.

Is it like the face of former President Fidel Ramos who appears to have billions of pesos worth of accountabilities to the Filipino people? It would not seem so. The bulk of Napocor's P1.3 trillion debt appears to have been incurred under his administration.

Is it like the face of Malacañang spokesman Ignacio Bunye, whose unqualified loyalty appears to primarily belong to his boss, Mrs. Arroyo, and not to the Filipino people? It would not seem so. As a public servant, he owes primary loyalty and truthfulness to the Filipino people.

Is it like the faces of the commissioners of the Commission on Human Rights whose accomplishments, if any, appear not to have made any significant difference in favor of the Filipino people in general? It would not seem so. There are too many cases of human rights abuses which have remained unsolved to this day.

Is it like the faces of the commissioners of the Commission on Elections who appear to have wasted, at least, a billion pesos for the judicially voided purchase of election computers? It would not seem so. They have caused a billion pesos worth of injustice to the Filipino people.

Is it like the faces of the commissioners of the Commission on Audit whose accomplishments, if any, do not appear to have effected any significant service to the Filipino people, especially in relation to the mismanagement of the Napocor and the super expensive Diosdado Macapagal Avenue? It would not seem so. Instead of guarding public funds, they appear to have tolerated massive graft and corruption at the expense of the Filipino people.

Is it like the face of Jose Ma. Sison or any of his colleagues who appear to be waging a revolution by remote control? It would not seem so. A true leader of the Filipino people, like the revolutionaries Andres Bonifacio and Apolinario Mabini, would have most likely found it inconceivable not to fight in the Philippines where the revolution is supposedly being waged.

Is it like the faces of the head of the Integrated Bar of the Philippines (IBP) and his fellow IBP officers who have the duty to tell the Filipino people the truth about the legal system, including anomalies in the SC, regardless of Chief Justice Davide's and the other justices' personal sentiments?

Is it like the face of the *jueteng* lords whose profitable operations appear to have become more profitable under the Chavit Singson-friendly Arroyo administration? It would not seem so. During Chavit Singson's declarations against himself regarding *jueteng* operations in the country, he expressed willingness to go to jail with Erap. What happened? Mrs. Arroyo had Erap jailed, but kept Chavit Singson out of jail and free from prosecution. Is this a double standard of administration of justice? Obviously. And this is the bigger problem: If Mrs. Arroyo can do it to a popularly elected President like Erap, she can do it to any citizen of lesser standing. That means and includes the majority of the Filipino people.

The way we see it, the face of justice is like the collective face of the Filipino people. It reflects their unshakeable faith in God, the *Constitution* and the rule of law as the foundation of their faith in themselves. It manifests their recognition of those who have betrayed their trust.

It shows, finally, a grim determination to do justice to themselves, regardless of the consequences.

The sooner, the better.

So off to adventure day to colorful Hong Kong, which is the next most polluted city in Southeast Asia.

Ah but, not to concern because there is close checking, with stripping and searching to great extent, for terrorist possibilities. They even took EJ's belt and being that his pants are now a LOT too big, he is holding up his pants with one hand while they frisk him with the other.

So, finally I made it through the gate and out again into the population where I found the nearest possible seat to collapse. This happened to be in the luggage recovery area but a seat is a seat and it felt like a heaven-sent couch. EJ wasn't feeling well either but I promptly slouched so I could get my head on the back of the seat and dozed off. I cannot call it "sleep" but couldn't move either so what the heck.

This lasted a very short period of time but long enough for "security" to check on us and they were so very nice I am totally grateful.

When I awakened I was "ok", fuzzy eyesight and "weak" like rubber-band legs but functional and glad to be alive. When questioned I was able to laugh it off and explain that there seemed to be something in the spray that I objected to quite strongly.

Didn't think about it again until we got to the check-in procedures of the return trip where the agent asked if we need "services", i.e., a wheelchair or anything. Nope, nothing and we were fine and eager to get on with the day.

Problem is we didn't feel any better but with aspirin and antihistamines we were just about to improve enough to actually enjoy the final lap back to Manila. We had passed all the scanners so guessed we didn't have SARS or bird flu.

This time we boarded a "commuter" plane, which

was small and "intimate". It was actually so sparsely filled that we did, in fact, have lots of fun with the crew, one of whom even knew about the Tallano Land circumstances. We were traveling on Journalist recognition so we could talk about the paper and really enjoy the conversations.

We hit one abrupt air pocket, which flung drinks and us all over the plane but since we were strapped in it was harder on the crew than on us and we could even laugh about that as the only rough spot on either flight. It was even funnier in that my seat was somehow unattached and I about left it under my feet.

This was all fine and good until we landed and waited (in the back of the plane) for others to deplane, which gave us another 10 minutes aboard. By the time we got to the door and into the "loading" tunnel things were not going too well. Being a little plane it was parked as far away from the terminal as the portable tunnel would reach and it was somewhere near 100 degrees inside and all UPHILL because the plane was so small. Still OK to great extent but only until we reached the terminal where I realized I was in REAL trouble and had to really struggle, with many stops to the top of the corridor to reach the "people" who were already concerned and getting me a chair available.

I simply said that it seemed the SPRAY was something I couldn't handle. However, it was the spray in Hong Kong to which I referred—but that twisted all wicks right up to tight. We got escorted by hand through every checkpoint without a blurb—even right to and through the final "customs-immigration" check and stamp desk. EJ even got a lecture on the advantage of getting a "retirees" visa and save the troubles annually. Fine, we said, but you have to have \$50,000 EACH in the bank in the Philippines for six months to qualify so we guessed we would consider it if necessary later. Meanwhile they were pushing me right on out the door to meet our ride waiting for us. We were pampered, checked on and never have we experienced such a rapid processing.

Then it dawned on us on the way home that the plane was saturated with spray-fog because it is a commuter plane usually filled with overseas workers. With a double dose in one day—the airport personnel were petrified of TROUBLE IN PASIG RIVER CITY.

You have to understand that they don't warn you and in fact do not even tell you that you are being gassed worse than at Nazi camp.

It has taken two days to get vision back to abnormal as is normal and the ears, which are usually good in my case, back to some "balance" and the swelling down. EJ couldn't hear already so just had to suffer through it.

And there was Salvador Allende, who as the socialist president of Chile was killed by the military, which then installed Gen. Pinochet following a coup which was widely believed to have been encouraged, if not actually supported, by the CIA.

The assassination of foreign leaders perceived by U.S. intelligence to be a serious threat to U.S. global interests has been an officially acknowledged part of U.S. foreign policy. We saw the latest example of that in the attempted "political decapitation" of Saddam Hussein and in what is widely perceived as the endorsement which the Bush administration gave to the Israeli military who assassinated the leader of a terror group in Palestine.

The Bush administration is today locked in what it considers America's life-and-death struggle with global terrorism and when GMA decided to pull the Philippines out of the war in Iraq, that decision has been interpreted in foreign circles as a shocking setback to America's war on terror and as an act tantamount to giving aid and comfort to America's sworn enemies.

Second, that's not really the serious part of the matter. One serious part of the matter was GMA's remark, after pulling out a small Philippine contingent of Iraq, that she would be giving more weight to the Philippine alliance with the Islamic countries than she would to Philippine alliance with the West, and we can be sure that remark, no matter how offhand it might have been, is a remark which has given intelligence analysts in Washington the shivers, particularly considering that the Bush administration now considers the Philippines as the latest training ground for Osama bin Laden's army of global terrorists.

The other part of the matter is the impression GMA is giving that she will be playing the "China card" against the U.S. And there's evidence she means what she says. There is, for instance, that

project with China for the rehabilitation of the Manila railroad, which could be just the beginning of many more projects to come, economic and military, such as buying military hardware from China.

If these were normal times and if there is not any Cold War in effect between the U.S. and China, GMA's moves and remarks might be taken lightly in Washington. And the hunger of the people is GMA’s No. 1 enemy. It is in fact the enemy No. 1 of whoever sits in Malacanang and that includes FPJ [Fernando Poe, Jr.].

Enemy No. 2 is GMA’s miseducation—a term made aptly memorable by the late Renato Constantino in referring to what he described as the “miseducation of the Filipino”. Constantino’s thesis could not be more evident than in the field of economics. In that discipline, the would-be economists of the country have it pounded on their unformed minds that there is only one school of economics that qualifies as true economics, and that is the school of *laissez faire* or free market or free trade economics. It is the singular thesis of this school that the state could not do anything to actively promote and protect its domestic industries and should allow those industries to compete in the domestic market place against all imports, from whatever source. And if as a result of that competition the domestic industries collapse or are overwhelmed for any reason whatever, then by all means let them collapse and let the people starve even as they drown in imported goods.

Well, what the students are never told is that the *laissez faire* school has never been taken seriously by any nation-state and that the school of thought which in fact came to dominate the economic thinking of the world’s leaders seeking strength and power for the countries they lead in what is known as the school of mercantilism, the original name of what is now known as protectionism.

You can research into the economic history of the countries now constituting what is known as First World—America, Japan, Germany—and of the Asian NICs such as India, China, South Korea, there is only one common lesson they will all give you. Industrialize or starve and protect your industries from foreign competition if you want to industrialize.

The kind of economics GMA learned, however,

is exactly the opposite. The central message of that economics is: Forget industrialization and forget protectionism because a poor country does not have [to] industrialize. All that it has to do is continue importing, and devaluating its currency.

Now, if the founding fathers of America had taken to the kind of economics that the schools here taught GMA, or if the founding fathers of modern Japan and modern Germany had taken to the economics applied by GMA, they would all be starving as the Philippines is starving now.

What GMA does not realize is that the hunger that now grips the land, which is her enemy No. 1, is due directly to the policies spawned by the free trade school and that her miseducation [as] an economist continues to blind her to that fact and prevents her from taking the necessary steps that would roll the hunger back.

That's why her miseducation as an economist is her enemy No. 2. Both are lethal enemies she does not recognize and they are the enemies which, in the end, will do her in.

What then keeps her from recognizing the enemies? Nothing but pride and arrogance, both of which are laughably and absurdly misplaced.

She is too proud and arrogant to admit that the economics they taught her and what she absorbed is as outdated and wrong as the theory which had dominated the sciences for a long time, that the Sun revolves around the Earth instead of the other way round, that is, until someone named Galileo proved it is the Earth which revolves around the Sun and not the other way round.

Hunger, on one hand and free trade economics on the other, are the two hands waiting in the wings for the opportunity to do her in.

No government presiding over a nation as impoverished—and as hungry—as the Philippines is today, can possibly escape the kind of turmoil that eventually enveloped France in the period immediately preceding the French Revolution and which in fact brought about that revolution.

The pride and arrogance of the then ruling class were best expressed in the words of Marie Antoinette when, told by a courier that the mob was hungry [and wanted bread], responded: "Let them eat cake." The storming of the Bastille followed. And, with that, her head.

Here, GMA has not responded to the hunger of the masses by saying they should eat cake. She has responded by saying, "Let them see me do the boogie with that little boogie woogie from the House."

Narra town police chief Senior Supt. Perla Bacuel said they were looking into the possibility that some of the suspects may have been involved in other disappearances in the western island of Palawan since the 1980s.

Farm laborer Eladio Baule, his son Gerald Baule and nephews Sabtuary Pequi and Johnny Buyot allegedly killed the victim, Benjie Ganay, last July 17 after Ganay accidentally touched Eladio Baule's daughter's bottom during her wedding party, Bacuel said.

The four suspects, who were drunk at the time, then set fire to Ganay's body and Bacuel said the aroma of roasting flesh may have tempted the group to eat parts of the burnt body.

The father and son then allegedly served some of the roasted flesh to other drinkers at the wedding party.

The crime was only discovered about eight days later, after the two nephews confessed to the police who originally found their accounts too shocking to believe.

The nephews insisted they did not take part in the murder but were only forced to eat parts of the body.

Bacuel said this was the first time she ever heard of such a bizarre crime in this area, adding they were looking into the possibility that Eladio Baule may have been a member of one of the rural cults that is known for chopping up their enemies.

LTD;) HOLDING TRUST (TIAS 12087) as THE OUTSTANDING, PRIMARY ‘DULY CONSTITUTED CREDITOR OF THE UNITED STATES: did, by CERTIFIED MAIL to the U.S. DEPARTMENT OF PUBLIC DEBT, PARKERSBURG VA; TENDER A ‘ONE TRILLION DOLLAR ‘GOLD EQUITY’ GOLD COLLATERAL’ DEBT SWAP by DEBT REDUCTION’ for RETURN OF ONE TRILLION DOLLARS IN T-BILLS which would be RE-INJECTED INTO THE U.S. ECONOMY TO CONFORM WITH THE ‘PRESIDENT’S STATE OF THE UNION ADDRESS’ regarding the needs for JUMP STARTING THE AMERICAN ECONOMY. Our proposal was for JUMP STARTING; Manufacturing, Industry, Housing, Health Care, Education, Research and Development, and for other purposes.

The ONE TRILLION DOLLAR ‘DEBT SWAP-DEBT REDUCTION’ was ignored.”

As an interesting side-note at the time of these postings by VK, when some of the outstanding idiotic errors were brought to her attention she accused the helpful party of “bringing down” the Rumor Mill News website. We CONSTANTLY got blame (CREDIT?) for “taking down” Rumor Mill News. Don't they just wish? I was going to do this to say thank you to the people who guarded the gold for all these years, and kept it out of the hands of the people who would use it to enslave us even more than we are already! Needless to say, I was NOT able to do this with our share of the commission because Gunther and I were like all the rest of the 'little people' ... we got nothing and the reason we got nothing was because Doris Ekker demanded that Gunther and I turn 100% of the gold transfer over to them. Gunther told me at the time that the Federal Reserve had offered them a larger piece of the pie than we were offering them."

We, E-E, didn't even have a thought about so much as visiting the Philippines or have any interest in Philippine gold at that time. Gunther was in prison first time we heard of him when Rayelan showed up with a book she wanted GEORGE GREEN to publish. It had nothing to do with Ekkers.

GEORGE MERCIER'S INVISIBLE CONTRACTS

PART TWELVE OF A TWELVE-PART SYNOPSIS (Pages 553-565)

WARNING: WHAT YOU ARE ABOUT TO READ IS HAZARDOUS MATERIAL. PLEASE DO NOT ACT ON THIS INFORMATION WITHOUT ACCEPTING FULL RESPONSIBILITY FOR YOUR OWN ACTIONS.

Please note that although this is the "final chapter" in terms of this synopsis, it is not the final chapter in Mercier's letter to Mr. May, which concludes with a section relating to the myriad invisible contracts that bind us to the King, many of which are not covered in the first twelve chapters, entitled "An Endless List" and is followed by the "Epilogue". These final two installments are simply not available at present in the public domain of the Internet and are likely to be superfluous to the knowledge already imparted.

Since the fraudulent bankruptcy of the United States in 1933, the *Constitution* and *Bill of Rights* have been entirely suborned by the Law Merchant (the law of contracts or *Uniform Commercial Code*) and almost all adjudication of law occurs under Admiralty Jurisdiction. This is because the King is presumed to be the First Party in all commercial contractual settings—and everything is now considered to be "in commerce".

In the marriage contract, for instance, the parties being wed might tend to think that this is a contract between themselves as individuals with God Creator as third party—or first party—BUT the actual "legal" contract is between the King as First Party and the husband and wife as secondary parties.

Because Admiralty can only deal with fictions of law, the contract is between the fictitious STATE on the one hand and the fictitious JOHN DOE and JANE ROE on the other hand. Thus, when baby JOHNNY DOE comes along as the fruit of the marriage, the wondrous child itself is property of the state. The use of all-caps names signifies corporate fictions. Meanwhile, the human beings known as John and Jane Doe become the surety for the contract because "legally" there exists a "unity of interest" between JOHN DOE and John Doe and between JANE ROE and Jane Roe.

What is important to understand is that the Law of the Land is now the *Uniform Commercial Code* or law of contracts. The tort-based concepts of right and wrong no longer apply; all that matters is whether or not a "person" acts within the acceptable parameters of contract law. This contract law is expressed in Publicly Noticed statutes, so there is no reason for you not to be aware of what the law IS.

Mercier's patient explanation of INVISIBLE contracts is a "revelation". We can now see how it is that **FAILURE TO OPPOSE ERROR CONSTITUTES APPROVAL AND FAILURE TO DEFEND THE TRUTH CONSTITUTES ITS SUPPRESSION.** Yes, and "Tolerance of evil is no virtue."

The bottom line: **An invisible contract exists**

anytime a benefit, conditionally offered, is accepted—even when such acceptance amounts to no more than tacit consent (ratification of the contract by failure to object).

Clever rule-making has ensured that *everyone* is subject to the King. **If you have a bank account or a credit card, drive a car, get married, put a child into a public school, work as an employee, are an entrepreneur, travel outside the country, travel on the King's highways, sue or defend a suit, apply for food stamps or any other benefit provided by the King, call the police to protect you from another one of the King's subjects, use Federal Reserve Notes for your personal (individual) benefit, are involved in any insurance contract, lease or own any property, derive any personal commercial benefit or avail yourself of any product or service made available by the King's favor, if you vote—have we left anyone out?—then you are deriving a benefit provided by the King.**

Every tacit acceptance of a benefit offered by the King conditionally binds us in an invisible contract and makes us subject to the King's Publicly Noticed statutes, the "laws of man".

All of the laws that mankind NEEDS are contained in the 118 pages of Phoenix Journal #27: the *Phoenix Operator-/Owner Manual*. [Many journals are still available through Phoenix Source Distributors: 1-800-800-5565. The Journals can be viewed online at www.PhoenixSourceCanada.com.]

The laws of man (the King's laws), however, are contrary to Natural Law in that their very purpose is to enslave mankind. There are so many laws now that no man can so much as read them all—and yet, "Ignorance is no excuse." And so it is no wonder that "the land of the free" has become "the home of the enslaved" and has more people in prison on a per-capita basis than any other nation in the world. And it should be no wonder any longer exactly HOW the REPUBLIC of the united states has become, instead, the fascist (corporate-controlled) UNITED STATES, a corporation of which most readers are mere members, while the ruling-class are corporate officers and directors.

If we shall be so fortunate as to have the chance to repair the situation, perhaps the *Global Constitution* should begin with the over-arching "restraintment" that any law of man that is contrary to Natural Law is automatically void. Only in this way can we ensure that all law springs from the sovereignty of each individual.

In this chapter, George Mercier covers the residency contract: Wherever you reside, you derive some conditional benefit from the state and some reciprocity is expected. That reciprocity is defined in the Publicly Noticed statutes of the state in which you reside.

[QUOTING:]

THE RESIDENCY CONTRACT

Another invisible contract that is difficult to see is the Residency Contract. By being “resident” within a particular Kingdom for a certain length of time, it is presumed that you have accepted those juristic benefits which that regional Prince of yours is offering you. If the benefits are legitimate, then the reciprocity your regional Prince expects back from you in the form of a state income tax, is very reasonable...

The basic power of taxation is an attribute of Sovereignty, and is inherent in every Government unless explicitly denied or limited by its Constitution.... Properly rephrased, what that means is that the jurisdiction of Government (remember during this Residency Contract discussion, I am only talking about the several States) to first throw benefits at folks, and then in turn demand and get reciprocal taxation compensation back in return for having done so, is simply unlimited—unless the Juristic Institution in its constitutional structure has been explicitly restrained (limited) from asking for reciprocity back in return....

So the place to disable a State’s expectations of reciprocity has its seminal point of origin in the Juristic Institution’s own Charter—and an examination of your regional Prince’s Charter will reveal that not very much reciprocity restraint exists there, if any.

As this background legal setting applies to us, Residents are **objects** accepting juristic benefits, and so now Residents are **persons** over which the State has reciprocal expectations of taxation jurisdiction...

Now we ask ourselves the usual question: Just what benefits are being thrown at us this time, in order to justify one more juristic layer of taxation?

As a point of beginning, Residents accept the benefits offered by State Constitutions. The fact that a state conducts certain programs for its Residents does not mean that these benefits are available to all who live within its borders...

Generally speaking, State Residents are State Citizens; and Citizens, as members of the State body politic, possess election **rights of suffrage**.

Another benefit inuring to State Residents is the protectorate operation of the State Police Powers.

By the use [of] this power, a wide ranging array of benefits can be thrown at folks in justification for the enforcement of the reciprocal demands of taxation. But in addressing the Residency Question itself, which is a sister to Citizenship, two Cases come to my mind:

In *Cook vs. Tait*, which is primarily a Citizenship Contract Case, the Supreme Court ruled that income received by a Citizen of the United States while resident in Mexico is taxable due to benefits received while outside of the United States. (The old acceptance of benefits story: When benefits offered conditionally have been accepted, there lies a contract and it becomes immoral not to require a mandatory exchange of reciprocity). The Court then listed those benefits that American Citizens carried with them no matter what their geographical *situs* was.

In *Shaffer vs. Carter*, a Resident of Illinois was experiencing income from property he owned in Oklahoma. It was held that Oklahoma can tax non-Residents on their property located within the Oklahoma boundary *situs*, and the reason is that protective benefits were accepted by that Oklahoma property [and so we see that even “property” can somehow accept benefits] and so the state is entitled to a part of the financial gain that property realized (which is also a correct statement of Nature, although the Supreme Court did not use those words.)

The taxation key in both of those Cases was the acceptance of benefits.

Viewed from a Judge’s perspective, what this means is that it is permissible for a political jurisdiction to throw some benefits at you, and then demand, and get, some *quid pro quo* financial compensation in return for having done so. In this respect, due to Sovereignty, Governments differ from Individuals in the respect that Individuals have to document with evidence the voluntary acceptance of a benefit (of which silence, by the *Ratification Doctrine*, can be reasonably inferred in some circumstances) from someone else before bringing that other person to his knees in a Courtroom; Government, however, simply throws benefits at everyone at large, and the acceptance of the benefit by silence is automatically assumed absent explicit, blunt and timely benefit rejection and disavowal by you. The several States as independent Sovereignities also possess this inherent power, except as limited by the *United States Constitution*. [The *Constitution*, however, was all about how sovereignty supposedly devolved upon the “people”, NOT upon corporate fictions such as the various state and federal governments.]

And so as it applies to occupancy, Residency Status is very much a privilege in the sense that contracts are in effect; by your silence, after taking occupancy in some Prince’s kingdom, you attached a reasonable expectation of using the Prince’s police protectorate powers, among taking advantage of other juristic benefits; and so now state statutes that define a reciprocal taxation liability being expected back in return after you have lived in that kingdom for some 60 to 90 days, or whatever, and then continues liability attachment unless you have been out of his kingdom for more than six months in any one year, etc. are all morally correct and provident.

By your silence, benefits offered conditionally by your regional Prince were accepted by you through your refusal to disavow them, so invisible contracts were then and there created by your acts (your act of refusing to reject and disavow the juristic benefit).

Therefore, State Income Tax Protestors, who merely make the declaration, while in the midst of some type of state income tax enforcement proceeding, that they “are not residents” or are not “state citizens” are wasting their time.

...Your Residency Contract is not unilaterally terminated by your mere declaration that you are not a Resident; contractual termination has to occur for a good substantive reason. One such reason would be Failure of Consideration (meaning that you explicitly and timely rejected all state and municipal benefits). Now that there has been a failure of benefit transference, now you have a substantive attack to make on the assertion of a Residency Contract on you. Your objective is to terminate the contract.

...You must address the Contract question head on, that by the act of your silence a Residency Contract was entered into, and you must come to grips with that fact.

The local state tax collector did not receive any Notice of your Rejection of Benefits, so his assertion of a reciprocal tax against you is provident, up to a limited point. And so winning, on point, will be predicated upon your correctly addressing the existence of the contract in arguments for what it really is, and then attacking the content substantively on the hard mandatory requirement of benefit enjoyment (which does not exist in your Case due to Failure of Consideration), a defense line that causes contracts so deficient in Consideration to fall apart and collapse under attack in adversary judicial proceedings.

When trying to get out of a contract where one of

the parties is a Juristic Institution, a few low-level Trial Judges will find your position to be novel and philosophically uncomfortable, and so you should brace yourself for some snortations descending down to the floor of the Courtroom from the Bench. I did not realize this at first, but some Judges are actually jealous of people turning around so smoothly walking away from a juristic taxation contract; the Judge went to Law School, and then possibly went to work for a law firm, and then they were called to be a Judge; in their minds they look back and see all that money they threw out the window to Government year after year only to wind up in the pockets of some Special Interest Group, and here you are, actually *getting away with* what they did not know how to do themselves, and what is nowhere documented in statutes.

GLOBAL TAXES ARE BACK. WATCH YOUR WALLET

Like a bad sequel to a rotten horror movie, the debate over global taxation once again is rearing its ugly head—courtesy of the United Nations. And, despite lacking the requisite hockey mask and chain saw, the seemingly countless proposals for the imposition of global taxes are truly terrifying.

In July, *Inter Presse* news service reported that a top U.N. official was preparing a new study that will outline numerous global tax proposals to be considered by the General Assembly at its September meeting. The proposals will likely include everything from global taxes on e-mails and Internet use to a global gas tax and levies on airline travel. If adopted, American taxpayers could wind up paying hundreds of billions of dollars each year to the United Nations.

U.N. Secretary-General Kofi Annan is among those leading the charge, having stated that he “strongly supports finding new sources of funding” for the U.N. through global taxes, according to *Inter Presse*. In fact, Annan made very clear his support for the imposition of global taxes in a 2001 Technical Note that he authored for a U.N. conference. “The need to finance the provision of global public goods in an increasingly globalized world also adds new urgency to the need for innovative new sources of financing,” Annan wrote. The Note goes on to describe and evaluate the merits of several global tax proposals.

Global tax proposals are not new. Various plans have been flitting around in academic circles and liberal and socialist think-tanks for decades. And while the United States and other developed nations have staved off such proposals in the past, Third World nations have increasingly dominated the U.N. General Assembly by sheer numbers since 1970. As a result, they have begun to see promise in their quest to take and keep for themselves the wealth of citizens from nations like the United States—specifically using the term “redistribution”. Recent U.N. actions have also provided a new excuse and set the stage for the Third World to not only renew its pursuit of global taxes but also hold out hope for eventual success.

In 2000, the U.N. General Assembly approved a “Millennium Declaration” that committed the world body and its member nations to a sweeping list of objectives, particularly in the area of assisting “developing” nations. Among them were five specific goals, to be achieved by 2015, aimed at reducing poverty, improving children’s health and fighting AIDS around the world.

Arguing that developed nations like the United States have not done enough to achieve these goals, despite the fact that we provide the bulk of the U.N.’s money, U.N. leaders have recently begun using the Millennium Goals as an excuse to explore global taxation. As *Inter Presse* reported, U.N. Secretary General Kofi “Annan has warned that unless current development assistance is doubled to \$100 billion

annually, the world’s 132 developing nations will fail to meet their Millennium Development Goals.”

Using the Millennium Goals as the excuse, the United Nations is set to once again begin considering specific methods to extract wealth from citizens of the United States and other first world nations for “redistribution” to the citizens in the less developed, poorer Third World. Among the schemes being contemplated are:

- **E-mail tax...** [E]-mail users would pay a tax of about \$.01 for each megabyte of data that they send, generating up to \$150 billion per year.

- **A tax on fossil fuels like gasoline, coal, oil and natural gas...** [T]he tax rate would have to be very high—enough to generate \$750 billion per year, of which U.S. taxpayers would pay more \$150 billion.

- **Currency transaction tax (CTT)...** Advocates of the CTT... want to impose a tax of around .1% on each transaction. According to the United Nations, such a tax would generate up to \$264 billion per year.

- **International air transport tax...** According to one estimate, an international transport tax would generate \$2.2 billion per year.

- **Aviation Fuel Tax...** Very similar to the air transport tax, this plan would place a levy on airline fuel costs and would yield around \$12.5 billion per year.

Those are the most frequently discussed of a bevy of global tax proposals that have been put before the international community. Others include a tax on the international conventional arms trade, fines for ocean dumping, a tax on commercial fishing, a tax on Earth-orbiting satellites, a tax on the use of the electronic spectrum (for television, radio, cell phones, etc.), a tax on the profits of international businesses and even a tax on international advertising....

POLLUTANTS CAUSE HUGE RISE IN BRAIN DISEASES

The numbers of sufferers of brain diseases, including Alzheimer’s, Parkinson’s and motor neurone disease, have soared across the West in less than 20 years, scientists have discovered.

The alarming rise, which includes figures showing **rates of dementia have trebled in men**, has been linked to rises in levels of pesticides, industrial effluents, domestic waste, car exhausts and other pollutants, says a report in the journal *Public Health*.

In the late 1970s, there were around 3,000 deaths a year from these conditions in England and Wales. By the late 1990s, there were 10,000.

“This has really scared me,” said Professor Colin Pritchard of Bournemouth University, one of the

report’s authors. “These are nasty diseases: people are getting more of them and they are starting earlier. We have to look at the environment and ask ourselves what we are doing.”

The report, which Pritchard wrote with colleagues at Southampton University, covered the incidence of brain diseases in the UK, US, Japan, Australia, Canada, France, Germany, Italy, Netherlands and Spain in 1979-1997. The researchers then compared death rates for the first three years of the study period with the last three, and discovered that dementias—mainly Alzheimer’s, but including other forms of senility—more than trebled for men and rose nearly 90 per cent among women in England and Wales. All the other countries were also affected.

For other ailments, such as Parkinson’s and motor neurone disease, the group found there had been a rise of about 50 per cent in cases for both men and women in every country except Japan. [*Do you suppose there are fewer mad cows in Japan? Or could it have something to do with plutonium poisoning and prevailing winds?*] The increases in neurological deaths mirror rises in cancer rates in the West.

The team stresses that its figures take account of the fact that people are living longer and it has also made allowances for the fact that diagnoses of such ailments have improved. It is comparing death rates, not numbers of cases, it says.

As to the cause of this disturbing rise, Pritchard said genetic causes could be ruled out because any changes to DNA would take hundreds of years to take effect. “It must be the environment,” he said....

NASA’S FINANCES IN DISARRAY AUDITOR QUILTS

WASHINGTON—As NASA sets course for the Moon and Mars, the space agency’s finances are in disarray, with significant errors in its last financial statements and inadequate documentation for \$565 billion posted to its accounts, its former auditor reported.

NASA’s chief for internal financial management said the problem stemmed from a rough transition from 10 different internal accounting programs to a new integrated one, but audit firm PriceWaterhouseCoopers noted basic accounting errors and a breakdown in NASA’s financial controls.

PriceWaterhouseCoopers and NASA parted ways earlier this year, according to the space agency’s inspector general, Robert Cobb. PriceWaterhouseCoopers declined to comment, but a source familiar with the situation said the audit firm opted out of the contract because it was unhappy with the relationship.

In a scathing report on NASA’s Sept. 30, 2003, financial statement—which got scant attention at its release but was detailed in a cover story in the May issue of *CFO Magazine*—the audit firm accused the space agency of one of the cardinal sins of the accounting world: failing to record its own costs properly....

\$565 billion in adjustments

“The documentation NASA provided in support of its September 30, 2003, financial statements was not adequate to support \$565 billion in adjustments to various financial statement accounts,” the auditor

wrote in a Jan. 20 report to Cobb, NASA's inspector general. It also noted "significant errors" in financial statements provided by NASA.

That big number—\$565 billion, with a "B"—was the result of posting problems, new software and a "massive cleanup" of 12 years of NASA's financial records, said Patrick Ciganer, NASA's chief for integrated financial management.

Under the new system, Ciganer said in a telephone interview, errors that were discovered in the transition could show up multiple times in the accounting process: once as an erroneous credit in one column, then as a debit to delete the error, then as a credit in the correct column. By this reckoning, a \$40 billion contract that stretched over nine years and several separate NASA centers generated \$120 billion worth of entries, and these were turned over to the auditors....

Mr Aguss said: "It's rusty coloured and you can see a few crystal pieces in it.

"I dread to think what could have happened if it had hit her on the head—she was extremely lucky," he added.

One meteorite makes it through the atmosphere and falls to Earth each week on average, according to David Fagg, secretary of Norfolk Astronomers.

PENTAGON LOOKS TO DIRECTED-ENERGY WEAPONS

A few months from now, Peter Anthony Schlesinger hopes to zap a laser beam at a couple of chickens or other animals in a cage a few dozen yards away. If all goes as planned, the chickens will be frozen in mid-cluck, their leg and wing muscles paralyzed by an electrical charge created by the beam, even as their heart and lungs function normally.

Among those most interested in the outcome will be officials at the Pentagon, who helped fund Schlesinger's work and are looking at this type of device to do a lot more than just zap the cluck out of a chicken. Devices like these, known as directed-energy weapons, could be used to fight wars in coming years.

"When you can do things at the speed of light, all sorts of new capabilities are there," said Delores Etter, a former undersecretary of defense for science and technology and an advocate of directed-energy weapons.

Directed energy could bring numerous advantages to the battlefield in places like Iraq and Afghanistan, where U.S. troops have had to deal with hostile but unarmed crowds as well as dangerous insurgents.

Aside from paralyzing potential attackers or noncombatants like a long-range stun gun, directed-energy weapons could fry the electronics of missiles and roadside bombs, developers say, or even disable a vehicle in a high-speed chase.

The most ambitious program is the Air Force's Airborne Laser, a plan to mount a laser on a modified Boeing 747 and use it to shoot down missiles.

At the same Air Force Research Laboratory in New Mexico, researchers working with Raytheon Co. have developed a weapon called the Active Denial System, which repels adversaries by heating the water molecules in their skin with microwave energy. The pain is so great that people flee immediately.

"It just feels like your skin is on fire," said Rich Garcia, a spokesman for the laboratory who, as a test subject, has felt the Active Denial System's heat. "When you get out of the path of the beam, or shut off the beam, everything goes back to normal. There's no residual pain."

A Humvee-mounted Active Denial weapon is expected to be given to all services by the end of this year for evaluation, with a decision about deployment expected by the end of 2005.

But the idea of using directed energy against humans is creating debate fueled by deaths allegedly caused by Taser stun guns and the alleged abuse of Iraqi prisoners—which put the military's respect for human rights under a microscope.

Some experts believe the use of directed energy will be limited by international law and treaties.

...Military officials believe the intended uses of the Active Denial System do not violate any international laws or treaties and do not cause any permanent health problems.

"You can rest assured that with this system, when it finally is deployed, we will be very, very clear about what the intended uses are and what is clearly outside of bounds," said Marine Corps Capt. Daniel McSweeney, spokesman for the Joint Non-Lethal Weapons Directorate. "It's not intended to be used as a torture device. That goes against all the design intentions and parameters."

...“It’s encouraging that the U.S. is searching for more humane weapons,” said the Lexington Institute’s Thompson. “But it’s very hard to convince other countries that our goals are ethical.”

NEVADA CORPORATIONS:

What They Don't Say Can Really Help You

Budget's "Tip of the Week" #5:

NRS 78.752—Insurance and other financial arrangements against liability of directors, officers, employees and agents

In the first four installments of "Tip of the Week" we took a close look at several very interesting provisions of Nevada's corporate statutes. Sometimes, however, what is NOT mentioned in the statutes is just as important.

In Nevada, as many readers may be aware, there is no statute mandating the **issuance of stock**. (Nevada is not unique in this regard; several other states' corporate statutes similarly ignore this key issue. What makes Nevada unique is the combination of statutory provisions, non-addressed key issues and actual practices, all of which add up to make Nevada the ONLY state that allows for privacy of ownership and control of a corporation.)

As if to underscore the non-necessity of stock issuance, there is no requirement to hold an **annual meeting of stockholders**. Yes, there are many references to the stockholders' meeting but nowhere is it stated that any such meeting must be held.

Similarly, Nevada is one of a few states that does not nullify the use of **"bearer" shares**. It is not that there is a statutory provision endorsing the use of bearer shares or even addressing the issue; it is that the issue goes entirely unmentioned, whereas in most other states the use of bearer shares is statutorily denied.

A major, major issue that is not addressed anywhere in the *Nevada Revised Statutes* is that of **nominee officers and directors**. The use of nominee officers and directors has been common in practice in Nevada for more than 75 years and yet this issue, which is the key to privacy of control of a Nevada corporation, is simply not mentioned. Doesn't that make you wonder why not?

Other states (Wyoming comes to mind) have directly addressed the issue of **nominee stockholders**. In Nevada, however, there seems to be more power granted by not restricting the use of this technique even by defining it.

Nevada only requires a corporation's primary officers to be listed annually but does not abridge the key roles that can be afforded to **secondary officers**, such as a vice president, who may exercise all of the powers of the president in the president's absence; an assistant treasurer, who may be empowered to sign checks and otherwise fulfill the role of treasurer; or an assistant secretary, who may perform all of the duties of the secretary. When nominee service is used, the primary officers are assuredly absent, empowering these secondary officers, who are never listed in the public records with the Secretary of State.

Finally, since only an annual list of officers needs to be filed, a corporation may change its officers and directors at any time through a proper resolution (a PROTECTED "internal" record of the corporation) without notifying the state to modify the public record.

This listing is, of course, by no means all-inclusive. We trust, however, that it provides the reader with a lot of serious "food for thought" as to possibilities for private control and ownership of Nevada corporations.

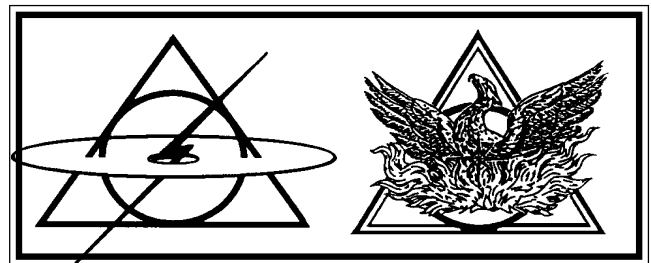
