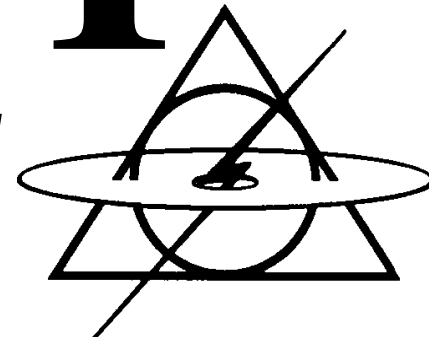

The Filipino people are hungry. They are hungry for food and justice. While so few among them have so much food to eat, so many of them have so little. While so few can afford the cost of justice, so many cannot.

Is that the worst? No. If so many of them have

so little food or justice, so much more have no food or no justice at all.

If some of the rich complain of economic difficulties, then the poor who constitute the majority ought to have more reason to complain.

Are they complaining? Yes. Are they getting anything substantial out of their complaints? No. Why? Because their complaints are not effective. Why are their complaints ineffective? Nobody is really listening or responding with substantial relief to the complainants.

Is the government or administration really listening? No. It is too busy concocting new tax measures to impose on the already impoverished majority.

Is big business listening? No. It is more concerned with earning its millions or billions worth of net profits.

Is the church listening? No. The daily or religious service-to-religious service collections that lead to earning huge net profits for the church continue with no sign of any intention of being stopped or relaxed.

If there is so little or no food nor justice under a supposedly peaceful regime, what does a deteriorating

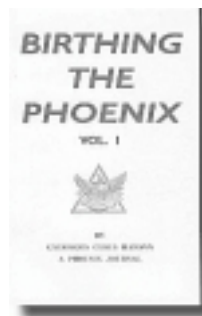

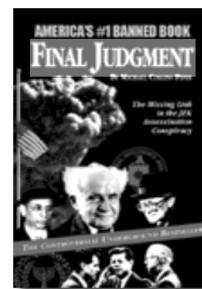

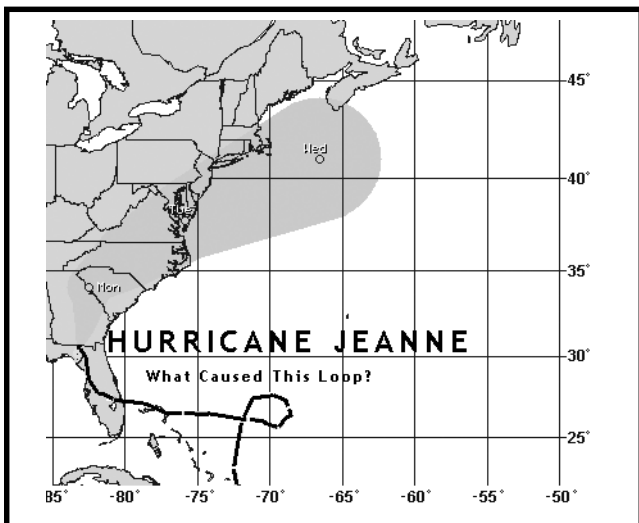

JERUSALEM—Madonna's visit to Israel last week, as part of a High Holidays pilgrimage organized by the Los Angeles-based Kabbalah Centre, was greeted here with an enthusiasm deeper than mere excitement at the presence of a pop superstar. Israelis were understandably grateful to her for showing solidarity with their besieged country and for defying the fear of terrorism that has kept so many tourists away. Her very presence reminded Israelis that they still had friends around the world. [H: Madonna?]

However reassuring, Madonna's embrace should be treated by Jews warily. The source of her Jewish connection, the Kabbalah Centre, has been repudiated by the mainstream Jewish community for its alleged cult-like behavior. Accusations against the Centre (the pompous spelling is theirs) include exploiting volunteers, breaking up marriages when one partner opposes involvement in the group, and even instructing one terminally ill L.A. man to cure himself by filling his swimming pool with water "blessed" by the Centre's leaders. (In fact, the Kabbalah Café in the Centre's L.A. headquarters has a sign that reassures patrons that all coffee and tea sold there is made with this water.)

The mainstream Jewish community is so wary of the Centre—which claims to have influenced about 3 million people, including Mick Jagger and Britney Spears—that the Jewish Federation of Greater Los Angeles has excluded it from a listing of local Jewish organizations.

But no less disturbing for religious Jews than the Centre's alleged abuses is its doctrinal distortion of "cabala", the ancient mystical tradition revered as the inner sanctum of Judaic devotion and thought.

In traditional cabalistic schools, the 72 Hebrew names of God form the basis for arduous meditations and ascetic

Arguably for the first time in history, we can study and even experience something of the devotional life of another faith. With its openness to non-Jews, the Centre could have performed an important role in this process of spiritual exchange. But its profound corruption of Jewish mysticism negates any potential contribution.

Some Jews argue that Madonna’s endorsement of Jewish mysticism helps make Judaism attractive to alienated young Jews. Yet Jews need to protect the integrity of their tradition. No matter what the short-term benefits, Jews should shun the Kabbalah Centre and those who promote it. Distorting Judaism is not good for the Jews. Whether it is jay-walking, spitting on the sidewalk, having socially unacceptable sex, using drugs, drinking and driving, spending, cheating, lying, stealing, whatever it is, you are at the crux of it. You are the problem, as is the person next to you. If we believe in God that has given us life and we continue to do things which destroy our energy, our mind, body and spirit, then we are the problem. It isn’t God. It isn’t Satan. It isn’t the government. It isn’t anybody else. It’s us.

Some people believe man has dominion over the Earth—and we see what that kind of thinking has done—and yet they blame others for their problems. They blame the communists, the liberals, the conservatives. They blame those people who don’t think like them, who don’t go to the same church or who are a different color, wear different clothes, drive a different car, speak a different language, and live in different places. In general, it seems that individuals who blame others lack one thing, accountability for

their own actions. “Hallelujah, let me give up all of my sinful ways and be saved, then I won’t have to take one bit of accountability for anything I’ve ever done on this Earth and I’ll find heaven someplace else.” Not so. *Au contraire, mon ami.* We will be back again and again and again until we get this place like it was before and the only way we are going to get it like it was is to recognize our accountability. No one is going anywhere without the other and no one is coming from anywhere else to do it for us. All colors and all mindsets have to work together to fix what we have done. Black, white, yellow and red, man/woman, human being, we are connected, related and accountable.

We are all connected to and affected by everything that happens and every thought that goes out into the universe. For one day, one hour, for just five minutes try to remember that everything you are thinking affects the entire universe. Can you do that? We expect God to do it. We expect God to be tuned right into all this. God can do it, I guess, because it is omnipotent, omnipresent, omnifuture, omni this and omni that. God’s supposed to be right there at the other end of the line. At the moment we need it, we just call out, “Oh God, help me, save me and I’ll never do it again.” That’s real audacity. No humility there. Where does our accountability for how we act come in? What gets us into the circumstances in the first place?

I defy any of us alcoholics to say God told us to drink. I defy any of us drug abusers to say God told us to do drugs to get our minds straight. God didn’t tell us anything. We told ourselves to take drugs because there was something in our lives that we didn’t want to deal with. We can protest, disagree and procrastinate; we can say we were explaining this or that, but the truth is we couldn’t handle the reality of life so we found another way to deal with it. Some of us try to do it sexually and [that] runs out real fast. Some of us try to do it by eating and that keeps on going forever. We never stop eating, trying to correct that feeling inside. There are even people who eat and then throw up. Now that’s a problem, but we don’t call them problems anymore; we call them illnesses and diseases. Let’s quit dancing around the issues. Call problems what they are and take accountability.

We hold God accountable for our lives, but we are of God, created by that creative energy, so we must take accountability because we are part of that energy, part of the Creation. We are just one part, the two-legged part. There are winged and four legged and other parts of it and they seem to be able to take accountability. Even the water takes accountability. People ask me to pray for them and when they get well or something good happens they say, “Thank you for the prayers.” I say, “Thank yourself, because you took accountability for your life and what has transpired in it is by your faith.” That’s accountability.

Have you ever been in therapy? Probably ninety percent of us have and the other ten percent have thought about it. Therapy is getting up in the morning, looking at yourself in the mirror and saying, “Today I am accountable for everything I do and every word I utter. It’s my responsibility.” Try it one day. Mark it on your calendar. Draw a circle around one day next week and declare it Total Accountability Day. Don’t blame anybody for anything and take total responsibility for everything that happens that day.

People always ask how the Indians did it and I usually say something like, “We’d build a fire and dance around it and then go hunt buffalo.” People like to hear that stuff. The truth is that indigenous people are human beings and we worked with the problems at hand. Sometimes answers were simply put off as being part of “The Great Mystery”, but each person sought to find, in their own time, their connection and a way to better serve their community, to better serve those of a

like mind which held their community together. They took accountability for their actions, realizing that the community would be threatened by any act of selfishness and disregard for others.

The concept of like mind and heart held many indigenous communities together. Nations were built upon that concept. Early on, our Six Nations brother advised the founding fathers, “When you build your government, make sure you include a spiritual core. Make sure that our government contains a spiritual world view.” The thirteen colonies came together, each based on their own religious need, their own religious world view and decided they couldn’t do that and maintain a union. Instead, they concluded that freedom is based upon equal representation. So we, as a nation, lost the opportunity to build a government with one heart, to acknowledge the sacredness and connectedness of all people and all things and we continue to be divided by bigotry, racism, classism and intolerance.

We are sacred and we have an accountability for everything that happens in our lives. We can blame the government but changing it, throwing out the scalawags, will not change anything because we’d just get other scalawags in there. Changing the constitution is just more paperwork giving us something else to think about, something else to dwell on, creating job security for people who interpret it. We can create a new government, we can put new people in office, we can put far right, far left, up the middle, conservatives or liberals in there, but let me tell you, if change does not occur within us as individuals, if we do not take accountability for the sacredness that dwells within, all the changes in the world won’t make any difference at all.

Taking accountability is most likely a matter of how we are influenced during our early years. All children are pure and are only corrupted by their interactions with those who are in charge of them, those who abuse them in mind, body and spirit. We can build all the jails and child abuse shelters we want but, once again, unless the abuser changes from within, nothing will change. We will still have mothers who put their kids in cars and let them go into lakes. We will still have mothers who stab their children to death. We will still have fathers who kill their families and we will continue to ask why.

We keep wanting to look for someone to blame. We look for representations of Iktomi, the one of wisdom. He knew all things but we turned him into the trickster and some people say our world was tampered with because the trickster came among us. We don’t want to take responsibility for our own actions, we want to blame somebody else. “God hates me. God has forsaken me. Jesus is not answering my prayers. I can’t find a job. I have a bad heart. I’m broke and poor. No one likes me. My parents abused me. I’ve been kicked out of my church. I’m out of favor with my religion.” Once again, we aren’t taking accountability for what we’ve done. We created that “trickster”, whatever it might be, and we are accountable for what happens in our lives and in the world.

Why are we so anxious to point our fingers at others? Do we think we can fool God? If there is indeed a judgment day when everyone goes before “the Father and Son” as many people claim to believe, then we will still be held accountable for what we have done. Whether we are accountable today, tomorrow or next week, one way or another we will still pay for what we have done. The Pope will pay for what he has done. I will pay for me. You will pay for you. Why judge or blame anybody else? Look at yourself. Ask yourself, “Am I being accountable for this action and this thought about that person or that person’s behavior?” It is none of your business what somebody else does because you are not going to have to pay for anyone but yourself; I

pay for me, you pay for you.

Finding fault delays our responses to any given situation, responses that require us to take accountability for our existence and in so doing, removing forever the questions of who and what we are. If we finger-point, if we blame, if we look to other things as being the cause, we never see the cause because we are busy looking outside of ourselves rather than WITHIN. Our resentment, hatred and anger dwell in our hearts. That is where we hate, that is where we don’t forgive, that is where we carry it all. I used to give people a little green bag to represent the heart and would tell them to carry it with them everywhere they went so they would know, every time they looked at it, that they were carrying garbage around with them. Take accountability for your garbage. Take accountability for your life.

I am addicted, yes, but I chose to make that addiction mine. I will choose if and when to break my sobriety. I will choose to take a drink; I will choose to do drugs. I will choose to do whatever it is I do in this moment, the next moment and for all the moments of my life. I will choose what to do with my life, not you. My choice is not a result of what you do to me, what you say to me, what you think of me, or how you act around me. It is I who make my decisions, not you. If I get to a place where I no longer want to make the wrong decision, whatever that is—people say, “I made the wrong decision,” just say you made a decision—then I must find a way to change and realize that it’s for my benefit and, therefore, for the benefit of those around me. Unless I am willing to make that change, to be accountable for who and what I am, then nothing will change. I make a difference and you make a difference. Accept the accountability.

Each of us is right. There is no one right person, no one right way. No one is more right than anyone else. Everyone is right and should be respected, but not everyone is accountable. Take accountability and remember, everything you do is not for yourselves but for all your relations.

# The Fight Against Usury

## THE FIGHT AGAINST USURY

Lending money at interest has been condemned by men such as Plato, Aristotle, Plutarch, Seneca and Cicero, early fathers of the Christian church; the majority of popes and councils up to 1830; likewise modern authors such as Goethe and Wagner.

The fight against usury goes back to the earliest known beginnings of civilization. From the days of Sumer to the present, decent people have struggled against this tool of the forces of darkness. Charging interest was condemned by the ancient Greek philosophers. Money was to them something dead; something dead cannot be allowed to grow. Aristotle wrote in his work *Politics* (Book One, part X): "The most hated sort, and with the greatest reason, is usury, which makes a gain out of money itself, and not from the natural object of it. For money was intended to be used in exchange, but not to increase at interest.... Wherefore of all modes of getting wealth this is the most unnatural."

Up until the end of the Middle Ages it was forbidden for Christians to charge interest. To charge interest on a loan was tantamount to murder and robbery. Later, those who charged interest were treated as heretics.

Martin Luther stated plainly: "All usurers are thieves and belong in the gallows." Everyone who lent money at an interest rate of 5 to 6 percent was considered to be a usurer. During the Middle Ages only Jews were allowed to lend money with interest. In *Deuteronomy* a Jew is forbidden to charge interest from his brother. But the goy (non-Jew) was not his brother. And to Jewish extremists plunder was not unfamiliar.

In ancient Babylonia the legal interest rate was 30 percent on money and 50 percent on grain. In Assyria there was no upper limit for interest rate. The farmers were often so deep in debt that they starved to death along with their families. This led to ruthless exploitation of the soil.

In the city of Uruk in Sumer there lived two brothers who lent money with interest. When a borrower no longer could repay his loan, he lost his house and had to start working for free for the brothers. The slave could be lent also to other employers. This is a classical example of economic slavery.

Almost 3,700 years ago the ruler of Babylon, Hammurabi (1848-1805 B.C.), who was descended from the Amorite dynasty, forbade through his legal acts (containing 93 paragraphs) the taking of interest on interest, which meant that the borrower had to give in addition to the assets he had borrowed the same amount in goods or money. Anyone who broke the rule was severely punished, though very few abided by it. The 282 statutes of Hammurabi, written in Akkadian, were found in 1901-02 at excavations at Susa in ancient Elam (now Iran).

The tribune Tiberius Gracchus of the Roman Empire tried in 133 B.C. to reduce the power of the moneychangers through stricter laws against usury and to limit the legal land ownership to *iugeri* (about 600 acres) per family. He was murdered the same year.

In 48 B.C. Julius Caesar deprived the moneychangers of the right to coin money and had it done himself. With a larger money supply he was able to erect many public buildings. Common people adored Caesar for his contribution to making money more available. After the

murder of Caesar there was an end to the abundance of money. The money supply was reduced by 90 percent. Taxes rose sky-high. As a result most people lost their land and their homes. The slander of Caesar goes on even today.

The Freemasons wanted to acquire as much wealth as possible in order to serve their demons during the 19th and 20th centuries.

The Irish economist Margrit Kennedy has pointed out that a 1 percent loan is doubled in 70 years. A 3 percent loan with accumulated interest doubles in only 24 years. A 6 percent loan doubles in 12 years, and at 12 percent the amount is doubled in just six years.

If anyone had lent one cent in A.D. 1 and charged a 4 percent interest, in 1750 he could have bought gold weighing as much as the whole Earth. (At 5 percent interest it would have been possible as early as the year 1403.) In 1990 he would have been able to buy 12,246 such "nuggets".

These extreme examples show how madly interest damages each country's economy.

After the so-called French Revolution the use of paper money was widespread.

The gold traders began practicing economic fraud to become even more powerful. They lent secretly part of the gold that had been deposited with them and kept the interest they made on such illegal loan. The gold traders then issued more receipts (bank notes) of gold deposits than they had gold, then lent these notes and charged interest on them. Far more money was lent than what the creditor had cover for. Soon these money crooks lent as much as up to 10 times more than they had gold deposited.

This breach of trust has become common in all areas in the world of the Freemasons. The American banks have the right to lend 10 times more money than they actually have. This means that their interest actually is close to 80 percent and not 8 percent, which is officially claimed. The Masonic bankers create money out of nothing and force us to pay interest thereon.

The Prieuré de Sion initiated, with the aid of the moneychangers (above all the Portuguese Rabbi Menasseh ben Israel, who lived in the Netherlands, and Antonio Fernandez Moses Carvajal), the insurrection of 1642, led by Oliver Cromwell, which in turn led to the first republic (commonwealth) in England in 1649. In the year 1643 a large group of rich Jews came to England. They met with the Portuguese ambassador in London, Antonio de Souza, a Maranno, where further moves were discussed. All their actions were coordinated by Carvajal.

Having deposed and executed Charles I in 1649, naming himself as dictator in 1653, Cromwell became bloodthirsty and hostile to cultural development, letting the moneychangers strengthen their financial power. Under the puritanical rule of the Lord Protector Cromwell, music and other cultural activities were practically banned. Even colorful garments were forbidden.

In November of 1688 (under the sign of the scorpion) the Catholic king of England James II (Stuart) was overthrown through a well-organized invasion financed by the moneyed Jews of Amsterdam and led by the Prieuré de Sion and the Orange Order. The king was exiled to France and in February of 1689 William of Orange, the prince of Nassau, was put upon the English throne by means of a *coup d'état*, which became known as the Glorious Revolution. Even official historians admit that the people did not participate in this coup.

England at that time was in poor condition after more than 50 years of war with France and the Netherlands, and the new king, William III (of Orange), asked several powerful bankers for help. They provided the English state with a loan of 1.25 million pounds but only delivered 750,000 pounds. The terms of the loan were as follows:

The names of the lenders were not to be revealed, and these were guaranteed the right to found the Bank of England, whose directors were ensured to establish a gold reserve so as to be able to issue loans to a value of 10 pounds for each pound deposited gold in the bank vault. They also were allowed to consolidate the national debt and secure payment for annuity and interest through direct taxation of the people.

The privately owned Bank of England was established in 1694 with absolute control over the currency (the right to issue bank notes). The lending of money on usury was able to continue at an even larger scale. Thus the English people suffered a huge national debt. Taxes had to be raised and prices doubled. To the Masonic bankers it was necessary to have a monopoly on money issuing. That way they were able to make enormous profits and also control political processes.

The Bank of England was allowed to lend money to an amount 10 times the security the lender put up. With 5 percent interest it only took two years for the bank to earn back an amount equal to the original security.

By the year 1698 the national debt had risen from one and a quarter million pounds to 16 million. In 1815 it was 885 million pounds and in 1945 it had grown to 22.5 billion pounds. By 1995 the national debt had risen to more than 300 billion pounds, equal to 45 percent of GNP.

Not even the Macmillan Committee, which was appointed in 1929, managed to find out who governed the Bank of England. Only one name has leaked out—that of Rothschild. All great wars have been started and financed by the economic conglomerate emanating from one single banking family—the Rothschilds.

In the Netherlands, secret societies had been able to found a central bank as early as 1609. About 40 of the world's most important central banks were established in a similar way as that of the Bank of England. In that way the Masonic bankers ruled the long-term development in the world with loan interest as a method, the central banks as middlemen, the politicians as dummies and the people as ignorant wage slaves. The Freemason-controlled banks thus can govern political life by acting without being seen. The English people strengthened the power of these invisible Freemasons through paying taxes during three centuries. Central banks were supposed to keep the economy stable.

In reality it works quite differently.

Benjamin Franklin wrote of the British colonies in North America in the 1750s: "Nowhere on Earth does one find a happier and more well-being people." He explained that this was due to that "we in the colonies make our own currency," called "colonial scrip." He further explained: "By issuing our own currency we can control its buying power, and we are not obliged to pay interest to anyone."

In these British colonies in New England, there was a wealth contrasting sharply to the poverty and misery in England. There was enough money, and it was definitely interest free.

When the Masonic bankers in England heard Franklin's speech to the British Parliament, they made sure that Parliament forbade the colonies to use their own financial system and instead demanded they use interest money in gold and silver. Only an insufficient amount of this money was to be available. The money supply was reduced in half, and the colonies were forced to borrow money from the Bank of England. The result was steep interest and price increases. Within a year the streets were full of unemployed people.

In American schoolbooks the reason given for the outbreak of the Revolutionary War was the tea tax, but according to Franklin "the colonies would gladly have borne the little tax" (of 2 percent) on tea and other matters had it not been that England took away from the colonies their money which created unemployment and dissatisfaction." The result of the influence of the English banks on the British Parliament was horrendous poverty in America. When this situation had been created, it was easy to get people ready for war, which the Freemasons did with satisfaction. They wanted a safe base for their future global activities.

Among the men who drew up the *Constitution* of 1787, there were those who thought one should protect oneself against the financial drain of the international bankers. Therefore Article I, Sec. 8 of the *Constitution* reads: "Congress shall have power... to coin money, regulate the value thereof..."

Alexander Hamilton, a Freemason and secretary of finance in the government of George Washington, and also the agent of the international financiers, ordered the establishment of a privately owned union bank and the introduction of interest money. His argument was simple: "A limited national debt would be a blessing to a nation." He considered it dangerous for the government to issue its own currency.

Thus the United States got its first central bank in 1791. It was privately owned but had a contract running for only 20 years. It was not renewed when it expired. Andrew Jackson referred to the fact that the *Constitution* had given Congress the right to issue currency in sufficient quantity but not transfer this right to others.

The historian Richard Boesen disclosed that the Freemason Nathan Rothschild (1777-1836), who in 1806 had founded his bank in London and who partly financed the Napoleonic wars through the Bank of England, subsequently issued an ultimatum—either the contract be renewed or there would be war. Jackson called the Masonic bankers a bunch of thieves and promised to exterminate them. Rothschild gave his own orders: "Teach these insolent Americans a lesson. Force them back to a colonial status."

The British government began to limit the American sea trade and checked the American expansion in Canada. President James Madison in 1812 had no other choice but to let Congress declare war on England. The intention of the leader of the Freemasons, Rothschild, was to lay waste the country to such an extent that the Americans would be forced to seek financial aid. Great Britain, however, failed to regain the lost colonies, and the United States failed to occupy Canada. The war was actually fought in 1814.

Many lives were lost, but Rothschild did not triumph this time. The renewed central bank contract was again suspended in 1836 during Andrew Jackson's presidency (1829-1837), despite the fact that he was grand master of Tennessee. The central bank was abolished.

Even so European bankers and their American agents managed to exercise an extensive control of the American monetary system. Gustavus Myers admits in his book *History of the Great American Fortunes* (1910): "Under the surface the Rothschilds had for a long period of time a direct influence by dictating the American financial laws. The legal records show that they were the ones in control of the old Bank of the United States."

In American history books there is nothing about the role of the banks in the first and second American wars of independence (that is 1775-83 and 1812-1814). Neither is there anything about the debt-free "greenbacks" that Abraham Lincoln issued. Their existence is only verified by a few encyclopedias.

To finance the American Civil War, which broke out on April 12, 1861, President Abraham Lincoln was forced to utilize the right of the Congress to issue its own currency. Between the years 1862 to 1864, 450 million interest-free "greenbacks" were printed. Lincoln promised at his re-election in 1864 to begin fighting the banks as soon as the war was over. Lord Goschen, the representative of the financial world, wrote in *The London Times*: "If this financial policy becomes permanent, the government can without expenses acquire necessary monetary provision. It can pay its debt and repay its loans without debt. It will have enough money to trade (on the open market). It is going to be more healthy than any other (before) in history. If we do not overthrow this government, it will overthrow us."

The North during the Civil War was financed by the Rothschilds through their American agent August Belmont (actually Schoenberg) and the South by the Erlanger brothers who were related to the Rothschild family.

The Civil War ended on April 9, 1865, and international

Freemasonry got busy to remove President Lincoln.

The assassination of Lincoln was carried out by John Wilkes Booth (Botha), a Freemason of the 33rd degree, on April 15, 1865 in Washington, D.C., only six days after the end of the Civil War. Izola Forrester, Booth's granddaughter, stated in her book, *This One Mad Act* (1937), that Booth belonged to the lodge Knights of the Golden Circle and also Giuseppe Mazzini's "revolutionary" movement Young America. Izola Forrester revealed in detail that the Freemasons were involved in the assassination of the president. Booth was soon eliminated.

The above-mentioned Masonic lodge Knights of the Golden Circle was mixed up in the plot. This name had begun to be seen in the press, and so the Freemason leader Albert Pike in 1866 decided to rename it the Ku Klux Klan; "kyklos" in Greek meaning "circle".

It was officially founded as a new organization in 1866 in Pulaski, Tennessee. In 1882 it was banned. The present group with the same name was founded in 1915 by William Joseph Simmons and thus has not grown out of the Masonic lodge that existed in the 1860s and 1870s.

After the demise of Lincoln, things were "normalized". The amount of money in circulation, which in 1866 amounted to \$1.9 billion or \$50.46 per capita, had by 1876 been reduced to \$605 million or \$14.60 per person.

As a result there were 56,446 bankruptcies in 10 years and a loss of \$2 billion. In 1887 the Masonic bankers reduced the money amount further to \$6.67 per head. The Irish writer Margrit Kennedy stated in the book *Interest and Inflation Free Money* that the interest rate always goes up when there is a shortage of money. This in turn leads to bankruptcies and worsens the unemployment rate.

In American schoolbooks it is claimed that it was all for the good that the Democratic candidate for president in 1896, William Jennings Bryan, was not elected, since he was against the gold footing and the "sound money" of the banks (that is money that creates debt). Bryan explained in his "Cross of Gold" speech at the Democratic National Convention, in Chicago on July 9, 1896: "When we have restored the money of the *Constitution*, all other necessary reforms will be possible, and that until that is done there is no reform that can be accomplished."

Bryan was not elected, and 17 years later, in 1913, Congress passed a bill (introduced by the Masonic President Woodrow Wilson), that purported to repeal the right of the Congress to issue currency and transferred this right to a "federal reserve" funding system.

Congressman Charles A. Lindbergh, father of the famous aviator, had the following to say about this: "When the president signs it, the invisible government of the money brokers has become legalized. The worst legal crime of the century is a fact. The day of reckoning is only a few years removed."

The man who played a very important role in providing the United States again with a central bank was Paul Warburg. He was a German immigrant, arriving in America together with his brother Felix. Both brothers became partners in the banking house Kuhn, Loeb & Co, led by the Illuminatus Jacob Schiff, who also belonged to B'nai B'rith. The Warburgs were supported by Nelson Aldrich (later to become grandfather to Nelson and David Rockefeller), known as the handyman in the Senate of John Pierpoint Morgan. The family of (Samuel Moses) Del Branco in 1559 moved from Italy to Germany taking the name Warburg. In 1798 the family founded the bank of M.M. Warburg & Co.

The 1907 financial panic had been caused by Masonic banker J.P. Morgan, historian Fredrick Lewis Allen concluded in 1949. This was used as pretense to show that there was a need for a central banking system.

Frank Vanderlip, who worked for Rockefeller, admitted in his memoirs: "I do not believe I exaggerate in saying that our secret excursion to Jekyll Island was the actual beginning of that which eventually became the Federal Reserve System."

During the aforementioned Jekyll Island meeting at the end of 1910 Paul Warburg had emphasized that the term "central bank" should be avoided under all circumstances.

It was decided to present the project as a Regional Reserve System.

It was made sure that Morgan's candidate, the Freemason Thomas Woodrow Wilson, was elected president. His campaign was financed by Jacob Schiff, Bernard Baruch, Henry Morgenthau, *New York Times* publisher Adolph Ochs and other powerful Jewish financiers and Freemasons.

The high-ranking Freemason Edward Mandel House, by many historians considered the "actual" president of the United States during Wilson's administration, proposed in his novel *Philip Dru: Administrator* (1912), which was published anonymously, a transition to a progressive income tax and a central bank. These requirements were known from the Illuminati five-point program. House was in favor of forming a world government and adopting the kind of socialism Marx dreamed of. To accomplish this he was willing to use political fraud.

The Federal Reserve bill was presented the night of December 22, 1913, when most of the members of the congressional committee were asleep. That same day the bill hastily was pushed through the House of Representatives and the Senate, President Wilson signed the *Federal Reserve Act* and control over money supply was transferred from Congress to private Masonic bankers. Four times earlier the American people had managed to get rid of a central bank, but not the fifth time.

The *Federal Reserve Act* was hailed as the victory of democracy over the money trusts, which was hardly the case. Paul Warburg immediately began working at the Federal Reserve for a salary substantially less than that he received as a banker. Neither the president, members of Congress nor the secretary of treasury have any authority over the Federal Reserve.

The Federal Reserve System is actually a cartel of 13 large private banks, of which the Bank of New York is the most important.

President Woodrow Wilson allowed the national debt to grow from \$1 billion to \$455 billion. Interest became the third largest post of the federal budget.

The United States borrowed up to \$4 trillion from various private banks in 1992. At the same time the deficit was \$285 billion. In 1991 another 2 million people were registered as poor in the United States. The national debt was slightly less than \$1 trillion in 1980; in 1995 it was \$5 trillion. The 32.9 million Americans who in the year 2002 lived in poverty were 1.3 million more than those of 2000 (31.6 million).

The economist Milton Friedman is convinced that the economic collapse of 1929 took place because the Federal Reserve System refused to buy government bonds, which would have given the banks more cash, and thus it caused the monetary crash, which in turn led to the deep economic crisis.

In the 1810s the Freemasons had been brought into Europe in order to prepare their socialistic revolutions. Particularly bad was the situation on Guernsey in 1815, one of the Channel Islands. Less than half the size of Jersey, it enjoys a mild and humid climate and fertile soil. People had no money to buy things; production stopped and workers went idle. Bankruptcy was near, since taxes to England and interest to the creditors could not be paid, and no new loans were granted. The situation was desperate. People were beginning to leave the island and emigrate to Australia.

In 1815 Guernsey needed a new market hall. There was no money. Then somebody proposed that the island should avail itself of its ancient prerogative and issue its own interest-free money. At first the proposal was turned down, but as they urgently needed 5,000 pounds and only had 1,000 pounds in hand, the Bailiff Daniel de Lisle Brock in 1816 decided to issue 4,000 pounds in one-pound interest-free Guernsey state notes. This was in addition to the current supply of English pounds, which two main banks were circulating on the island already.

Work was begun on the market hall, everything being paid for with this new money. When the hall was finished, customers arrived, and business was better than expected. By 1822 the market hall was paid for. The 4,000 one-

pound notes were destroyed. The first project with the new money was so successful that it was soon followed by others. Next a new road was needed; there was gravel, stone and plenty of labor—but no money to pay for it. In all, the states issued 55,000 pounds' worth of notes, which paid for the rebuilding of the market. A new school was built, then several more, the whole surroundings of the market hall were renewed, and several other public buildings were constructed, as well as widening of the streets. A new harbor was built along with the best new roads in Europe and sewers. The sum was paid for with taxation, and the notes were again destroyed. All these projects provided employment and economic stimulation.

In 1827 de Lisle Brock was able to speak of "the improvements which are the admiration of visitors and which contribute so much to the joy, the health and well-being of the inhabitants". Things had certainly improved since 1815. It is significant that the great depression never troubled Guernsey. There was no unemployment, and the income tax was 10 pence on the pound.

Things got even better. The import of expensive English flour was reduced. The money supply never exceeded 60,000 pounds. Unemployment was practically nonexistent. Guernsey became a prosperous island community. But the Freemasons disliked this paradise, for fear that the idea should spread to other parts of Europe. In that case they would no longer be able to continue their destructive projects.

In 1830 the banks launched a counterattack and began to flood the island with their own notes. The bankers Finkelstein & Co. of London were the first to open an office on the island. There they started their propaganda for "better money", "real money". People believed this hogwash, which resulted in money shortage and loan applications in the banks. De Lisle Brock fought like a lion to save the island's sound economy and high standard of living—but to no avail. The intrigues and undermining work of the Freemasons steered the island economy over to the banks and their exploitation.

The Guernsey example of 1816 to 1837 speaks for itself. We can do without Masonic economy and do much better. But to try to do away with interest is considered the worst possible crime against humanity.

By 1837, 55,000 pounds had been put into circulation by the government for the primary purpose of local projects such as the sea walls, the roads, a new marketplace, a church and a college. These 55,000 pounds more than doubled the money supply, but there was no inflation.

In 1914, while the British restricted their own money supply, Guernsey issued more—another 140,000 pounds over the next four years. By 1958, over 500,000 pounds of interest-free money was in circulation on Guernsey, and still no inflation.

By 1990, there was a total of 6.5 million pounds in circulation, issued interest free. There was no public debt as in the rest of Britain, which was still paying for its war debts. And yet on Guernsey, prosperity was very much evident everywhere.

It was nothing new. In 1793, Liverpool suffered from extreme cash flow problems, and solved this by creating out of nothing by an act of Parliament some 300,000 pounds of non-repayable money, which was used for public works with great benefit to the city and its people. This issue of money by the Liverpool Corporation alleviated the immediate debt crisis.

On June 30, 1934, the London magazine *New Britain* published a statement by the Freemason and former Prime Minister David Lloyd George: "Great Britain is a slave under the international financial powers."

The Masonic bankers during the last 25 years have lent money to the governments of the industrial nations, which find it harder and harder to repay their enormous debt. The private sector has become exactly that much richer. This monetary power has enough money to stop any intransigent politicians. Popularly elected politicians no longer have any means of conducting the policies they wish. They cannot take back their power until the debts

are paid. For every dollar borrowed, the politicians relinquish more power. The developing countries are in much worse situation. They are not even able to pay interest on their loans.

During 1982-1990 the banks of the industrial nations received \$1.345 trillion in interest and annuity from these poor countries.

The Argentine-German economist Silvio Gesell (1862-1930) wished to introduce "free money". Margrit Kennedy relates in her book *Interest and Inflation Free Money* (1988) how adherents to Gesell's theory of a free economy in the 1930s made several attempts with interest-free currency in various countries, including Germany, Switzerland, Spain and the United States. Particularly successful was the model used in the small town of Woergl in the Tirol in Austria. In 1932 the ideas described in Gesell's book *Die natuerliche Wirtschaftsordnung (The Natural Economic Order, 1916)* were introduced.

In August 1932 the town council of Woergl issued their own bank notes, called work certificates, to a value of 32,000 schillings. Backed by an equivalent amount of ordinary schillings in the bank, the town put 12,600 work certificates into circulation. The fee on the use of the money was 1 percent per month or 12 percent per year. This fee had to be paid by the person who had the banknote at the end of the month, in the form of a stamp worth 1 percent of the note glued to its back.

The town paid for wages and building materials with this money. A ski-slope was built; streets were renewed as well as the canal system. They built bridges, improved roads and public services, and paid salaries and for materials with this money, which was accepted by the butcher, the shoemaker, the baker, by everyone.

The small fee made everyone put this money into circulation before using one's "real" money. Within a year 32,000 work certificates had been in circulation 463 times and thus had made possible the exchange of goods and services to value of 14,816,000 schillings. In comparison to the sluggish national currency it circulated eight times as fast. Unemployment was reduced by 25 percent within a year. When, however, 130 communities in Austria began to be interested in adopting this model the Austrian National Bank on September 1, 1933, prohibited the printing of any local currency.

Unemployment returned, prosperity disappeared, and the situation was "normalized", that is, Freemasonized.

#### Economic Slavery

Interest charges are always included in today's prices, which makes all goods and services very expensive and leaves very little money in the wallet. The economic historian John King has pointed out that because of interest, businesses must constantly raise their prices. This is camouflaged as inflation. He recommended abolishing interest as soon as possible, so as to avoid economic catastrophe. Everyone must now help pay interest. It is included in all prices—about 77 percent of rental rates, for instance. Taxes and other fees and imposts add up. Thus we have become slaves of the bankers. All goods would be only half as expensive without interest payments.

According to the Swedish historian Herman Lindqvist, the Freemasons decided in the 1810s that wages should be fixed at the poverty level. Such an attitude shows an enormous contempt for ordinary people. Between the years 1860 and 1910 almost a million Swedes left for America in connection with several years of famine, poverty and difficulties in providing for themselves.

During the Middle Ages conditions were much better than the Masonic myths claim. It has been calculated that a Saxony bricklayer, in addition to free food, made, in today's currency, at least 26,000 marks a month. Craftsmen normally received various benefits in addition to their wages. Despite the high wages, working hours were short, normally eight hours a day, and at work five and a half days a week. Mining journeymen in Saxony only worked six hours a day. Not until 1479 did they put in an extra hour. Often the journeymen enjoyed a free Monday, called "blue Monday", usually without wage reduction. This was terminated in Sweden with the 1669 guild order.

So as not to be confused with noblemen, craftsmen in Freiburg, in Saxony, were advised not to wear gold jewelry and velvet and satin clothes, even though they could well afford all this. The fact that the economy and cultural life flourished was due to the bracteate coins, which were the basis of a system with continuous withdrawal of coins, since they often broke. Withdrawal occurred thrice yearly and also served as taxation. Using old coins was not permitted. No one wanted to hang on to "bad" money, so as not to make a loss, since by exchange of 12 (old) coins one received only nine (new) ones. The economy prospered because the effect of interest-generating money was not present. There was to be no interest charged. For the frail, the old and the sick there were sick houses, and the rich usually provided housing, clothing and free meals for the poor. Wealth was relatively evenly distributed at all levels of society.

All this disappeared when the Masonic bankers took control of the economy. From then on, no one could afford a decent life. To enable people to stand this misery, the lie that things were much worse before is propagated, which is certainly not true.

The current interest system makes it possible for those that already have money to get even richer, while those in need find it increasingly hard to make ends meet. From 1968 to 1982 the national income of West Germany increased by 300 percent, while the interest on the national debt increased by 1,160 percent. In 1982 that interest amounted to 29 billion DM. When interest is abolished, inflation vanishes. Kennedy stressed in her book that the income tax must also be abolished. The government will have to be satisfied with a very low VAT; otherwise the gray economy will grow. As of now interest rates go up when there is not enough money available.

The European Community during the years 1982-88 lost up to 735,000 jobs due to the debt crisis, while the United States lost 1.8 million jobs during the same period.

The Swedish national debt was 1.4 trillion crowns in the fall of 1997, which makes Sweden more debt-ridden than either Brazil or Argentina. Interest on the national debt was 111 billion kronor yearly, which is about 40 billion more than the cost of old-age benefits. Every Swede owed various banks 158,558 crowns each in 1997. Half of Swedish national income goes to pay interest. Twenty-five percent of the export income went to support of the national debt in 1990. The head of the central bank, Bengt Dennis, said: "In the circles where I move, it is expected that Sweden keeps a high interest rate."

In the beginning of the 1990s the bankers Salomon Brothers, which had provided the Swedish government with huge loans, demanded that the Swedish crown be devalued. The government complied.

Argentina went bankrupt in the spring of 2002, having a national debt of \$132 billion. Two Jewish banks (Banco de Patricios and Banco de Mayo) collapsed in 1998 due to the owners' criminal activities. This was a final blow to the national economy.

The Italian national debt in the summer of 2001 was astronomically 2,391,663,000,000,000 lire (\$145,831,500,000), roughly equivalent to 105 percent of the GNP.

The sultanate of Brunei in northern Borneo has free schools and free medical care. There is no tax and no VAT, but the standard of living is very high. Interest rates are very low. The country has enormous amounts of oil and gas, which is exported and has given them large incomes. The sultan, Muda Hassanal Bolkhiah, is one of the richest men in the world. His assets are roughly estimated at \$20 billion.

Norway also has oil and gas, but the politicians do not wish to abolish the income tax and other charges. Prices are horribly high; medical care means long lines.

On May 1, 1998, exactly 222 years after the founding of the order of the Illuminati (222 being a third of 666, which in turn is a third of 1998), the European Central Bank was established, actually a cartel of private banks. All of the people shall be in debt through taxation. The Masonic bankers are thus trying to realize the Knights Templars' ancient idea of creating a European super state



# Psychic/Spiritual Healing

## PSYCHIC/SPIRITUAL HEALING

Psychic-Spiritual healing has been around for thousands of years. It is the oldest form of healing on the globe. It has been lost in its truth in this age and has been diluted in its authenticity by charlatans and con artists wanting to make the “fast buck” off unsuspecting volunteers. Being a practitioner of the healing arts for well over 10 years has led me to participate in many forms of healing and to experience first hand their healing effects. While being in the Philippines I had the wonderful opportunity to visit and participate in the treatment by a “Psychic/Spiritual Healer”. The Philippines is well known for its psychic healers, most of whom have been uncovered and found to be frauds. My Philippine experience had a similar outcome and I would like to explain the practice of many of such “healers”.

First the participants are bathed in spiritual, biblical excerpts from (in this experience) the *Christian Bible*. Many prayers were intoned before the “healer” even stepped through the door to perform her work. This sets the ground work for the healing to be made effective by invoking a Saint to do the work through the “healer” being used as the instrument for it. It is well understood that the person performing the acts of “spiritual surgery” is only the channel or instrument for the energy of the Saint to work through.

At this particular forum, the initial treatment was performed on all those who came. It was called “spiritual injection”. After the initial prayers and reading from the *Bible*, the lady “healer” walked into the small little church-like building and walked to the altar area in what I would consider an already self induced trance. She and her helpers called the people to come up in small groups. When my turn came, I waited in line and then I stood in front of her as she scanned my body by placing a couple of white blank sheets of paper in front of me. She seemed to be able to detect the problem areas of the body through this method as if she was looking with some sort of “astral vision” or her “third eye” to make a diagnosis of the condition. After the scanning she would proceed to put the end of her fingers, mostly the middle and forefinger together and press with a jerking type motion on specific points on the body. This to me was a sort of acupressure but in this case was referred to as “spiritual injection” as if she was injecting a healing energy, like prana, chi, ki, etc., into the points selected. The uncanny part about this is that she did go to the parts of the body I was feeling some tension in at the time, my abdomen. This directness of point selection gave me an open mind to the proceeding events to discern properly the credibility of such “healing”. I was then asked to return to my seat to wait to see if I would be called for “spiritual surgery”.

After all the people in the room received a spiritual scanning and “injection” she would then begin to look around as if peering into the ethers and select a person randomly. They would go to the front, lie down on the table and, if necessary, take off or unbutton their shirt/blouse before beginning. Some would be asked to remove their trousers/slacks depending on the part being “operated on”. This was done behind a sheet to give privacy to the recipient.

Then she would begin to perform “spiritual surgery”. This incorporated the use of cotton balls, small and big being used to catch and soak up the blood coming out of the supposed incisions being made without scalpel or knife of any sort. She allowed the close relatives, friends, etc., to come up, watch and even help by holding the opened *Bible* over the area being worked on. Her helpers would dip little pieces of cotton made into teardrop type shapes in hot coconut oil and pass them to her on command. There is a candle burning on the table with an aromatherapy type plate on top filled with coconut oil to

keep it hot. She would use these pieces of cotton to put onto the area she is working on. Her fingers would be closely held together and moving as if she was typing on a little keyboard or kneading dough. As she would do this, red blood type fluid would roll down the side of the area and at times she would pull from her fingers little pieces of “toxic” material that supposedly came from inside the body.

She showed me a stringy, ropey piece about 3 inches long and told me it was a vein. She would continue to explain at times that there is a problem here, and talk about it in a commanding voice yet in such a general way that there was no detail of the exact nature of the disease or problem. For instance, while she was working on EJ’s knee she said, “knee problem, under the knee cap” or something very similar. And to give you the background, she was told in advance of the nature of EJ’s complaints by a friend of ours before we started. This negates the scanning credibility but in my case I didn’t let any one know what was my issue. So again I was open to the fact she may be the real deal.

After watching her perform on many people before EJ and I, I didn’t see any miracles take place. The people would hobble up to the table and they would hobble back, but most of them received a coconut oil massage on the area of surgery and the back. In my case, because I was tired from the early morning 6-hour drive to get there plus getting over a bad dose of heat stroke, it felt good to just lie down and then get a warm coconut oil massage for 5 minutes.

My experience with the surgery entailed her doing her “kneading dough” on part on my abdomen and in the area of the liver while telling me not to eat foods with preservatives and to wash my vegetables and soak them before cooking to get the chemicals off. Also saying to abstain from chicken because I had a type of allergic reaction to this. This was good advice along with no soft drinks, etc., which I do not drink anyway. The chicken part made me wonder for I have never had any discomfort after eating chicken. She supposedly pulled out a cyst from my abdomen area and said this is from the liver. I could see how all the cotton being used was easily fed into her fingers as they were moving, while being combined with the oil to give it an appearance of different shapes even though it was light red to dark red at times. I saw her reach behind the table, in front of where she stands, but did not exactly see her get any red dye or red powder, which I assume she was doing. She was open about the cotton balls dipped in hot oil being passed, but made statements as to “do you feel the heat” as if it was something mysterious like her fingers were producing the heat. Her helpers stood close by with larger cotton balls to catch the “blood”, holding them close to her fingers. I could see her pulling a little at a time into her hand in which she would form stringy veins to clumps of toxic materials, cysts, etc. This she would hold up, look at it intently and then flick into the wastebasket. I felt like grabbing it or saying can I touch it but I didn’t. At the time I didn’t want to expose any fraud or con.

After she instructed me on what kind of food to eat she gave me a bag of raw herbs to make a tea out of and drink 3 times a day with meals. There is also a list of what to do for all who experience spiritual injection and spiritual surgery, which is as follows:

For those who experience spiritual injection only, for a period of 24 hrs;

1. Do not take a bath or shower, sponge only with hot water.
2. Abstain from alcohol and anything cold or sour.

For those who received spiritual surgery for a period of 5 days;

1. Do not take a bath or shower, sponge only with hot water.
2. Abstain from alcohol, red meat, fruits, chicken,

by means of the banking system.

The Danish “no” to the “euro” at a referendum in September 2000 and the Swedish “no” in September 2003 showed, however, that not everything goes as planned. One does not have to be a prophet to see that the euro does not stabilize the economy, though one must not say it out aloud. Bernard Connolly, who was head of the department of currency policy at the European Commission in Brussels, in 1996 published a book, *The Rotten Heart of Europe*, claiming that fixed exchange rates and the monetary union (EMU) would lead to instability and growing unemployment. He felt the result would be horrifying. Connolly was summarily fired.

At a visit to Sweden in August 2003, Connolly stressed that the introduction of the euro would lead to economic disaster and to the fall of the European democracies. He warned that the euro is used as a pretext for forming an economic, political and military super state.

The problems have become worse in southern Europe. Portugal for instance is already at the brink of a political breakdown, and riots in the streets are not far away. This will then spread to the rest of Europe. He compared the situation to the economic collapse in Argentina, but the EMU countries are worse off. Argentina was able to cut its connection to the dollar, but EMU countries cannot abandon the euro.

One meter was one meter in 1910, just as now. A liter is a liter, but a Swedish krona of 2004 is no longer worth the same as in 1910. Its value has sharply declined. Is that not strange?

Swedish and U.S. official statistics state that in the year 2000, roughly 140 percent of the average working man’s income went to necessities such as food, living, clothing, education medical care, as compared to 75 percent in the early 1970s. Today it is barely enough for both parents to work to make ends meet.

In the 1970s the total value of the world trade of industrial goods was 50 percent, the rest was in stocks and shares. In the year 2001 the relation was 1 percent goods and 99 percent with securities. Speculation dominates.

The current monetary system encourages fraud and extension of the gray economy and has led to the fact that those who constantly are in need of money lose more and more to those who have far more than they need. More and more money is collected in the hands of certain individuals, who happen to be Masonic bankers. If interest is abolished, everyone benefits from the new system, not only the 80 percent considered poor.

Alfred Herrhausen, member of the board of Deutsche Bank, has pointed out: “Those responsible for the current monetary system, know very well that it cannot last, but they do not know any alternative or do not want to know of any.”

To the Freemasons it is important to keep us in economic slavery; otherwise they would have done everything to abolish interest. Through taxes and duty the government owns most of the result of the economic activities of the people. What are then the Freemasons’ beautiful phrases of humanism really worth? The Masonic leaders’ foremost goal has been to conceal as best as they can the current economic slavery. One must ask oneself if they have been successful.

anything cold or sour.

3. Do not lift heavy objects.
4. Refrain from sexual activity for 36 days.
5. Massage your operation with blessed coconut oil morning and evening.
6. Have a warm bath on the 6<sup>th</sup> day, pray and thank God for the blessing.

So my conclusion to the whole experience is one of half con/half healing. What I mean is that those who believe in her will get “some” help. Faith does a lot of good and the mind will put into operation what it believes. “It is done unto you according to your belief” as the Christed teacher taught. Therefore what I see are people reaching out for some last vestige of hope and with their belief in the supposed healer they get it according to the extent of their faith. But again, no real miracles were observable and therefore there is also a need for some “real” physical action to be used at times. This is where the diet counsel and herbs comes in along with the set of rules to follow which keeps one’s mind focused on the healing of their body. The mind is the tool for initiating healing to begin and my perspective is that this truth is exploited in her practice of “healing”. She doesn’t charge for the injection or surgery. There is a donation box which everyone is aware of, though, and in the rules there is the requirement to massage with “blessed” coconut oil. This can be conveniently purchased at the connected store right beside the “healing chapel” for 100 pesos, which is close to \$2 U.S. That is no bargain so money is definitely a part of the “spiritual work” being done.

In my perception, when there is real spiritual activity being expressed for the welfare of our fellow man, cost is kept at a minimum and there is no requirement of purchasing anything to ensure success. On the outside of the building was written something like “Spiritual Christian...” with an Inc. at the end. On the next line was something saying an affiliation with an already established business of sorts and her being a member of that. (These were not in English.) This certainly made my head ponder a few things.

True healing isn’t franchised, at least this type of healing. And by the way, the tension in my abdomen area wasn’t reconciled, to put in nicely, and this doesn’t mean I didn’t believe enough in the Saint working through her. I certainly did pray to God and ask for help and had a totally open mind to the possibility of being relieved. I stayed open to possibilities yet always with a discerning and discriminating mind. One lesson we all must learn is to always discern the truth from the lie.

So all in all, it was a very eventful experience and one I am grateful for the opportunity to have. In each person is an ability to heal self which is God given. This natural healing ability is one that can be initiated by an outside source to facilitate the healing action. Scams, cons and frauds abound as a very lucrative business in the Philippines and must be kept in mind whenever there is an opportunity that seems too good to be true. May logic and reason be your guide with an ever-powerful presence of conscience and intuition.

## CHINA'S TRIPLING GOLD DEMAND

Maybe if Nauru, one of the world's smallest nations at 8.5 square miles and 13,000 citizens, tripled its gold demand, nobody would notice.

But China is a whole different story. Here's a nation with 1.2 billion people. When analysts announce its gold demand is set to triple, that's big news.

Where are these dramatic forecasts coming from? The World Gold Council recently predicted "a rise in demand for gold in China from the current 200 tons to an annual 600 tons over the next few years".

A loosening of China's iron grip on the nation's gold market is what's driving this demand. The *Associated Press* reported on Sept. 7 that "China's gold-crazed masses will now be allowed to trade in the precious metal under reforms that will upgrade trading on the country's emerging market."

The *AP* report went on to say, "Trading in gold will provide another choice for individual investors who keep their money stashed in bank accounts due to a lack of desirable investment options."

Bored Chinese savers ... now big-time gold investors?

How much of this stashed Chinese money are we talking about? According to China's central bank governor, Zhou Xiaochuan, 1.2 trillion yuan (\$145 billion) is piling up dust in the nation's savings accounts.

...So what made China lift the "golden curtain"?

Probably not out the goodness of its still communistic heart. Over the past few years, as the dollar—the currency China is so utterly dependent on—sunk to new lows, the Chinese government has quietly scrambled to increase its paltry reserves of gold.

Contrast this: China's foreign exchange reserves currently amount to a whopping \$144 billion—the largest dollar reserve in the world—yet its gold reserves are at a miniscule 3 percent of that.

The United States maintains the example of what a "prudent" gold reserve should be. At a purported 262 million ounces, our gold reserve represents about an ounce per citizen. But for the Chinese government to attain anywhere near that lofty per-capita standard, it would have to acquire at least a billion ounces of gold, something that could theoretically take 14 years of the planet's entire production of the precious metal. Needless to say, this just isn't realistic. And the economic and political consequences of even attempting to do so—and of officially throwing in the towel on the dollar in the process—could herald a global depression of nightmarish dimensions.

Give China credit for being subtler than that. If, instead of making a higher gold reserve official state policy, China liberalized its gold acquisition and ownership laws so that its citizens could load up on the

precious metal, the government would have access to a large, latent gold reserve, yet not officially undermine the dollar.

This is apparently what's happening now, and China's state-run newspaper isn't bashful about saying so. "Encouraging civilian reserves of gold has strategic significance and economic value. In case of an economic crisis, the state could buy gold from residents and use it to pay back foreign debt," China's *Financial News* quietly reported recently.

Notwithstanding the implied threat of a totalitarian government one day confiscating privately held gold at bargain basement prices (or at no price at all), the Chinese people are still expected to stockpile gold at an unprecedented rate.

...So what happens if a big chunk of that \$145 billion in Chinese savings gets invested in gold?

While it may be hard to hazard any kind of accurate guess, it's safe to say gold would be heading higher. A lot higher. And that would be regardless of whatever gold purchases the U.S. and other nations made.

But China isn't the only nation liberalizing gold sales.

In India, consumer demand has been averaging a stunning 31 percent annual growth. Eleven years before China did, India deregulated their gold trade and, since then, private gold ownership has soared in popularity (not that the precious metal didn't already have powerful cultural and religious significance to the Hindus).

Throw in the increasingly popular Islamic Dinar, the 100 percent gold currency hoped to one day be the money for a billion Muslims, and you start to see the kind of global demand shaping up for gold.

## KAZAKHSTAN TO GAIN ACCESS TO WORLD HYDROCARBON MARKETS BYPASSING RUSSIA

*RIA Novosti*, 9/29/04

ASTANA—Kazakhstan and China are holding a tender among banks to credit the construction of an Atasu (Kazakhstan) - Alashankou (China) oil pipeline, Kazakhstan's Energy and Mineral Resources Minister Vladimir Shkolnik said.

...He said the project would cost \$700 million and would be equally financed by the "Kazakh and Chinese sides", with the "Chinese side acting as the underwriter".

According to Shkolnik, "Kazakhstan's contractors will do 70 per cent of the construction, and China's, 30 per cent." "The pipeline will increase Kazakhstan's transit attractiveness, since Russian oil, too, is expected to be shipped to China," he noted.

*[Sino-Russian trade is now denominated primarily in the Chinese national currency, the yuan, so once again the U.S. dollar finds itself set aside as the "currency of choice" in international dealings.]*

Russia's Energy and Industry Minister Viktor Khristenko had earlier said that Russia's use of the Kazakhstan-China pipeline "will largely depend on the conditions of its exploitation".

...Under the project, the pipeline will be laid from the oil-pumping station of Atasu in the Karaganda region to railway station Alashankou in China. According to preliminary technical and economic characteristics, it will

be 988 kilometres long and have a pipe diameter of 813 millimeters. Its throughput capacity in the initial stage will be 10 million tons a year, and at the second stage, up to 20 million tons. The pipeline is expected to be finished in mid-December of 2005 and go online in 2006.

With the pipeline on stream, the Chinese side will be receiving oil from the Caspian region of Kazakhstan.

## CHINA'S PREMIER TO ARRIVE IN MOSCOW

*RIA Novosti*, 9/23/04

MOSCOW/BEIJING—Wen Jiabao, Premier of the PRC (People's Republic of China) State Council, is to arrive on an official visit here today.

According to the Chinese Foreign Ministry, this is Wen Jiabao's first Russian visit since his appointment to the post of PRC State Council Premier in March 2003. Moreover, his trip will serve as an important stage of preparations for the Russian-Chinese summit, slotted for mid-October in Beijing.

...Russia and China will attach priority to fuel-and-energy cooperation, as well as trade-and-economic, investment, science-and-technological and humanitarian interaction, during their talks in the Russian capital.

Both sides will also focus on their international cooperation, as well as **joint anti-terrorist operations** [*emphasis added*] the Chinese Foreign Ministry's officials said.

...Talking to *RIA Novosti*, the Russian Foreign Ministry's official spokesman Alexander Yakovenko noted that Russian-Chinese cooperation was mostly developing rather successfully over the last several years. The 2003 bilateral trade turnover stood at \$15.76 billion throughout the 2003 period, soaring by 32.1 percent on 2002 levels. The Russian-Chinese trade turnover reached the \$9.45-billion mark over the January-June 2004 period, skyrocketing by 39.1 percent on similar 2003 levels.

...Experts estimate Chinese investment on Russian territory at more than \$1 billion, with China getting \$800 million worth of Russian investment. Khabarovsk hosted the first-ever Russian-Chinese investment forum this past June, with the concerned parties charting 12 major investment projects with Chinese capital to the tune of \$700 million. Joint Russian-Chinese construction projects worth approximately \$300 million are now being implemented in Moscow. Similar construction projects worth \$1 billion were launched in St. Petersburg.

## PUTIN SLAMS NATO-LED FORCES ON AFGHAN DRUG TRADE

MOSCOW—Russian President Vladimir Putin on Thursday accused foreign forces in Afghanistan of letting the drugs trade run out of control—one week after the United States itself rebuked Afghanistan for the booming business.

"They're doing almost nothing, not even just to



reduce the drugs problem,” *Interfax* news agency quoted Putin as telling Viktor Cherkesov, head of Russia’s drugs control agency.

...International peacekeepers, now under NATO leadership, have been in Afghanistan since the U.S.-led invasion of late 2001.

...“They should get more involved and not just watch as caravans roam all over Afghanistan, then through the (former Soviet Union) to the West,” Putin said.

...Last month Russian troops seized one tonne of Afghan heroin. But the United Nations says many times that amount hit Europe’s streets last year—90 percent from Afghanistan.

#### RUSSIA FILES NEW CHARGES AGAINST BEREZOVSKY, ISSUES ARREST WARRANT

*AFP, 9/23/04*

Russia has filed fresh charges against exiled tycoon Boris Berezovsky and issued an international warrant for his arrest, a top legal official said.

“Following the appeal of the prosecutor’s office for the Moscow region, the court has sanctioned B. Berezovsky’s arrest,” Moscow Region Prosecutor Ivan Sydoruk told Russian media.

He said new charges of massive fraud and abuse of office had been filed against Berezovsky in connection with a purchase of a 14-hectare plot of state-owned land that was privatized in the 1990s.

Sydoruk also said an international warrant had been issued for Berezovsky over the new charges and described the magnate, who was **granted asylum in Britain** [*emphasis added*] where he now lives, as “hiding from justice outside Russia.”

Berezovsky quickly rejected the new charges.

“Everything connected with the sale of this plot by the state to me as a private individual was an absolutely legal act,” Berezovsky said in an interview with Echo Moscow radio station.

He said regulations under which the land purchase was made were approved by former president Boris Yeltsin and argued that questioning that purchase now amounted to questioning the status and authority of the Russian president.

A spokesman for Berezovsky called the levelling of new charges “sheer nonsense” and a politically-motivated response by President Vladimir Putin to the tycoon’s funding of “various controversial things” in Russia.

Alex Goldfarb [*Who?*], executive director of the New York-based Foundation for Civil Liberties, said the foundation spent about 25 million dollars in the past four years supporting various groups including those opposed to the war in Chechnya.

He told *AFP* that the foundation also provided most of the legal defense funds for Akhmed Zakayev, a leading Chechen separatist who was granted asylum in Britain but who is wanted by Russia in connection with acts of terrorism.

“All this taken together makes Putin believe that

there is a conspiracy behind recent negative press that he has gotten in the western media,” Goldfarb said.

...Berezovsky, a billionaire who made his fortune through shadowy deals in Russia in the 1990s, was already wanted by Russian authorities on fraud charges.

All-round business, cultural and humanitarian contacts are making progress. Uniting our two countries are shared stances on essential global developments and a desire to give a joint rebuff to the latest threats and challenges, and come at the best possible solution of key contemporary issues.

“As the world has come against atrocious manifestations of international terrorism, we Russians see Germany as a reliable ally in combat against that evil—an ally who is, just as Russia, working to build up efforts for stronger security in Europe and the entire world.

“A fruitful dialogue and mutually lucrative partnership of our two countries will carry on their dynamic progress to the benefit of the Russian and German nations. Of that, I am convinced.”

#### VANUNU TELLS AUSTRALIAN RADIO: ISRAELI NUKES UNJUSTIFIED

ADELAIDE, Australia—Convicted nuclear whistleblower Mordechai Vanunu told an Australian radio station by phone that Israel has “no reasonable justification” for producing nukes and should focus on improving its relations with its Arab neighbors instead.

Vanunu was released from jail this April after serving an 18-year sentence for treason. The interview with Radio Adelaide is an apparent violation of his terms of release, which forbid him from speaking with foreign press.

...“My revelation about Israel’s nuclear secrets revealed to the world that... they made a big, big mistake,” Vanunu said in the interview Thursday.

“They produce a lot of atomic bombs and hydrogen bomb... they had no reasonable justification. They should realize that... they lost in this war of nuclear secrets and they should admit to the world they went in the wrong direction and go for real peace with the Arabs in the Middle East,” he said.

...He wants to revoke his Israeli citizenship, but must first find a country that will offer him a passport. He said he has approached Ireland, Norway, England, Canada, Denmark and his native Morocco seeking citizenship or asylum, but has not yet received a positive

answer.

#### SYRIA, AT UN

#### SAYS ISRAEL BEHIND U.S. WAR ON IRAQ

UNITED NATIONS—Syria on Monday accused Israel of inciting the United States to invade Iraq to distract attention from its own actions in the region, where it retains its grip on the Palestinian territories won in a 1967 war.

Syrian Foreign Minister Farouq al-Shara used his country’s annual address to the U.N. General Assembly opening debate to deliver a fierce critique of Israeli policy, as the Jewish state accused Damascus of “directing terrorism” and threatened preemptive strikes against militants on its territory.

Shara accused Israel of refusing to comply with 40 Security Council resolutions and hundreds of General Assembly resolutions demanding that Israel withdraw from the Palestinian territories as a step toward a Middle East peace. Washington had used Baghdad’s noncompliance with U.N. resolutions as one of its rationales for the March 2003 invasion of Iraq.

Instead, Shara said, Israel had built up a nuclear arsenal, expanded Jewish settlements on Palestinian lands, built a “racist segregation wall”, which Israel says is intended to keep out suicide bombers, transformed its army into “armed gangs bent on systematic killings and war crimes” and shunned the peace process, “despite the hand extended in peace by the Palestinians, Syrians and Lebanese.”

...The United Nations had been of little help in resolving the Arab-Israeli conflict, which was as old as the world body itself, Shara said. [*Emphasis added:*]

**Despite the adoption of over 600 resolutions on the subject, Israel “did not implement a single one of them, and continues to find protection inside and outside the United Nations,” he said.**

# Lawful Avoidance Of Key IRS Designations

**Budget's "Tip of the Week" #8:**

**Avoiding the IRS Designations of:**

**"Personal Service Corporation", "Personal Holding Company" and "Controlled Group"**

The tax advantages of properly operated Nevada corporate shelters may be secondary to the benefits of liability protection, asset protection and privacy but they are worth discussing all the same, especially since many tax professionals don't seem to "get it".

The IRS will tag a corporation as a "Personal Holding Company" and assess a surcharge of 39.6% on undistributed earnings in cases where more than 60% of the corporation's income is derived from "passive" sources such as dividends, interest and rental income. The IRS applies a designation of "Personal Services Corporation", assessing all income at a flat rate of 35%, in cases where a C corporation is engaged in the performance of personal services (consulting-type work) and where such services are performed by employee-owners. Yet another IRS designation is that of "Controlled Group", based on complicated rules for determining allowable cross-ownership of corporations, whereby the IRS seeks to lump all of the income into a single, consolidated return—resulting in the highest possible tax rate, of course.

Each of these designations is based on the corporation's OWNERSHIP. How very fortunate, then, that ownership of Nevada corporations is statutorily permitted to be very PRIVATE: It is not a matter of public record, only of the protected (by *NRS 78.257*) internal records of the corporation.

To be considered a "Personal Holding Company" a corporation must be owned by five or fewer stockholders. It is totally permissible for a corporation to earn 100% of its income from passive sources, as long as it is owned by six or more stockholders. It is similarly easy to avoid the designation of "Personal Services Corporation": Don't own the stock! "Controlled Group" status is also very easily avoided with Nevada corporations: Simply ensure that no entity owns 80% or more of any other entity and that in brother-sister corporate relationships there are six or more stockholders. As no liability is attached to stock ownership, surely you could find a trustworthy friend or six who wouldn't mind holding stock in the corporation? If not, give us a call—we know of hundreds of corporations in similar circumstances.

With regard to "Controlled Group" status, the IRS has from time to time invoked *Section 482* of the *Infernal Revenue Code*, which lumps together income from corporations if they APPEAR to act out of a unity of interest. To our knowledge, however, even this blanketing regulation is relatively easily overcome, as long as the corporations act in their own, separate, well-documented self-interest.

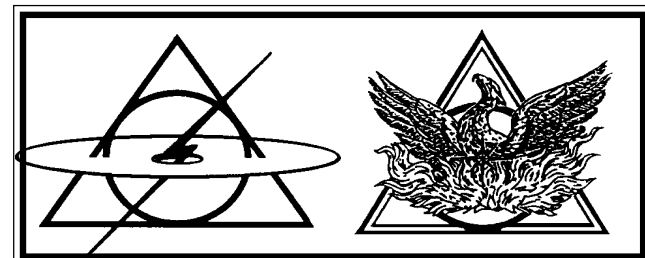
