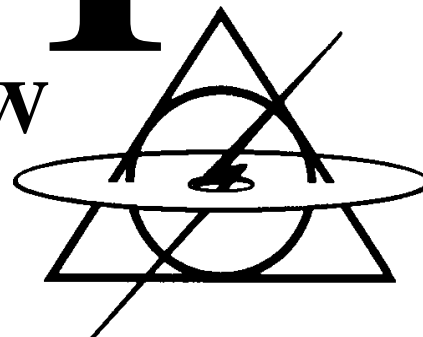

Earthquake Swarms As Planet Awakens

It has been more than TWO MONTHS since the frightening events of December 26 and things are NOT slowing down geophysically. On February 28, 2005 USGS reported a series of earthquakes off the west coast of Vancouver Island, northwest of Seattle: 4.9, 4.5, 4.8 and 4.8 Richter-magnitude quakes in quick succession, followed by a 4.9 on March 1 and a 4.7 on March 6. As revealed in the following article, these relatively large REPORTED events are only part of the picture.

SEAFLOOR EARTHQUAKES SIGNAL ERUPTION OFF VANCOUVER ISLAND

Mount St. Helens may not be the only Northwest volcano spitting out lava these days.

A scientific SWAT team from Seattle is sailing this afternoon for a spot off the coast of Vancouver Island, where they suspect an underwater eruption is under way.

“We really don’t know what to expect,” said Edward Baker, an oceanographer at the Pacific Marine Environmental Laboratory, which is part of the National Oceanic and Atmospheric Administration (NOAA). “If we’re very lucky, we may get pictures of brand-new lava on the seafloor.”

Their observations will help improve understanding of the Juan de Fuca plate, a tectonic time bomb capable of producing earthquakes and tsunamis on par with the disaster that struck the Indian Ocean in December.

Baker is co-leader of the 20-person team, which has been scrambling since Sunday, when swarms of earthquakes started rattling the ocean bottom 200 miles offshore. In the past six days, the

area has been rocked by nearly 4,000 temblors, most tiny, but some exceeding magnitude 4.

“It has been going on long enough that we’re pretty sure lava is moving,” Baker said.

The researchers keep scientific instruments packed and ready to go so they can act quickly when an underwater eruption starts. This time, they were especially lucky because the University of Washington had a research vessel docked at Portage Bay, between assignments.

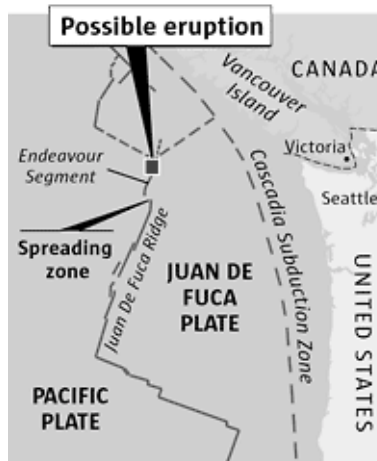
Team members from Hawaii, Oregon, Canada and Massachusetts canceled lectures and family gatherings to make the weeklong cruise, funded by the National Science Foundation and NOAA.

“We know so little about what goes on when these volcanoes erupt,” said Joe Resing, an ocean chemist at the marine laboratory. “Opportunities like this are

very rare.”

The rapid-response team, which has raced to seven underwater eruptions over the past 10 years, is the only one of its kind.

Among their main tools is a network of Navy hydrophones originally used to monitor enemy submarines. The sensitive instruments can detect underwater earthquakes that are too faint and far away to be picked up by land-based seismographs.

...The sensors located the shaking on the Juan de Fuca Ridge, where fresh oceanic crust forms as tectonic plates pull apart and magma wells up from deep within the earth. This seafloor spreading is slowly forcing the Juan de Fuca plate under the North American plate, creating a subduction zone that has unleashed massive earthquakes in the past.

An eruption along the ridge doesn't directly raise the risk of an earthquake on the subduction zone, Baker said. But the regions are closely linked, like pieces in a puzzle. [Ed: *And eruptions are clear evidence of built-up pressures.*]

“It's the same plate movements which cause the earthquakes on the spreading ridge and allow new magma to come up that also cause the subduction earthquakes on the other side of the Juan de Fuca plate,” he said. “They're both expressions of the Juan de Fuca plate movement, and everything we can learn about how that movement is expressed will give us a better insight into the whole package.”

To try to figure out what's going on nearly two miles below the sea surface, the scientists will lower instruments into the water to collect samples and measure temperature, salinity and the chemicals and particles given off by underwater eruptions.

“It's sort of like drilling holes all over the Earth's crust to look for oil,” Baker said. “We're going to be drilling holes in the water to look for evidence of hot fluids.”

Though underwater volcanoes are little more than cracks in the crust, they produce the same plumes of gas as land-based volcanoes like Mount St. Helen's, Baker said.

“If there's a big eruption, it's very obvious in the water.”

The team will also lower a camera-equipped sled to the ocean floor, hoping for a glimpse of lava.

If they see it, it may still be warm—but it won't be molten, said Resing, who as a graduate student used to scuba dive during Hawaiian eruptions, to study what happened to lava when it hit the water. “It just cools instantaneously,” he said.

It's also possible that magma is moving underground, but hasn't breached the surface yet, Baker said.

In that case, the pictures will at least reveal how much the volcanic unrest has rearranged the seafloor and affected marine life in the area, which researchers have mapped in the past.

The shaking is near the well-studied Endeavour hydrothermal vent field, populated by giant tube worms, clams and other creatures that live in scalding hot, acidic water—and it's possible the effects might have been felt there.

“Some of the greatest, most rapid changes that occur in these ecosystems are during eruptions,” Baker said. “These are catastrophic events on the seafloor.”

The USGS has not reported a single large event

off the Oregon coast, yet AP reports the southern portion of the Cascadia Subduction Zone is also swarming with earthquakes.

QUAKE SWARM OFF OREGON COAST IS STUDIED

NEWPORT, Ore.—An earthquake “swarm” that began last weekend has resulted in thousands of small earthquakes off the Oregon coast in recent days but the size of the quakes did not pose any tsunami threat, officials said.

Scientists from Oregon State University said they are joining National Oceanic and Atmospheric Administration researchers on Saturday for a cruise to investigate a site on the undersea Juan de Fuca Ridge northwest of Astoria called the Endeavor segment.

“These earthquake swarms are associated with seafloor spreading,” said Robert P. Dziak, an Oregon State oceanographer who works with NOAA at the university's Hatfield Marine Science Center in Newport.

“We suspect what happened was that magma pushed up into the crust and the lava may have broken the surface,” Dziak said.

The quakes are generally small and not a tsunami threat, although a section of the sea floor off the Northwest coast called **the Cascadia subduction zone is similar to the Indian Ocean area** that produced a magnitude 9 quake and tsunami that devastated southeast Asia last December.

The much smaller quakes off the Northwest coast generally ranged from magnitude 2 to magnitude 4 and typically occur in swarms during seafloor spreading events, scientists said.

During the first 36 hours of the swarm, nearly 1,500 small quakes were detected. The undersea quake activity was continuing at a “moderate pace”, Dziak said.

At the other end of the North American continent, 5.1R and 5.4R quakes were reported on the Gaspé Peninsula March 6, 2005 by the USGS, showing just how interconnected everything really is.

In the last issue we noted that certain large-magnitude events were simply going unreported by the USGS. We now have some confirmation of that fact from Australian geophysicist Harry Mason.

NEW HIGH-ENERGY QUAKE CLUSTER IN OZ/SE ASIAN REGION

This morning our radio news in Perth reported a strong 7.1 richter earthquake from the area north of Darwin (see Banda Sea event data below).

Currently we have no reports of a significant Tsunamis event linked with this seismic event.

This Banda Sea event is along the same Australian plate boundary fault as the deadly Boxing Day Aceh 9.3 richter quake-tsunamis event. It proves that the area of the Andaman-Nicobar-Sumatra Arc and the associated edges of the Australian plate are still highly unstable—over a very large region.

This may be a developing stress scenario and as a

consequence it remains a VERY dangerous region.

It would appear that a cluster of MULTIPLE earthquakes initiated between 10.40 and 10.44 GMT/UTC time today (03-02-2005) over a very large area around and within Australia and SE Asia—BUT see below for discussion of veracity of this computer generated data.

The European-Mediterranean Seismic Centre (EMSC) has recorded seismic signals from multiple receiver sites that have allowed them to generate computer designated quake info as follows:

The info is preliminary and the EMSC have not yet posted it on their World map, neither have the U.S. IRIS site logged it on their map.

The spread of locations might NOT be real and might purely reflect the error ring for computer developed epicentres from ONE quake in the Banda Sea (however I find it an abnormally large error ring). Geo-physicists to examine the raw data and deliberate on the cluster locations AND an accumulation of collaborating “felt reports” BEFORE we can accept this data as real world. Currently only the Banda Sea quake is definitely real ???

For instance the 6.9-7.1 mB (richter) event at 10.41:21.41 on 02-03-2005 (Lat -19.46S and Long 140.69E at a depth of 30km) is apparently located NE of Mt Isa and onshore within Queensland in an isolated area of several gold-copper mines. The area is not normally a quake prone zone. At this time I have no local “felt reports” and thus this quake event must be considered theoretical or spurious. Also the quakes reported from south of SE Australia have not yet been given “felt reports” and thus MAY be erroneous.

But some 36 individual seismometer Rx sites recorded the data for the NE Mt Isa quake and contributed to the EMSC estimate of its location. It should therefore have a HIGH chance of being real.

Also the other reported quakes vary from the Mindanao trench (Philippines) to south of Victoria-NSW (Australia) and this is much too large an error ring for normal computer generated epi-centers. Instead of seeing them as foreigners, we need to treat them and interact with them as we would new children into our family, new relatives that have come from a far place to be with us to eat at the table of wisdom. There was a lot of talk, also, about language and how we must maintain our languages, our rituals and our ceremonies. We must do that, that’s true. That is for the preservation of the culture, but we don’t have to sell or prostitute those things. What we need to do is share the power of how we have survived.

The power of how we have survived is in two phases. The first part is an awareness that everything is sacred, period. Everything we can imagine, everything we have ever thought of, everything we have ever been told exists or even the possibility that it exists, is sacred. Everything, every conceivable object, act, or thought has a purpose and a reason for being in the circle of creation and is connected and related. Until we can accept that, we will continue to be separated, alienated and unwitting participants in the destruction of the earth. Power isn’t a matter of wearing certain clothes or participating in certain ceremonies, those are cultural things. Power is about recognizing our sacredness and the sacredness of everything within the universe, as far out as we can remember. Everything is sacred. Everything is part of the creation. That concept seems to be difficult for many people to grasp, and based on how they act and what they say, not many people believe it.

It is no wonder, then, that we are concerned about the earth, that we died heartbroken because our land was taken and that we still die today when our sacred places are covered by the wheels of progress and the needs of the few.

All things come from the mother earth. Everything we eat and wear, our homes, steel for our automobiles, ore, our raw materials, all come from the mother earth. Everything we send into space—and that eventually falls back onto the ground—comes from the mother earth. All the volcanic ash that blows up comes from the core of the mother earth. The water comes from beneath the ground—the mother earth. The mother earth is what gives life to us all. If we do not respect the earth, if we do not see ways in which to have modernization and technology without destroying the earth, then we will not have much left and things such as water, clean air and food will become scarce. In its cycle of purification the mother earth will extract its power, pulling from it those things which we need to exist. At that time, power will become real to us because it will be your power and my power that it extracted. Everything is connected and related and the earth's power is our power. We are killing ourselves by allowing things to continue as they are.

We need to listen, our children need to listen, that's what power is about. Mothers need to retake control of the family, to take control of what is taught and shared. The best lesson we can teach our children is that their power comes from the earth. We who are life givers—which is all of us—need to reflect upon our willingness to accept our connection to the earth. If we cannot believe in our connection to the earth, what is left? We who are as sacred as the earth, the stars, the moon, the Creator, the Mother-Father, we who are the beings here on earth representing the two legged, if we cannot see our sacredness and our connectedness to the earth, what hope is there? It won't do any good to be in church on Sunday, Saturday, or Friday. It won't do any good to be at some seminar, sitting in front of the TV or reading some book intellectualizing the possibility of our spirituality. We are already as spiritual as we are going to get. What we seek, we already are, we just need to recognize our connection to the earth and the sacredness of all things.

Power is established and based upon our needs, just as God or whatever God represents to us, is based upon our needs as human beings, as two legged. When you read about Indian power, forget the magical mystical things that have been written, the romanticized things that have been said. It really just boils down to this, everything is related, everything is connected, everything is sacred. It has been said over and over again but nobody pays any attention to it. Instead, people are looking for some magical ceremony, some mystical stuff to wear, something to hang around their necks or put on their backs. You don't need any of that, those things are for the people of that culture. All you need to know is that you are sacred and that you are connected and related to all things, and then act accordingly.

I am frequently asked by people how they can find

out about their Indian ancestry. Why do people need to believe that someone in their past may have had Indian blood? Why aren't we satisfied with simply being human beings? One day it will not matter if we are 1/72nd, 1/82nd, 1/13th, 1/12th, 1/2, 3/4ths or a full blood. It will not matter because we are, have always been, and will be for infinity, human beings. We will be man-woman, woman-man, sometimes both at the same time. We will be black, white, yellow and red, poor and rich, happy and sad. We will be all of those things. We have been in the past and we will be again.

Mr. Collins Piper obviously recognizes the truth expressed in CONTACT's masthead: "Not to oppose error is to approve it; Not to defend truth is to suppress it."

"If it were not for the strong support of the Jewish community for this war with Iraq, we would not be doing this. The leaders of the Jewish community are influential enough that they could change the direction of where this is going, and I think they should."—U.S. Congressman Jim Moran (Democrat of Virginia) speaking at a public forum in his congressional district.

Despite the very public frenzy in the United States that followed these remarks by liberal Congressman Jim Moran, even the influential New York-based Jewish newspaper, *Forward*, was forced to admit in its Feb. 28, 2003 issue that the role of the pro-Israel lobby and its adherents who held high-level policy-making positions in the administration of President George W. Bush were increasingly becoming a topic of public discussion. Congressman Moran had simply summarized the issue in a few short but controversial remarks.

Forward cited liberal American Jewish columnist Michael Kinsley who wrote on Oct. 24, 2002 that Israel's central role in the American debate over possible war with Iraq was "the proverbial elephant in the room". Of that elephant, Kinsley added: "Everybody sees it, no one mentions it." *Forward* stated it flatly: "Kinsley was referring to a debate, once only whispered in back rooms but lately splashed in bold characters across the mainstream media, over Jewish and Israeli influence in shaping American foreign policy."

The Jewish newspaper noted that now, even "mainstream" American publications, ranging from *The Washington Post* to *The Economist* and even broadcast outlets such as CNN and MSNBC were featuring frank and open discussion of the topic. According to *Forward's* assessment:

Many of these articles project an image of President Bush and Prime Minister Sharon working in tandem to promote war against Iraq. Several of them described an administration packed with conservatives motivated primarily, if not solely, by a dedication to defending Israel.

A few respected voices have even touched openly on the role of American Jewish organizations in the equation, suggesting a significant shift to the right on Middle East issues and an intense loyalty to Sharon. Still others raise the notion of Jewish and Israeli influence only to attack it as anti-Semitism.

Yet, as if in confirmation of the basic thrust behind Congressman Moran's comments, even Ari Shavit, writing on April 9, 2003 in *Ha'aretz*, the Israeli newspaper, declared simply: "The war in Iraq was

conceived by 25 neo-conservative intellectuals, most of them Jewish, who are pushing President Bush to change the course of history."

In fact, as we will demonstrate, the historical record indicates—beyond question—that the then-impending war on Iraq was indeed largely the product of a long-standing—and carefully calculated and orchestrated—plan. That this plan aimed to establish an American global hegemony based upon the geopolitical aims of a small, but influential, group of policy makers inside the administration of President George W. Bush—a group tied intimately, for nearly a quarter of a century, to the grand design of a "Greater Israel", a longtime dream of the Zionist pioneers who founded the state of Israel and whose modern-day hawkish "right wing" followers are increasingly influential in all areas of Israeli society, particularly in the government realm.

This select group of Americans—now increasingly well known—describe themselves as the "neo-conservatives". They constitute a virtual "War Party" in America. They are unabashedly admiring and supportive of the hard-line Likud bloc in Israel led by Ariel Sharon. These neo-conservatives have directed policy decisions inside the Bush administration that have essentially placed the United States of America (under President George W. But it is important to recognize that, in many respects, the policies that the neo-conservative "War Party" has been advancing are, from a historical standpoint, much at variance with the traditional American outlook. The policies of the "War Party" represent only a miniscule—albeit forceful and influential—faction in America. Philip Golub, a journalist and lecturer at the University of Paris VIII, has written of the neo-conservative strategy:

The neo-conservative right has been attempting, with varying success, to establish itself as the dominant ideological force in the United States for more than 25 years, especially in the definition of foreign policy.

Long thwarted by democratic process and public resistance to the national security state, it is now on the brink of success, thanks to George Bush's disputed electoral victory in 2000, and to 11 September 2001, which transformed an accidental president into an American Caesar. President Bush has become the neo-conservative vehicle for a policy that is based on unilateralism, permanent mobilisation and "preventive war".

War and militarisation would have been impossible without 11 September, which tipped the institutional balance in favour of the new right. Apart from such opportunist motives as seizing the strategic chance to redraw the map of the Middle East and the Persian Gulf, this choice reflects much more far-reaching imperial ambitions...

This authoritarian project became feasible in the unipolar world after 1991, when the U.S. got a monopoly on the use of force in interstate relations. But it was conceived in the 1970s, when the extremist coalition now in control was first formed.

The aim is to unite the nation and secure U.S. strategic supremacy worldwide. The instruments are war and permanent mobilization, both requiring the constant identification of new enemies and the establishment of a strong national security state, which is independent of society.

American author Michael Lind points out that the imperial dream outlined by the neo-conservative clique “was opposed by the mainstream U.S. foreign policy elite and by a majority of the American people, who according to polls opposed U.S. military action in Iraq and elsewhere without the support of allies and international institutions like the United Nations. The foreign policy of the radical right was enthusiastically supported by only two groups in the United States—neo-conservative policymakers and intellectuals at the elite level, and Southern Protestant voters within the mass voting public.”

Despite widespread opposition—both in the United States and across the globe—on March 17, 2003, American President George W. Bush formally announced that a war upon Iraq was imminent. After many long months of acrimonious debate, the American president declared that the United States—allyed with Britain and a handful of countries—would effectively “go it alone”, without the support of the world community. Some critics would call to attention the fact that March 17 was the eve of Purim, the traditional Jewish holiday celebrating the victory by the ancient Jewish people over their hated enemy, Haman. However, not all Jews—in America or elsewhere—lined up with the “neo-conservative” clique, even though, in fact, most of the pivotal neo-conservative leaders are indeed Jewish.

RICHARD PERLE & WILLIAM KRISTOL

As American Jewish writer Stanley Heller pointed out in the days prior to the attack on Iraq: “We owe it to Americans to tell them the whole truth, that part of the war drive is being fueled by a wacko militarist clique from Israel and its interlocking bands of American Jewish and Christian supporters.” In addition, Professor Paul Gottfried—an American Jewish academic who calls himself a “conservative” but who objects strenuously to the activities of the self-styled “neo-conservatives”—added, writing elsewhere:

No one who is sane is claiming that all Jews are collaborating with [neo-conservative pro-war leaders such as] Richard Perle and [William] Kristol. What is being correctly observed is a convergence of interests in which neo-conservatives have played a pivotal role. At this point they control almost all [Washington, D.C.] “conservative” think tanks, the “conservative” TV channel [pro-Zionist billionaire Rupert Murdoch’s Fox News], The Wall Street Journal, The New York Post, and several major presses, together with just about every magazine that claims to be conservative.

Professor Gottfried’s comments thus introduce us to two key names that shall appear again and again in these pages: Richard Perle and William Kristol. They are perhaps the two most influential of the “War Party” neo-conservatives—by virtue of combined position, outreach and financial clout. They are the central players who have been responsible, in overwhelming part, for shaping the policies of the Bush

administration that have led to the current conflict in the Middle East involving the deployment of American military forces against Iraq and the undeniably disastrous occupation which has followed.

Although we shall learn much more about Perle and Kristol, a brief introduction to the two neo-conservative figures is appropriate.

Often called “the Prince of Darkness”, Richard Perle (who is Jewish) has been active in pro-Israel causes in official Washington since the mid-1970s when he was then an aide to powerful (now deceased) Sen. Henry M. Jackson (D-Washington), a leading congressional supporter of Israel. During that period, Perle was investigated on charges of espionage for Israel. Later Perle became a lobbyist for Israeli arms interests and eventually was appointed by President Ronald Reagan to a key post in the Department of Defense.

After leaving the Reagan administration, Perle remained active in Washington, DC, enmeshed in a wide variety of institutions and organizations, almost exclusively devoting his energies to advancing Israel’s cause, and particularly that of the Likud Party of Ariel Sharon. Of recent date, Perle has maintained a special affiliation with the “neo-conservative” think tank known as the American Enterprise Institute.

However, when George W. Bush assumed the presidency, he named Perle to head the Defense Policy Board, a little-known but influential advisory board. It was from this post that Perle—utilizing his multiple contacts with longtime associates named to high posts inside the Bush administration itself—began making an active drive to advance the war against Iraq.

Although Perle resigned as chairman of the Defense Policy Board just days after the firing of the opening guns against Iraq—following allegations that he had conflicts of interest, stemming from his private financial business dealings that intersected with official government policies upon which he had an impact and from which he stood to personally benefit—he remained a member of the board, and certainly its most influential, until his formal resignation in March of 2004.

Considering all that we now know about Perle, it may be no coincidence that as far back as 1986 it was reported that once, while on a visit to Britain, Perle was introduced during a debate with then-Labor Party leader Denis Healey as “the person in charge of World War III”. Some Perle critics later suggested that the gentleman who made the remarks may have been empowered with psychic abilities, considering the critical role Perle has indeed played in sparking the American war against Iraq.

William Kristol (also Jewish) is equally influential, although in a different realm. As the son of an equally influential father, Irving Kristol—once described as the “godfather” of the neo-conservative movement—the younger Kristol parlayed his father’s connections into a post as chief of staff to Vice President Dan Quayle who served under the first President Bush. But that was only Kristol’s first step in his rise to vast power.

After the Bush-Quayle defeat by Bill Clinton in 1992, the younger Kristol, through his own aggressive efforts—not to mention increasingly favorable promotion of Kristol by the major media—emerged as perhaps the best known voice of the “neo-conservative” philosophy. He became actively involved in setting up a well-funded and far-reaching public relations and information network, linked to numerous foundations and think tanks with which his father had already been associated.

In addition to accepting an appointment as editor of Rupert Murdoch’s weekly national neo-conservative magazine, *The Weekly Standard*,

Kristol also founded his own organization, Project for the New American Century.

As we shall see, Kristol’s own operations and activities meshed precisely—actually, interlocked—with those of Richard Perle. And as the push for war against Iraq became increasingly more bellicose after George W. Bush became president—and then, even more so after the 9-11 terrorist attacks, which the neo-conservatives repeatedly sought to link to Iraqi leader Saddam Hussein—Perle and Kristol worked ever more closely, merging their own networks of influence to the point that the neo-conservative philosophy became the guiding force behind the entire Bush foreign policy making apparatus.

William Kristol—along with another close colleague, Robert Kagan—has been the foremost publicist for the neo-conservative imperial strategy. Their book, released in the year 2000, *Present Dangers: Crisis and Opportunity in American Foreign and Defense Policy*, was a comprehensive statement of the neo-conservative point of view, featuring essays by Perle—of course—and an assembly of other neo-conservative “stars” associated with Kristol and Perle.

In a review of the book, former British diplomat Jonathan Clark commented that: “If the book’s recommendations were implemented all at once, the U.S. would risk unilaterally fighting at least a five-front war, while simultaneously urging Israel to abandon the peace process in favour of a new no-holds-barred confrontation with the Palestinians.”

Ironically, as Michael Lind, a foremost critic of the neo-conservatives, has pointed out: “This turned out to be a prediction of the policies that the administration of George W. Bush would adopt in the following two years.” Lind notes: “The radical Zionist right to which [Perle and Kristol] belong is small in number but it has become a significant force in Republican policymaking circles.” Lind adds that the chief concern of many of those in this neo-conservative network is “the power and reputation of Israel.” He points out that they have waged vicious public relations campaigns against anyone who stands in their way—even including prominent and influential American military leaders who have questioned the neo-conservative policies.

THE ISRAELI CONNECTION

Thus, it is clear that the pro-Israel orientation of the neo-conservatives has been a primary matter of concern in the formulation (and conduct) of the policies they have sought to implement.

And this raises the question as to how much influence the state of Israel (and its American adherents, particularly in the neo-conservative network) did indeed play in sparking the war against Iraq.

As we have seen, the role of Israel in the Iraq affair was a problematic one in terms of protecting Israel (and American Jews) from a possible backlash by many Americans who resented the idea that perhaps U.S. policy was being predicated on the interests of Israel alone.

On November 27, 2002 *The Washington Post* reported that a group of American political consultants who had previously advised Israeli politicians had been hired by the Israel Project—described as “a group funded by American Jewish organizations and individual donors”—to draft a memo to American Jewish leaders and Israeli leaders as to the best means by which to address the raging controversy over Iraq. The memo advised them: “If your goal is regime change, you must be much more careful with your language because of the potential backlash. You do not want Americans to believe that the war on Iraq is being waged to protect Israel rather than to protect America.”

However, as Michael Lind reflected in his new biography of President Bush, the influence of Israel and the neo-conservatives is undeniable:

Under George W. Bush, the American executive branch and the government of Israel were fused in a degree without precedent in American history.... Bizarre as it seems, thanks to the influence of the Israeli model on neo-conservatives in the Bush administration, the United States, the leading power in the world, began acting as though it were an insecure and besieged international pariah state, like Israel under the leadership of the Likud Party.

Writing in *Time* on Feb. 17, 2003, one of the most prominent of the American neo-conservatives in the media, columnist Charles Krauthammer, announced that the proposed war against Iraq "is not just to disarm Saddam. It is to reform a whole part of the world ... What the U.S. needs in the Arab world is not an exit strategy but an entry strategy. Iraq is the beckoning door...." Krauthammer frankly named the targets of the neo-conservative war policy: "Iran, Saudi Arabia, Syria and beyond."

In truth, published evidence indicates that the government of Israel did indeed desire a U.S. assault upon Iraq—as a first step toward additional action against other perceived enemies of the state of Israel. On February 18, 2003, the Israeli newspaper, *Ha'aretz*, reported that Israeli Prime Minister Ariel Sharon was calling for the United States to move on Iran, Libya and Syria after what was presumed to be the successful destruction of Iraq by the United States—a view no different than that expressed by the aforementioned Krauthammer.

Sharon said: "These are irresponsible states, which must be disarmed of weapons of mass destruction, and a successful American move in Iraq as a model will make that easier to achieve."

The Israeli prime minister told a visiting delegation of American congressmen that "the American action [against Iraq] is of vital importance."

The Israeli newspaper also reported that in meetings with Sharon and other Israeli officials, U.S. Undersecretary of State John Bolton—one of the key "neo-conservatives" inside the Bush administration who had been promoting war against Iraq—had said, in the Israeli newspaper's words, that Bolton felt that after Iraq had been dealt with "it would be necessary thereafter to deal with threats from Syria, Iran and North Korea."

In addition, on Feb. 27, 2003, *The New York Times* freely reported that Israel not only advocated a U.S. war on Iraq but that Israel also believed that, ultimately, the war should be expanded to other nations perceived to be threats to Israel. The *Times* stated:

Many in Israel are so certain of the rightness of a war on Iraq that officials are already thinking past that conflict to urge a continued, assertive American role in the Middle East. Defense Minister Shaul Mofaz told members of the Conference of Presidents of Major American Jewish Organizations last week that after Iraq, the United States should generate "political, economic, diplomatic pressure" on Iran. "We have great interest in shaping the Middle East the day after" a war, he said. Israel regards Iran and Syria as greater threats and is hoping that once Saddam Hussein is dispensed with, the dominoes will start to tumble.

And while there were American Jews, acting independently of the established Jewish community leadership organizations, who opposed the war against Iraq, there is no question that elite American Jewish organizations closely tied to Israeli intelligence and the

government of Israel were firmly behind the drive for war. Those organizations were acting as Jewish organizations, purporting to represent all Jewish Americans when in fact they did not.

After the war erupted, the Anti-Defamation League (ADL) of B'nai B'rith—described by critics as a propaganda arm of Israel's clandestine services, the Mossad—issued a statement. It declared: "We express our support for the United States Government in its effort to stop Iraqi President Saddam Hussein and the danger he poses to the stability and safety of the region. The need to stop Saddam Hussein is clear."

CRITICS RISE UP IN AMERICA

However, while the Israeli leadership and their neo-conservative allies were calling for war, there were many Americans of all races, creeds and colors who were standing up and declaring their opposition.

In the months of debate leading up to the American attack on Iraq, Rep. Dennis Kucinich (D-Ohio) emerged as perhaps the most outspoken and articulate congressional critic of the proposed war. He sounded out multiple arguments against the war, ruling it totally unfounded and counter to all traditional American policy:

Unilateral military action by the United States against Iraq is unjustified, unwarranted, and illegal....

Unilateral action on the part of the United States, or in partnership with Great Britain, would for the first time set our nation on the bloodstained path of aggressive war, a sacrilege upon the memory of those who fought to defend this country. America's moral authority would be undermined throughout the world. It would destabilize the entire Persian Gulf and Middle East region...

Policies of aggression are not worthy of any nation with a democratic tradition, let alone a nation of people who love liberty and whose sons and daughters sacrifice to maintain that democracy.

The question is not whether or not America has the military power to destroy Saddam Hussein and Iraq. The question is whether we destroy something essential in this nation by asserting that America has the right to do so anytime it pleases. America cannot and should not be the world's policeman. America cannot and should not try to pick the leaders of other nations. Nor should America and the American people be pressed into the service of international oil interests and arms dealers...

If the United States proceeds with a first strike policy, then we will have taken upon our nation a historic burden of committing a violation of international law, and we would then forfeit any moral high ground we could hope to hold.

Quite remarkably, even after the war actually began, Kucinich refused to be silent, refusing to be bullied into supporting the war under the guise of "supporting the troops"—a popular catchphrase that has historically been used to convince Americans to support an unpopular war after American troops have been formally committed to action. Undaunted by accusations of being "unpatriotic", etc, Kucinich said:

I support the troops. But, this war is illegal and wrong. I do not support this mission. I will not vote to fund this Administration's war in Iraq. This war is killing our troops. This war is killing innocent

Iraqi civilians. This war must end now. It was unjust when it started two weeks ago, and is still unjust today. The U.S. should get out now and try to save the lives of American troops and Iraqi citizens. Ending the war now and resuming weapons inspections could salvage world opinion of the United States. The greatest threat to the United States at this time is terrorism, which this war will breed.

Kucinich was not the only American public official to take a daring public stand against the war—but he was certainly one of the most forthright and outspoken.

Just as American troops began their assault on the Arab republic, the longest serving member of the U.S. Senate—and the former leader of the Senate Democrats—Sen. Robert Byrd of West Virginia delivered a blistering address on the Senate floor, declaring the war to be totally at odds with traditional American policy. He said, in part:

Today I weep for my country. I have watched the events of recent months with a heavy, heavy heart. No more is the image of America one of strong, yet benevolent peacekeeper.

We proclaim a new doctrine of preemption which is understood by few and feared by many. We say that the United States has the right to turn its firepower on any corner of the globe which might be suspect in the war on terrorism. We assert that right without the sanction of any international body. As a result, the world has become a much more dangerous place. We flaunt our superpower status with arrogance.

When did we become a nation which ignores and berates our friends? When did we decide to risk undermining international order by adopting a radical and doctrinaire approach to using our awesome military might? How can we abandon diplomatic efforts when the turmoil in the world cries out for diplomacy?

Clearly, although the neo-conservatives hardly reflected the thinking of many Americans of many political persuasions, they did indeed reflect a particular brand of philosophy and one indubitably bound up with the hard-line imperial agenda of Israel's Likud.

And with that in mind, it is appropriate to begin examining the nature of the neo-conservative network that rules the roost in official Washington under the administration of George W. Bush.

TEMPEST IN A TEAPOT?

Ken Livingstone, Mayor of London, had the amazing temerity to tell a particular reporter (by the name of Finegold) the reporter was like “a Nazi prison guard”.

Of course no one is like a Nazi prison guard except one of those Holocaust Nazi types and Mr. Finegold took exception to the remark as did, apparently, every top-level “friend of Israel” in the British government.

In the tried-and-true manner of an average goy, the London Mayor set about clarifying his position in an effort to subdue the storm of criticism which ensued. “Remove left foot, insert right foot” seems to apply to this scenario because as we know, no apology is quite sufficient for those who “never forgive, never forget”. Zionism IS racism, Mr. Livingstone, by its very definition in the Talmud. THIS IS ABOUT ISRAEL, NOT ANTI-SEMITISM

...No serious commentator has argued that my comments to an *Evening Standard* reporter outside City Hall last month were anti-semitic. So I am glad that Henry Grunwald, president of the Board of Deputies of British Jews, accepted on these pages that “Ken is sincere when he states that he regards the Holocaust as the worst crime of the last century.”

...Throughout the 1970s, I worked happily with the Board of Deputies in campaigns against the National Front. Problems began when, as leader of the Greater London Council, I rejected the board’s request that I should fund only Jewish organisations that it approved of...

Relations with the board took a dramatic turn for the worse when I opposed Israel’s illegal invasion of Lebanon, culminating in the massacres at the Palestinian camps of Sabra and Shatila. The board also opposed my involvement in the successful campaign in 1982 to convince the Labour party to recognise the PLO as the legitimate voice of the Palestinian people.

The fundamental issue on which we differ, as Henry Grunwald knows, is not anti-semitism—which my administration has fought tooth and nail—but the policies of successive Israeli governments.

To avoid manufactured misunderstandings, the policies of Israeli governments are not analogous to Nazism. They do not aim at the systematic extermination of the Palestinian people [?], in the way Nazism sought the annihilation of the Jews. [??]

Israel’s expansion has included ethnic cleansing [fact, by definition]. Palestinians who had lived in that land for centuries were driven out by

systematic violence and terror aimed at ethnically cleansing what became a large part of the Israeli state. The methods of groups like the Irgun and the Stern gang were ... to drive out people by terror.

Today the Israeli government continues seizures of Palestinian land for settlements, military incursions into surrounding countries and denial of the right of Palestinians expelled by terror to return. **Ariel Sharon, Israel’s prime minister, is a war criminal who should be in prison, not in office. Israel’s own Kahan commission found that Sharon shared responsibility for the Sabra and Shatila massacres.**

Sharon continues to organise terror. More than three times as many Palestinians as Israelis have been killed in the present conflict. There are more than 7,000 Palestinians in Israel’s jails.

To obscure these truths, those around Israel’s present government have resorted to demonisation. Initial targets were Palestinians, and have now become Muslims. Take the Middle East Media Research Institute, run by a former colonel in Israeli military intelligence, which poses as a source of objective information but in reality selectively translates material from Arabic and presents Muslims and Arabs in the worst possible light.

Today the Israeli government is helping to promote a wholly distorted picture of racism and religious discrimination in Europe, implying that the most serious upsurge of hatred and discrimination is against Jews.

All racist and anti-semitic attacks must be stamped out. However, **the reality is that the great bulk of racist attacks in Europe today are on black people, Asians and Muslims**—and they are the primary targets of the extreme right. For 20 years **Israeli governments have attempted to portray anyone who forcefully criticises the policies of Israel as anti-semitic.** The truth is the opposite: **The same universal human values that recognise the Holocaust as the greatest racist crime of the 20th century require condemnation of the policies of successive Israeli governments—not on the absurd grounds that they are Nazi or equivalent to the Holocaust, but because ethnic cleansing, discrimination and terror are immoral.**

They are also fuelling anger and violence across the world. For a mayor of London **not to speak out against such injustice would not only be wrong—but would also ignore the threat it poses to the security of all Londoners.**

We next turn to the Jerusalem Post for its reply to the London Mayor’s exercise of his rights of free speech. Do they refute ANY of his specific claims as bolded above?

Surely they wouldn’t have the chutzpah to “demonise” him while ignoring the opportunity to refute a statement such as the “bulk of racist attacks in Europe today are on black people, Asians and Muslims”? Can they refute his statement that the state of Israel was predicated on ethnic cleansing?

Let’s see what the response is, shall we?

A few weeks ago London Mayor Ken Livingstone likened a Jewish journalist to a Nazi concentration camp guard because he didn’t approve of the reporter’s employer. Despite the furor, the mayor remains unrepentant.

Offensive as this comment was, abetted by his lack of minimal remorse, it could have been dismissed as a momentary indiscretion that he was psychologically incapable of retracting. Livingstone, after all, has a long history of putting his foot in his mouth.

But on Friday Livingstone dispelled any lingering doubts.... Among repeated calumnies against the Jewish state, Livingstone opined that Prime Minister Ariel Sharon is “a war criminal who should be in prison, not in office”.

Not only is Livingstone not seeking to extricate himself from the mess he got himself into last month, but he’s clearly out to pick an even greater fight. Moreover, he does so at a time in which Britain’s Jews face increased hostility both from homegrown hate-mongers and from the UK’s growing, sometimes extreme, Muslim community.

We haven’t forgotten the fact that the terrorists who attacked Mike’s Place on Tel Aviv’s beachfront in 2003 came here from Britain, where they were exposed to anti-Israeli diatribes of the sort Livingstone dispenses so generously. Moreover, recent statistics show that in 2004 anti-Semitic incidents in Britain rose by a whopping 41%.

If he were a responsible politician, Livingstone would spend his energies calming intercommunal tensions and combating anti-Jewish libels, which further feed the blazing fires of anti-Semitism. To refrain from doing so is grossly negligent. To fan the flames—as Livingstone blithely does with no provocation—is outrageous.

The distinction Livingstone presumes to draw between being anti-Israeli and anti-Semitic is itself threadbare.

...This is not to say that Israel or its leaders are exempt from any criticism. If that were the case every local newspaper, including this one, would be out of business. The test, however, is whether said criticism is reasonable, of the sort that could be addressed to any other country. Minister Natan Sharansky has proposed a “3-D” test.

His D’s include Demonization—when, for example, Israel is painted with Nazi images; Double-standards—when Israel is measured by a different yardstick from that applied to other countries; and Delegitimization—when Israel’s basic right to exist as a secure Jewish state is denied.

If we apply this test to Livingstone’s spoken and written pronouncements, it fast becomes obvious that he fails on all three counts. He has crossed the line of legitimate criticism over to what is effectively anti-Semitism.

Livingstone demonizes, applies double standards and delegitimizes Israel. Indeed he portrays Israel as “a threat to us all”.

He falsely accuses it of “organizing terror” and of persisting in policies of “ethnic cleansing” against Palestinians. This is not even a stone’s throw from classic anti-Semitic assertions that Jews are the source of all evil. It is all but indistinguishable, except that instead of individual Jews being assailed, his barbs are aimed at the Jews’ state.

Livingstone has basically said that this Jewish state deserves misfortune and bloodshed, that it brings these upon itself and that it destabilizes the rest of the world. And he has automatically made anyone who supports or is presumed to support Israel, such as British Jewry, accessories to a “crime”.

CHERTOFF COMES FROM
LONG LINE OF TALMUDIC RABBIS

America's new "Homeland Security Czar" Michael Chertoff doesn't like to talk about his childhood very much, probably because much of it was spent in Israel. Given the fact that his mother was an Israeli citizen, and that Michael is also an Israeli citizen (probably a dual-national), it is hard to imagine that given the intense Zionist and Talmudic character of his family that he would not have visited Israel on several occasions as a child.

"My childhood was ... average Nothing stands out. It all kinds of blends into the murky past," he told *The Star Ledger* of Newark in March 2001. How convenient.

Pressed for more details about his past, Chertoff reclined in his chair and said, "I'll take the Fifth."

Now why would an intelligent person with intelligent parents have nothing to say about their childhood? Usually it is because they have something to hide. In Chertoff's case it is clearly his Israeli roots.

"My religious and spiritual beliefs are pretty much what I want them to be," he said. Given his background, this must mean that he is a devoted Talmudist, which should concern Americans who are not Jewish. Especially since this man is the head of "Homeland Security" for the United States.

The *Talmud* is the essential law that governs the behaviour and thinking of most Jews in America. It professes a Jewish exclusivist world view that is profoundly anti-Christian. It is actually anti-everything that is not Jewish.

His father, Gershon Baruch Chertoff, was a teacher of the *Talmud*, a rabbi, as was his uncle Mordecai Chertoff. Their father, Paul Chertoff, Michael's grandfather, was also "teacher" of the *Talmud* at a major Jewish teacher's institute (yeshiva) in New York City. When Paul Chertoff died he was described as an "Ex-professor of *Talmud*" in the *New York Times* of 1966.

Michael's father, Gershon, was the first child of Paul Chertoff from Russia, and his wife Esther Barish, from "Roumania", according to the 1930 U.S. Census. Gershon Baruch Chertoff became a graduated teacher of the *Talmud* in May 1935.

In 1930, the Jewish immigrant couple lived in a \$90 rented apartment in Brooklyn and had three children, Gershon (15), Naomi (11), and Mordecai (7). Apart from being taught to be devoted Talmudists, the Chertoff children were also raised to become dedicated Zionists.

Naomi Chertoff was already serving her fourth term as national president of the Young Women's Zionist Organization of America when she married Monroe Seligman in 1946. Naomi had even attended Hebrew University in Palestine before Israel became a state on May 16, 1948.

Michael's uncle, Rabbi Mordecai Chertoff, married Lily Sefton in London in 1951. Because there is no

published record of Gershon marrying Livia Eisen, the first airline hostess for Israel's El Al Airlines, it seems likely they were married in Israel.

Michael's mother, Livia (Eisen) Chertoff was born in Poland and "lived in Palestine and England before her marriage". ... Chertoff's mother was a founding Zionist who lived in Israel

Does anyone remember Public Law 102-14, which prescribes decapitation for gays in violation of Talmudic law? "Nah, couldn't be"?

President Bush had quite a bit to say about "democracy" to President Putin at their last meeting. Perhaps he meant the kind of "democracy" found in places like Israel (or the U.S. for that matter) under 'war criminal' Sharon?

A COUNTRY HELD CAPTIVE

It's very sad, this Mitzna business with the empty chairs, and now the illegal donations. Because it proves that not only is there no room in the political arena for people with good intentions, but also for people who think differently. Our democracy has been commandeered by one man.

We are not talking about a dictator who has taken over the country by military force. On the contrary. We are talking about a nice man, a white-haired grandpa with a little paunch and a pleasant manner. A man with a sense of humor, and most importantly, a crowd-pleaser. He was elected by the largest number of votes ever cast for a politician in Israel. But within a year and half of taking office, he has established an autocracy, a government of one.

Sharon reserves more powers for himself than any prime minister we know of in the democratic world today. In practice, he is not only the prime minister, but also the defense minister and the commander in chief of the army. The generals, once famous for their brainstorming, now speak in one voice: the voice of Sharon.

The Shin Bet and the Mossad take orders from him, and now he's appointed a Mossad chief after his own heart, a comrade-in-arms and a Likudnik to boot. Sharon also controls, among others, the Israel Lands Administration, the Israel Broadcasting Authority and Channel Two, headed by a loyal director-general from Ofra. He keeps tabs on relations with the United States via his personal chum, Aryeh Genger. He neutralized the national security adviser appointed in the wake of one of the more important recommendations of the Agranat Commission. The commission felt that multiple viewpoints would prevent a repetition of the kind of fixed "conception" that was father and mother to the fiasco of the Yom Kippur War. Now there is only one conception: Sharon's.

The leader of the only democracy in the Middle East is like Henry Ford senior, who told his managers they could paint the cars any color they wanted as long as it was black.

The surest way to become an autocrat without a military coup is to put together a government with a broad parliamentary base that will leave the opposition powerless. Meretz, for example, has submitted 68 no-confidence proposals against Sharon, but who ever heard about it? The bigger the government, the more it looks like a train station, full of people rushing around with cell-phones. Forget about life or death decisions. All too often, we hear excuses like "No one told me,"

"I didn't know," "I wasn't there." Or: "We decided in principle, but we didn't know it was a one-ton bomb. We didn't know they were going to kill the wife, too."

Sometimes a round of telephone calls is made at night, when the army is already rolling and the ministers are too sleepy to know exactly what they're approving. Sharon has been a pro at wrapping governments around his little finger since Lebanon. He keeps saying he has a "detailed plan" but the government doesn't have a clue what it is. No political-strategic debate has ever been held.

...Sharon's life is ... a dictator's dream come true: a government with no opposition, with no system of checks and balances, with that "quiet please, we're shooting" ambience.

With Mr. Peace and Security at the helm, there have been more terrorist attacks than in the days of any previous prime minister, and the economy is sliding downhill. But Sharon casts a giant shadow over all his competitors. He is a beloved man, a man to be trusted. With his secret plan that offers the Palestinians nothing aside from mutual violence, with an apathetic public that offers not a murmur of protest, with the herd mentality of the media and the moneyed, we have become an autocracy, a regime that offers no alternative—even without a *putsch*.

The "Western" AXIS powers (U.S.-Britain-Israel) have been having more difficulty getting things all their own way on the world stage recently. Meanwhile, the ALLIANCE (Russia-China-India-Brazil and many more) continues to draw nations into its orbit. Russia, for instance, is completely ignoring U.S. and Israeli pressure to disengage with Iran (or Syria, for that matter, as reported in the last issue).

RUSSIA DELIVERS NUCLEAR FUEL TO IRAN

New York—"The Russians have delivered the (nuclear) fuel. We now have it," a senior Iranian official tells NewsMax.com.

The confidential source confirmed that the nuclear poker game between Washington and Tehran has moved up another notch.

The source was referring to the Iranian nuclear power station now nearing completion in the Persian Gulf port of Bushehr. When completed, the two light-water nuclear reactors will be among the largest in the world.

...Almost ten years since it was restarted, the Bushehr project is now moving rapidly to completion.

Although Moscow and Tehran insist the light-water reactors at Bushehr are not designed for bomb making (a fact confirmed by the International Atomic Energy Agency, the U.N. nuclear watchdog), the Bush administration fears that any experience in handling nuclear materials could eventually find its way to military use.

U.S. intelligence sources believe that Iran has developed several sites for nuclear weapons development, some of them underground in "hardened" bunkers.

The Iranian source could not confirm Russian-delivered nuclear fuel has yet been moved into the reactors' cores.

Once such fuel is in place, it would only be a matter of weeks before the reactors could be activated. The reactors would then be tested for several months before they could come fully on-line.

The Iranians are now unofficially claiming that they expect Bushehr to become fully operational in "early 2006".

...The White House would like to increase the pressure on Iran by bringing the nuclear issue to the U.N. Security Council, with a threat of crippling economic sanctions.

...Iranian sources tell NewsMax that they have "credible" evidence the Pentagon has been developing a commando operation to land U.S. troops inside the reactor site to disable it.

Should Washington ever decide on a commando strike it may get more than it bargained for.

The Iranian source also claimed that "retired" Russian special forces [!] may be "assisting" in Bushehr's security, with some Chinese Navy sailors [!!!] covering maritime exposure.

Yet, despite all the posturing by both sides, neither has felt compelled to pull a trigger.

The problem is, no one has found a credible smoking gun that indicates Tehran is secretly developing an atomic bomb.

While expressing concern over "circumstantial" evidence, IAEA chief Mohammed ElBaradei says he has found no "violations" to report to the Security Council.

That is buttressed by revelations that secret surveillance flights the Pentagon has conducted over Iran has yet to turn up any incriminating evidence.

Yet Israel's foreign minister, Sylvan Shalom, recently warned that "within 6 months" Iran would have completed most of its tests and will have the all the knowledge to produce an atomic bomb.

"They (the Israelis) are trying to pull Washington more deeply into the mess in the Persian Gulf," explained the Iranian source. "In the end, will it hurt Washington? Yes. Will it hurt Iran? Yes ... We will all lose," he lamented.

Russia has also continued to "cozy up" to Europe and this is highlighted by Russian joint exercises with NATO forces. Note also our emphasis in this following article underlining the broadening Alliance elsewhere in the world.

SERGEI IVANOV ON RUSSIA-NATO RELATIONS

RIA Novosti, 2/22/05

MOSCOW— ... Commenting on the present-day level of Russia-NATO relations, [Sergei Ivanov] noted that such relations were marked by greater trust. About 100 joint exercises have been conducted over the last three years, becoming an important element of Russia-NATO relations. This is very important from the psychological standpoint because the mindset of Russian and NATO servicemen keeps changing, Ivanov stressed.

Progress in the nuclear security sphere is yet another cooperation aspect. It was impossible to imagine just a few years ago that Russia would cooperate with NATO countries in this field, Ivanov stressed, reminding *Izvestia* that such exercises will be held in the United States this April.

The sides also pay attention to interoperability issues. This is an extremely important aspect in the context of coping with joint threats, the terrorist threat included. Joint peacekeeping operations which seem possible in the near future must comply with all Russian political interests and laws....

Talking about military-technical cooperation with other countries, Ivanov stressed that India and China which were Russia's leading partners will retain this status in the foreseeable future. Russia will receive new clients, such as Thailand, Malaysia and Venezuela. Military-technical cooperation is marked by tough competition; and we must defend our interests accordingly, Ivanov added....

And it looks like Russia has picked up yet another Alliance member in South America: Uruguay.

RUSSIA INTENDS TO STEP UP COOPERATION WITH SOUTH AMERICA

BUENOS AIRES—Russia and Uruguay have agreed to draw up a cooperation program for the period from 2005 to 2010.

The parties reached this agreement at a meeting between Russian Central Election Commission chief Alexander Veshnyakov and Uruguayan President Tabare Vazquez on Thursday, reported the Russian embassy in Uruguay.

Veshnyakov heads the Russian delegation at the inauguration ceremony of the new president of Uruguay Tabare Vazquez.

Mr. Veshnyakov handed over President Vladimir Putin's message to his Uruguayan counterpart.

Mr. Veshnyakov updated President Vazquez on prospects and areas of cooperation in the energy sector, cattle breeding, oceanography and measures against natural disasters.

They also discussed the proposal advanced by President Hugo Chavez of Venezuela to modernize oil refineries in Montevideo, the project that will involve Russian enterprises, according to the embassy.

The conferees also focused on intensifying Russia's contacts with the Southern Cone Common Market (MERCOSUR), as Uruguay is taking the presidency in the organization in July 2005, the Russian diplomatic mission noted.

The economic hit-men and jackals have failed so far to deter Venezuelan President Chavez from doing what he knows is in the best interests of his country despite grave personal risk:

CHAVEZ TO SUSPEND OIL EXPORTS TO U.S. IN CASE OF ASSASSINATION ATTEMPT

CARACAS—Venezuelan President Hugo Chavez threatened to suspend oil exports to the United States if someone tries to assassinate him, adding that U.S. President George W. Bush would be to blame.

"If they kill me, there will be a really guilty party on this planet whose name is the president of the United States, George Bush," Chavez said on his weekly radio program, "Hello, Mr. President."

"If, by the hand of the devil, those perverse plans succeed ... forget about Venezuelan oil, Mr. Bush," he said.

Chavez said he was convinced that Washington was "sketching out the assassination plans" before his Bolivarian Revolution advances in Venezuela and Latin America.

Chavez revealed a week ago that Cuban President Fidel Castro had warned him of a U.S. assassination plot.

"Now, I am going to say it. Neither Fidel Castro nor I talk nonsense.

"If something happens to me, I blame the president of the United States," he said.

"I will not hide. I am going to be in the streets with you. I entrust myself to God, but I know that I have been condemned to die," Chavez said.

"Each second of my life I will spend in the struggle and God's will be done," he said.

Castro said on February 12: "If Chavez is assassinated, the blame will fall on Bush.

"I say that as someone who has survived hundreds of the empire's (assassination) plans," he said.

Chavez has also recently accused the United States of being involved in an April 2002 coup, which removed him from power for less than two days.

Washington has accused Chavez of being undemocratic especially when it comes to the Venezuelan opposition, and has more recently criticized arms purchases from Russia and Brazil.

Venezuela is the only Latin American member of the Organization of the Petroleum Producing Countries, and sells about 1.5 million barrels daily to the United States, nearly as much as Saudi Arabia.

U.S. Secretary of State Condoleezza Rice recently called Chavez "a negative force" in Latin America....

Argentina has also withstood the jackals and hit-men and has just managed to reduce its defaulted-debt burden by about 60% (by standing up against the usual, deadly, IMF prescriptions). It's not over but it's a good start. Note, however, how the banks laid off risk onto "retail bondholders" (pensioners) (emphasis added):

ARGENTINA DID IT

BUENOS AIRES—The Argentine government has something to celebrate, today. Wall Street believes that up to 80 percent of holders of defaulted country's debt cashed in their papers for new bonds in what will amount to the biggest sovereign "haircut" in modern history. Analysts from the U.S. Stock Exchange had to admit that the 70 percent cut Argentine bid—the largest ever—was a success.

After three years in default and two of tough negotiations with national and foreign creditors, Argentina concluded debt swap on Friday, with a considerable acceptance from holders. Analysts believe the level of orders will be in the range of 75/85 percent, when South American authorities provide with definitive figures, next week.

Argentina's success means a serious defeat for global speculators, who would have preferred a minor cut in the nominal value of their bonds. According to sources in New York, the estimated 70 percent loss of net present value on about \$102 billion in principal and past due interest from the country's 2002 default will set a dangerous precedent for future sovereign restructurings.

Argentina is offering about \$41 billion of new bonds to replace about \$102 billion of defaulted debt and interest.

Creditor's lobbyists openly failed to show Argentina's higher international reserves and economic growth figures since the default as proof it can pay more. In fact, deep social and economical crisis since then is far from being over, with poverty rates in the region of 50% and unseen unemployment levels for a country known as one of the wealthiest of the Third World.

Retail bondholders learnt late in time that banks held the biggest responsibility in the case. **Acting as financial brokers, banks got rid of Argentine papers as soon as they learnt that country's economy was about collapse late in 2001. Then, they offered bonds to their retail clients in countries as Japan, Germany and, mainly, Italy. Most of them were pensioners who lacked of vital information to decide, but fell to the temptation of unusual high rates according to market standards.**

However, even when Argentina won the game with the investor community in a handsome way, the success in the operation does not mean a full solution to country's huge debt problem. According to last estimations, after the swap Argentina's debt will be over 85% of country's GDP, out of the 135% prior to the operation....

NEVADA CORPORATIONS:

Another Privacy Measure: “Uncertificated” Stock

Budget’s “Tip of the Week” #19:

NRS 78.235: “Issuing Stock” Without a Certificate

Another special provision of Nevada’s corporate laws is the ability to use what the statutes refer to as “uncertificated” stock. That’s right, here in Nevada it is perfectly permissible to have “phantom” stock certificates. And now you know why our Budget kit leaves out the stock certificates, which are not needed to operate your corporation fully within the law.

As a general rule of good Nevada corporation management (maintaining privacy of ownership), it is often better to not issue stock, relying on NRS 78.197 (which specifies that debt holders may have the rights of stockholders). But when stock must be issued, why not issue phantom certificates? Note that Section 5 of NRS 78.235 (excerpts below) requires that the corporation “shall send the stockholder a written statement containing the information required on the certificates”. This provision is obviously intended to protect the interests of the stockholders for other than one-person corporations and it is hard to imagine running into any problems for failing to notify yourself in writing once a year. Note that the corporation’s bylaws could be written to waive any penalty for failure of notification.

NRS 78.235 Stock certificates: Validation; facsimile signatures; uncertificated shares and informational statements; replacement.

....4. Unless otherwise provided in the articles of incorporation or bylaws, the board of directors may authorize the issuance of uncertificated shares of some or all of the shares of any or all of its classes or series. The issuance of uncertificated shares has no effect on existing certificates for shares until surrendered to the corporation, or on the respective rights and obligations of the stockholders. Unless otherwise provided by a specific statute, the rights and obligations of stockholders are identical whether or not their shares of stock are represented by certificates.

5. Within a reasonable time after the issuance or transfer of shares without certificates, the corporation shall send the stockholder a written statement containing the information required on the certificates pursuant to subsection 1. At least annually thereafter, the corporation shall provide to its stockholders of record, a written statement confirming the information contained in the informational statement previously sent pursuant to this subsection....

When added to the mix of other privacy-of-ownership provisions available in Nevada, it is easy to see why it is impossible for anyone on the outside of the corporation to know who owns it—unless the owner tells them. Combining “uncertificated” stock with the concept of bearer shares, it is fully understandable how ownership of a Nevada corporation can change hands merely through entries made in its stock ledger, without any need for recourse to stock certificates.

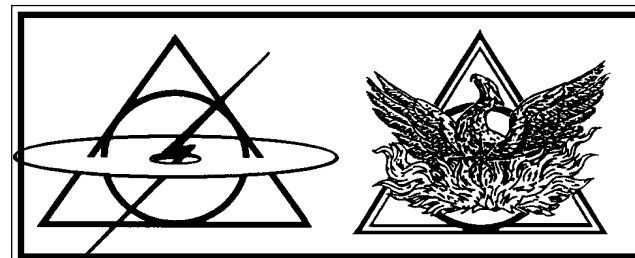
