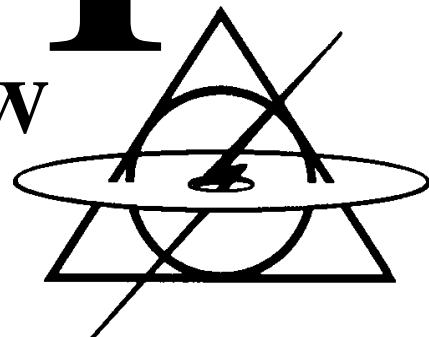

in his being paid a rather large sum of money.

Is the man afraid Terri will remember and be able to communicate that he attempted to kill her? Oh, don't say, "oh no"; does anyone remember Laci Petersen in California to realize what a man is capable of doing when irritated?

You let them murder Jesus? Does that give you the right to murder Terri Schiavo? WHERE HAVE I BEEN?

I am tired, friends—bone tired. However, explanations are mandatory when the response of one touches so many and so many are family, friends, and yes indeed, those who themselves ask to be on our mailing list.

Do “I” object to objections to that which I write? No, but I do object when objections are insulting to that for which I write—mostly when I would “rather not”.

We are extremely buried in work here and it has little to do with someone called Terri Schiavo in a place called Florida.

Because of the focused interest AND THE FACT THAT THE WORLD IS LAUGHING AT THE “SATAN U.S. WHO KILLS ITS CITIZENS” Cmdr. saw fit to write and I was as blasted as anyone from that writing—FOR I HAD PULLED A PONTIUS PILOTE in that it was all so distant and without backup data sufficient to “have a reasonable bit of input” I would not even state my opinion on the matter.

However, I was pulled up very short when from JR I received a good reason why we should kill Terri because her position brings, obviously, such pain and bother to those having to watch her struggle or simply stay ALIVE in the body.

I was told that there had been a lot of study into the case and thus the stance on the position taken. However, I remind JR that the bottom line is that the person of which there was reference was, as stated, “taken by God” or “released” to God after only some 8 months, not 15 years.

Do I need to take a stand in this issue? Yes, because of the direct and pointed disrespect shown to “me” personally.

When I write I identify my input and because of the past attacks and actual “taking” of identified parties for both commercial and “fool-you” takers, Hatonn asked to be identified with less hoopla as “GCH”.

So, when GCH shows up it is acknowledged, stated, written and followed by a “/” D or d. I always write a small “d” because it indicates nothing more than responsibility or identification for which I do, in fact, take full responsibility.

When emails go out to our circle of family and friends (who have asked to be on that list) it goes out on a site that begins as “Doris”. I have NEVER sent even one piece of mail on that site—it is simply a mailing address.

Now to specifics, please.

Without realizing that there was information appended to a mailing received regarding the government input on the Terri case by the emailing party, Cmdr. addressed the case and since there had been inquiries regarding the specific subject I did not further question his intent to write. However, in the events that came later I had cause to really look at what in the world could have caused such offense and discovered JR’s note on the topic at the bottom of the internet posting.

The next thing received here was a note which addressed “D/GCH” at least twice and was specifically addressed to “Doris”—“GCH”. The note was specifically and pointedly directed to me for how in the world, I suppose, would “GCH” object to anything any individual with such knowledge and study on the matter, express as “right to die” or better put, “right to live” as in Terri Schiavo.

Well, I then took up the study of the matter and was conscience stricken because I had simply “washed my hands” of the case.

It all happened on the anniversary of my SON’S DEATH and today is THE DATE of my son’s FUNERAL. Right to life? Right to death? How can we tell what another WANTS—REALLY?

God very succinctly spoke to me (YES INDEED) when I asked “how do we know what Terri could possibly want?”

“Elementary, Dr. Watson,” came the very pointed reply: “She is alive!” After 15 years of ability and opportunity to “die”—SHE IS ALIVE. If more is required to keep a person alive then you have ulterior motives on the part of the “killers”, my friends.

Worse, I found that Michael, the husband, has every reason acceptable in a world of murder and mayhem to want Terri dead—money, adulterous affair with family no less and why all the other mean and hateful demands, i.e., CREMATION when it is against the very “church” laws of “her” religion and a taking of her ashes for burial AWAY FROM HER FAMILY AND STASHED IN OLD PENNSYLVANIA IN “HIS” PLOT.

I guess where I fall off the puzzle wagon is in that somehow the “government” and judicial system should stay out of our personal affairs. I consider that THE

VERY PURPOSE OF GOVERNMENT, LAW AND OFFICIALS ELECTED ARE FOR THE PROTECTION OF CITIZENS' "RIGHT TO LIFE" AND ALL THOSE OTHER NICE "TAKE CARE OF CITIZENS" WE FEEL AS "CITIZENS".

We are just informed right now that a pace-maker is now inserted, the heart is responding and indeed, he is out of danger while, incredible as it may seem, the Veteran's Affairs officers are after getting some medical coverage, rehab coverage and “right to LIVE” assistance. It is a good Easter morning here in that particular instance even if it is little of my “business”.

I shall try harder to not allow anything to appear as being my opinion but you know what? I have learned from my teacher over these years and it is

difficult to find anything that is presented by HIM with which I can long disagree, for we live the confirmation of this miracle under way—every moment of ever day. This is certainly not an argument of some sort, for each individual has RIGHT to whatever thoughts you might have but “making ‘it’ so” is not the necessarily accurate conclusion. In THIS instance of prior experience I most certainly HAVE BEEN THERE AND DONE THAT! “THAT” is the test of my journey and the conclusion of a consideration of “my purpose”. Nobody, but nobody, follows “Doris” and neither could Doris even begin to accomplish all the dastardly and insanely conjured nonsense to which I am given attribute.

And yes indeed, KNOW that I certainly have considered over these few days of meditation and confrontation from yes, this ONE source—tossing the job, just quietly going on with our task at hand, silently (not sharing with anyone) to avoid this kind of rancor, especially on our PRIVATE email site but you know what? I don't have alternatives as THIS “IS” OUR SITE FOR ADDRESS AND COMMUNICATIONS. The fact is that so many individuals tried to insert themselves into anything with “Ekker” in the “address” that we couldn't even get a site when “Ekker” is one of the few unique names around.

We are not to share “other's” sites because of desire for privacy and, so be it. But, when these things come to this site when there are at least three other sites that get things to us, we are somewhat at a loss as to what to do. We hold no one onto our mailing list and certainly GCH's messages are going to get published so perhaps we should reconsider any mailings at all other than the paper—and do away with any “quality of living” as in contact with our friends and/or families.

I am grateful for information regarding these topics of current interest. I note, however, that even on CNN it was noted that the polls which showed 8 out of 10 people “felt Terri should die” that the question asked was “would you want to live in a permanent COMA?” Oh, Terri is neither in a coma nor would anyone WANT to live in a coma. Oops! (???) Please don't try to impress me with polls and numbers—I am in the Philippines where “Wonderland” looks like “Saneville” only to realize that the largest and most noble country in the world—taught these people all of the dirty tricks they know.

I'm confident that GOD'S LARGER PURPOSE will be served no matter what it is I might think or how much water I might, AS A MEDICAL PERSON, try to get past Terri's lips as my oath of service would demand.

This whole focus is far beyond anything relative to Terri's “right to die” or “to live” for it goes to the very foundation of that which WE ARE and that which we reflect AS A HUMANITARIAN NATION/SOCIETY.

Terri Schiavo, a brain-damaged woman from Florida who lies dying in a hospice after a court ordered her feeding tubes pulled out 13 days ago could be dead by the time you read this.

Or she could still be hanging on as her parents Robert and Mary Schindler fight an uphill court battle to have her feeding tube reinserted to give her a chance to recover. Her husband Michael is firm on keeping the tube out and allowing her to die.

For many Filipinos, especially those unfamiliar with American law and culture it seems unusual and rather cruel to kill a patient that some doctors say still has a chance to recover with intensive therapy.

Some of us are also asking whose wishes should be followed: that of the husband WHO IS ALREADY LIVING WITH ANOTHER WOMAN WITH WHOM HE HAS TWO CHILDREN, or the parents who want to save their daughter. Her blood ties are with her parents, not with her husband.

[INTERRUPT QUOTING]

To avoid interruption of thought in the following “Background” offered, let me pull *Black’s Law Dictionary* so that we have a good definition of “consortium”, which reminds me, frankly, of “The devil made me do it...”

CONSORTIUM: Conjugal fellowship of husband and wife, and the right of each to the company, society, co-operation, affection, and aid of the other in every conjugal relation.

Damages for loss of consortium are commonly sought in wrongful death actions, or when spouse has been seriously injured through negligence of another, or the spouse against third person alleging that he or she has caused breaking-up the marriage. Cause of action for “consortium” occasioned by injury to marriage partner, is a separate cause of action belonging to the spouse of the injured married partner and though derivative in the sense of being occasioned by injury to spouse, is a direct injury to the spouse who lost the consortium. End quote.

Please remember that rumors had it that the reason Terri was found “unconscious” and underwent that cardiac arrest in the first place is that Michael had hit her in the heat of a marital “fight” where, perhaps, she just said “no”. Moreover, he did not remain without consortium very long and has two offspring from his “mistress” to prove INFIDELITY—after he had been paid handsomely for his inconvenience. Wouldn’t we all love to see Terri live to sue him for “consortium”?

Now, in addition, however, if the very definition of this term is “breaking up a marriage...” is it not logical to note that the marriage is consequently null and void—or, it wasn’t “broken up”. It would appear that it has been overlooked quite long now that someone could file for divorce to finalize that “break up” since obviously Terri’s ability to “consort” has not changed. Oh well, let’s read on from the paper.

BACKGROUND: So Philippine readers can understand better the Schiavo case, we share here some information taken from the CNN website.

On Feb. 25, 1990, Terri Schiavo collapsed in her Florida home from what doctors said was a potassium imbalance. After she collapsed, her brain did not receive oxygen for about five minutes. The oxygen deprivation caused severe brain damage.

Doctors hired by Michael said she is in a persistent vegetative state. That does not mean she is brain dead. People in a persistent vegetative state cannot think, speak or respond to commands and are not aware of their surroundings. Terri breathes on her own and blinks.

But doctors that Terri’s parents hired said she is not in a vegetative state and has the capacity to improve with therapy. ***She has not received physical therapy for more than a decade. [This gets more important since there comes a \$700,000 award for her therapy and rehabilitation. This certainly indicates that there WAS something viable about the person in the aftermath of the court awards. Ah indeed, “money” always rears its ugly head.]*** Her parents contend that when she received therapeutic care, she uttered a few one-syllable words. Until March 18, Terri received nourishment and hydration through a tube that placed the nutrients directly in her stomach.

In 1992, a Florida jury awarded Michael Schiavo \$300,000 for loss of consortium as part of the medical malpractice suit he filed. The jurors also awarded \$700,000 to Terri. The \$700,000 went into a trust over which her husband has sole control. He said he used the money for her medical care and HIS legal expenses, and that the money ran out about three years ago. [Emphasis added.]

Florida law specifies that the spouse of an incapacitated adult is that person’s guardian. In 1993, the Schindlers petitioned the court to remove their son-in-law as Terri’s guardian. They lost.

They said there is a conflict of interest because ***Michael lives with his girlfriend and has two children with her. They said that he cannot uphold the best interest of his wife while living in what they describe as an adulterous relationship.*** Michael said he is removing his wife’s feeding tube as part of keeping his promise to her that he would not allow artificial means to preserve her life.

[END QUOTING]

My goodness, it would appear to me that if she couldn’t “consort” in any way that she couldn’t have made (forced somehow) Michael to remove all means

of life support—AFTER 15 YEARS YET.

If this is hard to understand then you DO NOT “understand”; certainly you cannot believe the magnitude of our work. Simply wishing a thing to be otherwise than it IS can be no more than that; wishing.

Little Crow did a fine job of outlining the position of his Native American people called “Indians” for some incredible form of misidentification. But note please that the concept is quite adaptable to ALL PEOPLE who are on earth as a species.

Perhaps the better part of consideration of this topic would be simply to insert Chapter 8 (oh goodness, Doris, here is one Chapter 8 if not THE Chapter 8 of infamy and VK Durham). THIS ONE has importance.

[QUOTING: *THE SACRED HILL WITHIN*, by Little Crow, Lakota:]

CHAPTER 8 PLACE

Place has a lot to do with accountability and responsibility. We are in and on a place within the universe that we refer to as the mother earth, and upon the mother earth are placed all things of creation. All things of creation are in place and wherever they are, wherever they sit, stand, fall, or are buried in the place they are supposed to be. This idea eliminates the need of asking ourselves what we should be doing today. We have already answered that question. We are in our place, doing whatever we are supposed to be doing. That is where we choose to be, for whatever reason.

This place where we find ourselves, here on this sacred ground, is important to us as Indian people. We were brought here and given this place, this mother earth, to care for before anyone else was here. We came here in a responsible and accountable way to take care of the earth and to do it in a way that is as much in balance with our surroundings as possible, remembering that we are human beings who, even

then, became distracted by possession of territory, land, horses, people, places and things, in accordance with our needs—no more and no less.

In the caretaking of the place where we found ourselves, we were instructed that there are certain ceremonies and rituals that we are to perform which are exclusive to our culture. Each culture has something exclusive to it and a way in which it is to accomplish the same accountable, responsible acts in caring for the land. Every nationality, in its traditional oral history, myths, folktales, legends, whatever you wish to call them, has had accountability for the earth. Whether that accountability is practiced by druids, witches or warlocks, shamans, goddesses, priestesses or priests, it is the same. We are all put in this place to take care of the land and we are accountable to pray and to conduct our ceremonies and rituals, to practice our world views, for the benefit of the earth, the universe and everything that has been created. It is our responsibility, as indigenous people to do that. We have been given those things so we might remember who we are, where we came from, what we are related to and who our relatives are.

[H: Oh yes you ARE “indigenous”, my friend—to somewhere! Cop-out games do not take away your accountability and responsibility to this wondrous creation to which you certainly come along to be defined as “indigenous” even if your ORIGINS are elsewhere.]

When we asked the Creator how we would remember what we were to do, we were told that we would be given instruction in the sky so we could see it and not forget in case our thinking got a little feeble, we were told that our elders and holy people would instruct us, based on what was in the sky. We were told that we are to do our ceremonies at specific places and times, so as those constellations move across the sky, we follow and do our ceremonies in certain places because we were instructed that is where they are to be done. The reason tribal people have always been so determined to retain a particular place, a particular land base, is because that land base is directly related to the constellations that appear in the sky above it. Whatever the season, whatever the time of year, the corresponding constellations are there above that land.

[H: This simply IS the “map” of your place and location and there is nothing mystical or mysterious about it. At any season of the cycling of “years” you are on the map and identification easily accomplished from within your operating orbiting system or outside of it. That is not a complicated fact so why do you complicate it?]

You can see why the issue of land is so important to indigenous people. We were put here so that we could fulfill our obligation, meet our contract, so to speak, but we have been denied access to the places on which to do that. The land has been stolen, taken by force and by genocide. In taking the land, the place where we are to practice our world view is eliminated. If you eliminate that, you eliminate the hope of the world. Thirty million Indian people were killed so that the land could be taken and our obligation goes unfulfilled. Now I ask you, who is Satan? To me, Satan is the one who denies you your language, your ceremony and your ritual; the one who says you cannot fulfill your obligations and your responsibility because you are a sinner or because that isn't the way that it should be done. The country has fallen, integrity has fallen, all because we have not been able to pray in the way we were given. Many of our people turned to another way in confusion, still hoping

to fulfill their obligation by praying to another form of God which was brought to us. We have been assimilated and acculturated and have put our ceremonies and rituals aside for this new teaching which does not recognize an accountability for the earth but says, rather, that the earth was put here for the whims of man, that man has dominion over the earth and we can do whatever we want to it. We have the idea that after the earth becomes unlivable, we'll just create a stargate and go someplace else, but let me tell you, there is no place left for us to go and there is no one who is going to come and rescue us. It is up to us to clean up the mess we have created.

[H: Oh golly-gee, more shock and awe!]

Indigenous people in this country have been forbidden to practice our “religion”, to practice our ceremonies and dances by law, by acts of Congress, by the signing of legislation. People have asked why we don't fight for religious freedom legally by using the constitution. The constitution has never, nor will it ever, apply to us because, as sovereign people, sovereign nations, we are outside of it, even though it is the one that we have defended with our lives, as many of you and your sons and daughters have done and will do in pursuit of the idea of democracy. We don't need the constitution to protect our religious freedoms, which is a good thing, since it never has. We were here long before the constitution existed and we'll be here long after it's gone. What we need to protect our religious freedom is to be able to say to ourselves, in faith, that we are following what we truly believe and let it go at that.

Still, one has to wonder what it is about our world view that is such a threat. It must be threatening, otherwise how can one explain why there was such a campaign to crush it out, to destroy it. Perhaps those in power didn't want people to know the truth, that the earth is alive and that it is from the earth that we gain our strength and our power, our God-ness, our goodness, whatever it is we seek, whatever we think we need. Our power derives from our admitted addictive connection to the earth. We are children of the earth, products of the earth. The earth is our mother. We are connected to all things of the earth and all things of the earth are sacred. Everything is sacred, the four legged, the winged, the ocean, the breeze, the grass, the dirt and the garbage. Even the piles on the ground left by our four-legged brothers, what's left on our cars and our hats by birds, what's in diapers—it's all sacred and comes from sacred, pure beings. God is in all things and all things are God. Everything has spirit and is alive. God is the trees and the grass. God is the sun that gives us light and yet creates bumps on our skin, puts cataracts on our eyes and burns us up with cancer. Everything is endowed with the holiness, the sacredness, of the Almighty God which we worship deep within our heart, in that place where God dwells.

[H: Oh, you don't want all those “nasty” things? Tuff! It is part of the contract YOU SIGNED AT BIRTH in order to receive the gift in the first place. Some of you are a long way BEHIND in your work and cleaning.]

Given the importance of the land to the survival of indigenous people, it becomes clearer as to why the treaties with the Indian tribes in California were never ratified. It was so the land could be taken and the people could be displaced. Many people have expressed admiration for Ted Turner's TBS epic about Native Americans. It included the Northwest, the Southwest, the Northeast, the Southeast and, of course, the mighty plains, but it did not give a

proportionately balanced representation of California Indian people. Nothing was said about the area which contained the largest concentration of Indians in this country. In California there are people fighting for recognition, still struggling to survive, but they weren't mentioned. That's because most of us don't know anything about the first people of California. We are ignorant. We have been told they were terminated and exterminated, but they still exist.

Unfortunately, we have been taught about Indian people primarily within the context of history, as something from the past. I recently saw a calendar that contained photographs of Indian women taken from museums and out of books by Edward Curtis and other photographers. There were no pictures of living women, nothing contemporary. Based on what I have seen, that is the norm rather than the exception. In truth, Indian women are alive and kicking. They steadfastly hold the family together, they hold the hoop together. Traditionally, as long as there has been one woman to breathe, the hoop has never been broken. It's been weak and it's been buried, it's been covered with dust but it has never been broken, even though many Indian people have been convinced that it has. We bought into that idea and have allowed ourselves to be devastated even more by losing hope.

The land is important to all people because we were all brought to this place to take care of it. We have an accountability to take care of and shelter the earth as we would a child, to nurture it with all of the love possible within us. If your culture or ethnic group has not been concerned with the preservation and care of the mother earth as part of its accountability and responsibility, you have sorely missed the boat. We are having to live with the end result of those cultures which do not give thought to the sacredness of the earth and those things upon the earth which are in their place. We have seen the lack of accountability, the denial and finger pointing, blaming that group or this group, but it is all of us that allow these things to happen because one person can and does make a difference. If we have abused or allowed the earth to be abused, then we are part of that process which leads to the demise of those things which were given to us so that we might live and have abundance of spirit. Life is a valuable thing and is not to be cast aside. Those who throw life away have no comprehension of its value and cannot grasp the idea of loving themselves unconditionally. To love one's self unconditionally is to love God unconditionally because God dwells within us. God dwells within all things. All things created are God and are sacred and spiritual, not just two-legged. It is simple-minded and egotistical to think that only humans are sacred and in that thought process, we start creating hierarchies of who is more sacred and who is less sacred based on our perceived importance. We want leaders but since we think we don't have the stuff by which leadership is made, we give ourselves over to somebody else and when they fall from grace we are devastated, disillusioned and give up.

[H: This is why the concept so aptly put is “familiarity breeds contempt”. The point is that when people become very familiar in a mode of trust and yet bear other responsibilities of teacher or leader in some sense recognized or not, it becomes difficult to evaluate things objectively as presented by or through that individual. We experience that very happening constantly, for misperceptions are placed in the middle of the confusion. This

is best explained as in example of someone doing something which you are NOT and thus the personal attitude is most often that the “other” is somehow unreal or certainly not somehow credible in all things. Become very familiar with any individual and you lose your ability to be objective in all things—especially in the concept of, perchance, leadership or given-accepted responsibility. This is why, if you have a job or purpose and recognize it as it is presented, then you must take your responsibility and move on. If God be with you—who stands against you is of no merit. Fall to slings and arrows in “scatter-shot” and you hurt far more than self, for a mission can fall on such seemingly small details. Do what you are committed to do and stay the course if it be worthy of God and yourself.]

Throughout recorded history, indigenous people have been called heathens, pagans or savages, but we are none of those. We are not disrespectful of the idea of a higher power, a supreme authority. We just see it in a different way, in a way which our needs dictate. We see it in everyone and everything and, therefore, treat all things with sacredness, in a sacred way. This place called the mother earth has been, to us, the altar of our existence. As we kneel on that earth and the power surges through our bodies and as we pray for all of our relations, *Mitakoye Oyasin*, for all of those things to which we are connected and related, we are simply fulfilling the instructions shown to us in the sky that tell us what ceremonies we are to do, and when and where they are to be done. We have been given this place, this sacred earth, to protect and take care of and everyone can help us do that by supporting those issues which give us the right to do it, those issues that give us access to the places where our ceremonies are to be done.

Every one of us is a piece of the giant puzzle of existence and we fit in the place in which we find ourselves. We need to accept that and do what is called of us to do, to be accountable for who and what we are and why we are here. We were put here to breathe so that life will continue, to create oxygen with the plants, to realize that we too create life with each breath. With each breath we give life back as we have taken it in the breath before.

We are here in this place and we are accountable and responsible, not only to ourselves, but also for all our relations.

To Truly Understand the euthanasia movement, you need to look at your history: Eugenics, Euthanasia, and abortion.

Eugenics = A Form of Darwinism

Definition: The science of improvement of the human race germ plasm through better breeding.

Introduction: Eugenics is an ideology, a movement, not a conspiracy.

Margaret Sanger: The great work of her life was enlisting the feminist movement in the service of the eugenics movement.

This was Hitler’s Movement, but not his alone. It would appear he had been keeping up with American Medical Journals. Psychiatrists, namely one Dr. Foster Kennedy, President of the Euthanasia Society, Proposed giving a child until his fifth birthday to prove he was worthy of living if born with disabilities.

It has been reported that the Nazis formulated their own Eugenics and Euthanasia Laws on the backs of U.S. laws. In the 1920s the U.S. was involved in Genetic Genocide. Those who didn’t live up to certain mental, physical and social aspects were forcibly sterilized. If these options were not met, they were segregated (put into camps). In the 1930s the number of forcibly Sterilized in the U.S. was 2,000-4,000 per

year. Between 1907 and 1939, more than 30,000 people in twenty-nine states were sterilized, many of them unknowingly or against their will. Margaret Sanger supported all this as well as the U.S. immigration laws put into effect to keep out most undesirables, including jews who would flee from Nazi Germany. Because Sanger viewed Negroes as illiterate (social underclass) she hired Dr. Clarence Gamble of Procter and Gamble fame to head up a program aimed at the black population.

She had many communications with Ernst Rudin Professor of Psychiatry, and Director of Kaiser Wilhelm institute on Genealogy. Together with Alfred Ploetz and under the head of Wilhelm Frick they formed the committee on Racial Hygiene (*rassenhygiene*).

The Nazis began their program first on their own people. It has been estimated 400,000 Germans were Sterilized in Germany before they turned to the Jews and others.

To continue to understand these issues, one needs to understand BIOETHICS. (*I see the word BIO before anything and I tend to run. Generally Genetic engineering of food, i.e. bio-engineered corn (starlink). The stuff of Monsanto!*)

Bioethics: the moral and legal study of science usually pertaining to medicine.

With BIOETHICS at the top of the pyramid we work down to eugenics. The eugenics movement never died. Margaret Sanger’s work is behind the abortion movement. Although Planned Parenthood would have you believe otherwise, these words are there for all to see.

Sanger and Eugenics—Eugenics is the study of improving hereditary qualities by socially controlling human reproduction. Margaret Sanger was not a racist, an anti-Semite or a eugenicist. Eugenicists, like the Nazis, were opposed to the use of abortion and contraception by healthy and “fit” women (Grossmann, 1995).

Notice the words “Healthy and Fit”. She likened the movement to politics and social class, but truth be told eugenics is more than politics. ABORTION is a form of Eugenics. To continue:

In 1927, the eugenics movement reached the height of its popularity when the U.S. Supreme Court, in Buck v. Bell, held that it was constitutional to involuntarily sterilize the developmentally disabled, the insane, or the uncontrollably epileptic. Oliver Wendell Holmes, supported by Louis Brandeis and six

other justices, wrote the opinion.

Although Sanger uniformly repudiated the racist exploitation of eugenics principles, she agreed with the “progressives” of her day who favored:

—incentives for the voluntary hospitalization and/or sterilization of people with untreatable, disabling, hereditary conditions;

—the adoption and enforcement of stringent regulations to prevent the immigration of the diseased and “feebleminded” into the U.S.;

—placing so-called illiterates, paupers, unemployables, criminals, prostitutes and dope-fiends on farms and open spaces as long as necessary for the strengthening and development of moral conduct.

Margaret Sanger by her own writings was a eugenicist. She was also a Feminist. Some of her Quotes:

Feeble-mindedness “*in one generation becomes pauperism or insanity in the next. There is every indication that feeble-mindedness in its protean forms is on the increase, that it has leaped the barriers, and that there is truly, as some of the scientific eugenicists have pointed out, a feeble-minded peril to future generations—unless the feeble-minded are prevented from reproducing their kind.*”

(Feeble-mindedness is a term to loosely describe a lower intelligence or I.Q.)

On adultery: *A woman’s physical satisfaction was more important than any marriage vow, Sanger believed. (Birth Control in America, p. 11)*

On the purpose of birth control: *The purpose in promoting birth control was “to create a race of thoroughbreds”, she wrote in the Birth Control Review, Nov. 1921 (p. 2).*

On eradicating ‘bad stocks’: *The goal of eugenicists is “to prevent the multiplication of bad stocks”, wrote Dr. Ernst Rudin in the April 1933 Birth Control Review (of which Sanger was editor). Another article exhorted Americans to “restrict the propagation of those physically, mentally and socially inadequate”.*

On the YMCA and YWCA: *“...brothels of the Spirit and morgues of Freedom!” (The Woman Rebel - No Gods, No Masters, May 1914, Vol. 1, No. 3)*

On motherhood: *“I cannot refrain from saying that women must come to recognize there is some function of womanhood other than being a child-bearing machine.” (What Every Girl Should Know, by Margaret Sanger (Max Maisel, Publisher, 1915))*

Jesus said: *“Daughters of Jerusalem, weep ... for your children. For, behold, the days are coming, in which they shall say, Blessed (happy) are the barren, and the wombs that never bare, and the breasts which never gave suck.” (Luke 23:24)*

It would Appear that even the Lord knew this day was coming! (I saw that quote and had to include it.)

Part of the Eugenics movement is “Population Control” and survival of the fittest. It would surprise many to know that the BUSH family has been involved with this movement. To truly understand all this you must read the history of the Bush family and their dealings with Averell Harriman, The Rockefellers, Gen. William Draper, and their Dealings with Dr. Rudin, and the Nazis. In Fact his grandfather Prescott lost a senate election when he was exposed as an activist for the eugenics movement **(Is that why JEB BUSH won’t do anything?)** Also as a matter of Note, Daddy Bush was involved with mass sterilizations in third world countries as well as involved with those who perform sterilizations on Kids here in the USA.

In 1988, the U.S. Agency for International Development signed its latest contract with the old Sterilization League (a.k.a. Association for Voluntary Surgical Contraception), committing the

U.S. government to spend \$80 million over five years.

Having gotten away with sterilizing several hundred North Carolina school children, “not usually less than eight to ten years old”, the identical group is now authorized by President Bush to do it to 58 countries in Asia, Africa and Ibero-America. The group modestly claims it has directly sterilized “only” two million people, with 87 percent of the bill paid by U.S. taxpayers.

Part of the philosophy in the Eugenics movement was not only sterilizations of those deemed unfit either mentally, physically or racially, but also those deemed unproductive or to use Hitler’s terms “Useless eaters”. Dr. Ron Cranford’s philosophy falls into the latter. There must be an understanding that the dark side to bio-ethicists is the movement into eugenics and euthanasia.

Abortion = The Killing of a baby while *in Utero*. Plain and simple, MURDER For the sake of Convenience! When I was growing up we would watch medical dramas on tv. Always someone had the story line of the pregnant woman in need of medical help in a crisis. KRISTOL’S MEN IN THE BUSH WHITE HOUSE

In fact, Kristol’s personal tentacles inside all reaches of the Bush administration are immense. On March 19, 2002 *The Washington Post* described Kristol’s wide-ranging and intimate ties to key White House insiders. Noting that one Joseph Shattan had been hired as a speechwriter for the president, the *Post* added, pointedly:

Shattan, who worked for Kristol when he was Vice President Dan Quayle’s chief of staff, will join Bush speechwriter Matthew Scully and [Vice President] Cheney speechwriter John McConnell, both of whom also worked under Kristol on the Quayle staff. Fellow Bush speechwriter Peter Wehner worked for Kristol when he was chief of staff to then-Education Secretary William Bennett [himself a protégé of Kristol’s father, Irving Kristol], while National Security Council speechwriter Matthew Rees worked for Kristol at *The Weekly Standard*.

In effect, many of the very persons writing the official speeches and public statements for not only the president and the vice president, but also other key foreign policy makers, owed their patronage to Kristol. However, the *Post* noted, Kristol’s influence went beyond that. Others inside the Bush administration also owed their loyalty to Kristol:

Energy Secretary Spencer Abraham is a Kristol acolyte from the Quayle days while drug control policy chief John Walters worked under Kristol at the Education Department. Jay Lefkowitz, the new director of Bush’s Domestic Policy Council, was Kristol’s lawyer. Other Kristol pals include National Security Council Director Elliott Abrams, Cheney Chief of Staff I. Lewis “Scooter” Libby, Deputy Defense Secretary Paul Wolfowitz, Undersecretary of State John Bolton and **Leon Kass, the head of**

Bush’s bioethics [emphasis added] panel. The tentacles reach into [Bush’s personal inner circle]: Al Hubbard, a close Bush friend, was Kristol’s deputy on the Quayle staff.

What makes all of this so particularly remarkable is that Kristol himself backed Bush’s Republican primary opponent, Arizona Sen. John McCain, a feverish supporter of Israel, in the 2000 presidential campaign. As such, it might be said, Kristol—initially, perhaps, somewhat of an “outsider” in Bush circles—very much became an “insider”—and one with incredible and unrivaled influence.

One of Kristol’s critics noted the massive promotion that Kristol received in the American media, commenting as early as 1996 that Kristol was, “by quite some distance, the most widely quoted private citizen in the media [and, as a consequence] the most important strategist in the Republican Party”.

What this means, essentially, is that when the major American media wanted to promote a particular idea or viewpoint, newspaper reporters and broadcast journalists turned to Kristol for his “neo-conservative” point of view—often to the exclusion of better-known, more respected, and more knowledgeable individuals. Some say that this is no coincidence, considering what is perceived to be a strong pro-Israel bias on the part of the major media.

With William Kristol acting as an articulate and forceful media functionary, the “neo-conservative” forces inside the Bush administration have had a powerful ally who, in turn, has extremely lucrative resources—and international connections of influence—supporting him. As such, in the wake of the 9-11 terrorist attacks, when the Bush administration geared up to respond to the assault on America, Kristol and his neo-conservative forces began rallying to broaden the U.S. response against the prime suspect, Islamic fundamentalist leader Osama bin Laden, into an all-out assault on the Arab and Muslim worlds. Initially, Secretary of State Colin Powell seemed to be the one well-known figure in the Bush administration who stood in the way of an American imperial policy hinging on a war against Iraq.

Joined by the military’s Joint Chiefs of Staff in urging a cautious approach to the crisis, Powell was being confronted inside the Bush administration by a tightly-knit group of hard-driving warmongers trying to run roughshod over the administration’s stated policy and determined to subvert it for their own ends.

While Deputy Secretary of Defense Paul Wolfowitz was the Israeli lobby’s key point man inside the Bush administration pushing for an all-out assault on key Arab states such as Iraq and Syria—not to

mention the Islamic Republic of Iran—his efforts were being ably promoted by the efforts of William Kristol and his "neo-conservative" political and propaganda network.

KISSINGER AND KRISTOL

In its Sept. 24, 2001 issue, the Washington-based *American Free Press* gave a capsule summary of Kristol's background, noting that he is a member of the secretive Bilderberg group, funded jointly by the Rockefeller and Rothschild financial empires. Kristol is also a member of the Council on Foreign Relations, which is perhaps "the" elite American policy-making group—the American affiliate of the Rothschild-funded London-based Royal Institute of International Affairs.

An investigation by the *American Free Press* uncovered further details about the Kristol family's wide-ranging contacts. With former Secretary of State Henry Kissinger serving on their board of directors, the Kristols operate a company known as National Affairs, Inc., which issues two publications, *The National Interest* and *The Public Interest*.

Much of their company's funding comes from the Lynde and Harry Bradley Foundation, with which the younger Kristol was previously associated. In fact, this foundation—as we'll see further—is known for its generous funding of anti-Arab and anti-Islamic propaganda causes.

While, as noted, Irving Kristol has long been a key player inside the influential "neo-conservative" American Enterprise Institute, his son William Kristol maintained at least two other primary public relations outlets of his own:

1) Empower America, co-founded by Kristol with two former Congressmen, Jack Kemp (R-N.Y.) and Vin Weber (R-Minn.), and former Education Secretary William Bennett—three non-Jews, incidentally—all known for their enthusiastic and loudly and often stated devotion to the pro-Israel cause; and

2) Kristol's more recent venture, the newly-formed Project for the New American Century, an unabashedly internationalist pressure group calling for the exercise of American military might abroad, particularly in pursuit of measures designed to advance the interests of Israel.

Just one week after the 9-11 terrorist attack on the United States—in conjunction with neo-conservative Deputy Defense Secretary Paul Wolfowitz's campaign inside the Bush administration to broaden the war against terrorism to include efforts to crush Arab and Islamic states that are perceived by Israel to be its enemies—William Kristol issued a call to arms signed by a host of foreign-policy luminaries, echoing Wolfowitz. These luminaries, in turn, used their connections through the academic, media and policy-making establishments to pressure the Bush administration for the action Wolfowitz demanded.

THE TANGLED WEB OF RICHARD PERLE

Most influential among Kristol's collaborators who signed that letter is the ubiquitous Richard Perle, the former Reagan era assistant secretary of defense for

international security policy. In fact, Perle is perhaps the singular driving force behind a closely-knit group (including Wolfowitz) whose origins in the modern-day national security establishment go back to the 1970s when Perle was a top aide to the late Sen. Henry M. Jackson (D-Wash.).

Perle and one of his closest collaborators, Stephen J. Bryen, first appeared on the Washington scene as highly influential U.S. Senate staffers. Perle was a top aide to then-Sen. Jackson, chairman of the pivotal Senate Armed Services Committee. Bryen was a senior aide to then-Sen. Clifford Case (R-N.J.), a high-ranking GOP member of the Senate Foreign Relations Committee.

Both Jackson and Case were known as ardent public advocates for Israel. But behind the scenes, their two assistants were busy providing "special services" to the tiny, yet powerful, Middle East state.

In 1970, after the National Security Council ordered a wiretap of the Israeli Embassy in Washington, Perle was revealed to be passing classified information to an officer of the Israeli embassy. Although then-CIA Director Stansfield Turner angrily demanded that Jackson fire Perle, Jackson refused, lending fuel to the fire of long-standing speculation that the Israeli lobby had a "hold" over the veteran lawmaker.

By 1975 Jewish-American journalist Stephen Isaacs, a writer for *The Washington Post*, was noting in his book, *Jews and American Politics*, that Perle—along with another top Jewish congressional staff member, Morris Amitay, who later headed the American Israel Public Affairs Committee, or AIPAC, a top lobby for Israel—"command[ed] a tiny army of Semitophiles on Capitol Hill and direct Jewish power in behalf of Jewish interests".

THE TEAM B AFFAIR

But Perle's influence reached far beyond the halls of Congress. Not only was he a key "inside" player on behalf of the Israeli lobby on Capitol Hill, but during the mid-1970s he also played a critical part in the selection of a formal body—officially known as "Team B"—that functioned as a purportedly "independent" advisory council on intelligence estimates relating to Soviet aims and capabilities.

In fact, the members of Team B were bound by their determination to make every aspect of U.S. foreign policy geared toward policies that would prove beneficial to Israel.

To understand what is happening in our world today as a consequence of the rule of the neo-conservatives in official Washington, it is critical to understand the geopolitical events surrounding the history of the group known as Team B.

Although Team B was debated and discussed at the highest levels, it was not until the late Andrew St. George, an eminent international correspondent, formerly associated with *Life* magazine, began writing about its history in the pages of a maverick national weekly newspaper, *The Spotlight*, that the story of Team B reached a widespread audience.

Team B emerged in the mid-1970s at which time hawkish factions in the Israeli government were lobbying

hard in Washington for more arms aid and cash infusions through the U.S. foreign aid program. Loyal supporters of Israel such as Sen. Jackson argued that Israel needed more military might to protect the Middle East against "Soviet aggression"—an argument that delighted hard-line anti-communists in both political parties. Israel was playing the "Soviet card" to the utmost.

The Israelis were arguing vehemently against détente, for they feared that cooperation between the United States and the Soviet Union could result in joint actions by the two super-powers that could prove inimical to Israeli interests.

As such, it was in 1974 that University of Chicago Professor Albert Wohlstetter accused the CIA of systematically underestimating Soviet missile deployment. Wohlstetter—a widely known architect of U.S. nuclear strategy—also happened to be Richard Perle's longtime intellectual mentor. In fact, the relationship was even closer: Growing up in Los Angeles, Perle was a high-school friend of Wohlstetter's daughter.

Based largely on Wohlstetter's opening gun, Perle and other pro-Israel activists on Capitol Hill and in official Washington began attacking the CIA and demanding additional inquiry into the CIA's analysis of Soviet strength. Perle used the offices of Sen. Jackson—who was angling for the Democratic Party's presidential nomination in 1976, primarily financed by American Jewish backers—as the "headquarters" for the attack on the CIA.

However, U.S. intelligence analysts were scoffing at Israel's alarmist cries. Led by senior analysts in the Office of National Estimates, they reassured the White House that, at least for the moment, the Soviets had neither the intent nor the capability to attack a major target of vital U.S. interest, such as the oil-rich Gulf states.

Nonetheless, Israel's Washington allies maneuvered in an effort to counter-balance the findings of the Office of National Estimates. Under political pressure from Senator Jackson and other supporters of Israel, President Gerald Ford agreed in mid-1976 (while George Bush was serving as CIA director) to institute a so-called "audit" of intelligence data provided by the CIA's own National Intelligence Officers (soon to be called the "A-Team") by a committee of "independent" experts—known as the "B-Team".

However, the newly established and ostensibly "independent" group—B-Team—headed by Harvard professor Richard Pipes, a Russian-born devotee of the Zionist cause, became an outpost of Israeli influence.

(Years later Pipes' son, Daniel Pipes, would emerge as one of the neo-conservative network's leading anti-Arab and anti-Muslim propagandists, operating a well-funded think tank, the Middle East Institute—operating closely with Perle. In the summer of 2003, President George W. Bush named the younger Pipes to the federally-sponsored U.S. Peace Institute, despite the widespread objections of many persons who viewed Pipes to be a bigoted hate-monger with a single-minded political agenda.)

In any case, Richard Perle was largely responsible for the selection of the Team B membership. Paul Wolfowitz was among those selected for Team B because of Perle's recommendation. Likewise with

veteran diplomat Paul Nitze, among other prominent members of the team selected.

Anne Hessing Cahn, a later student of the Team B affair, has written that “There was an almost incestuous closeness among most of the B Team members,” quoting Perle as saying, that “The Jewish neo-conservative connection sprang from that period of worries about détente and Israel.” Robert Bowie, former CIA deputy director for national intelligence, described the efforts of Team B as “a fight for the soul of the Republican party, for getting control of foreign policy within one branch of the party”.

In the meantime, John Paisley, recently retired from the CIA, was appointed by CIA Director Bush to act as the CIA’s liaison between the CIA’s own in-house “Team A” and the Israeli-influenced “Team B”. Meade Rowington, a former U.S. counter-intelligence analyst quoted by Andrew St. George in *The Spotlight* on Feb. 5, 1996 noted: “It soon became clear to Paisley that these cosmopolitan intellectuals were simply trying to discredit the CIA’s recommendations and replace them with the alarmist view of Soviet intentions favored by Israeli estimators.”

By early 1978 the B-Team had finished its review of the CIA’s procedures and programs and issued a lengthy report that was harshly critical of almost every finding U.S. intelligence had made in previous years about Soviet military power and its intended uses.

The Israeli-influenced B-Team report said that the Soviets were secretly developing a so-called “first-strike” capability, because Soviet strategic doctrine assumed that such a sneak attack would make them the winners of a nuclear exchange with the United States. The B-Team dismissed the estimates of analysts who held that Moscow was unlikely to start a nuclear conflict unless attacked. In the end, of course, the B-Team findings prevailed and the direct consequence was that there was a virtual revival of the arms race and a massive new infusion of U.S. military and other aid to Israel during the 1980s.

Drawing on what critics charged (and which proved to be) fraudulent estimates provided by Israeli intelligence—the foundation of the B-Team’s report was the warning that the Soviet Union was fast running out of its petroleum supplies.

As a consequence, the B-Team forecast that beginning in 1980 Soviet oil production would suffer critical shortfalls, forcing Moscow to import as much as 4.5 million barrels a day for its essential needs. Starved for oil—the Israeli disinformation claimed—the Soviets would invade Iran or another oil-rich Gulf state even if it meant a nuclear confrontation with the United States.

Although the team’s final report was secret, with access reserved for a handful of government leaders, John Paisley reportedly got his hands on a copy of the report in the summer of 1978 and set to work writing a detailed critique that would destroy this Israeli disinformation. But Paisley was murdered before he could ever complete his task.

According to Richard Clement, who headed the Interagency Committee on Counter-Terrorism during the Reagan administration: “The Israelis had no compunction about ‘terminating’ key American intelligence officials who threatened to blow the whistle on them. Those of us familiar with the case of Paisley know that he was killed by the Mossad. But no one, not even in Congress, wants to stand up and say so publicly.”

Solid evidence compiled over the years by a variety of independent critical researchers in and out of government—many of them Jewish, by the way—indicates that the Zionist intriguers on Team B did indeed exaggerate Soviet imperial designs and military strategy as Paisley and other unbiased analysts contended.

DOLLAR HEADED FOR COLLAPSE—MAHATHIR

KUALA LUMPUR—The U.S. dollar is facing an imminent collapse and the global economy will suffer a “catastrophe” when it is rejected as the currency for trade, former Malaysian prime minister Mahathir Mohamad said in remarks published yesterday.

Mahathir, who famously ignored International Monetary Fund (IMF) advice and instead chose to peg his country’s ringgit to the U.S. dollar during the Asian financial crisis, said a standard gold currency was now the best alternative for world trade. The dollar was retaining some value because of fears of a global economic catastrophe if it was rejected, he told a conference of some 650 chief executives from 30 countries at a conference in Kota Kinabalu on Borneo island on Tuesday, *The Star* newspaper reported.

“But the catastrophe will come one day because even the most powerful country in the world cannot repay loans amounting to \$7 trillion,” Mahathir said.

The former premier said he believed central banks worldwide were reducing their U.S. dollar reserves and he suspected that Malaysia was also switching to other currencies.

Telling reporters that he was giving his personal views, he warned that “unless [the Americans] change their president and have a more responsible president who will try to reduce the deficit, they will have serious trouble with the U.S. currency.”

Mahathir told the CEOs it was doubtful that the sliding dollar could regain its old strength as the administration of U.S. President George W. Bush did not consider deficits worth reducing.

The huge deficit meant that the dollar had no backing but it continued to be used internationally because some people still accepted payments in dollars.

“But there will come a time when we will switch away from the dollar and we have suggested the use of gold for international trade,” he said.

...Mahathir, who was widely condemned internationally for imposing capital controls and pegging the ringgit to the dollar during the Asian financial collapse 1998, has since won plaudits for his handling of the crisis. He created a stir in January when he joined a chorus of calls for Malaysia to review the currency peg of 3.8 to the dollar given the U.S. unit’s decline in value.

THE DEATH OF THE DOLLAR

Cesar was supposed to be a god. Julius Caesar was killed on the Ides of March (March 15th).

Today, we don’t make men gods. Instead society has made our financial system into a false god.

On March 15th, 2005, (the ides of March) we may have just witnessed the beginning of the death of our financial system as General Motors stock took a nosedive from \$34/share down to \$30.

It does not seem like much (GM down just over 10% in one day), but as of March 17th, the stock is down to \$28.35, and the market cap is down to \$16 billion. (GM is down nearly 18% for the week.) It’s the type of volatility that we usually only see in silver stocks!

...Apparently, someone in power did the equivalent of shouting “the emperor has no clothes” and people woke up, and are beginning to see more clearly! The media decided it was time to expose the truth that GM is nearly insolvent, and will expect to lose \$1.50/share in the first quarter alone!

But the story is worse than that! GM has \$300 billion in debt ... and has a market cap, now, of \$16 billion. See the problem there? The bondholders could buy the company nearly 20 times over if they used their money to buy stock instead of loan it to the company. The implication is clear—that GM is headed towards bankruptcy, and will default on the bondholders, who will then own a company worth less than \$16 billion dollars!

For every one point that interest rates rise, refinancing GM’s debt will cost an additional \$3 billion in annual interest payments—money that they clearly do not have! Where is GM going to get another \$3 to \$6 to \$9 billion as interest rates rise by 1%, 2%, and 3% more? Selling cars? Nope. Selling stock? Unlikely in this market! Borrowing more? From whom? The U.S. government itself is propping up this bond market, and there are no buyers even for U.S. bonds, and there haven’t been for months now!

So, therefore, GM will soon be a \$300 billion dollar blow-up! How big is that? It’s bigger than Enron, Global Crossing, LTCM, K-Mart, and the IRAQ war all put together!

\$300 billion going belly up is a big enough event to topple the U.S. government! ... It will shake the confidence in the entire financial system. Companies as big as GM are not supposed to go bankrupt in our “normal” world. They are “supposed” to be “too big to fail”.

The value of the “official” U.S. gold hoard of 261 million ozs., at \$440/oz. is only a mere \$115 billion. [Russia holds more gold than the U.S. and Russia is all but completely debt-free and thus in a much better position to withstand an economic collapse.]

See what this \$300 billion blow-up will mean? Imagine the financial chaos as a pile of wealth almost three times larger than the current value of the U.S. “official” gold hoard evaporates!

The annual deficit is around \$700 billion. How will the U.S. government sell bonds to finance the deficit if bondholders are getting wiped out?

If the government can't sell bonds while running a deficit, then the government must simply be printing money to fund the deficit—and they are, as can be seen in the rate of growth of the money supply, **M3 [which is increasing at the rate of almost one TRILLION dollars per year]!** Therefore, inflation is raging, and interest rates must keep pace, which is why GM is doomed!

Interest rates must head up, as confidence in the U.S. dollar bond market will be shaken like a tree in a hurricane!

Foreign nations are all sounding the alarm already that they will be selling U.S. bonds to diversify the holdings of their central banks: Russia, India, China [*all primary Alliance members*], South Korea, Japan... what major foreign nation is left to buy them?

LAVROV GOES TO LUXEMBOURG TO PREPARE FOR MAY SUMMIT

MOSCOW/BRUSSELS—Russian Foreign Minister Sergei Lavrov is scheduled to participate in a session of the Russia-EU Permanent Partnership Council, a ministry spokesman said.

The meeting is designed for discussion of four Russia-EU common spaces and coordination of the EU-Russia Summit to be held in Moscow May 10.

The perspectives of Russia's relations with the EU, taking into consideration what has been called “**the 2007 factor**”, **when the new EU constitution comes into force, the Russia-EU Partnership and Cooperation Agreement's initial term will expire and Russia will enter the WTO.**

“In these conditions, it is important to prevent the occurrence of a vacuum in our relations and adequately adapt the existing cooperation mechanisms,” Foreign Ministry spokesman Alexander Yakovenko said.

...The Cooperation Council at the level of foreign

ministers was formerly responsible for coordinating cooperation between Russia and the EU and had the right to adopt decisions, obligatory for both sides. However, it was decided at the EU-Russia Summit in St. Petersburg in May 2003 to reorganize the Council into the Permanent Partnership Council.

“Its sessions meet in the format of not only foreign ministers, but also ministers supervising other branches of the national economy,” Yakovenko said.

SPAIN RISKS U.S. ANGER BY SELLING ARMS TO CHAVEZ

MADRID—Spain's socialist Prime Minister, Jose Luis Rodriguez Zapatero, has been forced to defend a decision to sell arms worth •1.3bn (£900m) to the left-wing Venezuelan President, Hugo Chavez, in a deal condemned by the opposition as “a monstrous error”.

In Spain's biggest arms deal for many years, its arms factories will supply ten C-295 transport planes, four coastal patrol corvettes and four smaller coastguard patrol boats to Mr. Chavez's army. Mr Zapatero said the vehicles would be used to monitor coastlines, combat terrorism and drug traffickers, and mount rescue operations during natural disasters....

Washington has become deeply anxious about President Chavez's arms build-up. The Venezuelan leader recently bought weapons and equipment from Russia and Brazil. The U.S. Defence Secretary, Donald Rumsfeld, said he could not imagine why Venezuela, with an army of 34,000, wanted 100,000 AK-103 assault rifles, reportedly bought from Russia. “I am worried. I personally hope [that deal] doesn't happen. If it does, it won't be good for the hemisphere,” Mr. Rumsfeld said.

Venezuela, the world's fifth largest oil exporter, is a major supplier to the U.S., but President George Bush strongly disapproves of President Chavez's left-wing populism. Wary that Mr. Chavez might undermine American influence in the region, **Washington backed a failed coup against him in April 2002** [*emphasis added*] and ... described his government as authoritarian.

Mr. Zapatero, who, on his election, withdrew Spanish troops from Iraq, has reversed the pro-American stance of his conservative predecessor, Jose Maria Aznar.

Mindful of Spain's historic links with Latin America, Mr. Zapatero has this week spearheaded Europe's first mission of solidarity with three progressive presidents of the region—Inacio Lula da Silva of Brazil, Alvaro Uribe of Colombia [*surprise!*] and Mr. Chavez, joining their summit this week in Venezuela....

China is becoming good friends to many African nations, as the U.S. has been. **Between 2002 and 2003, China-Africa trade jumped 50 percent**, to \$18.5 billion, Chinese officials say. It's expected to grow to \$30 billion by 2006. U.S.-Africa trade was \$44.5 billion last year, according to the Commerce Department. As the world's largest oil importer behind the U.S., China has oil interests in Sudan, Chad, Nigeria, Angola and Gabon....

Under the auspices of the UN, the China-Africa Business Council opened this month, headquartered in China, to boost trade and development. It has peacekeepers in Liberia and has contributed to construction projects in Ethiopia, Tanzania and Zambia, though critics say it is using these projects to garner goodwill that it can tap into during prickly issues like Taiwan's independence or UN face-offs with the U.S.

NEVADA CORPORATIONS:

Maintaining Privacy Of Corporate Records

Budget's "Tip of the Week" #2:

NRS 78.257—Right of stockholders to inspect and audit financial records; exceptions

Last week we discussed *NRS 78.105* and how it appears to have been written specifically to provide access to the corporation's records by the corporation's *stockholders*. What about a case where the stockholder's interest in accessing the records has nothing to do with the stockholder's interest in the corporation? And what about other parties who might want to access the corporation's private records? *NRS 78.257* holds the answer to those questions, though the answers are, no doubt, NOT what such parties might wish to hear!

After defining who is entitled to inspect the corporate records and the notice that must be given for doing so in paragraph 1, then specifying that the inspecting party bears the costs of extracting such in paragraph 2, *NRS 78.257*, paragraph 3, states (emphasis added):

3. The rights authorized by subsection 1 may be denied to any stockholder upon his refusal to furnish the corporation an affidavit that such inspection, extracts or audit is not desired for any purpose not related to his interest in the corporation as a stockholder. Any stockholder or other person, exercising rights under subsection 1, who uses or attempts to use information, documents, records or other data obtained from the corporation, for any purpose not related to the stockholder's interest in the corporation as a stockholder, is guilty of a gross misdemeanor. ...

A gross misdemeanor conviction is punishable by incarceration for up to one year in the county jail and a \$2,000 fine. Note that this statute spells out rights of the *stockholders* to inspect corporate records—the *stockholders*, not "just anyone". **There is no mandate of any kind for non-stockholders to ever inspect any corporate records. It is a gross misdemeanor for any non-stockholder to even attempt to use information from the corporate records in any way contrary to the interests of the stockholders.**

Next week, we'll look at a method of owning a corporation without owning its stock—and yes, the answer to that riddle can also be found built right into the *Nevada Revised Statutes!*

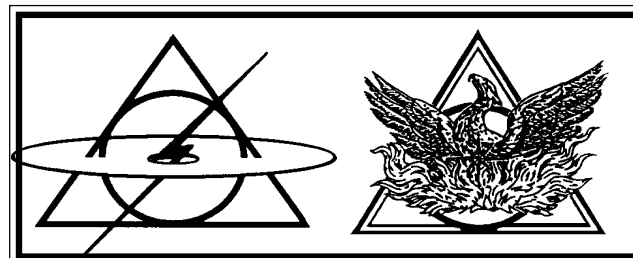
