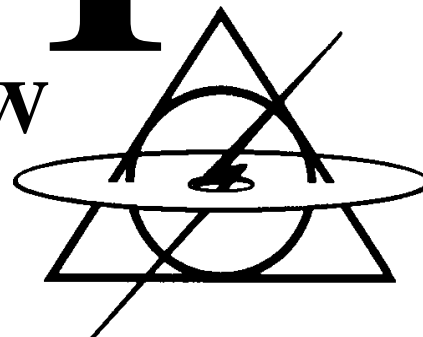

GOING BERSERK

President Gloria Macapagal-Arroyo (GMA), the 14th President, continues to rack up a record of achievements unmatched in Philippine history. Among them:

1) The highest level of public debt (P4.08 trillion—\$78B—as of yesterday) and the highest amount of foreign borrowing. (More than Corazon Aquino, Fidel Ramos and Joseph Estrada combined).

2) The No. 2 most corrupt country in the world; No. 1 in Asia according to the World Economic Forum and Asian Development Bank.

3) The most dangerous place for journalists in the whole world, according to the New York based Committee to Protect Journalists (CPJ) and earlier the London-based ICJ.

4) The new *shabu* (methamphetamine) manufacturing center in Asia.

5) The harshest repression rate of freedom of speech and of assembly topped by a "no-permit, no-rally" policy.

6) The highest unemployment rate (13.9 percent or five million unemployed) and the highest underemployment rate including the collapse of the garment industry.

7) The weakest link in the war on terror and the loss of standing and respect in the international community accompanied by the deterioration of U.S.-Philippine relations.

8) The most expensive and the most fraudulent elections ever held on May 10, 2004.

9) The fastest deterioration in the poverty line from 32 percent under President Erap to 47 percent in four years.

10) The highest price of oil products ever (P33 per liter).

11) The highest dollar-peso exchange rate (P56 to \$1)

12) The highest importation of rice over a four-year period (more than 5,000 (sic, should be 5 million) metric tons) indicating a failure in agriculture.

13) The most number of casinos and gambling establishments.

14) The most number of foreign and domestic trips by a president.

15) Control of the Supreme court and inferior courts.

16) The largest number of retired Armed Forces of the Philippines (AFP) and Philippine National Police (PNP) officers appointed to civilian postings.

17) The biggest number of doctors, nurses, managers, professionals, even domestics and caregivers LEAVING the country.

18) The biggest percentage increase of service and clearance fees, tolls (3,000 percent), license fees, ever imposed by any administration. You even have to pay to enter a National Bureau of Investigation office.

19) The lowest amount (\$14 million) of foreign investment in any given year.

20) The biggest number of pyramid scams, pre-need plans bankruptcy, thereby a failure to protect consumers.

21) Condemnation by the German government and business associations on the Fraport-Piatco issue [Airport fiasco].

22) The PEACE bonds scam giving away P1.8 billion to Code NGO and incurring a P35 billion additional debt in the process.

23) The biggest importer of used cars and tax-free luxury cars.

25) Control of ALL TV stations.

URGENT COMMENTS OF THE DAY

I must not move on until I have pointed out some important notations to consider as to the team in Manila and as well to allow you readers to see and experience the varied fronts of possibilities and potentials.

T-A FOUNDATION (FDN)

There has been a bit of misunderstanding, EJ, regarding the Court of Appeals (CA) hearing tomorrow, Fri. 13. This is not for the purpose of singularly deciding on the position or standing of Julian Tallano. The hearing will decide whether or not to

allow the FDN to “intervene”.

This is the logical sequence of events so that the issue of whether or not the PERSON presenting as Julian Morden Tallano is “the” legitimate person individual. It won’t matter once the FDN is recognized!

Since Judge Reyes will be present and probably be asked to testify as to “knowledge” of individuals who have appeared before him and to comment on the legitimacy of the petition and standing of the FDN, it “should” go quite well. However, there is so much consternation over the whole hornet’s nest as to shock and awe, so just go with the punches. The FDN now has excellent standing and yet has no legal way of enforcing inventories, responsibilities, etc., after two “annual standing” reports. Since all those documents are now filed and registered, things can proceed as to court recognition. Just play through for it is but one attention focus.

FOREIGN JOURNALISTS AND THE PHILIPPINES

Foreign journalists, in spite of warnings, are “flocking” to the Philippines BECAUSE THE WORD IS OUT THAT THINGS ARE “COMING DOWN”. BY “COMING DOWN” IT MEANS THE DISPOSITION OF THE FALSE PRESIDENT AND ADMINISTRATION, PROBABLY THE GOVERNMENT AND JUDICIAL SYSTEM AS WELL, ARE READY TO TOPPLE.

OUR PEOPLE WILL **KEEP CLEAR OF IT.**

PASSPORTS AND VISAS

Since there is a possibility of obtaining a “visa” coverage of some kind to allow for no foreign mandatory trips, you might want to inquire or have “Bob” inquire since he has worked his way into the circles of legitimate access to “exceptional” recommendations. By “exceptional” I only refer to “outside the typical ongoing 60-day mandates”. This does NOT refer to actual “exceptional” handling.

If it is not easily accomplished or accomplished for less than the cost of the annual trip required, go with the trip and never mind further requests until we are past the need for extensions, get passports renewed at the Embassy and “check out the water”. Things should be getting far less complicated along those lines quite soon now.

GOSSIP AND RUMORS

Since things are heating up so measurably and even the incarcerated young soldiers from the Oakwood “Incident” are being released along with the blow-out of the case against Estrada, things will hop, skip and jump right along in Philippine time allowances.

You can note the big shift out of government positions by Cabinet members while some are replaced by extremely coddled criminals just to “get through” this “time”. Watch closely when a criminal from Health Insurance fraud is put into the slot as head of HEALTH affairs as SECRETARY because the one in place, Mr. Dayrit, refused to stay after all but being ordered to do so by the False President, Arroyo. The crooks are peeling off like onion skins so PAY ATTENTION.

U.S.A. INVOLVEMENT?

The most important and most telling clues are now falling around the U.S. Embassy turn-over. U.S.

Ambassador Francis Ricciardone, yesterday, sent the loudest shot across the bow yet noticed.

Not only is the *Charge d’Affaires* already GONE but Mr. Ricciardone is departing next week after wrapping up last minute affairs of a personal nature. He has, however, made an official statement that might well curdle the blood of the criminally sitting President of the Philippines:

He has stated that the U.S. Government “opposes a violent extra-legal overthrow of the Arroyo administration but that Washington is open to a changing of the guard in the country if it is done within the bounds of Constitution.”

He continues: “I’ve said publicly and privately to people that if you wanted to know the attitude of the U.S. on political change, **we are for it.** We think change is an important thing in any living, breathing, dynamic political system.”

He also stated that during his stay he had noted NO investment flow and things have deteriorated continually. Gloria Arroyo really has little or no “China Card” to play when you actually look at circumstances for China is growing without anything from the Philippines. That would come later and without need for violence.

I would point out one more interesting thing: Imelda Marcos is asking for clearance to make a “health” trip “to China” because of her knees. Now isn’t that just too interesting to miss? Now THAT does represent a “China Card” of some great significance so keep your eye on that one too. Always “follow the money”, so to speak, and keep patient for patience is THE STRATEGIC CONSIDERATION FOR “OUR TEAM”.

AS TO ESTRADA AND “OCULAR” EVALUATION BY THE COURT

The flaws of the prosecution case against Estrada surfaced in a BIG WAY at yesterday’s inspection of the supposed (as claimed by self-admitted criminal, Governor “Chavit” Singson) star witness against Erap. THE CLAIMS COULD NOT HAVE HAPPENED—PERIOD. Moreover, Singson had claimed to be an eyewitness to the delivery which dropped off some P130 million in “one” delivery in satchel to Erap personally.

AGRO-FORESTRY & INDUSTRIAL DEVELOPMENT PLAN

INTRODUCTION

It is difficult for the mind to grasp the extent of the rape, pillage and plunder of the smaller nations of Southeast Asia. As an example, nearly one third of the jungle, forest, and timberland of the Philippines has been denuded: 8 million of its 30 million hectares stripped bare and the fragile topsoil left for the monsoons and typhoons to wash away, destroying the life in the streams and rivers on its way to silting and ruining the bays and ports. With no vegetation to protect them, the hillsides come crashing down in mammoth landslides, killing hundreds of people every year.

It is quite easy to say that the answer to these problems and others such as increasing carbon dioxide and depleting oxygen lies in reforestation. It is quite another matter to accomplish any significant amount of reforestation. Many of those elegant Narra and Philippine Mahogany trees took hundreds of years to grow and they cannot be replaced, even in a century. Faster-growing species, such as Eucalyptus and Paulownia, are mature enough to harvest in 12 years but even that is a long time to wait for a return on an investment, especially since those trees must be irrigated at times and washouts repaired at other times so the expense doesn't stop with the planting.

Ruben G. Camurungan, Ph.D. (Doc), an agronomist extraordinaire with years of experience in the sugar business leading to extensive knowledge of the manufacture and uses of the several types of alcohol, has envisioned and worked out all of the myriad details of what appears to us to be the "break-through" worldwide solution to this worldwide problem. Ethyl alcohol (ethanol, sometimes called denatured alcohol) is the same component that furnishes the hangover (and the preliminary euphoria) in whiskey, beer, wine, vodka, etc. It is also used in "Bunsen burners" in school laboratories that burn with such a beautiful blue and smokeless flame. Mixed with gasoline, ethanol increases octane, is much cleaner-burning, is non toxic, water soluble, and also quickly biodegradable. Most modern cars and trucks are factory-equipped with "flexible fuel" systems designed to burn up to 85% ethanol. Currently, in the state of Iowa, USA, 72% of all the fuel sold contained ethanol. The market is enormous.

Dr. Camurungan, President of ARCAM Holdings and Development Corporation, describes his system: "Plant fast growing trees, (e.g., Eucalyptus, Paulownia, etc.) for the production of raw materials for integrated wood industries; in between rows of trees, plant agricultural crops, preferably sugarcane, sorghum, cassava, corn, and/or sweet potato as raw material for alcohol production, for animal feeds production, or for other downstream industries, while waiting for the trees to mature. Agro-Forestry Farm size may vary from 5,000 hectares at the lowland areas to 60,000 hectares combination of foothill and upland areas."

Probably the most important feature of the agri-program is its economic feasibility. While it takes some two years to clear, level, pre-condition the soil, install the irrigation system, and plant trees and the agri-crop, before the end of the two years there should be harvestable agri-crop available to sell or process to alcohol. By the end of the third year the agri-crop is projected to support the entire project and begin to pay back the investment with a projected rate of return of some 32%. At current margins of profit for the alcohol, the agro portion of the project can pay for itself in 5-6 years.

Said another way (for "investors"): Who would not jump at the opportunity to invest in a project that will pay for itself in 5-6 years and yield a return of some 30% per year thereafter? On top of that, after twelve years the rate of return is nearly 100% per year.

Again quoting Dr. Camurungan: "Sources of revenues are: (1) Sales from Salvaged Logs; (2) Sales from Alcohol; (3) Sales from Animal Feeds; (4) Sales from thinned-out Logs starting on the 7th year and thereafter; and, (5) Sales from commercial logs harvested starting on the 12th year and thereafter. It takes 12 years for the Eucalyptus trees to mature, from planting time to harvest. The project shall have paid for itself even before commercial harvesting of the trees starts. On the 12th year and thereafter, when commercial tree harvesting starts, annual gross income from operations amounts to almost the total value of investments."

THE PROCEDURE

While the procedure is not too difficult to comprehend, the magnitude of the project(s) and the benefits thereof may be a bit mind-boggling. For the first project in an area, a ravaged area of sufficient size (at least 24,000 hectares (59,300 acres)) that has an existing or potential water and power supply should be selected. (Adequate electricity must be available to build a small city or the agri-portion of the project will run too far ahead because it may take 2-4 years to build the required multipurpose hydroelectric/irrigation facility.)

Dr. Camurungan: "A Community Center and an Industrial Complex will be established in every project site, employing rural and urban population. Each Community Center will be complete with basic infrastructure. Livelihood and social concerns are addressed. ..." (Let us point out that if 5 workers are required per hectare at least 120,000 workers are required just for the agri-portion of the project. Putting that together with all of the people required to run a city to support that many workers, plus the distillery and "Industrial Complex" and we see a city of some 800,000-1,200,000 people. And let us remind the reader that we are describing one project of 24,000 hectares.)

"Tree Farm Development: On a 24,000-hectare Agro-Forestry Farm module, for example, 2000 hectares are developed and planted every year with Eucalyptus trees. In between rows of trees, Cassava / Sweet Potato / Corn are planted, harvested every year and processed into alcohol and/or animal feeds.

"Tree Harvesting: On the 12th year, and every year thereafter, 2000 hectares of Paulownia or Eucalyptus trees are harvested and planted anew. In this manner, at any point in time, 2000 hectares are being harvested while 22,000 hectares of trees remain standing, at progressing stages of maturity. Thus, the commercial tree farm is always green all year round, an undertaking that would guarantee the establishment of a sustainable forestry program."

In most poverty-stricken countries there are only a few areas of denudation close by sources of power and water so a very critical part of this program will be the construction of multipurpose hydroelectric/irrigation dams with their accompanying distribution systems. In some places irrigation may not be necessary but to lose one or more years' plantings and saplings to drought would prove very expensive and would also interrupt the "rolling" harvest schedule. Obviously, it becomes necessary to select one or more areas that are immediately viable to begin the program while dams and generation facilities are planned and built in other places to serve the new little cities that will can be well-planned and beautifully built.

At this point we must observe that arable land should never be used for homes and the buildings of cities. In the U.S. states of California and Florida homes and cities have been allowed to crowd out the produce and citrus-growing acreage so that they are becoming net importers of food. It is best to build the cities on hilly or rocky ground that will support only ornamental shrubs and trees, thus preserving arable land for food production.

After a site is selected, ownership of the land must be gained (or joint ventures established) and the

proper permits obtained from the myriad agencies that will be involved. Once the paperwork is all in place a “tent city” can be put up to house the people who will operate the equipment to begin clearing the land so that the city and reforestation area can be started.

COMPONENTS OF A TYPICAL COMPLETE FACILITY

While recognizing that all denuded or logged-over areas are not precisely 24,000 hectares in size (that is an area approximately 10 miles by 10 miles, 16 kilometers by 16 kilometers), we will continue to describe that as a “model” example. We must admit that, for professional city planners and architects, to be able to plan a beautiful city for well over 1 million people, “from the ground up”, will be a pure joy. Actually, they will start from 6-8 meters (20 feet) below ground to dig the drainage and service (communications, water, electricity, natural gas (or hydrogen), and sewage disposal) systems in a labyrinth of interconnected concrete tunnels beneath every street and thoroughfare. This is more expensive in the beginning but will pay for itself many times over in avoided maintenance costs and the beauty of the city is enhanced because there are no overhead wires or utility poles.

In the city the streets can be very wide so that buses have their own lanes. Overhead covered walkways with moving sections and escalators up and down in heavily traveled areas can be provided between offices and shopping malls. Shops can all be contained within the malls so as to eliminate the vendor clutter on the open, tree-lined streets and sidewalks. Parking structures with ground-floor auto sales and maintenance facilities can be spaced around the perimeter of the malls.

We have estimated that each 24,000-hectare project will require as many as one million people. Here is how we arrive at that very conservative conclusion:

A hectare is equal to 2.5 acres and the estimated number of workers required to attend the reforested area with its intercrop of corn, sugar cane, and various root crops is 5 per hectare, or 2 per acre. 24,000 multiplied by 5 is 120,000. To man the Industrial Complex will require an additional 2,000 so we have a base employment of 122,000.

The average number of children per Filipino family is five. Five times 122,000 is 610,000 so we have to have 15,250 teachers (at 40 students per teacher), 12,000 policemen, 12,000 firemen, etc., all of whom have children, requiring more teachers, etc.

If the number of shopping malls to serve one million people is two, when we add the sales clerks, executives and supervisors, all of the health services people, municipal employees and service/repairmen, we reach a number of 85,000 support workers, adding up to 207,000 total employees. After a very large page of computer calculations we arrive at a total population of 1,119,600. If our margin of error is no worse than 10% the figure of 1 million should be acceptable.

INVESTMENT REQUIRED

As in most endeavors, labor is the major cost. In this project, wherein we can expect no serious income for at least two years while the labor cost is at or near

its maximum, it is the most difficult hurdle to overcome. Furthermore, if we are to demonstrate a corruptionless society wherein there is no need for corruption, we will want to pay those 207,000 employees adequately. While we have no reliable benchmark to use, the Sagip Pinoy program of Jose B. Comendador uses the amount of \$652 per month as his target, and based upon our knowledge of the huge amount of research he has done, we believe that in a rural setting where most of the transportation is furnished, the average family can be comfortable with \$20 per day, at least in the two “start-up years”.

Twenty dollars times 207,000 is \$4,140,000 per day, a two-year total just over \$3 billion. The pre-planned underground infrastructure, streets, street lighting and sidewalks are estimated at \$10,000 per home, about \$2 billion. At \$24,000 per good quality 3-bedroom home, 207,000 homes cost about \$5 billion. Estimating 6,000 students per school, approximately 100 schools are needed and, at \$10M each, comes to \$1B. Four hospitals could cost about \$40M, and 2 Malls at \$200M each are \$400M. Last, but not least, Municipal buildings and equipment, fire and police buildings and equipment should cost about \$200M. The grand total is approximately \$12 billion—an investment of \$12,000 per person. The cost? To whom? To the “government”? If the Global Alliance Program is used, it doesn’t cost the government anything. More on this later: in Sovereign Economics.

PRODUCTS AND MARKETING

The primary products will be ethanol, wood products and veneer, pulp for paper, lumber, and animal feed. Secondary products will be electricity, hot, drying air generated by waste and scrap-fired steam-powered co-generators, effluent distilled water to be filtered and bottled, and carbon dioxide (dry ice).

The profitability of ethanol production has recently been increased by several multiples by the doubling of the price of crude oil, with which it must compete as a source of fuel. When crude oil is costing some \$20/bbl, refined gasoline is priced at approximately \$0.20/Liter (at the refinery). Now that crude oil is above \$40/bbl, at the refinery gasoline is at least \$0.38/Li. Ethanol can be produced for \$0.16/Li (using cassava feedstock) to \$0.26/Li (using sugar cane feedstock), and the cost is not nearly so vulnerable to international manipulation as is the cost of crude oil.

Ethyl alcohol has many uses besides being a preferred substitute for gasoline, but the demand for the huge volumes as fuel is what suddenly propels it to the position of being the centerpiece of a technology that can alleviate poverty all around the tropical girth of the world (as well as wherever corn, sugar beets, potatoes and sweet potatoes thrive). The advantage of the tropics is that many crops can be grown and harvested twice in one year.

There is, of course, more to the project than just producing the alcohol; it must be mixed with gasoline or diesel and distributed to service stations where it can be sold. Dr. Camurungan has an arrangement with GMT Trading, Inc. who will take the alcohol to its refinery (where it will be refining crude oil into gasoline and other derivative products) where it can be mixed with gasoline and/or diesel and then distributed to its network of service stations.

Since 1999 the major auto makers in the US and

Europe, and Nissan in Japan, have been manufacturing all of their engines to use a mix of 15% gasoline and 85% ethanol. This modification has been named “flexible fuel” and includes a sensor that determines the percentage of ethanol coming from the fuel tank and adjusts the fuel/air mix to match the cleanest burning mix to the throttle setting. Other makes and older cars can use a mix of 90% gasoline and 10% ethanol so, at least in the early period of distribution, the latter mix will be available. Ethanol is corrosive and requires stainless steel storage and vehicle fuel tanks as well as Teflon-coated hoses and fuel lines so modifications must be made to service stations before the much lower-priced “E85” is widely available, although a few better-financed operators might want to get a head start by making the modifications to dispense E85 from a special pump.

POWER AND WATER

There are probably a few areas in most countries where there is sufficient electricity and irrigation water to support at least one “unit” of the AGRO-FORESTRY & INDUSTRIAL DEVELOPMENT PLAN. In the Philippines there are no doubt several but there are many more denuded and logged-over areas that have virtually no electricity and/or no irrigation water. These areas will require the installation of a large dam to impound the water and a hydro-electric generating system to extract the energy from the water as it is released into the irrigation system.

POWER & SYNERGY, INC. is a 10-year-old company that is led by engineers with several decades of experience in power generation of virtually all kinds. It is currently working with Dr. Camurungan to locate and evaluate sites for the Agri-Forestry projects, the most immediate in the province of Nueva Ecija near the city of Cabanatuan in the Central Luzon Valley. The dam and hydro-electric generator would be located in the Sierra Madre Mountains on the eastern side of the valley, an area much abused by illegal logging. The dam will impound enough water to irrigate some 100,000 hectares (the equivalent of 4 Agro-Forestry projects) and will generate some 100 megawatts of electricity, an ample amount for the projects with some left for export to the surrounding area through the national grid. This system is projected to cost some \$200 million for the dam and generator plus \$100M for the electricity and water distribution systems.

SOVEREIGN ECONOMICS

The current selling price for gasoline is \$0.55 per liter—or \$2.08 per gallon. (It requires 3.78 liters to make 1 gallon.) Each hectare will produce an average of 5000 liters (per crop)—or 1320 gallons—at a current maximum price of \$0.45/Li—\$1.66/gal., for a total of some \$2,200, and that times 24,000 hectares gives us ethanol maximum gross income of some \$50 million per crop. Two crops would earn \$100M per year. There are other products to be sold and in the 12th year when the first timber crop is harvested the gross income should more than double to over \$200M, making the Agro-Forestry-Industrial portion of the project very profitable.

But the “City” portion is quite a different problem.

The interest alone on \$12B at a very low 2% is \$240M per year so from a purely traditional banker's economic analysis, taking the entire project as one whole, it could not be funded because the income is insufficient.

However, with the aid of the DON ESTEBAN BENITEZ TALLANO & DON GREGORIO MADRIGAL ACOP FOUNDATION, INC. (FDN), and the GLOBAL ALLIANCE INVESTMENT ASSOCIATION (GAIA), it can be funded quite easily and can serve as an example of Sovereign (Gold Based) Economics.

The FDN is the steward of 50% of the estate that was created by King Luisong long before the Spanish first came to these islands. Some 617,500 metric tons of gold were leased by the Philippine government in 1949 from its owners, Tallano and Acop, most of which should still be in the vault of the Central Bank in Quezon City. The Original Certificate of Title (OCT No. T-01-4) was last acknowledged in the Pasay City Court (RTC 111) of Judge Ernesto A. Reyes in October of 2001. The title means that most of the land that has not yet been transferred to beneficiaries of the Agrarian Reform Act, or is in some other way subject to legitimate public or private ownership, is under the stewardship of the FDN with the mandate to distribute it to the poor farmers. What better way could be imagined than what has been described above?

GAIA is the holder of a very large debt of the U.S. Treasury and its DEEDS OF ASSIGNMENT FOR CONSIDERATION (DEEDS) are designed to be used as RESERVES in all of the banking systems in the world, just as is any other U.S. Treasury debt.

The matter of SOVEREIGNTY arises when a nation's banking system is considering the use of the DEEDS. Most bankers are accustomed to getting their education and directions from the IMF or World Bank personnel and seldom act as though they live and work in a sovereign nation that can decide upon what it will base its money. As soon as this, or any other, nation decides to use the GAIA DEEDS as banking reserves they may do so. No one will object—mainly because no one has any right to object because it is a matter of SOVEREIGNTY.

To return now to the funding of the project. GAIA is interested in transforming some of its "paper" debt from the U.S. Treasury into gold so that its assets will not decline if the U.S. dollar declines in value as compared with gold. GAIA is willing to give 50% of its asset to entities (nations, local governments, NGOs, etc.) for their assistance through the use of a Joint Venture Partnership with the entity: GAIA puts up the RESERVES which the JVP presents to its domestic commercial bank which uses those RESERVES to issue its own payment for gold which it then uses as the final RESERVES upon which to base lines of credit to the Project Proponent and GAIA.

To give that "life", we can illustrate how the FDN and GAIA would help fund this project and perhaps hundreds more like it. Before we do so, however, we will mention that the program has "stabilizers" and "safety nets" built in so that it will operate effectively in virtually all economic environments and conditions. To save space and the readers' time we will not print the several pages required to describe those here.

Having calculated that the Agro-Forestry project will require the equivalent of some \$12B for the arbitrary "unit" of 24,000 hectares producing an

average of 240,000,000 liters of ethanol (at two crops per year), we could use that formula to estimate the funds required for projects of different sizes. The following illustration will apply to one unit.

To stabilize and protect the transaction from external interference, GAIA will arrange to purchase 2,500 metric tons of gold (the amount calculated to fund a project requiring \$12B) from the FDN at a premium price of \$500/oz. At the same time GAIA will form a Joint Venture Partnership with the National Treasury (thus creating a new and separate entity) to effect the purchase of the gold at the current LMER (London Metals Exchange Rate) so that the National Treasury cannot be criticized for overpaying.

Two GAIA DEEDS are required, one for \$40B to purchase the gold from the FDN, and the other for \$33B to be used by the JVP to purchase the gold from GAIA, making the total collateral "at risk" \$73B.

To clarify, all banking is based upon RESERVES and the GAIA DEEDS are designed to serve as banking RESERVES, the same as any other U.S. Treasury debt. Banks, Central Banks, and National Treasuries all hold and maintain RESERVES and are expected to issue new credit, or in the case of a Central Bank or National Treasury, new currency and/or credit commensurate with those RESERVES. This results in an increase in the "money supply". When a nation allows an increase in its money supply without a concomitant increase in its legitimate RESERVES, the value of its currency unit will decline. This is called "inflation" because there is no legitimate "backing" for the new money issued. Conversely, if the new money issued is used to buy gold to be placed in its RESERVES the QUALITY of its RESERVES will be enhanced and the value of its currency unit will be increased.

In this case, the GAIA DEEDS are used as RESERVES for a short time so that new money/credit can be issued to purchase the gold from GAIA that GAIA has purchased from the FDN.

GAIA then pays the FDN the first tranche of \$30B (the current LMER less a reserve of 10% to cover interim expenses). When the gold (or title thereto) is delivered to the JVP it is divided into two equal parts; one part is assigned to the National Treasury and the other to GAIA. When the price of gold reaches a "target price" of \$500/oz, GAIA can then sell enough to pay the second tranche (which includes the 10% reserve) to the FDN, bringing the total received by the FDN to \$500/oz.

The court's mandate to the Administrator in 1976 was to establish a Foundation to administer 50% of the assets "in the interest of the Philippine farmers, poor families and their children either Christian or Muslim especially those who become victims of martial law, and to uplift, economic, social and health condition of those families living under poverty line by providing employment with the use of the proceeds of the sale of the estate which the administrator is authorized to do so." The above-described transaction places \$30 billion in the hands of the FDN with which it could very easily establish a Joint Venture with ARCAM Holdings and Development Corporation, furnishing not only the land but also the funds with which to build the city and do the project while carrying out its mandate to near perfection.

BENEFITS

Some of the benefits of such projects are obvious; some are not. Employment and living conditions will be vastly improved for some 1 million people per "unit". Unproductive land, and some that is endangering other land and people, will have been returned to active, high-value production, never to be "lost" again. The erosion of precious topsoil that kills fish and silts up harbors and bays will have been arrested; soon the streams and rivers will again be clear and filled with fish and other beneficial aquatic life. Forested areas, such as these will become, feed moisture back to the atmosphere, helping to enhance and maintain a better balance of rainfall. Growing plants take carbon dioxide from the air and give off oxygen; these projects have the potential, if there are enough of them world wide, to reverse the depletion of oxygen in the air we breathe while decreasing the so-called "greenhouse effect" of an overabundance of carbon dioxide.

This beneficial effect is compounded by the use of the ethanol, especially E85, in the millions of internal combustion engines. The following is a quote from the website of the State of Minnesota:

Ethanol is good for our environment

Ethanol is one of the best tools we have to fight air pollution from vehicles. Ethanol is an oxygenate, which simply means that it contains oxygen (about 35%). Adding oxygen to fuel results in more complete fuel combustion, thus reducing harmful tailpipe emissions.

Ethanol also displaces the use of toxic gasoline components such as benzene and MTBE, both known carcinogens. Unlike petroleum-based fuels, ethanol is non-toxic, water soluble and quickly biodegradable.

Nationally, while somewhat hidden, the financial benefits of even one unit are very significant. The money supply in the Philippines is reported by the BSP as P1.5 trillion, or \$28 billion. The issuing of \$30B to purchase the gold will double the money supply because the FDN will not take any of it offshore. The mandate is to invest it for the benefit of the PEOPLE. The National Treasury will gain some \$15B worth of gold, thus doubling its foreign exchange reserves, all without borrowing one centavo from anyone.

Upon funding the second unit the Republic of the Philippines will be in a position to declare its currency gold based, i.e., directly acceptable virtually anywhere with no further need of "foreign exchange". Soon after that it can stop taxing its own people—no more "vat" or personal income tax. It can also rearrange its tariffs and duties to protect its own agriculture and industries and pay (or repudiate) its external debt.

This program can be used in any nationalistic people-friendly nation. Many nations have already received shipments of gold from the Philippines and there is plenty of gold in the Philippines to supply those that have not. This is not a fairy tale; this is the reality that has been hidden from the "former colonies" for more than a century and this is the truth that will set them free.

PROGRAM OF GOVERNMENT COALITION FOR NATIONAL SALVATION (CNS)

As referenced in this issue's lead article, we present the CNS program outline for the Philippines:

I. Political Reforms

1. Immediate shift to a unicameral parliamentary and federal system for the country with appropriate number of regions such as Muslim Mindanao being divided into three federal states, taking into consideration ethnic, tribal, cultural, linguistic and economic elements.
2. Install immediately the structures and institutions of the interim government.
3. Establish a revolutionary freedom Constitution until a new Constitution is framed and ratified by the people.
4. Reorganize the departments or ministries of government in such a manner that governance will be more systematic and the bureaucracy professionalized and trimmed down.
5. Fair and adequate representation of the regions in all the branches of the national and regional government.
6. Abolish Congress until the new government has conducted new elections.
7. Conduct thorough national reorientation, defining correct democratic parameters and prescribing proper conduct of leaders and citizens as well as foreigners who visit the country.
8. Allow dual citizenship of Filipinos who reside in countries that are not threats to our national security.
9. Abolish Comelec.
10. Foster national unity by respecting the Shari'ah Law, the Confederation of Sultanates and the heritage of ethnic groups.
11. Change the name of the country because Philippines is a name originating from the name Philip, a Spanish syphilitic king.

II. Social Reforms

1. Free and compulsory education from the elementary to the university level in the public school system.
2. Free medicines, medical attendance and hospitalization in the public health system.
3. Housing to be sold at cost to the poor and underprivileged.
4. Cancellation of PPA and other irrational charges in the supply of electricity and water.
5. Bringing down the price of rice with corresponding subsidy for rice farmers.
6. Settle once and for all questions on land titles and ownership.
7. Create agricultural settlements with complete facilities.

III. Economic Reforms

1. Reversion to the government of all public utilities dealing with electricity, water, telecommunications since they are not designed for profit but for public service.
2. Living wage and profit sharing for labor, with participation in the formulation and implementation of management and labor policies.
3. Using the Central Bank as an instrument of national development.

4. Subsidy to the farmers and easy credit where the collateral is the viability of the project and the integrity of the borrower.
5. Re-engineer the land reform program as to primarily involve public lands, vacant lands, undeveloped lands and foreclosed lands.
6. Pegging the peso to the US dollar at a definite ratio instead of the current floating rate.
7. Stress on the development of local industries and giving priority help to Filipino entrepreneurs.
8. Support and promote Filipino inventors and inventions and Filipino artists and their creations.
9. Protect and defend Filipino Overseas Contract Workers wherever they may be found.
10. Work on debt repudiation at the maximum or debt moratorium at the minimum.
11. Review our WTO-GATT commitments to protect Filipino industries.

IV. Criminal Justice Reforms

1. Arrest, prosecute, convict and sentence criminals of all types, the grafters and the corrupt in government, the economic saboteurs, the drug lords, the smuggling lords, the kidnapping lords, murderers and rapists and criminals of all types, with speed and without regard to status in life.
2. Public execution of all types of criminals committing heinous crimes as defined by the government like graft and corruption of a certain magnitude, plunder, economic sabotage, drug lords, gambling lords, kidnapping for ransom lords and their confederates, murder and rape, fraud of certain magnitude like pyramiding and fraud in connection with deployment of foreign contract workers, within the first six months of the term of the new government.
3. Immediate execution of those convicted by final judgment of capital offenses.
4. Confining criminals convicted of serious offenses in reformatory farms away from population centers.
5. Community service as penalties for light offenses instead of fines and or imprisonment.
6. Confiscation of all properties of economic saboteurs, the grafters and the corrupt, drug lords and pushers, kidnappers for ransom, smuggling lords, gambling lords, major tax evaders with unpaid taxes running up to tens of millions and the like with the exception of those who surrender eighty per cent (80%) of their ill gotten wealth before their arrest and within one month from the assumption of the new government.

8. Abolish the Office of the Ombudsman and place that office as a division in the Department of Justice.
9. Abolish the Sandigan Bayan and create a People's Court which will review on appeal cases involving public officials and their co-conspirators.
10. Create RTC branches which will try cases solely involving public officials and their co-conspirators.

V. Reforms in the Conduct of Foreign Affairs

1. Implement an independent foreign policy with stress on the Filipino First Policy.
2. The most favored nation clause and reciprocity

shall be the basis of our relationship with all countries of the world.

3. Limit the number of our embassies and ban partisan political appointments in the diplomatic corps and in the consular service.

VI. Reforms in the Educational System

1. Revise totally the curriculum with stress on a humanist and Filipino value system, adopt the Paolo Freire (action-reflection-action or praxis) proposition approach to education instead of the banking method.
2. Emphasize love of country and the Filipino community.
3. Improve the training of teachers by sending them to take masteral and doctoral courses, especially in the physical sciences, here and abroad.

VII. Reforms in the Military and Police

1. Create a Department of Homeland Security to replace the DILG.
2. Pursue a non-aggressive defense security policy and rename the AFP to the Philippine Self-Defense Force.
3. Adopt a Joint Chief system.
4. Promotion and assignment in the military service shall be based on seniority and performance.
5. Provide housing facilities to members of the military establishment and their families which they shall own even after retirement.
6. Investigate, prosecute and convict erring officials and personnel in the RSBS, PVB, AFSLAI and similar financing and fraternal institutions.
7. Actively and aggressively prosecute the claims of Filipino veterans in the United States of America.
8. Define an inextendible time limit for the grant of pensions, retirement and veteran's benefits, death and disability benefits for soldiers and their beneficiaries.

VIII. Reforms in the Bureaucracy

1. Immediately upgrade the salaries of officials, civilian, military and the police, in an effort to make them live decently and eradicate the temptation of graft and corruption.
2. Establish a professional bureaucracy devoid of partisan politics.
3. Make officials and employees participate in community activities, once a week, designed to improve the lives of Filipinos.
4. Infuse complete discipline and service with a smile in the public service so that the people will trust government.

IX. Reforms In National Orientation

1. Weekly reform educational seminars in the schools and in the barangays to stress humanist and Filipino values and the promotion of correct behavioral conduct of citizens by themselves and among each other.

This Program of Government was adopted from several proposed programs from different groups/sectors including the Alliance for National Transformation and Solidarity (ANTS).

SIR PETER VICKERS HALL

TAVISTOCK INSTITUTE FOR HUMAN RELATIONS

... Sir Vickers Hall remained an active Fabianist, even though he was running a conservative “think tank”. As a member of the British oligarchic Vickers armament manufacturing family, he had position and power. The Vickers family armed both sides in the First World War, and again during Hitler’s rise to power. Vickers’ official cover was the University of California Urban and Regional Development Institute. He was a longtime confidant of British Labor leader and Committee member, Anthony Wedgewood Benn.

Both Vickers and Benn are integrated with the Tavistock Institute for Human Relations, the premier brainwashing institution in the world. Vickers uses his Tavistock training to very good effect when speech-making. Consider the following example:

“There are two Americas. One is the 19th century heavy industry based society. The other is the growing post industrial society, in some cases built on the shards of the old America. It is the crisis between these two worlds that will produce the economic and social catastrophe of the next decade. The two worlds are in fundamental opposition, they cannot co-exist. In the end the post industrial world must crush and obliterate the other one.” Remember, this speech was made in 1981 and we can see from the state of our economy and our industries just how accurate were Sir Peter’s predictions.

When concerned people ask me how long the current recession will last, I refer them to Sir Peter’s statements, and then I add my own opinion, that it will not end until 1995/1996, and even then, what emerges will not be the America we knew in the 1960s and 1970s. That America has already been destroyed. **[H: Where do you think you ARE now in April-May, 2005? Just the happenings in all facets of politics, international affairs and yes indeed,**

spoiled religions should give you a picture to cause spasms of shuddering. You are now set-up for the “kill” and you march like the lemmings to the cliff, jump off and await a big disappointment that you do not “ascend”. Moreover, you will die in a state of ignorance—not Grace.]

I reported Sir Peter’s speech in my newsletter soon after it was delivered. How prophetic it was, but then it was easy to predict a future already written for America by the Committee of 300 and its executive Club of Rome. What was Sir Peter saying in a euphemistic manner? Translated into ordinary everyday English, he was saying that the old American way of life, our true and trusted Republican form of government, based upon our Constitution, was going to be crushed by the New World Order. America as we knew it, was going to have to go, or it would be crushed to pieces.

As I said, Committee members often make themselves highly visible. Sir Peter was no exception. To make it clearly understood where he was coming from, Sir Peter rounded off his speech by declaring:

“I am perfectly happy working with the Heritage Foundation and groups like that. True Fabians look to the New Right to push through some of their more radical ideas. For more than a decade the British population has been subject to a constant propaganda barrage of how it was on the industrial skids. All of this is true, but the net effect of the propaganda was to demoralize the population.” (This is exactly as intended by the new-science scientists at Tavistock Institute.)

“This will happen in the United States as the economy worsens. This (demoralizing process) is necessary to make people accept difficult choices. If there is no planning for the future, or if constituencies block progress, there will be social chaos on a scale which is currently hard to imagine. The outlook for urban America is bleak. There is a possibility of doing something with the inner cities, but basically the cities will shrink and the manufacturing base will decline. This will produce social convulsions.”

Was Sir Peter a psychic, a magician of great report or merely a charlatan fortune teller with a great deal of luck? The answer is “none of these”. All Sir Peter was doing was reading off the blueprint of the Committee-Club of Rome for the slow death of the United States as a former industrial giant. Looking back over the 10 years after Sir Peter’s predictions, can anyone doubt that the Committee’s plans for the demise of an industrialized United States has become a *fait accompli*?

Haven’t Sir Peter’s predictions proven to be remarkably accurate? Indeed they have, almost down to the last word. It is worth noting that Sir Peter Vickers, (Vickers Halls’ father-in-law), worked on the Stanford Research paper, “*Changing Images of Man*”, from which much of the 3,000 pages of material advice sent to the Reagan administration, was taken. Moreover, as a senior MI6 British intelligence officer, Sir Peter Vickers Hall was in a position to give Heritage a great deal of advance information.

As a member of the Committee, and NATO, Sir Peter Vickers Hall was around when NATO directed the Club of Rome to develop a social program which would utterly change the direction in which America wanted to go. The Club of Rome, under Tavistock direction, ordered Stanford Research Institute (SRI) to develop such a program, not only for America, but for every nation in the Atlantic Alliance and the OECD nations

It was Sir Peter’s protégé, Stuart Butler, who gave Reagan 3,000 pages of “recommendations”, which no doubt contained some opinions expressed by

Anthony Wedgewood Benn, a Member of Parliament and a ranking member of the Committee of 300. Benn told members of the Socialist International, who met in Washington on December 8th, 1980: “You can thrive under Volcker’s credit collapse if you profile Reagan to intensify the credit collapse.”

That Butler’s advice was taken and applied to the Reagan administration can be seen in the collapse of the Savings and Loan and banking industries, accelerated under Reagan economic policies. While Benn called it “profiling”, he really meant that Reagan should be brainwashed. It is worth noting that Von Hayek, who is a founder member of Heritage, used his student, Milton Friedman, to preside over the Club of Rome’s plans to de-industrialize America, using the Reagan presidency to accelerate the collapse of first the steel industry, and then the auto and housing industries.

Others in on this plot to undermine the sovereign integrity of the United States through economic collapse were: William F. Buckley Jr., Milton Friedman of the Hoover Institute, Jacques Ruff—the so-called “czar” of France’s economic policies—and most importantly, Etienne D’Avignon.

[H: Please note that as all of this destruction was taking place the set-up for the demise of the Philippines was in full “theft-of-every-asset” mode. This was structured as to “appear” very reasonable and appropriate to one Ferdinand Marcos but in actuality was a structured program for grabbing wealth under “disguise” and finally snatching Mr. Marcos as well. Yes, it is very difficult to tell which player is doing what for they are all on the same team but vying for the top positions of POWER.]

Were they able to strip ALL of the assets supposedly HELD? It remains to be seen, doesn’t it? With just the Global Alliance program it can all be somewhat reversed but WITH the coalition of the Philippines it can be demanded (and assets used) for the return of the precious metals, etc. This means that “reserves” can be supported by the Alliance while the hard metal holdings are accounted, which in turn allows the nation to provide CURRENCY for use of the nation and people. This holds TRUE for any “sovereign” nation. Try it in any COMMONWEALTH nation and you will run right up against the Queen of England and LONDON “CLUB OF ROME”.]

In this regard, French Black Nobility member Etienne D’Avignon, as a member of the Committee of 300, was assigned the task of collapsing the steel industry in this country. It is doubtful whether any of the hundreds of thousands of steel workers and shipyard workers who have been without jobs for the past decade, have ever heard of D’Avignon. I fully reported the D’Avignon Plan on the April, 1981 issue of *World Economic Review*. Attending that fateful Dec. 10, 1980 Club of Rome meeting in Washington, D.C. was a mystery man from Iran who turned out to be Bani Sadr, the Ayatollah Khomeini’s special envoy.

One speech in particular at the December 10, 1980 conclave caught my attention, mainly because it came from Francois Mitterand, a man the French establishment had discarded, and widely perceived in France as washed up. But my intelligence source had previously told me that Mitterand was in the process of being picked up, dusted off and returned to power. Consequently his statement carried a good deal of weight for me:

“Industrial capitalist development is the opposite of freedom. We must put an end to it. The economic systems of the 20th and 21st centuries will use machines to crush man, first in the domain of nuclear

energy which is already producing formidable results.”

Mitterand’s return to the Elysee Palace was a great triumph for socialism. It proved that the Committee was powerful enough to predict happenings and then make them happen by force or whatever means necessary, to make its point that it could crush any and all opposition, even as was the case with Mitterand, who had been totally rejected in a few short days before, by a discerning political power group in Paris.

NAMES TO REMEMBER

Another group representative at the December 1980 Washington meetings with “observer status” was John Graham, also known as “Irwin Suall”, head of the fact finding committee of the Anti-Defamation League (ADL). The ADL is an outright British intelligence operation run by all three branches of British intelligence, that is, MI5, MI6 and the JIO.

Suall works closely with Hall and other Fabianists. He was singled out as useful to British intelligence while at Ruskin Labor College at Oxford University in England, the same communist education center that gave us Lord Alfred Milner, Cecil John Rhodes, Guy Burgess, Donald McClean and Kim Philby. Oxford and Cambridge universities have long been the province of the sons and daughters of the elite, those whose parents belong to the “upper crust” of British high society. While at Oxford, Suall joined the Young People’s Socialist League, where he was “tapped” by British intelligence shortly thereafter.

Suall was posted to the United States, where he came under the protection and sponsorship of one of the most insidious leftists in the country, Walter Lippmann. Lippmann founded and ran the League for Industrial Democracy, and Students for a Democratic Society, both leftist spoiler operations to set industrial workers at variance with what it called “the Capitalist class” and management. Both of Lippmann’s projects were an integral part of the Committee’s apparatus that stretched right across America, of which Lippmann was a most important member.

Suall has strong connections with the Justice Department and can secure FBI profiles of any person he targets. The Justice Department has orders to give Suall everything he wants, when he wants it. Most of Suall’s activities center around “keeping an eye on right-wing groups and individuals”. The ADL has an open door to the State Department and makes good use of State’s impressive intelligence agency.

The State Department has a layer of right-wing agents, posing as “fearless anti-Semitic fighters”. There are four leaders in this group of informers. This spy group has been in operation for the past two decades. They publish virulently anti-Jewish “newspapers” and sell a wide variety of anti-Semitic books. One of the principal operators in the group works out of Louisiana. A member of this group is a writer who is dearly beloved in Christian right-wing circles. The group and the individuals who go to make it up, are under the protection of the ADL. Suall was deeply involved in ABSCAM, and is often called upon by law enforcement agencies to assist in investigations and sting operations.

[H: Start paying close attention now because you will be seeing some really well-known players making the focus list, i.e. James Baker III, Dean Rusk, Philip Agee and it is more current value historically to that which we are doing. Our GLOBAL holdings were actually validated and used through the very people such as James Baker III and Bush’s honchos—circulating right to the Philippines.]

Suall was assigned to “dog Reagan”, in terms of the course laid out for the newly-elected President by

the Heritage Foundation, and to figuratively fire a few warning shots if Reagan seemed to be deviating, or taking off his blinders at any time. Suall helped to get rid of any troublesome right wing advisor not beholden to Heritage for his or her job with the Reagan administration. Such a person was Ray Donovan, Reagan’s Secretary of Labor, who was eventually removed from his post, thanks to the dirty tricks department of the ADL. James Baker III, one of those on the list of 3000 recommendations made by the Heritage Foundation, was the go-between who carried Suall’s messages of hate about Donovan to the president.

Another important plotter was Philip Agee, the so-called CIA “defector”. Although not a member of the Committee, he was nevertheless its case officer for Mexico, and instructed by the Royal Institute for International Affairs (RIIA) and the Council on Foreign Relations. For the record, nothing happens in the United States without the sanction of the RIIA. It is a continuing and ongoing agreement, first OPENLY entered into (there were many such secret agreements before that) by Churchill and Roosevelt in 1938, in terms of which U.S. intelligence services are obliged to share intelligence secrets with British intelligence.

As a practical example of how this arrangement works, we have only to look at the period during the Korean War when Gen. Douglas MacArthur wanted to bomb the bridges across the Yalu River and the staging areas for China’s forces that were getting ready to cross the river. MacArthur sent a message to Harry Truman, detailing what he was about to do. The cable caused consternation in the Socialist-dominated U.S. State Department, and the president was summoned to attend a meeting at Blair House, where he was to receive his instructions from the RIIA.

At the meeting, the ardent Socialist Secretary of State, Dean Rusk, told Truman that he could not give his assent to the MacArthur plan. Rusk stated very vigorously that the United States had a commitment to the British government not to take action that might involve attacks on the Manchurian side of the Yalu River WITHOUT PRIOR CONSENT BY THE BRITISH. The British government never gave its assent to the MacArthur plan, which would not only have ended the Korean war, but which would also have put paid to China as a future world military power. The British were protecting their drug trade with China, in pursuance of the policy of the Committee of 300.

This is the basis of the so-called “special relationship” that exists between the two countries, boasted about by Churchill and Lord Halifax. This “special relationship” cost millions of American lives in WWII, Korea and Vietnam. It was the “special relationship” that was responsible for the Gulf War against Iraq on behalf of British interests. More especially, the war was fought by American troops to protect the interests of British Petroleum (BP), which is one of the most important companies in the Committee of 300 in which members of Queen Elizabeth’s immediate family have a big stake.

No intelligence activity has taken place since 1938 except through this special joint command structure. Philip Agee joined the CIA after graduating from Notre Dame where he was inducted into its Jesuit Freemason ring. Agee first came to my attention in 1968 as the intelligence officer behind the riots at the University of Mexico. One of the most important things about the Mexican student riots was that they occurred at the same time as student riots were occurring in New York, Bonn, Prague and West Berlin.

With the coordination expertise and its special intelligence network of which INTERPOL is an

integral part, it is not as difficult as it might seem at first sight for the Committee to set in motion carefully timed global actions, whether they are student rioting or deposing leaders of supposedly sovereign nations. It is all in a day's work for the "Olympians". From Mexico, Agee moved on to align himself with Puerto Rican terrorist groups. During this time he became a trusted confidant of the Cuban dictator, Fidel Castro.

It should not be imagined that while Agee was carrying out these operations, he was doing so as a "rogue" agent. On the contrary, he was working for the CIA during all of these assignments. Trouble came when Castro's DGI (Cuban intelligence service) was able to "turn" him. Agee continued to work in his capacity as a member of the CIA until his double roll was uncovered. This involved the biggest Soviet listening post in the West, located at Lourdes, Cuba. Staffed by 3,000 Soviet specialists in signals monitoring and deciphering, Lourdes has the capability of monitoring thousands of electronic signals simultaneously. Many a private phone conversation between a member of Congress and his mistress was picked up at Lourdes and used to telling effect.

Although we are told today in 1994 that "Communism is dead", the United States has done nothing to close down this vast spy operation which sits on our doorstep. Incidentally, Lourdes has the capability of picking up even the weakest "tempest" signal, which is the type given off by a fax machine or an electric typewriter. When deciphered, the contents of whatever is being typed or faxed, is known. Lourdes remains a dagger in the heart of the United States. There is absolutely no reason for its continued existence. If the U.S. and Russia are truly at peace with each other, why the continued need for so massive a spy operation? The simple truth is that, rather than retrenching personnel, as we are led to believe, the KGB and its follow-up organization took on additional recruits during the early 1990s.

GINGRICH AND ISRAEL

In early 1995 the then-newly-elected Republican House Speaker, Newt Gingrich, long a vocal advocate for Israel, gave a little-noticed speech in Washington before a gathering of military and intelligence officers calling for a Middle East policy that was, in his words, "designed to force the replacement of the current regime in Iran ... the only long-range solution that makes any sense".

That the then-*de facto* leader of the "opposition" Republican Party endorsed this policy was no real surprise since, at that time, Gingrich's wife was being paid \$2,500 a month by the Israel Export Development Company, an outfit which lured American companies out of the United States into a high-tech business park in Israel.

Mrs. Gingrich was introduced to her employers when she was on a tour in Israel sponsored by the American-Israel Public Affairs Committee (AIPAC),

a registered lobby for Israel.

A former AIPAC official, Arne Christensen, had served as a top policy advisor to Gingrich. Prior to his service for the Israeli lobby, Christensen had been on the staff of ex-Rep. Vin Weber (R-Minn.), a close Gingrich associate—and yet another member of the Council on Foreign Relations—who is, as noted previously, also one of the principals in William Kristol's "think tank" known as Empower America.

Weber later emerged as a top advisor to Sen. John McCain during his presidential campaign. And McCain is, yet again, also a CFR member. This perhaps helps explain how things came full circle and McCain promoted the line that the U.S. should take provocative measures against "rogue" states. But the Israeli connection is what counts most . . .

JOHN MCCAIN— NEO-CONSERVATIVE SPOKESMAN

The Washington Post revealed on Feb. 25, 2000 that McCain included among his closest advisors three well-known pro-Israel commentators who are voices for what is indubitably the "Jewish Right"—figures in the so-called "neo-conservative" network: *New York Times* pundit William Safire, columnist Charles Krauthammer and the ubiquitous William Kristol, whose employer, fanatic pro-Israel media baron Rupert Murdoch, a satellite of the Rothschild family, endorsed McCain for president through the aegis of his daily, *The New York Post*.

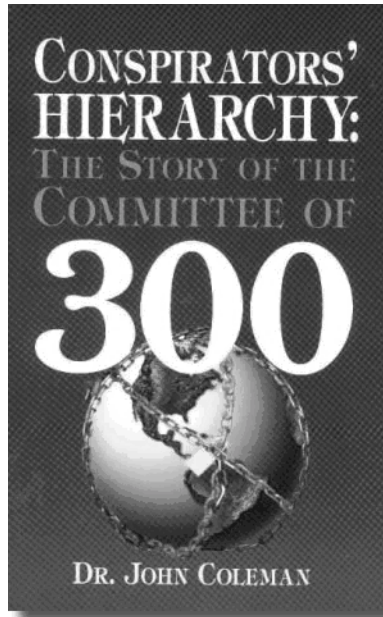
McCain himself has declared his allegiance to Israel, above and beyond U.S. interests. In a March 14, 1999 speech in New York to the National Council of Young Israel, McCain said:

We choose, as a nation, to intervene militarily abroad in defense of the moral values that are at the center of our national conscientiousness even when vital national interests are not necessarily at stake. I raise this point because it lies at the heart of this nation's approach to Israel. The survival of Israel is one of this country's most important moral commitments.

In short, McCain would be willing to commit the United States to a war in defense of Israel, even if U.S. "vital interests are not necessarily at stake". His endorsement of assaults upon the "rogue" Islamic states is part and parcel of this policy, which hardly places America first.

McCain has said that he is "driven" by "Wilsonian principles"—the internationalist philosophy that U.S. military might should be used to enforce world standards, as dictated by the United States itself.

In fact, the record shows that McCain has long been part of an elite group promoting U.S. military action in defense of Israel. According to the Aug. 2, 1996 issue of the London-based *Jewish Chronicle*, McCain was a member of a little-known operation calling itself the Commission on America's National Interest that issued a report rating Israel as a "blue chip" interest for the United States worth "spending serious treasure and serious blood on"—a conclusion many Americans might question.

The report ranked Israel's survival "on a par with preventing nuclear, biological and nuclear attacks on the U.S. as a vital American interest". The *Chronicle* summarized the report, quoting the group, with the headline: "Americans 'should go to war to defend Israel.'"

Contrast this view with the results of a Sept. 1998 poll by the Pew Research Center for the People and the Press (reported in the Dec. 28, 1998 issue of *The Washington Post*) which found at the time that only 45 percent of the American public would support American intervention if Arab forces invaded Israel, compared with 74 percent of so-called "opinion elites" who would favor U.S. ground troops being committed to such a conflict. But popular opinion in America apparently does not count.

The war against "rogue" states and preparations for possible U.S. military action to defend Israel was continually being hard-pressed in the highest circles. It was clearly at the top of the elite's agenda.

NEO-CONSERVATIVES EXPAND THEIR TARGETS

On November 29, 1998, writing in *The Washington Post*, former Secretary of State Henry Kissinger, a key CFR figure and longtime advocate for the Zionist cause, had a prominently placed article entitled "Bring Saddam Down". More recently, however, the advocates of Israel began expanding their targets.

In the March 2, 2000 issue of *The Washington Post*, columnist Jim Hoagland wrote that there must be "a broad political and military strategy for the Persian Gulf ... built around active U.S. support for representative democracy not only in Iraq and Iran but also in the conservative Arab monarchies of the region. The two rogue states cannot be isolated as the only candidates for change...."

In other words, now even Arab states such as Saudi Arabia and perhaps the United Arab Emirates and Kuwait and others may face the wrath of the imperialist "neo-conservative" elite, using the power of the American military to achieve their goal.

Hoagland added that "U.S. policy on Iraq is a subject fit for campaign debate [and that] ... the candidate who can persuasively outline an integrated political and military strategy to deal with the multiple national security challenges of the gulf deserves serious consideration by American voters."

In the end, although heavy-handed "rogue states rollback" advocate John McCain did not achieve the presidency, his Republican primary opponent, George W. Bush, did. And it was during the administration of the new Republican president that the war against Iraq was launched—culmination of a long-standing plan by the clique of "neo-conservatives" whose well-financed, closely knit network had been planning just such a move for nearly a generation.

THE OTHER 'AXIS OF EVIL'

Another key element in the push for an American imperium as advocated by the neo-conservative power bloc is the "axis of evil" between the neo-conservatives (whom, as we have seen, are largely hard-line Jewish hawks allied with the Sharon regime in Israel) and the so-called "Christian Right" in America—the hard-line dispensationalists.

Although journalist Jon Lee Anderson smirked in *The New Yorker* at what he called the "usual claims" by Iraqi deputy prime minister Tariq Aziz that, in Anderson's rendition of Aziz's remarks,

"America had been hijacked by a small group of Jews and Christians, the oil lobby, and the military industrial complex," Aziz's allegations were on the mark.

While neither all American Jews nor all American Christians were allied with the neo-conservatives and the Christian fundamentalists in supporting the drive for a Greater Israel, Aziz was correct when he referred to a "small group"—influential though it may be.

The Christian Right, in fact, constitutes only a segment of the American Christian fundamentalist movement—although a large one to be sure. However, because the Christian Right has emerged as a key power base in the electoral ambitions of George W. Bush and the Republican Party, its influence on behalf of the neo-conservatives and the dream of a Greater Israel is beyond question.

Bush biographer Michael Lind believes that George W. Bush is personally driven toward acceptance of the neo-conservative doctrine precisely because of the fact that Bush seems to have abandoned his own family's traditional mainstream Christian religious convictions and adopted the same brand of Christian fundamentalism practiced by the hard-line Christian Right advocates of Israel.

Lind writes: "There is little doubt that the bonding between George W. Bush and Ariel Sharon was based on conviction, not expedience. Like the Christian Zionist base of the Republican Party, George W. Bush was a devout Southern fundamentalist."

THE ASHCROFT CONNECTION

Although Bush has placed many neo-conservatives in powerful foreign policy making positions, we would be remiss in failing to mention his appointment of former Missouri Senator John Ashcroft—the member of a small but vocal fanatically pro-Israel Christian sect known as "the pentacostals"—as U.S. Attorney General. In that post Ashcroft is in charge of the entire American federal justice system and oversees the Federal Bureau of Investigation (the FBI), the federal law enforcement apparatus.

Although America's "liberal" special interest groups loudly protested Ashcroft's appointment, the fact is that while blacks, feminists, abortion advocates, homosexuals and others were cowering in fear at the prospect of John Ashcroft as attorney general, one particularly influential interest group—the pro-Israel lobby—had already given its "okay" to Ashcroft. The first public sign of Israel's love for Ashcroft came when it was widely reported in the major media that Abe Foxman, national director of the Anti-Defamation League (ADL)—a powerful unit of the Israeli lobby—had announced that he expected Ashcroft to be a "just" man.

Ashcroft supporters loudly touted Foxman's effective endorsement. Meanwhile, those insiders who read *The New Republic (TNR)*, a journal known as an influential and strident voice for the Israeli lobby, got the hint about Ashcroft's "acceptability" from a key source. Ashcroft's longtime policy director, Tevi Troy—an Orthodox Jew who once publicly referred to non-Jews as "goyim" (a racist term)—wrote an article (published in *TNR* issue of Jan. 29, 2001) promoting Ashcroft. Troy—now the Bush administration liaison to the Jewish community—said Ashcroft was "more than tolerant; he's downright philo-Semitic". Troy revealed: Ashcroft was born to a gentile family in a predominantly Jewish Chicago

neighborhood. His mother served as a *Shabbos* goy [i.e. a non-Jew who works for Jews on the Jewish sabbath] turning ovens on and off as needed. Ashcroft's father even took a *mezuzah* [a Jewish religious symbol] with the family when they moved from Chicago to Springfield, Missouri, where he kept it affixed to his doorpost until his death, in 1995. Ashcroft, I'd wager, knows more about Judaism than half the Jewish members of the Senate.

In the meantime, while liberal Jewish Democratic New York Sen. Charles Schumer was soothing his "liberal" constituents by publicly opposing Ashcroft, Schumer (like other insiders) knew full well that Ashcroft had been his (Schumer's) partner in introducing congressional measures in previous years designed to advance the interests of Israel. Among other things, Ashcroft and Schumer together:

- Co-sponsored a dangerous police-state style so-called "anti-terrorist" measure—strongly promoted by the ADL and the Israeli lobby—that grass-roots patriots across America rallied against and largely managed to bloc from total passage. This, of course, was well before the 9-11 attacks.
- Led efforts in Congress to force the transfer of the U.S. Embassy in Tel Aviv to Jerusalem; and
- Co-sponsored a measure to mandate U.S. opposition to any independent declaration of a Palestinian state.

For his vocal campaign against the Palestinians, the Institute for Public Affairs for the Union of Orthodox Jewish Congregations of America hailed Ashcroft as having "long been on record as a staunch supporter of the State of Israel and its safety and security".

AN ALLIANCE OF JEWISH AND CHRISTIAN EXTREMISTS . . .

Since assuming the post of attorney general, Ashcroft has indeed been a leading voice in favor of the neo-conservative Likud-style policies pursued by the administration, devotedly protecting Israel's interests. In the meantime, Ashcroft's neo-conservative allies in the Bush foreign policy apparatus have forged a powerful alliance with the Christian Right voting bloc. Former CIA analysts Bill and Kathleen Christison have described this phenomenon in particularly biting words:

The dual loyalists in the Bush administration have given added impetus to the growth of a messianic strain of Christian fundamentalism that has allied itself with Israel in preparation for the so-called End of Days. These crazed fundamentalists see Israel's domination over all of Palestine as a necessary step toward fulfillment of the biblical Millennium, consider any Israeli relinquishment of territory in Palestine as a sacrilege, and view warfare between Jews and Arabs as a divinely ordained prelude to Armageddon.

These right-wing Christian extremists have a profound influence on Bush and his administration, with the result that the Jewish fundamentalists working for the perpetuation of Israel's domination in Palestine and the Christian fundamentalists working for the Millennium strengthen and reinforce each other's policies in administration councils.

The Armageddon that Christian Zionists seem to be actively promoting and that Israeli loyalists inside the administration have tactically allied themselves with raises the horrifying but

very real prospect of an apocalyptic Christian-Islamic war.

The neo-conservatives seem unconcerned, and Bush's occasional *pro forma* remonstrations against blaming all Islam for the sins of Islamic extremists do nothing to make this prospect less likely.

These two strains of Jewish and Christian fundamentalism have dovetailed into an agenda for a vast imperial project to restructure the Middle East, all further reinforced by the happy coincidence of great oil resources up for grabs and a president and vice president heavily invested in oil.

All of these factors—the dual loyalties of an extensive network of policy-makers allied with Israel, the influence of a fanatical wing of Christian fundamentalists, and oil—probably factor in more or less equally to the administration's calculations on the Palestinian-Israeli situation and on war with Iraq.

But the most critical factor directing U.S. policymaking is the group of Israeli loyalists: neither Christian fundamentalist support for Israel nor oil calculations would carry the weight in administration councils that they do without the pivotal input of those loyalists, who clearly know how to play to the Christian fanatics and undoubtedly also know that their own and Israel's bread is buttered by the oil interests of people like Bush and Cheney.

This is where loyalty to Israel by government officials colors and influences U.S. policymaking in ways that are extremely dangerous.

THE HISTORY OF THE ALLIANCE . . .

One American Jewish historian, Benjamin Ginsberg, writing in his study, *The Fatal Embrace: Jews and the State*, has explored the role of the Christian Right's alliance with the neo-conservatives. He explains:

Close relations between Israel and Christian fundamentalists began to develop after the conservative Likud bloc came to power in Israel in 1977, and strengthened after Reagan's presidential victory in the United States in 1980. After Reagan took office he received a telegraph signed by Reverend Jerry Falwell and other prominent Christian fundamentalist leaders urging him to give his full support to Israel which, they said, "from a religious, moral and strategic perspective", represented "our hopes for security and peace in the Middle East". The Begin government awarded Falwell the Zabotinsky Award for service to Israel and brought him and other leaders of the Christian right to Israel frequently as honored guests. Falwell strongly supported Israeli annexation of the occupied territories and moving the Israeli capital to Jerusalem. "There is no question that Judea and Samaria should be part of Israel," Falwell declared. Moreover, "I believe that the Golan heights should be annexed as an integral part of the state of Israel," he said.

Author Michael Lind suggests that Falwell may indeed be "the Likud Party's most important lobbyist in the United States". In addition, as Jewish-American authors Ken Silverstein and Michael Scherer noted, Begin loved Falwell so much that he also presented Falwell with a Learjet for his efforts on behalf of Israel.

THE NEO-CONSERVATIVES AND THE FUNDAMENTALISTS

Since Begin's time, subsequent Likud prime ministers built close ties with American evangelicals. According to Silverstein and Scherer:

Christian conservatives provide Israel—and in particular the hard-line Likud Party of Prime Minister Ariel Sharon—with its most important political support in the United States. They oppose Israel ceding land to the Palestinians and are pressuring the Bush administration to close Palestinian offices in the United States. They also have close ties to GOP congressional leaders and to a group of high-ranking hawks in the Pentagon—led by Deputy Defense Secretary Paul Wolfowitz—that some DC insiders call the "Kosher Nostra." ...

They work to support Israel, ironically, because they believe it will lead to the ultimate triumph of Christianity. For them, the ongoing crisis in the Mideast has been prophesied in the Bible: After Jews reclaim the Holy Land, nonbelievers—including Jews and Muslims—will perish in Armageddon, and Jesus will return as the Messiah to lead his followers to Heaven.

Indeed, thanks to the top-level connections and grassroots activism of evangelical Christians, U.S. policy in the Middle East has never been so closely aligned with Israel as it is under the administration of George W. Bush ...

The Christian evangelicals are particularly hard-hearted against Arabs and Muslims. They believe "that Arabs and Muslims can be traced back to Ishmael, the unfavored son of Abraham, who was promised by God vast land and resources but who would never be satisfied with what he had. No matter how much good fortune Arabs receive ... they will never know spiritual peace," in the view of these Christian extremists.

(And it should be noted that this is not the standard view of the typical American Christian, as we shall see.)

Pointing out that one of the hawks within the Bush administration who has worked closely with the Christian right is Douglas Feith—the deputy to Deputy Defense Secretary Paul Wolfowitz—Silverstein and Scherer cite Feith's former associate at the Center for Security Policy, Frank Gaffney, who asserts: "You are seeing American government policy being profoundly influenced by beliefs that are shared by the pushers outside [the Christian evangelicals] and the people on the inside [the Jewish neo-conservatives]."

Noting the enthusiastic reception by Israel's Likud of the fundamentalists, Michael Lind comments that "The fervent support of Israel by Protestant fundamentalists ... has been manipulated for a quarter of a century by right-wing Israeli politicians and their neo-conservative allies."

Ironically, however, even "liberal" American Jewish groups that do support Israel, but which publicly advocate a negotiated settlement with the Palestinians, see the danger in this unholy alliance between the Christian evangelicals and the Jewish neo-conservatives.

Rabbi Eric Yoffie, head of the Union of American Hebrew Congregations, is quoted as saying that this alliance of evangelicals and neo-conservatives sees "any concession as a threat to Israel, and in this way they strengthen the hardliners in Israel and the United States".

THE FANATICS IN CONGRESS

In the U.S. Congress, there are a number of lawmakers who are closely aligned with the Christian fundamentalists and their Zionist warhawk allies. Notable among them are House Republican Majority Leader Tom DeLay of Texas who "agrees with hawkish Israelis that the West Bank and Golan Heights are part of Israel rather than occupied territories".

In the Senate, one of the leading pro-Israel Christian "hawks" is Sen. Sam Brownback, a Kansas Republican. However, perhaps even more rhetorically and fanatically extreme than Brownback in terms of supporting the hard-line Likudniks—Christian and Jewish alike—is Sen. James Inhofe of Oklahoma, another member of the Republican Party.

Although on Election Night 2000, NBC's Tom Brokaw described Sen. James Inhofe (R-Okla.) as a "foreign policy expert", Inhofe's record of expertise seems more in the field of religious fanaticism of the Christian Zionist fundamentalist persuasion.

For example, on March 4, 2002, Inhofe said in a speech to the Senate that God allowed terrorists to attack the United States on Sept. 11, 2001 to punish America for being too tough on Israel. In a speech condemning his fellow Republican, President Bush, who then was perceived to be pressing too hard on Israel, Inhofe stated in no uncertain terms:

One of the reasons I believe the spiritual door was opened for an attack against the United States of America is that the policy of our government has been to ask the Israelis, and demand it with pressure, not to retaliate in a significant way against the terrorist strikes that have been launched against them.

Although American broadcast media had previously attacked speakers from the Muslim world who had suggested, in one fashion or another, that the Sept. 11 attack on the United States was the will of Allah, there was hardly a mention anywhere of Inhofe's inflammatory remarks.

Inhofe was not the only American Christian fundamentalist to make such a comment. On Oct. 11, 2002, evangelist Joyce Meyer told the Christian Coalition at its national conference that the American people deserved the 9-11 attack for failing to stand firmly with God on the side of Israel. "If we don't obey God, God's protection is lifted," she announced. Yet, the major media has ignored such pro-Israel insanity. Inhofe has also sought to explain that the native Palestinians have never had a historical right to Palestine and that when they were there, they contributed little to the region.

For example, in another Senate speech Inhofe quoted the 18th century French philosopher Voltaire as describing the Palestine of his day as being a "hopeless dreary place". However, what Inhofe, in his bias in favor of the Jewish occupiers of Palestine seems to have ignored is what Voltaire is also reported to have said on another occasion: "While the Arabs are distinguished by courage, hospitality and humanity, the Jews are cowardly and lecherous, greedy and miserly."

The Oklahoma senator suggested that Palestine was a desolate area that no one wanted. "Where was this great Palestinian nation?" asked Inhofe. "It did not exist. It was not there. Palestinians were not there." While any normal individual with even the most minimal knowledge of the history of Palestine knows that Inhofe's claims are the product of a fevered imagination, the sorry fact is that many millions of Americans share those provocative and hateful views.

It was just as predicted: The political summit that Speaker Jose de Venecia organized was meant to get the representatives of various political parties to agree in condemning, frowning at, and discouraging all attempts to seize government power or conducting extra-constitutional efforts to bring the Gloria government down.

In a sense, Sen. Miriam Defensor hit it right on the nail when she, before walking out, stated that this summit was useless because neither the summit nor the politicians have any credibility.

Why they expect to come off credibly, especially in the matter of denouncing and discouraging all attempts to seize government power through extra-constitutional means, is beyond anyone's ken, considering that over four years ago, these very same people who are now in power and position, did just that: They, along with the treacherous Angelo Reyes, seized power through unconstitutional means while deposing a constitutional government. Or have they conveniently forgotten their Edsa II *coup d'etat*?

But didn't the prostituted Davide Court rule that the elite Edsa II *coup d'etat*, including the withdrawal of support from then President and Commander-in-Chief Joseph Estrada was constitutional? IS GEORGE W. REALLY DESTABILIZING GMA?

Of course he is, silly. The destabilizing began when the U.S. ambassador publicly accused the Philippine judiciary of corruption two years ago.

As far back as that time, the *Asian Wall Street Journal*, had warned George W. Bush not to identify the U.S. with GMA because she had lost touch with her people. ...The U.S. wants—or wishes—this government changed, period—but just do it peacefully, and that peaceful change can come about, as Edsa II demonstrated, by a simple declaration from the AFP chief of staff that the AFP is withdrawing its support from this government.

...[I]f GMA has read the outgoing U.S. ambassador's message correctly she is smart enough to consider alternatives and one such alternative would be simply to abdicate before the AFP takes on the American ambassador's instructions and declares official withdrawal of support from this government.

Who knows, perhaps Gloria's woes could be solved with a brilliant plan like the ethanol project proposed by GAIA?

RUSSIA ACCUSES FOREIGN AGENCIES OF SPYING

MOSCOW—Russia's security chief accused U.S. and other foreign intelligence services Thursday of using non-governmental organizations that promote democracy to spy on Russia and bring about political upheaval in former Soviet republics.

The remarks by an ally of President Vladimir Putin reflect concern in the Kremlin over its waning regional clout following the ascent of pro-Western governments on its borders.

"Along with classic forms of influence on political and economic processes, foreign intelligence agencies are ever more actively using non-traditional methods," including working through "various non-governmental organizations", Federal Security Service chief Nikolai Patrushev told lawmakers.

"Under cover of implementing humanitarian and educational programs in Russian regions, they lobby the interests of the states in question and gather classified information on a broad spectrum of issues," he said.

"...Our opponents are steadily and persistently trying to weaken Russian influence in the Commonwealth of Independent States and the international arena as a whole," Patrushev said. "The latest events in Georgia, Ukraine and Kyrgyzstan unambiguously confirm this."

...U.S. officials say the programs of American groups—whose activities include providing election training, underwriting exit polls and supporting independent media—are not interference, but acknowledge that some of the money has helped opposition groups.

Patrushev suggested Russia believes the next Western target is Moscow ally Belarus, where U.S. officials have not masked their disgust at authoritarian President Alexander Lukashenko. Bush has called Belarus the last dictatorship in Europe, and Secretary of State Condoleezza Rice said it was time for a change in the country, where a presidential election is to be held next year.

Patrushev said the International Republican Institute, a group that promotes democracy and gets most of its money from the U.S. government, held a meeting in Slovakia last month during which "the possibility of continuing 'velvet revolutions' on the post-Soviet space was discussed." He also claimed \$5 million was earmarked for IRI funding of opposition groups in Belarus this year....

THE SHARE OF EURO IN RUSSIA'S INTERNATIONAL RESERVES CAN BE INCREASED TO 50%

MOSCOW—The share of the euro in the Russian gold and foreign currency reserves can be increased to 50%, said Pavel Teplukhin, president of the Troika Dialogue managing company.

"The country's international reserves must be maximally adjusted to the balance of payment structure," he thinks. "And the balance of payments consists of two parts, the trade balance and the capital account."

Russia's main trade partners are EU countries, with whom settlements are made in the euro, Teplukhin said.

"...The euro/dollar ratio in the country's international reserves should be close to 50:50," he thinks....

"Russia is becoming an active member of the IMF, not a borrower but a net creditor of the countries that are the recipients of the World Bank and IMF assistance. In this situation, the voice of the Central Bank in currency interventions should become louder," the company president thinks.

In his opinion, the Central Bank should not only tackle the domestic foreign policy but also influence the international dynamics of the exchange rate. To be able to do this, Russia should adopt "a creative attitude to the balance of the dollar, the euro and the yen in its international reserves".

"The Central Bank can play this part now because it is one of the world's largest holders of international reserves," argues Pavel Teplukhin.

The Russian gold and foreign currency reserves top \$144 billion and may grow to \$170-180 billion by the end of the year, according to the Central Bank's forecast....

A pair of new studies confirms recent fears that bacteria are growing increasingly resistant to drugs and that you can be infected anywhere.

The number of cases of "superbugs", as researchers call them, has been increasingly steadily in recent years, the reports conclude.

The best medicine? Wash your hands a lot.

...One of the most vexing superbugs is methicillin-resistant *Staphylococcus aureus*, or MRSA.... It can cause skin infections, severe bloodstream infections and even death.

...Avoiding MRSA infections is surprisingly simple: Follow Mom's advice.

"If you get a cut or an abrasion, try to keep it clean and dry" Kaplan said, and don't share towels or washcloths. Most importantly, he said, "Wash hands, wash hands, wash hands."

A study released in March found standard soap and 10 seconds of scrubbing to be among the most effective ways to get rid of bacteria.

...And if regular drug-resistant bacteria weren't bad enough, some bacteria have become multidrug resistant (MDR).

While many stock-market investors have recently discovered the meaning of the word "risk", it's too bad they never learned to invest in Nevada shell corporations, which continue to appreciate in value.

- Use nominee service so that there is no link to you personally;
- Open a no-interest bank account for the corporation;
- File "zero income" (non-activity) tax returns every year;
- DO NOT TRANSACT ANY BUSINESS WITH THE CORPORATION.

A shelf corporation maintained in this manner typically carries a premium of \$1,000 PER YEAR OF AGE, in addition to the initial costs of setting it up. Even after annual maintenance costs (at least, through Budget Corporate Renewals) it is possible to have an annual gain of \$500 to \$1,000, making the incubation of shelf corporations a very rewarding enterprise!

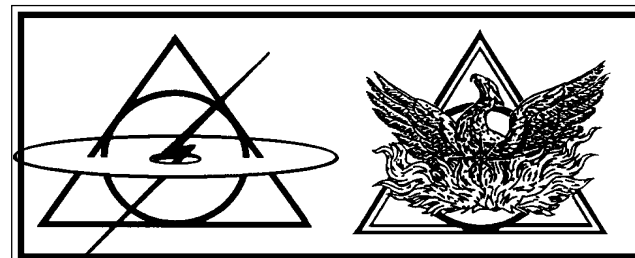
