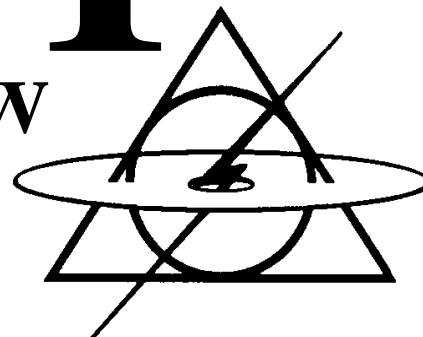

LESSONS TO REMEMBER AND USE EVERY MINUTE OF THE REST OF YOUR LIVES

Since life deals you many things and experiences at a single moment and you can only mentally focus on ONE ITEM as in thought processing—you must attend carefully THE TOPIC OF THE MOMENT WHILE CATEGORIZING THE OTHER ATTENTION GRABBERS IN PRIORITY LISTINGS. “filing” something with a county recorder as being somehow a “registration” and PROOF of something or other as in “public notice”. No, it is NOT.

A recorder will always protect his office and himself by the emphatic printed statement that the document he receives and files is simply THE DOCUMENT presented to him and has nothing to do with validity or TRUTH. He is paid to file it and record it in a proper file—NO MORE. He is not given authority or information to otherwise consider the document UNLESS IT SOMEHOW REFLECTS ON HIMSELF OR HIS POSITION.

If you have TWO receiving stamps on something and they bear the same date of filing and recording information you can be pretty sure that the stamped date is more appropriate as validation of filing BUT NOTHING AS TO THE DATES OF PRESENTATION OTHERWISE. WE WILL ALSO EXAMPLE THAT ELSEWHERE FOR I DO NOT WISH TO SPEND TIME ON IT HERE.

AWARENESS:

AWARENESS DEPENDS ON ATTENTION!

We WILL live in the currently present moment whether or not we like it. That is reality of expression. However “awareness” of the momentary incidents varies according to the attention devoted to the incident. The most IMPORTANT incidents can and do occur all the time but of which you remain individually and totally UNAWARE. Most things are NOT in your space of recognition or are “off your stage”. This can be exemplified by a storm outside your area, no matter how large or small, and that which is within your experience as raindrops blow against you or your window glass. Which gets more attention?

I like the description of some as to “awareness” and “moment”. A moment is actually the short span of time between a split millisecond and a few seconds but it also means the difference between “nothing” and “infinity”, misery and/or bliss. Life itself is the sum total of these moments; the more significant each moment lived, the more significant one’s life presents. As much as living in the present, you must also learn to grasp the moments and savor the fleeting experience.

YOU MUST INCREASE YOUR AWARENESS:

This can be accomplished by many means but first RELAX in the moment so that reason, logic and senses can properly attend whatever is presented. Even as with a fire to be extinguished, panic only further confuses the immediate issue. More appropriate to anything is “attention”. Example: When you misplace your keys or your glasses, perhaps still on your face, it is not Alzheimer’s friends; it is the absence of awareness in WHERE YOU PUT THEM IN THE FIRST PLACE. If this happens many times and becomes a recognized discomfort to you it is a fact that you WILL PAY BETTER ATTENTION. The more discomfort resulting in the loss the more important it becomes to watch what you do WHEN YOU DO IT.

So, be calm and let things unfold or recheck sequence and if you are not “dead” you will find the likely incident needing recall.

When you do “act” on something intentionally you must treat the action as something being experienced for the first time and not as an habitual automatic “reaction”. It is good, in fact, to change your habits so that you are more aware of what you are doing and it also protects you from the “enemy” or thief awaiting your appearance as in “habitual” activities. Do NOT be dependable FOR YOUR ENEMY. You will also find new information every time you change the approach be it to the market or to a document where information offered must be noted and sorted.

In a document, for instance, just the addition of the most tiny offset of print proves tampering in any given sentence.

One good and immediate example of a fraudulent document is one which VK has offered openly to attempt to prove her marriage to Russell Herrman, Hermann,

Herrmann, Herman. She has tried to authenticate by signature of Thomas Ganz, her presented “falsely in every way”, a marriage “application” which is also supposed to serve as a legal registration (without any numbers given, of course). However more telling is that her document is done in such a way that the lines of type run slightly “upward” from left to right.

Mr. Ganz’s signature and signing “line” runs counter to the body of the notation which instantly proves the fraudulent addition of the signature and signature LINE. It takes no more than a ruler or straight edge to establish the fraud.

She has repeated the tampering in her latest document posted on her site as PROOF of her holdings and interests. The tampering is so apparent that at SECOND look it cannot be missed both in simply “print” and in evidence offered. This is just an example of the short document where she fills in the dates as being done in 1988 to stand somehow as valid proof of standing and yet she continues then to say that the numbers were calculated in May, 1990; in the same paragraph.

She also notes that this is SUPPOSED to represent her “Durham Trust” according to a “corporate” name NOT INCORPORATED UNTIL 2002 AND YES, INDEED, WE DO HAVE THE REGISTRATION OF THE ENTITY IN CURRENTLY UPDATED FORM FROM THE STATE OF IOWA. Anyone can get it right off the Internet in less than 6 seconds.

Filing this garbage with a “recorder” means nothing except that Mr. Clausen “filed” the document as stated and charged (or not) for the SERVICE to be entered into some record with established file locations and, further, that he established it in a file and after which if removed it is not his problem unless he, of course, removed it. It is highly unlikely that one Doris Ekker from Manila, Philippines could or would remove the original document well marked “separately” by stamp as Confidential and Original, matching rubber stamp additions.

You will get far more attentive as when, as the fox and the rabbit where the fox is running for his dinner and the rabbit is running for his life. Mont Pelerin is an economic foundation devoted to issuing misleading economic theories and influencing economists in the Western world to follow models it lays out from time to time. Its leading practitioners are Von Hayek, Milton Friedman and Ludwig Von Mises. It has strong connections with the Knights of Malta, THE HERITAGE FOUNDATION and the German Marshall Fund. It is backed by Rothschild and Rockefeller money. Some of their secret meetings are held at the Hoover Institution.

THE HOOVER INSTITUTION

Originally founded to fight Communism, the institution has slowly but surely turned toward Socialism. It has an annual budget of \$20 million, funded by companies under the umbrella of the Committee of 300. It now concentrates on “peaceful changes”, with emphasis on arms control and domestic U.S. problems. It is frequently quoted by the news media as a “conservative” organization, whose views they seek when a conservative viewpoint is needed to slant the story being presented. The Hoover Institution is far from conservative, and following the 1953 take-over by a group allied with the Club of Rome, it has become a One World Government-New World Order outlet for “desirable” policies.

HERITAGE FOUNDATION

Foundation by brewery magnate Joseph Coors, to act as a conservative think tank, Heritage was soon taken over by Fabianists Sir Peter Vickers Hall, Stuart Butler, Steven Ayzler, Robert Moss and Frederick Von Hayek, and placed under the direction of the Club of Rome. This institute played a major role in carrying out British Labor leader Anthony Wedgewood Benn’s order to “Thatcherize Reagan”. Heritage is certainly not a conservative operation, although, at times, it may look and sound like one.

HUMAN RESOURCES RESEARCH OFFICE (HUMRRO)

This is an army research establishment dealing in “psychotechnology”. Most of its personnel are Tavistock-trained. “Psychotechnology” covers GI motivation, morale, and music used on the enemy. In fact a lot of what George Orwell wrote about in his book *1984* appears to be remarkably similar to what is taught at HUMRRO. In 1969, the Committee of 300 took over this important institution and turned it into a private non-profit organization run under the auspices of the Club of Rome. It is the largest behavioral research group in the United States.

One of its specialties is the study of small groups under stress. HUMRRO has had a very pronounced effect on how the army conducts its self. The mind-bending techniques are straight out of Tavistock. HUMRRO teaches the army that a soldier is merely an extension of his equipment and has brought great influence to bear on the “man as weapon” system and its “human quality control” so widely accepted by the United States Army. HUMRRO has had a very pronounced effect on how the army conducts itself. Its mind-bending techniques are straight out of Tavistock. HUMRRO’s applied psychology courses are supposed to

teach army brass how to make the idea of a human weapon work. A good example of this is the manner in which soldiers in the war against Iraq were willing to disobey their field manual standing orders and bury 12,000 Iraqi soldiers alive.

This type of brainwashing is terribly dangerous, because while it is applied to the army today, and the army applies it to brutally destroy thousands of “enemy” soldiers, tomorrow the army could be told that civilian population groups opposed to government policies are “the enemy”. We are already a mindless, brainwashed flock of sheep, yet it seems the HUMRRO can take mind bending and mind control a step further. HUMRRO is a valuable adjunct to Tavistock, and many of the lessons taught at HUMRRO were applied to the Gulf War, which makes it a little easier to understand how it came to be that American soldiers behaved as ruthless and heartless killers—a far cry from the moral behavior of the traditional American fighting man.

[H: You can see that the “trial balloons” went up in the FIRST Gulf War and now see what you are having in this Second one! You are finding that your soldier will pour on depleted uranium ammunition without even noting the damage to selves and indeed, without question. You see atrocities taking DAILY headlines and certainly the abuse of “prisoners of war” rampaging throughout the system. You have become a vicious and violent society, my friends. It is fed to you constantly on all your media machines and by speaking heads and stupefying sit-coms of total absurdities and degrading of all morals along with, especially, presenting parents and adults in the worst possible clown-like circumstances. You people had best LISTEN to the music presented for your children’s guidance—especially that RAP “mind-training” script.]

RESEARCH ANALYSIS CORPORATION

This is HUMRRO’s sister “1984” organization, situated in McLean, Virginia. Established in 1948, it was taken over by the Committee in 1961, when it became part of the Johns Hopkins bloc. It has worked on more than 600 projects, including integrating blacks into the Army, the tactical use of nuclear weapons, psychological warfare programs, and mass population control.

Obviously, there are many more major think tanks, and we shall come to most of them in this book. One of the most important areas of cooperation between what think tanks turn out and what becomes government and public policy are the “pollsters”. It is the job of the polling companies to mold and shape public opinion in the way that suits the conspirators. Polls are constantly being taken by CBS-NBC-ABC, the *New York Times* and the *Washington Post*. Most of these efforts are coordinated at the National Opinion Research Center, where as much as it will amaze most of us, a psychological profile was developed for the entire nation.

Findings are fed into the computers of Gallup Poll and Yankelovich, Skalley and White for comparative evaluation. Much of what we read in our newspapers or see on television has first been cleared by the polling companies. ***What we see is what the pollsters think we should see.*** This is called “public opinion making”. The whole idea behind this social conditioning is to find out how responsive the public is to POLICY DIRECTIVES handed down by the Committee. We are called “targeted population groups”, and what is measured by the pollsters is how much resistance is generated to what appears on the “Nightly News”. Later, we shall learn exactly how this deceptive practice got started, and who is responsible for it.

It is all part of the elaborate opinion making process created by Tavistock. Today, people believe they are well informed but what they do not realize is that the opinions they believe are their own, were in fact, created

by the research institutions and think tanks of America, and that none of us is really free to form our own opinions about the information provided by the media and the pollsters.

[H: These “polls” are the backbone of the disinformation spewed about the Philippines every day in every way. The entire society is manipulated—BUT the greatest users of the information are the controllers who know exactly what they are doing and right now the circumstances are being readied to dump this unlawfully sitting “President”, GMA. This is, again, a very intentional focus of the controlling POWERS so don’t go thinking that a fluke has appeared in the ointment.]

Polling became an art just before the United States entered the Second World War. Unsuspecting Americans were conditioned to look upon Germany and Japan as dangerous enemies to be stopped. In a sense, this was true, and that makes conditioned thinking all the more dangerous, because based on the INFORMATION fed to the public, the enemy did indeed appear to be Germany and Japan. Just recently we saw how well Tavistock’s conditioning process worked when Americans were brainwashed to perceive Iraq as a threat, and Saddam Hussein as a personal enemy of the United States.

[H: Now you have witnessed that YOU WILL BELIEVE ANYTHING and wars can be set forth on PURE LIES. Weapons of Mass Destruction where there are NONE except those of the U.S. and Britain are PRIME EXAMPLES. Now it just goes, “Oops!” Thousands continue to die and more will die incredibly terrible deaths because of depleted uranium—BUT, “OOPS” does it every time.]

Such a conditioning process is technically described as “the message reaching the sense organs of persons to be influenced”. One of the most respected of all pollsters is Committee of 300 member Daniel Yankelovich, of the company Yankelovich, Skalley and White. Yankelovich is proud to tell his students that polling is a tool to change public opinion, although this is not original. Yankelovich got his inspiration from David Naisbett’s book, *Trend Report* which was commissioned by the Club of Rome.

In *Trend Report*, Naisbett describes all of the techniques used by opinion makers to bring about public opinion desired by the Committee. Public opinion making is the jewel in the crown of the OLYMPIANS, for with thousands of new science social scientists at their beck and call, and with the news media firmly in their hands, NEW public opinions on almost any subject can be created and disseminated around the world in a matter of a week or two.

This is precisely what happened when George Bush was ordered to take an aggressive stance against Iraq. Within two weeks, not only the United States, but almost the entire world public opinion had been turned against Iraq and Saddam Hussein. These media change artists and news manipulators, report directly to the Club of Rome, which in turn reports to the Committee of 300 at whose head sits the Queen of England. She rules over a vast network of closely-linked corporations who never pay taxes and are answerable to no one else, who fund their research institutions through foundations whose joint activities have almost total control over our daily lives.

Together with their interlocking companies, insurance businesses, banks, finance corporations, oil companies, newspapers, magazines, radio and television, this vast apparatus sits astride the United States and the world. There is not a politician in Washington, D.C. who is not somehow beholden to it. The left rails against it, calling it “imperialism”, which indeed it is, but the left is run by the very same people who control the right, so that the left is no more free than is the right-wing.

Scientists engaged in the process of conditioning are called “social engineers”, or “new science social scientists”, and they play an integral part in what we see, hear and read. The “old school” social engineers were Dr. Kurt K. Lewin, Professor Hadley Cantril, Margaret Meade, Professor Derwin Cartwright and Professor Lipssitt, who together with John Rawlings Reese, made up the backbone of new science scientists at Tavistock Institute.

During World War II, there were more than 100 researchers at work under the direction of Kurt Lewin, copying slavishly the methods adopted by Reinhard Heydrich of the German Secret Service. The OSS was based on Heydrich’s methodology, and as we know, the OSS was the forerunner of the Central Intelligence Agency. The point of all of this is that the governments of Great Britain and the United States already have the machinery in place to bring us into line in a New World Order. With only a slight modicum of resistance materializing, this machinery has been gaining in size and strength since 1946. Each passing year has added new refinements.

It is this Committee of 300 which established control networks and mechanisms far more binding than anything ever seen in this world. Chains and ropes are not needed to restrain us. Our fear of what is to come does that job far more efficiently than would any physical means of restraint. We are being brainwashed to give up our Constitutional right to bear arms; our Constitution itself, to allow the United Nations to exercise control over our foreign policies, to allow the IMF to take control of our fiscal and monetary policies, and permit the president to break United States law with impunity by invading a foreign country and kidnapping its head-of-state. In short, we have been brainwashed to the extent where we, as a nation, will accept each and every lawless act carried out by our government without question.

I, for one, know that we will soon have to fight to reclaim our country from the Committee, or lose it forever, but when it comes right down to it, how many will actually take up arms? In 1776 only 3 percent of the populace took up arms against King George III. This time around, 3 percent would be woefully inadequate. We should not allow ourselves to be led down dead-end roads, for that is what our mind-controllers are expecting us to do. Statistics produced by the Institute for Higher Learning show that the reading and writing capabilities of high school children in the United is LOWER than it was among high school children in 1786.

What we face today is not only the loss of our freedom and the very fabric of our nation, but far worse, the possibility of the loss of our souls. The steady chipping away at the foundation upon which this Republic rests has left an empty void, which Satanists and cultists rush to fill with their synthetic soul material. This truth is difficult to accept and appreciate because there was nothing SUDDEN about these events. If a sudden shock had hit us, a cultural and religious shock, we would have been shaken out of our apathy.

But gradualism, which is what Fabian Socialism is, does nothing to sound the alarm. Because the vast majority of Americans can see no MOTIVATION for the things I have described, they cannot accept it, and so the plot is scorned and often mocked. By creating chaos through presenting hundreds of daily choices people must make, we have come down to a position where, unless motivation can be clearly shown, all information is rejected.

However, if we can get enough people to see the truth, the motivation block will get weaker, until it will eventually be forced aside as more and more people become enlightened and realize that the notion that “this cannot happen in America” should be dispensed with.

The Committee of 300 is counting on our maladaptive responses to govern our reaction to created events, and it will not be disappointed as long as we, as a nation, continue with the way we respond and the manner of our responses. We must turn responses to created crises into ADAPTIVE responses by identifying the plotters and exposing their plans for us, so that these things become public knowledge. The Club of Rome has already made the *transition to Barbarism*. Instead of waiting to be “raptured”, we must stop the Committee before it can accomplish its goal of making us their prisoners of the New Dark Age they have planned for us. It is not up to God; it is up to us. We must take the necessary action.

Part Three: Enron, Inslaw

ENRON— THE LITTLE-PUBLICIZED

Although the collapse of oil industry giant Enron emerged as perhaps the 21st century’s first major financial and political scandal—with multiple connections to both the Democratic and Republican Parties—the very central (and pivotal) Jewish connection to the Enron affair has gone largely unnoticed. As we shall see, there are some quite interesting aspects about the scandal that have been kept out of the public arena. And in this regard, the Enron scandal is very much an appropriate introduction to our overall examination of Zionist power in America.

Although the fact that Enron executive Andrew Fastow—who was convicted, along with his wife, for his misdeeds—was Jewish was mentioned in some media (with Fastow’s rabbi coming to his public defense) the much bigger and more explosive Jewish connections surrounding Enron were almost uniformly covered up.

The Jewish role in Enron is indubitably illustrative of how the major media suppresses “the Jewish connection” in major affairs of this type and is worth reviewing here in our study of Jewish power in America.

The fact that some distinguished Jewish institutions (and not just big name politicians of both parties) were on the receiving end of Enron’s “dirty money” was lost in the shuffle. Here’s a story (a revealing one) you won’t read anywhere else.

While “everyone knows” that the now-infamous Enron Corporation was lining the campaign coffers of Democratic and Republican politicians alike, what was not reported in the major media is that the corruption-racked corporation and those behind it have also been major financial backers of the burgeoning Holocaust industry (and the Israeli lobby) in the United States and in Israel.

That’s right. While Kenneth Lay, the non-Jewish chairman of the Enron Corporation, was busy struggling to keep his employees (and investors) from finding out about the sorry state of the giant enterprise, Lay and his wife Linda (along with Enron itself) were bankrolling a so-called “Holocaust museum” in Houston, Texas.

In fact, according to the Jan. 18, 2002 issue of *Forward*, one of the most authoritative and respected Jewish newspapers in America, the Lays and Enron “donated hundreds of thousands of dollars to Houston’s Holocaust museum, accounting for approximately 10% of the institution’s \$3 million budget”.

The truth is that Kenneth and Linda Lay were so enmeshed with the museum that they were scheduled to serve as honorary co-chairs at the museum’s annual dinner in March of 2002. Mrs. Lay was actually a member of the museum’s board.

For its own part, the crowd at the museum protested that they knew nothing about Enron’s business dealings, which is probably true, but the

question remains as to whether angry Enron investors and employees will start demanding that the museum return the “dirty money” siphoned off through contributions from Enron. But the Enron connection to the Holocaust industry is even bigger and much higher reaching than this.

While the media still portrays Enron as some sort of “Texas cowboy” enterprise, the truth is that a little-known, but extraordinarily wealthy, billionaire Jewish family based in New York were major figures behind Enron and also prime financial backers behind activities at the U.S. Holocaust Memorial Museum in Washington.

Although Enron’s chairman, Kenneth Lay, has been the focus of the media spotlight, evidence demonstrates that Enron is largely the fiefdom of the heirs of the late Arthur Belfer, a Polish-born immigrant often described as a “Holocaust survivor”, despite the fact that Belfer left Poland in 1939. Belfer started out as a pillow importer, then began dealing in lucrative contracts for sleeping bags supplied to the U.S. armed forces. He then branched out into the oil business and established Belco Petroleum as one of the largest industrial companies in the nation.

Critics of media coverage of Enron have noted that although articles buried in the Dec. 5, 2001 business sections of both *The Wall Street Journal* and the *New York Times* outlined the Belfer connection to Enron, subsequently the Belfer name has been relegated to the background, with functionary Kenneth Lay—essentially a “hired gun” for the Belfer family—being the scapegoat in the Enron disaster.

While the Belfer name was never mentioned once in a major *Newsweek* story purporting to tell the whole tragic Enron story, it just so happens that Belfer’s heirs were (at the time the scandal erupted) major stakeholders in Enron, dating back to the 1983 sale by Arthur Belfer of his Belco Petroleum Corp. to Enron’s predecessor.

Although Belfer died in 1993, the Belfer family’s foundation (enriched by the company’s now-controversial Enron holdings) has been funding a regularly convened “Arthur and Rochelle Belfer National Conference for Educators” held with much fanfare at the U.S. Holocaust Memorial Museum in Washington, D.C.

Two such conferences were slated for 2002. Middle- and high-school teachers from across the country who specialize in “Holocaust education” are brought by the Belfer endowment to the museum in Washington where they are trained in the process of indoctrinating school students in the lore and legend of “the Holocaust”.

What cannot be denied—despite the media’s decision to sweep the Belfer name under the rug—is that the names “Enron” and “Belfer” are practically indistinguishable.

No “disinterested party” by any means, Arthur Belfer’s son, Robert Belfer, served on Enron’s board of directors but also, more notably, on its three-man executive committee, along with Lay. While the media has cast Robert Belfer off to the sidelines, it is beyond reason to suggest that he had no knowledge of the company’s sorry state of affairs.

The public record shows that Belfer money has

also been widely distributed to Jewish causes in the United States and Israel. Robert Belfer was recently elected chair of the board of overseers of the Albert Einstein College of Medicine at Yeshiva University in New York of which he and his wife Renee have long been financial benefactors. Belfer also serves on the board of the Israeli-based Weizmann Institute of Science (a driving force behind Israel’s secret nuclear weapons development program) and of the American Jewish Committee, one of the most influential power blocs in the Israeli lobby in America.

Mrs. Belfer is also a trustee of the American Friends of the Israel Museum. The Belfers’ money giving reaches far and wide: they are also contributors to Thanks to Scandinavia, a venture that honors Scandinavians who fought against the Axis powers during World War II.

Some have suggested that because of the intimate ties of the Belfer/Enron empire to the Holocaust industry and the Israeli lobby the major media has made a conscious decision to effectively “divorce” the Belfer name from the Enron scandal in order to spare the distinguished Holocaust industry and the Israeli lobby any embarrassment.

While it appears that Belfer and his family have suffered major losses in the Enron debacle, *The Wall Street Journal* assured its readers that the family “hasn’t been wiped out financially”. Selma Ruben, Belfer’s sister, is married to Lawrence Ruben, an immensely wealthy New York real estate developer. Another sister, Anita, recently died. Her heirs are reported to have lost vast sums of money in the Enron affair.

So while the major media is hyping the entirely irrelevant question as to whether Republican politicians or Democratic politicians (or both) are somehow responsible for the collapse of Enron, the Belfer family (and those in the Holocaust industry and Israel-related causes who have thrived on Enron’s largess) are escaping the focus of public attention.

Considering the connections of Enron, it may thus be no coincidence that two of the primary congressional figures who are being touted by the media as “investigators” of Enron are Rep. Henry Waxman (D-Calif.) and Sen. Joseph Lieberman (D-Conn.), two lawmakers known as strong supporters of Israel’s cause.

Thus, from this brief overview of the now-infamous Enron scandal, which has been the subject of massive media coverage, we see that there has indeed been a hidden “Jewish connection” that has been ignored in the major broadcast and published media in this country.

The final results of the Enron affair are yet to be seen, of course, but the very fact that there has been this little-known Jewish connection that has been ignored or deliberately suppressed is a very telling indicator that Zionist power in America is so immense that such a Jewish connection remains under wraps.

In his previously mentioned book, *The Fatal Embrace*, Jewish American Professor Benjamin Ginsberg wrote candidly and forthrightly about the frequency with which one has found a “Jewish connection” in a number of major American political scandals, ranging from the legendary Credit Mobilier affair of the 19th century to the geopolitical and financial intrigues surrounding the construction of the Panama Canal—not to mention a host of other such events that have become part of American history.

And all of this is not to disregard the very definitive role that Jewish families in the United States—and worldwide—played in the massive trans-Atlantic trade in African slaves, a point widely disputed by Jewish organizations and the mass media but thoroughly documented, beyond any question, in the landmark work, *The Secret Relationship Between*

Blacks and Jews, issued by Minister Louis Farrakhan's Nation of Islam.

Of course, while the word "scandal" is not generally applied, although it should be, there is also no question that Zionist influence played a substantial role in the promotion of the outrageous lies told by the administration of George W. Bush in promoting the American invasion of Iraq in the spring of 2003, on the very eve of the Jewish holiday of Purim, at which time the Jews celebrate the destruction of their enemies, a most unpleasant type of celebration by any normal standards.

Nonetheless, the patently false claims about entirely non-existent weapons of mass destruction made by Young Bush and his Jewish advisors, such as Paul Wolfowitz, Douglas Feith and Richard Perle—and promoted in the media by such Zionist hardliners as William Kristol—were a blatant fraud on the American people (and the world).

Yet, it is highly unlikely that these guilty parties—Zionists all, Jewish and non-Jewish alike—will ever be brought before a tribunal and prosecuted for these very real war crimes.

And that is the sad reality of what happens when Zionist power has become so immense that the interests of the Zionist movement are thoroughly commingled with the affairs of a nation, resulting in a high-handed and quite blatant institutional corruption—and a prevailing lack of moral principle—that governs in high places today. The fact is that there are few—if any—limits on Zionist power in America.

While there are no laws demanding the prosecution and punishment of public officials who tell lies when they are *not* under oath (which is, unfortunately, most of the time), perhaps there should be. The bottom line is that Zionism has played a major part in some of the most outrageous—and profitable—rackets of our day.

However, another scandal of recent American history, one certainly worth reviewing, provides a bleak demonstration, in the most specific sense, of how Zionist power has infiltrated and manipulated the highest ranks of our nation's law enforcement: the U.S. Justice Department and the federal court system.

This is the INSLAW affair, the next topic of examination in our review of Zionist power in America.

THE INSLAW AFFAIR: ZIONIST CONTROL OF THE COURTS AND THE U.S. JUSTICE DEPARTMENT

The fine hand of Israeli intelligence and its influence at the highest levels in the Justice Department is the common thread running through the web of conspiracy in the INSLAW affair.

Although the INSLAW affair has faded into the background, a review of this outrageous scandal is fully appropriate in considering Zionist power in America. Here's the story.

In March 1982 the Washington, D.C.-based INSLAW company, owned by Bill and Nancy Hamilton, won a \$10 million three year contract with the Justice Department, which planned to install the remarkable PROMIS software, developed by Bill Hamilton, in the 22 largest U.S. attorneys' offices and a word-processor version in 72 others. PROMIS was a highly sophisticated tracking software perfect for use by intelligence agencies, designed for tracking targeted individuals.

In the meantime, however, Dr. Earl Brian, a longtime crony of then Attorney General Edwin Meese, began using his political clout to interfere with the Hamiltons' contract in order to win the contract for a company that he owned. This happened after the Hamiltons refused Brian's offer to purchase INSLAW. Brian, who had wide-ranging international

contacts, was widely believed to be a longtime asset of the CIA.

In early 1983 the Justice Department arranged with the Hamiltons to demonstrate PROMIS to an Israeli who called himself "Dr. Ben Orr" and who purported to be representing the Israeli Ministry of Justice. "Ben Orr" said he was most impressed with PROMIS, but, to the Hamiltons' surprise, he never bought the product.

It was only later that the Hamiltons learned why: using his contacts inside the Justice Department, Earl Brian had managed to steal the software and then provided it to LEKEM, a top-secret signals intelligence unit of the Israeli Defense Force, with the software. The head of LEKEM was longtime Mossad operative Rafael "Dirty Rafi" Eitan. In fact, Eitan was the "Dr. Ben Orr" who had visited the Hamiltons.

And by this time it had already been revealed that Eitan was the Mossad official directing the American spying operations of Israeli spy Jonathan Pollard. Eitan's LEKEM operations had been covertly funded by a series of offshore corporations in the Bahamas that had been set in place some years before by the law firm of Burns and Summit. This just happened to be the firm of Deputy Attorney General Arnold Burns, a key player in the Justice Department's campaign to liquidate INSLAW.

Former Israeli intelligence operative Ari Ben-Menashe has said that PROMIS was perfect software for use by Israeli intelligence in tracking the Palestinians and political dissidents critical of Israel. He said: "PROMIS was a very big thing for us guys, a very, very big thing. It was probably the most important issue of the 1980s because it just changed the whole intelligence outlook. The whole form of intelligence collection changed." So Brian had done his Israeli friends a big favor.

Brian also sold PROMIS to the Royal Canadian Mounted Police, the Canadian Security and Intelligence Service and to Jordanian military intelligence, among many, many other places. In truth, the full extent of Brian's intrigue in dealing PROMIS worldwide has yet to be told.

Of course, all of this was happening behind the scenes and unbeknownst, at that time, to the Hamiltons. However, by 1985—with their software totally looted and distributed internationally—the Hamiltons found that the Justice Department was withholding more than \$7 million in payments due on the contract, forcing INSLAW into insolvency. Then, in 1984, Justice abruptly canceled the contract.

While facing bankruptcy and liquidation, the owners of INSLAW were also fighting off hostile takeover attempts waged by CIA asset Earl Brian and various of his allies, including the Wall Street firm of Charles Allen and Company.

In February of 1985 the Hamiltons sought Chapter 11 bankruptcy protection in federal court in Washington and also sued the Justice Department for the damages and losses they had suffered. They hired Leigh Ratiner, an attorney with the firm of Dickstein, Shapiro and Morin, to represent them.

In the meantime, Washington attorney Leonard Garment—who represented the Hamiltons' nemesis, "Dirty Rafi" Eitan, and the interests of Israel in the Pollard spy scandal—popped up in the INSLAW affair. A friend of Eitan's covert financial benefactor, Deputy Attorney General Burns, Garment was a senior partner of Dickstein, Shapiro and Morin, which abruptly fired Ratiner, the attorney representing the Hamiltons.

The Hamiltons subsequently determined that it was quite likely that Mossad figure Eitan had transferred some \$600,000 out of an Israeli slush fund to Garment's law firm in order to finance the firm's separation

agreement with Ratiner, the Hamiltons' lawyer.

(During the same time frame, Garment himself is known to have played a part in "fixing" a case against Liberty Lobby, the publisher of *The Spotlight*, after the populist institution filed suit against *The Wall Street Journal* for publishing smears of Liberty Lobby, including one written by Garment's wife. *The Spotlight*—not coincidentally—was also reporting, in depth, on the burgeoning INSLAW scandal—more about which later.)

Despite their troubles, the Hamiltons won a much-deserved victory. The Justice Department's conspiracy against INSLAW was so patently obvious and outrageous that in January 1988 federal bankruptcy court Judge George Bason Jr. issued a ruling in favor of the Hamiltons and against the Justice Department. Bason concluded that the Justice Department had deliberately tried to bankrupt INSLAW so that they would be able to grab control of the software and not pay the Hamiltons the money they were due.

Bason's decision was subsequently upheld, but by this time, he had already been denied reappointment and removed from the bench and replaced by S. Martin Teel, who was no less than the former Justice Department lawyer who was defending Justice against the Hamiltons.

It was after Bason ruled against the Justice Department and in favor of the Hamiltons, saying Teel's clients/colleagues had stolen the PROMIS software through "trickery, fraud and deceit", Bason was denied reappointment and Teel was appointed in his place. Bason later charged, in testimony before Congress, that the Justice Department had conspired to force him off the bench in retaliation for his ruling against the department.

A key player in the effort to dislodge Bason in favor of Teel was then-Deputy Attorney General Arnold Burns, a powerful attorney with longstanding ties to the Anti-Defamation League (ADL) of B'nai B'rith. Burns is also a founder of "Nesher", a quietly influential group of some 300 high-ranking federal officials and bureaucrats who meet informally, bound together by a desire to advance the Zionist cause.

And by no coincidence, as already noted, Burns was one of the Justice Department officials who was working assiduously to liquidate INSLAW in the first place.

Former Judge Bason also raised questions about whether Teel was even professionally qualified for the promotion in light of his extremely limited experience with bankruptcy litigation.

Be that as it may, Teel was given Bason's judgeship, a reward for helping cover for a corrupt conspiracy involving complicity by assets of both the CIA and Israel's Mossad.

According to investigative reporters Mark Fricker and Stephen Pizzo, "The INSLAW case had become the judicial kiss of death in Washington, with no judge wanting any part of it. INSLAW's allegations raised serious questions about corruption and lawlessness within the Department of Justice, and the banning of U.S. Bankruptcy Judge Bason had sent the judiciary a chilling message." Chief U.S. District Judge Aubrey Robinson in Washington, D.C. said of other judges in relation to the INSLAW affair: "They wouldn't touch it with a 10-foot pole."

By this point, the Hamiltons had begun to attract some media attention, thanks in part to the pioneering efforts of independent journalists such as Harry Martin of *The Napa (California) Sentinel* and *The Spotlight* and its talk forum, *Radio Free America (RFA)*, hosted by Tom Valentine. Along with former Judge Bason, and computer specialist Michael Riconosciuto (who was associated with Earl Brian in the INSLAW intrigue) Bill and Nancy Hamilton of INSLAW were among the guests who came on RFA to discuss the scandal.

The Hamiltons were now being ably represented by former Attorney General Elliot Richardson (since deceased), who felt great disgust and revulsion at the activities of the officials in the department that he headed for a brief period during the Nixon era.

Alerted to growing public awareness of the affair, then-Rep. Jack Brooks (D-Texas), chairman of the House Judiciary Committee, convened a special inquiry into the INSLAW matter. Brooks found that the Justice Department, under the new attorney general, Dick Thornburgh, constantly stonewalled in an effort to keep the matter under wraps.

Meanwhile, the Justice Department appealed the ruling upholding former Judge Bason's judgment in favor of INSLAW to the U.S. Court of Appeals which, in May of 1990, fixed things for the department. The appeals court ruled that the Hamiltons' case should have never been in bankruptcy court in the first place and dismissed their suit, saying essentially that if the Hamiltons wanted to sue the Justice Department they would have to start all over again. The court did not address the actual merits of the complaint—simply ruling that the bankruptcy venue had never been the place to hear the case.

In 1991, under growing congressional pressure, Thornburgh's successor as attorney general, former CIA official William Barr, appointed retired federal judge Nicholas Bua of Chicago as an internal Department of Justice special counsel to investigate INSLAW, although no one ever truly believed that the Justice Department would ever find itself guilty of anything.

In 1992, after the Hamiltons appealed to the Supreme Court, the court (predictably) upheld the lower court ruling in favor of the Justice Department. In March 1993, to no one's surprise, former federal Judge Nicholas Bua submitted a special report whitewashing the Justice Department. Finally, in August of 1997 the Court of Federal Claims in Washington, D.C. ruled against the Hamiltons and found—again to no one's surprise—that the Justice Department was not guilty of any wrongdoing in the INSLAW affair, all of the evidence notwithstanding.

It is worth noting that all throughout the period as the INSLAW affair unfolded, a number of people connected to INSLAW and the investigation of the scandal started turning up dead.

- In August of 1991, the best-known INSLAW victim—independent journalist Danny Casolaro—who was working with Bill and Nancy Hamilton of INSLAW, and also collaborating closely with CIA operative and INSLAW conspiracy whistle-blower Michael Riconosciuto, was found dead in a motel room in Martinsburg, West Virginia. Although his death was ruled a "suicide", the weight of the evidence suggests otherwise. But Casolaro was only the best known of the INSLAW victims.

- In 1992, San Diego businessman and free-lance intelligence operative Ian Stuart Spiro's wife and three children were found murdered. Later Spiro was found dead in another location. Although the authorities announced Spiro (who worked for both British and Israeli intelligence) had killed his family and then himself, there are few who believe it.

What is interesting—in light of the multiple Israeli links in the INSLAW affair, is that the retired San Diego County Deputy Sheriff, Tim Carroll, who was brought in as a special "investigator" in the Spiro case, had been the longtime liaison between the sheriff's office and the Anti Defamation League (ADL) of B'nai B'rith, a conduit for the Mossad.

Not coincidentally, Carroll also helped orchestrate (and participated in) the massive (and thoroughly unwarranted) police raid in 1995 on the home of Willis A. Carto, the publisher of *The Spotlight*. This raid was part of a high-level conspiracy (with multiple

Mossad connections) which ultimately succeeded in destroying the weekly which, at the time, was the one major independent national publication exposing the INSLAW affair.

A Mexican gardener who was an apparent witness to the Spiro murders was also later murdered.

- Reporter Anson Ng of the London-based *Financial Times* was working with Casolaro investigating ties between INSLAW and money laundering connected to the Israeli-instigated Iran-contra affair. Found dead in Guatemala in July of 1991, Ng had a single bullet wound in his chest. Authorities ruled the case a suicide. Others say it was murder.

- Dennis Eisman, attorney for INSLAW whistle-blower Michael Riconosciuto, was also found with a gunshot wound in his chest. That, too, was ruled a suicide, yet another convenient death.

- In March of 1990, British journalist Jonathan Moyle, who was investigating an INSLAW figure in Chile was found hanging in his hotel wardrobe in Santiago. Again, said to be "suicide".

- Defense analyst Alan D. Standorf. His body was found at Washington National Airport on the floor of a car beneath luggage. He worked at a secret military listening post in suburban Virginia.

- Former Nixon aide Michael Allen May died four days after *The Napa Sentinel* reported his connections to the so-called "October Surprise" scandal which also implicated INSLAW conspirator Earl Brian. An autopsy said May had pharmaceutical drugs in his system.

- Engineer Barry Kumnick disappeared after inventing a new computer program that could project the thoughts and characteristics of criminal or military individuals and predict behavior or movement. Kumnick's system was designed to work with the PROMIS software developed by INSLAW. Just another convenient death in a string of many.

Evidence unearthed by INSLAW's attorney, Elliot Richardson, points toward who was most likely responsible for this series of murders and this secret underlies the Zionist connections of the INSLAW affair.

The fact is that Richardson and the Hamiltons discovered that the Justice Department's "Nazi-hunting" Office of Special Investigations (OSI) was being deployed as the base of a top-secret covert operations unit of the Justice Department and that it was the OSI that was actually responsible for the theft of INSLAW's PROMIS software. One undeclared mission of this covert intelligence service has been the illegal dissemination of the proprietary version of PROMIS, according to information from reliable sources with ties to the U.S. intelligence community.

INSLAW has, moreover, obtained a copy of a 27-page Justice Department computer printout labeled "Criminal Division Vendor List". That list is actually a list of the commercial organizations and individuals who serve as "cutouts" for this secret Justice Department intelligence agency....

The Justice Department's secret intelligence agency also has its own "proprietary" company that employs scores of agents of diverse

nationalities, as well as individuals who appear to be regular employees of various departments and agencies of the U.S. government or members of the U.S. armed forces, according to several sources.

Richardson's brief also made the stunning suggestion that evidence suggests INSLAW investigator Danny Casolaro was murdered by this secret Justice Department unit inside the OSI.

Since it is no secret that the OSI has worked closely for years with Israel's intelligence service, a logical conclusion can be drawn that the OSI and the secret Justice Department unit inside the OSI itself are effectively acting as assets of the Mossad.

U.S.-ISRAEL CRISIS DEEPENS OVER DEFENSE EXPORTS TO CHINA

The U.S. administration has refused to rescind sanctions against Israel until the latter proves it has increased its monitoring of security-related exports, deepening the crisis between the two countries.

Defense Minister Shaul Mofaz, who was about to leave for Washington for talks on the matter, canceled the trip following the increased U.S. demands.

The crisis erupted over Israel’s sale to China of replacement parts for Harpy attack drones.

The U.S. wants to see Knesset legislation enacted within 18 months tightening oversight of military exports, and is demanding a memorandum of understanding be signed. The U.S. also wants a written apology from Israel and Mofaz.

Opposition in Israel is mounting against the signing of such a memorandum. In any case, the agreement is not intended to end the crisis, but rather to stop it from gathering steam, by allowing for the gradual lifting of sanctions.

The sanctions were imposed as the result of a bill passed last month by the U.S. House of Representatives, which placed a five-year ban on the purchase of defense items from any country that sells arms to China.

Israel sold China the drones, which are said to attack and destroy enemy radar transmitters, in the mid-1990s. It says that it is now upgrading them as provided for in the sales agreement.

Israel believed the tension between the two countries was going to subside after Mofaz went to Washington to sign the understanding, in which Israel agreed to meet most of the U.S. demands. However, the harsher demands are an indirect way of rejecting a request by Mofaz to end the crisis and rescind the penalties, which could do serious harm to Israel’s defense industries and air force.

After Israel raised a white flag and acquiesced to most of the demands, the U.S. made additional, harsher demands, and was said to have shown contempt for the Israeli delegation. The American delegation is headed by Lisa Bronson from the Pentagon, and also includes a representative from the State Department, the head of its Bureau for Political-Military Affairs, Acting Assistant Secretary Rose Likins, who is the principal link between the departments of state and defense. Likins had recently met with Mofaz in Israel.

The draft referendum points to a lack of understanding on the part of the U.S. of domestic political affairs in Israel. It is a strange agreement, by which Israel agrees to the continued sanctions the Americans are imposing.

The article in the agreement putting pressure on the Knesset to enact a law monitoring military exports is sure to arouse the ire of several of Israel’s lawmakers.

The Americans are said to be angry at the media reports that appear every time the Israeli delegation has been about to leave for talks in the U.S. The Americans

understand the talks to be Defense Ministry briefings, while in Israel they were reported as bringing about an end to the crisis over the Israel-China drone parts deal.

Now Uzbekistan, a member of the SCO, has taken the next step, demanding that the U.S. abandon its base in that country.

UZBEKISTAN KICKS U.S. OUT OF MILITARY BASE

Uzbekistan has given the U.S. six months to close its military base there, in its first move to sever relations with its former sponsor.

The air base near the southern town of Khanabad, known as K2, was opened weeks after the September 11 attacks to provide vital logistical support for Operation Enduring Freedom in neighbouring Afghanistan.

Analysts have said that Uzbekistan agreed to the base, the first Pentagon presence in what is a former Soviet stronghold of central Asia, because of a large U.S. aid package and Washington’s silence about the country’s appalling human rights record.

A U.S. defence department spokesman said at the weekend: “We got a note at the U.S. embassy in Tashkent on Friday; the gist of it was that we have 180 days to cease operations at the K2 airfield.”

He added that the defence and state departments were evaluating “the exact nature” of the request. “K2 has been an important asset for the war in Afghanistan,” he said. “We will have to evaluate what to do next.”

The U.S. presence in Uzbekistan has been under intense moral scrutiny after the massacre by Uzbek troops of hundreds of civilians in the southern city of Andijan in May.

The White House was at first muted in its criticism of the massacre, but the state department has grown increasingly vocal in condemning the attack and calling for an independent investigation.

The Pentagon has sought to renew the leasing agreement for the base, for which it has paid \$15m to the regime of President Islam Karimov since 2001.

Critics have accused the U.S. of propping up one of the world’s most brutal regimes in exchange for the base’s short-term benefits. The Uzbek authorities are accused of killing and jailing ordinary Muslims under the guise of fighting religious extremism and terrorism, and the state department says torture is used by police in Uzbekistan as a “routine investigation technique”.

A former British ambassador to Uzbekistan, Craig Murray, who was sacked after criticising western support for the Uzbek regime, said: “The U.S. has managed to hand the dictator Karimov the propaganda coup of kicking out the world’s greatest power. Western policy towards Uzbekistan has been unsustainable for a long time.”

He said the Uzbek decision to curtail relations with Washington was “due to a change-around in economic policy. There has been no significant investment from the west for a while; **it’s all Russian and Chinese state-owned companies.**”

“Karimov took the decision years ago not to have democracy and capitalism, it just took the U.S. a lot longer to work that out.

...He said the move would put pressure on other

central Asian states to turn away from the west, towards China and Russia, because of their reliance on Uzbekistan’s resources.

Uzbekistan’s demand for the Americans to leave the base prompted a senior state department official to cancel a planned visit to the capital, Tashkent, according to the *New York Times*.

...The *New York Times* also quoted a senior state department official as saying that the Uzbek demand was connected to U.S. support for neighbouring Kyrgyzstan’s refusal to send home those who had fled Uzbekistan after the Andijan massacre.

The U.S. secretary of state, Condoleezza Rice, has phoned the Kyrgyz government about 29 of those who fled, now being held in the southern city of Osh, and asked that they be ferried out by the UN to a neutral third country.

Her intervention sparked the Uzbek demand for the base to be closed, the official said.

VIENTIANE—A set of documents, including a complex, long-term program and a Russia-ASEAN economic agreement, will be adopted at the first Russia-ASEAN summit in Kuala Lumpur in December, Russian Foreign Minister Sergei Lavrov said Thursday.

Lavrov, who was attending a Russia-ASEAN conference in Laos’ capital, said the sides agreed to promote counter-terrorism cooperation on the basis of the relevant agreement.

The conferees outlined “serious cooperation prospects on disaster prevention and relief”, he said.

Lavrov said at the conference that Russian-ASEAN cooperation had become an important stability and development factor in the Asia-Pacific region.

“The Association has not only become an organizer of economic integration, but also a core element of political interaction in the region,” he said. “Russia, whose destiny is linked with Asia, regards itself as an important figure in these processes.”

The Association of Southeast Asian Nations (ASEAN), formed in 1967, comprises Indonesia, Malaysia, Singapore, Thailand, the Philippines, Brunei, Vietnam, Laos, Myanmar and Cambodia.

RUSSIA, CHINA TAKE RELATIONS TO NEW LEVEL

MOSCOW—Two economic and political leaders of the future—Russia and China—are taking their relations to a new level with clear ambitions to influence the global geopolitical order, two respected dailies reported Wednesday.

Izvestia and *Nezavisimaya Gazeta* dailies wrote that a joint military exercise, Peaceful Mission 2005, which is scheduled for late August, is designed to show this.

According to Goldman Sachs, a U.S.

investment bank, the main global trends in 2050 will have been formed by the so-called BRIC, which is made up of four rapidly developing nations: Brazil, Russia, India and China. According to *Izvestia*, Brazil trails Russia in all respects, and Russia's relations with India and China have been given priority in recent times. So far, this has not been done to counterbalance the West.

There are problems in Russian-Chinese relations, but they obviously feature more positives than negatives. Territorial disputes have been settled without any particular difficulties, Chinese investment is welcome in Russia and concerns about an increase in Chinese workers coming to Russia can be eased by resolving the problem of migration.

The Russian economy, primarily consumers and gross domestic product, needs Chinese workers and investment. In this context, the joint military exercise combines politics, geopolitics and economic, as well as being significant for the two countries, which view themselves as future superpowers.

Nezavisimaya Gazeta wrote that the biggest concerns of the United States and other Pacific countries were that the exercise would be conducted under the aegis of the Shanghai Cooperation Organization (SCO), which comprises China, Kazakhstan, Kyrgyzstan, Russia,

Tajikistan and Uzbekistan. While the organization used to be regarded as an anti-terrorist one, it is now beginning to show the signs of a military bloc. If India joins the SCO, a bloc covering Eurasia might emerge, which, no doubt, would bring an end to the unipolar world that emerged after the Cold War.

DISTANT OBJECT FOUND ORBITING SUN

Astronomers have found a large object in the Solar System's outer reaches. It is being hailed as "a great discovery".

Details of the object are still sketchy. It never comes closer to the Sun than Neptune and spends most of its time much further out than Pluto.

It is one of the largest objects ever found in the outer Solar System and is almost certainly made of ice and rock.

It is at least 1,500km (930 miles) across and may be

larger than Pluto, which is 2,274km (1,400 miles) across.

The uncertainty in estimates of its size is due to errors in its reflectivity.

It might be a large, dim object [*like Nibiru*], or a smaller, brighter object. Whatever it is, astronomers consider it a major discovery.

...It was picked up by astronomers of the Institute of Astrophysics in Andalusia as part of a survey of the outer solar system for new objects that they have been carrying out since 2002.

"We found a bright, slow moving object while checking some older images of our survey for Trans-Neptunian Objects," Jose-Luis Ortiz, one of the objects co-discoverers, told the *BBC News* website.

It was subsequently designated 2003 EL61.

However, American astronomers also appear to have detected it.

The same team that found Sedna have designated it K40506A after it was picked up by the Gemini telescope and one of the twin Keck telescopes in Hawaii.

They are due to present their findings at a conference in Cambridge in September.

Because the object is relatively bright, astronomers are frantically checking other observations that may have picked it up, particularly robotic sky surveys.



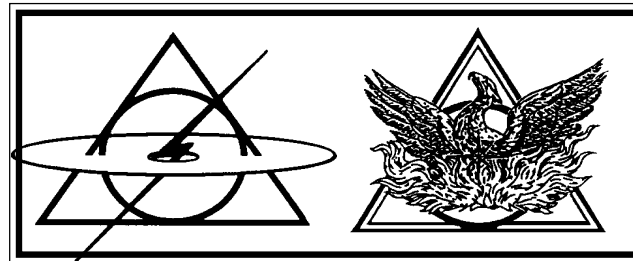
