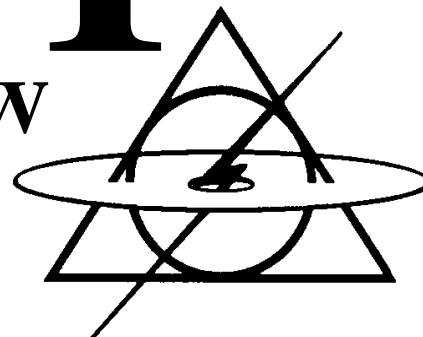

Marvelous Ethanol

ENERGY FREEDOM AHEAD

OMAHA, Nebraska—Like the first automobiles made by Henry Ford in America, the “Indy” cars at the 2007 Indianapolis 500 will be racing around the track at 230 miles per hour on 100 percent ethanol.

From California to New York drivers are filling their tanks with E-10 fuel, which is unleaded gas with 10 percent ethanol. In some states ethanol is used to oxygenate the gas and replace the banned methyl tertiary butyl ether. The ethanol makes the gas burn more efficiently and cleaner. “It’s good for the environment; good for the balance of trade; good for the American farmer and our rural communities; and it’s significantly lowering our nation’s dependence on foreign oil,” Jeff Broin, CEO of Broin Companies, told *American Free Press*.

Broin Companies design and build ethanol plants and manage and market the products from 16 plants. The corn mash that is left over from the production of ethanol is sold as high-protein livestock and poultry feed. There are more than 8,000 private investors in the 16 plants Broin manages. “A very high percentage of them are farmers,” he said, “adding value to their grain.” From the 700 million gallons ethanol produced every year in these plants, he said, there is a yield of 2 million tons of high protein cattle feed.

“Ethanol is a high performance renewable fuel that is good for the environment and made in America,” Broin said. “Forty billion gallons of ethanol-blended fuel are used in the U.S. per year. Bio-fuels have been and will continue to be an increasing portion of the U.S. fuel supply.”

Pure ethanol produces only carbon dioxide and water as emissions, Broin said, and E-10 in your car will clean up your tail pipe emissions 15 to 33 percent. The non-profit American Coalition for Ethanol (ACE) says ethanol production is “extremely energy efficient”, with a positive net energy balance of 125 percent compared to 85 percent for gasoline. This makes ethanol production “by far the most efficient method of producing liquid transportation fuels”, according to ACE.

Seven out of eight major studies have shown that ethanol production yields a net positive energy gain of between 20 and 36 percent.

The Energy Security Act of 2005, passed in late July, contains critical provisions that will double the nation’s use of clean-burning, renewable fuels such as ethanol. By 2012, demand for ethanol and biodiesel fuels in the United States will reach a minimum of 7.5 billion gallons annually through the newly enacted Renewable Fuels Standard. “This nationwide Renewable Fuels Standard is a significant victory, both for the people who have built the ethanol industry and for the American public who will benefit from a larger supply of homegrown, cost-effective fuel,” said Bob Scott, ACE President. “It is time for this country to take charge of its energy situation, and the production and use of ethanol empowers us to fuel an important portion of our own energy needs.”

Currently some 550 gas stations in the United States offer an 85 percent ethanol fuel, known as E-85, and the number of outlets is expected to double in the coming year, according to Robert White of the National Ethanol Vehicle Coalition. Where a gallon of unleaded gas costs \$2.45 in the Midwest, a gallon of E-85 sells for \$1.89. Four million cars currently on the road in America are

“flexible-fuel” vehicles designed to run on E-85, like White’s 320 horsepower Chevrolet Avalanche. Daimler Chrysler, Ford, General Motors, Mercedes-Benz, Nissan, and Saab all offer “flex fuel” vehicles.

Clearly ethanol production from corn and the more drought resistant sorghum is a growing industry across the Midwest, bringing much needed revitalization to many rural communities. One bushel of corn will produce 2.8 gallons of ethanol. Using corn to make ethanol increases the value of a bushel of corn, making it a winning solution for American farmers.

I traveled from Chicago to Omaha on Amtrak to attend the ACE ethanol conference and trade show and learn about the many benefits of America’s homegrown alternative to imported oil from the Middle East.

As the train rumbled through the Midwest’s endless fields of corn, I read the latest newspaper reports about how the soaring price of gasoline was profiting few while hurting many. Rising oil prices have resulted in bigger profits, year after year, for the oil producers.

ExxonMobil, *USA Today* reported, earned \$7.8 billion in the second quarter, a 35 percent increase over last year’s record profits, while polls show that two-thirds of the American people say the high price of gas will cause them “financial hardship” during the next six months.

“More than a third said the hardship will be serious,” the 48-state *AP-AOL News* poll conducted in early August reported.

As I watched the nightly news on CNN, I was surprised to hear the talking heads advise viewers not to buy ethanol-blended gasoline because it would reduce their mileage.

As 1,000 people from across the nation attended the ethanol conference at the Qwest Center, *The Omaha World Herald’s* lead editorial warned readers to avoid ethanol blended gas because it could damage their cars and reduce their mileage.

The anti-ethanol editorial was largely based on a recent article published in *Popular Mechanics*, which, as *American Free Press* has revealed, has become a propaganda outlet for the most radical elements in the Bush administration.

A “Fuel Economy Study” comparing performance and cost of ethanol blends and standard unleaded gasoline was commissioned by ACE and the results released on Aug. 17. The study compared four different ethanol blends, E-10, E-20, E-30, and E-10 AK, which contained ethanol denatured with isopentane and biodiesel.

The cars used in the test were a 2005 Chevrolet Impala, a 2004 Toyota, and a 2005 Ford Taurus.

All three cars got the best mileage using the E-10 AK blend. While the test cars showed slightly reduced mileage using the E-10, 20, and 30 blends, their cost per mile was significantly lower than when they used unleaded gasoline. “In general,” the study concluded, “the more ethanol used, the lower the cost per mile.”

Paying \$20 at the gas pump, drivers can travel up to 15 miles farther on ethanol-blended fuel than on straight unleaded, ACE said in its press release on the study.

“If drivers want to save money at the pump as gas prices reach new record highs, this pilot study confirms that ethanol is the fuel of choice,” Brian Jennings, ACE executive vice president, said. “Using ethanol is like money in your pocket, and you feel good about filling up on this home-grown fuel because it comes from America’s farm fields, not the oil fields of the Middle East.”

“Our dependence on foreign oil will cripple and ultimately destroy this nation,” former Sen. Tom Daschle (D-S. D.) said in his speech at the ACE awards banquet.

In South Dakota, Daschle said, every third row of corn now goes to produce ethanol.

“In 10 years we will be producing 15 billion gallons of ethanol,” Daschle said. “America’s corn fields will be our victory gardens.”

OPENING UP JEWISH EYES

My position is not an enviable one. I am a daughter of Jewish parents who grew up with a conventional set of beliefs. Although I never had the "chosen people" nonsense fed to me, I was conditioned by certain factors in my childhood. My Jewish education was paltry at best, perhaps because my sister and I preferred to "sleep in" rather [than] to attend Sunday school. And yet, I was given the usual "there's an anti-Semite under every rock" warning. I had a meal of fear and paranoia served up with my weekly brisket.

My mother once told me about a woman in the family who had married an Italian fellow.

"Every time they fought, he called her a kike." I don't know whether or not it was a true story. I don't know if it was merely my mother's way of keeping my leash attached to her so that I would not stray from the clan. After all, she had been tormented as a child and called a "Christ Killer". I suspect that, on one level, she was motivated by motherly love. And yet, I believe it was her "fear" which played a more significant role. Unfortunately for Mom, "fear" was not a teacher whose class I willingly attended, and as I grew older, forbidden fruit developed a sweet fragrance.

As my sister and I aged, our rebellious natures emerged. We experimented with psychedelics and dated all types of people. I do not believe it was a personal vendetta against my parents. I do not believe it was an "I'll show you" statement. It was, I believe, intellectual curiosity and a need to make my own mistakes that accompanied me along my journey; and mistakes I made—although I prefer to call them "learning experiences". In the words of Frank Sinatra (or Paul Anka) "I did it my way." Religion, parental warnings, government statements and rules were not blindly accepted. They had to make sense to me, and they rarely did. I grimaced when some authority figure told me, "It's true because I say it's true."

My mother was a Zionist who, as she grew older, used her coloratura [*the ornamentation of music written for the voice with florid passages, especially trills and runs*] soprano voice to sing at fund raisers. She claimed to be an atheist. My father had been raised in an orthodox family and opted to become a doctor because he had witnessed the excruciating death of his mother from esophageal cancer when he was but a young boy. He was truly motivated by the desire to help. Dad was an old fashioned doctor who made house-calls but never made a great deal of money. Those who have

read my essays know the details of my past. Since my purpose is not to bore you to tears, I will resist the urge to describe my upbringing in great detail.

Although I was raised on the usual Jewish diet of paranoia, I found myself extending my circle of friends to all colors and belief systems. It was the time of the sixties, and since I was a Greenwich Village hippie, race and religion were never factors in my friendships. As Martin Luther King said, "It was the content of ones character" that attracted me.

In those days, I was not a political animal though I listened attentively as my parents and older sister discussed politics. When JFK, RFK, MLK and Malcolm X were assassinated, I tried to silence the "still small voice" within me. I began a foray into the world of spirituality and clung to my innocence. However, like a withering branch, it was destined to snap. And, snap it did.

I found myself in an upside down world in which such horrors as Waco, the Mena Arkansas drug drops, and the OKC bombing awakened me from my somnolence. Though I concentrated on spirituality I could no longer silence my inner voice. Something was deadly wrong on Planet Earth. I knew that all my meditation and acts of kindness were not enough. As an inhabitant of three-dimensional reality, I had to find a balance between the mountain top and the valley.

And, though many years have passed, I still strive hungrily for that balance. Maybe I always will.

On September 11, 2001, my little world was knocked off its axis. I quickly found myself among a group of 911 truth seekers who could not accept the government's official fiction of Arab [hijackers] with box-cutters flying planes into the World Trade Center. A new chapter of my life had begun. I wanted to share my beliefs with friends.

I recall the first time I spoke about David Icke to a churchgoing woman with whom I'd taught.

"But he's a Nazi" she warned me as she sent me a disinformation website.

"Have you ever read his writings or seen him speak?" I inquired.

"NO."

Case closed. I realized that my newfound information was not going to be easily accepted.

Next came my reeducation about the country of Israel. I was dismayed to learn that it was not the "lone democracy in the Middle East" anymore than Lee Harvey Oswald was the "lone gunman" who assassinated John F Kennedy. I was shocked to see the myth of "A people without a land . . . and a land without people" smashed before my eyes. I was horrified to learn that Israel was a racist, apartheid state. I was heartbroken as I read about the massacres and systematic elimination of the Palestinian people, and the twisted fiction that the history books had placed in front of our eyes and between our ears. I saw the myth about how Israel had taken desert land that had been occupied by a nomadic group of savages and turned it into a productive fertile oasis explode before me. Once again the history books had become a fiction of the most devastating distortion proportions.

I read Ralph Schoenman's book *The Hidden History of Zionism* and listened to Ralph and his wife Mya Shone's radio show "Taking Aim".

The Israelis had seized the Palestinian people's citrus groves, olive trees, rock quarries and homes. They had brutalized the peoples of that area. They had eradicated farmers, artisans and town dwellers and substituted a work force composed of a settler population. The history of Palestine was one of unspeakable suffering and subjugation, armed displacement, massacre and expulsion.

Through Ralph Schoenman, I learned that Rabbi Fishman had presented a map to the UN's select committee on Palestine based on Theodore Herzl's diaries. It declared Eretz Israel stretched from the brook of Egypt to the Euphrates, including all of Palestine, all of Transjordan, Egypt up to the Nile including Cairo, 2/3 of Syria, 40% of Iraq, the southern tier of Turkey, up to and encapsulating Kuwait.

The Zionists were awarded 55% of the most fertile land.

Every major Zionist spokesman talked about eliminating the Palestinians. It was no secret, though an uncanny amount of people today do not seem to know about it.

The Kermit report stated, "We will use terror, assassination, intimidation, land confiscation, and cutting off all social services to rid Galilee of its Arab population."

Moise Dayan talked about how the geography books were changed. Records of the villages and towns no longer exist.

It was through the *Hidden History of Zionism* that I first learned about the Nazi/Zionist collaboration and how the ordinary Jew had been duped by an unconscionable cabal of greed and power. Sadly, I might add, the rank and file Jew is still being duped.

I want to wake up the ordinary Jewish person to the crimes that their leaders have perpetrated and continue to perpetrate. For, at the end of the day, the rank and file Jew is as expendable in the Zionists' grand scheme as the rest of the populace is. There is no safety in tribal banding together. It is only the truth which can set us free.

And yet, I have not found the vocabulary. Should I give up? Can I make a difference or am I merely trying to hold back a boulder?

The other night I watched a television special about Bob Dylan. I was struck by his youth and the profundity of his words. I felt myself drowning in a sea of nostalgia. Were those times as pure as they appeared? Were those times as idealistic as I remembered? Have I romanticized the hopes and dreams of the '60s? Perhaps . . . but I doubt it. Of course we were dreamers, but we were dreaming of a wonderful world. We were dreaming of a world upon which we felt we could have a great impact. We believed in our dream. Do we still have vestiges of that dream as 300,000 people demonstrated in Washington, DC on September 24th, 2005?

And yet, as I look out on a world so precariously close to the edge, a world that appears to be hanging onto that withered branch that I know all too well, I can only ask, "What in God's name has happened to us?"

STONEMAN. Boston. Samuel Stoneman was vice chairman of the board of General Cinema Corporation. His daughters are Jane Stein and Elizabeth Deknatel. They run the family's foundation.

AARON STRAUS. Baltimore. The family fortune was based on the nationwide Reliable Stores Corporation. They are major contributors to "good" causes in the Baltimore region.

NATHAN & OSCAR STRAUS. New York. Heirs to the R. H. Macy and Abraham & Straus department store fortunes. Oscar Straus II and Oscar Straus III are key family figures today.

STRAUSS. Dallas. Former Democratic Party National Chairman and U.S. Ambassador to Russia, Robert Strauss is a high-powered lawyer with the firm of Akin, Gump, Strauss, Hauer & Feld. The son of Charles, a merchant, Robert Strauss was a key player in the rise of Lyndon Johnson to the presidency. His brother Ted's wife Annette formerly served as mayor of Dallas.

STRELITZ. Norfolk, Virginia. The Haynes home furnishing chain, based in Virginia, is the source of this family's wealth. E. J. Strelitz is CEO of the company.

SWIG. San Francisco. This family owns the Fairmont Hotel in San Francisco and other Fairmonts across the country. The Plaza Hotel is one of their crown jewels. Benjamin Swig and his son Melvin opened up the first shopping mall in the United States. Ben was partnered with Jack Weiler (See ARNOW-WEILER) in the commercial real estate business. Ben's brother Richard, and Ben's sons Kent, Robert and Steven, are involved in family foundation activities along with an in-law, Richard Dinner.

SYMS. New York. Sy Syms, head of the Syms Corp., which has a chain of 40 stores selling designer

labels at discount prices, has brought his son Robert and daughter Marcy into the family business. Marcy has been a vice president of the American Jewish Congress. The family has also branched out into real estate.

TAUBER. Detroit. Joel Tauber made his fortune in manufacturing: Key Fasteners, Key Plastics (automotive parts) Keywell Corporation (scrap metal) and Complex Tooling & Molding (computer parts). Son Brian is involved in the family business. Daughter Ellen Horing is a money manager in New York. Another daughter, Julie McMahan, works with disadvantaged children.

TAUBMAN. New York. Developer of major shopping malls nationwide, Taubman had early business dealings with Max Fisher of Detroit (See MAX FISHER) and has been closely associated with Leslie Wexner (See WEXNER) of The Limited stores. Taubman was involved in the purchase and sale of the Irvine Ranch in Southern California. Taubman bought the Sotheby's auction house and ended up being sentenced to a year in jail for price fixing. *Vanity Fair* reported in late 2002 that Taubman was a popular figure among his fellow inmates. His sons William and Robert are big players in the family empire.

TISCH. New York. Leading supporters of Israel, best known today for their control of the CBS broadcasting empire, Lawrence and Preston Tisch were among the most powerful Jews in America, although Lawrence recently died. Loews, CAN Financial, Lorillard and Bulova are all part of the Tisch empire. Lawrence had sons James, Daniel, Tom and Andrew, the latter involved in the executive committee of the American Israel Public Affairs Committee. Preston, who owns the Giants team, served as postmaster general of the United States. His son Steve is a filmmaker and his son Jonathan is the president of Loew's hotels.

TISHMAN. New York. This construction family includes David, Norman, Paul, Louis and Alex. Numerous family members are highly active in Jewish affairs. Nina Tishman Alexander and her husband Richard Alexander and Bruce Diker, another family heir, are among the family members engaged in a variety of causes.

WASSERMAN. Los Angeles. The late Lou Wasserman, longtime head of MCA, the entertainment conglomerate, was—along with his partner, Jules Stein—a sponsor of the rise to fame (in films and in politics) of Ronald Reagan. He has been called the "king" of Hollywood.

WEILL. New York. As chairman and CEO of the Travelers Group, Sanford Weill is one of America's wealthiest Jewish tycoons. His son Marc is ensconced at Travelers. His daughter Jessica Bibliowicz runs Smith Barney Mutual Funds.

WEINBERG. Baltimore-Hawaii. Harry Weinberg started off in the transit business in Baltimore and then branched out to Hawaii where he became a major player in the real estate business during the 1950s when air tourism to the islands boomed.

WEINER. New York. Chairman and CEO of Republic National Bank of New York and Republic New York Corporation—founded by Edmond Safra (See SAFRA)—Walter Weiner was a founding partner of Kronish, Lieb, Weiner & Hellman. His sons are

John and Tom.

WEXNER. New York-Columbus, Ohio. Leslie Wexner owns it all: The Limited, Express, Lerner's, Victoria's Secret, Henry Bendel, Abercrombie & Fitch, Bath and Body Works, and Lane Bryant. He is particularly concerned with educating future Jewish leaders.

WINIK. New York. Elaine Winik was the first female president of the United Jewish Appeal-Federation and chair of the United Jewish Appeal. Her daughter Penny Goldsmith is a major figure in AIPAC and in the ADL. The Winik fortune was made in the production of handbags.

WINTER. Milwaukee. Elmer Winter started Manpower, the temporary employment agency that has 1,000 offices in some 32 countries. He's also been active in expanding business between the United States and Israel and served as national director of the American Jewish Committee.

WOLFENSOHN. New York. Born in Australia and trained as a merchant banker in London, James Wolfensohn became an executive partner at Salomon Brothers in New York. In 1995 he was appointed head of the World Bank—truly a one-man Jewish powerhouse.

WOLFSON. Miami. The Wolfson-Meyer Theater Company became Wometco and in 1984 was acquired by Kohlberg, Kravis, Roberts & Company after having established itself as a pioneer in motion picture and television broadcasting in the 1920s. The investment firms Wolfson Initiative Corporation and the Novecentro Corporation are parts of the family empire. Family members include Louis III and Mitchell. The best known Wolfson was the infamous Louis who became entangled in an unpleasant scandal involving former U.S. Supreme Court Justice William O. Douglas who was taking money from the Wolfson family foundation.

ZABAN. Atlanta. Based on a janitorial supply firm, Mandle Zaban and his brother Sam and his son Erwin established Zep Manufacturing that ultimately evolved into National Service Industries, now ruled by Erwin who has been a director of the Anti-Defamation League.

ZALE. Texas. Morris Zale established one of the world's largest jewelry chains, but the company was sold in 1987. Heirs David, Marjory, Stanley and Janet are active in Jewish affairs. The two sons still work in the jewelry business.

ZARROW. Tulsa, Oklahoma. Henry and Jack Zarrow produce oil rigging parts and supplies through the Sooner Pipe and Supply Corporation.

ZILKHA. Truly a "global" Jewish family, the Zilkhas are heirs to the international Banque Zilkha which had been the largest privately-owned commercial bank in—get this—the Arab world. After the founding of Israel, the Baghdad-based French-speaking family moved west. Family chief Ezra has son Elias and daughters Donna Zilkha Krisel and Bettina Louise. Major players in the small Sephardic Jewish elite in America and active in Israel. They have also branched out into arms manufacturing.

ZIMMERMAN. Boston-Atlanta-Palm Beach. Harriet Morse Zimmerman, the daughter of a Boston shoe manufacturer, was a vice president of AIPAC and once arrogantly bragged that "the biggest donor to Israel in the world is the U.S. Congress." Her son Robert is active in Westport, Connecticut. Her daughter Claire Marx and her son-in-law, Mark O'Leary, are also heavily involved in Jewish affairs.

So there we have it—a grand overview of what are undoubtedly the most powerful Jewish families in America. By no means, as we have said, is the list complete. There are many other names that could be added to the list, usually "lesser fry" (so to speak) in some of the smaller cities and locales around the country.

In addition, there are an increasing number of powerful and wealthy foreign Jewish families—from

Israel, Iran, Russia and elsewhere—establishing their positions on American shores.

Although it would be convenient, for literary sake, to be able to say that there are “200” or “300” or “400” particular families—in the style of some fanciful and contrived conspiracy-minded works or even in the style of *Forbes* and *Fortune* magazine, this would betray reality. What we have assembled here, in easy-to-read format, based on a thoroughly “respectable” and sympathetic source, is a perfectly acceptable accounting of the vast array of wealth and power assembled in relatively few hands, a few families whose faces and names are largely unknown to the American (or world) public as a whole.

But rest assured that they are powerful and that persons behind the scenes (and those in political office) know very well who these elite power brokers are. They are, as we have said, able to make American presidents and politicians, and they are able to break them. They are truly Those Who Reign Supreme in America—the New Jerusalem.

And now, before we proceed into an in-depth examination of very specific facts and figures about the vast wealth and power of the Zionist elite, let us take one more brief digression and examine a particularly well-known American entrepreneur who—while not Jewish (so far as is known)—does, in fact, owe his rise to fame and wealth due to his behind-the-scenes support from some of the most powerful Zionist families in the United States today. We refer to the one and only Donald Trump.

WHO TOWERS BEHIND TRUMP? THE STRANGE STORY OF “THE DONALD”

No, Donald Trump is not Jewish, but an inquiry into the background of this flamboyant American entrepreneur provides some surprising insights into Trump’s path to power and influence, for the fact is that Trump’s rise to stardom came as a direct consequence of his having functioned as hardly more than a colorful front man for some very wealthy behind the scenes sponsors. The story of the colorful businessman (and now television star) called “The Donald” is one that demonstrates how non-Jewish individuals and financial interests can rise to great heights through the sponsorship of Jewish interests.

Everyone knows, of course, about Trump’s gambling operations and of the wide-ranging links of the gambling industry to organized crime. But the story is much bigger than that. In his own memoir, *The Art of the Deal*, Trump proudly described how in 1987 he bought his first casino interests when he purchased 93 percent of the voting stock in the Resorts International gambling concern.

What Trump doesn’t tell his readers is what the late Andrew St. George reported in *The Spotlight* on Oct. 30, 1978 (and in the previous Sept. 25, 1978 issue): that Resorts International was established and controlled by front men for the Rockefeller and Rothschild families and their “enforcers” in the CIA and its allied intelligence agency, Israel’s Mossad.

The Spotlight’s report focused on the activities of Resorts International and provided readers with an extensive overview of the “fixed” gambling rackets conducted by underworld gambling elements.

What made the report so explosive was that this newspaper pointed out that the illegally rigged casinos were being operated with the collusion of “respectable” politicians, law enforcement officials, Wall Street financiers who floated loans to finance the gambling resorts, and the high-profile gambling resort operators themselves.

In addition, as St. George pointed out, many of these casino resorts run by the mob through a variety of front

men have actually been engaged in a *de facto* partnership with behind-the-scenes mobsters who have assisted the CIA and the Mossad in massive laundering of drug and gambling profits that have been channeled into covert operations of the two allied intelligence agencies. In return, the CIA and the Mossad, using their own influence, have provided “protection” for the illegally fixed gambling operations, preventing law enforcement authorities from cracking down on this corruption.

Where does would-be president Donald Trump fit into the picture? To find the answer, one must turn to the murky origins of Resorts International.

In fact, Resorts evolved from a CIA front company set up in the early 1950s by then-CIA director Allen Dulles and his close associate, three-term New York Governor Thomas E. Dewey, political functionary in the so-called “Rockefeller Republican” wing of the GOP.

The front company in question was the innocuously named Mary Carter Paint Company which did, in fact, operate a national chain of paint stores but which was set up to function as a covert CIA money laundering operation.

In 1958-59 Dewey and a number of associates used a reported \$2 million in CIA funds to buy a controlling interest in the Crosby-Miller Corporation (headed by Dewey friend James Crosby) which was then merged with Mary Carter.

Among other things, the new corporation laundered CIA money for arming the anti-Castro Cuban exiles. The company also launched into lucrative casino gambling enterprises in the Caribbean where the CIA was quite active during that period, having engaged the Lansky crime syndicate in now-thoroughly documented and widely known plots to topple Fidel Castro who had enraged the mob by closing down its Cuban gambling enterprises.

Thus it should be no surprise that in 1963, Alvin Malnik, a top henchman of crime syndicate boss Meyer Lansky, was found to be closely connected to the operations of Mary Carter Paint.

Imagine how many law-abiding Americans who bought Mary Carter’s paint products would have been surprised to learn that they were helping fund a joint operation of the CIA and the mob which posed behind the smiling face of a “typical American housewife”, the fictional “Mary Carter” whose visage adorned its products.

In 1963 Mary Carter Paint spun off its paint division and during the next several years began developing its casino operations, particularly in the Bahamas.

In 1967-68 Mary Carter Paint officially changed its name to Resorts International and began massive expansion internationally. *The Spotlight* determined that several principal investors provided the funds and assets for the venture:

- Meyer Lansky, the acknowledged “chairman of the board” and chief financier of the underworld gambling syndicate, who maintained his own longstanding ties to not only Israel and the Mossad, but also the CIA and the American intelligence community;

- David Rockefeller, head of the Rockefeller financial empire, who provided his family’s clout and CIA and global banking connections to assist in the operation;

- The Investors Overseas Service (IOS), then the world’s largest flight-capital conglomerate, controlling assets worth \$2.5 billion. The nominal chief of IOS was colorful Bernard Cornfeld. However, Cornfeld himself was no more than the front man for two behind-the-scenes principals:

- 1) Tibor Rosenbaum, who was not only the Mossad’s Swiss-based chief financier behind covert arms deals, but also the head of the Banque De Credit

Internationale of Geneva, the Lansky syndicate’s chief European money laundry; and

- 2) Baron Edmond de Rothschild of the European banking family and a personal business partner of Rosenbaum in Rosenbaum’s Mossad-related ventures ranging far and wide.

Another investor was William Mellon Hitchcock, one of the heirs to the Mellon family fortune (one of America’s largest private family fortunes which, for many years, has also maintained close ties with the CIA).

This was the group that capitalized Resorts International, which, through a wide-ranging public relations program, aided and abetted by the American media, promoted the myth that the “new” company was “cleaning up” gambling. To promote the fable, the new venture hired on (at inflated salaries) a raft of former FBI and CIA operatives and Justice Department lawyers who assured the world that the gambling ventures run by Resorts International were “syndicate free” and “family friendly”, the facts notwithstanding.

Resorts International expanded by leaps and bounds and soon became one of the most profitable of all the gambling enterprises, and by 1970 the underworld figures who were running the casinos (in league with their behind-the-scenes partners) began moving to expand casino gambling in the United States.

Mob chief Meyer Lansky called a high-level meeting of gambling syndicate figures in Acapulco, New Mexico and there the assembled mobsters pinpointed the fading resort of Atlantic City as their first new target. (Prior to that time, of course, the mob had already established Nevada as the only outpost of legalized casino gambling on U.S. soil.)

In the wake of this meeting, the resources of Resorts International were used (publicly and privately) to begin the lobbying campaign that resulted in the legalizing of gambling in Atlantic City and once the New Jersey legislature opened up the Garden State, Resorts moved in.

In 1987 upon the death of longtime CIA front man James Crosby, the nominal head of Resorts International, up-and-coming young New York real estate tycoon Donald Trump stepped into the picture and bought Crosby’s interest in the gambling empire.

Trump soon became a household name, with his colorful personality and his insistence upon naming a variety of luxury hotels, apartment houses and other commercial ventures after himself. But while the name “Trump” appeared in the headlines, the names of the real movers behind Resorts International remained hidden from public view. There is no doubt, considering the origins of Resorts International, that Trump could not have assumed the management in this enterprise if he had not had the covert support of those who brought it into being.

Trump himself ultimately shed his role in Resorts International during the period of his much-publicized “bankruptcy” but he remains a major player on the financial scene and in the gambling industry.

Thus, although Trump—a major character on the American scene—is evidently not of Jewish descent, he definitely owes much to the patronage of the Zionist elite. And this does say a great deal about the ways of power in America—the New Jerusalem. Let us proceed forward and examine those who definitely constitute America’s new elite.

COLD, HARD FACTS & FIGURES: ZIONIST POWER IN AMERICA TODAY— ACCORDING TO JEWISH SOURCES AN INTRODUCTORY NOTE . . .

In the pages which follow will be found a wide-ranging variety of quotations taken verbatim from an

The quotations are all clearly cited with footnotes [*in this section we have integrated footnotes into the text in square brackets using italics at the end of each citation for clarity*] and are direct and unabbreviated, unless clearly noted by ellipses. The [*section captions*] appearing before each quotation are summary words selected by this author/editor for descriptive purposes and for subdividing the diverse areas of Jewish and Zionist power and influence that are being discussed. Please note that these [*captions*] are not part of the actual quotation itself and should not be cited as such by researchers and writers who use this volume as a reference work.

We believe that this assembly of quotations is the most hard-hitting and informative conglomeration of such material—taken from recently published works—that has ever been assembled in the modern era and, beyond any question, the most concise and complete overview of the wealth and power of Those Who Reign Supreme in The New Jerusalem.

There is to be found a great deal of material on this subject matter if one looks in the right places, but in the pages of this work you will find it all tightly bound together in one place, a handy reference for those who dare to delve into one of the most controversial subjects of our time: Zionist power in America.

JEWISH FINANCIERS PROFITED UNDER REAGAN

The first area in which Jews become important in the Republican regime of the 1980s was economic policy. Although Jews play a major role in the liberal political camp, during the 1980s a small group of Jewish bankers and financiers become important allies of the Reagan administration and key agents in its economic and fiscal programs. Jews presided over the great expansion of liquidity—money and credit—that fueled the economic boom and expansion of equity values of the Reagan era. The Reagan administration had come into office praising the virtues of free market competition and unfettered capitalism and promising to restore national prosperity by lowering taxes, reducing government interference in the economy, and curbing burdensome government regulation of business. Jewish financiers played a critical role in helping the administration to fulfill its pledges. In turn, the administration, for a time, protected these financiers from attack by their corporate and political foes. [*Benjamin Ginsberg, The Fatal Embrace: Jews and the State, p. 189*]

‘A MARRIAGE OF CONVENIENCE’

In implementing its policies, the [Reagan] administration found itself in a *de facto* alliance with a small, but powerful, group of Jewish bankers and financiers. This group of individuals created or perfected the new financial instruments that, taken together, served the administration’s interests by expanding the supply of credit during the 1980s that, in turn, fueled the great bull market of that era.

For example, Jewish financiers and traders perfected the stock index futures that greatly increased liquidity in the financial system by allowing for highly leveraged securities transactions. ... Such

Jewish financiers as Saul Steinberg, Victor Posner, Carl Icahn, Nelson Pelz, the Belzberg family, Sir James Goldsmith, and others were among the leaders in hostile takeover efforts.

Of the major actors in the area of corporate takeovers, only two—T. Boone Pickens and Cincinnati-based Carl Lindner—were not Jews. Jewish arbitrageurs—Ivan Boesky came to be the most famous—became major factors in the acquisition of huge blocks of stock, easing the way for takeover attempts.

Jews pioneered program trading that, among other things, permitted corporations to generate excess revenues in their pension funds that could then be employed for other corporate purposes.

During the 1980s, the Reagan administration and the Jewish financiers enjoyed a perfect marriage of convenience. The administration was concerned with promoting economic growth and enhancing prosperity among its upscale constituents, even if this came at the expense of blue-collar workers and corporate managers whose firms were absorbed or simply put out of business.

For their part, the Jewish financiers saw an unprecedented opportunity to acquire wealth and power with the blessing and protection of the federal government. [*Benjamin Ginsberg, The Fatal Embrace: Jews and the State, p. 192*]

JEWISH FINANCIERS & JUNK BONDS

As outsiders, on the margins of the banking and securities industries, Jews were better able to see and make use of the new opportunities made available by the financial deregulation and permissive climate of the Reagan era. Whereas traditional investment bankers would offer advice and financial assistance to clients involved in mergers and acquisitions, the Jewish upstarts were willing to participate in such acquisitions themselves. The *parvenu* Jews saw the incredible possibilities inherent in the junk bonds that established firms disdained. The Jews honed the art of risk arbitrage, another field snubbed by WASP Wall Street. Jewish newcomers and a few of their non-Jewish allies saw the possibility of using junk bonds to finance hostile takeover attempts.

In their endeavors, the Jewish financiers enjoyed the blessing and protection of the Reagan administration. The administration courted the financiers and protected them from a hostile Congress. [*Benjamin Ginsberg, The Fatal Embrace: Jews and the State, p. 193*]

‘VIRTUALLY ALL THE TAKEOVER SPECIALISTS’

The activities of the Jewish financiers, of course, particularly their involvement in the wave of corporate takeovers that took place between 1985 and 1986 when nearly one-fourth of the corporations that had been listed in the *Fortune* 500 disappeared, provoked intense criticism from a number of quarters. ...

Many of Reagan’s opponents in the Democratic Party and the liberal media understood that it was the *de facto* alliance between the administration and the Jewish financiers that made sufficient money and credit available to fuel economic expansion despite the huge budget deficits that would otherwise have diminished the availability of capital to private concerns. ... It apparently did not go unnoticed in executive suites across the country that virtually all the takeover specialists and their financial backers were Jews. [*Benjamin Ginsberg, The Fatal Embrace: Jews and the State, pp. 194-197*]

‘BEDOUINS ON JETS’

Syrian Jews, who have clustered in Brooklyn, New York, have also emerged as major force in the sportswear industry, particularly blue jeans lines such as Jordache and Gitano. In many ways, these newcomers constitute, if anything, a throwback to an even earlier tradition of transnational Jewish businessmen. Products of a community under constant siege, they travel the world like Bedouins on jets, with few loyalties beyond their immediate family operations. [*Joel Kotkin, Tribes, p. 51*]

CALIFORNIA, HERE THEY COME . . .

... [T]he Jewish community in both Greater Los Angeles and California, which more than doubled during the 1970s and 1980s, continues to grow in power and size, attracting Jews from other parts of the United States, as well as [Jews from Iran, Israel and Russia]. By 1990 the Jewish population in Los Angeles—which in 1920 had fewer Jewish residents than Buffalo, New York—had expanded by over 150,000 to some 600,000, making it the second largest center for the Diaspora [Jewish world outside Israel] after New York. [*Joel Kotkin, Tribes, p. 61*]

MEDIA: ‘A DISPROPORTIONATE INFLUENCE’

Although not in control of the media and the arts, as some anti-Semites suggest, Jews clearly possess a disproportionate influence in movies, publishing, advertising and theater. In the media, according to one survey in the 1970s, one quarter of the leading figures were Jewish, more than ten times their percentage in the general population. [*Joel Kotkin, Tribes, p. 61*]

‘THE REAL POWER IN HOLLYWOOD’

Jewish power in Hollywood no longer centers on those who own the studios but on the assorted agents, independent producers and writers who increasingly dominate the industry, including promoters such as Arnon Milchan, Michael Ovitz and David Geffen, a former [talent] agent and record producer whom *Forbes* in 1990 identified as “the richest man in Hollywood”. Traditional Jewish skills in selling, marketing, assembling the various “elements” needed for mounting a production remain critical. ... Margo Bernay, a craft union business agent whose family first started commuting to Hollywood from the old Jewish neighborhoods of East Los Angeles in the 1930s, observes:

“If you look at the real power in this town it’s the agents, the producers; it’s not with the studios. In the old days the studios owned the talent; now the talent owns the studios. So that’s where the Jews are, where the creativity is, the talent, the glamour, the power. It’s the *sechel* [reason] side of the business, the mentality. It’s the part of the business that doesn’t have boundaries that you get in big corporations—it gives you the space Jews have been brought up to push for.” [*Joel Kotkin, Tribes, pp. 61-62*]

THE NEW JEWISH IMMIGRATION INVASION

... Despite repeated predictions of its demographic demise, the American Jewish community has continued to expand; between 1970 and 1990—in the face of rising rates of intermarriage and a low birthrate—the number of self-defined Jews in America grew by 300,000. This small population growth has come about in part due to large-scale

immigration from Diaspora communities in Iran and South Africa. Most important, however, has been emigration from the Soviet Union, totaling over 250,000; as of 1991, an additional 100,000 with visas await their turn to leave.

Reasons behind this preference for the hated *galut*, or exile, vary. For some, presence of relatives in the United States, with by far the largest community of Russian Jews' descendants, made all the difference.

Another factor is frankly economic; America, where Jews are the wealthiest of all major ethnic groups, generally offers a far better field of opportunity for the largely well-educated Soviet Jews than does tiny Israel. Certainly those who have come, despite the usual problems of adjustment, have done reasonably well. Within a few years, according to one recent nationwide survey, the average Soviet Jewish family [in America] earns more annually than the average American one. [Joel Kotkin, *Tribes*, p. 63]

ISRAELIS FIND NEW 'LAND OF MILK AND HONEY'

Given their success in America, few American Jews have migrated outside the confines of the United States. Yet, the Jewish Bedouin tradition lives on in other members of the tribe, most notably and ironically the Israelis. Rather than becoming the "sons of the land" celebrated by the earlier Zionists, as many as 800,000 Israelis—products of a small, relatively poor and war torn country—have sought better opportunities elsewhere. In some years, particularly before the mass migration from Russia, the number of outbound Israelis has actually exceeded the number of immigrants.

Although present in countries as distinct as Finland and Singapore, their favored place to settle has been the United States, with as many as a half-million concentrated in major colonies in New York and Los Angeles. In comparison, total American Jewish immigration to Israel during the four decades after 1948 has numbered no higher than 60,000, less than half the number of Israelis who legally applied for full American immigrant status between 1970 and 1987. [Joel Kotkin, *Tribes*, pp. 63-64]

SILICON VALLEY: THE NEW PROMISED LAND

... The "wandering Israelis" of today, for example, have achieved positions within the more elite ranks of technical and other professional workers. Engineers alone account for nearly 20 percent of the total, with an estimated 13,000 laboring as scientists, engineers and other professionals in California's high-technology industries alone, a population roughly one-third the size of Israel's native-born technical work force. [Joel Kotkin, *Tribes*, p. 64-65]

JEWISH FINANCE: 'AN INTERNATIONAL FLAVOR'

While there is no real evidence of an international conspiracy of Jewish bankers, some Jews in banking have conspired. The money game holds a fascination for Jews that some might say is equivalent to sex to the French, food to the Chinese, and power to the politicians. And since the Diaspora scattered Jewish communities, their financial concerns have always had an international flavor. But some Jews have overstepped the bounds of morality and law in the realm of international banking. [Gerald Krefetz, *Jews and Money: The Myths and the Reality*, p. 101]

ART: 'A STRONG JEWISH FLAVOR'

... Jewish art? Not long ago, the phrase would have been a contradiction in terms. In 99.9 percent of the Jewish experience there was no high art. Folk art yes, decorative and ornamental, but serious work in the Western sense, no. Today the picture is completely changed, and Jews enjoy every phase of the art world: as artists, dealers, collectors, critics, curators, consultants and patrons. In fact, the contemporary art scene has a strong Jewish flavor. In some circles, the wheelers and dealers are referred to as the Jewish Mafia since they command power, prestige, and most of all, money. And, as with the family *capo*, influence is dispensed adroitly: artists who lived through years of neglect are turned into overnight successes; successes are guillotined so swiftly that they may not know they've been decapitated. [Gerald Krefetz, *Jews and Money: The Myths and the Reality*, p. 140]

'MY SON, THE . . .'

... In the United States there are approximately 30,000 Jewish physicians, nearly fourteen percent of all physicians in private practice. [Gerald Krefetz, *Jews and Money: The Myths and the Reality*, p. 167]

Of the five hundred thousand attorneys, it is estimated that over twenty percent of them are Jews, nearly ten times the representation that might be expected. In 1939 it was estimated that over half the attorneys practicing in New York City were Jews. By now the proportion is even greater: perhaps three out of five lawyers are Jews.

The last survey of the New York City bar found sixty percent of the city's 25,000 attorneys to be Jewish, eighteen percent Catholic and eighteen percent Protestant. Most of the Jewish lawyers—roughly seventy percent of them—are from Eastern European heritages. [Gerald Krefetz, *Jews and Money: The Myths and the Reality*, p. 185]

... Today 15 percent of the 740,000 lawyers in the United States are Jewish.

Jewish representation is seven times greater than in the general population. In elite legal circles, the concentration is even more striking. Forty percent of partners in the leading law firms in New York and Washington are Jewish. Jews hold two of the nine seats (22 percent) on the Supreme Court. [Steven Silbiger, *The Jewish Phenomenon*, p. 62]

The American Medical Association estimates that there are now 684,000 doctors in the United States. Jewish physicians total about 100,000, or 15 percent. Like lawyers, this number is seven times higher than the Jews' share of the general population. Nine percent of 1988 medical school applications came from Jews. [Steven Silbiger, *The Jewish Phenomenon*, p. 65]

At least 20 percent of the faculty at America's leading universities are Jews, with over 25 percent in the prestige medical schools, 38 percent for similar law schools, rising even higher at Harvard, where half the law faculty is Jewish. Today Jews are 20 percent of the nation's doctors and lawyers. [Lenni Brenner, *Jews in America Today*, p. 62]

CITY DWELLERS . . .

Before World War II, the majority of Jews lived in Europe, twice as many as the number that lived in the United States. After the Holocaust, twice as many Jews lived in the United States as in Europe. Of the 14.4 million Jews in the world ... America accounts for 5,900,000 or forty-one percent of world

Jewry. Jews in the United States make up 2.7% of the population. ... Nearly 60% of the Jews in the nation live in the northeast, though the area's relative share appears to have declined recently. The north-central region contains 11.9% of the Jewish population, the south, 15.8% and the west, 14.3%. In terms of national averages, Jews are over-represented in the northeast, under-represented in the north-central region and the south, and almost par for the population in the west.

To put it another way, Judaism is an urban, or increasingly suburban, religion. Over 77% of the Jewish population live within the fourteen largest cities or county agglomerations. Almost all the rest of American Jews live in cities or towns. There are relatively few rural Jews. [Gerald Krefetz, *Jews and Money: The Myths and the Reality*, p. 241-242]

'THE BEST EDUCATED'

In the postwar era, America's Jews became the best educated of any major American ethnic or religious group. By the mid-1970s, according to Father Andrew M. Greeley's study *Ethnicity, Denomination, and Inequality* (1976), Jews averaged fourteen years of education. This was a half-year more than Episcopalians, the American religious group with the highest social standing. While less than one-half of Americans went on to college, more than 80 percent of Jews did so, and, as indicated by the statistics from Harvard, Princeton and Yale, Jews were more likely to attend elite institutions. In 1971, for example, Jews made up 17 percent of the students at private universities. [Edward S. Shapiro, *A Time For Healing: American Jewry Since World War II*, p. 100]

JEWISH PROFESSORS 'FAR SURPASSED' GENTILES

In 1940, only 2 percent of America's professors were Jews. By the 1970s they were 10 percent. The postwar Jewish presence in academia was notable not only for its high proportion but also for its distinctive profile. Jewish academicians congregated in the most intellectually demanding fields—fields that emphasized abstract and theoretical reasoning—and at the most prestigious institutions.

They were over-represented in anthropology, economics, history, mathematics, physics and sociology, and under-represented in agriculture, education, home economics, journalism, library science, nursing, and physical education.

Electrical engineering, the most theoretical branch of engineering, had a greater proportion of Jews than mechanical, civil or chemical engineering. Medicine was a high-status profession, and Jews were disproportionately represented in biochemistry, bacteriology, physiology, psychology, and other academic fields allied to medicine.

By every possible criteria, Everett Carl Ladd, Jr. and Seymour Martin Lipset wrote in 1975, Jewish academicians had "far surpassed their Gentile colleagues". At this time, Jews were one-fifth of the faculty at elite universities and one-quarter of the faculty of the Ivy League. They constituted an even higher proportion of Ivy League professors under the age of thirty-five and of faculty at the elite medical and law schools. Others may be addressed to Global Alliance Investment Association, 3132 West Post Road, Las Vegas, Nevada, 89118 USA.

The purpose of this Public Notice is to clarify an issue that has been used for more than three years to delay the litigation of the Motion for Annulment of Judgment filed April 9, 2002 by the government's Solicitor General and numbered CA G.R. SP. NO. 70014 in the Court of Appeals. It is in the interest of GAIA to bring this matter to the attention of the public since it impedes the use of the 400,000 metric tons of gold leased by the government, which lease has now expired, making the gold available for the GAIA Program worldwide. The value of the gold at current prices is approximately five trillion dollars, an amount that could greatly alleviate poverty in Southeast Asia.

One of the ploys used by the government was to declare the person appearing in court an "imposter" and not the "real" Julian Morden Tallano, the Court Appointed Administrator of the Tallano-Acop estate. It has required more than one year for the National Bureau of Investigation to decide: "Agent-on-case concluded that based on the above-findings, Subject JULIAN MORDEN TALLANO, the intervenor in the case of Republic of the Philippines vs. Regional Trial Court, Pasay City, Branch 111, et al., and Prince JULIAN MORDEN TALLANO, the alleged Real Party-in-interest in the above case, are one and the same person."

In his Clarificatory Order of January 19, 1976, Judge Enrique A. Agana clarified that a false or fictitious person allegedly represented by attorneys but not appearing in person was attempting to usurp the position and property of Acop by using the name Acopiado and bribing someone in the Court to change the name on his Decision dated November 4, 1975. The above report of the NBI contains the following comment: "As to the identity of

ANACLETO MADRIGAL ACOPIADO, the only available evidence to establish his alleged existence is the altered Death Certificate issued by the Local Civil Registrar of Taguig, Metro Manila on 28 November 1994."

Subsequent to filing its Motion for Annulment of Judgment April 9, 2002 the Solicitor General obtained a Temporary Restraining Order (TRO) to stop the Estate from doing any further business. The TRO expired on June 6, 2002 and GAIA entered into a Letter of Intent (LOI) with Tallano June 7, 2002. To preserve the ability to conduct business for the Estate/Foundation in a different venue, GAIA formed the FOUNDATION FOR THE TALLANO ESTATE, INC. in Nevada June 17, 2002 and subsequently formed the DON ESTEBAN BENITEZ TALLANO & DON GREGORIO MADRIGAL ACOP FOUNDATION, INC. in Nevada July 29, 2003. With the participation of the Court Appointed Administrator, Prince Julian Morden Tallano and Founding Trustee, Cenon C. Marcos, the DON ESTEBAN BENITEZ TALLANO & DON GREGORIO MADRIGAL ACOP FOUNDATION, INC. was also formed in the Philippines October 14, 2003 to administer that 50% portion of the assets of the Royal Family for the benefit of the Filipino PEOPLE.

Although the Foundation was ordered to be set up by Judge Agana in 1976, the Order was not obeyed by the Administrator until the necessary funds were furnished by GAIA. Since ALL of the funds to support the Foundation were furnished by GAIA, even to hiring and paying the necessary consultants and attorneys, GAIA has insisted upon the exclusive control of the statutory 40% of the assets and has met with no objection. The Court Appointed Administrator has frequently offered and paid "commissions" as much as 70% of the funds received for sale of properties, which establishes a precedent far above the requirement of GAIA.

In the Letter of Intent of June 7, 2002 GAIA committed to assist in the recovery of fines, penalties and Royalties due the Royal Family, real properties, and the gold leased to the government in 1949. On June 25, 2002 the Court of Appeals issued a Writ of Preliminary Injunction, ostensibly to "maintain the status quo" and "enjoining respondents from enforcing the Orders dated July 7, 1997, July 11, 2001, and October 8, 2001 in Civil Case No. 3957-P and from conducting further proceedings in said case." Since those listed cases were land-related and contained no reference to the Royalties, fines, penalties, or gold, it is presumed that there are no impediments to terminating the lease and proceeding with the inventory of the assets of the Estate/Foundation as required by law.

Sworn testimony was recorded in the court of Judge Agana in 1972 of the fact that Fr. Diaz (aka Colonel Santa Romana) and Tallanos had just conducted an inventory of the 617,500 tons of gold leased to the Central Bank and had found only 400,000 metric tons to be there. Other documents have been located that confirm that President Quirino leased the gold for the government in 1949 as the reserve for the Philippine money supply. These are documented facts, not fictitious stories concocted by creative con-men.

In an unconfirmed (yet) related story, the two presidents, Ferdinand Marcos and Ronald Reagan, created a plan to leave as their legacy to the world a gold-based money they named Ang Bagong Lipunan (ABL) and President Marcos shipped thousands of tons of gold to other nations to serve as their reserves or gold base. When the shipments were completed and a signal given, all of those nations would shift to the new currency which they could then use in international trade as well as domestically.

In the case of the backing of the ABL, it is clear that the gold came from that being leased by the Republic of the Philippines from the Estate/Foundation, the ownership of which has now reverted to the Estate/Foundation at the expiration of the lease. Although not sufficiently yet documented, there is evidence that 217,500 metric tons was transported to the U.S., which gold would be subject to the claim of GAIA pursuant to the debt of the US Treasury to GAIA that is expressly payable in gold. Regardless of where it may be located, it is likely that much of the gold in the world is or could be subject to a legal and legitimate lien by the Joint Venture Partnership created by GAIA and the Foundation.

In the case of "natural" or "treasure" gold located in the Philippines or its territorial waters, the Land Title OCT No. T-01-4 gives ownership of most of the land and sea area of the archipelago to the Royal Family since 1764. As a percentage of the total land area, the so-called "public" lands are very small, being restricted to those lands occupied by government buildings and facilities and only during occupation by those facilities, reverting to Estate/Foundation stewardship for "The Royal Family" when no longer so occupied. Thus, mining and treasure hunting will come under the management of the Estate/Foundation at the proper time.

"The Royal Family" (of the Philippines) consists of all of those persons that might trace their ancestry to King Luisong Taguean (who died in 1764) and/or to his ancestors, which should include virtually all Filipinos. It is important that Filipinos understand that the Estate/Foundation does not claim

"ownership" of these assets (the land, gold, minerals and other natural resources); it acts as the Trustee or STEWARD of these assets for the benefit of the Royal Family, i.e., all Filipinos, and deserves their support and participation in the development of the nation. As such, it can, and should, act to accomplish objectives privately that are normally expected of governments.



World News Insights

U.S. news provides scant if any coverage of events unfolding in the Philippines. The following piece by Alejandro Lichauco provides some insights into the volatile situation. There is little doubt that Erap Estrada would be every bit as much under the control of the U.S. as is Gloria Arroyo.

HOW DOES GMA HANDLE A U.S. THAT WANTS HER OUT?

Washington wants GMA out. That's the unmistakable message of the recently released U.S. Embassy report purporting to be an assessment of the Philippine political situation and pointing to fallen President Joseph Estrada as the "most acceptable alternative" to GMA.

The report is message to one and all—both the political opposition and the Armed Forces of the Philippines—that the Bush administration can't stand the situation a minute longer, that GMA must go and that there isn't any point searching for an alternative to her because Estrada is the alternative, period.

The elite—meaning, the church, the Makati Business Club and the foreign-funded non-government organizations who pass for "civil society"—might find Estrada totally unacceptable but at this point they constitute only the minority and a comparatively miniscule one at that. What matters is what the restive *masa* feel and there's no question about how they feel. They feel overwhelmingly in favor of Erap, particularly after the death of Erap's dear friend FPJ and Washington can't ignore that.

If it's a choice between placating the restless *masa* and placating the miniscule, well-fed and even over-fed elite, Washington's long range strategic interest can only tilt in favor of the former.

And Washington made sure that the restive, hungry *masa* were informed of that fact.

That, in effect, was what the U.S. Embassy report, was about. It was about Washington telling the restive, hungry *masa* that good old Uncle Sam is finally cutting ties with this country's pro-U.S. Filipino elite and this time Washington will identify with the interest of the masses, pretty much as it did when it mounted Magsaysay to the presidency in the 1950s.

Washington is now making a bid for the support of the Filipino masses which over the years have come to attribute the cause of their plight to a callous elite that have functioned essentially as the conduit for implementing the anti-poor policies of the International Monetary Fund and the World Bank (WB), and lately of the World Trade Organizatin (WTO), all agents of the U.S. [And what would be any different with Estrada in the presidential seat?]

For Washington must be clearly aware that even the illiterate masses now instinctively sense that their plight is a necessary consequence of the anti-poor policies of the IMF-WB-WTO and that these international organizations have been able to work out their policies in this country only through the collaboration of a pro-American elite—the very elite that brought Estrada down and who now wish to replace him with Noli de Castro.

But no way and Washington made sure of that. That's the reason for the earlier assessment report that under Noli, the Philippines will even be worse off than it is today.

Why then is there this sudden U.S. concern to be identified with the Filipino masses?

The answer that easily springs to mind has to do

with the continuing insurgency and the emergence of China as a factor that is bound sooner or late to play a crucial role in Philippine affairs.

The U.S. in plain language, can't afford to see the Filipino masses driven straight to the embrace of China and one way that embrace can be avoided is for Washington to identify with the longing of the masses. At the moment, the most pronounced longing is to see GMA replaced, and replaced by one whose heart the masses believe belong to them. And that is Erap.

Washington knows that the longer GMA stays, the more difficult and oppressive will life be for the masses and that in turn can translate and will in fact translate, easily into plain anti-Americanism.

GMA, in spite of the so-called China card she has been displaying and playing is widely perceived by the masses as America's doll, the pullout from Iraq and contracts signed with China notwithstanding. And the impression has been immeasurably reinforced by that stupid contract which GMA's National Security Adviser, Norberto Gonzales, signed with the venerable Venable law-lobby firm.

See? She really is America's doll. She is giving the whole country away, including its Constitution to Uncle Sam. And that explains why we are dirt poor—so the *masa* logic runs.

That's why she has to go, and under circumstances which will make it clear to everyone, rich and poor alike, that she will go because Washington will make sure that she goes.

How then does GMA handle that? How does she handle a U.S. determined to see her politically decapitated long before the expiry of her term?

The Venezuelan Embassy in Washington D.C. issued a press release late this morning to inform that Venezuela President Hugo Chavez' pledge to ship approximately an additional one million barrels of gasoline to the United States in the wake of Hurricane Katrina's devastation will begin to come to fruition on September 25 with the arrival at Port Everglades (Florida) of the bulk tanker 'B/t Energy Pride' with a first shipment of 240,000 barrels.

The gasoline, produced by Petroleos de Venezuela (PDVSA) will be available immediately to U.S. consumers through PDVSA's wholly-owned U.S. subsidiary, CITGO Petroleum Corp's distribution network ... and is supplementary to PDVSA's normal shipments.

"As a Hemispheric neighbor and business partner, we are pleased that we are able to provide immediate relief by increasing gasoline supplies available in the United States in the aftermath of this devastating natural disaster," said Venezuela's Ambassador to the United States, Bernardo Alvarez Herrera. "We're sending additional barrels of gasoline that otherwise would have gone elsewhere, and we will continue to do whatever we can to help alleviate energy shortages and the dislocations faced by the people of the United States as a result of Hurricane Katrina."

Three other shipments of 240,000 barrel each will arrive at regular intervals on the heels of this first. It is expected that the entire additional volume of close to one million barrels will be delivered to the U.S. distribution system no later than October 31. ...

CHAVEZ - VENEZUELA MOVES RESERVES FROM U.S. TO EUROPE

Venezuela has moved its central bank foreign reserves out of U.S. banks, liquidated its investments in U.S. Treasury securities and placed the funds in Europe, Venezuelan President Hugo Chavez said Friday.

"We've had to move the international reserves from U.S. banks because of the threats," from the U.S., Chavez said during televised remarks from a South American summit in Brazil.

"The reserves we had (invested) in U.S. Treasury bonds, we've sold them and we moved them to Europe and other countries," he said.

Chavez, a sharp critic of what he calls "imperialist" U.S.-style capitalism, has often criticized foreign banks for the power they wield in international financial markets at the expense of poorer countries.

Chavez again proposed the creation of a South American central bank that would hold the foreign exchange reserves of all the central banks in the region.

"I'm ready right now with the Venezuelan central bank ... to move \$5 billion (euro4.15 billion) (of Venezuelan reserves), to a South American bank," Chavez said.

Central bank officials could not be immediately reached for more details.

Chavez has also argued against central bank autonomy, saying excess foreign reserves should be spent on economic development projects.

Under his presidency, Venezuela's mostly pro-Chavez Congress changed central bank laws earlier this year so the government could tap reserves for spending, despite criticism that it would lead to devaluation of the local currency and higher inflation.

Every year the central bank must now compute an "optimum" amount of reserves and hand over the rest to a newly created national development fund.

Money held in the fund will be used for overseas purchases and to pay off outstanding debt.

Foreign exchange reserves held by the central bank stood at \$30.434 billion (euro25.27 billion) as of Sept. 28, according to central bank data.

President Vladimir Putin said Tuesday ... "We are developing and will deploy new strategic high-precision systems that have no rivals across the globe. These hypersonic systems will be capable of changing the course and altitude. They will be practically invulnerable, including to air defense systems," the president said speaking on live television and radio.

Commenting on the president's statement, an air defense expert, speaking on condition of anonymity, said that Putin must have meant state-of-the-art air-defense systems, or "weapons of the future" that specialists and researchers had been working on for a long time.

The expert added that the new system would combine the functions of air defense, missile defense and space defense.

The expert said the Russian army already had sea- and land-based missile complexes such as Bulava and Topol-M.

Putin also said that Russia would continue providing its army with mobile missile systems, state-of-the-art tanks, new and modernized air defense systems.

He added that last year Russia overcame an important psychological barrier when "allocations for army re-equipment topped the \$5-billion profits from arms exports," while only a few years ago, Russia did not buy anything for the army.

"A great deal has been done in the past few years to restore the defense industry's financial health," Putin said, adding this included debt settlements and jobs. ...

My son said it was a propane smell, but a neighbor said it didn't smell like propane. Maybe it was kind of gassy. It was in fact giving me a headache.' Scores of people in the District called authorities yesterday to complain that a similar odor was invading homes, businesses, a dozen schools and two police stations."

As reported by the *Thunder Bay Television* News Service in their article titled "Strange smell in Longlac" and which says, "Municipal officials are urging Longlac residents to exercise caution as they investigate reports of 'gasoline-type' odours in the town's sewer system. The problem first cropped up about ten days ago in a variety of homes and businesses ... and is reportedly most noticeable in basement areas. The Municipality of Greenstone says it still doesn't know if the smell is from sewer gases, natural gas or an industrial solvent. One of the top research scientists concerned with methane is the American Dr. Thomas Gold of Cornell University, and whose theories much of the world's science in this area is now based upon, and as we can read from this 1978 report by the Geophysical Institute, University of Alaska Fairbanks titled "Goldian Methane" and which says:

Natural gas is mostly methane, normally more than 80%. Composed of one carbon atom and four hydrogen atoms, methane is the simplest of the hydrocarbons. The hydrocarbon compounds that form the world's oil and gas reserves have long been thought to form from decomposition of vegetable material many millions of years ago, and thereby to be in limited supply.

But now a bold new idea is circulating about the source of methane. Dr. Thomas Gold of Cornell

University suggests that a vast store of methane was trapped deep within the earth when the planet was formed. Under high pressure from the weight of overlying rocks composing the solid outer part of the earth, Gold's methane, according to his suggestions, is trying to move upward and to seep out of the earth, a process called outgassing. Gold's idea has major implications about the world's available fuel reserves. If he is right, new exploration and deeper drilling methods can yield a huge supply of energy that might last a million years at the current usage rate. The idea has special interest for Alaska and the Canadian Arctic, too, since the upward migration of methane can be stopped by permafrost. Alaska's frozen North Slope and other Arctic regions with extensive permafrost may be major methane traps. ...

But as we have all too often seen in the West, the theories put forth by Dr. Gold have been met with increasing scorn in his own country, but to Russia his theories have proved invaluable, even to the point that Russia is now one of the world's largest oil producers and the predictive value of major earthquakes has reached 70%, and as we had previously reported upon:

So concerned have some of the lower levels of the United States Government become, due to the continuing series of micro-quakes occurring in the New Madrid Fault Zone Region, that they are now calling for massive preparations to take place, and as we can read as reported by the *Associated Press* News Service in their article titled "Congresswoman Emerson Calling for Quake Exercise in New Madrid Fault Zone" and which says:

"Earthquake experts agree it's a matter of time when, not if, another major quake strikes along the New Madrid Seismic Zone. But with this particular 'herd' we see evidenced in the United States today, they can be likened more to sheep than to human beings, as they no longer are able to think for themselves ...

Nevada Vs. Delaware: Private Vs. Public

Budget's "Tip of the Week" #16:

Response to the Often-Asked Question: What About Delaware?

"My friend said that her attorney said that the best place to incorporate is Delaware because that's where all the big corporations are based."

The fundamental distinction between Nevada and Delaware is that while Nevada's statutes create benefits for **private** corporations, Delaware's corporate statutes have principally been designed to benefit shareholders of **public** corporations. Many large, public companies that trade on various exchanges across the country incorporated in Delaware because Delaware's statutes provide the best protection of the rights of shareholders. In recognition of the foregoing, Delaware's corporate law with regard to corporate takeovers is the strongest anywhere in the country. And if you want to "go public" with your corporation some day, Delaware's onerous disclosure requirements probably won't bother you.

On the other hand, Nevada's provisions for establishing and maintaining privacy of ownership and control is unparalleled. In Nevada, ownership of a corporation is not a matter of public record: There is no prohibition against the use of bearer shares; there is no requirement for stock to be issued; nor is there any requirement for an annual meeting of stockholders. In terms of privacy of control, the use of contract ("nominee") officers and directors has been a common practice since 1925. In addition, *NRS 78.257* makes it a gross misdemeanor for anyone to even *attempt* to use a Nevada corporation's records for purposes contrary to the interests of the owners.

Delaware is NOT "tax-free". A Delaware corporation's taxable income is taxed at the rate of 8.7%. In addition, its franchise tax has a graduated rate depending on capitalization, amounting to a minimum of \$30 and a maximum of \$130,000.

Nevada's corporate law easily surpasses Delaware's in terms of protection of corporate officers and agents. Delaware has recently adopted a statute that allows a corporation to limit the liability of a director for monetary damages—but *officers* of Delaware corporations are still not covered. **The following acts of officers and directors would be protected under Nevada law, but are exposed to liability under Delaware statutes:**

1. Acts or omissions not in good faith;
2. Monetary damages occasioned by acts of officers (directors are now exempt);
3. Breach of a director's duty of loyalty;
4. Transactions involving undisclosed personal benefit to the officer or director;
5. Acts or omissions that occurred prior to the date that the statute which provides for indemnification of directors was passed and approved.

In summary, Delaware cannot match Nevada in providing shelter for small, private corporations.

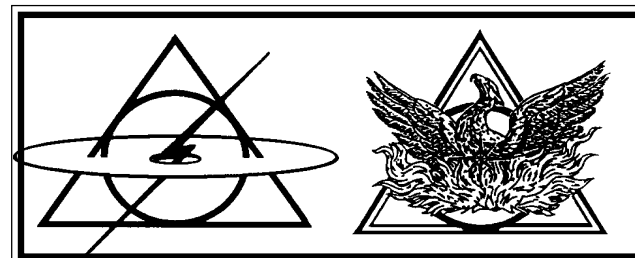
