



PREFACE

Whitley Strieber

When Art Bell and I completed this book in August of 1999, we did not expect to see the kinds of enormous changes in climate that it predicts for at least fifteen or twenty years. Nothing in the scientific data suggested otherwise. If anything, climatology was saying that really significant change was decades off.

In fact, we were roundly criticized for even suggesting that the climate might be at the brink of a catastrophe. Matt Lauer of the *TODAY* show interviewed us, taking a position that was reflected elsewhere in the media: we were irresponsible alarmists attempting to make money by exploiting people’s fears. Most national media wouldn’t even give us airtime. Not even the cable talk shows would take us.

These refusals came despite the fact that the climate had demonstrated, just a few months before our book was published, that our theories were not only valid, but that the situation was far more urgent than even we had realized.

Our concern was and is that rapid melting of ice at the poles will alter ocean currents and cause a sudden change in climate. This change will start with climatic upheavals unlike any seen before, and will lead to a planetary climate so unlike what we have at present that the long-term disruptions will be devastating.

Sadly, the media rejection of our book meant that the simple, powerful methods of reducing greenhouse gas emissions and thus, slowing this process down have not been generally embraced.

People don’t want to think about the environmental catastrophe that is staring us in the face because they feel helpless, and they are served by a media that reflects this by being indifferent, or even hostile, to discussing these issues. Worse, the matter has been politicized in the United States, with conservatives [following] the lead of George W. Bush, Rush Limbaugh, and the Rev. Jerry Falwell, who has gone so far as to state flatly that he “doesn’t believe in” global warming. While the Democrats have been more forthcoming, they also perceive public indifference to the issue, with the result that little was made of the growing environmental catastrophe in the 2000 election campaign.

What was so ironic and so sad is that people can, by following the simple procedures outlined in this book, gain very real control over greenhouse gas emissions, and do this without any cost to industry at all. But we need an international effort. Many, many people have to embrace the program for it to work. This was where the media was to have come in. But it did not.

If we do not do something, and right now, sudden climate change is inevitable, and it seems clear that is going to happen much sooner than anybody thought possible. Science is going to be blindsided. In fact, this is happening right now.

On July 11, 2000, Discover.com published the results of a study from the Norwegian scientific journal *Cicerone*. This story suggested that the northern ice cap would be gone within fifty years. It also pointed

to another important factor discussed in our book: Human-generated greenhouse gases are not the only factor causing global warming. They are merely the part of it that we can control. We need to realize that the whole process of sudden climate change is part of the earth’s fundamental ecology. As we detail in the book, science tells us that it has happened before, long before there was any “human effect” on the atmosphere. Discovery.com said, “The latest estimates for the ice sheet’s end show significantly faster melting than the greenhouse effect can account for.”

Just a few weeks later, on August 25, 2000, an astonishing story emerged from a midsummer tourist excursion to the North Pole: The pole had melted.

Where there had been ice from time immemorial, there was now open water. Some scientists were predictably dismissive. On August 25, Mark Serreze of the University of Colorado said on CNN, “We’ve seen features like this before.” He did not say when, however, and in fact, open water has never been observed at the North Pole before, never in human history. The last time the pole lacked an ice cover altogether was the Eocene Era, which ended fifty million years ago.

The key point in this book is that rapid melt of polar ice will cause crucial ocean currents to fail, leading to a sudden and devastating acceleration in climate change.

The ice at both poles is melting at a rate that [was] completely unexpected even as the book was written in 1999. Worldwide, melting glaciers are unleashing floods of water into oceans that need a certain level of salinity to maintain the stable water temperatures that currents depend on.

Virtually all the world’s glaciers, from the Himalayas to the Antarctic, are in retreat. The most serious situation is in Greenland. The Greenland ice sheet is flooding the northern ocean with fifty billion tons of water a year as the ice melts. Worse, the margins of the ice sheet are thinning at a rate of two meters a year. This means that the glaciers themselves are becoming unstable, and the threat exists that they will suddenly [slide] into the sea.

“We are seeing widespread indications that something like that is going on, causing the glaciers to move faster toward the margins,” commented William B. Krabill, author of a study of the glaciers that appeared in the journal *Science* in July 2000. The melting of Greenland would raise ocean levels 21 feet, but major effects on climate will take place long before that happens.

The situation in the Antarctic is just as dire. For the past ten years, the Antarctic ice pack has been breaking up. In March 2000, two massive icebergs broke off the Ross Ice Shelf. The larger of the two was 185 miles long by 23 miles wide, slightly smaller than the state of Connecticut. In September of 2000, Professor John Lowe of London University suggested that global warming could cause a mini-ice age in Britain within a few decades. He described the evidence as “startling”. This is not an isolated event. It is one of a series of huge ice breaks in the Antarctic that began in 1987, when a berg the size of Rhode Island broke off the Ross Ice Shelf. On February 9, 1988, the *New York Times* reported “an extraordinary two years of glacial breakup”. This led to what is now the complete destruction of the Larsen Ice Shelf, and the increasing instability of the Ross.

The melt of floating ice, such as the polar cap and the Antarctic ice shelves, will not cause sea levels to rise, and there is not much evidence that a sudden glacial surge off Greenland or the Antarctic will take place in the near future. The issue is not sea levels, it’s fresh water: Polar melt is flooding the northern and southern oceans with it.

This is exactly what is believed to have led to the last great climatic event, which we discuss in detail in this

book. We also discuss the substantial evidence that this event began with a ferocious series of storms that led to two hundred years of reduced temperatures in the northern hemisphere, and a reduction of temperatures above the Arctic Circle that is just now ending.

There appears to be a great climatic cycle that is marked by long periods of stability punctuated by sudden change. We are almost certainly at one of the points of sudden change. It will come when fresh water flooding into the polar oceans combines with rising air temperatures to increase water temperature so much that the great currents that control climate stop flowing.

When [we] wrote our book, we thought that this situation would develop over a period of years. Given the past twelve months, however, it now seems clear that it could happen at any time. Indeed, it has probably already started.

In November 27, 1999, the prestigious British newsweekly *The New Scientist* published a story entitled "Freezing Future: There's Now Alarming Evidence that Europe is Facing an Ice Age." The story went on to corroborate the warnings voiced in our book. "The ocean currents that give Europe its mild climate are changing," *The New Scientist* said. "Scientists have found evidence that global warming may cause a big freeze by switching off a current called the North Atlantic Drift."

Due to the flooding of the northern oceans by fresh water from rapidly melting polar ice, there have already been dramatic shifts in the very currents that control our weather. There is even data showing that a deep sea current in the arctic has actually gone into reverse.

When we read these stories, shortly before our book was published, we immediately informed the book's publicist, who sent out press releases.

For the most part, the media did not respond, not even to this open and obvious physical evidence that our warnings were not only appropriate, but frighteningly timely.

Not all media powers reacted the same way. Columnist Liz Smith was particularly affected by the book. "I picked up this book just as those New Year storms were savaging Europe, leaving almost 100 people dead. But those storms are only a drop in the bucket compared to what this book claims is in store for us unless we get busy and do something about it."

The storms she referred to were truly alarming natural events. Over a hundred people were killed as winds reaching as high as 125 miles an hour ravaged Europe in two successive storm waves. The second storm, on December 28, 1999, swept France with winds of unprecedented velocity, destroying hundreds of millions of trees and wreaking havoc with power lines, roadways, and homes.

Prior to this, storms from Spain to Italy reached incredible altitude, resulting in falls of eight-pound hail. Why these blocks of ice were plummeting from the skies mystified scientists. "The most surprised person of all by this phenomenon is me," said geologist Jesus Martinez Frias, who was headed a team of scientists collecting and analyzing the blocks of ice. Months later, they announced that the ice was indeed a weather-generated phenomenon.

To us, it was just a precursor of things to come. It meant that cloud tops were reaching the kind of extreme heights predicted in this book, and allowing ice masses to form at ultrahigh altitudes then grow to immense size as they plummeted to the earth. This is happening because temperatures near the surface are rising, due to heat being trapped by greenhouse gases. Temperatures above the stratosphere are dropping, due to the fact that less and less heat is radiating up from below.

The effect was reported by scientists in May 1999.

The mesosphere, about forty miles up, has been cooling by a degree a year for the past ten years. This is ten times faster than anyone had previously predicted. Gary Thomas of the laboratory for atmospheric and Space Physics at the University of Colorado says that this may be the climate change "miner's canary". In the past, miners would take a canary with them into deep mines. The bird would die from odorless gases long before the miners themselves would realize it was there. If the canary died, the miners got out.

The radical temperature difference between the upper and lower atmosphere means that the potential for extreme storms is rising, and throughout 1999 and 2000, they marched across the world. Not only were weather extremes felt in Europe, there were devastating storms in Venezuela, China, India, and Southeast Asia. When torrential rains flooded Caracas on December 20, 1999, 30,000 people were killed. The previous May, an Oklahoma tornado set a world wind record when wind speeds in the funnel cloud were recorded at 318 miles per hour. In November 1999, a monstrous super-cyclone very much like the one described in this book killed at [least] 12,000 people in India. Millions were left homeless, and desperate survivors began burning the carcasses of 200,000 drowned cattle, buffaloes, and pigs in an effort to prevent the spread of disease.

On November 23, 1999, the *New York Times* published an article that directly supported the theories in *The Coming Global Superstorm*. The article described the same climatic event that is discussed in this book, the one that brought on weather chaos toward the end of the last ice age. Dr. Gerald R. Dickens of James Cook University in Australia compared the way a warming trend like the one we are in now climaxes to a rubber band: "You gradually pull at both ends and, at some instant, the rubber band suddenly breaks."

The article, for the most part, discussed a sudden climate change event that took place 55 million years ago. But it illustrated our point very clearly. In the words of Dr. Dickens: "The earth can, for natural reasons, suddenly change dramatically."

When you add the push effect of human intervention to the natural processes that are occurring right now, there is obviously potential for explosive change.

It is now October 2000, and we have seen a devastating cascade of changes, most of which have been totally unexpected. The weather has become ultra-violent, highly unpredictable, and extremely dangerous.

On January 31, 2000, *U.S. News & World Report* published an article about weather change, essentially blaming the present situation on short-lived oceanic phenomena like El Nino and La Nina, alternating warm and cold water cycles that occur in the Pacific Ocean and profoundly affect climate in the Americas. The article concluded, "It's too soon to panic."

Too soon? We don't think so. As this preface is being written, world weather patterns are sliding deeper into chaos. Over five million acres of arid land have already burned in the American west, and predictions are that six million acres will have burned by the end of the year. On August 27, 2000, the Montana fires combined into a single giant 247,000-acre conflagration and became the largest single fire ever recorded in the United States. Then the winds began to rise.

At the same time that fires raged in the west, the Midwest and northeast were experiencing one of their wettest summers on record. This pattern of extremes was a continuation of a situation that began to evolve

in January, when temperatures plummeted to -15 degrees in New York, while they soared to 81 degrees in south Texas.

Regional extremes like these continued world wide, and the summer of 2000 promised, like the summers of 1997 through 1999, to be one of the hottest on record. In early July, a thermal invasion of extremely hot air from the Sahara Desert invaded southeastern Europe and Turkey. Temperatures exploded to unprecedented heights, shattering records across the region. Turkey and Greece saw temperatures as high as 113 degrees, and it went to 111 degrees in the Balkans. Roads became impassable because of melting tar, and fires broke out across the region.

In India in September of 2000, fifteen million people were made homeless by monsoon flooding.

A more disturbing event took place in northern England on August 21. Freak storms, not predicted by British meteorologists, surprised Hull and York with torrential rain, hail, a serious tornado, and five inches of snow. Similar weather struck in North Wales two hundred miles away, where hail blocked roads as temperatures plummeted.

This is exactly the sort of bizarre weather that would take place in this part of the world if the normal flow of warm water from the south was slowing down, but had not yet ended altogether.

Our book predicts these effects, but it goes farther than that: it predicts what is in store for us over the next few years, and it would appear that climate change during this period could be far more dramatic than expected.

The book was not only shunned by the media in the United States, it received review attention that was almost entirely hostile. This was in dramatic contrast to the British press, which generally supported the book.

However, no major reviews anywhere in the world discussed our speculations that there was almost certainly a much more developed society on earth far earlier than conventional scientific wisdom.

Throughout the year 2000, there have been a series of discoveries pushing the dates for crucial human developments back farther and farther, much more in line with our theories.

We suggested that this earlier society was consumed by a previous dramatic weather upheaval. We made our case that this society must have existed by briefly surveying a number of ancient structures whose origins and structural engineering have not been satisfactorily explained. Among these structures was one off the small Japanese island of Yonaguni (Okinawa) in the Pacific. This enormous structure subsided into the ocean about nine thousand years ago, approximately during the time that the last upheaval was taking place.

Despite compelling evidence that it is man-made, science has dismissed it as of geologic origin, largely because of its dates. There could have been no civilization in Japan nine thousand years ago that would have been capable of building such a large structure.

In November 1999, however, unmistakable carvings of human origin were found on the sea floor near the monument. It has now been theorized that the object must have come up out of the sea about five thousand years ago, then subsided again after the carvings were made.

[H: I cannot resist this insertion: Do you have any concept at all of how silly you as a species actually ARE?]

This seems unlikely to be the last word on this particular structure. Nevertheless, our speculations about the past were just controversial enough to justify our entire [thesis] being ignored. This means that readers did not get informed either of the crisis nature

of the present situation or of the means we have of exerting what could be a crucial degree of human control over it.

Whether the civilization we believe may have been there existed or not, conventional science certainly offers ample and all but irrefutable evidence that the climatic upheaval that took place then was caused by a “snap back” of the climate from a global warming spike exactly like the one that is taking place now.

There is substantial evidence, also, that the upheaval overtook this planet during a single, awful season of incredible weather chaos. If such an event were to happen today, it would result in the deaths, ultimately, of many billions of people.

[H: Yes indeed, and this without any consideration of “Bird Flu”.]

Not only would the initial catastrophe cause many to die, the agricultural disaster that followed would lead to a much greater loss of life.

On July 11, 2000 in the *New York Times*, Bob Herbert’s “In America” column quoted Dr. Michael Oppenheimer, chief scientist of Environmental Defense, a national environmental research organization. Dr. Oppenheimer said, “The last time it was as warm as it probably will be by the end of this century, globally speaking, was several million years ago. There is no way we can know for sure if that’s a world we can safely cope with.”

Given the fact that Dr. Oppenheimer did not know, at that time, that the North Pole would melt in a few weeks, it is safe to say that he may not have been talking about the end of this century at all. His remarks might be even more accurate if he had said, “at the end of the next few months or years”.

The Coming Global Superstorm is not a book of speculation about some vague possible future. It is a call to action about events that are almost certainly staring us right in the face. It seems now, as of August 2000, that the kind of climate change we describe is much, much closer to happening than we ever dreamed when we were writing the book...and that was just one year ago.

Dear Senator Grassley:

This is in reply to your August 26 letter on behalf of Ms. xxxx x. Durham, who has once again contacted you about the death of her husband, Russell Herman aka Russell Herrman.

Our records show that over the past ten years, the FBI has received numerous contacts from Ms. Durham, as well as inquiries on behalf from elected

representatives, regarding her allegations that her husband was murdered. In response, we have advised her that in order for the FBI to initiate an investigation of any complaint we receive, specific facts must be present to indicate that a violation of federal law within our investigative jurisdiction has occurred. Our reviews of the information she has provided over the years, including her present communication to you, have identified no specific, factual information to indicate that a violation of federal law within the investigative jurisdiction of the FBI has occurred or upon which to base an FBI investigation. It should be noted that in 1995, an inquiry by our Springfield, Illinois, Office determined that Ms. Durham's husband, had in fact, died of cancer. We are, therefore, unable to be of assistance to Ms. Durham.

I hope this information will be helpful to you in responding to Ms. Durham

He has recently been predicting and publicizing, via the Internet, the Grand Jury indictments of George W. Bush, Dick Cheney, Karl Rove and Scooter Libby (to name only a few). Last week federal prosecutor Patrick Fitzgerald announced the indictment of Libby with no mention of the others. Will there be more indictments? Or has Mr. Flocco been grandstanding?

In his 10-page post of September 4, 2005 titled "Why Bush Sr. chose 9-11-01 as hit date: no payback on bond billions for terrorism fund" Flocco has certainly been grandstanding, using the mis- disinformation provided to him by VK. [The post may be found at: <portland.indymedia.org/en/2005/09/324172.shtml>.] Just his title shows his ignorance, and his lack of due diligence. The so-called "Brady Bonds" are U.S. Treasury bonds and will be paid (or extended at the option of the holder) by the U.S. Treasury at their maturity date—no ifs, ands, or buts—without regard as to where their "records" are. VK trumpets that, with the destruction of the brokerage firm Cantor-Fitzgerald in the north tower of the World Trade Center, the bonds have vanished, along with their \$240 billion obligation of the U.S. government, which has somehow all inured to the Bush family. Mr. Flocco has discredited himself in just his first paragraph so there is no need for us to spend more time and space on VK's musings as posted under his byline.

We will note for the "statute of limitations" record that VK has again proclaimed her holding of records and property belonging to Cosmos Seafood Energy Marketing, Ltd.

Who was Russell Herman? He told us he was a retired officer of the CIA. He and Cecelia Xalis set up CSEML into which they transferred the ownership of the Peruvian Bearer Bond (Gold Certificate for \$1,000) 3392-181. Those are matters of public record, as is the acknowledgement of the reconfirmation and re-issuance of the debt to CSEML by the Peruvian Consulate in Los Angeles. On a personal level, Russell Herman presented to us as very alert, intelligent, serious and careful of what he said. He did

not "brag" and he did not seem to "exaggerate"; his credibility increased with interchange. He had a job to do and things to "attend" and very intelligently and with professional business persona told us what to do and what would probably happen and how to be prepared.

While VK continues to "improve" on her old stories, and invent new ones, she has been modestly consistent in blaming Bush & Co. for Russell Herman's death. Additionally, she finally realized that Bush had known for a long time that 3392 was the property of CSEML since he had tried to get Frankie Sue del Pappa, then Secretary of State in Nevada, to transfer the corporation to him—a fact reported to us by both Russell Herman and Cecelia Xalis. Bush was smart enough to know that Russell couldn't just "sign off" a corporate asset so blaming Russell's death on Bush comes up hollow. As we look at the history and the situation, it appears that the only intended beneficiary of Russell's death was VK Durham, which seems to be confirmed by her desperate attempts to forge documents proving herself married to him, or creating fictitious documents purporting to transfer ownership of 3392 from CSEML to herself, or (lately) purporting to have transferred a portion of 3392 to CSEML and then taking it back in 1992.

We do have to thank her, however, for keeping the statute of limitations alive, and for never (publicly yet) disparaging Russell Herman. Many adventurous men (and women such as Valerie Plame) get caught up in the adventure and challenges of clandestine work only to awake later on in life and realize that what they have been doing was wrong. Doris and I are genuinely sorry that Russell had to die before he could make the reparations that he had so carefully planned and we will keep working to make his dreams, and yours and ours, come true. Now it is that many are gone on before us across the greater divide and we could start a catering service with that which remains buried but untouched. Christmas party? I can't even remember just what that was actually like. I suppose the bottom-line here is that life is not just for parties and lying to oneself that all things are good just because God is in HIS Heaven and we simply have to chant our mantras.

I recognize that as people want to know endings—there are none. There are a few conclusions along the way as a curtain falls on one act but rises on yet another in this play and for that we are grateful. Even with SARS and BIRD FLU

'SECRETIVE' CLUB OF JEWISH BILLIONAIRES

In May 1998, the *Wall Street Journal* reported on "a secretive and loosely organized club of twenty of the wealthiest and most influential Jewish businessmen in America", called the "Mega Group" or "Study Group". Leslie Wexner, the chairman of The Limited, and Charles Bronfman, the co-chairman of Seagram Co., founded the group in 1991. Meeting twice a year for two days, members attend a series of seminars related to philanthropy and Jews. Faced with the aging of the immigrant generation, the blurring memory of the Holocaust, and the high rate of intermarriage, the group tries to keep both the philanthropic momentum and the Jewish identity going. This community of the very wealthy enables its members to seek partnerships for their individual causes and learn from one another about their successes and challenges. Networking sessions exist in other faiths, but there are few from the highest ranks of businesses such as this one. Mega Group members keep a low profile because they do not want to be in competition with established Jewish institutions. They take on special projects that they think can make a difference, such as supporting Jewish day schools or programs like the "Birthright Project", which sends to Israel any young Jew born on this planet who wants to go. [Members] include Steven Spielberg of Dreamworks; Laurence Tisch, chairman of Lowes Corp.; bagel tycoon Marvin Lender; Leonard Abramson, founder of U.S. Healthcare; and Lester Crown, investor and part owner of the Chicago Bulls.

'TWICE THE SELF-EMPLOYMENT RATE'

In general, American Jews have nearly twice the self-employment rate of other ethnic groups in the U.S., a ratio similar to that in Great Britain and Europe. Only 4 percent of Laotian and Puerto Rican immigrants are entrepreneurs. At the top are Korean and Israeli immigrants, with rates approaching 30 percent. This entrepreneurial drive is crucial to Jewish success, as 80 percent of millionaires in the U.S. are self-made and did not inherit their wealth.

THE JEWS OF WALL STREET

A short list of other well-known Jewish Wall Street movers and shakers includes:

'MASTERS' OF THE INTERNET?

A *Forbes* article about the Internet in July 1998 titled "Masters of the New Universe" pointed out that there were thirteen corporate leaders of the Internet boom. Research revealed that four (30 percent) are Jewish.

JEWISH SOB SISTERS

A prime example of Jewish straight talk is Dr. Ruth Westheimer, *nee* Karola Ruth Siegel . . . Is Dr. Ruth alone as a leading Jewish purveyor of [sexual and sob-sister advice] to America? Hardly. Dr. Joyce Brothers and Dr. Laura Schlessinger on the airwaves and Ann Landers (Esther Pauline Friedman Lederer) and her twin sister Abigail "Dear Abby" Van Buren (Pauline Esther Friedman Phillips) in print, all have made their living doing the same thing.

'A VAST RIPPLE EFFECT'

Jews were the creators of Hollywood and the large studios that defined it. The Jewish involvement in motion pictures is more than a success story; it is the basis of the disproportionate influence that Jews have had in shaping American popular culture. And it does not end with movies, since the film industry, in effect, gave birth to the television industry.

The day of the big studios has passed, but the Jewish influence on Hollywood remains. Dreamworks owners Steven Spielberg, David Geffen and Jeffrey Katzenberg together have a \$5 billion nest-egg to back them. Sumner Redstone, who owns Paramount Pictures through his Viacom, once owned a large percentage of Columbia Pictures and Twentieth Century Fox. Michael Eisner leads the Disney studio, which in Walt's day, ironically, excluded Jews. Edgar Bronfman's Seagram owns Universal Studios. Michael Ovitz manages celebrity careers. ...

In addition to the corporate chieftains, a huge number of Jewish people participate in the entertainment industry. It has not been part of a grand scheme, but when an ethnic group becomes as heavily involved, and as successful, in a particular industry as Jewish people have been in movies, the group's influence, connections and power produce a vast ripple effect, and other Jewish actors, writers, editors, technicians, directors and producers follow in their footsteps. ...

JEWS AND THE NEWS: 'A CLOSE-KNIT COMMUNITY'

The Jewish influence is just as pronounced in television as it is in the movies. On the TV news desk, Jews have been very visible in front of the camera. As journalists, their personal religious and cultural beliefs are

not made an issue in their reporting, but their power is significant because they influence how we as Americans view the world and shape our opinions. ... Even more influential than reporters are the television news producers, since they decide which stories will go on air, in which order and how long they will run. A disproportionate number of these are Jewish as well. ...

At one point in the 1980s, the executive producers of all three evening news shows were Jewish. Furthermore, as Jewish Power [by J. J. Goldberg, cited elsewhere] points out, while Jews make up "5% of the working press nationwide—hardly more than their share of the population—they make up one-fourth of the writers, editors and producers in America's 'elite media', including network news divisions, the top newsmagazines and the four leading papers."

The remarkably high percentage of Jewish people in television has lasted for generations, perhaps because it is a relatively small and close-knit community. In a poll of TV's creative leaders, 59 percent said they were raised in the Jewish faith, while 38 percent still identified themselves as Jews.

TWO HOMES, MUCH-TRAVELED, DINE OUT

A 1993 survey of subscribers of *The Exponent*, the Philadelphia weekly Jewish newspaper, gave a clear picture of Jewish wealth and also of Jewish spending. Such surveys are decidedly unscientific, but the results show that Jews are [fiscally] conservative, yet they spend for things that they value:

- 26.1 percent owned a second home;
- 34.7 percent had traveled outside the United States in the past twelve months;
- 49.2 percent had dined out ten or more times in the last thirty days;
- 21 percent belonged to a health club.

THE PEOPLE WHO CAN AFFORD TO BUY BOOKS

Jews are the cornerstone of hardcover book sales, "accounting for between 50 and 75 percent of non-institutional hardcover sales in the United States." Even 25 percent would represent an amazingly disproportionate share of total sales. Hardbacks are the more expensive editions that precede the cheaper paperbacks and provide publishers with their greatest margins. Jewish-American buyers, then, are extremely important to the publishing industry.

JEWISH NAMES IN THE FORBES 400

It would be impossible to mention all of the successful Jewish business-people in America today. One of the clear benchmarks of success, however, is

being listed in the *Forbes* 400. To make the list in October 1999 required a net worth of at least \$625 million. Jewish individuals accounted for 23 percent of the entire group, 36 percent of the top fifty and 24 percent of the billionaires—eleven, eighteen and twelve times their relative percentage of the U.S. population at large. And these percentages in the *Forbes* 400 have been consistent over time, although the players change from year to year; studies of the lists from 1982, 1983 and 1984 conducted by others reveal similar figures.

2004 LIST OF THE JEWS OF THE FORBES 400

What follows is a list of those Jewish Americans appearing on the *Forbes* 400 list of the wealthiest Americans for the year 2004, although the list may not be complete for as Jewish-American writer Steven Silbiger has pointed out⁸⁵ (in reference to previous such lists) that there have been perhaps as many as fifteen others who might also be included, but who keep their Jewish antecedents private.

(At the end of the primary list is a smaller list of persons whose names appear on the *Forbes* 400 list for 2004 but whose ethnic antecedents are unknown or unclear, but probably Jewish.) This list that follows is probably the most comprehensive, up-to-date summary of the top Jewish billionaires and mega-millionaires in America today, although there are many substantial Jewish fortunes that did not make the "top 400" (but which have been on the list before). Note, though, that numerous heirs to the Mars Candy fortune and the Pritzker hotel empire have, for example, divided multi-billions of dollars among themselves, making them among the wealthiest family groupings on the face of the planet.

The number following the individual's name is his position on the *Forbes* 400 list (although note that several people can occupy that particular position), meaning that there are often actually more than 400 names on the *Forbes* list.

AMERICA: THE 'GREATEST' TRIUMPH . . .

In America the triumph is greatest of all. Former Vaccine Researcher Speaks Out

The following interview has been heavily redacted in accordance with Fair Use provisions. Readers with Internet access can read the article in its entirety at the author's website.

Early in the interview Jon Rappaport establishes that his guest helped develop a few vaccines but would not disclose which ones from fear of losing his pension. We jump into the dialogue a little further along.

[QUOTING, emphasis added:]

JON RAPPOPORT INTERVIEW OF EX VACCINE RESEARCHER

<NoMoreFakeNews.com>, October 2005

Q: Do you believe that people should be allowed to choose whether they should get vaccines?

A: On a political level, yes. On a scientific level, people need information, so that they can choose well. It's one thing to say choice is good. But if the atmosphere is full of lies, how can you choose? Also, **if the FDA were run by honorable people, these vaccines would not be granted licenses.** They would be investigated to within an inch of their lives.

Q: There are medical historians who state that the overall decline of illnesses was not due to vaccines.

A: I know. For a long time, I ignored their work. . . . Because I was afraid of what I would find out. I was in the business of developing vaccines. My livelihood depended on continuing that work.

Q: And then?

A: I did my own investigation.

Q: What conclusions did you come to?

A: **The decline of disease is due to improved living conditions.**

Q: What conditions?

A: Cleaner water. Advanced sewage systems. Nutrition. Fresher food. A decrease in poverty. Germs may be everywhere, but when you are healthy, you don't contract the diseases as easily.

Q: What did you feel when you completed your own investigation?

A: Despair. **I realized I was working a sector based on a collection of lies.**

Q: Are some vaccines more dangerous than others?

A: Yes. The DPT shot, for example. The MMR. But some lots of a vaccine are more dangerous than other lots of the same vaccine. As far as I'm concerned, **all vaccines are dangerous.**

Q: Why?

A: Several reasons. **They involve the human immune system in a process that tends to compromise immunity. They can actually cause the disease they are supposed to prevent. They can cause other diseases than the ones they are supposed to prevent.**

Q: Why are we quoted statistics which seem to prove that vaccines have been tremendously successful at wiping out diseases?

A: Why? To give the illusion that these vaccines are useful. If a vaccine suppresses visible symptoms of a

disease like measles, everyone assumes that the vaccine is a success. But, under the surface, **the vaccine can harm the immune system itself.** And if it causes other diseases—say, meningitis—that fact is masked, because no one believes that the vaccine can do that. The connection is overlooked.

Q: It is said that the smallpox vaccine wiped out smallpox in England.

A: Yes. But when you study the available statistics, you get another picture.

Q: Which is?

A: There were cities in England where people who were not vaccinated did not get smallpox. There were places where people who were vaccinated experienced smallpox epidemics. And smallpox was already on the decline before the vaccine was introduced.

Q: So you're saying that we have been treated to a false history.

A: Yes. That's exactly what I'm saying. This is a history that has been cooked up to convince people that vaccines are invariably safe and effective.

Q: Now, you worked in labs. Where purity was an issue.

A: The public believes that these labs, these manufacturing facilities are the cleanest places in the world. That is not true. **Contamination occurs all the time.** You get all sorts of debris introduced into vaccines.

Q: For example, the SV40 monkey virus slips into the polio vaccine.

A: Well yes, that happened. But that's not what I mean. The SV40 got into the polio vaccine because the vaccine was made by using monkey kidneys. But I'm talking about something else. The actual lab conditions. The mistakes. The careless errors. SV40, which was later found in cancer tumors—that was what I would call a structural problem. It was an accepted part of the manufacturing process. If you use monkey kidneys, you open the door to germs which you don't know are in those kidneys.

Q: Okay, but let's ignore that distinction between different types of contaminants for a moment. What contaminants did you find in your many years of work with vaccines?

A: All right. I'll give you some of what I came across, and I'll also give you what colleagues of mine found. Here's a partial list. In the Rimavex measles vaccine, we found various chicken viruses. In polio vaccine, we found *acanthamoeba*, which is a so-called “brain-eating” amoeba. Simian cytomegalovirus in polio vaccine. Simian foamy virus in the rotavirus vaccine. Bird-cancer viruses in the MMR vaccine. Various micro-organisms in the anthrax vaccine. I've found potentially dangerous enzyme inhibitors in several vaccines. Duck, dog, and rabbit viruses in the rubella vaccine. Avian leucosis virus in the flu vaccine. Pestivirus in the MMR vaccine.

Q: Let me get this straight. These are all contaminants which don't belong in the vaccines.

A: That's right. And if you try to calculate what damage these contaminants can cause, well, we don't really know, because no testing has been done, or very little testing. It's a game of roulette. You take your

chances. Also, most people don't know that some polio vaccines, adenovirus vaccines, rubella and hep A and measles vaccines have been made with aborted human fetal tissue. I have found what I believed were bacterial fragments and poliovirus in these vaccines from time to time—which may have come from that fetal tissue. When you look for contaminants in vaccines, you can come up with material that IS puzzling. You know it shouldn't be there, but you don't know exactly what you've got. I have found what I believed was a very small "fragment" of human hair and also human mucus. I have found what can only be called "foreign protein", which could mean almost anything. It could mean protein from viruses.

Q: Alarm bells are ringing all over the place.

A: How do you think I felt? Remember, **this material is going into the bloodstream without passing through some of the ordinary immune defenses.**

Q: How were your findings received?

A: Basically, it was, don't worry, this can't be helped. In making vaccines, you use various animals' tissue, and that's where this kind of contamination enters in. Of course, I'm not even mentioning the standard chemicals like formaldehyde, mercury and aluminum which are purposely put into vaccines.

Q: This information is pretty staggering.

A: Yes. And I'm just mentioning some of the biological contaminants. Who knows how many others there are? Others we don't find because we don't think to look for them. If tissue from, say, a bird is used to make a vaccine, how many possible germs can be in that tissue? We have no idea. We have no idea what they might be, or what effects they could have on humans.

Q: And beyond the purity issue?

A: You are dealing with the basic faulty premise about vaccines. That they intricately stimulate the immune system to create the conditions for immunity from disease. That is the bad premise. **It doesn't work that way.** A vaccine is supposed to "create" antibodies which, indirectly, offer protection against disease. However, the immune system is much larger and more involved than antibodies and their related "killer cells".

Q: The immune system is?

A: The entire body, really. Plus the mind. It's all immune system, you might say. That is why you can have, in the middle of an epidemic, those individuals who remain healthy.

Q: So the level of general health is important.

A: More than important. Vital.

Q: How are vaccine statistics falsely presented?

A: There are many ways. For example, suppose that 25 people who have received the hepatitis B vaccine come down with hepatitis. Well, hep B is a liver disease. But you can call liver disease many things. You can change the diagnosis. Then, you've concealed the root cause of the problem.

Q: And that happens?

A: All the time. It HAS to happen, if the doctors automatically assume that people who get vaccines DO NOT come down with the diseases they are now supposed to be protected from. And that is exactly what doctors assume. You see, it's circular reasoning. It's a closed system. It admits no fault. No possible fault. If a person who gets a vaccine against hepatitis gets hepatitis, or gets some other disease, the automatic assumption is, this had nothing to do with the disease.

Q: In your years working in the vaccine establishment, how many doctors did you encounter who admitted that vaccines were a problem?

A: None. There were a few who privately questioned what they were doing. But they would never go public, even within their companies.

Q: What was the turning point for you?

A: I had a friend whose baby died after a DPT shot.

Q: Did you investigate?

A: Yes, informally. I found that this baby was completely healthy before the vaccination. There was no reason for his death, except the vaccine. That started my doubts. Of course, I wanted to believe that the baby had gotten a bad shot from a bad lot. But as I looked into this further, I found that was not the case in this instance. I was being drawn into a spiral of doubt that increased over time. I continued to investigate. I found that, contrary to what I thought, vaccines are not tested in a scientific way.

Q: What do you mean?

A: For example, **no long-term studies are done on any vaccines.** Long-term follow-up is not done in any careful way.

Why? Because, again, the assumption is made that vaccines do not cause problems. So why should anyone check? On top of that, a vaccine reaction is defined so that all bad reactions are said to occur very soon after the shot is given. But that does not make sense.

Q: Why doesn't it make sense?

A: Because **the vaccine obviously acts in the body for a long period of time after it is given.** A reaction can be gradual. Deterioration can be gradual. Neurological problems can develop over time. They do in various conditions, even according to a conventional analysis. So why couldn't that be the case with vaccines? If chemical poisoning can occur gradually, why couldn't that be the case with a vaccine which contains mercury?

Q: And that is what you found?

A: Yes. You are dealing with correlations, most of the time. Correlations are not perfect. But if you get 500 parents whose children have suffered neurological damage during a one-year period after having a vaccine, this should be sufficient to spark off an intense investigation.

Q: Has it been enough?

A: No. Never. This tells you something right away.

Q: Which is?

A: The people doing the investigation are not really interested in looking at the facts. They assume that the vaccines are safe. So, when they do investigate, they invariably come up with exonerations of the vaccines. They say, "This vaccine is safe." But what do they base those judgments on? They base them on definitions and ideas which automatically rule out a condemnation of the vaccine.

Q: There are numerous cases where a vaccine campaign has failed. Where people have come down with the disease against which they were vaccinated.

A: Yes, there are many such instances. And there **the evidence is simply ignored.** It's discounted. The experts say, if they say anything at all, that this is just an isolated situation, but overall the vaccine has been shown to be safe. But if you add up all the vaccine campaigns where damage and disease have occurred, you realize that these are NOT isolated situations.

Q: If vaccines actually do harm, why are they given?

A: First of all, **there is no "if". They do harm.** It becomes a more difficult question to decide whether they do harm in those people who seem to show no harm. Then you are dealing with the kind of research which should be done, but isn't. Researchers should be probing to discover a kind of map, or flow chart, which shows exactly what vaccines do in the body from the moment they enter. **This research has not been done.** As to why they are given, we could sit here for two days and discuss all the reasons. As you've said many times, at different layers of the system people have their motives. Money, fear of losing a job, the desire to win brownie points, prestige, awards, promotion, misguided idealism, unthinking habit, and so on. But, **at the highest levels of the medical cartel, vaccines are a top priority because they cause a weakening of the immune system.** I know that may be hard to accept, but it's true. **The medical cartel, at the highest level, is not out to help people, it is out to harm them, to weaken them. To kill them.** At one point in my career, I had a long conversation with a man who occupied a high government position in an African nation. He told me that he was well aware of this. He told me that **WHO is a front for these depopulation interests.** There is an underground, shall we say, in Africa, made up of various officials who are earnestly trying to change the lot of the poor. This network of people knows what is going on. They know that vaccines have been used, and are being used, to destroy their countries, to make them ripe for takeover by globalist powers. I have had the opportunity to speak with several of these people from this network. ...

Q: This network you speak of. . .

A: It has accumulated a huge amount of information about vaccines. The question is, how is a successful strategy going to be mounted? For these people, that is a difficult issue.

Q: And in the industrialized nations?

A: The medical cartel has a stranglehold, but it is diminishing. Mainly because people have the freedom to question medicines. However, **if the choice issue [the right to take or reject any medicine] does not gather steam, these coming mandates about vaccines against bio-warfare germs are going to win out.** This is an important time.

Q: The furor over the hepatitis B vaccine seems one good avenue.

A: I think so, yes. To say that babies must have the vaccine—and then in the next breath, admitting that a person gets hep B from sexual contacts and shared needles—is a ridiculous juxtaposition. Medical authorities try to cover themselves by saying that 20,000 or so children in the U.S. get hep B every year from "unknown causes" and that's why every baby must have the vaccine. I dispute that 20,000 figure and the so-called studies that back it up. ...

Q: Well, it is national security, once you understand the medical cartel.

A: It is global security. The cartel operates in every nation. It zealously guards the sanctity of vaccines. Questioning these vaccines is on the same level as a Vatican bishop questioning the sanctity of the sacrament of the Eucharist in the Catholic Church. ...

Q: Within the National Institutes of Health, what is the mood, what is the basic frame of mind?

A: People are competing for research monies. The last thing they think about is challenging the *status quo*. They are already in an intramural war for that money. They don't need more trouble. This is a very insulated system. ...

Q: What about the combined destructive power of a number of vaccines given to babies these days?

A: It is a travesty and a crime. There are no real studies of any depth which have been done on that. Again, the assumption is made that vaccines are safe and therefore any number of vaccines given together are safe as well. But the truth is, vaccines are not safe. Therefore **the potential damage increases when you give many of them in a short time period.** ...

Q: What is one thing you want the public to understand?

A: That **the burden of proof in establishing the safety and efficacy of vaccines is on the people who manufacture and license them for public use.** Just that. The burden of proof is not on you or me. And for proof you need well-designed long-term studies. You need extensive follow-up. You need to interview mothers and pay attention to what mothers say about their babies and what happens to them after vaccination. You need all these things. The things that are not there. ...

Q: To avoid any confusion, I'd like you to review, once more, the disease problems that vaccines can cause. Which diseases, how that happens.

A: We are basically talking about two potential harmful outcomes. One, the person gets the disease from the vaccine. He gets the disease which the vaccine is supposed to protect him from. Because, some version of the disease is in the vaccine to begin with. Or two, he doesn't get THAT disease, but at some later time, maybe right away, maybe not, he develops another condition which is caused by the vaccine. That condition could be autism, what's called autism, or it could be some other disease like meningitis. He could become mentally disabled. ...

Q: Looking back now, can you recall any good reason to say that vaccines are successful?

A: No, I can't. **If I had a child now, the last thing I would allow is vaccination.** I would move out of the state if I had to. I would change the family name. I would disappear. With my family. I'm not saying it would come to that. There are ways to sidestep the system with grace, if you know how to act. There are exemptions you can declare, in every state, based on religious and/or philosophic views. But if push came to shove, I would go on the move.

Q: And yet there are children everywhere who do get vaccines and appear to be healthy.

A: The operative word is "appear". What about all the children who can't focus on their studies? What about the children who have tantrums from time to time? What about the children who are not quite in possession of all their mental faculties? I know there are many causes for these things, but vaccines are one cause. I would not take the chance. I see no reason to take the chance. And frankly, I see no reason to allow the government to have the last word. Government medicine is, from my experience, often a contradiction in terms. You get one or the other, but not both.

Q: So we come to the level playing field.

A: Yes. Allow those who want the vaccines to take them. Allow the dissidents to decline to take them. But, as I said earlier, there is no level playing field if the field is strewn with lies. And when babies are involved, you have parents making all the decisions. Those parents need a heavy dose of truth. And only you can decide whether to do it. It is every person's responsibility to make up his mind. The medical cartel likes that bet. It is betting that the fear will win. ...

Now comes a new crackdown **across Europe**. The British legislation would allow police to detain terror suspects for up to three months without charge, compared with the current 14 days; clear the way for deporting foreigners to countries with spotty records on human rights; and make it easier to jail people who publish or sell material deemed to incite terrorism.

"The U.K. has one of the toughest anti-terrorism packages in Europe. The French also have tough measures and the **Italians** have now pushed through legislation that gives authorities great powers," said Magnus Ranstorp, a terrorism expert at the **Swedish National Defense College**. "There is certainly a strong desire voiced publicly in Europe to not relinquish civil liberties in return for security, but these new measures are being pushed through quickly."

So desperate have these Western Nations been to destroy the freedoms of their people that the government of **Australia** has resorted to the American tactic of just simply lying to their citizens, and as we can read as reported by the *Reuters News Service* in their article titled "Australia government accused of security scare campaign" and which says:

Australia's government is playing politics with anti-terrorism laws by unveiling plans to deploy troops in the event of an attack just days after it warned of an undisclosed terrorist threat, opposition parties said on Monday. Howard's warning of a terrorist threat, of which he has refused to give details, and the law changes have overshadowed debate in parliament on labour reforms that are a centrepiece of Howard's fourth-term agenda but are unpopular with voters.

Defence Minister Robert Hill said on Sunday he wanted laws allowing the deployment of troops with **shoot-to-kill** powers to be passed before the Commonwealth Games was held in Australia's second-biggest city, Melbourne, in March. The move comes after the upper house Senate was urgently recalled on Thursday to pass amendments to make it easier for police to arrest suspects just a day after Howard revealed a possible terrorist threat had come to light. "It seems the government is unveiling these strategies one after the other to keep Australian citizens in a perpetual state of fear," Democrats Senator Natasha Stott Despoja told reporters.

BILDERBERG PROFITS FROM BIRD FLU

Donald H. Rumsfeld was chairman of Gilead before he became defense secretary in January 2001. Rumsfeld reportedly recused himself on Oct. 27 from government decisions concerning medications to prevent or treat avian flu rather than sell his considerable stock holdings in Gilead.

Gilead reported a 51 percent increase in revenues for the third quarter of 2005, compared with 2004. The company received \$12.1 million, more than a 700 percent increase in its quarterly royalties received from Roche. Because Roche has worldwide commercial rights on the production of Tamiflu, the billions being spent on the flu medication will greatly increase corporate profits at Roche and Gilead. ...

Two well-known members of the secretive group known as Bilderberg, Etienne F. Davignon and George P. Schultz, sit on Gilead's board of directors, while a third member of the elitist group, Lodewijk J.R. de Vink, is on the board of Hoffman-LaRoche.

De Vink, a Dutch-American, is a founding member of Blackstone Healthcare Partners, LLC, a corporate advisory service of the Blackstone Group, a global investment firm

founded by Peter G. Peterson, the chairman of the Council on Foreign Relations and former chairman of the Federal Reserve Bank of New York, and Stephen A. Schwarzman. Among other things, de Vink is a member of the European Advisory Council of Rothschild & Cie.

Dovetailing the Bush bird flu plan is a controversial Senate bill called the *Biodefense and Pandemic Vaccine and Drug Development Act of 2005* (S. 1873). ...

Barbara Loe Fisher, president of the National Vaccine Information Center, a private advocacy group pushing for safer vaccines, said the Burr bill is "a drug company stockholder's dream and a consumer's worst nightmare."



When Is An Owner NOT A Stockholder?

Budget's "Tip of the Week" #3:

NRS 78.197—Rights of persons holding obligations of corporation

If you own part (or all) of a corporation, you're a stockholder, right? In Nevada, the answer to that question is, "Not necessarily." Let's look at another unique provision of Nevada corporate law:

NRS 78.197 Rights of persons holding obligations of corporation.

A corporation may provide in its articles of incorporation that the holder of a bond, debenture or other obligation of the corporation may have any of the rights of a stockholder in the corporation.

With this provision written into your Articles of Incorporation, you "may have any of the rights of a stockholder"—without owning stock! Thus, the holder of a note COULD own the corporation and could even be afforded the same VOTING RIGHTS as a stockholder—without being a stockholder. And in the absence of stockholders—in cases where no stock has been issued—presumably, the holder of a promissory note of the corporation could have 100% of the voting rights at any meeting.

If such a provision related to NRS 78.197 is NOT in your current Articles of Incorporation, check and see if the following standard clause exists under an Article relating to Amendments:

Except with respect to amending the non-assessability of shares per Article IV, this corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation or its Bylaws in the manner now or hereafter prescribed by statute or by these Articles of Incorporation or by the corporation's Bylaws, and all rights conferred upon the stockholders are granted subject to this reservation.

If so, the corporation may "amend... these Articles of Incorporation... in the manner prescribed by... the corporation's Bylaws". In other words, the Articles of Incorporation are modified by the Bylaws. If such a provision exists in your Articles of Incorporation, we suggest that you amend the Bylaws to reflect wording such as NRS 78.197 suggests for the Articles of Incorporation.

If neither of these provisions exists in your corporation's Articles, you might want to file an Amendment of the Articles of Incorporation. We can handle such a filing with the Secretary of State for you, just ask.

Next week, we'll look at what might be called a "turnip" or "prickly pear" clause in the *Nevada Revised Statutes*: NRS 78.7502.


