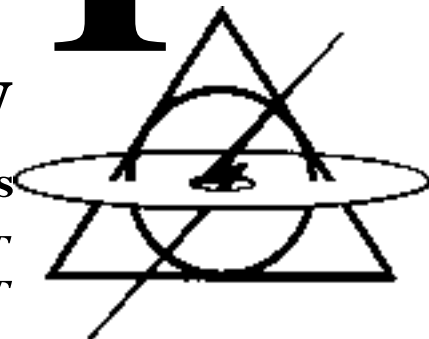

That's just one of the surprising discoveries that have resulted from the extended life of NASA's *Mars Global Surveyor*, which this month began its ninth year in orbit around Mars. Boulders tumbling down a Martian slope left tracks that weren't there two years ago. New impact craters formed since the 1970s suggest changes to age-estimating models. And for three Mars summers in a row, deposits of frozen carbon

Prediction of a global climate change on Jupiter Philip S. Marcus

Jupiter's atmosphere, as observed in the 1979 *Voyager* space craft images, is characterized by 12 zonal jet streams and about 80 vortices, the largest of which are the Great Red Spot and three White Ovals that had formed in the 1930s. The Great Red Spot has been observed continuously since 1665 and, given the dynamical similarities between the Great Red Spot and the White Ovals, the disappearance of two White Ovals in 1997-2000 was unexpected. Their longevity and sudden demise has been explained, however, by the trapping of anti-cyclonic vortices in the troughs of Rossby waves, forcing them to merge. Here I propose that the disappearance of the White Ovals was not an isolated event, but part of a recurring climate cycle which will cause most of Jupiter's vortices to disappear within the next decade. In my numerical simulations, the loss of the vortices results in a global temperature change of about 10 K, which destabilizes the atmosphere and thereby leads to the formation of new vortices. After formation, the large vortices are eroded by turbulence over a time of 60 years—consistent with observations of the White Ovals—until they disappear and the cycle begins again.

Pluto is undergoing global warming, researchers find October 9, 2002

BIRMINGHAM, Ala.—Pluto is undergoing global warming, as evidenced by a three-fold increase in the planet's atmospheric pressure during the past 14 years, a team of astronomers from Massachusetts Institute of Technology (MIT), Williams College, the University of Hawaii, Lowell Observatory and Cornell University announced in a press conference today at the annual meeting of the American Astronomical Society's (AAS) Division for Planetary Sciences in Birmingham, AL.

The team, led by James Elliot, professor of planetary astronomy at MIT and director of MIT's Wallace Observatory, made this finding by watching the dimming of a star when Pluto passed in front of it Aug. 20. The team carried out observations using eight telescopes at Mauna Kea Observatory, Haleakala, Lick Observatory, Lowell Observatory and Palomar Observatory. Data were successfully recorded at all sites.

An earlier attempt to observe an occultation of Pluto on July 19 in Chile was not highly successful. Observations were made from only two sites with small telescopes because the giant telescopes and other small telescopes involved lost out to bad weather or from being in the wrong location that day. These two occultations were the first to be successfully observed for Pluto since 1988.

Pluto thought to be warming up

Astronomers at the University of Tasmania have found that the solar system's smallest planet is not getting colder as first thought and it probably does not have rings.

Dr John Greenhill has collected observations from last month's event when Pluto passed in front of a bright star, making it easier to study.

French scientists have shared the measurements they took in Tasmania that night, which indicate that the planet is unlikely to have rings.

Dr Greenhill says the results are surprising because they show Pluto is warming up.

ESA sees stardust storms Heading for Solar System

Until ten years ago, most astronomers did not believe stardust could enter our Solar System. Then ESA's *Ulysses* spaceprobe discovered minute stardust particles leaking through the Sun's magnetic shield, into the realm of Earth and the other planets. Now, the same spaceprobe has shown that a flood of dusty particles is heading our way.

... What is surprising in this new *Ulysses* discovery is that the amount of stardust has continued to increase even after the solar activity calmed down and the magnetic field resumed its ordered shape in 2001.

Scientists believe that this is due to the way in which the polarity changed during solar maximum. Instead of reversing completely, flipping north to south, the Sun's magnetic poles have only rotated at halfway and are now more or less lying sideways along the Sun's equator. This weaker configuration of the magnetic shield is letting in two to three times more stardust than at the end of the 1990s. Moreover, this influx could increase by as much as ten times until the end of the current solar cycle in 2012.

Ulysses sees Galactic Dust on the rise Aug 1, 2003

Since early 1992 *Ulysses* has been monitoring the stream of stardust flowing through our Solar System. The stardust is embedded in the local galactic cloud through which the Sun is moving at a speed of 26 kilometres every second. As a result of this relative motion, a single dust grain takes twenty years to traverse the Solar System. Observations by the DUST experiment on board *Ulysses* have shown that the stream of stardust is highly affected by the Sun's magnetic field.

... Unlike Earth, however, the Sun reverses its magnetic polarity every 11 years. The reversal always occurs during solar maximum. That's when the magnetic field is highly disordered, allowing more interstellar dust to enter the Solar System. It is interesting to note that in the reversed configuration after the recent solar maximum (North negative, South positive), the interstellar dust is even channelled more efficiently towards the inner Solar System. So we can expect even more interstellar dust from 2005 onwards, once the changes become fully effective.

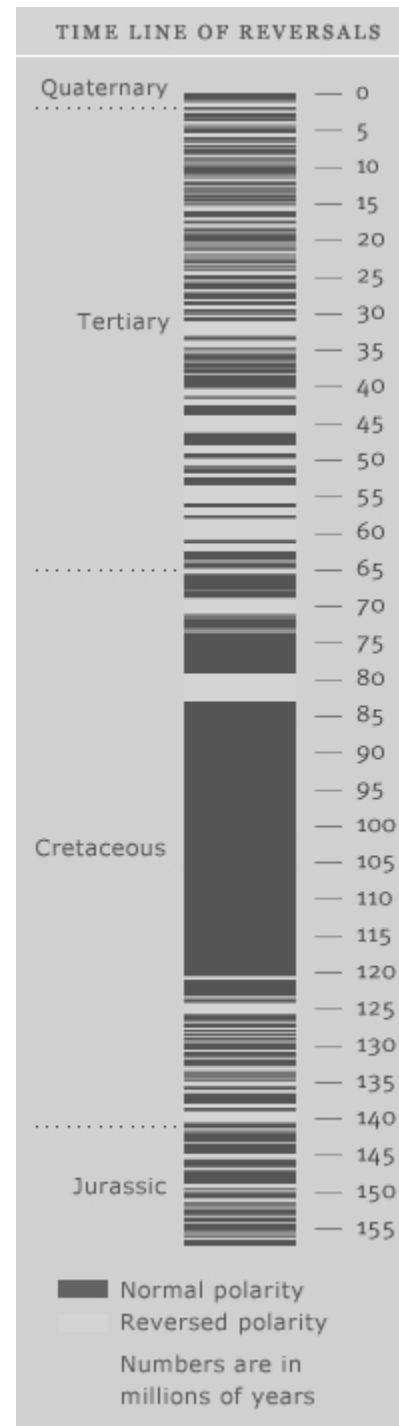

SPACE WARS

This is such a hot topic right now that we’re going to use some space to review recent events.

On March 14, 2006, the *Boston Globe*, in an article captioned “Pentagon Eyeing Weapons in Space”, reported:

“The Defense Department’s budget proposal for the fiscal year beginning Oct. 1 includes money for a variety of tests on offensive and defensive weapons, including a missile launched at a small satellite in orbit, testing a small space vehicle that could disperse weapons while traveling at 20 times the speed of sound, and determining whether high-powered ground-based lasers can effectively destroy enemy satellites.”

On December 14, 2006 the National Reconnaissance Office put up some kind of an “experimental” satellite worth hundreds of millions of dollars—as much as the Pentagon’s ENTIRE request for testing weapons in space. This suggests that the special satellite was part of the much larger “black” or classified budget of \$439 billion, which, according to the Boston Globe, “almost certainly includes other space-related programs”. “Somebody”, however, apparently knew the significance of this particular little bird.

On January 4, 2007 the skies lit up over a broad area of the west-central United States with a dazzling display of “something”—reported at the time to have been a “Russian booster rocket”, which the Russian launchers denied by providing specifics of their booster’s safe re-entry on December 27. The tremendous luminance of the January 4 event certainly suggests that something literally “blew up”. Video frames of the event (presented in the January 10 issue) clearly showed two “lights” moving above the disintegrating mass—and in the OPPOSITE DIRECTION. NOTE, please, that the debris was moving NORTH to SOUTH, so if this was a satellite take-down, the satellite was in a circum-polar orbit (over-flying Antarctica), not one with a far more ordinary East-West orientation.

On January 11, *Aviation Week* reported, China brought down one of its aging weather satellites by using a ballistic missile of some kind. Notably, this satellite was also said to have had a circum-polar (North-South) orbit. Russian Defense Minister Sergei Ivanov described such reports as “unsubstantiated”, “unfounded”, “largely exaggerated” and “abstract”.

On January 12 it was reported by *Reuters* that the National Reconnaissance Office (NRO) lost contact with a brand new “experimental” spy satellite worth millions of dollars.

Meanwhile, *RIA Novosti* recently reported Russian General Gareyev’s outline of a new military doctrine for Russia, which “... will be based on the concept of active defense”.

On January 23 the *New York Times* carried an article boldly headlined, “China Confirms Test of Anti-Satellite Weapon”. Curiously, however, **not one statement made by any Chinese official cited in the article actually confirms the headline’s assertion.** Here are the citations attributed to the foreign ministry spokesman, Liu Jianchao:

“This test [RK: WHAT test? WHOSE test?] was not directed at any country and does not constitute a threat to any country,” he said. [RK: In fact it probably constituted the ELIMINATION of a threat in the form of that pricey NRO satellite and the Chinese satellite on the same circum-polar orbit was

probably collateral damage.] “What needs to be stressed is that China has always advocated the peaceful use of space, opposes the weaponization of space and an arms race in space,” he said. “China has never participated and will never participate in any arms race in outer space.” “China has nothing to hide,” he said. “After various parties expressed concerns, we explained this test in outer space to them.”

The *New York Times* also cites Xu Guangyu, “a former Chinese army officer and an official at the government-run China Arms Control and Disarmament Association”:

“What China is saying is, ‘Let’s sit down and talk,’” Mr. Xu said. “There is a trend toward weaponization of space that no one, especially China, wants to see.”

Would someone please tell me how those words from Chinese officials in aggregate can be used to justify the headline, “China Confirms Test of Anti-Satellite Weapon”—or much more, confirm the use of a ballistic missile to shoot down China’s own satellite? If they did it to make some kind of a point, why wouldn’t they MAKE THEIR POINT instead of remaining silent for weeks?

Just a day earlier, on January 22, a *Reuters* article entitled “China Experts See Space Blast as Puzzle and Warning” quoted the same Mr. Xu, who described China’s non-explanation as “baffling”. “I don’t know whether the American reports about the satellite are true. It’s odd and abnormal that they [China’s diplomats] haven’t said anything.” “If it is a negotiating chip, it’s illogical not to come out and announce something.” INDEED.

Remarkably, “No current treaties or agreements prohibit military strikes against satellites,” according to Alex Jones’ InfoWars.com website—so if, hypothetically speaking, a couple of cosmospheres knocked down a piece of really nasty military hardware, it was at the very least “legal” to do so.

On January 26 the *Associated Press* carried a brief article entitled, “Putin Slams U.S. Space Weapons”, which cited Russian President Vladimir Putin, who “criticized U.S. plans for space-based weapons, saying it was the reason behind a recent Chinese anti-satellite weapons test ... Putin avoided directly criticizing China, saying only that Russia was against putting any weapons in space. Instead, Putin chose to issue a warning to the United States on the dangers of the militarization of space.”

So, President Putin says the reason for the Chinese satellite downing was “U.S. plans for space-based weapons”. And that takes us right back to those three frames taken from early video of the January 4 event—which has somehow been forgotten in all the hoopla about the purported “Chinese” anti-satellite test—showing those two lights moving in the opposite direction from the disintegrating whatever-it-was.

“We must not let the genie out of the bottle,” Mr. Putin said during that AP interview.

Well, to make some sense out of these events, we must acknowledge the existence of those Russian cosmospheres, which remain as hidden from public view today as they were during the Battle of the Harvest Moon back in 1977, 30 years ago (as reported by Dr. Beter)! In 1992 we were informed that there were already hundreds of “service platforms” for THOUSANDS of cosmospheres and that some of those craft were even then permanently stationed over areas such as the San Andreas Fault. How very fortunate that control of Near-Space remains, for now, in the hands of the more CHRISTIAN element.

For those who question the existence of these technologies, the 1899 interview with Nikola Tesla would be quite revealing and if there is room, it should be included in this issue.

CHINESE YEAR OF THE PIG

Let’s have a slightly different look at “the stars” from the perspective of the Chinese Horoscope. For the Chinese, the Solar New Year begins February 4 and the Lunar New Year this year will be on February 18, the occasion of the second New Moon following the Winter Solstice. They recognize this year as 4704 in their counting, the twenty-third stem-branch, etc.—and we won’t go into further details of their numbering at this point.

This is the Year of the Pig, more specifically it is the Year of the Female-Yin-Red-Fire Pig. PLEASE NOTE: THE PIG AND THE SNAKE HAVE A FIGHTING RELATIONSHIP, so this does not promise to be a comfortable year for the snakes.

Richard Giles of AstrologyCom.com has written up his analysis of the forthcoming year and we think you’ll be interested in some of what he has to say:

The mythological stories of the Pig are fascinating, as **the Pig is always associated with knowing the next world.** ... The Celts regarded the pig as an assistant in understanding the spiritual nature of man. In many other mythologies too **the Pig is regarded as an animal of spiritual authority. The Pig even has a shaman-like quality to him as there are old stories of him changing into human form. [RK: Perhaps there are some Humans who would like to come up out of the “earth” this year and into their higher form as well.]**

The Pig is naturally an overprotective parent who is very concerned with the well-being of his offspring—a stickler for education and the right values. He instills the children with a strong sense of morality.

This year the element is Yin Fire, which is more powerful than Yang Fire. Yin Fire symbolises emotions, tension, agitation and illusions. Underneath is Yin Water. Resulting from this combination will be many conflicts over politics, government and also authorities imposing their will onto the people.

2007 is a mixed one with the year being ruled by the Fire element in Chinese and the Pig being ruled by Water element. With Fire and Water together it’s going to be a struggle, as one is inimically the enemy of the other. Fire is on top this year with Water below—and Fire cannot burn without support. When Fire and Water clash, they either result in lots of scalding hot steam and explosions or they can transform whatever situation it was into something completely different.

Previous Fire Pig years have been very dangerous, with much political to-ing and fro-ing, plus lots of upheavals. Other Fire Pig years were 1947 and 1887. In 1947 ... Palestine was partitioned after a British plan to divide Palestine was rejected by the UN. Britain recorded its most severe winter since 1894 and a fierce blizzard hit New York, where 28 inches (72 cms) of snow were recorded. It was the year of the first plane to fly at supersonic speeds (above the speed of sound) and Bell Laboratories invented the transistor, which revolutionised radio and electronics. The CIA was established in the U.S. (Water rules secrets) and, also that year, President Truman released his Truman doctrine, which was an attempt to slow down the spread of communism throughout the world. It was the birth year of the Cold War. At the same time in Burma, the national leader Aung San (father of today’s Aung San Suu Kyi, under house arrest) was assassinated.

The other most interesting event of 1947 was the report of a crashed UFO near Roswell, New Mexico

in the USA. Although several flying saucer crashes were reported in the literature around that time, the Roswell crash is the one that has dominated UFO research and been the most publicised.

The place of extraterrestrial races in the Five Elements system is ruled by the Fire element and the issues of UFO contact with humans on earth has resulted in UFOs becoming classified information and subject to great secrecy. Secrets are ruled by the Water element. The resultant clash has been a point of dispute with many citizens' groups ever since the 1960s. **We can expect that in 2007 this issue may surface again very strongly and the resultant publicity may allow some secrets to be revealed about UFO sightings in the past.** With Fire (ideals) and Water (secrets) prominent in the 2007 chart we can expect clashes of values over secrecy. It's possible some great announcement may be made by authorities in 2007, not necessarily to do with Roswell, but perhaps to do with the possibility of ET life in our solar system (or elsewhere) being acknowledged this year. Other secrets may also be revealed in politics or about our ancient past history this year.

The economy in a Fire Pig year can be very driven, as the Yin Fire aspect starts off the year well. Seasonally, when the Spring and Summer months begin (which is from March/April onwards in the Chinese calendar) then the economies of many countries will perform well. These months are favoured by the Fire element. After the summer finishes and the second half of the year comes, the Water element in the Pig year is more favoured: the Fire dies off, so the economy and stock market may slow right down in that second half. In 1997 which was also a Yin Fire year, the Asian markets collapsed in the second half of that year.

... Fire and Water can contribute to sudden breakthroughs though, in technology or new energy devices, and there is great potential for new and dramatic inventions that revolutionise the way we generate power and also solve medical problems.

Fire and Water clashing says a lot about climate and weather and you can bet that the year 2007 will be one of even more unnatural climate extremes. Expect dramatic weather changes, storms, fires, droughts, volcanic eruptions, floods and even tsunamis. Other events that could be characteristic of 2007 will be chemical fires, industrial explosions and incidents related to factories or chemicals mixed in the wrong manner causing toxic poisoning and maybe even in food poisoning outbreaks.

The Fire Pig year will also be a year of drama and change in politics, as the Fire/Water combination means clashes of values and criticism, unrest, threatened coups or violence in politics and arguments, disputes and fights over values and rights. Those who tackle political issues in a violent, combative or aggressive mode will not do well this year, but those who take on issues with a more sympathetic and embracing approach, using mediation techniques, are far more likely to achieve success in a Pig year. **There could be sudden changes in leadership, many arguments in politics and dramatic rebellions of peoples fed up with oppressive rulers.** ...

The Snake, ruled by Fire, is the Chinese zodiac animal opposite to the Pig, and traditionally the animal opposite the year sign has a testing time that year. ...

Today these Acts address the people of the United States themselves as their enemy. **[RK: You certainly BECOME an "enemy of the state" if you set yourself up as a sovereign individual instead of simply being a well-**

behaved, tax-paying slave (creature of the FOURTEENTH Amendment).]

2nd: The *District of Columbia Organic Act* of 1871 created a private corporation (hereinafter "Corp. U.S.", Trademark name, "United States Government") **[RK: Really?]** owned and operated by the actual government for the purpose of carrying out the business needs of the government under martial law. This was done under the constitutional authority for Congress to pass any law within the ten-mile square of Washington, District of Columbia.

3rd: In said Act, Corp. U.S. adopted their own constitution (*United States Constitution*), which was identical to the national Constitution (*Constitution of the United States of America*) except that it was missing the national constitution's 13th Amendment and the national constitution's 14th, 15th and 16th amendments are respectively numbered 13th, 14th and 15th amendments in the Corp. U.S. Constitution. **[RK: Evidence?]** At this point take special notice and remember this Corp. U.S. method of adopting their own Constitution, they will add to it in the same manner in 1913.

4th: Corp. U.S. began to generate debts via bonds etc., which came due in 1912, but they could not pay their debts so the 7 families that bought up the bonds demanded payment and Corp. U.S. could not pay. Said families settled the debt for the payments of all of Corp. U.S.' assets and for all of the assets **[RK: AND LIABILITIES, INCLUDING, NOTABLY, BONUS 3392-181]** of the Treasury of the United States of America.

5th: As 1913 began, Corp. U.S. had no funds to carry out the necessary business needs of the government so they went to said families and asked if they could borrow some money. The families said no (Corp. U.S. had already demonstrated that they would not repay their debts in full). The families had foreseen this situation and had the year before finalized the creation of a private corporation of the name "Federal Reserve Bank". Corp. U.S. formed a relationship with the Federal Reserve Bank whereby they could transact their business via note rather than with money. Notice that this relationship was one made between two private corporations and did not involve government; that is where most people error in understanding the Federal Reserve Bank system—again it has no government relation at all. **[RK: Pay attention. It's all about CONTRACTS, just like George Mercier's Invisible Contracts revealed.] The private contracts that set the whole system up even recognize that if anything therein proposed is found illegal or impossible to perform it is excluded from the agreements and the remaining elements remain in full force and effect.**

6th: Almost simultaneously with the last fact (also in 1913), Corp. U.S. adopts (as if ratified) their own 16th amendment. Tax protesters challenge the IRS tax collection system based on this fact, however when we remember that Corp. U.S. originally created their constitution by simply drafting it and adopting it; there is no difference between that adoption and this—such is the nature of corporate enactments. You must also note that this amendment has nothing to do with our nation, with our people or with our national Constitution, which already had its own 16th amendment. The Supreme Court ruled that it did nothing that was not already done other than to make plain and clear the right of the United States (Corp. U.S.) to tax corporations. We agree, considering that they were created under the authority of Corp. U.S.

7th: Next (also 1913) Corp. U.S., through Congress, adopts (as if ratified) its 17th amendment. This amendment is not only not ratified, it is not constitutional; the nation's Constitution forbids Congress from even discussing the matter of where Senators are elected, which is the subject matter of this amendment. According to the United States Supreme Court, for Congress to propose such an amendment they would first have to pass an amendment that gave them the authority to discuss the matter.

8th: Accordingly, in 1914, the Freshman class and all Senators that successfully ran for re-election in 1913 by popular vote were seated in Corp. U.S. Senate capacity only; their respective seats from their States remained vacant because neither the State Senates nor the State Governors appointed new Senators to replace them as is still required by the national Constitution for placement of a national Senator.

9th: In 1917, Corp. U.S. enters WWI and passes their *Trading with the Enemy Act*.

10th: In 1918, President Wilson is reelected by the Electoral College but their election is required to be confirmed by the constitutionally set Senate; where the new Corp. U.S. only Senators were allowed to participate in the Electoral College vote confirmation the only authority that could possibly have been used for electoral confirmation was corporate only. Therefore, President Wilson was not confirmed into office for his second term as President of the United States of America and was only seated in the Corp. U.S. Presidential capacity. Therefore the original jurisdiction government's seats were vacated because the people didn't seat any original jurisdiction government officers. It is important to note here that President Wilson retained his capacity as Commander in Chief of the military. Many people wonder about this fact imagining that such a capacity is bound to the President of the nation; however, When John Adams was President he assigned George Washington to the capacity of Commander in Chief of the military in preparation for an impending war with France. During this period, Mr. Adams became quite concerned because Mr. Washington became quite ill and passed on his acting military authority through his lead General Mr. Hamilton and Mr. Adams was concerned that if war did break out Mr. Hamilton would use that authority to create a military dictatorship of the nation. Mr. Adams averted the war through diplomacy and the title of Commander in Chief was returned to him.

(See: *John Adams*, by David McCullough; this book covers Mr. Adams' concerns over this matter quite well. Mr. Adams was a fascinating man.)

11th: In 1933, Corp. U.S. is bankrupt, they force a banking holiday to exchange money-backed Federal Reserve Notes with "legal tender" Federal Reserve Notes; the *Trading with the Enemy Act* is adjusted to recognize the people of the United States as enemies of Corp. U.S.

12th: Some time after 1935, you ask Social Security Administration for a relationship with their program. With the express purpose of generating Beneficiary funds to United States General Trust Fund (GTF) the Social Security Administration creates an entity with a name (that sounds like your name but is spelled with all capital letters) and an account number (Social Security number). They give you the Social Security card and let you know that the card does not belong to you but you are to hold it for them until they want it back. If you are willing to accept that responsibility over the card you activate the card by signing it, which gives you the ability to act as the fiduciary for the cards actual owner Corp.

U.S. and you can use the card's name and number to thus transact business relations for the card's actual owner. You are also to note that though the card verifies its agency (you as the single person with authority to control the entity so created) it is not for use as identification. On review: notice the Social Security Administration was the creator of the entity, they offered you the opportunity to serve its Trustee capacity (by lending it actual consciousness and physical capacity), they gave you something (the card) that does not belong to you to hold in trust and they reserved the actual owner of the thing (Corp. U.S.) as the beneficiary of the entity—by definition, this only describes the creation and existence of a Trust. More importantly: the name they gave this Trust is not your name, the number they gave the Trust is not your number and your lending actual consciousness and physical capacity to this Trust's Trustee capacity does not limit you or your capacity to separately act in your natural sovereign capacity in any way—what you do, when you do it and how you do it is still totally up to you.

13th: In 1944, under the *Bretton Woods Agreement*, Corp. U.S. is quit-claimed to the International Monetary Fund, and becomes a foreign-controlled private corporation.

14th: In 1968, at the National Governor's Conference in Lexington, Kentucky, the IMF leaders of the event proposed the dilemma the State governors were in for carrying out their business dealings in Federal Reserve Notes (foreign notes), which is forbidden in the national and State constitutions, alleging that if they did not do something to protect themselves the people would discover what had been done with their money and would likely ... kill them all and start over. They suggested the States form corporations like Corp. U.S. and showed the advantages of the resultant uniform codes that could be created, which would allow better and more powerful control over the people, which thing the original jurisdiction governments of this nation had no capacity to do. Our Constitutions secure that the governments do not govern the people rather they govern themselves in accord with the limits of Law. The people govern themselves. Such is the foundational nature of our Constitutional Republic.

15th: By 1971, every State government in the union of States had formed such private corporations (Corp. State), in accord with the IMF admonition, and the people ceased to seat original jurisdiction government officials in their State government seats.

Now, having stated these historical facts, we ask you not to believe us, but rather prove these facts for yourself. We then ask you to contact us and share your discovery with us.

When you find there is no error in this historical outline, then remember these simple facts and let no one dissuade you from the truth.

The Bottom Line: when you speak about these private foreign corporations remember that is what they are and stop calling them government.

Further, it is very important that we cease to attempt to fix them. It is far more important that we learn how to reseat our original jurisdiction government and spread the word about the truth. By reseating our State and national governments in their original jurisdiction nature, we gain the capacity to hold these private foreign corporations accountable. They owe us a lot of money, in fact they owe us more money than there is available in the world. **[RK: THIS HAS NOW BEEN CERTIFICATED IN THE FORM OF THE GLOBAL ALLIANCE CERTIFICATE OF DEBT.]** In fact it is impossible for them to pay and that gives us the

leverage we need to take back our nation and put things right. The process is a simple one. The difficulty is in getting our people to wake up to the truth. That's why we ask you to prove the truth for yourself and contact us with your discovery.

That means that you must stop acting and communicating like you are anything other than the sovereign that God created you to be. And, stop referring to Corp. U.S. or the STATE OF 'X' as anything other than the private foreign corporations that they are. And, finally, stop listening to the Bigfoot Patriot Mythology that is espoused by those that only give these facts lip service.

It's time to wake up and follow the truth, time to repent and become a moral and honorable society instead of lauding our Piety while we stand guilty of:

a) not knowing the truth;

b) not living the truth;

c) believing God will save us even though we have the tools to know the truth the ability to use the tools but we refuse to live by the truth and use the tools we have to save ourselves and thereby become free.

Thank you, Jonur. Greetings in the Light of the Radiant One. I am Commander Gyeorgos Ceres Hatonn, fourth-dimensional commander of God Aton's Intergalactic Fleet of "Silver Clouds". We are known as "the Hosts of Heaven" and have come in great silver craft that your governments call UFOs (Unidentified Flying Objects). There are no "UFOs", chelas (students); there is NOTHING unidentified floating around anywhere that your governments have not tracked and monitored.

Nikola Tesla Interview

THE NEW WIZARD OF THE WEST

By Chauncy M'Govern, *Pearson's Magazine*, May 1899

Not to stagger on being shown through the laboratory of Nikola Tesla requires the possession of an uncommonly sturdy mind. No person can escape a feeling of giddiness when permitted to pass into this miracle-factory and contemplate for a moment the amazing feats which this young man can accomplish by the mere turning of a hand.

Fancy yourself seated in a large, well-lighted room, with mountains of curious-looking machinery on all sides. A tall, thin young man walks up to you, and by merely snapping his fingers creates instantaneously a ball of leaping red flame, and holds it calmly in his hands. As you gaze you are surprised to see it does not burn his fingers. He lets it fall upon his clothing, on his hair, into your lap, and, finally, puts the ball of flame into a wooden box. You are amazed to see that nowhere does the flame leave the slightest trace, and you rub your eyes to make sure you are not asleep.

The odd flame having been extinguished as miraculously as it appeared, the tall, thin young man next signals to his assistants to close up all the windows. When this has been done the room is as dark as a cave. A moment later you hear the young man say in the laboured accentuation of the foreigner: "Now, my friends, I will make for you some daylight." Quick as a flash the whole laboratory is filled with a strange light as beautiful as that of the Moon, but as strong as that of old Sol. As you glance up at the closed shutters on each window, you see that each of them is as tight as a vice, and that no rays are coming through them. Cast your eyes wherever you will you can see no trace of the source of the odd light.

Scarcely have you begun to marvel when the light goes out by a touch on a button by the young man's hand. The room is in darkness again until the same laboured accentuation causes the reopening of all the shutters. Some animal is now brought out from a cage, it is tied to a platform, an electric current is applied to its body and in a second the animal is dead. The tall young man calls your attention to the fact that the indicator registers only one thousand volts, and the dead animal being removed, he jumps upon the platform himself, and his assistants apply the same current to the dismay of the spectators.

You feel a creeping sensation course up your back, and you see the indicator slowly mounting up to nine hundred, and then one thousand volts, and you involuntarily close your eyes, expecting the young man to fall dead before you the very next minute. But he does not budge. Quickly the indicator goes up, up, up, until presently it shows that ten thousand volts, then two million volts of electricity are pouring through the frame of the tall young man, who does not move a muscle.

At a sign, the current is stopped, the room is again made dark as night, and presently the visitor sees the sharply-defined black silhouette of the young man, with a beautiful halo of electricity in the background, formed by myriads of tongues of electric flame which are darting out from every quarter of the tall, thin frame. The place is lighted once more, and as the young man comes up to you and shakes your hand, you twist it about in the same fashion as you have seen people do who hold the handles of a strong electric battery. The young man is literally a human electric "live wire".

To tell of these and a thousand other wonders that Tesla does in a trice gives only a faint conception of their effect on the visitor. To really appreciate them one must see, hear, and feel them in the flesh. It is a scientific treat of a lifetime, but it is a treat that few can enjoy, for the laboratory of Tesla is securely locked

against everyone not provided with an introduction from a personal friend of the audacious wizard.

"Oh, pshaw! these are only a few play-things," Nikola Tesla replies when the visitor puts into words the astonishment he has experienced; "none of these amount to anything—they are of no value to the great world of science. But come over here and I will show you something that will make a big revolution in every business and home as soon as I am able to get the thing into working form," and then he leads the way through a forest of queer-looking discs and mysterious coils of copper and steel, until the party reaches a raised wall of masonry, on which reposes a long cylinder of glass filled with water, and surrounded by a circle of large mirrors. The roof over this apparatus is of glass, and as the sun pours its rays through this, the rays strike the mirrors and are reflected again towards the glass cylinder, magnifying glasses intensifying the heat of the rays before they strike the cylinder.

"This is the experimental model of the apparatus with which I hope some day to so harness the rays of the Sun that that heavenly body will operate every machine in our factories, propel every train and carriage in our streets, and do all the cooking in our homes, as well as furnish all the light that man may need by night as well as by day. It will, in short, replace all wood and coal as a producer of motive power and heat and electric lighting.

The plan of Nikola Tesla to harness the rays of the Sun to do man's bidding is probably the boldest engineering feat that he or anyone else has ever attempted. Though the idea is so great, its principle is so simple that a schoolboy can readily comprehend it. It consists of concentrating the heat of the Sun on one spot (the glass cylinder) by the series of complicated mirrors and magnifying glasses until the resulting heat is something terrific.

This manufactured heat is directed upon the cylinder filled with water. This water is chemically prepared so that in a short time the water has evaporated into steam and has passed from the cylinder through a pipe and into another chamber. In the latter place this Sun-made steam is made to operate a steam-engine of ordinary construction, the horse-power of which will be determined by the size of the apparatus by which the Sun generates steam in that spot. This steam-engine is used to generate electricity. And this electricity can be either used at once or else stored up in storage batteries to be used on days when there is no sunlight.

It will be seen that the object of this plan of Tesla is to do away with coal, wood, or other fuel, in the manufacture of steam. The remainder of his invention calls for the use of this Sun-made steam-pressure, as steam-pressure made from coal is at present in use, throughout the world. The advantage of this Tesla invention is that the cost of manufacturing steam to generate electricity, which would propel say one hundred tram cars, would be infinitely smaller than the cost of the coal required to produce the power to do the same work. The cost of manufacturing the electricity to operate these one hundred tram cars by the Tesla plan, when once the Sun station has been completed, would only be a sufficient amount to pay the salaries of a few engineers in charge of the Sun-station.

"In this way electricity will be so cheapened," says Mr. Tesla, "that it will be possible for the poorest factory-owner to use it as a power at a smaller cost than steam. Electricity will in this way supplant steam as a motive power on all railways and—in the shape of storage batteries—on all water vessels. And the humblest citizen will profit by the new system of producing electricity; for he can have it in his home to do all his cooking and lighting and heating. And it will be even cheaper for him than coal, wood, or petroleum."

It is, of course, not the intention of Mr. Tesla that one Sun-station will provide all the electricity for the whole world. His scheme is that in every city and town the local authorities shall build one or more of these Sun-stations by public taxation for the use of the whole population, just as these cities now have waterworks and gas plants. Each factory and home will then get its supply of electricity from the nearest Sun-station by ordinary electric wires.

Any person can appreciate the big boon that Tesla will confer on humanity by the early completion of this master task. Among other things it will solve a question that has been occupying the minds of scientific men for a long time, *viz*: As the supply of coal in the Earth will be exhausted in about a thousand years, what are we going to do for fuel? "It was when Tesla first thought about the question that he turned his mind to the invention of some form of making power that would not depend upon coal. The plan to harness the Sun's rays is the result.

Quite independent of his scheme to harness old Sol, but yet capable of cooperation with it, is Tesla's invention to transmit electrical power without the use of wires. This consists of a means of generating electricity in one spot, where it can be done with little cost, and transmitting the electricity to some other spot where it is impossible to generate electricity except at a big outlay of money.

Of course, it is now possible to transmit electrical power from one place to another by the use of electrical cables, but the cost of these transmitting cables is nearly as great as would be the cost of generating the electricity itself in the locality to which it is desired to transmit it. By the use of Tesla's invention, the atmosphere takes the place of the electrical cables in the transmission of the power, and as the use of the atmosphere would be free, the cost of the transmission of electricity from one city to another would be merely nominal.

To make the atmosphere take the part of the costly cables, Tesla's plan is to erect large power stations at every spot where a great waterfall like Niagara, for instance, makes the cost of generating electricity only trifling when the apparatus has once been constructed.

Above each of the stations Tesla wants to build a high tower, over which will be suspended a large balloon. As the electricity is generated in the station below it is conveyed by cables to the tower, and thence to the balloon, where the electricity is set free into the atmosphere. As the atmosphere at this height is much rarefied, and as Tesla has demonstrated rarefied atmosphere to be a good conductor of electricity, the electricity which is thus set free will be carried on by the atmosphere to any indefinite distance.

The second part of the Tesla plan for transmitting electrical power without wires calls for the erection of receiving stations wherever desired. These will act as sort of receivers and storage houses for the electricity set free into the atmosphere at the generating station miles away. Over each of the receiving stations will be put up a tower and a balloon, which will be equipped with the apparatus necessary to absorb the free electricity in the atmosphere and send it to the receiving station below, from which it can be sent out on wires to light the surrounding country and drive all the machinery of that particular district.

It will be observed that in this scheme Tesla depends on getting his electricity through the agency of the waterfalls, while in the previous scheme he depends upon the agency of the Sun for the same purpose. But the inventor is far from believing that the two schemes will conflict. He believes that when both inventions come into popular use they will work together for the common good of man. "The agency of waterfalls to generate electricity could be used when that agency is most convenient in view of natural conditions," says Tesla, "and the agency of the Sun could be used in all other cases. But my scheme of transmitting electrical

energy without wires can be applied with equally good results to both systems."

Of all the great inventions which Tesla has well on the way towards that point where they can be given to the world for every-day use, his wireless telegraphy invention is the furthest advanced. All that is necessary now is the formation of a company to put up the public station. The principle of this invention is almost too well known now to bear extended explanation. Briefly described, it consists of constructing an apparatus to stir up the electric currents in the Earth in such a way that their disturbance will be felt on a second apparatus fitted up in a different part of the world. Different disturbances of the electric currents produce correspondingly different impressions on the second apparatus—the receiver—and in this way an intelligible code is readily arranged.

For the benefit of non-scientific people the great inventor has described for me his wire-less telegraphy invention in the following words:

"Imagine you have on a table before you an immense rubber bag snugly filled with water. I take a rubber tube with a piston-rod in it and insert the tube into the rubber bag. When I press on the piston-rod I compress the water in the bag so that it expands the bag.

"When I withdraw the piston," continued Tesla, "the bag will shrink just so much as there is water drawn up into my tube; and now if I put a second tube with a piston-rod into the bag at the other end, at every pressure of the first piston-rod the effect will be felt and measured in the second tube. Now if a certain action of one piston-rod indicates a certain word or a certain sentence, if you watch the other piston-rod carefully you may easily read it. This is exactly what takes place in wireless telegraphy," concluded Tesla; "let the rubber bag stand for the Earth, the water for the electric currents in the Earth, and the two tubes and piston-rods for a sending oscillator and receiving oscillator. One sort of disturbance by one oscillator means a certain sentence, and when this particular disturbance is recorded on the second oscillator the operator there knows exactly how to interpret it."

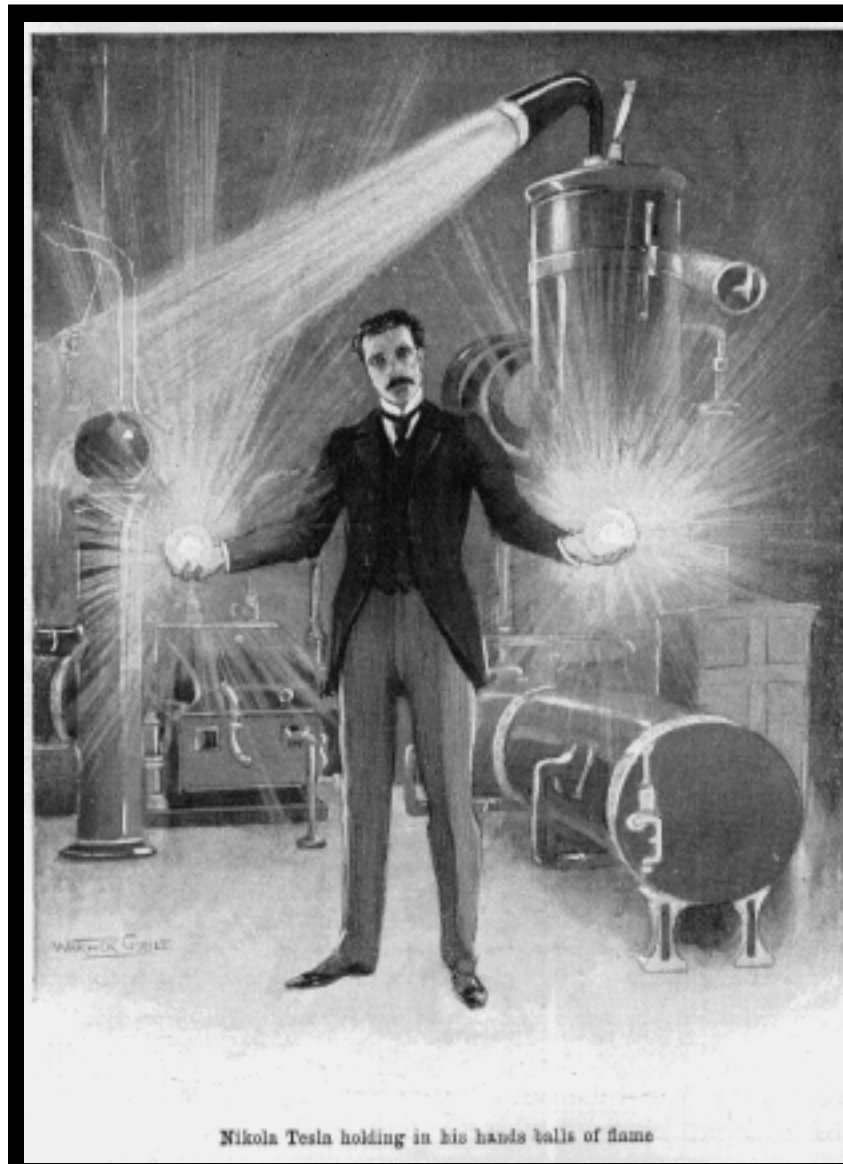
The "oscillators" to which the inventor refers are huge discs on which are insulated hundreds of coils of copper wire whose ends connect with the centre of the disc, where there is a huge round copper ball. They are really the only apparatus required for wireless telegraphy. To operate them Tesla simply turns the transmitting oscillator face downwards, and turns on a current which causes immense tongues of visible electric flashes to leap from the ball into the ground. The receiving oscillator has a delicate contrivance which throbs with each disturbance of the Earth's electric currents and records them on a specially contrived apparatus.

Not the least fascinating of Tesla's numerous inventions is one to which he has given the name of "visual telegraphy". With this apparatus one person has only to look into the receiver of an ordinary telephone in one city, and, while talking to a friend a thousand miles away, he can watch the expression on the other's face, criticise the cut of his new suit of clothing, or advise him what to do for that tired look about the eyes. In this invention the experimental apparatus has proved thoroughly successful. The principle of this invention is that just as much as sound-waves make an impression on the immediate atmosphere, so do light waves make their impression.

"Now, as sound waves of the human voice are transmitted miles and miles by the present telephone after their impression is made on the telephone transmitter," says Mr. Tesla, "just so my experiments

have demonstrated that the light waves of the human body can be transmitted by a different sort of telephone miles and miles away. All we need is the invention of a new transmitter. As the impressions of light waves are so many times more delicate than the impressions of sound waves, it follows that to transmit the impression of the human face, for instance, we require a transmitter many times more delicate. Now, selenium being an extremely sensitive substance, I have utilised this material in the construction of the transmitter which I have just described, and I have found it to be perfectly satisfactory."

To make our homes, our offices, and the streets at midnight as light as day, is another of the great tasks which Mr. Tesla set out for himself many years ago. His hope was to invent a new kind of electric light



which would have the strong, steady glow of sunlight.

That Tesla has succeeded in his dream to make artificial daylight there can be no doubt. To every visitor of his laboratory he shows numerous balls of glass of different sizes which look like miniature suns. The glass balls are perfectly empty, there are no wires in them, nor are there any wires on the outside of them. They do not burn the fingers when they are touched. The light does not hurt the eyes as sunlight and ordinary electric light do.

By the time this article is published, a number of the leading New York and Chicago photographers will have their studios supplied with the new artificial daylight.

"The reason I have chosen to introduce the new daylight to the photographers first," says the inventor, "is that I believe them to be the severest critics, and most hard to please in the matter of light. If it succeeds with them, a new light will succeed everywhere."

Not the least ingenious of Tesla's great schemes is his invention to fertilise impoverished land by electricity. When Tesla has a company formed to put

this invention on the market it will no longer be necessary for the farmer to spend half his year's receipts in purchasing fertilisers. He has only to buy an electric fertiliser of his own, which he can secure for a trifle at the nearest town.

Dumping a few loads of loose earth into the fertiliser, it comes out at the other end, ready to be spread over the surface of the impoverished ground, where it will insure for the following season the luxurious crop of the virgin soil.

The explanation which Mr. Tesla gives of just why so simple a piece of work should be productive of such wonderful results is not difficult to comprehend. "Everyone knows," says he, "that the constituent of a fertiliser which makes the ground productive is its nitrogen. Everybody knows also that nitrogen forms four-fifths of the volume of the atmosphere above that piece of unfertile land. This being the case it occurred to me: 'Where is the sense in the farmer buying expensive nitrogen when he has it free of cost at his own door? All the agriculturist needs is some method by which he can separate some of this nitrogen from the atmosphere above the ground and place it on the surface.' And it was to discover this means that I set to work."

As far as the non-technical eye can perceive, the working model of the electric fertiliser consists of nothing but an upright copper cylinder with a removable top, with a spiral coil of wire running throughout the length of the cylinder. Through the bottom of the cylinder are two wires, which connect with a specially constructed dynamo. A quantity of loose earth, treated by a secret chemical preparation in liquid form, is shovelled into the cylinder, an electric current is passed through the confined atmosphere; the oxygen and hydrogen are thus expelled, and the nitrogen which remains is absorbed into the loose earth. There is thus produced as strong a fertiliser for a nominal price at home as it is possible to purchase at a large cost miles and miles away.

Mention is made in this paper of only those inventions of Mr. Tesla which have passed beyond the experimental stage. But there are hundreds of other promised wonders in the yet incipient stage of development in the great inventor's miracle-factory. As I have heard one of his admirers express it, an enumeration of these "sounds like the dream of a half-intoxicated god". Signalling to other planets, raising of certain of the dead by electricity, ending all wars by a terrible machine—these are a few suggestions selected at random.

Nikola Tesla is a young man yet, and on this account many of his promises have been looked upon by older scientists as but fanciful dreams of a youthful mind. He has scarcely ever made any invention which the scientific world has accepted as possible on the first public announcement. But sooner or later the scientific wisecracks have been compelled to admit that Tesla has proven their theories to be wrong.

How these conservative scientists sneered at Tesla's "Utopian audacity" when he first suggested that man should harness the great Niagara Falls! But they humbled their pride sufficiently to be present when the enterprise was formally completed. Again, when he announced the invention of the "Tesla coil" they set him down as "pipe-dreamer". But a few of the brightest of them set to work seriously on the "coil" with the result that one of them—Rontgen—discovered his famous X-Rays. No one who is privileged to know Tesla personally, to have heard him explain his plans, and to have been shown through his unique workshop, has the slightest doubt that every one of his promises will be fulfilled in an equally successful way.

Final Warning: Part 12c

Here is another great confirmation of something Commander Hatonn said in the early 1990s which rubbed on a lot of people, who "knew better". He said that the United States was part of OPEC!

Again, those who wanted to walk away from the truth used this statement as their "reason", without trying to understand what was being said.

As we see in this installment of David Allen Rivera's Final Warning: A History of the New World Order, OPEC is an organization of COMPANIES, not of nations, and the United States, in the form of Bush, Rockefeller and companies, was most certainly, heavily involved in it.

The POINT was that the OPEC oil embargo of the 1970s should never have been referred to as the "ARAB oil embargo".

We continue with our series, taking up with "The Seven Sisters" (NOT celestially speaking, of course, as this is just another usurpation of a goodly term). Part 12c finishes Chapter Eight.

THE SEVEN SISTERS

One oil cartel is the Organization of Petroleum Exporting Countries, known as OPEC, which is made up of Iran, Iraq, Venezuela, Kuwait, Saudi Arabia, Algeria, Indonesia, Libya, Nigeria, Qatar and the United Arab Emirates [not to mention the largest oil companies]. The group was created on September 14, 1960 for the purpose of setting oil prices by controlling oil production. They were originally thought to be primarily Arabian in ownership; however, it is actually an international group, which includes Americans. The cartel was established from an agreement signed on September 17, 1920 by Royal Dutch Shell, Anglo-Iranian and Standard Oil for the purpose of fixing oil prices. By 1949, the cartel was made up of Anglo-Iranian, Socony-Vacuum, Royal Dutch Shell, Gulf, Esso, Texaco and Calso. In the early 1950s, revelations surfaced that the oil companies would pump the oil from the Middle East, then split the profits with the government of the country where the oil was produced. **OPEC was formed to make people believe that the Arabian oil reserves were not owned by non-Arabian oil companies.**

Those non-Arabian oil companies are another cartel, which had been informally called "The Seven Sisters" [which] control what is shipped to the United States and how much is refined into gas and heating oil. Originally, it was made up of the Rockefeller-controlled Exxon (previously known as Standard Oil of New Jersey, or Esso), Mobil (Socony or Standard Oil of New York, which merged with Vacuum Oil), and Chevron (Socal or Standard Oil of California); the Mellon's Gulf Oil; Shell (Royal Dutch Petroleum), Texaco and British Petroleum (Anglo-Iranian). They controlled 90% of crude exports to world markets by controlling every important pipeline in the world, such as the 753-mile TransArabian Pipeline from Qaisuma in Saudi Arabia to the Mediterranean Sea, which was owned by Exxon, Chevron, Texaco and Mobil. Exxon owned the 100-mile Interprovincial Pipeline in Canada; and also the 143-mile pipeline in Venezuela. The 799-mile Alaskan Pipeline was owned by British Petroleum and Exxon. By controlling these and other vital arteries, they can restrict the flow of oil, limiting supplies to refineries.

You could also see their link, through the joint ownership of the major crude oil production companies:

The Sisters were also interlocked with eight of the largest banks in the country and with each other: Exxon had ties to Mobil, Chevron and Texaco; and Mobil had ties to Exxon, Shell and Texaco. **When six of the nation's major commercial banks held their Executive Board meetings, the directors of the top eight oil companies, with the exception of Gulf and Chevron, met with them.** When the Bank of America had a Board meeting, the directors of Chevron and Getty Oil met with them. Chevron also had ties with Western Bancorp. Shell and Mobil directors were present at the Board meetings of First National City Bank. Mobil also had ties with Bankers Trust and Chemical Bank. Exxon was tied in with the Chase Manhattan Bank (a holding company for hundreds of smaller oil companies, including Humble Oil and Creole Petroleum), Morgan Guaranty and Chemical Bank. Amoco (Standard Oil of Indiana) was tied in with Chase Manhattan, Continental Illinois and National Bank and Trust.

Some of the oil executives who were members of the Council on Foreign Relations: Lawrence G. Rawl (Chairman of Exxon); Lee R. Raymond (President of Exxon and Trilateral Commission member); Jack G. Clark, Sr. (Vice President of Exxon); Alfred C. Decrane, Jr. (Chairman of Texaco); John Brademas (a Director of Texaco and Trilateral Commission member); William J. Crowe, Jr. (a Director of Texaco and Trilateral Commission member); Allan E. Murray (Chairman & President of Mobil, and Trilateral Commission member); Lewis M. Branscomb (a Director of Mobil); and Helene L. Kaplan (a Director of Mobil).

The Seven Sisters also controlled 70% of the U.S. coal supply, which during World War II the Germans used to make pollution-free synthetic fuel. Their philosophy was "to mine it now, it's coal; to mine it later, it will be like gold."

These seven companies announced their alliance with the statement: "We have formed a very exclusive club ... And we are now united. We are making history." Remember, in 1914, Congress referred to Standard Oil as "the invisible government". The oil companies are powerful and their power was never more apparent than it was during the manufactured crisis of 1973.

On October 6, 1973, as synagogues in Israel observed *Yom Kippur*, the Jewish Day of Atonement, Syrian MiG-21s attacked a group of Israeli jets. Egypt, Syria, Jordan and eight other Arab nations had mobilized against Israel. Egypt attacked the Sinai Peninsula with 4,000 tanks, knocking out many Israeli tanks; while Syria attacked the Golan Heights with 1,200. New Soviet-made SAM-6 missiles plucked Israeli planes out of the sky with ease. However, within a few days, the tide was turned. Israel regained control of the Heights and took a large part of Syria. On October 12, they were only 18 miles from Damascus. With 12,000 soldiers and 200 tanks, they swept across the Suez Canal in two directions to surround the Egyptian Third Army, which had been caught on the east side, and came within 12 miles of Cairo.

Since the first day of the war, Russia had been airlifting supplies to the Arabs, so to counter that move, the United States said they intended to supply Israel "with whatever it needs". Once Israel began smashing their way to victory, Russia sent a Naval force of 71 ships, including 16 submarines, to the Mediterranean, and put their seven airborne divisions on full alert.

On October 12th, the Chairmen of Exxon, Texaco, Mobil and Chevron (who made up the production company of Aramco in Saudi Arabia), sent Chief of Staff Gen. Alexander Haig (who later became Reagan's Secretary of State) a memo warning against any increased aid to Israel by saying it would "have a critical and adverse effect on our relations with the moderate Arab producing countries". On October 17th, Omar Saqqaf, the Foreign Minister of Saudi Arabia, gave President Nixon a letter from King Faisal, which said that if the U.S. did not discontinue their shipment of military supplies to Israel within two days, there would be an embargo. Nixon stated that he was committed to supporting Israel. The U.S. Sixth Fleet of 49 ships, including 2 aircraft carriers, was sent to the Mediterranean, where they maintained a state of combat readiness.

OPEC met and decided to raise the price of oil to \$5.12 a barrel, which was 70% higher than they had agreed to before the Arab-Israeli War. The next day, the Arab countries met and decided to cut oil production by 5%; however, the Saudis later decided to cut back production by more than 20% and by October 20th, had embargoed all oil shipments to the U.S. and countries that were partial to Israel.

As the Israeli counterattack continued, Egypt and Syria were in serious trouble and Russia urged the UN to call a ceasefire. Jim Akins, the ambassador to Saudi Arabia sent a message to Aramco that the oil embargo would not be lifted "unless the political struggle is settled in a manner satisfactory to the Arabs". Two days later, the Saudis requested from the Aramco directors information concerning the amount of oil used by

the U.S. military, which they supplied. The Saudis then instructed them to stop all supplies to the military. In December, OPEC announced a price of \$11.65 a barrel and the result was economic chaos in the United States and Western Europe.

Though Aramco claimed that they had no choice in what they did and that they weren't acting as agents of a foreign government against the United States, the cry went out that the oil industry was putting "profits before patriotism". Before the embargo, America was importing 1.2 million barrels oil a day; and by February, only 18,000 barrels, which was a drop of 98%. The rush was on to reallocate other sources of oil (Venezuela and Iran had not joined the boycott) and to distribute it throughout the world. The global emphasis of the American oil companies [was] revealed when they refused to favor the U.S. at the expense of the other countries, causing us to lose a higher percentage of the available oil supply.

In Egypt, Sadat's terms for a ceasefire [included] that Israel had to withdraw from all territories that it had won during the 1967 war; thus pressure from the United States and the Soviets forced Israel to turn ... victory into a negotiated compromise.

To add insult to injury, when the winter was at its worst during the shortage, the announcement that oil companies were experiencing record profits left a very sour taste in the mouths of Americans. Exxon announced that their third quarter profits were up 80% over the previous year, while Gulf was up 91%. Exxon ended up the year with a profit that was an all-time record for any company, in any industry.

By March 1974, the embargo was lifted from the U.S. and the oil companies scrambled to salvage their shattered reputations. However, the incident would never be forgotten, because it shocked the American people back to the reality of just how much control a foreign government and multinational corporations could exert over our nation. The price of oil never went down to ... pre-embargo levels and the threat of another shortage would always remain as the Arabs [OPEC, as pointed out previously, comprises far more than "Arabs"] realized that they could achieve political leverage by using oil to blackmail the world.

There have been many changes in the oil industry since the inception of the Seven Sisters. In 1984, Chevron (Standard Oil of California) bought and merged with Gulf Oil; and then in 2001, merged with Texaco (who in 1984 had bought Getty Oil) to become Chevron-Texaco, the 2nd largest oil company in the country and 5th largest in the world. In 2002, Shell Oil acquired a couple of Texaco's interests. In 1998, Exxon (Esso, Standard Oil of New Jersey) merged with Mobil (Socony, Standard Oil of New York) to become Exxon-Mobil, the biggest oil company in the country and third largest company in the U.S. In 1987 British Petroleum purchased the remaining 45% of Sohio (Standard Oil of Ohio) that they didn't already own, then in 1998, merged with Amoco (Standard Oil of Indiana) and in 2000 merged with Arco (Atlantic Richfield).

The Seven Sisters are now the Four Sisters, so what you have now is an expanded amount of power and influence that is concentrated in less hands, as oil companies have sought to consolidate their interests because of economic concerns. It's uncanny in that it has happened in less than 20 years. It's almost as if the old Standard Oil Company was coming back together. In 2001, Conoco (Continental Oil) and Phillips Petroleum (Phillips 66) merged to make Conoco-Phillips, the 3rd largest oil company, the 12th largest company, and the 6th largest oil company in the world. If this trend continues, it will make it all the more easier [sic] for oil companies to manipulate and control a crucial commodity like gasoline and oil.

CLUB OF ROME

This think-tank of Anglo-American financiers, scientists, economists, politicians, heads of state and industrialists from ten different countries met in April 1968 at Rockefeller's private estate in Bellagio, Italy at the request of Aurelio Peccei, the Italian industrialist who had close ties to Fiat and the Olivetti Corporation. He claimed to have solutions for world peace and prosperity, which could be accomplished through world government. The Club of Rome (COR) was established with a membership of 75 prominent scientists, industrialists and economists from 25 countries, which along with the Bilderbergers have become one of the most important foreign policy arms of the Roundtable group.

Many of the COR executives were drawn from NATO and they have been able to formulate a lot of what NATO claims are its policies. Through Lord Carrington they were able to split NATO into two factions, a left-wing political group (whose doctrine was formed on the basis of Peccei's book *Human Quality*) and its former military alliance.

The first Club of Rome conference in the U.S. was in 1969, where the American branch was organized as the "American Association of the Club of Rome". Among its members were: Norman Cousins (honorary Chairman of Planetary Citizens), John Naisbitt (author of *Megatrends*), Amory Lovins (a speaker at Windstar, John Denver's New Age center in Snowmass, Colorado), Betty Friedan (founding President of NOW, the National Organization of Women), Jean Houston and Hazel Henderson (New Age authors and speakers), Robert O. Anderson and Harlan B. Cleveland (CFR members and part of the Aspen Institute for Humanistic Studies), Sen. Claiborne Pell (D-RI) and Rep. Frank M. Potter (staff director of the House Subcommittee on Energy).

Their first book, called *The Limits to Growth*, was published in 1972 and described their vision for the world:

"We believe in fact that the need will quickly become evident for social innovation to match technical change, for radical reform of the institutions and political processes at all levels, including the highest, that of world polity. And since intellectual enlightenment is without effect if it is not also political, The Club of Rome also will encourage the creation of a world forum where statesmen, policymakers and scientists can discuss the dangers and hopes for the future global system without the constraints of formal intergovernmental negotiation."

For the most part, the Club (main office at 193 Rissener Landstr. in Hamburg, Germany) functions as a research institute on economic, political and social problems, and claims that "there is no other viable alternative to the future survival of civilization than a new global community under a common leadership." Their website claims:

"The Club of Rome's mission is to act as a global catalyst of change that is free of any political, ideological or business interest. The Club of Rome contributes to the solution of what it calls the world *problematique*, the complex set of the most crucial problems—political, social, economic, technological, environmental, psychological and cultural—facing humanity. It does so taking a global, long-term and interdisciplinary prospective aware of the increasing interdependence of nations and the globalization of problems that pose predicaments beyond the capacity of individual countries."

It almost sounds like the Club of Rome is the A-Team of internationalist groups. Just like how the proposals suggested by the Bilderbergers seem to gain acceptance, we have to worry that the same thing will happen with the COR.

On September 17, 1973, they released a Report called the "Regionalized and Adaptive Model of the Global World System", which was prepared by Directors Mihajlo Mesarovic and Eduard Pestel (part of the "Strategy for Survival Project"), which revealed the Club's goal of dividing the world into ten political/economic regions (which have been equated to the 10 "Kingdoms" of Bible prophecy), which would unite the entire world under a single form of government. These regions are: North America, Western Europe, Eastern Europe, Japan, Rest of Developed World, Latin America, Middle East, Rest of Africa, South and Southeast Asia, and China. The same plan was published in a Club of Rome book called *Mankind at the Turning Point*, which said: "The solution of these crises can be developed only in a global context with full and explicit recognition of the emerging world system and on a long-term basis. This would necessitate, among other changes, a new world economic order and a global resources allocation system ..."

In 1976, they published *RIO: Reshaping the International Order*, which called for a new international order, including an economic redistribution of wealth.

Howard T. Odum, a marine biologist at the University of Florida, who is a member of the Club of Rome, was quoted in the August 1980 edition of *Fusion* magazine as saying: "It is necessary that the United States cut its population by two-thirds within the next 50 years." He didn't say how this would be accomplished. Their 1972 book, *The Limits to Growth* (which sold 12 million copies in 27 languages), dealt with the problem of worldwide overpopulation and stated that "if the world's consumption patterns and population growth continued at the same high rates of the time, the earth would strike its limits within a century."

During the Carter Administration, a task force was appointed to expand upon this report and on July 24, 1980, a two-volume document called *Global 2000 Report*, which had been written by former Secretary of State Cyrus R. Vance, was presented to President Carter and then Secretary of State Edmund S. Muskie. It attempted to project global economic trends for the next twenty years and indicated that the resources of the planet were not sufficient enough to support the expected dramatic increase in the world population. **The report called for the population of the U.S. to be reduced by 100 million people by the year 2050.**

About six months later, the Council on Environmental Quality made recommendations based on the Report, called "Global Future: A Time to Act". They suggested an aggressive program of population control which included sterilization, contraception and abortion. In August 1982, the *Executive Intelligence Review* published a report called *Global 2000: Blueprint for Genocide* which said that the two aforementioned Presidential reports "are correctly understood as political statements of intent—the intent on the part of such policy centers as the Council on Foreign Relations, the Trilateral Commission and the International Monetary Fund, to pursue policies that will result not only in the death of the 120 million cited in the reports, but in the death of upwards of two billion people by the year 2000."

Peccei wrote (based on a report by COR member Harland Cleveland, U.S. Ambassador to NATO, who believed that Third World countries should decide for themselves who should be eliminated):

"Damaged by conflicting policies of three major countries and blocs, roughly patched up here and there, the existing international economic order is visibly coming apart at the seams ... The prospect of

the necessity of the recourse to triage deciding who must be saved is a very grim one indeed. But if, lamentably, events should come to such a pass, the right to make such decisions cannot be left to just a few nations because it would lend themselves to ominous power over life of the world's hungry."

Throughout the world, **the Club of Rome has indicated that genocide should be used to eliminate people whom they refer to as "useless eaters".**

This would be accomplished by using limited wars in advanced countries, and even a limited nuclear strike at a strategic location; as well as starvation through created famines and diseases in Third World countries.

In the 1976 novel *Ceremony of the Innocent* by Taylor Caldwell, she effectively explains the rationale behind their actions: "... there will be no peace in the tormented world, only a programmed and systematic series of wars and calamities—until the plotters have gained their objective: an exhausted world willing to submit to a planned Marxist economy and total and meek enslavement—in the name of peace."

Have their plans for genocide already started? AIDS (Acquired Immunodeficiency Syndrome) has become a plague in our society, spreading to 91 nations. In the early 1990s the *U.S. News and World Report* stated: "If there is not a cure for AIDS within the next thirteen years, tens of millions will die." Even though there has been a lot of talk about AIDS awareness and prevention, the full danger of it has been covered up by the Center for Disease Control and the media, which has increasingly shown its pro-homosexual bias.

In 1969, at a House Appropriations hearing, the Defense Department's Biological Warfare unit requested funds to develop, through gene-splicing, a new disease that would be resistant to treatment and break down a victim's immune system. They received \$10 million (H.B. 15090), to produce "a synthetic biological agent, an agent that does not naturally exist and for which no natural immunity could have been acquired".

In the 1972 Bulletin of the UN's World Health Organization (WHO), volume 47, page 251, it says: "An attempt should be made to see if viruses can in fact exert selective effects on immune function. The possibility should be looked into that the immune response to the virus itself may be impaired if the inflicting virus damages, more or less selectively, the cell responding to the virus." This sounds like the AIDS virus, so why is it being discussed by a health organization?

Derivatives from sheep and cattle have been commonly used to manufacture vaccines; however, certain viruses common to these animals can interact indefinitely, forming a new strain of deadly viruses called retro-viruses. In 1974, the National Academy of Sciences recommended that "Scientists throughout the world join with members of this committee in voluntarily deferring experiments (linking) animal viruses." Dr. Robert Strecker, a practicing gastroenterologist with a Ph.D. in pharmacology, who was hired as a consultant to work on a health-care proposal for Security Pacific Bank, said: "I don't think there is any doubt that AIDS is a man-made problem. The question is whether it was made either accidentally or intentionally. I believe the AIDS virus was requested, predicted, produced and deployed."

The most common theory about the origin of AIDS was that it came from green monkeys in Africa. Yet several virologists have said that the AIDS virus does not occur naturally in any animal. Besides, it would have been statistically impossible to reach the point we are at now, just from a single episode. If the AIDS virus had originated with the monkeys, then the

disease would have surfaced with the Pygmies, who are closer to them, and used them as a food source; yet, it appeared first in the cities. Further damaging evidence comes from the fact that AIDS practically occurred simultaneously in the United States, Haiti, Brazil and Central Africa.

Strecker's research indicated that the AIDS virus (code-named 'MKNAOMI') was developed by the Frederick Cancer Research Facility of the National Cancer Institute in cooperation with the WHO, in their laboratories at Fort Detrick, Maryland (which until 1969 was part of the U.S. Army's germ warfare unit, known as the Army Infectious Disease Unit, or Special Operations Division); by combining bovine (cow) leukemia virus and *visna* (sheep) virus, and injecting them into human tissue cultures. The bovine leukemia virus is lethal to cows, but not to humans; and the *visna* virus is deadly to sheep, but not to man. However, when combined, they produce a retro-virus that can change the genetic composition of the cells that they enter. He said:

"If one analyzes the genes of the human AIDS virus and the genes of the bovine leukemia virus of cattle and the *visna* virus of sheep, and compares them, the genes appear related. How is it possible that the bovine *visna* virus—which looks like AIDS and produces an AIDS-like disease, and which produced *pneumocystis carinii* pneumonia in chimpanzees in 1972—has not been analyzed and compared with AIDS ... until 1987 when 'Characterization and Molecular Cloning of Bovine *Lente* (Latin for 'slow') Virus Related to Human Immunodeficiency Virus' was published in *Nature* magazine. Matthew Gonda, the author, described a virus that looks like AIDS, named bovine *visna* virus, and suggested that it was most closely related to AIDS and may well be its precursor."

On August 11, 1988, Ted Strecker, Dr. Strecker's brother, was found shot to death in his home in Springfield, Missouri. His death was ruled a suicide. On September 22, 1988, Illinois State Representative Douglas Huff of Chicago was found dead in his home. The autopsy revealed that he died of a stroke as a result of an overdose of cocaine and heroin. Rep. Huff just happened to be a very vocal supporter of Dr. Strecker's work to publicize the AIDS cover-up. Coincidence or conspiracy?

There was a vaccination program for Smallpox in Africa by the WHO. Some researchers believe that the Smallpox vaccination program in 1972 was used to introduce the virus into the population. On May 11, 1987, the *London Times* ran an article called "Smallpox Vaccine 'Triggered AIDS Virus'", written by Science Editor Pearce Wright, who linked the mass vaccination program of the World Health Organization in the 1970s to the outbreak of AIDS because Central Africa was the focus of the program, and they have become the most affected area in the world.

Though in Africa AIDS is generally regarded as a heterosexual disease, in the United States it has the stigma of being a 'gay' disease. Prior to 1978, there was no sign of the AIDS virus here; yet in 1978, the killer disease struck with a vengeance within the homosexual community. The evidence points to the introduction of an experimental Hepatitis B vaccine. In 1969, Dr. W. Schmugner, a Polish physician, who was educated in Russia, came to the United States, where he became head of the New York City Blood Bank. He set up guidelines for a Hepatitis vaccine study and only promiscuous males between the ages of 20 and 40 were included in the study, which has led some to believe that this was how the virus was introduced into the gay population.

In 1978, more than 1,000 non-monogamous gay adult males received an experimental vaccination

against Hepatitis B, which was sponsored by the National Institute of Health and the Center for Disease Control. With the Hepatitis vaccine, which is not produced from a human tissue culture, it is impossible to have an accidental contamination, which seems to indicate that the AIDS virus was intentionally put in the vaccine. In 1981, the Center for Disease Control reported that 6% of those receiving the Hepatitis vaccine were infected with AIDS, but in 1984, they admitted that it was actually 64%. These Hepatitis vaccine studies are now in the possession of the Justice Department in Washington, DC.

To allow the disease to become entrenched within the population, various facts were covered-up and glossed-over. A great deal of emphasis had been put on the prime cause of AIDS infection, being the exchange of body fluid through sexual activity and intravenous drug use, which has brought a campaign for the importance of using clean, unused needles and condoms. The use of a condom does not guarantee protection against the transmission of the AIDS virus. All it takes is one AIDS *virion* (a complete virus particle with its outer coat intact) and the smallest sperm [*Ed: this looks like a mis-speaking; should be the smallest pore in latex rubber, perhaps?*] is 500 times larger than one such *virion*. In addition, the quality of condoms [has] become highly suspect, since failure rates of 30-50% have been reported.

The risk of casual contact has been played down when in fact AIDS is a highly contagious disease which demands that a quarantine be placed on those who suffer from the disease. **Rather than treat the disease as the epidemic it is, the government has concerned itself with giving AIDS carriers more rights and more exposure to the general population.** There is concrete medical evidence that indicates that the virus can survive up to 7 days on a dry petri dish and up to 15 days in an aqueous (wet) environment. This raises the question, what would happen if an AIDS carrier would sneeze into a punch bowl or a salad bowl. It can incubate 10-15 years before causing any noticeable signs of illness, which means that sexual relations [expose] you to every sexual contact your partner has had in that period of time.

A February 1985 report in the British medical journal *Lancet* said: "There is little evidence for homosexual activity among African AIDS patients (and it) appears to be transmitted through heterosexual contact or exposure to blood through insect bites ...". On September 9, 1985, a research team of researchers from the National Cancer Institute, the Laboratory of Tumor Cell Biology and the Institute of Tropical Medicine said that "human retroviruses could be transmitted by mosquitoes or within the parasite itself." **In a report published in the October 1981 issue of *Science*, Boston hematologist Dr. Jerome Groopman and researchers with the National Institute of Health said that recovery of the AIDS virus "from saliva suggests that direct contact with this body fluid should be avoided ..."**

On January 11, 1985, the Center for Disease Control reported: "There is a risk of infecting others by ... exposure of others through oral-genital contact or intimate kissing ('french' kissing)." Dr. Richard Restak, a Washington neurologist, made this statement:

"At this point live AIDS virus has been isolated from blood, semen, serum, saliva, urine and now tears. If the virus exists in these fluids, the better part of wisdom dictates that we assume the possibility that it can also be transmitted by these routes. It seems reasonable, therefore, that AIDS victims should not donate blood or blood products, should not

contribute to semen banks, should not donate tissues or organs to organ banks, should not work as dental or medical technicians, and should probably not be employed as food handlers.”

Professor William Haseltine of the Harvard Medical School, in a presentation to a University audience, said that anyone “who tells you categorically that AIDS is not contracted by saliva is not telling you the truth. AIDS may in fact be transmissible by tears, saliva, bodily fluids and mosquito bites.”

AIDS is an epidemic that will not be stopped. The scientists that created this deadly virus have created a virus that multiplies 100 times faster than influenza. There are more than 180 different AIDS viruses and 300 strains, which makes blood testing meaningless. The virus is constantly mutating, which makes it impossible to develop a general vaccine that would be effective with everyone. Quite simply, AIDS is a world-wide, modern-day plague, and every year the number of those affected increases drastically. In the March 1987 issue of *Vanity Fair*, Dr. William Grace, chief of Oncology at St. Vincent’s Hospital in New York, is quoted as saying: “I think AIDS is going to devastate the American medical system.” Besides not being able to combat it medically, the disease will progress to being an economic drain, especially if national health care is instituted.”

If its purpose was to glean out the population, it certainly will be successful. It must be assumed that the progenitors of this disease must have a measure of protection to prevent themselves from being exposed. The elite have already segregated themselves from the general population by virtue of their position, so from that aspect, there is little risk from being contaminated. In the event of medical treatment, they have access to the best medical treatment that money can buy and most likely possess a private, untainted blood supply. Somehow, I just can’t help thinking that when their goal of limits to the population have been reached, how will they end the scourge which they have placed upon the earth. Just as the saying goes, that a lawyer in court doesn’t ask the witness a question that he doesn’t already have the answer for; the same reasoning would seem to apply here, that the Illuminati would not unleash a disease that they didn’t already have a cure for.

Bro. R. G. Stair, a well-known radio evangelist, had received an anonymous letter which seemed to confirm this theory. The writer claimed to be a molecular biologist who worked in the same laboratory with Dr. Robert C. Gallo (the molecular biologist noted for his involvement in the co-discovery of the AIDS virus). The writer claimed that there is an AIDS vaccine that is now available and that 500,000,000 doses have been produced and [are] now available. Now the bombshell. The writer accidentally discovered that Gallo had actually created the AIDS virus and found a couple letters in his office from high government officials which mentioned the New World Order.

In 1961, in a Litton Bionetics laboratory (... working with the Navy’s Biomedical Research Laboratory in association with the University of California), retroviral experiments with African Green Monkeys and Human T-Cell Leukemia were being conducted under the auspices of the National Institute of Health (contract # SVCP PR#8 NIH #71-2025). It consisted of taking monkey viruses that were harmless to humans, recombined them with DNA, RNA and enzymes from other animal viruses that were known to cause leukemias, lymphomas and sarcomas; then got them to jump species and cultured the new mutant viruses into human white blood cells in some studies, and in other studies—human fetal

tissues, which produced an “immune-system destroying, cancer-causing viruses” for which “no natural immunity could have been acquired, and no cure exists”. The scientist who was directing the tests was Dr. Robert Gallo.

In 1975, Gallo and eight other scientists (working at the Bethesda Cancer Research Center in Maryland) had been working to modify the genetic structure of the virus so that it can be more easily transmitted. That same year, after Fort Detrick had become demilitarized, the newly established Frederick Cancer Research Facility was placed under the direction of the Bethesda Cancer Research Center, where Gallo was the Director. One investigation revealed that in March 1976, a special federal government virus development program began producing the AIDS virus and it was headed by Dr. Gallo and Dr. Novakhatskiy of the Ivanosku Institute in Russia. Gallo would later be investigated and found guilty of scientific misconduct, but President Clinton pardoned him.

In response to the charges that AIDS was developed as a military biological warfare weapon, in February 1987, Army Col. David Huxsoll said: “Studies at army laboratories have shown that the AIDS virus would be an extremely poor biological warfare agent.” He later denied saying it.

Whether AIDS is the vehicle of elimination that the Club of Rome has referred to, or a precursor, just like Gulf War Syndrome, Ebola and SARS, is undoubtedly open to speculation, even in light of all the questions raised. However, you can’t deny how neatly this little piece of the puzzle fits into the entire picture of preparing the world for a one-world government.

INDEPENDENT COMMISSION ON INTERNATIONAL DEVELOPMENT ISSUES

The Toronto *Globe and Mail*, on April 7, 1980, reported the story of a conference to be hosted by Canadian Prime Minister Trudeau that fall, which would “reshape global structures”. The Summit, known as the “North-South Dialogue”, which would “make recommendations on ways of breaking through existing international political impasse in North-South negotiations for global development”, was sponsored by the Independent Commission on International Development Issues and was to include President Jimmy Carter, *Newsweek* and *Washington Post* publisher Kathryn Graham, Robert McNamara, former British Prime Minister Edward Heath and West German Chancellor Helmut Schmidt.

On January 14, 1977, Robert McNamara, President of the World Bank, proposed the establishment of an international commission of politicians and economists who would meet, not as government representatives, but independently to discuss “basic proposals on which global agreement is both essential and possible”. Willy Brandt, the former West German Chancellor, was asked to chair the commission.

On September 28, 1977, Brandt announced his intention to launch the Independent Commission on International Development Issues, and said that it “would not interfere with

ongoing international negotiations, and would make recommendations to help improve the climate of North-South relations”. Brandt wanted the Commission, consisting of 18 members, to represent many views and to be politically and regionally balanced with a majority coming from developed countries. Their initial meeting was in December 1977.

There [were] two phases to what is more commonly referred to as Brandt’s Commission. The funding for the first (\$750,000) in 1980, producing *North-South: A Program for Survival*, was provided by the Dutch Government, as well as Denmark, Finland, India, Japan, Republic of Korea, Norway, Saudi Arabia, Sweden, United Kingdom, the Commission of the European Communities, OPEC Special Fund, German Marshall Fund of the United States, the Ford Foundation, Friedrich-Ebert and Friedrich-Naumann Foundations of the Federal Republic of Germany, and the International Development Research Center of Canada.

Subsequent funding was provided by the governments of Denmark, the Netherlands, Norway, Sweden, United Kingdom and the OPEC Special Fund.

The funding for the second phase (\$350,000), which produced the 1983 report *Common Crisis: North-South Cooperation for World Recovery*, came from the governments of Canada, the Federal Republic of Germany, the Netherlands, Kuwait, the Commission of the European Communities and the German Marshall Fund of the United States.

In short, the Brandt Reports “called for a full-scale restructuring of the global economy” and the purpose of the Commission was “to influence public opinion to help change government attitudes, as well as to make proposals for revitalizing North-South negotiations”.

In the 380-page report called *North-South*, which called for the “instant” redistribution of wealth from the richer to poorer nations and a stepping up of world disarmament. They wanted “greater power for the International Monetary Fund and the World Bank”. Their rationale was that the “transfer of wealth must be tackled, not out of charity, but to ward off economic collapse ... Hence, the global super summit now. Worldwide security is not achieved by granting more aid but by reshaping global structures, by greater regionalized planning and development.” **In *Common Crisis* they recommended that a supernational authority be established to regulate world commerce and industry, international currency and an international police force under the direction of the UN Security Council.**

Budget's "Tip of the Week" #14:

Maintaining Separation between the Corporation and Yourself

When properly handled, a corporation is a legal "person", separate, distinct and totally apart from you. The key to keeping things that way is to ensure that the corporation is indeed properly treated. The quickest way to lose the protection afforded by your corporate shelter is for you to treat it with disrespect.

One simple thing that many people fail to do on a regular basis—and which can tear down the walls of separation between themselves and a corporation—occurs when they sign documents in behalf of their "brainless child" (corporation). All it takes to do things right is to follow the signature with an indication that you are acting as an agent or officer of the corporation rather than in a personal capacity. If you are acting as a particular officer, as the vice president, for example—follow your signature with, "Vice President" or "VP". In cases where you would rather not disclose any particular position held within the corporation you may sign as "John Doe, Agent", which simply means that you are acting as an agent for the corporation and NOT in a personal capacity.

The above advice applies to ALL situations where you might sign for the corporation, including checks, of course, but also when signing such mundane things as invoices for goods received or services performed. And it certainly applies to any kind of agreement—a lease, purchase or rental agreement, for instance—as well as corporate resolutions. After a while you will find that you do this automatically and thus automatically uphold the fundamental protective insulation of your separateness from the corporate entity.

Failure to adhere to this basic corporate formality "could" allow a prospective litigant to assert that the corporation is nothing more than a "straw man" and that it actually functions only as your "alter ego". We have put the word "could" in parentheses because in Nevada there actually exists only one case in the last quarter-century where a prospective litigant managed to "pierce the corporate veil" and cause liability to be assessed against the corporation's owner/manager—and that was a case of outright and unabashed fraud. It's great to have that measure of protection but you can easily bolster it by developing the good habit of following your signature with a title.

The next essential step in maintaining separation between the corporation and yourself is to always document key decisions made for the corporation in the form of corporate resolutions. If you do not know how to construct a resolution, give us a call and we will be pleased to help out.
