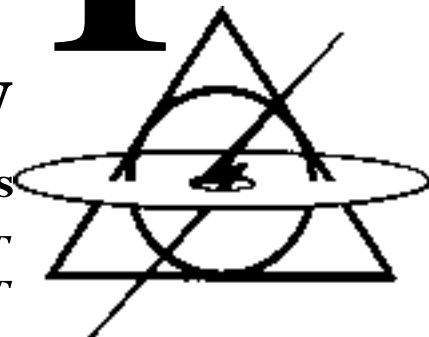

IF THE TRUTH HURTS PREPARE FOR PAIN

You almost have to feel some sympathy for those who have operated under cover of darkness to control everything. Certainly, one of the greatest challenges for the elite controllers at this time is how to beat a retreat from the Truth as it now pours forth over the planet. And again, a little differently but with the same meaning: “If EJ has fallen, why did Aton accept his contract to do this mission at THE most critical time in 24,000 years?”

Everyone sets up situations for their own learning, including the ones posing those questions. If a man has a problem with fidelity, for instance, he will set up many temptations until he learns and no longer needs to repeat the experience. GOD ALLOWS.

How many times have the questioners wondered when someone would come along and “just do it” FOR THEM?

What if EJ was, say, a king in a past lifetime? What if God said alright, fine, you may be a king—as long as you serve me? And so the situation was set up whereby EJ could “have it all” but only if he did so for the right reasons, only if he would serve God above all. But when the time came and EJ was tested, he chose to serve himself, lying to himself and saying (believing, even) that God’s Plan calls for him to be the king “by hook or by crook” and “no matter what”—i.e., “the end justifies the means”. That is not God’s way BUT IT COULD AND DID SERVE HIS PURPOSES IN GETTING THE PROGRAM TO THIS POINT.

Is this not all very HUMAN? Every one here experiencing in this density has fallen—more than once—in case any of us needs a reminder. We KNOW that it makes no sense to wait on someone of perfection to do it for us; SOMEONE(S) have to change their heart(s) into goodness. What are YOU waiting for?

Why NOW, at this very critical juncture? THERE IS ONLY THE NOW, wherein each one is experiencing according to the patterns of their own desires. Perhaps, back when EJ “was” king in previous experience, he did not serve God but each time he got to the other side he promised he would, if given another chance. And so he has been given other chances. And that also answers the question, “When did it begin?” It began, it seems, a very, very long time ago—perhaps even in a galaxy far away.

KINGS OF OLD AND THE OLD KING’S GOLD

Tutankhamun, Nee Tutankhaten

Was EJ Ekker “once upon a time” a king? In the days of Akhenaten (Akhenaton, who is said to have died between 1334-1336 BC), it has been suggested that while Doris was Akhenaten, EJ could have been the boy Tutankhamun, the now famous “King Tut” known primarily for the golden artifacts found in his tomb in 1922.

According to John F. Brock in his book, *Four Surveyors of the Gods*:

“... Akhenaten’s actions were reviled and vilified by the subsequent Pharaohs, the first being his own son **Tutankhaten who changed his name to Tutankhamun in protest at his father’s heretic and disruptive actions...**”

And from Wikipedia:

“His original name, Tutankhaten, meant ‘Living Image of Aten’, while Tutankhamun meant ‘Living Image of Amun’ ... ‘The hidden (one)’.”

“King Tutankhamun restored all the old gods and brought order to the chaos that his relative had caused.

He built many temples devoted to Amun-Ra.”

And so we see that **Tutankhamun, nee Tutankhaten, sought to undo the work of Akhenaten, replacing the Aten with Amun-Ra.** Interestingly enough, Amun-Ra, “the hidden one”, is usually depicted with the face of a bird, carrying a staff and a ring.

Tutankhamun reigned only perhaps nine to ten years and died at age 19 or so only days after a fall (probably from his horse).

“King Solomon” (By Any Name)

Approximately 300 years later, along comes “King Solomon”, who bears some resemblance to Tutankhamun as you shall soon see. I have put the name in quotations because, according to Commander Hatonn in a writing of February 24, 1995: “There was NO SOLOMON as a PERSON!!” Well, there was NO JESUS, either; his name was Jmmanuel.

That portion of the 1995 writing ends with this statement: “THE STORY NOW FITS THE NEEDS OF THE WOULD-BE SLAVE-MASTERS. THERE IS NOTHING SACRED AND CERTAINLY NOTHING HOLY ABOUT ANY OF IT!! YOU GOT SUCKERED IN AND DEMAND TO REMAIN VICTIMS OF THE LIE.”

Another writing from Commander Hatonn also referenced King Solomon just a few months later, on May 4, 1995, and clarified:

“The fact is that Satan (by any name) is the King of Liars, and know that anything connected to the Royalty of any third-dimensional free-will state—will be mostly LIES. That is the ONLY way to maintain power and control.”

King Solomon was married to the Pharaoh’s daughter and is said to have had 1,000 other wives along with some 300 concubines. He is, of course, famous for ordering a babe to be cut in two. In the *Old Testament* he is referred to as Jedediah, “beloved of Yah”—the God of this World who advocated all that ungodly pillage, plunder and rape stuff.

Could EJ Ekker have been the legendary “King Solomon” (by any other name)?

In a writing of September 27, 1999, Commander Hatonn carefully separates EJ Ekker from the Board of Directors of the Phoenix Institute:

“We have a Board of Directors (literally) that are NOT E.J. and Doris Ekker. In fact Doris turned over the Secretary position of the Institute to Nora Boyles in February of 1993 and only came as again acting Secretary following Nora’s total incapacitation from terminal cancer. Now Nora is deceased and Doris remains as ‘acting’ Secretary, etc. That is not my story so we will leave that with, however, stating that we were never without open Board meetings WITH A FULL BOARD OF ADVISERS AT ALL TIMES AND ALL MEETINGS (PUBLIC) IN ATTENDANCE.”

And then we read, a little further along in the same writing:

“... OK, Board of Directors **and King Solomon:** Give us your answer!”

Did Commander Hatonn thus associate EJ Ekker with the legendary “King Solomon”? It sure seems to be an intriguing possibility.

Very recently, EJ purchased every copy he could find in Manila of a book entitled, *The Richest Man Who Ever Lived: King Solomon’s Secrets to Success,*

Wealth, and Happiness, to distribute them to friends and business associates. Please try to ignore for a moment the issue of WHOSE MONEY he used to do so. The book is based primarily on “King Solomon’s” *Book of Proverbs* and obviously EJ wanted to share “this” great wisdom with everyone, even as he continues to work at poisoning the truth presented by Commander Hatonn and Aton by publishing the KNOWN FALSE Jonur writings. Does EJ Ekker believe he was King Solomon?

This “intrigued” me quite a bit, so I set about looking up information about the life of this “richest man who ever lived”—and found some interesting connections along the way.

It’s interesting to note that the line of descent should have seen “Solomon’s” eldest brother, Adonijah, take the throne following the demise of “King David” but **when Adonijah had the temerity to suggest coregency, “Solomon” simply had him killed**—along with anyone else who might stand in his way. Whoever he was, this man was ruthless and ungodly. The following is taken from Wikipedia:

Beginning of Solomon’s Reign

David, before he died, had given Solomon a charge regarding his own actions as a man, and regarding his attitude toward several of the influential personages about the king’s court. As soon as Solomon had become established over the kingdom, Adonijah, through Bathsheba, the queen-mother, asked the king for Abishag the Shunammite as a wife. This request was equivalent to asking for coregency, and Solomon so regarded it, for he quickly sent Benaiah to slay Adonijah. Abiathar, formerly David’s trusted priest, who had conspired with Adonijah, was sent to the priest-city Anathoth, to his own fields, and deprived of his priestly office. Joab, learning the fate of Adonijah and Abiathar, fled to the altar for refuge; but Solomon commissioned the same executioner, Benaiah, to slay him there. Shimei, who had cursed David, was also in the list of suspects. He was given explicit orders to remain in Jerusalem, where his movements could be under surveillance. But on the escape of two of his servants to Philistia he left Jerusalem to capture them; and on his return he, too, fell under the sword of the bloody Benaiah. This completed the destruction of the characters whose presence about the court was likely to be a perpetual menace to the life of Solomon.

Solomon’s Ring and the Eagle

Solomon’s ring is often associated with Solomon’s Seal, the hexagram, though it is said that it may have been a 5-pointed star or pentagram. (And what shape do you think is defined by the striking eagle’s two wingtips, two outstretched claws and beak?) It supposedly gave Solomon **control over demons.** From the *Jewish Encyclopedia* (JewishEncyclopedia.com):

More frequently it was the **eagle** that executed Solomon’s orders. When David died Solomon ordered the **eagles** to protect with their wings his father’s body until its burial (*Ruth* R. i. 17). Solomon was accustomed to ride through the air on

a large **eagle** which brought him in a single day to Tadmor in the wilderness (*Eccl. R. ii. 25*; comp. *II Chron. viii. 4*). This legend has been greatly developed by the cabalists as follows: “Solomon used to sail through the air on a throne of light placed on an **eagle**, which brought him near the heavenly *yeshibah* as well as to the dark mountains behind which the fallen angels ‘Uzza and ‘Azrael were chained. The **eagle** would rest on the chains; and **Solomon, by means of a ring on which God’s name [RK: either the six-pointed hexagram or the five-pointed pentagram] was engraved, would compel the two angels to reveal every mystery he desired to know.**” According to another cabalistic legend, Solomon ordered a demon to convey down to the seven compartments of hell Hiram, King of Tyre, who on his return revealed to Solomon all that he (Hiram) had seen in the nether world.

No doubt that is the same Hiram as in “Hiram Abiff” of the Freemasons’ rituals.

Other GCH References to King Solomon

While EJ Ekker seems to want to associate himself with the old “King Solomon” (based on his “at any cost” and YOUR expense distribution of *The Richest Man Who Ever Lived* books), Commander Hatonn was quite explicit in his rejection of the man at the origin of Freemasonry:

March 19, 2001: “By the way, **anyone who enjoys being a King Solomon—is mentally sick or warped.** Be careful what you demand for self as to expert authority.”

June 23, 2000: “No, God is not starting some kind of global welfare system in our work. Nor, God forbid, are we starting a whole new group of MATTOIDS to replace the old. THAT is up to the players as to how it will ultimately ‘become’.

“Would this just be another form of ‘King Solomon’s’ rule? No, we do not cut babes in half nor do we ever, even in play, suggest such a stupid thing. You cut one another in half at every opportunity so why would we introduce more violence into the considerations for right vs. evil?”

January 16, 2002: “Most of you who question ‘me’ do so without any notion or belief, actually, in ME. Therefore, to give input of ‘to do’ or ‘not to do’ only widens the breach already present. **I am NOT ‘King Solomon’ and whoever tries for that position is riding for disaster and loss of all the friends he thought he had—before offering the ‘help’.**”

January 2, 1990 (republished 12/26/01): “Further, the lion symbolizes Secret Wisdom. King Solomon was often symbolized as a lion; to overcome this beast is to become a master of such wisdom. You should further remember that Samson and Hercules both ‘conquered the lion’—the lion also represents one of the Four Corners of Creation.”

King Solomon’s Gold and the Philippines

Archbishop Mar Levi Bar Thoma of the Apostolic and Catholic Church of the East wrote a book entitled, *GOD TODAY EXHORTS: “COME OUT OF HER, MY PEOPLE”*, in which he indicates a connection between the legendary gold of King Solomon and the gold in today’s Philippines with the following simple statement:

“Being a descendant of royal Malayan blood, the

Tagean family had its share of power, authority and riches from the collected taxes during its 900-year rule in the empire, and even **two millennia earlier when there was commerce with King Solomon of Israel.**”

Commander Hatonn confirmed this connection, equating the Marcos Gold with the gold of King Solomon in late 1999:

October 29, 1999: “Now it is noted that also on the front page of the paper today is Enrile shouting that Enrique Zobel’s allegations about the Marcos gold were ‘stupid, false, as fantastic as King Solomon’s Mine’.”

October 31, 1999: “Enrile, however, said Zobel’s statements were ‘fantastic as King Solomon’s mines’. [H: Oh my, but King Solomon’s mines ARE NOT ‘FANTASTIC’.]”

Knights Templar, Order of the Assassins, Jackals

It is a generally accepted fact that the Crusades were concerned more with the legendary gold of King Solomon’s Mines than religion. Associated with the Crusades we find the Knights of the Temple of Solomon, better known subsequently as the Knights Templar.

The Knights Templar were closely associated with the *Hashasin* of Persia, from which is derived the word, assassin.

EJ Ekker has admitted achieving a high level in Freemasonry. He has not denied being connected to the United States intelligence establishment (DIA, probably) and his closest associates are identified with the CIA (“jackals”—assassins). He wears a “signature” ring which bears the image of a striking eagle, where both the ring and the eagle were notable “trademarks” of King Solomon—and the symbol of the striking eagle could be construed as forming the shape of a pentagram. He is VERY interested in the Philippines gold. And he seems to personally identify with and promote the idolization of King Solomon.

“King Solomon” is “said” to have authored *Canticles*, *Ecclesiastes* and *Proverbs*. On the Internet today you will find uninformed comments to the effect that EJ Ekker is the author of most of that which has been printed in *CONTACT* newspaper over the years. Does that surprise you? Of course YOU know better but would it really be surprising if “history” were to record it somewhat incorrectly?

In any case, let’s lead into the next section with the following citation from *Proverbs 22:7*: “**The rich rule over the poor, and the borrower is servant to the lender.**”

DISSATISFIED LENDERS IS “THE MISSION” BANKRUPT?

The price of gold has more than doubled from the point at which many loaned money to advance “The Mission” and that means that a number of loans are now “mature”—and callable. I have engaged in some discussion with others by email and some of that is probably worth sharing.

To set things up, the first question I asked was whether or not contracts have to be in writing in order to be valid. The reason for posing this question is that there are numerous OTHER contracts in place, of which some of the lenders might be unaware. After some discussion, it was resolved that no, contracts do not have to be in writing to be valid. With that as

background, let’s just jump right into my email reply following that resolution:

Good, we understand that contracts do not have to be in writing. I am going to pose the next question up front because it is all I want you to answer; the extra text below is to give you some information as to why this question is so important.

Next Question: IS THE MISSION (the umbrella and all entities affiliated with and under it) BANKRUPT? Do The Mission’s liabilities exceed its assets?

OK, here’s some information for you to digest:

I am glad you can see that “written contracts” are not the only kind of contracts. In fact, ALL contracts are verbal; when REDUCED to written form they are simply more easily verified and adjudicated. That said, where Party A says he understands a certain agreement (contract) with Party B and Party B agrees that’s the way it is—such a contract is no less binding. It’s only when Party A and Party B disagree that one or the other (or both) might wish they had reduced their agreement to written form. (I use the word “reduce” because in almost every case there are numerous subtle understandings which are NOT included in the written form of the agreement.)

The reason for going through this stuff with regard to contracts is that it is important to understand that many contracts exist between the various Mission-related entities and the numerous individuals who have contributed to getting The Mission to this point. EQUITABLE terms (dealing only with “money” and agreements with regard to same) are the only terms today’s courts can adjudicate because they do not get into issues of tort or moral judgments of right and wrong. So first let’s talk about only the MONEY (the “means”) and not the moral commitment/obligation to succeed (the “end”), even though, as you will see as this progresses, the means and ends are inextricably linked.

In purely equitable terms: There are many contracts, written and unwritten, between numerous Mission-related entities and numerous individuals who have contributed—both monetarily and/or by work/effort. It is also notable that there is a legal principle that “A workman is worthy of his hire” and you might notice that the courts really respect this, requiring employment contracts to be fulfilled before even the taxation authorities are paid out-ahead of settlement with creditors.

As Director of several entities, I must (I HAVE AN AGREEMENT/CONTRACT to) endeavor to uphold ALL contracts WHILE UPHOLDING MY FIDUCIARY RESPONSIBILITY TO THE OWNERS. This is why it is very important to understand WHO OWNS GLOBAL ALLIANCE INVESTMENT ASSOCIATION.

The truth is that GAIA exists for the benefit of all people and that means all actions taken by me as a Director must take into consideration the OWNERS, who are ALL PEOPLE. Thus, my decisions must be, even in equitable terms, “good for everyone”—not just those who lay claim by virtue of their written or unwritten contracts. The Articles of Incorporation of GAIA (the primary

contract by which my actions are governed) are explicit: I MAY ONLY CONSIDER THE GOOD OF THE COMPANY AND MUST PUT ITS WELL-BEING FIRST, AHEAD OF ALL OTHER CONSIDERATIONS.

When we're talking about the extinction/dissolution of a corporate body due to bankruptcy (where liabilities exceed assets), the rights of the owners are NIL except with regard to limited liability. That brings us to the next question:

IS THE MISSION (the umbrella and all entities under it) BANKRUPT? Do The Mission's liabilities exceed its assets?

The response from the individual to whom that email was addressed showed SOME understanding but cautioned, "you guys are on VERY THIN ICE," presumably meaning that the respondent is aware of plans afoot to shut things down. I will just share my response and the reader can probably infer quite accurately the tone of that to which the response is addressed:

As I've said, I actually WELCOME an all-out effort to foreclose, so I don't consider any risk whatsoever to the "VERY THIN ICE" comment. Your statements regarding what an equity/admiralty judge "probably" will do are an opinion. In my opinion, it is GOD who shall do the FORECLOSING.

The asset GAIA holds is NOT A BOND. True, it originated FROM a bond BUT: 1) The accumulated interest—all of the value—was assigned to CSEML when the bond was declared "lost or stolen" (so, the bond itself no longer has any value whatsoever except as an historical artifact); 2) All of the foregoing history is MOOT when it comes to the Certificate of Debt, which every equity/admiralty judge MUST consider because it was perfected according to the terms of equity/admiralty as spelled out in the Uniform Commercial Code. What is MISSING in your mathematics (based on your "VERY THIN ICE" comment) is: THIS IS GOD'S PLAN. I don't really care who believes that to be the case; it is so. All of this CAN ONLY conspire for Goodness, no matter what the intentions of the various participants.

Mark and others with matured contracts (and there are PLENTY, I can assure you) SHOULD seek their legal remedies ESPECIALLY IF THEY DO NOT BELIEVE THE GAIA ASSET WILL BE REALIZED. Many others will probably be prompted to JOIN as plaintiffs in the action once it becomes clear that it is underway. Just guessing but there are probably going to be at least half of the \$10-20 million of outstanding loans in "matured" status by the time this gets into a court for adjudication. I will [well, maybe] want to join in as a claimant as well because "a workman is worthy of his hire." I only know about maybe \$500,000 in GAIA assets (assuming EJ doesn't have/find a way to squirrel those away in the interim), those funds having come from recent lenders (in the last couple or three years). There could be more and in that case I'd like to know and have any hidden assets revealed through

discovery, too. John Ray has hinted that there could be more and if so, LET'S FIND OUT!

(I sense some misunderstanding with regard to "immunities" but that is a side issue not necessary to your understanding of the situation with regard to the claims of Mark and others.)

So, to the next question: What would YOU do if you were a Director of Global Alliance Investment Association, faced with a claim from one or two of what you know to be many debtholders and claimants?

The email correspondence with regard to this subject was interrupted at this point due to some travels. The answer to the question left hanging, above, should be obvious because where liabilities exceed assets, no one may be paid out to the prejudice of the other claimants.

On the other hand, GAIA can only be "bankrupt" IF its liabilities exceed its assets and that is surely NOT the case when the \$60 trillion now "due and owing" from the U.S. Treasury is considered. Is that \$60 trillion "real"? **THE CLAIMANTS WHO WOULD SHUT THINGS DOWN EITHER DON'T BELIEVE OR CARE THAT IT IS REAL—OR WANT TO BURY IT.**

What would "wise old King Solomon" do? EJ Ekker has warned that anyone who causes him trouble over this issue can expect not to be paid anything, ever—and certainly nothing at all "for now".

MARK MOORE SLANDER AND LIBEL
'JUST AS VALID NOW AS THEN'

As recounted to some extent in the May 9, 2007 issue, back in October 2003 Mark Moore wrote up a "declaration/affidavit" in which he directly accused me of being a "liar, cheat, con man and thief". For some reason(s) of his own, Mark Moore seems fixated on the events of three and one-half years ago. Yes, it is guilt which anchors us to the past (and fear which holds us back from the future).

You might think there would be more concern and pressure for answers with regard to serious CURRENT matters such as MONEY LAUNDERING, FINANCIAL SUPPORT OF TERRORISM, INCITEMENT TO SEDITION AND POLITICAL INTERFERENCE—but no, Mark Moore's primary focus seems to be to show that Ron Kirzinger was somehow "the only responsible party for the Artemis operation".

I made my statement with regard to this matter, which was published in the May 9 issue, clearly declaring that is not the case here. Undaunted by the FACTS of the matter, however, Mark Moore presses on, prefacing his mish-mash with the meaningless mojo that he is "surrounding" himself "in the light of Aton"—as if that mystically means Mark Moore is not being merely malicious.

In the back-and-forth of emails, it has been revealed that my efforts toward "The Mission" have amounted to the contribution of Budget Corporate

Renewals, Inc., \$500,000 or so in its pre-split condition (now somewhat less due to EJ Ekker's damaging actions); along with BCR's paying of fees for ALL Mission-related entities (several tens of thousands of dollars); along with the costs of warehousing all of the Phoenix Journals (several tens of thousands of dollars more); as well as other non-itemized contributions.

In exchange, my very minimalistic living needs were met and a company with which I am involved in Canada was the beneficiary of a CONTRACT—which has now been unilaterally breached by EJ Ekker, leaving me wholly without supportive income.

So much for the allegations that I'm "only in it for the money". I have given EVERYTHING I HAVE, ALL OF MY PRODUCTIVE LIFE ENERGIES—and still have to face this kind of spurious "criticism" which crosses the line into libel and slander? No, the SHAME IS NOT MINE, MARK MOORE.

With regard to Artemis Distributing, Mark Moore was in a location and a position to ensure production and distribution of the miraculous, God-given Gaia Products—but chose, instead, to not only not contribute his own efforts but to stop the efforts of those trying to get those products out to people who very much want them.

In an email dated May 12, 2007, following several paragraphs of praise for my efforts, "fair and balanced" Mark Moore condescendingly writes:

"What type of Lighted example would I represent if I didn't offer my hand to a brother who had begun to fall and found himself in a tough situation?"

Well, Mark, this is certainly a tough situation—and what kind of a "hand" are you offering other than a BACKhand?

"You see my brother that for whatever reason, you made a free-will choice to not personally respond to my Declaration of October 29, 2003. If you'd only supplied the recent information back then, the Declaration would have been much shorter. So now you express frustration at E.J.'s non-responsiveness—do you understand the 2-way-street implications here?"

Who so JUDGES that another has "begun to fall" and ON WHAT BASIS? And if "the Declaration would have been much shorter"—what is there to cause so many pages of current correspondence at the expense of MANY people's attention?

Why do I choose not to run your full misrepresentation, Mark? Because it is meaningless, except for the fact that you have reactivated the laches relating to slander and libel.

Mark Moore, even while demanding that all contracts must be upheld "no matter what", demands that I unilaterally abrogate contracts with others intended to protect their privacy. No, I will not do so and it's just too bad you have so little respect for the rights of others, Mark.

Apparently I am not the only one wondering why Mark Moore stays on this age-old Artemis non-issue because he writes:

"Some have questioned my reasoning as to the importance of the Artemis [sic] Operation of year's [sic] past. Here it is: If you were to get complete control of the enormous Philippine Operation, would you take the same courses of action for GAIA, TLN/FDN [sic] or Monex that you've demonstrated in handling the leadership/responsibilities of the

comparatively tiny Artemis? Ron, remember trust is a 2-way street.”

Sic and sick, Mark. It is NOT POSSIBLE for me to control “the enormous Philippine Operation” for the simple reason that control must rest with Filipinos—by law—as EJ Ekker now knows very well. I for one would not have it any other way.

You have clearly misJUDGED what happened with Artemis Distributing and proven your own discernment to be extremely faulty, Mark. You nor anyone else has so much as shown any inclination toward understanding how Global Alliance or the Tallano-Acop Foundation function, much less how they can be used in combination to effect positive change in the World.

If there was anyone more qualified than me, don’t you suppose GCH might have ensured that THAT one would be in my position? “For some reason(s)”, however, which you obviously do not begin to understand, GCH left me as the ONLY Director of Global Alliance with a right to vote on any issue and the sole director of CONTACT, INC. and Phoenix Source Distributors.

Oh, we know, Mark: You know better than GCH, right? Because you’re surrounded in the Light of Aton, right? Stop with the blasphemy, already!

Nevertheless, I wrote Mark Moore back, demanding of him:

“Show me (PROVE—not just ALLEGE) one lie, much less a pattern of lying that qualifies me as a ‘liar’. Show me one cheat, much less a pattern of cheating that supports calling me a ‘cheater’. Show me one act of theft, much less a pattern of thievery to justify calling me a ‘thief’. Show me one way I have conned anyone, much less a pattern of conning people to warrant labeling me a ‘con man’. The simple reason you can’t prove your position is that it is NOT TRUE. You are WAY out of line and way past owing an apology—‘in my opinion’.

“With regard to your MONEY, you really should be communicating with the man who has signing authority and who claims to have sole control over all Mission-related assets: EJ. Maybe you should be glad you DIDN’T commit EVERYTHING you had to The Mission, to the extent that someone like EJ could put YOU out on the street in a strange country and cut you off from all financial support. ‘Not to worry’, though, because I am STILL in service (actually and factually) even while being harped at by such amazing (but not amusing) distractions as you have presented.”

You might think Mark Moore would be anxious to put forth his “documentation” of my alleged misconduct at this point—showing PROOF of any of his allegations—but NO, he did not because HE COULD NOT.

While still blasphemously stressing that he is supposedly “in Lighted service to Creator ATON—let there be no mistake here”, MARK MOORE thrashes about trying to explain how he has labeled my “ACTIONS as representative of a ‘liar, cheat, thief and con man’”—WITHOUT SPECIFICALLY IDENTIFYING EVEN ONE SUCH ACTION WHICH CAN BE TAKEN AS A LIE, CHEAT, THEFT OR CON.

He accuses me of ducking “my” responsibility while ignoring the allegation that **HE IS THE ONE**

MAN MOST RESPONSIBLE FOR NON-PRODUCTION OF GAIA PRODUCTS.

He states that I, Ron Kirzinger:

- 1) “ran the Artemis operation”—FALSE;
- 2) was “aware of the myriad problems”—something of which he, being on the scene, is far MORE “GUILTY”;
- 3) “received funds from the operation”—FALSE; I received some funds FOR the operation which were used FOR the operation, nothing more; Connie was the sole beneficiary as far as I can determine;
- 4) “INSISTED that I publish an Artemis Ad in Contact ‘until further notice’ to continue selling discredited products—HALF-TRUTH ONLY. For whom was I the agent? On whose behalf was this insistence? Gee, could it have been GCH Himself?

But, of course, Mark Moore knows better than GCH, right? Because he is in the Light of Aton, right? Sorry, Mark, but pulling rank on Commander Hatonn will only merit you demerits because HE IS IN CHARGE OF THIS TRANSITION, NOT YOU.

Mark says: “I’m not familiar with your ‘Dad’, Mom or ‘The Mission’ you refer to. I’m an appointed Ground Crew Member in Lighted Service to Gyeorgos Ceres Hatonn’s Mission and of whom I am in regular contact.”

OH, REALLY?

MARK MOORE VS GCH

Does anyone else find it strange that Mark Moore entirely avoided addressing anything written by GCH November 4, 2003 and presented in the May 9 issue with regard to Artemis? I guess some of this needs repeating:

“As to Artemis—never mind anything as relative to CONTACT (Mark or otherwise). Games are not up for playing. I have asked that a few products be available—and so be it.”

So, Mr. Mark, WHO WAS IN CHARGE OF THE ARTEMIS OPERATION? WHO ASKED THAT A FEW PRODUCTS BE AVAILABLE?

“We will not longer argue or debate. We will CLOSE DOWN any operation.”

Because—WHY, Mark?

“There will be no ‘outdated’ product even if it is such that IMPROVES with age—like good wine. All else has been properly labeled or has no connection with anyone now choosing to damage anything we have done or offered.”

WHO is the one “choosing to damage anything we have done or offered”—Mark?

“We should run a ‘closeout’ flyer to use with those ‘mailing labels’. Then I ask that Connie resign, in writing, so that we can publish a ‘notice’ to that effect.

“There has been no lessening of products offered—the point is that with Fed control and debacles—the product had to be brought into total conformity and you cannot EXPECT other than problems. Any credit card problems must be worked through the credit card company for remedies are readily and IMMEDIATELY available. But we will jeopardize NO INDIVIDUAL [RK: RK] longer to serve where

unwelcome or subject to, for goodness sakes, wars, chosen ‘sides’ and other thrusts at parties ‘assumed’ to have done things WRONG. No, the very fact that seekers and destroyers could NOT find the evidence they thought interesting for their destructive use—proves the business is intact and fully qualified through proper BUSINESS channels.

“Perhaps Mark and a few others would like to live through prison and outrageous fines for the privilege of serving as did Diane. She is out of the loop FOREVER—or at least for the next five years at which time she will never again serve willingly just to help people of our little circle.”

Mark, you are so far in the wrong it is almost absurd to continue with this. Artemis was not “mine”; I didn’t own it and I didn’t own “top dog” responsibility for it, either. You SHIRKED your responsibility, instead making your best efforts to set me up for some kind of takedown. Oops! And yet, as the facts come out PROVING YOU WRONG, you steadfastly refuse to admit the possibility that you have erred so greatly.

Is THIS why you have had such a falling-out with Commander Hatonn that you have had to literally reinvent Him as “your” Aton/Hatonn?

“How is it that we NOW have blastings and threats of some disastrous escapades when all we offer is management through better ways and SHARE that which is gifted—for your use.”

I am NOT sorry for the “sucker punch” set up by Commander Hatonn, Mark. You wouldn’t have known of this writing because it was PRIVATE. There are TOTALLY VALID REASONS FOR PRIVACY, PEOPLE.

“We either have the tools we need or we find them for we will not forfeit any program because of lack of understanding and the minding of another’s business affairs.”

But Mark, of course, is just acting to protect all those who were supposedly harmed by defective Artemis products? GIVE ME A BREAK, ALREADY! WHO wouldn’t rather have had the Gaia Products available for the last three years?

“Ron Kirzinger is an integral part of our program and, in spite of everything—HAS DONE HIS JOB SUPERBLY AS TO OUR NEEDS.”

WHOSE needs? Oh, yes, of course, the needs of “The Mission” from which Mark Moore has so thoroughly disassociated himself by stating he’s “not familiar with ... ‘Dad’, Mom or ‘The Mission’ [I] refer to”. Yes, THAT Mission.

GCH had more to say about Mark Moore in a public writing of October 27, excerpts of which follow, interspersed again with my comments:

“I remind all of you that when you, for instance, call another a thief and/or ‘con man’—you had best be able to PROVE that statement and when we ALL must depend on that receiver of such accusations for our own function—we are torn into factions of ‘favorite’ personalities. We have a MISSION to accomplish—we CANNOT have personalities as individual focus.”

Did that sound like some kind of “vote of confidence” for you and your approach to the situation, Mark? Does it mean ANYTHING to you that GCH was so opposed to what you were doing even as you set out down this path?

Perhaps the following is what really set you in opposition to GCH:

“What does Mark wish to be or do when he ‘grows up’?”

WHY WEREN'T YOU IN NEVADA DOING ALL THE THINGS THAT I, AS A CANADIAN YET, WAS TRYING TO DO FOR “THE MISSION”??? BUT NO, YOU WERE TOO BUSY ATTACKING ME WHILE LASHING OUT IN PURE IGNORANCE AND IGNORING COMMANDER HATONN'S REBUKE:

“Some think it is some sort of mystical dare for anyone to rebuke or insult me, or my team/crew. No, it may be incorrect in concept—and indeed ‘insulting’—but certainly ‘acceptable’. Have YOU further to offer? Insults and rebukes bring reactions which then get out of hand while realizing that what anyone thinks or comes to believe about ‘me or thee’ is neither mine, nor your, business. However, once the mud is slung, so to speak, and spatters on everyone around in the scatter—it becomes our need to walk through the ‘fling-zone’ as best we can.”

“Dear brother” Mark, before you start condescendingly addressing a presumed (by you) “fallen brother”, perhaps you would review this excerpt (after removing the lumber from your eyes):

“What is the REAL pain in your being that causes drastic and assumed ‘irreversible’ actions in your expression of YOUR life and living? When you determine, TRUTHFULLY, the answer to that question—you will find ever so much less pain and far better solutions for your position in any event.”

Did you then go within and try to determine the cause of the REAL pain in your being? Apparently not, since you are continuing down the same SORRY PATH.

In a writing of November 8, 2003, Commander Hatonn (the REAL one, not Mark Moore's version of him), wrote quite a bit more on this dreary subject and to save space I will simply again use excerpts which capture the “flavor”:

“However, we cannot have a tearing down of other people and their business affairs on personal vendettas and certainly not even where the commentator or ‘revelator’ of something or other (totally without fact or basis) is bringing bias and damage to the very things for which we stand and serve.”

Did it even occur to you, Mark, that Commander Hatonn was referring to YOU?

Also: **“I wonder, however, if you truly think that ‘turning in’ your brother is ever a reasonable ‘answer’ to YOUR problems?”**

“I have to equate careless actions as being as serious as eating your seed grain. Once gone—ALL GONE! Kill your goose and there are NO eggs, gold or otherwise.”

Who or what is the “goose” being killed? Who is intent upon ‘turning in’ a brother WITHOUT FACTS OR BASIS? Why have there been no eggs, gold or otherwise? What do you think, Mark: Was Commander Hatonn talking about you or someone else here?

Also: **“If you are somehow being ‘involved’ in some possible ‘criminal’ activity then you must protect yourself and the program properly and as**

well as possible. This certainly in no way gives anyone right to tear down a brother for self-serving perceived affronts. Whatever can be gained by such betrayals—especially when the conclusions singularly reached are INCORRECT—after calling a man a thief and con man?”

“Apologies? Come now, anyone going so out of their way to conjure such tales are not planning to ‘apologize’ for we note that the only response is more and a wish to further distribute the WRONG information AS IS.

“I hope that all of you will better consider your ‘last resort contacts’.”

So, Mark, the self-professed “last resort contact” referred to above, tell us again how you are all wrapped up in the light of Aton with your attempts to further this nonsense?

In a writing of November 11, 2003, Commander Gyeorgos Ceres Hatonn had the following things to say (again, excerpts only, interspersed with my comments for brevity):

“People who set themselves up as some kind of moral savior or ‘last resort’ are ‘full of it’. They should be avoided, in business, as you would protect your body in a plague. Give NO ACCESS to information and make sure that what is provided is ill-advised for ‘their’ use.

“As with Mark, going a step further in consideration of a long chain of events which you can check off on your fingers—Mark won't work with Ron or with Bruce and on down the line one after another. How, therefore, can you better protect your own property, activities and selves? There is no cause to ‘share’ anything at all—NOW. And, moreover, it is the decision (choice) of the individual and nothing anyone has ‘done to him’.”

Gez whiz, Mark, I don't think GCH could have been much more explicit in his condemnation of what you were up to then—and continue into today. And STILL you try to justify your actions? No wonder you need your own version of Commander Hatonn!

MARK MOORE VS DORIS EKKER

On November 13, 2003 DORIS chimed in as she found her words used inappropriately by Mark Moore in the making of his “case”. Doris wrote (all emphasis is mine):

I note, however, in the recent Mark's declaration and earlier accusations of Ron of “heinous crimes against humanity” [the actual quote, “that your ACTIONS are indicative of a thief and con man”], that simple statements from those phone calls have been used and quoted as my having made them—and indeed, quoted, to my short memory, fairly accurately—but **out of context and certainly representing bias on my part when unintended.** However, regardless of accuracy, the use of this email site for such **personal and insulting mud-slinging** is not acceptable.

If you wish to get Mark's interchanges, please contact him personally—we do not wish to further address the circumstances in this manner.

We have a “perfect” Teacher-Guide walking us through the most minute detail of this “mission”

and we would not be here nor could we ever hope to pull off such a massive and mammoth program without that input and association with higher guidance. When He nudges me to write for Him, I clear my space, I wash my brain (so to speak) and the material presented must stand on its own—which it always does.

Mark taunts Hatonn with his thrust about putting all the details and rebuttals about his interests, alone, on this “forum”. This is NOT a “forum”—it is an email address for use between us, I hoped, friends. Mark insists that I am incorrect in that we have to presume that some on the list are NOT our friends but in fact are his backup for slurs, accusations and yea, even to some interesting claims to “saving CONTACT'S readers” and backing his **slings and arrows** with their input.

Interestingly enough, one of the parties proclaimed as calling on him for “last resort” salvation has written a long response actually “correcting” his first message to Mark which Mark had sent to “everybody” to back his thrust at Ron K. **The correcting response did not reflect what was put into the “Declaration”.**

We found the VK debates and document-gathering to be as unpleasant as anything we have ever had to do—but that was mandatory to establish this program with proof of “title”. I see **nothing other than harangue and hassle in Mark's vendetta** and we cannot take time for it. If we can't rise beyond the **terrible reflection of nastiness and doing same in the “name of God”** (whatever is chosen as a label) while pinpointing “service” vs “being within” a being, we have GONE NOWHERE FORWARD.

It seems to me to be quite unthinkable to use our private “site” (which is not even a website) for another's **personal harangues**. This is our communications mailbox, including OUR FAMILIES (and, temporarily, our CONTACT friends), and misusing it in the manner Mark wishes is totally unacceptable. We have, in fact, had to REMOVE some of our own children from the list because they were able to “receive” at their offices but **we will NOT load their computers further with this nonsense. And yes, Mark, this IS nonsense.**

Will we be back in press? Yes indeed. Moreover, we have been caused to look closely at many things formerly out of our line of attention. And, no, we do not hesitate to share whatever is in interest. Right now we have no funds for the paper. Mark is correct in the daily survival category and, further, **he refused to run appeals for help as suggested by Rex, and later Valerie, until they were forced to ask us to intervene and insist that he do so. How consistent is that behavior with his self appraisal as the subscribers' “last resort”?**

In his declaration, describing his own contribution to CONTACT, Mark says, “...resulting in CONTACT becoming a finely tuned operation (the hands-on, creation-to-printer-to-reader phase, as opposed to the financial aspects of same).” Yes indeed. He soon learned to take our roughly edited drafts and those of the Rays for the News Desk, choose what to run and where to put it, write the

headlines, format the whole paper, and send it electronically to the printer—ready to print. For that we are grateful and our hats are off to him for that job well done. As a technician, Mark is “par excellence” and surely has few peers in his ability to create better ways to get jobs done.

Ron, on the other hand, is a top-notch businessman. He has been the prime mover in the creation of at least four successful businesses since coming to Las Vegas to work with Cort Christie some ten years ago. From where we are we cannot help shedding tears of pure anguish that they cannot control their personal animosities long enough for us to get this job over here finished. Once this is done there will never be any need for them to cross each other’s path, there will be so much to do that is fun to do. And let me make it clear that we do not ascribe the difficulty to be 50/50. From here, based upon the recent exchange, it becomes obvious that Mark must bear **at least 75%** of the responsibility for nastiness.

In the quote above Mark seems to lay the blame for the financial failure of *CONTACT* on somebody else—he doesn’t say whom. He seems to have copied that attitude from Ed Young who steadfastly refused any and all responsibility for asking help for *CONTACT*. As Editor and Chief of *Spectrum*, however, Ed never let an issue go to print without asking for support. That would seem to indicate that the Editor and Chief is not above responsibility for the financial success of the business, especially if it requires the use of some space in the paper.

In his nasty letter to Ron and in his declaration, Mark has not been entirely truthful. For instance, he reported, and PUBLISHED, that the amount in arrears with the printer was \$9,600 when it is actually less than half that. When Valerie and Bruce went to see him, the printer was warm and cordial and would do whatever he could to make any “transition” as easy as possible—including continuing to run our small numbers. He has a new press geared for major color format and has to do, literally, special runs for us. He also attends the “handlers” (mail and UPS) and is happy to do so—but will actually be glad if we can get moved. We have been getting 700-800 papers per issue; a printer needs at least 1000 to make a profit. Mark had previously led us to believe that the printer was unfriendly and wanted rid of us. ...

... When the battles get under way I must be honest, I don’t want to do this any more I can’t bear the recognition that we fail miserably to reflect the very goodness we espouse and credit unto our selves. Do I wish that I had just said “no”? Yes, often. But, I/We didn’t and therefore, we will FINISH this job and your faces, too, can bring back those big smiles.

What will happen with Gaiandriana? Nothing. Everything will simply be closed—period and end of discussion. Mark questioned Cmdr’s notation about Dr. Wendell Hoffman with “(Dr. Hoffman?)” when referenced to Gaiandriana, etc. How disrespectful to not just Cmdr. but to Dr. Hoffman. DR. HOFFMAN WAS THE “FIRST” (FIRST) to be given the “gift” and indeed, right through a rather difficult to “explain” gift of drias and drios

presented in physical format. I do not intend to even discuss that here in a hagggle circumstance for it is the very GIFT OF LIFE ITSELF.

For several years Wendell supplied ALL of the Gaiandriana and mitochondria (Aqua-Gaia) while researching technically (for he certainly had the lab facilities to do so). Not only that, he continued through the years to support the paper financially—RIGHT TO THE TIME OF DEATH THIS YEAR. So, Mark may well be “protecting” you helpless readers of what we have to assume is somehow “his paper”—but **he has just helped you out of the very thing we most need in this barrage of depopulation thrust upon us.** BUT, NO MORE OF MY LOVED ONES WILL EVEN BE SUBJECT FOR CONSIDERATION OF FINES, JAIL TIME OR ANY OTHER NASTY REPURCUSSION BY SO MUCH AS ANSWERING A PHONE.

Will Mark continue to run or lay out the paper? I don’t know—I assume so for he continues to say that he plans to do so—or implies somebody should or would fire him, relieve him or whatever. NO, I send writings and requests and there you have it. Our requests have recently been met with full compliance, albeit with some friction, but we do wish he would take a vacation away from Tehachapi for a change of scene and perhaps a better perspective.

I cannot believe that you who already have more garbage on your email than you can stand want all this personal **vendetta** which is not even “returned”. Mark wants Ron to “just respond”? WHY in the world would an intelligent individual do THAT?

The “declaration” is somehow supposed to be WHAT? It is a notarized letter addressed to “Ron”. ...

That’s enough, surely. Face it, Mark: You have had to do a whole lot of TWISTING and misrepresenting of information to make your “case”. Or is it, as both Commander Hatonn and Doris referred to it, really a VENDETTA? You “say” you don’t hate me and never have? REALLY?

You say your “Declaration/Affidavit” is just as valid now as it was then? I agree—though its validity is closer to zero on my value scale than yours. Come, come, Mark: Grow up and GET REAL instead of insisting you are wrapped in the pure light of Aton while continuing with your dastardly deeds.

You have a matured note or two. You want to be paid out and EJ Ekker is refusing to pay “at the moment”. What is a RESPONSIBLE “Lighted member of the Ground Crew” to do? Trash ME?

I’m sure that would suit you just fine and that you would welcome such a “helping hand” from any others you might manage to swing your way.

No doubt you have also provided a good measure of relief to EJ Ekker, whose “indiscretions” have been rather well PROVEN—but somehow don’t seem to matter very much to you and others simply tolerate.

“If you know not me, you know not the Father who sent me,” Mark. But even though you profess to not know my Heavenly Father, you are serving His Will and all that you do SHALL conspire for goodness—so, by all means, “carry on!”

IMMIGRATION ISSUES

Following my own “acquittal” at the Bureau of Immigration and Deportation, occasioned by what appears to be a concerted effort on the part of EJ Ekker and some of his paid minions I was feeling “washed out” from the tension and felt no urge to pursue more vigorously any case against Mr. Ekker.

Professor Jaime Ramirez, however, has taken matters into his own hands with a personal vow that he will follow through until “his” project is completed—meaning, he has no intention of quitting until Mr. Ekker is removed from his country.

No, neither I nor Cenon Marcos put the Professor up to this; it is something he is doing based on his own strong beliefs and a deep personal commitment.

People here deeply respected Doris Ekker but only tolerated EJ Ekker’s overbearing nature because he had the money they needed to sustain themselves. When the latter kind of relationship breaks down, a certain amount of animosity is to be expected.

When I was brought in for questioning at Immigration we all learned a few things. The Immigration officer was respectful and helpful as he pointed out that the mere SIGNING OF ANY DOCUMENT or TAKING OF ANY BENEFIT WHATSOEVER could be sufficient grounds for reuring a WORKING visa. Setting up any business deal for personal profit falls into the latter category—and that appears to be what Mr. Ekker has been doing for a very long time while registered only as a “visitor” in this country.

When the Immigration officer was informed that I had recently become a Trustee of the Tallano-Acop Foundation, his immediate reaction was that I should forthwith apply for a working visa. Well, Mr. Ekker was a Trustee of the Foundation FOR YEARS. Oops?

I had to tell Professor Ramirez that I took exception to his second “charge”, in that Mr. Ekker is certainly NOT “Chairman” of anything other than a *de facto* (illegitimate) version of the Tallano-Acop Foundation. Nevertheless, according to the Professor at least, it is illegal for Mr. Ekker to hold that position as a foreigner in a Philippines-based entity. I suppose we shall see “in the fullness of time”.

FIRED ATTORNEY THREATENS EXPULSION

Did you ever hear the one about a guy who walked into the bar with a penguin under one arm? No? Well, don’t worry: this is almost as funny.

The services of Attorney Alejo F. Estepa were terminated on March 19, 2007, just two days after the expulsion of Mr. Ekker and suspension of “placeholder” Tom Taylor from the Foundation.

At a costume party on or about April 7 (the date of the Foundation’s Annual Meeting) it looks like some real kidders got a little carried away as they held their pretend version of the Foundation’s real meeting.




