## MEDIA RESORTS TO RELENTLESS O.J.-BASHING

According to Gary Wean, Commander Hatonn, and others, the Mishpucka has invested a lot of energy to ensure a guilty verdict in the O.J. Simpson set-up and trial. So the jury's return of its verdict to acquit O.J. was shocking—I had come to expect yet another victory for the Elite destroyers who seem always to have THEIR way in world events. It was a thrilling reminder of the power of the jury, and a reminder, too, that we each have the power to turn everything around.

This lesson is not lost on the adversarial crew, however, and their media vilification of O.J., the jury, and the jury system has been relentless. As always, it is based, not on fact, but on assumption, innuendo, and name-calling. In the newspapers, it is reflected in the editorial cartoons, (selected see below) letters to the editor, headlines, columnist commentary, even the business section. TV reporters and anchorpersons portray the assumptive state of "we all KNOW he's guilty", feature anguished interviews with the Browns and the Goldmans, and then accuse the JURY of making an emotional decision! And the sparks of racial strife were fanned mercilessly in an attempt to divide and conquer. That most white Americans bought the package that O.J. "got away with murder" shows how easily led are our citizens. Here are a few examples from this week's DAILY NEWS, [quoting:]

"The evidence was overwhelming against him, but I always figured he'd get off," Michael Jefferson said. "If you've got money in America, you can get away with a lot." "It's totally ludicrous," said

Tommy Valentine, 24, of Hollywood. "They say you can get away with murder in the United States. I guess they're right." "DNA doesn't lie—why couldn't the jury figure that out?" said Jodi Sessions of West Hills, in tears after the verdict. [DNA may not lie, but it sure can be cloned and planted at the scene! Reminds me of the saying "Figures don't lie, but liars figure!"]

**RACE ISSUE POLARIZED PUBLIC OPINION** [headline]: The jury's verdict is in, but in a city once again divided along racial lines by a criminal court trial, the deliberations may only be just beginning. Most whites believed O.J. Simpson was guilty. Most African-Americans thought him innocent. To most whites, the central question in the trial was whether Simpson was a murderer responsible for the deaths of his wife and her friend. [Well, let's say they bought the package they were given. Of course, the whole trial was a set-up from both sides, and it's nothing short of miraculous that the jury saw through it enough to acquit.]

To most African-Americans, the issue was whether the system that brought Simpson to trial was tainted by racial bias. [That's what they WANT you to think, in order to keep the conflagration burning. The "racial issue" focuses on Fuhrman, obscuring the fact that this case was a set-up from day one.] The racial divisions over the case grew deeper as the trial progressed. [As planned! This statement was repeated by many media sources, including Jack E. White in Time magazine.]

**THE TAINTED VERDICT** [This was an editorial headline]: About the only phrase Johnnie Cochran Jr. uttered last week that rings true in reflecting on the Simpson trial is the idea of a "rush to judgment". There

can be no denying that conclusions were drawn well before the closing arguments—indeed, well before the evidence even was presented.... Why should racial bias—whether or not true—take precedence over determining guilt or innocence? And why would African-Americans be cheering in downtown Los Angeles after the not guilty verdict was announced? Perhaps it was foolish for us to believe that the predominantly African-American jury could ever remove itself from such a historical straightjacket—or that Cochran & Co. wouldn't try to capitalize on it. The clincher, of course, came when a verdict was reached in less than four hours. Given the weight of evidence against Simpson [WHAT evidence?—no matter how inept the investigatory techniques or dastardly the views of Mark Fuhrman—it's hard to defend such a quick-and-dirty deliberation. And as it was pointed out by the prosecution, if not Simpson, then whom? [That's a good question! Of course, it's unlikely we will ever be allowed to find out!]] So we are left with a country more divided than ever by race, a country where blacks and whites look at each other with suspicion, disbelief and contempt. [Perpetrators' mission accomplished!] [End of quoting.]

This barely scratches the surface of the propaganda that pervaded ONE issue of ONE newspaper. Those guys do not take it well when their plans go awry!


## JURY NULLIFICATION: MEDIA REVEALS POWER OF THE JURY

It seemed that a breath of fresh air had wafted through the mainstream media-polluted coverage of the O.J. trial—the issue of jury nullification. It's always good for this information to get out to the public, although in this case, it seemed to be used to DISCREDIT the jury. This article appeared before the verdict was heard, in the October 2 issue of THE BAKERSFIELD CALIFORNIAN, [quoting:]

LOS ANGELES (AP)—In the world of TV viewers-turned-legal-experts in the O.J. Simpson case, the term "jury nullification" is not yet part of the jargon. But it could become familiar if jurors who begin deliberations today decide to vote from their hearts instead of their minds. [See how cleverly they are creating damage control and covering themselves in the event that the jury reached a verdict of not guilty. They are misrepresenting the central concept of jury nullification as the right to make an emotional decision, rather than a logical one.] "Jury nullification means going outside the law, nullifying the law," Loyola University law professor Laurie Levenson said of the oldest legal concept in American law, dating to 1670. "It says, 'We

don't care about the evidence: our gut reaction is that this man should go free," she said. If there was one thing that made prosecutor Marcia Clark furious in defense lawyer Johnnie Cochran Jr.'s summation last

week, it was what she denounced as an "outrageous" demand for jury nullification.

Cases that have resulted in jury nullification often involved political causes, civil disobedience or—an

issue raised in the Simpson case—racism. Historically, it was a tool used by Southern white juries to avoid convicting other whites who had lynched blacks, Levenson said. They ignored the facts and voted from prejudice. [*Keeping the racial pot stirred up, aren't they!*] One of the earliest cases in which jurors defied the law was the 1670 unlawful assembly trial of William Penn for organizing Quaker meetings. The jury was told by the judge that they could be jailed if they failed to convict. Nevertheless, they acquitted. In 1740, John Peter Zenger, publisher of the *New York Weekly Journal* was jailed on a charge of seditious libel for satirizing the king's appointed governor for the British colonies. His lawyer, Andrew Hamilton, argued for jury nullification and won. [*You may have noticed the absence of jury nullification authorization in the jury instructions. In fact, the opposite is stressed: that the jury is obligated to judge according to the law as given by the judge. And how many people learned about this in civics class?*]

# Mental Flossing With The Basics

We are always urging discernment, but sometimes it's not so easy to sort things out. There can be no true discernment without correct basic guidelines. These basics should apply universally—whether you are trying to make sense of world "news" or your own life.

It is a thought-provoking process to examine the basics of your own life—the concepts out of which you operate, form opinions, and direct your energy. We all operate from such a set of beliefs—it's such an automatic process that most of us are unaware of its existence. Although our belief system is learned, it is more accurate to say it is mis-learned, because so many of our beliefs are absolutely false and/or not in our best interest. Several years ago, I compiled the following list of **BASICS** (by my perception) as a way of consciously guiding myself AWAY from old, worn out, habitual thought patterns that were NOT based upon Truth. I have found it to be a great tool for learning. When I pay attention to my thoughts and behavior in any situation, I have the opportunity to compare them with the **BASICS**. (This soon becomes an automatic process.) If I'm out of line, I am faced with a choice: correct myself or continue to reaffirm my own delusions. Experience has shown me that the latter path is a poor choice and that self correction is immeasurably rewarded.

What is your life but a continuous stream of thought-based choices? How does this list compare with your own set of basic beliefs?

## THERE ARE NO BAD THINGS

Everything is a learning experience. Everyone is in the process of learning. We learn by making mistakes. We need to make mistakes in order to learn (although it is best to learn from the mistakes of others!).

## THERE ARE NO VICTIMS

There is true justice in the universe. Your life is the manifestation of your thought. All things originate in thought. Everything happens for a reason. Things are rarely as they appear to be. What **APPEARS** to be a "bad thing" may be greatly enhancing the learning of those involved.

I am responsible for my life and everything that comes my way. No one can "make" me angry, happy, unhappy...but me. My life is my own creation.

## THE GOAL IS GOD

We graduate from this Earth-based school with a diploma in the thoughts of God. Through the learning process, through trial and error, we learn to let go of the thoughts of man (the ego). As we do that, little by little, we take on the thoughts of God (also called I AM or Infinite Intellect).

## GOD IS WITHIN EACH INDIVIDUAL

We are dual entities—God and man. We are inherently complete, all powerful, ONE, limited only by our own thought-based choices to be limited and separate. ## BIG BIRD JOINS HEADS OF STATE IN U.N. BRAINWASHING CAMPAIGN

From the September 17 issue of *PARADE MAGAZINE*, [quoting:]

Nearly every head of state in the world will be at the United Nations in New York on October 22-24 to attend a special meeting of the General Assembly. Kings and queens, presidents and prime ministers will be there to mark the UN's 50th anniversary.

And tomorrow Big Bird is scheduled to visit Leah Boutros-Ghali, wife of the UN secretary-general, to deliver letters from children around the world, wishing the United Nations a happy anniversary. It's part of a *Sesame Street* celebration that will reach preschool children in 86 countries and in 14 languages on October 23-27. In fact, teachers around the world are planning lessons on the history and work of the UN for a global teach-in. [*Just how much valid information do you suppose will be presented?*] The United Nations is providing curriculum aids to encourage teachers from preschool through college to devote several classes to the UN during the third week of each October. [*They always keep us on the edge of our seats during the last half of October!*]

While students study the UN charter—which was adopted in 1945, in the aftermath of World War II—today's leaders are expected to adopt a declaration reaffirming its principles of working together for world peace, security and social progress [*according to their own warped definitions*]. The declaration being drafted also includes at least three activities not considered in 1945: development (not just of industry but of human beings...their health and opportunities and futures), environmental action and democratization.

## U.N. SEEKS TO BORROW FROM WORLD BANK

From the September 27 issue of *THE ORLANDO SENTINEL*, [quoting:]

UNITED NATIONS—The United Nations, facing its most severe financial crisis in half a century, will try for the first time to borrow money from the World Bank for operating expenses, the organization's highest-ranking financial officer said Tuesday. Joseph Connor, the former chief executive of Price Waterhouse who is now United Nations undersecretary-general for administration and management, said Tuesday that a World Bank loan is only one of many ideas being explored "to lift from our shoulders the burden of debt" [*and place it on the shoulders of the citizens of the world, primarily of the U.S.*]

## UPDATE ON DANIEL NEW

From a Press Release issued on October 3 by Colo-

nel Ron Ray, P.O. Box 1136, Crestwood, Kentucky 40014, (502) 241-5552, [quoting:]

Schweinfurt—The U.S. Army informed members of the 3rd Infantry Division that they will be expected to be in U.N. uniform on Tuesday morning, 10 October 1995, preparatory to shipping out to Macedonia at the end of the month. Each soldier is to turn in two BDU (battle dress uniform) tops to have a United Nations patch and a red, white and blue American flag sewn on the shoulders. Instead of a helmet or a beret, a blue baseball-type cap with the U.N. insignia will complete the new U.N. uniform. Their U.N. Commander, a Finnish General, will arrive in Schweinfurt later in the month. Specialist Michael New, medic, remains firm in his conviction that something is fundamentally wrong with this change in uniform and the foreign allegiance it represents, particularly as Specialist New asks the Army how can an "All-Voluntary Army" soldiers constitutionally be placed by the U.S. President under the command of foreign officers, and under the strategic direction of the Secretary-General of the United Nations. Specialist New is reluctant to participate against his oath of enlistment to support and defend the *U.S. Constitution*. Specialist New has asked to see the "legal justification" for such a significant alteration of his uniform and allegiance, but to date nothing has been offered in writing. In the meantime, New stands on his oath, "to protect and defend the *Constitution of the United States of America...*"

New's position seems [ah, that's the rub] to have strong vocal Congressional support, including the Majority Leader of the U.S. Senate, Robert Dole, the Speaker of the U.S. House of Representatives, Newt Gingrich and Senator Phil Gramm, New's senior senator from Texas and a candidate for President. Although Specialist New met briefly while on leave with Senators Gramm and Dole personally on Friday, September 22, 1995, they do not appear to have followed up on their strong speeches by taking any action on the New case specifically. [Talk's cheap, especially for would-be presidential candidates.]

#### Historical Context—U.N. Military Operations (1948-1995)

Colonel Ray adds this quote from Ambassador Richard Starr, which appeared in *The Washington Times Commentary*, April 18, 1994, [quoting:]

"During its first 46 years, the U.N. became involved in only about a dozen peacekeeping missions. When Boutros-Ghali, a former Egyptian diplomat with no military experience, was elected U.N. secretary general in November 1991, the annual budget for peacekeeping amounted to \$700 million. Within the past 30 months the latter has grown 6.5 times, with the number of troops quadrupling. Under Mr. Boutros-Ghali, the U.N. has entered into 11 new operations and proposes seven additional ones (in Sudan, Bosnia, Sri Lanka, Solomon Islands, Zaire, Burundi and Afghanistan). If all are accepted, this would increase annual outlays to more than \$8.6 billion and bring the total number of U.N. troops to approximately 168,000."

#### POPE MAKES TIMELY VISIT

From the October 4 issue of *THE DAILY NEWS* (Los Angeles), [quoting:]

A healthier Pope John Paul II returns to the United States today with popularity ratings any politician

would covet. The pope began 1995 as *Time Magazine's* Man of the Year, his 12th appearance on *Time's* cover. His book, *Crossing the Threshold of Hope*, was a best-seller in 20 countries.

During his five-day visit, the pope will confer with President Clinton, address the United Nations General Assembly and preach to huge crowds at outdoor Masses in Giants Stadium in the New Jersey Meadowlands, at Aqueduct race track, on the Great Lawn in New York's Central Park and at Oriole Park at Camden Yards in Baltimore.

And from the October 1 issue of the same paper, [quoting:]

While the visit is being billed as pastoral—the shepherd of the world's 980 million Roman Catholics tending his flocks—theologians, public officials, and community leaders say that wider portents are unavoidable. The pope has become a leading figure of the century by transcending national and ideological boundaries and speaking out for peace and human rights. [He talks the talk.] Although the visit may not raise the huge emotional surges of 1979, it comes at a confluence of historic and social crosscurrents—the 50th anniversary of the United Nations, a time of dramatic shifts in American life...[in other words, he has great propaganda value at this time.]

And from a later issue of the same paper, [quoting:]  
Meanwhile, there are about 225,000 Communion wafers to be baked and stamped for various Masses, 75,000 rosaries to be blessed, tens of thousands of folding chairs to unfold, 320,000 square feet of carpet to unroll, thousands of flowers to place, 1,200 buses to load and unload, stages and altars to install.

"I'm very excited," said Maria Kobrinsky, 21, of Ventnor, N.J., who will trek to North Jersey to see him.

"Spiritually, I feel it will be uplifting." [What's spiritually uplifting about joining throngs of humanity to listen to platitudes-spouting by a robotic replicated humanoid? It helps to remember that we must all make mistakes in order to learn. Who among us HASN'T learned "the hard way" that appearances are deceiving—that what was portrayed as "God's Truth" turned out to be "man's delusion"? And isn't it hard to resist creating heroes and putting them up on a pedestal to work miracles for us—to rebuild our nation—to do God's work—whatever else we'd rather not do ourselves.]

By bringing together former leaders and other internationally influential players for the forum, organized by his San Francisco-based foundation, Gorbachev hopes to begin a thoughtful study of issues in a world no longer dominated by the two superpowers [but still dominated by the same behind-the-scenes Elite power groups]. In the city where the United Nations was founded 50 years ago, Gorbachev spoke intently of his hope for creating an entity that can help steer the world during this time of change—but slowly [and surely along the path created with the help of Gorby's sidekick, Henry Kissinger and other Khazarian schemers.]

# Nora's Research Corner

## Mystery, Babylon The Great

### FREEMASONRY

#### Part VII—Section 4 in a Series

*Editor's note: Part I of this series was in the 11/15/94 issue of CONTACT; Part II, Section 1 was in the 11/29/94 issue; and Part II, Section 2 was in the 12/27/94 issue; Part III was in the 2/7/95 issue; Part IV was in the 2/28/95 issue; Part V was in the 3/21/95 issue; and Part VI was in the 5/9/95 issue; Part VII, Section 1 was in the 7/11/95 issue; Part VII, Section 2 was in the 8/1/95 issue; Part VII, Section 3 was in the 10/3/95 issue; we are presenting Part VII, Section 4 here.*

This section is intended to clarify and add additional information to subjects discussed in previous parts of this series, and provide more information on what turn out to be controversial subjects: Albert Pike, Lucifer and the Palladian Rites.

### VICARIOUS SOLOMONIS

In Section 2 of this Article VII on Freemasonry I shared General Ludendorf's discovery regarding the Masonic roles of the leaders, rulers or monarchs as "Vicarious Solomons" under a head who is unknown except to them and must be of the "lineage of Solomon". Ludendorf gathered this information and also the information that the various countries are identified as "Provinces" in Masonry from the basic Constitution of Sweden. A confirmation of Ludendorf's information is to be found in Arthur Edward Waite's book, *A New Encyclopedia of Freemasonry, Two Volumes in One* (This book was a gift from a supporter and friend, N.M.; thank you.). In the section titled: "Masonic Chronology", pages 68, 69 and 77 (Vol. 2) there are the following entries (quoting):

1779. Duke Charles was placed at the head of the Order of Strict Observance in Germany, being the Seventh Province. [N: The Order of Strict Observance had been created for Aristocrats by Frederick the Great and Voltaire—see previous Sections 2 and 3 of this article.]

1780. King Gustave III erected a Ninth Province of the Order of the Temple of Sweden, and Duke Charles was installed as Vicar of Solomon.

1811. Charles XIII of Sweden resigned the office of Grand Master in favour of his adopted heir, afterwards Charles XIV, but remained Vicar of Solomon. (End of quoting.)

The above quotes were the only references of this nature to be found in Waite's chronology, but they at least partly confirm Ludendorf's information. Waite does not provide a separate bibliography, and the subject of "Vicar of Solomon" is not discussed in the text. His Masonic Chronology includes many, many listings of Monarchs, Princes, Dukes, Lords, Earls, etc., who established or were initiated into one or another branches of Freemasonry, a great many of whom became Grand Masters. The chronology covers the years 926 A.D. through 1917. The Grand Lodge of England is very prominent therein, with world-wide "legal" lodges.

### GRAND LODGES IN THE UNITED STATES

Two friends, P.C. and P.R. provided me with a bundle of information from the Freemasonry Archives,

revised 7/2/95, on the computer "Internet". One article by Art De Hoyos and S. Brent Morris titled: "Is It True What They Say About Freemasonry" assures us, according to these gentlemen, that the Masonic Grand Lodges hold all the authority in their jurisdiction (in other words, there are no secret superiors). On the other hand, they also tell us that if a lodge does not act according to approved standards it is not Masonic and can be ignored or pressured into shaping up (my words). What are the standards? According to Hoyos and Morris they "must trace their origins to a British Grand Lodge and maintain recognition among other Grand Lodges"! (How this recognition is maintained is not stated.)

So—there you have it, right off the Internet. By extrapolation this probably means it is the Masonic hierarchy of Britain and/or the Grand Masters of the "lineage of Solomon" that will be causing the Freemasons and their affiliates of the United States to promote the "New World Order"—all Grand Lodges must go along, it appears, or be declared a maverick by the rest of them.

There is one Grand Lodge in every State of the United States. A listing with the addresses of each is also provided by the Internet (see bibliography). The names of the Grand Masters are not on the list. (You may be interested to know that some Masons are now arguing on the Internet that Masonry is not a secret society, only a fraternity with secrets! I guess that includes the names of the Grand Masters.)

### FREEMASONIC CANVASSERS

A lady from Texas questioned the statement, found in Section 1 of this article, that Scottish Rite Freema-

sons and Rebeccas would be starting their campaign across the United States promoting the "New World Order". Her concern was that the women's order affiliated with the Scottish Rite Freemasons is called the "Order of the Eastern Star". I was able to reach Ronn Jackson by phone for clarification of his statement in this regard. Ronn states what he intended to convey was that all of the Masonic groups and their related family groups will be doing the canvassing. Further, it will be the underlings, not the higher echelons, out going door-to-door. I apologize for not catching and preventing any misunderstanding. I have not researched all of the various affiliated groups of Masonry. Nevertheless, in that bundle of material from the Internet, an article titled: "Masonic FAQ (Frequently Asked Questions) Introduction", provides information on Freemasonic affiliates. The following is a non-verbatim listing from this article:

They are:

**The Order of Eastern Star**, an adoptive rite of Freemasonry for women over 18 years of age related to a Master Mason in good standing. This includes wives, widows, sisters, daughters, mothers, granddaughters, step-mothers, step-daughters, half-sisters, nieces, daughters-in-law and grandmothers.

**Order of De Molay**, for young men between the ages of 13 and 21.

**Rainbow Girls**, the complement of De Molay.

**Acacia**, a college fraternity

**Order of Amaranth**

**Daughters of Mokama**

**Daughters of the Nile**

**Desoms**

**Grotto**

**Job's Daughters**

**High Twelve International**

**National Sojourners, Inc.**

**Philalethes**

**Royal Order of Scotland**

**Tall Cedars of Lebanon**

**White Shrine of Jerusalem**

It appears the Rebeccas are affiliated with the Masonic splinter group of Odd Fellows. There are also

the Shriners, the Druids, etc. In other words a very large assortment of people of various ages and focus are intended to do the canvassing.

The lady from Texas is 90-years old and proud of her work with the Masons. I have no doubt she speaks truly for herself, nor that most Masons feel the same way. The rather large question is: have they, along with the rest of us, been terribly deceived?

If the information Ronn Jackson has obtained is true, and if the plan is not dropped due to publicity, then the Masons and all of their affiliates, as well as the rest of the United States population must come to realize that the old Masonic propaganda that the lodges are non-political and non-religious are all LIES! They are a secret society whose present secret superiors plan to overcome and take dominion of the world usurping all legitimate governments and creating a One-World religion—proving exactly what the anti-Mason authors have warned about all along.

### ALBERT PIKE AND THE WORSHIP OF LUCIFER BY HIGH DEGREE MASONS, AND THE PALLADIAN RITES

That bundle of material from the Freemasonry Archives on the Internet included several articles on Albert Pike and what is called a hoax regarding the reported statement of his to the effect that specially selected groups of high degree Masons worship Lucifer, groups involved in the Palladian Rites. One article starts with the words (quoting):

Taxil's hoax concerning Albert Pike and Lucifer. Dr. Robert A. Morey parts company with most of his fellow anti-Masons on this issue. (End of quoting.)

I was unable to see where Dr. Morey was "anti-Mason" from this article, but be that as it may be. Dr. Morey informs us about the "hoax" perpetrated by a man using the pen name of Leo Taxil, who supposedly wrote the "fictional" statement credited to Albert Pike regarding the worship of Lucifer among some of those Masons in the 30th, 31st & 32nd degrees, Scottish Rite. Dr. Morey denounces Lady Queensborough (Edith Starr Miller) who uses the quote in her book, *Occult Theocracy*. This is the same quote used by Gary H. Kah, in his book, *En Route to Global Occupation*, which I reviewed in an earlier article on the "Beast" in this series. Lady Queensborough had quoted from an article by A.C. De La Rive in *La Femme et l'Enfant dans la Franc-Maconnerie Universelle (Woman and Child in Universal Freemasonry)*. Apparently, De La Rive's article had been taken from a work by Leo Taxil, who later repudiated his work as a hoax! Subsequently, A.C. De La Rive is reported to have also repudiated the article. There are numerous references used by Dr. Morey to support his Internet article, works of others who have described and reported the events perpetrated by Leo Taxil.

I was able to locate the reference by E. Sidney Hartland in the *Encyclopedia of Religion and Ethics*, subject "Satanism", also an article on the "Palladian Rite" by Arthur E. Waite in his *The New Encyclopedia of Freemasonry*. It is true, these two articles relate the story of how Mr. Taxil, who was a Freemason for a short period before he was ousted, was very resourceful in writing articles to pique the public's interest. In fact, there was said to be an entire series of articles by himself and a Diana Vaughn relating how she was a member of Women's Freemasonry (a Palladist), supposedly met Lucifer, and was prepared to marry "Asmodeus". Shortly before the marriage occurred she became "converted to the Catholic faith" and became the subject of a great deal of attention by the Church and arranged media publicity, all bringing in profits to Leo Taxil. Later, after he was "unable" to produce this "Diana Vaughn", Mr. Taxil admitted it was all a hoax intended to embarrass the Catholic Church which had taken quite an interest in the conversion of "Diana Vaughn", supposed sister of the mystic "Thomas

Vaughn", etc. Leo Taxil was said to be anti-Masonic and anti-Catholic, and had used this means to harm both institutions, as well as support himself through his writings. All of the above is said to have included numerous articles, several public meetings, correspondences with high Catholic officials over many months, and eventually tarnished other anti-Mason authors with Taxil's now-tainted image.

Of course, the story is not trustworthy because Leo Taxil has proved himself untrustworthy, whatever the media reports on the situation reveal. Further, it is highly unlikely that any high ranking Catholic official would have fallen for a story that Diana Vaughn was a "sister of the Mystic, Thomas Vaughn". Thomas Vaughn was a famous Rosicrucian who lived in the middle of the seventeenth century, well over a hundred years before Leo Taxil. (Ref.: *Secret Societies and Subversive Movements*, pg. 316; *The Secret Teachings of All Ages*; and *Fame and Confessions of the R.C.* by Eugenius Philathes [Thomas Vaughn], printed in London, 1652, available from Kessinger Catalog in the Freemasonry Archives on the Internet.)

The story involving "Asmodeus" and Diana Vaughn is quite bizarre, and bears little relevance to the material from either *Occult Theocracy* or *En Route to Global Occupation*. Further, "Asmodeus" is "an evil spirit (in Jewish demonology)" (Ref: *American College Dictionary*), and was not mentioned in the Albert Pike "quote".

I would like to provide the entire quote as given in Edith Starr Miller's book, *Occult Theocracy*, and make further comments upon it. Her material is taken from the A.C. De La Rive article, but is a slightly different translation from, and less complete than, that translated by Eric Serejski and credited to De La Rive by Dr. Morey. There is not space to show both translations. Those who want the complete article by Dr. Morey can obtain it from the Internet. (Quoting: pages 220 and 221:)

The technological dogma of Albert Pike is explained in the "Instructions" issued by him, on July 14, 1889, to the 23 Supreme Councils of the world and have been recorded by A.C. De La Rive in *La Femme et l'Enfant dans la Franc-Maconnerie Universelle* (page 588) from which book we translate and quote as follows:

"That which we must say to the crowd is—We worship a God, but it is the God that one adores without superstition.

"To you, sovereign Grand Inspectors General, we say this, that you may repeat it to the Brethren of the 32nd, 31st and 30th degrees—The Masonic religion should be, by all of us initiates of the high degrees, maintained in the purity of the Luciferian doctrine.

"If Lucifer were not God, would Adonay (The God of the Christians) whose deeds prove his cruelty, perfidy, and hatred of man, barbarism and repulsion for

#### BAPHOMET, THE GOAT OF MENDES.

The practice of magic—either white or black—depends upon the ability of the adept to control the universal life force—that which Eliphas Levi calls the great magical agent or the astral light. By the manipulation of this fluidic essence the phenomena of transcendentalism are produced. The famous hermaphroditic Goat of Mendes was a composite creature formulated to symbolize this astral light. science, would Adonay and his priests, calumniate him?

"Yes, Lucifer is God, and unfortunately Adonay is also God. For the eternal law is that there is no light without shade, no beauty without ugliness, no white without black, for the absolute can only exist as two Gods: darkness being necessary to light to serve as its foil as the pedestal is necessary to the statue, and the brake to the locomotive.

"In analogical and universal dynamics one can only lean on that which will resist. Thus the universe is balanced by two forces which maintain its equilibrium: the force of attraction and that of repulsion. These two forces exist in physics, philosophy and religion. And the scientific reality of the divine dualism is demonstrated by the phenomena of polarity and by the universal law of sympathies and antipathies. That is why the intelligent disciples of Zoroaster, as well as, after them, the Gnostics, the Manicheans and the Templars have admitted, as the only logical metaphysical conception, the system of the two divine principles fighting eternally, and one cannot believe the one inferior in power to the other.

"Thus, the doctrine of Satanism is a heresy; and the true and pure philosophic religion is the belief in Lucifer, the equal of Adonay; but Lucifer, God of Light and God of Good, is struggling for humanity against Adonay, the God of Darkness and Evil."

One must not lose sight of the fact that Pike occupied simultaneously the positions of Grand Master of the Central Directory of Washington, that of Grand Commander of the Supreme Council of Charleston and that of Sovereign Pontiff of Universal Freemasonry.

(Pages 233 and 234:)

As regards the position of women in Masonry, we think that this cannot be better explained than in the words of Albert Pike himself. In *La Femme et l'Enfant dans la Franc-Maçonnerie Universelle* page 578, A.C. De La Rive states that on July 14, 1889, Albert Pike, Sovereign Pontiff of Universal Freemasonry, addressed to the 23 Supreme Confederated Councils of the world the following instructions, which we quote here-with in part:

"To the science of Faust, the real Mason will join the impassibility of Job. He will eradicate superstition from his heart and cultivate decision of character. He will accept pleasure only when he wishes it and will wish it only when he should do so.

"We earnestly recommend the creation of Lodges of Adoption. They are indispensable to the formation of Masons who are indeed Masters of themselves. The priest tries to subdue his flesh by enforced celibacy... The real Mason, on the contrary, reaches perfection, that is to say achieves self mastery, by using his zeal in Lodges of Adoption in submitting to all natural ordeals. Commerce with women, belonging to all brethren, forms for him an armour against those passions which lead hearts astray. He alone can really possess voluptuousness. To be able, at will, to use or to abstain, is a twofold power. Woman fetters thee by thy desires, we say to the adept, well, use women often and without passion; thou wilt thus become master of thy desires, and thou wilt enchain woman. From which it must perforce result that the real Mason will succeed in easily solving the problem of the flesh.

"It is evidently not absolutely necessary that the man whom you are leading towards the high grades be immediately perfect and have understood our secret on his entrance into Masonry. That which we ask you is first to observe him with the greatest care during his apprenticeship and afterwards, when he enters the Lodge of Adoption as Companion to use that as your criterion, your instrument of infallible control.

"The Lodge of Brothers which has failed to annex a Lodge of Sisters is incomplete and destined inevitably never to produce anything but Brethren, with whom politics are the chief concern, men who will be chiefly preoccupied with intrigue and rivalry, who will do bad

work and whose politics will be incoherent." (End quote)

There is a footnote to the De La Rive's article which Dr. Morey claims was part of the original article but was not used by Edith Starr Miller. (Quote:)

It was the Sister Diana Vaughn that Albert Pike, in order to give her the greatest mark of confidence, charged to carry his Luciferian encyclical, to Paris, during the Universal Exposition. (End of quoting.)

Dr. Morey uses this footnote to further tie the fictional story of Diana Vaughn to the Albert Pike "quotes" and Leo Taxil's "hoax".

I can readily see where this "footnote" is an imposture: (1) Since the women's order was secret, as was the Palladian Rites, why would "Diana Vaughn" be bringing secret documents to a "Universal Exposition"? If the documents were intended for a large group, why the secrecy? (2) Why would Diana Vaughn need or warrant Albert Pike's mark of confidence, and why would anyone, good or bad, put such volatile material in the hands of any second party simply as a "mark of confidence"? (3) Consider the times of Albert Pike—middle to late nineteenth century, and the improbability that a woman would be traveling alone from America to France at that time. It is not impossible but is unlikely. I accept the probability that this footnote is spurious, along with the serialized story of Diana Vaughn, Asmodeus, etc.

Not having been around at the time, what do I conclude from all this? I'm afraid there is now little solid ground on which to stand regarding the above quotes, widely reported to be repudiated by Taxil, except for several other supportive bits of information. Whatever the truth as to Albert Pike's "supposed statements" reported by Taxil and De La Rive the words used sound very much like those of Pike. Also there are works of others and Pike himself in his book, *Morals and Dogma*, which clearly point to that "worship" of "Baphomet" by the Masons, an image identical to that used by the Satanists. Pike also followed in time sequence on the heels of Adam Wieshaupt who instigated the women's lodges—some were similar to the present adoptive lodges for women and some followed the secret lodges as described above in the book, *Occult Theocracy*. The fact there is no record of such a lodge in Charleston, as pointed out by Dr. Morey, is no proof one did not exist.

It is very interesting that the "false" quotes attributed to Pike by Taxil follow the code of Wieshaupt very closely. Nesta Webster, in her book, *World Revolution*, states on page 287, (quoting):

The Bolshevik revolution has in fact followed out the code of Wieshaupt in every point—the abolition of monarchy, abolition of patriotism, abolition of private property and inheritance, abolition of marriage and morality, and abolition of all religion. (End of quoting.)

Dr. Morey points to the number of Christians and upright people who are Masons and who would not tolerate such goings on as described above. Certainly, I believe most of the Masons are as he describes. What I don't believe is that they are aware of every thing involved in Freemasonry or that they have been allowed to become aware of everything—their time, and that of their family, is so taken-up by the work of the lodge that there is no time for many other pursuits, they are taught to ignore anti-Masonic literature, and the activities of the higher grades are kept secret.

In order that you may compare the unchallenged words of Albert Pike with the challenged quotes given above in Edith Starr Miller's work, I present the following from Pike's book, *Morals and Dogma*. I believe the two bear a marked resemblance (quote:)

1. (page 734): "There is in nature one most potent force, by means whereof a single man, who could possess himself of it, and should know how to direct it, could revolutionize and change the face of the world.

"This force was known to the ancients. It is a universal agent, whose supreme law is equilibrium;

and whereby, if science can but learn how to control it, it will be possible to change the order of the seasons, to produce in night the phenomena of day, to send a thought in an instant round the world, to heal or slay at a distance, to give our words universal success, and make them reverberate everywhere.

"This agent, partially revealed by the blind guesses of the disciples of Mesmer, is precisely what the adepts of the middle ages called the elementary mother of the great work. The Gnostics held that it composed the igneous body of the Holy Spirit; and it was adored in the secret rites of Sabbat or the Temple, under the hieroglyphic figure of Baphomet or the hermaphrodite Goat of Mendes... With this electromagnetic ether, this vital luminous calorie, the ancients and alchemists were familiar.

2. (page 818): "It is absurd to suppose that men of intellect adored a monstrous idol called Baphomet, or recognized Mahomets as an inspired prophet. Their symbolism, invented ages before, to conceal what it was dangerous to avow, was of course misunderstood by those who were not adepts, and to their enemies seemed to be pantheistic." (End of quoting.)

Please see the picture of Baphomet (aka the Goat of Mendes) also attached. It is taken from Manly Palmer Hall's book, *The Secret Teachings of All Ages*. (Mr. Hall was a very high-degree Mason.)

The above quotes were included in my article "He Goats and a Little Horn", contained in my book, *The Garden of Aton*. In that article I show how the biblical symbolism of the He-Goat is related to Chief princes—this is what they were called! According to the biblical prophecy of *Daniel*, chapter 8, the Great "He-Goat" of this prophecy was Alexander the Great of Greece. Also, according to this prophecy, it will be from the descendants of the four leaders who shared Alexander's dominions after him that the anti-Christ (that little horn) of the end time will come. The fact that all these "elite" have purposely intermarried with each other and are to be found in almost every country, as well as the fact that these same "elite" are heavily involved in the hierarchy of International Masonry should give everyone pause—not to mention the further facts that the "goat-god" is part of Freemasonry; that the Khazars (also known as Goths and Ashkenazi Jews) come from Gothland (aka Goatland); and that the goat is a biblical symbol of the adversary.

Edith Starr Miller (page 226) knowing that many of the anti-Mason authors had been discredited (by Taxil's "hoax"), used a quote regarding a human initiation from Alice Bailey's book, *Initiation Human and Solar*, Published by the Lucifer Publishing Co. N.Y. (1922), page 106, to show that part of what Pike was talking about was not unknown or unused by others of similar persuasion, yet had not been discredited.

In fact, the initiation ceremony quoted from Alice Bailey's book involves the use of an equilateral triangle, enclosed by a circle of "adepts", for the invocation of the "god". You may recall that General Erich Ludendorff advised us (see Section 2 of this article in the 8/1/95 issue of *CONTACT*) that, to the Masons, "the even-sided triangle represents the creative power of Jehovah". (!!) You may also remember that Mazzini and Pike gave the name of "Triangles" to the lodges using the Palladian Rite (See my article in the 5/9/95 issue of *CONTACT*.) Further, you may be surprised to learn that the "god" invoked is a "blue-white flame, which burns but destroys not"! With this we have arrived at an entirely new meaning to, and reason for, the use of the blue and white colors by Benjamin Creme's "Maitreya", Lucis Trust, the Flag of Israel, and the United Nations. Blue and white are the colors of their "god", invoked by the use of the equilateral triangle inside the circle of adepts. The comments by Alice Bailey on this initiation ceremony indicate, as Edith Starr Miller states, that the "god" is a "good god". Nevertheless, if this same "god" sends his troops to annihilate you, you will know "he" is not God, Who is One, Who is Light, and Who is the Creator—Whose

Laws include the one "Thou shall not kill". (I shall have more to say regarding the use of the blue and white colors in Freemasonry in the next concluding Section 5 of this article.) The Lucis Trust was the only "religious" group allowed offices at the United Nations for many years. Why this is so was never made clear.

It is clear that the Bosnians and others in Yugoslavia today are tragically learning that the "blue and white god" or the United Nations' colors and troops, are not the good guys. Keep in mind that the international headquarters of the United Nations, the World Bank and Freemasonry are all located in one huge, magnificent, complex building in Geneva, Switzerland. Their long-time hidden and inward connections are now outwardly professed for all the world to see. According to Nostradamus it is the anti-Christ in the "blue turban" who will fight the returning Christ (Esu/Immanuel—now known as Sananda) in the battle of Armageddon. Further, Hatonn has said that the United Nations forces with their blue hats are the ones indicated by Nostradamus. The name of the person actually heading the United Nations and/or the anti-Christ faction, is not known at present. Nostradamus tells us the anti-Christ will have the next-to-the-last name of Mohammed, which turns out to be "Abdallah" (aka Abdullah).

The Lucifer Publishing Co. is now called Lucis Trust. You can locate a recent edition of Alice Bailey's book through the *Books-In-Print Directory*. It is certainly a sign of the time (1922) that the publishing company could use the name Lucifer and get away with it. Those of you who have read my other articles in this series will know that the works of Alice Bailey, Lucis Trust, Madame Blavatsky, etc., reveal a close alignment with Gnosticism, the *Caballa*, Masonry, Lucifer as the "Light Bearer", and Benjamin Creme's Maitreya. Everything is related.

To return to the idea of Lucifer and Pike's supposed fictitious quotes about him, consider further how the ideas in these quotes closely follow various brands of Gnosticism, the *Babylonian Talmud* and the *Caballa*, which are part of the "traditions" of Freemasonry!

What I am suggesting here is that, whatever the truth regarding Leo Taxil's part in the publishing of words claimed later to be falsely ascribed to Albert Pike, what was said has some precedents in the work of Pike and others, except for the serial yarn of Diana Vaughn's escapades. Given the period of Pike's leadership of Freemasonry (a time when the people of the United States had recently relaxed their long-term, anti-Masonic stance after the Mason, Captain Morgan's murder due to his revelation of the Masonic rituals in

1826, and the therefore urgent need to maintain the acceptance of Freemasonry in the United States by the European and Jewish Secret Superiors), I am inclined to hold open the possibility that Leo Taxil's "hoax" was itself a hoax designed to cover-up or disclaim some leaks in information about Albert Pike's doings, which could have caused further problems. It is clear from the quotes out of Pike's *Morals and Dogma*, given above, that not all of Pike's ideas would have been acceptable to most people—Masonic propaganda to the contrary. To be fair, I must say, many Masons would like Albert Pike's memory to be buried, once and for all. One frequently hears as rebuttal from Masons who disagree with what one of their members have said, that "no one speaks for Freemasonry". And—this is true! Although most lodges do receive "approved" itinerant lecturers which help to carry the same messages to all the lodges. The real heads of Freemasonry are all Secret! However, given the above "easy out" any one can "legitimately" deny anything said by even a 33° Mason—so what is this all about anyway?

Consider the possibility that what Leo Taxil did (or is reported to have done) really protected Freemasonry from a public outrage at the time, and still today, through articles like the one by Dr. Morey—that it was the Secret Superiors of the lineage of Solomon at the head of Freemasonry who hired Taxil to both protect Masonry and also embarrass the Catholic Church. The use of public media and forums has long been a tool of the "Elite" for public control and requires contacts and money. Who was Leo Taxil to rate such costly notoriety—a nobody with nothing to lose, apparently from the story—yet even the Pope (Leo XIII) got involved in this? It is also curious indeed that De La Rive's publication appears to have been a Masonic one. (In my opinion, that Jewish demon, Asmodeus, may certainly be a clue to the perpetrators. After all, Solomon's Seal is supposed to have control of demons, and is all part of Jewish Gnosticism, *Caballa*, the *Babylonian Talmud* and Freemasonry.) I suggest, those who are able, read the works of Nesta H. Webster, also Robinson's book, *Proofs of a Conspiracy*, for more confirming information on Masonic history. These authors were not tainted by Taxil's dubious activities.

There are additional items to share regarding what has been said about the Palladium Rites and Albert Pike. I will quote from pages 214 and 215 of *Occult Theocracy* (quoting:).

From letters scattered through different Masonic archives, it is evident that Mazzini formed his great project after 1866. The grand patriarch of the sect in Europe, Lord Palmerston, had died. Convinced that the

power he had wielded was purely the result of personal influence with the different chiefs and that, not being based on an efficient organization it was unlikely to endure, Mazzini set himself to study the problem of the international organization of Freemasonry, and in 1870 reached an agreement with Pike for the creation of the Supreme Rite.

The Franco-Prussian war, which, enabled the King of Piedmont, already called King of Italy, to take Rome, favoured the abolition of the temporal power of the Pope, and at this time the constitution of central high Masonry was decreed and signed between Albert Pike and Giuseppe Mazzini. The act of creation is dated Sept. 20, 1870, the day upon which the army of invasion, commanded by the Freemason, General Cadorna, entered the Eternal City.

The two founders divided their powers according to the following plan. To Pike was given dogmatic authority and title of Sovereign Pontiff of Universal Freemasonry, while Mazzini held the executive authority with the title of Sovereign Chief of Political Action. Mazzini evinced great deference towards the views of the patriarch of Charleston and begged him to draw up the statutes of the grades of the Supreme Secret Rite which would thus be the liturgic bonds of the members of centralized high masonry.

Albert Pike, in honour of his Templar Baphomet, which was in the keeping of his first and historic Supreme Council, named the order the *New and Reformed Palladian Rite* or *New and Reformed Palladium*. (Footnote: In his *Cyclopedia of Fraternities* Stevens writes that the "Order of the Palladium" was founded in 1730 and soon afterwards introduced in Charleston where it remained inactive until 1886. It blossomed anew under the name of "Reformed Palladium" and gave a new impulse to the traditions of High Masonry. Stevens adds that the Palladium is little known as the number of its members is strictly limited and the deepest secrecy surrounds all its deliberations.) (End of quoting.)

I was able to locate another brief article on "Palladium, Order of the" on pg. 281 of Robert Macoy's *Dictionary of Freemasonry* (quoting:)

The date of the origin of this society is unknown. It first appeared at Douay, France. Its rituals and statutes are ascribed to Fenelon; the rules admitted both sexes to membership; its professed objects were spiritual and moral improvement. The male members were called the "Companions of Ulysses", and the female the "Sisters of Penelope". The seal of the order was a heart, crowned with flowers, upon an altar, ornamented with a garland, with a branch of laurel at the right, and

another of palm, at the left. Upon the heart was the inscription: "Je sais aimer", I know how to love. This device and the intimacy which prevailed between the Companions of Ulysses and the Sisters of Penelope indicate with sufficient plainness the certain end and principal object of the order of the Palladium. Its existence was of short duration. (End of quoting.)

Whether Fenelon was the one who set-up such an Order is very doubtful indeed. He was a Catholic and a Christian theologian. (See Nesta Webster's *Secret Societies and Subversive Movements*, pg. 144, also *American College Dictionary*, subject: Fenelon. He died in 1715.)

Please note the use of the title of Sovereign Pontiff of Universal Freemasonry for Albert Pike. This is a title questioned by Dr. Morey as to its legitimacy in the material claimed by Taxil to be a hoax. Dr. Morey states there never was such a position. How would he know, if it was kept secret?

Also note that the name Palladium is associated with the Templar idol Baphomet (aka the Goat of Mendes), which was a supposed relic kept at Charleston! How the Palladium Rite came to be linked with Baphomet and the secret Sister Orders is still not clear to me except possibly through Wieshaupt's leadership, and/or the accounts of the Osirian rites of Egypt involving the Goat of Mendes (which was a phallic worshiping cult at Mendes, Egypt, involving women and a goat. What is important to remember here is that, according to Hatonn, Adam Wieshaupt was the "old boy himself", Lucifer in incarnation. This makes a great many of the almost unbelievable revelations which came later (Wieshaupt died in 1830) more comprehensible and shows their relatedness under Wieshaupt's Code.

If you reread Wieshaupt's Code given above you will also see that "abolition of patriotism" is part of it. Section 5 will conclude this article on Freemasonry with ending comments from General Erich Ludendorf's book, *Destruction of Freemasonry Through Revelations of Their Secrets*, pertaining to the reason women are not admitted to the regular Masonic lodges, and the meaning of the blue and white colors to Masons.

# Health Update

Have you checked your emergency food supplies lately? Recently, I was dismayed to discover that my supply of brown rice—240 pounds of it—was rancid, and fit only for pigs and chickens. Although I had read that rice had a long shelf life, it dawns on me now that they must have been referring to processed white rice. It prompted me to research the shelf life and optimal storage techniques for various food items. Three sources

of this information were *Making the Best of Basics, Family Preparedness Handbook* by James Talmage Stevens, *The Alpha Strategy* by John Pugsley, and a Mormon-published book called *Family Preparedness*.

## WHERE TO STORE

A cool, dry room is ideal—the basement, garage, or a cool room in the house or closet. North-facing rooms are obviously better because they are cooler.

## SHELF LIFE FOR VARIOUS FOODS

**SEEDS:** Nature designed seeds to remain viable for many seasons, and they form a significant part of our diet. Grains like spelt, wheat, oats, rye, barley, and millet, legumes like dried peas and beans, and sprouting seeds like alfalfa will keep for 10 years or more if properly stored. They should be kept dry and as cool as possible, preferably in airtight containers.

Most seeds contain oil, and for this reason it is best to store grains whole, without crushing. Once milled, grains are not only more susceptible to insects, they can also turn rancid as the oil is exposed to air when the seed is crushed. Wheat, for example, will keep for at least a decade if properly stored; however, whole grain flour has practically no nutritional value after being stored for 30 days at room temperature. When buying whole grain flour from the store, buy only if it has been refrigerated, and be sure to keep it refrigerated until used.

Seeds with a limited shelf life include brown rice (6 months) and peanuts (a few weeks). Pasta products, stored dry, airtight, and cool, will last five years or more. It is recommended they be stored with bay leaves or covered with salt to discourage insects.

**CANNED GOODS:** Certain canned goods may keep for several years. Acidic canned foods have the shortest shelf lives, and manufacturers recommend that they be used within one year. That would include canned fruits such as pineapple and grapefruit, canned spinach and tomatoes. Tuna and most canned vegetables such as potatoes, yams, corn, carrots, and beans will last two or three years without substantial deterioration if stored in a cool, dry place.

**MISCELLANEOUS FOODS:** Sugar, although devoid of nutrition, lasts forever. Honey and salt also have indefinite shelf lives. Oil has a shelf life of 2 years if kept in its original, sealed container; olive oil lasts longer than most others.





# Scientific Fundamentals For The Enquiring Mind

*Editor's note: This is the continuation of a scientific "course" that Commander Hatonn started teaching on pgs. 42-53 of the 9/19/95 issue of CONTACT and was continued in the 10/3/95 issue on p. 23.*

More and more frequently you will be left in the ignorance of that which goes on around you as you are going to be buried in hyperbole and sophisticated antics by "authorities" and "experts" who can swamp you in DNA blather until the cows come wearily home. The FACTS will always remain that tampered evidence will always present WRONG conclusions. That is the very terror awaiting you. I feel it continues to be my miserable task to get you some level of informed knowledge on the basics of LIFE STRUCTURE so that you can begin to be an informed person in your own life-stream. Boring? Perhaps, but I cannot see how your own structure could bore you. Without knowledge you have and can be NOTHING save pawns and puppets.

Therefore, let us try another short writing on definitions and discussion on:

## UNITS FOR LIFE REPRODUCTION: CELLULAR ASPECTS

### PREVIEW QUESTIONS

1. It appears to be a truism that death must come to all living things. How can you reconcile this fact with the observation that life has persisted on Earth for at least two billion years?
2. If you were given the task of designing a machine that could reproduce itself, what basic elements would you build into it? Are any such machines in existence? What advantage would such machines have, as compared to ones that can only be repaired?
3. In a mountain camp, two small children found four baby mice in a box filled with old papers and other litter. They decided that the babies must have originated from the litter, because no mother was to be seen and they had found motherless baby mice in a similar situation earlier. Have grown-ups ever believed such nonsense? Do living things ever arise spontaneously from nonliving material?
4. Suppose you had four tapes of information that you wished to duplicate exactly and distribute evenly in groups of two. What sort of mechanism could you devise to accomplish this most efficiently?
5. A man has 46 chromosomes in the nucleus of most of his cells; so does a woman. If a new offspring is the product of a cell from each mate, why does the offspring only have 46 chromosomes in the nuclei of his cells, instead of 92?
6. Cells multiply by dividing. What is involved in this neat trick?

### TERMS

**SEMEN:** A thick fluid ejaculated by the male during copulation composed of a suspension of sperm cells.

**SPERM:** The male sex cells or gametes, also known as spermatozoa.

**OVA:** The female sex cells or gametes, also called egg cells.

**FERTILIZATION:** The union of a sperm cell and an egg cell to form a fertilized egg or zygote. More precisely, the union of the sperm cell nucleus with the egg cell nucleus to form a single zygote.

**BIOGENESIS:** A basic biological concept that all life comes from preexisting life. This means that, as far as can be determined at the present time, spontaneous generation does not occur.

**MITOSIS:** Specifically, a form of nuclear division during which the duplicated chromosomes are exactly distributed to the two resulting daughter nuclei. The term is also used in a general sense to refer to ordinary cell division.

**INTERPHASE:** The stage in the life cycle of the cell when chromosomes are not discretely visible. The synthesis and duplication of DNA occur during this phase, which can be divided into G<sub>1</sub>, the nonmitotic stage of normal metabolic activity; S, the stage of DNA duplication; and G<sub>2</sub>, the second gap stage just preceding the visible stages of M (mitosis). Thus, the cell cycle follows the pattern G<sub>1</sub> → S → G<sub>2</sub> → M, with G<sub>1</sub> normally being the longest period in the cycle.

**PROPHASE:** A stage in the mitotic cycle during which the chromosomes become distinct and the spindle apparatus forms. In animal cells, the centrioles divide and migrate poleward.

**METAPHASE:** A stage in the mitotic cycle during which the chromosomes line up in an equatorial plane at right angles to the spindle.

**ANAPHASE:** A stage in the mitotic cycle during which the chromosomes separate and migrate toward the polar regions of the cell.

**TELOPHASE:** A stage in the mitotic cycle during which the duplicated and separated chromosomes are formed into two new nuclei. Cytokinesis usually accompanies this stage in mitosis.

**CHROMOSOMES:** Dark-staining threadlike bodies in the cell nucleus; they are known to be the gene-containing nuclear structures. The chromosomes become conspicuous during mitosis and meiosis. Each species has a characteristic and constant number of chromosomes.

**CENTROMERE:** The region of a chromosome where the spindle fiber is attached during mitosis.

**HOMOLOGOUS:** "Same formed" or in agreement. Here it refers to maternal and paternal chromosomes that are similar in appearance and pair during meiosis.

**DIPLOID:** A double chromosome number, i.e., twice the chromosome number characteristic of the ga-

mete of the species, often designated the  $2n$  number of chromosomes. The result of gametic fusion; i.e.,  $n + n = 2n$ .

**HAPLOID:** The chromosome number characteristic of the gamete of the species, often designated the  $n$  number of chromosomes. Haploidy is the result of meiosis, during which the diploid chromosome number ( $2n$ ) is reduced by half ( $n$ ).

**MEIOSIS:** Specialized cell division, occurring during the life cycle of an organism, that leads to a reduced number of chromosomes (haploid or  $n$ ) in the gametes.

**SYNAPSIS:** The pairing of homologous chromosomes during prophase of meiosis.

### PROGRAMMED UNIT: THE PROCESS OF MITOSIS

1. Cells multiply by dividing—cell division does not normally occur as just a single splitting in two however. Complex events occur in the \_\_\_\_\_ of the cell, which we now know is the center of hereditary control activities.







On occasion my visions become sensory at which time I can not only see a probable future event, but I can hear and feel the experience as well. Visions can take me on journeys to ancient civilizations, to life in outer space, or to future events. Somehow, I am able to enter a *timestream*, traveling backwards or forwards, until it stops and I find myself at some point in time. While on these journeys I maintain my full awareness and all my senses. If people are present when I arrive they seem to have no awareness of me. It has taken some time for me to become accustomed to this form of travel. A casual thought such as, "I wonder what it is like up there?" would result in my being there before I consciously completed the thought. I have no awareness of time. Only thoughts merging into other thoughts, very similar to lucid dreaming.

Most recently, after a pilgrimage of sorts to the Great Pyramid of Giza, I experienced such a timestream journey. This time however, it was different in that a "presence" was a part of the experience. This presence read my thoughts and questions and responded to them—through a voice that I could hear in my mind—much as a master teacher might. It was as if all knowledge was accessible to this presence. I say presence as I can only describe it as an intelligence without form. Since my first contact of this type, in Egypt, this presence has identified itself as my monad. As I understand it, a monad is the totality of our being: everything we are now, have been in past lives, or are building for future lives. This totality then is a portion of a greater consciousness.

Timestream journeys occur without notice. I have never been able to force one. It happens when I least expect it and often at the most inappropriate times. Each journey appears to be built upon previous ones. It is like I am being shown a pattern of events in such a way that I can understand and accept each experience. Unlike the majority of my previous visions which focused on physical changes in the world, this new inner-world experience focuses on a greater period of change—the New Millennium.

My first timestream journey into the New Millennium occurred in the spring of this year. I had returned to New England from Egypt and was busy working on a new series for *ECR (Earth Changes Report)* on the building of the Great Pyramid (see *ECR 5/95*). While transcribing my notes from Egypt I found myself back at the Giza Plateau facing the Great Pyramid. No sooner did I think, "Am I recalling my previous timestream experience?" than I found myself at the entrance to a long corridor. Slowly, I floated forward. Having previously learned to operate in this realm, I merely brought the thought or desire to mind, and action was immediate. A luminescence emanated from the walls, though there were no visible signs of lighting devices. Turning around, I observed that the light from the walls was going out. As I moved forward, new light emanated from the walls a few feet in front of me. Continuing down the hall I came to a large ebony statue positioned in the middle of an entrance way to three inner chambers. [H: Now readers, don't tell me you don't understand this—in this very writing he has just walked you through that lighted tunnel in your mind. Don't tell me you didn't "see" anything for it is impossible that your mind did not picture his realization as he described it for you. THAT is the way the mind WORKS!] The statue was in the likeness of a warrior dressed in a short kilt, wearing a helmet and carrying a shield. Some of its features reminded me of photographs of early Native Americans. What appeared to be a golden sword—tip pointing upward—was held at waist level by the right hand. Clearly, by its facial features and stance, this statue was meant as a protector. As I gazed at the colossus a voice spoke out, "Do not seek that which you are not ready to commit to." [H: I suggest ALL of you in each instance consider this command.]

Startled, I spun around expecting to see a figure. This was not the voice that I usually hear in my visions.

In my sixteen years of metaphysical experience, I have learned not to give into fear but to focus instead on confronting it and making choices. "I would not be here if I were not committed. Who asks?" was my thought response to the voice.

"I am the guardian, Thoth. You may pass," said the voice. [H: And, further, readers, you may well not encounter any entity known as "Thoth" but you WILL find a guardian at every gate of passage.] With that I found myself in the center of an antechamber facing three androgynous-looking entities. Seated at a large rectangular stone table, they were dressed in white robes with hoods covering the back half of their heads. Their eyes were blue-grey in color and emitted streams of a thin, white, thread-like substance that projected into my eyes.

They spoke, "In the next year we shall meet with you eleven more times. Each time you will be taken into the New Millennium. Before we show you the future, however, we will give you a basis by which you will be able to understand what is to be presented to you. For now you may ask about all you experience, and share with whomever you choose. Later, you will be shown some portions that are not to be shared until the time is correct. For the next few minutes open your heart and mind and listen."

Taken back by their words and energy, I slowly lowered myself to the floor, crossed my legs, lotus-style, and waited. They continued, "If all time pieces were discarded would time continue?"

A long pause followed and I thought, "Am I being tested in some manner?" They continued, not commenting on my thoughts which, I realized, they had clearly heard.

The next thing I remember is a sharp pain in my solar plexus, not uncommon when I return from these journeys. My eyes were still blinking in rem-like fashion as I tried to focus. As my vision returned to normal I wondered if these entities had been an influence on me since my early inner experiences. I will need to ask them next time.

## BACTERIA MAKES CANADIAN DEBUT

The Canadian Press, TORONTO

Canada's first outbreak of a killer bacteria that's sweeping the United States has hit a Toronto hospital, where 25 patients have been placed in isolation.

The strain of this bacteria, called enterococci, has now become resistant to the antibiotic vancomycin [H: The last one that worked that you have.]. It can't be stopped with any antibiotics currently licensed in Canada.

It hits people with weakened immune systems, such as heart surgery patients and people undergoing chemotherapy.

None of the 25 patients at Toronto Hospital appear in danger, the hospital said Thursday.

Dr. Donald Low, head of microbiology at Toronto's Mount Sinai and Princess Margaret hospitals, said there are isolated cases of the bacteria in Edmonton and Montreal.

Hospital officials have received permission from Health Canada to use two antibiotics available in Europe but not licensed in Canada.

# Jury Nullification

## Voting Your Conscience

With the advent of the recent O.J. Simpson verdict, the media is abuzz with the term *jury nullification*. To say there is historical precedent for jurors "voting their conscience" is the grossest of understatements. The foundation SUPPORTING the power of jurors is broad and solid.

Let's go back in time to 1794 and see whether jury instructions have changed much.

In the February Term of the Supreme Court of 1794, what follows is the charge to the jury in the first jury trial before The Supreme Court of the United States. These "jury instructions" illustrate with remarkable clarity the true power of the jury. We are quoting the information below exactly as it came to us. The original newspaper or publication that this appeared in is not indicated by the copy we received. [Quoting:]

THE STATE OF GEORGIA  
vs.  
BRAILSFORD, ET AL.  
3 Dall. 1

The charge was delivered to the jury by the first Chief Justice of the United States Supreme Court, John Jay, who helped author *The Federalist Papers*. Associated with Jay, and united and unanimous with him in this, the first charge to a jury—delivered in a civil case by the United States Supreme Court—were James Wilson, thought by many to be the leading lawyer of the era—who was himself a delegate to the Constitutional Convention, and who signed the *Constitution* itself; also John Blair, a former Chief Justice from Virginia and a signer of the *Constitution*; also William Patterson, a delegate to the Constitutional Convention and a signer of the *Constitution*; and also William Cushing, a former Chief Justice of Massachusetts.

Here were three delegates to the Constitutional Convention, and an author of *The Federalist Papers*, uniting in a charge to a jury in a civil case, after the merits had been argued by counsel for four days before the jury, and in which it was admitted that there was no issue of fact—but only of the law.

Following is the charge to the jury delivered by Chief Justice Jay:

JAY—CHIEF JUSTICE

This cause has been regarded as one of great importance; and doubtless it is so. It has accordingly been treated by the counsel with great learning, diligence and ability; and on your part it has been heard with particular attention. It is, therefore, unnecessary for me to follow the investigation over the extensive field into which it has been carried; you are now, if ever you can be, completely possessed of the merits of the cause.

The facts comprehended in the case, are agreed; the only point that remains, is to settle what is the law of the land arising from those facts; and on that point, it is proper, that the opinion of the court should be given. It is fortunate on the present, as it must be on every occasion, to find the opinion of the court unanimous. We entertain no diversity of sentiment; and we have experienced no difficulty in uniting in the charge, which it is my province to deliver.

We are then, gentlemen, of opinion, that the debts due to Hopton & Powell (who were citizens of South Carolina) were not confiscated by the statute of South Carolina; the same

being therein expressly excepted. That those debts were not confiscated by the statute of Georgia, for that statute enacts, with respect to Powell & Hopton, precisely the like, and no other, degree and extent of confiscation and forfeiture, with that of South Carolina. Wherefore it cannot now be necessary to decide, how far one state may be of right legislate relative to the personal rights of citizens of another state, not residing within their jurisdiction.

We are also of the opinion, that the debts due to Brailsford, a British subject, residing in Great Britain, were by the statute of Georgia subjected, not to confiscation, but only to sequestration; and therefore, that his right to recover them, revived at the peace, both by the law of nations and the treaty of peace.

The question of forfeiture in the case of joint obligees, being at present immaterial, need not now be decided.

It may not be amiss, here, gentlemen, to remind you of the good old rule, that on questions of fact, it is the province of the jury, on questions of law, it is the province of the court, to decide. But it must be observed that by the same law, which recognizes this reasonable distribution of jurisdiction, you have nevertheless a right to take upon yourselves to judge of both, and to determine the law as well as the fact in controversy. On this, and on every other occasion, however, we have no doubt, you will pay that respect, which is due to the opinion of the court. For, as on the one hand, it is presumed, that juries are the best judges of facts; it is, on the other hand, presumable, that the court are the best judges of law. But still both objects are lawfully, within your power of decision. [End quoting.]

"But times have changed, laws have changed," some people shout from the distance. Perhaps, but what you have just read is THE ORIGINAL INTENT OF THE FOUNDERS UNDER THE CONSTITUTION—which still holds true today.

In 1852, in a book titled *AN ESSAY ON THE TRIAL BY JURY*, [Boston: John P. Jewett and Co., Cleveland, Ohio: Jewett, Proctor & Worthington. 1852], Mr. Lysander Spooner writes, [quoting:]

### MORAL CONSIDERATIONS FOR JURORS

The trial by jury must, if possible, be construed to be such that a man can rightfully sit in a jury, and unite with his fellows in giving judgment. But no man can rightfully do this, unless he hold in his own hand alone a veto upon any judgment or sentence whatever to be rendered by the jury against a defendant, which veto he must be permitted to use according to his own discretion and conscience, and not bound to use according to the dictation of either legislatures or judges.

The prevalent idea, that a juror may, at the mere dictation of a legislature or a judge, and without the concurrence of his own conscience or understanding, declare a man "guilty," and thus in effect license the government to punish him; and that the legislature or the judge, and not himself, has in that case all the moral responsibility for the correctness of the principles on which the judgment was rendered, is one of the many gross impostures by which it could hardly have been supposed that any sane man could ever have been deluded, but which governments have nevertheless succeeded in inducing the people at large to receive and act upon.

As a moral proposition, it is perfectly self-evident that, unless juries have all the legal rights that have been claimed for them in the preceding chapters,—that is, the rights of judging what the law is, whether the law be a just one, what evidence is admissible, what weight the evidence is entitled to, whether an act were done with a criminal intent, and the right also to *limit* the sentence, free of all dictation from any quarter,—they have no *moral* right to sit in the trial at all, and cannot do so without making themselves accomplices to any

injustice that they may have reason to believe may result from their verdict. It is absurd to say that they have no moral responsibility for the use that may be made of their verdict by the government, when they have reason to suppose it will be used for purposes of injustice.

It is, for instance, manifestly absurd to say that jurors have no moral responsibility for the enforcement of an unjust law, when they consent to render a verdict of *guilty* for the transgression of it; which verdict they know, or have good reason to believe, will be used by the government as a justification for inflicting a penalty.

It is absurd, also, to say that jurors have no moral responsibility for a punishment inflicted upon a man *against law*, when, at the dictation of a judge as to what the law is, they have consented to render a verdict against their own opinions of the law.

It is absurd, too, to say that jurors have no moral responsibility for the conviction and punishment of an innocent man, when they consent to render a verdict against him on the strength of evidence, or laws of evidence, dictated to them by the court, if any evidence or laws of evidence have been excluded, which *they* (the jurors) think ought to have been admitted in his defense.

It is absurd to say that jurors have no moral responsibility for rendering a verdict of "*guilty*" against a man, for an act which he did not know to be a crime, and in the commission of which, therefore, he could have had no criminal intent, in obedience to the instructions of courts that "ignorance of the law (that is, of crime) excuses no one."

It is absurd, also, to say that jurors have no moral responsibility for any cruel or unreasonable *sentence* that may be inflicted even upon a *guilty* man, when they consent to render a verdict which they have reason to believe will be used by the government as a justification for the infliction of such sentence.

The consequence is, that jurors must have the whole case in their hands, and judge of law, evidence, and sentence, or they incur the moral responsibility of accomplices in any injustice which they have reason to believe will be done by the government on the authority of their verdict.

The same principles apply to civil cases as to criminal. If a jury consent, at the dictation of the court, as to either law or evidence, to render a verdict, on the strength of which they have reason to believe that a man's property will be taken from him and given to another, against their own notions of justice, they make themselves morally responsible for the wrong.

Every man, therefore, ought to refuse to sit in a jury, and to take the oath of a juror, unless the form of the oath be such as to allow him to use his own judgment, on every part of the case, free of all dictation whatsoever, and to hold in his own hand a veto upon any verdict that can be rendered against a defendant, and any sentence that can be inflicted upon him, even if he be guilty.

Of course, no man can rightfully take an oath as juror, to try a case "according to law," (if the law be meant anything other than his own ideas of justice), nor "according to the law and the evidence, *as they shall be given him.*" Nor can he rightfully take an oath even to try a case "*according to the evidence,*" because in all cases he may have good reason to believe that a party has been unable to produce all the evidence legitimately entitled to be received. The only oath which it would seem that a man can rightfully take as juror, in either a civil or criminal case, is, that he "will try the case *according to his conscience.*" Of course, the form may admit of variation, but this should be the substance. Such, we have seen, were the ancient common law oaths. [End quoting.]

When you open a letter one day that reads: "You've been called for jury duty," in your heart of hearts REMEMBER WELL WHAT YOU HAVE JUST READ. You needn't make any loud pronouncements about it. As you go into the jury box and ultimately the jury room, remember the *Constitution* and your true power as a member of *we-the-people*.
