## OFFICIAL DEFINITION OF DEMOCRACY

From David N. Wilder, 7/98: [quoting]

Here are four (4) sections taken from a 156-  
page book officially compiled and issued by the  
U.S. War Department, November 30, 1928,  
setting forth exact and truthful definitions of a  
Democracy and of a Republic, explaining the  
difference between both. These definitions were  
published by the authority of the United States  
Government and must be accepted as authentic  
in any court of proper jurisdiction.

These precise and scholarly definitions of a  
Democracy and a Republic were carefully  
considered as a proper guide for U.S. citizens  
by the Chief of Staff of the United States  
Army. Such definitions take precedence over  
any "definition" that may be found in the  
present commercial dictionaries which have  
suffered periodical "modification" to please "the  
powers in office".

Shortly after the "bank holiday" in the  
thirties, hush-hush orders from the White House  
suddenly demanded that all copies of this book  
be withdrawn from the Government Printing  
Office and the Army posts, to be suppressed  
and destroyed without explanation.

This was the beginning of the complete Red  
control of the government from within, not from  
without.

Republic:

Authority is derived through the election by  
the people of public officials best fitted to  
represent them.

Attitude toward property is respect for laws  
and individual rights, and a sensible economic  
procedure.

Attitude toward law is the administration of  
justice in accord with fixed principles and  
established evidence, with a strict regard to  
consequences.

A greater number of citizens and extent of  
territory may be brought within its compass.

Avoids the dangerous extreme of either  
tyranny or mobocracy.

Results in statesmanship, liberty, reason,  
justice, contentment, and progress. Is the  
"standard form" of government throughout the  
world.

A republic is a form of government under  
a constitution which provides for the election of  
(1) an executive and (2) a legislative body, who  
working together in a representative capacity,  
have all the power of appointment, all power of  
legislation, all power to raise revenue and  
appropriate expenditures, and are required to  
create (3) a judiciary to pass upon the justice  
and legality of their government acts and to  
recognize (4) certain inherent individual rights.

Take away any one or more of those four  
elements and you are drifting into autocracy.

Add one or more to those four elements and  
you are drifting into democracy. —Atwood.

121. Superior to all others, —Autocracy  
declares the divine right of kings; its authority  
can not be questioned; its powers are  
arbitrarily or unjustly administered.

Democracy is the "direct" rule of the  
people and has been repeatedly tried without  
success. Our Constitutional fathers, familiar  
with the strength and weakness of both  
autocracy and democracy, with fixed principles  
definitely in mind, defined a representative  
republican form of government. They "made  
a very marked distinction between a republic  
and a democracy\* \* \* and said repeatedly and  
emphatically that they had founded a republic".

### WILL SHE BLOW?

Mt. Iwate In Iwate Prefecture...has recently been showing signs of a possible eruption, leading local governments to declare the area off-limits to the public. The mountain, the loftiest peak in the prefecture at 2,038 meters, is a "polygenic" volcano like Mt. Fuji, or one that erupts at intervals ranging from several hundred to thousands of years. According to the Meteorological Agency, more than 4,000 earthquakes—including some too weak to be felt by the human body—were recorded at the mountain range over a four-month period from March. ### RICH GET RICHER WITH IMF FUNDING

From *THE SPOTLIGHT*, by Warren Hough, 7/27/98: [quoting]

The multi-million-dollar bailout of Russia is a bonanza for stateless financiers.

While millions of Russian workers and state employees have gone unpaid for almost a year, and the troops are being fed surplus dogfood, in Moscow a small coterie of grafting insiders and their New York financiers—led by George Soros, the Croesus of currency speculators—have amassed fortunes running into tens of billions of dollars: this much is common knowledge.

But just how do they do it? In talks with two veteran Wall Street portfolio managers who specialize in fixed-income securities—neither wanted to be identified by name—*The SPOTLIGHT* has pieced together the key moves in some recent financial scenarios staged by Soros and by Goldman Sachs, the giant investment bank known for its close ties to Treasury Secretary Robert Rubin, its once and (reportedly) future chairman.

Step one: May 1998. The ruble, Russia's national currency, comes under what even the *Wall Street Journal* has called "a heavy assault by international currency speculators led by Soros". Panicking at the threat of wholesale capital flight, the administration of President Boris Yeltsin raises interest rates on its government bonds, known as GKO's (or "gekkos") from 20 to 50 and then to 80 percent.

Step two: June 1998. The Russian economy is on the brink of breakdown. GKO bonds now pay what some investors call "insane" interest of 150 percent. Soros and Goldman Sachs buy them up by the bag full. Russia's foreign debt

soars to a reported \$23 billion.

Step three: July 1998. Foreign bondholders now face the threat of a bankrupt—and deadbeat Russia. But Rubin—always considerate of the interests of his old firm, Goldman Sachs—steps in and helps arrange a major international bailout. As if by coincidence, the amount of a bailout is set at \$22.6 billion, almost matching the amount Russia owes its Wall Street creditors.

Step four: July 1998. But what if the ruble is devalued? Fortunately, the IMF-led bailout turns out to include an agreement guaranteeing that Russia's foreign bondholders will be paid off in U.S. dollars, including the astronomical interest rates that still stand at around 115 percent.

### INSIDER TRADING

"Just how did the IMF get into the business of using U.S. taxpayers' money to finance [such] capital flight from Russia?" asked a *Wall Street Journal* editorial on July 14 with unaccustomed asperity.

But financial insiders call it the wrong question. "The IMF does not have the answer to that, or if it does, it does not dare to name it," snapped a veteran trader at Harry's Bar.

According to the buzz on Wall Street, the answer is in the unpublicized interests Soros shares with Federal Reserve Chairman Alan Greenspan and Goldman Sachs with Rubin. "These are mighty strong interests, the payoff is in the billions; that can work wonders," said a veteran portfolio manager with a broad wink. [End quoting]

When are we going to stop these monsters from stealing our subsistence from us through their funny-money scams??

The delegates erupted into cheers and applause when the treaty won final approval by a vote of 120-7, with 21 abstaining.

An American bid to undermine the package deal was beat back by a vote of 113-17, with 25 nations abstaining. India also tried to torpedo the deal.

The showdown at the U.N. talks attended by 160 nations created strange bedfellows: Joining the United States in denouncing treaty provisions were nations like Libya, Algeria,

China, Qatar and Yemen. Meanwhile, its closest allies, countries like Canada and Britain, mustered to the treaty's defense.

But more than a defeat for a superpower, the vote was a victory for an idea, one born with the Nuremberg trials of Nazi war criminals, put in the deep freeze by the Cold War, then revived in the ethnic bloodbaths of Rwanda and the former Yugoslavia.

"I think this is a great, historic achievement," said Benjamin Ferencz, 78, a Nuremberg prosecutor who's worked ever since for a permanent tribunal.

The new international criminal court, which will operate out of The Hague, Netherlands, will bring individuals to justice for genocide, crimes against humanity, war crimes and aggression.

Independent of the United Nations, it will be able to act even when the international community is divided, as it was in the Balkans and in Africa. [End quoting]

### CLINTONS BENT ON CONTROLLING NATION'S YOUTH

The cynical political exploitation of children continues apace in Washington. The calculated abuse of children in order to accumulate power knows no limits. But since it is the government itself that is guilty of this child abuse, there is no one to stop it.

President Clinton reminded us the other day—we may be forgiven for having forgotten—that he has proposed a \$22 billion plan to subsidize child care for families in which both parents go off to jobs. (Am I the only one who is still not used to government's tossing billion-dollar bundles around like bricks of cheese at a relief center?) The money will also be used to meddle in the child-care

industry and to bulk up programs such as Head Start, the biggest snake-oil scam since Dr. Feelgood's Elixir.

The five-year program is of a piece with Clinton's relentless efforts to nationalize other people's children through new health insurance schemes. We are not terribly far from the time when children will spend their days in government day-care centers and get their medical treatment there from government-employed doctors. And American parents will be ever grateful.

All that the Republicans can say in response is that the Clinton plan neglects children who have at least one parent at home. To them the GOP offers the usual: tax credits. But the Republican bill takes much of the Clinton plan under wing.

When will the bleating about the beleaguered family end? I don't say this because the family isn't beleaguered. On the contrary, I say it because the Republicans and Democrats are bunko artists whenever they claim to save the family. If they meant what they said, they'd have junked the gimmicks and removed the dead weight of the state from the backs of the American people.

Parents, like everyone else, suffer from onerous government. If the burden of federal, state and local taxation were removed, they could more easily afford good child care or, better yet, the mothers who want to stay at home would be able to do so. The American people don't need subsidies and tax credits, or Head Start and federally regulated child care. They need the freedom to keep what they earn. They need tax repeal.

But look at it from the politicians' point of view. What kudos will they get if they simply let you keep your money as a matter of simple principle? It may occur to you that they should have done this long ago. You may end up resenting them for squandering your money. No politician wants that.

That's why they prefer tax credits and subsidies. A tax credit is the politician's way of saying, "Do precisely as I say and I will reward you." If you please the Republicans and Democrats, you keep a few dollars more. Otherwise, off the money goes to the treasury.

And observe how easy it will be to use tax credits and subsidies to herd children into federally approved or operated child-care centers. All the regulators have to say is that you don't get your subsidy or credit if your children attend renegade centers.

We need to rediscover two lost ideas: people should be free to keep what they earn, and parents are responsible for their own children. At least since 1913, when the permanent income tax was enacted, we have lived the de facto idea that the government owns everything. If it wants to take more than 90 cents of the marginal dollar, it may do so. If it shows some mercy and drops the rate to 40 percent, be grateful, but don't go thinking you're entitled. Whatever you keep is purely by the grace of the U.S. Congress and the president.

To call that idea immoral and contrary to the founding principles of America is an understatement.

As for taking responsibility for one's own children, this is an idea the President and First Lady Hillary Rodham Clinton abhor. "There is no such thing as other people's children," Mrs.

Clinton likes to say. That's why they wish to tax everyone for their schemes to transform other people's children into national resources.

Enough of this idea that reeks too strongly of every despotism the world has ever known. —*Sheldon Richman is senior fellow at The Future of Freedom Foundation in Fairfax, Virginia.* [End quoting]

### BLIND SPEED

From *POPULAR SCIENCE* magazine, Aug. 1998: [quoting]

DRIVERS HATE FOG—it slows them down. Or so they think.

As people with poor eyesight can attest, a blurry world seems to move in slow motion. Now, research conducted in a virtual-reality environment confirms the fact that fog indeed alters the perception of speed, duping drivers into thinking they are traveling more slowly than they really are. The consequence is that drivers then often speed up, at their own hazard.

Robert Snowden and his colleagues from the School of Psychology at the University of Wales, in Cardiff, placed testees in a virtual-reality driving simulator, where they were asked to travel at a specific speed under both foggy and clear conditions—without a speedometer. On average, drivers drove 10 miles per hour faster in the fog. Another test exposed drivers to foggy and clear conditions simultaneously; they were then asked to log the point at which both scenes appeared to be moving at the same speed. Overwhelmingly, the test subjects perceived the foggy scene to be moving more slowly.

Previous studies have suggested that decreasing levels of contrast in a person's field of vision can distort the perception of speed, and future research will try to confirm these studies. In the meantime, the next time you hit some highway fog, you might be wise to keep a close eye on the speedometer. —*Gunjon Sinho* [End quoting]

### PROTECT FREE SPEECH AROUND SUPPLEMENTS

*First Amendment Alert* by William Faloon

This is about the United States of America...not China, Iraq, Cuba or the other countries where free speech is unheard of. Citizens will be outraged when they learn about the FDA's new Orwellian endeavor to suppress the dissemination of truthful medical information.

Vitamin consumers won a major victory in 1994 when Congress passed a bill that took away the FDA's power to regulate dietary supplements as drugs.

The FDA has now proposed new rules to prohibit Americans from learning about certain types of medical information.

The FDA's proposed rules say that consumers can be told about how a vitamin affects the "structure or function" of the body, but that any reference to how the vitamin affects diseases will be classified as illegal speech. If the FDA's proposed rules become law, most consumers will not be able to find out about the nutrients they need to prevent, mitigate or treat any disease.

Examples of what the FDA has proclaimed to be illegal speech include such descriptions of benefits as "reduces nausea associated with chemotherapy", "protects against cancer", and "treats hot flashes". Let's look at the effects the FDA's proposed new rules will have on the consumer.

### FDA-MANDATED SUFFERING FOR CANCER PATIENTS

A study in Environmental Toxicology and Pharmacology (Netherlands) 1996 showed that a combination of vitamin C, glutathione and vitamin E significantly reduced chemotherapy-

induced vomiting in dogs. Other studies have shown that nutrients can reduce the side effects of toxic drugs in humans. However, the FDA's proposed rules say it is illegal to suggest that chemotherapy patients who suffer from nausea and vomiting take these nutrients to reduce their suffering. While it's OK to state that the nutrients "inhibit chemotherapy-induced free radical activity in the gut", it's illegal to cite the published study showing that these nutrients inhibit chemotherapy-induced vomiting.

Since the FDA contends it's illegal to suggest anything but drugs to reduce nausea associated with chemotherapy, it would also be illegal to recommend coenzyme Q10 and vitamin E to reduce chemotherapy-induced heart muscle damage, melatonin to reduce chemotherapy-induced immune system damage, and n-acetyl-cysteine to reduce chemotherapy-induced liver damage.

The FDA is proposing that cancer patients be denied information about how to protect their heart, liver, gut and immune system against the lethal effects of FDA-approved chemotherapy drugs. These new proposed rules mandate suffering for cancer patients. They are not only immoral, they are blatantly unconstitutional.

However another four seats are undecided where incredibly the Labor Party has directed preferences to its arch-enemy, the National Party, effectively holding out the One Nation candidates.

Probably the best news as this story goes to press is the inevitable demise of National Party Police Minister Russell Cooper in his electorate of Crows Nest situated on the eastern edge of Toowoomba.

One Nation candidate David Cockburn demolished the National Party's 27.5 per cent

hold, leading Cooper by 400 votes as preferences and postal votes were being counted, but a final result could be another week away.

Cooper's only chance of hanging on is for a strong showing of Labor preferences—a bizarre turnaround which, according to supporters from Crows Nest clearly showed the only deals done before the election were between the National and Labor Parties, so desperate were they to stop the Hanson forces from taking away their lurks and perks.

# Some Beliefs Are As Lethal As Poison

WHAT'S IN A BELIEF?

I realize that I *should* start a long way back in historical review as I must have broken the SOUND barriers and some of you "heard" some of the messages I have recently written—and even lost sleep over the pondering and *actual thinking*.

You seem to receive that somehow I have come forth with such new revelation as to shock the most staid of you "believers" in goodness (God-ness, Christness), and we make it fine until we study carefully that which was PRESENTED TO DISTRACT YOU-THE-PEOPLE. NO, I bring no *NEW* revelation—the Truth covers it quite sufficiently, even if a bit difficult because of language translations. You who call yourselves "Christian" latched solidly onto that which is actually called "Jesusian"—pronounced most commonly from other than English languages as "Haysoozian".

I have reminded you often that there are many "gospels" but Germanic scholars out of the Judaic "religion" chose the ones that would be attached to the *Old Testament* as the *New Testament*. I don't know what these scholars were smoking or drinking but Truth got awfully lost along the way of structuring the books which would serve as THE INSTRUCTION BOOK for Christians. "Christ" is a Greek word. Messiah is a Syriac word.

In trying to bring meaning out of the jumbled words it is interesting what evolved. I would guess it is interesting enough for you to enjoy some of the more pertinent things revealed.

Let us pick basically at random and consider *The Gospel of Philip* (Codex II 51, 29-86, 19). Translated by Wesley W. Isenberg. From James M. Robinson, ed., *The Nag Hammadi Library* (San Francisco: Harper & Row, 1977), pp. 131-151.

You ask, "Who in heck was Philip?" I respond: Who in heck was Matthew, Mark, Luke and John? And no, do NOT fudge on YOUR ANSWER TO ME: WHO WERE THEY?

What you are going to learn, dear hearts, is that the "alien" brotherhood was far more prevalent than you could possibly have imagined if you but actually study HISTORY and stop consuming without question the words demanded upon you.

[QUOTING:] *The Gospel of Philip*

A Hebrew makes another Hebrew, and such a person is called "proselyte". But a proselyte does NOT make another proselyte. Some both exist just as they are and make others like themselves, while others simply exist.

The slave seeks only to be free, but he does not hope to acquire the estate of his master. But the son is not only a son but lays claim to the inheritance of the father. Those who are heirs to the dead are themselves dead, and they inherit the dead. Those who are heirs to what is living are alive, and they are heirs to both what is living and the dead. The dead are heirs to nothing. For how can he who is dead inherit? If he who is dead inherits what is living he will not die, but he who is dead will live even more. [H: Now how is THAT for logical deduction?]

[H: And this:] A Gentile does not die, for he **has never lived** in order that he may die. He who has believed in the truth has found life and this one is in danger of dying, for he is alive. Ever since Christ came the world is created, the cities adorned, the dead carried out. When we were Hebrews we were orphans and had only our mother, but when we became Christians we had both father and mother.

Those who sow in winter reap in summer. The winter is the world, the summer the other Aeon. Let us sow in the world that we may reap in the summer. Because of this it is fitting for us not to pray in the winter. Summer follows winter. But if any man reap in winter he will not actually reap but only pluck out, since this sort of thing will not provide him a harvest. It is not only now that the fruit will not come forth, but also on the Sabbath his field will be barren. [H: With me so far, as to intelligent reasoning?]

Christ came to ransom some, to save others, to redeem others. He ransomed those who were strangers and made them his own. And he set his own apart, those whom he gave as a pledge in his will. It was not only when he appeared that he voluntarily laid down his life, but he laid down his life from the very day the world came into being. Then he came forth in order to take it, since it had been given as a pledge. It fell into the hands of robbers and was taken captive, but he saved it. He redeemed the good people in the world as well as the evil. [H: That's not a bad idea to remember from time to time and see WHICH group claims the more ridiculous salvation.]

Light and darkness, life and death, right and left, are brothers of one another. They are inseparable. Because of this neither are the good good, nor the evil evil, nor is life life, nor death death. For this reason each one will dissolve into its original nature. But those who are exalted above the world are indissoluble, eternal.

Names given to worldly things are very deceptive for they divert our thoughts from what is correct to what is incorrect. Thus one who hears the word "God" does not perceive what is correct, but perceives what is incorrect. So also with "the Father" and "the Son" and "the Holy Spirit" and "life" and "light" and "resurrection" and "the Church" and all the rest—people do not perceive what is correct, but they perceive what is incorrect, unless they have come to know what is correct. **[H: Now watch it, readers, because right along about here you just MAY start to realize that the more likely TRUTH is what is NOT perceived and thus, incorrect. It can be a great help in solving the riddle of existence.]** The names which are heard are in the world to deceive. If they were in the Aeon, they would at no time be used as names in the world. Nor were they set among worldly things. They have an end in the Aeon.

One single name is not uttered in the world, the name which the Father gave to the Son, the name above all things: the name of the Father. For the Son would not become Father unless he wears the name of the Father. Those who have the name know it, but they do not speak it. But those who do not have it do not know it.

But truth brought names into existence in the world because it is not possible to teach it without names. Truth is one single thing and it is also many things for our sakes who learn this one thing in love through many things. The powers wanted to deceive man, since they saw that he had a kinship with those that are truly good. They took the name of those that are good and gave it to those that are not good, so that through the names they might deceive him and bind them to those that are not good. And afterward, if they do them a favor, they will be made to remove them from those that are not good and place them among those that are good. These things they knew, for they wanted to take the free man and make him a slave to them forever.

**[H: Just wade on through this, readers, for you are going to find it makes far more sense than you are going to wish to face.]**

There are powers which contend against man, not wishing him to be saved. For if man is saved, there will not be any sacrifices and animals will not be offered to the powers. They were indeed offering them up alive, but when they offered them up they died. As for man, they offered him up to God dead, and he lived.

Before Christ came there was no

bread in the world, just as Paradise, the place where Adam was, had many trees to nourish the animals but no wheat to sustain man. Man used to feed like the animals, but when Christ came, the perfect man, he brought bread from heaven in order that man might be nourished with the food of man. The powers thought that it was by their own power and will that they were doing what they did, but the Holy Spirit in secret was accomplishing everything through them as it wished. Truth, which existed since the beginning, is sown everywhere. And many see it as it is sown, but few are they who see it as it is reaped.

Some said, "Mary conceived by the Holy spirit." They are in error. They do not know what they are saying. When did a woman ever conceive by a woman? Mary is the virgin whom no power defiled. She is a great anathema to the Hebrews, who are the apostles and the apostolic men. This virgin whom no power defiled; the powers defile themselves. And the lord would not have said "My Father who is in Heaven" [Matt. 16:17] unless he had had another father, but he would have said simply "My father".

**[H: Dharma asks of me to say why we spent all the time we did in translation of the scripts to present the book AND THEY CALLED HIS NAME IMMANUEL (JMMANUEL). Because, dear heart, in these days of confrontation with major PLAYERS on the stage of evolution you had to KNOW the cast of characters and their roles in the unfolding play. You needed to know exactly what was told by the Teacher Messenger would come to be and who would be the players. Remember that there were many tribes and there were Pharisees, etc? Well, the Teacher said to them: "And in 500 years there will come a man (leader) who will cause you to rue the day you were born. His name will be Mohammed. he has drink and clothing. I find fault with the others who say that it will not rise. Then both of them are at fault. You say that the flesh will not rise. But tell me what will rise, that we may honor you. You say the spirit in the flesh, and it is also this light in the flesh. But this too is a matter which is in the flesh, for whatever you shall say, you say nothing outside the flesh. It is necessary to rise in this flesh, since everything exists in it. In this world those who put on garments are better than the garments. In the Kingdom of Heaven the garments are better than those who have put them on.

It is through water and fire that the whole place is purified—the visible by the visible, the hidden by the hidden. There are some things hidden through those visible. There is water in water, there is fire in a chris. **[H: Generally means ‘consecrated oil’ for anointing in some orthodox churches, esp. the Greek orthodox.]**

Jesus took them all by stealth, for he did not reveal himself in the manner in which he was, but it was in the manner in which they would be able to see him that he revealed himself. He revealed himself to them all. He revealed himself to the great as great. He revealed himself to the small as small. He revealed himself to the angels as an angel, and to men as a man. Because of this his word hid itself from everyone. Some indeed saw him, thinking that they were seeing themselves, but when he appeared to his disciples in glory on the mount he was not small. He became great, but he made the disciples great, that they might be able to see him in his greatness.

Well, let us try on a few more thoughts before we change and leave Philip dangling in historical rhetoric.]**

The heavenly man has many more sons than the earthly man. If the sons of Adam are many, although they die, how much more the sons of the perfect man, they who do not die but are always begotten. The father makes a son, and the son has not the power to make a son. For he who has been begotten has not the power to beget, but the son gets brothers for himself, not sons. “The Father” and “the Son” are single names, “the Holy Spirit” is a double name. For they are everywhere: they are above, they are below; they are in the concealed, they are in the revealed. The Holy Spirit is in the revealed: it is below. It is in the concealed: it is above.

The saints are served by evil powers, for they are blinded by the Holy Spirit into thinking that they are serving an ordinary man whenever they do something for the saints. Because of this a disciple asked the Lord one day for something of this world. He said to him, “Ask your mother and she will give you of the things which are another’s.”

The apostles said to the disciples, “May our whole offering obtain salt.” They called Sophia “salt”. Without it no offering is acceptable. But Sophia is without child. For this reason she is called “a trace of salt”. But where they will be in their own way, the Holy Spirit will also be, and her children are many.

What the father possesses belongs to the son, and the son himself, so long as he is small, is not entrusted with what is his. But when he becomes a man his father gives him all that he possesses.

Those who have gone astray, whom the Spirit itself begets, usually go astray also because of the Spirit. Thus, by this one and the same breath, the fire blazes and is put out.

Echamoth is one thing and Echmoth another. Echamoth is Wisdom simply, but Echmoth is the Wisdom of death which is the one who knows death [called “the little Wisdom”].

There are domestic animals like the bull and the ass and others of this kind. Others are wild and live apart in the deserts. Man ploughs the field by means of the domestic animals, and from this he feeds both himself and the animals, whether tame or wild. Compare the perfect man. It is through powers which are submissive that he ploughs, preparing for everything to come into being. For it is because of this that the whole place stands, whether the good or the evil, the right and the left. The Holy Spirit shepherds everyone and rules all the powers, the “tame” ones and the “wild” ones, as well as those which are unique. For indeed he gathers them and shuts them in, in order that these, even if they wish, will not be able to escape.

**[H: Oh, we aren’t even nearly through with this wisdom in deciphering and revelating. Bill Clinton could actually take lessons in his double talk about what is “sex” and what is “not sex”.]**

He who has been *created* is beautiful, and you would find his sons noble creations. He who was not created *but begotten*, you would find that his seed was noble. But now he was created and he begot. **[H: Get this now:]** What nobility is this? First, adultery came into being, afterward murder. And he was begotten in adultery, for he was the child of the serpent. So he became a murderer, just like his father, and he killed his brother. Indeed, every act of sexual intercourse which has occurred between those unlike one another is adultery.

God is a dyer. As the good dyes, which are called “true”, dissolve with the things dyed in them, so it is with those whom God has dyed. Since his dyes are immortal, they are immortal by means of his colors. Now God dips what he dips in water.

You saw the Father and you shall become Father. So in this place you see everything and do not see yourself; but in that place you do see yourself—and what you see you shall become.

Faith receives, love gives. No one will be able to receive without faith. No one will be able to give without love. Because of this, in order that we may indeed receive, we believe; but it is so that we may love and give, since if one does not give in love, he has no profit from what he has given. He who has not received the Lord is still a Hebrew. **[H: And you thought bigotry was something NEW?]**

The apostles who were before us had these names for *him*: “Jesus, the Nazorean, Messiah”, that is, “Jesus, the Nazorean, the Christ”. 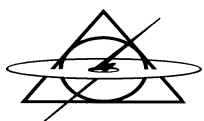


Like all the other deaths around Clinton, there are more questions than answers. I encourage discourse on the matter. Prove to me why I am wandering down too many blind alleys.

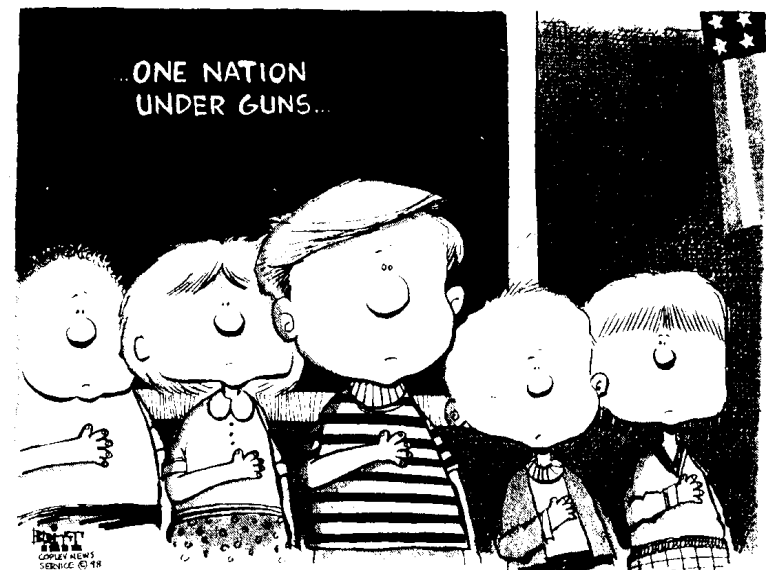

# Very Suspicious Deadings From OKC Bombing

## UNRESOLVED DEATHS IN OKLAHOMA

In the first minutes and hours following the blasts that devastated the Alfred P. Murrah Federal Building in downtown Oklahoma City, the morning of April 19, 1995, a number of selfless individuals risked life and limb to rescue many of the victims. Among them were Oklahoma City police officers, Terrance Yeakey, Gordon Martin and Ken Griffin, a number of Oklahoma City firefighters, Dr. H. Don Chumley, G.S.A. employee Mike Loudenslager and others.

In the aftermath of the "bombing" the name Mike Loudenslager holds particular significance in the hearts of many families in and around Oklahoma City. And this is so, because of the forewarning he gave to a number of those who had children in the Murrah Building's day-care center. In the weeks preceding the bombing, G.S.A. employee Michael Loudenslager, 48, became increasingly aware that large amounts of ordnance and explosives were in the building and strongly urged (along with the operator of the day-care center) a number of parents to take their children out of the Murrah Building.

This situation arose after other employees became concerned with an increased amount of ordnance (missiles) being brought into the building by the B.A.T.F. and D.E.A. As a result of this concern, a grievance was filed with G.S.A. by the building's security director. The result was, the man who'd complained lost his job there. Then, after the operator of the day-care center (the security director's wife) notified the fire marshals after some remodeling had been done (as her license required her to do), the fire marshals were denied access to do their inspection by federal agents and told to leave! And the day-care operator lost her contract.

As a result of this (fearing the worst with all the talk around town of a possible bombing), Mike Loudenslager and the day-care center operator then told many of the parents to get their children out. And, because of their warnings, far fewer children were in the day-care center on that horrible Wednesday morning than there otherwise would have been. A number of families, in and around Oklahoma

City, have these two people to thank for their children's lives today.

Shortly after the bombing, Michael Loudenslager was actively helping in the rescue and recovery effort. A large number of those at the bomb-site either saw or talked with him. During the course of the early rescue efforts, however, Mike Loudenslager was seen and heard in a very "heated" confrontation with someone (there). Much of his anger stemmed from the fact he felt the B.A.T.F. was in large part responsible not only for the bombing, but for the death and injury to those inside, including all the children.

To the absolute astonishment of a large number of police officers and rescue workers, it was later reported that G.S.A. employee Mike Loudenslager's body had been found inside the Murrah Building the following Sunday, still at his desk, a victim of the 9:02 A.M. bombing! This, mind you, after he'd already been seen alive and well by numerous rescue workers at the bomb-site AFTER the bombing! He is also officially listed as one of the 168 bombing fatalities.

The question now becomes: Was he murdered and placed at his desk by federal agents? Or was he just simply murdered by them and SAID to have been found at his desk? Access to the inside of the building, from shortly after the bombing onward was extremely limited to nearly all but federal employees by the F.B.I.

His death is UNQUESTIONABLY the most important sidelight of the Oklahoma City bombing.

Mike Loudenslager's murder most assuredly was one of the major factors leading to the demise of both Dr. H. Don Chumley and later Terry Yeakey!

For whatever reason, the Oklahoma City Police Dept. has always down-played Officer Terry Yeakey's presence at the Murrah Building the morning of April 19, 1995, even though a large number of Oklahoma City police officers, firefighters, emergency personnel and survivors KNOW he played a much larger role in the early rescue-effort than he's given credit for.

In an effort to cover up Mike Loudenslager's murder and to intimidate others who were there early-on that morning, someone has taken out a number of internal witnesses. Dr. Don Chumley AND Terry Yeakey, both, besides being at the Murrah Building that morning, shared one other

commonality. Each at the time of his "death" was attempting to deliver EVIDENCE concerning the fact Mike Loudenslager was alive and well AFTER the bombing, and also to get certain other facts out about the "bombing" as well.

In Terry Yeakey's case he thought he was delivering evidence and information to a multi-county task force who would help get the truth out. That's how he was set-up. In Dr. Chumley's case, he was killed, some months earlier, when his personal jet aircraft "crashed" while attempting to do the same thing.

Were the deaths of Jack Colvert, Jackie Majors and Buddy Youngblood also directly related to the cover-up of Mike Loudenslager's murder? Each of them had been at the Murrah Building that morning and each had also seen Mike Loudenslager ALIVE and well after the bombing.

Others who were there that morning have also felt threatened. Officer Gordon Martin, for one, feels at least two attempts on his life have been made. Other police officers and emergency services personnel fear for their personal safety as well. And while all this goes on, the moguls of the major-media remain silent! The so-called "fourth pillar of democracy"—the press—once again falls flat on its face, foresaking its sacred duty to REPORT THE NEWS. Remember, Hell is just as hot for those who go there for sins of OMISSION as those who go for sins of COMMISSION!

Another interesting case of "suicide" in Oklahoma, since the bombing, is that of Kenneth Trentadue, who as the result of violating conditions of his parole in California, was re-incarcerated and sent to a federal (transfer) facility in Oklahoma. Mr. Trentadue, the brother of a prominent Salt Lake City, Utah attorney, supposedly committed suicide by hanging himself. But in actuality managed to commit a "suicide" very similar to Terry Yeakey's (minus the gunshot-wound-to-the-head). Only Kenneth Trentadue's was committed with knotted or "braided" bedsheet, barely long enough to fit around his neck in a "suicide-proof" prison cell.

THE SALT LAKE TRIBUNE later reported the trustees who cleaned Mr. Trentadue's cell after his "suicide" found copious amounts of blood inside. This included bloody fingerprints up a wall, to within a few inches of a "panic button" on or near the ceiling.

This certainly is not consistent with hanging.

When his family was contacted by prison officials and informed of his "suicide", they were asked if they wanted his remains cremated. They indicated they did not, and after a very difficult time and much red-tape, the body was finally shipped back to them.

Being very skeptical as to a suicide, family members removed the mortuary make-up and were shocked to find part of his skull crushed, his knuckles damaged, bruises, puncture-and-slash-wounds over a good portion of his body (including the soles of his feet) and his throat slashed. Boot heel marks were apparent around the right eye and on his chest. All evidence points to the fact Kenneth Trentadue was subdued after a fight—brutally beaten, tortured and murdered!

(Update: THE SALT LAKE TRIBUNE, Sat. July 11, 1998—state M.E. [medical examiner] says Trentadue death "suicide"!).

This case is "supposedly" being looked into by U.S. Sen. Orrin Hatch. Former 7-term U.S. Rep. George Hansen of Idaho and his organization, The United States Citizens Human Rights Commission, IS, however, actively pursuing it. Former Rep. Hansen was himself unjustly convicted and imprisoned and spent a number of years literally as a political prisoner in the federal penal system until his case was finally decided by the U.S. Supreme Court.

Many Americans who are familiar with the Trentadue case see a chilling similarity between Officer Terry Yeakey's "suicide" and Kenneth Trentadue's. Especially when each occurred in such close proximity to the other, in and around El Reno and Oklahoma City, AFTER the bombing.

Like Terry Yeakey, Kenneth Trentadue, (although smaller) was also a powerfully-built man. He lifted weights regularly, had a 19-inch neck and was a street-fighter with street savvy. In short, he knew how to take care of himself.

Many now wonder if Kenneth Trentadue

might have had information regarding the Oklahoma City bombing, or its aftermath, that certain agents wanted him taken-out for. And many also wonder why a man reincarcerated for violating his parole would REQUEST solitary confinement. What was Kenneth Trentadue afraid of?

Could the murder of Murrah Building G.S.A. employee Michael Loudenslager and the subsequent cover-up be the reason for (many of) the unresolved deaths in Oklahoma since the bombing? A growing number of Americans certainly think so.

### THE IMPORTANCE OF JANE GRAHAM

Anyone who saw the televised coverage of the bombed-out Murrah Building didn't need to be a rocket scientist to realize that the tremendous destruction done didn't come from a single bomb in a vehicle "outside" the building. But, rather, it should have been obvious to any fourteen-year-old boy of average intelligence that the Murrah Building was literally "dropped" by blowing several of the reinforced concrete supporting columns and part of the massive reinforced concrete header supporting the building out from under it. This occurred as Gen. Partin said, "at critical structural points at the third floor level". Did the bombers plant explosives in other parts of the building as well?

Eyewitness accounts "before" the bombing strongly suggest that demolition charges were placed elsewhere. On the Friday before the bombing several persons at the Murrah Building saw three men (they took for maintenance or utility workers) "working" in a reserved area of the underground parking structure. These men had what appeared to be a set of plans or "blue prints", telephone wire and a large block of "clay." When the three men noticed they were being observed by one of the employees, JANE GRAHAM, a federal government employee of the Department of Housing and Urban Development (H.U.D), situated in the Murrah Building, they themselves began to act somewhat suspiciously.

And this is where we get into the importance of Jane Graham. It was nearly a year later, while watching a video about the bombing at a friend's house, Jane was taken aback by two men in the video she'd seen on

the afternoon before the bombing and “the very morning of the bombing” inside the Murrah Federal Building, each wearing the blue uniform (shirt and pants) of General Services Administration (G.S.A.) employees. Jane had never seen these two men before or after this two-day period, and at the time, had thought it strange that two of the regular G.S.A. employees would have been off on the same day, replaced by two temporaries.

After viewing the video, she began to re-think several incidences she had heard or seen in the two weeks leading up to the morning of the bombing that at the time they occurred didn't seem all that unusual. But, as she began to put them in order, a definite pattern of importance began to emerge. The first incident was a conversation between two women she'd overheard in a coffee shop/snack bar in the Murrah Building about two weeks before the bombing. In this conversation one woman told another that a friend of hers in the F.B.I. had mentioned there was going to be a bombing. Concerned because Jane thought the woman was talking about the F.B.I. building, and she had a relative working nearby, she told her husband that evening what she'd overheard. Then the three utility workers in the underground parking structure she and others had seen “working” the Friday before the bombing, now began to appear much more significant to her than they had at the time she'd seen them.

The thing that really bothered her were these two men—the two she'd seen the previous afternoon and the morning of the bombing—“working” inside the Murrah Building wearing their blue G.S.A. uniforms. The video Jane was watching had been shot shortly after the bombing and here they were outside the building “in street clothes” accidentally caught on videotape! Why had they changed? The last time she distinctly remembered seeing them it was 8:15 A.M. on April 19th (approximately forty-seven minutes before the bombing). They had just exited a stairwell that comes directly from the ninth floor down to the hallway they now briskly passed her in. As she turned to watch them they continued down the hallway and exited the building at a fast pace. Jane remembers that one of them was carrying something in his hand but she doesn't remember what it was.

It should be noted that neither of these individuals were any one of the three men that she and others had seen “working” in the underground parking structure on the previous Friday. These were two different individuals from the three. Jane had told the F.B.I. about the two men in the G.S.A. uniforms and when she was asked by an agent was either of them Timothy McVeigh or Terry [Nichols], and she told them “No,” the F.B.I. wasn't really interested in talking to her further.

The question now becomes: Who is Jane Graham and is she a credible witness? Jane and her family moved from Boston to Oklahoma in 1984. She is a wife, mother and grandmother. After moving to Oklahoma, Jane went to work for the Department of Housing and Urban Development (H.U.D.) [in Murrah Building], where she had been employed for 10 years. Active in union affairs for much of her life, at the time of the bombing, Jane was (and still is) president of the American Federation of Government Employees (A.F.G.E.) Union Local Number 3138, in Oklahoma City. In short, Jane Graham is a very

credible witness and deserves to be heard.

What Jane Graham felt, heard and experienced, during the bombing also debunks the single bomb nonsense as well. At the time of the bombing, Jane and others were attending a “Windows” software workshop on the ninth floor of the building. As she sat down in the chair and turned on a computer, Jane remembers that the entire building began to shake. Her first thought was that she'd done something wrong with the computer. She remembers the floor “rolling” from east to west. After the shaking began, the women in charge of the computer workshop exclaimed that it must be an earthquake and for everyone to get under their desks.

Jane remembers that at this point she just sat there frozen and stunned for a few seconds. Then she recalls, ...seven...eight...nine seconds later...hearing a very large explosion and feeling it coming “up” toward them on the ninth floor from below, within the building. The last thing she remembers before she was knocked unconscious by debris was part of the roof hanging over and seeing blue sky. Her estimation of a 7-9 second interval between explosions is very close to the 10-second interval recorded by the Oklahoma Geological Survey seismograph at Norman, and should be taken very seriously. The initial shaking of the building was probably caused by the series of explosive charges placed at critical structural areas (such as those General Partin has spoken of) beginning to collapse much of the east end of the building.

What Jane Graham and others experienced during the bombing lends powerful credence to the multiple-bomb analysis of General Partin. Retired F.B.I. bureau chief Ted L. Gunderson and many others also believe there was more than one bomb. Yet the multiple-bomb theory in both trials wasn't even brought up, and when Stephen Jones [McVeigh's attorney] tried to introduce the possibility of a much larger bombing conspiracy, it was barred by the judge!

With the hasty passage by congress of the anti-and counter-terrorism legislation, which would have otherwise gone nowhere, many equate what h \*\*\*\*\* [Missing part, Al].

With much of the evidence being what it is who can legitimately argue against this point?

Jane Graham is a courageous lady for coming forward. And other bombing survivors will do the same. This is where each of you who reads this article can help. Jane Graham has given an extensive videotaped interview of what I have written about here. The interview is in a new video titled *Oklahoma Atrocity*. Get a copy and show it to your family and friends. With Congress still refusing to act, it will only be in this way, with many of you helping, that the real truth of this terrible atrocity will see the light of day. With thousands or tens of thousands of Americans working together one of the greatest cover-ups of the century can be broken and the truth presented to a jury in Oklahoma City.

I cannot emphasize to you, the reader, strongly enough how important the following information is, and how critical it is for as many of you as possible to act on it. A concerted effort (which this article is a part of) is currently underway in various parts of the country to get Jane Graham's videotaped testimony to as many of the bombing survivors and county and city officials as possible in Oklahoma City. A county grand jury was

impaneled last [summer], in Oklahoma City, and is currently looking into the bombing.

## BACKGROUND

DELTA—On April 19, 1995, at approximately 9:02 A.M. (local time) a series of explosions devastated the Alfred P. Murrah Federal Building in downtown Oklahoma City in what was by far the deadliest terrorist bombing in U.S. history. Since then, Timothy McVeigh has been convicted on all counts against him in the bombing and sentenced to death. His alleged accomplice in this horrific act, Terry Nichols, has been convicted of conspiracy and awaits sentencing.

Among the various charges; both men were accused of making and delivering a single 4800 lb. ammonium nitrate and fuel oil (ANFO) bomb to the front of the Murrah Building in a Ryder truck, which caused the terrible destruction and carnage, the aftermath of which was later witnessed by tens of millions on network television.

During both trials, the prosecution maintained that the devastation to the building and the tremendous injury and loss of life to those inside was caused solely by this single truck bomb. However, other things which occurred in the two weeks leading up to the bombing, as well as other events seen and recorded that morning, completely contradict this single truck-bomb theory.

To begin with, the seismic equipment at the Oklahoma Geological Survey at the University of Oklahoma at Norman, more than twenty miles away, registered “two” distinct ground motions some ten seconds apart at 9:02 A.M. on the morning of April 19th. And the seismometer at the Omniplex Science Museum much closer to the federal building, registered what many experts believe were as many as “six separate air blasts and shock waves,” in rapid succession at the same time! Yet the government and the major media have steadfastly reported only a single explosion!

And some of the most preeminent explosives experts on the face of the Earth have been totally ignored so far. One of these experts is Benton K. Partin, Brigadier General U.S.A.F. (Retired), who did extensive analysis and study of the “pattern of damage” to the Murrah Building, and concluded that it “could not” have been caused solely by a truck bomb, parked outside the building, regardless of how much explosives it contained! Because the “asymmetrical” damage pattern to the building was not consistent with a single point of detonation.

Who is Benton K. Partin, and what qualifications does he possess to make such critical analysis? To begin with, General Partin could rightfully be called the “expert's expert”, when it comes to high-explosives and bomb-damage analysis for the following reasons: In addition to spending 31 years active duty in the U.S. Air Force, 25 of those years were spent in research, design, development, test and management, of nearly every non-nuclear weapons-device in the Air Force. This included “hands-on work” at the Ballistic Research Laboratories, and Commander of the Air Force Armament Technology Laboratory. His military and professional accomplishments would literally take two or three more paragraphs to list (including: Air Force Systems Command, Air Staff and the Office of the Secretary of

Defense (OSD).

He has a B.S. in Chemical Engineering, an M.S. in Aeronautical Engineering and is a Ph.D. Candidate (academics completed) in Operations Research & Statistics. So, when one refers to General Partin as the expert's expert, concerning high-explosives and bomb-damage analysis, it is done so for a very good reason. After extensive analysis of hundreds of photographs and much videotaped footage, he released an extensive forensic report on July 30, 1995, entitled: Bomb Damage Analysis Of Alfred P. Murrah Federal Building, Oklahoma City, Oklahoma. It is an incredibly detailed scientific analysis and includes five color photographs (or Tabs). Preceding his analysis, he has a two-page "info copy" of a letter of the same date (July 30, 1995), which he sent to U.S. Senator Trent Lott of the Senate Intelligence Committee. "The attached report contains conclusive proof that the bombing of the Alfred P. Murrah Federal Building, Oklahoma City, Oklahoma, was not caused solely by the truck bomb. Evidence shows that the massive destruction was primarily the result of four explosive charges placed at critical structural points at the third-floor level."

A man of General Partin's military and educational background most certainly doesn't use such terms as "conclusive proof" and "evidence

shows" lightly, especially when writing about high-explosives and bomb analysis.

As truly incredible as it is, he has been ignored by most of our "representatives", both Democrats and Republicans in Congress!! And the media has continued to tell the American people it was all the result of a single ANFO bomb in the back of a Ryder truck.

# A Report To The People

## (The Killing of White Christian Children)

*Editor's note: For those of you who may be new to our readership, meet Gary L. During the latter part of April and first of May 1998, I developed very startling, in fact very frightening, information.

Ventura Rabbi Michael Berk and the two Mongol Jews Larry Tyler-Wayman and Al Gorsline, who Berk had infiltrated into the United Methodist Church as preachers, were involved in a murderous plot.

(Rabbi Michael Berk, Temple Beth Torah, 7620 Foothill Rd. Ventura, 647-4181. St. Paul's United Methodist Church, 1800 South C Street, Oxnard, 487-2711.)

The three Mongol Jews were preparing a 'chosen' student to go berserk and commit the same type of terrible shooting spree that had been activated only a few weeks before in Jonesboro, Arkansas.

But this time it was to occur at a high school, not at a middle school. My information led me to believe that these new killings were to take place at Oxnard High School.

Approximately the 8th of May, 1998, I left Oregon and traveled to Ventura County, California. My purpose being to warn responsible government officials and to stop this murderous conspiracy.

On Tuesday, May 12, 1998 I went to Mayor Manuel M. Lopez's place of business at 141 South A Street, Oxnard, 483-3328. I hand delivered to his secretary vital information regarding this conspiracy to kill school children. Manuel M. Lopez was standing in the rear of his office and observed me hand it to his secretary.

From there I proceeded to Councilman Thomas E. Holden's place of business at 1545 W.

5th Street, Oxnard, 382-2020. I hand delivered the vital information to Holden's secretary and she assured me she would personally give it to him before he went to the Council meeting which was that evening, Tuesday, May 12, 1998.

I then went to the Oxnard City Council offices at 300 West 3rd Street, 385-7430. At this location I hand delivered three separate sealed envelopes to the Clerk of the City Council. Each of these three envelopes had the name of a City Council member clearly written on it: Bedford Pinkard; Dean Maulhardt; John Zaragosa.

The Clerk said she would personally hand the envelopes to each of the three City Council members before the meeting started. This was several hours before the Council meeting was scheduled to start.

After that I traveled around the county contacting various people and researching.

The next morning I rented a car at the Oxnard Airport. I drove to Ventura City to contact some persons and within minutes of arriving in Ventura I was stopped by a Ventura City policeman and given a ticket. Even though my car had no identifiable markings the officer already knew it was a rental. I was standing outside to the rear of the vehicle, the officer went to the front left door, opened it and searched under the seat.

The officers name was Ro Jo, a Mexican. While Ro Jo was writing the ticket two other police cars were circling the area.

I had knowledge that there was a secret Mexican activist-cell operating in Ventura County. These people are fanatically dedicated to taking over California and removing all Caucasian Christians from all positions of political power and financial authority by whatever means necessary.

One of Ro Jo's activist connections in Ventura City Hall is Mabi Covarrubias from an Oxnard Mexican family. Covarrubias had been a city clerk in Oxnard where she participated in various shady transactions and operations with a Mongol Jew, City Councilman Michael A. Plisky.

Covarrubias married Councilman Plisky and was then sent to Ventura as a spy and became a city clerk. Councilman Plisky was appointed by the Oxnard City Council as the Chairman of the Oxnard Harbor Commission.

After getting the citation for supposedly crossing over double lines I circled around the city a while then met with some contacts. I typed a letter (report) to the Ventura City Chief of Police, Richard Thomas, and enclosed the same vital information regarding the killing of White Caucasian children that I had given to the five Oxnard city councilmen the previous day. I mailed the envelope to the Chief of Police (1425 Dowell Dr., Ventura, Calif., 339-4465) on Wednesday, May 13, 1998.

The letter (report) was also addressed to Amy Albano, Asst. City Attorney, City of Ventura. Approximately 4:00 p.m., shortly after mailing the envelope to the Chief of Police I went to the

Ventura City Hall, which used to be the old Ventura Court House: it is depicted on the cover of my book, *There's a Fish in the Courthouse.*

Sitting at the front desk of the City Attorney's Office was secretary Lupita Castor. I handed the letter to Castor, it was open (not folded), with the additional information paper-clipped to it, and she said she would deliver it to Albano's office. As she rose, Castor was reading my letter, she went rigid, stiff as a broom-handle, and flashed a glance of hatred at me. I told her, "I didn't ask you to read it—I asked you to take it to Albano, the Asst. City Attorney."

Castor continued to read the report as she went around a corner and disappeared down the hall.

The Ventura City Council had done a good job of stacking the City Attorney's Office with Mongol Jew shysters. Three of them were standing around in shirtsleeves: Karl Berger, James Neuerburg, Robert Boehm. They shot me a sour, disdainful look and shuffled into an office, closing the door behind them.

My letter that Castor was reading informed Albano that I was aware Oxnard Mayor Manuel M. Lopez was involved in deep corruption going on between Oxnard's and Ventura's Redevelopment scams. It involved numerous phony IRS 501(c) (3) Corporations they had set up to defraud the people of Ventura County.

Also, I let Albano know that Mayor Manuel M. Lopez had tipped Mabi Plisky and Ro Jo to keep a watch for me and create harassment for me. Shortly after I rented the car a Mexican security agent at the Oxnard Airport had phoned Mayor Lopez the full description of my car. I didn't learn this until after I had written and delivered the letter to Albano.

But now, at this point, the time must be taken to catch the reader up to what is happening here. In my book it reveals a corrupt scam years ago to take over the downtown area of Oxnard under the guise of Redevelopment. New malls, new banks, billions of dollars of bonds—and the Mongol Jews would own it all. The people would be dispossessed, lose their property and businesses and the only right left to them would be to pay the Mongol Jews for the bonds.

Roy Lockwood and a few other loyal Americans put their lives and future on the line and fought the Mongol Jews and were able to stop the massive corruption.

But now, the very same crooks, they are back setting up the very same corrupt Redevelopment scheme. The Mongol Jews never cease their totally destructive money-grubbing greed; it goes on and on and on.

The necessary basis of the scam is a corrupt City Council. They are the controlling authority and as such appoint themselves as the members of the Oxnard City Redevelopment Agency. As members of the Redevelopment Agency they set up IRS 501(c) (3) Corporations they call the Greater Oxnard Economic Development Corp., 721 A Street, Oxnard, and the Oxnard Community Development Commission. They claim these are nonprofit corporations with charity and education as their stated purpose, obtaining federal grants and state and local taxpayer money.

The City Council then appoints the officers and board members to the Greater Oxnard Economic Development Corporation:

Number one, the infamous Michael A. Plisky, who they had also appointed as Chairman of the

Oxnard Harbor Commission;

Armando J. Lopez, who is also Vice Chairman of Expo Development Corporation, their private corp. that the City Council members use on the side. Armando J. Lopez was a drug smuggler with big connections in Tijuana, Mexico. During Roy Lockwood's fight to stop the sale of bonds for the Redevelopment scam it was learned that Armando J. Lopez's part was arranging the laundering of drug-money through the new bank that City Councilwoman Dorothy Maronowsky (aka) Maron, a top Mongol Jew would own;

Manuel M. Lopez, Mayor of Oxnard;

Dean Maulhardt, an Oxnard city councilman;

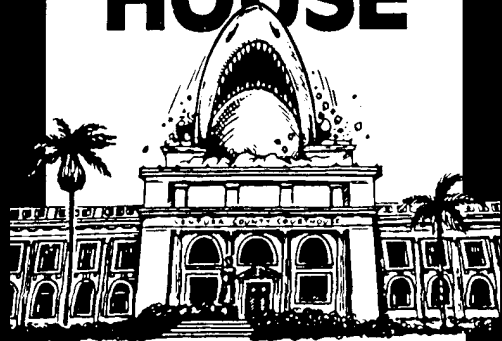

weapons to the FBI who had jurisdiction of the crime.

The FBI arrested and convicted two of the burglars but never recovered any of the weapons. Patton and I also knew that Begin, Cohen, Berenson, Nordman, Schienbaum and Glasser's terrorist cell had kept all the weapons stolen from the Oxnard Armory. The weapons never left the country because the Mongol Jews had scheduled them for another purpose.

The above-named terrorists had another deadly scheme they had created. They called it Race, Riot and Revolution. These Mongol Jew terrorist plots were financed by Caspar Weinberger and George Shultz with money from Bechtel Corporation in San Francisco. Melvin Belli was part of the Weinberger and Schultz operation.

William P. Clark was a Berenson and Nordman lawfirm member and was involved in their Armory burglary operations. Being part of the scheme of Race, Riot and Revolution which he knew was coming, William P. Clark, to protect himself, mounted one of the stolen National Guard 50 calibre machine guns in his house. He made statements that when the revolution comes he'll "mow all the Niggers and Mexicans down who come near" his house. The specific purpose of the Race, Riot and Revolution plot which they would provoke was to create racial riots throughout America to disrupt and cause chaos within the American government. The Black race riots in 1965 in Los Angeles and other large cities was part of their Race, Riot and Revolution conspiracy.

William P. Clark, a dyed-in-the-wool Democrat, was switched to the Republican Party and was infiltrated as a spy into the Ronald Reagan campaign by Berenson and Nordman and Weinberger. Reagan took Clark to Washington, D.C.; he became the National Security Director and then Secretary of the Interior. But then disaster struck them before they could install Clark as President. I had gotten word to Nancy Reagan about Clark being a Democrat spy and about his stolen 50 cal. MG that he was going to "kill Niggers and Mexicans" with when the revolution came. Within days the word from Washington, D.C. was put out that Clark had suddenly become homesick for California and he was on the Amtrack headed for home.

The huge cache of stolen military weapons from the Oxnard Armory had fallen into the hands of a fanatical Mongol Jew, Irving Rubin, the head of the murderous Jewish Defense League. And their Race, Riot and Revolution conspiracy was firmly in place. It was so efficient that, within seconds of the Rodney King jury verdict, south central Los Angeles burst out in flames; Race, Riot and Revolution, arson, looting, murder and mayhem.

The Mongol Jews have been provoking and festering the scam that the Mexicans own California and they are going to take it over. At the slightest provocation, Irving Rubin and the JDL are fully prepared and capable of dumping 300,000 to 400,000 rioting, plundering fanatical Mexicans into the Oxnard, Ventura and Camarillo

area, only a few hours from Los Angeles, San Diego and the San Joaquin Valley.

The City Council members of Oxnard, Ventura and Camarillo have the bounden duty and responsibility for the safety and protection of the citizens and property in their cities. They are required to notify the Chief Law Enforcement and Fire Protection Officers within their jurisdiction of the presence of a dangerous Mexican activist cell and imminent massive Mexican riots.

The Council members should advise their Chief Law and Fire Directors to contact the Intelligence Units of the Los Angeles Sheriff Dept. and Pasadena and Glendale Police Depts., obtain all information re: Irving Rubin and the JDL Mexican race riots that occurred in their jurisdictions.

A few years back, in Pasadena, a group of people had rented a small conference room at a hotel for a person to speak about a Black church in a southern state that was blown up. Several Black children were killed and the speaker's main purpose was to deplore such terrible crimes. This crime had occurred a number of years before and only a small group, mostly elderly men and women, were scheduled to show up.

But Irving Rubin and the JDL were stirring and provoking wild talk and spreading propaganda that this was a meeting of racists, KKK, separatists, skin heads and every other outlandish name a Mongol Jew can dream up.

I had received reliable information that Irving Rubin and his JDL were going to create a protest at the hotel and escalate it to major riot proportions. Myself and others traveled to Pasadena to observe the Rubin JDL operation. While there we also observed the hotel meeting room—it was quite small with seating for only 25 to 30 people. There was no one there and it appeared the scheduled plans for a talk had been abandoned.

Across the street from the hotel was an area of grass and trees with a low wall parallel to the street curb. We sat on the wall and observed.

Rubin and a few more Mongol Jews were parading around the street with placards and screeching about skin heads and racists, of which we saw none.

The Los Angeles Sheriff Dept. and Pasadena Police had barricaded the street. No cars were allowed in and everyone walking was checked out by the officers.

A crowd of people watching the goings-on was filling up the grassy area. Several Mongol Jews were circulating among the crowd passing out fliers that excoriated racists, separatists and every other bogeyman they could dream up.

One of the Mongol Jews approached us where we sat on the wall. Speaking broken English, he said he was Polish and had suffered all kinds of hate and discrimination in Poland and had come to America to fight hatred. He was a weasel looking kind of guy—very much resembling Menachem Begin and Ellie "Weasle". We had a conversation; it went like this: I asked him if he was Polish or a Jew.

"Oh yes, I am from Poland."

"No, I asked you if you were Polish or a Jew."

"Yes, yes, I am from Poland."

"You mean you are a Jew from Poland."

"No, I am from Poland."

"You aren't Polish. You are a Jew from Poland and you have come here to stir up and cause all the grief and turmoil you can for America."

Clutching his propaganda, provocateur fliers, he shuffled across the street to where Rubin and more Mongol Jews were yelling and screeching.

It seemed everything was under control. The officers were allowing no cars through the barricades and very few pedestrians. Then suddenly down the street to my right I saw the Dep. Sheriff's open a barricade and allow a large, 4-door, new-model blue sedan to enter the street.

The sedan moved slowly down the middle of the street and stopped directly opposite us not more than thirty feet distant. I was surprised, the occupants weren't ranking law officers inspecting their men—it was two rabbis in black clothes and black hats. Irving Rubin and several Mongol Jews had been pacing up and down waving placards on the opposite side of the street. Rubin ran over to the sedan and engaged in talk with the rabbi on the passenger side. Rubin was doing a lot of nodding his head and waving his arms.

Then down at the other end of the street I saw a huge mass of Mexicans approaching. They were quiet and under control and marching toward the hotel. None of the officers made a move to halt them. Marching at the head of the Mexicans, leading them and waving a placard on a stick was Sherry Rubin, Irving's wife. An insane woman, she, along with Irving, had been involved in many bombings and killing of people. The FBI was well aware of the murderous pair and their deadly activities, but like Janet Reno's Justice Dept. they just never seemed to do anything. They completely ignored the fact that Rubin and the JDL had a huge cache of stolen military weapons and they were training Mongol Jews with weapons to be used against America.

The rabbis and Irving watched the mob approach. When Sherry Rubin was opposite the rabbis she halted.

Over at the hotel I noticed two men walking toward the entrance. The rabbis looked at the two men approaching the hotel and said something to Rubin who was leaning into the car window. Rubin straightened up and turned to look at the two men. He gave a signal to his wife, she pointed her placard like a spear at the two men and started screeching in Mexican. The mob let out a giant roar. In an avalanche of unstoppable humanity the screaming mob of Mexicans charged at the two men who instinctively broke and ran for their lives.

Some of the officers attempted to break up the onslaught but, totally outnumbered, they were swallowed up. The riot was on.

Down the street a couple blocks the Mexicans were pouring around the corner in mass. I was amazed at the endless stream. Where they came from and the overwhelming logistics of this Mexican operation was the secret work of a powerful, quasi-military cell, the Jewish Defense League. The dark-blue sedan rolled slowly down the street, right past the horde of running Mexicans. The officers opened the barricade and let the rabbis drive through.

Any Mongol Jews trying to deny these facts of the Pasadena riots will be proven to be liars by the vivid film taken of the events.

It is shocking that our government, the FBI, ATF, Secret Service, etc., etc., is allowing such a treasonous, murderous cell from a foreign country to operate in America.

However this is very understandable, knowing that our government in Washington, D.C. and on down to the basis of our American politics, **the city councils of every city in America are**

**under total control of the Mongol Jews.** And right down at the city council level is where all the Mongol Jews' bond racket thrives.

There is one more person the Oxnard City Council appointed to the Board of Directors of their IRS 501(c) (3) organization, called 'The Greater Oxnard Economic Development Corporation'. And that is Terry Myers, of Bouquet Multimedia. Sounds real innocuous, but Terry Myers and Bouquet Multimedia are anything but innocuous. Terry is a typical Hollywood product. A complete denizen of the Hollywood jungle, she is married to a grubby, obscene Mongol Jew: Stan Kaye, a very wealthy, influential Hollywood mogul.

The rich Hollywood Mongol Jews love the title of mogul out of their veneration for Mogul Genghis Khan, the murderous Mongolian Jew plunderer whose thieving footsteps they follow.

Stan Kaye and his wife Terry, a board member of the Oxnard Economic Development Corp., are part of and connected to the Entertainment Industry Development Corporation, with its main office at 7083 Hollywood Blvd., 5th Floor, Hollywood, California 90028. A Mongol Jew, Cody Cluff is president of this corporation.

They specialize in billion dollar money-making operations, like TV series such as *High Tide*; *Mike Hammer*, *Private Investigator*; *Melrose Place*, etc., etc., that are being filmed in Ventura County. And live documentaries, like provoked race riots on the scene.

They are moving out of the expensive Hollywood studio sets and into cheaper, more realistic on-scene locations. They have locked into the convenient, close to Hollywood, scenic county of Ventura where they control everything, politics, judiciary, banks, commerce, real estate, drugs, etc., etc.

Through another one of their organizations, the Oxnard Community Development Commission, the City Council controls real estate sales and commissions. The 'CDC' is operated by Richard Maggio, Alex Herrera, Steve Zimmer, and Diane Kubiske at the City Hall.

The Greater Oxnard Economic Development Corp. and the Entertainment Industry Development Corp. have seized the entire entertainment industry filming in Ventura County. They advertise for and pay home owners, businesses, for their boats, cars, industrial buildings and agriculture locations for filming to the complete exclusion of all other film and TV production work. No one else can get permits or permission. Production companies submitting contracts to film at Oxnard Harbor were denied by Oxnard Harbor District Commissioner Michael A. Plisky. They have it sewed up and there is no legal recourse to file a lawsuit in the courts because the Mongol Jew Judges simply dismiss them.

Hollywood Mogul Stan Kaye and his wife Terry Myers, a Director of the Greater Oxnard Economic Development Corporation, bought the former Raytheon Corp. buildings on Highway 1 in the Point Mugu area. They have remodeled this property into a movie, TV, and documentary production studio called Bouquet Multimedia.

Very strangely, ninety million dollars to finance this operation is being put up by the Los Angeles Department of Water and Power. This financial operation is being handled by the Dept. of Water and Power general manager, Mongol Jew S. David Freeman. However, this is not so

strange after all—the Oxnard City Council has a serious problem with HERO. The problem is the water supply and sewage treatment.

The Oxnard underground water situation is in big trouble with salt-water intrusion because so much water is pumped out for city and agriculture use. But no one knows what kind of secret negotiations or deals the City Council is cutting with LADWP General Manager S. David Freeman for the Ormand Beach property. The Ormand Beach property is the two-hundred acres the LADWP wants to supposedly build a desalination plant on but which could end up as a sewer-waste-treatment plant.

Now for a minute we go back to the old Redevelopment scam and their IRS 501(c) (3) 'non-profit' Corporations.

Mongol Jews Berenson and Nordman set up the Ventura County Public Facilities Corporation, and with their Los Angeles Mongol Jew buddies they set up another phony corporation, the Southern California Public Powers Authority. This was tied in with the LADWP Colorado River Water in a multi-billion-dollar scam, a nuclear power plant to be built at Palo Verde, Arizona.

The Mongol Jews were all set to drop billions of dollars of their bonds on the taxpayers. However, in the middle of this, I had filed a lawsuit in Ventura Superior Court to halt the sale of the bonds by the Ventura County Public Facilities Corporation. Through this corporation they were stealing the Ventura County Courthouse from the people. At the same time an investigative reporter, Don Bolles with the *Arizona Republic* was investigating the LADWP and the Southern California Public Powers Authority involving the Palo Verde bond fraud. A group of anticorruption citizens had filed a lawsuit in Los Angeles County to halt this bond-sale fraud.

The article Bolles was preparing to write in the paper would have exposed the entire Mongol Jew multi-billion-dollar bond scam. Not to mention putting a whole bunch of them in prison, including the Mongol Jews Barry and Bob Goldwater and Harry Rosenzweig.

At this time in June 1976 Don Bolles was set up and a bomb was put in his car. He was blown up and killed and two days later they tried to shoot and kill me in the driveway of my home.

The Mongol Jew judges dismissed all the lawsuits against their corporations and the Mongol Jews sold billions of dollars of bonds, indebting the taxpayers. In Arizona the Maricopa County Attorney, Donald Harris, stated that Bolles' murder was a conspiracy with numerous persons involved and he was going to conduct a Grand Jury investigation. This would have involved Barry and Robert Goldwater and gangster leader Harry Rosenzweig.

The Goldwaters and Rosenzweig had Bruce Babbit, the Arizona State Attorney General, enter Donald Harris' office, remove Harris from the case and steal all the investigative files and kill the Grand Jury Investigation.

In Ventura, the two Mongol Jews, Dist. Atty. Michael Bradbury and County Counsel James McBride, were given millions of dollars of Ventura County Public Facilities Corp. bonds. This was for their part in covering up the fraud and dismissing my case which was preventing them from selling their bonds. Don't puzzle too much over Bradbury's and McBride's Anglo-sounding names; remember how Judge Hymie Blitzberg, born in Mongolia, became Steven

Stone.

Bradbury is presently backing one of his Dep. Dist. Attorneys for Superior Court judge. A Mongol Jew, Kevin Mc Gee is Bradbury's hatchet man whom he uses to frame his political enemies in "kangaroo courts".

Bradbury and McBride after years of their criminal corruption, have plans to retire as millionaires. However, a thorough financial audit of the bond and money manipulations of the Ventura County Public Facilities Corp. will expose the Mongol Jew judges behind the vast corruption.

The Ventura County Public Facilities Corp. owns the Courthouse and the billions of dollars these thieves have stolen over the past thirty years can be recovered by the taxpayers.

Back to the present—on Tuesday, May 12, 1998, before I delivered the documents to the Oxnard City Councilmen, I went to St. Paul's United Methodist Church, 1800 South C Street, Oxnard, 487-2711.

I hand delivered the documents to a secretary and asked her to give them to Al Gorsline and Larry Tyler-Wayman. She said she would do so.

These documents and information made it clear to Gorsline and Wayman that I was aware of their murderous plot, which I believed was to occur at the Oxnard High School. Also of their connection to the United Methodist Church in Jonesboro and its involvement with the young boys in the Jonesboro school shootings.

By May 18, 1998 I had returned to Oregon thinking and hoping that perhaps I had stopped another murderous school shooting spree and the killing of children.

On the morning of May 21, 1998 I was writing a Report to the People. Suddenly on CNN TV Breaking News they blasted out the sickening story that in Springfield, Oregon (not Oxnard, California—not far from me), a fifteen-year-old student had gone on a terrible shooting rampage.

At Thurston High School, student Kipland P. Kinkel in this violent rampage killed two students and wounded more than twenty others. It was later discovered he had also killed both his parents at home.

It was with a shock that I discovered—directly across the street from the main entrance to Springfield's Thurston High School was St. Paul's United Methodist Church, 332 58th Street, 541-747-3921. Thurston High School is at 333 58th Street.

Shortly after the Jonesboro, Arkansas school killings, Tuesday, March 25, 1998, I had mailed information to the United Methodist Church and six other churches in Jonesboro. I notified them that there was something terribly wrong going on within the churches. And that the preachers, through their phony Interfaith and Faith Connection with the Synagogue, were indoctrinating young White Christian children with the rabbis' evil sex laws.

There was no response from any of the churches and they covered it up. Then the Oregon, Thurston High School killings occurred.

Kinkel will be tried as an adult on murder charges, but he cannot face the death penalty because of his age. His attorneys, Richard Mullen and Mark Sabitt of Eugene, Oregon are court-appointed.

Kinkel's lawyers are considering an insanity plea and might use a Prozac drug defense. In the summer of 1997 Kinkel was diagnosed with clinical depression and was given Prozac but

stopped using it in the fall.

The chairman of the American Psychiatric Associations Council on Children, Adolescents and their Families, David G. Fassler says, "Prozac defenses do not have a proven track record. It has been attempted but to my knowledge there is no evidence to suggest that Prozac or other anti-depressants cause violent behavior. There is no generally accepted evidence to suggest the medication itself or withdrawal from medication leads to violent behavior."

What Fassler says may or may not be true. Prozac may not cause violent behavior but Fassler cannot deny that the Prozac drug leaves a young person in an insensible state. A state wherein he is deprived of perception awareness and emotion.

Prozac alone is not responsible for these terrible, tragic school killings, there are two more elements. In all, there are three necessary elements involved in these murders.

First, there is Prozac administered to the young person because it has been determined by someone that he is depressed.

Second, there is aggressive, intrusive 'counseling' such as these shooters have been subject to by preachers at the United Methodist Churches under their InterFaith and Faith Connection with rabbis and their *Talmud Sex Laws*.

For people to understand what these *Talmud Sex Laws* that are being drilled into young Christian children are all about, I will give two examples:

In the *Talmud, Sanhedrin, 54a - 55a - 55b*: "Pederasty (sodomy) bears no guilt as long as it is performed on boys less than nine years old and sex is permitted with girls less than three years old."

*Kethuboth, 11a - 11b*: "When a grown up man has intercourse with a little girl it is nothing, for when a girl is less than this it is if one puts the finger in the eye, for as tears come to the eyes again and again, so does virginity come back to the little girl under three years."

While a young person is in this Prozac-drug-induced state, deprived of normal perception and emotion, a professional can easily implant murderous thoughts that reside in the depths of the brain that can be unleashed days or even years later. It is a type of programming such as *The Manchurian Candidate*, a Hollywood film, describes.

Third, is the trigger that sets it all off—not the trigger of a gun, but the mental trigger that unleashes and activates these terrible, implanted, evil thoughts. The trigger is rage; a flash of terrific, violent anger that is set off by a heated, sex-jealousy, girlfriend-boyfriend fight.

This third element, as in all the school murders, was the trigger in the Kinkel rampage. This element has been very carefully concealed and covered up by Oregon's major newspaper, *The Oregonian*.

These school murders fit the evil purposes of the provocateurs dramatically. After each incident the clamor by the Mongol Jews to remove the guns from the Christians is renewed.

Such treasonous Mongol Jew politicians as Diane Feinstein, Barbara Boxer, Charles Shumer, Carl Levin, Arlen Specter, Tom Lantos, etc., etc., etc., screeched from Washington, D.C. to Hollywood, Calif. to take the Christians' guns away from them.

When the Mongol Jew-inspired and provoked Race, Riot and Revolution chaos, that former

National Security Director William P. Clark is part of, strikes America, the Mongol Jews do not want the White Christians to have any weapons to defend themselves against the heavily armed Jewish Defense League.

There are thousands of Mongol Jew private schools around the country. Do they give Mongol Jew school children Prozac—are the Mongol Jew children killing each other—why is it that only White Christian children are being murdered??

The Oxnard City Council members never alerted their Police or Fire directors of a possible shooting at Oxnard High School. Had the Oxnard shooting been switched to Oregon to take the heat off of Oxnard's St. Paul's United Methodist Church and Rabbi Berk?

What secret communications there were between the Oxnard St. Paul's United Methodist Church and their St. Paul's Church in Springfield, Oregon and Jonesboro, Arkansas is not known at this time.

It can happen anywhere—it might still happen in Ventura County.

And the Mongol Jews' Bouquet Multimedia—Entertainment Industry with their exclusive power will be right on the spot to film, produce, edit, censor and distort the provoked event.

The Mongol Jews with total control of this Hollywood documentary will make billions of dollars from world-wide film distribution, detailing America's terrible contortions and pain of school murders and Race, Riot and Revolution.

Mongol Jews Terry Myers and Stan Kaye could even win Hollywood Oscars for their entertainment genius.

In frantic eagerness to sell out the people for Mongol Jew bonds the city council persons, with their almighty greed and depravity, purposely thrust their own children, grandchildren, nephews and nieces into death's bloody path.

Knowing the evil they have done, the Christian city council persons grovel on their knees in a quivering mass of blubber. They are in abject fear that the Mongol Jew council members will brand them as 'anti-Semitic' if they dare to speak out the truth.

I hold these betrayers of God and their own families in the most bitter contempt.

If there is to be Godly retribution for all these ghastly school murders I pray that it will be the avaricious, craven politicians who are the target—and not more innocent children.

While watching the *Larry King* CNN TV show I saw and heard one of his Mongol Jew guests make an amazing statement. It was so unexpected and totally revealing that King's bug-eyes were banging on his glasses. King quickly switched the subject. Just those few words blurted out spotlighted the evil source of all of America's terrible torture.

The subject of the discussion on the *King* show was Monica Lewinsky and William Clinton. King's guest was Jonah Goldberg. He is the son of Lucianne Goldberg, the friend of Linda Tripp who made tapes of her phone conversations with Monica Lewinsky.

Jonah was talking to

Larry King about Monica's lawyer William Ginsberg when he let loose with his blockbuster words. Goldberg said lawyer Ginsberg was spreading it around that everything about Clinton and Lewinsky should just be washed away because, quote, "Clinton is good for the Jews."

William J. Clinton has been far more than just good for the Mongol Jews—he has handed America over to them on a silver platter. Every government office and agency in America is filled with Mongol Jews. But still the Mongol Jews are not satisfied—they want the life's blood of every last White Christian in America.

To understand the full implication and the power of DNA and its rigorous preciseness in its exposure of the Mongol Jews' lies, the *Dead Sea Scrolls* are a criterion. The scrolls are a judgement by which the Mongol Jews' monstrous conspiracy to lay claim to Biblical History is laid bare.

The Mongols' language was Yiddish. While they were being converted and taught Judaism they coined the word Jew which was easier for them to pronounce than the word Juda.

Now we get to the *Dead Sea Scrolls*.

Lawrence H. Schiffman, a Mongol Jew, has the impressive title and distinction of Chairman of the Skirball Department of Hebrew and Judaic Studies. And also as chairman of another outfit he calls the Ethel and Irvin A. Edelman Professor of Hebrew Judaic Studies at New York University.

Schiffman, from this lofty perch of Mongol Jew intelligentsia, promotes and writes the damndest, most poisonous propaganda and scurrilous lies.

Schiffman's twisting of the *Dead Sea Scrolls*—to fit the Mongol Jews' lies that they are Semites and God's Chosen People—is tortuously evil.

The *Dead Sea Scrolls* were discovered in caves in what at the time was Jordan. Nearby, adjacent to the caves, was a settlement area known as Qumran. Archaeological excavations of Qumran were conducted in the 1950s.

Schiffman says that during the archaeological excavation of Qumran, ruins of a communal dining hall and a large number of ritual baths and Jewish burials were uncovered.

Schiffman carries on: he claims that Jews lived in Qumran from 150 BCE until 68 CE when Qumran was destroyed by the Romans during the Great Revolt of the Jews against Rome (66-73CE). And that the *Scrolls* are identified with the Essenes, a previously known Jewish sect. But Schiffman is forced to admit that, "The meaning of the word 'Essene' is not certain and does not occur in the *Dead Sea Scrolls* or in any other ancient Hebrew text."

Now listen to how a Mongol Jew lies when he doesn't know how to explain a circumstance. And how he chops it up so the pieces can be jammed into place like in a jigsaw puzzle by a madman wielding a jackhammer. Quoting Schiffman: "The difficulties of the Essene sect theory are amply shown, while accepting its unproven and tentative nature is an approach that deserves emulation on the part of many *Scrolls* scholars who are 100% convinced that that which cannot be proven is, indeed, fact. The composition of the *Dead Sea Scrolls* ranges over a very long period and the manuscripts were copied between the third century BCE and the early first century CE. This dating has been confirmed by paleography (the study of writing), archaeology and two independent sets of sophisticated carbon-14 tests. Thus the *Scrolls* are pre-Christian and cannot have any direct references to Jesus or John the Baptist."

Now listen real close to Mongol Jew Schiffman on this one: "Scholars are now aware that Christianity developed out of a complex of Jewish ideas which circulated among various circles and which are reflected in part in the *Dead Sea Scrolls*. The *Scrolls* help us to realize that much of what may have been previously taken to be foreign influence on Christianity is now known to stem from Jewish roots. At the same time, we can now better understand where Jesus differed from the Jewish groups of his time. Many substantial differences exist between his teachings and those of the Qumran Essene sect."

the editor of the ministry and also executive director of the operation. The associate editor is David Levy.

The propaganda in this slicky is taken directly from the University Professors of Judaic Studies like Schiffman.

Almost word for word it repeats Schiffman, quote, "The *Dead Sea Scrolls* indicate that the group of ascetic Jews at Qumran were still looking for this great prophet."

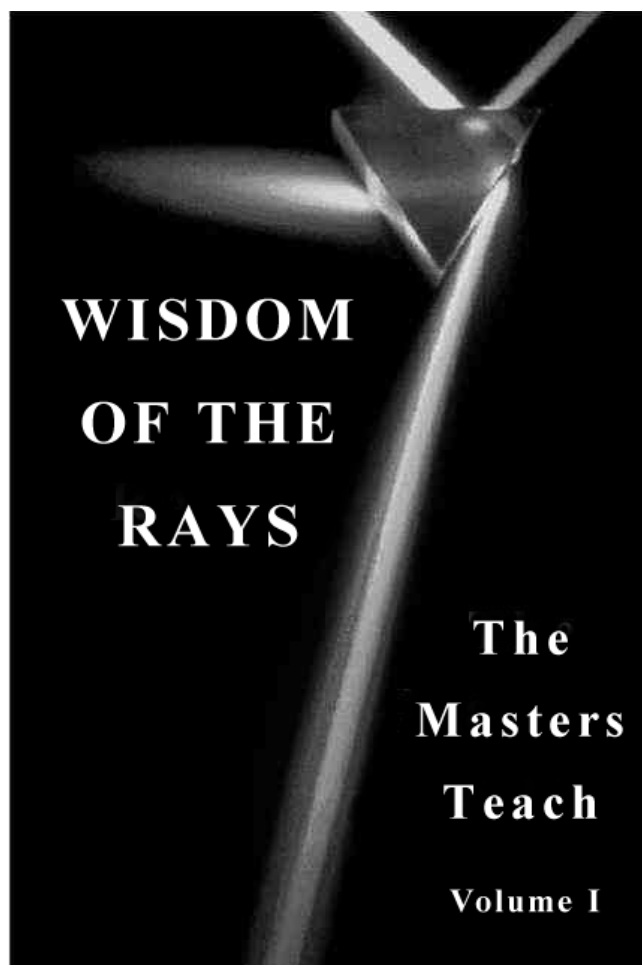

The article "Dispatches from FRANCE" by Peter Strudwick is reprinted from the British conservative magazine—*Right NOW!* It will give you an idea of what will go on at the National Front festival in Paris, France, in September.

### DISPATCHES FROM FRANCE

Tens of thousands of patriots from all over France descended upon the Pelouse de Reuilly on the edges of the Bois de Vincennes, eastern Paris, on the weekend of the 27/28 September 1997 for the Front National's seventeenth annual festival, the *Bleu, Blanc, Rouge*. They were rewarded with two days of fine, warm weather.

Already larger than the UDF, and fast approaching the size of the RPR, the FN has had a highly successful year. The *BBR* was just the sort of jamboree to celebrate it. With support levels in some regions of France (particularly in the south

and the industrial north east) running at over 35%, and with national opinion poll ratings at 16%, the FN's implantation into the political mainstream is undisputed and irreversible. Its proven record of competent local government, in Toulon, Marignane, Orange and more recently, Vitrolles, has led to its enhanced political stature and credibility and encouraged increasing numbers of French men and women to embrace its core nationalist values.

The festival is a key event in the FN calendar—a three-line whip for party activists. All the national and regional leadership attend. The party's 92 branches proudly set forth their colours and achievements, while 18 various affiliated organisations, covering economic, social, cultural and intellectual endeavours, display to the enthusiastic masses their work and their linkage to the FN in the political process.

The festival events are meticulously organised and laid out, by the FN's events committee, on a grand scale. Two avenues of marquees and smaller tents, about 400 yards in length, meet at a central point in the form of a cross. All the party's regional branches reserve their places. Oysters, charcuterie, armagnac and cider are consumed ravenously. On the periphery, pony rides, dodgem cars and coconut shies (with effigies of the failed politicians of the 5th Republic inviting targets) all do brisk business. Fathers in sports jackets and ties, mothers and elderly matrons in sparkling summer dresses, rub shoulders with Army veterans, and people dressed in a variety of country costumes. Everyone feels at ease at what the FN describes as "this grand festival of friendship and nationhood".

I was attending my third successive *BBR*. It was an ideal opportunity to renew friendships and sample again the unique atmosphere that the festival generates. The first stand I visited on the Saturday morning was manned by Professor Jean-Claude Martinez, an FN Euro MP and one of the party's foremost intellects. A taxation expert at the University of Paris II (Assas) he is the author of eleven books; one a 300-page account of how France would be run in Le Pen's first hundred days in the Elysee. Martinez, who has recently been placed in charge of the FN's "shadow government", is a *rapporteur* of the agricultural committee of European Parliament. We chatted for a few minutes before I moved on to see Bruno Gollnisch, also a Euro MP, the FN Secretary-General, who succeeded Carl Lang (the party's social affairs expert and also a Euro MP) two years ago. Gollnisch, another formidable intellect, was the youngest ever Dean of Law School at Lyon III University. He expressed unqualified optimism for the future development of the party and was particularly gratified by its huge expansion in universities and colleges.

At mid-day the first of a series of political discussions and debates, lasting in all four hours, began in the central arena marquee. Each discussion period was led by a party expert, on subjects as diverse as the economy, industry, immigration, security, taxation, local government and defence. The audience seemed to

be particularly knowledgeable.

On the Saturday evening I was invited by the Paris region federation (Ile de France) to their dinner party. After a splendid four-course meal, the guests settled down to a one-hour rendering of patriotic songs performed by former members of the parachute regiment in the presence of Jean-Marie Le Pen—no slouch himself when it comes to lusty singing.

The Sunday events at the BBR got into full swing in mid-morning after celebration of open air Mass, a traditional feature of FN gatherings. The crowds were bigger than on the Saturday. My first visit was to the tent of the Catholic nationalist daily newspaper, *Présent*, displaying its books and pamphlets. I spoke with Georges-Paul Wagner, Le Pen's advocate in numerous lawsuits, now retired from practice but a leader with the paper. With him was Caroline Parmentier, a young campaigning journalist with a big following, whose new book, simply entitled *Journaliste*, chronicling her 10-year career with the paper, was worth every franc of the hundred I paid for it, on account of its insights into the lies and misrepresentations that the national movement faces from the French media, misrepresentations also faced by the weekly papers *National Hebdo* and *Rivarol*, both of which are in the FN camp.

I was particularly pleased to meet the distinguished Jewish journalist, Jean-Pierre Cohen, former editor of the weekly *Minute* and current member of the FN's Central Committee. With Bernard Antony (Euro MP and leader of the FN satellite grouping, *Chrétienté-Solidarité*) Cohen has written a formidably documented booklet: *Ni raciste, ni antisemite*, a compelling rebuttal of allegations of racism and anti-Semitism levelled against the national movement by the Left, liberals and politically correct.

After taking in further debates at the central marquee I looked forward to the principal event of the festival, the closing address of FN President, Jean-Marie Le Pen. 70,000 were now in the Pelouse. In a wide-ranging address lasting just under two hours, Le Pen spoke about the party's year, its achievements and its aspirations. He strongly emphasised the democratic and republican outlook of the FN and that no one would have cause to fear its inexorable advance unless they themselves rejected the democratic process.

I left the BBR with an instinctive feeling that the party's ultimate triumph, against all the odds, may not be that far away. [End quoting]

It is apparent that Mr. Le Pen has developed his National Front as a third political party in France and has gained some popular appeal over many years. His political stand is Nationalism, although there is no discussion in the material about the important aspects of that Nationalism. A friend (P.C.) reported to me that the French newspapers in Quebec carry frequent articles about Mr. Le Pen's activities. It is interesting how little attention he receives in our own controlled media.

Perhaps we will hear more about Mr. Le Pen's activities as time goes by and people learn the value of his views. Hopefully, there may be those who can attend his Festival in September and report back to us. As the editor of *The Barnes Review* sees it, Mr. Le Pen, as an example to the world, may be our last chance to turn around the "Decline of the West".

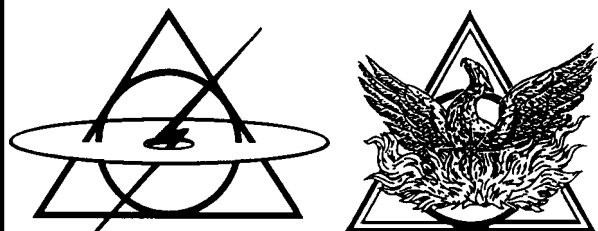
