### RUSSIA, IMF, EBRD DISCUSS GOLD-BACKED BONDS

Russia, the International Monetary Fund (IMF) and the European Bank for Reconstruction and Development (EBRD) on Tuesday discussed the possible issuance of Russian gold-backed bonds, the finance ministry said.

The ministry said in a statement that the bonds were one of the first questions discussed during talks with the IMF. The bonds are aimed at financing gold producers and the Fund has been reported as having some objections over the project.

"The head of the IMF mission, Jorge Marquez-Ruarte, told the participants of the talks that after further consultations on the project with IMF specialists, the IMF would send the Russian finance ministry an official declaration on this question," the statement said.

The ministry said the head of precious metals reserve Gokhran presented a report on the project and that the discussion involved the EBRD, WestDeutsche Landesbank, the government and the Association of Russian Commercial Banks.

The EBRD had earlier said it was considering a plan to lend money to pre-finance gold production by buying certificates or bonds backed by gold.

The loan would be used to finance production, on the basis that the companies would deliver a specified amount of gold at the end of the period, which would be sold to pay off the loan.

The amount being discussed was 50 tonnes of gold with the loan for a period of 11 months to one year, roughly equal to the gold production cycle.

Russian media had earlier reported that the IMF had objections to the scheme as it was worried it would impact the dwindling gold and hard currency reserves of the central bank.

An IMF mission is currently in Moscow, discussing whether and on what basis it would give more credits to Russia. [End quoting]

### ROOTS OF THE BRAZILIAN CRISIS

Just when it seemed the worst was over for Asia, a new and potentially huge crisis has

developed in Brazil. The devaluation of the Brazilian real last week marked the failure of the IMF-style policies in that country, and raised the spectre of a financial meltdown in the world's eighth largest economy. Martin Khor gives the background to the crisis.

The devaluation of the Brazilian real last week caused shockwaves around the world, raising fears of a new round of financial instability that could delay a recovery in Asia.

The Brazilian crisis is also a blow for the International Monetary Fund and the Group of Seven developed countries, which had insisted that developing countries, like Brazil, should still allow the free flow of capital into and out of their economies, despite the damaging effects.

With the IMF's free-market model even more in tatters, there could well be a shift of world opinion in favour of Malaysia-style exchange controls for countries wanting to insulate themselves from volatile capital flows.

The developments in Brazil are a blow to hopes that the global economy was beginning to become more stable, following the roller coaster ride that began with the Thai crisis 18 months ago, spread to other Asian countries and hit Russia last year.

Throughout this period, Brazil had also been subjected to speculative attacks. Its central bank spent US \$9 billion of foreign reserves to defend the real in October 1997.

Twelve months later, it faced another serious round of capital flight.

The real would have been devalued then, except for a pledge by the IMF and the G7 countries that they would provide a US \$41.5 billion loan for Brazil.

It was meant to be a new kind of IMF deal,

one put in place for a country in trouble before a crisis strikes, so as to prevent a financial meltdown and devaluation, rather than previous IMF deals which were made after the breakout of crisis.

It was crucial for the IMF's already tattered reputation (and more importantly, for the credibility of the free-market policies it advocates) for Brazil to stand up, stick to the IMF's usual conditions, and avoid a financial crisis.

Another big failure would bring the free capital mobility model, already being blamed by so many experts for the Asian debacle, crashing down.

There were already voices within and outside Brazil that called on the government to impose some controls on the exit of funds and prevent an impending and uncontrollable exodus of capital.

But the authorities decided to stay faithful to the IMF-style policies of maintaining free capital flows, cuts in government spending and other reforms, and at the same time defending the value of the real. [End quoting]

Things will never get better until the politicians quit dealing with the "devil himself": the IMF and world banking gangsters.

### MULTICULTURALIST TEACHERS PUSH FOR REVOLUTION

The professional educators working to design an ideology for the new multicultural America often pose as advocates of "tolerance". But speeches delivered last November at the sixth annual conference of the National Association for Multicultural Education (NAME) show that the real goal is to consolidate the left-wing's political dominance.

Notes taken by education researchers at the NAME conference in St. Paul, Minnesota, reveal that multiculturalist teachers, far from endorsing tolerance, condemned private property as an instrument of "White supremacy" and vowed to start a revolution in the U.S. against the American people and their way of life.

NAME is the professional teachers' association that seeks to replace normal public school courses with multiculturalist curricula. Courses endorsed by NAME teach the notions of "global citizenship" that are being promoted in schools and commercial advertising by multinational corporations as a way to enhance international trade. By indoctrinating public school students with an ideology that deconstructs the tradition of liberty established by America's founders, NAME's multiculturalist educators hope to foment a revolution against middle-class values.

Far from being a course of study to teach tolerance for "ethnic diversity", the goal of multiculturalist schooling, the speakers said, is to achieve power for some groups at the expense of others. Geneva Gay of the University of Washington told one conference workshop that multiculturalist education demands the destruction of the American political and economic system.

Multicultural education is about power. Multicultural education is about the reallocation of power, said Gay. Multiculturalism is about creating a revolution. She said people of different cultures shouldn't have to adjust to life

in the U.S. Why should they adjust to a society that "isn't any good for any of us", she asked. Gay urged multiculturalist educators to be cautious about revealing their goals to the public. "The way I am talking to you here, I would never speak with people outside the field," she said. [End quoting]

### ESTRADA TO INSIST ON 75-25% WEALTH DEAL

The government wants a 75 percent share of the recovered wealth of the Marcos family to indemnify human rights victims during martial law and to provide funds for pro-poor projects, President Joseph Estrada said yesterday.

He said his administration is already set to negotiate formally with the heirs of the late dictator for a sharing of the fabled Marcos wealth believed to have been ill-gotten during his 20-year presidency.

Mr. Estrada said he has been informed by Marcos' son, Ilocos Norte Gov. Ferdinand "Bongbong" Marcos Jr., that former First Lady Imelda Marcos has given her children the signal to sit down with the Estrada government.

"We'll start with a claim of 75 percent of the wealth. I am also pushing for this because there is already some \$580 million in an escrow account at the Philippine National Bank," the President said during his weekly radio program.

The money at PNB were funds deposited by Marcos in Swiss banks. These funds were ordered released and transferred to an escrow account in the Philippines by the Swiss Supreme Court in 1997. However, the money cannot be withdrawn unless Mrs. Marcos is given her day in court.

Mr. Estrada pledged that he will ensure that any deal with the Marcos family was "favorable" to the government.

"I told him (Ferdinand Jr.) that it is my duty to make sure any negotiation favors the government. This was my pledge when I assumed the presidency," he said.

Mr. Estrada and the Ilocos Norte governor met Friday night at Malacañang, where Ferdinand Jr. reiterated his family's offer for a "global" compromise deal.

"He visited me yesterday and we talked about a possible negotiation," Mr. Estrada said.

"But I told him whatever negotiation that may happen ... it must be lawful and, it must be advantageous to the government," he added.

Ferdinand Jr. had offered to share the Marcos wealth on condition that the government would drop all pending cases against the Marcoses.

Mr. Estrada surmised that what Bongbong meant by "global" is the extent of the Marcos family's wealth. "That's why we need these negotiations so that the Marcoses can point to us where these assets are located," he said.

According to Mrs. Marcos, the government need not go abroad to look for her family's wealth because several of these assets can be found in many of the country's largest corporations. "I have documents to prove (we own) it," she added. [End quoting]

### NEARLY 9,000 DIE IN EARTHQUAKES DURING 1998

Nearly 9,000 people died worldwide in earthquakes during 1998, triple the number that died the year before and a twenty-fold increase from 1996, the U.S. government said.

Despite the rise in deaths, the number of people killed by earthquakes last year was still under the long-term average of about 10,000 annually.

"This is the fifth consecutive year in which the death toll has been below average worldwide," said Waverly Person, a director with the U.S. Geological Survey, which recently compiled the earthquake data.

The agency's analysis showed that 8,928 people died from earthquakes around the globe in 1998, compared to 2,907 the previous year and just 419 people in 1996....

The strongest earthquake in the world last year registered an 8.3 on the Richter scale and took place March 25 in the Balleny Islands region between Australia and Antarctica.

The only other earthquake above an 8.0 occurred on Nov. 29 in the Ceram Sea near Indonesia, registering 8.1 and killing 34 people....

The impression that more earthquakes are occurring could be due to the agency's ability to detect more earthquakes thanks to the growing number of seismograph stations around the world, Person said. [End quoting]

### FOOD-POISONING SCAMS AT TAJ MAHAL

NEW DELHI, India—Heading to the Taj Mahal? Be careful where you eat.

Police say unlicensed guides and shady restaurant owners are teaming up with unscrupulous doctors to sicken foreign tourists with tainted food and then divvy up their medical insurance money.

A Scottish man and a South Korean woman told police in November that a cheap restaurant near the world-famous monument served them food that made them ill, then took them to a doctor who charged huge amounts to cure their diarrhea.

Police believe once the tourists' insurance company had paid the inflated medical bills, the profits were split among the doctor, the restaurant owner, and the guide. In some cases, police say, even the tourists themselves participate, agreeing to file false insurance claims in exchange for cash.

In the case of the Scot and the South Korean,

police have arrested six people, including the restaurant owner and a guide, on charges of serving adulterated food, Agra senior police superintendent Subesh Kumar told *The Associated Press* this week.

Police have identified dozens of doctors, restaurants and self-styled guides involved in such scams and have warned them, Kumar said.

Dr. Sudhir Gupta, who has investigated such cases for foreign insurance companies, says the doctors charged between \$465 and \$1,400 for treatment—substantial sums in India.

The Taj Mahal, built by the Mogul emperor Shah Jahan as a tomb for his queen, Mumtaz Mahal, attracts three million tourists a year. It is located in Agra, 125 miles south of New Delhi. [End quoting]

### FEINSTEIN CAMPAIGNS AGAINST GAS ADDITIVE

Excerpted from *THE DAILY NEWS*, Los Angeles, 1/27/99: [quoting]

Sen. Dianne Feinstein has asked Congress to drop California from a federal order requiring the use of gasoline additives such as MTBE, saying the chemicals are unnecessary and pollute the state's drinking water.

Feinstein, D-Calif., noted in introducing three bills this week that some experts have named methyl tertiary butyl ether a possible carcinogen to humans.

Environmentalists claim the odorless oxygenate has contaminated thousands of the state's drinking water wells through leaky underground tanks. But representatives of the chemical industry have defended MTBE, saying it's essential to help gasoline burn more cleanly and has not been linked to cancer.

Feinstein's proposed legislation would let California oil refiners make a gasoline without MTBE, as long as they meet the state's strict air-quality emission standards.

"It makes little sense to continue using a chemical additive that is unnecessary, is polluting the general drinking water supply in California and may well have other health implications," she said.

A federal mandate now in place prevents refineries such as Chevron, Tosco and Shell from selling an oxygenate-free gasoline in high-smog areas, including Southern California and the Sacramento region, even though the gasoline meets state air quality standards.

Similar legislation submitted last year failed to make it out of committee. Feinstein's bill is a companion to an identical bill introduced earlier this month in the House by Rep. Brian Bilbray, R-San Diego.

This year, the bill has the support of U.S. Sen. John Chafee, R-R.I., chairman of the Senate Committee on the Environment and Public Works. [End quoting]

### MOBIL OIL IMPLICATED IN INDONESIAN ARMY MASSACRES

From *THE JUBILEE*, Nov/Dec/98: [quoting] Mobil, the giant U.S. oil multinational, is keeping a low profile as investigators probe allegations that it helped Indonesia's armed forces carry out massacres near Mobil drilling sites in the province of Aceh in northern Sumatra.

*Business Week*, one of the most widely read magazines in the United States, published a six-page late December feature on the company, titled: "What Did Mobil Know? Mass graves suggest a brutal war on local Indonesian guerrillas in the oil giant's backyard."

The revelations came shortly after two other U.S. companies—Freeport McMoRan of New Orleans and CalEnergy of Omaha—were accused of business malpractice in Indonesia by investigative reporters at the *Wall Street Journal*.

All three exposés were published in the months after the fall of Gen. Suharto's 32-year regime, which has allowed new light to be shed on the role of foreign multinationals in the southeast Asian country's affairs.

Mobil owns 35 percent of PT. Arun, a liquefied natural-gas producer in Aceh, while Pertamina, Indonesia's state-owned oil monopoly, holds the controlling 55 percent stake. Aceh provides an estimated 30 percent of Indonesia's total oil and gas exports and 11 percent of the country's total exports.

Mass killings and disappearances near the Mobil drilling site had been rumored for a decade, ever since the Gerakan Aceh Merdeka (Free Aceh Movement), a local separatist group, began attacks on Mobil installations in 1980. [End quoting]

It's about time these robber barons and murderers are called down for their actions.

### FEDERAL I.D. CARDS POSTPONED

When Social Security was started, the government promised that the Social Security number would never be used for identification. But the 1996 Illegal Immigration Reform Act requires that state drivers' licenses after October 1, 2000 must contain Social Security numbers as the unique numeric identifier. This is clearly an attempt to convert drivers' licenses (a state matter) into national I.D. cards that **will soon also include** fingerprints and a magnetic strip containing all sorts of other information (retina scan, DNA print, voice print) to enable the government to track everyone's movements.

The Omnibus Spending Bill passed in October prohibits the government from issuing final regulations about this during the current fiscal year, which ends September 30, 1999. The stage is set for a battle next year. [End quoting]

### INTEL BLINKS: ID TRACKER WILL BE OFF INITIALLY

Intel Corp. has blinked in the growing controversy over its plans to include ID technology in its new chips.

Even as several advocacy groups were calling for a boycott of Intel products, the company announced it is backtracking somewhat in how the technology, which could be used to track chip users over the Internet, will be deployed.

Several privacy groups were scheduled to announce on Monday a boycott of products made by Intel.

The boycott was called by the Washington-based Electronic Privacy Information Center, a consumer advocacy group, and of Green Brook, N.J., a high-tech lobbying group.

Intel announced last week that it would put

several security features in future processors, starting with the Pentium III later this quarter. One plan is to put processor-specific IDs on each chip that can be accessed by software and transmitted over the Internet.

"Intel's proposal to put a unique ID code inside of every computer it sells will significantly reduce the level of privacy available to computer users around the world."

But in an apparent bow to its critics, Intel announced Monday a change in how the ID technology will be used. Spokesman Chuck Mulloy said Intel has reversed an earlier decision, and that each machine will default to having the ID inactive. Before, Intel said the ID would automatically be activated unless turned off by the user.

Still, early shipments of the chips will still have the earlier configuration, meaning users will have to opt out manually.

An EPIC spokesman said the boycott will continue until more assurances come from Intel addressing privacy concerns.

Intel has pushed the tracking technology as a way to foster e-commerce and other online activities. Companies could require remote users to use the technology, while banks may offer more features to its customers that have processor IDs turned on. The ID could also help enable the ultimate in software copy protection, tying applications to a specific machine.

But groups including the American Civil Liberties Union raised red flags over the technology, saying it could be used to track consumers over the Internet. Intel has said it has no plans to match the processor IDs with names in a database. [End quoting]

If we believe that Intel—or the government, or etc., wouldn't use this feature to track all users, you need to have your sanity checked.

Meanwhile, the logical part of my brain kept returning to the obvious medical event that preceded Lyla's death—and that internal voice kept asking the question "could the Hepatitis B Vaccine that Lyla received that afternoon have killed her?" Most doctors I asked scoffed at the notion and said the vaccine was perfectly safe. But I began to search around on the Internet and Medline and discovered disturbing evidence of adverse reactions to this vaccine.... [End quoting]

I hope this helps to bring home the dangers of vaccinations. Don't let this happen to you. There are alternative methods to use to strengthen your immune systems. Do research.

### NEW PLOY TARGETS AFFIRMATIVE ACTION

From *The Bakersfield Californian*, 1/27/99: [quoting]

#### Group threatens to sue university trustees

The Center for Individual Rights (CIR), the conservative legal group that successfully challenged affirmative action in Texas law school admissions, unveiled a new legal strategy Tuesday of threatening to seek personal damages from trustees of universities that give admission preference to minorities.

"I would think that trustees would be well advised to get on this problem now and start reforming these practices now, so CIR does not have potential clients come to us down the road," said Terence Pell, senior counsel at CIR.

Pell spoke at a news conference held Tuesday to publicize two new CIR brochures, one advising students how to challenge school admission policies and the other advising trustees of public schools of their personal liability in racial discrimination cases. That brochure argues that trustees of private schools are similarly liable if their schools receive federal funds.

Former Education Secretary William Bennett, joining Pell, said affirmative action programs are "a serious social and moral problem" on par with the legal barriers to African Americans before the 1964 Civil Rights Act.

Janelle Byrd, the lead NAACP Legal Defense Fund lawyer who faced CIR attorneys in the Hopwood case in Texas, responded with accusations that CIR is "trying to create an atmosphere to frighten trustees into dismantling legal affirmative action programs".

Byrd said she hoped that lawyers for public

universities would counsel their trustees that "Bakke is still the law of the land, not Hopwood".

"Bakke" is the famous 1978 U.S. Supreme Court ruling that struck down racial quotas in higher education admissions, but which also held that colleges and universities could consider an applicant's race as one factor in determining admission. "Hopwood" is the 1996 ruling by the 5th U.S. Circuit Court of Appeals, which the Supreme Court let stand, striking down "diversity" as a rationale for considering race in college admissions.

At his news conference, Pell charged that affirmative action programs similar or identical to those struck down at the University of Texas are widespread in public universities throughout the country.

And while he insisted that CIR is "not looking for more lawsuits" to file, it is set to go to trial in Ann Arbor in May on a suit challenging the University of Michigan's affirmative action policies—"if potential clients find their way to our door, we'll consider that". [End quoting]

The education of students is taking more and more of a back seat to addressing legal potholes and pitfalls.

I was nine years old, trudging down the cold, wet streets of Springfield, with a beat-up leather satchel of popular magazines over my shoulder. My ragged coat was two sizes too big and the weight of my bag dragged the collar to one side. I stepped carefully over the puddles on the sidewalk. I didn't want the cardboard lining in my shoes to get any wetter.

Selling magazines was what I did to earn money for my family. One of five boys, I had lost my mother to pneumonia when I was five. My father had initially sent me and my two younger brothers to an orphanage. After several months we returned home. Dad worked two or three jobs to keep a roof over our heads. We did whatever we could to help out: harvested walnuts, gathered trash, collected scrap metal to sell by the pound.

Most of the time, I sold magazines. I had my regular route and regular customers. Once, I was hanging around a local nightclub trying to scrounge up business, and a stranger called out, "Hey, kid! How many magazines have you got in that bag?" I counted them out. Making a show of it, he bought them all!

But the week before Christmas, 1939, business was not good. On my rounds that day, I stopped at the barber shop. The men talked about whether it would be a white Christmas, as though that would somehow make the holiday better. I knew snow wasn't going to make a lot of difference at my house.

I listened for the sound of the twelve o'clock whistle, then headed for the Coca-Cola Bottling Company. I had my report card with its good marks in my pocket. All I had to do was present it for a free Coke. Then I visited Mrs. Wells, an elderly lady who lived a few blocks away. She offered me some cookies from her cookie jar. The cookies and soda were my lunch. Not bad.

I came to the Queen City Casket Company on Clay Street. The owner, Mr. Rader, always took me back to his factory to ask his workers if they wanted any magazines. They teased me, saying, "Come on, Jimmy, climb into one of our satin-lined caskets and take a little nap." I shook my head. I didn't want to have anything to do with a casket.

Shaking off the rain like a wet dog, I went into Mr. Rader's office. After a quick glance he led me, shivering, over to the stove. He frowned when he noticed the hole in the top of my shoe. "Jimmy, let me see your soles."

Hopping on one foot and then the other, I showed him. "You can't walk around like that," he said. "Come with me."

Before I could protest, he whisked me into his pickup truck. *Where on Earth is he taking me?* I wondered. We pulled to a stop in front of a shoe

store. Inside, a salesman fitted me with the finest pair of shiny black oxfords I had ever seen. When I stood up in them I felt about 10 feet tall. "We'd like a pair of new socks too," Mr. Rader said.

My feet warm and dry, I got into the pickup truck and Mr. Rader drove us back to his factory. I didn't know what to say. No one had ever done anything that nice for me—not old Mrs. Wells, not the people at the Coca-Cola Bottling Company, not even the big shot who bought all my magazines at the nightclub. Mr. Rader had done it because he really wanted to help. I was afraid I wouldn't be able to hold back the tears if I tried to talk, and I didn't want to be a crybaby.

As I stood in his office, fingering the strap on my bag, Mr. Rader took out a business card and wrote something on it, then handed it to me. With teary eyes, I read, "Do unto others as you would have them do unto you." He put his hand on my shoulder. "Jimmy, I want you to know I love you." Never in all my nine years had I heard those words. Maybe my mother had said them to me, but I had been too young to remember.

I said good-bye, my hand closed around the business card in my pocket, and went back out into the cold winter evening. Yet for the first time in my young life I sensed a flicker of hope that somehow things would be all right. Maybe not that Christmas, maybe not even the next year. But with people like Mr. Rader in the world, there was hope. There was kindness and love, and that would always make a difference.

All those years later I stood with Mr. Rader's card in my hand. The card had migrated into that old envelope; its message I had carried with me ever since that day in 1939. —by Jim Sowards, Lampe, Missouri [End quoting]

# Setting Up The Middle East FOR WAR!

It is not for me to argue in favor of the existence of the New World Order conspiracy. What is unarguable is that literally every American politician who left a profound legacy on the Middle East, and especially Israel, was and is a member of the Manhattan think-tank considered the headquarters of the NWO, the Council On Foreign Relations (CFR). A short list of some of the better known characters would include Henry Kissinger and his deputy Joseph Sisco, Cyrus Vance, James Baker, Warren Christopher, Walter Mondale, Madeleine Albright, et al. Beneath this level of public exposure lies an insidious cabal of CFR members such as Edgar Bronfman, head of the World Jewish Congress and Henry Seigman, chairman of the American Jewish Congress, who exert a powerful influence on Israeli and diaspora leaders and ultimately on Jewish public opinion. All the evidence more than just indicates that the current Middle East peace process was hatched by the CFR and is promoted with all the necessary weapons at its disposal.

**This peace process is a surefire formula for war...and soon.**

The year 2000 will most likely see Israel and its neighbors caught up in bloody turmoil.

## THE OSLO ACCORDS— MADE IN NEW YORK

In August 1993, the Israeli government headed by Yitzhak Rabin announced that it was on the verge of signing a "peace" accord with the PLO. The American public was told that Washington was completely caught off guard by the announcement and was even angry for being left out of the negotiations held in Oslo.

Later testimony by actors in the Oslo Accord tell a very different story. In February 1994 I interviewed one of the two Israeli Oslo negotiators, Ron Pundak. He told me that "From the first day we arrived in Oslo we coordinated our negotiations with the State Department. At the end of each day's sessions, we reported back to Washington. Warren Christopher was very skeptical at first, but later became most helpful to us."

In August 1995, Rabin told *NY Times* columnist William Safire that he never wanted to become involved with this peace process.

He admitted that he was ordered to by President George Bush at a meeting in Kennebunkport, Maine in September, 1992. Bush demanded that Rabin "prepare the Israeli public for some painful withdrawals".

The CFR had long before corrupted Rabin, in

large part through his "friendship" with Kissinger and now was calling in its cards. The same grooming and corrupting process has taken place throughout the top rungs of the Israeli political leadership, including with Prime Minister Binyamin Netanyahu who has now isolated himself from his government by carrying on what Rabin was forced to begin: Israel's weakening and then demise.

## GOALS OF "PEACE"

Although Rabin was the tool to sell Oslo to the Israeli public, the ultimate goals of this peace process were taken over by Foreign Minister Shimon Peres and his deputy, Yossi Beilin. Ron Pundak noted, "Beilin doesn't believe in borders. He thinks they are the root cause of conflict and doesn't care if Israel loses hers."

Shimon Peres advanced such thinking with a program he called The New Middle East. In his vision, Israel would give up its present borders, including its most vital strategic positions, to join in an economic union with its Arab neighbors.

To secure the pullback of Israel's present borders to those of 1948, some 200,000 Jews would have to be removed from their homes. The Israeli government, through Beilin, obligated itself to carrying out a plan of delegitimization, in fact demonization, of the Jewish residents of the Administered Territories and later the Golan Heights, as a prelude to their forced removal.

The secret clauses of Oslo were leaked by an alarmed employee of a government ministry, first to *Jerusalem Post* reporter Steve Rodan. After a three-month fact-checking period, the *Post* printed the less frightening details on its front page and suffered expensive government retaliation immediately after.

Through an intermediary, I was given the details of what the *Post* backed off printing, which I published in my newsletter *Inside Israel*. Beilin's plan called for a covert war against the "settlers" or Jewish residents of disputed territories, which included incriminating the innocent in timely outrages and murdering public figures to instill terror and uncertainty. This plan ultimately led to the assassination of Prime Minister Yitzhak Rabin.

When these charges were first published, there was widespread disbelief that the political leadership of Israel could be so evil. Today in Israel, thanks to the bungled Rabin murder, perhaps a third of the public accept that this covert war did take place and is still taking place.

It is inevitable, that by the year 2000, the festering coverup of the Rabin assassination will finally break down. When the truth comes out, that Rabin's convicted assassin was a minor fall guy for a high-level international

conspiracy, and that the leaders of the ruling Labor government carried out the hit, a sense of utter dismay and abandonment will erode the very foundations of Labor Zionism. The effects will be profound beyond immediate comprehension. One would hope that the ultimate result will be a massive reform of the Israeli political system.

## WHAT THE OUTSIDERS WANT

In July 1997, the CFR finally revealed its plans for Israel in its Middle East Task Force report, headed by Henry Seigman. All doubts about the CFR's intentions evaporated in the report. It was recommended that Israel withdraw to its 1948 lines, that Jerusalem be divided and that half the city be the capital of a Palestinian state. The world now knew for a written fact what were the ultimate goals of the diplomacy of CFR members Albright and Clinton. The task force report was a formula for guaranteed war.


And, in fact, on a global plane, what has been done to Israel is no different than what was previously and subsequently arranged for Bosnia, Croatia, Rwanda, Somalia, Kosovo, et al. Bitter enemies were armed to the teeth and through diplomacy, forced to cooperate with each other elbow to elbow. One spark was all that was needed to explode numerous peoples placed in this situation recently and that spark will fly in Israel before or during the year 2000. Probably several months before.

Superficially, Israel is just another in a long line of nations chosen for chaos in preparation for the international change of status quo called the New World Order. But there is far more to the story and it centers around Jerusalem.

There is much symbolism surrounding Jerusalem and the end of the millenium and not a few people want a piece of the city when the flames die down. First among them is the Vatican. In a story broken first by *La Stampa* in Italy and *Shishi* in Israel, and later verified with documented proof in *Haaretz*, in May 1993, Shimon Peres promised the pope hegemony of the Old City of Jerusalem by the end of the year 2000. In October of 1998, the Vatican forced out Hebrew University, the tenants of a large property they own in West Jerusalem and are now building an embassy to be opened prior to the millenium. Barely a month later, the Holy See demanded a say in the final status of Jerusalem as dictated by the first Oslo Accord.

If the Vatican gets its way and inherits political control over the holy sites of Jerusalem, it will be greeted by many hundreds of thousands of Protestant groups from America and Europe who are planning to descend on the city prior to and during the year 2000 in anticipation of a messianic return. To satisfy these hopes, prophecies of Gog and Magog may have to be self-fulfilled.

## THE WAR OF THE MILLENIUM

War is a near certainty and numerous scenarios could presage it. Most likely it boils down to the PLO and its sister organizations creating some atrocity too big for Israel to ignore. Troops will try to crush the Palestinian Authority and neighboring Arab states will attack Israel on land or with missiles to defend Islamic honor. Israel, now withdrawn from many of its most strategic defensive positions, and with an army of 50,000 PLO "policemen" standing mere meters from its cities, will be overwhelmed and forced to use unconventional weapons. The big powers will then step in, send foreign (i.e. UN) troops enmasse to keep the peace, dictate terms over the sovereignty of Jerusalem and greet the new millenium with a New World Order.

## —LEGAL NOTICE— CERTIFICATE OF DEBT

The CONSTITUTION of the UNITED STATES OF AMERICA and the UNIFORM COMMERCIAL CODE (international) provide a procedure for the legal authentication of a debt in the case of the Debtor refusing to acknowledge such debt. This procedure includes the notification of the Debtor of the details of the debt and a notice of intent to collect. After a period of ninety (90) days from the date of the notice and if there has been no response from the Debtor the debt is made authentic and collection procedures may begin. There is no appeal from this procedure; it is final.

On April 28, 1998 the then owner, Rick Martin, of a debt (described in detail later) of the UNITED STATES TREASURY/FEDERAL RESERVE SYSTEM (UST/FED) assigned the debt to GLOBAL ALLIANCE INVESTMENT ASSOCIATION (GAIA), a Nevada corporation. GAIA immediately initiated the procedure by informing UST/FED of the nature of the debt and of GAIA'S intent to collect. GAIA then took the additional step of running the legal notice in a weekly newspaper of world-wide circulation four consecutive weeks beginning May 5, 1998. UST/FED has made absolutely no response and the statute of limitation for countering the legal notice has run its course. Now, this document and its publication in the same newspaper four consecutive weeks serve as adequate and final verification of the UST/FED debt to GAIA. Nothing further is legally required; no denial or appeal is possible.

The debt referred to is described as follows: The principal and interest accrued to Bonus Contract-Certificate Number 3392-181, approved by Legislative Resolution on April 24-27, 1875, Duly Authorized by the President of Peru, April 26, 1875 and Acknowledged and Accepted May 1, 1875, Re-affirmed, Re-confirmed and Reconformed on behalf of the government by the Consulate General of Peru, August 21, 1989, Order Number 7309, Document Number 046, Duly Sealed by said Counsel General of Peru at Los Angeles, California, United States of America, assumed and guaranteed by the United States of America pursuant to Presidential Order confirmed by the US Senate per petition of Elihu Root, Secretary of War, in 1906, further assumed and guaranteed by the Federal Reserve System pursuant to the Federal Reserve Act of 1913 and recorded August 1, 1994, by Deed, Instrument Number 1893, Book of Deeds Number 433, Page 849, City of Nashville, State of Illinois and subsequently recorded August 10, 1998 at 8:35 A.M., Clark County Recorder's Office, Las Vegas, Nevada, Official Records 980810 Instrument 00323.

The principal and interest are payable in gold coin or gold bullion and portions thereof may be assigned, sold, loaned or leased to others as collateral, but only as collateral, and no claim will be entered by any holder directly to the UST/FED without the express written consent of GAIA. Further, no holder, including GAIA, will in any way use the asset to the detriment of the national security or economic stability of the United States of America. The assignor of the debt to Mr. Martin, Russell Herman (also spelled Herrman and Herrmann), a very patriotic American, requested of Mr. Martin that Herman's business partner, V. K. Durham, be given a certain amount of time to implement his wishes and, if unsuccessful, to use the asset to the benefit of all people, reserving forty-eight percent (48%) of its value for the express benefit of the citizens of the fifty States of the United States of America. When appropriate, the granting of such an asset to the citizens of America (*we-the-people*) will result in an era of enormous prosperity which will, when also distributed to other nations, buoy up and expand all of the world's economies for all of its people, not just the rich as is now the condition.

Mr. Martin and his associates have worked for years, first in an attempt to assist V. K. Durham and later as the direct assignee, to find a way to work with the UST/FED within the United States to effect the use of this asset for the benefit of the American people FIRST. 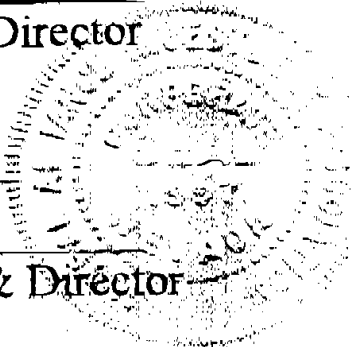

### THE ISLAMIC (GOLD) DINAR

**[H: PLEASE PAY ATTENTION, NOT JUST TO THE TOPIC BUT TO THE COUNTRIES LATER NAMED. YES, IT IS VERY IMPORTANT.]**

Pakistan, a Muslim country, recently exploded an atomic bomb following the same action by its Hindu neighbor, India. These bombs everyone has heard about and the potential for these and other countries to end the existence of mankind on Earth certainly is frightening to everyone except perhaps stock market-crazed westerners who are simply not sober enough to care. *Frightening as the atomic bomb is, another kind of bomb, namely The Islamic Dinar, could pose an even bigger threat to our existing financial system which I believe would be enormously bullish for gold.* Although I believe the Islamic Bomb may be a threat to the status quo, almost no one *has yet* caught on to this very recent development. **[H: Emphasis mine and I shall take this liberty along the way throughout this article.]**

is cracked up to be on its web site ([www.users.dircon.co.uk/~netking/murabitn.htm](http://www.users.dircon.co.uk/~netking/murabitn.htm)). However, I believe the movement is real and, for reasons noted below, I think it could indeed pose a threat of devastation to the U.S. Dollar and existing world order. Following are a couple of the reasons I think this could be true. **[H: Well, it IS true and it can actually destroy "the dollar" as you know it but our own intentions are to simply move out from under the "dollar" anyway, except as a measure for value. There must always be something of equal or better value to utilize with any changing "order" and our intent is to allow things to flow naturally in our endeavors toward insight and use IN CHANGE. You would be actually AMAZED at how far along this project has moved.]**

### ENORMOUS CARNAGE TO ASIAN MUSLIMS RESULTING FROM OUR FLOATING RATE SYSTEM

One of the reasons given for the continued insane rise in Wall Street has been the flow of money OUT of the Asian countries into the U.S. markets in search of a safe haven. But this makes no sense to the tens of millions of Muslims in Indonesia who are now suffering through a fate worse than we faced in the 1930s. Indonesia, which is comprised virtually 100% of Muslims, contains the 4th largest population in the world. Those people blame Suharto but they also blame the U.S. because Suharto was financially tied into the U.S. and our internationally dominant fractional reserve banking system. This underlying anger, which has been caused by enormous devastation suffered by hundreds of millions of Muslims throughout Asia, is likely to provide a powerful incentive for Muslims to "stick it to the Great Satan" by selling dollars and buying Islamic dinars. **[H: Still wonder why the Khazarian banksters are so p—articulated off at the Arabs and Islamic nations? Doesn't this perhaps explain why the Iraq hotshot trials and tribulations when it is realized that the banks, as are, along with the dollar, are about to go down. And NO, this only strengthens our program every way from last Friday—remember, GOLD backing.]** At the same time, these people see this as a way to protect themselves by holding real money rather than the fake paper IOUs which have, overnight, lost up to 70% of its purchasing power. The dominant theme of the sponsors of the Islamic Dinar is the liability aspects of paper money and that as a result it is dishonest money. Islamic Religious Beliefs: Not unlike Christians who have forgotten the basics of their faith founded on biblical teachings, so too have many, if not most, Muslims forgotten the basics of their faith based on the *Qur'an*. One of the main pillars of the Islamic faith is the observance of *Zakat*, which dictates that Muslims must give at

least 2-1/2 % of their income to the poor. Wealthy people are encouraged to give more. Eventually, the list of countries where it is traded is likely to grow to a much larger number given the large number of Islamic Countries who are members in the Islamic Development Bank, which includes some 51 countries. During 1982, the Islamic Development Bank was prescribed by the IMF as a holder of Special Drawing Rights (SDRs). SDRs are a unit of IMF currency tied to gold. The Islamic Dinar, which is the unit of account at the Islamic Development Bank, is equal in value to one SDR. **MEMBER COUNTRIES OF THE ISLAMIC DEVELOPMENT BANK ARE AFGHANISTAN, ALBANIA, ALGERIA, AZERBAIJAN, BAHRAIN, BANGLADESH, BENIN, BRUNEI DARUSSALAM, BURKINA FASO, CAMEROON, CHAD, COMOROS, DJIBOUTI, EGYPT, GABON, GAMBIA, GUINEA, GUINEA-BISSAU, INDONESIA, IRAN, IRAQ, JORDAN, KAZAKHSTAN, KUWAIT, KYRGYZ REPUBLIC, LEBANON, LIBYA, MALAYSIA, MALDIVES, MALI MAURITANIA, MOROCCO, MOZAMBIQUE, NIGER, OMAN, PAKISTAN, PALESTINE, QATAR, SAUDI ARABIA, SENEGAL, SIERRA LEONE, SOMALIA, SUDAN, SYRIA, TAJIKISTAN, TUNISIA, TURKEY, TURKMENISTAN, UGANDA, UNITED ARAB EMIRATES AND YEMEN.** [H: And this only

the visible parts of the ice cap (glacier in motion). They may soon be trading gold Islamic Dinars globally on the Internet through an organization located at [www.e-gold.com](http://www.e-gold.com) [H: BE VERY CAREFUL OF THIS, READERS.] Readers are encouraged to visit this web site for more information, but essentially, the technology now exists to enable you to buy and sell gold right from your computer. It will be quite easy to make compatible our Islamic Agency, which will be operated by a Web Site to your e-gold Web Site.

[H: STOP, LOOK AND LISTEN: THIS IS EXACTLY WHAT WILL DO YOU IN, LITTLE GOLD SEEKERS. THE U.S. HAS FULLY LAID PLANS TO CONFISCATE GOLD, AGAIN, JUST AS IN THE BEGINNING OF THE 1930s. WHEN THAT HAPPENS YOU WILL HAVE TO TURN IN YOUR GOLD "ANYTHINGS" AND THE DINARS WILL ALSO BE TAKEN AND SO WILL ALL BANK ACCOUNTS WHEREIN GOLD IS THE SOURCE OF THE WEALTH WILL BE FROZEN AND CONFISCATED. At this juncture, the western world could care less about gold because it has convinced itself that man can control his own destiny. The ECB used “consolidated accounting” to bring together the full European system of Central banks... This implies that the individual national central banks are under the control of the ECB for all important decisions.

“Since the ECB is controlled by *Germany*, France and Italy, with over 55% of the votes, and these have all stated that they will hold their gold—the implication is that any significant sale of gold by the ECB is unlikely,” the report argued.

Now, let us just look around at a few things taking place here and there on an international scale.

The deposits, Zobel claims, were initially worth \$26 billion and may have reached \$35 billion at present.



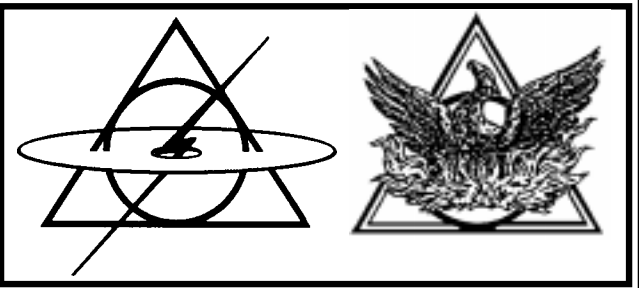
