## TRAINING AMMO CLAIM DISPUTED

The Army claim that only training ammunition was used in a recent mock raid on a small Texas town is a deliberate lie, according to other Army sources and an investigator.

Army Special Operations Command at Fort Bragg, North Carolina, has confirmed that elite Night Stalkers and Delta Force troops were involved in a training exercise, code named Last Dance. Walt Sokalski confirmed that the operation began Feb. 8 in Kingsville, Texas, and will continue in the area until February 20.

He also confirmed that **live ammunition and explosives were used in the middle of a populated area with no advance warning to residents** [*emphasis mine*].

Sokalski insisted that every possible safety precaution was taken, including the use of training munitions and special stray bullet "traps".

He told *WorldNetDaily* that full-powered ammunition and explosives are never used in areas where civilians are located. The "simunition" is less powerful and uses plastic bullets that can only travel 100 yards. Such bullets are not considered lethal. [*How comforting!*]

Residents of Kingsville reported hearing machine-gun fire and explosions lasting two hours when the Night Stalkers arrived in their little town unannounced. Many suffered sufficient fear over the incident to seek medical treatment, and some are talking to lawyers about possible legal action.

County commissioners ordered the county judge to send a letter to the city council and to the Army to protest the attack on their town and the fact that they were not informed.

Night Stalkers are some of the best pilots in the world. They are expert at flying high-speed helicopters at low altitudes. They delivered another elite group, the Delta Force to the site in Kingsville. They arrived in a hail of bullets and explosions that rocked the town and scared some residents nearly to death. Residents of a retirement home across the street were reported to be on the floor under their beds thinking the world was coming to an end.

*WorldNetDaily* sent Alex Jones, an Austin talk-show host, to Kingsville to inspect the damage caused to two buildings used in the dramatic attack. He reported finding brass shells from spent .308 ammunition, used shotgun shells marked "Hatton Pattern Solid", extensive blast damage from grenades, multiple fires in different parts of the building, bullet holes in the floor and walls and all the windows of the building blown out completely.

"That doesn't sound like fake stuff to me," Jones responded when he was asked if he agreed with Sokalski's statement that less-powerful training bullets were used.

An active-duty Army captain who asked that his name be withheld contacted *WorldNetDaily* after reading Sokalski's claim. He has many years of experience and is concerned about the nature of the exercise. He knows what to look for to determine if training munitions were used.

### GENE TECHNOLOGY REJECTED

World's Largest International Agricultural Research Network Vows not to use Terminator Technology. It's bad for poor farmers and it's bad for crop biodiversity, concludes the Consultative Group on International Agricultural Research (CGIAR) meeting in Washington. With more than 70% of the Third World's rice and wheat crops based upon its crop-breeding programmes, the world's largest network of agricultural research institutes is vowing not to use Terminator Technology (a biotech-based strategy that prevents seed from regenerating in a second growing season). The decision is a slap in the face to one of its major funders—the US Government, and to Monsanto Corporation—who claim their technology will help feed the hungry.

Proud Policy: RAFI has learned that a special committee of the Consultative Group for International Agricultural Research (CGIAR) has agreed to advise its network of 16 International Agricultural Research Centres to adopt a no-use policy with respect to the Terminator Technology jointly patented by the US Department of Agriculture and a Monsanto subsidiary, Delta and Pine Land Seed Company. The decision, by the Genetic Resources Policy Committee of the CGIAR, will—if custom is maintained—be accepted by the entire network at its annual gathering in Washington October 26-30. This is the first time, to RAFI's knowledge, that the CGIAR—with an annual budget of about US\$325 million in 1998, has taken such a controversial policy position and directly challenged the CGIAR's biggest long-term donor—the US Government.

1800 Letters: "Its the right decision and it is also a courageous decision," says RAFI director, Pat Roy Mooney. "Since the patent was granted in the United States last March, it has attracted unprecedented opposition from farmers' organizations, environmentalists, and agricultural scientists. More than 1,850 individuals from 54 countries have written personal protests to the US Secretary of Agriculture demanding that the technology be

banned," Mooney adds.

Risky Business: The CGIAR's policy committee, chaired by World Food Prize-winner, M.S. Swaminathan of India, began studying the Terminator at RAFI's request last April. The policy committee agreed to call for a network-wide ban on the use of the technology when it met in Washington Tuesday this week. Government delegations arriving in Washington for next week's formal meetings learned of the decision as they arrived at their hotels.

Voices for the Poor: "RAFI doesn't have direct access to the final resolution," Mooney reports, "but several delegates confirm that the ban was accepted because the Terminator threatens the well-being of 1.4 billion poor people who, according to FAO statistics, depend upon farm-saved seed for their food security. Many also opposed the Terminator because of its direct and indirect threat to crop genetic diversity. By rendering the harvested seed sterile, the Terminator puts a chilling end to 12 thousand years of farm seed conservation and community plant breeding." According to RAFI's sources, opposition to the Terminator was strongest from CIMMYT (the International Maize and Wheat Improvement Centre near Mexico City), IPGRI (the International Plant Genetic Resources Institute in Rome) and from the committee's Chair, M.S. Swaminathan.

Third World Target: "This is a serious blow to Monsanto and to the US Government," Pat Mooney asserts, "Both parties have argued that the Terminator was designed with Third World farmers in mind. They have also specifically identified crops like wheat and rice in countries such as India, China and Pakistan. The inventors claim that Terminator will give companies with proprietary genetic traits confidence to risk selling their seeds abroad. Since farmers can't save the seeds, they are forced back to the marketplace to buy seed every season. Patented genes can't be bred into other varieties by poor farmers. "Traditionally," Mooney explains, "women farmers not only save seed but they use purchased seed to cross with other breeding stock to improve and adapt the seed to their local needs. The Terminator makes all this impossible."

Growing Opposition: For these reasons, the Government of India has announced that it won't allow Terminator technology into the country. The Terminator has also been banned in at least one Brazilian state and the technology was the subject of active debate in the Irish Parliament yesterday. "The Terminator patent is pending in 87 countries, RAFI believes that many of these countries will block the patent on the grounds that it is contrary to public morality. The decision by the CGIAR will accelerate opposition around the world. "The CGIAR's members have just cause to be proud of their stance on the side of poor farmers," Pat Mooney concludes. [End quoting]

### GLOBAL TALKS ON CUTTING GENE RISKS

#### 174-NATION SUMMIT FIRST OF ITS KIND

Prospecting, piracy, private eyes—the buzzwords negotiators are using at an international summit this week suggest intrigue and danger.

Even the meeting's backdrop—the exotic old Caribbean pirate port of Cartagena, Colombia—adds to the atmosphere.

But instead of weapons or precious metals, experts from 174 nations are debating how to regulate trade in gene-engineered potatoes, cotton, grains and trees.

The U.N.-backed summit represents the first global attempt to reduce the risks that laboratory-designed species might pose to public health and the environment.

For 20 years, biotech companies have been genetically manipulating plants and animals to make them more attractive—redder, juicer tomatoes, for example—speed their growth or make them more resistant to disease.

These new combinations could increase the food supply and reduce the need for hazardous farm chemicals. But opponents fear the unintended consequences of messing with Nature.

For example, scientists added commercially valuable traits from the Brazil nut to a strain of soybeans but ended up making the soybeans risky for people with nut allergies.

Another fear is that genes inserted in crops to give them certain favorable traits—resistance to herbicides, for example—might jump to surrounding wild plants. Some weeds have already become impervious to weedkillers in this way.

These plants, animals and microbes are commercial products as much as they are life forms, and the rights are tightly held by a small and shrinking group of multinational companies. Policing these rights is also on the agenda at the conference, which was convened to negotiate what is being called the Biosafety Protocol.

"We're experiencing a big shift into a biotech century," said Jeremy Rifkin, who is president of the Washington-based Foundation on Economic Trends and wants a moratorium on the commercial use of genetically-engineered organisms. "We need to be asking a whole different set of regulatory environmental and liability questions. It's going to affect everybody."

Biotech industry leaders contend their products are already subject to stringent safety standards.

Agribusiness giant Monsanto says its 60 genetically-engineered crops have been the subject of 25,000 field trials in 45 nations. More regulation would "massively disrupt all international trade in biological materials," said Val Giddings of the Biotechnology Industrial Organization.

The United States is taking part in the summit but cannot vote on the protocol because the Senate has not ratified the U.N.-sponsored biodiversity agreement.

The biosafety debate has gotten little attention in the United States, even though it exports 80 percent of the world's bioengineered materials.

Europe, however, has seen protests calling for a ban on the sale of "Frankenstein foods", at least until their risks can be determined.

"There is a huge domain of scientific uncertainty about the impact of these things," said Ian Taylor, scientific adviser for the environmental group Greenpeace in England.

A 68-year-old toxicologist in Scotland, Arpad Pusztai, has become a cause celebre in the biosafety debate.

He added insect-resistant genes and proteins to potatoes and fed them to rats. The animals suffered damaged immune systems, growth problems and shrunken brains, he said. It was thought to be the first time that trials of genetically-modified food showed harmful effects.

However, his employer, the Rowett Research Institute in Aberdeen, described the findings as "muddled" and "misleading" and refused in August to renew his contract. Other scientists have come to his defense.

Even supporters of genetic engineering say more testing is necessary, especially, when food is involved. [End quoting]

To be ready for a worst-case scenario if public communications break down, amateur radio stations are being installed at our major control sites. As the year 2000 marches westward across the globe from New Zealand, our operators will be in contact with other hams around the world and will monitor various other shortwave transmissions to get a feel of what problems and breakdowns, if any, are occurring with electrical and natural gas distribution systems in other countries. If we learn of a problem that occurs in another company with similar equipment, we can gain a few hours of precious time in which to apply a fix. I have to work on New Year's eve, but those owners with an opportunity to listen may find a lot of interesting shortwave broadcast and utility signals in the air as y2k descends on us. I

wouldn't be surprised to see some FEMA, MARS, or other agency y2k-disaster exercises scheduled during 1999. [End quoting]

### GROUP HONORING SCIENTIST GOING INTO BANKRUPTCY

COLORADO SPRINGS—The International Tesla Society, a breeding ground for weird science, has closed and is headed for liquidation.

Bankruptcy may bring an end to the avant-garde organization that formed in 1984 to operate a museum on East Bijou Street and to sponsor an annual symposium of idealistic and eccentric inventors honoring the king of weird science: Nikola Tesla.

Tesla was a brilliant inventor whose innovations in alternating current changed the world, but whose largest concepts—such as how to transmit electricity without wires—never made it into mainstream science. The scientist, born in the then-Austrian-Hungarian Empire, spent several months in 1899 experimenting in Colorado Springs.

His theories, and those of his followers, are still a frequent topic in Internet chat rooms.

Hundreds of inventors, tinkerers and conspiracy theorists came to the Tesla festival each year hoping to follow in his innovative footsteps. They sought to create cars that run on water alone, antigravity devices, perpetual motion machines, medical cures and more.

"There were a lot of flakes all the time, but also a lot of mainstream scientists," said Roy Stewart, the owner of Tesseract Design and Instrument in Boulder and a former society member.

Stewart is now concerned the society's museum collection may get lost in the bankruptcy shuffle.

The rooms in the green office building on Bijou once held notes on Tesla's experiments, articles about his research, signed photos and letters. The museum also included reproductions of the inventor's creations, such as a working Tesla coil—a high-voltage transformer Tesla used to create energy fields.

Today the rooms are empty.

Lawyer Robert Mason, who represents the Tesla Society, said the owner of the office building locked the museum's doors last month. Workers packed and removed everything inside shortly afterwards, according to people who work in the nearby offices. All that remains of the museum is a weathered brown metal sign with chipped white letters.

Mason said the collection is actually owned by many different people who loaned items to the museum. He said he is unsure where the collection is being kept. "I can't tell you where it is," Mason said. "It hasn't been sold."

Stewart has asked the city of Colorado Springs to acquire and preserve the collection. "My only concern is keeping the information intact," he said. "It might be too late. I might be closing the barn door."

In its Chapter 7 bankruptcy filing Dec. 9, the group listed \$71,452 in debts and no assets. The case is to be heard in a meeting of creditors Jan. 29. [End quoting]

Much along the same lines as several of our Mental Motorcycling and Proficient Motorcycling articles, “Outside Lies Magic” preaches the discipline of *noticing*, or, as a high-performance driving instructor of mine once called it, “getting the big picture”.

I suppose I am enjoying the book so much because I feel a kindred spirit with the author. Noticing is something I’ve been preaching for many years. I don’t think I would be bragging to say that I have at least a predilection for it, though I have no idea where I first acquired the skill, if it is, indeed, even a skill. All I know is that I tend to notice lots of little, seemingly meaningless things around me that most people miss. That may not seem like much, but the larger part is that my mind tends to tie these little extraneous facts together with others to reach conclusions. Conclusions that otherwise would probably never be arrived at. The professor says this talent is often mistakenly referred to as intuition, or even as a sixth sense. Actually, it is just plain logical-progression thinking, but with a few extra facts thrown in to help tie together the loose ends.

Perhaps the most famous noticer was Sherlock Holmes. Holmes noticed little things that other people passed over, asked himself why they were, and through logical deduction often found answers that seemed totally hidden to others.

A perfect example of this came a few years ago when a community’s downtown merchants hired a marketing expert to try to win back some of the business they had lost to a local shopping mall. The merchants had done everything they could think of. They had nearly all the same stores and merchandise available, and often at even better prices. They held every kind of promotion imaginable, and while they were moderately successful with the older crowd, they couldn’t seem to attract the young married couples that were their lifeblood.

The marketing expert, who was also an expert noticer, looked things over for a couple

of days and calmly suggested that all the downtown on-street parking be changed to angled, head-in spaces. Within weeks, business was booming again. Why? Because 30 years of building giant malls and huge pull-through parking lots for everything from airports to post offices to restaurants had created a generation of drivers with no parallel parking skills! Pick a dozen teenagers and 20-something mothers at random, and you’d be lucky to find one that could successfully parallel park his/her car. Offer them a shopping area where that’s the only available convenient parking, and they’ll stay away in droves.

But by now you’re probably asking, “What the @#%& has any of this got to do with motorcycling?” Well, I happen to think a great deal. It’s a state of awareness. People who notice lots of seemingly insignificant little details that most others miss, have a better idea of what’s going on around them. They seem more capable of handling a crisis situation, but even better, they are better able to avoid ever getting into a crisis situation in the first place. It’s usually just a matter of making decisions based on more and better up-front information.

I offer, as an example, a situation that happened to me several years ago. While riding down a residential street, with a friend slightly behind and to my left on his own bike, I saw a ball bounce in the street and roll across our path. It would be across the street and out of our way in plenty of time. A glance to the right revealed a small boy standing on the lawn at least 30’ from the road, gazing intently in the ball’s direction, unmoving, with an unmistakable look of abject fear on his face. At the edge of the street were hedges, about knee-high. The ball had bounced through one of these.

With a quick glance in the mirror to be sure no one was on my tail, I grabbed the clutch and hammered my brakes, coming to a panic stop. My friend shot on by me, violently swerving a second later to avoid colliding with a small dog that had burst from the hedges full tilt, chasing the ball.

Later, my friend asked me what had prompted my sudden stop. “You saw the kid, right?” I asked. “Yes,” he said. “But I never saw the dog coming. Did you?”

“No,” I said. “I didn’t. But I saw what was hanging from the kid’s hand. Didn’t you?”

“Now that you mention it,” he said, “he was holding a rope or something. I didn’t pay any attention to it.”

“Maybe you should have noticed,” I said. “It was a leash. That look of fear on his face wasn’t because he was worried about the ball. He was afraid we were going to hit his dog.”

Nothing superhuman here. No ESP involved. I just noticed something he didn’t, or perhaps more true, we noticed the same things, but I questioned “Why?” and logically made the connection that may have saved me from serious injury.

It doesn’t require any special training or talent, just practice. Work on noticing the little things, and asking yourself how they fit into the big picture. You’ll become a safer rider and driver, and even occasionally astound your friends. Like Holmes said, it’s really quite elementary. —Fred Rau [End quoting]

Some very excellent advice especially in these times when little details could be life-savers for your future.

### SHOULD AMERICANS REFUSE TO PAY THE UNCONSTITUTIONAL NEW PHONE TAX

The Federal Communications Commission is getting ready to impose a sneaky new tax—which will cost consumers \$1 billion this year—on every long-distance phone call made in the USA. The Telecommunications Act of 1996 instructed the FCC to create “mechanisms” to fund universal public school access to the Internet, so the Commission slapped a 5% tax on all interstate long-distance phone calls.

The new phone tax, which is expected to rake in a whopping \$13 billion over the next five years, is part of Vice President Al Gore’s initiative to connect every public school to the Internet.

“Unelected federal bureaucrats are imposing a billion-dollar tax on the American people—despite the fact that the *U.S. Constitution* grants only Congress the power to levy taxes,” said Steve Dasbach, the Libertarian Party’s national chairman. “It’s bad enough that Congress has the power to impose taxes,” said Dasbach. “But what will happen when the energy Department decides to raise the gasoline tax? Could we stop the Department of Agriculture if it imposes a tax on food? What if the Securities and Exchange Commission decides it wants a tax on mutual funds?”

At least with Congress, we can vote them out of office. But FCC Chairman William Kennard

and millions of other federal bureaucrats never have to face voters in an election. That's what's so frightening about this tax.

Another troubling aspect of the new phone tax: to keep it secret, the FCC put pressure on telephone companies not to list the tax as a separate line-item on phone bills, but, instead, to bury it in the general charges.

"The FCC's new tax is like an obscene phone call: It's unwanted, offensive, and nobody wants to admit they're responsible for it," said Dasbach. "The FCC's behavior proves that the only thing worse than an unconstitutional tax is a sneaky unconstitutional tax."

The FCC has already collected more than \$600 million from business users, and residential phone bills should be hit with the Gore Tax in July. [End quoting]

### FILLING THE PIPELINE

FIBER-OPTIC CABLES, long touted as great conveyors of data, actually don't live up to their potential. That's because the current method of transmission is a complex process involving 16 lasers to keep the signals stable over distances ranging to 50 miles. This method reduces data capacity to about 40 gigabits per second, far short of the 10-terabit-per-second capacity of the cables themselves.

Silkroad of San Diego has developed a single-laser transmission technique that could eventually use the entire fiber-optic cable. Current capability, the company says, is 200 gigabits per second over 200 miles. The technique, called refractive synchronization communication, is bidirectional, so it can be used interactively.

The technology could increase the amount of data available on the Internet, and broaden the channel capacity of cable TV companies. It could also handle the increased bandwidth of digital TV. —F V. [End quoting]

It saddens my heart when people are hurt. I cannot intentionally hurt anyone. At birth, I weighed 3 lbs. Even after 6 months, I was carried cross-ways on a pillow. I was sickly most of my early life.

At one year of age I had whooping cough. The area doctor was called—a man of many years of experience. He thoroughly examined me, and then pronounced me dead and left the house. It took nearly 2 hours to get dad home from work.

He wrapped me in hot towels, massaged my body, blew into my mouth and nostrils and after some minutes he felt a faint vibration on my heart. The doctor was called. He told my parents that only God had intervened to bring

me back to life. That God had other plans for me. That no one could survive that long without brain damage. And, with God all things are possible. The Earth is the Lord's and the fullness thereof. God is the Way, the Truth and the Light.

At Christmas time in my first year of high school, I was clearing some new ground for crops and got poison ivy all over my body. I got 3½ years of high school. I was too poor to go to college. But I had better teachers—God's angels furnished me with the knowledge that I needed. They were my guides and protectors. Ready answers always came to me. God's angels have always protected me and I have faced many dangers. A copperhead snake struck 3 times and hit my right leg each time, but couldn't bite me. A large coiled rattlesnake was 3 feet from me and the way I had to go was past it and a high cliff below me. Its tail was in the air and its tongue was flipping in and out...a boy came down and killed it. It had 13 rattles and a button, was 4" thick, and over 5 feet long. I was fishing at a 5-foot-wide creek. I felt something hitting my leg. I looked down. I was standing in the middle of a 3-foot-long water snake, its head and tail bouncing against my leg, trying to get from under my foot. I found myself on the other side of the creek and my shoes not wet. A tree snake jumped—missed.

God has always provided. I needed \$2 for a diploma on Monday. My grandmother and aunt sent it by a sister. She brought it to me at 8PM on Sunday. I didn't have a suit of clothes to graduate in. A family moved into a house that had been vacant for nearly a year. They moved in 3 days before I graduated. My mother asked me to go see if they had a boy my size. They did. He had 3 suits, and all fit. So never doubt God. And, all through the war for nearly 5 years—bombs fell all around me; I heard bullets. I picked up 3 wheel-barrow loads of metal the next morning. Many times I heard bullets around my head. So, never doubt God and His angels. I walked 4½ miles each way to high school.

As God and His angels have always protected me, I could not lie. To do so would have broken the thread of protection. Even when little, I always told the truth. I have only love and compassion in my heart for all of life.

I never had the chance to study accounting. Three days after getting out of the Army I worked one day at a large automobile dealership (6 makes of autos). They called and asked me to go 50 miles to their Dodge and Plymouth dealership—to be the only person with the books, as their bookkeeper was in the hospital. I was there 3 months. Then, continued on for 22 years. God was my teacher.

Our family walked almost 3 miles each way to church—Corinth Baptist Church in Ben Hur, Va. Taught intermediate boys for 2 years, served 2 6-month terms as BYPU president—sung in the choir. I never moved my membership.

In my many activities—God has always sent me to be there "when I am needed", and to furnish me with the "instant knowledge" that was required. —J.C. [He couldn't have much better initials!!] [End quoting]

**—PUBLIC NOTICE—**  
**MEMORANDUM OF AGREEMENT**  
**NATIONAL SECURITY**  
**(CONFIDENTIAL)**  
**September 9, 1996**

The following constitutes an agreement among the following parties: **E.J. Ekker, Doris Ekker, and Rick Martin**. These parties, signing as individuals, shall stand individually and jointly responsible for ONLY their actions as they apply to themselves individually or to any corporate entity wherein they are jointly corporate officers and/or directors. They shall NOT be responsible for the actions of ANY OTHER PARTIES nor shall they stand responsible for the actions of any alleged-owners, alleged-partners, trustees or beneficiaries. This agreement concerns transactions utilizing the instrument referred to as the Peruvian Bonus Certificate 3392-181, which originated in 1875 and was accepted as United States of America Treasury debt in 1906, and subsequently as debt of the Federal Reserve in 1913. Said debt, as accepted, is inclusive of all interest and penalties (as reflected in the calculations made on the Federal Reserve's own computer in Los Angeles, California in 1989 with members of the "intelligence" community present to monitor the activity). This agreement arises as result of several telephone conversations with authorities in the Treasury Department held over the past few weeks and is meant to memorialize those conversations for our own future use.

Since the debt was assumed prior to any other agreements involving monetary departments, divisions, or branches of government, it is a bonafide outstanding debt of the U.S. Treasury and the Federal Reserve System.

The applicable restrictions and limitations in this transaction will apply to all participants. Due to NATIONAL SECURITY considerations no input to change or remand the validity of the debt created by BONUS 3392 will be accepted from the COUNCIL ON FOREIGN RELATIONS, the UNITED NATIONS, or any other entity, foreign or domestic.

As a consideration of National Security (as well as Global Security), transactions WITHIN these guidelines will not be interfered with or blocked by the U.S. or its assigns. The consideration for such noninterference is that none of these contracts will be lodged for collection until such time as there is an additional agreement as to the lodging and honoring, through payoff, of the contracts.

Generally, it will be the practice of the Holder to expect the funder to provide loan capabilities and to purchase gold as needed wherever there is security; it is NOT required that the gold be housed within the U.S.

The Holder will not directly do business with any national group under sanction by either the U.S. or U.N. There is to be no restriction, however, on other parties or nations conducting business in their normal way. The Holder will conduct itself in the strictest accordance with all applicable laws.

The Holder has agreed to use its portion of funds for humanitarian purposes. No portion of its funds or assets will be used for purposes of ARMS ACQUISITION, WAR MAKING, OR THE OVERTHROW OR SUBVERSION OF ANY NATIONAL GOVERNMENT. However, the Holder has no way to police the use of funds by any other participating party.

We agree that we will issue no SINGLE deed in excess of \$10 billion (USD) and no group issue to a single entity of greater than \$1 trillion (USD)—per year. Preferably the deeds will be issued and utilized in increments which would be appropriate in "ordinary" working conditions. It is also agreed that in any one year there will be no more than \$5 trillion (USD) and there must be capability of the currency sources to issue funds timely. The understanding is that the documents themselves will be used as COLLATERAL so that it is not utilized as a "cash" demand or a "call" on the gold reserves. We, the below signed, herein agree that all transactions involving us, individually or as corporate representative, will be additionally backed by hard-metal gold (or other precious metal) totaling the full value of our portion, prior to any line-

of-credit being drawn-upon against the "bonus" collateral. If this is impractical at the time of a transaction, it will be accomplished as soon as possible.

Further, it is understood and accepted that any outside requests made to the U.S. Treasury for confirmation of the validity of the debt of Bonus Certificate 3392-181 will be met with denial and a "wall of silence" as is considered standard procedure in such matters concerning national security.

We, the below signed, attest that we will make it clearly understood to all participants wishing to utilize the Bonus Certificate 3392-181 for collateral that the debt is not to be "called" by those participants. However, we also clearly stipulate that once the deed has been issued, we are unable to control the actions of any other individual and/or corporate participant, and as such, we will not be legally held accountable for another's actions. We further stipulate that when functioning in our capacity as a corporate representative, we are protected under the laws governing the corporation to the full extent that such protection exists. Further, we will not agree to negate the value of the contracts if and when there should be a call on the Treasury, Federal Reserve or its owners. It is our understanding that the Federal Reserve has a working relationship with the Treasury Department regarding valid debt both prior to and following the Federal Reserve Act of December 23-24, 1913. We have not been made privy to those arrangements.


It is also agreed that in the event of a call for payment on this debt, negotiations can be entered into to accept currency of the date of demand rather than a full demand for payment in gold. # Signs Of Armageddon (aka World War III) And The Lamb With Two Horns

The location of the biblically prophesied area of the battle of Armageddon is in northern Israel near the shared borders between Israel, Syria, Jordan, the Palestinian West Bank and Lebanon. It is also known as Megiddo, or Harmageddon and is adjacent to the Plain of Esdraellon. It has been said that this plain is large enough to accommodate the world's armies. However, I believe this was calculated at a time when the world's population was smaller. Some maps in old *Bibles* of today give the name "Megiddo" to the town at the area, which is on the road going inland from Haifa, and between the coast and the River Jordan.

Israel has occupied nine miles into the border of Lebanon in spite of United Nations resolutions to withdraw. They insist it is critical to their own security that they do so because Lebanon, for one thing, owns the higher ground in the area. On 2/28/99 an Israeli general and three others were reported on CBS TV news as killed by a car bomb as they were traveling in a convoy four miles into Lebanon's territory. This has focused attention on this area again as a trouble spot. The actual circumstances of the bombing were not given. One wonders if the bomb was thrown from beside the road by a Lebanese or whether it had been placed in the general's vehicle in Israel before he started the journey. Wars have been started over just such incidents, and some of the incidents were covertly created for that purpose. In any event, Prime Minister Netanyahu of Israel is now under pressure to "control" the situation, hopefully short of war. However, as we see in Iraq, escalating the conflict only awaits another excuse of some sort.

Israel and Syria are also at odds. Lebanon was part of Syria before the British divided it from Syria and set up a puppet government in Lebanon in 1926. Syria and the people of Lebanon still consider themselves the same people. Israel has tried to get Syria to control the freedom fighters, called Hezbollah, which continue to infiltrate Israel's posts on the border and in the Golan Heights, killing Israelis and bombing military vehicles as circumstances allow. To date there have been a great number of Syrian and Lebanese civilians lost due to Israeli attacks, and many more Hezbollah killed over the number of Israeli soldiers.

However, the Hezbollah are fighting for their land and way of life, and are willing to die for it. Israel wants Syria to disarm the Hezbollah, something Syria refuses to do. There have been no U.N. sanctions against Israel in spite of their

open disregard of U.N. resolutions to withdraw and which are non-enforceable unless approved by the Security Council. So far the U.S. and Israel have prevented this approval. In my opinion, this is the Achilles' Heel of the U.N. which effectively prevents justice and peace in spite of all the "peace-keeping" forces in use over the world. (The map on p. 9, printed in 1997, shows the territories in dispute since the June 1967 Arab/Israeli [six-day] War, including Palestinian lands.)

Some self-rule has been granted the Palestinians in some areas since 1967. However, the greater police and military control of the areas, as well as access to it, still rests with the Israelis. Also, the Palestinians have no control whatsoever over Israelis who have settled on the lands they have occupied, even those where the Palestinians have limited self-rule. The Palestinians are hedged in, in every way, while

the Israelis have continued to this day to settle more of their land. Such implacable arrogance and aggressiveness can only cause hatred and violence! Of course, the Israelis are also insisting that the Palestinians give up their arms, which would conveniently leave the Israelis a clear field to take over all of the land without hindrance.

If you look at the second map (on page 10) you can see that, strategically, Syria (as well as Iraq and Iran) is being surrounded by the forces of the U.S. and its allies, Britain, Israel, and Turkey, through the use of the U.S. and Britain's currently-imposed northern and southern no-fly zones in Iraq. Presently they are bombing all of Iraq's military installations in these zones. Iraq has pulled back its military to Central Iraq, and was not, for a while, returning the fire of the allies in these zones, according to CBS TV news. Jordan, according to Arab sources, has a treaty with the U.S., Israel and Turkey whereby they promise mutual assistance for "humanitarian objectives". This leaves Syria in a very vulnerable position should the allies decide to end the problem of the Hezbollah in favor of Israel. The U.S. and its allies can no longer claim to be "carrying out the United Nation's sanctions". Through their own actions they are strictly on their own in the present confrontation with Iraq. Therefore, one can assume they would make similar independent decisions in the future involving other nations in the area.

It is interesting that Jordan will have a new king during these next critical years. He has had military training and is General of the Home Guard, or Special Forces in Jordan. His name is Abdullah, and he is married to a Palestinian. His mother was English. He was raised in England. Abdullah has little or no governmental experience, so it would be difficult to say whether he will

follow in his father's footsteps. He is a Hashimite who can trace his lineage back to Muhammed. The population of Jordan is 90% Palestinian. According to CBS News on 2/5/99, Jordan has no oil. King Hussein ruled for forty-seven years in relative peace (after Hussein making peace with Israel), and through making deals with his neighbors.

If you saw the report of King Hussein's funeral on CBS TV you know which countries sent representatives and which were noticeably absent. The U.S. packed the house by sending Clinton and three former presidents; Israel sent Netanyahu and Peres. Arafat of the PLO, King Assad of Syria and Boris Yeltsin of Russia were the other foreign representatives listed on TV. Clinton gave King Hussein a eulogy which praised his participation in the recent Arab/Israeli peace talks in the U.S. However, the fact that Netanyahu derailed the agreements soon thereafter by approving Israeli settlement on more disputed land in East Jerusalem was not mentioned. In fact, the U.S., while "talking the talk", has never required Israel to live up to its peace agreements. We were told that King Assad of Syria, while being present, had hardly spoken to King Hussein following Hussein's peace with Israel.

One wonders about the position of other Arab nations such as Saudi Arabia, Libya, Egypt, Iran, Kuwait, Oman, Yemen and all of the African nations, which were not represented at the funeral. Obviously, King Hussein was more closely tied to Western politics than to that of the Islamic world. Noticeably absent also was any representation from Great Britain, the European countries and Asia. It appears that Great Britain likes to keep their involvement behind the scenes in public affairs.

Interestingly, Clinton said the U.S. would be giving Jordan "\$300,000,000.00 to ensure the stability of the new government". I can see many places in the world who need the aid

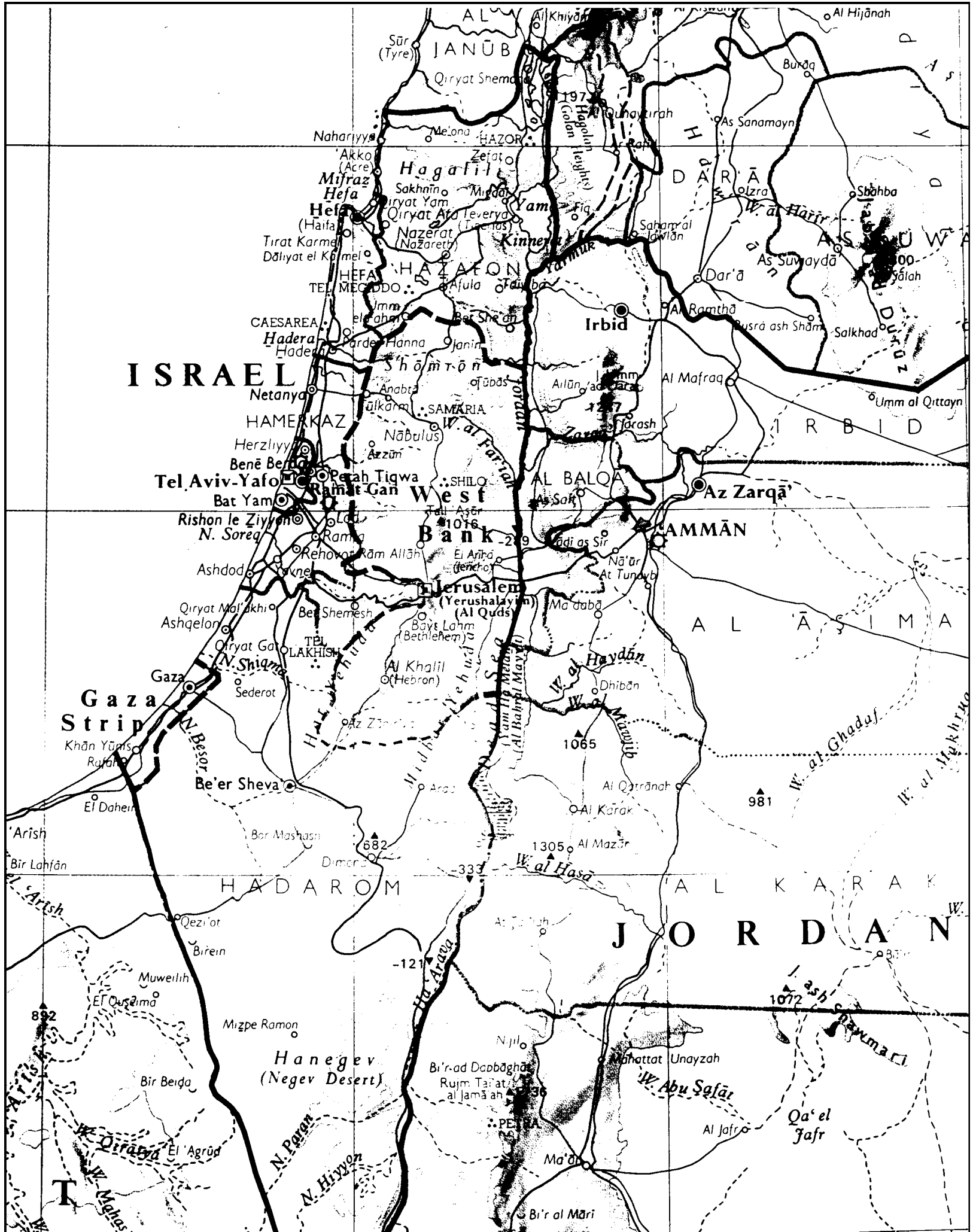
more. Perhaps the gift was some kind of insurance that Abdullah follow in his fathers footsteps?

According to a 2/16/99 article on Jordan by Ahmed Rufai, International Editor of *The Final Call* newspaper: [quote]

Jordan was created after World War I as a reward to the Hashimite family where rebellion, with British support, contributed to the fall of the Ottoman empire. The empire had been Islamic

united force against Christian Europe and its imperialism. By funding the Hashimite family's rise in Syria, Iraq and the newly created state of Jordan, the British gained successfully in the Middle East, observers note.

Another British imperialist creation against a united Muslim empire, they say, was the Saud family, which was helped in founding Saudi Arabia, and the Sabah family of Kuwait.



King Hussein was enthroned after his grandfather Abdullah, was murdered and his father, Talah, was found incapable of ruling.

"As an artificial entity, Jordan had never been able to support itself and therefore depended on a colonial relationship with Britain and the United States, and later Israel," said Dr. Farouk Mustafu, professor of Arabic and Middle East studies at the University of Chicago.

At one point in the 1960s, Mr. Hussein spent weeks in Washington, waiting for U.S. assistance to pay his Army's salary. [End quote.]

Americans were told that the no-fly zones over Iraq were intended to protect the Kurds in the north and the Shiite Muslims in the south from Saddam Hussein. It is difficult to see where the present military action against Iraq fulfills these purposes. Indeed, it appears that Turkey has invaded northern Iraq to fight the Kurds, even pursuing them into northern Syria. American planes flying over northern Iraq are based in Turkey. What protection was offered the Kurds from Turkey? None.

The 1/5/99 issue of *The Final Call* newspaper has a report from Amnesty International on U.S. surplus military equipment being sold or given to countries who have a record of human rights violations. Among these countries was Israel and

Turkey. Violations in Turkey were against Islamics and Kurds. An excerpt from that report is quoted below: [quoting]

In Turkey, U.S.-supplied helicopters, armored personnel carriers, trucks and jet fighters were used against villagers who resisted evacuation by the authorities. After pressure from Congress, the State Department in 1997 admitted that Turkey's special paramilitary gendarmes and police, notorious for political killings, "disappearances" and torture, were using M-16 and AR-15 assault rifles and helicopters obtained from the US in their operations.

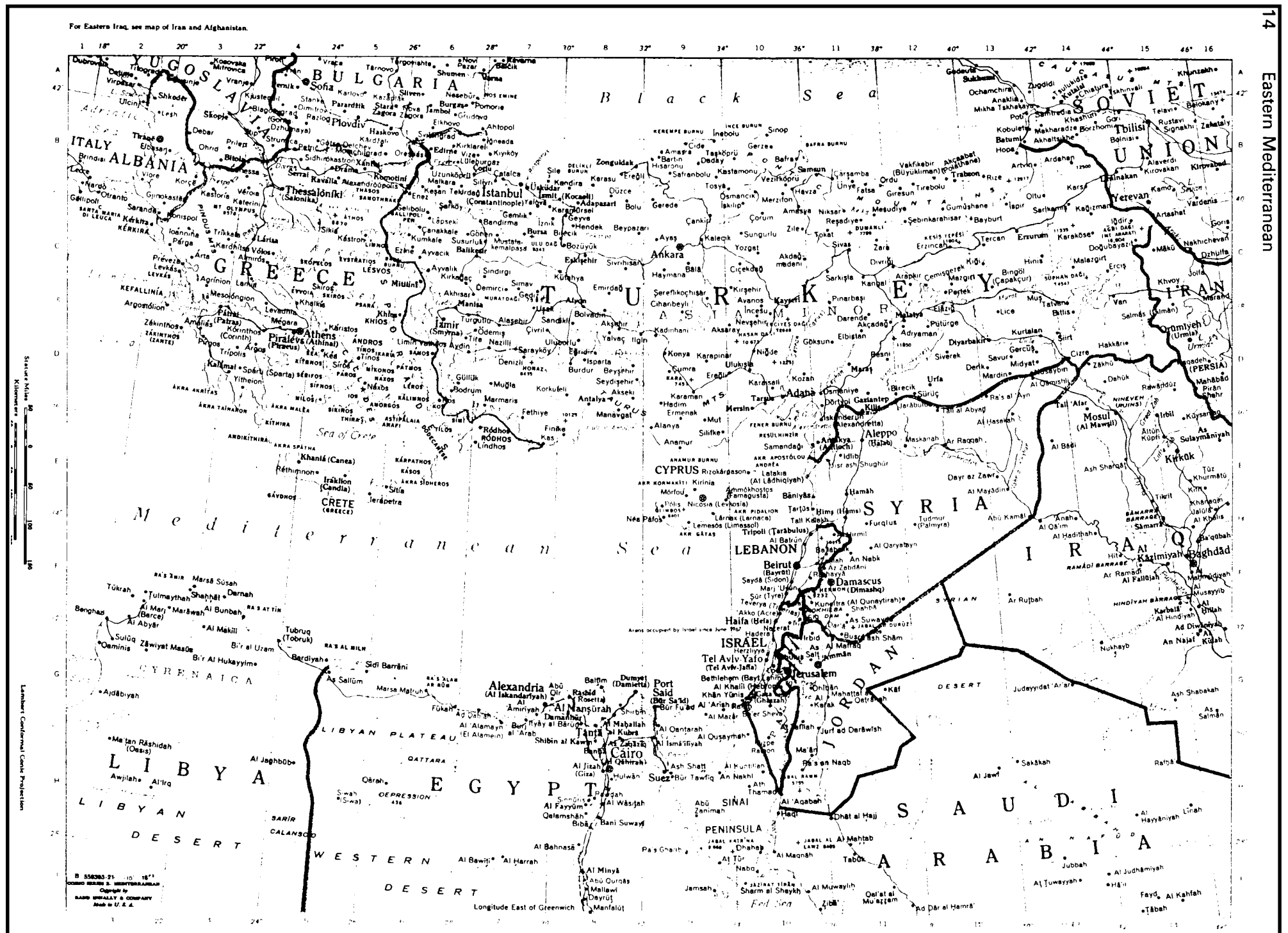
Even after the U.S. government held up a few arms exports to Turkey, abuses by Turkish security authorities persisted. Yet, according to Amnesty, in 1998 hundreds of U.S. armored vehicles were allowed to be exported to Turkey by the Commerce Department. That same year, U.S. Defense Secretary William Cohen visited Turkey and lobbied on behalf of U.S. companies wishing to co-produce advanced attack helicopters there. In spite of documented evidence of electro-shock torture mainly against Islamists and Kurds, U.S. companies negotiated a sale of 10,000 electro-shock weapons there. The existence of electrical equipment for torture was confirmed by a Turkish Parliamentary Commission of Human Rights. [End

quoting]

The human rights violations committed by Israel and reported by Amnesty International were indiscriminate killings of civilians in Lebanon in what it called "Grapes of Wrath", using U.S.-supplied helicopters.

Where is all of this leading? If you read my article titled "What Is Happening In The Middle East?", you know the Arabs believe that Turkey plans to strike against Syria while Israel bombs industrial and military sites in Syria and Iran. Certainly, if Turkey has pursued Kurds into northern Syria, they appear to be provoking some sort of defensive or retaliatory action on the part of Syria. What will actually occur, and when, is of course not known. However I began to take the view of the Arabs very seriously when I read Gordon-Michael Scallion's "Predictions for 1999", in the January/February issue of *Earth Changes Report*. Among them was the following: [quoting]

## GMS INTERPRETATION:

This may indicate the emergence of the biblically prophesied "Anti-Christ". Turkey has been mentioned in my previous predictions (dating back to the early '80s) as where the start of the final battle between good and evil will occur, before the millennium of peace begins. This stanza may be referring to Turkey, since it has been suggested by researchers and the *Bible* itself that Noah's Ark came to rest on top of Mount Ararat in Turkey. [End quoting]

Mr. Scallion has encouraged his readers to look at his predictions and try to intuitively understand the meanings. He does not claim that his interpretation may cover all that can be understood from the prediction. In my view, "The Chameleon" is a very apt description of the U.S. and its allies in their current action in Iraq. The stated purposes have changed more than once and the current action is unfathomable unless you take into account the biblical prophecy in the *Book of Revelation*, Ch. 13, regarding the U.S., Britain and the Beast. Following are verses 11 through 18: [quoting]

11 And I beheld another beast coming up out of the Earth; and he had two horns like a lamb, and he spake as a dragon.

12 And he exerciseth all the power of the first beast before him, and causeth the Earth and them which dwell therein to worship the first beast, whose deadly wound was healed.

13 And he doeth great wonders, so that he maketh fire come down from heaven on the Earth in the sight of men,

14 And deceiveth them that dwell on the Earth by the means of those miracles which he had power to do in the sight of the beast; saying to them that dwell on the Earth, that they should make an image to the beast, which had the wound by a sword, and did live.

15 And he had power to give life unto the image of the beast, that the image of the beast should both speak, and cause that as many as would not worship the image of the beast should be killed.

16 And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads:

17 And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name.

Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six.  
[End quoting]

According to Commander Hatonn's comments in the past, the "two horns like a lamb" are the nations of Britain and the U.S. They are two so-called peaceful nations who change their direction to an alliance with "the beast". Also, it appears to me that the International Monetary Fund, which is headed by the Rothschilds out of the City of

London and largely backed and controlled by the international bankers of these two nations, is intended to be the controlling financial power of the world along lines predicted in this text, as we are gradually finding out.

Gordon-Michael Scallion's prediction describes this "Chameleon" as "Fulfilling his destiny by resurrecting the dead". According to the biblical verse, the second beast (the lamb with two horns) had "power to give life unto the image of the beast". I see two possible meanings to these predictions, although there may be more. One has to do with the present ability of scientists, through the use of DNA, to clone animals and humans. The predictions could refer to robotoids. They might also refer to the combined power of Britain, the U.S. and its allies to make the first beast (the United Nations or the World Government Federation) active and in control of the world. According to Hatonn they have developed a robotoid army which has been programmed to fight until they drop. Therefore, it is possible that both interpretations of the predictions can become true.

I came across one biblical verse which would place the anti-Christ in Turkey at the time of the prophecies of the *Book of Revelation*. Turkey now occupies the area once known as Asia Minor.

According to the letters to the seven churches, in the *Book of Revelation*, it appears that "Satan's seat" is in the area of the church at Pergamos, a former ancient city in what is now western Turkey. Whether or not this area can be construed today as the "seat of Satan" is the question. From the scripture I have interpreted the passage to refer to a particularly anti-God spirit alive in this "church", rather than an identifiable entity. I leave the final interpretation to you. (Ref.: *Book of Revelation*, 2:12-17.)

Through all of this keep in mind that the Jews claim that "God" will give them all of the land between the River Euphrates and Egypt. The River Euphrates starts in Turkey, and runs through Syria and Iraq. The greater plan of Israel and the Jews throughout the world is to bring this so-called "covenant" of "God" to reality. This area also fits into the plans of the "Beast" as one of the ten regions of the New World Order.

There is an article in the *Jerusalem Post* of 2/5/99 titled: "Golan Law makes withdrawal harder". This Golan Law was recently passed in Israel and requires that "61 members of the Knesset, followed by a majority in a referendum, must approve before territory under Israeli sovereignty can be ceded". That means the Israelis do not intend to give up their positions on any "disputed" lands. According to them, they own it! It is under their "sovereignty". Obtaining 61 votes in the Knesset is considered next to impossible.

In the same newspaper there is an article about

Egyptian ambassador Bassiouny regarding peace with Syria. The Ambassador claimed there were documents to prove that Syria wanted a full peace with Israel. However, he had to concede that the Syrian leader still had very specific conditions. "Assad would like to achieve the peace, but not at any price...." Mr. Bassiouny has been claiming Syrian intentions for peace for a very long time. Nevertheless, it appears that the two opponents are very far apart on any arrangements whatever.

I believe the vote on the Golan Law in the Knesset was also prompted by, among other things, recent "land for peace" problems with the Palestinians' recent military action by their allies in Iraq and pressure from many Israelis, especially mothers with sons on the front lines who want peace so their sons can come home. Netanyahu's response to them, according to CBS news, was that Israeli security was his prime concern. That appears to mean a planned perpetual occupation of the border of Lebanon, the Golan Heights (Syria) and Palestine (the Gaza Strip and the West Bank). The Arab nations cannot fail to understand this.

The vote in the Knesset also insures that any peace for land agreements with the Palestinians will meet with strong (and some say impossible) opposition.

Therefore, don't be fooled by any future American-staged propaganda attempts to bring about a Palestinian/Israeli "peace for land" agreement. Any real change won't happen as long as the current law is on the books in Israel, or unless some mighty event occurs which changes the situation.

It is clear that the ancient "divide and conquer" plan has been at work for some time in the Middle East under British and then U.S. backing. Turkey is what is left of the former Ottoman Empire and is now in cahoots with its former enemies. Also the Syria and Iraqi governments now appear to be out of favor with their former backers. Is this the "Chameleon" at work?

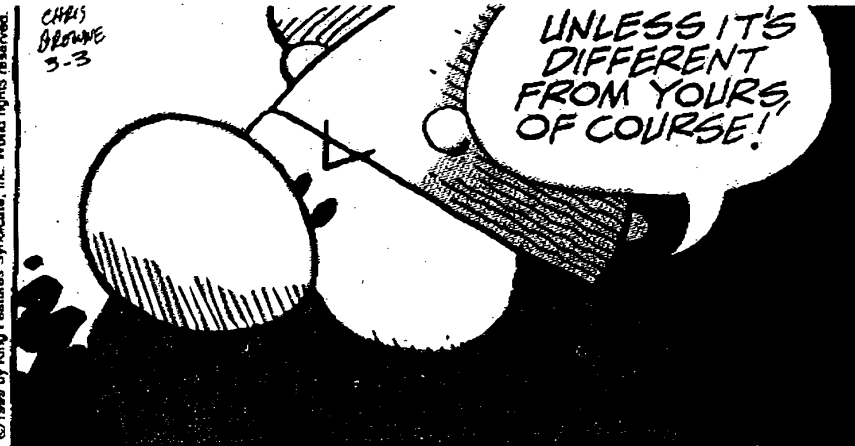

# Contrail Spraying Generates Outrage

depopulation of the planet by eliminating at least three-fourths of the inhabitants. Henry Kissinger once said before the United Nations that "we have to reduce the world's population by at least 60 percent." There are simply too many of us "useless eaters". The population has built up to this finale and now it must be slashed.

What we are witnessing and experiencing through sickness generated by poison contrails is but a part of the plan to render the masses unfit and unable to put up any sort of resistance to those who would see us dead. And it is working because the majority cannot comprehend the Big Picture, where Good and Evil now face off against each other, and we stand right in the middle of the battleground. Stan has been following the contrail story and, on Feb. 20, 1999, he posted a newsletter report about it. Stan may well be expressing a view that is held by many, so let's see what he said about the contrails: (quoting)

Yes, some folks will suffer negative reactions to the immunization processes. This is unavoidable. In war you will have casualties; this is a constant.... America cannot afford to

kill off its own people; it needs her people to stay intact! (End quoting)

Stan does not appear to embrace any knowledge about the "elite's" Global Plan 2000. He fails to realize that part of the reason for building huge underground facilities (including small cities down there) and stockpiling supplies there, is to survive a nuclear war or any other emergency that would make living on the surface a dangerous proposition. No, it seems more likely that the "elite" are working toward killing us off in larger numbers.

William Thomas' latest paper, *Hospitals Jammed As Banned Pesticide Is Sprayed From The Skies*, posted on his Internet website, <http://www.islandnet.com/~wilco/> on Feb. 23, 1999, states in part: (quoting)

Seattle, WA: As formations of unmarked tanker aircraft continue to criss-cross American skies on a mission authorities refuse to disclose, an environmental laboratory has identified an extremely toxic component of the spray drifting over cities and countryside.

Several independent sources claim that samples of fallout from the lingering smoke trails have been independently tested and found to contain ethylene dibromide (EDB). "We had the fuel sampled in August, 1997" a contrails investigator who wishes to remain anonymous told this reporter. "The lab immediately identified the sample my friend took in, however once the lab started receiving quite a few phone calls, they went cold! They didn't want much to do with us after that."

The lab in question—which shares its name with several subsidiaries and several separate

laboratories—could not confirm the test, which would remain confidential in any case. But in 1998, a U.S. Air Force public affairs officer told residents of Las Vegas that their sudden upsurge of respiratory ailments could have come from “routine” fuel-dumping by military aircraft reducing weight for landing.

The 1991 document *Chemical Hazards Of The Workplace* warns that repeated exposure to low levels of EDB results in “general weakness, vomiting, diarrhea, chest pains, coughing and shortness of breath, upper respiratory tract irritation” and respiratory failure caused by swelling of the lymph glands in the lungs. “Deterioration of the heart, liver and kidneys, and hemorrhages in the respiratory tract” can also result from prolonged contact with JP-8 [jet fuel].... EDB may also damage the reproductive system.

Mark Witten, a respiratory physiologist at the University of Arizona in Tucson where an official U.S. Air Force study on JP-8 was carried out, told *Scientist* in March 1998 that crew chiefs “seem to have more colds, more bronchitis, more chronic coughs than the people not exposed to jet fuel”.

Hundreds of photographs and videotapes made by ground observers show pairs or larger formations of aircraft spreading a white mist that thickens and drifts toward the ground. More than 200 eye-witnesses—including police officers, pilots, military and public health personnel—have provided detailed accounts of aerial spraying in characteristic “X”s and east-to-west grid patterns, followed by occluded skies, and acute auto-immune reactions and respiratory infections throughout affected regions.

“I keep coughing phlegm that tastes bad,” 50-year-old Mary Young of Sallisaw, Oklahoma told ENS after an aircraft sprayed her home at rooftop level one night last January with something that struck the windows like sand. “My eyes hurt. My joints hurt. I’m not catchin’ my breath right. I can’t get rid of this cold. I’ve had this bad headache—it’s not just a headache. My eyeballs hurt so bad—way in the back—I just wish they would fall out.”

Severe headaches, nosebleeds, shortness of breath, joint pain and a dry, hacking cough “that never leaves” are being reported by countless Americans jamming hospital Emergency Rooms from coast to coast. While December and January are traditionally bad months for asthma sufferers, patients, doctors and nurses across the U.S. report hospital wards filled to overflowing with bronchitis, pneumonia and acute asthma admissions at up to twice normal winter rates.

Early last month, *The News and Observer* of Raleigh, North Carolina reported that respiratory admissions to Durham regional hospital jumped from the usual 184 patients a day to 247. Ambulance drivers were told that the hospital was not receiving any more patients.

In New York City, doctors are calling a flood of respiratory cases an epidemic. “We have people double- and triple-parked in the ER on stretchers,” Dr. Elliot Friedman, associate director of emergency medicine at Jamaica Hospital Medical Center in Queens, told the *New York Times* on January 31. “And there have been times when upwards of 40 people have been admitted that are waiting for someone to be discharged,” Friedman added.

“This high fever is not typical of other flus,”



Dr. Sigurd Ackerman, the president of St. Luke’s-Roosevelt Hospital Center told the [New York] *Times* shortly after a TV cameraman panned up to frame lingering “X”-shaped contrails over Times Square. Dr. Robert Saken, a partner in the Soho Pediatrics Group, told that newspaper, “It was surprising to me how sick they got and how quickly it happened.”

That same day in Lake Havasu, Arizona, headlines in *Today’s News Herald* announced: “Victims curse unnamed bug, but can’t call it the ‘flu’.” M.D. Mary Lou Kallername told the *Herald* “that a nameless virus is bringing at least 10 patients a day into her office and driving some into the hospital, but laboratory tests show only a few are suffering from Type A or other identifiable strains of influenza.”

The previous weekend, after San Francisco resident Curtis Schumann noticed “sky grids in the making”, and Melanie Zucker watched nine contrails being woven over Berkeley, local TV stations reported Bay Area emergency rooms inundated with flu-like cases.

In Seattle—where a resident reports “I’ve lived here for 26 years, never seeing this number of contrails at once”—pneumonia patient Lowell Barger told ENS that in the hospital where he was admitted in late January, “their respiratory ward was overflowing with people, and they were having to put respiratory patients in other wards.” At that time, a resident of Spokane, listening to a police radio scanner, told ENS he heard “many rescue calls for people with breathing difficulties”.

In Palmyra, New Jersey, shortly after Lucrecia Moon watched unusual lingering contrails from a McDonald’s restaurant, a nurse reported “many people ill.” In Las Vegas, Nevada, TV news coverage told of area hospitals being filled with people experiencing breathing problems.

After a resident of Lexington, Kentucky watched helicopters circling the city for several days, flying low overhead at 3 a.m., “the sky looked like a giant checkerboard from the planes criss-crossing it, and the air still had the steel-mill smell.” According to this eye-witness, “Everyone here is sick. So far six counties have closed all the schools because all the students were sick with ‘flu-like symptoms’. I’ve been having headaches, a sore throat, and an annoying, hacking cough for the past four months and it seems to get worse after I see these aircraft circling the area.”

Similar “chemtrail” sightings continue to be

reported over Phoenix, Arizona. The January 28, 1999 edition of *Arizona Republic* reported that “the incidence of bronchial problems in Phoenix this month is 237 hospitalizations vs. last year at 160 or so.”

At the same time, hospitals in Portland, Oregon; Marietta, Georgia; Chandler, Arizona; Bakersfield, Santa Cruz, Redding and Salinas, California—and other cities across the nation—were jammed with bronchitis, pneumonia and other acute respiratory cases after repeated spraying and cobweb-like fallout was reported in those regions.

“We’re getting sprayed real heavily with the contrails,” a south Pennsylvania resident told ENS. “It’s just total saturation.”... Overfilled Pennsylvania hospitals were forced to divert respiratory emergencies to other facilities with bed space....

The January 7 *Philadelphia Daily News* reported that “Emergency Room patients overflowed into the hallways at West Jersey Hospital in Berlin, New Jersey”... At Northern Westchester County Hospital, “there was a 24-hour waiting period to get in.”

In Manitou, Michigan, Registered Nurse Kim Korte was driving north on M52, when she noticed “stripes” in the sky...“evenly spaced and covered the whole sky”.... Within 24 hours Korte became very weak and feverish. After her boyfriend told her that “many in his family started coming down with the same complaints,” the RN “started noticing a lot of my patients and their family members were coming down with these symptoms at the same time.”

In Austin, Texas—where Richard Young reports that “The skies here are filled almost daily with trails crossing each other”—a school nurse told a worried parent that she had seen over 100 sick children in a single day.

Where is the mass media’s reporting of this mass phenomenon? Indications of a concerted cover-up came on February 11, when a retired Southern Baptist preacher named Everett Burton finally succeeded in reaching C-Span. After voicing his opinion on the Clinton impeachment trial, this former minister told Americans to get a copy of the *Constitution* and read it to realize what they have lost. Rev. Burton then advised viewers not to take his word for what was happening in the U.S., but to “just look up in the skies as the planes regularly spray contrails across the skies, spraying people and making them ill.” At this point, Rev. Burton was cut off. The screen flipped from C-Span to the

Tennessee state seal, and remained silent for several minutes.

Americans are not alone in their anxious bewilderment and suffering. In England, after lingering contrails and cobweb-like fallout were reported over London and Birmingham, the BBC reported on January 14 that more than 8,000 people—mostly elderly—died from pneumonia and other respiratory complications in the last week of December and the first two weeks of January 1999.

According to the BBC, in early January of this year, more than 97,100 people in England and Wales were stricken with respiratory ailments in a single week—almost double the usual rate. Ambulances in the Greater Manchester and Mersey region were each dealing with more than 1,000 calls every day—almost twice the norm. Norfolk and Norwich suffered such an unexpected increase in deaths, a refrigerated semi-trailer capable of holding 36 bodies was pressed into service as a temporary morgue.

As this story goes to press, fresh leads now point to a bacteria in the spray that targets the respiratory tract. Lab tests confirming this development are expected to be in my hands shortly. (End quoting)

As bad as things sound in England, they actually appear worse than stated above by William Thomas. The British Ministry of Defense (M.o.D.) has been carrying out classified germ-warfare tests since the 1980s using live E-coli and other bacteria whose behavior mimics Anthrax. Since the tests are classified, it is not known how many bacteria are actually being released, or how close the test sites are to residential areas.

Also, it was recently reported by Professor Brian Spratt of Oxford University that the M.o.D. was conducting germ-warfare tests in the 1960s and '70s. How many other countries are undergoing this spraying is not known at this time.

It appears that William Thomas has posted information from a source within the Canadian Intelligence Service, stating that “heavy spraying is taking place over Victoria, British Columbia.” It would only make sense that this is probably taking place over the rest of Canada as well. He also has reports of spraying over Europe and Australia, but no details at this time. And CONTACT has received information from Boise, Idaho indicating many people are sick there from spraying conducted throughout the month of January.

Part I of this series [*in the 2/16/99 issue of CONTACT, Front Page story*] discussed Dr. Cole's testimony before the U.S. Senate in May of 1994, concerning U.S. Army “testing” of chemical and biological agents, conducted since 1949. In Dr. Cole's actual testimony he stated that “the Army... recognized they could be causing disease and death.” But that didn't seem to bother the Army. Dr. Cole said, “The Army has not monitored the health of citizens who may have been exposed during its tests.” Quite simply, there was no such thing as informed consent.

Prior to 1977 there appeared to be no requirement to notify the public about the so-called “testing”. Title 50 of the United States Code, Section 1520 was enacted in July of 1977, and required that no chemical or biological test could be conducted “on civilian

populations unless local civilian officials in the area in which the test or experiment is to be conducted are notified in advance of such test...” It does not appear that this law was ever complied with. No matter, the law was repealed in November of 1997.

Section 1520 was replaced with a new Section 1520a in November of 1997. The new law allows “tests” with “any micro-organism (including bacteria, viruses, fungi, rickettsiac, or protozoa), pathogens, infectious substances, and any naturally occurring, bioengineered, or synthesized component of any such micro-organism, pathogen, or infectious substance... that is capable of causing death, disease, or other biological malfunction in a human, an animal, a plant, or another living organism; deterioration of food, water, equipment, supplies, or materials of any kind; or deleterious alteration of the environment.”

According to Section 1520a, the above biological agents can be used on civilian populations for “Any peaceful purpose that is related to a... research activity.” (Doesn't really sound very peaceful, though.) But under Subsection (c), this “testing” can only be done “if informed consent to the testing was obtained from each human subject in advance of the testing on that subject.” Now, have you been informed that “testing” is going on? Well, it wouldn't be much fun for those who ordered the “testing” if they had to tell us about it! So the spraying continues. And even more disturbing now, Mr. Thomas is finding symptoms that appear exactly like Gulf War Illness!!!

If it is a requirement of the law that we must be informed about testing, but we are not being informed, then it is not testing, is it? It is chemical and biological warfare being waged against the civilian population, and not by Iraq, and not by Libya, and not by Bin-Laden—but by our own government, or at least with their consent. If you are not outraged by all of this, you certainly should be.

On Thursday, February 18, 1999, the *Associated Press* reported that the Centers for Disease Control (C.D.C.) “wants 11 Western states with a high incidence of hepatitis A to require that children be vaccinated.” What do you suppose would be in those shots?

In addition to the human death and suffering from chemtrails, there is now increasing evidence of animals dying. The symptoms always appear to be fatal to animals. In Ash Fork, Arizona (about 50 miles west of Flagstaff), many local residents have lost livestock from the aerial spraying, including the death of 17 horses and numerous wildlife. A sticky cobweb-like substance was found on the backs of some of the animals. Also, a woman from Mt. Shasta, California states that the spraying has been going on there, and four of her five goats recently died. A vet came to see them and said he smelled “chemicals” on their breath, as though they had ingested a high level of some toxic chemical, though the environment in which these prize goats were lovingly cared for was free of anything which could have explained the tragedy. And on the day of the spraying (a few days before the goats died) she and her son were lying on the lawn looking up at the contrail patterns in the sky; by that night both mother and young son were very ill.

The nationwide Anthrax scare really seems to be the big threat these days. Air Force Major

Mike Albeg recently said about the Anthrax vaccinations given to airmen that the Anthrax vaccine “is as safe a vaccine as any other”. That's a scary thought, for those of you who are aware of the darker side of this subject.

On Sunday night, February 21, 1999, Fox-11 TV News in Los Angeles ran a very thorough report on the Anthrax scare and biological terrorism in general, showing men in suits that reminded one of the movie *Outbreak*, with Dustin Hoffman.

The reporter stated that “this may be the gravest danger facing us in the new millennium.” This is a danger you cannot see, hear, taste, or smell but which is incredibly deadly. Dr. Michael Nacht, Bio-Chemical Terrorism Expert, called Anthrax “a poor man's nuclear weapon”, so lethal is it. The report stated that, in the past three months in Los Angeles, there have been 30 Anthrax hoaxes! Are we being prepared for something big? If we are, will it come from Iraq or from Edwards Air Force Base—with Iraq getting the blame?

On Monday, February 22, 1999, on *Art Bell's* radio program, Art said: (quoting)

There continues now, on a daily basis in the U.S., to be Anthrax scares. Every single day there is a new Anthrax story, and I suppose they will eventually get so common that we won't hear about them anymore[?].

Robin writes [Art never allows the use of last names from those who call or write into his program], “I was talking to a friend in New York today and he said that 28th Street is closed down due to an Anthrax scare.” I have no way of confirming whether that was true or not. (End quoting)

Anyone aware of the “elite” World Controllers and who comprises their group should know about the Council on Foreign Relations (C.F.R.). The C.F.R. was set up at the conclusion of World War I by the same group of international bankers (Rothschilds, Rockefellers, Morgans, Warburgs, etc.—see my book *The Untold History of America*) who set up the Federal Reserve (a “private corporation”, *Lewis v. U.S.*, 680 F.2d 1240 [1982]) in 1913. The C.F.R. worked diligently behind the scenes to form the United Nations—the visible arm of the One World Government.

The C.F.R. publishes a bimonthly magazine called *Foreign Affairs* (P.O. Box 420235, Palm Coast, Florida 32142). This publication is very important reading, in that it often indicates general trends and directions we can expect to see the world going toward, maybe six months after they are written about in *Foreign Affairs*.

The March/April 1999 issue of *Foreign Affairs* has an article titled “It Could Happen Here,” which reviews a number of new books on chemical and biological weapons of mass destruction. One of the books, *America's Achilles' Heel: Nuclear, Biological and Chemical Terrorism and Covert Attack*, by Richard A. Falkenrath, et al. (Cambridge: MIT Press, 1998), is quoted from in the article: (quoting)

Chemical weapons suitable for mass-casualty attacks can be acquired by virtually any state.... Certain very deadly chemical warfare agents can quite literally be manufactured in a kitchen or basement in quantities sufficient for mass-casualty attacks.

Many states...could construct improvised but effective biological weapons.... Culturing the



required micro-organisms, or growing and purifying toxins, is inexpensive and could be accomplished by individuals with college-level training in biology and a basic knowledge of laboratory technique. Acquiring the seed stocks for pathogenic micro-organisms is also not particularly difficult. (End quoting)

This way you can have any group, like the C.I.A. or the K.G.B. or the MOSSAD, pull off an Anthrax attack and then blame it on some Timothy McVeigh, if he had a college level course in biology with laboratory skills thrown in. Funny thing though—you never read about the things that governments do to their own citizens, like the spraying of innocent Americans with all the nasty crap that is now making us sick and killing us. As for a big attack though, does “It could happen here” mean it WILL happen here?

Now here’s some really disturbing information (not to say that the preceding isn’t). On Monday night, February 8, 1999, over a dozen black helicopters flew into the center of Kingsville, Texas (pop. 25,276), a small city on Highway 77, about 50 miles southwest of Corpus Christi. Soldiers in full combat gear rappelled from the choppers to the ground and stormed the place.

The “urban terrain” infiltration exercise was carried out by the U.S. Army (those who sprayed us) Special Operations Command and

had the code name Operation Last Dance. Does that mean the next time it will be the real thing?

Two buildings in Kingsville were damaged during the maneuvers. An abandoned police station was destroyed by fire, and a commercial building had its roof damaged after two or more black helicopters attempted to land on it.

Mayor Phil Esquivel knew all about the operation (which was a scary, middle-of-the-night surprise to much of the general populace), but he said he “was sworn to secrecy for national security reasons. They asked us to keep it secret,” repeated Esquivel several times. “I respect national security.” (If it was the real thing, would the Mayor still be counted on to keep quiet?) The operation lasted several hours. One resident (who only gave the name Thelma) who lives outside of town said, “They flew right over us, and our house just trembled.” How about the nerves of those awakened from a sound sleep by the sounds of a veritable invasion force?!

On Sunday night, February 7, 1999, the residents of Grand Prairie, Texas (pop. 99,616), about 16 miles west of Dallas, had a similar experience with 15 black helicopters.

Here’s the real disturbing part of this story: (This part is not confirmed, and it may be difficult to confirm.) On the same day, Sunday, a female Texas Ranger pulled over a flatbed

semi-truck on Highway 72 in Clayton, Texas (pop. 450), about 57 miles southwest of Shreveport, Louisiana. The Ranger asked to see the truck driver’s manifest, and he complied. She read the manifest and said she thought the truck was over that particular highway’s weight limit. When she pulled back the tarp on the flatbed, she got the shock of her life. Stacked on the truck were dozens of signs emblazoned with the message ‘THIS AREA IS NOW UNDER MARTIAL LAW’. Were these signs on their way to your town for use in the near future?


Recently, the National Park Service rejected the plans of the U.S. Marines to conduct a military exercise in mid-March in the city of San Francisco at Presidio Park due to protests by local peace activists. But former California Governor and current Mayor of Oakland (just across the Bay from San Francisco) Jerry Brown agreed to allow the exercises to be conducted in his city. The military exercises, called “Operation Urban Warrior”, will begin on March 15th and last four days, and will involve the deployment of of Hovercraft and Harrier jets, as well as Cobra and Huey helicopters. Humvees and armored personnel carriers will be used on the ground, and the troops will be firing blanks from their guns.

Did you hear about any of this activity on C.N.N., A.B.C., C.B.S., or how about N.B.C.? No? What are we being prepared for? What

are the implications of all of the above? Are there any patterns that emerge that would cause us to pay close attention to things unfolding around us?

If enough people get sick and die from the spraying of deadly substances, or if we had some kind of chemical or biological attack, would the government institute Martial Law and bring out the soldiers WITH GAS MASKS ON? It might be a good idea to go and rent the movie *Outbreak* once again. It’s a very disturbing movie, but there may be important parallels!

Let’s see—plagues, pestilence, disease and death—don’t these things fit into Biblical prophecy? The “elite” Controllers are doing everything they can to make sure of that! Remember—you came here to experience this, or change it. Which will you do? We can create a better way.

### **FEBRUARY 1999 ROBERT HOUCHINS**

Royal Raymond Rife was a brilliant scientist born in 1888 and who died in 1971.

After studying at Johns Hopkins University, Rife developed technology commonly used today in optics, analytical chemistry, radio chemistry, electronics, biochemistry, ballistics and aviation. It could be said that Rife practically developed electromedicine himself. He received 14 awards plus an honorary doctorate from the University of Heidelberg for his work. In the 66 years that Rife spent designing and building medical instruments, Rife worked for Zeis Optics, the U.S. Government and private benefactors such as millionaire Henry Timken.

Because Rife was self-educated in many fields, he acquired the habit of looking beyond tradition and dogma for his answers. He mastered so many disciplines that his mind contained the skills and knowledge of an entire team of scientists and technicians of different persuasions. Where technology did not exist to perform a new task, Rife simply invented and built it himself.

Scientist Royal Raymond Rife discovered that the unique electronic "signature" of each specific disease can be modified to eliminate nearly every affliction known to man—rapidly and harmlessly. The distinguished medical doctors who originally confirmed part or all of this discovery included E.C. Rosenow, Sr. (Chief of Bacteriology, 32 yrs., at Mayo Clinic),

Frederic Koch (Detroit, Brazil), Gaston Naessens (Quebec), Sakae Inoue (Japan), George Mazet France), Franz Gerlach (Germany), Niello Mori and Clara Fonti (Italy), Cameron Gruner (McGill Univ.), T.J. Glover (Canada), Florence Seibert (V.A. Research Lab, Bay Pines, Fla.), Irene Diller (Inst. of Cancer Research, Phila., Penn.), Eleanor Alex Jackson and Virginia Livingston (NJ and San Diego clinics).

The University of Southern California sponsored a Special Medical Research team years ago, to evaluate this electronic therapy on the terminally ill. An initial success rate of 87.5 percent was recorded. After some improvements were made on the treatments, every patient, all 16 in the study, had recovered without side effects of any kind after 130 days. The medical team which evaluated the therapy for the University of Southern California included: Rufus Klein-Schmidt (President, Univ. of Southern California), Milbank Johnson (then President of the Southern Calif. AMA), Arthur Kendall (Director, Northwestern Medical School), Edward Kopps (Metabolic Clinic, La Jolla), George Fischer (Children's Hospital, NY), Karl Meyer (Hooper Foundation, San Francisco), Whalen Morrison (Chief Surgeon, Santa Fe Railway), and George Dock.

The gifted scientist Royal Raymond Rife truly had discovered the cure for deadly disease. His treatments were based upon a mechanical application of frequency to the body. Other medical treatments were either biological or chemical in nature and depended on the body's own immune system to heal the sick. In reality a sick person has a very poor immune system or one that is temporarily losing the battle. Rife's discoveries took the burden of healing off the body and left only the task of removing the dead [byproducts of] disease from the system. Rife's work was so astonishing that he was awarded many government contracts to develop practical uses for his discoveries of specific frequency [for specific diseases].

Rife discovered that any disease can be eliminated with frequencies based on its individual electromagnetic signature. One of his projects was to eliminate the diseases that were plaguing the poultry industry. He treated an entire flock of chickens and made them disease-

free. One government contract requested that he destroy the bacteria in fossil fuels so that our national reserve of gas and oil would not spoil and could be stored indefinitely without being replaced every few months. Think of the money that would be saved by the American public. Alas, Richard Nixon announced that his friends in the oil industry would never have to worry about Rife hurting their business and had his inventions destroyed.

Where technology didn't exist, Rife invented it—the first microdissectors, micromanipulators and heterodyning ultraviolet microscopes. He won 14 government awards for scientific discoveries and an honorary medical degree from the University of Heidelberg. Millionaires like Henry Timken (owner of Timken Bearings) financed Rife's work, such as the Universal Microscope, with 5,682 parts. With this superb microscope, Royal Raymond Rife became the first human being to actually see a living virus in its natural color. After nearly 20,000 unsuccessful attempts, Rife finally isolated and identified the human cancer virus, and named it "Cryptocides Primordiales". Rife inoculated 400 lab animals with this virus, created 400 tumors, and then eliminated them. He did the same with many other diseases.

The discoveries of Rife were presented to the Smithsonian Institution in Washington and the Franklin Institute in Philadelphia along with the instruments used. This is all chronicled in *The Cancer Cure That Worked*, a book written by Barry Lynes in 1987.

How did Rife's instruments eliminate so many different afflictions? For decades, Rife painstakingly identified the precise energetic signature unique to each disease, using spectroscopic microscopes. By exposing disease organisms to destructive resonance derived from their own unique pattern of oscillation, Rife discovered he could destroy them by the millions, in seconds.

Every biochemical compound oscillates at its own distinct frequency pattern. Therefore, every living thing has its own unique electromagnetic signature, and this pattern is unlike any other species or organism.

After decades of research, Rife isolated the patterns, modified them and used them to kill the microbes that produced them. Just as the resonant frequency which shatters a wine glass can only shatter that type of glass, so Rife's frequencies destroy only disease organisms with the exact same pattern of oscillation. If history is any indication, the drug industry will stop at nothing to eliminate any threat

to its profits. It will use every ounce of its political muscle to restrict sale of Rife instruments before customers find them far more effective than drugs.

Why would the medical industry destroy a cure for disease? The cartel was alarmed that their customers might abandon drugs for a far more effective cure that costs only pennies in electricity to use. This would eliminate profits of nearly a billion dollars a week for the drug industry. How long do you think it would ignore such a threat? The answer is, not long. After a preliminary "offer you can't refuse" made by Morris Fishbein (the President of the American Medical Association), to buy the miraculous discoveries of Rife, Rife refused to sell out and tried to bring his electronic cures to the people.

This is what happened to Rife and his astonishing electronic therapy:

First, arsonists burned the Burnett Lab in New Jersey, which was validating Rife's work. Then, someone fatally poisoned Dr. Milbank Johnson, president of the Southern California American Medical Association. He died hours before a press conference where he was to announce to the world that Rife's electronic therapy had cured every patient (16 out of 16) in that medical study supervised by the University of Southern California. (First thought to be accidental death, the poison was discovered years later by federal investigators when Dr. Johnson's body was exhumed.) Dr. Nemens, who had duplicated some of Rife's work just 40 miles from Rife's lab, was killed in a mysterious fire which destroyed his lab. Rife himself was finally killed at Grossmont Hospital by an "accidental" lethal dose of Valium.

Following Dr. Milbank Johnson's murder, threats, and a string of other incidents, doctors who had actually been photographed with Rife denied they ever met him. Dr. Isaac Kendall, Rife's chief research associate and Dean of Northwestern Medical School, disappeared for

years after receiving \$200,000 in "grants".

Why would hospital administrators be interested in anything that costs pennies to use, and keeps people out of the hospital? Remember—conventional therapy keeps a patient in bed at \$600 a day (for the bed). And hospitals can bill a cancer patient \$200,000 if he has insurance. Then how about research foundations or teaching institutions? Wrong. Who wants a cure that eliminates hundreds of millions of dollars in grants alone with the diseases it eliminates? Even the billion-dollar insurance industry could be eliminated by a cure for most illness.

First, understand that the drug industry supports the medical journals almost entirely with its advertising. It kept Rife's electronic therapy out of the journals merely by threatening to pull its ads from anyone publishing it.

Meanwhile, the regular news media "naively" assumes that if anyone had such a versatile cure, the proper authorities would tell them. But health care is just too profitable. Those whose livelihood depends on treating disease are often quick to mislead those who ask about anything that might replace their services. Even using beneficial herbs or vitamins is often branded quackery.

If you discovered a cheap and harmless method of eliminating nearly every incurable disease, what would you expect? Medicine's highest awards? It's more likely that your discovery will be received as heresy, for challenging orthodox views and authority. Pasteur, for example, was ridiculed and reviled, until medicine finally accepted his germ theory of disease. And before him, Semmelweis was hounded to death merely for claiming that 19th century surgeons might be killing patients by operating with dirty hands. Other visionaries who were discredited and roasted over a pit in a "medical Inquisition" were Roentgen for discovering X-rays, Morton for ether anesthesia,

and Harvey for claiming that blood circulates! And now that health care is the nation's largest industry, anything that eliminates all illness will be highly unpopular with a lot of folks whose services become unnecessary.

The following are just a few of the distinguished medical doctors harassed and persecuted in recent years for discoveries that threatened the health care industry—Doctors Revici, Burzynski, Livingston, Ivy, Burton, W.F. Koch, Coley, Glover, Lincoln, Priore and Naessens, a scientist. There is a tragic story behind each of these names: Dr. Koch was killed by arsenic injected in his toothpaste. Perhaps now you understand that any true cure for cancer, diabetes, arthritis, and other diseases must always be suppressed for the status quo to continue. profitable for others.

Royal Raymond Rife died in the 1970s, a broken man. All record of his work has been erased from the archives of the newspapers and the scientific community.

This electronic technology was buried for years, recently resurrected, and is once again available. But if such an electronic device exists, then where is it? And why hasn't your doctor told you? 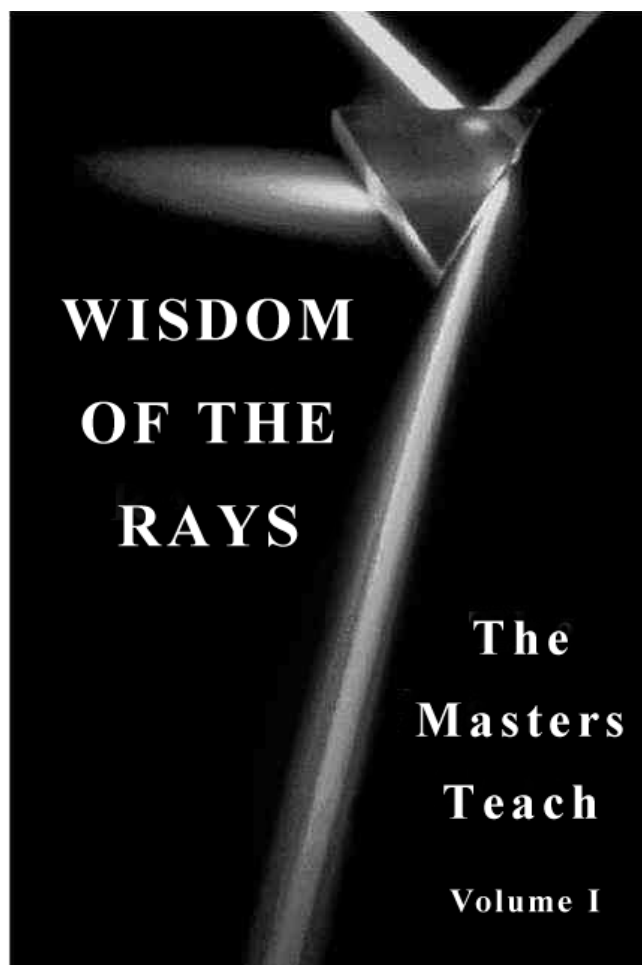

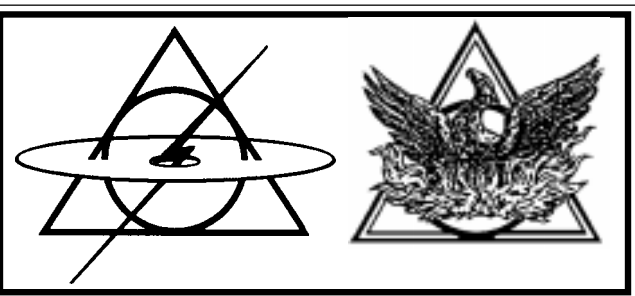
