

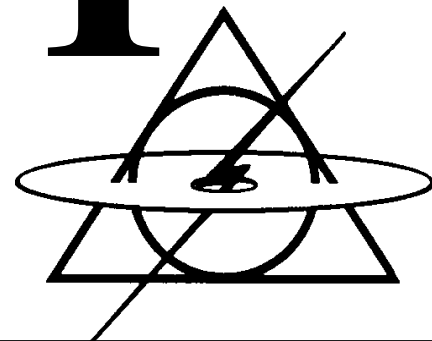

special emphasis: man has to work and produce in order to support his life. He has to support his life by his own effort and by the guidance of his own mind. If he cannot dispose of the product of his effort, he cannot dispose of his effort; if he cannot dispose of his effort, he cannot dispose of his life. Without property rights, no other rights can be practiced.

Now, bearing these facts in mind, consider the question of what social system is appropriate to man.

A social system is a set of moral-political-economic principles embodied in a society's laws, institutions, and government, which determine the relationships, the terms of association, among the men living in a given geographical area. It is obvious that these terms and relationships depend on an identification of man's nature, that they would be different if they pertain to a society of rational beings or to a colony of ants. It is obvious that they will be radically different if men deal with one another as free, independent individuals, on the premise that every man is an end in himself—or as members of a pack, each regarding the others as the means to his ends and to the ends of "the pack as a whole".

There are only two fundamental questions (or two aspects of the same question) that determine the nature of any social system: Does a social system recognize individual rights?—and: does a social system ban physical force from human relationships? The answer to the second question is the practical implementation of the answer to the first.

Is man a sovereign individual who owns his person, his mind, his life, his work and its products—or is he the property of the tribe (the state, the society, the collective) that may dispose of him in any way it pleases, that may dictate his convictions, prescribe the course of his life, control his work and expropriate his products? Does man have the *right* to exist for his own sake—or is he born in bondage, as an indentured servant, who must keep buying his life by serving the tribe but can never acquire it free and clear?

This is the first question to answer. The rest is consequences and practical implementations. The basic issue is only: Is man free?

In mankind's history, Capitalism is the only system that answers: Yes.

**CAPITALISM IS A SOCIAL SYSTEM BASED ON THE RECOGNITION OF INDIVIDUAL RIGHTS, INCLUDING PROPERTY RIGHTS, IN WHICH ALL PROPERTY IS PRIVATELY OWNED.**

The recognition of individual rights entails the banishment of physical force from human relationships: basically, rights can be violated only by means of force. In a Capitalist society, no man or group may initiate the use of physical force against others. The only function of the government, in such a society, is the task OF PROTECTING MAN'S RIGHTS, i.e., the task of protecting him from physical force; the government acts as the agent of man's right of self-defense, and may use force only in retaliation and only against those who initiate its use; thus the government is the means of placing the retaliatory use of force under *objective control*.

**[H: To you citizens who base your lives, YOUR THOUGHT, on the Constitution—which expresses these same RIGHTS and RESPONSIBILITIES: You have indeed spiraled a long way downward, and it happened so insidiously and in steps whereat you asked for more and more control and force to be directed toward YOU in order to have protection. It is a most vicious circle.]**

It is the basic, metaphysical fact of man's nature—the connection between his survival and his use of reason—that Capitalism recognizes and protects.

In a Capitalist society, all human relationships are voluntary. Men are free to cooperate or not, to deal with one another or not, as their own individual judgments, convictions, and interests dictate. They can deal with one another only in terms of and by means of reason, i.e., by means of discussion, persuasion, and *contractual* agreement, by voluntary choice to mutual benefit. The right to agree with others is not a problem in any society; it is *the right to disagree*—that is crucial. It is the institution of private property that protects and implements the right to disagree—and thus keeps the road open to man's most valuable attribute (valuable personally, socially, and *objectively*): the creative mind.

This is the cardinal difference between Capitalism and Collectivism.

The power that determines the establishment, the changes, the evolution, and the destruction of social systems is philosophy. The role of chance, accident, or tradition, in this context, is the same as their role in the life of an individual; their power stands in inverse ratio to the power of a culture's (or an individual's) philosophical equipment, and grows as philosophy collapses. It is, therefore, by reference to philosophy that the character of a social system has to be defined and evaluated. Corresponding to the four branches of philosophy, the four keystones of Capitalism are: metaphysically, the requirements of man's nature and survival—epistemologically, reason—ethically, individual rights—politically, freedom.

This, in substance, is the basis of the proper approach to political economy and to an understanding of Capitalism—not the tribal premise inherited from prehistorical traditions.

The "practical" justification of Capitalism does not lie in the Collectivist claim that it effects "the best allocation of national resources". Man is not a "national resource" and neither is his mind—and without the creative power of man's intelligence, raw materials remain just so many useless raw materials.

The moral justification of Capitalism does not lay in the altruist claim that it represents the best way to achieve "the common good". It is true that Capitalism does—if that catch-phrase has any meaning—but this is merely a secondary consequence. The moral justification of Capitalism lays in the fact that it is the only system consonant with man's rational nature, that it protects man's survival *qua-man*, {I do not recognize this phrase}(characteristic "qua" of-"man")and that its ruling principal is: *justice*.

Every social system is based, explicitly or implicitly, on some theory of ethics. The tribal notion of "the common good" has served as the moral justification of most social systems—and of all tyrannies—in history. The degree of a society's enslavement or freedom corresponded to the degree to which that tribal slogan was invoked or ignored.

"The common good" (or "the public interest") is an undefined and undefinable concept; there is no such entity as "the tribe" or "the public"; the tribe (or the public or society) is only a number of individual men. Nothing can be good for the tribe as such; "good" and "value" pertain ONLY to a living organism—to an individual living organism—not to a disembodied aggregate of relationships.

"The common good" is a meaningless concept, unless

taken literally, in which case its only possible meaning is: the sum of the good of all the individual men involved. But in that case, the concept is meaningless as a moral criterion; it leaves open the question of what is the good of individual men and how does one determine it?

It is not, however, in its literal meaning that that concept is generally used. It is accepted precisely for its elastic, undefinable, mystical character, which serves, not as a moral guide, but as an escape from morality. Since the good is not applicable to the disembodied, it becomes a moral blank check for those who attempt to embody it.

When "the common good" of a society is regarded as something apart from and superior to the individual good of its members, it means that the good of some men takes precedence over the good of others, with those others consigned to the status of sacrificial animals. It is tacitly assumed, in such cases, that "the common good" means "the good of the *majority*" as against the minority or the individual. Observe the significant fact that that assumption is tacit: even the most collectivized mentalities seem to sense the impossibility of justifying it morally. But "the good of the majority", too, is only a pretense and a delusion, since, in fact, the violation of an individual's rights means the abrogation of all rights; it delivers the helpless majority into the power of any gang that proclaims itself to be "the voice of society" and proceeds to rule by means of physical force, until deposed by another gang employing the same means.

If one begins by defining the good of individual men, one will accept as proper only a society in which that good is achieved and *achievable*. But if one begins by accepting "the common good" as an axiom and regarding individual good as its possible but not necessary consequence (not necessary in any particular case), one ends up with such a gruesome absurdity as Soviet Russia, a country professedly dedicated to "the common good", where, with the exception of a minuscule clique of rulers, the entire population has existed in subhuman misery for over two generations.

What makes the victims and, worse, the observers accept this and other similar historical atrocities, and still cling to the myth of "the common good"? The answer lies in philosophy—in philosophical theories on the nature of moral values.

There are, in essence, three schools of thought on the nature of the good: the intrinsic, the subjective, and the objective. The *intrinsic* theory holds that the good is inherent in certain things or actions as such, regardless of their context and consequences, regardless of any benefit or injury they may cause to the actors and subjects involved. It is a theory that divorces the concept of "good" from beneficiaries, and the concept of "value" from value and purpose—claiming that the good is good in, by, and of itself.

The *subjectivist* theory holds that the good bears no relation to the facts of reality, that it is the product of a man's consciousness, created by his feelings, desires, "intuitions", or whims and that it is merely an "arbitrary postulate", or an "emotional commitment".

The *intrinsic* theory holds that the good resides in some sort of reality, independent of man's consciousness; the *subjectivist* theory holds that the good resides in man's consciousness, independent of reality.

The *objective* theory holds that the good is neither an attribute of "things in themselves" nor of man's emotional states, but an evaluation of the facts of reality by man's consciousness according to a rational standard of value. (Rational, in this context, means: derived from

the facts of reality and validated by a process of reason.) The *objective* theory holds that *the good is an aspect of reality in relation to man*—and that it must be discovered, not invented, by man. Fundamental to an *objective* theory of values is the question: Of value to whom and for what? An *objective* theory does not permit context-dropping or “concept-stealing”; it does not permit the separation of “value” from “purpose”, of the good from beneficiaries, and of man’s actions from reason.

Of all the social systems in mankind’s history, *Capitalism is the only system based on an objective theory of values.*

The *intrinsic* theory and the *subjectivist* theory (or a mixture of both) are the necessary base of every dictatorship, tyranny, or variant of the absolute state. Whether they are held consciously or subconsciously—in the explicit form of a philosopher’s treatise or in the implicit chaos of its echoes in an average man’s feelings—these theories make it possible for a man to believe that the good is independent of man’s mind and can be achieved by physical force.

If a man believes that the good is intrinsic in certain actions, he will not hesitate to force others to perform them. If he believes that the human benefit or injury caused by such actions is of no significance, he will regard a sea of blood as of no significance. If he believes that the beneficiaries of such actions are irrelevant (or interchangeable), he will regard wholesale slaughter as his moral duty in the service of a “higher” good. It is the *intrinsic* theory of values that produces a Robespierre, a Lenin, a Stalin, or a Hitler. It is not an accident that Eichmann was a Kantian.

If a man believes that the good is a matter of arbitrary subjective choice, the issue of good or evil becomes, for him, an issue of: MY feelings or THEIRS? [Ed: Then There is] No bridge, understanding, or communication among men, and an objectively perceivable reality is their only common frame of reference; when these are invalidated (i.e., held to be irrelevant) in the field of morality, force becomes men’s only way of dealing with one another. If the subjectivist wants to pursue some social ideal of his own, he feels morally entitled to force men “for their own good”, since he *feels* that he is right and that there is nothing to oppose him but their misguided feelings.

Thus, in practice, the proponents of the *intrinsic* and the *subjectivist* schools meet and blend. (They blend in terms of their psycho-epistemology as well: by what means do the moralists of the *intrinsic* school discover their transcendental “good”, if not by means of special, non-rational intuitions and revelations, i.e., by means of their feelings?) It is doubtful whether anyone can hold either of these theories as an actual, if mistaken, conviction. But both serve as a rationalization of power-lust and of rule by brute force, unleashing the potential dictator and disarming his victims.

**The objective theory of values is the only moral theory incompatible with rule by force. Capitalism is the only system based implicitly on an objective theory of values—and the historic tragedy is that this has never been made explicit.**

If one knows that the good is *objective*—i.e., determined by the nature of reality, but to be discovered by man’s mind—one knows that an attempt to achieve the good by physical force is a monstrous contradiction which negates morality at its root by destroying man’s capacity to recognize the good, i.e., his capacity to value.

Force invalidates and paralyzes a man’s judgment, demanding that he act against it, thus rendering him morally impotent. A value which one is forced to accept at the price of surrendering one’s mind, is not a value to anyone; the forcibly mindless can neither judge nor choose nor value. An attempt to achieve the good by force is like an attempt to provide a man with a picture gallery at the price of cutting out his eyes. Values cannot exist (cannot be valued) outside the full context of a man’s life, needs, goals, and *knowledge*.

The *objective* view of values permeates the entire structure of a Capitalist society.

The recognition of individual rights implies the recognition of the fact that the good is not an ineffable abstraction in some supernatural dimension, but a value pertaining to reality, to this earth, to the lives of individual human beings (note the right to the pursuit of happiness). It implies that the good cannot be divorced from beneficiaries, that men are not to be regarded as interchangeable, and that no man or tribe may attempt to achieve the good of some at the price of the immolation of others.

The free market represents the *social* application of an *objective* theory of values. Since values are to be discovered by man’s mind, men must be free to discover them—to think, to study, to translate their knowledge into physical form, to offer their products for trade, to judge them, and to choose, be it material goods or ideas, a loaf of bread or a philosophical treatise. Since values are established contextually, every man must judge for himself, in the context of his own knowledge, goals, and interests. Since values are determined by the nature of reality, it is reality that serves as men’s ultimate arbiter; if a man’s judgment is right, the rewards are his; if it is wrong, he is his only victim.

It is in regard to a free market that the distinction between *intrinsic*, *subjective*, and *objective* views of values is particularly important to understand. The market value of a product is not an intrinsic value, not a “value in itself” hanging in a vacuum. A free market never loses sight of the question: Of value to whom? And, within the broad field of objectivity, the market value of a product does not reflect its *philosophically objective* value, but only its socially objective value.

By “philosophically objective”, I mean a value estimated from the standpoint of the best possible to man, i.e., by the criterion of the most rational mind possessing the greatest knowledge, in a given category, in a given period, and in a defined context (nothing can be estimated in an undefined context). For instance, it can be rationally proved that the airplane is *objectively* of immeasurably greater value to man (to *man at his best*) than the bicycle—and that the works of Victor Hugo are *objectively* of immeasurably greater value than true-confession magazines. But if a given man’s intellectual potential can barely manage to enjoy true confessions, there is no reason why his meager earnings, the product of his effort, should be spent on books he cannot read—or on subsidizing the airplane industry, if his own transportation needs do not extend beyond the range of a bicycle. (Nor is there any reason why the rest of mankind should be held down to the level of his literary taste, his engineering capacity and his income. Values are not determined by fiat nor by majority vote.)

Just as the number of its adherents is not a proof of an idea’s truth or falsehood, of an art work’s merit or demerit, of a product’s efficacy or inefficacy—so the free-market value of goods or services does not

necessarily represent their philosophically objective value, but only their *socially objective* value, i.e., the sum of the individual judgments of all the men involved in trade at a given time, the sum of what they valued, each in the context of his own life.

Thus, a manufacturer of lipstick may well make a greater fortune than a manufacturer of microscopes—even though it can be rationally demonstrated that microscopes are scientifically more valuable than lipstick. But—valuable *to whom*?

A microscope is of no value to a little stenographer struggling to make a living; a lipstick is; a lipstick, to her, may mean the difference between self-confidence and self-doubt, between glamour and drudgery.

This does not mean, however, that the values ruling a free market are *subjective*. If the stenographer spends all her money on cosmetics and has none left to pay for the use of a microscope (for a visit to the doctor) *when she needs it*, she learns a better method of budgeting her income; the free market serves as her teacher; she has no way to penalize others for her mistakes. If she budgets rationally, the microscope is always available to serve her own specific needs and no more, as far as she is concerned she is not taxed to support an entire hospital, a research laboratory, or a space ship’s journey to the Moon. Within her own productive power, she does pay a part of the cost of scientific achievements, *when and as she needs them*. She has no “social duty”; her own life is her only responsibility—and the only thing that a Capitalist system requires of her is the thing that nature requires: rationality, i.e., that she live and act to the best of her own judgment.

Within every category of goods and services offered on a free market, it is the purveyor of the best product at the cheapest price who wins the greatest financial rewards *in that field*—not automatically nor immediately nor by fiat, but by virtue of the free market, which teaches every participant to look for the *objective* best within the category of his own competence, and penalizes those who act on irrational considerations.

I would like to take up the “free market” at the next session, please, for we have other duties to attend.

I would remind all of you, however, that as you sort the wheat from the chaff, even about such things as “income tax” and forms, etc., look at the preamble of your *Constitution of the United States of America*. Then read your *Constitution* and see what has gone wrong. There was a built-in system for taking care of the needs of government FOR THE PEOPLE, OF THE PEOPLE AND BY THE PEOPLE. ## WHAT IS CAPITALISM?

Now observe that a free market does not level men down to some common denominator—that the intellectual criteria of the majority do not rule a free market or a free society—and that the exceptional men, the innovators, the intellectual giants, are not held down by the majority. In fact, it is the members of this exceptional minority who lift the whole of a free society to the level of their own achievements, while rising further and ever further.

A free market is a continuous process that cannot be held still, an upward process that demands the best (the most rational) of every man and rewards him accordingly. While the majority have barely assimilated the value of the automobile, the creative minority introduces the airplane. The majority learns by demonstration, the minority is free to demonstrate. The "philosophically objective" value of a new product serves as the teacher for those who are willing to exercise their rational faculty, each to the extent of his ability. Those who are unwilling remain unrewarded—as well as those who aspire to more than their ability produces. The stagnant, the irrational, the subjectivist have no power to stop their betters.

(The small minority of adults who are unable rather than unwilling to work, have to rely on voluntary charity;

misfortune is not a claim to slave labor; there is no such thing as the RIGHT TO CONSUME, CONTROL, AND DESTROY THOSE WITHOUT WHOM ONE WOULD BE UNABLE TO SURVIVE. [H: ANYBODY LISTENING?]) As to depressions and mass unemployment, they are not caused by the free market, but by government interference into the economy.)

The mental parasites—the imitators who attempt to cater to what they think is the public's known taste—are constantly being beaten by the innovators whose products raise the public's knowledge and taste to ever-higher levels. It is in this sense that the free market is ruled, not by the consumers, but by the producers. The most successful ones are those who discover new fields of production, fields which had not been known to exist.

A given product may not be appreciated at once, particularly if it is too radical an innovation; but, barring irrelevant accidents, it wins in the long run. It is in this sense that the free market is not ruled by the intellectual criteria of the majority, which prevail only at and for any given moment; the free market is ruled by those who are able to see and plan long-range—and the better the mind, the longer the range.

The economic value of a man's work is determined, in a free market, by a single principle: by the voluntary consent of those who are willing to trade him their work or products in return. This is the moral meaning of the law of supply and demand; it represents the total rejection of two vicious doctrines: the tribal premise and altruism. It represents the servant of the tribe, that a man works in order to support his own life—as, by his nature, he must—that he has to be guided by his own rational self-interest, and if he wants to trade with others, he cannot expect sacrificial victims, i.e., he cannot expect to receive values without trading commensurate values in return. The sole criterion of what is commensurate, in this context, is the free, voluntary, uncoerced judgment of the traders.

The tribal mentalities attack this principle from two seemingly opposite sides: they claim that the free market is "unfair" both to the genius and to the average man. The first objection is usually expressed by a question such as: "Why should Elvis Presley make more money than Einstein?" The answer is: BECAUSE MEN WORK IN ORDER TO SUPPORT AND ENJOY THEIR OWN LIVES—AND IF MANY MEN FIND VALUE IN ELVIS PRESLEY, THEY ARE ENTITLED TO SPEND THEIR MONEY ON THEIR OWN PLEASURE. PRESLEY'S FORTUNE IS NOT TAKEN FROM THOSE WHO DO NOT CARE FOR HIS WORK (I am one of them) NOR FROM EINSTEIN—nor does he stand in Einstein's way—nor does Einstein lack proper recognition and support in a free society, on an appropriate intellectual level.

As the second objection, the claim that a man of average ability suffers an "unfair" disadvantage on a free market...

Look past the range of the moment, you who cry that you fear to compete with men of superior intelligence, that their mind is a threat to your livelihood, that the strong leave no chance to the weak in a market of voluntary trade. When you live in a rational society, where men are free to trade, you receive an incalculable bonus: the material value of your work is determined not only by your effort, but by the effort of the best productive minds who exist in the world around you.

The machine, the frozen form of a living intelligence, is the power that expands the potential of your life by raising the productivity of your time. Every man is free to rise as far as he's able or willing, but it's

only the degree to which he *thinks* that determines the degree to which he'll rise. Physical labor as such can extend no further than the range of the moment. The man who does no more than physical labor, consumes the material value-equivalent of his own contribution to the process of production, and leaves no further value, neither for himself nor others. But the man who produces an idea in any field of rational endeavor—the man who discovers new knowledge—is the permanent benefactor of humanity...It is only the value of an idea that can be shared with unlimited numbers of men, making all sharers richer at no one's sacrifice or loss, raising the productive capacity of whatever labor they perform.

In proportion to the mental energy he spent, the man who creates a new invention receives but a small percentage of his value in terms of material payment, no matter what fortune he makes, no matter what millions he earns. But the man who works as a janitor in the factory producing that invention, receives an enormous payment in proportion to the mental effort that his job requires of him. And the same is true of all men between, on all levels of ambition and ability. The man at the top of the intellectual pyramid contributes the most to all those below him, but gets nothing except his material payment, receiving no intellectual bonus from others to add to the value of his time. The man at the bottom who, left to himself, would starve in his hopeless ineptitude, contributes nothing to those above him, but receives the bonus of all of their brains. Such is the nature of the "competition" between the strong and the weak of the intellect. Such is the pattern of "exploitation" for which you have damned the strong.—(from *Atlas Shrugged*)

**[H: This is exactly that which has taken place with the *Spectrum* "group", taking (thieving) everything from the ones who established EVERYTHING they (*Spectrum* group as a whole and as individuals) have—and now claim it as their own, while destroying the very ones who gave the ideas and actually produced the products, whatever those might be—from actual funding, paying for service, the VERY ONES WHO NOW EMBEZZLE THOUGHT PRODUCTION AND FUNDS, and now claim persecution because the ones damaged said, "No, too much!" He has had opportunity to give you honest reasons for his actions—and thus far he has not yet told anything resembling TRUTH or REASON. Others got caught in his facade presentation by their own ego-chains.**

**Rick gave a long dissertation on not tampering with anything in the writings—while deleting the**

**most important one single paragraph in the reproduced letter making his point. But some of you, especially in that group—continue to pound us over their indiscretions, so we ask you, "What is the matter with you?" There is NOTHING the matter with us! Do YOU really have time to waste on rubbish? No, good people, YOU DO NOT!]**

And such is the relationship of Capitalism to man's mind and to man's survival.

The magnificent progress achieved by Capitalism in a brief span of time—the spectacular improvement in the conditions of man's existence on earth—is a matter of historical record. It is not to be hidden, evaded, or explained away by all the propaganda of Capitalism's enemies. But what needs special emphasis is the fact that this progress was achieved by non-sacrificial means.

Progress cannot be achieved by forced privations, by squeezing a "social surplus" out of starving victims. Progress can come only out of individual surplus, i.e., from the work, the energy, the creative over-abundance of those men whose ability produces more than their personal consumption requires, those who are intellectually and financially able to seek the new, to improve on the known, to move forward. In a Capitalist society, where such men are free to function and to take their own risks, progress is not a matter of sacrificing to some distant future, it is part of the living present, it is the normal and natural, it is achieved as and while men live—and enjoy—their lives.

Now consider the alternative—the tribal society, where all men throw their efforts, values, ambitions, and goals into a tribal pool or common pot, then wait hungrily at its rim, while the leader of a clique of cooks stirs it with a bayonet in one hand and a blank check on all their lives in the other. The most consistent example of such a system is the Union of Soviet Socialist Republics.

Half a century ago, the Soviet rulers commanded their subjects to be patient, bear privations, and make sacrifices for the sake of "industrializing" the country, promising that this was only temporary, that industrialization would bring them abundance, and Soviet progress would surpass the Capitalistic West.

Today, Soviet Russia is still unable to feed her people—while the rulers scramble to copy, borrow, or steal the technological achievements of the West. Industrialization is not a static goal; it is a dynamic process with a rapid rate of obsolescence. So the wretched serfs of a planned tribal economy, who starved while waiting for electric generators and tractors, are now starving while waiting for atomic power and interplanetary travel. Thus, in a "people's state", the progress of science is a threat to the people, and every advance is taken out of the people's shrinking hides.

This was not the history of Capitalism.

America's abundance was not created by public sacrifices to "the common good", but by the productive genius of free men who pursued their own personal interests and the making of their own private fortunes. They did not starve the people to pay for America's industrialization. They gave the people better jobs, higher wages, and cheaper goods with every new machine they invented, with every scientific discovery or technological advance—and thus the whole country was moving forward and profiting, not suffering, every step of the way.

Do not, however, make the error of reversing cause and effect: the good of the country was made possible precisely by the fact that it was not forced on anyone as a moral goal or duty; it was merely an effect; the cause

was a man's right to pursue his own good. It is this right—not its consequences—that represents the moral justification of Capitalism.

But this right is incompatible with the intrinsic or the subjectivist theory of values, with the altruist morality and the tribal premise. It is obvious which human attribute one rejects when one rejects objectivity; and, in view of Capitalism's record, it is obvious against which human attribute the altruist morality and the tribal premise stand united: against man's mind, against intelligence—particularly against intelligence applied to the problems of human survival, i.e., productive ability.

While altruism seeks to rob intelligence of its rewards, by asserting that the moral duty of the competent is to serve the incompetent and sacrifice themselves to anyone's need—the tribal premise goes a step further: it denies the existence of intelligence and of its role in the production of wealth.

It is morally obscene to regard wealth as an anonymous, tribal product and to talk about "redistributing" it. The view that wealth is the result of some undifferentiated, collective process, that we all did something and it's impossible to tell who did what, therefore some sort of egalitarian "distribution" is necessary—might have been appropriate in a primordial jungle with a savage horde moving boulders by crude physical labor (though even there someone had to initiate and organize the moving). To hold that view in an industrial society—where individual achievements are a matter of public record—is so crass an evasion that even to give it the benefit of the doubt is an obscenity.

Anyone who has ever been an employer or an employee, or has observed men working, or has done an honest day's work himself, knows the crucial role of ability, of intelligence, of a focused, competent mind—in any and all lines of work, from the lowest to the highest. He knows that ability, or the lack of it (whether the lack is actual or volitional), makes a difference of life-or-death in any productive process. The evidence is so overwhelming—theoretically and practically, logically and "empirically", in the events of history and in anyone's own daily grind—that no one can claim ignorance of it. Mistakes of this size are not made innocently.

When great industrialists made fortunes in a free market (i.e., without the use of force, without government assistance or interference), they created new wealth—they did not take it from those who had not created it. If you doubt it, take a look at the "total social product"—and the standard of living—of those countries where such men are not permitted to exist.

Observe how seldom and how inadequately the issue of human intelligence is discussed in the writings of the tribal-statist-altruist theoreticians. Observe how carefully today's advocates of a mixed economy avoid and evade any mention of intelligence or ability in their approach to politico-economic issues, in their claims, demands, and pressure-group warfare over the looting of "the total social product".

It is often asked: Why was Capitalism destroyed in spite of its incomparably beneficent record? The answer lies in the fact that the lifeline feeding any social system is a culture's dominant philosophy and that Capitalism never had a philosophical base. It was the last and (theoretically) incomplete product of an Aristotelian influence. As a resurgent tide of mysticism engulfed philosophy in the Nineteenth Century, Capitalism was left in an intellectual vacuum, its lifeline cut. Neither its moral nature nor even its political principles had ever been

fully understood or defined. Its alleged defenders regarded it as compatible with government controls (i.e., government interference into the economy), ignoring the meaning and implications of the concept of *laissez-faire*. Thus, what existed in practice, in the Nineteenth Century, was not pure Capitalism, but variously mixed economies. Since controls necessitate and breed further controls, it was the statist element of the mixtures that wrecked them; it was the free, Capitalist element that took the blame.

Capitalism could not survive in a culture dominated by mysticism and altruism, by the soul-body dichotomy and the tribal premise. No social system (and no human institution or activity of any kind) can survive without a moral base. On the basis of the altruist morality, Capitalism had to be—and was—damned from the start.

For those who do not fully understand the role of philosophy in politico-economic issues, I offer—as the clearest example of today's intellectual state—some further quotations from the *Encyclopaedia Britannica's* article on Capitalism:

“Few observers are inclined to find fault with Capitalism as an engine of production. Criticism usually proceeds either from moral or cultural disapproval of certain features of the Capitalist system, or from the short-run vicissitudes (crises and depressions) with which long-run improvement is interspersed.”

The “crises and depression” were caused by government interference, not by the Capitalist system. But what was the nature of the “moral or cultural disapproval”? The article does not tell us explicitly, but gives one eloquent indication:

“Such as they were, however, both tendencies and realizations [**H: of Capitalism**] bear the unmistakable stamp of the businessman's interests and still more the businessman's type of mind. Moreover, it was not only policy but the philosophy of national and individual life, the scheme of cultural values, that bore that stamp. Its materialistic utilitarianism, its naive confidence in progress of a certain type, its actual achievements in the field of pure and applied science, the temper of its artistic creations, may all be traced to the spirit of rationalism that emanates from the businessman's office.”

The author of this article, who is not “naive” enough to believe in a Capitalistic (or rational) type of progress, holds, apparently, a different belief:

“At the end of the Middle Ages, Western Europe stood about where many underdeveloped countries stand in the 20<sup>th</sup> Century. [**H: This means that the culture of the Renaissance was about the equivalent of today's Congo; or else, it means that people's intellectual development has nothing to do with economics.**] In underdeveloped economies, the difficult task of statesmanship is to get under way a cumulative process of economic development, for once a certain momentum is attained, further advances appear to follow more or less automatically.”

Some such notion underlies every theory of a planned economy. It is on some such “sophisticated” belief that two generations of Russians have perished, waiting for automatic progress.

The classical economists attempted a tribal justification of Capitalism on the ground that it provides the best “allocation” of a community's “resources”. Here are their chickens coming home to roost:

“The market theory of resource allocation within the private sector is the central theme of classical economics. The criterion for allocation between the public and private sectors is formally the same as in any other resource allocation, namely that the community should receive equal

satisfaction from a marginal increment of resources used in the public and private spheres...Many economists have asserted that there is substantial, perhaps overwhelming, evidence that total welfare in Capitalist United States, for example, would be increased by a reallocation of resources to the public sector—more schoolrooms and fewer shopping centers, more public libraries and fewer automobiles, more hospitals and fewer bowling alleys.”

This means that some men must toil all their lives without adequate transportation (automobiles), without an adequate number of places to buy the goods they need (shopping centers), without the pleasures of relaxation (bowling alleys)—in order that other men may be provided with schools, libraries, and hospitals.

If you want to see the ultimate results and full meaning of the tribal view of wealth—the total obliteration of the distinction between private action and government action, between production and force, the total obliteration of the concept of “rights”, of an individual human being's reality, and its replacement by a view of men as interchangeable beasts of burden of “factors of production”—study the following:

**[H: KEEP IN MIND THAT THESE QUOTES ARE FROM THE MOST PRESTIGIOUS INFORMATION SOURCE IN THE WORLD: THE ENCYCLOPAEDIA BRITANNICA.]**

“Capitalism has a bias against the public sector for two reasons: First, all products and income accrue [**H: ?**] initially to the private sector while resources reach the public sector through the painful process of taxation. Public needs are met only by sufferance of consumers in their role as taxpayers [**H: What about producers?**], whose political representatives are acutely conscious of their constituents' tender feelings [**H: !**] about taxation. That people know better than governments what to do with their income is a notion more appealing than the contrary one, that people get more for their tax money than for other types of spending. [**H: By what theory of values? By whose judgment?**]

“Second, the pressure of private business to sell leads to the formidable array of devices of modern salesmanship which influence consumer choice and bias consumer values toward private consumption...[**H: This means that your desire to spend the money you earn rather than have it taken away from you, is a mere bias.**]...Hence, much private expenditure goes for wants that are not very urgent in any fundamental sense. [**H: Urgent—to whom? Which wants are “fundamental” beyond a cave, a bearskin, and a chunk of raw meat?**] The corollary is that many public needs are neglected because these superficial private wants, artificially generated, compete successfully for the same resources [**H: Whose resources?**].

“A comparison of resource allocation to the public and private sectors under Capitalism and under Socialist Collectivism is illuminating. [**H: It is.**] In a Collective economy, all resources operate in the public sector and are available for education, defense, health, welfare and other public needs without any transfer through taxation. Private consumption is restricted to the claims that are permitted [**H: by whom?**] against the social product, much as public services in a Capitalist economy are limited to the claims permitted against the private sector. In a Collective economy, public needs enjoy the same sort of built-in priority that private consumption enjoys in a Capitalist economy. In the Soviet Union teachers are plentiful, but automobiles are scarce, whereas the opposite condition prevails in the United States.”

Here is the conclusion of that article:

“Predictions concerning the survival of Capitalism are, in part, a matter of definition. One sees everywhere in Capitalist countries a shifting of economic activity from the private to the public sphere. At the same time the private [**H: after World War II**] consumption appeared destined to increase in Communist countries. [**H: Such as the consumption of wheat?**] The two economic systems seemed to be drawing closer together by changes converging from both directions. Yet significant differences in the economic structures still existed. It seemed reasonable to assume that the society which invested more in people would advance more rapidly and inherit the future. In this important respect Capitalism, in the eyes of some economists, labors under a fundamental but not inescapable disadvantage in competition with Collectivism.”

**[H: Please keep in mind another point in consideration of Encyclopaedia BRITANNICA—exactly THAT “Britain” is a SOCIALIST state.]**

The collectivization of soviet agriculture was achieved by means of a government-planned famine—planned and carried out deliberately to force peasants into collective farms; Soviet Russia's enemies claim that fifteen million peasants died in that famine; the Soviet government admits the death of seven million. [**H: OPEN YOUR EYES, NEIGHBORS—YOU ARE NEXT!**]

This is what the *Encyclopaedia BRITANNICA* refers to as “INVESTMENT IN PEOPLE”.

In a culture where such a statement is made with intellectual impunity and with an aura of moral righteousness, the guiltiest men are not the Collectivists; the guiltiest men are those who, lacking the courage to challenge mysticism or altruism, attempt to bypass the issues of reason and morality and to defend the only rational and moral system in mankind's history—Capitalism—on any grounds other than rational and moral. [END OF QUOTING]

It is certainly time to consider your next moves, chelas. Are you going to simply sit and quibble over your belly-buttons, or take responsibility as God allows you the GIFTS for your production and actual abundance and participation in a world not gone down in an Apocalypse of some humankind's making?

## GOLD AND ECONOMIC FREEDOM

by Alan Greenspan, July 1966

An almost hysterical antagonism toward the gold standard is one issue which unites statist of all persuasions. They seem to sense—perhaps more clearly and subtly than many consistent defenders of *laissez-faire*—that gold and economic freedom are inseparable, that the gold standard is an instrument of *laissez-faire* and that each implies and requires the other.

In order to understand the source of their antagonism, it is necessary first to understand the specific role of gold in a free society.

Money is the common denominator of all economic transactions. It is that commodity which serves as a medium of exchange, is universally acceptable to all participants in an exchange economy as payment for their goods or services, and can, therefore, be used as a standard of market value and as a store of value, i.e., as a means of saving.

The existence of such a commodity is a precondition of a division of labor economy. If men did not have some commodity of objective value, which was generally acceptable as money, they would have to resort to primitive barter, or be forced to live on self-sufficient farms and forgo the inestimable advantages of specialization. If men had no means to store value, i.e., to save, neither long-range planning nor exchange would be possible.

What medium of exchange will be acceptable to all participants in an economy is not determined arbitrarily. First, the medium of exchange should be durable. In a primitive society of meager wealth, wheat might be sufficiently durable to serve as a medium, since all exchanges would occur only during and immediately after the harvest, leaving no value-surplus to store. But where store-of-value considerations are important, as they are in richer, more civilized societies, the medium of exchange must be a durable commodity, usually a metal. A metal is generally chosen because it is homogeneous and divisible: every unit is the same as every other and it can be blended or formed in any quantity. Precious jewels, for example, are neither homogeneous nor divisible.

More importantly, the commodity chosen as a medium must be a luxury. Human desires for luxuries are unlimited and therefore, luxury goods are always in demand and will always be acceptable. Wheat is a luxury in underfed civilizations, but not in a prosperous society. Cigarettes ordinarily would not serve as money, but they did in post-World War II Europe where they were considered a luxury. The term “luxury good” implies scarcity and high unit value. Having a high unit value, such a good is easily portable; for instance, an ounce of gold is worth a half-ton of pig iron.

In the early stages of a developing money economy, several media of exchange might be used, since a wide variety of commodities would fulfill the foregoing conditions. However, one of the commodities will gradually displace all others, by being more widely acceptable. Preferences on what to hold as a store of value will shift to the most widely acceptable

How many of you recognize the name, Alan Greenspan? Of course you do. He HEADS the Federal Reserve and when he speaks—THE WORLD LISTENS. What does he think about banks, gold standards and things of great finance, as relative to freedom? It is hard to tell in this day of confusion, isn’t it?

Well, let me offer you a writing BY ALAN GREENSPAN published in *THE OBJECTIVIST* in July of 1966. This one man, if he would do so, could take that which we offer and immediately reverse the entire world concept of financial structure. And no, I do not project anything—I simply make a statement of fact. I am here to offer information as given by himself on some topics which make the difference in your world’s freedom or enslavement.

Since those days, the U.S. has gone through so many ugly changes and one of which tossed you into the sea of a foundationless means of trade VALUES. You have NOTHING on which to base currency, value or structure of economic stability. When Switzerland moved from the gold standard this year, you lost it globally, citizens. Can it be regained? Yes.

First, let us consider Mr. Greenspan’s article in point and then as we move on we can point out just how simple it could be to bring back hard-backing in the system right through that which we hold. Would it buy freedom? No—only a movement into a better way with equality, but it requires an undoing of every one of the protocols as offered in the manifesto for

commodity, which, in turn, will make it still more acceptable. The shift is progressive until that commodity becomes the sole medium of exchange. The use of a single medium is highly advantageous for the same reasons that a money economy is superior to a barter economy; it makes exchanges possible on an incalculably wider scale.

Whether the single medium is gold, silver, seashells, cattle or tobacco is optional, depending on the context and development of a given economy. In fact, all have been employed, at various times, as media of exchange. Even in the present century, two major commodities, gold and silver, have been used as international media of exchange, with gold becoming the predominant one. Gold, having both artistic and functional uses and being relatively scarce, has always been considered a luxury good. It is durable, portable, homogeneous, divisible, and, therefore, has significant advantages over all other media of exchange. Since the beginning of World War I, it has been virtually the sole international standard of exchange.

If all goods and services were to be paid for in gold, large payments would be difficult to execute, and this would tend to limit the extent of society's division of labor and specialization. Thus, a logical extension of the creation of a medium of exchange is the development of a banking system and credit instruments (bank notes and deposits) which act as a substitute for, but are convertible into, gold.

A free banking system based on gold is able to extend credit and thus to create bank notes (currency) and deposits, according to the production requirements of the economy. Individual owners of gold are induced, by payments of interest, to deposit their gold in a bank (against which they can draw checks). But since it is rarely the case that all depositors want to withdraw all their gold at the same time, the banker need keep only a fraction of his total deposits in gold as reserves. This enables the banker to loan out more than the amount of his gold deposits (which means that he holds claims to gold rather than gold as security for his deposits). But the amount of loans which he can afford to make is not arbitrary: he has to gauge it in relation to his reserves and to the status of his investments.

When banks loan money to finance productive and profitable endeavors, the loans are paid off rapidly and bank credit continues to be generally available. But when the business ventures financed by bank credit are less profitable and slow to pay off, bankers soon find that their loans outstanding are excessive relative to their gold reserves, and they begin to curtail new lending, usually by charging higher interest rates. This tends to restrict the financing of new ventures and requires the existing borrowers to improve their profitability before they can obtain credit for further expansion. Thus, under the gold standard, a free banking system stands as the protector of an economy's stability and balanced growth.

When gold is accepted as the medium of exchange by most or all nations, an unhampered free international gold standard serves to foster a worldwide division of labor and the broadest international trade. Even though the units of exchange (the dollar, the pound, the franc, etc.) differ from country to country, when all are defined in terms of gold the economies of the different countries act as one—so long as there are no restraints on trade or on the movement of capital. Credit, interest

rates, and prices tend to follow similar patterns in all countries. For example, if banks in one country extend credit too liberally, interest rates in that country will tend to fall, inducing depositors to shift their gold to higher-interest paying banks in other countries. This will immediately cause a shortage of bank reserves in the "easy money" country, inducing tighter credit standards and a return to competitively higher interest rates again.

A fully free banking system and fully consistent gold standard have not yet been achieved. But prior to World War I, the banking system in the United States (and in most of the world) was based on gold, and even though governments intervened occasionally, banking was more free than controlled. Periodically, as a result of overly rapid credit expansion, banks became loaned up to the limit of their gold reserves, interest rates rose sharply, new credit was cut off, and the economy went into a sharp, but short-lived recession. (Compared with the depressions of 1920 and 1932, the pre-World War I business declines were mild indeed.) It was limited gold reserves that stopped the unbalanced expansions of business activity, before they could develop into the post-World War I type of disaster. The readjustment periods were short and the economies quickly re-established a sound basis to resume expansion.

But the process of cure was misdiagnosed as the disease: if shortage of bank reserves was causing a business decline—argued economic interventionists—why not find a way of supplying increased reserves to the banks so they never need be short! If banks can continue to loan money indefinitely—it was claimed—there need never be any slumps in business. And so the Federal Reserve System was organized in 1913. It consisted of twelve regional Federal Reserve Banks nominally owned by private bankers, but in fact government sponsored, controlled, and supported. Credit extended by these banks is in practice (though not legally) backed by the taxing power of the federal government. Technically, we remained on the gold standard; individuals were still free to own gold, and gold continued to be used as bank reserves. But now, in addition to gold, credit extended by the Federal Reserve Banks ("paper" reserves) could serve as legal tender to pay depositors.

When business in the United States underwent a mild contraction in 1927, the Federal Reserve created more paper reserves in the hope of forestalling any possible bank reserve shortage. More disastrous, however, was the Federal Reserve's attempt to assist Great Britain, who had been losing gold to us because the Bank of England refused to allow interest rates to rise when market forces dictated (it was politically unpalatable). The reasoning of the authorities involved was as follows: if the Federal Reserve pumped excessive paper reserves into American banks, interest rates in the United States would fall to a level comparable with those in Great Britain; this would act to stop Britain's gold loss and avoid the political embarrassment of having to raise interest rates.

The "Fed" succeeded; it stopped the gold loss, but it nearly destroyed the economies of the world in the process. The excess credit, which the Fed pumped into the economy, spilled over into the stock market—triggering a fantastic speculative boom. Belatedly, Federal Reserve officials attempted to sop up the excess

reserves and finally succeeded in breaking the boom. But it was too late: by 1929 the speculative imbalances had become so overwhelming that the attempt precipitated a sharp retrenching and a consequent demoralizing of business confidence. As a result, the American economy collapsed. Great Britain fared even worse, and rather than absorb the full consequences of her previous folly, she abandoned the gold standard completely in 1931, tearing asunder what remained of the fabric of confidence and inducing a world-wide series of bank failures. The world economies plunged into the Great Depression of the 1930s.

With a logic reminiscent of a generation earlier, statisticians argued that the gold standard was largely to blame for the credit debacle which led to the Great Depression. If the gold standard had not existed, they argued, Britain's abandonment of gold payments in 1931 would not have caused the failure of banks all over the world. (The irony was that since 1913, we had been, not on a gold standard, but on what may be termed "a mixed gold standard"; yet it is gold that took the blame.)

But the opposition to the gold standard in any form—from a growing number of welfare-state advocates—was prompted by a much subtler insight: the realization that the gold standard is incompatible with chronic deficit spending (the hallmark of the welfare state). Stripped of its academic jargon, the welfare state is nothing more than a mechanism by which governments confiscate the wealth of the productive members of a society to support a wide variety of welfare schemes. A substantial part of the confiscation is effected by taxation. But the welfare statisticians were quick to recognize that, if they wished to retain political power, the amount of taxation had to be limited and they had to resort to programs of massive deficit spending, i.e., they had to borrow money, by issuing government bonds, to finance welfare expenditures on a large scale.

Under a gold standard, the amount of credit that an economy can support is determined by the economy's tangible assets, since every credit instrument is ultimately a claim on some tangible asset. But government bonds are not backed by tangible wealth, only by the government's promise to pay out of future tax revenues, and cannot easily be absorbed by the financial markets. A large volume of new government bonds can be sold to the public only at progressively higher interest rates. Thus, government deficit spending under a gold standard is severely limited.

THIS IS AN OPPORTUNITY FOR ANY HUMAN-LOVING MAN TO STEP FORWARD AND TURN THIS SYSTEM ABOUT. The abandonment of the gold standard made it possible for the welfare statist to use the banking system as a means to an unlimited expansion of credit. They have created paper reserves in the form of government bonds which—through a complex series of steps—the banks accept in place of tangible assets and treat as if they were an actual deposit, i.e., as the equivalent of what was formerly a deposit of gold. The holder of a government bond or of a bank deposit created by paper reserves believes that he has a valid claim on a real asset. But the fact is that there are now more claims outstanding than real assets.

The law of supply and demand is not to be conned. As the supply of money (of claims) increases relative to the supply of tangible assets in the economy, prices must eventually rise. Thus the earnings saved by the productive members of the society lose value in terms of goods. When the economy's books are finally balanced, one finds that this loss in value represents the goods purchased by the government for welfare or other purposes with the money proceeds of the government bonds financed by bank CREDIT EXPANSION.

In the absence of the gold standard, there is no way to protect savings from confiscation through inflation. There is no safe store of value. If there were, the government would have to make its holding illegal, as was done in the case of gold. If everyone decided, for example, to convert all his bank deposits to silver or copper or any other good, and thereafter declined to accept checks as payment for goods, bank deposits would lose their purchasing power and government-created bank credit would be WORTHLESS as a claim on goods. The financial policy of the welfare state requires that there be no way for the owners of wealth to protect themselves.

This is the shabby secret of the welfare statist's tirades against gold. Deficit spending is simply a scheme for the "hidden" confiscation of wealth. Gold stands in the way of this insidious process. It stands as a protector of property rights. If one grasps this, one has no difficulty in understanding the statist's antagonism toward the gold standard.

If you SAY NOTHING, there is no reason to condone or deny—for it is in action of use of words and teaching, wherein lays the judgment of the intent of man.

## HANGING AROUND

The holdover from that act in the U.S. still slops over onto other nations who held court with the U.S. When, for instance, Marcos in the Philippines declared Martial Law—he managed to make it basically illegal for a Filipino to hold gold, deal in gold—or do more than, basically, wear a gold chain if you could afford to purchase it—which no “citizen” could manage.

A decree made it unlawful for banks to use gold, hold gold or “handle gold”, OTHER THAN THE BANGKO SENTRAL (CENTRAL BANK).

“But Martial Law was removed when the EDSA revolution took place, la-te-da...”, you say? No, just “parts” of those laws were returned to Constitutional law. One that was retained was this one regarding gold.

In the Philippines, the only institution legally able to handle gold is still the Central Bank—which is also, by law, not ever audited. The tales have it that the gold from that Central Bank was stripped out and moved to international stations for safekeeping.

Do you really think it is still in safekeeping? Of course not, and neither does the U.S. have any reserves to even cover the value-based, LEGAL COMMITMENTS OF THE GOVERNMENT TO HONOR CONTRACTS AND CERTIFICATES PRIOR TO 1913, WHICH THEN BECAME THE DEBT OF THE FEDERAL RESERVE—INTO PERPETUITY! THOSE OBLIGATIONS CANNOT BE VOTED AWAY, MANDATED AWAY OR DISMISSED. THEY WILL STAND INTO “FOREVER” AS DEBT, REGARDLESS OF WHAT GOVERNMENTAL ACTIONS ARE TAKEN. HOWEVER, THIS ONE BINDING OBLIGATION IS THAT WHICH “SHALL” SAVE THE NATIONS—THE GLOBAL NATIONS. AND, ITS ONE MANDATE IS THAT IT IS VALUED DEBT BASED ON GOLD.

“But if the U.S. doesn't have enough gold, what then?” We KNOW right off the top that the U.S. doesn't base anything on gold and they “can't” pay such a Treasury (or Fed) debt with anything except more worthless “notes”. However, a lot of GOOD can be established by use of currency against such contracts or debts. Nobody of sane mind would wish to collapse the world monetary systems because of the anarchy, which would surely come with such an action. YOU CAN, HOWEVER, GROW AND BUILD UP THROUGH THE SYSTEM AND RECOVER “VALUE-BACKED” EXCHANGE.

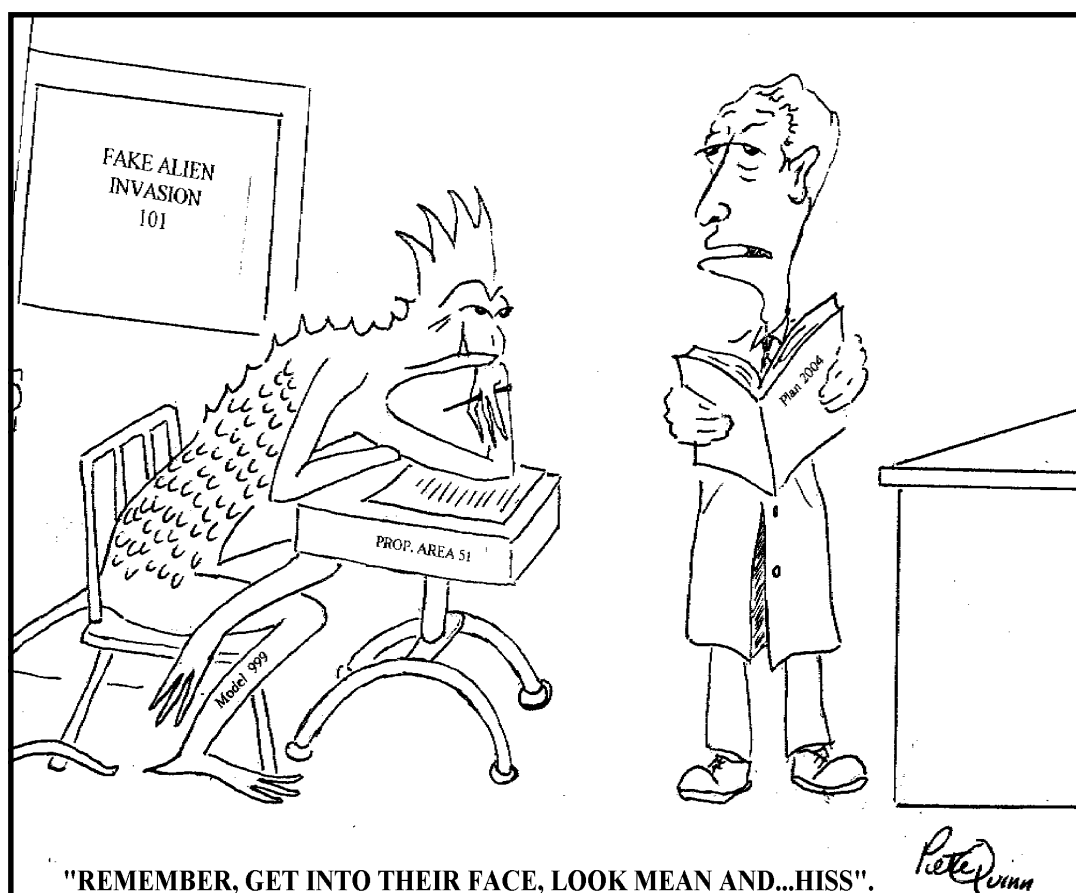

### 25-YEAR CHRONOLOGY OF GOLD

- Saudi Arabia, Europe, and the Far East BELIEVE IN GOLD AND ALWAYS HAVE.



- Saudi controls 60% of the world-oil supply.
- In 1971, President Nixon removed the dollar from the gold standard. Had he not done that THE U.S. WOULD HAVE BEEN LEFT GOLDLESS.
- President Nixon took that unprecedented step to PROTECT THE DOLLAR from severe devaluation, but he DEFAULTED ALL U.S. DEBT AT THAT TIME, AS IT WAS GUARANTEED BY GOLD FOR DOLLARS.
- In 1976, at the International Monetary Fund (IMF) Jamaica Accords, GOLD WAS DEMONETIZED in order to keep the price of dollar-denominated gold cheaper.
- This cheaper dollar against gold enabled the Saudis to purchase gold WITH THEIR PROFITS IN OIL SALES so they would have LASTING VALUE FOR THEIR DEPLETING OIL RESERVES.
- Saudis believe that once their oil is gone, they DON'T WANT DOLLARS RATHER THAN GOLD.
- Saudis have taken the long view on gold and CONTINUE TO ACCUMULATE PHYSICAL GOLD WITH THEIR OIL PROFITS.
- Today Saudi is in fear that the dollar will again DEFAULT ON GOLD CONTRACTS on the COMEX (New York Gold Exchange) and on the LBMA (London Bullion Market Association), AS THEY DID IN 1971.
- This fear of [Ed: (sic) non-] delivery of gold on contract to the Saudis is the alleged, yet non-public, reason why the Bank of England publicly pre-announced a gold auction that effectively drove the price of gold from \$292/oz to \$252/oz recently. The Bank of England was the provider-of-last-resort of physical gold to an unknown bullion bank member of the LBMA, who owed physical gold to an unknown party (Saudi?).
- IMF and Swiss gold sales are intended to free up additional physical gold in large quantity, in order to continue honoring gold contracts to the Saudis.
- THE LBMA WAS FOUNDED IN 1988, IN ORDER TO HANDLE INTER-COUNTRY OIL-FOR-GOLD CONTRACTS.
- Recently, Frank Venerasso and Bill Murphy discovered and announced that in the COMEX and LBMA the BULLION BANKS ARE SHORT UP TO 14,000 METRIC TONS OF GOLD, which is a little less than 50% of the gold contained in the Central Bank vaults around the world.
- The CFTC, a governmental Commodity investigative body, is currently investigating the gold market bullion banks for market manipulation, for suppressing the price of gold on COMEX and the LBMA.

[H: Now, to any of you destroyers and confused parties who should be more UP ON EVERYTHING THAN ANYONE ELSE IN THE WORLD, what do you think may be found in the GOLD STORAGE VAULTS of the "official dealers" and such as Wilmington Trust, Iron Mountain Reserve, Monex, Mocatta—and you name it? **makes the banks responsible for ANYTHING? Do you think a bankrupt insurance plan will cover anything? No, not EVER! # Global Alliance Investment Association

## Part Two of a three-part series

### WHAT IS GLOBAL ALLIANCE?

As the name suggests, it is an alliance, currently in formation, of individuals, organizations, corporations, and nations, the intent of which is to establish a non-usury solidly-based banking system, impervious to manipulation by forces external to any nation, as an alternative to the current paper/credit system being used to exploit and control the wealth of all nations. Additionally, it is being formed to create a "liquid" flow of capital into nations and communities that allows for the PEOPLE, at a grass roots level, to better themselves through employment in building housing, agricultural and infrastructure projects, medical and educational facilities, and in industries of all kinds—to improve the quality of life and to share God's abundance with all of His people, not just the greedy and avaricious who now control the wealth and who would wrest from the poor any new wealth created.

A corporation has been formed, headquartered in Las Vegas, Nevada, USA, with representatives in Canada, Greece, South Africa, the Philippines, Malaysia, and several States in the U.S.

### WHAT IS THE GLOBAL ALLIANCE OFFER?

To enter into a Joint Venture (JV) with a Joint Venture Partner (JVP) wherein GLOBAL (GAIA) furnishes the Collateral which can be used by the JV to fund the purchase of gold to be utilized as additional collateral against which lines-of-credit can be arranged. **THIS POINT MUST NOT BE MISSED! THE GAIA COLLATERAL PROVIDES ADDITIONAL EMPOWERMENT TO A CENTRAL BANK TO CREATE "NEW MONEY" FOR THE PURCHASE OF GOLD FOR ITS OWN RESERVES. THE GAIA COLLATERAL IS TO BE USED TO PURCHASE GOLD AND ONLY TO PURCHASE GOLD.** The gold will be divided 50/50 with GAIA and can then be used as collateral to fund the projects of both. **SO, FOR PROJECT FUNDING THE GOLD IS THE COLLATERAL, not the Gaia Collateral.** The effect to the JVP is that it has enough collateral to fund its project (even if the project itself has or produces little or no collateral), in exchange for the effort of providing only the banking contacts needed. Gold is currently low in price and can be expected to rise in price as a result of the significant amount of buying expected. The rise in price is quite likely to be sufficient to pay off the project loans. The price of gold is currently (November 1998) around US\$300 per ounce; in 1980 it reached \$850. If there were no increase in the price of gold, when the project is finished and can support itself the gold can be sold to pay off the line-of-credit and the Collateral retained by the funding bank. Should this program spread widely and gold raises in price corresponding with the additional demand, the profit can be

retained by the JVP or, as in the case of Islamic-type (non-usury) banking, shared with the bank in lieu of paying interest on the line-of-credit. The quality of the Collateral exceeds that of U.S. Treasury debt and might be re-used for additional projects. For emphasis and additional clarity let us express the GAIA OFFER as a formula:

**DEED** (GAIA Collateral) → issued to **JV** → **CENTRAL BANK** → issues its own new funds to buy **GOLD** → uses **GOLD** as Collateral for two equal **LINES-OF-CREDIT** → **PROJECT FUNDS** (for both JVP and GAIA), when **PROJECT** finished → **GOLD** is (or can be) **SOLD** → **LINE-OF-CREDIT paid off** → remainder, (if any) is **PROFIT** (which could be shared with bank).

### WHY A JOINT VENTURE?

A joint venture is required because GAIA has not been successful in accomplishing such funding alone and, without the use of the Collateral neither the JVP nor the funding bank would move to accomplish their funding, nor would they participate in the benefit of the claim to ultimately be made against the U.S. Treasury and the Federal Reserve (U.S.T./FED). (At some as yet unknown time, the JVP and/or funding bank, in concert with GAIA and other claimants (including we-the-people of the U.S.), can make a claim against the U.S.T./FED, and thus the owners of the FED, the international banking Cartel who also own and/or control the Bank of International Settlements, the World Bank and the IMF. The Cartel banks have assets reportedly in excess of one hundred trillion dollars.)

An important note: Although the FED acts as the Central Bank for the U.S., it is a private corporation established in 1913 pursuant to the Federal Reserve Act and is owned by the wealthy European families referred to herein as the Cartel. These same families control the United Nations and international press, as well as virtually all of the finance, industry, commerce, and politics in the so-called "industrialized world" through interlocking boards of directors and a series of organizations, a few of which are the Council on Foreign Relations, the Tri-Lateral Commission and the Bilderberg Society. These same families are the guarantors of the GAIA Collateral.

### WHAT IS THE GAIA COLLATERAL?

The Collateral is the interest accrued to the 1875 Peruvian bearer bond Bonus #3392-181 as valued by the FED at the direction of Alan Greenspan and accepted by U.S. Treasury Secretary Lloyd Bentsen for then-President George Herbert Walker Bush in 1989. It is a valid debt of the FED and the owners of the FED because the FED accepted all prior debt of the U.S. as a condition of the Federal Reserve Act of 1913 authorizing the FED to act as the central bank of the U.S. It is a debt of the U.S.

Treasury because the U.S. Congress and President Theodore Roosevelt assumed the debt of Peru in 1906 to avoid war with several European nations pursuant to the Monroe Doctrine (a mutual defense pact between all nations of the Western Hemisphere).

These are well-established facts, facts which can be verified in many ways, facts that cannot be refuted. George Bush called it his "Superfund" and used it on several occasions. But George Bush was not the owner of the Bonus 3392 bond; it was owned by Russell Herman, his long-time friend from the time of his directorship of the CIA. Mr. Herman had it reconformed and reissued as a Contract/Jurat of identifiable ownership by the Peruvian consulate in Los Angeles (Order No. 7309, Document No. 046) to Cosmos Seafood Energy Marketing, Inc. As CEO of Cosmos Seafood Energy Marketing, Inc. Mr. Herman assigned the Contract/Jurat to Mr. Rick Martin who subsequently assigned it to GLOBAL ALLIANCE INVESTMENT ASSOCIATION. This chain of title has been recorded in the States of Illinois and Nevada through every legal means available and there is no way to refute it. It is clear that as long as a claim is not entered against the U.S. Treasury the use of the debt as collateral will not suffer interference.

We have spent some four years and a lot of money in what we perceived to be the need to prove its authenticity. Every attorney we have consulted has reached the same conclusion: As a matter of law there is no legitimate question as to its authenticity. It is merely a contest between those who control the world of finance and a small team efforting to make a legitimate claim against them. They have the bigger gun right now. In the process, however, we consulted an attorney, a reputed expert in foreign bonds in Texas, who, after some study, said (I will paraphrase), "This is like a major artwork. You cannot prove that it is an original; you can only prove that it is not a forgery. In art, when you meet with a genuine, legitimate, qualified buyer (in this case, user) it is up to the buyer to examine the article and when he and any experts he might employ are satisfied that it is not a forgery, the assumption must be made that it is legitimate and takes the appraised value." That is where we are now, and that is what makes us so confident that all that is left to do is to USE it so that it may establish its own worth.

### WHY NOT CLAIM AGAINST THE U.S. TREASURY?

We did. We soon learned that the Secretary of Treasury, Robert Rubin, is an employee of (paid by) the IMF. To honor the GAIA claim would be instant disaster (for them) so they delay, stall and stonewall. They have agreed, however, that we can use it as collateral, off shore, as long as no claim is made to the U.S. Treasury. How about suing them in Federal Court? We then learned that the U.S. Attorney General, Janet Reno, whose approval is required to sue a Federal Agency, is also an employee of the IMF. However, when there are enough claimants of national stature the U.S.T./FED can be sued successfully in the World Court. Until then we intend to leave them alone and to use it as they have suggested, as collateral for loans made off shore.

The Memorandum of Agreement (establishing the JVP) contains a paragraph (#4) stating that no effort to make a claim on, or verify, or otherwise authenticate the Collateral will be made without the express written permission of GAIA. This requirement has several objectives: the primary one being to coordinate the claims when it is appropriate to make them so that they are all prosecuted

simultaneously; next, it is a foregone conclusion that such a request (for validation) cannot receive a positive response, and finally, we have agreed to discourage such contacts to the Treasury to save the time of Treasury, ourselves, and our joint venture partners and their funders. Further, the debt is all structured in one entity so that to honor any part of it is to honor all of it, which would destroy the present banking system before its alternative is available.

Several attempts have been made by the U.S.T., representatives of the Bush family, and the FED to buy all of the Collateral from GAIA, the most recent in Manila by two Americans claiming to represent the FED and offering "membership" in the "London high-yield trading club" whereby the profit would be "unlimited". Compared to that, Bush and Twigs are cheapskates (their best offer was \$5 million and an island in the Bahamas).

#### THE MONEY CIRCLE— NEW WAY OF COLONIZATION

In the U.S. the news is so well controlled by the Cartel that there is hardly enough information available to allow one to understand what is happening, especially outside the U.S. Having exhausted the possibilities of making a successful claim in the U.S., and having a contact in the Philippines, in August of 1998 we (the Board of Directors of GAIA) flew to Manila. As soon as we were exposed to the real news our suspicion that the IMF was being used as a re-colonization tool was confirmed. It is also the mechanism through which the Cartel transfers all of the interest paid by the nations, people, corporations, and small banks, to its Big Banks.

This concept is so important that some time must be given to understanding how it operates.

Over a long time the Big Banks have succeeded in establishing the idea that they get to make the rules regarding banking. They have been so successful in subverting governments (via "democracy") that there is hardly a government left in the world that does not submit to them.

As an aside, to explain how governments are controlled: it is easiest and least expensive to manage a democracy, which explains the constant drive to convert all nations to democracies. Democracies require campaigning for votes which takes money. The Cartel owns the Press and Media and most of the relevant Public Relations firms. The Cartel, through one mechanism or another (usually through PR firms) provides advice and financial support to all candidates, no matter to which "side" or "party" the candidate belongs, which leaves all elected officials and legislators beholden to them. During a campaign as much money as possible is raised from the people and corporations, which is supplemented by representatives of the Cartel when useful. All of this money is spent on advertising, etc., which ultimately is paid to the press and media, which they own. The Cartel thus makes a lot of money from every election (no matter who wins) while making all of the candidates feel obligated to certain representatives (not recognized as such, of course) of the Cartel. Assassination, blackmail, and the murder (or threatened murder) of family members are also employed when necessary to keep government officials in line.

But the having of such political control is not enough to satisfy the peculiar ego-needs of the Cartel owners. They cannot ever be satisfied; they must flaunt it to truly enjoy it.

The objective of the Cartel (already owners of most manufacturing, commerce, media, and money, in the world) is the complete subjugation of the world by the year 2000.

In fact, it is called Plan 2000. The so-called "millennium bug, Y2K", is one of their devices to trigger chaos after which they can gallop forth and "rescue" the world, which by then will be very grateful to be rescued.

Keeping in mind their Plan 2000, we can better see what they are doing. First they created and tested "derivatives" to see if they could get away with the enormous leverage required to despoil whole currencies. Then they invented and used their so-called "high yield" "trading/roll-over programs" to justify their huge increase in "assets" without admitting that it was all simply increasing the money supply. Next (actually, it was all a process rather than a sequence) they promulgated the "globalization" concept to remove currency controls and position everything for the kill. By this time their hedge funds and currency traders were in place so that, in concert, they could quickly drive down the value of currencies, in whole regions, not just one nation at a time. This currency trading is hugely profitable, allowing them to suck billions out of each system. At the same time they could short-sale the stock markets, thus making more billions while devaluing stocks to bargain-basement prices. (*Who knows how much profit they made during the period while those same stocks were being puffed up to inordinately high values.*) All of this money is now poised to be used to purchase stocks, businesses and properties at fire-sale prices. **They have successfully stolen from each nation far more than enough money to buy everything of value in the nation, with a profit left over.**

But that is not all. Some of these nations may still have some value left, especially in oil, minerals, or other raw materials. Most smaller nations have sought loans from the Big Banks, which they cannot now repay with their economies in disarray. IMF "to the rescue"! IMF loans (granted in return for a continuing license to steal from the nation—open currency, transparency, privatization, 100% alien ownership, etc.) are offered, sometimes, as in the case of Brazil, before the nation knows it will need such "help". In the Philippines we were told by one distraught Secretary, "If I accept \$1B of the IMF loan nearly all of it will go to pay the money-center banks. I will be left with only a few pesos for projects and the public will not know or believe where the money went. I will be accused of stealing or wasting it. If I do it I may be jailed; if I do not I may be fired. It is a hard place to be."

So the IMF is used to complete the circle; the debt is transferred to the IMF and the Big Banks get their interest. And so our point is made: ALL interest money will ultimately end up back in the coffers of the Big Banks. It seems quite clear that the Cartel has invented a way of periodically squeezing the juice from its former colonies without taking any responsibility for their welfare between squeezings.

#### THE MONEY MYTH: ONLY "THEY" CAN INTRODUCE NEW MONEY SUPPLY

An idea that the Big Banks have succeeded in inculcating in the banking business is that the money supply and granting of credit (which adds to money supply) must be tightly controlled or "inflation" will occur, devaluing the currency. Such amateurs as are found in typical banks and central banks are of course not qualified or experienced enough to make such determinations; such momentous calculations must be done "up there" somewhere—at a much higher level (nobody seems to know exactly where or who has that responsibility).

The concepts of globalization, openness, transparency, privatization, and so forth are all part of the scheme to de-

nationalize the control of a nation's money by the nation and place it in the hands of the banking Cartel, i.e., IMF. A few hundred years ago there was a clear distinction between money and credit. To be real, money had to have substance, or to be backed by substance, usually gold or silver, so that the slips of paper representing the money could be redeemed in gold or silver. This meant that banks had to keep gold and silver equal to some fraction of the paper money issued, usually in the neighborhood of 1/20, on the theory that all depositors will not ask for their metal at the same time. Being tied to the price of gold, which (for their purposes) had to be controlled world wide, was far too confining for the elite bankers so they have finally forced all nations except the Swiss off the "gold standard". Now anyone espousing the gold standard is laughed at and derided for being "old fashioned" and out-of-date. Paper currencies (although really worthless) are more "modern" and provide greater "flexibility". Besides, gold-based currencies are not so easily "traded" and devalued as are paper currencies. Now, excepting the Swiss franc, all money is credit. There is no real money, only credit. The U.S. currency has imprinted at the top: "Federal Reserve Note". A Note is evidence of a debt, a promise to pay, which equals credit. The world no longer deals in value, it deals in debt.

Nations have the right, and the duty to their people, to issue their own currency. It is uniquely their prerogative within their own country to issue a lot or a little. However, when it comes to inter-country (international) transactions, there are guidelines and requirements to be met to establish a par value for the currencies of the countries involved. In June of 1997 the currency traders, in league with the IMF (they are all of the same club), mounted a merciless raid on the currencies in Southeast Asia, taking perhaps as much as a trillion dollars (U.S.) out of the area. If we use business logic instead of bankers' traditional teachings, we will arrive at the conclusion that, done cautiously and with care, at least that amount of money can be created within Southeast Asia to be re-injected into the system to make it whole again, especially if it is used to first purchase gold to be used as the reserve upon which the newly-created money can be based. From a business perspective, there is no investment available today with the upside potential, and low downside risk, of gold. From a humanitarian perspective, there is no other opportunity to do so much good for the poor people of the world, without harm, even to the elite banksters. It is the mission of GAIA to accomplish this.

#### SOURCE OF FUNDS

God (Aton, Allah) frequently shows us His sense of humor, fair play, and justice. But seldom all at once in such a recognizable way as He has done with His provision of the GAIA Collateral.

Collateral frequently takes the form of third-party debt. An example would be a U.S. Treasury Bond, a debt of the U.S. Treasury, perhaps purchased as a stable, interest-earning reserve by the central bank of another nation, and then used by that nation as the Collateral for the issuance of its own currency (or other banking device) as payment for some obligation, perhaps an international trading transaction. Thus the U.S. Treasury Bond, actually a debt, is treated as though it were an asset, the theory being that, in addition to acting as a "reserve", it can be sold or traded or "cashed-in" at the U.S. Treasury. Some U.S. Treasury Bonds are issued to mature (be paid off) at the end of 30 years and thus cannot be "cashed-in", even though this does not prevent their use as central banking reserves and

interest-earning investments for banks, insurance companies, pension funds, etc. Some are constantly in motion, being bought and sold and traded around the world just as if they were not a debt which could be made worth zero at the stroke of a U.S. President's pen.

The GAIA Collateral is a debt of the U.S. Treasury. But it is even more valuable than the typical U.S. Treasury Bond because it is **payable in gold** (not in paper money), and its claim for payment reaches beyond the U.S. Treasury to the European-based International Banking Cartel, owners of the Federal Reserve System (FED) (which acts as the central bank for the U.S.), and thus cannot be abrogated by a U.S. President. The QUALITY of the GAIA Collateral is far greater than that of U.S. currency (Federal Reserve Notes) or U.S. Treasury debt issued after 1933—they are not backed with anything other than the so-called “good faith and credit” of the U.S., which was secretly declared bankrupt in 1933 and is now by far the world's largest debtor. Only U.S.T. debt pre-dating the Federal Reserve Act of 1913 has a claim on the FED and its owners, the Cartel. In reality, the only collateral in the world today that has greater quality than the GAIA Collateral is the actual possession of physical gold. Whatever can be done with U.S.T. Notes, Bills or Bonds can be done even more safely with GAIA Collateral.

The question is frequently asked, “What good is collateral if you cannot claim on it?” Can you claim on a U.S.T. 30-year bond? Of course not. You might trade or sell it but it will not be redeemed before its date of maturity. Why would you want to redeem the GAIA Collateral? What would you get for it? You would get U.S. currency which is redeemable in nothing but more paper, not gold, and is not a claim on the really big money in the world, the Big Banks owned by the Cartel. When it becomes recognized, through use, the GAIA Collateral will become the second-most treasured reserve in the world, after only physical gold.

That God had a hand in the creation of the GAIA Collateral can be most easily shown by recounting the events leading to its valuation by the FED and its acceptance by the U.S. Treasury in 1989. It began in New York City in 1875 when a bond-house named Hobson & Hurtado issued and sold 3600 gold certificates at \$1000 each for the government of Peru to finance the expansion of Peru's bat guano industry. Bonus Bond No. 3392-181 was not turned in for redemption when due in 1885 and was thus an outstanding debt of Peru in 1906 when the U.S. assumed all of Peru's then-outstanding debt pursuant to the Monroe Doctrine (a Western Hemisphere defense pact) to avoid war with Germany and England who were threatening to invade Peru, Bolivia and Chili.

Bonus Bond No. 3392-181 was still outstanding when, after more than one hundred years of political finagling, the European Bankers finally managed to get control of the U.S. central banking function through the enactment of the Federal Reserve Act in 1913. As a condition of allowing the new Federal Reserve System, a private corporation owned by the European Bankers, to issue (and be paid interest on) U.S. currency, the FED assumed all then-outstanding U.S. debt, which of course included Bonus No. 3392-181.

Bonus No. 3392 is next mentioned in the documentation as the subject of a legal opinion rendered by a lawyer named Ernesto Arias Schreiber in Lima, Peru dated June 9, 1977 (confirming that, per the Peruvian Civil Code, “the nature and effects of the obligation are ruled” by the laws of “the United States of America”). George Bush was Director of the U.S. Central Intelligence Agency in 1975-1977. There has never been any question that the

bond, a “bearer” bond (meaning that its bearer is its owner), was the property of Mr. Russell Herman who was a high-level CIA operative when George Bush was CIA Director. Mr. Herman has told Mr. Rick Martin on several occasions that he and Mr. Bush were at one time good friends and business partners.

The next documented appearance of Bonus No. 3392 was when a consortium containing Alan Greenspan (FED Chairman), George Bush (President), James Baker III (Secretary of State), Lloyd Bentsen (Secretary of the Treasury), and Russell Herman had it valued at the FED's Los Angeles office and accepted by Bentsen for Treasury.

In August of 1989 Mr. Herman had the bond reconformed as a Jurat/Contract and issued as one of **identifiable ownership** to his corporation named Cosmos Seafood Energy Marketing, Inc. In 1993 Mr. Herman, as CEO, assigned the Contract to Mr. Rick Martin and in April 1998 Mr. Martin assigned it to GLOBAL ALLIANCE INVESTMENT ASSOCIATION. As a request accompanying his assignment to Mr. Martin, Mr. Herman received Mr. Martin's pledge that no less than 48% of the funds made available through the use of the Collateral would be used for the benefit of “we the people”, meaning the American people whom Mr. Herman came to realize he had wronged by participating with Bush & Company (CIA) in their drug importation business, and that, to the degree possible, none of the funds would be used for war or war-related activities.

All of the above is documented and filed in both the States of Illinois (where the assignment to Mr. Martin occurred) and Nevada (where GAIA is domiciled), and appropriate public notices have been published.

Who, but God, could turn the thievings of the European Banksters into such a magnificent asset that it can free and empower all of the world's people—at the expense of the Banksters?

#### HOW IT CAN BE USED

Because the GAIA Collateral is a debt of the U.S.T./FED payable in gold, its proper use is to obtain gold. Then the gold so obtained can be used as collateral for loans with which to provide liquidity for banks, central banks, pension funds and other large trusts, insurance and finance companies, and for corporations to use in funding projects.

The first, and seemingly most difficult to visualize, step is the conversion of the Collateral to liquid funds to be used to pay for gold. There are many ways: Central banks issue currency, so that one is easy. If the Central bank has been the victim of Bankster brainwashing to the idea that it must “sell bonds” to obtain cash, it may not be so easy. Banks, insurance companies, and large corporations usually have access to a wide variety of funding mechanisms such as Letters-of-Credit, Bankers Acceptances, Prime Bank Guarantees, Collateral Receipts, Commercial Paper, Guaranteed Investment Contracts, and so forth. One key to using them is to take in the Collateral as a rented item (so as not to trigger a tax), have it accepted by the Board of Directors and immediately added to the balance sheet as an asset titled “U.S.T. debt”. (The “rent” could be the effort required to assist GAIA in funding its portion.) It might be useful to include a statement in the corporate minutes that the corporation intends to use the Collateral as an asset with which to purchase gold—at current prices gold is a legitimate investment, more especially when the Collateral with which to purchase the gold costs only effort and time on the part of certain executives.

Small and medium-sized corporations have to have

help from banks or big-brother corporations. Some smaller banks may wish to use a collateral Receipt to gain the help of a larger bank. Transactions involving insurance companies and banks can also be useful.

By far the best solution, however, is to arrange the assistance of the central bank which, when the benefits are understood, should not be difficult for the business and banking community. Can central banks issue credit without the Collateral? Yes—they have been doing so for years. The main advantages of using the Collateral are 1) a valid claim on the Cartel's gold (at the proper time) resulting in a doubling of the central bank's profit, 2) through added numbers of participants, a greater certainty that collection will be made, 3) that collection will be made sooner, and 4) through the Alliance, better protection from IMF, the currency traders and the corporate raiders.

While it is not possible to foresee every kind of transaction and provide a template to be used, it is possible to state that GAIA controls its own collateral and is ready, willing and able to “tailor” transactions to fit situations.

#### WRAPPING IT UP

There is a relatively small group of persons, calling themselves Zionists, planning to own/control all of the world by the end of the year 2000. Although headquartered in the City of London, most of them call themselves Jews. They operate through the Council On Foreign Relations, the Trilateral Commission (which includes some Japanese), the Bilderbergers, the Club of Rome, high officers of the Freemasons and most “Fraternal Orders”. Only a small percentage of Jews belong to this elite “club” we have referred to herein as the Big Banks and the international Cartel.

I CERTAINLY DO NOT WRITE FOR MY COMMITTED “ENEMIES” AT ANY CAUSE. I SIMPLY DO NOT CARE AT ALL—WHO OR WHAT THEY THINK ME TO BE! I WILL, HOWEVER, REBUT EVERY LIE, THEFT AND DECEIT THAT IS BROUGHT TO MY ATTENTION BY INQUIRING MINDS BECAUSE A “THINKING” MIND IS A PRECIOUS THING INDEED.

COSMIC VISIONS AND DAVID ICKE

Since there is an upsurge in the interests and focus on the investigative writings of David Icke, I will respond to the petitions for comment.

It is unfortunate that David has been sucked into coverage of this topic of “Reptilians”, real or imagined, not because it is a “taboo” subject, but because the presenters of most of his information are very manipulated and controlled people. I see that he is totally misled in several avenues of presentation by very QUESTIONABLE individuals. The obvious is that which comes from one who actually is supposed to have LED in these gross and bloody rituals with the Royal House of Windsor. If one is so controlled as to participate in such atrocities—is this one not so controlled as to possibly give “imagined”, or incorrect information? These are the types of sensational information that bring totally erroneous information to an already mind-washed people, and become so controversial and hyper-sensational as to then negate the remainder of an investigator’s VALID work. David has not “misrepresented”, but the sensationalists take the information and further fluff it, sound-bite it, and it comes out presenting something never intended. I don’t care who the interviewer might be—this is what happens with sensational presentations. You are so uninformed, yet, about what is abounding in your immediate impacting world ON SELF, that to attend the hypothetical or “spaced-out” input is consuming time worthy of input into that which might well be changed through recognition of circumstances. You can see that your world is in trouble—can you change a reptile—whether real or imagined? The snake in the apple tree was not at all a serpent, so start there and the problem of recognition might be easier to manage.

When you speak of “Reptilians”—you are NOT speaking of actual snakes, alligators, lizards and reptiles as such. If you spoke of a “fish” person you might well think of someone with very rough and “scaled” skin covering, etc. When “I” speak of Reptilian DNA-RNA-genetic-fundamental structure, I am not speaking, either, of ACTUAL reptilian creatures—but simply a species of humanoids who might, or might not, have some features reminding you of reptilian characteristics. These can consist of “typical” head bobbing, tongue flicking, muscle tensing, etc., of facial muscles and other “characteristics” which may well remind you of, say, a lizard. There is also a cold, calculating aura around evil which projects the total lack of capacity of compassion or conscience—as in “cold-blooded” response or action.

One of the nicest compliments I received, toward recognition of my own presentation, and this can be a good hook upon which you can hang some possibilities, is something an ANGRY Col. Bo Gritz wrote TO ME: “What kind of a warrior are you anyway? The ONLY THING REPTILIAN ABOUT YOU is your ability to be as a chameleon...”. These are ATTITUDES, people, but the fundamental underlying recognition is “related” to something familiar. If a Teacher says to a person: “You are the rock upon which I will build my church,” or “You are the Oak which stands the winds of time”—does this mean that the persons involved are ACTUALLY rocks or trees? Does this mean that Bo Gritz might be a Reptilian and noted that I am not? Do you have to BORROW more confusion?

I’m very, very saddened that David has chosen to scatter this information, BECAUSE OF ITS SENSATIONALISM. He states that he “doesn’t KNOW” and is just passing along what he has encountered, etc. But people reading will place their own interpretation on both the information and the presenter. We have been the focus of such targeting since onset of our own work. I am also saddened that it is getting so much attention as to bring such a host of inquiries for my comments. This indicates a giant leap into the “unknown” in such manner as to simply be “sensational” and yes, I know, that it is of uppermost “interest” and curiosity, therefore I make every effort to respond to these inquiries as we find time to do so. What this does, however, is begin to take the edge off the very TRUTH David has offered prior to now, because it becomes such a bit of fluff and again, melodrama! At a “speculative” period of presentation of any information, it can only be of “interest” and not “fact”. But this is HIS presentation and he may present anything he chooses in any way he chooses, so, YOU READERS; TAKE CARE TO NOT READ ANYTHING INTO HIS PRESENTATION THAT IS NOT THERE. Dear ones, in ETHERIC FORM there is no “NEED” for “shape shifting” or scaled projections—UNLESS YOU BUILD THEM INTO YOUR PERCEPTION PROGRAMMING. God is LIGHT, thought, energy. Can these other THOUGHTS manifest? Of course, just as you can manifest ANYTHING you can conceive in thought.

David is placed in a position of being UNABLE to NOT look at the information, for it is pouring in upon him and he is not stating that any of it is fact, only that it bears attention. You must see that it is similar to “abductions by aliens”—fact or fiction, any seriously interested parties MUST LOOK AT THAT WHICH COMES FORTH. CONCLUSIONS CAN ONLY BE DRAWN THROUGH LOOKING.

The major interest comes from the recent travels of David, where he is discussing, more currently, Reptilian species. I responded to this inquiry recently but perhaps there was no publication in the paper.

Yes, we will meet with David as soon as it is feasible because he needs a lot of “fill-in” and indeed, yes, “confirmation”. He is not “nuts” and this is “serious”—just as intended to be. I also want him to have, at hand, the facts as regards where, what, when, why and how of the Cosmic “helpers” for the Light beings. If he thinks he is compromised by what he reveals—consider the attitudes regarding our input, especially in light of people he “respects”, calling us Satan and

Satanic. It shows how easy it is to be fooled.

Part of the reason, in fact, that we are going through this terrible phase of realization is the very fact of what Icke might refer to as some sort of “shape-shifting”, in which the “perception of viewing parties” is that somehow whoever or whatever is being observed is “reptilian”. Is this recognition coming from actual observation, or individual perception? I do not have “time” to attend that topic satisfactorily, for Dharma must attend other things of far more importance to the largest numbers of OUR people. That is her mission, and these other topics are simply “interesting”, and the priority attention in urgency must be first given proper attention. We need, for instance, to accomplish “our mission” here in order to offer support and necessary physical support in funds and direction to such as David Icke.

Actually, I have covered all of these topics, which now catch your attention and they need not be repeated, except that we were shut down as to physically publishing at least a third of our information offered. We have stopped attending that which is “waiting” and, as a for instance, Dr. Overholt will not release our information, which he holds on disc, until we are able to pay him whatever he deems reasonable extortion for same. So it has to sit and wait until we have other resources. I remind you that the “adversary”, of which there are many, many, unknowingly, ARE from the “Reptilian” DNA codes. This is not that which is important, however, for every HUMAN given opportunity in the expression of physical experience—has no need to even note such structure. There is the so-called good intent and negative intent in EVERY INDIVIDUAL. However, as you near a time of being better able to see through the physical facade, you are able to more often consciously experience seeing “through” the facade and into the REALITY. Then, there is also the strengthening energy-increase in certain instances and with certain releases of, say, adrenaline—which actually causes a change of appearance, as energy frequencies of cellular structure change. So, yes, a predominant structure can most certainly become dominant enough to become visible.

My own people have very openly described certain people literally “looking like a lizard or a snake”, with attendant motions—flicking of tongues, bobbing of heads, swaying in serpentine motion, etc. You have ALL experienced this. Artists depict people in insane care centers as “snake pits”. The people are then presented as semi-reptilian in appearance as well. In other words: “Which came first, the chicken or the egg?”

You have all sat before a TV and proclaimed: “Look, she looks just like a little lizard.” These ARE simply the Serpent People. The line of genetic heritage and DNA-RNA structures is becoming more visible but it is energy interpretation—not actually PHYSICAL change as such, although it COULD BE. And NO, it does NOT mean that any ONE is evil or even weird. It does mean that there are genetic patterns that go with DNA-RNA structuring, which surface or become more superficial in certain circumstances or with energy changes.

Dharma, for instance, is so vulnerable to these patterns in viewing perception that there have actually been separations of herself from the presence of others—because the visibility of such features are so uncomfortable as to cause her to wish herself absent from the encounters. This was very pronounced in this past winter, right here in the Philippines. It is far more easily noted when the predominant citizenry are basically different from the accustomed “every-day” person of any nationality culture. Your OWN, more-familiar race or species become even more easily observed in an alien setting.

There is also a NOTED pattern when such a genetically-impressed individual is exposed to various patterns in environment. If you have a “native”, as in “aboriginal”, circumstance with native drum-beat and sound

track, the natives will enhance themselves to APPEAR deliberately as “something” (bird, snake, etc.) they wish to represent. So, let us consider the very factor of Hard-Rock or Metal “noise”. There is only a repetitious BEAT and repetitious words, which *entrances* and opens the mind to other factors then presented. These are called “triggers” and usually the one involved is not aware of ANYTHING, except to comment on the “good music” or simply sit and bob about like the little lizard testing the air—to the beat of the underlying “noise”.

Watch a bunch of people in a writhing expression of serpentine motion on a Rock dance floor “discotheque”. The word itself is a version of “dis”, meaning unattached and technology of same—or disattaching, through technical means (noise and repetition), the consciousness into a world of receiving whatever is in point of the message being offered. Look at your Rock STARS! They are mostly burned out, disconnected, scrambled bodies detached from any wisdom of a brain. Some grow OUT of that trance and become incredible producers of good works—but it is difficult, and if the “Reptilian” genetic structure is strong enough—they will not survive in a world of absence of that which they must have to survive. These are easily-manipulated and addicted individuals.

Just remember something: **You are a “soul having a human experience” and not a “human having a soul experience”, as can only be in a “physical expression of being”.** So too, you have “people having some need to present as serpents”, for you do not find “serpents presenting as people”. Please think about it!

The facts are that evil is, unfortunately, very associated with reptiles (snakes and vipers), so perhaps you can more easily see why anything of evil nature immediately conjures a reptilian vision in the mind. This predisposes you to FEAR and panic at such recognitions. But always remember something: As a baby begins to crawl, what does he do? He gets on his hands and knees and he bobs back and forth EXACTLY IN THE SAME MOTION AS A LIZARD. He will often concentrate, as well, with his lips parted and his tongue testing everything. Furthermore, for every “bad” reptile, there are a zillion goodly creatures who eat rodents and insects, and generally help mankind.

Over in the stash places of Southeast Asia, the treasure IS placed in caves and tunnels—wherein then are introduced snakes, because the very presence of the reptiles will cause man to back off and go away. Some of the snakes are vipers and so deadly; the intelligent thing is to beware. But does this mean you go ape-scream? Of course not.

So, do we or “you” know individuals of this ilk? Yes, of course. They are not so subtle but that you are easily manipulated, and more especially if you are not impressed with those particular genetic or DNA qualities. Are you then BETTER than they? Better? Better than what?

This is why, however, you have the big push to produce “Little Grays” and “Reptilian” type of structured replicas or clones. These are, however, most noticed in cross breeding or DNA-genetic CROSSING (intentionally) of formation patterns.

The replicated “Reptilians” in a laboratory are not as shrewd and cunning as are their patterned-after clone-lines. They are, in their simple form, very, very docile and yet, childishly curious. They have to be deliberately programmed to perform in certain ways to the “master’s” instructions. The paper was good and I consider most of the messages to be extremely good now. I, myself, have a great deal of input. I do feel it unfortunate that so much would be presented as that coming from David Icke, who is simply presenting what OTHERS TELL HIM, but who is, after all, an outstanding speaker and writer, that he may be discredited through such interviews that cause a focus on these particular subjects, without balance of his other good and outstanding works. But, readers, NOTHING IN MANIFEST LIFE is truly OUTRAGEOUS! Remember your lessons: **WITH GOD ALL THINGS ARE POSSIBLE, EVEN THAT WHICH IS “FANTASTIC”, AND YOU, THROUGH PROJECTION OF THOUGHT, PRODUCE WHAT YOU “THINK”.**

I do not, no, feel any threat from these entities—they are such low-life forms as to only be a “bother”. However, to counter toward FREEDOM and GOODNESS, there must be ability to function in a human, physical manner to DISPLACE the bounders, rather than have some destructive annihilation of their species. Here again, the PERFECT example is available to you who have experienced a separation of *CONTACT* and *Spectrum* persons.

I am presented with a letter from one of our closest friends, who writes with inquiries about the instructions ATON gave about “identification” and there being a process of “SO-CALLED” identification of the “speaker”, with **NO NOTICE OF THE RECEIVER.** (Ref: *CONTACT*, January 26, 1999, page 12.)

I am now supposed to comment on “my presentation” regarding this topic—WHEN THE PRESENTATION WAS “NOT MINE IN THE FIRST PLACE”, WAS NOT “ATON’S” IN THE FIRST PLACE, AND THE POINT IS TO DECIPHER CONTENTS AND PAY ATTENTION TO THAT WHICH IS CONTRADICTIONARY AT BEST, NOT MY INPUT AS FACT.

Even after we INSISTED that these RECEIVERS, who presented such as that very writing, offer identification, those people HAVE REFUSED TO IDENTIFY THEMSELVES. Doris, further, demanded that a notice be put into the paper that she WAS NOT the receiver of that information—and yet, here full-circle comes requests that she, or we, explain ourselves. I could go right down the article and yet I point out that the inquiry comes from a writing in the paper presented in full—against us and the Ekkers. Do you now see, perhaps, how difficult these presentations come to be, and how totally without reason comes a refusal to identify the “receiver” of messages?

Let us suppose that you got the same message—only to find out that it came from Judge Jason Brent of Mensa, “kill off the old, infirm”, Malthusian idealist? How about if you find it came from Charles Manson or, yet, Adolf Hitler? Would it make no difference to you? Should it make a difference? Well, where the worst error happens is that, through non-identification, the readers of our years and years of writings are caused to believe, by non-identification, similar-to-identical names and structure of the writings themselves, that they were/are presented by OUR receivers. Is this fair? Are there clues?

Why are receivers HIDDEN? The clues to imposter speakers, as well, are very evident and in your face.

But to Paul P. and the questioners, we will start by saying that that was NOT our writing and we cannot speak FOR their intent.

I will take time to point out several things Paul has underlined for specific attention, to put you at ease until you



can recognize for selves subtle things from that specific writing in point.

A SPEAKER CAN GIVE YOU ANY SPEECH IT/HE/SHE CHOOSES, AND ANY "IDENTIFICATION"—YOU HAVE NO WAY OR AUTHORITY TO PERCEIVE FROM PRINTED WORDS—ANYTHING. I CAN TELL YOU THAT I AM EINSTEIN AND HOW CAN YOU TELL THE DIFFERENCE? You would still suspect something could be "wrong" if dharma puts her label all over it but at the LEAST YOU THEN HAVE A FOCUS OF WHO "MIGHT HAVE" INPUT. It is simply a matter of BEING RESPONSIBLE for your receiving or your writing. I would prefer that every writing also have a notation of who EDITS same. I didn't say "checks typos", I said "EDITS".

Specifically look at a statement that says "I am turning over 100% responsibility of...to...from..." and then there is NO IDENTIFICATION OF SPEAKER/WRITER. So, in one stupid statement these people have spoken FOR GOD, FOR A LOT OF OTHERS and still have given no identification of SELVES! How much of your HOLY BIBLE was changed just through such outrageous presentations? ALL OF IT; THAT'S A FACT. THE FACTS ARE THAT THE FALSE-CHRISTIANS WROTE THE ORIGINAL INSTRUCTION BOOKS IN THE FIRST PLACE AND YOU HAVE SPENT THE REMAINDER OF THE 2000 YEARS FOLLOWING THE FALSE PREMISES.

Now, let us look at just one or two items that can without doubt show you that ATON/HATONN are NOT writing SPECTRUM's presentations, starting with THAT message in point WHICH CAME FROM "THEM", BUT WHICH WERE STILL FLOWING UNLIMITED THROUGH THE CHOICES OF THE SAME EDITOR-IN-CHIEF.

First let me remind you of the paper's (CONTACT's) purpose: TO GIVE INFORMATION. You will lose half your audience by treating the paper as a "cult paper" from some invisible energy; and by that I mean, some religious or controversial presentation.

We have stressed, over and over again, TO PLAY "DOWN" the participation of "higher energy" forms and present as is factual and easily accepted—as JOURNALISM.

That was the primary cause of one of the first MAJOR disputes. CONTACT was chosen after 12 years of building a connection with the teams having to play out a very human interaction. It became the accepted communications tool between such as the IMF, FED, etc., and frankly, the first weekly input to the CIA's information pool, from and between "us". We agreed to do nothing overt—or covert, and our agreements could be monitored by any and all—right in the public statements and agreements—WHICH WOULD APPEAR IN CONTACT.

So, we are moving along when the Editor of the paper sees fit to place outrageous and controversial "invisible" calls to "religious" attention, writings ON THE VERY BACK of the PUBLIC NOTICE being run for a specific purpose of COMMUNICATIONS with these before-mentioned entities.

What was THE request made? To STOP running those "Spiritual messages", SUPPOSEDLY OF MINE (but were NOT), until we finished the Public Notice, because the objection was presented that this couldn't be a proper paper because it was just a "cult rag" of some kind.

Almost all of "MY" writings had been hidden away. The very writings themselves were going FIRST to Ed the Editor. When this became obvious, and that all the e-mail PERSONAL letters between family and friends were being used as "GOSPEL" of some kind, we asked that the method of transfer be interrupted. Then Al was receiving but he and Ed again decided to HOLD OUR INFORMATION, except for bits and pieces with no meaning. Then THEY started their "housecleaning". Please know that following March 10, there

WAS NO VALID CONTACT presented by that team, and prior to that there had been a full movement, by OTHER WRITERS AND RECEIVERS, to clear out our regular presenters.

Those nice people were basically telling the truth about the "cleaning" but they never, TO THIS DAY, seem to realize THEY WERE THE ONES BEING CLEANED OUT. They continually told on themselves, but the readers had no way of knowing, and STILL DON'T, because they STILL DO NOT IDENTIFY THEMSELVES [AS RECEIVERS].

There seems to be an assumption that if a speaker gives you a bunch of hogwash you don't need to know the receiver? The facts are that NEITHER means much if the READER can't discern. However, when you have a "takeover" of property under way through this deception—it DOES BECOME IMPORTANT.

Next, look at a "challenge"! There is NO WAY to challenge an ENERGY on a piece of printed paper—especially out of context. A challenge is demanded if you question a speaker—literally in presentation in audio-format. The Spectrum kids have totally refused, over and over, to PRESENT A SPEAKER in such form—even in a conference demanded by Dr. Carlson and from many of you who have DEMANDED MEETINGS. There, is where you can challenge and have meaning and no, NO HIGHER BEING objects in any way to such challenges.

Facts remain that the one best instruction is also in "that" paper in point: You, the reader, have to discern truth of works and presentations for, in a paper presentation, there is no other way. Anyone can write anything, anytime. I also believe that "Perhaps you ones are being tested to see who is awake and who is on auto-pilot", (as Pseudo-Aton is presented as saying.). And how do you get off auto-pilot? By not getting hoodwinked by would-be misrepresentations and having no way to relate to THE RECEIVER WRITING THE MATERIAL. It is extremely simple, readers: do you take your lessons from say, Harvey Dobinkie or Dr. Wayne Dwyer? Is Dobinkie's less valuable than Dr. Dwyer's? Perhaps, but when you have such subtle information as comes through in messages—you must learn to discern and to JUDGE the output.

Let me example from the provided writing: Page 12, Jan. 26, 1999 edition of CONTACT, from an "Aton" writing (not any connection to dharma, Doris, OR US).

"You will do a great service for the ones who have become lax or sloppy in their communications skills. All of My Hosts are experts in communicating, so where might the breakdown be? If you do not demand Truth for yourself, then you will not have truth."

Ah, but how would another "receiver" know if a receiver "has become sloppy"? A RECEIVER can only get cleared with self and no other! AND, if you are talking about receivers and possible sloppiness—who might be the sloppiest: the one who says "I am...", or the One who has had identification in use for over a dozen years which has never varied? Or might there be a PROBLEM in one who REFUSES TO IDENTIFY BUT CONTINUES TO "CLEAN MY HOUSE", AND CONTINUES EVEN TO THIS DAY, AND WITHIN ANOTHER PAPER, TO NOT GIVE RECOGNITION OR IDENTIFICATION?

You have to understand something: I would prefer to have JOURNALISM. If there is an article by "Jack Smith" or "Mike Blair" of Spotlight—even though you don't know Mike or Jack, you have instant recognition. When just "any" resource puts something up for you and gives NO recognition, you have PROBLEMS, people, with others who DO NOT WANT YOU TO KNOW WHO IS PRESENTING THE INFORMATION!

Just an example please:

"WHAT WOULD JESUS DO...?"

"\_\_\_\_\_ [Leave blank for a minute, please.] said recently that assassinating world leaders offers

a good solution to the world's troubles, 'I know it sounds somewhat Machiavellian or evil to think that you could send a squad in to take out somebody like Osama bin Laden, or to take out the head of North Korea,' \_\_\_\_\_ remarked. 'But isn't it better to do something like that, to take out [Yugoslavian President] Slobodan Milosevic or [Iraqi President] Saddam Hussein, rather than to spend billions of dollars on a war that harms innocent civilians and destroys the infrastructure of a country?' Even Adolf Hitler opposed the assassination of enemy leaders."—from SPOTLIGHT, 8/23/99

So, OK, who might write such a thing? And, would it not be quicker to get to the CAUSE—just to assassinate about 30 of the U.S. top controllers? How about all the International Controllers—or, how about the head of Israel—you name it!

Would you expect this from a Jason Brent of Mensa perhaps? How about CIA directives?

So, who espouses this? Wow—really? CHRISTIAN COALITION PRESIDENT, PAT ROBERTSON! CHRIST-ian?

Are you actually going to ask me if the WHO is not rather important in your own questioning?

So this "Aton", by Anonymous, continues: "I offer these words as a template of sorts so that you may refer to them and remember where you come from and where you are heading. [H: Where DO you come from and where ARE you headed?] The adversarial forces (those who choose to disconnect from Source and oppose those who choose to remain connected) must ALWAYS wear a sign. The clues are ALWAYS there, so no excuses, please!" [H: Well, we know who WE ARE and we KNOW where we are headed—so WHO must have the problem?]

OK, let us go further. But first, please recall that dharma has written and spoken for me since 1987. All of you readers CAME TO KNOW ABOUT ME THROUGH HER RECEIVINGS! Now, someone comes along and AFTER a few months has TAKEN OVER, with his/her Editor in charge. Now, study that one for a minute because THEY gave you NO IDENTIFICATION—BUT IN FACT, LEFT YOU THINKING THAT THE WRITING WAS INDEED FROM ME THROUGH DHARMA. AND AT THAT POINT, DORIS DEMANDED A STATEMENT IN THE PAPER THAT STATED THE WRITINGS WERE NOT "HERS". THE STATEMENT READ IN SUCH A WAY, HOWEVER, AS TO BE INSULTING AND STILL WITHOUT PRESENTING ABILITY TO IDENTIFY RECEIVERS.

Look at this part of that same writing: "Those of you who are drawn to CONTACT for insight and useful information are among the 'Ground Crew' for My Hosts.

"But—do not think for one moment that one needs to read, or even know about, CONTACT in order to be 'Ground Crew' for there are MANY who simply follow their own Guidance (Conscience) and do their job. For these ones, the challenges of the newspaper would only serve to distract them from their particular chosen path."

Do you see anything WRONG WITH THIS CONCEPT?

If you have a mission outlaid through this conduit, then wouldn't you have to get your instructions from SOMEWHERE? And: "For those ones, the challenges of the newspaper would only serve to distract them from their particular chosen path." (???)

Now, try that again and see what might be a bit wrong in concept? Why would anyone on some other mission or direction be interested in the paper at all, and certainly, why WOULD THEY BE "WRITING" FOR SAME? IN OTHER WORDS, WHY WOULD SOMEONE ON ANOTHER PATH BE SO MUCH AS LOOKING AT CONTACT, IF INDEED OUR MISSION IS OUTLAID AS DIRECTLY AS WE HAVE DONE FOR NEARLY A DOZEN YEARS?

“Aton” then goes on to give away the truth: “I need scientists as much as I need philosophers and receivers.” This couldn’t possibly be an attempt of our Editor-and-Chief (“scientist”) to justify his own position through this receiver, who also says that Dr. Young is “ONE OF THE BEST RECEIVERS” IN THE UNIVERSE? I would suggest that scientists are among the very most important participants and have NEVER INDICATED OTHERWISE—EVER.

Look very carefully at this next: “But most importantly, I need independent thinkers and DOers. The faces of My poor little children, who come from broken homes, Light up not because of the money dealers on Wall Street, but because of the dedicated ones who serve the only decent meal in their day at school cafeterias. This is My Plan in action!” But from where comes that “only decent meal”? Do you see anything a bit less than GOD in presentation in that statement? This “anonymous receiver” is placing such irrelevant statements in GOD’S presentation as to be embarrassing. What does a broken home have to do with HUNGER and the only decent meal of the day—served by ANYONE? This in effect presents Aton as some kind of a “lunch god” just as the bringer of cat food becomes the “cat-food god of the refrigerator”. But this goes on to next say: “This is My Plan in action!”

So, might next come Anonymous and say: “But that is not what I meant and you are one of those ‘spin-doctors’ [as also presented in this same writing].” If it is NOT WHAT WAS MEANT—then why state it? And, what exactly WAS MEANT and wouldn’t GOD ATON KNOW WHAT HE MEANT?

Now, something very important is in this next: “The adversary plays his role well and is a master of third-dimension. HE WILL CLOUD YOUR MINDS WITH ILLUSIONS OF GRANDEUR AND GET YOU ONES CHASING FANTASTIC DREAMS—ALL UNDER THE PRETENSE OF SERVING THE ‘LIGHTED’ CAUSE.”

Pointed? At whom? Oh, well yes, I see: ME! But, is there possibly something amiss right here in this statement?

“...cloud your minds with illusions of grandeur and get you ones chasing fantastic dreams...”—manifestation is THOUGHT (dreams, if you will). **WITH GOD ALL THINGS ARE POSSIBLE**—so what is meant here by GOD SAYING THAT SOMETHING IS FANTASTIC? No, do not fudge on me now, readers: THIS WRITING IS FROM ATON, THE ONE LIGHT—GOD! It says right up top: “It is I, Aton, The One Light. I am the Breath of Life. I am Source of your soul essence...”

However, to fulfill the God Plan 2000 you are going to have some pretty fantastic things come to be—AREN’T YOU? And now, supposedly, the ONE GOD OF LIGHT is telling you to cease and desist from any “fantastic” thoughts. But not to worry, this same “Being” continues to tell the poor “little one” to be at peace, don’t fret and don’t be concerned—just because you are giving out lies and presenting them as coming from GOD. I would suggest both CONCERN and a bit of conscience attention.

The facts that are being put forth by these anonymous imposters of goodness are WRONG, and those “fantastic” things they have TRIED DESPERATELY TO STOP: ARE COMING TO PASS! NOW, WHO MIGHT BE THE WAVERING PARTIES INVOLVED: THOSE WHO STAY THE COURSE, OR THE ONES WHO RUN AWAY AND DISTRACT THROUGH DECEPTION, LIES AND FALSE TEACHINGS? These latter will always try to cover themselves in excuses and make every effort possible to stop the “Doers” before they can succeed, so the do-nothings can say: “Look, see, I told you so.”

In fact, this last bash about the dwelling where Ekkers have their things and live, and the taking of it—WORKED BEFORE, so by all means the adversary will try it again—you

know, the Ekkers did not pursue a business venture in CONCLUSION in 1988 to postpone a trip wherein they attended a hearing over THAT VERY HOUSE. It won’t happen again, so if the house is again LOST—so be it. Perhaps every subsequent loss becomes less bothersome.

Now for the biggest and most notable CLUE of all: “I, Aton, caution all readers to henceforth question any and all writings, INCLUDING THIS ONE. Read them as if they are from a master con-artist who will give you great truth 99% of the time, only to suck you in and distract, or even destroy, you with the remaining 1%.” So you just met yourself! You here are left to even question the “non-receiver” and non-presenter of the writing because of the deception and lack of identification of the participants in the writing itself. Anyone, INCLUDING MYSELF, can call myself “ATON”, and I do almost all the time. In fact, does that make it so? No, only IF IT IS SO!

Therefore: BOTH THE SPEAKER AND THE RECEIVER ARE PURELY FICTIONAL IN PRESENTATION IN THAT WRITING OFFERED, PAUL. It has NOTHING whatsoever to do with ME, ATON OR DHARMA/DORIS.

I would note a last reference in that writing: “Seek first knowledge and truth. Let not the limitations of imposed beliefs and prevailing thought distract YOU from following YOUR own unique path. Still yourself and sense the inner, feeling state of resonance...” Don’t any of you get just a bit sick of this “resonance”, “en-light-en” ment, “frequency”, “low-astral”, “high-Astral”, etc.? What is being referred to here is “Astral”—all of which is basically very low etheric energy. The term “Astral” is the catch-phrase.

And finally: “Follow your own path and seek always clarification and balance. Cast no stones upon another and be quick to forgive those who still feel a need to cast stones at you. It is out of ignorance that these ones do such things. This same ignorance is why they have chosen to come into this experience at this time. When you show them that you need not get offended by their actions, you have helped show them a better way.” Well, it appears to me that this is a VERY IGNORANT speaker and receiver. I remind you of something, readers: GOD IS NOT IGNORANT, SO SOMETHING HAS TO BE ELSEWISE INCORRECT ABOUT THIS WRITING.

I remind you: Evil is subtle! “Casting stones” and “persecution” (because someone tells the truth about you) and other such misleading words and terms are bogus stories (BS). If one cannot stand in the LIGHT and respond, at the least with an identification which shows responsibility for self’s presentations or actions—one is HIDING SOMETHING. Forgiveness? Be quick to forgive? Would this mean that the other, asking for identification and Truth, is simply asking too much? And is this some kind of “humble modesty” to NOT DO SO? This is cowardice, and a decision to not do so, and is therefore a proof of an intentional deception. Does this further mean: DON’T ANSWER but be “quick to forgive” anyone for even suggesting such a remarkable thing? I mean, after all, this PARTY did end with:

“I am Aton, The One Light!” And pay attention here: “I am the Spark of Life that animates your bodies and fires your souls.” “Aton” means “God” as a label of Creator. So “SPARK” (???) If one “IS” LIGHT and IS LIFE, why would that wondrous and perfect energy represent self as only a little “spark” and “animates your bodies and fires your souls.” (???) WRONG! The thought is nice and, certainly stated under other than detailed attention to specific and explicit meaning, would be exactly that: a nice picture in thought presentation. The FACTS are, however, that Creator IS life, IS Light, IS Love, IS Truth—but so too are you, if you do our job. You animate self after being given the GIFT OF LIFE and YOU FIRE YOUR OWN SOUL, so that you find your way to the perfection of self with CREATOR.

I suggest that this person wrote that “there must be identification from entities”? Is the RECEIVER not somehow an “entity” needing to identify? I am an entity and I do identify myself to my receivers. Is it less important that I DEMAND, AT THE LEAST, IDENTIFICATION FROM SOMEONE SPOUTING OFF SOMETHING IN MY NAME? WELL, THUS FAR THE SPECTRUM WRITERS HAVE REFUSED AND CONTINUE TO REFUSE, STATING A DESIRE FOR MODESTY AND HUMILITY INSTEAD OF PRIDE IN FORM. AH, BUT THE OPPOSITE OF PRIDE IS NOT “HUMILITY”; THE OPPOSITE OF PRIDE IS “SHAME”. THESE WRITERS ARE FALSE IN PRESENTATION AND MISLEAD YOU. AND, BELIEVE IT OR NOT: IT SERVES ITS PURPOSE VERY WELL INDEED.

A more recent observation by those anonymous “receivers” is a statement regarding the “turbulence” surrounding “you” if you are trying to make connections with higher energies. This is a real clue. The one thing that is NOT present, as you make connection with Lighted beings, is CHAOS OR TURBULENCE. There becomes PERFECT peace and BALANCE in both seeking and in connecting. This is why you will note that receivers and speakers seem to delay a “start” to action, whether it be writing or speaking. When that connection is made there is always a feeling of not being necessary to the moment in physical form or service. That PERFECTION of calm balance is so blessed and so wondrous (as in perfect meditation) that the circumstance is only relinquished to further SERVE. There CEASES to be any “turbulence” AT ALL. So, if you are experiencing “turbulence” in making connections—BEWARE, TAKE CAUTION AND TAKE HEED TO WHAT IS TAKING PLACE—IT IS NOT GOING TO BE GOD OR HOSTS WHO MAKE TURBULENCE OR CONFUSED ENERGIES. AND NO, IT IS NOT THE SAME AS HAVING OTHER RESTLESS ENERGIES IN THE ROOM OR AROUND OTHER PERSONS. I often have to clear a room of these drifting energies, most of which are simply entities come to have lessons. Some thought turbulence also emanates from various ego-dominated persons in, simply put, their presence.

I do not object to this presence because my scribes and my speakers—have to recognize what is taking place and why.

Thank you, Paul, and may all of you discuss this, and when you have opportunity—TALK ABOUT THESE THINGS—SHARE—QUESTION AND REALLY LOOK AT WHAT IS COMING FORTH. It is best to always compare something against something else so that relative comparison is possible.

We do not have time in these worlds to focus on every term and every word, so we don’t do so unless obligated to point out things—language itself is misleading. People are often saying, “I don’t know whether...”. No, “whether” must have an “or not” or a statement. And this often-used phrase today: “...wasn’t that much...” or “all that”. Factually speaking, “all what?”, and “how much” is “that much”?

Another good example of ridiculous is “Oracle” announcing that he had “...met a woman who...” and then “I knew I had to go and stop Ekkers...”. From what? For what? And WHY? Let me tell you: From successfully concluding a world change in positive movement forward! Why would there be a necessity of a total stranger who thinks himself to be a “Mayan Shaman” to STOP Ekkers from anything? The OBVIOUS first realization is that the person in point is totally ignorant of information and facts surrounding anything, and much the more—Ekkers.

These are just little points, readers, that I hope will cause you to think—so that at the least you question the presenters, and not we who don’t and can’t imagine whom or what those dog-fights are about.

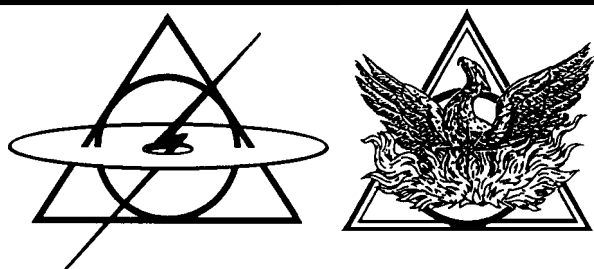
